

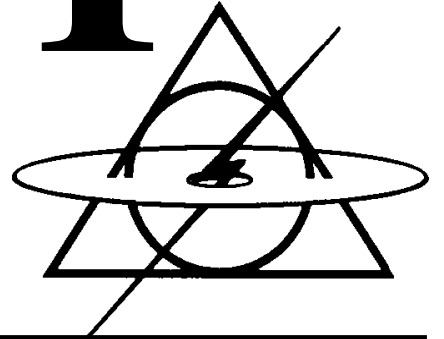

The use of computers in counting votes leaves a major question unaddressed: Who programs the computers? And, by the way, do you know what the Voter News Service is? Remember in 1992, when most anyone you talked to indicated that they had voted for Perot—but not so amazingly to the perceptive, Perot's final vote tally was within whiskers of the projections from the polls leading up to that election? With the much-ballyhooed Iowa Caucus selection process just recently completed, the following piece is especially timely.

MICROCOSM OF HOW OUR ELECTION
SYSTEM HAS BEEN COMPROMISED:
THE IOWA CAUCUS

Just so everyone understands, the Iowa Caucus operates like 2000 classroom elections. There are 2000+ caucuses in each major party, one for each party in each of the 2000+ precincts in Iowa. (A precinct is about 5 or six streets around one's house, a little larger geographically in rural areas, usually housing 200 to 800 eligible voters.)

First, we'll take a brief look at the actual mechanics. Then we will examine a letter by Senator Charles Grassley (R-Iowa) in which he tries to defend the mechanics of the 1996 Iowa Caucus, and in so doing unwittingly provides us with a perfect illustration of why a tiny but well-organized Elite has succeeded in wresting the election process away from the American people during the last quarter-century.

Using the GOP side of the Iowa Caucuses, Republicans gather in living rooms, cafés, high school classrooms and social lodges all across Iowa. Each eligible voter must attend his own neighborhood precinct meeting, if he wants to vote at all. In 1996, about 100,000 people participated in the Republican Caucuses, or a little less than 50 voters per precinct, on average.

At each precinct meeting, a set agenda is suggested by the state party, although many precincts just vote for the presidential candidates. The voting in the GOP is done on a piece of paper. Then the votes are counted immediately, with all factions welcome to participate or witness the count. THIS IS THE WAY IT SHOULD BE DONE.

Next, the total vote count for that precinct is reported to the GOP County Chairman (there are 99 counties in Iowa, and 99 county chairmen). Next, each County Chairman calls the total vote for his county into a central location. In 1996 that central tabulating center was *Voter News Service* in New York City, the exit-polling arm of AP wire, ABC, CBS, NBC, and CNN. (On our web-site, www.networkamerica.org, there is a button in the left column which leads to a picture of a *Voter News Service* exit-poll box used in New Hampshire, which we videotaped ourselves. This box has the logos of all the above-mentioned TV networks and wire services. Ted Koppel showed an identical box at a different location on the Nov. 2, 1996 *Nightline* in a lame attempt to try and refute the contention that the election-night competition between the big TV networks to project winners and losers is a hoax. We have that on videotape, also.)

GOP Iowa Caucus vote in 2000 is not yet confirmed. If you are in Iowa and you will be with a County Chairman, it will be on his tally sheet where he should call his results. If anyone in Iowa can confirm who is counting the Iowa Caucus Republican and Democratic county vote, it would be greatly appreciated. I think you will find that both the Democratic Iowa Caucus and the Republican Iowa Caucus votes are counted by the TV networks and *Voter News Service*. If we can confirm that, I will do an entire e-wire just on the implications of such a state of affairs. If you can help us out with that, please e-mail us at netamerica@unidial.com. Thanks.

In any case, in 1996, the tally sheet told the County Chairman to call his county totals in to *Voter News Service* and reminded the County Chairman that the first 10 or so who called their totals into New York City would get a free *Voter News Service* mug (whoopieee!).

The final step is that *Voter News Service* announces the totals, or partial totals, as was the case in 1996. The final totals for 1996 have never been released to this day. (Please bear in mind the timing involved: As explained in our last e-wire, the networks claim to be able to accurately project the caucus one minute after the Iowa Caucus begins and before even one vote has been cast, based on supposed *Voter News Service* ENTRANCE polls. Then *Voter News Service* claims to be able to tabulate enough of the Caucus vote to go home by 11:15 PM that night, four hours and fifteen minutes after the Caucus begins. BUT when it comes to getting the FINAL totals, explaining discrepancies and answering questions about their performance—neither the Iowa GOP nor *Voter News Service* are able to accomplish the task, even with four years to do so.

The reality is this: The Iowa GOP relinquishes its responsibility to count the Iowa Caucus Vote to *Voter News Service* so that it will insulate itself from any discovered vote manipulation. The fact that the GOP trusts the 4 big TV networks and their exit-polling arm to do the counting for the Iowa Caucus should tell all who are not totally brain-dead volumes about the way this country really is working. Then, when vote fraud must be done, as we believe was the case in 1996, *Voter News Service* deliberately stops the count and goes home (as least, that's what they tell us) before finishing. They know from experience that once the TV networks have announced the winner, they can go home and NEVER release a final count. And that's exactly what they did in the 1996 Iowa GOP Caucuses.

In 1996, *Voter News Service* abruptly announced that vote tabulation was being cut off at 11:15 PM. Did they have a bedtime curfew?? Of course they did NOT have a bedtime curfew. They cut off the counting at that point in 1996 so as not to reflect over the airwaves the strong Buchanan vote in Dubuque and Souix City. They didn't want the public to get the impression that Buchanan had finished strongly ahead of Dole anywhere. (The same thing happened at the despicable GOP Convention in San Diego in August 1996, when the GOP gangsters actually tried to prevent even one Buchanan vote from being announced during the convention roll call. They didn't succeed, but they illegally denied hundreds of Buchanan votes from being announced on the floor. This story was published by us in 1996 and will be on our web-site soon.) But most importantly, the reason VNS went home before the final tally was announced was to leave some loose ends, in case they were caught red-handed in the vote fraud by a voice loud enough to be heard, in which case they would feign confusion and backtrack.

MACROCOSM OF HOW OUR ELECTION
SYSTEM HAS BEEN COMPROMISED

In our e-wire of a few days ago, we promised to explain HOW it could be that a handful of mega-software companies could gain so much power over our voting system, with no checks and balances. Senator Charles Grassley's (R-Iowa) remarkably candid letter tells us how.

Listen to what Senator Charles Grassley said in response to a letter from Mrs. Lois Pusateri of Dubuque, Iowa—asking if *Voter News Service* was counting the vote (his letter is on file):

Grassley: "To start with, let me explain the system. Seeking to ensure an honest reporting of voting information, since 1988, the Iowa Caucuses have operated under the system whereby the precinct gives its results to the county which, in turn, passes the information on to the official reporting outlet, the *Voter News Service* (VNS). All reports go directly from the county to VNS. The State Republican Party has no role in this reporting process and no independent verification of the votes. VNS is the first entity to get the results and then it reports them. I don't know for certain why there was a discrepancy between what you saw reported and what the actual numbers were, but there is a significant lag time between the time the votes are cast and when the state party gets the final, confirmed information from the county. This is why the final numbers aren't available for several weeks. I certainly understand your concern regarding voting fraud. It is, indeed, a very serious matter. But, under the system I described above, I believe a fair accounting of the Iowa Caucuses takes place. Please contact me again when you have questions or concerns on any matter."

By the way, the entire nation owes a debt of gratitude to Mr. and Mrs. Sam & Lois Pusateri of Dubuque, Iowa for gathering, preserving and extracting information (such as the Grassley letter) and research on the Dubuque, Iowa vote fraud. This investigation would have been a shadow of itself without them. (The response to Sen. Grassley by Mrs. Pusateri is on our web-site, in the archives, in the vote fraud section, in the section about the 1996 GOP Primaries.)

Also, the Dubuque story would not have been uncovered in such detail without the hawkeye observation and investigation of Tim Wozniak, at that time a student at Loras College in Iowa, who noticed in the midst of the Dubuque County Caucuses that the county chairmen were calling their vote in to *Voter News Service*. Doug Zeitz and Chris Schaper, both Buchanan Brigadiers who flew in from California for the last week of the Caucus, and amidst doing many other vital tasks, noticed as they were about to board their plane back to California on the morning after the Caucus that the results reported in the *Cedar Rapids Gazette* (via AP and *Voter News Service*) had shorted Buchanan in Dubuque County by a full 13% of his votes.

Now let's analyze Senator Grassley's above letter in catechism form (Q & A), and from it extrapolate information which tells us how and why public officials all across the United States have abdicated their solemn responsibilities to the American voter.

Q. Does Senator Grassley confirm that the GOP has turned its authority over the Iowa Caucus vote count to the exit polling arm of ABC, CBS, NBC, *CNN*, and AP wire?

A. Yes, Senator Grassley forthrightly confirms this.

He calls VNS the "official reporting outlet", and further tells us that it's been going on since at least 1988.

Q. Does Grassley tell us that both the Democratic side of the Iowa Caucus and the Republican side of the Iowa Caucus are entrusted to *Voter News Service*?

A. Yes, he seems to say that, as he does not restrict his comments to the Republican Iowa Caucus but simply talks about the Iowa Caucus.

Q. Is Senator Grassley concerned that his Party has turned the final tabulating process over to a New York City-based private company, which we know, and he should know, is an arm of the big TV networks?

A. Not at all. He states that he believes "under the system I described above" that "a fair accounting of the Iowa Caucuses takes place".

Q. Why does Senator Grassley say he believes this?

A. He doesn't say, and he is reproached for this glaring omission by Mrs. Lois Pusateri in a follow-up letter, for she had asked him this exact question in her initial letter.

Q. Is Grassley concerned that the Iowa GOP has totally relinquished its responsibility in the vote count to VNS?

A. Not at all. He seems only to be concerned about making it clear that the GOP has no part WHATSOEVER in the count. He says, "The State Republican Party has no role in this reporting process and no independent verification of the votes. VNS is the first entity to get the results and then it reports them."

Q. How does he address Mrs. Pusateri's question as to why the final results have not been published—even three months after the Caucus was over?

A. Incredibly, Grassley defends this absurdity on the part of the Iowa GOP and VNS by stating that "there is a significant lag time between the time the votes are cast and when the state party gets the final, confirmed information from the county. This is why the final numbers aren't available for several weeks."

Q. But isn't Grassley's letter dated June 6, 1996, a full fifteen weeks after the Iowa Caucuses?

A. Yes, it is. It doesn't seem to cross Grassley's mind that the 99 GOP County Chairmen of Iowa can call in their final results to *Voter News Service* within 4 hours, but that these same 99 County Chairmen can't get their results to the Iowa State GOP Headquarters in 4 months (by now 4 years).

Q. Doesn't Grassley address the question as to why the final results still hadn't been released at the time of his letter, or why the Dubuque total is still falsified, shorting Buchanan 13% of his vote?

A. No, he does not.

Q. Doesn't Grassley express any concern about the situation?

A. Yes, he states that he understands Mrs. Pusateri's "concern regarding voting fraud. It is, indeed, a very serious matter."

Q. Is Senator Grassley talking like a moron?

A. Yes, he is.

Q. But is he talking any less absurdly and cravenly than election officials and elected officials across the United States of America?

A. No, he is not talking any less or any more absurdly than the others. They all sound alike when addressing the vote fraud vs. honest elections issue. He sounds like a bought-and-paid-for company man, who must stick to the party line if he wants to have a chance to remain where he is.

And the Grassley attitude is the exact same attitude we find exhibited by Board of Elections officials and

Secretaries of State all over the country. The changes in law after Watergate gave the major parties at the national level a greatly increased power of the state and local parties. By 1999-2000, all you have left are petty people and petty bureaucrat types in all those election-related positions. (We'd love to find some exceptions.)

The election officials we have run into across the country fit into one of three categories: 1) Ambitious climbers who want to prove to the party they are loyal, and who wouldn't THINK of rocking the boat, no matter what was at stake; 2) aging women who need the job; and 3) bureaucratic types who have never had a better job and don't want to lose it for any reason.

By the late 1980s the computer revolution in elections that began about 1973 was almost completed. These individuals serving in election-related positions are by the late 1980s told that such and so a company will provide the software and the know-how and all they have to do is sign the results as "True" about a week after the election. Easy. Convenient. No fuss. No muss.

Item: In the 1999 Iowa Straw Poll, the County Board of Election Supervisor was running the count. After the press conference, which was held about 24 hours before the Straw Poll, I was able to ask the Elections Supervisor who programmed the software which they used to count the votes. She couldn't say. Pressed a second and third time, she said "someone" in her office. Turning to a co-worker, she said something like, "Isn't Bob involved in that?" No full name was ever given. Typical. That's the way they all are. She was a nice lady—in way over her head.

When they do give a name, it usually means that that person loads the software onto their computers, which means absolutely nothing. Any honest programmer will tell you there are numerous ways to warp an election, and even have the program hide what it did after the voting hours are over. Honest programmers will tell you that no one can really read a computer program except the person who wrote it.

Item: Under oath, in Cincinnati during our case against the Hamilton County Board of Elections in 1985, the Board of Elections admitted that no one locally could read the software used to count the election ballots. Computer expert Robert Strunk gave a massive expert opinion to the court on this, which is available on our web-site.

Item: In a mid-1980s case in West Virginia, State Representative Leo Underwood, a Protestant pastor, found it odd that he had gotten exactly 11 votes in every last precinct in an unsuccessful bid for the state Senate. He sued and finally got the local programmers to the stand. All took the *Fifth Amendment*. Since he knew them all, he later asked why. They told him that their lawyers told them they must, because—since none of them could read the program provided by the national mega-software company—none of them could say for sure whether there was fraud or not.

Item: Every judge in every part of the United States has blocked inspection of any computer program ever contested in court, which amounts to over a dozen cases. One of these cases (from Indiana) was covered on that lone Dan Rather *CBS Evening News* 5-minute report which appeared in early November 1988 (we have it on videotape).

Item: In 1996, Pat Buchanan's local chairman, Dan Giroux, went to Hamilton County election headquarters on Primary night and asked to see the vote being counted. "You can't," said Bruce Taylor, head of the BOE at that time. "Why not?" asked Giroux. "It might

compromise ballot security." Dan Giroux later told me he wondered, "Whose security?"

Item: On the Wednesday morning after the 1999 November Cincinnati City Council Election, the head of the local Democratic Party, Tim Burke, and the head of the local Republican Party, Mike Allen, appeared on the *Jerry and Craig Morning Talk Show* on 55 WKRC radio.

I called in and asked them while on the air, with tens of thousands of people listening, if it were not true that as heads of the Board of Elections as well as heads of the local major parties, they would sign a document stating that the election results announced the night before were true. They both agreed.

I then asked them what was the NAME of the person who had programmed the computers to count the votes the night before. Democratic Chairman Tim Burke said, I think it's so-and-so. Bluffing, I snapped back: "I think you're wrong." Mr. Burke backed off.

Then the liberal host, Craig Kopp, said, "OK, Jim, who is it?" I responded that I had no idea, but that the heads of the two major parties who were about to sign the computer-generated results as true in their capacity as election officials had just revealed before tens of thousands of Cincinnatians that they didn't even know who wrote the program to generate the results they were going to sign as true.

Keep in mind that the system in use in 1999 was the same crooked system about which Judge Niehaus had ruled that "There is no safeguard against the computers being programmed to distort the election results"—in 1985! (A crooked Appeals Court overturned his decision without comment in 1987.)

Now, if you met either Tim Burke or Mike Allen, you would immediately recognize them as competent professionals. These guys are not stupid. Nor are their backgrounds mysterious. Mike Allen went to Elder High School a few years after I went to St. Xavier High School, and Tim Burke graduated from the Latin/Greek/Philosophy program at Xavier University a few years before I did in the early 1970s. But that's what's happened to our election system. The monied Ruling Elite have erected a few computer companies and a few voting-machine companies. It's so easy for those election officials now; so convenient for the voters. All we have to do is go home after work, turn on the TV and watch the results. Just like microwaving a cup of coffee.

This is what's happening. This is the way in which election officials in over 3000 counties and all 50 Secretaries of State in all 50 states have been tempted and/or coaxed and/or ordered into relinquishing their responsibilities and betraying the trust of the American people. Did I say all 50 Secretaries of State? Yes. For, even in New Hampshire, 30% of the precincts now count the votes by computer, with no provision for citizen checks and balances. That's 3 out of 10 people whose right to a fair election is not being protected, even in New Hampshire.

So, while you're watching the Iowa Caucus results this Monday Night, think about these things. And try to figure out how it is that the "talking heads" on the big TV networks are curious about everything else, are allowed to talk about anything else, "anything at all", except how the vote is counted.—Jim Condit Jr., Director, Citizens for a Fair Vote Count

Let me run by you a brief list of items that are "the law" in America today. As you read, consider what all these have in common:

1. A national database of employed people;
2. 100 pages of new "health-care crimes," for which the penalty is (among other things) seizure of assets from both doctors and patients;
3. Confiscation of assets from any American who establishes foreign citizenship;
4. The largest gun-confiscation act in U.S. history—which is also an unconstitutional *ex post facto* law and the first law ever to remove people's constitutional rights for committing a misdemeanor;
5. A law banning guns in ill-defined school zones; random roadblocks may be used for enforcement; gun-bearing residents could become federal criminals just by stepping outside their doors or getting into vehicles;
6. Increased funding for the Bureau of Alcohol, Tobacco and Firearms, an agency infamous for its brutality, dishonesty and ineptitude;

By October 1, 2006, “Neither the Social Security Administration or the Passport Office or any other Federal agency or any State or local government agency may accept for any evidentiary purpose a State driver’s license or identification document in a form other than [one issued with a verified Social Security Number and ‘security features’].”

10. And my personal favorite—a national database, now being constructed, that will contain every exchange and observation that takes place in your doctor’s office. This includes records of your prescriptions, your hemorrhoids and your mental illness. It also includes—by law—any statements you make (“Doc, I’m worried my kid may be on drugs; Doc, I’ve been so stressed out lately I feel about ready to go postal.”) and any observations your doctor makes about your mental or physical condition, whether accurate or not, whether made with your knowledge or not. For the time being, there will be zero (count ‘em, zero) privacy safeguards on this data. But don’t worry, your government will protect you with some undefined “privacy standards” in a few years.

All of the above items are the law of the land. Federal law. What else do they have in common?

Well, when I ask this question to audiences, I usually get the answer, “They’re all unconstitutional.”

True.

My favorite answer came from an eloquent college student who blurted, “They all SUUUCK!” Also true.

But the saddest and most telling answer is: They were all the product of the 104th Congress. Every one of the horrors above was imposed upon you by the Congress of the Republican Revolution—the Congress that pledged to “get government off your back”.

BURYING TIME BOMBS

All of the above became law by being buried in larger bills. In many cases, they are hidden sneak attacks upon individual liberties that were neither debated on the floor of Congress nor reported in the media. For instance, three of the most horrific items (the health-care database, asset confiscation for foreign residency and the 100 pages of health-care crimes) were hidden in the Kennedy-Kassebaum *Health Insurance Portability and Accountability Act of 1996 (HR 3103)*.

You didn’t hear about them at the time because the media was too busy celebrating this moderate, compromise bill that “simply” ensured that no American would ever lose insurance coverage due to a job change or a pre-existing condition.

Your legislator may not have heard about them, either, because he or she didn’t care enough to do so. The fact is, most legislators don’t even read the laws they inflict upon the public. They read the title of the bill (which may be something like *The Save the Sweet Widdle Babies from Gun Violence by Drooling Drug Fiends Act of 1984*). They read summaries, which are often prepared by the very agencies or groups pushing the bill. And they vote according to various deals or pressures.

It also sometimes happens that the most horrible provisions are sneaked into bills during conference-committee negotiations, after both House and Senate have voted on their separate versions of the bills. The conference-committee process is supposed simply to reconcile differences between two versions of a bill. But power brokers use it for purposes of their own, adding what they wish. Then members of the House and Senate vote on the final, unified version of the bill, often in a great rush, and often without even having the amended text available

for review.

I have even heard (though I cannot verify) that stealth provisions were written into some bills after all the voting had taken place. Someone with a hidden agenda simply edits them in to suit his or her own purposes. So these time bombs become “law” without ever having been voted on by anybody.

And who’s to know? If Congress people don’t even read legislation before they vote on it, why would they bother reading it afterward? Are power brokers capable of such chicanery? Do we even need to ask? Is the computer system in which bills are stored vulnerable to tampering by people within or outside of Congress? We certainly should ask. Whether your legislators were ignorant of the infamy they were perpetrating, or whether they knew, one thing is absolutely certain: The *Constitution*, your legislator’s oath to it, and your inalienable rights (which precede the *Constitution*) never entered into anyone’s consideration.

Ironically, you may recall that one of the early pledges of Newt Gingrich and company was to stop these stealth attacks. Very early in the 104th Congress, the Republican leadership declared that, henceforth, all bills would deal only with the subject matter named in the title of the bill. When, at the beginning of the first session of the 104th, pro-gun Republicans attempted to attach a repeal of the “assault weapons” ban to another bill, House leaders dismissed their amendment as not being “germane.” After that self-righteous and successful attempt to prevent pro-freedom stealth legislation, Congress people turned right around and got back to the dirty old business of practicing all the anti-freedom stealth they were capable of.

STEALTH ATTACKS IN BROAD DAYLIGHT

Three other items on my list (ATF funding, gun confiscation and school-zone roadblocks) were also buried in a big bill—*HR 3610*, the budget appropriation passed near the end of the second session of the 104th Congress. No legislator can claim to have been unaware of these three because they were brought to public attention by gun-rights groups and hotly debated in both Congress and the media. Yet some 90 percent of all Congress people voted for them, including many who claim to be ardent protectors of the rights guaranteed by the *Second Amendment*. Why?

Well, in the case of my wrapped-in-the-flag, allegedly pro-gun, Republican congressperson: “Bill Clinton made me do it!” Okay, I paraphrase. What she actually said was more like, “It was part of a budget appropriations package. The public got mad at us for shutting the government down in 1994. If we hadn’t voted for this budget bill, they might have elected a Democratic legislature in 1996—and you wouldn’t want THAT, would you?” Oh, heavens, no, I’d much rather be enslaved by people who spell their name with an R than people who spell their name with a D. It makes all the difference in the world!

HOW SNEAK ATTACKS ARE JUSTIFIED

The Republicans are fond of claiming that Bill Clinton “forced” them to pass certain legislation by threatening to veto anything they sent to the White House that didn’t meet his specs. In other cases (as with the Kennedy-Kassebaum bill), they proudly proclaim their misdeeds in the name of bipartisanship—while carefully forgetting to mention the true nature of what they’re doing. In still others, they trumpet their triumph over the evil Democrats and claim the mantle of limited government, while sticking it to us and to the *Constitution*. The national database of workers was in

the welfare-reform bill they “forced” Clinton to accept. The requirement for SS numbers and ominous “security” devices on drivers’ licenses originated in their very own *Immigration Control and Financial Responsibility Act of 1996, HR 2202*.

Another common trick, called to my attention by Redmon Barbry, publisher of the electronic magazine *Fratricide*, is to hide duplicate or near-duplicate provisions in several bills. Then, when the Supreme Court declares Section A of Law Z to be unconstitutional, its kissing cousin, Section B of Law Y, remains to rule us.

Sometimes this particular form of trickery is done even more brazenly: When the Supreme Court, in its Lopez decision, declared federal-level school-zone gun bans unconstitutional because Congress demonstrated no jurisdiction, Congress brassily changed a few words. They claimed that school zones fell under the heading of “interstate commerce”. Then they sneaked the provision into *HR 3610*, where it became “law” once again. When angry voters upbraid Congress people about some Big-Brotherish horror they’ve inflicted upon the country by stealth, they claim lack of knowledge, lack of time, party pressure, public pressure, or they justify themselves by claiming that the rest of the bill was “good”.

The simple fact is that, regardless of what reasons legislators may claim, the U.S. Congress has passed more Big-Brother legislation in the last two years—more laws to enable tracking, spying and controlling—than any Democratic Congress ever passed. And they have done it, in large part, in secret. Redmon Barbry put it best: “We the People have the right to expect our elected representatives to read, comprehend and master the bills they vote on. If this means Congress passes only 50 bills per session instead of 5,000, so be it. As far as I am concerned, whoever subverts this process is committing treason.” By whatever means the deed is done, there is no acceptable excuse for voting against the *Constitution*, voting for tyranny.

And I would add to Redmon’s comments: Those who do read the bills, then knowingly vote to ravage our liberties, are doubly guilty. But when do the treason trials begin?

BILLS AS WINDOW DRESSING FOR AN UGLY AGENDA

The truth is that these tiny, buried provisions are often the real intent of the law, and that the hundreds, perhaps thousands, of pages that surround them are sometimes nothing more than elaborate window dressing.

These tiny time bombs are placed there at the behest of federal police agencies or other power groups whose agenda is not clearly visible to us. And their impact is felt long after the outward intent of the bill has been forgotten.

Civil forfeiture—now one of the plagues of the nation—was first introduced in the 1970s as one of those buried, almost unnoticed provisions of a larger law. One wonders why on Earth a “health-care bill” carried a provision to confiscate the assets of people who become frightened or discouraged enough to leave the country. (In fact, the entire bill was an amendment to the *Internal Revenue Code*. Go figure.)

I think we all realize by now that that database of employed people will still be around enabling government to track our locations (and heaven knows what else about us, as the database is enhanced and expanded) long after the touted benefits of “welfare reform” have failed to

materialize.

And most grimly of all, our drivers' licenses will be our *de facto* national ID card long after immigrants have ceased to want to come to this Land of the Once Free.

It matters not one whit whether the people controlling you call themselves R's or D's, liberals or conservatives, socialists or even (I hate to admit it) libertarians. It doesn't matter whether they vote for these horrors because they're not paying attention or because they actually like such things.

What matters is that the pace of totalitarianism is increasing.

And it is coming closer to our daily lives all the time. Once your state passes the enabling legislation (under threat of losing "federal welfare dollars"), it is YOUR name and Social Security number that will be entered in that employee database the moment you go to work for a new employer. It is YOU who will be unable to cash a check, board an airplane, get a passport or be allowed any dealings with any government agency if you refuse to give your SS number to the drivers' license bureau. It is YOU who will be endangered by driving "illegally" if you refuse to submit to Big Brother's procedures. It is YOU whose psoriasis, manic depression or prostate troubles will soon be the reading matter of any bureaucrat with a computer. It is YOU who could be declared a member of a "foreign terrorist" organization just because you bought a book or concert tickets from some group the government doesn't like. It is YOU who could lose your home, bank account and reputation because you made a mistake on a health-insurance form. Finally, when you become truly desperate for freedom, it is YOU whose assets will be seized if you try to flee this increasingly insane country.

As Ayn Rand said in *Atlas Shrugged*, "There's no way to rule innocent men. The only power government has is the power to crack down on criminals. Well, when there aren't enough criminals, one makes them. One declares so many things to be a crime that it becomes impossible for men to live without breaking laws."

It's time to drop any pretense: We are no longer law-abiding citizens. We have lost our law-abiding status. There are simply too many laws to abide. And because of increasingly draconian penalties and electronic tracking mechanisms, our "lawbreaking" places us and our families in greater jeopardy every day.

STOPPING RUNAWAY GOVERNMENT

The question is: What are we going to do about it? Write a nice, polite letter to your Congress person? Hey, if you think that'll help, I've got a bridge you might be interested in buying. (And it isn't your "bridge to the future", either.)

Vote "better people" into office? Oh, yeah, that's what we thought we were doing in 1994. Work to fight one bad bill or another? Okay. What will you do about the 10 or 20 or 100 equally horrible bills that will be passed behind your back while you were fighting that little battle? And let's say you defeat a nightmare bill this year. What are you going to do when they sneak it back in, at the very last minute, in some "omnibus legislation" next year? And what about the horrors you don't even learn about until two or three years after they become law? Should you try fighting these laws in the courts? Where do you find the resources? Where do you find a judge who doesn't have a vested interest in bigger, more powerful government? And, again, for every one case decided in favor of freedom, what do you do about the 10, 20 or 100 in which the courts decide against the *Bill of Rights*?

Perhaps you'd consider trying to stop the onrush of these horrors with a constitutional amendment—maybe one that bans "omnibus" bills, requires that every law meet a constitutional test or requires all Congress people to sign statements that they've read and understood every aspect of every bill on which they vote. Good luck! Good luck, first, on getting such an amendment passed. Then good luck getting our *Constitution*-scorning "leaders" to obey it. It is true that "the price of liberty is eternal vigilance", and part of that vigilance has been, traditionally, keeping a watchful eye on laws and on lawbreaking lawmakers. But given the current pace of law spewing and unconstitutional regulation-writing, you could watch, plead and struggle "within the system" 24 hours a day for your entire life and end up infinitely less free than when you began. Why throw your life away on a futile effort?

Face it: If "working within the system" could halt tyranny, the tyrants would outlaw it. Why do you think they encourage you to vote, to write letters, to talk to them in public forums? It's to divert your energies; to keep you tame. "The system" as it presently exists is nothing but a rat maze. You run around thinking you're getting somewhere. Your masters occasionally reward you with a little pellet that encourages you to believe you're accomplishing something. And, in the meantime, you are as much their property and their pawn as if you were a slave. In the effort of fighting them on their terms and with their authorized and approved tools, you have given your life's energy to them as surely as if you were toiling in their cotton fields, under the lash of their overseer. The only way we're going to get off this road to Hell is if we jump off; if we, personally, as individuals, refuse to cooperate with evil. How we do that is up to each of us. I can't decide for you, nor you for me (unlike Congress people, who think they can decide for everybody). But this totalitarian runaway truck is never going to stop unless we stop it, in any way we can. Stopping it might include any number of things: tax resistance; public civil disobedience; wide-scale, silent non-cooperation; highly noisy non-cooperation; boycotts; secession efforts; monkey wrenching; computer hacking; dirty tricks against government agents; public shunning of employees of abusive government agencies; alternative, self-sufficient communities that provide their own medical care and utilities.

There are thousands of avenues to take, and this is something most of us still need to give more thought to before we can build an effective resistance. We will each choose the courses that are right for our own circumstances, personalities and beliefs.

Whatever we do, though, we must remember that we are all, already, outlaws. Not one of us can be certain of going through a single day without violating some law or regulation we've never even heard of. We are all guilty in the eyes of today's law. If someone in power chooses to target us, we can all, already, be prosecuted for something. And I'm sure you know that your claims of "good intentions" won't protect you, as the similar claims of politicians protect them. Politicians are above the law. YOU are under it, crushed under it.

When you look at it that way, we have little left to lose by breaking laws creatively and purposefully. Yes, some of us will suffer horrible consequences for our lawbreaking. It is very risky to actively resist unbridled power. It is especially risky to go public with resistance (unless hundreds of thousands publicly join us), and it becomes riskier the closer we get to tyranny. For that reason, among many others, I would never recommend any particular course of action to anyone—and I hope you'll think twice before taking "advice" from anybody about things that could

jeopardize your life or wellbeing. But if we don't resist in the best ways we know how and if a good number of us don't resist loudly and publicly—all of us will suffer the much worse consequences of living under total oppression.

Whatever courses of action we choose, we must remember that this legislative "revolution" against We the People will not be stopped by politeness. It will not be stopped by requests. It will not be stopped by "working within a system" governed by those who regard us as nothing but cattle. It will not be stopped by pleading for justice from those who will resort to any degree of trickery or violence to rule us. It will not be stopped unless we are willing to risk our lives, our fortunes and our sacred honors to stop it. I think of the words of Winston Churchill: "If you will not fight for the right when you can easily win without bloodshed, if you will not fight when your victory will be sure and not so costly, you may come to the moment when you will have to fight with all the odds against you and only a precarious chance for survival. There may be a worse case. You may have to fight when there is no chance of victory, because it is better to perish than to live as slaves."

1. Re the employee database: *Welfare Reform Bill, HR 3734*; became *Public Law 104-193* on 8/22/96; see section 453A.

2. Re health-care crimes: *Health Insurance Portability and Accountability Act of 1996, HR 3103*; became *Public Law 104-191* on 8/21/96.

3. Re asset confiscation for citizenship change: Same law as #2; see sections 511-513.

4., 5., and 6. Re anti-gun laws: *Omnibus Appropriations Act, HR 3610*; became *Public Law 104-208* on 9/30/96.

7. and 8. Re terrorism & secret trials: *Antiterrorism and Effective Death Penalty Act of 1996, S 735*; became *Public Law 104-132* on 4/24/96; see all of *Title III*, specifically sections 302 and 219; also see all of *Title IV*, specifically sections 401, 501, 502 and 503.

9. Re *de facto* national ID card: Began life in the *Immigration Control and Financial Responsibility Act of 1996*, sections III, II 8, 119, 127 and 133; was eventually folded into the *Omnibus Appropriations Act, HR 3610* (which was itself formerly called the *Defense Appropriations Act*—but we wouldn't want to confuse anyone, here, would we?); became *Public Law 104-208* on 9/30/96; see sections 656 and 657, among others.

10. Re health-care database: *Health Insurance Portability and Accountability Act of 1996, HR 3103*; became *Public Law 104-191* on 8/21/96; see sections 262, 263 and 264, among others. The various provisions that make up the full horror of this database are scattered throughout the bill and may take hours to track down; this one is stealth legislation at its utmost sneakiest.

And one final, final note: Although I spent aggravating hours verifying the specifics of these bills (a task I swear I will never waste my life on again!), the original list of bills at the top of this article was NOT the result of extensive research. It was simply what came off the top of my head when I thought of Big-Brotherish bills from the 104th Congress. For all I know, Congress has passed 10 times more of that sort of thing. In fact, the worst "law" in the list—#9, the *de facto* national ID card—just came to my attention as I was writing this essay, thanks to the enormous efforts of Jackie Juntti and Ed Lyon and others, who researched the law.

Think of it: Thanks to congressional stealth tactics, we

had the long-dreaded national ID card legislation for five months, without a whisper of discussion, before freedom activists began to find out about it. Makes you wonder what else might be lurking out there, doesn't it? And on that cheery note—THE END

WORLD ELITE MEET AT ECONOMIC FORUM

World leaders and businessmen are gathering in the Swiss ski resort of Davos for the opening of the annual World Economic Forum on Thursday. The six-day gathering is an informal meeting of the world's political and economic elite.

The guest of honour is President Bill Clinton. He is the first sitting U.S. President to frequent the meeting and security will be tight.

Now in its 30th year, the World Economic Forum meeting at Davos has become one of about half-a-dozen key economic and political gatherings of the year.

Former *Observer* Editor Will Hutton, who has been attending the event for over a decade, says it is a useful barometer of opinion. "Davos doesn't tell you what is going to happen particularly—it tells you what the international common sense is at a particular moment in time and what the order of priority of concern is amongst central bankers, finance ministers, heads of government and chief executives," he says.

This year's cast list is hugely impressive. Some 30 world leaders—including Tony Blair and Bill Clinton—will drop in. More than 1000 senior executives from the world's top companies will also attend. They will pay thousands for the privilege, but they'll also see the likes of Bill Gates of Microsoft and Rupert Murdoch of *News International* sharing a stage.

One key theme is the growing concern over the impact of globalisation. Organisers fear a repeat of last December's riots in Seattle at the World Trade Organisation meeting. A massive security operation is already underway.

The continuing weakness of the euro will also be discussed, as will the ongoing recovery in the Asian economies.

But while those attending may believe the global economic outlook to be more benign than for years—some warn that there is still a real threat to global stability.

REPUTED COCAINE BANK MONEY LAUNDRY WIZARD FOR GEORGE BUSH FAMILY ARRESTED IN CHICAGO

The reputed cocaine bank money laundry wizard for former President George Herbert Walker Bush and two of his sons has been arrested in Chicago. The matter is tied as well reportedly to corrupt top IRS Officials, Chicago Region Office fingered by our work.

Giorgio Pelossi, a prominent Swiss accountant, was arrested January 20, 2000, at O'Hare International Airport, after officials of the U.S. Immigration and Naturalization Service, INS, found he was wanted on an international arrest warrant issued in Milan, Italy, about a year previous. Pelossi, 61, was somehow actually traveling under his own name. His name showed up on a passenger manifest in a routine check provided to officials of the INS. (Savvy sources, however, dispute that it was so "routine" but was rather a follow up of matters outlined in our TV documentary, 11/29/99.)

In his appearance before a Federal Magistrate in Chicago, Pelossi agreed not to oppose being sent back to Italy by extradition. Pelossi signed papers in Chicago's Federal District Court waiving his right to a hearing in Chicago.

Pelossi is reportedly the cocaine bank money laundry expert for the former president and two of his sons, Texas Governor George W. Bush and Florida Governor Jeb Bush. Some claim that the matter also reportedly implicates the other son, Neil Bush, who escaped federal prison through a reputedly corrupt arrangement upon the downfall of Denver-based Silverado Savings & Loan Association, an apparent CIA proprietary operation of which Neil Bush was an official. Some contend Silverado, at the hands of Neil Bush, was likewise a money laundry for illicit funds including reportedly narcotics trafficking.

For a year or more now, journalists and commentators in Spain have been writing and talking about the elder Bush and two of his sons, George W. and Jeb, being reportedly implicated in billions of dollars of dope money laundered through banks in Spain, Italy, Mexico, and the United States. The cocaine banking cartel, for which Pelossi reportedly was the kingpin and brains, was centered in Milan and Barcelona.

According to stories, some date-lined Rome, in December, 1995, by *Reuters*, *United Press International* and other news and law-enforcement personnel, Italian authorities contended they had proof leading them to assert that the Archbishop of Barcelona was implicated with the Vatican Bank and others in a vast money-laundry ring reportedly involving, among others:

I. FIRST NATIONAL BANK OF CICERO (a Chicago suburb, Al Capone Land, a long-known mafia enclave). Later it became the flagship of PINNACLE BANC GROUP. Still later, to confuse matters, the bank was called Old Kent Bank, a unit whose head office is Grand Rapids, Michigan. Pinnacle was the successor and alter ego to the mysterious, scandal-wrecked, BANK OF CREDIT AND

COMMERCE INTERNATIONAL, which supposedly (although not actually) went under in 1991. BCCI was a reputed assassination and espionage funding apparatus for various intelligence agencies, including the American CIA, the French CIA and Israel's The Mossad (The Institute).

Bishop Paul Marcinkus, head of the VATICAN BANK until 1991, was also the dominant force controlling First National Bank of Cicero. Marcinkus was originally from Cicero and ran a church there. Marcinkus fled the Vatican, sheltering himself with his Vatican passport when Italian authorities sought to grill him and possibly prosecute him for various criminal offenses he reportedly committed as Vatican Bank chief. He returned to the U.S. and lives in Sun City, Arizona.

II. Roger D'Onofrio, an American CIA official, with dual citizenship, U.S. and Italy, living near Naples, Italy. Italian authorities, in the wire service and other stories of December 1995, described him as the CIA's secret paymaster in Italy, to fund political assassinations of those not liked by the American CIA and to pay-off or destroy opposition parties in the Italian government.

The Pelossi-Marcinkus-D'Onofrio ring reportedly, through Vatican Bank and other financial institutions, trafficked in smuggled gold, osmium nuclear bomb triggers, high quality counterfeit foreign currencies and other illicit goods and services. With the corrupt connivance of top officials of the INTERNAL REVENUE SERVICE, Chicago Region office, Pelossi reportedly arranged the laundering of billions of dollars through concealed and dummy accounts, reportedly in the following banks, among others; and for and on behalf reportedly of George W. Bush, Jeb Bush and the elder Bush, their father:

HARRIS BANK OF CHICAGO and their Foreign Exchange section, called ForEx, a unit of BANK OF MONTREAL, owned principally by the whiskey-soaked BRONFMAN FAMILY (SEAGRAMS booze, Cineplex-Odeon movie theater chain, as well as numerous operations of records-entertainment in California). The former major owner of Harris Bank, now also a major stockholder of Bank of Montreal, is U.S. Senator Peter Fitzgerald (R., Ill.). Harris Bank/Bank of Montreal are interlocked with the worldwide Mexican bank cartel, Grupo Financiero Bancomer. In May, 1998, Bancomer pleaded guilty to U.S. federal criminal charges of vast dope money laundering. They tried to whitewash the matter with an explanation on their web-site: <http://www.bancomer.com>. Bancomer has operated in the U.S. through branches in Los Angeles and New York. Their attempt to open a branch in Chicago was opposed by one or more City of Chicago Alderman who referred to the Bancomer criminal guilty plea. Yet, the Federal Reserve apparently is ready to let Bancomer operate throughout the U.S. in various units. Bancomer is not only reportedly implicated in the Russian embezzlement caper, where many billions of dollars disappeared or were laundered. They also are reportedly implicated in the ring of which Pelossi has been the brains and kingpin, for the Bush Family and others, Portugal, SPAIN, Italy and elsewhere, including Morocco and COLUMBIA.

Harris Bank also has secret and dummy accounts of reputed terrorist OSAMA BIN LADEN. His concealed accounts are reportedly jointly [held] with SHARON PERCY ROCKEFELLER, top official in Washington, D.C. of PBS and her family. She is the wife of U.S. SENATOR JOHN D. ROCKEFELLER 4th (D., West Virginia). Her family reportedly is in the construction business with bin Laden. The first thing is, "What is He doing now? Why are the messages a bit demanding and somewhat personal in nature, when we don't want to hear about ourselves but, rather, to get on with 'the program'—you know, the money!"

Well, if you can't figure it out as to meaning or continuity of presentation, readers, what have you been doing for 14 years? I certainly appreciate input, and if possible to integrate conveniently into our processing, we will do so. I note, however, that a lot of you who would now like to sort-of "run" a bunch of things—since we enter probability of accessing the wherewithal—haven't kept up carefully with the full program of educational input. If you have taken time out for "living" while we marched the journey, you will have to understand that we may well not "agree" with you in some measure in some facets of our perception vs. yours. The property is monitored from the keyboard onward and back again. If there is anything so private that you need to tell us as to be unsuitable for e-mail or fax transmission, then it should not be shared.

I will example just a bit of this, to our friend Robert N. He has excellent ideas and runs into very positive possibilities—BUT SO FAR THE IDEAS ARE "NOT NEW" AND—IN THAT STANCE OF TOTAL "PRIVACY", AS IN "FEAR OF SEEING EYES"—ARE TOTALLY WITHOUT ADDITIONAL MERIT "TO US" AT THIS TIME.

Some of the products and advantages of systems or products are, yes, a bit faster or more efficient than those in use—but they are also incredibly more expensive so have many drawbacks, as well. The apparatus itself in some of these instances is the SAME as some already planned for use in the design and structure. We cannot be responsible as to someone later saying we used something of "theirs", for this is not so and we will refuse to even consider use of such products if this is the expected outcome.

We have run into this VERY IDENTICAL thing now from several "resources" in distant places, when the systems are quite sufficient as laid forth and certainly can be modified when appropriate. If we cannot "share" ideas, then please DO NOT send them to our attention.

And no, we CAN'T go get scrambled e-mail programs for encryption. We do not want it and would not use it if we had access. We have to use public facilities which handle e-mail servers from around the globe, and we can neither afford nor do we have a desire to change it at this point. There is SECURITY in not hiding things, even little things. The "idea" is exceptionally good but totally impractical for what we

are doing.

We have made formal agreements to NOT function in many things and ways during this upstart period. You each—who want to deal with us at any time now or later—must keep up totally with what those guidelines might be. OUR MAJOR AND OUTSTANDING COMMITMENT AT THIS TIME IS TO NOT “KNOWINGLY” SET UP A PROGRAM THAT WE KNOW WILL INVOLVE MASSIVE “TRADING” OPERATIONS, FOR OUR ASSET WOULD BREAK THE BANKS AND IT IS RECOGNIZED—AND WE WILL NOT BEND FROM THAT POSITION. What others do about that with THEIR HALF of working funds is THEIR business but we will not participate with our portion. Ours will be used, FIRST, to back with gold or precious material of value to cover all potential risks for lenders, banks and, yes, the government-controlled operations of world economies.

Please realize that we enjoy the opportunity to share and consider our OWN individual wishes and hopes and growth, but we can't turn to individual wishes until we have moved strides ahead of where we are now. WE HAVE A JOB TO DO AND IT IS NOT AN INDIVIDUAL PREFERENCE FOR OURSELVES OR OUR FRIENDS; IT IS A MANDATORY PERIOD OF SETTING A FOUNDATION UPON WHICH ALL CAN GROW AND PARTICIPATE FOR AND WITHIN GOD'S GREATEST GOOD.

Communications are very expensive and extremely inconvenient here. E-mail is the only easily accomplished system and serves well but it, too, is expensive and a distance from “home”, and when you are going through what E.J. has been experiencing, just walking is almost prohibitive to going regularly to the outlet—to often find it inoperable or the place closed for something or other and/or the system server down.

Please remember that an outgoing FAX costs some \$7.50 PER PAGE. Incoming faxes cost \$1 per page, including that little “sending” page. So a joke faxed to us costs YOU whatever and costs Ekkers \$2.00, if there is a cover directive page. And yes, we HAVE to receive things and there is a demand for “hard copy” of items relative to court cases, banking, etc., and that runs from \$35.00 to whatever—because if mail goes by “mail”, it has to be couriered to the “post-office”, which is quite a distance from this location. I speak of this to allow you to realize that we are working under very limited circumstances and are trying diligently to keep expenditures to an absolute minimum.

Ekkers were required to move from one little apartment into another because of repair work, etc. That did, however, double the expenses. This is NOT a complaint session, friends, only insight as to this end of the string.

Do I have ideas to share with you? Yes, but I note that you have as many limitations in any given circumstance as the next individual. All claim great limitations as to money flow and are, in fact, pushing on us to “hurry”, lest desperation overtake everyone. This creates immense pressure.

There is much that needs attending and Ron K. in L.V. is trying to keep up with it all, while certainly he cannot even pay his rent. We must separate from NCH and we have a bunch of corporations hanging out in the rain without shelter. We are not fully aware of all the ramifications of the problems with NCH and their own problems and legal case ongoing with, we assume, the

FTC. We are going to need nominee service; we need to transfer corporations and, in fact, BUILD a new corporation agency service. And no, we do not just want to blunder into another circumstance even more entangled than this one. We need a good agency without issuing stock of any kind—to prevent what has just happened from happening again, where individuals get the “ego-bug bite”.

Yes, I do understand that there need to be backup funds before any of our own team feels capable of moving and/or setting up such a business, for yes, we have major thoughts regarding that very business and I don't wish to again divulge the plans. It will take a full-time operation just to handle those incorporations at the other end of the international line, in this instance, between the U.S. and those incorporating FROM the Philippines, for that is one of the things we will need so that we can remain OPEN and always in full cooperation with the guidelines to which we have made agreements. We want to be able to do business with ANY corporation anywhere—openly and under all laws of each and all nations in which we participate in any way.

This means that our FIRST concern is outfitting such an operation on two ends of the connection—and letting the projects as laid forth by co-venture parties take their own proper direction at appropriate sequence of “their” events. However, as things come to our attention, as in, let's consider, desalination facilities for gaining fresh water (a desperate need here), irrigation systems, waste disposal (a major disaster as is, here), we can hook up business parties with one another—but WE WILL BUTT OUT AND THEY WILL WORK OUT WHAT THEY WILL. Will we have “pull”? Yes, but we will not overstep our agreements in ANY WAY, and that means we stay out of the other party's business except for suggestions AS REQUESTED, out of all political matters, and that we completely function within the laws of the land. We are NOT an individual avenue for individual business partners.

Our thrust in the U.S. is as outlined. We have businesses to set forth as always planned AND WE CERTAINLY PLAN MAJOR ASSISTANCE TO THE NATIVE AMERICAN SOVEREIGN TRIBES. We have no intention of butting into their business except to structure agreements which meet our needs—but which will serve them far better than ourselves.

This is just not possible in the human arena? Oh yes, it is not only possible but we are making it work and—other than among such as the *Spectrum* groupie—it is incredibly functional. When the PEOPLE get out of their greedy way, we can accomplish global change and maintain stability. I have my team and it is working extremely well, and impatience will be “overlooked”, for we will not “sell that wine out of its time”.

MAJOR meetings were held and concluded YESTERDAY regarding coalitions here who have a lot of integrated input into “their” side of the programs and methods of accomplishing our goals. Ekkers did NOT even attend—for we are, I remind you, keeping OUT of the business of those who must carry that ball across the goal line in their own setting. WE SUPPORT THEM and consequently we are supported by them. And NO, “your” curiosity is not my command to spew the chatter and gossip about the world to “shore up” your “faith”. You either have faith in Higher Cause or you do not. When you want continued PROOF in

To go on a business trip, inclusive of others, is not abandonment when you have

taken great care to have people attend the house and the birds and to be present EVERY DAY for that purpose. To have remained stable in that dwelling through amazing negative odds for fourteen years without interruption, again, proves that you COULD NOT be considered as “abandoning” anything in or on that property. Any information, files or business materials—including the offices with forced vacating—further secures your position. You perceive the world needs cleaning and clearing through better balance, nurturing and non-pollution? What of YOU? If one is polluted, so too will be the other. Clean up yourself and you will clean up your world. You need to check out carefully: **WHAT YOU REALLY WANT AND WHAT IS PREVENTING YOU FROM HAVING IT—NOW!**

THE point to know right here and right now is that you will get whatever on which you focus attention. Furthermore, as long as you continue to focus on those unwanted things, the more you will present and create of same.

You must, readers, turn your full attention to **WHAT YOU DO WANT** so that you have something to move toward. Running "away" from something only assures that that which is unwanted will keep following you—because it IS yours. **YOU CANNOT RUN AWAY FROM SELF, AND YOU WILL FIND THAT YOU CAN ONLY CHANGE SELF AND THEN PERHAPS YOU MIGHT FINALLY CHANGE THAT WHICH IS NEGATIVE IN YOUR ENVIRONMENT—USUALLY SELF AND YOUR OWN ATTITUDES AND EXPECTATIONS OF THAT "OTHER" OR THAT "THING".**

The next thing which usually flows out of your mouth is your expressed desire to "just be happy". Wow! Do you actually even think about what, exactly, would make you happy? Tossed about most often is money, more money or "if (the spouse) didn't waste the money..." (you would have more to waste and get happy). Then there is sex: "If I could just have more sex from my wife..." What do you ACTUALLY DO to make her want to have more contact of that nature with YOU? Is your whole focus on "getting some"? You trivialize the entire meaning of a relationship in this way. **Sex DOES NOT "love" make! Making true LOVE does not in any way involve the physical aspect of being.** The push for whatever you push "for", is usually SELF-GRATIFICATION TO FEEL GOOD FOR THREE MINUTES—AND HARBOR RESENTMENT FOR THE NEXT THREE HOURS.

Next come the other things in line of wishes: more time off, a vacation, freedom, sports/activities and on down the list. Surprising as it may seem, **RIGHT AT THE TOP OF THE LIST IS A RELATIONSHIP WITH GOD**—even if you don't recognize it. It is fact that until you have a good relationship with God—by whatever name you call that super-being—you are NOT at peace or at rest or in balance. Things of the world simply don't cut the longing within of KNOWING within God that you ARE. Until you find balance in that relationship—with respect and reverence and CO-APPRECIATION AS CO-CREATOR OF YOUR OWN UNIVERSE—YOU WILL HAVE YOUR MOTOR AT HALF, OR LESS, THROTTLE.

Facts are, readers, you DON'T "want" change because if you do try something, it might not work and, therefore, FEAR looms out front like a Berlin Wall. **YOU FEAR PAIN THAT "MIGHT" COME WITH CHANGE.** This is usually, if not always, EGO-PAIN of some impacting variety. **YOU ACTUALLY DO NOT WANT TO CHANGE FROM THAT WHICH HAS BEEN YOUR CATCH-BASIN FOR ALL YOUR FAILINGS AND EXCUSES.** You would actually rather complain and stay in a bad circumstance than make a real move to change, if it means further endurance of pain.

Since it is PAIN that you FEAR, can't you allow that to work FOR YOU instead of against you? You can get some leverage, if you simply reassociate your attitude to a realization of the massive pain of NOT CHANGING NOW and into the massive possibilities of pleasure in the experience of CHANGING RIGHT NOW.

FRIENDS VS. LOVERS
VS. PARTNERS/SPOUSES
VS. "RESPONSIBILITY"

Ah, now we are getting there, aren't we?

You must realize that if a relationship between a husband and wife is bad and is stopped in time, it can often have a retained "friendship" lasting lifetimes. And here, you might well ask why or "how" to accomplish that.

Get apart! You are living in blame, desire for revenge, demands upon one another that are not mutually acceptable and on and on, according to whatever your differences might be. Yes, there ARE responsibilities built into this possibility—but on what are you feasting NOW? And, what WAS it that attracted you to one another BEFORE you tied that fateful knot and came to live in total proximity to one another?

In "courting" you will find a special desire to look pleasing and well-kept, be friends, flexible in activities—and in other words, each is presenting at your "best". Then the relationship gathers steam and you come under the pressure in the cooker with no way to run and no place to hide—without the cooker do you continually ruin wonderful friendships through such contracts, which are simply GOING TO BE BROKEN? And yes, that contract called a marriage license is the major assumption of enslavement and bondage. The facts are that you have usually fallen into lust, NOT LOVE, and your expectations of getting whatever you equate to security and readily available other to fill the needs YOU HAVE. With only those things in focus, usually there will be NEITHER resulting from the bonding.

Until you have RESPECT and REVERENCE for one another, you have problems which cannot be overcome by any means of tampering. RESPECT is the key word in relationships. You can get away forever without "lust love" but respect ensures true LOVE—and in true LOVE there is desire for giving and exchanging of selves.

GOD asks not that you "worship" HIM. He asks, in a relationship with HIM, that you RESPECT AND REVERE HIM. HONOR HIM AS HE HONORS YOU! And NO, if you have the unfortunate impression that God is a pious wimp of some kind—watch out! And, furthermore, **GOD WINS IN EVERY ENCOUNTER—BEFORE IT IS OVER.**

I suggest you not just go about marking calendars to judge how much time you might have for your play because **GOD HAS NO LIMITATION OF TIME OR SPACE** and, ACTUALLY, neither do you.

I hear such things as: "But what if I stop smoking and die of cancer anyway?" or, "What if I stop drinking and die of liver problems anyway?", or "What if I give up smoking pot to get in touch with God and lose the connection?" Oh, my: **YOU WEREN'T IN REAL TOUCH WITH GOD IF THAT IS SO, MY FRIEND. YOU ARE SIMPLY DELUDING SELF.** And now for the biggie: Why would you have CANCER or LIVER FAILURE? Are you planning on these negative results coming to pass? Ummnn hummnn, I thought so.

God takes into consideration YOUR ACTIONS THROUGH YOUR INTENT and when HE finds you doing negative things to self, you get a minus point in the balance book of LIFE. **GOD IS UNLIMITED AND WHAT YOU ARE DOING—SLOPPING AROUND IN THE NEGATIVE LIMITATIONS—IS LIMITING YOUR PERCEPTION OF GOD AND SELF.** ALL things are possible with God.

I repeat that which I have spoken before: **Change is usually not a question of capability; it's almost always a question of motivation.**

What does pleasure mean TO YOU? What does pain mean TO YOU? Is it bodily pain—as in headache or you broke your arm—or are you talking about self-pain, as in emotional hurt? Well, if you are IN PAIN,

you must change or, at the least, remain in pain—and that is easily understood, isn't it? Every change you have ever accomplished in your life is the result of changing your associations about what means pain and what means pleasure. And, don't lie to self: **YOU ARE NOT LIVING IN PAIN TO MAKE SURE SOMEONE ELSE LIVES IN PLEASURE—IF YOU ARE IN PAIN, YOU CAN KNOW THAT THE SIGNIFICANT OTHER IS ALSO IN PAIN BECAUSE YOU WILL MAKE SURE OF IT.**

BUT, WHAT IF YOU DO CHANGE?

Here we go in the “iffings”. What if your wife changes and becomes that typical “prostitute” you want in your bedroom, making all those stupid assumptions and lies dumped on you—happen? Are you going to like that prospect? It might even help your income—but will it produce happiness? Pleasure beyond the very limited moment? And what of more money—FOR WHAT? If you stop your focus on LACK, you could immediately create MORE.

So, you want to change? When? You WILL when you are really ready and when you perceive it is bad enough to risk the negative possibilities. I remind you, though, that if you do not change self and simply move into the mire and muck of worse expression, you are destined for further distress and not Roloids relief. Often you have severed the limb you most needed but cast away—so change might well be carefully attended WITHIN what is, and see if you can bring about positive results. But KNOW that you will have to do more than your assumed “share”, for you have at least done half to destroy what was once present in a relationship—with person or “thing”. If YOU are willing to make changes and find it more satisfying, then you can step further if you are timid in your desires to having BIG CHANGE. If you smoke, for instance, and your spouse can't stand it—go do your smoking away from spouse and outside of the house—but I suggest you do not toss your “butts” into the places SHE/HE is going to have to clean up AFTER you. These are simple things of courtesy, my friends.

When you treat others with courtesy and appreciation, respect and consideration—half your personal problems ARE SOLVED. Picking up cigarette and cigar butts is tantamount to picking up turds to one who detests the habit. If YOU can't see that, then you have other things to change—like blindness and deafness.

I have further news for you who drink or use drugs—under that influence you both stink and are a total bore, if not outright stupid and sloppy. Only another drunk can even stand your presence. These are facts, and what you choose to do about your own negative habits and “leaning tree” attitudes of “blame anything else but self” is strictly up to you. However, these are habits which you must leave, or you will find no pleasure for long in any other relationship. **Changing relationships is usually NOT A SOLUTION, for you change not your habits or demands on “that other”; you just fool them into getting attached and then hit them with both open barrels of your “real self” when your pretenses are DOWN. Some of you are so immature as to cause the “other” to have so much pain that they will precipitate the change.**

What is usually done in personal relationships? Let's say you “hung in there”; it was painful and you really weren't happy, BUT you stayed in it anyway.

Why? You rationalized that it would get better SOMEHOW—without doing anything to MAKE IT BETTER, except in possible short spurts after a real blow-up. **YOU WILL DO ALMOST ANYTHING TO STAY IN THE PAIN YOU HAVE, SOMEHOW, EVEN BLAMING LIFE FOR BEING A VEIL OF TEARS AND MEANT FOR SUFFERING. NO, IT IS NOT MEANT FOR ANYTHING SAVE GROWTH, LEARNING AND JOY. WHO TOLD YOU THE LIES?**

LEVERAGE

“Give me a lever long enough and a prop strong enough, and I can single-handedly move the world.”—Archimedes

Knowing that you have failed to live up to your own standards for your life is the ultimate pain, friends. The greatest leverage you can create for yourself is the pain that comes from inside, not outside. With this fully in mind, then KNOW that one of the strongest forces in the human personality is the drive to preserve the integrity of your own identity. And, readers, this does NOT COME FROM STEALING FROM ANOTHER THAT WHICH YOU DESIRE.

If you really wish to “change” someone, further, you do not shout at him or her what are obvious, to you, inconsistencies and contradictions in their actions. If you really want to help somebody, you won't access this kind of leverage by making them wrong or pointing out that they're inconsistent, but rather by asking them questions that cause them to realize for themselves their inconsistencies. This is a much more powerful lever than attacking someone. If you try to exert only external pressure, they'll push against it, but internal pressure is next to impossible to resist.

This kind of pressure is a most valuable tool to use on yourself. Complacency breeds stagnation; unless you're extremely dissatisfied with your current pattern of behavior, you won't be motivated to make the changes that are necessary. Let's face it: The human aspect responds to pressure. Here, I ask that you not jump over to conclusions regarding “right” and “wrong” actions, as in “against the law”, for in breaking laws you have a very different set of circumstances, which we will discuss a bit later.

When you make errors in your decisions, choices and actions which are truly immoral, unethical or outright against the law—even under the guise of “thinking” self to be somehow “right” in your assumptions of what is due and owing to you—you err, every time. And, when you cause others to make errors through your misrepresentations and outright fabrications presented, as in “authority” expertise—you really open self to due-and-owing PAIN.

People will actually go to their death or doom, loss and social disgrace to keep from recognizing that they are WRONG and need to CHANGE. They will “change all the rules” to suit themselves, the laws to interpret for selves as to making somehow “right” their foolish actions, and will stand to their own destruction and that of others with them—rather than adjust their EGO-manias. They will structure lies, cheat, steal or whatever and somehow make it seem “right” or “RIGHTEOUS”—as in “God told me to do it”—when “the devil made me do it” is beneath their threshold of getting their points across to “their team”. They feed on each

other's assumptions and input—LIES. Justifications for wrong actions are as common as breathing, readers, and these egotistical, narcissistic people with such egos that cannot bear confrontation will get rid of EVERYONE AROUND THEM BEFORE THEY WILL CHANGE AN ATTITUDE. Oh, they will APPEAR and CLAIM an attitude change, but it will not be forthcoming after the fact—they will simply hit harder the missing defenders and hold ever more tightly to their thieved property, no matter how ridiculous they are. Worse, they will say “God said...” or “God appointed me to...”. This IS a SICK personality and is, thus, dangerous in every aspect of activity.

Any pattern of emotion or behavior that is continually reinforced will become an automatic and conditioned response. Anything you fail to reinforce in a positive way will eventually dissipate and leave you again to the results of original habits and acceptance. And yes, you CAN train, and through training there is nothing that cannot be changed or accomplished. You can turn bad morals to good; you can destroy bad principles and recreate good ones; you can lift men to angelship, if there is a desire for such lofty wishes.

You continually reinforce negative habits and addictions—therefore, it results in conclusion that you have to reinforce the good habits you wish to achieve. All you have to do is backslide into the negative consequences of breaking the new desire to find the “fight” started all over again, and the SHAME rises and pleads to be buried in MORE OF THE ADDICTING MEDICATION.

Unfortunately, in the human experience it is, as John Locke stated: “Good and evil, reward and punishment, are the only motives to a rational creature: these are the spur and reins whereby all mankind are set on work, and guided.”

So, you don't agree? LOOK AROUND YOU! Through the expressions and actions of greed and “evil” enterprises, you have all but destroyed your very world in which you must sustain life.

If you do not see need for massive and major CHANGE, you are already lost and doomed, my friends. And, if you “don't give a damn”, you prove your lack of conscience or care.

SO, WHAT DO WE THINK WE ARE BUILDING?

You are not going to like my answer if you are a drifter in either direction, toward new balance or destruction. We are presenting A BETTER WAY upon which a foundation of value and change into both a balanced society and a balanced ecological system is presented—through the labors and handiwork of human expression. That means YOU MUST DO SOMETHING WITH THAT TREE, RATHER THAN SIMPLY HUG IT. IF IT IS SICK—HEAL IT AND FIX ITS PROBLEM, AND HUGGING A SICK PLANT IS NOT ENOUGH, FOR YOU ARE MOVING INTO A TIME OF USING THAT WHICH HAS BEEN OFFERED TO HELP HEAL, RATHER THAN SIMPLE USE OF HOCUS-POCUS. If you have, for instance, an oak tree dying of mistletoe parasite—clean out the parasite and protect the tree. YOU have developed parasites that destroy—they are NOT of God, including parasitic MAN.

We are not in the “business” of “just drifting”. We are in the business of creating and manifesting those creations. We are building that “parallel” world you

like to talk about—so that the destruction of the one you have is simply a failed realization. **We are not interested in parking another destroyed-planet illusion in your solar system—we plan to reconstruct and re-create balance and harmony in the world to become REALITY in God's orbiting perfection.**

Does this require duplication in some way? Yes, because the rot (cancer) must be removed and the new structure established and created.

Will mankind be left to dangle in the wind? Yes, if that is what he chooses, for evil itself is not going to be the predominant functioning status of the “New World” in creation.

Every day, actually every moment, there are decisions, choices and responsibilities to be met. Then you can say, “Well, in this way or circumstance, I am allowing others to become attuned to their own shortcomings.” It is a time for hard realizations where choices **MUST BE MADE** for the protection of the **WHOLE**, and this includes **PROTECTION OF YOU** as well as that which is and shall come to be, as confrontations become more and more

pressuring.

So, readers, don't be too hard on those, or self, over imperfections—for imperfections teach the greatest lessons and offer the most valuable opportunities to each of us. Therefore: **PRAY FOR ONE ANOTHER SO THAT THE CONDUITS OF FLOW WILL BE SUSTAINED OR REOPENED, IF YOU PERCEIVE THEY HAVE BECOME CLOGGED BY THE DEBRIS OF LIVING.** And so be it!

WHERE TO, TO DEATH OR LIVING?

By now, although you don't realize it, each of you in physical projection has experienced that which you call death and, more often, have experienced that which you call, erroneously, “near death”.

None see the **WHOLE** picture in any such experience and none of you retain all that you **DID EXPERIENCE** in consciousness.

The real **POWER** that emerges from near-death experiences (if you wish to call them by that accepted term) is a collective one—not what one person saw or heard but the sum of the many. When you have listened to the thousands of experiences from those willing to speak of their own experiences, a collective message

emerges which speaks with a very loud and thunderous voice. There are what might be considered “summations” assembled from the sum of the many who are willing to share. **YOU KNOW WHEN YOU HAVE TOUCHED GOD!**

DYING

Oh my, we would need to recognize some signs, I suppose, so that you can relate to your own possible experiences.

The FACT of actually making that “death transition into life” is recognition that any pain to be suffered comes first, for there is **NO PAIN IN THE ACTUAL TRANSLATION.**

It is most reported, however, that in a physical trauma circumstance, rather than from some “astral adventure”, there is an instinctive fight to “live”. We can discuss these various things as we move along, but the facts are that even in attempts at suicide, there is an instinctive drive to live, even as the translation is being made, for the soul strives to face the chosen experience of physical life and almost always finds the actual taking of one’s own life not really very acceptable—**TO SELF.**

These are automatic realizations because to the conscious mind it is inconceivable that any other reality could possibly exist besides the Earth-world of matter bounded by time and space. You are used to the world of matter. You have been trained since birth to live and thrive in it. You know yourselves to be yourselves by the external stimuli you receive (those senses of human). Life tells you who you are and you accept its telling. That, too, is automatic and to be expected.

At passage, the body goes totally limp.

Your heart stops.

No more air flows in or out.

You lose sight, feeling and movement—although the ability to hear goes last. Identity ceases. The “you” that you once were becomes only a memory.

There is **NO PAIN** at the **MOMENT OF DEATH.** I repeat this one because what is feared most is the suffering prior to the death passage and the fear of that which is unknown. Well, “unknown” is not a good description because you **DO, INDEED, KNOW.**

There is only peaceful silence, a calm, a quiet—a release.

It is, frankly, easy not to breathe. In fact, it is easier, more comfortable and infinitely more natural **NOT** to breathe than to breathe.

The greatest surprise for most people in dying is to realize that dying does **NOT END LIFE.** Whether darkness or light comes next, or some kind of event—be it positive, negative or somewhere in between, expected or unexpected—the biggest surprise of all is to realize you are still **YOU.** You can still think, you can still remember and you can still see, hear, move, reason, wonder, feel, question and tell jokes—if you wish.

You are still alive, VERY MUCH ALIVE. Actually, you’re more alive AFTER DEATH than at any time since you were last born. Only the way of all this is different; different because you no longer wear a dense body to filter and amplify the various sensations you had once regarded as the only valid indicators of what constitutes “life”. You had always been taught one has to wear a body to live.

If you expect to die—when you “die”—you will be disappointed. The only thing dying does is help you release, slough off and discard the “jacket” you once wore (more commonly referred to as a physical body).

That is all there is to it. Nothing else is lost.

You are not your body. It is just something you wear for a while, because living in the earthplane is infinitely more meaningful and more involved if you are encased in its trappings and subject to its rules.

SO, WHAT THEN, IS “DEATH”?

Well, hold on to your hats, kids, for it is not less, it is **MORE.** There is a great step-up of energy at the moment of passage into that next life. There is an increase in speed—as if you are suddenly vibrating faster than before—and that’s because you are, for you are in “free-form” soul expression, expressing.

Let us present it as others have described it so that it is easily understood: Using radio waves as an analogy, this “speed-up” is comparable to having lived all your life at a certain radio frequency when all of a sudden someone or something comes along and flips the dial. That flip shifts you to another, higher wavelength. The original frequency where you once existed is still there. It did not change. Everything is still just the same as it was, only **YOU** changed, **YOU** speeded up to allow entry into the next radio frequency on the dial. **AND NO, IT IS NOT INTO WHAT YOU MIGHT CALL THE FOURTH DIMENSION, FOR YOU ONLY EXPERIENCE THE MENTAL REALIZATION THAT YOU “WERE” ALREADY IN THE “ALL DIMENSIONS” ALL THE “TIME”—AND THAT IS REPRESENTED IN THE MOMENT OF “NOW”. FURTHER, YOU LOOK UPON THE LIVING PHYSICAL INDIVIDUALS ACCORDING TO “THEIR” LIMITATIONS AS TO TIME AND SPACE—AS YOU HAVE NONE. OPTIONS REGARDING THESE THINGS ARE THE CHOICES MADE AT THAT LEVEL OF UNDERSTANDING.**

As is true with all radios and radio stations, there can be “stepons” and “bleedovers”, or distortions of transmission signals due to interference patterns. These can allow or force frequencies to coexist or commingle for indefinite periods of time. Normally, most shifts up the dial are fast and efficient; but, occasionally, one can run into interference—perhaps from a strong emotion, a sense of duty or a need to fulfill a vow or keep a promise. This interference could allow coexistence of frequencies for a few seconds, days or even years where this can exhibit as hauntings or is represented by a comatose state of the “body”, where the brain is functioning but the mind is “away somewhere”! However, sooner or later, eventually, every given vibrational frequency will seek out or be nudged to **WHERE IT BELONGS.**

You fit **YOUR** particular spot on that dial by your speed of vibration existing. You can’t “just exist” or coexist forever where **YOU DO NOT BELONG. THIS IS WHY IT IS SO IMPORTANT TO LEARN NOW ABOUT THOSE THINGS.**

Who can say how many spots there are on the dial or how many frequencies there are to inhabit? No one knows, so it behooves you to aim for the highest you can get.

You shift frequencies in “dying”. You switch over to life on another wavelength. You are still a spot on the dial, but you move up (or down) a notch or two with each transition and insight growth.

You **DO NOT DIE** when you “die”. You simply shift your **CONSCIOUSNESS** and speed of vibration frequency. So, sorry if this disappoints you: **THAT’S ALL DEATH IS—A SHIFT!**

OK, SO WHAT’S “EXISTENCE”?

In responding to this question, let us start with “time” and “space”.

Time and space, as you recognize and know them, **EXIST ONLY ON THE EARTHPLANE** of physical manifestation. When you leave the earthplane, you leave such constraints and limitations.

There are realms and dimensions of existence without number, ranging from the slower, denser vibrations of form to higher, finer streamers of non-energetic currents. And there is more beyond that: realities that cannot be measured or

described in the convenience of mathematics or mind-play.

“HELL” refers to levels of “negative thought-forms” that reside in close proximity to the earthplane. It is where you go to work out—or remain within—your hang-ups, addictions, fears, guilts, angers, rage, regrets, self-pity, arrogance or whatever else blocks you from the power of your own **LIGHT.** You stay in hell (and there are many divisions to this vibratory level) for however long best serves your development. There is no condemnation here, only the outworking of your misjudgments, mistakes, misalignments or misappropriations (what some people call “sin”). In “hell”, you have the opportunity to either revel in your folly or come to grips with the reality of consequences—every action has a reaction and what is inflicted on another can be returned in kind. You experience the “flip-side” of your despair or your demands, “living through” the extremes of whatever you dread (fear). This is not a “punishment for your sins” but a confrontation with any distortion of your sense of values and priorities. You do not leave until you have changed your attitudes and perceptions.

“HEAVEN” is a term used to describe levels of positive thought-forms that reside in close proximity to the earthplane. These are just “terms” but they serve well enough for understanding, for they have become pretty well accepted in general recognition. It is where you go to recognize or enjoy your worth, talents, abilities, joys, courage, generosity, caring, empathy, givingness, virtue, cheer, diligence, thoughtfulness, patience, loving kindness or whatever else reveals the power of your own **LIGHT.** You stay in “heaven” (and there are many divisions to that level) for however long best serves your development. There is a sense of benefit here, as if one has found one’s true home and all is well. Some people regard this as “time-out”, “recess” or a “time of rewards”. In heaven, you have the opportunity to assess your progress as a soul, to evaluate pros and cons and outcomes and to remember all truths, including that of your **REAL** identity. You experience the glory of love and the power of forgiveness. This is not an end point but, rather, the realization of your purpose in Creation’s story, how you fit—and what possibilities for future growth and learning exist. You do not leave until you are ready for your next advancement—either in the world of form or beyond it.

No one “knows” how vast Creation is—only that it has always been and will always be. Shapes and embodiments change and alter, substance is recycled—but existence **EXISTS,** as does energy.

Existence is life, never-ending and ongoing, forever and ever eternal. Yet, its only true movement (without the distortion of time and space) is expansion and contraction, as if the existence that exists were capable of breathing—which it is. What appears as a progression—a “time-line” of starts and stops and ever-changing variations—is but an overleaf, an illusion that helps you to focus on whatever spot on the dial you currently inhabit, so that you can accomplish what you set out to do, or at least have the opportunity to so do and not be distracted by **THE TRUTH** that undergirds reality.

Another example which is effective in giving insight is to consider television in analogy. The picture you enjoy seeing—the progression of a storyline with characters acting out a script—is but a trick of perception. What exists, what is really there, is quite literally **ONE ELECTRON AT A TIME** (with black-and-white and three at a time with color) fired from the back of the television **TUBE** to the screen, to be illuminated once it hits the screen as a tiny dot. The continuous barrage of electrons-turned-into-dots creates the appearance of images, as scanning lines (raster bars) roll from top to bottom, separating information coming in (new dots) from information fading out (old dots). You adjust the vertical hold on your set, not to remove strange bars appearing in the picture but to place all screen activity within the range of your own

perceptual preference. A television picture tube is nothing more than a “gun” that fires electrons at a screen. Your mind connects the electrons/dots into the picture images you think you see, while it totally ignores the true reality of what actually undergirds the operation. The way television operates—at the least in your daily experience of it—is an illusion.

Existence is a lot like television. What exists, what really exists, can’t be fathomed by how it appears to operate or what it seems to be. The facts are that you do not need to fully understand the workings—but only to turn on the on-switch and check out a channel or run up and down the dial, channel-hopping, as most “men” are oft apt to do. So, yes, if you wish, you can reduce a baseball or football game on TV to a bunch of electrons and nothing more.

When your TV picture becomes “scrambled”, you call it “broken”—well, when YOU ARE SCRAMBLED, CAN’T YOU EXPECT AS MUCH?

I know that sometimes you literally lie awake at night wondering “Why me?” Then a voice responds, usually, “Oh, nothing personal—you have to do it sometime, why not you and why not now?”

Now would be a good time, I suppose, to discuss “LIGHT” and “ENLIGHTENMENT”, but I think I will save that for another sitting. And as you move along in understanding, you will find answers to questions like: “We understand why children are afraid of darkness, but why are men afraid of light?” Plato noted this a trillion years ago.

Inclusive in the response to this inquiry, however, is a reminder to you of the dangers of any kind of drug-induced experience of that transition processing. **With drugs or other mind-altering substances, you make that journey, alright, but it is NOT where you intended to go, no matter how good it may seem.** These “substances” are a PHYSICALLY-CAUSED hallucination process—which are caused, basically, by a “downer”—and the journey may seem good at the experience, but the sensing brain-body-mind has consciousness with which to contend as the substance removes itself from your system, and ALL IS TOTALLY DISTORTED IN THE “ABSENT” STATE OF MENTAL GYRATIONS. **TO FULLY APPRECIATE YOUR EXPERIENCE, YOU NEED TO MEET GOD CLEAR AND TOTALLY SOBER.** You will also come to KNOW how and why YOU ARE CO-CREATOR, for once within the presence of GOD, you know all things are possible and you have but to choose that which is most worthy of expressing.

If you look for that “partner” called God with all your heart and all your soul—YE SHALL FIND HIM. And, furthermore, you will find that nothing so far experienced can equal the very GLORY IN THE PRESENCE OF GOD OUR CREATOR. HE “thought” you uniquely—and worthy of HIS highest honor, Creation—are you to offer less in return unto HIM?

And by the way: GOD DOES NOT WANT YOU TO HAVE LESSER THAN THAT WHICH IS “BEST”, SO DON’T BE LESSER TO PLEASE YOUR ENEMY.

I ask to end this now, even though it is not too long as we usually go, but I want you to really dig into these topics on this matter because it is the most important KNOWING you can come by. THIS IS THE WAY IT “IS” AND ALL THE WISHING YOU MIGHT CHOOSE WILL NOT CHANGE THESE UNIVERSAL FACTS. YOU CAN CHANGE YOUR SCRIPTS BUT YOU CANNOT CHANGE THAT WHICH IS THE VERY BASIS OF UNIVERSAL CREATION OF INFINITE “LIFE”.

Those tools range from the most insidious, addictive drugs (either in direct, "raw" form, or blended with tobacco, wines, and liquors), through the degradation of family values through movies and TV "sitcoms" and the exploitation of sex and music, and finally to the aggrandizement of corruption in politics and the virtual abandonment of the Herculean effort required to maintain a decent and effective school system. These covert tools of world control are far more pervasive and damaging than are the few indiscriminate bombings attributed to "terrorists" which often share the same goal of world domination.

Dictionaries and encyclopedias will define sovereignty in political terms, as though only states/nations could possess it. Sovereignty is far more than that. Sovereignty also describes the appropriate relationship between God and man; a relationship wherein there is no "broker" between God and man, and wherein sovereignty, provided by God, is matched by the acceptance of responsibility by the man. (The use of the term "man" is intended to include women and children; God does not discriminate.)

And so, sovereignty is that status of freedom granted by God in exchange for the acceptance of responsibility (for himself) by the individual.

Nations, like men, are born sovereign. Men lose their sovereignty in many ways, but God provides a way for each to restore his sovereignty by rejecting commitments made for him by others and reaffirming his direct connection to God. Nations usually lose their sovereignty through colonization, losing a war with a neighbor nation, or by taking loans from the IMF/World Bank which require their political leaders to sign agreements giving up certain basic rights regarding the responsibility of the nation to determine the amount of currency it may issue or have in circulation, in addition to arms and nuclear restrictions.

Nations, too, have a way to regain their sovereignty—by reestablishing their responsibility for themselves. One of the several significant objectives of Global Alliance Investment Association (GAIA) is to provide the ways and means for nations caught in the IMF/WB debt trap to regain their sovereignty.

"Globalization", transparency, open markets and open ownership, options, "puts" and "calls", derivatives, "short" (commodities, common stock and currency)

sales, currency trading and foreign exchange are all tools of, and invented by, the international bankers (the trading elite) for the purpose of "winning" the money and property **earned** by the working (producing) people. Other, less visible, tools are organizations such as the "Black Nobility", the Club of Rome, the Trilateral Commission, the Bilderbergers, the Freemasons and the Council on Foreign Relations, to name only a few. Even the United Nations was formed by—and is used to implement the policies of—the international bankers' "cartel". Through its ownership of virtually all of the major press and media, commerce and manufacturing, transportation and communication, and its loans to those it does not own, in combination with its control (through its lobbies) of the governments of nearly all of the "developed" nations, the cartel maintains a stranglehold on the economics of the world.

That economic stranglehold is maintained by using all of the tools listed above plus two more: first, the "brainwash" effect of controlling the content and curricula of the major (and most minor) schools of economics and banking for two centuries, so that the not-yet-developed nations believe that the source of all money (foreign exchange, especially) is from those "wealthy nations" and banks controlled by the cartel; and second, that the issuance of new currency by a nation leads inevitably and immediately to a dilution of the valuation of that currency—which is strictly enforced because the cartel dictates and controls the value of every currency and it allows no one to forget it—except Malaysia. Dr. Mahathir was absolutely correct when he said, "The IMF and the international bankers (Jews) use the foreign exchange value of our currency to 'discipline' us—our only recourse is to set and freeze the value of the ringgit." In September 1998, after losing some \$240B to the manipulators, they froze the currency value and stopped the "short" selling in their stock market, which actions have proven so successful that even the major press occasionally admits that the Malaysian economy is much healthier than those "saved" by the "austerity" of the IMF.

To regain sovereignty, each nation must regain control of the value of its currency. As long as the international bankers, via the manipulation of "foreign exchange rates", are able to control the value of all nations' currencies, they will be able to rob, pillage and steal the assets of the victim nations. Only by committing and maintaining its currency on a "common denominator" with other nations can a nation break the foreign control of the value of its currency. That common denominator is, and has always been, gold. Gold has been used as the foundation of money for millennia. Only in the last one hundred years has it been derided and criticized into a secondary role by the fiat paper-money advocates, the international banking cartel.

Not only have they ridiculed and scorned gold, they have preached that a return to the gold standard is so complicated that it has become virtually impossible. That is, of course, as wrong as so many other things they preach in their prestigious "schools of economics". Perhaps, if you have no gold in your nation, returning to a gold standard might require some thought and planning, or the assistance of an alliance of nations dedicated to the achievement of economic independence. But for a nation in Southeast Asia, especially the Philippines, it is easy, actually much easier than continuing to try to cope with others manipulating the value of your currency.

In 1945, at a conclave later called "Bretton Woods", the Allied Nations, seeing that they would win World War II, began to plan for the "post-victory recovery period". One of their devices was the United Nations, others were the World Bank and the International Monetary Fund. The few "nationalistic" delegates who recognized the seeds of world domination and control in those high-sounding "charters" were quickly quashed by the bankers. Wars cost a lot of money and the bankers—especially the Federal Reserve System in the U.S.—had created paper money to loan unstintingly; they were not about to be denied the objectives of their having orchestrated the war in the first place. "Reconstruction" would require a lot more money and they knew that if they could coordinate and consolidate their control of the money supply, they could virtually control the world.

That is why any nation that has accepted a WB/IMF loan is prevented by those loan agreements from deciding the amount of its own currency it shall issue, or from paying off those loans by issuing its own currency to do so. Thus it should be made clear that sovereignty can only be achieved by a nation after the WB/IMF loans have been repaid, so that the agreements are no longer in force. If the nation's own currency is not acceptable as payment, what is? U.S. dollars, foreign exchange currencies and probably gold and gold-based money; only by reading the agreements can we be sure.

If the Philippine debt to the WB/IMF is some \$50B, it would take approximately 5,000 metric tons of gold to pay it. Does the Philippines have that much gold? Yes, many times that. Does the WB/IMF need or want gold? They say they do. If the problem is that easily solved, why hasn't it been done?

Could it be that there is a "borrowed-money syndrome" here that promulgates the idea that WB/IMF money needs never be paid back? That paying it off, especially in GOLD, is a huge waste? Or could it be that the local bankers and finance people are so accustomed to the *status quo* that they never question whether it can, or should be, paid off? Who would benefit if the WB/IMF debt were paid and the country returned to a gold-based currency? Just about everyone, except the WB/IMF and the international banking cartel; to confirm that, President Estrada should be asked who it is that is pushing him so hard for constitutional change. It seems that someone is more than a little desperate to effect that change; quite obviously, there are forces at work that want to collect on their campaign support by being allowed to buy Philippine companies and properties at fire-sale prices.

What would be different if the Philippines were returned to sovereignty and its currency based upon gold? To state it in a broad sense: Within a few years, the Filipino people could easily achieve a standard of living equal to or greater than exists in the U.S. or Japan.

Inflation would be zero (gold does not “inflate”), so the 10% “inflation component” in domestic interest rates could be removed, leaving interest rates around 4% (instead of 14%). That alone is a huge boon to all of government, commerce and industry and would free billions of pesos for more constructive use. Even the federal tax rates could be greatly lowered, at the same time as wages for all governmental employees could be increased to reduce the need for graft and corruption. No one in the nation would need to borrow money “offshore” (there is a way for the central bank to provide adequate gold-based money without depreciating the value of the peso), so all of the concern over the nation’s “credit rating” would be gone (and gold-based money provides an immediate and automatic AAA rating anyway). There would need be no concern over “foreign exchange” and “balance of payments” because gold-based currency is directly acceptable as payment for goods and services (without the waste of time and expense of going to an intermediate foreign exchange currency) and a nation with gold-based currency need not worry about its balance of payments, since the big problem of enough “foreign exchange” has been solved—it is no longer needed. There would be no need for Overseas Workers to send “forex” home. Wages would soon be better (in real terms) here than anywhere. The Finance Department would not have to crawl and beg for foreign loans because none would be needed—the nation would have plenty of money.

New money can be printed, practically without limit, if it is **always** used first to purchase gold to be held as reserves within the banking system of a nation, even if it must purchase the gold from “off shore”. In fact, as gold reserves are accumulated the peso will increase in relative value, helping to elevate the level of its purchasing power, which is especially beneficial to the poor. This nation has more than adequate gold “on shore” and thus can double the value of its gold buying by buying from its own people with its newly issued currency. Infrastructure facilities, new or improved utilities, port and airport improvements, railroads and rapid transit systems and highways all increase the value of the nation—all of which can be matched by measured and appropriate increases in the money supply. This nation is not starving for money because it is poor; it is poor because the IMF agreements allow the “rationing” of the money supply, removing virtually all semblance of sovereignty.

The Administration might say, “But we don’t have 5,000 tons of gold and the IMF agreements prevent us from printing \$50B worth of pesos to pay for that much gold; how can we get enough gold with which to pay them off?” Suffice to say, without giving away our strategies, that there are several ways it may be done with the assistance of Global Alliance Investment Association. All that is now required is the WILL; when we work together, we can find the WAY.

The failure of the World Trade Organization in Seattle exposed “globalization” for the farce it is. Its beneficiaries are almost exclusively the “transnational” corporations that already have most of the world’s wealth, the same corporations that are owned/ controlled by the Elite international banking cartel, who are the owners of the Federal Reserve System and the guarantors of the debt of the U.S. Treasury to Global Alliance. To be positioned to do business in a GLOBAL community does not require that a nation open itself to allowing foreigners to buy up the best of its properties, businesses and natural resources; it does require strong financial reserves and a freely recognizable currency, which are both entirely within the reach of the Republic of the Philippines.

“CYANIDE WAS USED TO KILL LICE” CLAIMS IRVING

LONDON—Traces of cyanide in human hair recovered from Auschwitz and on metal ventilation grilles over the concentration camp’s gas chambers were evidence of a delousing programme by the Nazis and not of mass extermination, David Irving, the Hitler historian, said yesterday.

Mr. Irving told a High Court judge that the SS used the gas chambers simply to fumigate bodies, clothing and hair shorn after death from inmates of the Polish concentration camp in the face of a plague of lice.

He accepted that, according to a report by a forensic laboratory in Krakow in December 1945, residual traces of hydrogen cyanide were found by scientists. Subjects for analysis included a 55lb. bag of hair thought to have been taken from about 500 young Jewish women. Mr. Irving said: “Corpses arrived in a fully clothed state. As a corpse cooled, the lice crawled off the body, so you had an infestation problem. These were not homicidal gas chambers. They were used to delouse clothing and cadavers. The Germans processed human hair as part of hygiene methods.” Told that experts on Auschwitz would give evidence that what was happening there was mass gas extermination, Mr. Irving, 62, said: “That is the conclusion of a closed mind.”

The historian was beginning his third week under cross-examination by Richard Rampton, QC [Queen’s Counsel], during his libel action against Deborah Lipstadt, the American academic, and Penguin Books, which published her work *Denying the Holocaust: The Growing Assault on Truth and Memory*. He is suing both for damages over the claim that he is a Holocaust-denier who has twisted history.

Mr. Irving, who is accused of trying to exonerate Hitler for what happened to the Jews, claims that he is the victim of an international conspiracy to ruin his reputation as an historian. Yesterday, he went on to claim that the chambers, which were fitted with a door consisting of a peephole and thickened glass, were used as bomb shelters by the SS.

Mr. Rampton, counsel for the defendants, has told the court that between the first edition of his book, *Hitler’s War*, in 1977 and its second in 1991, Mr. Irving’s views had undergone a big change. In the later edition, all traces of the Holocaust as an historical truth had disappeared and Auschwitz had been “transformed from a monstrous killing machine into a mere slave-labour camp”.

Yesterday, Mr. Irving said that he stood by the man whose work had persuaded him that mass extermination never took place at Auschwitz. Fred Leuchter, a consultant in the design of execution

facilities in America, had visited the camp in 1988 on behalf of a German, Ernst Zundel, who was on trial in Canada for publishing material that denied the existence of homicidal gas chambers at Auschwitz.

In a report, Mr. Leuchter recorded only very small traces of cyanide in the gas chamber remains and relatively large traces in the delousing remains—concluding that the camp had not been used for extermination.

The report was condemned as “flawed rubbish” by Mr. Rampton, but Mr. Irving responded: “It was pioneering work, even though it has been superseded. Leuchter was barking up the right tree.”

The hearing continues.

GASOLINE ADDITIVE POSES CRUEL CHOICE: CLEAN AIR OR CLEAN WATER?

SACRAMENTO, Calif. (AP)—It smells like turpentine and spreads through water so quickly and thoroughly that a scant spoonful can foul an Olympic-sized swimming pool.

MTBE, a widely used gasoline additive that makes cars burn [fuel] cleaner, has posed a cruel dilemma: It’s making the air cleaner [sic], but it’s polluting the water.

A suspected animal carcinogen with unknown health effects on humans, MTBE has become the curse of water officials from California to New England.

Leaking from gas stations’ underground fuel tanks, it has forced wells to close, run up millions of dollars in cleanup costs, sparked lawsuits and prompted state, local and federal investigations into a petrochemical that is still something of a mystery.

“It’s a diabolical chemical. It moves up, it moves down, it moves everywhere. Our feeling is that as long as MTBE is in gasoline, our groundwater is in jeopardy,” said Dennis Cocking of the South Tahoe Public Utility District, where 12 of 34 wells were closed because of MTBE.

MTBE has two critical characteristics: its ability to spread quickly, caused by its high solubility, and its permanency. Even in its tiniest proportions, five parts per billion (ppb), MTBE has an easily detectable smell.

“The stuff moves like wildfire. It increases exponentially. Once you find out you have a problem, you have a big problem. And once it’s in, how do you get it out?” said Doug Marsano of the Denver-based American Water Works Association, a consortium of water agencies that has urged President

Clinton to ban MTBE.

According to Marsano, the chemical has been detected in varying amounts in all 50 states. Significant MTBE contamination also has been found in such pastoral areas as Ronan, Montana and Spring Green, Wisconsin, as well as in major cities like Dallas, Denver and Las Vegas.

"You can see it in a contiguous line from California to the East Coast. One of the great questions here is why a chemical that we don't have a lot of information about is being used in such a widespread manner," Marsano said. "At this point, we think it is a problem in every state, but just how significant a problem we don't know."

A European study in the mid-1990s linked MTBE to liver and kidney tumors in mice. The danger to humans is unknown.

"At the levels we're seeing in drinking water, there is no direct human study that shows cause and effect. The studies being used to assess risk are essentially studies being done on animals," said California's top drinking-water official, Dr. Dave Spath of the Department of Health Services. "But the problem with MTBE is whether [or not] there is a significant future threat because of all these tanks that have leaked over many years."

As a result, California—the nation's No. 1 user of MTBE, with about 11 percent of all fuel containing the substance—has banned it by the end of 2002 and other states are expected to follow suit. Eight Northeastern states from New Jersey to Maine joined to ask Congress to allow them to decide whether [or not] MTBE or similar clean-air additives should be put in their gasoline.

And an Environmental Protection Agency panel has recommended strengthening programs to reduce MTBE's presence in drinking water.

The MTBE industry defends the additive.

"Because of cleaner-burning gasoline with MTBE, cities like Los Angeles are enjoying their best air quality in 50 years," said Terry Wigglesworth, Executive Director of the Oxygenated Fuels Association....

...MTBE, called an oxygenate because it adds oxygen to gasoline, was developed by oil companies in the 1970s to boost octane and replace lead. Smog fighters noticed that MTBE improved gasoline combustion and dramatically reduced tailpipe pollution, in some cases up to 40 percent.

Following the passage of the *Clean Air Act* in 1990, federal authorities ordered the phase-in of oxygenates in gasoline sold in the nation's smoggiest urban areas.

MTBE became the oxygenate of choice. The other best-known oxygenate, ethanol, is a type of alcohol made from corn and is used widely in the Midwest. Supporters of ethanol see it as safer; MTBE backers dispute that.

MTBE, or methyl tertiary butyl ether, is now found in the fuel consumed by 70 percent of the nation's cars. About 4.5 billion gallons of the additive are manufactured annually.

In Santa Monica, hit first and hardest by major MTBE contamination in 1995, the substance leaked into the water supply from the underground tanks of

at least a dozen gas stations.

The city of 92,000 has shut down at least half of its wells and is now importing most of its water from Southern California's main wholesaler. The city believes the cleanup could cost \$100 million.

"It was quite astounding," said Assistant City Attorney Joe Lawrence. "It went from a low of 20 ppb to a high of 600 ppb. Once it leaked out, it created havoc with the drinking water."

Glennville, a scenic mountain town of 300 in the Sierra Nevada, was devastated by the MTBE that spread into its water supply from a single leaking underground tank. The contamination registered 20,000 ppb.

"Even the ice had a strange odor," Lori Jauch said. "In the very beginning, when they came up and told us what was happening, I think everybody in the community was shocked. They had one meeting, and everybody was upset."

The town's water supply was shut down and water is now trucked in from Bakersfield, an hour to the west.

[JR: Air and water are both essential to life, so why must we have to sacrifice one for the other? There are alternative additives that are safer and natural, such as ethanol, made from corn, but all the profits don't go to the oil and chemical companies with the big lobbies. Everyone agrees that MTBE is bad for our vital water supplies nationally but they blame it on mandates from Congress and won't stop until legislation is changed. As usual, the people must rise up and demand a ban on the use of this MTBE, and not just in gasoline.]

VENEZUELA DAMAGE ESTIMATED BETWEEN \$10 BILLION AND \$30 BILLION

CARACAS, Venezuela (AP)—Venezuela needs between \$10 billion and \$30 billion to repair the damage from December's massive floods and landslides and much of the money will have to come from other countries, a top official said Friday.

"The figures are astronomical because a substantial part of the national infrastructure has been destroyed," Vice Foreign Minister Jorge Valero told reporters.

Valero's statement is the first official estimate of the damage since avalanches of mud, water and boulders came crashing down the mountain that separates the capital, Caracas, from the Caribbean Sea on Dec. 15. Much of the Caribbean coastline north of Caracas was destroyed.

Private economists had estimated the damage at up to \$20 billion.

Valero said a meeting will be held Feb. 21 in Madrid to discuss additional financing to rebuild areas hit by the disaster. At the meeting, the Venezuelan government will present a master plan to reconstruct the affected areas, he said. He said members of the European community, the United Nations and multilateral organizations will attend.

The landslides killed between 5,000 and 30,000

people and left another 100,000 homeless. In addition to the foreign aid requests, Venezuela is considering issuing debt to pay for new housing and agricultural aid, officials say.

Despite a recent surge in the price of oil, Venezuela's main export product, the economy remains in recession. It shrank 7.2 percent in 1999. **[JR: It is astounding the amount of damage caused by this flooding. With all the international input, I hope something positive will be accomplished, especially for the people.]**

DETECTOR WILL SPOT "INVISIBLE" MINES

British scientists have developed a detector that pinpoints "invisible" landmines. It uses powerful pulses of electromagnetic energy that last less than a billionth of a second to create radar pictures of buried objects.

The first versions of the device, being built at the Defence Ministry's Defence Evaluation and Research Agency (DERA) at Malvern, Worcestershire, will be used in trials to detect anti-personnel mines that contain no metallic parts and defy detection by other methods.

It is hoped to use the detector to find mines laid during wars such as those in Angola, Bosnia, Cambodia and the Falklands.

There are more than 100 million landmines, laid in more than 60 countries, mostly in the Third World, causing at least 25,000 casualties a year.

In other words, somewhere in the world a landmine explodes and kills or maims a person every 20 minutes. Clearing these objects from fields and from the outskirts of African and Asian cities has become a major political concern and has triggered considerable interest in the British project.

"At present, the only really effective way of clearing mines is to try to dig them up or detonate them with some kind of robot vehicle," said Dundee University mathematician Dr. Paul Smith, a researcher involved in the new detector's development. "It's a slow and dangerous business."

The device designed by Dr. Smith and his collaborators at DERA gets around such risks by exploiting a technique known as ultra-wideband synthetic-aperture radar.

At the heart of the machine, a specially designed generator is used to emit powerful but very brief bursts of electrical energy, every thousandth of a second. These pulses consist of energy that covers a very wide part of the electromagnetic spectrum, and this is bounced back from objects in ways that differ according to their wavelength.

The device's detector then builds up a series of images created by these different reflected pulses and combines them to create a picture of nearby objects.

"Essentially, we can create images of any object that has been buried or hidden and from its shape tell whether it is manmade or not and, therefore, whether it is potentially lethal or harmless," says Smith.

"We have already completed successful preliminary tests and hope to complete full trials in

the near future. Hopefully, we can then begin landmine clearing in earnest after that.”

COPS CAN NOTIFY WHOLE NEIGHBORHOOD

SCARBOROUGH, Maine (AP)—Although sometimes referred to as “Reverse 911”, the notification system has nothing to do with the 911 system that people in the United States rely on for emergencies. Scarborough is the only community in Maine that provides this service but the technology is catching on across the country. Scores of agencies have put similar systems to use over the past five years, and police are using the tool in novel ways....

In Maine, the episode unfolded after a violent burglary attempt in Portland in which a family was terrorized by five bandits. It ended when the father was shot while being forced to lie on the floor.

The incident moved from Maine’s largest city into this bedroom community of 15,000 after a getaway car was wrecked a half-mile from Peterson’s house and three suspects fled into the woods.

That’s when Joe Giacomantonio, Community Resources Officer for the Scarborough Police Department went to work, grabbing his mouse and firing up his “Reverse 911” computer program.

Looking at a map on his computer screen, he used the mouse to outline a four-square-mile area where the suspects were loose. Then he recorded the message, and the computer did the rest.

The phone calls started going out to 400 homes at 3 a.m., even as police prepared to go door-to-door.

Two of the suspects were found hiding in a hunting trailer but a third remained on the lam at daybreak.

It was a couple of hours later when Peterson saw a teenager fitting the message’s description dart from the woods wearing only boxer shorts and a sweatshirt on a cold morning.

He dialed 911.

“Before I was off the phone with the dispatcher, they had him,” Peterson said.

It was a happy ending. The shooting victim survived and the suspects were arrested.

When it was over, Giacomantonio sent another message saying the suspects were in custody.

“The public loved it,” said Giacomantonio....

...“Reverse 911” is a registered trademark of Sygma Micro Corp., which installed Scarborough’s system for \$23,000. It is sophisticated enough to indicate whether a call was received or whether a message was left on an answering machine. It also can be programmed to keep trying.

It has other tricks, as well.

During a hurricane, for example, police could send an evacuation notice to coastal residents, asking recipients of the message to press “1” if they intend to comply, “2” if they need help, or “3” if they intend to ride out the storm.

Using a printout, police and firefighters would know whom to check on when going door-to-door.

There are three major companies marketing the systems. Sygma Micro Corp. and Avtex, based in Edina, Minn., have targeted law-enforcement agencies. Sygma says it has about 100 systems in the field, and Avtex says it has installed 280.

Dialogic Corp. of Franklin, Tenn., targets emergency agencies and operators of chemical and nuclear plants and has installed roughly 1,100 systems, said David Krikac, the company’s Marketing Director.

[JR: This is a positive use of the electronic surveillance systems, which affords the citizens and the community extended protection and is cost effective for police departments. NATIONAL STANDARDS READY TO REGULATE ORGANIC PRODUCTS

PACIFIC GROVE, Calif. (AP)—Consumers gobbling up organic products at an unprecedented rate should have a better idea of what they’re eating when the nation’s first organic-labeling rules roll out this year, a federal agriculture official said Thursday.

“This will not be a perfect rule, a holy grail, but it’s a place to start so that farmers and consumers and the government can have some agreement on what organic means,” said Keith Jones, who heads the U.S. Department of Agriculture’s National Organic Program.

Jones said the rules expected to take effect this summer will require organic producers to go through a mandatory planning process, to use materials from a restrictive list and to have their farming practices verified by an authority.

Enforcement, he said, will be handled by state, county and private agencies that currently oversee the industry but use a hodgepodge of rules and guidelines.

“We have empowered certifiers in this rule. But we’re also going to ask certifiers to step up to the plate and take action,” said Jones, speaking at the Ecological Farming Conference in Pacific Grove, California, the nation’s largest annual gathering of organic farmers.

Congress called for consistent national “organic” guidelines 10 years ago. But earlier proposals included irradiated and genetically-engineered food in the organic categories, drawing more than 280,000 protest letters from consumers and organic farmers.

Jones said the revised rules now match industry standards that exclude irradiated and genetically-engineered products.

Katherine DiMatteo who heads the Greenville, Massachusetts-based Organic Trade Association said that despite existing self-regulation, her industry needs the promised federal regulations.

“Without the government, we would not be able to enforce this program universally,” she said.

Sales in the industry reached \$6 billion last year and industry organizations project growth of 20 to 25 percent a year as organic products become mainstream, according to the Organic Trade Association.

[JR: When we can’t agree among ourselves and within each industry to establish reasonable standards, we are asking for the federal government to do it for us. Why is it more acceptable to have things dictated to us when we could have done it ourselves? TALMUD TACKLES ELECTRIC CHAIR

(*Religion News Service*)—As American law schools grapple with the implications of globalization and the influence of non-Anglo-American traditions on the U.S. legal system, the study of Jewish law is drawing increased interest across the country.

More than three dozen law schools now teach the subject. The American Association of Law School Professors has its own Jewish law section. And a Jewish law casebook is now available as a reference tool for budding lawyers.

But the most profound evidence may be found at the highest level of American justice. Exhibit A:

Last month, a brief was filed before the U.S. Supreme Court regarding Florida’s use of the electric chair and whether it constitutes “cruel and unusual punishment”, prohibited by the 8th Amendment.

What made this brief unique is that it does not rely on a single tenet of American law, but rather solely on the *Talmud*.

According to the two lawyers who filed the brief, Nathan Lewin and former Israel Supreme Court Justice Menahem Elon, the *Talmud* can provide an important means of evaluating the fair implementation of the death penalty.

“What we’re saying is that under Jewish law three principles apply,” Lewin told the *Jerusalem Post*. “That you should (execute) as painlessly as possible, as quickly as possible and with the least mutilation of the body as possible. Those all derive from the principles that were in the *Talmud* 2,000 years ago.”

They are consistent, as well, with the 8th Amendment.

Because the case is being brought on behalf of a Death Row inmate facing execution in Florida’s electric chair—“Old Sparky,” which has a history of malfunctioning—the Supreme Court brief filed by Lewin and Elon does not discuss whether capital punishment should be abolished, but simply how it should be administered.

“I would consider it a substantial contribution,” Lewin said, “if in either a majority or concurring opinion, the court says, ‘Look, our conclusion that this is cruel and unusual punishment is buttressed, is informed, is supported by the fact that 2,000 years ago the rabbis in the *Talmud* said it would be

impermissible to actually burn somebody at the stake, because that would be a death that would disfigure and would cause pain over an extended period of time.'

"That would engender respect in the world at large for a body of law that we study all the time and believe is divinely inspired and worth our time and attention."

[JR: This might seem benign when addressing the issue of cruel punishment, however, are we now advocating that our constitutional law is less applicable than Jewish law here in the United States? That would certainly validate *Public Law 102-14*, which installed the *Noahide Laws* as the law of the land way back in 1991.]

AS A LAME DUCK, CLINTON LIKELY TO
DUCK CONGRESS WHERE HE CAN

WASHINGTON—In just a year President Clinton will face a large crowd on a cold Washington day and, as he watches his successor sworn in on Jan. 20, 2001, he will find himself not the most powerful person [sic] in the world for the first time in eight years....

...Yet Clinton's power will severely diminish in his final year. Allies and adversaries know he will be leaving the stage soon, a situation that adds to the obstacles Clinton already confronts as an impeached President facing a Congress controlled by an opposing party.

Clinton's last year in office is likely to be defined by that tension—the struggle between an energetic President and his lame-duck status. Attention already has begun to turn to his possible successors. As the year progresses, many will find their activities and opinions of far more interest than Clinton's.

"He will have to balance his natural activism and wanting to be like Franklin Roosevelt with the political reality, and that will cause a lot of problems for him," predicted James Thurber, an American University political scientist....

...Clinton is likely to try to stay influential in 2000 in three ways—by seeking triumphs overseas, by issuing executive orders that do not require Congress' approval and by pushing for the election of Vice President Al Gore, First Lady Hillary Rodham-Clinton and Democratic House members.

And, of course, Clinton faces an additional task in his final year—rebuilding his image after his impeachment, trying to ensure that his tenure is remembered more for peace, prosperity and low crime rates than for the scandals that tarnished it.

Clinton, to be sure, is not giving up on pushing bills through Congress. Aides say he should never be underestimated, noting his record of sensing the public mood and using it to outmaneuver the opposition.

The President will push especially hard this year for two measures on which advisers believe the public is on his side—gun control and a "patients' bill of rights"....

...Clinton also is determined to tackle investment

in poor areas and repair of the nation's decrepit school buildings, and he talks repeatedly of the need to shore up Social Security and Medicare. His goal of adding a prescription-drug benefit to Medicare has gained steam in recent days.

But many believe it will be extremely difficult for Clinton to win legislative victories this election year, with neither party eager to make politically risky choices and Republicans reluctant to hand Clinton any achievements....

...But it will not be easy. And as his domestic power wanes, Clinton undoubtedly will focus more energy overseas. He would hardly be the first leader to do so.

James Steinberg, Clinton's Deputy National Security Adviser, said major foreign-policy goals for this year include forging peace in the Middle East, bringing China into the world-trade system and solidifying relations with Russia under its new president.

Clinton has made a large personal investment in Mideast peace, and it would be a glittering addition to his legacy. Under Clinton's prodding, Israel's talks with the Palestinians and with Syria are making halting progress [sic]....

...The appeal of foreign policy is that Clinton can act like a grand leader without interference from a pesky Congress. Another way to make a mark is to issue executive orders that do not require congressional approval.

Earlier this month, the President posed before the Grand Canyon to announce he was creating three new national monuments and expanding a fourth, protecting more than a million acres of wilderness in California and Arizona.

Clinton took the action under the 1906 *Antiquities Act*. Some Republicans protested that this was an abuse of that law, which they contend was intended only for small parcels.

Clinton will take many more such unilateral actions before his time is up, predicted Stephen Wayne, a presidential expert at Georgetown University.

"He will use the executive power as much as he can," Wayne said. "Obviously, he can't restructure Social Security and Medicare with executive orders, but he will probably use a maximum amount of the discretion he has."...

...Keenly aware of history, Clinton regularly cites the presidencies of Theodore Roosevelt, Franklin Roosevelt, Harry Truman and John Kennedy. As his tenure enters its twilight, he has begun speaking of lofty themes—racism, poverty, volunteerism—and many expect that will only increase as his final year winds down....

[JR: He may be a "lame-duck president" but he still has a lot to quack about through the power of his pen and executive orders. The liberals can have this president as their icon, as he is likely assured sainthood in their heaven.]

U.S. ADMITS WRONGLY DECLASSIFYING SECRETS

WASHINGTON (AP)—About 1,000 documents containing nuclear-weapons secrets were mistakenly

declassified and made available to the public under an openness campaign begun five years ago, the Energy Department has told Congress.

While the documents were opened to researchers, only one of the files was actually examined by any outsiders before the mistakes were discovered, the Department said in a report. That document involved nuclear-weapons deployment to foreign countries in the 1950s.

The documents were among millions of pages of papers declassified between 1995 and 1998 under an executive order [EO] from President Clinton directing federal agencies to lift the veil of secrecy from papers that contain historical material and are more than 25 years old.

The declassification effort, which is expected to continue for a few more years, involves papers on everything from the 1950s and 1960s nuclear bomb tests to the war in Vietnam, UFO research and the failed Bay of Pigs invasion of Cuba....

...During the review, auditors found that 14,890 pages containing secret weapons information had been mistakenly declassified and made available for public view at the National Archives, according to an unclassified summary of the report sent to the armed services committees of the House and Senate.

The material covers "about 1,000 documents", many of which originated in the old Atomic Energy Commission but had been transferred to other agencies and declassified there, an Energy Department official said....

...Included among the 14,890 pages was information on nuclear bomb tests in the 1950s and 1960s "that provided insight...in weapons-design technology" as well as yields on specific weapons and their deployment and storage, according to the unclassified summary.

In a letter accompanying the report, Energy Secretary Bill Richardson cited "the gravity of these inadvertent releases" and said he was increasing the number of auditors and expanding training programs for those conducting declassification at the other agencies.

While the documents contained information that was in some cases 30 to 40 years old, the report said it still could be useful to someone seeking to build a crude nuclear device.

Such information, because it is technically less sophisticated, "can provide useful design parameters to emerging (nuclear) proliferant nations and to terrorist groups," said the DOE report.

The documents were erroneously declassified for a variety of reasons, the Energy Department official said. In some cases, reviewers were inadequately trained and did not recognize the material, and in other cases documents dating back decades were misfiled or incorrectly labeled, said the official....

[JR: When you have so many secrets and a government too big to function efficiently, you have snafus in the "oops" department. If I remember correctly, technical information on making "the" bomb has been available since the 1960s in major libraries. It's access to the nuclear ingredients that controls whether a nation or terrorist has the capability.]

HELMS OFFERS UN COUNCIL
"HAND OF FRIENDSHIP"

NEW YORK (NYTNS)—Sen. Jesse Helms (R-N.C.) came to the United Nations Security Council Thursday offering a “hand of friendship” but delivered the sort of clenched-fist message that has made him the symbol of right-wing hostility to the United Nations.

Helms, the most powerful conservative voice in foreign policy as Chairman of the Senate Foreign Relations Committee, argued that Congress had the right to dictate conditions for the payment of American debts to the organization. He warned the United Nations to keep its “utopian” visions away from American sovereignty.

“If the United Nations respects the sovereign rights of the American people and serves them as an effective tool of diplomacy, it will earn and deserve their respect and support,” he said in a speech to Council members. “But a United Nations that seeks to impose its presumed authority on the American people without their consent begs for confrontation and, I want to be candid, eventual U.S. withdrawal.”

Helms tried to put a positive face on his visit, arranged by Irwin Belk, a North Carolina businessman and a friend of the Senator who was appointed an alternate delegate to the General Assembly last fall, and by Richard Holbrooke, the American permanent representative to the United Nations and this month’s Security Council President.

Holbrooke has spent months trying to build bridges with a hostile Congress, led by Helms, that has held up payments of UN dues and delayed the confirmation of ambassadors and other foreign policy officials—notably including Holbrooke himself.

“It is important,” Helms said, “that this body have greater contact with the elected representatives of the American people and that we have greater contact with you.” He invited Security Council members to visit his committee in Washington....

...In his speech, Helms, asserting that he was speaking for the American people, delivered a clear-cut conservative manifesto on the United Nations and didn’t leave anything open for compromise.

At the end of his address to an extraordinary gathering of ambassadors, nearly every member of the Security Council challenged Helms’ bleak portrayal of the United Nations and criticized the United States for letting the organization down.

Ambassador Alain Dejammet of France, visibly agitated, said to Helms: “We hear you, but the idea in this house is that others must be heard as well.”...

...Helms told the Security Council that unlike the Europeans, the American people were moving away from “supra-national institutions” and want no part of “utopian” international arrangements, including the international criminal court created last year over U.S. objections.

Thursday’s session was a gamble for Holbrooke, diplomats said. But it seems to have paid off both for Helms, who was welcomed with fanfare and was given an unusual stage to air his views, and for his adversaries. Diplomats from around the world got the chance to tell Helms directly what they thought.

[JR: Yes, everyone in the UN heard what Helms said but few governments agreed with his views, including our closest allies. Their contention is that we have no

right to attach conditions for paying our designated 25% share of UN expenses. Most Americans question if the UN is worth keeping and if it is in our best interest. If the U.S. pulled out of the UN, the UN would not survive.]

PUTIN’S POPULARITY TESTED

MOSCOW—A boycott by reform-minded Russian lawmakers is creating the first political crisis for acting President Vladimir Putin and could prove costly as Putin seeks to build on his popularity with less than 10 weeks to go before presidential elections.

The boycott is led by some of Russia’s best-known liberals, who expressed outrage over a deal between Communist deputies and those loyal to Putin. Because the dissenters make up only a one-third minority of the lower house, the Duma can still pass legislation.

Nonetheless, the boycott is a blow to Putin. It tears at his image as a guarantor of political stability. It opens the door to political opposition to Putin, something that until now has been nearly non-existent.

“It is not so exotic as before to be in opposition to the all-popular Vladimir Putin,” wrote the Moscow newspaper *Vremya MN*.

With the presidential vote approaching, Putin’s high approval ratings and his command of the Kremlin give him a sheen of invincibility. He has not yet, however, come under any kind of sustained political attack.

The Duma dispute threatens the immunity to criticism Putin has so far enjoyed. Some Russians fear that Putin is more inclined to authoritarianism than democracy.

The reformers could argue that Putin is trying to turn the Duma into a rubber-stamp body by pushing aside its independent voices.

Critics of the 3 ½-month war in Chechnya are also becoming bolder. The war has become closely identified with Putin and he owes much of his popularity to it.

Putin remains under pressure from the West to find a political settlement for the conflict. But domestic criticism of the bloodshed in Chechnya has been muted, even as the war is turning more grisly and unpredictable.

Though a leading Russian general said Wednesday that the military operation would be over by Feb. 26, reports from Chechnya suggest otherwise.

“It will be possible to seize Grozny only when the rebels leave it themselves and decide to surrender it to troops,” said Malik Saidulayev, a Chechen businessman loyal to Moscow on the Army’s prospects of capturing the rebellious republic’s capital. “There is still a long way to go in the capture of Grozny. In reality, the situation there is far from the one painted by military reports.”

The Duma dispute is about who will run the show in parliament. Liberals such as Sergei Kiriyenko and the centrists allied with former Prime Minister Yevgeny Primakov complain that the Unity faction and the Communists, who remain the single largest party in the Duma, bullied them out of their share of leadership posts.

Primakov, who heads the Fatherland-All Russia faction, called the divvying up of Duma plums a “profanity”.

“We are being dictated to,” he said.

The Yabloko faction of Grigory Yavlinsky and the Union of Right Forces, led by former Kremlin stalwarts Kiriyenko and Boris Nemtsov, joined the

boycott. A group of independent deputies also objected to the Unity-Communist plan.

The deeper question is whether Putin wants a partnership with the Communists....

...The Kremlin threw its considerable weight behind Communist Gennady Seleznyov to be re-elected as Duma speaker.

Putin has praised Seleznyov as a pragmatist, a sharp departure from the scorn that Putin’s predecessor in the Kremlin, Boris Yeltsin, heaped on all Communists.

“What I saw today was beyond my imagination,” Nemtsov said. “The Communists strike a deal with the Kremlin...It is impossible to imagine a conspiracy between Yeltsin and the Communists even in the worst of nightmares.”

[JR: It would seem that Putin has been ill-advised or has become over-confident in his new position of power. The opposition is becoming bolder and Putin walks a fine line until the March elections. At least the endless rhetoric and spin won’t last forever, as it does in the U.S.]

PRESIDENT CLINTON IS A BACK-DOOR MAN

WASHINGTON—Visions of stealthy black helicopters landing on your lawn and disgorging Nomex-clad troops to steal your PGP keys aren’t just for conspiracy theorists.

The Clinton Administration wants to be able to send federal agents armed with search warrants into homes to copy encryption keys and implant secret back doors onto computers.

“When criminals like drug dealers and terrorists use encryption to conceal their communications, law enforcement must be able to respond in a manner that will not thwart an investigation or tip off a suspect,” Attorney General Janet Reno and Deputy Defense Secretary John Hamre wrote in a seven-page letter to Congress.

The idea first surfaced in mid-1999, when the Justice Department proposed legislation that allowed them to obtain surreptitious warrants and “postpone” notifying the person whose property they entered for 30 days.

The Justice Department’s thinking was that if a suspect was using data-scrambling encryption products, the FBI’s G-men might need to enter the suspect’s home and install software to tap into and decipher scrambled communications.

After vocal objections from civil liberties groups, the Administration backed away from the controversial plan. The final draft of the *Cyberspace Electronic Security Act (CESA)* submitted to Congress had removed the secret-search portions. But the White House now appears to think it doesn’t need new legislation to enter a suspect’s computer.

[JR: I believe that the Echelon satellite system and “hired hackers” would eliminate the real need for these home visits by federal agents. Our controllers already have the technology and access-capability through the manufacturers of hardware and software. What they need is permission to be able to use their present illegal stealth procedures (for obtaining information) legally in open court. This is also an excuse to create another government agency.]

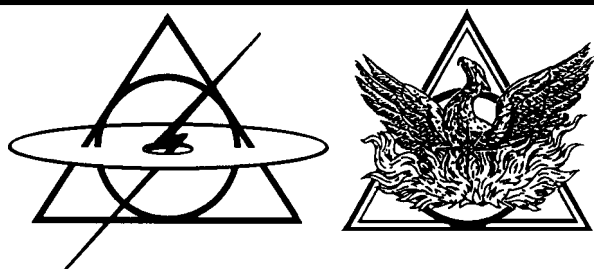
