#### **GLOBAL BALKANIZATION PLAN**

In referring to this information, I ask you to consider both the Philippines and Kosovo, and you might wish to title this: Global Balkanization Plan.

It will also bring up "Bosnia", at which point you who are United States Citizens will RECOGNIZE that Bosnia was and is the current reference for the continuation of the War Powers Act and the National Emergency which is annually extended to give the President authority to rule through Executive Order and maintain Martial Law. Bosnia continues to be used as the reason and it is simply annually extended as such, so that there is no distraction or note by Congress. There will be a small annual note published but no focus or debate will take place only in that it is "renewed" or "extended".

Manong Max Soliven's brilliant article on the hostage drama and the ongoing conflict between the AFP and the MILF (STAR, 01 May) clearly shows that controversial Harvard Prof. Samuel P. Huntington's "clash of civilizations" scenario is now in progress here. In a word, the globalists' plan to "Balkanize" the Philippines, just like its Indonesian neighbor, has begun.

The former "mujahideens" turned "terrorists" and their fanatical Islamic "fundamentalist" brothers used to be a part of the 4,000 Muslims from over two dozen Islamic countries who saw action in BOSNIA.

In 1997, the U.S. State Department released [a list of 30 Foreign Terrorist Organizations (FTOs) banned from operating on U.S. soil, in compliance with the Anti-Terrorist Act of 1998. Of the 30 groups

These are: the Islamic Group (Egypt), Al-Jihad (Egypt), Hamas (Israel, Palestine Authority), Armed Islamic Group (Algeria, France), Kurdish Workers party (Turkey) and the Liberation Tigers of Tamil Eelam (Sri Lanka).

In addition to the six FTOs whose headquarters are located in Britain, an additional 16 groups on the State Department's 1997 list either receive funding from groups based in Britain, or receive military training and logistical support from groups operating freely from British soil. Those groups are: the Abu Nidal Organization (Palestinian Authority), Harkat ul-Ansar (India), Mujahideen e Khalq (Iran), Kach (Israel, Palestinian Authority), Kahane Chai (Israel, Palestinian Authority), Abu Sayyaf (Philippines), Hezbollah (Israel, Lebanon), Khmer Rouge (Cambodia), ELN (Colombia), Shining Path (Peru), MRTA (Peru), Democratic Front for the Liberation of Palestine (Israel, Palestinian Authority) and PFLP-General Command (Israel, Palestinian Authority).

These paid hacks masquerading as "mujahideens" and "fundamentalist freedom fighters" are dragging the faithful followers of Islam into a bloody conflict which may yet turn global.

The situation we are all about to be in—unless most of us wake up—is not new. As Prof. Huntington correctly surmised, "Conflict along the fault line between Western and Islamic civilizations has been going on for 1300 years. The lines drawn in the eastern boundary of Western "Christianity" during the Middle Ages are again being re-drawn by the descendants of those who initiated it in the year 1500. "This line runs along what are now the boundaries between Finland and Russia and between the Baltic states and Russia, (and) cuts through Belarus and Ukraine, separating the more "Catholic" western Ukraine from Orthodox eastern Ukraine. In short, the peoples to the north and west of this line are protestant or Catholic, while the peoples to the east and south of this line are Orthodox and Muslim.

When a few people at our Internationals Press Seaport Hotel and World Trade Center inquired about the Philippines, it was about the "hostage" situation regarding the 21 people (including 10 foreign tourists from their countries) who were kidnapped by Moro bandits of the Abu Sayyaf from the luxury resort of Semporna (Sipadan island) in Malaysia.

[H: Oops, Mr. Soliven, this is not quite fair. Most of the hostages taken are Malaysian and you leave the international impression by your use of "in Malaysia" that this somehow must be near, somehow, Kuala Lumpur or something. No, this is a very upscale "diving" resort but is far closer to the Philippines than to big old Malaysia. The place in point is SABAH, remember? And Sabah is "old Borneo''—remember those old tales of the "Wildmen of Borneo"? Well these are not "wild" men, Max, DONE LATELY THAT YOU WOULD LIKE TO THESE ARE TRAINED BY THE CIA AND HIDE OR KEEP HIDDEN? However, who can blame the Malaysians? from Basilan. Therefore, the almost half a million Moros (and some Christians) living and working many illegally—in Malaysian Borneo (Sabah) are the first to fall under suspicion.

> The Abu Sayyaf, on the other hand, aren't concerned about what happens in retaliation to their Muslim brethren. They're after lurid headlines and "ransom" money. Banditry is alive and well in our southern archipelago under the guise of a religious jihad and the goal of carving an Islamic state out of our rich island of Mindanao.

[H: I am curious as to just how anyone,

between a camouflage-uniformed Filipino Christian and a camouflage-uniformed Muslim? And, moreover, how do you tell a Filipino Moro from a Filipino Moro?]

Our armed forces have to press their offensive into the Basilan heartland of the Islamic insurgency, even if thus far they've not come upon any hideout where the hostages abducted from Semporna last Sunday are being held. Keep the pressure on, keep the bandits on the run—eventually they'll be flushed out of one of their island lairs.

#### [H: Easy for you, Mr. Soliven, in Boston, Massachusetts, U.S.A.?]

The NEW YORK TIMES yesterday (Sunday) ran as its banner headline on the front page a timely story: "South Asia Called Major Terror Hub in a Survey by U.S." [H: Oh, my goodness, the New York Times, yet!]

The report said that Americans today face greater threats from "loose networks" of groups and individuals "motivated more by religion or ideology than by politics, and financed increasingly by drug trafficking, crime and illegal trade". same seven countries that Washington, D.C. has been accusing of harboring and aiding terrorist since 1993: Cuba, Iran, Iraq, Libya, North Korea, Sudan and Syria. "But," the article goes on to say, "Afghanistan also poses 'a major terrorist threat' by, among other things, continuing to shelter the Saudi exile Osmena bin Laden, who is wanted in the 1998 bombings of two American embassies in Africa (Kenya and Tanzania), as well as other Afghan-trained Islamic militants sought by the (U.S.) Administration." mobilization generates no-holds-barred struggles for power, which can overwhelm still weak and immature states.

Then there is the equally-complex problem of reconciling the egalitarian democratic ideology with cultures where authority still rests on the personal power exercised by dominant personalities.

Taiwan, South Korea and Thailand have shed generations of military rule. Indonesia has held its first free election in 44 years. Even in China, the "softening" of totalitarianism seems well along, although a greater diversity of political interests and opinion seems unavoidable in China's future—and its rulers realize it. That is why they are suppressing individual dissidence so firmly.

In 1992, the World Bank had projected that, by 2020, six Asian economies would be among the 10 largest in the world. Just now, this expectation seems hopelessly optimistic. Yet, Asia's fundamentals remain sound. And I for one believe it can become a model of economic vigor again.

In societies made up of "big people" and "small people", the common folk have extravagant expectations of government. Thus, a 1993 survey found 85% of Filipino respondents saying it is government's obligation to provide jobs for all and 84% saying it is government's task to provide decent incomes for all. [H: And WHO was president of the Philippines at that time?]

Populist politicians who outdo each other in the lavishness of their political promises can easily turn such a representative system into what Peter Drucker calls "the pork-barrel state". [H: AGAIN, NOW: WHO WAS PRESIDENT AT THAT TIME?]

Democracy, it seems, develops best where it develops civic landscape instigated by economic change.

In the West, electorates were enfranchised gradually their participation hedged by gender, wealth and literacy qualifications. It took Britain almost 150 years to develop a middle-class parliament. By contrast, the advent of democracy in the Third World has been a telescoped revolution.

#### MAKING DEMOCRACY WORK

Making democracy work, especially for ordinary, poor people, I see as Asia's biggest challenge over the next 20 years. Fortunately, democracy has become part of the spirit of the new millennium. Even authoritarian regimes must pretend they are acting on behalf of their captive peoples. And, even more fortunately, there are outside forces to shore up Asian democracy where it falters.

Foremost among these is the market system, which has changed East Asia dramatically over this last generation. Among us, open markets have not merely brought faster and more sustained growth. Markets have also been a liberative force. Just as, in Western Europe, early Capitalism subverted Feudalism, so has the commercial way of the life eroded authoritarian regimes in East Asia.

In the era of globalization, even foreign investments can become a democratizing influence. Consider how Beijing is being compelled to establish the rule of law—as the basis of foreigners to do business in China and to assure the sanctity of contracts—as part of its efforts to attract outside investments, trade and technology.

the emerging knowledge society—makes more difficult the state's control of people's political views. Indeed, information technology—whose key resource is intellectual capital—requires for its evolution a drastic expansion of the ASEAN Regional forum and APEC, will be bolstered

individual freedom in any given country.

Even now, across differences in history and culture, the financial crisis is compelling East Asian states to establish their authority less and less on coercion and cronyism—and more and more on transparency, accountability and consensus, and for a simple reason: As the example of the former Soviet Union instructs us, a government whose political authority is founded on coercion cannot run an economy that is expected to work at world standards.

Another weighty influence on the side of open markets and democratic systems is the United States. As the main market of the East Asian economies, its entrepreneurial economy is Asia-Pacific's engine of growth. American military presence underpins Asian stability, and its "soft power" helps to share our popular cultures.

#### ACCOMMODATING THE AMBITIONS OF THE RISING POWERS

To give Asian democracy the time it needs to mature, our statesmen must—in concert—create the spacious environment that stimulates economic development and the rise of civil society. We must never forget that peace and development must coexist as the two sides of the same coin, if both are to endure.

In most of our countries, we have already built "the bared bones of democracy". We can change our rulers without too much violence. And procedural or transitional democracy of this kind can lead to a truly peopleempowered democracy.

My own bottom-line requirements for a transitional democracy are three: free elections, free media and free markets—and a good measure of social justice for the poorer segments of the community. [H: If this doesn't give you shivers, you are already too dead to notice the

Free elections guarantee there is open competition for political power. And every successful election helps consolidate democracy.

Free media helps to ensure that people are able to make their choices wisely.

And free markets—by nurturing civil society stimulate popular demands for the rule of law and the protection of human rights.

And these concepts should be accompanied by consultation, consensus, fairness, transparency, efficiency and accountability in governance: a level playing field for enterprises. And, on the part of citizens, civic consciousness and civic responsibility.

If we work together to promote these basic concepts and values in our respective national societies and in our relations as nations and as economic groupings, then our countries could harvest a better future, with benefits and opportunities for the great majority of humankind.

MANILA, PHILIPPINES—In a stunning move that shocked the nation, outgoing Philippine President Fidel Ramos fired Solicitor General Romeo de la Cruz just two weeks before the inauguration of populist President-elect Jose Erap Estrada.

The unprecedented move was in retaliation to the 34page report which de la Cruz had filed with the Philippine Supreme Court stating that there was no evidence to back up the conviction and 12-year jail sentence of former first lady Imelda Romualdez Marcos. De la Cruz urged the top Court to reverse the conviction which everyone in the Philippines knows was made by a politicized Court under the influence of Ramos and his revolutionary predecessor, Corazon C. Aquino.

What so infuriated Ramos was that he had appointed de la Cruz as Solicitor General and saw the report as "high

Ramos is himself a master traitor who has in his lifetime betrayed his cousin and benefactor, Ferdinand Marcos, in 1986 in his capacity as a CIA asset and informer. He has betrayed the legal Government he was sworn to uphold and betrayed the Philippine people by helping to steal the 1986 election.

He has betrayed his wife by supporting a mistress in lavish style at taxpayers' expense.

Ramos apparently never imagined that de la Cruz would do his job honestly.

Under the unconstitutional and unlawful Aquino and Ramos regimes of the last 12 years, the unforeseen appearance of an honest and courageous justice official must have been traumatic, indeed.

As soon as de la Cruz's Supreme Court report became known by the cabal that has been running the Philippines since it overthrew the Marcos Government in 1986, Ramos got his marching orders by cabal spokesman Stephen Bosworth, the U.S. State Department functionary who organized the kidnapping of the Marcos family into forced exile and detainment that year.

#### REGARDING THIS SERIES OF WRITINGS

These writings are going to be information taken from a file which was brought to Manila, the Philippines for use as reference for dates, etc. related to Global Alliance Investment Association (GAIA) and information in our files which has been published but most of which is not in our "package" of support materials. This is not to find the information unimportant but to render it in some quantity allowing better use of same.

We do get such a myriad of questions regarding so many things-mostly just from curiosity-that GCH requests that we get what we can onto "our" disk, so that at least what we do have can be utilized.

Please remember, you who know the story, that Rick Martin was a vital part of the loop with V.K. Durham as well as with Russell Herman while he was still alive.

In the pressures of trying to type V.K.'s material with which she flooded us, as in a total bombardment, I, Doris, finally had to turn it over to someone else to handle. It was so difficult to sort and type, correct spelling and get ready for publishing that nobody, after a while, would touch it. So, SOMEWHERE—BACK THERE in U.S.-Land—are files and files of V.K.'s "sharings".

Much was kept at Ekkers' but all of that has now been dumped or removed, moved or outright stolen when the grab for CONTACT was made by the now "Spectrum" group. We have no idea what is left and, at best, Rick has

Since our disconnection from V.K. Durham, we have no information regarding her location or present state of health or contact information. The clarification of these statements will be shown as we print or reprint correspondence, lines of events as offered by V.K. herself as well as from Russell Herman. V.K. KNEW about the connections of Ekkers-Martin-CONTACT at the time of the contacts while Russell was still alive but it appears she chose to rewrite the script after Russell's death. Did she know about Russell's transfer to us? I, Doris, don't know the answer to that, and it appears that she may well have not known because Russell built in a period of time to allow her to get the job accomplished—with our help.

She was so angry when we finally had to publish the transfer that she screamed fraud, forgery, etc., even of Russell's signature. I apologize right here, up front for lack of dates and writers on much of the material, for Rick had extracted relevant material and just stuck it in a file and much of it will not have information regarding dates, etc. I will comment if I can remember "about when", etc. but that is the best I can do. I believe, however, that you can piece together the approximate time and every so often [H] has commented.

It appears to me to be best to start with a bit of a chronology and personal things from V.K. and/or Russell Herman and where possible, flesh out the information with actual public notice copies of relevant material.

It should be noted that this will be "copy", so to question me about these things is not appropriate since, in some instances, such as the "Timeline" now first offered, I had no input but will have a comment or two as we get to late July and the first few days of August 1993. You will please note that Russell was failing but was actually still very bright and functional. He also had the use of his hands, in contradiction to V.K.'s claim that he "could not have signed anything because he had a broken arm". At the time of the transfer, there was NOTHING wrong with you did print our response. Thank you. Russell's arm or hand, although he was very weak.

V.K. has had "enough already" and I can't imagine that V.K. could remember everything while in the horrendous and terrifying middle of her "husband" being killed. Yes, indeed, this would be a story for a series of motion pictures to surpass anything Bond has done to date.

Anyone who can't believe our wondrous Government in the Land of the Free, and the CIA, would do this to "one of their own", I suggest you go to the movie rental store and get a film on a man named Barry Seal and just watch. [D: Some of the names throughout the entire series will be "phonetically" spelled because often times we would not have the correct spelling. For example: In Rick's first few paragraphs there is a Dare SHAUT, and a Dare SCHAUT. I dare shout that I don't know which is correct. BUT, I DO WELL REMEMBER DARE SHAUT/SCHAUT. FURTHERMORE: ANDY NICHOLAW WILL KEEP POPPING UP IN ALL THE WRONG AND MYSTERIOUS PLACES THROUGHOUT THE **ENTIRE TIME PERIOD.**]

- 1. Hatonn writes about Dare Shaut and COSMOS on Dec. 10, 1992 in Vol. 21, #9 of THE PHOENIX LIBERATOR.
- 2. In a writing dated Dec. 16, 1992, Hatonn states, Re: COSMOS: "I am not going to discuss details about this ongoing situation. I cannot jeopardize my people or the project by loose speaking. Suffice it to say that things ARE happening and if you pay attention you will see what many of them ARE!"
- 3. THE PHOENIX LIBERATOR, Vol. 21, #12, page 28, Nord Davis writes an article regarding the Nov. 27, 1992, Dare Schaut/(Dr.) Andy Nicholaw "conference" call concerning Cosmos Seafood Energy Marketing, Ltd. The address for COSMOS was given over the air as being RR1, Box 171, Okawville, IL 62271 (V.K. Durham's address).
- 4. In a letter TO HATONN dated Jan. 20, 1993 FROM Charles Dare Schaut. Schaut cries libel at the information written about COSMOS (appearing in Vol. 22, #1 of THE PHOENIX LIBERATOR). In another letter written by V.K. Durham and signed BY RUSSELL HERMAN, CEO/CB and V.K. Durham, CO/CEO/CB for Cosmos Seafood Energy Marketing, Ltd., she ends the letter with the following statement: "By the way, it surely must be real or George Bush would have not tried to obtain \$2B410M for Iran in 1989. Of course, we, Cosmos Seafood Energy Marketing, Ltd. refused him collateral"
- 5. On page 16 of Vol. 22, #3 of THE PHOENIX LIBERATOR, is a letter dated Jan. 29, 1993 addressed to Mister Rick Martin (please print).

[Quoting:]

We are in receipt of your Jan. 26, 1993 edition wherein

We would like to apologize to our lateness in response as, on Christmas Day, we were in an auto accident which left us in a state of disarray. These things happen, however we do apologize for our lateness in responding.

[Still quoting, later on:]

To keep you on an update, we (Cosmos Seafood Energy Marketing, Ltd.) forwarded on to President Bill Clinton on the 19th day of January 1993 our offer to assist in the restoration of the Republic; this consisted of 18 pages which originally was intended to THE PHOENIX LIBERATOR to publish so all of you could read what we had to say. We are holding it up for 30 days to allow our new president, Bill Clinton, time to peruse our letter. If there is no response in 30 days, we shall send this on for publication so you will be informed.

[End of quoting]

It was initialed by V.K. and Russell.

[D: We later DID publish the offer.]

[D: The next is referring to "things", valuable artifacts, held by Russell and V.K. Knecht was trying to sell them for V.K. We have no idea of the final disposition of the things. However, we did have MANY conversations with Robert Knecht. He is a well-recognized expert in art. gold, etc. We have seen reference to "Dr. Knecht" even in Southeast Asia in an international publication. He told us, personally, that he was helping V.K. and that he was acting as executor for that reason and, of course, the valuable holdings. He further said that he had "many" Peruvian certificates but the BONUS 3392-181 was in a "class of its own". He said, however, that if we sent the information from the "Russell Will", that he would see that the \$40 million bequest would be made to CONTACT. The full information was sent but in the meanwhile he had some major dispute with V.K. Durham, after which he said, "She has now really botched it; she has filed murder charges against Bush and his associates (named) and nothing can be distributed from the 'Will' itself until that is under control..."]

In a continuous flow of correspondence and phone calls,

V.K. continued to assure us that she was within days of receiving massive sums for those items. However, when Knecht would get a buyer, V.K. would set other conditions on the sale and delays were constant. V.K. had promised that if *CONTACT* would assist her with funds, she would be paying them all back through this separate resource. [D: This never happened.]

6. In a conversation [**D**: With permission, Rick taped the conversation.] with Houston-based attorney Dr. Robert Knecht, on 9-24-97, he said:

[QUOTING:]

He brought it out of Burma. These are temple objects that have been there for thousands of years in these temples. And when Russia attacked, that blew up the temples, and the government, with General Herman and General Dwire, brought all this stuff out. And then when General Herman was murdered... the case came up to me and I opened up these vaults by winning the case and all these artifacts for V.K., and she was almost killed. She was in a coma for a year, and I surfaced with these and they've been appraised out by the government people in the case at 316 million—about that....

... and I discounted it. I said, for a quick, say, 250 million for all of them. Get it out of here. And I wanted to close that case, and everybody comes in here and wants this to be a museum and that's not how you close a case.

Question: What is the nature of the objects?

The Ming-Hu robe of 1500 AD, that's of the Ming-Hu family. Ming being a dynasty, and there's two, there were three of them. And we have one and two of them are in the museum in Beijing.

And they're going at 50 million a piece, over there. We have one of them here, in the vault. I also have a 300-karat diamond which was taken out of the Buddha's eye. It's 54-facet, 300 karat of V6. And then there's a black diamond that was found in the temple, and also a goblet from about 1800 years old that was used for a sacrificial goblet—a blood goblet made all out of ivory. Then there's two tapestries from Belgium. How they got over there, I don't know. I opened this case; I put it out for 250 million. Everybody comes in here, and "Oh, I want this, I want that...". You can't do that in a case.

[Still quoting, later on:]

But see, Dwire and the other one, General Dwire and Schenault, were on the Burma Road.

[End of quoting]

7. THE PHOENIX LIBERATOR and CONTACT [D: After George Green tried to take the Liberator and assets to Nevada, it was found that Green had also taken about \$400,000 in gold intended for the Phoenix Institute and buried it in his back yard. It became necessary to merge the paper and the name was changed to CONTACT. We have never been able to establish the extent of Green's thefts but we do know of much, much more.] Received (documented) telephone calls from Russell Herman and V.K. Durham on, initially, the following dates: 9/21/93, 12/3/93/ 12/10/93, 12/15/93, 12/27/93, 12/30/93, 1/3/94, 1/6/94, 1/14/94, 1/15/94, 1/18/94, 1/19/94, 1/20/94, 1/21/94, 1/24/94, 1/29/94. [D: Ekkers probably received twice, at least, as many calls (almost daily and sometimes two or three daily) but we did not have any reason to document them.]

8. On May 26, 1995, *CONTACT* received the following information from V.K. Durham:

[Ouoting:]

Received your paper and the article on killer germs. Most impressive. However, curiously, this killer germ identified as Cryptosporidiosis is almost identical to the resident germ in the bathroom commode in this house Russell and I have inhabited.

[Still quoting, later on:]

I believe there is cause and reason to believe this is the origination of the illness of Russell Herman, and later he was

gassed by Serin [sic] out in the yard in front of the house.

Reasoning: Prior to the incident of the "gassing", Russell had been swelling profusely in the abdominal region, as a matter of fact, the swelling was so profuse, he would have to split the seams in his jeans to accommodate the swelling. He was exhibiting bloody stools, and kidney difficulties with extreme pain in the mid-section.

Immediately after the gassing, he perspired profusely. He was bleeding from the eyes, nose, ears, spitting up blood, nauseated and disoriented and did lose consciousness. The combination of the two made him ill enough for the first encounter with the hospital "United Nations medics", all employees/personnel in St. Mary's were wearing dark blue slacks/shirts, white blouses, black ties with epaulettes on the shoulders in the wing in which Russell was taken.

Russell, while missing from 9:30 a.m. on October 28<sup>th</sup>, 1993 until 21:27:52 hours that date, was strung up like a piece of beef with a pair of hooks under the shoulder blades with a cross bar across the shoulders in the back, he was burned with cigarettes, and beaten to the point of his left rib cage being broken, as was the left arm from the shoulder to the elbow.

Evidenced on Russell's rectum were marks where a prod had been placed up his rectum, with entry areas around the anal area as though wires had been inserted in addition to the initial prod.

After leaving St. Mary's, Russell expelled what looked like tobacco in his feces. From appearances, pure tobacco had been shoved up his ass, up and through the intestines to reach the liver area which would cause abnormal liver functioning (the evidence exists).

Still, this did not kill on the desired time level, nor did he cooperate with them, they never did get what they wanted, and that was his signature to sign off on the certificate/contract. Russ could not have signed off had he wanted to, he did not have that capacity.

[D: More than V.K. knew, he couldn't sign off on the documents, for he had already transferred them "even" out of V.K.'s ability to do anything with them. I probably would have died of terror had I actually realized the extent of this incredible intrigue. We didn't actually have enough recognition to try to run or hide. We did have several attempts on our very lives, cars in chases, etc., and we just marked it up to nuts from the U. of Science and Philosophy that was suing us because of George Green. Agents were CAUGHT tapping phones (total idiots) and were also caught with listening devices to the windows at the "office", spying on Rick, et al. The "Powers" knew Russell had transferred the "CONTRACT" but they ran smack into Commander Gyeorgos Ceres Hatonn, and had to back off.]

Being unable to walk to and fro to the bathroom facilities here at home, it became necessary to use a urine bottle. After a while the same killer germ, Cryptosporidiosis, began to cultivate in the urine bottles. (The evidence exists.)

All the cancer tests were negative. Accuracy rate 75-80%. Still radiation and chemotherapy was given, the burns are evidenced on his hips. Now we have excessive invasive radiation.

Well, that did not kill him. Hospice decided with the doctors that I was to give him 10 mgs of morphine every four hours with a 2 hour break-through, and I was supposed to rub it into his gums even if he was asleep (then I would have been guilty of murder).

Russ and I wised up to the morphine in a hurry. He cold turkeyed all the way. Much to their consternation, that little guy still was alive. He still had not died.

I truly feel as though I let him down, and I was too exhausted to care for him and I put him back into the hospital where he could be given proper care, while I got some well needed rest. I had told the hospital and doctors on Sunday, "I

am going to take him home on Tuesday, as he is doing so well." On that Monday, he was murdered. His vital body fluids were extracted while he was still alive, the redness is from morphine and the accompanying fear.

[End of quoting]

9. On Jan. 4, 1995, Grandma wrote to *CONTACT*. [Quoting:]

Please be assured; in the event I can get that portion of my own processed [**D: referencing the Herman Will**], the *CONTACT* will indeed get \$40 million dollars out of my own, this will be in Federal Reserve notes, and the gold bequesting shall not be affected.

(This was addressed to Rick and to E.J.)

Russell Herman and I decided too many years ago, how very important this *CONTACT* paper is to the people, and we both, the two of us, made a free choice to assist this paper in the event we were able to do so. This is the reason the Will of Russell Herman left such a bequest.

[End of quoting]

[D: This is another very good and logical reason why Rick and Ed (Young) would actually STEAL the paper itself, CONTACT. Spectrum is not the same thing as CONTACT any way you spell it. They had to get rid of files and they had to have the name because when we validate this contract—it brings the Will of Russell Herman to bear, and \$40 million will have to be paid. So, you might see that stealing the paper and the bank accounts were no "little" thefts. Ed had already been dismissed from ANY connection with the paper and yet they went forward and published three additional editions, which damaged beyond recovery the paper itself. Then they started Spectrum using mailing lists and stolen material. Rick (and Charles Neil) were neither longer "anything" to Global Alliance Investment Association, having threatened Ekkers, used extortion, announced themselves "enemies" and resigned quite legally and lawfully from all association with said GAIA. They did, however, apparently think that \$40 million might tide them over for a while, if all else failed.]

10. On Sept. 12, 1994, Grandma wrote to Rick & Readers the following:

[Quoting, Portions:]

Frankly, when we picked up Grandpa's frozen body, it was unlike anything I had ever seen. First, all of us have seen the death camps of Auschwitz and Dacha [sic], and know of the emaciation of the bodies which were nothing but skin stretched over bones. This was the way Grandpa was. But something different here—Grandpa's frozen body had a skin color just as good as my own—his "buns" were red as fire, there were "scratch marks" on his face which were not there when I last saw him, and the blood was still blood red. Then, there were the 'scalpel' marks, just tiny incisions between the shoulder blades, and down mid lower back, ever so slight, but as though something had been inserted, after a tiny piece of skin had been pulled back, then the skin put back in place, this area was yellowish in color where the invasions occurred—no "voiding" in his Pampers.

Those "scratches on his face, on the left side" bother me... it's as though Russ had been put into the freezer still alive and had scratched his face in desperation for air. I just do not know. But I do know something very strange went on here. A forensic autopsy would evidence his skin under his fingernails if this bore up as fact.

[Still quoting, later on:]

They tried to tell me the marks on Papa's back was skin tissue breakdown/bedsores. Bullshit! I rubbed his back the day before with talcum powder and it was as clear as it could be, no marks!

11. In a legal notice/letter dated Dec. 14, 1993, addressed to Medicare & Mutual of Omaha, Mrs. Russell Herman writes.

[Quoting:]

On the date of October 28, 1993, Mr. Russell Herman was taken across the state line, from Illinois to Missouri, without his permission, or the wife's permission; and

Unauthorized invasive treatments were performed on the subject's person/body without authorization from either himself an/or the wife; and

being admitted into the St. Mary's Hospital Care Facility, and Mr. Herman, upon entering said hospital, without authorization either from him or his wife; was suffering from the following (see unsigned registration/admission sheet of 10/28/93.)

- A) Gastrointestinal bleeding;
- B) Intestinal obstruction;
- C) Suspected "D" (diverticulitis), and
- D) Abnormal liver function.

There was no mention of "any" life threatening illness.

[End of quoting]

- 12. In a document dated Feb. 4, 1994, titled Declaration at Common Law, Notice to Beneficiaries; Addendum to Establishment of Beneficiaries Russell Edward Herrman/Herman and/or V.K. Durham, we read the following: [Quoting:]
- E) A very small gutsy newspaper exists in Phoenix, Arizona, a bequest is herein identified as \$40MM (million gold dollars, gold coin, gold bullion, gold) is also made to this small paper identified as the CONTACT, INC. NEWS for "its" projects.

[End of quoting]

[D: It is noted here that the "location" given as Arizona was an error and was immediately corrected by V.K. Durham and the correction run as a Public Notice of correction and also, we were informed, corrected in the State filings.]

13. In a letter addressed to "20-20" dated Sept. 6, 1994, Mrs. Russell Herman writes.

[Quoting:]

Russell Edward Herrman, born July 2, 1927. On the 9th day of April 1940, at the age of 13, his mother lied about his age, and egged him into the United States Coast Guard. It was getting rid of an extra mouth to feed.

Russell Edward Herrman/Herman's serial number #E630724. He started out an ordinary seaman, in the engine room of steamers, on the Great Lakes, at 13 years

On April 9, 1945, he did continue into the Coast Guard. Finally, Donny, his brother, who was on the Denver, coaxed Russell into the WW II. Russell enlisted into the Army in 1946 and out in '47. Re-enlisted in 1947, out in 1950, re-enlisted in 1950, out in 1953, reenlisted in 1953, out in 1957, then back into the U.S.

Coast Guard. From 1957, U.S. Coast Guard went well past "Discharge time of 20 years" to 1993. Fifty-three (53) years, in the service of this nation. A nation that does not even know who the man is, or was, nor can his records be determined.

As the story goes: General MacArthur had gotten wind of there being some POWs behind the enemy lines, at the INCHON RESERVOIR. Russie's unit was sent out between 80 or 180 yards of the objective, and was told to "PULL OUT, ABORT AND PULL BACK", leaving the POWs still behind enemy lines during this 'scouting venture'. Russell sustained a blow to the head, causing a need for 217 stitches, and his nose had to be re-attached; he lost the use of the right eye.

15. In a letter published in the Sept. 10, '96 CONTACT addressed to: Dear Rick and Readers, dated Sept. 10, 1994, Grandma writes.

[Quoting:]

First, I want you to know, Grandpa was buried on the 6th of September 1994.

For the Services, which were held graveside, first our wedding vows were re-affirmed and read by Pastor Johnson. Second, the poem written by Russell's dearest female friend Cecelia Xalis entitled "In Flanders Fields do Poppys Still Grow". Third, Grandpa's "Notice to All Beneficiaries" was read. And do you young ones know what happened when this was going on? Well, a gentle breeze began to blow through the trees and the corn fields... over the hills... throughout the cemetery... and all the while this butterfly fluttered over Grandpa's casket. Then, taps was played, and the echo came again... from another bugle... far over the hill... the Honor Guard fired their Salutes to Russell Edward Herrman/Herman.

[End of quoting]

16. From the same issue of CONTACT we read Grandma.

[Ouoting:]

The day we sent the letters to the President of the United States of America offering to assist the nation back in July of 1993, the two of us commented; "We have just signed our death warrants." Then, we both got our acts together to protect you young ones... our Last Will and Testaments were IN ORDER.

The CONTACT, Inc. News has a paper trail which "IF" followed will show, the dates, what occurred after those dates... but just to fill you in, it goes like this:

- \* 1992—we offered to assist the young President, William Jefferson Clinton in restoring the nation, and
- \* 1993—we offered to assist the nation, rebuild after those disastrous floods. This was in July.
- \* 1993—August we extended the offer to assist. Papa was ill from the "smoke/fog".

[D: It was in early August that the transfer of the contract was made for interim holding by Rick Martin. We paid for Rick's trip for that purpose and

hand, to be secured. He reported some "interesting" things about the circumstances but we do not have further input as to how or what actually took place. The request from Herman was to hold in security the documents until such time as it would be necessary and/or appropriate to transfer the contract further into some "Global" corporation which would by then be established. It was established as Global Alliance Investment Association so that its label would be

- \* 1993—October 13th, took the Interest into Boatmen's National Bank and in accordance with Title 17 of the Illinois Banking Laws and the proper UCCs, tried to draw down on the accrued interest due and payable on Bonus 3392-181.
- \* 1993—November 1st, we issued a letter demanding to "Seek and Identify" these POWs. The unit got within a turn back across state lines whereupon Russell Herman could be sent to Marion, Illinois Veterans Health Care Facility. It was stamped received. (Russell was never admitted to St. Marys in Clayton, Missouri, on the 28th or any following date. He was kept illegally until the 17th day of November 1993.)
  - \* 1993—November 3<sup>rd</sup>, Boatmen's National Bank in Of course, this Coast Guardsman, or this "Medics" or Belleville/St. Louis, Missouri did attempt to use another Certificate identified by the Peruvian Embassy as Certificate 1065, whose alleged owners were M.O.H. Enterprises. They denied payment, as rightfully they should have, as this 1065 was one of the Dreyfus contract, which was a contract of suspect, as they would tell the Peruvian Government "We shipped out 10 tonnes"...when, in fact, they "shipped out 30 tonnes"...and did not pay the Peruvian Government what was actually owed to them. So, the Government cancelled those Certificates and rightly so.
    - \* 1993 We filed Ex-Parte in Federal District Court on Boatmen's National Bank..."Violations of Title 17, and
    - \* 1993—The Judge called, said he was not familiar with the UCCs, and recused himself. No other judge has been assigned, nor have we been noticed of assignment of said judge. (Of course we have one year, and in all probability an Ancillary will be filed, citing murder (no statute of limitations of time).
    - \* 1993—December 10th, Illinois Department of Veterans Affairs; came to the house and after gleaning all the information stood up and said: "Well, Mrs. Herman, if you plan on getting some of these bills paid, don't look to us. And I suggest to you, after he is dead, go take bankruptcy." This was at 10:15 A.M. on the 10th.
      - \* 1993—Hospice was called in to assist.
    - \* 1993—Hospice demanded I give Russell 10 mg of Morphine every 4 hours with a 2 hour break-through, and he had to take it even if I had to rub it into his gums while he was sleeping. Hospice was told by me, "I will not be a party to murdering my husband, as I know with these amounts of dosages, he will become anorexic, dehydrate and go into pulmonary cardiac arrest." Needless to say, that was the end of Hospice.

This battle with Hospice went on from November 1993 up to about February 1994.

\* 1994—March. Russell was admitted into the Marion Veterans Hospital in Marion, Illinois. (God what a little trooper he was.)

Little did I realize, even though I had won the battle over the morphine, they had snuck another one in on me which old dumb-ass me, did not fully know about— "Lasix/Furosemide". The son of a bitches had been giving him the aforementioned in his IVs. And he had prescriptions here at home. Recently I discovered, now **Rick reported back with documents signed and in** this is straight from the manufacturer's printout: "Adverse oral and gastric irritation 3) nausea 4) vomiting 5) cramping 6) diarrhea 7) constipation 8) jaundice have your pecker in your hand because if you have (intrahepatic cholestatic jaundice) 9) pancreatitis."

Let's go backwards—The initial diagnosis was: gastrointestinal bleeding, suspected bowel obstruction, liver malfunction. This is the diagnosis of October 28, 1994, Washington County Hospital in Nashville, Illinois (Lasix/furosemide?)

Veterans Administration printout of June 1994 diagnosis: Gastrointestinal cancer. He was receiving Lasix in his IVs.

\* 1994—From March to the day Russell Herman died, we were being told Cancer of the Prostate, blip blip, bla bla.

Russell Herman's Death Certificate: Cancer of the Mets, and the death certificate is signed by an unknown doctor, not the primary doctor Dr. Hyde of the Marion Veterans Hospital. (?)

I requested an autopsy, in writing, from the Veterans Hospital. This was vehemently and adamantly denied on the fact: "We will not do an autopsy that can or could be used in ANY court of law in this country." Quote, end quote, Dr. Petith (Petoo).

Dr. Petith stated: "Mrs. Herman, you are not a medical person, and you do not know what you are talking about."

At the end of the same document we read,

[Quoting:]

Both Grandpa and I, Grandma, knew the consequences when we came out and did what we intended to do, back in 1989, we both knew we would be casualties of defense of America and defense and support of the American people whereas and whereby, they could once again wrest themselves from the same things identified in the great and inestimable Declaration of Independence, oppression, despotism and tyranny from a tyrannical government. Also, Grandpa and Grandma were willing to pay the ultimate price, with our lives if necessary. Grandpa has lost his life... in an honest and faithful attempt to restore this once great nation to its former status. Let's not let him have died in vain and allow his wishes to go unfulfilled.

[D: My own thoughts are that when V.K. realized that that mess was dumped onto our shoulders, she may have tried to protect us by denying the possibilities present in the transfer of that cursed document. I suppose the most simplistic way to define the "Grandpa's Will" is: Grandpa and Grandma and Andy knew a long time ago that there's gold in them thar vaults, weren't recalling belonging to those scutters that took it... it belonged to the American peoples as it rightly was their'n affore the funny munny and monopoly stuff was put into illegal law back in the olden days of Grandma and Grandpa, and Grandma's and Grandpa's Grandma, and Grandpa (Get it?).

Now Julian, it's like this: It ain't nice to steal, and there really is a RIGHT and a WRONG, even though our politicals don't know the difference, but it is there and it ain't right to take that which don't belong to them away from the old folks, the youngins, and the less fortunate who don't know they had something or tuther worth sumpthin... wurth stealin in the furst plase... but they stole it anyway, and that ain't sittin well.

First, I thank you from the bottom of my heart for your evidenced concern. I also am concerned, but there is a task set in motion, and at hand which must be completed and that task is restoration of this nation, in peace if possible.

I must tell you, when we first started out there were 26 of us. Now, due to "deaths" there are only 2 left. But in the true course of history, our forefathers pledged their lives, their fortunes, their plight to ensure Americans safety of a free and harmonious, liberated society.

Unfortunately, we have lost twenty-four from our "group", even Grandpa (making it 25), but we all have but one regret: We only have one life to give.

\* 21—In a letter from Grandma dated Sept. 5, 1994, [Quoting:]

We are unable to obtain a proper autopsy to determine the cause of Grandpa's death. They kept throwing blockades in the pathway. We all know who "they" are.

We had a nice conversation. He and Russell recounted and recanted "old Navy days". When we left, he was jovial, as was Russell (the week of Nov. 17, 1993).

His errors, omissions and LIES have traveled around the globe over and over again and have come back to us in Manila from so many sources as to be staggering to us who didn't think anyone noticed. CONTACT was never involved in anything but a personal bequest from Russell Herman. Bellringer passed on information which was so incorrect as to make us feel that perhaps the Internet should sue such parties who misuse the very system itself. After Russell Herman's death, CONTACT (we and immediate friends) stepped in and actually supported V.K. Durham in every way—including monthly financial support. She had done, she claimed, the "first phase", which seemed to have been limited to choosing a name and appointing some acting "trustees". Among the trustees were both Jean and John Ray.

Armed with this information, Rick was sent back to Illinois to structure whatever V.K. had in mind. So, on May 27, 1996, Rick traveled to Okawville, Illinois to meet with V.K. Durham.

It had been discussed that V.K. wanted to issue Express International, Inc. in the amount of 2.5 billion dollars. V.K. Durham suggested and agreed to such a contract but valued at 10 billion U.S. dollars and it was broken down into specific percentages per V.K.'s

At the same time V.K. offered a Pledge and Assign in the amount of 4 million U.S. dollars, with the idea in mind that a smaller P&A might be easier to fund at

The story and the "timeline" of that can be offered later in Rick's own declaration regarding other documents.

With this brief explanation, we can offer Rick's notes as compiled on 9/1/97 for convenience of quick reference to dates and contacts.

- \* Under separate cover, on July 30, 1996, a certified Public Notice was sent to the U.S. Department of the Treasury, to one Lawrence Summers. Delivery was confirmed on August 2, 1996.
- On August 29, 1996, V.K. Durham ("Grandma") sent via FAX a letter to Russell Munk, in follow-up to her telephone conversation with him, with five pages of attachments consisting of the Corollary to the Monroe Doctrine.
- \* On August 29, 1996, Russell Munk telephoned JULY 9, 1997 Rick Martin concerning the "Peruvian" contract issued to Hellenic Express International, Inc. and stated that Hellenic Express International was in a very unique SWORN UNDER PENALTY OF PERJURY, position. He also stated that the documentation concerning the "Peruvian" contract had gone far within the Department of the Treasury. He did not elaborate further on that statement.
- \* On August 30, 1996, Rick Martin responded to up historical documents from Tehachapi, with a coverletter requesting that the demand for payment to HEII be expedited.
- \* A second letter dated August 30, 1996 written by Rick Martin on behalf of CONTACT was also faxed to Russell Munk concerning and reasserting the September 25, 1994 Beneficiary Claim (Bequest) for \$40 million in gold, gold coin, American gold dollars, and/or gold bullion, per the final wishes of one, Russell Herman.
- \* On August 31, 1996, Doris and E.J. Ekker received a telephone call from an individual represented to be "very high-up in Treasury". This individual made an offer of \$250 million dollars on behalf of the Department of the Treasury in an effort "to make the entire (Peruvian) Contract 'go away'". In this same telephone conversation, it was stated that if the offer were not accepted, the contract would be "black-balled" internationally after May 28, 1997, and that anyone handling or traveling with these contract documents would be arrested by Interpol.

On August 31, 1996, V.K. Durham was consulted after this telephone call and the offer was declined by V.K. Durham and HEII.

- On September 3, 1996, Rick Martin wrote to Russell Munk on behalf of HEII to reiterate the demand for payment and to point out that Russell Herman included \$6 trillion dollars in his Last Will & Testament for the U.S. Department of the Treasury.
- \* On September 3, 1996, V.K. Durham wrote to HEII and to Russell Munk concerning the Russell Will.
- \* Following this an agreement was made between the U.S. Department of the Treasury and Hellenic Express International, Inc. One of the terms of the agreement was: HEII agreed not to call the debt AT THIS TIME. In exchange for this, Treasury agreed not to blackball the contract internationally under the condition that financing for the contract be sought in the private sector, not with the Federal Reserve banks. [D: As a domestic transaction. Offshore transactions were also suggested.]

- I, RICK MARTIN, BEING FIRST DULY DEPOSE AND SAY THE FOLLOWING, TO WHICH I HAVE DIRECT KNOWLEDGE OF THE CONTAINED HEREIN AND FACTS COMPETENT TO TESTIFY TO SAME:
- 1. On May 27, 1996, I traveled to Okawville, Russell Munk's telephone call by refaxing V.K.'s back- Illinois to meet with V.K. Durham to discuss securing ONE Pledge & Assign Contract for Hellenic Express International, Inc. in the amount of 2.5 billion dollars. V.K. Durham agreed to such a contract [but] valued at 10 billion U.S. dollars and broken down into specific percentages; 2.5 billion was pledged to Hellenic Express International, Inc. The term of the Pledge & Assign was for one year, ending on May 28, 1997.
  - total amount of 4 million U.S. dollars, with the idea in Robert Knecht. In addition to providing a Limited mind that a smaller Pledge & Assign might be easier to Power of Attorney to represent our Pledge & Assign fund in the beginning.
  - contract document, early in the morning of May 28, 1996, I typed a revised Pledge & Assign Contract on V.K.'s electronic typewriter at her home.
  - 4. There were two "witnesses" present at V.K.'s at this time and they were John Ray and Jack Jones.
  - 5. On the morning of May 28, 1996, V.K. Durham, myself, John Ray and Jack Jones drove into Nashville, Illinois in the county of Gallatin to sign the Pledge & Assign in the presence of a notary located at the Magna Bank in Nashville.
  - 6. Prior to entering the bank where the notary was present, Jack and I walked one block down the street to a photocopy place of business and had several copies of the documents reproduced, an equal number of 10Bs and 4Ms. The actual number is a matter of public record with the notary.
  - 7. I requested from V.K., in the presence of these two witnesses, that we sign all copies which had been reproduced in blue ink, and have all copies notarized. Hellenic Express International, Inc. would then have a number of "originals" with which to work, rather than working from plain photocopied documents. V.K. agreed to this concept.
  - 8. After all present signed in blue ink all of the Pledge & Assign documents, they were then each notarized. V.K. Durham asked for one blue-ink original for her files. I gave her one of the 10B and one of the 4M, very reluctantly.
  - I think the most appropriate thing to do next is consummating these Pledge & Assigns, did V.K. Durham enter into discussion (or documentation) concerning the issue of the need for, or desirability of, full disclosure.

Contained within the text of the Pledge & Assigns is the following statement: "I do hereby make this assignment and pledge contract of my own free will, in good faith, as owner-Signatory of Peruvian gold Contract & Bonus Contract-Certificate Number 3392-N-181. Said pledge and assignment is FINAL."

- 10. Upon returning [to California], financial packages were compiled, including copies of the Pledge & Assign contract. These packages were first sent to George Bush. Word came back to HEII that George Bush was not ready to deal "at this time".
- 11. Then other world leaders and influential people received these financial packages, including former Senators Baker and Bentsen, and Alan Greenspan, to name just a few.
- 12. "Claims" were made by HEII for \$40 billion, 16 million U.S. dollars to the Federal Reserve Bank in San Francisco, the Federal Reserve System in New York City, the World Bank and several others. The claim which had been submitted to the Federal Reserve Bank San Francisco was returned with a letter from the Vice President (counsel) stating that if this or any other documents were resent to the Fed, they would be immediately thrown away.
- 13. Over the months that followed, many contacts were made world wide, and many financial packages were mailed out, in the pursuit of achieving financial associates who could finalize funding for this Pledge & Assign Contract.
- 14. At V.K.'s request of HEII, I wrote a Limited 2. V.K. also agreed to a Pledge & Assign in the Power of Attorney to her friend and associate Dr. Contract for a period of one year, beginning January 3. After some discussion and editing of the 30, 1997, at V.K.'s direct request of HEII, I provided Dr. Knecht with an "original" 10 billion dollar Pledge & Assign Contract.
  - 15. On June 30, 1997, having heard no word from Dr. Knecht, HEII revoked Dr. Knecht's Limited Power of Attorney and it was requested that all documents (including the one original instrument in his possession) be immediately returned to HEII. As of this date it has not happened. [D: As of today, it still has not been returned!]
  - 16. On July 9, 1997, I spoke with Dr. Knecht in follow-up to the prior day's conversation and Hellenic Express International Board concluded to discontinue any attempt at funding through Dr. Knecht. This was confirmed with Dr. Knecht by me on the telephone and all action on behalf of HEII has now ceased.
  - 17. Throughout many months of telephone conversations with V.K. Durham, she continually pleaded with me "not to talk on the phone" about business or the contracts. Further, she continually pleaded with me "not to fax any documents or information about the contracts". Complying with her request, we stopped communicating with her about any of the ongoing series of events. When we did share with her, it was merely out of courtesy, not a requirement of some kind.
- 18. On April 11, 1997, as journalist for the Las Vegas newspaper CONTACT: THE PHOENIX PROJECT, I wrote to Ms. Laurie Logan at the State 9. At no time within my presence, prior to Department, Office of Passport Policy & Advisory Services, to request permission to enter the country of Libya to interview President Muammar al-Qaddafi.
  - 19. Permission to travel to Libya was granted by the State Department and my passport was returned

with the necessary approval stamped within my passport.

- 20. On May 14, 1997, I received a letter from the Libyan Embassy requesting more specific information from me concerning the proposed trip to Libya. I responded on May 26, 1997 with a 5-page letter. As of this date there has been no response from the Libyan Embassy concerning this proposed trip to interview the President.
- 21. On May 20, 1997, I telephoned Ms. Laurie Logan at the State Department to ask for specific printed information concerning the Libyan embargo. I was referred to the U.S. Department of the Treasury, Office of Foreign Assets Control division, fax-on-demand service. On May 20, 1997, I received from the U.S. Department of the Treasury, specifics concerning the embargo against Libya and Iraq. I also obtained information on Iran. The language contained within these documents is very clear in her demands. restricting any business ventures with these embargo clear specifics as to what may or may not be Holding Trust. My letter was specific and to the point. permitted of me, AS A JOURNALIST.
- Durham offered billions of dollars from the Peruvian Gold Certificate/Contract to help Iran's [earthquake] disaster victims. After advising V.K. about the Department of the Treasury's restrictions concerning Iran, this offer was then cancelled.
- 23. On May 28, 1997, V.K. Durham issued an extension to the Pledge & Assigns, also witnessed by John Ray and Jack Jones, and sent to HEII five "original" extensions to those contracts.
- 24. On May 28, 1997, HEII again made a claim against the Federal Reserve Bank of San Francisco in the amount of \$40 billion, 16 million dollars. As of this date there has been no response.
- 25. On June 10, on From the Desk of V.K. Durham letterhead, I received a letter addressed to me c/o: HEII in which V.K. discusses setting up a parallel "trust" separate from her "living trust". I have no idea what she is referring to, as there has not been any discussion of this. V.K. goes on to place a demand on HEII for an accounting of all Pledge & Assigns in numerical order, even though none of the from V.K. Durham in which she reiterates her contracts were numbered and she has no right to place such a demand.
- 26. Further, in her letter of June 10, V.K. places a demand on HEII to return all Pledge & Assigns in our possession. HEII did not and does not acknowledge V.K.'s right to make such a demand.

    - 37. On July 2, 1997, HEII received a faxed letter cancellation, cease and desist and termination as of May 28, 1996 to the Pledge & Assigns. Said demand, of moment of signing.

#### **GOVERNMENT LIES ABOUND**

Here it is 10 years after the Gulf War, and the lies told by the U.S. Government are still pouring in. Most recently, Seymour Hersh writes in The New Yorker that a two-star general ordered a massacre against a five-mile line of retreating Iraqi soldiers and did so two days after a cease-fire went into effect. Hundreds of soldiers were murdered, men and boys who posed no threat and didn't know the War was still on. Many civilians, including children, were also shot. The numbers are still unclear because the corpses were buried quickly by the tankbulldozers.

This is no speculative piece. Hersh quotes many eyewitnesses to the attack and the carnage on the record, one of whom was very close to the general, and musters irrefutable evidence, gleaned from more than 300 interviews, of war crimes (a phrase used by an anonymous leaker inside the military). American soldiers called it a turkey shoot that ended up destroying 700 tanks, armored cars and trucks. The allegations have been made before and examined in four separate Government reports. But Hersh goes through them and, in the course of an exhaustive and terrifying 25,000word article, shows that each one is a whitewash.

Why was this bloodshed not reported at the time? There were no media around to witness it. They were operating under the military's rules—accepted by a press said to be jealous of its liberties—against any unsupervised reporting in postwar Iraq. The general, meanwhile, told journalists about the incident and spoonfed them tales about dangerous Iraqis attempting suicidal post-cease-fire attacks. He said it was a proportional retaliation, a claim that Hersh completely demolishes with the help of people inside the military who could be silent no longer.

Is it any wonder that the U.S. is hated in huge swaths of the Gulf region? So much for George Washington's ideal of being a beacon of liberty to the world. To many, the U.S. is nothing but a torrent of helicopter gunships unleashing hell on retreating soldiers and innocent civilians. This is not only a repudiation of America's founding principles; it is a flagrant violation of every rule of warfare agreed upon by every civilized country from the Middle Ages to the present day. This is the behavior of a murderous rogue state, not an indispensable nation.

And who is the two-star, now four-star, general responsible for the war crimes? None other than Clinton drug czar Barry McCaffrey, the man charged with using Government power to keep drugs from besotting American society. It is an interesting change of jobs: from one hot war to another. Just as he was careless with the rules of war during battle, he has been careless with liberties in the drug war. And just as the Iraq War did not achieve its objective of ousting Saddam, but has resulted in the deaths of millions of civilians, the drug war has not achieved its objective, but has resulted in the jailing and looting of innocents.

The lasting effect of the Gulf War has been to spread disease and death all over Iraq via a cruel policy of sanctions punctuated by periodic bombings. The final domestic effect was to prop up military spending at home at a time when it should have and could have been in a year and 10 years after discussion about the War cut. It's still a dangerous world out there, we are constantly told, so we need the firepower to blow away retreating soldiers anytime we wish. Then there's the Oklahoma bombing: Timothy McVeigh learned how to devalue life during his stint as a tank operator in the Iraq it. Hold McCaffrey responsible for the massacre and War. [While we're talking about lies: Timothy McVeigh is NOT responsible for the damage done to the Murrah Building, which was so extensive that it MUST have been caused by much more than a simple fertilizer bomb.]

But here's what really interests me. This is only the latest report of lies. For 10 years, we've had streams of reports that together show that the U.S. lied about nearly every aspect of that War. We were told about the effectiveness of U.S. smart bombs, when in fact most didn't work or didn't hit their targets. We were told that civilians weren't targeted, when they were. We were told that Iraq had nukes but none have been found. We were told that Iraq's invasion of Kuwait was a surprise, but it turned out the U.S. had effectively given the go-ahead.

And it's not only the Iraq War. The same pattern repeats itself on Kosovo. A recent report from Newsweek showed that the U.S. did very little damage to the Serbian military and instead smashed the civilian sector (another war crime). Other reports have shown that U.S. atrocity stories were trumped up, that the mass graves were mostly filled with Serbs whom we declared to be the enemy, that the most dangerous element in the postwar period has proven to be the KLA—our ally in the War.

Again and again, the truth about U.S. wars has turned out to be exactly the opposite of Pentagon press releases. And yet, these credible revisionist accounts don't make interesting reading for the masses. The American public long ago lost interest in Iraq and Kosovo. Once the propaganda engines were turned off, most people stopped paying attention. Hence, the version of events that continues to survive in the popular mind is one of a heroic and spotless U.S. laying waste to a demonic enemy.

If we were to develop an axiom about war informed by the last several, it would be this: Believe nothing (nothing!) that the Government tells you while the war is going on. Assume that it is all a lie, that the enemy is not nearly as evil as the Pentagon says, and that the U.S. is behaving a darn-sight worse than the evening news claims. Go ahead and believe the worst about the U.S. while the battle is going on and, 10 years hence, you won't be far off the mark.

That the U.S. is lying after the War must also be presumed. But the tendency is exactly the opposite. During and after war, Government controls the news. The media echo Government reports because those are the only kind of reports there are, because they know that any questioning of the Official Line of the day will lead to a loss of access, and because they are fundamentally

pro-state [and because the major media are controlled by the Khazarian Elite Thugs].

Of course, there will always be debunkers during war, a handful of people who will say outrageous things like: "Mass graves? I don't believe it"; "Milosevic is no Hitler"; "The Kosovars are ruled by a criminal band of drug runners." During the War, these debunkers are denounced as unpatriotic and told to produce their sources. But sometimes they cannot. They doubt the Official Line because they have developed an instinct for spotting the wartime lie.

The evidence to back their claims only starts pouring has been closed down. Fair? Certainly not. But it is the reality. And, tragically, the feds can count on this holding true for any war they start.

There is, however, something that can be done about don't let the man who employs him off the hook either. Bone up on past wars and acquaint yourself with the lies and the new truths about those wars. Stand up for journalists who dare to stand up to the Power Elite; Lord knows, it doesn't happen very often. Examine the history of warfare to understand how the state uses it to destroy liberty.

And when the next war breaks out, prepare to discount every bit of information you hear about it. Read Antiwar.com. Speak out on behalf of writers and commentators who take an independent stand. Oppose U.S. military intervention in any foreign conflict. Above all, ascribe no decent motives to the federal Government. Always and everywhere, it is the enemy of truth.

#### **UN PREPARES WORLD LEADERS** FOR GLOBAL GOVERNANCE

United Nations Secretary General Kofi Annan has issued his Millennium Report to prepare world leaders to begin implementing global governance at the UN Millennium Summit September 6-9. The Millennium Summit is being touted by the UN as "the largest single gathering of heads of state and/or government ever held in the world".

The report outlines the need for a complete restructuring of the UN and a change in the UN Charter to permit it to legally enforce global governance, a euphemism for world government. The UN, said Annan during the press conference for the release, proposes to do nothing less than "chart a course for the world's peoples in the first decades of the new millennium".

In usual UN style, Annan's report is very vague in its language, overly optimistic in its goals, short on substance and drastically distorts its true intent-to restructure the UN into a world government.

Global governance, insists Annan, "does not mean world government". Instead, he uses classic UN doublespeak by saying that global governance is a loose group of international "decision-making structures" which articulates and advances the "cause of common humanity", within a "robust international legal order"

and the "principles and practices of multilateralism". According to Webster's New World Dictionary, however, government is "the exercise of authority over a state...", "the right, function or power of governing" or "a system of political administration by which... nation[s]... [are] governed". Government, no matter how hard the UN tries to redefine it, is still government.

One of the first tasks of the UN once it has the power to govern is to "lift more than 1 billion people out of [poverty] by 2015" by "ensuring that people in all developing countries can benefit from globalization". This will be done, according to the report, by "rich countries... opening their markets to poor countries' products", providing them with "deeper and faster debt relief" and giving "more and better focused development assistance".

Annan affirms that "economic success depends in considerable measure on the quality of governance a country enjoys. Good governance comprises the rule of law, effective state institutions, transparency and accountability in the management of public affairs, respect for human rights and the participation of all citizens in the decisions that affect their lives." A casual reader would believe that this is what the UN is creating. But, it is not. Nowhere in any UN or NGO document is there any mention of a structure of governance that would permit real checks and balances to absolute power. There will be absolutely no direct accountability to the people governed. Instead, the "emerging global legal order" is based upon signing and ratifying "international treaties and conventions".

Citizens must also be protected from themselves. "Security" has been redefined from meaning security from "external attacks" to security "of communities and individuals from internal violence". Hence, asserts Annan, "The Security Council has a moral duty to act on behalf of the international community." In other words, the UN should intervene militarily like NATO did in Kosovo. Even so, small arms "endanger peacekeepers and humanitarian workers" and benefit terrorists and "perpetrators of organized crime". Of course, Annan's one-dimensional solution is gun control and the time-honored practice of all tyrants, the establishment of a global police state.

The greatest justification for global governance, according to Annan, is the need to protect the environment. Annan calls for the immediate ratification of the Kyoto Protocol, which he claims will reduce the global carbon dioxide (CO<sub>2</sub>) to "5 percent below 1990 levels". However, because only the industrialized nations are [to be] bound by the [proposed] treaty, leaving developing nations free to increase their emissions, the Kyoto Protocol is not designed to accomplish any CO<sub>2</sub> reduction. The Kyoto Protocol is nothing more than the greatest massive income redistribution plan ever conceived in the mind of a socialist. Annan would also create what is called "green accounting" to integrate the environment into "mainstream economic policy" to make sure all human activity and development is "sustainable".

Annan's solution to the world's problems is to bring every human activity under the control of the UN. The root causes of poverty, war and environmental destruction are greed, power, hatred and corruption [Khazarian "virtues"]. These are issues of the soul and spirit. Although they can be curtailed at the point of a gun, no amount of governance can ever change it. Only God can do that by changing the heart.

#### **BUSH AND CLINTON UNITE** TO BLOCK KOSOVO PULLOUT

WASHINGTON—Senate Republicans who are pressing to set a date for the withdrawal of U.S. troops from Kosovo have been ambushed by an unlikely alliance between President Clinton and the Republican presidential candidate, George W. Bush. [No, this alliance is totally "likely", in that Bush, Sr. controls Clinton and the current excuse for the maintenance of martial law in the United States is STILL the annually renewed "state of emergency" related to Kosovo.]

The two political opponents have joined together in a last-ditch effort to prevent the passage of a bill which would cut off funds for the 5,900 U.S. troops in Kosovo by July 1, 2001 and which observers believe was on the verge of winning majority support in the Republican-controlled

The bill, jointly sponsored by the Republican Armed Services Committee Chairman, Senator John Warner, and the veteran Democrat Senator Robert Byrd [Cathy O'Brien completely exposed this would-be slave-master in Trance Formation of America.], would pull the U.S. troops out unless Mr. Clinton or his successor obtains congressional approval for continued deployment.

The President would also be required to put forward a timetable for the transfer of responsibility for peacekeeping in Kosovo to European nations, and to certify that all NATO countries are paying their share for the operations.

The Byrd-Warner bill has been described as "a *de facto*" pull-out decision by the United States" by the former NATO Supreme Commander, General Wesley Clark, and is viewed with alarm in most European capitals.

Domestic political opposition to the bill has mainly come from Democrats, who are in a minority in the Senate, and from Republican Senator John McCain, who warned this week that the bill would "send the message to NATO that the United States is an unreliable ally".

Until yesterday, momentum had seemed to be growing for the bill, with most Republicans assuming that the plan had the support of Mr. Bush, the Texas Governor. But the Republican Senate leadership was taken by surprise by Mr. Bush's statement this week that the bill interferes with the constitutional powers of the presidency.

"The Clinton-Gore Administration has failed to instill trust in Congress and the American people when it comes to our military and deployment of troops overseas, but the Governor does not believe that this provision is the way to resolve the lack of presidential leadership," the statement said. "Governor Bush views it as a legislative overreach on powers of the presidency."

Senior members of the Clinton Administration kept up the pressure against the bill yesterday. The plan to withdraw U.S. troops was "playing with fire", the Secretary of State, Madeleine Albright, said. [And this hound from hell ought to know all about playing with fire.] "We are more than bookkeepers and spectators. We are leaders."

Meanwhile, the Defence Secretary, William Cohen, said that President Clinton might have to veto the bill, even though that would jeopardise \$8.6 billion (£5.76 billion) worth of new defence-spending projects contained in separate sections of the bill.

#### SOLZHENITSYN: RUSSIA ROOTED IN ROT

For 20 years, Alexander Solzhenitsyn was the conscience of Russia, speaking out from exile in the United States against the brutal Soviet communist system and calling on his beloved Russia to cast aside the Moscow dictatorship and turn to democracy.

Today, with the collapse of the communist regime a reality, Solzhenitsyn is home in Russia and once again speaking out against the Government—this time the one that replaced the hated communist dictatorship, a new regime he says is utterly corrupt and destroying his homeland

"Our whole apparatus is rotten," he told the newspaper Novaya Gazeta. "Corruption has caused everything else to rot. Not one step has been made against corruption. Why? Because they're all involved. They are drenched in it, and there's no way out," Solzhenitsyn raged.

"The huge reforms that were hailed have left half the country's population in poverty. And now we are hearing the same words from the new power. What an encouraging conclusion"

The famed 81-year-old is the author of the Nobel Prizewinning book The Gulag Archipelago, an account of his life in the dreaded concentration camps in which he was imprisoned for criticizing the Soviet dictatorship. He returned to Russia in 1994 and has been devastated by what has happened to Russia since the old communist regime fell, only to be followed by internal chaos.

He blames Russia's sorry internal state on a criminal conspiracy led by former communist officials, who stole vast Government-owned industries and have continued to mercilessly loot them while the nation's economy crumbles.

He has insisted that the 20th Century was disastrous for his homeland, and he places much of the blame on former President Boris Yeltsin, who he charges wrecked the country with so-called economic reforms that allowed the looting to take place.

And he puts little hope for a turnaround under President Vladimir Putin: "The new President said we will continue with the reforms. What does this mean? That we will continue looting and destroying Russia till the end? Everyone knows that hidden financial magnates control the Kremlin. We haven't yet heard that the new power will stop this way of working." [Let us HOPE that Mr. Putin sees the Light and makes choices to deparasitize his great nation.]

He reserved some of his harshest criticism for the financial oligarchs, who have proposed to change Russian law to allow the free sale of agricultural land, nationalized since 1917. He says these people will buy up the land at bargain-basement prices with the fortunes they have stolen, leaving most Russians landless.

"All we have left is the land. The magnates' greedy hands are now reaching out for Russian land. Having stolen billions of dollars, they now need to hide it somewhere. It is obvious that the law is being prepared for the magnates. What normal person can afford to buy even a tiny piece of land?" he asked, answering his own question glumly: "No one."

"Privatization has meant that our valuable national companies have been given away for 1 to 2 percent of their actual worth. Nobody tells us whether the stolen 98 percent

will ever be returned or if it is already lying somewhere in a foreign bank," Solzhenitsyn said, warning that the worst may be yet to come.

"Russia desperately needs to be saved. The international machinations of the new power have still not emerged, and that is frightening."

#### OTTAWA DEFENDS "BIG BROTHER" DATABASE

OTTAWA—Human Resources Development Canada, already reeling from criticism that it has mismanaged its \$1 billion job-creation programs for years, yesterday was accused by a federal privacy watchdog of building an Orwellian computer database whose [sic] existence puts the privacy of millions of Canadians at risk.

Bruce Phillips, the Privacy Commissioner of Canada, revealed in his annual report to Parliament that HRDC has quietly compiled "an extraordinarily detailed" and "relatively invisible" database that contains unprecedented amounts of personal and financial information on 33 million living and deceased Canadians.

Mr. Phillips expressed "profound concern" that information from the database has been shared with companies and researchers outside of the Government without the Canadian public's knowledge or informed consent.

"Successive privacy commissioners have assured Canadians that there was no single federal Government file or profile about them," Mr. Phillips wrote. "We were wrong-or not right enough for comfort."

Opposition MPs expressed shock and concern about the existence of one, single massive Government database.

"This is scary stuff," said Maurice Vellacott, a Canadian Alliance MP and human resources critic. "It sounds like the future, like the Big Brother described in the science fiction books, but none of us realized it was occurring right now."

Jean Dube, the Conservative human-resources critic, was stunned. "It's wrong and not acceptable," he said.

Outside the Commons, Jane Stewart, the Human Resources Minister, defended the collection of such massive amounts of personal information, saying it began in 1985 and "is fully permitted by the laws of Canada".

"When we're talking about building public policy for Canadians, it's wise to make sure we are testing the impact to see if changes to Canada pensions and disabilities, for example, are doing what they were supposed to do. That's how the information is used," she said.

She refused to answer further questions.

Mr. Phillips said he finds it difficult to accept that all the information in the HRDC database is relevant to the Department's programs and policy activities, as Ms. Stewart claimed.

The information is never purged once collected, he added, which explains why the files on Canadians totaled 33.7 million at last count. The current population of Canada is about 30.4 million.

If the prospect of an HRDC database is terrifying, its name is innocuous—the "Longitudinal Labour Force File".

Mr. Phillips said HRDC did not try to hide its existence from taxpayers, but the Department never made any attempt to communicate to the public just how much

information it has collected about each person.

The database contains up to 2,000 different details about Canadians—alive and dead—including their personal income tax information, records of their employment, citizenship, travels and immigration matters, as well as their ethnicity and use of provincial and municipal social and employment assistance benefits.

The database also contains information about a person's education, marital and family status, disabilities, language and mobility across the country, among other

"Canadians don't know how much information is being collected about them and the extent to which it is being integrated and shared with others. How many Canadians know their tax information is in an HRDC profile?" Mr. Phillips wrote: "Continually centralizing and integrating so much personal data on almost every person in Canada poses significant risks to our privacy."

The Privacy Commissioner's report states that he has spent the past two years unsuccessfully trying to persuade HRDC that the existence of such a database threatens Canadians' right to personal privacy and he suggested that the data should be kept in several different databases, if it is compiled and stored at all.

Despite his deep concerns about the database and the information collected in it, Mr. Phillips said HRDC is now proposing to expand it to include more data on social assistance recipients from provinces and new territories, as well as information about student loans, retirement pensions and old-age security benefits.

He said HRDC is emphasizing that its data are stored securely and coded in such a way that nobody could be identified when they are shared with private research firms and other governments for research purposes. HRDC also says its practices meet "minimum legal provisions".

Mr. Phillips said the emphasis on data security ignores serious privacy concerns.

"The Department's response is inadequate... Surely, a higher duty than that is imposed," he said of HRDC's declaration that it has met minimum legal provisions.

"This is a difficult time for HRDC and we don't want to be seen as piling it on," Mr. Phillips added, referring to the job creation grants crisis and the strain it has placed on all HRDC employees.

"But it's now more than two years since this discussion began. It is time to open it up to include all those whose information the Department is systematically mining in the interests of 'social policy development'," he added.

Ms. Stewart said her officials will create a working group to study what HRDC can do to alleviate the privacy concerns.

#### AIDS VACCINE TO BE TESTED IN UGANDA

BALTIMORE—An oral AIDS vaccine is expected to undergo human tests in Uganda in as little as 18 months, and could provide an inexpensive form of prevention in poor countries hit hard by the disease. [Right up front, let's remember that what we are dealing with here is a recombinant retro-virus that can mutate into something "different" in every new host. THERE IS NO WAY Africa (CONTACT, 3/11/97).]

#### TO DEVELOP AN EFFECTIVE VACCINE FOR A **RECOMBINANT RETROVIRUS.**]

The vaccine, which could cost \$1 per dose or less, is being developed by the institute headed by Dr. Robert Gallo, one of the co-discoverers of AIDS [who ought to and no doubt does know better than to expect this oral vaccine to be effective].

Uganda health officials said Friday that the vaccine is the only hope against the AIDS pandemic that affects millions in the country.

"I don't feel this announcement is the answer to AIDS, but it's a very important additional step toward the next line of HIV prevention candidates," said Gallo, who heads the University of Maryland's Institute of Human Virology. [So it is at best ineffective—and, at worst, Dr. Mengele—er, ah, Gallo?]

The oral vaccine, which uses the common salmonella bacteria, could be a cheap and easy means of preventing the deadly disease. [So let's give the AIDS sufferers a little bit of salmonella and see what THAT does for them. Is this called "practicing medicine", or what?]

"This has the potential to be as cheap as any vaccine," said Seth Berkley, President of the International AIDS Vaccine Initiative, a non-profit which is providing at least \$3 million over three years to complete development of the vaccine. [And funded by whom to effect this genocide?]

It is one of several vaccines expected to be tested in Uganda, according to Gallo's institute and the International AIDS Vaccine Initiative.

Once in full production, the salmonella bacteria used to make the vaccine could be grown in mass quantities, Berkley said.

Nearly 70 percent of the world's 33.6 million HIVinfected people live in sub-Saharan Africa. Current efforts to slow the spread of the virus by eliminating risky behavior are not enough because many people do not know they are infected, said Francis Omaswa, Uganda's Director General of Health Services.

"Even with an 80 percent cut in the prices of drugs, they will still be too expensive for our people" Omaswa said. "That brings us back again to a vaccine. It is for this reason that we have associated ourselves with this initiative." [And why don't you just dig your own graves and pay the Elite for the privilege?]

The strain of salmonella bacteria responsible for typhoid is genetically altered to be less infectious and to carry portions of the DNA of the HIV virus, which causes AIDS, into the body. [In short: a salmonella retro-virus.]

Once the salmonella bacteria invade intestinal cells, the bacteria die, their cells break apart and the HIV DNA they carry is released.

The infected intestinal cells are then hijacked by the HIV and produce a part of the HIV virus, which is not harmful but causes an immune response. Researchers hope that will allow the body to fight off an attack by the real HIV virus.

More than two dozen potential AIDS vaccines have been tried worldwide. Only one, however, has advanced to large-scale testing, the researchers said.

Results of trials of that vaccine, produced by Vaxgen, should be available in late 2002 or early 2003, said Dr. Peggy Johnston, Assistant Director for AIDS vaccines at the National Institutes of Allergy and Infections Diseases, a part of the National Institutes of Health.
