AIRBORNE TACTICAL LASER (can disable or destroy)

The Airborne Tactical Laser, a conceptual weapon system being considered by the Pentagon for rapid development, could neutralize an entire enemy convoy within minutes, military and industry sources say.

Military officials say the system could be used to either disable or destroy a target, offers a long-range capability currently unavailable, and can counter tactical, operational and strategic targets. [H: This is to mislead you. I repeat: These weapons are totally operational and have been used to take out planes and blow up any number of targets as well as detonate earthquakes and airquakes. This is not experimental technology—except to make it ever more deadly and destructive. You can also know that it can no longer be listed as "accidental" bombing—as in the claims of "hitting unintended targets"-warfare is now very sophisticated and intentional. Oh, yes, and by the way, these are the REAL weapons which are floating around on the industrial Internet of commercial give-and-take, and yes, the technology rests globally in the hands of nations have not yet come to have the toys of such as these war machines, for they would finally turn them against the invaders slowly choking the life from the nations in poor and struggling poverty and deterioration.]

The Airborne Tactical Laser concept integrates a 300-kilowatt chemical oxygen-iodine laser onto an MV-22 Osprey tilt-rotor aircraft, CH-47 Chinook helicopter, AC-130 gunship or possibly even ground vehicles, such as a 5-ton truck or the Army's Future Combat System.

The laser uses intense heat—roughly equivalent to that of a cutting torch—to melt metal and slice through enemy targets.

The system boasts a 10-kilometer range for groundto-air operations and 20 kilometers for air-to-air or airto-ground operations.

FILLING A GAP

The Airborne Tactical Laser fills a gap between the EXISTING VERY LARGE CHEMICAL LASERS PLANNED FOR THE AIRBORNE LASER AND THE SPACE-BASED LASER, and the electrically powered, solid-state lasers that could be available in the future. [H: Also available, tested and in use NOW.]

WEAPON CAPABILITIES

The tactical laser can be used as a weapon capable of knocking down low-altitude cruise missiles or to counter short-range tactical rockets.

It also is gaining attention as a precision weapon capable of quickly neutralizing enemy weapon systems without harming nearby civilians.

[MAGKASAKA = Farm Partnership Program] THE MAGKASAKA program launched in Malacanang last year is the Estrada Administration's response to the need to encourage investments into the countryside, which most investors consider a high-risk area. MAGKASAKA aims to promote joint-venture enterprises between agrarian reform beneficiaries (ARBs) and the private investors (including former landowners) in order to increase and sustain the productivity of the distributed lands and to transform the ARBs into globally competitive entrepreneurs.

[H: Wow, and just think: GAIA has over a thousand deeds of assignment IN THE HANDS of the coops and organizations of fisherfolk, farmers, forest enterprises and rehabilitation—right to the lobster and seaweed growers. The program moves right on into purchased and used as collateral against the loss of the area of opening up wondrous mining and metalholding operations, which would bring the commodities out of the caves and into the foundation upon which a stable economy can be built. Is President Estrada strong enough to accomplish this? YES! When he recognizes his own enemies to such growth and realization, he will act—and it will be a wondrous "independence" day for the celebration of the remainder of time. This is recognizing that within the immediate days ahead is the Independence Day recognition in the Philippines. MAGKASAKA addresses the age-old problem of lack of investment in the countryside, which slows down development. Even if the farmers have land, they do not have enough capital to make the land more productive and to develop scale. Unless investment comes in, the rural economy will remain backward, and the farmers will remain poor and mere tillers of the soil. Meanwhile, the market is increasingly becoming globalized, which is a reality independent of our will. If

this country is to survive, it has to contend with the challenges of the global market; it has to develop its comparative advantage and competitiveness. The whole economy must be geared toward this.

Through the MAGKASAKA program, the Estrada Administration and the Department of Agrarian Reform (DAR) aim to encourage the setting up of business enterprises jointly owned by ARBs and the private investors. Contrary to claims by some critics, arrangements under MAGKASAKA are not designed to favor the landowners. They are designed to ensure that both parties benefit, but with greater benefits accruing to the ARBs in terms of having priority in employment, better income, new technologies acquired, technical and management skills learned and prospect of owning the enterprise in the long run.

The ARBs put up only the use of the land, not the land itself, as business equity, so that whatever happens to the enterprise, the land will not be used to settle the obligations of the company. Thus, ownership of the land by the ARBs is always secured. Also, the ARBs are given priority in the hiring of personnel by the enterprise. On the other hand, the private investor provides the capital and the technical and management skills, which they pass on to the ARBs. Eventually, the ARBs should be able to run the business enterprise on

[H: In our program there is actual gold project product. Both the land and the project programs are then PROTECTED. If gold is the export contracts for the delivery of capital goods for the basis for the security—then it remains the security against any losses to bank, nation or the people.]

Joint ventures and other schemes under MAGKASAKA—such as production, processing and marketing arrangement, build-operate-transfer scheme, management contract, service contract, lease contract and combined or phased arrangement—are voluntary. An ARB is not compelled to enter into a partnership with an investor if he thinks the enterprise does not give him any advantage.

A prerequisite to the setting up of a joint venture or any other arrangement under MAGKASAKA is that the land should have been distributed to the farmer. Thus MAGKASAKA focuses on the ARBs, where land distribution has been completed. By promoting a joint enterprise, MAGKASAKA is actually trying to raise the collateral value of the reformed lands. This, by itself, is already advantageous to the farmer.

Who can join the MAGKASAKA program? Beneficiaries of agricultural lands distributed under CARP can enter into a joint enterprise with an investor. Beneficiaries of farmlands awaiting distribution can also join, provided the land transfer is completed before an agribusiness arrangement is completed.

The investor may be the former landowner, an individual, a corporation, a partnership, a Non-Government Organization (NGO), a farmers' cooperative or association, a Government-owned or controlled corporation, and other entities duly authorized by law. The investor should be willing to contribute capital, equipment facility and management service to the enterprise.

PROMOTING SUSTAINABLE RURAL **DEVELOPMENT**

By President Joseph Ejercito Estrada

Today we accelerate our efforts to rebuild a countryside consumed by decades of sacrifice, struggle and violence. We stand on the threshold of a technological revolution, forged by the partnership of Government, the business sector and our farming community.

I am pleased to witness today this initiative that will promote greater agricultural production in the Philippines. We look forward with much enthusiasm and optimism into this joint economic project that will scale up the production of corn through mechanization, and increase grain stockpiles through the provision of bulk handling facilities for corn producers in the Philippines.

The signing of two documents worth 30 million Deutchmarks or P613 million to be implemented in three provinces of Mindanao and two provinces of Luzon will foster and strengthen capabilities in our agricultural sector. The first document, a memorandum of understanding between the Bayerische Hypo UND Vereinsbank of Germany and the Department of Agrarian Reform (DAR) will promote the long-term financing of projects under the MAGKASAKA Program. The second document is a general framework agreement between Bayerische Hypo UND Vereinsbank and the Zamboanga Development and Management Corporation (ZDMC) for the financing of individual project.

I commend the Department of Agrarian Reform and those who worked on this project.

The Joint Economic Enterprises Program or the MAGKASAKA Program—which we launched in last year's CARP anniversary celebrations—continues to bear fruit. Let me also welcome our new partners in countryside development, the Zamboanga Development and Management Corporation (ZDMC). I also express our appreciation to the Bayerische Hypo UND Vereinsbank of Germany for its confidence in our local businessmen. Your faith and support in our ability to pursue this project encourages us to pursue this project with much enthusiasm.

Our passion for development in Mindanao and Northern Luzon, the whole Philippines for that matter, remains strong. We will not allow ourselves to be distracted by conflict. These projects we are now pushing are strategic in our nation's efforts to eradicate poverty where it is more rampant and debilitatingamong the poor marginal corn producers in the upland regions of the north and the far south.

These communities are the ones directly in the path of global competition. Left alone, they stand to lose the most from the dynamics of fundamentally unstable international commodity markets. This project, therefore, enables us to begin the process of leveling off the playing field in global trade. It signifies our Government's commitment to enhance productivity and competitiveness. It signals our rejection of the traditional recourse of maintaining high tariffs to protect inefficiency.

But there is a second, and perhaps more important reason for enthusiasm in today's ceremony. We are all aware of the present conflict in Mindanao, and the

doomsayers claim that direct foreign investments in this region are now lost. This project provides the clearest evidence that the Philippines, including the land of Promise that is Mindanao, remains a viable site for foreign direct investments. [H: What of man's individual ability to invest in himself?]

Poverty and absence of jobs and livelihood opportunities have been among the reasons for the conflict and violence in the countryside. This is why there is more reason to ensure the success of this project than the mere welcome of investment of new funds. This project locates itself in areas where it can deliver the biggest contribution to the peace and prosperity in the country. For this we are most grateful to our friends from Germany.

Finally, I take this opportunity to make a few comments on the critical portrayal of the Philippines in the media recently.

These past few days have been an occasion for reflection and analysis for most Filipinos unaccustomed to the hard realities that confront our developing nation. Too often we have become spectators in events we believe we could not influence, suspended in our indifference to build a future we think we cannot help.

The conflict in Mindanao is one such event. For years my predecessors watched as the power and be implemented in the corn-producing agrarian reform influence of secessions and fundamentalism grew to terroristic proportion. The nation and its leaders debated the course of action to take, captured by their unwillingness to act decisively, and provoking only halfhearted solutions.

The amounts will break down differently in Deutchmarks but since our audience is primarily U.S.-Canadian readers, we will try to stick mostly to the peso and the dollar. Therefore, not to in any way belittle the investment of P614 million, you have to realize that it can only scratch the very surface of needed input. Indeed, the need is GREAT. Therefore, the point of offering this project layout is to give you an idea of that which could be done in an incredible way with that which GAIA already has in the hands of the people—just waiting. Furthermore, it can be "funded" by any nation, and predominantly under consideration in very serious undertaking is Malaysia.

> The project is a joint venture under the Magkabalikat sa Kaunralarang Agraryo, or MAGKASAKA, program of the Department of Agrarian Reform (DAR) between HVB, Zamboanga Development and Management Corporation (ZDMC), and the agrarian reform beneficiaries, with DAR providing technical support.

> Two documents were signed recently in Malacanang covering the project. The first was a Memorandum of Understanding (MOU), signed by Morales and Benny Chui, member of the executive board of HVB, for long-term financing of projects identified and endorsed by DAR under the Magkasaka Program.

> The second was a General Framework Agreement (GFA) signed by George Aseniero, ZDMC President, and Benny Chiu and Michael Bott, Senior Vice President and Manager respectively, of HVB's Global Foreign Trade. ZDMC is the principal proponent of the project.

> for the financing of individual contracts for the acquisition of agricultural machinery and scientific equipment, including bulk handling facility, from Germany and other countries. The acquisition will be financed through a loan from HVB, Germany's secondlargest bank.

> Morales said the mechanized corn production and bulk-handling project is a prime example of the coordinated efforts of the private sector, the DAR and farmer's cooperatives through the Magkasaka Program, which was launched last year by President Estrada to

encourage investments in the countryside and boost the country's food security and poverty alleviation programs.

The project will set up a corn production and processing complex in some 2,000 hectares of cornfields in agrarian reform communities in Zamboanga del Norte. The facility will provide technology for plant genetics, grains processing and bulk handling.

Morales said the corn production techniques to be used in the project will be suited to the character of Philippine cornlands. He said there are ongoing studies for the establishment of similar production and processing sites in South Cotabato and in Tayug, Pangasinan.

He said the Philippines has to raise its corn production at world standard levels in order to minimize corn imports and in order for the corn-based local industries to become competitive in the global market.

"An increase in corn production can save us foreign exchange. We may also earn foreign exchange if the country produces enough corn for export," Morales

He added that efficient and large-scale corn production would help develop the cattle industry and other high value-added corn processing industries in Mindanao.

DAR BARES PROGRAM TO PROMOTE COMPETITIVENESS IN SUGAR BUSINESS.

A FLAGSHIP project that will promote the productivity and competitiveness of the sugar industry under the framework of the Magkabalikat as Kaunlarang Agraryo (Magkasaka) will soon be launched to ensure the survival of the industry in the rapidly globalizing economy. Agrarian Reform Secretary Horacio "Boy" Morales, Jr. announced recently.

Speaking in a forum of sugar landowners in Bais The GFA contains the general terms and conditions City, Negros Oriental, Morales said President Estrada will be issuing shortly several executive orders creating the Presidential Task Force Sugarlands Productivity Adjustment and Reform Initiatives for global Competitiveness, or Global Spark.

He said the Global Spark program aims to prepare the sugar producers and traders to be competitive in the era of free foreign trade. "If the Philippines is not able to produce sugar competitively, consumers are likely to buy imported sugar, and that could spell doom for the sugar industry," Morales said.

More than half a million workers are employed in

the sugar industry. Another two to five million end, only are collection agencies for the international painfully lacking in your religious belief systems based indirectly depend on the sugar industry.

"We should work together to reverse the trend in declining productivity in our sugar lands," Morales stressed.

Morales said Global Spark will be a six-pronged program to reinvigorate the sugar industry. Its strategies include: use of high-yielding seed canes; mechanization of land preparation, planting and harvesting; setting up of efficient farm-to-mill transport systems; modernization of milling operations; better bulk handling and shipping; and trading based on realtime market information technology.

"We are using the Magkabalikat sa Kaunlarang Agraryo, or Magkasaka, framework and guidelines to set up the joint venture firm that will implement this sugar competitiveness program," he said.

Magkasaka is a joint economic enterprises program of DAR launched in Malacanang last year which aims to promote agribusiness partnerships between private investors, including former landowners and agrarian reform beneficiaries.

sugar districts, namely, Ma-ao, San Carlos, Talisay and Murcia in Negros Occidental, and Barotac Nuevo, Calinog-Lambunao and New Frontier in Iloilo. These milling districts have a total service area of 116,565 hectares and produce 20 percent of the country's total sugar, while the islands of Negros and Panay account CONTINUE, for 60 percent of the country's total sugar production.

The project will involve 48,569 small landownerplanters and agrarian reform beneficiaries, and will also THROUGH THE PHILIPPINE NATIONAL POLICE. benefit special areas, such as Bogo-Medellin in Cebu and the province of Cagayan.

Morales said each of the seven sugar districts will be organized into a sugar trust company composed of sugar planters, workers and millers. The seven sugar ABUNDANT IN THE PHILIPPINES AS TO BE trust firms will, in turn, form a holding and marketing corporation called Global Spark Corporation, in joint venture with a corporate arm of the Department of Agrarian Reform (DAR) which is still being organized.

He added that the corporation will be listed in the stock market and non-sugar industry investors, whether domestic or foreign, can invest.

"DAR will own a minority share of the firm, which will gradually divest in favor of planter beneficiaries and workers through a mandatory and performancebased divestment plan. The participating planters, workers and millers, through their district-based sugar trust companies, will hold majority stock ownership of Global Spark Corporation," he said.

THEN THEY ARE BREAKING THEIR HONOR AND CONTRACT IF THEY EVEN SUGGEST OTHERWISE. WE ARE AN ALLIANCE, NOT A NEW CON-GAME SCAM FOISTED OFF ON THE PEOPLE. UNDER MAGKASAKA DAR IDENTIFIES P2-B JOINT VENTURE PROJECTS

The Department of Agrarian Reform (DAR) has OR PRESENT SOME DEVIOUS SCHEMES OR identified more than P2 billion worth of investments that can start up the Magkabalikat sa Kaunlarang Agraryo (Magkasaka) or Farm Partnership Program.

> Agrarian Reform Secretary Horacio Morales, Jr. said the projects, which will be joint ventures between private investors and farmers' cooperatives, will be located in 100 agrarian reform communities, or clusters of reformed lands that share infrastructure and support

> The projects can absorb investments ranging from P50,000 to P500 million, are designed to promote the production of high value crops and facilitate valueadding activities like processing of raw product among small farmers, thereby mainstreaming their participation in the nation's economy.

> Among the projects identified by the DAR are the processing and marketing of high value crops in Bicol worth P700 million; processing of palm oil worth P500 million in Sultan Kudarat; production and processing of sugar, corn and coffee in Bukidnon worth over P100 million; and coco-oil processing worth P100 million.

> He said the program aims to help small farmers compete in the global market while giving the private sector incentives to invest in viable rural-based enterprises.

> Joint economic enterprises entered into by the agrarian reform beneficiaries with private investors will be through any of the following schemes: joint venture, production, processing and marketing agreement, buildoperate-transfer, service contract, management contract, lease contract, combined or phased arrangements and other schemes that can optimize the operating size and productivity of distributed lands.

When President Estrada launched the program late

last year, he stressed that the DAR has incorporated safeguards to protect the agrarian reform beneficiaries' interest. One of these is that the farmers will only allow the use of the land as their equity, and not the land itself, so they will retain ownership of the land whatever the outcome of the enterprise. [H: This is especially beneficial to indigenous communities who own, rightfully, sovereign lands and who can share for profit the use of the land without forfeiting it should crop failures occur.]

Morales said the Magkasaka is one of the initiatives of the DAR last year in order to support the Government's poverty alleviation thrust and farm modernization program.

The Program likewise promotes the concept of civic Entrepreneurship, as more and more businesses tie-up with farmers' cooperatives and become directly involved in development in the countryside.

The DAR said that the program augments the joint partnership schemes that have been implemented under the auspices of the Department in recent years. As of last year, there were 426 production, processing and marketing agreements and investment contracts signed between the investors and agrarian reform beneficiaries. Fourteen of these contracts are investment tie-ups worth P79 million and benefiting 21,895 farmers.

Participating agribusiness firms include the Northern Food Corporation, Purefoods, Cargill, Nestle Philippines, Cindy's Food Corporation, Celebes Agricultural Corporation, Epoch Corporation and Coco Gold Marketing Corporation.

The tie-ups involved production and marketing of palay, tobacco, coffee, tomato, corn, garlic, cassava chips, copra, peanut and banana; establishment of and hog raising.

I would now ask to have copied the "highlights" of the CARP (Comprehensive Agrarian Reform Program) report. [QUOTING:]

CARP AFTER 12 YEARS

- * From July 1987, when the Comprehensive Agrarian Reform Program was implemented, to December 1999, the Department of Agrarian Reform (DAR) distributed a total of 3 million hectares of private and Government-owned lands to some 1.7 million farmer-beneficiaries. During the same period, the Department of Environment and Natural Resources (DENR) distributed 2 million hectares of public alienable and disposable lands to 1.27 million beneficiaries.
- * During the 12 years that CARP was implemented, the DAR distributed an average of 237,904 hectares per year.
- * Under the Estrada Administration, the DAR has distributed 222,911 hectares, almost 70 percent of which are private land holdings.
- * Of the total CARP target of 8 million hectares, both the DAR and DENR distributed a combined total of 4.9 million hectares as of December 1999.
- * Since the CARP was implemented, the DAR has put under leasehold arrangement a total of 900,000 hectares, involving 546,876 farmers. Leasehold agreements ensure the security of tenure of the farmers over the land they till.
- * Delivery of agrarian justice is one of the hallmarks of CARP. From 1988, a total of 162,246 cases were resolved by the DAR Adjudication Board (DARAB). Of these, 23,832 were decided upon by the DARAB in 1999.

- communities (ARC), the DAR organized 62 new ARCs in 1999, bringing to 1,140 the total number of ARCs nationwide. ARCs are clusters of barangays where land distribution is almost completed, and where there is convergence of services from different CARP-implementing agencies, donor communities, local government units and Non-Government Organizations.
- * To transform the ARCs into viable communities, an average of P40 million [in] investment per ARC is needed. Towards this end, the DAR has mobilized from 1992 to December 1999 a total of P26.35 billion from various donor countries and institutions to provide support services to the agrarian reform beneficiaries.
- * To complement the programs on land tenure improvement and program beneficiaries development, new strategies and approaches were adopted to promote social capital and draw in the involvement of the various sectors to agrarian-reform related undertakings. In 1999, the Magkabalikat sa Kaunlarang Agraryo (MAGKASAKA) was launched to encourage joint enterprises between the agrarian reform beneficiaries and the private sector in undertaking mutually beneficial agri-related projects.
- * According to a World Bank-sponsored study that spanned 30 years, agrarian reform in the Philippines has led to positive impact in terms of better education and improved health conditions of beneficiaries. Profits grew by 80 percent, and schooling-years of beneficiaries, particularly for women, doubled from 3 to 6 years. A Mid-Term Review also conducted by WB Agrarian Reform Community Development Program reveals that in 47 out of 55 ARCs sampled, net incomes rose by an average of 61
- * The DAR has mobilized a total of P17.7 billion in mahogany plantation; handicraft making; cattle fattening six foreign assisted projects under the current Administration, or about 80 percent of the total foreign portfolio of P25 billion.

It certainly appears to me that the "idea" is wondrous and the plan easily workable—with one exception: YOU MUST HAVE FUNDS FREE AND CLEAR TO BE ABLE TO IMPLEMENT SUCH PROGRAMS. IF A MAN HOLDS LAND, THAT IS WONDERFUL IF HE ALSO HAS THE MEANS FOR USING IT TO ITS MAXIMUM POTENTIAL WITH THE ABILITY TO RECLAIM AND RENEW THE LAND ITSELF IN THE PROCESS OF USING IT.

Many more jobs are then provided in the management of the very funds and banking-type holding companies to see to the funding resources, keep records in a very transparent manner which negates the spread of corruption from hidden manipulations of assets, and generally overseeing needs and petitions as they arise. GAIA is prepared to shore up funds to assist in repairing damages incurred through acts of Nature, for instance, where crops are lost to natural disasters. The fund itself will be based on hard value but when needs arise for continuous service and production, assistance will be available.

Too good to be true? NO, this is the way systems SHOULD WORK, so that nations can care for the whole and not be left vulnerable to the taking by any corrupt few. There can be funds allowed from PROPER income to cover governmental needs, for if you place the governmental responsibilities where they belong—with and for the people, as advertised, there is plenty without great taxation of anyone. In that manner you will also be able to sustain management of sectors where the need is—in the sectors. This will usually mean a going back to tribal law that

* Under the expanded framework for agrarian reform allows no corruption, lest a man be cast out for his unrighteous deeds.

So, are we talking about "democracy"? No, not as such; we are speaking of management by the people but considered for responsible considerations by the ones placed in stewardship of community matters. If you have JUST laws (rules and regulations) established, there is no cause for corruption and man can again begin to love and trust his neighbor, assist his neighbor and join in community with his brother regardless of doctrines of some religious order or another. When you stop stealing from one another and give to one another in a sharing thanksgiving, you will have that which GOD is all about. Therefore, why would you doubt that God would send messengers and a way to accomplish this act within community? And no, I did not say communal or communistic-I SAID "COMMUNITY" as in "brotherhood".

This has been a long morning of discussion and we hope it has been enlightening instead of boring. For, friends, if you will implement these ideas into a growing program, you will have founded true prosperity and community from what is turning into a rubble-heap no matter what were the original intentions.

The price? Responsibility! And the rewards are wondrous, indeed.

Please think on these things, for all we may do is offer-you must decide which you will choose and allow it to bring forth the sweet fruit instead of the sour grapes of the vineyard.

If it is a lie, then it is one of the most fiendish and malevolent pieces of propaganda ever contrived. For centuries it was a hot, volatile topic, but no more. In our modern "enlightened" age, we hear little from either its proponents or its deniers. Is the subject dead and laid to rest as some hope? Is there no more interest? Are there no more questions to answer? Is there no new angle or analytical tool that we can use to gain more insight? We believe a centuries-old question of this magnitude can benefit from a fresh look. We have new concepts and understandings, both in the investigative sciences and historical research. Modern studies of serial killers, kidnappers, child abusers, forensic psychology and cultic criminals provide new paradigms and templates that enhance our understanding of these events. The proven, modern and effective tool of Profiling is used in reinterpreting these old crimes. From this broader perspective we look back at some of the most controversial murder cases that ever happened.

Both the sordid tabloids and the "mainstream" We do not know whether to say "welcome" or media avoid this topic like a plague. Without going into who owns and controls the mass media, we can surely agree that this topic was dismissed as dead and buried—or so some hoped. Don't forget this is the same media that parade stories of sexual perversion, drugs and vicious crimes before our children and anyone else who will tune in or read. The Blood Accusation, if ever mentioned at all, appears as just another old canard perpetrated by anti-Semites against an innocent and virtuous people. This begs the question: Do some of these old stories (all involving actual murders) contain a kernel of truth at their root. Finding the elusive gold dust in this river of obscurity and oppression means that we have to sift through a lot of trash to get what we seek. This is the goal of our investigative report—a new look at the facts.

> We not only recount the almost totally suppressed history of the charges, we theorize a logical answer to the age-old query of "who done it". Join with us as a partner and explorer as we search for clues and answers to explain these admittedly bizarre cases. In the process we may offend some Christians and some Jews. This is probably inevitable given the strong emotions involved. Sometimes the truth is blunt and offensive, so we make no apologies for where this investigation may lead. We ask only that the reader approach this investigation in a spirit of candor, fairness and open inquiry, and to put aside, as much as possible, your biases and preconceived conclusions.

Our purpose, therefore, is three-fold:

- 1. Re-examine the existing English language accounts of ritual crime incidents with the modern tools of the investigative sciences and criminology, psychology, sociology and historical research for new insights and understanding;
- 2. Preserve an account of the crimes and incidents in light of these new awarenesses;
- 3. Preserve a bibliography of significant works addressing the Blood Accusations.

BLOOD RITUAL takes a sensible, but explosively controversial position on this ancient accusation. We postulate and demonstrate the overwhelming likely existence of a small, secret, subversive, cabalistic death sect deep within the outward trappings of Judaism. It was responsible for many of the bloody slayings we examine. Small radical cults and sub-groups are no strangers to Jewish cultural ethos. While the Judaic religion likes to present a united front to the "goyim" ("cattle," i.e., non-Jews; more politely called gentiles), it has always been more a coalition of sects and parties than a unified, monolithic entity like the Roman Catholic Church. Judaism is and always has been rife with sectarian splinter groups. Essentially, small stubborn sub-sects with radical agenda, including terrorism, are no stranger to Jewish life.

The Judaic culture is held up as a model. Public schools are required to teach and emphasize particular aspects of that culture and history. Certain other parts are, however, off limits. Let's just say that many pieces are left out of the puzzling picture. We bring together several of these missing pieces, elements that many readers have not seen before. There is, for instance, a well-documented ancient tradition of human sacrifice that lies at the base of Hebrew religious thought. We present concrete evidence that extremist criminal cultic activities, including magical blood rites and human sacrifice, are not so rare a phenomenon. In reality it has occurred all around the world in many cultures and at various times in history as we will demonstrate. To say 'it just couldn't happen among the Jews' is to ignore the evidence. Another ethno-characteristic we explore is a tendency toward radical violence that often melds with a strong tradition for exacting vengeance. History has several instances of Jewish cultic crime and violence that we cover in depth. While these facts are suppressed and ignored, they can easily be documented as we demonstrate. The ritual murder accusations are very likely the act of a violent cult based on a skewed religio-magical belief system. This tiny terrorist clique must surely be responsible for at least some of the hundreds of murders recorded and remembered over two millennia.

Breaking New Ground On An Old, But **Persistent Topic**

We illustrate a clearly discernible Modus Operandi ("method of operations" or M.O.) in the crimes. We confirm that a clear and understandable motive, a very basic criminal impulse—revenge—is a key element in comprehending the cases. We follow the activity of these serial assassins, these transgenerational killers, from one era to another as we answer the investigator's basic questions of: who, what and how, when, where and, finally, why.

This is the first major work on the allegations since 1943 that does not automatically exonerate, whitewash and absolve the Jews without taking at least a closer ritual murder cases and literary references catalogued since World War II, when the Iron Curtain of Suppression And Silence squelched open discussion of these and other controversial issues. BLOOD RITUAL is a frank, candid revisionist re-examination of this old, disconcerting, but persisting topic. Modern methods and tools of criminological analysis are employed to re-examine and reinterpret these old crimes. Such an analysis not only demonstrates that these crimes were real, it manifests a genuine fresh understanding of what we would now call serial murders with strong ritual and psychosexual overtones.

One further thing must be said. This book has nothing to do with World War II or the events popularly known as The Holocaust. While the research led us to profile some relevant persons and writings of that era, that material represents but a small part of the whole work. If the book lays heavy emphasis on any one historical era, it is the Middle Ages or the Nineteenth Century, not W.W. II. Feelings and opinions about who won or lost the War, or about the parties and ideas that conflicted, are irrelevant to the topic of the report. Belief or skepticism in The Holocaust and its attendant emotional baggage (on all sides) is of no importance to this study. Our focus is a unique and especially savage series of crimes, usually involving sadistic child abuse, almost all of which occurred many years before the War. As we will show, a similar book could be written (as many have) about the history of human sacrifice in diverse other cultures all around the world. CHAPTER TWO—THE NATURE OF THE **BLOOD ACCUSATION**

"Men never do evil so completely and cheerfully as when they do it from religious conviction."—Blaise **Pascal**

Since ancient times there have been rumors and allegations that some Jews ritually slay Gentiles for blood then used in religio-magical rites. Early churchmen had already pronounced a guilty verdict on the entire Jewish people for the crucifixion as well as their (to the church) stubborn and arrogant rejection of the Christian religion. Most Christians extended this blanket presumption of guilt to the ritual murder charges. Presumed guilt most often fell on the whole Jewish race. Yet always a perceptive few suspected that small, radical sects of Judaism were responsible for the ritual crimes. To understand the nature of the Blood Accusation, we must view it in the larger context

While both the Case Timeline and the Literary Timeline address this topic, this is an opportune point for some salient observations.

Hebrew Religious Development

The Jews portray their religion as highly advanced and evolved as compared to other faiths. While this is intrinsically disputable, this is not the purpose of the book. Judaism is neither better nor worse than any other religion. In truth, all religious belief systems spring from responses to basic human impulses, emotions and archetypes, especially fear. Most scholars in the anthropology of religion agree that the earliest developments of rituals and beliefs were primal reactions to fear. This led to the next level: the division into, and discernment of the forces of good and evil. Both inspire awe and fear. Even with today's knowledge and survival skills, being alone and uncomprehending in a savage wilderness of the primeval past would produce a quite natural fear reaction. Indeed, our primitive ancestors had plenty to fear. If gods or spirits were responsible for the elemental forces, is it good or evil when lightning strikes and kills a hunter trying to feed his family? Did a god slay him because he was evil? Or was the god evil? Did he fail to properly honor the god or spirit with ritual and ceremony. Was an offering or sacrifice demanded by the god of lightning? What is the greatest offering we can make? It is the sacrifice of our very life. Hence the lingering atavistic practice of human sacrifice in almost all cultures. Both magic and religion spring from the same needs—to understand and control our environment. Human sacrifice is a primal atavistic religio-magical ritual intended to manipulate a cosmic source, thus gaining control of a certain set of circumstances.

crucible. Just as each individual develops a unique and personal response to these primal drives and archetypes, so too with families, tribes, races and nations. That is to say, there is an ethno-cultural and ethnopsychological uniqueness in religious rituals and beliefs. The colorful and varied practices of all world religions reflect this. Every philosophy or belief system addresses the same eternal questions, but we have many and varying answers and practices. The theology and rites of, e.g., the Lutheran Church are strikingly opposite and contrary to the Hindu gurus of India with their unique belief systems, rituals and ceremonies to their pantheon of gods and demigods. We examine both the differences between cultures as well as their similarities.

Judaism too responded to the atavistic primal drives affecting all human beings. Their response was unique to their cultural ethos. The great variation of ritual practices reflects these ethno-psychological formations. The human sacrifice rituals of the Jews had strong attachments to the basic archetypal feeling and drive for revenge. Revenge is a strong motivating force in the development of the Hebrew culture. The Revenge Motive combined with lingering tendencies toward human sacrifice causing the formation of secretive sects sanctioning and practicing some peculiar rituals. These savage and horribly cruel rites not only extracted revenge. The magically inclined Jews also derived benefits, so they believed, through magical use of the blood of the victims. This sadistic sect evolved into an

look. Our book amasses the largest collection of of Hebrew history, its cultural and religious evolution. on-going clandestine cult operating under the outer trappings of Judaism. In actuality, it links directly to the perverted beliefs of ancient Hebrews who blasphemously believed Moloch was another manifestation of Yahweh/Jehovah (See Timeline of Cases and Events, c. 900 BC). As the Jews encountered more and more hostility from the Gentile world, most especially from the Christians, the need for revenge grew desperate and intense. This fired the need for human sacrifices even more. Not only was the ritual blood obtained, but by victim proxy, the Jews could torture, debase and desecrate their main oppressors, the despised and hated Christian religion.

The Hebrew History of Human Sacrifice

As with many other ancient cultures, human sacrifice played a pivotal role in the growth and development of Jewish religious ideas and in later Christian theology. While many unpleasant aspects and cruelties from the dim and misty past were probably omitted from the scriptures, convincing evidence demonstrates that human sacrifice was no stranger to the Hebrew cultural and religious ethos. The "purity of monotheism" so highly touted by the Jews took some time in developing fully. Dr. Paul Carus' monumental work, THE HISTORY OF THE DEVIL AND THE IDEA OF EVIL, references some clear examples.

"Human sacrifices are frequently mentioned in the *Bible.* Thus the King of Moab, when pressed hard by the children of Israel, 'took his eldest son that should have reigned in his stead and offered him as a burnt offering upon the wall' (2 Kings 4:27). He succeeded by this terrible expedient in saving the city, for the biblical report continues: 'And there was great indignation against Israel; and they {the Israelites} departed from him and returned to their own land.'

"The prophets were constantly preaching against All religions and magical systems developed in this the pagan practices of those Israelites who, in imitation of the religion of their neighbors, sought to 'sacrifice their sons and daughters to devils', or let them 'pass through the fire of Moloch to devour them'; but so near to the religious concept of the savage was even the purer faith of Israel that Jephtha still believed that God required him 'to offer his daughter up as a burnt offering.' (Judges 11:29-40).

Progress in civilization led to a modification but not a direct abolition of human sacrifices.

"Human sacrifices are one of the characteristic traits of Devil-worship, but not the only one. There are other devilish practices [to wit, rituals of desecration] which are based on the idea that the Deity takes delight in witnessing tortures.... [Note this in the accounts in our Timeline of Cases and Events.] The last remnants of the idea that the wrath of the deity must be appeased by blood, and that we acquire spiritual powers by eating the flesh and drinking the blood of the victim still lingers with us today.... pp. 10-14." [Emphasis and commentary added.]

For more on the Hebrew record of human sacrifice as presented in the Bible, see the early entries in our Literary Timeline as well as the Ancient Times section under Cases and Events.

Facts and Details of The Blood Accusation

At Purim (February or March, dates vary) and Passover (March or April, dates vary), a Christian was kidnapped, tortured, often crucified, killed and drained of blood destined for use in diabolistic rites. The victim was usually an adult at Purim, but often a young child

at Passover. Passover, of course, celebrates the Jews' deliverance from the Pharaoh of Egypt and the ten plagues Yahweh/Jehovah sent to smite these oppressors. The blood sacrificed the night before marked the homes of the Jews so that the angel of death and retribution "passed over" the "chosen" ones. Purim has its basis in the perhaps apocryphal Old Testament Book of Esther. In this highly stylized story (of which, see more in the Timeline), Haman, an archetypal Jew baiter, oppressor and would-be exterminator of the Jews, has gained the ear and favor of the sovereign. Haman targeted the Jews for death. Esther appeals to the king, who changes his mind and saves the Jews. Haman died on the gallows intended for the Jews who have celebrated ever since. While some speculated that Rosh Hashanah (New Year) and Hanukkah (the biblical Feast of Lights) were also times for murder and sacrifice, the case materials do not really indicate this.

As we will see in our Timelines, many of the ritual trials included testimony from converted Jews, even converted Rabbis and Grand Rabbis. The following is illustrative:

"Also the numerous confessions made by the Jews show that the execution of ritual murders is a law of the *Talmud* Jew. The former chief rabbi (and later monk) Teofiti declares that the ritual murders take place especially on the Jewish Purim (in memory of the Persian murders) and Passover (in memory of the murder of Christ). The rules are as follows: The blood of the victims is to be tapped by force. On Passover it is used in wine and matzos. Thus a small part of the blood is to be poured into the dough of matzos and into the wine. The mixing is done by the head of the Jewish family.

"The procedure is as follows: The family head empties a few drops of the fresh powdered blood into a glass, wets the fingers of the left hand with it, and sprays (blesses) with it everything on the table. The head of the family then says, 'Thus we ask God to send the ten plagues to all enemies of the Jewish faith.' Then they eat, and at the end the head of the family exclaims, 'May all Gentiles perish, as the child whose blood is contained in the bread and wine.'

"The fresh (or dried or powdered) blood of the slaughtered is further used by young married Jewish couples, by pregnant Jewesses, for circumcision, and so on. Ritual murder is recognized by all Talmud Jews. The Jew believes he absolves himself thus of his sins."

"Teofiti" as quoted in Runes, Dagobert D. THE WAR AGAINST THE JEW, p. 180. [For more on Teofiti, see Literary Timeline, 1803.]

The important Catholic newspaper of Italy, CIVILTA CATTOLICA, wrote fearlessly and plainly about the reality of Jewish ritual murder. See issues of 1881 and 1882. It affirmed many of the practices of the blood cult, which regarded the substance as ritually necessary for Passover. The blood was never used in its entirety, but reserved for possible shortages. Special agents, often with protective passports, were employed to carry the blood (usually dried, but sometimes in vials) to the required destinations. The killings were truly meant to desecrate Christ and his religion, and in a perverted acceptance of Christianity, to assure their salvation if he actually was the Messiah! Talk about chutzpah! The newspaper went on to publish a series of several articles with access to Hebrew

strive to do grevious bodily harm to a Christian at least once in his life. Blood rites were obligatory for five different ceremonies: circucision (the bris); weddings, where the blood is mixed with two eggs eaten by both husband and wife; the ninth of July or Tisha b'ab, a fast day commemorating the destruction of the temple; Purim and Passover.

The reputed rules for Purim were different. While Passover required the purity of a child, Purim required an adult be killed and tortured as a living effigy of the dreaded Haman of the Esther saga. There are some cases recorded where bands of drunken Jews attacked Christians at this time of the year, and many ritual murder case dates coincide with this Jewish Revenge Fest of Purim.

The kidnappings, disappearances, deaths, marks of torture and ritual incisions were all authentic enough, as we shall see graphically in our Timelines. As a result of the ritual nature of the crimes and their occurrence on or around Purim or Passover, suspicion usually fell first on the Jews. Ethnic prejudices were extremely strong in past times, and the Jews were perpetually under scrutiny and suspicions. As we shall see, they were at times the victims of a "bum rap" or false accusation. Yet we don't see how some politically correct historians can issue a blanket exoneration solely on the grounds of anti-Jewish prejudice. The question is not whether the accusations involved prejudice and ethnic hatred—they did. Neither is the question about the use of torture (of which, more later) and threats thereof to obtain evidence. These were methods used in those times. Yet as we shall see later, torture does not preclude the determination of truth. So out of our basic investigative queries, we have the "what" (bloody murders—no one dreamed up or faked the bodies!), we know "how", and we have dates and places for the "when" and the "where" to complete this basic litany of all detectives. All that is lacking is the elusive "who" category. Continue with us as we seek more definitive answers.

Characteristics of Subversive Societies and **Criminal Cults**

While the general definition of a cult offers enlightenment into exactly who were the perpetrators of these hideous murders, we must fine-tune our definition. We believe this particular cult was a blend of perverted religion, black magic and a propensity for grotesque psychosexual ultra-violence. Those attracted to and recruited by the cult already had tendencies toward violence and sadism. Since most of the victims were children and young women, we must recognize the strong psycho-sexual elements of the crimes.

All criminal cults have many elements in common, but a particular type of cultic activity may manifest more specialized and detailed traits. Some of the following characteristics are demonstrated in criminal cults like The Mafia, The Thuggees, and The Assassins to name a classic few. This Judaic religio-magical murder cult is distinguishable by these characteristics:

DEVOTION TO A LEADER OR **LEADERSHIP PRINCIPLE:** Don't stereotype all cults as having a dynamic dictatorial figure at their head. In the last several decades, we learned a great deal about "leaderless resistance". Individuals or small groups (such as the classic communist cell)

books which allegedly taught that every Jew should independently without involving fellow believers. Devotion to key guiding ideas or leadership principles can replace a live and present leader. The doctrine is dictatorial and harsh, therefore any lower-level leadership or individual motivation derived therefrom is equally stern and demanding. When the cult is transmitted transgenerationally within families, the strong leadership of the father and family elders adds even more authority to the doctrines and practices of the cult. The cultists believed they were performing a priest-like service for the Jewish community.

2. INTENSE DEVOTION TO A SECRET **DOCTRINE:** The doctrine was important, forming also the basis of the leadership principle. It provided theological veneer and justification for intensely violent and sadistic psychosexual crimes. These vile doctrines developed in the same crucible of thought that brought Moloch, Ba'al and other demonic deities into early Hebrew cultural and religious development. Absolute pure Hebrew monotheism is a myth. Yahweh/Jehovah was the overall winner, of course, but there are other herbs flavoring the stew! The cult's doctrine, likely framed in a Cabalistic backdrop, links directly to these early ritual abominations. We also must not forget the power of the basic motive—revenge. By itself, a thirst for vengeance is a strong and lasting criminal motivation. Combined with skewed doctrines giving license to bloodlust and sexual sadism in the name of religion, this becomes an even more volatile brew.

3. TRANSMISSION OF DOCTRINE AND RITUALS THROUGH ORAL TRADITION AND **CULT INITIATION:** While many cults have thick volumes of writings, a successful religio-criminal cult will not. Not only is oral tradition accurate and reliable, it provides no physical evidence (like a secret manuscript) pointing to a particular group. As with most cults (and many modern street gangs), this sect would have its own series of symbols with secretive meanings. Cults often take conventional religious symbols and change their meaning. This is how Santeria, Voodoo and other African spiritist Yoruba religions managed a successful underground existence in the New World. They co-opted Roman Catholic saints and symbols to remind them of their West African gods and goddesses. Remember too the persecutions of the written Talmud and Cabala. Jews were oftimes burned along with their books. A successful criminal learns from past mistakes made by himself and others. Besides, their doctrine was not excessively difficult or complicated, furthering ease of transmission. In family settings the passing on of cult lore and rituals throughout one's formative years would powerfully fix and imbed these details in a developing mind. Initiation rites began gradually with stories about past crimes. The next step would be presence and/or minor participation at a ritual sacrifice, progressively advancing to full participation in the murderous bloodlust.

4. UNIQUE OR PECULIAR RITUALS AND **CEREMONIES:** Along with the ritual murders themselves were certain other blood rites. The blood, imbued with magical power through the human sacrifice, becomes a key element in special blessings and magic potions. The ghastly ceremonies and practices used to torture and slowly bleed the naked victims were unique in the history of ritual magic and devoted to ideas, doctrines and rituals can act human sacrifice customs. These demonic rituals formed

in a crucible combining Judaic Cabalism with basic doctrines of sympathetic magic. They then topped this off by adding a good measure of Pedophile fetishism and Child Abuse. This makes for an unpleasant and shocking conclusion—but it is the truth. Read the literature and the case accounts. Decide for yourself.

5. INSULAR, SECRETIVE LIFESTYLE: For their protection, cult members probably (at least outwardly) denied knowledge or membership, much like secretive modern Satanists or pedophile groups. Since the Jewish people seemed to be outsiders no matter where they lived, this cultural insularity became an ethnic characteristic. Within this parochial and isolated culture, several levels deeper, dwelt the murder cult members.

Watch for these general characteristics of this cabal. They are part of a unique and peculiar criminal profile and Modus Operandi (M.O.). For a full development of a distinctive Criminal Profile, see Chapter Six, The Timeline of Cases and Events.

For Centuries, The Church Had Little Doubt About The Reality Of Jewish Ritual Murder.

One very powerful entity had little hesitancy in identifying the suspected perpetrators. The Roman Catholic Church, as well as the Protestant Reformers, had few reservations as to the guilt of the Jews. Our chapter on the refutations points to contradictory statements and stances taken by the church over two thousand years. These are featured in the Timelines. Overwhelmingly, the church and its clergy strongly supported the Blood Accusations. One of the clearest demonstrations of this comes from the Rota, the official Vatican roster of saints and beatified persons (the step before full sainthood). Some sources point to twentythree saints who were victims of ritual murder. The list below includes some of the better known personages. These and others are in the Timeline.

Ritual murder accusations, as others leveled against the Jews, usually aimed at "the Jews" as a whole race of people. Although some speculated about a cult of Jews, they usually assumed that the cult was widespread and that all Jews were probably complicit in attempts to cover the criminals' tracks. Even those who may have been more discerning usually kept their opinions to themselves, fearing to contradict the all-powerful church. For a Christian scholar to have postulated the reality of the crimes apart from the total guilt of "the Jews" was to have risked persecution, harassment and possible indictment for heresy. From the truth of some ritual killings, the church

extended the guilt to include all the Jewish people. bloody and superstitious crimes." William Walsh in

As we look through the history of Jewish-Christian relations, we will understand more about the zeitgeist or "spirit of the times". We must hone our critical thinking and turn off (or at least be aware of) our prejudices and biases. The honest, critical thinker will neither automatically assign guilt nor automatically dismiss the accusations solely based on prejudice, whether from philo-Semites or anti-Semites. We must be neither. We must be rational, open-minded, but critical and creative thinkers as we continue our inquiry.

Were All Jews Complicit?

Jewish ritual murder charges are without a doubt the one of the oldest, most horrific and most persistent accusation ever raised against an ethnic group. Along with many other accusations, most of which are outlandish and false, the Blood Accusation bashed the Jews. In the midst of all this hatred and Jewish-Christian strife, there were still a few voices who suspected that a small cult of Jews might be responsible for at least some of these horrible crimes. This did not, however, ameliorate or lessen the mental image of "the Jews" as individually and collectively responsible for the worst behavior of the worst elements.

When considering the factors, the only quest for investigators is to seek whatever grains of truth we find in the murky soup of claptrap, superstition and prejudice that has become our area of inquiry. To indict "the Jews" as an entire people is patently ridiculous. It is no more rational than the blame assigned them for the demise of Jesus. Jesus met his fate at the hands of the Jewish religious establishment with the complicity of Roman colonial authorities. When examining the biblical account, we see his downfall came through a cabal of powerful Temple Priests, Pharisees (a powerful sect of the day) and the cabals, and subversive secret societies are no strangers to the Jewish cultural ethos.

knew of the cult, only a small cadre aid or abetted it in any way. William Walsh, a traditional Catholic historian, covered the renowned La Guardia Case of 1491, a truly pivotal point in Jewish-Spanish relations. His position is quite close to our own. In addressing the Ritual Murder Deniers of the famous case, he says:

"Jewish writers have sought to prove that Torquemada or his subordinates 'framed' this group of victims, to complete the work of discrediting and suppressing the Spanish Jews, with a view to their expulsion. [See our discussion and Author's Notes, Timeline of Cases and Events, 1491.] I have great sympathy with the motives of Dr. Isidore Loeb [a French author] and Dr. Cecil Roth [See Literary Timeline, 1935.], and in so far as the ritual murder accusation was involved in this case, I wish to take my stand with them in repudiating and condemning this cruel charge from which the Jews have suffered in so many lands and ages. [We don't agree, but read on.] I do not believe that Jews, as a racial group or religious community, ever practiced such an iniquity—it stands to reason, from what we know of human nature, that the thing cannot be true as a general proposition. [That is, against all the Jews.] It does not follow, however, that individual Jews, or groups of Jew [Read, cults.], have never committed

See our discussion of Host Desecrations as acts of Sympathetic Magic in Chapter 3 for another congruency between Father Walsh's theories and our own. Refer also to the La Guardia 1491 case entry in Chapter 6 for his analysis of the investigation and trials that followed the murder.

Father Edward Flannery in his work THE ANGUISH OF THE JEWS says this: "...it is not outside the confines of possibility that an odd superstitious Jew may have indulged in the sacrifice, the falsity resides in the attribution of the crime to Judaism itself." This seemingly logical position, fully and without reservation releasing the Jews as a whole people from any responsibility, is not the politically correct answer. As we have discovered, the Jews may hate this position more than the one that blames all Jews. This is easier to debunk. Father Flannery's psoition, and our own, allows for some degree of reality to the allegations. The Ritual Murder Deniers greatly fear that loosing the argument on even one case will bring their historical house of cards falling down.

Without belaboring the point too much, we offer one more observation on the Cult Hyposthesis, this time from the DICCIONARIO DE HISTORI DE ESPANA, a historical dictionary found in almost all Spanish libraries and many Spanish homes.

"[The La Guardia Case, 1491] ...provoked a general indignation coupled with the recollection of a similar case which took place in Saragossa [1250. However the ritual crimes are not perpetrated by the Jews as an entire people, but by a few fanatics.] These fanatics have so embarrassed Jewish historians that they have tried to deny the authenticity of these ritual murders."

In addition, Spanish historian/sociologist Julio Caro Baroja, says in his multi-volume study entitled Roman Procurator, Pontius Pilate. Covert plots, secret LOS JUDEOS EN LA ESPANA MODERNA Y CONTEMPORANEA (Madrid: Ediciones Arion, 1961).:

"Certain Jews and Conversos [Jewish Catholic So we must be fair. While many Jews no doubt converts] might well have practiced certain murders along with other acts for purposes of magic and enchantment. But these acts cannot be attributed to the Jewish people as a whole and much less to the teachings of the synagogue."

> So is there reasonable suspicion to believe a tiny, but powerful cult or sub-sect could have perpetrated at least some of the crimes? Are there precedents in the history and culture of the Jewish people that inform our inquiry? There is surely probable cause justifying a new investigation, but this is not the "politically correct" answer in our "modern" times. Any voice raised in protest or criticism of certain governmentprotected ethnic groups or challenging "culturally correct" shibboleths risks ostracism and media quarantine or yet worse threats. This has not deterred us and will not stand in the way. We seek the truth wherever it is found.

IS TURKEY THE NEXT IRAN?

A century ago the Ottoman Empire was moribund, the Sick Man on the Bosphorus whose hold on the farflung provinces in the Balkans, North Africa and the Middle East was growing more tenuous by the day. Its precarious survival in the century following the defeat of Napoleon was due entirely to the inability of the Christian powers of Europe to agree on what to do with the spoils and the intractable "Eastern Question" remained on the European diplomatic agenda until the Great War.

right, a regional power par excellence and the pillar of the U.S. strategy in Eastern Mediterranean, the Middle East and Central Asia. [Yes, Turkey is a satellite of the British-Israeli-U.S. Axis. Geographically, it is part of the old homeland of Khazaria; though demographically it is, today, dominated by followers of Islam—the enemies of the Khazarians.] Its population will exceed that of Russia thirty years from now if today's demographic trends continue. Its influence is on the rise in its old holdings in the Balkans as well as throughout the former Soviet Central Asia. Turkey is aggressively pursuing its European Union candidacy, while resisting even feeble Western demands to make concessions on Cyprus—invaded in 1974 and partly occupied by 35,000 Turkish soldiers ever since or to end its brutal war against the Kurds in the eastern part of the country. In Cyprus, Turkey has flooded the occupied northern part of the island with settlers from the mainland, whose numbers (about 100,000) exceed the number of native Turkish Cypriots. [Turkey's posture regarding its occupation of Cyprus is remarkably similar in style to the Israeli occupation of lands taken and occupied—including the settlement of civilians within the conquered territory.]

The U.S. policy in the region has been consistently Turkophile for decades. The war in Kurdistan has been going on for almost three decades, and has claimed some 30,000 mostly civilian lives, but Turkey's status as a implicit assumption in Washington is that Turkey will remain "secular" and "pro-Western" [pro-Khazarian], and it behooves us to examine the validity of those assumptions. The lack of a coherent "Turkish" strategy in Washington was apparent in June 1997, when the Turkish Army forced the resignation of Necmettin Erbakan, the country's democratically elected Prime Minister. This was hailed by the Clinton Administration as a welcome event, a defeat for "Islamic fundamentalists" of Erbakan's Refah party and the victory for the "pro-Western" camp led by the Army and supported by some "secular" parties. In established democracies the Army does not Today's Turkey is back as a major player in its own replace elected governments, of course, but the propriety of political acts is judged in Washington on the basis of the desirability of their outcome, not on any lofty principle. [Whatever serves the interests of the Khazarians is MADE to be alright.] To this day, the Turkish Army is regarded by the U.S. foreign-policy establishment as the reliable guarantor of Ankara's permanently "pro-Western" secular orientation. This is because Turkey is a polity based on an Islamic ethos, regardless of its political superstructure. Turkey inherited this Islamic legacy from the Ottoman Empire. With the establishment of the Turkish nation state in 1923 by Mustafa Kemal "Ataturk" (the Father of the Nation), the Kemalist Project introduced a secular concept of nationhood, but the establishment of the multi-party political system in 1945 gave political Islam an opportunity to reassert three decades have produced a "Turkish-Islamic synthesis"—an Islamic concept of nationhood that has Ottoman roots and seeks to re-establish an Ottoman-Islamic concept of Turkish nationhood. Inseparable from internal repression is Ankara's external expansionism as a means of lessening political tensions. Its policy towards Greece has entailed military threats in pursuit of territorial revisionism. The status of the Aegean Sea was supposedly settled decades ago. Since 1974, however, and especially over the last eight years, Turkey has demanding that this status quo be revised. In January 1996 Greece and Turkey came close to war when Ankara disputed Greek sovereign rights over the Greek islet of Imia. But with or without EU membership, Turkish society will soon face a profound crisis. The Europeans are increasingly aware of this. Eric Rouleau, the former French Ambassador to Turkey who is recognized as one of the most authoritative analysts of Middle Eastern affairs in Europe, wrote an article in 1995 entitled "Turkey: Beyond Ataturk". Rouleau, who is personally deeply sympathetic to Turkey, says that "sickness is eating away the (Turkish) Republic. More than seventy years after its establishment by Kemal Ataturk, the Republic is in desperate need of an overhaul." He sees the Kurdish conflict as a key factor contributing to the remarkable revival of Islam in Turkey.

The academic and foreign-policy establishment in the United States has not faced these issues fairly and squarely so far. And yet, with each passing year it is becoming more urgent for the U.S. Government to break away from its unthinking Turkophilia that is detrimental to American interests and reputation. CLINTON'S SUMMIT HOPES FALL SHORT

WASHINGTON (UPI)—Up to the last minute, President Bill Clinton appeared to hope against hope that his first superpower presidential summit meeting with Vladimir Putin would start a new era. But the President of the United States flew home via Ukraine this week knowing all too well he was writing the end of an old chapter, not the beginning of a new one, in U.S.-Russian relations.

Clinton, ever the consummate performer, won polite applause from the Russian State Duma when he became the first American President in history to address it Monday. ["Polite applause" is a somewhat different appraisal of the facts than that which we presented in last week's issue of CONTACT: Clinton was heckled and ridiculed throughout his poorly attended presentation by Zhirinovsky. "Polite applause"? Come again?] But for a leader often accused by his critics of being too optimistic in his rhetoric, Clinton did not appear to make the mistake of thinking he was creating the foundation for a lasting alliance or friendship with his visit. He urged Russia and America to work "on the same side of history". But he acknowledged that "it is not guaranteed that we will be allies".

Two years ago, Clinton might well have spoken in optimistic terms about the possibility of a growing Russian-American alliance.

But that would have been before the Russian stock market collapsed in August 1998. It would have been before former Russian President Boris Yeltsin sacked his veteran Prime Minister Viktor Chernormyrdin—Vice President Al Gore's carefully cultivated friend—for the second and last time.

It would have been before the quiet, undemonstrative and tough Putin was plucked from relative obscurity to become Prime Minister last August and before Putin waged a ruthless, no-holds-barred war to crush secessionist terrorists and rebels in Chechnya over the winter, no matter what the cost in casualties. [Yes, and it would have been before Putin was given the Russian equivalent of the "nuclear football", ahead of schedule, as a clear statement to NATO to "back off, or else".]

Clinton had hoped to leave office with a Russia restored to stability seeking closer ties with Washington and eagerly seeking to reach new strategic nuclear-arms pacts with the United States.

But Putin has confounded these expectations. Under him, Russia, indeed, is finally returning to some degree of economic stability after a nightmarish decade of collapse and impoverishment. But he is charting an independent path from Washington, especially on strategic nuclear issues.

The Russians still have vivid nightmarish memories of how the burdens of trying to keep up with U.S. hightech anti-ballistic weapons programs pushed by President Ronald Reagan contributed to their economic collapse under Soviet President Mikhail Gorbachev. ["When you are at the pinnacle of strength, feign weakness" can be a very effective strategy. Is it possible that Yeltsin played the clown—while the White Russians pulled things together behind the scenes? According to some Russian officials, Putin believes that Yeltsin repeatedly made disastrous economic decisions based on the unwise blanket application of free-market principles that resulted in enormous economic suffering for scores of millions of ordinary Russians. And that Yeltsin made these mistakes mainly out of his desire to please Clinton and his top policy advisers. [It is peculiar, then, that BILLIONS of dollars have flowed from the Khazarian Axis into Russia—with no intention of repayment, ever.]

Putin, while no ideological communist, is not an ideological free marketer either, some of these Russian sources said. He wants to see a practical free-market system that actually works and functions efficiently in Russia, and he does not care if it meets with the disapproval of U.S. Government or Harvard University free-market theorists.

Thus, Putin was happy to play the gracious host to Clinton in Moscow and to seek good relations with him. But he did not share Clinton's driving desire to establish some new nuclear-arms reduction deal as a lasting legacy. His priorities were very different [and might have had something to do with preparing for WAR].

Clinton realized that. Much of his Duma speech was surprisingly defensive in tone. He felt the need to reassure the Russian people that "the United States wants a strong Russia". He knew only too well that many millions of Russians really believe America pushed disastrous free-market crash privatization policies on Yeltsin in order to weaken their country, not to strengthen it.

After seven and a half years in the White House, he now faces the very real prospect of leaving office with only the tattered remnants of a superpower relationship with the new ruler in the Kremlin. The President's top negotiators with Russia, National Security Adviser Samuel "Sandy" Berger and Deputy Secretary of State Strobe Talbott, had labored hard on visits to Moscow to prepare the ground for this weekend's summit meeting, the first Clinton has had with the cautious, shrewd and sphinx-like Putin since he succeeded Yeltsin as President at the end of December.

The President badly wanted to forge an agreement with Putin to push ahead for a START-3 Strategic Arms Reduction Treaty. He and his advisers realized there was no way major progress could be made rapidly on the center of their agenda, believing Putin would far prefer to deal with them, than gamble having to negotiate with a far tougher Republican President George W. Bush in case he should defeat Gore in November.

But, once again, Putin and his advisers confounded the Clinton Administration.

They had made very clear in advance they would not give Clinton the negotiating room he sought to reinterpret the 1972 Anti-Ballistic Missile Treaty to allow a very limited Alaska-based interceptor defense force to be set up to protect the continental United States from nuclear missiles launched by rogue states. And in the Moscow talks, they stuck firmly to that position.

Ever since Secretary of State Madeleine Albright became the first senior U.S. official to visit Putin in Moscow after he became President at the beginning of February, there has been a steady drumbeat of leaks from top Clinton Administration officials saying that they believed they were making progress in convincing the Russians to allow them to amend the 1972 ABM Treaty.

But finally, this weekend, Clinton Administration officials stopped playing that old tune.

Curiously, it was the usually dour Putin who appeared far more relaxed than the usually outgoing and effusive American President. This may have been because Putin got what he wanted from the summit much more easily than the U.S. leader did.

Russia's economy has been surging in recent months thanks to the benefits of the massive August 1998 ruble devaluation and the more than doubling of global oil prices over the past year and a half. It is still in terrible shape. But Putin has at least been able to preside over a very real improvement in living standards. He is the first Russian leader in a quarter of a century who has been able to say that at all. And for all its bloody casualties and ongoing outbreaks, he is still riding high from having fought the war in Chechnya.

Putin is in the very early, "honeymoon" days of his presidency. He was able to host the President of the Untied States and to stand up to him and defy him on key issues [like Khazarian control of the planet], but without histrionics or ugly exchanges. He was not seeking major negotiating concessions from Clinton and, therefore, was not disappointed when he did not get them.

The summit established him as master in his own In a striking contrast to the bold, optimistic rhetoric house, able to greet and host the President of the United States with dignity while maintaining his own independent position.

For Clinton, the summit was certainly no humiliation

or fiasco. [Ha!] But it was a far cry from the kind of closing visit he had long hoped to make it. Most of his ambitions for the U.S.-Russian relationship have collapsed or been derailed. He has no likely prospect of winning Russian agreement to reinterpret the 1972 ABM Treaty or to make progress toward a START-3 treaty as he had hoped. And he has lost any hopes he had of presenting himself and Gore as the sound, statesmanlike protectors of good relations with Russia while painting their Republican challenger, Texas Gov. George W. Bush, in alarming terms.

Clinton will continue to try and maintain good relations with Russia. He has pledged to support Russia's bid to join the World Trade Organization. He maintained his strategic nuclear dialogue with Russia.

ISRAEL'S TRAUMATIC RETREAT

Most countries don't take their myths to heart. Not Israel. Israelis have always believed their myths, shaping their lives and destinies around them, until discarding them for new ones.

That's the way the young country forged an identity more than half a century ago for a disparate people drawn together in a Sun-baked, crisis-plagued land.

They believed they had to be tougher than their Arab neighbors, so they built an awesome military machine. They believed they had no choice but to fight to exist, so military service was mandatory, universal and exalted. They believed their battles were truly matters of life and death, so they never shrank from them.

These myths began to unravel 18 years ago when Israel sent its soldiers plunging across Lebanon's borders, and they continued to unravel every year the troops remained there. Now with the abrupt retreat last week of Israeli soldiers from South Lebanon, followed by thousands from their puppet army, Israelis suffered one of the most traumatic experiences they have ever faced. Some Israelis said the sight of their soldiers and Lebanese allies fleeing across the border back into Israel, chased by fighters from the Hezbollah, or Party of God, was reminiscent of the Americans' last-minute escape from the rooftop of the U.S. Embassy in Saigon in 1975.

"We too learned that there are no happy withdrawals, no free withdrawals. The scent of humiliation permeates the air," columnist Hemi Shalev wrote in Ma'ariv, a popular Israeli newspaper.

The Vietnam analogy, however, doesn't really fit in this case.

America's defeat in Vietnam cannot be compared to the psychic damage to security-obsessed Israelis' belief that their military, whatever it faces, will somehow prevail. Americans have always been able to turn their backs on their overseas defeats and try to blot out bad memories. Israelis, who often feel as if they are dancing on their graves, do not have that luxury.

Indeed, for some time the Israelis have enforced a calm in the Middle East by convincing the Palestinians and their Arab neighbors that a military option was out of the question. The Israeli Army was unbeatable; so, for Arabs, peace was the only solution.

But the Israelis, exhausted by an unending drip of casualties in southern Lebanon, retreated at the hands of a guerrilla force. That has never happened before, and Israelis cannot help but take notice.

"For the first time in Israeli military history, we have been defeated by an enemy engaged in psychological warfare, including a sophisticated use of the Israeli media. Apparently, Israel's endurance is at a new low, although there will be additional tests of our stamina further down the road," wrote Ze'ev Schiff, Israel's leading military commentator in the daily newspaper Ha'aretz.

The toll for Israel's self-image began with its June 1982 all-out invasion of Lebanon. The Government justified its assault as retaliation for an attack on its

"I hope that I will find a forum to talk to the ambassador in London by Palestinians and for shelling Americans so that I can brainwash them for their own by Palestinian Liberation Organization fighters across the zone for the Israelis. They repeatedly tangled with the Lebanon border into northern Israel.

Clearly, however, some Israeli leaders were looking bring Globalism to the world and secure it for for a chance to push the PLO back from Lebanon's southern borders, and possibly to cripple it.

> They got that chance as Israeli soldiers easily crushed the PLO and raced toward Beirut. But the assault was fiercer than many Israelis had expected, and the devastation across Lebanon was stunning. The death and injury toll among Palestinians and Lebanese ran in hold in the mountainous strip where more than 100,000 the thousands.

At first, the Israelis said their troops would clear a 25-mile strip along the Lebanese border, thereby ensuring security for northern Israel. But the Army, urged on by Defense Minister Ariel Sharon, pressed on to Beirut, where it soon placed the city under a choking

Never before had an Israeli Army held a major Arab city captive. Never before had Israel's forces, famous for their lightning-short military campaigns, become bogged down in a grueling land war that seemed likely to drag on. To expel the Palestinians from Beirut, the Israelis resorted to continuous bombing of the city.

The blow-back from the fighting was terrific at home and around the world. [And when the Israelis, for nearly two decades, stood in defiance of UN resolutions calling for their withdrawal—did the British and Americans bomb their cities to force them to relent? Dumb question.]

Israeli officers and soldiers stepped forward, declaring that they would not take part in battles where civilian lives were at stake. [And here we see that even in Israel—Khazarian tactics are not the will of the people.] A small, but loud protest movement grew among the soldiers' ranks, a divisive precedent for Israelis who had rarely challenged their military leaders.

World pressure led the Israelis to halt their relentless bombing of Beirut, the Israeli peace movement gained support and average Israelis wondered what had become of their nation's honor. The PLO agreed to evacuate its fighters to Tunisia, but within days of their departure, a horrible slaughter took place.

Bent on revenge from years of religious warfare, Lebanese Christian militia slipped into two Beirut refugee camps, Sabra and Shatila, which had been under the Israelis' control and massacred hundreds of Palestinian civilians. An Israeli commission that investigated Israel's role in the slaughter pointed its fingers at a number of highranking military and government officials, citing their failure to prevent the bloodbath. [And there is your answer.]

When the Israelis arrived in southern Lebanon, some Arabs had welcomed them, thinking they had thrown off the burden created by the Palestinians who had set up their own state within Lebanon. The Israelis did that. But their occupation quickly became a target of hate for the Lebanese. The Iranian-backed Hezbollah found increasing support for its anti-Israeli resistance.

By 1985 Israel, exhausted by the suicide bombings and guerrilla warfare, withdrew from Lebanon, unable to reach a peace treaty with the Lebanese. Several hundred Israelis lost their lives over the three years. But the Israelis set up their own so-called security zone near their border, and worked hand in hand with their proxy militia, the Christian-led South Lebanon Army.

In no time the security zone became an insecurity guerrilla fighters in southern Lebanon, inflicting damage upon the communities where the fighters were based. At times, thousands of Lebanese fled toward Beirut to escape the fighting.

As hostilities lingered, Syria had an excuse to keep its troops in Lebanon and the Lebanese under its military

UN SANCTIONS "ARE KILLING IRAQ'S CHILDREN"

Deaths among babies and children in Iraq have more than doubled in the past 10 years because of the deprivation and malnutrition caused by UN sanctions, according to reports in the Lancet medical journal published yesterday.

These soaring child-mortality rates will present the defenders of sanctions with a difficult case to answer, and an editorial in the journal spells out a dire warning. "The courageous policy is to suspend [not abandon] sanctions, lest upcoming generations of Iraqis, out of resentment, suffering and isolation, grow up to be as aggressive as their current leader," it says.

The study, carried out by Mohammed M. Ali from the London School of Hygiene and Tropical Medicine and Iqbal Shah from the World Health Organisation, provides the first accurate data on child mortality in Iraq since 1991. The fieldwork was carried out by the United Nations children's organisation UNICEF, with the

permission of the Iraqi Government.

The researchers compared the death rates among babies and children under five years old in the autonomous (northern Kurdish) region with those in the rest of the country. They found a marked difference between the Kurdish area, which is benefiting from the oil-for-food programme, and the rest of Iraq, which is not.

improved; between 1994 and 1999, infant mortality declined from 64 to 59 per 1,000 live births and the under-five mortality ratio fell from 80 to 72 per 1,000.

In the rest of Iraq, child mortality more than doubled during the sanctions period, rising from 47 per 1,000 live births during 1984-89 to 108 per 1,000 in 1994-99; under-five mortality rose from 56 to 131 per 1,000.

The reports point to many critical factors undermining the health of the Iraqi populationparticularly for those who live in rural areas.

Hospitals and health clinics have had little or no maintenance since 1991 and their work has been hampered by shortages of power and water. [This is "thanks" in large part to the "surgical", laser-guided bombing of water-treatment facilities.]

Before sanctions, 90% of urban families and 70% of those in rural areas had access to safe water supplies. Now, that can be said of only half those living in towns and a third of those in the countryside.

Dr. Ali said yesterday that he and his fellow researcher were not trying to draw conclusions from their work. "We have showed that the increase in child mortality coincides with the start of sanctions," he said.

Since sanctions were imposed, there has also been an increase in malnutrition for mothers and babies—from 3% to 11% of the population—and a rise in endemic diseases such as measles and diarrhoeal diseases. Malaria, eradicated from Iraq in the 1970s, has returned.

Children of educated women traditionally fare better than those from illiterate families—but literacy is not helping in Iraq. "Clearly, education of the mother, suggested to be a determinant of infant-child mortality, has a limited effect in deteriorating socio-economic and health conditions, as seen in the south [and] centre of Iraq," write the authors.

Peter Kandela, a doctor who has just returned from the country, writes of what he calls the tragedy of Iraq in another Lancet article.

"Children who should be at school are scouring rubbish heaps and keeping cool in cesspits, and when they get ill, there will be no treatment for them," he writes. "These are the next generation; and who will blame those who survive to adulthood if they react with bitterness and fury against those they deem responsible?"

Two surveys were carried out for the study on child mortality and maternal mortality, the second of which is yet to be published. Between February and March 1999, researchers interviewed 23,105 married women aged 15-49 living in the centre and south of Iraq. Between April and May, 14,035 married women of the same age were interviewed in the autonomous Kurdish region.

One paper notes that Iraq had "spectacular social and economic development" between 1970 and 1990, followed by dramatic decline in the past 10 years. All progress stopped with the start of the Gulf War, the report says. [This "Mother of All Battles" is far from finished.]

Although a UN member since 1949, Israel has been the only country to be excluded from a regional grouping since the groups were first established in the 1960s. Its exclusion has prevented Israel from having representatives nominated to key UN bodies, including the Security Council.

Israel's Foreign Ministry said in a statement Friday that Foreign Minister David Levy had thanked WEOG members in a letter for their efforts to add Israel to the group.

"Adding Israel to WEOG," he said, was a step towards "repairing the fundamental distortion that has existed for four decades."

He said the move was a "sign of the turnabout and new relations toward normalizing the standing of Israel in the organization of the United Nations".

In addition to being excluded from a regional group, Israel has also been condemned by the UN more than any other nation, often with only the U.S. standing by its side.

U.S. Ambassador to the UN, Richard Holbrooke, called the move an "historic step forward in the elimination of a huge injustice". [We suppose that the referenced "injustice" is Israel's longstanding, flagrant violation of UN resolutions.]

FRANCE WELCOMES GERMAN PLAN FOR FEDERATION OF NATION STATES

> However, French public support for deeper integration was shown by an opinion poll yesterday in which 59 percent said they wanted France to support the Fischer plan. Only 33 percent were opposed.

> Addressing EU financiers and politicians, Mr. Fabius said France would use its six-month presidency to extend the powers of the "Euro-11" committee of finance ministers from the single-currency zone. Created on French instigation and fiercely resisted by Britain, France wants the Euro-11 to become the effective "economic government" of the euro zone, balancing the powers of the European Central Bank.

> Mr. Fabius, who served as Prime Minister under President Mitterrand in the early 1980s, said the singlecurrency group—soon to enlarge to 12 with Greece's adoption of the euro-was an example of the type of inner circle that Herr Fischer was calling for to lead the EU towards federation.

U.S., UK DENY PLAN TO "OVERTHROW" KENYAN GOVERNMENT

NAIROBI, KENYA—The United States and British governments have denied claims that they are sponsoring an elitist opposition group to topple the Government of Kenyan President Daniel Moi. [And Khazarian denial means what? That's right, confirmation.]

The allegations were made by The People, the thirdlargest daily newspaper in this East African nation, a former colony of Great Britain.

Addressing the country's 37th Independence Day celebrations, Moi Thursday confirmed that his Government had launched serious investigations into the claims.

U.S. Embassy spokesman Chris Scharf denied the claim, saying while embassy staff were in contact with all major political forces and elements in the country, it did not support any single figure or party. "Neither are we searching for one," he added.

Tories are calling on the Prime Minister to guarantee that a new European Union charter will not become legally binding on Britain.

The Charter of Fundamental Rights, which EU leaders are expected to approve in December, sets out a wide range of rights to which all EU citizens are entitled.

But critics fear that other European states will seek to have its provisions incorporated into EU law, making it binding on British courts.

The draft includes workers' rights as well as bans on capital punishment, cloning of human beings and the sale of human body parts.

In a letter to Tony Blair, shadow Foreign Secretary Francis Maude warns that there is "a great danger that the charter will become a blueprint constitution for a single European superstate".

He asks: "Can you give me a clear and unequivocal guarantee that your government will not allow such a charter to form part of the next European treaty, even as an annex, and would prevent it becoming enshrined in British law?"

Mr. Maude said: "I have received legal opinion that the charter will give the European Court of Justice wide scope to re-interpret many of the rules and directives already negotiated.

PLAN TO CREATE MORE NATIONAL **MONUMENTS CALLED "INSULTING"**

President Bill Clinton is considering a request from Interior Secretary Bruce Babbitt to declare an estimated half-million acres of federal land spread over four western states as national monuments.

If Clinton approves the recommendation—made under the American Antiquities Act of 1906—the states affected would be Washington, Colorado, Arizona and Oregon.

The Antiquities Act allows the president the authority, "in his discretion, to declare by public proclamation" lands owned or controlled by the federal Government as national monuments. The Government then protects that land, according to Babbitt.

Washington is slated to receive the greatest "protection" benefits; about 200,000 acres of lands located along the Columbia River would be renamed the Hanford Reach National Monument, if the measure is approved. That property is currently used as a buffer for the Department of Energy Hanford Nuclear Reservation, Babbitt said in a released statement.

Under a 1940s agreement, however, that estimated Other rights included are: to join a union; to strike; 51 mile parcel of land was supposed to be returned to "the local people" once the environmental issues were resolved, according to a spokesman for Representative Doc Hastings (R-WA). Babbitt said the parcel either had been or was currently "being cleaned up to meet EPA and state requirements", but was now deemed a "priceless natural landscape" and needed federal protection.

"These are priceless natural landscapes that have somehow remained almost untouched by exploitation, development and urban sprawl," Babbitt said. "But we are losing open spaces every day... We may not have another chance before they are lost."

NO MORE ANTHRAX SHOTS, CONGRESS TELLS DEFENSE DEPARTMENT

Bipartisan members of the House call on Defense Secretary Cohen to halt the controversial anthraxvaccination policy.

In the continuing war over the Defense Department's controversial anthrax-vaccination policy, bipartisan members of the House have called on Defense Secretary William Cohen to immediately stop the program, pending scientific studies.

Reps. Jack Metcalf of Washington, Dan Burton of Indiana, John Conyers of Michigan, Christopher Shays of Connecticut and Bob Filner of California sent a caustic letter on May 31 to Cohen in response to a disrespectful letter from a DoD official who had dismissed the lawmakers' concerns.

"You must no longer dismiss the preponderance of evidence which demonstrates significant problems with the current vaccine, and its impact on morale, retention and recruitment. Mr. Secretary, please personally respond to our letter dated May 16, 2000, fully and fairly addressing the facts presented. Our service members deserve a better vaccine and a better vaccination program."

The latest salvo come on the heels of a May 16 response from Acting Undersecretary of Defense Charles L. Cragin, who was replying to a letter signed by more than 35 members of Congress raising concerns over DoD's anthrax vaccination program. Cragin dismissed the lawmakers' concerns and sought to dissect various studies used by the congressional leaders to shed positive light on DoD's program.

In their May 31 letter, however, the five congressmen fought back and attached a strongly worded letter from Mohammad N. Akhter, the Executive Director of the American Public Health Association or APHA, in which his group urged DoD to suspend the anthrax shots pending further medical evaluations "or at

Hastings, who accused the Senator of insulting the public-health experts reviews the evidence for the safety and effectiveness of this vaccine".

> DoD has refused to pull back from Cohen's decision a year or so ago requiring all service personnel to be vaccinated, even though the General Accounting Office, among many other agencies, has cast doubt on the vaccination itself—let alone the policies behind the program—given the controversy surrounding the manufacturing plant that produces the product. Even the Food and Drug Administration has had problems with the facility and suspended its license to make the drug.

ISLAND STRATEGY: WHY FIJI MAY MATTER

Summary

Last month a political crisis erupted in Fiji. Last week, another exploded in the Solomon Islands. So far, the world has largely shrugged. After all, these are isolated islands in a region that has become a bit of a strategic backwater. But taken together with the steady crumbling of Indonesia, instability on these islands can allow an outside power to gain a strategic advantage. [And let's just mention the troubles in the Philippines right here and now. It is obvious that there is a concerted assault going on, with the intention of destabilization, which would provide the "excuse" necessary to send in a "peacekeeping force".] Why? To keep the U.S. Navy out of Asia.

attempted coup, followed by the seizure of political hostages and a confrontation that continues. Last week, a political crisis exploded in the Solomon Islands. Both cases involve complex internal political, economic and ethnic issues that, in general, are of great interest to the citizenry but not of particular interest to the outside world.

It is therefore startling to step back and realize that with these two crises, a virtually unbroken belt of instability now stretches from the Straits of Malacca in western Indonesia to the south central Pacific. It is easy to dismiss this as an interesting coincidence. And it may well be that purely local forces exploded simultaneously. So far, the world has largely ignored the events in the Pacific. No calls for international intervention have gone up. The Government in Australia, which has sought a larger role in the region, has in effect shrugged. Alone each of these events means little. But taken as a whole, they could threaten commercial shipping—and naval traffic. If, in the course of a few years, hostile forces emerge in control of these islands and portions of Indonesia, the world will find every reason to care.

At one level, there is both a common element and a unambiguous: Back off!]

Brutal fighting from Guadalcanal to Tinian revolved around the use of these islands as unsinkable, if immobile aircraft carriers....

...Guadalcanal prevented them from moving east [JR: Since no one can prevail upon Cohen to through Polynesia. And so the line of supply stretching from Pearl Harbor to Australia was never cut by Japanese air power. The United States could project power to Australia, blocking any plan to invade Australia, and allowing American forces to begin rolling back the Japanese in the Solomon Islands and New Guinea.

> More than a half-century later, the U.S. Navy still enjoys unchallenged access to and through all of these routes, the most important of which are the sea-lanes through the Indonesian archipelago. Through here pass the U.S. carrier battlegroups on their way to the Indian Ocean and the Persian Gulf. Choking these off would cripple Washington's modern-day ability to project power. This is not as unthinkable as it might seem. Every day, Indonesia crumbles literally one island at a time.

> But what power would be in a position to benefit from this situation? There is but one: China. The Government in Beijing is clearly intent on becoming the dominant East Asian power; it has an interest in keeping U.S. forces at bay and it has the means to take advantage. So long as American fleets lurk just over the horizon, China will fail in its ability to redraw a new regional order.

Consider the problem from the Chinese viewpoint. Last month, a political crisis erupted in Fiji: an The presence of U.S. naval power near—and sometimes just off—the mainland coast makes it difficult for Beijing to control coastal political interests that are naturally inclined to be more oriented toward the outside world than inland China. Today, coastal entrepreneurs have the navy of their foreign financial partners reassuringly over the horizon. The Government is acutely aware that the U.S. 7th Fleet affects both the regional balance of power and the domestic psychological fabric. The fact that Beijing cannot solve its Taiwan dilemma is testimony to this fact.

> For now and the foreseeable future, Beijing has few conventional military levers at its disposal. A blue-water navy capable of challenging the U.S. Navy could be generations away; it certainly won't put to sea in the lifetime of China's current leadership. There is no powerful navy in the world with which the Chinese can allv....
