UTAH MAN CHARGED FOR CASHING IN FAKE \$100-M BONDS

NEWARK, NEW JERSEY (AP)—US authorities What happens to the children of the liaisons? I the truth and scatter on that wealth, you are shot down charged an auto mechanic with trying to cash a bogus \$100-million Federal Reserve bearer bond allegedly issued in 1934.

> Kevin Jackson, 49, of Hyde Park, Utah, was them far better. Some of these people can turn the charged on Friday. He was arrested June 22 and is free on \$10,000 bond pending arraignment on two counts of mail fraud and one each of conspiracy and transporting a counterfeit security across state lines. Each count carries a prison term of up to five years and a \$250,000 fine.

> > In court papers filed after his arrest, Jackson claimed he got the bond through an intermediary of an unnamed Filipino general. Jackson claimed that notes with values up to \$100 million were produced before World War II and were issued to European nations to help their economies.

> > He further claimed that some of the bonds fell into the hands of the Japanese during the war and eventually ended up with the late dictator Ferdinand

> > The court documents, filed by Jackson's public defender K. Anthony Thomas, claim Filipino military generals got hold of the bonds after the dictator's death

> > Prosecutors said the Federal Reserve never issued any note in a denomination greater than \$1 million. The central bank could not immediately verify that claim Friday evening, said spokesman Dave Skidmore.

Jackson could not be reached for comment at his home or workplace, the Mechanic Shop in Smithfield, Utah. Messages left at both locations were not immediately returned Friday.

Thomas said he had not yet seen the indictment and declined to comment.

Assistant U.S. Attorney Patrick Rocco, who is prosecuting the case, said he could not comment on whether others would be charged, but said the investigation is continuing.

The case came to light when banking officials became suspicious after Jackson tried to deposit the bond in several financial establishments and to have funds transferred elsewhere or to take cash.

In court papers seeking to dismiss the complaint, Jackson's lawyer argued that the government denies the notes exist because, "If these notes were redeemed, the American economy would devastatingly suffer."

Note: The title "House of Windsor" was adopted by King George V in 1917. The "Windsors" are in reality of the House of Guelph, one of the Venetian Black Nobility's oldest dynasties. Queen Victoria's lineage is traced directly back to the Guelphs.

Members of the Committee of 300 are sometimes coopted from the hierarchy of the United Nations, but it has only occurred on two occasions.

Members are sometimes drawn for a particular period from MI-6, and are always drawn from the Anglican Church. Archbishop Runcie was handpicked by Queen Elizabeth.

An interesting connection between Japan and the Committee of 300 is found in the intervention of King Frederik IX of Denmark, backed up by King Haakon of Norway; King George VI of England, Queen Wilhelmina of the Netherlands and Grand Duchess Charlotte of Luxembourg, who "requested that Emperor Hirohito not be arrested or tried as a war criminal". But it was the power of the Order of the Garter which saved Emperor Hirohito from most probably being executed as a war criminal. Queen Elizabeth II had maintained a close relationship with the late Emperor Hirohito (formerly Crown Prince Akihito), and still does with his family. Other than that, it does not appear that the Committee of 300 exercises much influence in Japanese affairs.

Every "royal" and so-called European "noble" dynasties past and present, have seats on the Committee of 300, most often by way of nominees. For instance, the Hohenzollern dynasty might be represented by Edward the Duke of Kent; the Braganzas by the Duke of York, and so on. There are

just too many of these "royal" families for them all to have direct seats on the Committee of 300, and that means also, too many names to be individually mentioned here. But the thing to remember is the order of rank; first the royal family members, then dukes, earls, marquises and lords, then finally the "commoners", who usually get the title of "Sir".

BCCI: The bank was indicted on scores of charges of being heavily involved in drug-money laundering throughout the world. Its structure grids every operation of the Committee of 300. Of interest is its corporate structure:

BCCI Middle East Interests consist of 35 percent of stock held by the ruling families of:

Bahrain Sharjah Dubai Saudi Arabia

and a group of Middle East businessmen.

BCCI Cayman Islands 41 percent. Bank of America 24 percent.

BCCI Cayman Islands, and BCCI Luxembourg, established agency offices in Miami, Boca Raton, Tampa, New York, San Francisco and Los Angeles.

BCCI, U.S.A.:

In 1992, the directors of BCCI were found guilty of massive fraud, but the principals had already fled the United States by the time indictments were handed down. Two of the principals who helped establish the bank in the United States were Clark Clifford, a famous Washington lawyer and "insider", and his assistant, Robert Altman. After a lengthy trial, Altman was found not guilty on a technicality, or a series of technicalities. Clifford was "excused" from having to stand trial, on the grounds of ill health. Nothing that has happened in recent years, with perhaps the exception of the kidnaping and imprisonment of General Noriega, has so perverted the justice system of the United States, as have the cases of Clifford and Altman.

It is very interesting that the BCCI was brought to the United States by the Stephens family of Arkansas, a family that controls the biggest banking system outside of the New York banking network. "King" Stephens reportedly gave then-presidential candidate Clinton, \$2 million toward his election campaign. The money was said to have come from BCCI. The Saudi government concluded a settlement with the United States, in terms of which they will pay \$250 million against claims of \$300 million. This was concluded on December 27, 1993. The two Saudis who are said to have removed cash from BCCI accounts will not be prosecuted.

Planning Research Corporation

Part of approximately 350 firms that conduct research, surveys, and make recommendations to the government. They are part of what President Eisenhower called "a possible danger to public policy that could itself become captive of a scientific-technological elite".

Brookings Institution

Dedicates its work to what it calls a "national agenda". Wrote President Hoover's program, President Roosevelt's "New Deal", the Kennedy Administration's "New Frontiers" program (deviation from it cost John F. Kennedy his life), wrote President Johnson's "Great Society". Although Brookings wrote the programs, they were, in every detail, simply lifted from Fabian Socialist papers drawn up in England. In some instances, Brookings did not even bother to change the titles of the Fabian Society papers. One such instance was using "Great Society", which was taken directly from a Fabian Socialist paper of the same title.

Brookings has been telling the United States government how to conduct its affairs for the past 70 years and is still doing it on behalf of the Committee of 300.

Hudson Institute

Under the direction of Herman Khan, this institution has done more to shape the way Americans react to political and social events, think, vote, and generally conduct themselves than perhaps any except the BIG FIVE. Hudson specializes in defense policy research, and relations with Russia. Most of its military work is classified as SECRET. (One of its ideas was to build a moat around Saigon during the Vietnam War.)

Some of its earlier papers were entitled: "Stability and Tranquility Among Older Nations" and "Analytical Summary of U.S. National Security Policy Issues".

Hudson prides itself on its diversity; it helped NASA with its space programs and helped to promote new youth fashions and ideas, youth rebellion and alienation, for the Committee of 300 which was ostensibly funded by Coca Cola. Hudson may be quite properly classified as one of the Committee of 300's BRAINWASHING establishments. Some of its nuclear war scenarios make for very interesting reading, and if they can be obtained, I would recommend "The 6 Basic Thermonuclear Threats" and "Possible Outcomes of Thermonuclear War", and one of its more frightening papers entitled "Israeli-Arab Nuclear War".

Hudson also does corporate advising for Committee of Department of Justice.

300 companies, Rank, Xerox, General Electric, IBM and General Motors, to name but a few of them, but its really big clients remain the U.S. Department of Defense which includes matters of civil defense, national security, military policy, and arms control. To date it has not gotten into "wet" NASA, that is to say the National Oceanographic Agency.

National Training Laboratories

NTL is also known as the International Institute for Applied Behavioral Sciences. This institute is definitely a brainwashing center based on Kurt Lewin principles which include so-called T-Groups (training groups), artificial stress training whereby participants suddenly find themselves immersed in defending themselves against vicious accusations. NTL takes in the National Education Association

The National Education Association (NEA) has become the largest teachers union in the country, and its leadership has fought every initiative to improve what passes for education in primary and secondary schools. The National Teachers Association (NTA) is backed by the Carnegie Corporation and the Ford Foundation among others. This enabled it to defeat California's Proposition 174, which called for parents to be allowed to send their children to private schools, and to receive from the state an amount of \$2600 per child to subsidize the cost of private schooling.

NTA poured \$16 million into the drive to defeat Proposition 174, a drive which was backed by the ultrasocialist *San Francisco Chronicle* and its affiliated television stations. The initiative was defeated by a wide margin, but it opened the eyes of many parents as to what kind of teachers are out there. The NTA favored the New World Order's "Outcome Based Education" (OBE) which is an openly brazen attempt to turn American schoolchildren into future Socialists.

While officially decrying "racism" it is interesting to note that NTL, working with NEA, once produced a paper proposing education vouchers which would separate the hard-to-teach children from the brighter ones, and funding would be allocated according to the number of difficult children who would be separated from those who progressed at a normal rate. The proposal was not taken up, because it was held to be racially motivated.

University of Pennsylvania, Wharton School of Finance & Commerce

Founded by Eric Trist, one of the "brains trust" of Tavistock, Wharton has become one the more important Tavistock institutions in the United States, in so far as "behavioral research" is concerned, attracting clients like the U.S. Department of Labor, which it teaches how to produce "cooked" statistics by the Wharton Econometric Forecasting Associates Incorporated. This method is very much in demand as we come to the close of 1993, with millions more out of work than is reflected in U.S. Department of Labor statistics.

Wharton's ECONOMETRIC MODELING is used by every major Committee of 300 company in the United States, Western Europe and by the International Monetary Fund, the United Nations and the World Bank. Wharton has produced such noteworthy political figures as George Shultz and Alan Greenspan.

Institute for Social Research

This is the institute set up by "brains trusters" from Tavistock, Rensis Likert, Darwin Cartwright and Ronald Lippert. Among its studies are "The Human Meaning of Social Change", "Youth in Transition" and "How Americans View Their Mental Health". Among the institute's clients are The Ford Foundation, U.S. Department of Defense, U.S. Postal Service, and the U.S. Department of Justice.

Institute for the Future

This is not a typical Tavistock institution in that it is funded by the Ford Foundation, yet it draws its long-range forecasting methodology from the mother of all think tanks. Institute for the Future projects what it believes are changes that will be taking place in time frames of fifty years. The institute is supposed to be able to forecast socioeconomic trends, and to blow the whistle on any departures from what it has laid down as normal.

Institute for the Future believes it is possible and normal to intervene now and give decisions for the future. So-called "Delphi Panels" decide what is normal and what is not, and prepare position papers to "steer" government in the right direction to head off such groups as "people creating civil disorder". (This could be patriotic groups demanding abolition of graduated taxes, or demanding that their right to bear arms not be infringed.)

The institute recommends actions such as liberalizing abortion laws, drug usage, and that cars entering an urban area pay tolls; it demands that birth control be taught in public schools, require registration of firearms, make the use of drugs a non-criminal offense, legalize homosexuality, pay students for scholastic achievements, make zoning controls a preserve of the state, offer bonuses for family planning, and last, but by no means least, a Pol Pot Cambodia-style proposal that new communities be established in rural areas. As will be observed, many of the Institute for the Future's goals have already been more than fully realized.

Institute for Policy Studies (IPS)

One of the "Big Three", IPS has shaped and reshaped United States policies, both foreign and domestic, since it was founded by James P. Warburg and the Rothschilds in the United States, bolstered by Bertrand Russell and the British Fabian Socialists through their networks in America. These networks included the League for Industrial Democracy, in which Leonard Woodcock played a leading, behind-the-scenes role. Local lead players in the League for Industrial Democracy included "conservative" Jeane Kirkpatrick, Irwin Suall (of the ADL) Eugene Rostow (Arms Control negotiator), Lane Kirkland (Labor leader), and Albert Shanker.

For record purposes only, IPS was incorporated in 1963 by Marcus Raskin and Richard Barnett, both highly-trained Tavistock Institute graduates. Most of the funding came from Rothschild associates in America like the James Warburg Family Foundation, the Stern Family Foundation and the Samuel Rubin Foundation. Samuel Rubin was a registered member of the Communist Party who stole the Faberge name. (Faberge was Jeweler of the Imperial Russian Court) and Rubin made a fortune out of illegally using the Faberge name.

The objectives of IPS came from an agenda laid down for it by the British Round Table, which agenda in turn came from Tavistock Institute, one of the most notable being to create the "New Left" as a grass-roots movement in the U.S. IPS was to engender strife and unrest and spread chaos like a wildfire out of control, proliferate the "ideals" of left-wing nihilistic socialism, support unrestricted use of drugs of all types, and be the "big stick" with which to beat the United States political establishment.

Barnett and Raskin controlled such diverse elements as the Black Panthers, Daniel Ellsberg, National Security Council staff member Morton Halpern, the Weathermen Underground, the Venceramos, and the campaign staff of candidate George McGovern. No scheme was too big for IPS and its controllers to take on and manage.

Take the plot to "kidnap" Kissinger, which was in the hands of Eqbal Ahmed, a British MI-6 intelligence agent of Pakistani origin, laundered through "TROTS" (Trotskyite terrorists based in London). The "plot" was "discovered"

by the FBI before it could go too far. Ahmed went on to become the director of one of IPS's most influential agencies, The Transnational Institute, which chameleon-like changed from its former name, Institute of Race Relations, when intelligence agents of BOSS (Bureau of State Security), South Africa, unmasked the fact that it was tied directly to the Rhodes Scholarship Foundation, Harry Oppenheimer and Anglo American, and British mining interests in South Africa. BOSS also discredited the South Africa Foundation at the same time.

Through its many powerful lobbying groups on Capitol Hill, IPS relentlessly used its "big stick" to beat Congress. IPS has a network of lobbyists all supposedly operating independently—but in actual fact acting cohesively—so that Congressmen are pummeled from all sides by seemingly different and varied lobbyists. In this way, IPS was, and is still, able to successfully sway individual representatives and senators to vote for "the trend, the way things are going". By using key pointmen on Capitol Hill, IPS was able to break into the very infrastructure of our legislative system and undermine and subvert the way it works.

To give only a single concrete example of what I am talking about: In 1975, an IPS pointman persuaded representative John Conyers (D-Michigan) and 47 members of the House to request IPS to prepare a budget study that would oppose the budget being prepared by President Gerald Ford. Although not adopted, the request was reinstated in 1976, 1977 and 1978, gathering sponsors as it went.

Then, in 1978, 56 Congressmen signed their names as sponsors of an IPS budget study prepared by Marcus Raskin. Raskin's budget called for a 50-percent cut in the Defense Budget, a socialist housing program "that would compete with and steadily replace private housing and mortgage markets", a national health service, "radical changes in the educational system that would disrupt capitalist control over the distribution of knowledge", and several other very radical socialist ideas.

The influence of IPS on Arms Control negotiations was a major factor in getting Nixon to sign the treasonous ABM Treaty in 1972, which left the United States virtually defenseless against ICBM attack for almost 10 years. IPS became, and remains to this day, one of the most prestigious "think tanks" controlling foreign policy decisions, which we, the people, foolishly believe are the product of our law makers.

By sponsoring militant activism at home, and with links to revolutionaries abroad; by engineering such victories as "The Pentagon Papers", harrying the corporate structure, IPS was able, to some extent, to bridge the credibility gap between underground movements and acceptable political activism. IPS set its sights on penetrating religious organizations and using them to sow discord in America. Radical racial politics under the guise of religion, were used by the establishment media to spread IPS ideas.

Stanford Research Institute

Jesse Hobson, the first president of Stanford Research Institute (SRI), in a 1952 speech, made it clear what lines the Institute was to follow. SRI can be described as one of the "jewels" in Tavistock's Crown, in view of the key role it has played, and still plays in the United States. Founded in 1946, immediately after the close of WWII, it was presided over by Charles A. Anderson with emphasis on mind-control research and "future sciences". Included under the Stanford umbrella was the Charles F. Kettering Foundation which developed the "Changing Images of Man" upon which the Aquarian Conspiracy rests. What was not generally known was that Stanford did research for the U.S. Office of Education at the Education Policy Center at Stanford,

which also came under Willis Harmon.

Stanford Research Institute is plugged into at least 200 smaller "think tanks", doing research into every facet of life in America. This is known as ARPA networking, and represents the emergence of probably the most farreaching effort to control the environment of every individual in the country. At present, Stanford's computers are linked with 2500 "sister" research consoles, which include the Central Intelligence Agency (CIA), Bell Telephone Laboratories, U.S. Army Intelligence, the Office of Naval Intelligence (ONI), RAND Corporation, MIT, Harvard and UCLA. Stanford plays a key role in that it acts as the "library" for the others, cataloging all ARPA documentation.

"Other agencies, and one can use one's imagination here, are allowed to search through SRI's "library" for key words, anything that would "trigger" interest, such as certain phrases. Other agencies can look through SRI files and update their own master files, using SRI master files. The Pentagon for instance, uses SRI's "master files" extensively, and there is little doubt that other U.S. Government agencies do the same. Pentagon "command-and-control" problems are worked out at SRI.

While ostensibly these files apply only to weapons and soldiers, there is absolutely no guarantee that the same research could not, and will not, be turned to civilian applications. There is every indication that most police departments are linked through SRI computer files. SRI is known to be willing to do anything for anyone. It is my belief that if ever SRI were to be fully audited by the General Accounting Office (GAO)—the hostility which would arise from revelations as to what SRI actually does—an outraged public would most probably force its closure.

Massachusetts Institute of Technology, Alfred P. Sloan School of Management

This major institute is not generally recognized as being a part of Tavistock U.S.A. Most people look upon it as a purely American institution, but that is far from being the case. MIT Alfred Sloan can be roughly divided into the following groups:

It would take hundreds of pages to describe the One of SRI's more secret projects was the extensive activities in which it is engaged, so we can only touch on them in brief in this work. IDA is the "top brass" of military think tanks and also one of the least known, for IDA does not believe in advertising. The huge building it occupies close to the Pentagon, passes for a bank at first sight, and that is because it has a sign on the door that reads, "Suburban National Bank".

> Absolutely everything that IDA does is secret. It has immense influence and power, and few dare to cross its staff of top-ranking scientists who prepare extensive reports in very short periods of time for the handful of top strategists. One of its major tasks is economic studies on a global scale. It works at the highest level with the topechelon military strategists.

> One of the most extraordinary tasks undertaken by IDA was the effect of weather modifications using ELF radio waves to change normal weather to abnormal weather patterns. The NSA became very concerned that weathermodification experiments would have a detrimental effect on the national security of the United States, when used against it by Russia, and what these effects would be. One of IDA's most secret efforts concerned the economic future of China—and it is believed that based upon IDA findings, David Rockefeller journeyed to China to cement a relationship with the Li family that virtually rules China.

> IDA's "Jason Division" reads like something out of "James Bond" and, indeed, resembles the elaborate scientific facilities available to MI-6 for its many covert activities. Just as in MI-6, in Jason we find between 45 and 47 top scientists working on "research problems" of one kind or another. There is no list of "Jasons", but it is known in intelligence circles that the top scientist of the Jason Division is Norman M. Kroll, who at one time was head of the Physics Department at the University of California, San Diego.

> It is said that "the Jasons" spend all of their time together, even their free weekends and summer holidays. No one knows where they go for their summer vacations; they are usually spirited away under very heavy security conditions. What does the Jason Group work on? Apart from projects that are known to no more than five persons carrying CODEWORD classification—it is believed that the group works on only the top defense matters, among which is ballistic missiles, ELF radiation weapons, submarine detection techniques.

Without a doubt RAND is THE think tank most beholden to the Tavistock Institute—and certainly the RIIA's most prestigious vehicle for control of United States policies at every level. Specific RAND policies that became operative include our ICBM program, prime analyses for U.S. foreign policy making, instigation of space programs, U.S. nuclear policies, corporate analyses, hundreds of projects for the military, the Central Intelligence Agency (CIA) experiments in the use of mind-altering drugs like peyote and LSD. (The 20-year covert MK-Ultra operation which lasted for 20 years.)

THE "ENGLISH" JEW BEHIND THE FOUNDATION OF ISRAEL

It has always been assumed by historians and others that it was the pro-Zionist U.S. government at the end of World War Two and earlier that laid the foundations of the State of Israel.

Admittedly the U.S. did play a decisive role in this but research carried out recently in Britain by a Jewish professor has put a very different complexion upon the prelude to the establishment of a Jewish state in Palestine.

As in many fateful—and fatal—policy decisions, the machinations of the British Foreign Office played a decisive role in creating bloody mayhem, betrayal and misery on a monumental scale, not only in Europe but also in the Middle East.

William Rubenstein, professor of modern history at the University of Wales, has unearthed an extraordinary secret from the annals of British Government concerning the origins of one of the most influential members of government during the past century.

"This case is possibly the most remarkable example of concealment of identity in 20th Century British political history," commented Professor Rubenstein in History Today magazine.

leading Conservative politician, close ally and friend of Britain's un-elected wartime leader, Winston Churchill. Amery was the author of the infamous 1917 Balfour Declaration, which promised British government support for the Jewish rape and colonisation of the Palestinian nation.

Amery throughout his life deliberately concealed his Jewish origins and Professor Rubenstein who is himself Jewish, has established the deception beyond any doubt. In his disclosures about Leopold Amery's past, Professor Rubenstein says that Amery misled people about his past in his autobiography, My Political Life which was published just before his death in 1955.

In this book Amery declared that his father, Charles Frederick Amery, came from an old English West Country family. However, according to the historian he sought to conceal his mother's origins. Amery merely wrote that his mother, Elizabeth Leitner Amery was one of a stream of Hungarian exiles who emigrated after the 1848 European revolutionary turmoil, fleeing first to Constantinople (Istanbul) and then to England.

In fact, according to this new research, Amery's mother was born in 1841 to Jewish parents in Pest, which subsequently became part of Budapest. This area of the Hungarian capital was host to the Jewish ghetto and her own mother's name was Elisabeth Johanna Saphir, a common Jewish name in the region.

Professor Rubenstein says that Amery also changed his middle name Moritz to the more Anglicised Maurice in his full name, Leopold Charles Maurice Stennett Amery. He did so to further disguise his Jewish origins.

Amery's mother was of pure Jewish descent says the learned historian and therefore, according to orthodox rabbinical Jewish law and tradition so was her son.

Amery's actions and psychotic anti-German hysteria expressed during both World Wars and the intervening years left no doubt as to where his anti-Christian sympathies lay.

As the Assistant Secretary to England's War Cabinet in 1917 it was the deceitful pretend-Englishman Amery who drafted the now notorious blood-document, the Balfour Declaration, which was delivered by Lord Balfour, the then British Foreign Secretary.

It was the same hapless Lord Balfour who on behalf of the British Government signed the equally disastrous and infamous Versailles Diktat, which was to lead directly to the British declaration of war against Germany, the consequences of which left Europe in ruins.

This, the Balfour Report, a momentously evil document, was in effect the founding Charter for the State of Israel and what can be described as the ensuing Palestinian holocaust.

Amery thus had an overwhelming racial selfinterest as opposed to British interest, in promulgating this. He also founded the so-called Jewish Legion, the first racially exclusive Jewish fighting force created since Roman times. The Jewish Legion was composed of battalions of Jewish soldiers who were trained and served under superior British officers during the First World War.

This force was a forerunner to the present Israeli Rubenstein was referring to Leopold Amery, a Army. Many of its members deserted, attracted by the opportunity to vent their piratical bloodlust on the displaced Palestinian population. Surprisingly, Amery's openly pro-Jewish sentiments and collaboration failed to raise eyebrows among British Government colleagues, some of whom like Sir Anthony Eden who were known to be strongly anti-Semitic. Presumably such politicians regarded the Asiatic Amery's actions favourable to British interests at the time. It is for this reason that much of the Arab world despises Britain today, an alienation which costs billions of pounds and tens of thousands of jobs in lost trade and favoured-nation status.

> During the Conservative Government of Sir Stanley Baldwin (1925-1929), when he was Secretary of State for Dominion Affairs, Amery was actively one of the promoters of the greatest growth of British Jewry's exploitation of commercial, financial and political opportunity throughout the world. Yet, he disguised his own Jewishness so effectively that few of his parliamentary and government colleagues were aware that he was, in fact, Jewish or of where his true allegiances lay.

However, the act for which he is best known and often heralded by the English establishment's apologists "as a true Englishman", came in May 1940. Amery played a decisive role in bringing down Neville Chamberlain's government, which sought peace in Europe. It was Amery who with the impudence of the successful infiltrator made a war-provoking speech in the House of Commons: "Depart, I say. Let us have done with you. In the name of God, go!'

It signalled the departure of the "Peace in Europe" section of the Conservative Party and opened the door to those who fervently desired war with Germany, the removal of a trade competitor and the opportunity to loot Europe's most prosperous nation. More than half of this pro-war section had shares in munitions factories.

Amery, as a secret Jew, had good reason to hate and loathe Neville Chamberlain, the alleged appeaser of Germany's conciliatory leader. Chamberlain was one of the last, if not the last, of the old-style gentlemen of deny.] honour and decency in British Government.

Amery neither forgot nor forgave Chamberlain's bitter words in September 1939 when he said to his Foreign Secretary, Lord Halifax. "The Jews of America are pushing us into this war."

And so it was, Amery and the Conservative Party's "War with Germany" faction led by Winston Churchill, resolved to ignore Germany proposals for peace and plunged Britain into a global conflict which became the bloodiest in the history of the human race. It was a conflict which delivered half of Europe to the dictatorship of Jewish-Communism and the Palestinian nation to the emerging Jewish empire....

An ironic piece of history is that John Amery, Leopold's estranged son, was a British Fascist who had gone to live in Germany where he remained when Britain declared war on the German nation.

UNITED NATIONS (AP)—Iraq will start signing contracts with its oil customers in euros on Wednesday, its UN ambassador says is part of a campaign to stop using dollars, the "currency of the enemy" despite UN calls to hold off on the move.

Iraq, which exports about 2.2 million barrels of oil Wednesday if its proposal for a euro account isn't accepted—a warning that has spooked the oil market.

The United States and Britain, which take the hardest line against Iraq in the Security Council, have said they will not oppose creation of a euro-based account but said details need to be resolved. Diplomats said Friday that the proposal would likely go ahead.

U.S. HOT TO FIREPROOF NUCLEAR SITES

IDAHO FALLS, IDAHO—The Energy Department is preparing several major new initiatives to protect the nation's nuclear sites from catastrophic wildfires, following criticism of the way it handled blazes in the West this year.

Responding to charges that the agency was illprepared for fires that swept through its nuclear reservations in Idaho, Washington and New Mexico, the department has called for a comprehensive review of emergency procedures at these and other nuclear sites. due in mid-December, and assembled a team of experts to advise it on future safeguards.

Energy Secretary Bill Richardson has directed with the Departments of Agriculture and Interior over planning for wildfires.

"We have to assume the possibility of [fires like these] happening again," said Ellen Livingston, an adviser to Richardson.

Critics claim the Energy Department only narrowly escaped a potential meltdown of nuclear waste and other toxic materials at the Idaho National Engineering and Environmental Laboratories, the Hanford nuclear reservation in Washington, and Los Alamos National Laboratory in New Mexico, which could have had disastrous consequences.

At various points during the Hanford fire, flames burned close to areas where nuclear wastes could have exploded and caused an emergency. At one point, the fire was 400 yards away from 330 50-gallon barrels containing large amounts of uranium packed in combustible chemicals and stored near the Columbia River. The blaze also passed through an area of known contamination near nuclear waste dump sites, according to Doug Sherwood, the EPA's manager for Superfund cleanup at Hanford.

Moreover, large amounts of nuclear waste dumped into the ground and open ponds at these nuclear sites also were vulnerable, officials say. While advance planning by agency managers, such as trimming vegetation around major facilities, helped prevent a crisis, preparations overall were insufficient, critics say. For instance, firefighters were barely able to prevent blazes from reaching areas at Hanford where nuclear materials are stored, after winds shifted.

Robert Alvarez, a former senior adviser to Richardson and former Senate investigator on nuclearwaste issues, said attention to the problem is overdue. "These sites are where the most dangerous weapons in the world were made, and the most dangerous ingredients in the world were used, but [the Energy Department] does not have adequate safety plans or procedures with respect to wildfires. It's only by luck that the department was saved from major catastrophic consequences this summer," he said.

Among the problems encountered was the lack of adequate maps of areas with radioactive contamination at the nuclear sites. Emergency crews from nearby towns or counties didn't know which areas were hazardous and used different radio frequencies than department personnel, making communications difficult.

Some firefighters from outside the Energy Department were not equipped with radiation monitors and were not aware of the risks they faced battling blazes in or near the sites. Monitors used to sample air during the fires were not sensitive enough to detect unusual on the afternoon of Sept. 17 and before they returned releases of materials, such as plutonium, that are to work the next morning. potentially toxic even in minute quantities.

Levels were as much as 100 times higher than normal, but officials say the increases did not pose a threat to public health, because the amounts involved were small. Still, the Government Accountability Project of Seattle, a group that monitors Hanford, cautions that the data are seriously incomplete because the most reliable testing was done by the Environmental Protection Agency only after the fires ended.

> Charging that federal, state and local firefighters from outside the Hanford nuclear site weren't adequately trained, informed of the risks or equipped with dosimeters that monitor radiation, Heart of America Northwest, a citizens group in Seattle, asked the government in early August to investigate alleged willful negligence by the Energy Department.

An investigation of the Hanford fire by the Fish and Wildlife Service concluded that fire management plans were inadequate, that federal officials misjudged the seriousness of the blaze and that knowledge of how best to obtain resources was insufficient. For instance, the Energy Department's requests for extra help from a regional fire center in central Washington were denied because of misunderstandings about how to proceed, the investigation found.

Fires also threatened Idaho National Engineering and Environmental Laboratory, an 890-square-mile complex that includes the Western operations of Argonne National Laboratory in southeast Idaho. Last month an 8,000-acre fire forced an evacuation from the facility, and resulted in an accident that officials admit was very dangerous.

APPEALS EXPECTED FROM JURY RULING

WASHINGTON (AP)—The Supreme Court is seeing the effects of last summer's groundbreaking ruling which expands jury-trial rights in certain criminal cases: A pile of appeals by defendants who say their sentences are unfair.

The justices ruled that virtually any question that could boost someone's maximum sentence, such as whether a crime was motivated by racial hate, must be decided by a trial jury. Judges no longer can decide such issues on their own during sentencing.

In essence, the court said "the constitutional right to trial by jury means what it says," said New York lawyer Gerald Lefcourt, former president of the National Association of Criminal Defense Lawyers. "That's been bedrock U.S. justice since the Founding Fathers."

"There are dozens of cases that have come down the pike already" challenging sentences as a result of the ruling, said Miami criminal defense lawyer Neal Sonnett. However, he added, "Whether it has farreaching effects is yet to be determined."

The ruling, issued in June, said a New Jersey man who

a jury decide whether he acted out of hate and could be sent to prison longer than the ordinary maximum.

New appeals citing that decision are rolling in to the Supreme Court, and the justices already have ordered lower courts to take a new look at a number of cases. Lower courts have decided some defendants are entitled to a new sentencing.

Many of those cases involve drugs. Until now, judges often have decided such issues as how much cocaine someone sold: More cocaine can lead to a longer prison sentence. But many appeals say those decisions now must be made by the jury if the drug in our courts. More is sure to come.] quantity could boost the maximum sentence.

Other appeals say juries must decide such issues as the amount of loss in a fraud case, or a defendant's use of a gun, if that factor would allow a longer maximum prison term.

Prosecutors also are figuring out how to comply with the ruling in future cases.

Justice Department officials say the ruling will require prosecutors to prove more facts to juries when those facts would allow a longer maximum sentence.

Monmouth County, NJ, prosecutor John Kaye said many state laws allow higher maximum sentences if prosecutors show, for example, that someone is a career criminal, is involved with a street gang or committed a crime by using a stolen car.

"All those things will be tested now," Kaye said, judge would be "a little harder, but we'll work with it."

The whole issue stems from the Constitution's Sixth Amendment guarantee of a jury trial for criminal defendants. Even with that guarantee, trial judges traditionally have had wide leeway to impose sentences by considering all of a defendant's actions, even if they were not charged or proved to the jury.

In fact, the Supreme Court ruled in 1997 that convicted defendants can be sentenced even for charges on which a jury acquitted them, if the judge believes the defendant committed the act.

O'Connor's opinion called the ruling "a watershed change in constitutional law" and said it could invalidate recent federal and state sentencing rules that have sought to limit judges' discretion.

So far, however, the ruling's main effect appears to be in drug cases, said Steven Kalar, a federal public defender in San Francisco.

VACCINE REFUSAL MAY CAUSE NY TO TAKE CHILDREN

Today, 77 middle-schoolers will be yanked from home and taken into custody by New York state unless their parents agree to vaccinate them for a disease usually caught by drug abusers or the sexually promiscuous.

On October 10, students in Utica were sent home for failing to get hepatitis B vaccines by the state deadline. Parents were warned the children would be turned over to Child Protective Services for neglect if they were still without vaccination in 2 weeks.

"This is Hillary-Care coming home to roost in adding that proving such issues to a jury instead of a NY," said Jane M. Children are at a very low risk of exposure, unless the pregnant mother is infected.

THE MAN WHO DOESN'T LISTEN SEEMS TO KNOW WHAT "EVERYBODY" WANTS

"It's true that you are prime minister and minister of defense, but we are more veteran than you are in politics," said Meretz MK Ran Cohen on Monday to Ehud Barak. "Sharon will not come into the government to save you, or to save the peace process. He will come in to get control of the government and the peace process. He will do to you what he did to Begin and to Shamir, to Peres and to Netanyahu." Yossi Sarid, who headed the Meretz delegation to the prime minister, hinted that his doubts had to do with Barak's own character/conduct: "I don't want to be insulting, but when we sat in your government, you did not let us in on the peace process. Why should we believe you that you will let us in when Sharon is in the government?" The Meretz people came away from the meeting with a sense that the state of emergency has not changed Barak. He decides on his own what is good, and expects that "everyone" will accept his position, on all fours. If the other side refuses, "everyone" will know who is doing the refusing, and he will look the mothers straight in the eye.

This is how Barak acted toward the late Syrian President Hafez Assad, and this is how he is acting in Israeli politics. He has decided that Israel needs an emergency government, and now Sharon and Sarid have to sign. If they accept his conditions, for instance, concerning the structure of the emergency government, he has got what he wants. If they refuse, everyone will know who is to blame for the fact that there is no peace, and perhaps, God forbid, there is war.

COMING NEXT: A EUROPE-WIDE LEGAL SYSTEM

You might have thought that home affairs, by definition, would be the one area of policy that had nothing to do with Brussels.

Yet over the past month, the European Parliament's Home Affairs Committee has been dealing with one of the most ambitious schemes ever to have come out of the European Union. What is proposed is the establishment of an EU criminal code, complete with a European public prosecutor.

As a first step, national prosecution services will be combined into a unit known as "Eurojust". In due course, a separate EU jurisdiction will be created, covering such areas as drug trafficking, terrorism, money laundering and fraud.

Let us be clear: The Parliament is not simply asking for co-operation in these areas—something which already happens and which everyone supports. It wants an entirely new legal system. The idea is that, just as in the United States, petty crimes would be tried under state law, but serious offences would be dealt with under federal law.

Once you have a federal law-code, of course, you need a federal police force. The EU has already given substantial operational powers to Europol, intended as the forerunner of such a force, but there is frustration at the lack of progress. So, to speed things up, we are to get a European Police Academy.

The day is fast approaching when you could be arrested by a Europol officer, charged under European law, and tried before an EU court. As the European Commission has made clear, the EU legal system will be modelled on the Napoleonic and inquisitorial lawcodes favoured by most of the member states.

STEALTH SECRETS BREACHED

SEATTLE, WASHINGTON-A Russian mathematician who was given access to an American supercomputer loaded with stealth warplane design software is under investigation for espionage.

Federal agents suspect that Aleksey Yeremin, who logged on to the supercomputer from Moscow, took advantage of Lockheed Martin and military security lapses to steal stealth technology secrets.

The 3 1/2-year investigation stretches from the heart of the old Soviet empire to Lockheed's secretive Skunk Works plant in Southern California to a quiet suburb north of Seattle.

Yeremin, vice president of a software company based in Bothell, Wash., that did work for Lockheed, was e-mailed part of Lockheed's modeling program for designing stealth planes. And, sources say, it would have been easy for him to steal the rest of it.

The potential loss is staggering: America's global monopoly on radar invisibility.

later, Lockheed pulled the plug on its project with Yeremin: an ultra-high-speed, number-crunching computer program that was supposed to greatly accelerate stealth aircraft design work.

Federal criminal-justice sources say Yeremin, 46, has connections to the Russian military and nowdefunct KGB.

It is unknown whether Yeremin took any classified information. But sources told the Seattle Post-Intelligencer that some of the unclassified information he did obtain should have been classified top secret.

A retired Air Force three-star general said he is concerned the apparent leak could help the Russians build their own stealth warplanes.

"I don't think what is at risk here is making these (U.S.) aircraft any more visible to radar," said George Muellner, who played a key role in developing the nation's stealth fleet.

"But what is at risk is accelerating a country's ability to develop and build these sorts of aircraft—to produce something that is a threat downstream," he said. "If they started building and selling these things to the Iraqis, that would be a concern."

The joint FBI-Air Force probe has so far yielded no arrests, and no one has been publicly charged with a crime. Agents have seized the home computer of a Lockheed employee who worked closely with Yeremin.

That man told the Post-Intelligencer that he now realizes he was deftly manipulated by Yeremin.

"I am not 100 percent sure, but I am highly sure he is a spy," said the 38-year-old computer expert, who no longer works for Lockheed. He asked that he not be identified for fear of jeopardizing his current job.

He said he went beyond giving Yeremin portions of the MM3D simulation software—used to model highly complex interactions between stealth aircraft and radar—that the Russian needed to do his job. He said he also provided information that Yeremin could have used to determine American stealth capabilities.

"I have to admit, I am very gullible, very naive, very trusting," he said. "He asked very probing questions, but I pushed my concerns away.

"Now I can look back and see how he gathered information from me. He used textbook ways to win over someone; to recruit them as an operative or agent. He would earn my trust by saying he was not in any way... loyal to the country he was from, but wanted to come here."

The computer expert is befuddled by how Lockheed and the Air Force could allow a Russian with KGB ties access to such a sensitive program.

Lockheed refused to answer questions about whether security was compromised. The Air Force would not explain how it conducts security oversight of the defense contractor.

Officials at Skunk Works, in Palmdale, where the U-2 spy plane, the bat-winged F-117 and the F-22 were designed, first became aware in 1997 "that an employee... was not reporting contacts with foreign nationals as required by governing security regulations," Lockheed spokesman Sam Grizzle said in a prepared statement.

The officials reported the violations to "appropriate U.S. government agencies and followed their instructions in addressing the situation. The employee in question no longer works for Lockheed Martin," Grizzle said.

Yeremin "readily acknowledged working for the Soviet military," according to Sarbora, but "prior to 1990, if you were a scientist of any stature, you worked for the Soviet military structure. You didn't get to work, or support in school without working for the military."

Reached recently at his home in Moscow, Yeremin declined to discuss the espionage allegations. ...

The expert said he had been assured by Lockheed engineers that the test fixtures were not classified. But after the investigation began, federal agents claimed some were top-secret....

The computer expert said he left Lockheed after the company pulled his access to work on the stealth program. He remained a Lockheed consultant for a time, then left for another job.

CHINESE ARMY FIRES SUPER-GUN

New weapon with 200-mile range capable of raining bombs on Taiwan

Shocking the international military community like Saddam Hussein did with his 512-foot-long super-gun in 1990, the Chinese army has tested its "Taiwan rocket gun", a new weapon with a range of over 200 miles.

According to a recent report translated from the China Wen Hui Bao daily, "China has tested a newly developed rocket gun, named the WS-1B, which claims to have a range of 360 kilometers, the longest range in the world of a weapon of its kind."

Beijing's rocket gun has already raised concern inside the island nation of Taiwan. "The Chinese rocket gun could hit any area of Taiwan within minutes, if fired from the coast," stated a report filed this month by the Taipei Times.

"Various people have been working on this type of technology for some time," noted Frank Gaffney, noted defense analyst, president of the Center for Security Policy and a former assistant secretary of defense under President Reagan.

"It stands to reason that the Chinese communists would be interested in having the capability to attack Taiwan without having to use missiles. Although I think that when they go, they are not going to be terribly hung up about breaching the missile 'threshold'. Witness their 1996 missile shots into Taiwan's territorial waters," said Gaffney.

Reports have surfaced before in the Chinese press suggesting that Beijing was developing a super-gun. According to a Sept. 1999 article published by Janes Defense, "reports from Hong Kong say that China North Industries Corporation has developed a new long-range artillery system, described as a 'super range rocket gun' with a range of 360 kilometers.'

"The new reports note that the WS-1B is an Yeremin "pales in comparison" to open articles written artillery rocket," stated defense analyst Richard Fisher, a senior fellow at the Jamestown Foundation. According to Fisher, the Chinese super-gun may be more a rocket than a gun.

> "If the PLA were to have such a missile, that would mean that they have the ability to produce a precision strike SRBM that likely would cost much less than their DF-15 and DF-11 missiles, and that would allow a much higher salvo launch rate," Fisher said. "This kind of missile deserves close monitoring, as it has

the potential to rapidly increase the PLA's missile inventory aimed at Taiwan."

According to another defense expert, Beijing may not have to fire its new rocket gun at Taiwan. Instead, Red China may use its new super-weapon to win a war of diplomacy with the tiny island democracy.

suggested that the Soviet arms buildup was not intended to conquer Europe, but to 'Finlandize' it, reducing it to neutrality and trading with the Soviet Union on Soviet terms," stated defense analyst Philip Gold, a senior fellow at the Seattle-based Discovery Institute.

'We now know that the Soviet arms buildup was driven far more by internal dynamics than by coherent grand strategy, but I wonder if China might not intend to 'Finlandize' Taiwan," suggested Gold.

In March, WorldNetDaily reported that the Taiwan rocket gun is known to be directly related to Hussein's Babylon super-gun. According to the intelligence source who told WorldNetDaily about the new Chinese weapon, Dr. Gerald Vincent Bull, the designer of the Iraqi Babylon gun, assisted the Chinese artillery maker Norinco in its development of a super-gun.

Bull, considered a rogue scientist, worked with Iraq during the 1980s to develop the Babylon weapon capable of striking Israel. Bull also helped Iraq improve its SCUD missiles. The Iraqi super-gun project was discovered by British intelligence and shut down prior to the Gulf War. That gun was never used, but a smaller gun—"Baby Babylon"—was fired successfully. In 1990, Bull was found murdered outside his Belgian apartment, allegedly killed by Israeli agents.

The 19th Century science fiction novelist H.G. Wells popularized giant guns. Nazi Germany, hoping to bombard Britain during World War II, unsuccessfully similar to the Iraqi Babylon cannon. Other large German siege guns were often given nicknames such as "Big Bertha" or "Anzio Annie" by the Allied troops that suffered under their shelling. The largest Germandesigned gun, the World War I Paris gun, fired shells over 70 miles into the French capital.

Super-guns became less attractive after World War II with the introduction of small nuclear warheads and long-range missiles. The Chinese weapon developed by Bull is considered large enough to hurl large chemical or nuclear bombs on Taiwan.

The Chinese army rocket gun may also have an American guidance system. Beijing military sources openly noted that the rocket gun is capable of striking Taiwan from the Chinese mainland with various types of warheads, including guided smart bombs. The report from the China Wen Hui Bao daily noted that "guidance options include the use of GPS," the American-built Global Positioning Satellite navigation system.

Administration documents show that GPS technology was transferred to China with the approval both President Clinton and Vice President Al Gore. According to a 1997 Rand report, in 1996, the Clinton-Gore administration approved the sale of GPS navigation systems directly to a company owned by the Chinese army.

The GPS technology transfer was labeled "disturbing" and "raised serious concerns" in the 1997 Rand Corporation report on the Chinese military industry. The Rand report was made public in a 1998 federal lawsuit filed against the U.S. Commerce Department.

"The most troubling potential transfer to China is Rockwell's proposed joint venture deal with the Shanghai Broadcast Equipment Factory and the Shanghai Avionics Corporation, the latter of which is a key enterprise of the Aviation Industries of China," states the 1997 Rand report.

"More accurate GPS systems would enhance the "Back in the 1980s, people like Norman Podhoretz PLA's ability to carry out attacks against Taiwan's military and industrial facilities, potentially reducing the ability of the Taiwanese military to defend itself against PRC coercive diplomacy," the report notes.

THE FORGOTTEN DEFICIT

The federal budget deficit may be fast disappearing, before. America's huge and growing trade/current account deficit could soon spoil the "Goldilocks" economy-and few in Washington and on Wall Street even want to admit that there is a problem.

What is a Trade Deficit?

America runs a trade deficit when U.S. exports are less than imports. In other words, the rest of the world—especially Japan, Communist China, and OPEC (Organization of Petroleum Exporting Countries) members—ship us more real goods and services than we ship them. The "current account" deficit is the broadest measure of America's international economic position. It includes investment income in addition to goods and services. For the purposes of this article, we will use the term "trade deficit" to refer to this total picture.

Foreign countries benefit from this deficit because we ship them financial assets (dollar-denominated securities) in return for their goods. Simply put, America is borrowing from foreigners. This form of borrowing is often referred to as "dissaving". A trade deficit is, simply put, borrowing from abroad. The market value of foreign-owned U.S. assets now exceeds the value of U.S.-owned foreign assets by some \$1.4 trillion—an increase of more than \$1 trillion since Bill Clinton took office. To put it into perspective, the U.S. is now in debt to the rest of the world to the tune of about \$5,000 for every man, woman and child in America.

As we shall see, borrowing huge amounts from foreigners is filled with potential pitfalls. So far, foreigners have been happy to take our dollars and help

lower U.S. interest rates and drive our stock market higher. But what happens if foreigners no longer want to hold dollars? Our huge foreign debt poses the threat of a sudden, major weakening of the U.S. dollar if foreign holders become pessimistic about the American economy.

This rising indebtedness is due to America's mushrooming trade deficit. Between 1992 and 1998, the trade deficit grew from \$39 billion (0.6% of GDP) to \$202 billion (2.3% of GDP). It grew even larger during 1999 to a whopping \$347 billion.

Is There A Problem?

Some economists and public policy observers claim that the trade deficit is really not a problem. In fact, they even celebrate it as a by-product of a strong economy and America's role as marketplace for the world.

The potential negative implications of the trade deficit are underestimated in Washington, on Wall Street and in academic circles. The persistent and growing trade deficit shows that our economy, especially our manufacturing sector, is increasingly being dominated by foreigners. That deficit means that thousands of American jobs are being given away to foreign countries. Unless action is taken to correct this situation, there could be a protectionist backlash which could derail the world economy and financial markets.

What Caused the Problem?

What has caused the U.S. trade deficit to balloon out of control? There are many theories, yet no consensus. Some observers point to the paltry domestic savings rate that causes us to borrow from abroad. Others celebrate the deficit as a consequence of strong U.S. growth relative to other world economies.

clear that our deficit is being influenced by Japanese, Chinese and other foreign governments' purchases of U.S. government securities. They want to keep the dollar propped up to make their goods and services cheaper relative to American goods and services. This is pure market manipulation separate and apart from U.S. fiscal and monetary policy or domestic savings and investment trends.

This foreign accumulation of U.S. government securities is an alarming economic development. As Dr. Ernest H. Preeg of The Hudson Institute (www.hudson.org) points out in his new book, The Trade Deficit, The Dollar, and The U.S. National Interest, these massive holdings make America vulnerable in trade policy and even national security:

"Foreign governments increased official dollar holdings from \$432 billion in 1989 to about \$1 trillion in 1999. At some future point, large dollar-holders, such as Japan and China, could threaten to sell dollars, or shift them into euros and other currencies, as bargaining leverage against the United States related to trade or national-security issues. One Japanese prime minister has publicly spoken of the temptation to sell dollars, and Chinese military strategists have published studies about integrated warfare with the United States, including in financial markets."

What does Dr. Preeg mean by "leverage?" Well, if either Japan or China decided to sell their Treasuries, the result would be a financial crisis rivaling the 1973-74 episode that was characterized by "stagflation" and a 45% drop in the U.S. stock market. By dumping Treasury bonds, foreigners would force U.S. interest rates higher (when bond prices fall, interest rates rise). This would send the bond market into the proverbial tank and

it wouldn't do the stock market much good either.

In the short term, the trade deficit and foreign holdings of U.S. government bonds may have little impact on U.S. financial markets. But as the situation progresses, tensions between America and her trading partners are bound to flare. The U.S. and Japan have come close to an all-out trade war twice in the 1990s over everything from rice to luxury cars and consumer electronics. With oil prices skyrocketing and U.S. oil imports on the rise, tensions with OPEC could surface, especially if Saddam Hussein decides to cut production. Finally, Communist Red China considers the U.S. its number one enemy. We have a lot of disagreements with them over issues like Chinese proliferation of ballistic missiles and "weapons of mass destruction" and their expansionist aims with regard to Taiwan and the rest of the Pacific Rim. Don't think for a second that they would hesitate to use their \$105 billion in Treasuries as leverage in a crisis.

Is There a Cost From the Trade Deficit?

Some observers claim that the trade deficit is a benign deficit with no real negative effects. Others disagree. The Economic Strategy Institute (www.econstrat.org) has quantified the effects of the trade deficit. The trade deficit results in lower GDP (Gross Domestic Product) because it forces employment and investment away from U.S. export activities, as well as domestic business activities that have to compete with cheap foreign goods and services. The Institute estimates that eliminating the trade deficit would increase real GDP by some \$44 billion per year.

But there is another explanation: It has become competition, but will do so at a cost. Profits have to because investors don't like low earnings.

> Meanwhile, with rising oil prices and our growing dependence on foreign oil, the trade picture could get even worse—perhaps much worse.

Implications for the U.S. Dollar

Absent a protectionist backlash in the United States or a massive foreign liquidation of U.S. Treasury bonds, there is still another major concern surrounding the trade deficit: The dollar may be set for a major decline. A strong dollar makes U.S. goods more expensive overseas and foreign goods cheaper here. That means a strong dollar adds to the trade deficit. A weak dollar, with all of its negative implications, would lower the trade deficit. Alan Blinder of The Brookings Institution (www.brookings.org) and Princeton University warned of a coming fall in the dollar due to the trade deficit during testimony on December 10, 1999, before the U.S. Trade Deficit Review Commission:

"Another concern is that we may be setting up the dollar for a very big fall, and that brings me to my third and final point. I believe that a lower dollar, indeed, a much lower dollar, will ultimately play a major role, indeed, the major role, in whittling our trade deficit down, not to zero, but to a manageable size. I think the problem for public policy is simply to cope with the sinking dollar as it sinks."

A sinking dollar is not just a problem for public policymakers. It is a problem for investors as well. A rapidly sinking dollar has never been kind to the stock and bond markets; however, gold is probably the single most negatively correlated asset to the U.S. dollar. It www.blanchardonline.com

will be one of the few asset classes that can protect investors from a collapse of the dollar.

Potential Effects for Investors to Ponder

Eventually, these chickens will come home to roost. There will be a price to pay for continuing large trade deficits and a huge foreign debt. Three potential scenarios exist. All have negative consequences for the financial markets:

- 1. Protectionist Backlash. We've already seen the roots of protectionism in last year's violent protests at the World Trade Organization meeting in Seattle. Should that sentiment spread to the halls of power in Washington, D.C., we could see tariffs and embargoes spring up overnight around the world. Such a scenario would destroy whole corporations and eliminate jobs. In short, the U.S. and world economy would be crippled, much like what happened during the protectionist backlash of the 1930s. It would not be an exaggeration to say that the financial markets would collapse. Fortunately, this scenario does not seem likely.
- 2. Foreign Dumping of U.S. Treasury Bonds. Should foreigners sell U.S. Treasury bonds—or even cease purchases of U.S. Treasury bonds—the result would be a possibly steep rise in interest rates and the concurrent fall in stock and bond prices. Unfortunately, this scenario is a real possibility.
- 3. A Decline in the U.S. Dollar. A rapidly sinking dollar would more than likely mean inflation in the United States and a decline in our stock and bond markets. This scenario should be considered likely.

Gold: Financial Insurance

The potential effects of America's huge and U.S. companies have to match the import growing trade deficit should prompt investors to include gold investments in their overall financial plan. be shaved to compete with cheaper foreign goods. Investors have had the luxury of ignoring risk during Lower profits have an effect on the stock market, the "Goldilocks" economy of the 1990s, but they should not assume that this luxury will continue indefinitely. Gold is one of the few assets—perhaps the only asset—suited to providing a degree of capital preservation during any of the potential scenarios likely to arise due to our trade deficit.

> Gold is negatively correlated to the U.S. dollar, so when the dollar falls, the price of gold usually rises. This is exactly what happened in 1982-83 when the dollar fell and the price of gold increased from \$294 an ounce to \$514 an ounce in just 9 months—an increase of 74%. Once again from 1985-87 when the dollar fell again and the price of gold increased, this time from \$282 to \$502 over 21 months—an increase of 78%.

> Stocks and bonds are no longer negatively correlated with one another—but they are both negatively correlated with gold. So, should stock and bond prices fall under the pressure of a falling dollar, mass sales of U.S. Treasuries, or other negative economic and political events, gold will be useful as a portfolio diversifier.

> It is best if investors do not wait for the trade deficit to begin taking its toll on the financial markets to acquire their financial insurance in the form of gold. By then, it may be too late to buy gold at attractive prices. Today gold is trading at under \$275 per ounce—just above a 20-year low. And \$275 gold is lower than the annual peak in each of the past 20 years. In fact, \$275 per ounce gold is cheaper than the average annual price of gold in each of the past 20 years. There has never been a better time to buy gold for less.—Blanchard Economic Research, http://


