HOW TO QUIT A WINNER By E.J. Ekker

No matter what steps are taken to save it, it is becoming clear that the Estrada Presidency will be greatly foreshortened. That early termination can be a disgraceful debacle, or a triumphant withdrawal—leaving a legacy far more valuable than anything any other President has ever left this nation.

If, for instance, one of the last things done by President Estrada was to be his issuing and signing an Executive Order instructing the BSP to immediately implement the use of the GAIA DEEDs as banking reserves, the same as any other U.S. Treasury debt, the impact upon the Philippine economy would be no less than "electric". He could then say, as he waved "goodbye", "Because I am leaving now, I can do something that I could not do before. PROPOSAL TO JUMP-START THE PHILIPPINE ECONOMY AND REVERSE THE DIRECTION OF THE VALUE OF THE PESO

ACTIONS REQUIRED FOR IMPLEMENTATION

RP: Presidential Executive Order to BSP requiring BSP treat GAIA DEEDs as U.S. Treasury debt, payable in gold. (This allows BSP to issue new credit/currency equal to the discounted value of each project plus its accompanying DEED.) [Estimated time required: 1 day.]

BSP: Notify member banks (domestic only) that the GAIA DEEDs are to be treated as RESERVES the same as other U.S. Treasury debt with the exception that the "face amount" of the DEED does not require a discount for coupon or maturity so none of those calculations are needed. Please Note: Expert attorneys specializing in international banking have designed this program to fit into virtually all banking systems so that no special education of bank personnel will be required. [Estimated time required: 2 days.]

DOMESTIC BANKS: Main offices must pass on notification to branch offices. [Estimated time required: 2 days.]


GAIA: Telephone its contact persons in the Provinces; they will contact the 1200 plus DEEDholders to take their project proposals and feasibility studies to a bank of their selection. [Estimated time required: 2 hours.]

BRIEF DISCUSSION

The primary objective of the Alliance is to bring the means of freedom and upliftment to the disadvantaged peoples of the globe, beginning in Southeast Asia, specifically the RP. This requires countering the forces holding those peoples in economic bondage whose primary tool is the exclusive use of paper money, which allows them to control the value and supply of nearly all currencies, and to profit from trading in currencies whether the values are forced upward or down. This can best be accomplished through the return to gold-based currency so that "foreign exchange" is no longer required and currency trading becomes unprofitable.

The standard Memorandum of Agreement between GAIA and its Joint Venture Partners requires the purchase of gold with the 50% of loan emissions belonging to GAIA. That obviously requires the establishment and implementation of new procedures, especially for banks that are not familiar with the administration of gold or gold-based documents. For this special quick-start program, GAIA will make two modifications which will simplify and speed implementation, and reverse the downward trend of the Philippine peso. First, GAIA will grant a delay in the purchase of gold; a provision for that is already in the MOA. Second, with its line-of-credit (50% of the total loan), GAIA will purchase and hold pesos. The effect of this will be much the same as "BSP intervention" in buying an "oversupply" of pesos, but without the harmful wastage of precious foreign exchange reserves to do so. At the current daily volume of currency transactions (as listed in the newspapers, less than \$100M), only two average DEED loan transactions (purchasing \$40M each) would completely absorb all of the "loose" pesos. Anytime this proved to reduce the system liquidity too much, GAIA would be responsive to a request from BSP to reduce its rate of purchase.

As we sat to dictate I perceived a need to write longer instead. In the present era one recognizes his own standard, or flag, and through that standard the individual identifies himself with the subdivisions of mankind. MAJORITY RULE EQUALS TYRANNY

The controversy surrounding this year's presidential election has led to calls to abandon the Constitution's Article II provisions for the Electoral College to select presidents. Despite the fact the system has served us well for over 200 years, many Americans now call for its abandonment in favor of electing presidents by popular vote. Before we do this, let's consider the function it performs. California, Ohio, Texas, New York, New Jersey, Florida, Illinois, Pennsylvania and Michigan can boast a combined population of 137 million. That's slightly more than half our 272 million national population. It's, therefore, conceivable that just nine states could determine the presidency in a popular vote. The Electoral College gives states with small populations a measure of protection against domination by states with large populations. That's because the nine highpopulation states have a total of 243 Electoral College votes, but 270 are needed to win the presidency.

Compare Wyoming to California. California's population is over 33 million, while Wyoming's is 480,000. Thus, California has 69 times more people than Wyoming. California has 54 Electoral College votes (since it has 52 congressmen and two senators), while Wyoming has three votes. In terms of the Electoral College, California has only 18 times as many votes as Wyoming. The Electoral College forces presidential candidates to appeal to voters in states with small populations.

The Constitution's Framers feared tyranny of the majority. That's why there's an Electoral College—plus, even though California's population is 69 times that of Wyoming's, both states have two senators.

Despite public consensus, there's nothing inherently just or fair about majority rule. In fact, one of the primary dangers of majority rule is that it confers an aura of legitimacy and respectability on acts that would otherwise be deemed tyrannical. Ask yourself what dayto-day decisions would you like to be decided by majority rule? What about where you live, for whom you work, what kind of car you drive, what clothing you wear, what woman you marry?

You say: "Williams, those decisions are nobody else's business but mine. What's more, those are issues that not give Democrats any confidence that dented ballots will don't belong in the political arena anyway!" You're right. Plus, we'd all agree that it would be nothing short of tyranny if where you could live and whom you could marry was decided by majority rule.

What if the decision whether to enslave a group of people were made through a popular vote instead of a dictatorship? Wouldn't you say that it was tyranny nonetheless? Instead of enslave, we could easily substitute the words rape, murder, rob and torture, and reach the same conclusion. Those examples are extreme and unlikely in the United States, but the principle is just as applicable on questions like: Should a popular vote decide how much of my weekly salary is set aside for retirement, or how much is set aside for housing, clothing, food and entertainment? If a popular vote decided these questions, there's still tyranny, but of a lesser degree.

Americans should read the wise words of James Madison in Federalist Paper No. 10. There's no clearer statement that the Framers fashioned a republic and not a pure democracy. Our Constitution set limits on not only the power of the three branches of the federal government, it also set limits on the arbitrary will of the people that might be expressed through a majority vote.

Madison said, "Measures are too often decided, not according to the rules of justice and the rights of the minor party, but by the superior force of an interested and overbearing majority." And he's right.

ILLINOIS COURT DID NOT ACCEPT DIMPLED BALLOTS

The Chicago Tribune reports in today's Thanksgiving edition that a critical Illinois court ruling cited by the Florida Supreme Court may not have set the precedent Al Gore's lawyers claimed.

During arguments before the Florida Supreme Court, Al Gore's attorneys claimed that an Illinois Supreme Court ruling "was a sweeping directive to count controversial 'dimpled' ballots, in which ballots were indented but not punched through," the paper reported.

But the Tribune reported that the "Illinois case should be counted in Gore's favor. That's because the Illinois court actually affirmed a trial judge's order to exclude dented ballots, since he had decided he could not reasonably determine the voters' will by examining the ballots."

The Illinois case was referenced in Tuesday night's opinion offered by the Supreme Court, and has been trumpeted by the Gore team as a model for Florida counties engaged in the manual recount.

Attorney Burton Odelson, who represented one of the candidates in the 1990 Illinois case, told the *Tribune*. "The judge did not count ballots that were indented because he could not determine the voters' intent.

"From the beginning, I knew everybody [in Florida] was interpreting this case wrong and reading into it what they wanted to read into it."

The Gore team had a lawyer in the Illinois case present

an affidavit to the Florida Supreme Court stating that the Illinois court had agreed dented ballots should be included.

The *Tribune* said the attorney's affidavit "apparently was mistaken in its assertion that such ballots were counted."

NO CONTROLLING LEGAL AUTHORITY

Had God not created lawyers and lower courts, this year's presidential election—(you do recall that before the War for Florida we had an election, don't you?)—might well have been over by now.

In that impossible daydream, the U.S. Supreme Court swoops down to settle the questions that are slowing the outcome: Is it proper under law to recount only some ballots by hand? What about ballots from military men and women stationed overseas? If a chad's pregnancy is only in its first trimester, should it count as a vote?

Instead, the nation's eyes have been diverted from issues of elemental fairness to sideshows in county seats and local courtrooms. Ours may be a fine legal system, but when it tries to cope with a fast-breaking case in multiple jurisdictions, it can leave the public and the players confused. For almost three weeks, we've had no controlling legal authority.

Friday's decision by the U.S. Supreme Court to hear an argument brought by George W. Bush could get the core issues resolved, and elevate the current lawyers' game of selfish one-upmanship. Ordinary citizens who've been waiting for someone, anyone, to take charge can sound at least a small cheer.

Essentially, the court will consider two questions. Did the Florida Supreme Court get it wrong when it ruled that Katherine Harris, Florida's secretary of state, could not certify an earlier statewide count that would have given Bush a 930-vote victory? And, did the Florida Supremes write new election law—something the state legislature alone is supposed to do-when they allowed hand recounting to continue in three counties until a Sunday-night deadline of the Florida court's arbitrary choosing? If the answers are yes, Bush wins.

Much of the current confusion in Florida stems from the state court's decision issued late Tuesday. Those justices didn't order a statewide recount or order standardized rules on how to recount ballots-let alone what ballots to recount. So local officials are making up the rules as they go along, including what to do with socalled pregnant or dimpled chads.

That question is one example of the mischief that has run wild through lower courts and, with luck, will diminish now that the U.S. Supreme Court is involved. The Florida Supreme Court strongly hinted in its ruling

that dimpled chads can count as votes—a conclusion that helps Al Gore in Democratic counties. To support that notion, the Florida court cited language taken out of context from an Illinois Supreme Court decision, which at first blush appears to say dimpled chads should be counted as votes. In truth, as the Tribune reported Thursday, the Florida court got this backwards. The Illinois court actually ruled that a judge was correct when he excluded dimpled ballots because the dents didn't clearly reveal the voter's intent. Oops.

The U.S. Supreme Court is less likely to be bamboozled by attorneys who sloppily quote legal precedents. So, now that the nation's highest court is on the case, it would be good for both sides to ratchet down their alarmist rhetoric about each other's efforts to "steal" the election. This is a time to let the law rule. [JR: The democratically appointed Florida Supreme Court during the hearing asked Bush attorneys 100 questions and Gore's attorneys only six (as pointed decisions in their official Opinion of the Court brief solely on accepting, without verification, an incorrect case law presentation by Gore's attorneys that erroneously claimed an Illinois Supreme Court decision had previously ruled that questionable "dimpled" ballots were to be counted. Is it possible the Florida Supreme Court showed a little bias towards Gore and the Democrats? Politicians appoint judges that generally have similar perceptions, so judges are not immune from playing politics in the courtroom.]

SINGAPORE—Thailand's deputy prime minister, Supachai Panitchpakdi said he hopes to see the ASEAN Swap Agreement (ASA) grow into a full-fledged Asian Monetary Fund (AMF).

"It has been improving day after day. In due time it would encompass a wider arrangement and become multilateralised," he said.

Economic Ministers signed a protocol that gives flexibility to delay their commitment to cut tariffs on certain products under the Common Effective Preferential Tariff (CEPT) scheme.

The ministers are meeting ahead of the 4th ASEAN Informal Summit here tomorrow.

"I am hopeful that at the end of the day we would have a full-fledged Asian Monetary Fund," said Supachai, who is also commerce minister.

The ASA is a Chiangmai initiative aimed at assisting ASEAN countries meet their temporary liquidity problems.

A network of bilateral swap arrangements among ASEAN members, China, Japan and South Korea (ASEAN plus three) is being negotiated to provide temporary financing for members facing balance-ofpayments problems.

The AMF, mooted by Japan in 1997 has the same objective with the ASA.

It was previously opposed by the previous regime of the International Monetray Fund (IMF) on fear that it would undermine the latter.

But under the current managing director, Horst Kohler, the IMF is now more favourable towards a regional monetary cooperation.

> With Arab-Israeli tensions rising and the deadly Oct. 12 attack on the USS Cole in Yemen painfully fresh, U.S. forces in the Gulf area continue to be on "Charlie" alert status, indicating possible imminent terrorist attacks with neither targets nor aggressors identified.

> It is the highest alert status after "Delta," which is announced only when there is a specific known threat to U.S. forces. According to U.S. defense sources, Delta has been declared twice in the past two weeks, during which 23 ships of the U.S. Fifth Fleet, including an aircraft carrier group, left Bahrain for greater safety at sea.

> While the damaged *Cole* is on board a huge Dutch barge off the west coast of South Africa on its way to Pascagoula, Miss., thereby avoiding the Middle East and Mediterranean completely, the U.S. Navy on Wednesday took a calculated chance by sending the guided missile frigate USS Hawes through the Suez Canal.

> The *Hawes* is the first U.S. Navy ship in the canal since the Cole incident, and its transit coincides with Defense Secretary William Cohen's visit Wednesday with Egyptian President Hosni Mubarak.

Anger and discontent at America's support for Israel He was speaking to newsmen after the ASEAN has been growing across the Middle East, with incidents reported in several locations. In Kuwait, police continue to investigate four men arrested with 135 kilograms of high explosives who, according to the Kuwaiti newspaper Al Watan, were planning to attack the U.S. army base at Camp Doha, north of Kuwait City. And in Riyadh, Saudi Arabia, diplomatic sources have speculated that an explosion that killed a Briton in a car there last Friday could have been a case of mistaken identity for an American, or the attackers saw no difference.

"You American?" they shouted. Before the "westerner" could wind down his window to shout "no," his car was pelted with rotten tomatoes and eggs. "Bloody American. Filthy Yank," they reportedly screamed as their car roared away, tires screeching.

> According to U.S., British and other sources, the Clinton administration is trying to save its ammunition for a retaliatory strike at those responsible for the bombing of the USS Cole. Yemeni investigators, with the help of the FBI using DNA tests, have reportedly identified the body of at least one of the two suicide bombers and are holding at least 10 suspects.

> U.S. officials have alleged links with individuals involved in the bombing of the U.S. embassies in Kenya and Tanzania two years ago, in which more than 200 people died, and with Osama bin Laden, the wealthy Saudi exile and reputed terrorist living in Afghanistan. Bin Laden's base was struck by 80 Tomahawk cruise missiles fired from U.S. ships.

> On Tuesday, Gen. Henry Shelton, chairman of the U.S. Joint Chiefs of Staff, said another retaliatory attack with cruise missiles was "an option". Reports in London, however, suggest that bin Laden has moved his headquarters from Kandahar to an almost inaccessible mountain area to the north of Kabul, where he has been blasting out caves.

> British and American intelligence services have been working together to determine the best way to deal with bin Laden. British diplomatic sources said that Tuesday's summit meeting in Moscow between Prime Minister Tony Blair and Russian President Vladimir Putin may have eased the way for closer Russian cooperation for an attack on bin Laden.

> According to the London Daily Telegraph Wednesday NATO's Partnership for Peace agreement with Uzbekistan, Kazakhstan and Kyrgyzstan has allowed commandos from all three states to train with U.S. Special Forces in Montana and Alaska. A combined-force operation launched from old Soviet bases at Tashkent and Termez on the Afghan border could be launched with bombers, long-range artillery and raids by Special Forces.

[JR: The presence of 23 U.S. warships in the Gulf can only add to the tensions in the Middle East. Are these ships there to protect American interests, oil or the Israelis? Mr. Cohen's tour is not to restore trust and confidence as to American intentions as much as to deliver U.S. demands, pronouncements and denouncements. It seems our government is constantly rotating foreign troops onto American soil—presumably to train them to fight in their own countries. As for the Russians, one would hope they would use caution in allowing the U.S. and Britain to use their old bases to launch attacks against bin Laden. This might invite a hostile On Monday night in Muscat, Oman, jeers and reaction from the Muslims who occupy this region.

They would stress the need for a UN peacekeeping force to protect the safety and lives of the Palestinians, the statement said, adding that the ministers were following up on the decision of the Ninth Islamic Summit in Doha, Qatar on Nov. 12-14.

The ICFM ministers also wanted the UN to establish a fact-finding commission and a war-crimes tribunal to bring to justice those responsible for the deaths of many innocent Palestinian civilians, it said.

"The ministerial delegation will also hold consultation with the UN Security Council to similarly urge the Council to take effective and immediate measures to stop Israeli aggressions... and ensure implementation and compliance by Israel of all UN resolutions pertaining to the Middle East conflict," it added.

The ministerial delegation wanted to see a more active participation of the UN to ensure the success of the Middle East Peace Process, the statement said.

The UN, it said, had a moral and political responsibility towards the Palestinian cause until a just and comprehensive peace settlement was reached.

ISRAELIS WILL HINDER WESTERN INTERVENTION

Belatedly, Western governments have begun to accept the need for intervention in the Israeli-Palestinian conflict. This is what the Palestinians and Arabs have been calling for, and the Israelis—though still protesting—are beginning to recognise that it may now be inevitable. But if it is going to happen, the Israelis will surely do their utmost to make it as ineffective as possible.

An observer force would be small (possibly no more than 200 people) and unarmed, or lightly armed—for its own protection but not to stop violence between the two sides.

This is a lot less than the Palestinians have been seeking, and its chances of success are uncertain. Observers were sent to Hebron a few years ago and, in the words of the Palestinian spokeswoman Hanan Ashrawi: "They have been entirely useless."

"What we want," she told the Guardian yesterday, "is an international force with a mandate to protect the Palestinians and hold the Israelis responsible. It should be mobile and have the ability to intervene... We want Israel to be accountable and subject to international law."

> A lot depends on what the observers would be expected to do and how they would operate. Their most obvious function would be to monitor and document the violence, and to publish their evidence in full with a view to prosecution of anyone who commits crime under local or international law.

> This, in itself, might deter some of the excesses, though equally it could result in the excesses simply continuing behind the observers' backs.

> The personality and determination of the observers would also be important. Would they be nervous Norwegian policemen or characters like Scott Ritter, who plagued the Iraqis for years with his nuclear inspections?

> A protection force would entail a far bigger commitment. To be effective, it would need to be large enough and sufficiently well armed to restrain the Israelis. That is not impossible—witness NATO's defence of Kosovo—but it looks unlikely at this stage.

> A weak protection force would probably not help at all. It could easily end up as the meat in a sandwich—squeezed between the warring sides, as happened in southern Lebanon.

> Another problem is that a protection force might stop the fighting but consolidate the status quo. For example, besides protecting Palestinians it might be trapped into protecting Israeli settlements, which the international community regards as illegal. That would certainly please the Israelis but would not move the situation forward towards a sustainable peace.

> An initial intervention by observers, in sufficient numbers and with a proper mandate, would at least create an opportunity to cool the situation.

> It would also send a powerful signal from Western countries that the disproportionate, and often hysterical, use of force by the Israelis over the last few weeks is intolerable.

> Finally, multinational involvement would be a sign that America's lopsided domination of the peace process—which has been a large part of the problem—is coming to an end. [JR: We must realize that Israel has never and will never comply with the world's consensus for what is the right conduct that is applied to all other nations. She has a very narrow focus and will only do what her leaders feel is best for Israel and the Israelis. The opinion of the world, unless it directly affects their economy, is irrelevant.]

BRITAIN TO OFFER MONITORING FORCE FOR ISRAEL

Britain will today propose sending troops to Israel and the There are two basic options: an observer force or a Occupied Territories as part of an international monitoring force.

The initiative will be proposed to Israeli and Palestinian delegates at a specially convened meeting in New York by officials from Britain, France, the United States and the United Nations which are backing the plan. A Foreign Office official said: "We believe there is a good case for observers in either UN or non-UN hats who could report the conflict in an impartial way and act as a deterrent to violence."

The Palestinians have been pushing for an international force in the region where more than 280 people have been killed in the last two months, but Israel has been strongly opposed. To try to make it more acceptable to the Israelis, the proposal is being discussed as an observer mission, avoiding the use of the word force.

"It is not clear whether they would be military or On the other hand, an observer force is better than civilians," said the Foreign Office spokesman. "We recognise the difficulties but we are worried about the increasing seriousness of the situation." He added that Britain would be prepared to commit troops, despite already being stretched by having forces in Sierra Leone, Kosovo and Bosnia. Russia, a co-sponsor of the Middle East peace process, has also become increasingly involved in attempts at mediation, drawn in by the Palestinian leader Yasser Arafat to offset what he regards as pro-Israeli bias by the main mediator, the U.S.

> Mr. Arafat on Friday met Russia's President Vladimir Putin, who arranged a telephone conversation for him with Israel's Prime Minister Ehud Barak—the first time that the two men had spoken in three weeks. They agreed to renew low-level security ties, including the work of 10 joint liaison offices, which were closed last week after an Israeli soldier was killed at one.

> Before the fighting began two months ago, the liaison offices were a symbol of co-operation, albeit limited, between Israelis and Palestinians. The two sides conducted joint security patrols and worked out day-today problems in the field. Increased diplomatic efforts have had little effect on the conflict on the ground, where casualties are still mounting. Four Palestinians were killed yesterday, including a 13-year-old boy, and more than 30 injured in clashes on the West Bank as the plan for Israeli and Palestinian security forces to resume limited field-level co-operation failed to take hold.

> Israeli soldiers at the liaison office in the southern Gaza Strip came under fire yesterday and shot back, said an army spokesman. He added that Palestinian security officers turned up at other liaison offices in Gaza and the West Bank, but there was no co-operation.

> [JR: It is interesting that the UN and the U.S. and other major European nations are walking on eggs as to the phrasing of the title of an observer team that would be "acceptable to Israel". No one asked permission of Yugoslavia on what would be an acceptable reason to send a NATO force into Kosovo to push the Serbs out. In that case, there was a bias agenda behind the illegal invasion of a sovereign state where the Western coalition was against them—and there were no threats of being called anti-Semite.]

ISRAEL COULD BE FORCED TO ACCEPT OBSERVER MISSION

Senior Israeli officials have conceded that they may be forced to accept the deployment of an international observer force, following a week of intense diplomatic pressure from Britain, France and the United States.

Continuing negotiations in New York have persuaded officials that, despite their opposition to the creation of an observer mission to monitor the violence, as demanded by Palestinian President Yasser Arafat, they may be forced to back down to keep the support of the U.S. and other key allies.

The Observer understands that three options are under consideration. The first is a UN monitor force operating under the mandate of the UN Security Council and deployed on both Israeli and Palestinian sides of the confrontation lines.

The unarmed force would be multinational in flavour and several hundred strong. Although favoured by the permanent members of the Security Council, the principal Israeli objection stems from its complaint that the 'non-aligned' countries sitting on the council are often pro-Palestinian.

countries such as the U.S., France, Britain and Norway operating as an invited force, but not under UN auspices. The third option—considered the least likely—would see a force placed under the umbrella of the commission of inquiry into the present violence being led by the former U.S. senator and Northern Ireland peace negotiator, George Mitchell.

Israel objects in principle to the deployment of an observer force, saying it suits the Palestinian agenda of attempting to "internationalise" the crisis and dilute America's influence in the peace process, which Palestinians claim favours Israel. Israel claims that the deployment of the force would 'reward' the Palestinians for their violence.

The moves came as Palestinian reformers launched an attack on the culture of cronyism and corruption surrounding Arafat.

In the first signs of a genuine split within Arafat's Fatah movement—between the old guard that sustained Arafat in exile abroad and a younger generation that grew up in Palestine itself—a leading Fatah activist last week accused corrupt officials of endangering the twomonth-old Al Aqsa intifada.

The Palestinian newspaper Al-Hayat al-Jadida last week called for an "institutional uprising" to remove crooked officials. In his article, writer Kamal al-Astal said the Palestinian leadership was jeopardising the "blood of martyrs". He accused Arafat's officials of using their positions for personal gain.

PUTIN BROKERS ARAFAT-BARAK TALK

MOSCOW (AP)—In his first plunge into Mideast peacemaking, President Vladimir Putin on Friday raised Russia's previously low profile by arranging for Palestinian leader Yasser Arafat and Israeli Prime Minister Ehud Barak to speak by phone for the first time in three weeks.

Although Russia is a co-sponsor of the Mideast peace process, its role has been relatively small compared with

been making a new push to exert influence.

Analysts say that Russia could now be in a significant position in the process. That perception was underlined later Friday when Israel announced that Foreign Minister Shlomo Ben-Ami would visit Moscow at an unspecified date next week.

In the Friday phone call, which came during Putin's meeting in the Kremlin with Arafat, the Israeli and Palestinian leaders agreed to resume low-level security cooperation. Arafat also promised Barak to do everything to stop violence.

Sergei Markov, the head of the independent Institute of Political Studies, said Putin succeeded in Friday's phone call because Russia is "the only mediator which is trusted by both sides".

"The peace process has largely been undermined by A second option would be for a mission drawn from the pro-Israeli position of the United States," Arafat aide Saeb Erekat said in an interview published on Friday in the daily Vremya Novostei. "Russia is our friend, and stands for an independent Palestinian state with a capital in the eastern part of Jerusalem."

> In Washington, State Department spokesman Phil Reeker said "it is important for all nations and leaders to encourage Palestinians and Israelis to do everything possible to end the continued cycle of violence."

> "We welcome efforts made by other nations to help the parties end the violence, restore calm, and work their way back to the negotiating table," he said.

> Welcoming Arafat at the start of their talks, Putin said that an end to violence was essential for any diplomatic effort to succeed.

> "We are absolutely convinced that any meetings and efforts would be useless if we fail to reduce the degree of confrontation and violence in the Middle East," Putin said.

> The meeting with Arafat was Putin's debut in Mideast peacemaking, which until now has been in the hands of Foreign Minister Igor Ivanov.

> Arafat's trip followed two months of fighting between Israelis and Palestinians, in which more than 260 people have been killed.

> "The violence has reached an alarming degree," said Markov, the analyst. "Previously all they wanted was money, but with the events spinning out of control they now desperately need a mediator."

> "Barak and, especially, Arafat have been losing control over the situation," Markov said. "If they fail to find a solution, they will be forgotten in half a year."

> Arafat said he was grateful to Putin for accepting his initiative to visit Moscow.

> "We cannot forget that Russia is also responsible for the peace process and they have a critical role in this issue," Arafat said after arriving.

Arafat left Moscow on Friday night.

"We believe that in view of the very dangerous situation which borders on war, both sides must show resolve, wisdom and meet each other halfway," Russian Deputy Foreign Minister Alexander Avdeyev told reporters after Friday's talks.

Russia's relatively small role in the peace process became evident last month when Moscow was left out of an emergency Mideast summit in Sharm el-Sheik, Egypt. ANALYSIS: THE POWER OF PUTIN

It was not quite Camp David. But when Russian President Vladimir Putin called Israeli Prime Minister Yehud Barak and then persuaded Yasser Arafat to take over the phone, it was a key sign that the United States was no longer the only big power playing broker in the Middle East.

Excluded from last month's Sharm-el-Sheikh summit, despite being a nominal co-sponsor of the Middle East peace process, Russia showed it could bring the Israeli and Palestinian leaders back into direct contact something which the White House had failed to do.

Putin, a former KGB agent who was hand-picked by Boris Yeltsin to replace him in the Kremlin, is getting a taste for the world stage.

Two days before PLO leader Yasser Arafat flew to Moscow to make what could be a breakthrough phone call to Barak, Putin was hosting British Prime Minister Tony Blair, and giving his blessing to the new European Union's plan to build its own 60,000-strong peacekeeping force. Last month, the Russian president was in Paris, to join President Jacques Chirac in criticizing U.S. proposals to develop an anti-ballistic missile defense system.

"He is a strong leader, a patriotic leader. I don't think that's a bad thing," said Blair. "I know people say there is a risk in being so close with Russia and President Putin, but I think this is something that is well worth doing." "The important thing for Britain is stability in Russia. President Putin is someone who is trying not just to do his best for Russia, but in respect of Russia and its relations with the outside world," Blair added, and made a point of describing the Russian leader as 'my friend'.

But on the eve of the Blair visit, (his fifth meeting with the Russian leader this year), President Putin summoned a conference of his senior generals and admirals in Moscow, and declared: "No one will be allowed to resolve issues with Russia from a position of force." President Putin also announced a re-organization of the Russian arms exports system, with the goal of matching the United States as the biggest arms exporter. Russia currently holds fourth place, after the U.S., Britain and France. And when Israel bowed to U.S. pressure last month and blocked the sale to China of an advanced airborne early-warning system (AWACS), Russia stepped into the gap.

Then Russian Foreign Minister Igor Ivanov curtly informed the U.S. State Department that Moscow felt no longer bound by the secret 1995 deal to end arms shipments to Iran this year. News of the deal, reached between Vice President Al Gore and then-Russian Premier Viktor Chernomyrdin, embarrassed Gore in the last weeks of the U.S. presidential election campaign.

Arms sales play a key role in Putin's strategy to rebuild Russia's international influence. In August, he hosted Libyan foreign minister Abdel Rahman Shelgan for a Kremlin signing ceremony on a \$500 millions arms deal under which Russia would modernize Libya's obsolescent armed forces.

SEPARATION WOULD REDUCE ISRAELI-PALESTINIAN CONFLICT

WASHINGTON—Perhaps most Americans during these past two bizarre weeks believe that Florida really is the vortex of the world, but the undeniable fact remains that there are other places and causes beyond the House of Chads.

We have hardly heard anything about the Middle East recently. Yet profound changes are taking place in the now 2-month-old crisis that will shape the area for decades to come.

Israel, out of a new philosophy but also out of a gathering desperation over the rising violence, is slipping further toward the idea of a "separation" of the two peoples. Prime Minister Ehud Barak has hesitantly put forward the idea ever since he came into office two years ago, but now it is taking hold in Israeli minds.

Speaking of the, until now, prevalent idea that the Israeli people and the Palestinian people should be integrated, one of Hebrew University's most respected political scientists discussed with me the failure of this seminal idea during his stay at the Carnegie Endowment for International Peace here.

For a country seen as an economic basket case when context for an agreement," professor Shlomo Avineri told me, "but it is now turning out that the development of the two peoples is too uneven. The agreement was being compared to relations between France and Germany after World War II—but the European union was possible because both countries are at the same level of development. > The overall Arab side, meanwhile, has been characterized by a very careful response of the constituted Arab governments, whether Egypt, Jordan, Kuwait or Oman, to the new but as yet unconsolidated anger on the pro-Palestinian "Arab street".

> Despite early Israeli and American fears, for instance, that moderate Arab governments would be forced by the street sentiment to act strongly against Israel, those leaders have cautiously avoided past mistakes. They have also cleverly used and nurtured pro-Palestinian activism as the only activism permitted in virtually all of the Arab countries.

> On the other hand, this Palestinian/Israeli conflict is making unparalleled waves across the Arab world. For the first time, due to the new and far more independent Al Jazeera satellite television station in the Persian Gulf state of Qatar, Arabs across the region are seeing firsthand seething coverage of the fighting. And in another ominous development, elitist Arab intellectuals are using trips to Baghdad, where Saddam Hussein now poses as Saladin, the Arab warrior who defeated the Crusaders, to express their rage against Israel.

> The least recognized development is the extent to which the tenets of U.S. policy toward the conflictwhich have been essentially to meld the two peoples together through active cooperation and collective bargaining—lie in tatters. The once-promising "security cooperation" between Israeli and Palestinian forces, midwived by the CIA, has collapsed. The naive idea that progress was somehow being made so long as the two sides were "speaking" is laid bare.

> U.S. "development aid", paired with the misconception that almost any economic development would gradually but automatically drain away the humiliation of occupation, has actually enhanced that pain. The Palestinians have seen their incomes and power fall

> The idea of a separation of the two peoples is not only the best, but very likely the only, potential solution. Separation has many pitfalls, but it would at one stroke remove the resentment and dependency in the "colonial" Israeli-Palestinian relationship. The Palestinians would be on their own: to make their own mistakes and hold their own leaders accountable.

> Then the two peoples could perhaps learn how to

EGYPT WARNS U.S. OF REGIONAL WAR **IF VIOLENCE CONTINUES**

CAIRO—Egypt has warned the United States of an Arab war against Israel if the violence continues in the West Bank and Gaza Strip.

The warning was relayed by Egyptian President Hosni Mubarak to U.S. Defense Secretary William Cohen during their meeting in Cairo on Wednesday, said Arab diplomatic sources. The sources said Mubarak said the Arabs cannot stand by while the Palestinians are being attacked by Israel.

Mubarak was quoted as telling Cohen that Egypt would not return its ambassador to Israel until the violence ended against the Palestinians. Cohen urged Mubarak to reverse his decision to recall ambassador Mohammed Bassiouny, who returned to Egypt on Wednesday.

The Egyptian president also gave Cohen a letter to Barak. The letter said the first priority for Israel is to end the violence, a reference to Barak's opposition to the work of an international committee of enquiry to investigate the eight-week-old mini-war.

Mubarak's terms were issued as Palestinian Authority Chairman Yasser Arafat arrived in Cairo. Arafat urged Mubarak to obtain funding for Palestinians on the eve of Thursday's meeting of Arab finance ministers.

Arab League finance ministers were scheduled to be addressed by Arafat. Last month, Arab leaders pledged to grant the Palestinians \$1 billion in aid.

But Gulf countries, particularly Kuwait, have opposed a transfer of funds to Arafat. Instead, they proposed that the funding be sent directly to the Palestinians.

The finance ministers are expected to discuss a mechanism for the funding.

With low unemployment and strong purchasing power, the United States is serving as the locomotive for a less-robust global economy relying on our vast market for material goods.

GLOBAL GOVERNANCE ERUPTS AT THE HAGUE

THE HAGUE—Jacques Chirac, president of France, told the delegates negotiating the Kyoto Protocol in The Hague, that the Protocol is an important step toward global governance. Most of the 8,000 delegates and observers enthusiastically embrace the idea of a United Nations agency mandating energy policy for 38 developed nations. There are a few notable exceptions.

The U.S. congressional delegation was on hand to hear the French president link the Protocol to the UN's global governance agenda. In private conversations after the day's business was concluded, Sen. Chuck Hagel had sharp words of disapproval of attempts to transform the UN into a world government.

The Protocol, as conceived, though not yet fully negotiated, would give the UN body a double-whammy club to beat up on 38 developed nations. First, by setting emissions targets, the UN body would be able to effectively dictate the fossil fuel energy that a developed nation might use. Second, the UN would have the authority to "enforce" compliance, using procedures, sanctions and penalties that have not yet been defined.

Americans would not likely stand for an international law that openly gives the UN the power to set energyuse limits. So instead of attacking the input end of the energy pipe, the politically astute UN machinery is attacking the output end of the energy pipe. "Controlling emissions" is said to be the goal, and is presented as necessary to save the planet. Controlling energy use is wealth, with little or no impact on the planet.

The penalty for non-compliance has presented a particularly thorny problem, because most of the 38 developed nations will be unable to meet their agreed targets. This means that most of the affected nations will have to pay the costs-whatever they are-once the decision is taken. Consequently, compliance negotiations go on behind closed doors, with periodic reports that "some progress has been made". These negotiations have been ongoing for three years—since the Kyoto Protocol was adopted in 1997.

Chirac's global governance announcement could be As the money keeps flowing in, American the straw that breaks the back of the entire Protocol. After eight days of intense negotiations, there has been little movement on three major issues that must be resolved: emissions trading, carbon sinks and penalties for non-compliance. Add to these unresolved issues the implications of global governance, and the entire process could easily unravel.

> Perhaps this would be the best possible outcome of COP 6—admission by the delegates that the Protocol they pieced together in Kyoto is simply unworkable.

> One of the many problems with this fatally flawed Protocol is that it attempts to do two things at once: 1) reduce carbon dioxide emissions in the atmosphere and 2) empower the United Nations to enforce those reductions. Either of these two objectives is a formidable undertaking. As the delegates have struggled over the last six years, it has become increasingly apparent that empowering the UN has become more important than reducing emissions.

> Having heard Jacques Chirac say, not once, but twice, during his presentation, that global governance is the larger objective, the congressional delegations will have a new dimension to report to their colleagues

when they return to Washington.

Regardless of the decisions that are taken—or not taken—during this two-week session, the delegates will find some way to save face. One scenario being discussed in the halls is the "Kyoto scenario". This is a situation—as occurred in Kyoto—in which no agreement was reached until the last day, several hours after the scheduled adjournment. Delegates could again go into closed session late in the week, and stay in session until the last minute, and then simply announce that agreement has been reached on some of the important issues.

Credence was attached to this scenario when rumors spread through the halls that the U.S. would cave-in on up to 60 percent of the outstanding questions about carbon sinks. The European Union and the U.S. have been at odds on this issue since Kyoto. Environmental extremists have been lobbying heavily for the delegates to reject the U.S. position.

Adding to the uncertainty here is the uncertainty in the U.S. Presidential race. Some speculation has emerged that should George Bush be declared the winner, the U.S. delegation might withdraw resistance to all outstanding issues in order to advance the Protocol as far as possible before a new slate of delegates is appointed by a new administration.

Publicly, the U.S. delegation says that the present administration will be in place until Jan. 20, and the elections struggle has no effect on their negotiating positions. Traditionally, the rumors in the halls tend to be very accurate.

By the end of the week, the delegates will prove or disprove the rumors, and some kind of face-saving document will be applauded as progress. It will not likely repeat Jacques Chirac's reference to global governance. But like a stone once thrown, his words cannot be recalled, and his words will have an impact wherever they land. His words will land in the U.S. Congress, and they will land across America.

Those skeptics who have been unwilling to believe that the UN is, indeed, contriving a world government need only to listen to the president of France.

5.3 MILLION CONTRACTED HIV IN 2000

GROUP SAYS SUB-SAHARAN AFRICA HARDEST-HIT REGION

GENEVA—An estimated 5.3 million people, including 600,000 children under age 15, were infected with HIV/ AIDS this year, the World Health Organization said Friday. This is the first year that the number of new

infections in sub-Saharan Africa appeared to have stabilized, but that was offset by increases in morbiditythe rate the disease was contracted—and mortality in the same region during 2000.

An estimated 3.8 million people in the region were newly infected with HIV this year, as opposed to a total of 4 million there during 1999. The region is home to about one-tenth of the world's population but remains the world's hardest-hit. Not only did it account for 72 percent of new HIV infections last year, but the region also had 70 percent of the people living with HIV/AIDS and 80 percent of the AIDS deaths in the past year, WHO's Weekly Epidemiological Record said.

The adults are split almost equally between men and women, with an estimated 18.2 million men age 15 to 49 living with the named president of Congress last week, came as a relief disease, the UN health agency said. Overall, the number of new HIV infections in these countries "has remained relatively constant over the past few years," it said.

WHO statistics showed that the United States and Canada had an estimated 920,000 people living with HIV/ AIDS, with approximately 45,000 new cases this year.

An additional 540,000 victims live in Western Europe, which had about 30,000 new infections in 2000. Australia and New Zealand have an estimated 15,000 people infected with the disease, and about 500 new infections this year, the report added.

BOLIVIA: BECHTEL CORPORATION AT THE ROOT OF CIVIL UNREST

Bolivia, that landlocked country high in the Andes, which few in the U.S. ever think about, has been in the news. A week of enormous, often violent, civil uprisings here left at least seven people dead, more than a hundred others injured and flashed pictures of the nation abroad that made government leaders here very nervous for their and the nation's foreign image. Quick to put blame in the easiest place possible, government spokesman Ronald MacLean told the few international reporters here Monday, "I want to denounce the subversive attitude absolutely politically financed by narcotraffickers."

For reporters and editors who have never been here it may be an easy line to swallow, but it would take about two minutes on the ground to figure out how big a lie the Bolivian government seeks to spin. The issue in the past week's uprisings had nothing to do with drugs, it was about water. The culprits weren't narcotraffickers hiding out in the jungle but the well-tailored executives of the Bechtel Corporation sitting smugly in their downtown San Francisco offices a hemisphere away.

The roots of the uprisings here began last year when, under heavy pressure from the World Bank, the Bolivian government sold off Cochabamba's public water system to a Bechtel

numbers are confidential "intellectual property". What is very clear, however, is that Bechtel's people here were intent on getting as much as they could as fast as they could out of the people's pockets in South America's poorest country. Within weeks of hoisting their new corporate logo over local water facilities the Bechtel subsidiary hit local water users with rate hikes of double and more. Families earning a minimum wage of less than \$100 per month were told to fork over \$20 and more, or have the tap shut off.

Tanya Paredes, a mother of five who supports her family as a clothes-knitter was hit with an increase of \$15 per month. For Bechtel's CEO, Riley Bechtel, that's snack money at Fisherman's Wharf. For Parades it's her family's food budget for a week and a half.

It should have come as no surprise to Riley Bechtel or the Bolivian government that increases like these would send people into the streets, which it did. In January Cochabambinos shut down their city for four straight days with general strikes and transportation stoppages. The Bolivian government promised to force rates down, seeking to end the protests, promises broken within a few weeks. When thousands tried to march peacefully here on February 4th, President Hugo Banzer (Bolivia's Pinochet-style dictator for most of the 1970s) returned to his old ways, calling out the police and hammering people with two days of tear gas that left 175 injured and two youths blinded.

After months of promises made and broken by the government and Bechtel's company, the people of Cochabamba made it clear they'd had enough. In a popular survey of more than 60,000 residents last month, 90% said it was time for Mr. Bechtel's subsidiary to go and return the water system to public control. When residents here staged a final city shutdown starting last Tuesday, the Bolivian government came to the corporation's rescue, saying the company must not leave.

When the protest, overwhelmingly supported by people here, refused to back down after four days the Bolivian government declared a "state of siege" arresting protest leaders from their beds in the dark of night, shutting radio stations down in mid-sentence, and sending soldiers into the street with live bullets. On Saturday afternoon when 17-year-old Victor Hugo Daza was killed by a shot through his face it had finally come to the ultimate penalty for challenging Bechtel's control of <u>local water—death</u>. As protest leader Oscar Olivera said in a statement afterwards, "The blood spilled in Cochabamba carries the fingerprints of Bechtel [and the Workd Bank]."

It is true that the strength and international attention of Cochabamba's water protests did embolden, and become linked with, other protests around the country, marches by people in the countryside over a new law taking away control of rural water systems, a police strike in the capital city of La Paz, complaints about unfinished highways in other areas of the country. But when people marched 70 miles on foot from small towns to joint the protest, when women came door to door in my neighborhood gathering food donations to cook and take to the people at the conflict's center, narcotrafficking had about as much to do with it as Elian and Fidel.

In the middle of the protest, the mayor of a small town outside of the city explained to me, "This is a struggle for justice, and for the removal of an

outrageously high." Late Monday it appeared that Bolivians had gotten their way, as government officials released a letter it had sent to company executives, accusing them of fleeing the country and, therefor, ranged from nil to negative, therefore, it provides very nullifying the contract they signed last year.

Tuesday morning Bechtel released a statement of its own. Like the Banzer government, Bechtel sought to pin the blame on anything but themselves. If Riley Bechtel has any 100,000 angry Bolivian mothers who would love nothing better than to steer him straight.

 - 7. Rising Commodity Prices. Commodity prices have been on the rise for months, but gold has not kept pace. Base metals, raw materials and energy prices are all up. Meanwhile, gold prices have been lagging. History has shown that a wide disparity between commodity prices and gold does not persist for long. The price of oil has tripled over the past year and a half. In the final analysis, a significant, sustained rise in oil From 1979 to 1999, the Average Annual price prices is likely to exert an upward pull on gold prices. An oil price rise also tends to increase inflation. The two major upward moves in the price of oil in the 1970s were accompanied by increases in the price of gold.
 - 8. The Best News for the Dollar is Behind Us. For some time now, the price of gold has languished under the weight of a strong U.S. dollar. Because the dollar is the world's reserve currency and gold is priced in dollars, a strong dollar tends to depress the price of gold. It also attracts investors to U.S. stocks and bonds, particularly Treasuries. With our huge trade deficit, growing oil imports, and newly volatile stock market, the dollar could start losing ground. Should the dollar's decline be sustained, gold will benefit on two fronts. First, because gold is priced in dollars, as the value of the dollar declines, the price of gold will tend to increase. Second, as the value of the dollar declines, foreign investment in U.S. stocks and bonds will decline, adding to the negative momentum in those markets. This will indirectly boost investment demand for gold.
 - **9. Rising Interest Rates**. There is an old saying in the investment world: "Don't fight the Fed." Statements coming out of the Fed seem to indicate that, when election season ends, we can expect another round of interest-rate hikes. This will

- 10. World Tensions. These two events also touched off volatility on Wall Street and a short, sharp spike in gold prices. Unfortunately, these two incidents are likely only a small taste of what is to come. To many Americans, it appears that trouble spots have been appearing overnight. Actually, there are a host of potential hot spots and enemies that could cause trouble for the financial markets over the next several years: Iran, Iraq, China-Taiwan, North Korea, Colombia, Libya, India-Pakistan, and Israel just to name a few.
- 11. America's Mushrooming Trade Deficit. 5. Demand Fundamentals. ENRILE PROPOSES "WINNER-TAKE-ALL" **IMPEACHMENT TRIAL BY SENATORS**

Sen. Juan Ponce Enrile proposed yesterday what he described as a "winner-take-all" formula in the trial of the impeachment case against President Estrada.

He explained that the scheme involved the raffling off of a particular article of impeachment that will be heard and decided by the Senate.

"If the President is guilty on or innocent on one count, then the trial is over," Enrile said in his weekly radio program with Sen. Juan Flavier.

Enrile's proposal came on the heels of a suggestion by Makati City Rep. Joker Arroyo that the Senate conduct a piecemeal trial of the case, meaning the four articles of impeachment would be heard and decided one after the other.

The House of Representatives has impeached Mr. Estrada on charges of bribery, graft and corruption, culpable violation of the Constitution and betrayal of public trust.

Enrile claimed that a piecemeal trial would be unfair to the President because the Senate impeachment tribunal cannot isolate evidence and witnesses based on the specific charges.

He said that under his formula, the impeachment tribunal, in consultation with the 11-member prosecution panel from the House of Representatives, would pick

which among the four charges will be heard and decided.

Enrile added that the so-called "winner-take-all" setup will speed up the impeachment process and enable the senators to finish the trial within one month as set by Senate President Aquilino Pimentel Jr.

At the same time, Enrile reminded the prosecution panel that it would be the senators who will control, direct and make the ultimate judgment on Mr. Estrada's fate.

"The Senate will decide if the evidence presented will be accepted or not," Enrile said.

The impeachment trial starts on Thursday, capping a two-month political and economic chaos sparked by charges that the President received more than P400 million in bribes from illegal gambling operators and P130 million in kickbacks from tobacco excise taxes intended for Ilocos Sur.

The accusations were hurled by former political ally and drinking buddy Ilocos Sur Gov. Luis "Chavit" Singson.

Playing a dual role of judge and jury, the 22 senators will hear the arguments and evaluate the evidence presented by the House prosecution team to substantiate the charges against the 63-year-old former movie actor.

Under the Constitution, the Senate will render justice to an impeached president by a two-thirds vote of the chamber.

Pimentel said their verdict "will show the world whether or not we are a working democracy, or that we only have the facade of democracy."

"Our duty is to find the President guilty if the evidence so warrants, (or) innocent if the evidence presented by the prosecution falls short of being clear and convincing as our respective consciences see it," he stressed.

Pimentel expressed confidence the trial will be completed within the month even as the prosecutors and defense lawyers feared it will drag on until early next year when the campaign period for the May 2001 elections officially starts, forcing a break in the hearings.

Iloilo City Rep. Raul Gonzalez, a member of the witnesses could prolong the trial until February.

Some senators, however, were banking on the expertise of Chief Justice Hilario Davide Jr., who will preside over the trial, to shorten the process by limiting the number of witnesses to be called and documents to be presented.

Davide has demonstrated his firmness when he junked a motion by defense lawyers to quash the impeachment case on technicalities last week.

"The country is bleeding. I think it is in the best interest of the prosecution, the defense and the country that this (trial) is ended as soon as possible," Sen. Raul Roco said.

Pampanga Rep. Oscar Rodriguez, a member of the prosecution panel, said the piecemeal formula would be messy. Of the four charges, the bribery and corruption charges appeared to be the strongest. "The witnesses in the case are directly involved," he said.

He pointed out that the testimony of former Securities and Exchange Commission chairman Perfecto Yasay Jr. would carry much weight.

AFP READY TO BACK ARROYO—MERCADO

CLARK FIELD—Defense Secretary Orlando Mercado said here Saturday the Armed Forces will support Vice President Gloria Macapagal-Arroyo in case President Estrada is convicted by the Senate in his impeachment trial and removed from office.

Speaking at a press conference after a meeting of the Presidential Commission on the Visiting Forces Agreement, Mercado said the officers and men of the AFP have assured him that they will remain loyal to the Constitution and whoever is commander-in-chief.

"I have met with the hierarchy of the services—the Air Force, the Navy, including the Marines," he said. "In the Navy, I talked not only with the officers, men and women, but also the rank-and-file, and my message was simple—respect for the *Constitution* which we are sworn to protect, and uphold the institution that is the Armed Forces of the Philippines."

Mercado said he believes the President will honor any decision of the Senate—whether the impeachment tribunal convicts or acquits him.

"The President himself has stated publicly several prosecution team, said lengthy questioning of the times that he would not remain a minute longer if the verdict of the Senate is contrary to his position," he said.

PULSE ASIA SURVEY: MOST PINOYS WANT TRIAL FOR ESTRADA

Despite the almost daily rallies against President Estrada, most Filipinos still prefer an impeachment trial rather than a forced resignation in removing Mr. Estrada, according to a latest public opinion poll.

In a random survey of 300 Metro Manila residents— "As for the charge of culpable violation of the conducted daily from Nov. 16 to Dec. 2 by Pulse Asia at least 75 percent of the respondents agreed that "constitutional processes should be followed in trying to remove" the President.

On the other hand, about one out of 10 favored a He also discounted the possibility of a vacuum in the resignation ahead of the impeachment trial, while about Estrada's answer this Wednesday.

The survey, commissioned by and exclusive to *The* Rodriguez said Arroyo, Leyte Rep. Sergio Apostol STAR, has a margin of error of plus or minus six percentage points. It is designed to determine how senatorial race next year, prompting them to resign from Filipinos view political issues concerning the nation as the jueteng scandal drags on.

> From Nov. 16 to Dec. 2, the number of respondents favoring an impeachment trial remained basically steady, ranging from a low of 74 percent to a high of 78 percent.

> As for the number of those opposed, it ranged from a low nine percent to a high of 14 percent during the same period. The number of undecided ranged from 10 percent to 14 percent.

> In the same poll, those who believed that Mr. Estrada should not resign outnumbered those who believed that the President should be kicked out right away.

> From Nov. 16 to Dec. 2, the number of Filipinos who said Mr. Estrada should not resign ranged from 42 percent to 50 percent, while the number of those who said he should immediately resign ranged from 31 percent to 39 percent.

> However, this does not mean that all of those who favored an impeachment trial automatically support Mr. Estrada, said political analyst Felipe Miranda, president of Pulse Asia.

> Many of the respondents interviewed for the survey were critical of the President, Miranda said, and they preferred an impeachment trial because they wanted Mr. Estrada to answer the impeachment charges against him.

> A resignation ahead of or during the impeachment trial, they pointed out, would allow Mr. Estrada to step down from the presidency without disputing the charges, Miranda said. "They want a demonstration of guilt," he said.

> Many said they were also keen on Mr. Estrada taking the stand and personally disputing the charges against him, Miranda said, adding that they also expect a fair trial.

> Miranda said many of the respondents also want the senators, who will sit as jurors in the historic trial, to be open-minded in the admission of evidence that will be used.

> That is because they expect Mr. Estrada's innocence or guilt to be proven beyond reasonable doubt, Miranda said.

> However, in a statement, Malacañang ruled out the possibility of Mr. Estrada testifying, saying there was no need for it because his lawyers believe that the case against their client is weak.

> Mr. Estrada earlier vowed to answer the charges against him "point by point" but then decided to heed his lawyers' advice for him not to take the stand.

> What the poll also means, Miranda said, is that Filipinos are not in favor of a coup in ousting Mr. Estrada.

> Mr. Estrada is accused of bribery, corruption, betrayal of public trust and culpable violation of the Constitution. The charges mainly stem from allegations made by estranged drinking buddy Ilocos Sur Gov. Luis Singson that Mr. Estrada accepted over P400 million in bribes from jueteng bosses and pocketed P130 million in tobacco taxes intended for Singson's province.

This Public Notice, however, presents the knowledge of ongoing interference from our counterparts to the agreements and the breaking of each and all of those said agreements to varying degrees of diversion tactics of manipulation, delays and actual stone-wall operations. We acknowledge, however, that we find no outright DENIALS of said program or document value, only delays and refusal to provide information regarding same. We have also noted the utilization of such organizations as the World Bank and IMF to effect the rejection of the use of the collateral through intimidation and bribes of central bank personnel. It is our position, therefore, that we are no longer bound by those agreements as published September 9, 1996.

Because they are sensible, however, two of the requirements will continue to be met: the first being the limit of \$5T per year (beginning in 1996 and thus aggregating \$30T by January 1, 2001) (this restriction will not apply, however, to project funding within the U.S.A.), and the second being the prohibition of any use of "high yield" or "rollover" trading programs, which we believe are being used to grossly inflate the supply of U.S. dollars in an effort to destabilize the financial system of the U.S.A., and thus the world.

Researchers have been able to easily establish that the original bearer bond, 3392-181, was reconfirmed, then reconformed and reissued as a jurat/contract of identifiable ownership to Cosmos Seafood Energy Marketing Ltd., a corporation set up by its owner and Chairman, Russell Herman. It may be helpful to researchers to know that the owners, officers, and directors of Cosmos are the same as those of GAIA, obviating the need for concern as to the legitimacy of those transfers from Cosmos to GAIA. The asset has been affirmed, albeit by default, as the property of GAIA, and is available for use.

To facilitate the distribution of the asset to deserving end-users, it has been determined, upon advice of counsel, to issue portions of the accrued interest in the form of DEEDs OF ASSIGNMENT FOR CONSIDERATION. Such DEEDs are specifically designed to be banking reserves and, for ease of bankers' understanding, are to be treated exactly as is other U.S. Treasury debt, since such debt is widely used as reserves by banks everywhere.

GAIA has issued some 1,200 DEEDs, worldwide, with a total value of several trillion U.S. dollars. Honoring our agreement, none (to our knowledge) have been issued to U.S. entities. That can be changed; GAIA would be willing and able to support such a program in the U.S., given the cooperation of the U.S. Such a program would offer ability for the U.S. to reclaim gold which has been moved out of the country and upon which the value of the dollar can have established and authentic VALUE affixed. As it is, allowing derivative-based so-called "high yield" trading programs is creating dollars in ever-increasing and uncontrollable amounts. If Alan Greenspan has any claim to managing the "prosperity" of the U.S., it is only that he has held the regulators at bay and prevented them from controlling, or eliminating, the proliferation of derivatives. It is the rapidly expanding money supply that makes such prosperity possible, but without basis it must one day implode. The use of the GAIA asset and the return to a gold standard for the currency would prevent such a catastrophe if implemented in time.

As its name implies, Global Alliance Investment Association intends to become an Association of Allied nations willing to Invest their time and resources, Globally, to achieve financial stability and complete sovereignty. In 1945 the Bretton Woods Agreement established the World Bank and IMF with, ostensibly, similar intentions. Unfortunately, those noble goals have been perverted and the institutions have become instruments of control and collection for the major international banks. While GAIA has no desire to "compete" with the IMF/WB, because it has become so clear that their former beneficiaries became debtors and are now victims to be bled dry, GAIA will have to defend itself from being denigrated for its preference for non-usurious "Islamic-type" banking, or for its recommendation of basing currencies upon gold so that inflation is eliminated and interest rates can be brought to 2-4% as they were in the 1800s and, in the U.S., until the 1940s. High interest rates kill business, put home ownership out of the reach of the masses, and enrich only the already rich.

GAIA intends to offer its collateral as the basis for the creation of many regional "monetary funds" to be maintained under local control, although the overall GAIA program will soon obviate the need for such funds, once the nations taste and feel sovereignty. Such regional funds could be used to free nations from the IMF/WB debt trap by "purchasing" the debt. However, by far the majority of GAIA DEEDs will be issued to all sorts of entities that need additional collateral to enable them to finance peaceful, beneficial projects.

Because the debt to GAIA is payable in gold, and the GAIA program requires that at least 50% of the value of the DEEDs issued be used to purchase gold, and that gold held in the funding bank for the Alliance, the effect is to create substantial reserves that can be drawn upon in emergencies, especially natural disasters. The money would be immediately available, not like the current situation wherein organizations like the UN must beg for the funds.


