#### MALTREATMENT OF JAILED **HEALER CONTINUES** By Don Harkins

After being sent to prison for the crime of helping people, the developer of a harmless and effective treatment for a neurological dysfunction continues to receive terrible treatment.

After his Oct. 19 conviction for violating Food and Drug Administration (FDA) labeling laws, Liquid Deprenyl Citrate (LDC) developer Jay Kimball, 60, while in the custody of the U.S. Marshals Service, was handcuffed, waist-chained, leg-ironed and, for no apparent reason, transported 150 miles from the Hillsborough County Jail (HCJ) to the Hendry County Jail in LaBelle, Fla.

Kimball was returned to HCJ Nov. 20 with numerous injuries.

An HCJ employee reportedly stated that Kimball must have been transported in error as, considering his age and the nature of his conviction, he should never have been sent to LaBelle.

LaBelle is a facility that has been described as a deplorable, inhuman and bacteria-infested hellhole.

Kimball was sentenced by Florida District Federal Judge Richard Lazzara to serve 13 years for "misbranding" LDC—a crime which would ordinarily earn [at maximum] a three-year prison stay.

On one hand the judge said to the prosecutors, "you

contrary I have seen testimony and received letters about how good the product is. No harm done."

Then on the other hand he stated: "Mr. Kimball does not respect authority; he does not respect the law."

Lazzara also stated that Kimball's actions were "anarchy" in order to justify sentencing Kimball to serve more than four times the federal sentencing guidelines for such a crime.

Though the FDA has been persecuting Kimball since LDC became available to victims of degenerative diseases such as Parkinson's in 1990, the federal agency admits that there has never been one consumer complaint or even one reported adverse reaction attributable to LDC.

To the contrary, the court and the FDA have been provided with the results of 3,000 clinical case studies conducted by the University of Toronto which proved the product's safety and efficacy. The court was also provided hundreds of letters from LDC users who have had their quality of life returned to them with the help of the natural nutritive product derived from the ephedra plant.

based primarily on his defiance of non-scientific federal authority, U.S. marshals took custody of the 60-year-old man and justified further abuse with a false charging report produced by the Hillsborough County Sheriff's

The report, which follows Kimball through the "justice" system, stated as of Nov. 11 that Kimball had been convicted in federal court for manufacturing, distributing, dispensing and possessing cocaine.

According to Kimball, the speedometer in the transport van containing six male and two female prisoners with no seat belts in the vehicle except for the marshals, reportedly reached 100 miles per hour as it careened through traffic en route to LaBelle.

Kimball was catapulted out of his seat two times and suffered injuries to his shoulder for which he was denied medical attention when he arrived at the LaBelle facility. He also lost his voice and experienced difficulty breathing but was not allowed to see a doctor the entire time he was behind bars in LaBelle.

U.S. Marshal Vasquez, one of the transport deputies, subjected Kimball to a five-minute stream of extremely profane verbal abuse in front of LaBelle officials immediately prior to Kimball's return trip to Tampa, Kimball said. During the return trip Vasquez caused Kimball to fall again and injured his tailbone. Kimball did receive proper medical attention upon his return to HCJ.

Robin Hill of the U.S. Marshals Service office in Tampa refused to comment on her agency's treatment of Kimball but she did see to it that the charging report was changed.

The report, which is available on-line at http:// www.heso.tampa.fl.us/, has been changed to reflect a conviction for the manufacture, distribution and possession of "synthesized narcotics"—which is also and LDC is not a synthesized narcotic.

The U.S. Marshals Service is apparently insistent upon incorrectly identifying the nature of Kimball's conviction so that hardened prison officials who only know Kimball by what the "official" report tells them will treat him in the worst possible manner.

Whereas Aquinaldo's government-in-hiding was not recognized by any foreign power, much less by the entire inhabitants of the Philippine Islands.

But even assuming that we were, in fact, "independent" on June 12, 1898, was it historically appropriate to celebrate our "Centennial" on June 12, 1998? What happened to the 48 years of our dependence on the United States? Was 48 years of dependence added to 52 years of independence, thereby producing a result of 100 **DEFENSE.** Except for the Philippine Air years? #### FOR ISRAELIS, REFUGEE ISSUE IN PEACEMAKING IS POINT OF NO RETURN

JERUSALEM (AP)—Tsvi Michaeli is doing the math on his fingers: Israel's present population of 5 million Jews and 1 million Israeli Arabs plus 4 million Palestinians who have dreamed for generations of recovering the land they lost to Israel.

But like most Israelis, the 27-year-old Jerusalem hairdresser already knows the numbers by heart, totals in a demographic deadlock that looms as the possible breaking point of any Israeli-Palestinian accord.

"Five million of us, 5 million Arabs," Michaeli says. "You know how this place looks on a globe? It's a point." He stabs the air for emphasis.

"How can this be, and it still be Israel?"

Israelis disagree among themselves on peace proposals. But all seem to agree on the impossibility of the Palestinians' demand that Israel allow the return of millions of Palestinians from decades-old refugee camps in neighboring Arab countries and other sites.

It would be national suicide, even the most peaceminded Israeli politicians contend.

"It's the one issue which no Israeli I know of will compromise over," said Benny Morris, one of a new generation of Israeli historians who have challenged Israel's official version of its founding in 1948.

Israelis have long said the Palestinian exodus was largely spurred by Arab leaders' promises to annihilate Israel and return the refugees to their land.

Palestinians say, instead, that they were chased out by Israeli forces. The two sides disagree on numbers as well. The Israelis say the refugees total less than the United Nations figure of 750,000; the Palestinians say it's more.

According to Morris' research, military attacks or expulsion drove out residents in 228 of the 369 Arab villages then in Israel; another 90 of the communities fled in panic.

Israelis saw keeping the refugees out as a

Some villages were destroyed in fighting, others were razed; the Israelis simply built over others as the years your old house," said Tamara Elkoshi, a 55-year-old passed. Many homes and villages that Palestinians want to return to no longer exist.

Israel's "Law of Return," meanwhile, became enshrined as a tenet of the new Jewish nation promising any Jew, anywhere, citizenship and a home in Israel.

It is that law which enabled Michaeli's ancestors to immigrate here from Poland and elsewhere. The hairdresser's cubbyhole of a salon stands on a west Jerusalem street lined by graceful arcaded stone villas where well-to-do Arabs lived before 1948.

"It's my land. I'm Jewish, and this is a Jewish state," says 18-year-old Chen Almchios, selling mixed nuts at a three-tier shopping mall built on the site of a destroyed Palestinian village, Malha. "The Bible says, a state is the right of the Jewish people."

Generations later, families displaced from places such as Malha still live in UN-run refugee camps in Syria, Jordan, Lebanon, the Gaza Strip and the West Bank.

The Israelis charge that Arab governments would

rather maintain the camps as symbols of alleged Israeli persecution than absorb the inhabitants into their own populations. They maintain that the refugees of 1948 are balanced out by some 600,000 Jews who fled to Israel from Arab countries.

Palestinian officials adamantly reject a provision in President Clinton's peace plan that would have them renounce their long-held claim to the refugee families' right of return.

Many Israelis have assumed, and still hope, that in the end the Palestinians would do just that in exchange for Israeli concessions on other issues such as holy sites in Jerusalem.

It's not clear how many Palestinians—many of them now three or four generations removed from their old lives—actually would want to return.

But in the camps, return is seen as a birthright. People speak of a "refugee intefadeh", an uprising, if Palestinian leader Yasser Arafat concedes it.

For his part, Israeli Prime Minister Ehud Barak has been adamant: "The government under my leadership will not accept any agreement under any situation that will accept the 'right of return' in any shape or form," Barak said last week. Underscoring the point, Israel's Knesset passed the "Securing the Denial of the Right of Return Law" that requires lawmakers' approval for any Palestinian return.

Even those Israelis who acknowledge some blame for the refugee exodus say Israel cannot and should not reverse it, except to make financial restitution and accept limited family reunifications.

"There are many things that are acceptable to us. This is not acceptable to us," said Yael Dayan one of the most dovish Knesset members.

Without the displacement of hundreds of thousands of Palestinians, "there wouldn't have been a Jewish state," Morris said. "Whether it's right or not, if you believe there should have been a Jewish state, then this had to happen."

And now, what would happen if one of those displaced Palestinians were to wander through today's green, quiet Talbieh neighborhood in west Jerusalem, walk up to the site of their old home or garden, and knock?

"I would say 'Come, have a cup of tea, you can see resident of the area.

"I will be sympathetic: 'What happened to you was a tragedy. But you should know, a tragedy happened to us too. What would you do, if it would happen to you, such a tragedy?""

[JR: The Knesset was quick to pass the Securing the Denial of the Right of Return Law, so that it would no longer be an issue in future peace talks. When Israel in 1948 agreed to invoke UN Resolutions #181 and #194, she pledged that the Palestinian refugees driven from their lands and farms would be able to return home after the state of Israel was recognized. Can Israeli law now revoke both UN Resolutions #181 and #194 that the Israelis agreed to in order to obtain their statehood? The issue may be settled from the Israelis viewpoint but not from the Palestinian point of view. Israel alone gained their statehood by agreeing to the UN resolution and by confiscating and building on Arab-owned lands. The

#### PLAYING GOD

The latest round of peace talks in Washington has done little to dissuade the average Palestinian from continuing his anger and frustration towards the Israeli government and its army for their continued collective punishment.

it has ever gone in tightening the noose around the Palestinian population.

Side and minor roads, which were being utilized with great difficulty, to transport people from one location to another, have joined the major roads already closed in previous months.

Huge cement blocks and mounds of dirt have been strategically placed all over Palestinian territory, literally creating more than 40 islands in the West Bank.

Gaza, which is itself cut off from the outside world, has now been divided, by the Israeli army, into four areas. Travel between areas is forbidden.

Gaza International Airport and the Rafah crossing point to Egypt have been sealed. And the latest is the closure of the King Hussein bridge, which had been the only remaining exit-and-entry route for many Palestinians.

International law, which will soon be fortified by the International Criminal Court, forbids collective punishment of this kind. It is a violation of the Fourth Geneva Convention, which deals specifically with the responsibilities of military powers during periods of prolonged occupation. No reason is given for this collective indignity being heaped on more than three million Palestinians. We are not told whether this is for security purposes or, as many suspect, in the form of punishment and revenge. Neither are we told how long these latest restrictions will last. Will it last a day, a week, a month... no one knows. Considered akin to cattle, Palestinians are expected to adapt their lives to the whims of the all-powerful Israeli army.

The timing of this latest closure is connected to the recent Netanya bombing which has been publicly denounced by the Palestinian leadership. But few believe that such tactics will decrease, or in any way affect, the movements of those intent on carrying out such attacks.

The recall of permits recently issued to those with impeccable security status, and to members of the Palestinian Authority who have been granted VIP cards, will hardly affect individuals who are involved in suicide bombings and other violence.

Of course, the suspicion among Palestinians is that national internment in a large prison is part of the pressure that Israel is attempting to bring to bear on the Palestinian leadership, to force them to accept the "generous" Israeli offer.

Generosity is usually defined as people giving up something they own. It doesn't apply when an occupying power returns part of what it took by force to its original owners.

The U.S. and Israeli offers are extremely vague. The hope is that they can be enough to convince Palestinians to give Prime Minister Ehud Barak the support he needs to win the election; yet without the substance that will ensure the agreement's survival.

Short term interim agreements can afford to be

vague, but final-status agreements don't have the luxury.

This week's closures have been the harshest since 1967. No one can remember a time in the past 30 years in which such a tight closure has been implemented. At all times it was still possible to find a side road to travel on. If people were unable to use their own vehicles, they could rent a car in east Jerusalem.

If the road to the Ben-Gurion Airport was closed, the King Hussein bridge was traversable.

If the Gaza-West Bank road was off-limits, Gazans could utilize Gaza Airport. If the airport was closed there were the ground borders with Egypt.

This week all roads have been closed. People are, This week the Israeli government went the farthest for the first time, using animals to transport goods. Companies are driving trucks to unloading points and carrying cargo over newly established dirt mounds in order to reload them on other trucks from the Palestinian side.

#### SYRIA JOINS IRAQ, IRAN AGAINST ISRAEL

WASHINGTON (UPI)—Be careful what you wish for. You might get it. For years, if not decades, many U.S. and Israeli foreign-policy columnists regularly lamented that only the "lack of vision"—or courage, or anything you want to imagine—of Syrian President Hafez Assad was preventing Syria taking the "historic opportunity" of making peace with Israel.

Last year, tough old Assad, who had held Syria in an iron grip for a full 30 years, finally died, to be succeeded by his mild-mannered, Western-educated son Bashar, an eye-doctor by profession and an enthusiastic exponent of the economic wonders of the Internet.

Surely, progressive, forward-looking, young Bashar, so many of the Western experts and columnists said, would abandon the repressive, paranoid old ways of his father and lead his country out into a bold new era of engagement with the outside world.

And, indeed, he has.

But not the way they expected.

Bashar has launched a new era of Syrian foreign policy all right, but one that is on a collision course for war, not peace, with Israel; for confrontation, not engagement, with the United States; and for close military cooperation with Saddam Hussein in neighboring Iraq, not rejection of him.

Commercial air links are being resumed between Damascus and Baghdad for the first time in nearly 20 years. Iraq has responded by giving Iran permission to over-fly its territory when sending air shipments of arms and ammunition to the Iran and Syrian-backed Hezbollah (Party of God) Shiite militia in southern Lebanon.

Bashar, Middle East intelligence sources told UPI,

played the key role in brokering this agreement.

They also said that Bashar is working hard to achieve a rapprochement between historic enemies Iraq and Iran. Between 1980 and 1988 they fought the bloodiest war in modern Middle East history in which half a million people, at least three-quarters of them Iranians, died.

Bashar has even given the go-ahead for close military cooperation with Iraq. This involves, the sources said, joint planning for a coordinated response in the event of war with Israel.

Iraq has moved one of its few and precious armored divisions in recent weeks to the border with Syria, not to threaten Syria, but to be able to respond quickly in support of Damascus if hostilities erupt between Syria and the Jewish state. Late last year, Syria and Iraq, with no publicity, held joint military maneuvers, the first in their modern history.

The new spirit of cooperation extends to economic

Iraq and Syria hope this month or next to reopen a A friend of mine described the behavior of the major oil pipeline from the northern Iraqi oil fields through Syrian territory to the Lebanese Mediterranean port of Tripoli. It has not been used since 1982. Already, Syrian and Iraqi technicians are at work on the pipeline. In fact, Iraqi oil is already being refined in the Syrian city of Banias, the Middle East sources said.

> Bashar, one of the Middle East intelligence sources said, "has definitely embraced" a radically new concept for Syria. He has clearly approved a new strategic doctrine of cooperation with Iraq, Syria's historic regional rival, as well as with Iran, to create a powerful regional block of Iran, Iraq and Syria opposed to Israel and the United States.

> This move is a radical reversal of the cautious policies of Bashar's father for a full 30 years. Hafez Assad fought two fierce wars with Israel within six years. First, he directed Syrian forces in the 1967 Six-Day War, when he was Syria's minister of defense. Then, as president, he launched the 1973 Yom Kippur War, when his tough, massive tank army caught the Israelis by surprise and nearly swept them off the Golan Heights and across the Galillee to the Mediterranean before being held and rolled back.

> But after that, Assad followed a policy of more than 25 years of trying to avoid any outright direct conflict with the Israeli Army. Since the 1975 Israeli-Syrian disengagement agreement, not a single Israeli soldier or settler on Golan has been killed by direct Syrian action. In fact, Hafez Assad's greatest enemies were two fellow revolutionary Arab leaders of his own generation, Palestine Liberation Organization Chairman Yasser Arafat and President Saddam Hussein of neighboring Iraq. Syria and Iraq have always been rivals for the leadership of the Arab world, especially in the Fertile Crescent region they share. But ideological rivalries over the past 40 years have made things far worse. Both Saddam and Hafez Assad claimed to preside over the only true, ideologically pure regime of Baathism, or Arab Socialism.

> Hafez Assad always deeply distrusted and feared Saddam. Iraq has almost double Syria's population and vast oil wealth. When the United States mobilized a vast coalition and assembled a huge army of 700,000 men to roll Iraq out of Kuwait in the 1991 Gulf War, Hafez Assad joined them.

> Reversing this historic policy carries enormous risks for Bashar Assad. But it has major attractions to him as well.

The main risks are that he could blunder into a major war with Israel and that this time, unlike 1967 and 1973, Syria could be totally smashed. Then Bashar's Baathist regime, dominated by the Assad family's own Alawi religious sect concentrated around the mountainous western Syrian city of Latakia, could be swept from power. Or, by allowing the Iraqi military and security services to operate freely in Syria—a policy that was anathema to his father—Bashar could leave himself vulnerable to being toppled and killed in a coup plot orchestrated by Saddam.

But with all its risks, the policy of strategic alliance with Iraq also has many advantages for Bashar.

It is popular with the hawkish Alawite Baathists who dominate Syria's army and security services. They are filled with frustration at their inability to win a chance for military revenge against Israel, Middle East intelligence source say. And they are strongly supportive of this [new] policy.

Also, having been raised from childhood on the radical, anti-American ideology of Baathism, they want to expel the United States and its allies from the region, not come to terms with them.

A strong anti-U.S. and anti-Israel policy is also popular with Syria's Sunni Muslim majority, especially the radical fundamentalists among them. Hafez Assad slaughtered at least 10,000 of these people—possibly as many as 30,000—along with their families in 1982 when he used tanks and heavy artillery to literally flatten the city of Hama when it was in a state of insurrection, controlled by the Ikhwan, or Muslim Brotherhood.

Now Bashar, like his father before him, must take special pains not to offend Muslim religious leaders, especially radical ones, to avoid reopening that deadly old feud.

Finally, the policy of going radical and lining up with Saddam is also popular with Iran, which now fears the United States far more than it fears Iraq. It is also welcome to Hezbollah.

If Bashar instead had sought peace with Israel and closer ties with the United States, he would have risked being undermined, or even assassinated by Hezbollah and the Iranians.

In many respects, Bashar's policy is a product of weakness, not strength. Hafez Assad was strong enough to keep Saddam at arms length. Bashar is not. Hafez was strong enough to resist calls for a more radical, but risky policy towards Israel from his own generals and security chiefs. The young, inexperienced Bashar cannot afford to alienate them. Hafez could defy Iran on occasion. Bashar does not yet dare to.

For decades, U.S. and Israel analysts complained about Hafez Assad's supposedly baleful influence in the Middle East. Very soon, they may have cause to wish it was still there.

#### <u>CLINTON CREATES</u> <u>COUNTERINTELLIGENCE BOARD</u>

President Clinton has signed an order establishing a counterintelligence board that will bring together high-ranking FBI, CIA and Defense Department officials in an effort to devise a more effective strategy to combat spying, senior administration officials said yesterday.

Dubbed "CI-21", which stands for counterintelligence for the 21<sup>st</sup> Century, the "presidential decision directive" creates a board of directors chaired by FBI Director Louis J. Freeh that is charged with implementing a "pro-active" counterespionage program. The board will hire an executive who will be the federal government's foremost expert on counterintelligence, officials said.

"It is a dramatic change," a senior Clinton administration official said. "It is revolutionary in its focus and perspective."

In addition to Freeh, other members of the board will be the CIA deputy director, the deputy secretary of defense and a representative of the attorney general. The operation will be run out of offices at the CIA.

The presidential directive is significant, senior Clinton administration officials said, because it restructures the counterintelligence community by formalizing information-sharing without regard to borders or federal agencies. It also reflects a heightened focus on economic espionage and other types of spying, rather than solely emphasizing the protection of government secrets.

"We have always looked at spies and tried to figure out who was spying on us and what they were after," a senior administration official said. "Now, we are looking more at what it is we want to protect. We will no longer focus on embassies as the centers of foreign intelligence-gathering activities."

The CI-21 concept was developed in the aftermath of the Wen Ho Lee case and other security lapses that revealed systemic failures in sharing information about spying. While information will be shared and counterespionage strategy coordinated, the CIA will not be permitted to conduct surveillance activities in the United States [finished laughing?!]; its agents will continue to operate abroad.

Former FBI counterterrorism chief Bob Blitzer said CI-21 represents a major improvement. "It is a big change because of the deliberate focus" on counterespionage, Blitzer said. "This new structure will bring everyone together in terms of how to assess what is going on abroad, what is going on here, and what the entire intelligence community needs to do to counter past, present and emerging threats."

The first task of the board of directors will be to produce a study identifying American threats and vulnerabilities. And under CI-21, the National Security Council, composed of Cabinet-level secretaries with responsibility for security issues, also will have a new oversight role in counterintelligence.

# NATO'S DENIALS OF URANIUM OXIDE CONTAMINATION NOT REALITY

Assertions made by Kenneth Bacon, a Pentagon spokesman, that ammunition containing depleted uranium used by Americans in Bosnia and Kosovo could not cause oncological diseases in NATO servicemen do not conform to reality, says Major General Boris Alekseyev, chief of the environmental unit at Russia's Defence Ministry.

In his words, ammunition containing depleted-uranium cores, enhancing its armour-piercing power, were first applied by the anti-Iraqi coalition in 1991 during the Gulf War. 320 tons of shots containing depleted uranium were then used against Iraqi tanks and pillboxes.

The incidence of cancerous diseases in the locals grew 4.6 times after the Storm in the Desert operation had been over, the major general says.

Servicemen who had used the above weapons started to display heightened fatigue, head and muscle aches, loss of memory, difficulties in breathing

A mysterious disease was then for the first time mentioned—so-called the storm in the desert syndrome—which every  $7^{th}$  U.S. veteran of the Gulf War still suffers from.

Boris Alekseyev reminds that the syndrome caused such repercussions that the U.S. Congress demanded from the Pentagon a report explaining how depleted uranium affected men's health and the environment, *RIA Novosti* reports. So, the report has been submitted.

The document, in particular, says that "when a target is hit, over 70% of an armour-piercing core made of depleted uranium evaporates, contaminating the area with uranium oxides."

It also says that "if depleted uranium gets into the human body, it may cause chemical or radioactive damage," that is, radiation sickness.

According to Boris Alekseyev, servicemen who have handled such weapons, now undergo special regular medical checks.

In his view, this amounts to acknowledgement by the U.S. army command of a hazardous and lasting effect that depleted uranium has on man.

### Through Offset Deals, America Moves Defense Jobs and Technology Abroad

But because of a special kind of arms deal—that the jet's engine manufacturer, Pratt & Whitney, says was unavoidable—part of the aircraft's engines will be machined in Taiwan and then shipped back to the U.S. for assembly, irking U.S. defense workers who might otherwise have done the work.

That special type of deal is called an "offset" deal and it's become an increasingly expensive aspect of selling defense equipment to foreign governments.

The latest government data suggests several billion dollars worth of U.S. defense manufacturing work and technology and thousands of defense-sector jobs annually are traded abroad through the offsets demanded by foreign governments as conditions of arms deals.

Foreign countries "want to do more than just get the hardware from the United States," says Pat Scott, a spokesperson for the State Department's Office of Defense Trade Controls, which is responsible for restricting and approving defense offsets. "The trend is the desire to have U.S. technology and the ability to manufacture these items themselves, and to sell them."

Rebates for High-Tech Weaponry Offset deals are made when foreign countries successfully demand some form of compensation, a non-monetary rebate if you will, for purchasing armaments.

With international competition to win lucrative arms sales around the globe so fierce, the returns regularly surpass 100 percent of the value of the equipment purchased.

An offset arrangement can include sharing part of the manufacturing work of the purchased equipment. It can also involve transfers of American technology, licensed coproduction of the American equipment for U.S. troops or for sales to other countries, or other types of technological or economic benefits provided by the U.S. exporter.

The phenomenon has strategic thinkers concerned America is bartering away some of its technological edge. U.S. defense workers are concerned about losing jobs. And small- to medium-sized defense contractors worry about losing sub-contracting work.

Offsets have become such a concern, lately, the government has begun treating them as a priority. A congressionally required presidential commission recently was created to study the problem.

The commission, which met for the first time in December, includes the Secretaries of Defense, State and Labor, the director of the Office of Management and Budget, and the Deputy Secretary of Commerce, as well as the heads of the two biggest defense companies and the largest defense union.

Defense union leaders protested when Pratt & Whitney last January announced it would move jobs from Connecticut facilities to other countries to fulfill offset obligations with various countries.

But America's big defense contractors say they have little choice but to offer substantial offsets. Without them, they say, the U.S. would lose out on major arms deals. And with the U.S. government buying fewer arms since the Gulf War, they say, foreign sales are needed to keep their companies healthy and their work force employed....

Foreign arms sales secured through offsets currently account for about one third of current U.S. defense production, he says. "From the [prime contractors'] perspective, if they weren't winning that one-third sales, the production base would be one-third smaller."

The drawbacks of winning new deals with offsets, however, are also significant. U.S. defense companies trade away billions of dollars worth of U.S. manufacturing technology and work sometimes performed by smaller U.S. sub-contractors.

Over a recent six-year period (1993-98), U.S. arms manufacturers concluded \$38.5 billion in new arms deals—but they agreed to return \$21 billion in offsets, or 55 percent of the value, according to a draft of a Commerce Department study soon to be released.

Barber of the Center for Economic Organizating in Washington, D.C., told the presidential commission an analysis should be done to see if deals made with offsets have actually resulted in a net increase or loss in jobs for American workers.

The State Department reports last year issuing to U.S. companies a record number of 4,000 licenses for offshore defense manufacturing and related agreements.

Exporting that capability also can have nationalsecurity implications, says Tom Cardamone, executive director of the Council for a Livable World Education Fund arms control group in Washington, D.C. "It leaks U.S. weapons technology to countries that don't have it. And that proliferation of weapons technology is an important contributor to the continued militarization around the globe."

A similar concern was expressed in a recent U.S. intelligence community report forecasting future security threats to the United States. It predicted some U.S. military advantages could diminish "as weapons and militarily relevant technologies are moved rapidly and routinely across national borders in response to increasingly commercial rather than security calculations."

Surprisingly, the countries demanding some of the highest offset terms are some of America's closest, most economically stable and technologically advanced allies.

The United Kingdom, the Netherlands, Denmark, Sweden, Switzerland, Norway, and Germany all require offsets averaging more than 100 percent, according to a draft of the upcoming Commerce study. Canada, South Korea, Brazil, and Israel also demand such high offsets.

"The irony is that the more democratic the government, the more likely they are to have an offset program, because their parliamentarians are just like our congressmen, they want jobs for taxpayer revenue," says Johnson. "When you have a military in charge, they're less likely to have offsets, because they don't have to answer to the general public."

Offsets have become such big business in some countries, laws have been created requiring high offsets and bureaucracies were formed to negotiate and try to enforce the often-secret deals.

Boeing, a civilian and military contractor, recently said it does business with more than 225 U.K. companies, accounts for more than 40,000 U.K. jobs on an annual basis, and is Britain's third-largest export market, behind only the countries of the United States and Saudi Arabia.

But where economies abroad may be helped by offsets, workers in the country of origin can be hurt.

"At the same time we are transferring valuable technology developed by IAM members and paid for by U.S. taxpayers, we are also downsizing our work force and hence limiting our future ability to produce products for our own defense," said Thomas Buffenbarger, President of the International Association of Machinists and Aerospace Workers (IAMAW), recently. "For U.S. defense workers, this is an especially bitter pill to swallow."...

The AIA's Johnson notes that offsets are legal, and have become an essential way for American companies to compete in today's competitive global arms market. "We don't have export financing [to reduce prices] like our competitors. We can't bribe like our competitors, offsets are all we have," he says....

The one solution that everyone seems to agree on is While offsets help win U.S. companies and defense to negotiate with America's closest allies to agree to mutual restrictions on the levels of offsets. But because the offset deals are often secret it won't be easy, says Johnson. "It's just very hard to control."...

"I'd be hard-pressed to think of anything forthcoming out of it for the next five or six months." [JR: Our arms manufacturers don't seem to have a problem competing overseas even if it means eliminating U.S. jobs and compromising U.S. security. The offset deals that are negotiated trade away our technologies and our manufacturing jobs to foreign countries, some not too friendly or loyal to the U.S. and who will sell our technology to others as Israel has. There seem to be no rules or regulations governing such agreements. Another example is the NAFTA Treaty we signed which openly removes all such restrictions on equipment and technology sales. War and destruction make for huge profits and who wants to stop that? The U.S. sends our troops all over the world claiming to maintain peace, yet is the world's largest arms dealer and no one has sense enough to stop the arms race... what a paradox!]

#### **HOW THE UN KING** HAND-PICKS HIS COURTIERS

#### Kofi Annan is under pressure to reform the way senior staff are appointed

It was over lunch in a top-class Paris restaurant that Kofi Annan, the UN secretary general, unexpectedly popped the question to his guest Ruud Lubbers, a professor of globalisation at Tilburg University in the Netherlands, and that country's prime minister for 12 years until 1994.

Would Mr. Lubbers like to head the world's major agency for helping refugees, the UNHCR?

"I was surprised," Mr. Lubbers told a small group of top staff at the UNHCR's headquarters in Geneva recently. "I knew very little about the issue. I had not applied for the job." But surprises had been part of his career, he added.

If he was amazed by the job offer, the Netherlands' Labour government was furious. It had nominated Jan Pronk, the minister for international development, for the UNHCR post. Wim Kok, the prime minister put out a terse statement "regretting" the decision to bypass Mr. Pronk but added, patriotically, that he was glad "an able, experienced and former prime minister, and another Dutchman was chosen".

The episode perfectly summed up the two problems with top UN appointments. Rich Western governments feel they own the top jobs in the big money-spending programmes, rotating them among themselves. The secretary general, who makes the appointments, is not required to have a short-list, let alone advertise the job or give the initial screening to a selection panel.

Many former senior staff at the UN criticise the system, but nothing has been done to change it, despite lip service to reforming the UN.

"I'm not sure the secretary general should start from the position that Ruritania should get a particular post," says Sir Marrack Goulding, who served as under-secretary general for political affairs until 1997. "We need to have a much more transparent set of procedures for doing this."

"What is unacceptable, and it happens all the time, is that governments put pressure on the secretary general to appoint the person they want. This is unfair on the secretary general," he adds....

In the UNHCR case, according to a former diplomat who represented his country on the UN security council, the Dutch probably felt they had a right to a top job

"because they are a loyal and energetic member of the UN which pays a lot into the budget and haven't had a Dutchman at a senior level for a number of years"....

Another controversial recent appointment, that of Kenzo Oshima to head the Office for the Coordination of Humanitarian Affairs (OCHA), was done on Mr. Annan's own initiative.

According to a senior UN insider, the secretary general is dissatisfied with the work of a particular Japanese senior official in another post in the UN and wishes to remove him. To keep Tokyo happy, (it is, natural disasters. after all, another major UN donor), he asked the Japanese government to nominate someone to head OCHA. When Tokyo picked Mr. Oshima, who runs the department of international peace co-operation in the Japanese prime minister's office, Mr. Annan appointed him.

Under the UN charter, jobs are required to reflect an equitable geographical distribution that would befit a world body.

For the roughly 1,800 jobs in the secretariat in New York, a country's economic weight, as reflected in its budget dues to the UN, plays a role. Britain had 56 of these 1,800 jobs in New York, or 3%, according to figures from the mid-1990s.

When the figures are broken down for the senior jobs—those at department-head level and above—Britain had 10 out of 210, or 5%, corresponding exactly to its contribution to the overall budget.

The picture changes radically when it comes to the under-secretary general level and the heads of the main funds and programmes, such as the UNHCR, the UN Children's Fund, the World Food Programme, the UN Development Programme and the UN Population Fund.

These are mainly staffed by people from the wealthiest countries, with the United States disproportionately represented.

Given that Washington has for years refused to pay its dues in full, this discrepancy has caused major resentment. These appointments are all made by the secretary general.

The "agencies" of the United Nations—the International Labour Organisation, the World Health Organisation, the World Bank and the IMF—have separate systems of staffing and paying the top jobs, over which Mr. Annan has no control.

The UN secretariat's salaries are said by the UN to be around half those of the European Union, NATO and the World Bank.

Some governments are believed to top up the pay of their nationals who have top UN jobs, although this is against UN rules.

Britain has been making low-key calls for reform since the Labour government gained office. "We must have a UN whose staff and leadership represent all the countries of the world, but they must be recruited and promoted on the basis of their ability to do the job, not their nationality or political connections," Clare Short, the secretary of state for international development, told a New York audience in October 1999....

"This could include a definition of the competencies for the post, selection and search committees," the paper said, "and a clear process for taking the final decision, in which competence would be put above considerations of nationality."

#### REPORT: CHINA LEADERS FEARED ARREST

NEW YORK (AP)—The late Chinese leader Deng Xiaoping ordered the violent 1989 Tiananmen Square crackdown out of fear that demonstrators could topple the Communist regime, documents reportedly brought out of China by a disaffected civil servant say.

protests were controlled by unknown anti-communist conspirators. They also expose anxiety by the party's top leaders that the more than 1 million demonstrators gathered at Tiananmen Square could demand their arrest.

The documents detail conversations among Deng and other Communist leaders. They are said to be based on never-before-published minutes of secret high-level meetings, Chinese intelligence reports and records of Deng's private phone calls.

The documents were provided by an unnamed civil servant who describes himself as a Communist Party member sympathetic to reformers. They appear in *The* Tiananmen Papers: The Chinese Leadership's Decision to Use Force Against Their Own People.

The book, published by Public Affairs, was released in the United States this weekend.

"After thinking long and hard about this, I've concluded that we should bring in the People's Liberation Army (PLA) and declare martial law in Beijing," Deng was quoted as saying at a meeting held at the Party Central Office on May 18, 1989.

The documents say Deng was encouraged by several members of his inner circle.

one of the eight senior revolutionaries who then constituted the Politburo Standing Committee meeting.

#### FBI SEARCHES JEWISH CENTER FOR EVIDENCE OF TERRORIST FUNDING

NEW YORK (AP)—FBI agents executed the search warrant at the Hatikva Jewish Identity Center with assistance from the New York City Police Department at about 9 a.m., according to the center's director Michael Guzofsky.

About six hours later, authorities began loading a trailer with the seized items, which included 84 sealed cardboard boxes, 6 computers, a file cabinet, folders and a map of Israel.

William Muller, a spokesman for the U.S. attorney's office in Brooklyn, said court papers in the case were sealed and would not comment on when they might be opened.

Joseph Valiquette, a spokesman for the FBI's New York office, confirmed that the agency was "Qian said we might keep clear of political executing a federal search warrant at the center, issues in order for the three links to take place via located on Coney Island Avenue in the Parkville section of Brooklyn, but declined further comment.

> Guzofsky said the seizure would primarily turn up videotapes, books and other "ideological paraphernalia" made available at the center.

> Guzofsky said he attended a fund-raising dinner last month where Binyamin Kahane was a featured speaker. But he denied that Hatikva center was involved in fundraising for the younger Kahane's movement.

#### COURT TO PONDER CURRENCY COMPLAINT

SAN SALVADOR, EL SALVADOR (AP)—The Supreme Court has agreed to consider a complaint that El Salvador's recent adoption of the U.S. dollar as its currency is unconstitutional, officials said Saturday.

The complaint, filed in December by a private foundation set up to study the constitution, says the legislature didn't give sufficient notice as it drafted the law adopting the dollar.

A court official, Rene Hernandez Valiente, said Saturday the court had studied the complaint and agreed to consider it. A decision was expected within three months.

Under the new law, Salvadorans began using dollars—along with their traditional currency, the colon—on Monday.

However, the Foundation to Study the Application of Rights alleges that opposition politicians were not given sufficient time to debate the law because legislators drafted it in secret. The law was approved by Congress in November.

On Thursday, the opposition Democratic Center Union Party also asked the Supreme Court to declare the measure unconstitutional, claiming it violates requirements that the country regulate its monetary supply.

The adoption of the dollar is part of a trend in the region. Countries facing chronic inflation and jittery investors hope use of the greenback will stabilize and boost their economies.

Panama—Central America's richest nation—has long used the dollar, and Ecuador adopted it in September.

Argentina has pegged its own peso to the greenback, while Guatemala plans to adopt the dollar alongside its quetzal on May 1. Much of Cuba's economy also operates in dollars, though officials say that is a temporary situation.

But this propulsion can only come into action when the speed of light has already been achieved. From that it follows that a further drive is necessary, regulating

determine the truth or were frightened when normal speed up to that of light. This means that a starcraft, or beamship as referred to by the Pleiadians, requires two drive mechanisms, first the normal which accelerates up to the speed of light, and then a second for the hyperdrive, as you might refer to it. A drive then, which generates a million-fold, and even billion-fold, the speed of light, thus producing the hyper-speed by which hyper-space is pierced and penetrated. This is a space in which the mass seems to increase in relationship to the speed attained. So time and space simply collapse, and they become zero time and zero space. This actually means that time and space cease to exist. Thusly, distances of numerous light-years are traversed in a mere fraction of a second—with no lag of time.

> The actual "time" required to make a journey, say, from Pleiades to Earth is in the speeding up to light speed and the slowing down again at destination. In thought transference there is no time involved what-soever—except the split seconds required for disassembly and reassembly. The actual time of physical transference by craft is less than ten minutes of your calculations for such a distance.

You will not be given statistics of detail as to perceive as passing years. The "human" may be very old function because you ones have enough toys beyond your ability to control without bringing them into outerlimits of the cosmos. > Your thrust systems, of course, will work on the basis of light pulses from light-emitting drives. Lightemitting drives work for normal propulsion and move the beamships to nearby planets and a safe distance away from an orb—and then another drive is activated when the distances are great. We could refer to this second drive mechanism as a hyper-propulsion system, which surpasses time and space. It is a bit hard to describe these systems in Earth terms, for your language is different and so are the labels given to such minerals as mercury, which is utilized as well as the various programming crystals necessary for craft apparatus. We refer to things such as "tacheons" which are generated and harnessed in both drive systems with only differing magnitude and attitude.

> Pleiadians predominantly utilize disc-shaped craft, especially for long-distance travel, because of the aerodynamic qualities. Once in motion, we ride a "boundary layer" much similar to the principle applied to Tesla's bladeless turbine/pump. The boundary layer, for brief explanation, is the tiny distance, let us say, between the wing of an aircraft and the atmosphere passing across the surface—there is a totally static area untouched by the atmosphere itself to the surface. Once in motion there is nothing that touches the skin surface of the vehicle. The disc-like form, therefore, vouches the least resistance, and also offers the largest surface which rides the energy currents, to enable the drives to be most efficient.

#### **GRAVITY OF GRAVITY**

This is a bit easier to discuss and, further, is no longer a secret to Earth scientists. The beamship is completely surrounded by a protection-beam-girdle (excuse me, ladies). This allows every interference to simply glide away, without pushing. The same also occurs in the cosmos, which swarms with particles. Therefore, the beam-protection screen functions to protect the ship against all influences and resistances, with anything contacting the screen becoming pushed aside or disintegrated—as the boundary layer spoken of above. All things which would otherwise penetrate or are resistance-offering are simply diverted without evoking pressures in any manner. Resistance must be eliminated to reach sufficient speeds for distance travel.

Removal of this protecting screen brings into play another very important effect which is of great importance—especially to passengers and crew; the glide-away effect of the beam-protection-screen diverts the gravity and attractive forces, and the beamship in effect becomes a micro-planet which can travel at near lightspeed through any atmosphere without any risk at all.

The gravity of a planet does not influence the and there is no force levied against their beings just as if they were on a home planet where the balance is adjusted by natural selection and where the planetary gravity is in accordance with their anatomical capabilities.

In the beamship itself the gravity, of course, is controlled. When passengers on spacecraft from other worlds move in atmospheres alien to them, or on hostile planets with unbearable gravity and atmosphere, they must utilize controlled-environment coverings, light "aura" shields and transportable instruments and apparatus to measure, maintain and produce protection for the beings.

These things will be, and some already are, developed on your planet but Earth human must develop behavior balance before all technical knowledge is allowed perfection, for as I stated prior—Earth man always utilizes the wondrous inventions and higher scientific knowledges in detrimental ways. As you develop, the menace is ever present of the Earth human exercising his technical knowledge, abilities and inventions for evil intent and power-control motives. This continues to happen over and over again, not only with Earth humans, but with other humanoid beings on other worlds as well. As man develops these techniques which will allow him into the outer cosmos, he will not longer be allowed to continue this behavior without recourse—he will not be allowed to fly from planet to planet intending to capture and control and become victor over another race.

In cosmic space many dangers of many proportions lurk where other cosmic inhabitants are not helplessly exposed to attack by other races. There could follow deadly defeats for the Earth humankind, and complete slavery, which could equal the falling back into the primary existence.

It could also be possible that the planet Earth could be completely destroyed, because there are inhumane and hostile as well as humane races inhabiting planets, etc., in

the cosmos as well as humane and advanced races.

Pleiades (The Seven Sisters) are located in the constellation of Taurus, the bull. Clearly visible in the Northern Hemisphere on winter nights, they resemble a tiny reproduction of the Little Dipper and are often called such—actually, in Greek, they are often referred to as the "micro-dipper". These are one of the most carefully studied regions of the firmament. Man of Earth is drawn to them as if to a magnet by iron shavings.

These wondrous orbs have enraptured minds for centuries of your counting and we give honor to your 18th-Century comet hunter, Charles Messier, who was first to chart and identify them. The primitive equipment of the day often allowed amateur astronomers to mistakenly label stationary objects as comets so, to assist his fellow celestial watchers, Messier worked diligently from his observation atop the Hotel de Cluny in Paris, France. In 1771 he published his first catalogue of some forty-five non-cometary objects and it was in this

HERMES: "Listen to your inner selves and look register that the Pleiades were designated the label happenings, the alien recently "taken" by your CIA in Virginia, comes from the system designated as M-31. These are simply designations by Earth man to more easily place the heavens into a grid system.

> Many astronomers have charted many suns in the area of M-45. There are several thousand in this tiny sector of which some two hundred and fifty are recognized as members of this galactic cluster; the rest lie in the depths of space beyond the system. Once all of the more faintly visible stars have been examined, the total shall be far greater—closer to some half million.

> This celestial group is easily tracked by first locating the giant red star-which is visible beyond Starship-known as Betelguese, which appears in the Orion constellation as the "shoulder" of the Great Hunter. Next finding Aldebaran, a first-magnitude star in Taurus, draw a line between the two. Extend the line in a northwest direction almost an equal distance past Aldebaran. Here it will terminate just south of the beautiful Seven Sisters. This tightly grouped cluster of suns is in your own The Greeks refer to the cluster of stars that have galaxy; six of the seven are discernible by the unaided eye. Alcyone is the brightest. The beauty and peaceful connotations of these mysterious wonders are referred to in text, both past and present, as the Seven Stars, yet one of them is not visually seen. Almost a universal tradition, therefore, suggests that one of them has been misplaced or is hidden, and was so deemed the "Lost Pleiad" by the Greeks. Now, for some "proof of purchase"—how

would a missing star be classified and spoken of—and far later in historical documentation be proven—if there was not ancient attachment? How can you relate to something unknown? Therefore, it follows that it had to have been "proven" and "known" at some time historically. It seems quite amazing that ALL cultures of antiquity were aware of the seventh star, which is masked from the view of the inhabitants of Earth!

Could it be that the future is only the past again, entered through a different gate of perception?

The repeated acknowledgement will be fully understood and explained as the jigsaw puzzle is assembled—for now, most of the pieces are still a bit scattered and some are still missing completely. There is little room for doubting, however, that since the dawn of your recorded time, these stars have been a most powerful influence and are believed, upon your place, to be a powerful influence and to hold at least a portion of the responsibility for molding the destiny of humanity.

Throughout time thousands of cultures, religions and beliefs have been introduced to this delicate planet you call home in this present experience. Many of these ideals and ideas conflict or contradict one another—and existing in every single one is a positive/negative flow of information. However, in all of the societies and civilizations that have been researched for this connection, one topic remains alluded to as a consistent enlightening force, found in the earliest texts and legends—it is the mystifying cluster of suns, called Pleiades.

You will find that tracking the source of verbal legend is most difficult, if not impossible—until the Oral Tradition and teachings are brought forth and unfolded as we will now be doing—here and through the Lakota Brother, Little Crow, of the Lakota Sioux in permission and commission from Wakan Tanka/Tunkonshila (Grandfather), here at the closing of the Sacred Cycle. You can find truth in the hereditary conversations, from most unrelated areas of your world, which correctly reflect upon the Pleiades as the "Center of the Universe", the "Seat of Immortality", and the "Home of God". "A long time ago a party of hunters journeyed through the woods in search of a good hunting ground. Having found one, they proceeded to build their lodges for the winter, while the children gathered together to dance and sing.

"While the children were thus engaged, an old man dressed in white feathers, whose flowing hair shone like silver, appeared among them and bid them cease dancing lest a mysterious force befall them, but the children danced on unmindful of the warning, and presently they observed that they were rising little by little into the air.

"One of them exclaimed, 'Do not look back, for something strange is taking place.' One of the children disobeyed this warning and, looking back, became a falling star. The six other children reached the high heavens safely and can now be seen dancing in the Pleiades... the stars they became."
