Begin, please, with that which is labelled in their document, Article 2-and we will follow along. [QUOTING:]

#### **PART II: UNIDO**

#### ARTICLE 2

#### **FUNCTIONS**

In fulfillment of its foregoing objectives, the Organization shall generally take all necessary and appropriate action, and in particular shall:

- promotion and acceleration of industrialization, in particular in the development, expansion and modernization of their industries;
- (b) In accordance with the Charter of the United Nations, initiate, coordinate and follow up the activities of the United Nations system with a view to enabling the Organization to play the central coordinating role in the field of industrial development; [H: Remember UNIDO is referred to as "Organization". This portion notes that the UN will control YOU.]
- (c) Create new and develop existing concepts and approaches in respect of industrial development on global, regional and national, as well as on sectoral levels, and carry out studies and surveys with a view to formulating new lines of action directed towards harmonious and balanced industrial development, with due consideration for the methods employed by countries with different socio-economic systems for solving industrialization problems;
- (d) Promote and encourage the development and use of planning techniques, and assist in the development of an integrated and interdisciplinary approach towards the accelerated industrialization of the developing countries; [H: This is "regional control over private businesses."]
- (f) Provide a forum and act as an instrument industrialized countries in their contacts, consultations and, at the request of the countries concerned, negotiations diverted towards the industrialization of the developing countries;

agro-related as well as basic industries, to achieve the full utilization of locally available natural and human resources and the production of goods for domestic and export markets, as well as contribute to the self-reliance of these countries;

- (h) Serve as a clearing-house for industrial information and accordingly collect and monitor on a selective basis, analyze and generate for the purpose of dissemination information on all aspects of industrial development on global, regional and national, as well as on sectoral levels including the exchange of experience and technological achievements of the industrially developed and the developing countries with different social and economic systems; [H: Again, dovetails with regional government.]
- (i) Devote particular attention to the adoption of special measures aimed at assisting the leastdeveloped, land-locked, and island developing countries, as well as those developing countries most seriously affected by economic crises and natural calamities, without losing sight of the and voting, upon the recommendation of the Board. interest of the other developing countries;
- (j) Promote, encourage and assist in the development, selection, adaptation, transfer and use of industrial technology, with due regard for the socioeconomic conditions and the specific requirements of the industry concerned, with special reference to the transfer of technology from the industrialized to the developing countries as well as among the developing countries themselves;
- programmes aimed at assisting the developing countries (a) Encourage and extend, as appropriate, in the training of technical and other appropriate assistance to the developing countries in the categories of personnel needed at various phases for in the work of the Organization in accordance their accelerated industrial development;
  - (1) Advise on and assist, in close co-operation with the appropriate bodies of the United Nations, specialized agencies and the International Atomic Energy Agency, the developing countires in the exploitation, conservation and local transformation of their natural resources for the purpose of furthering the industrialization of developing countries;
  - (m) Provide pilot and demonstration plans for acceleration industrialization in particular sectors:
  - (n) Develop special measures designed to promote co-operation in the industrial field among developing countries and between the developed and developing countries;
  - (o) Assist, in co-operation with other appropriate bodies, the regional planning of industrial development of the developing countries within the framework of regional and subregional groupings among those countries;
  - (p) Encourage and promote the establishment and strengthening of industrial, business and professional associations, and similar organizations which would contribute to the full utilization of the internal resources of the developing countries with a view to developing their national industries;
- (q) Assist in the establishment and operation of to serve the developing countries and the institutional infrastructure for the provision of regulatory, advisory and developmental services to industry;
  - (r) Assist, at the request of Governments of the developing countries, in obtaining external (g) Assist the developing countries in the equitable and mutually acceptable terms.

#### **CHAPTER II—PARTICIPATION**

#### ARTICLE 3

#### **MEMBERS**

Membership in the Organization is open to all States which associate themselves with the objectives and principles of the Organization. [H: Please recall, "States" means nations.]

- (a) States members of the United Nations or of a specialized agency or of the International Atomic Energy Agency may become Members of the Organization by becoming parties to this Constitution in accordance with Article 24 and paragraph 2 of Article 25;
- (b) States other than those referred to in subparagraph (a) may become members of the Organization by becoming parties to this Constitution in accordance with paragraph 3 of Article 24 and subparagraph 2(c) of Article 25, after their membership has been approved by the Conference, by a two-thirds majority of the Members present

#### ARTICLE 4

#### **OBSERVERS**

- 1. Observer status in the Organization shall be open, upon request, to those enjoying such status in the General Assembly of the United Nations, unless the Conference decides otherwise.
- 2. Without prejudice to paragraph 1, the (k) Organize and support industrial training Conference has the authority to invite other observers to participate in the work of the Organization.
  - 3. Observers shall be permitted to participate with the relevant rules of procedure and the provisions of this Constitution.

#### ARTICLE 5

#### **SUSPENSION**

- 1. Any Member of the Organization that is suspended from the exercise of the rights and privileges of membership of the United Nations shall automatically be suspended from the exercise of the rights and privileges of membership of the Organization.
- 2. Any Member that is in arrears in the payment of its financial contributions to the Organization shall have no vote in the Organization if the amount of its arrears equals or exceeds the amount of the assessed contributions due from it for the preceding two fiscal years. Any organ may, nevertheless, permit such a Member to vote in that organ if it is satisfied that the failure to pay is due to conditions beyond the control of the Member.

#### ARTICLE 6

#### WITHDRAWAL

- 1. A Member may withdraw from the Organization by depositing an instrument of denunciation of this Constitution with the Depository. [H: Hold it—this is not true—Universal mandatory enlistments are planned!]
- 2. Such withdrawal shall take effect on the financing for specific industrial projects on fair, last day of the fiscal year following that during which such instrument was deposited.

3. The contributions to be paid by the matter within the competence of the Organization withdrawing Member for the fiscal year following that during which such instrument was deposited shall be the same as the assessed contributions for the fiscal year during which such deposit was effected. The withdrawing Member shall in addition fulfil any unconditional pledges it made prior to such deposit.

#### **CHAPTER III—ORGANS**

#### ARTICLE 7

#### PRINCIPAL AND SUBSIDIARY ORGANS [H: Provides 3 branches.]

- 1. The principal organs of the Organization shall be:
- (a) The General Conference (referred to as the "Conference";
- (b) The Industrial Development Board (referred to as the "Board");
  - (c) The Secretariat.
- and Budget Committee to assist the Board in the preparation and examination of the programme of work, the regular budget and the operational budget of the Organization and other financial matters pertaining to the Organization. [H: Uses P.P.B.S. "Program, Planning, and Budgeting System"—a mandatory control system under the Conference.]
- 3. Other subsidiary organs, including technical World Order.] committees, may be established by the Conference principle of equitable geographical representation.

#### ARTICLE 8

#### GENERAL CONFERENCE

#### [H: The Developmental Arm of the New World Order.]

- 1. The Conference shall consist of representatives of all Members.
- 2. (a) The Conference shall hold a regular session every two years, unless it decides otherwise. Special sessions shall be convened by the Director General at the request of the Board or of a majority of all Members.
- (b) Regular sessions shall be held at the seat of the Organization, unless otherwise determined by the Conference. The Board shall determine the place where a special session is to be held.
- specified in this Constitution, the Conference shall:
- (a) Determine the guiding principles and the policies of the Organization; [H: Part of P.P.B.S. functions and control.]
- (b) Consider reports of the Board, of the Director-General and of the subsidiary organs of the Conference:
- (c) Approve the programme of work, the regular budget and the operational budget of the Organization in accordance with Article 14, establish the scale of assessments in accordance with Article 15, approve the financial regulations of the Organization and supervise the effective utilization of the financial resources of the Organization;
- majority of the Members present and voting, conventions or agreements with respect to any session on the activities of the Board;

and to make recommendations to the Members concerning such conventions or agreements;

- within the competence of the Organization;
- (f) Take any other appropriate action to and carry out its functions.
- 4. The Conference may delegate to the Board such of its powers and functions as it may consider desirable, except for those provided for in: Article 3, subparagraph (b); Article 4; Article 8, subparagraphs 3(a), (b), (c) and (d); Article 9, paragraph 1; Article 10, paragraph 1; Article 11, paragraph 2; Article 14, paragraphs 4 and 6; Article 15; Article 18; Article 23, subparagraphs 2(b) and 3(b); and Annex I.
- 5. The Conference shall adopt its own rules of procedure.
- 6. Each Member shall have one vote in the procedure. 2. There shall be established a Programme Conference. Decisions shall be made by a majority of the Members present and voting vote. Decisions shall be made by a majority of unless otherwise specified in this Constitution or the members present and voting unless otherwise in the rules of procedure of the Conference.

#### ARTICLE 9

## INDUSTRIAL DEVELOPMENT BOARD [H: The Enforcement Arm for the New

- 1. The Board shall consist of 53 Members of the or the Board, which shall give due regard to the Organization elected by the Conference, which shall give due regard to the principle of equitable geographical distribution. In electing the members of the Board the Conference shall observe the following distribution of seats: 33 members of the Board shall be elected from the <u>States</u>. (States refers to "nations") Part B, and 5 from the States listed in Part D of Annex I to this Constitution.
  - 2. Members of the Board shall hold office from the close of the regular session of the Conference at which they were elected until the close of the regular session of the Conference four years thereafter, except that the members elected at the first session shall hold office from the time of such election and one half shall hold office only until the close of the regular session two years thereafter. Members of the Board may be re-elected.
  - 3. (a) The Board shall hold at least one 3. In addition to exercising other functions regular session each year at such times as it may determine. Special sessions shall be convened by the Director-General at the request of a majority of all members of the Board.
    - (b) Sessions shall be held at the seat of the Organization, unless otherwise determined by the Board.
    - 4. In addition to exercising other functions specified in this Constitution or delegated to it by the Conference, the Board shall:
    - (a) Acting under the authority of the Conference, review the implementation of the approved programme of work and of the Board; corresponding regular budget and operational budget, as well as of other decisions of the Conference;
  - (b) Recommend to the Conference a scale of (d) Have the authority to adopt, by a two-thirds assessments for regular budget expenditures;
    - (c) Report to the Conference at each regular

- (d) Request Members to furnish information on their activities related to the work of the Organization;
- (e) In accordance with the decisions of the (e) Make recommendations to Members and to Conference and having regard to circumstances international organizations with respect to matters arising between sessions of the Board or the Conference, authorize the Director-General to take such measures as the Board deems necessary to enable the Organization to further its objectives meet unforeseen events with due regard to the functions and financial resources of the Organization;
  - (f) If the office of Director-General becomes vacant between sessions of the Conference, appoint an Acting Director-General to serve until the next regular or special session of the Conference;
  - (g) Prepare the provisional agenda for the Conference;
  - (h) Undertake such other functions as may be required to further the objectives of the Organization subject to the limitations stipulated in this Constitution.
  - 5. The Board shall adopt its own rules of
  - 6. Each member of the Board shall have one specified in this Constitution or in the rules of procedure of the Board.
  - 7. The Board shall invite any Member not represented on the Board to participate without vote in its deliberations on any matter of particular concern to that Member.

#### ARTICLE 10

#### PROGRAMME AND BUDGET COMMITTEE [H: Balancers of the funds used for World Government conversion.]

- 1. The Programme and Budget Committee shall consist of 27 Members of the Organization elected by listed in Parts A and C, 15 from the States listed in the Conference, which shall give due regard to the principle of equitable geographical distribution. In the following distribution of seats: 15 members of the Committee shall be elected from the States listed in Parts A and C, 9 from the States listed in Part B, and 3 from the States listed in Part D of Annex I to this Constitution. In designating their representatives to serve on the Committee, States shall take into account their personal qualifications and experience.
  - 2. Members of the Committee shall hold office from the close of the regular session of the Conference at which they were elected until the close of the regular session of the Conference two years thereafter. Members of the Committee may be re-elected.
  - 3. (a) The Committee shall hold at least one session each year. Additional sessions shall be convened by the Director-General at the request of the Board or the Committee.
  - (b) Sessions shall be held at the seat of the Organization, unless otherwise determined by the Board.
    - 4. The Committee shall:
    - (a) Perform the functions assigned to it in Article 14;
  - (b) Prepare the draft scale of assessments for regular budget expenditures for submission to
  - (c) Exercise such other functions with respect to financial matters as may be assigned to it by the Conference or the Board.
  - (d) Report to the Board at each regular session on all activities of the Committee and submit advice or proposals on financial matters to

the Board of its own initiative.

- 5. The Committee shall adopt its own rules of procedure.
- 6. Each member of the Committee shall have one vote. Decisions shall be made by a two-thirds majority of the members present and voting.

#### **CHAPTER 16**

#### ARTICLE 11

#### **SECRETARIAT**

#### [H: The chief of the Administrative Arm of the New World Order.]

- 1. The Secretariat shall comprise a Director-General, as well as such Deputy Directors-General and other staff as the Organization may require.
- by the Conference upon recommendation of the Board for a period of four years. He may be reappointed for a further term of four years, after which he shall not be eligible for reappointment.
- 3. The Director-General shall be the chief administrative officer of the Organization. Subject to general or specific directives of the Conference or the Board, the <u>Director-General shall have the</u> over-all responsibility and authority to direct the work of the Organization. Under the authority of and subject to the control of the Board, the Director- expenditures for administration, research, other General shall be responsible for the appointment, regular expenses of the Organization and for organization and functioning of the staff.
- 4. In the performance of their duties, the receive instructions from any government or from any authority external to the Organization. They shall refrain from any action that might reflect on their position as international officials responsible only to the Organization. Each Member undertakes to respect the exclusively international character of the responsibilities of the Director-General and the staff and not to seek to influence them in the discharge of their responsibilities.

#### [H: NOTE: REQUIRED "LOYALTY" TO WORLD GOVERNMENT (SEE OATH REQUIRED), BUT LOYALTY TO U.S. CONSTITUTION NO LONGER POSSIBLE. THIS IS MOST IMPORTANT, CHELAS.]

- 5. The staff shall be appointed by the Director-General under regulations to be established by the Conference upon recommendation of the Board. Appointments at the level of Deputy Director-General shall be subject to approval by the Board. The conditions of service of staff shall conform as far as possible to those of the United Nations common system. The paramount consideration in the employment of the staff and in determining the conditions of service shall be the necessity of wide and equitable geographical basis.
- 6. The Director-General shall act in that capacity

#### **CHAPTER IV—PROGRAMME OF WORK AND FINANCIAL MATTERS**

#### ARTICLE 12

#### **EXPENSES OF DELEGATIONS**

Each Member and observer shall bear the expenses of its own delegation to the Conference, to the board or to any other organ in which it may participate.

#### ARTICLE 13

#### **COMPOSITION OF BUDGETS**

- 1. The activities of the Organization shall be 2. The Director-General shall be appointed carried out in accordance with its approved programme of work and budgets.
  - divided into the following categories:
  - (a) Expenditures to be met from assessed contributions (referred to as the "regular budget"); and
  - (b) Expenditures to be met from voluntary as may be provided for in the financial regulations (referred to as the "operational budget").
  - 3. The regular budget shall provide for other activities, as provided for in Annex II.
- 4. The operational budget shall provide for Director-General and the staff shall not seek or expenditures for technical assistance and other the Members, as apportioned in accordance with a related activities.

#### ARTICLE 14

#### PROGRAMME AND BUDGETS

- 1. The Director-General shall prepare and submit to the Board through the Programme and Budget Committee, at a time specified in the financial regulations, a draft programme of work for the following fiscal period, together with the corresponding estimates for those activities to be financed from the regular budget. The Director-General shall, at the same time, submit proposals and financial estimates for those activities to be financed from voluntary contributions to the Organization.
- 2. The Programme and Budget Committee shall consider the proposals of the Director-General and submit to the Board its recommendations on the proposed programme of work and corresponding estimates for the regular budget and operational budget. Such recommendations of the Committee Members present and voting.
- 3. The Board shall examine the proposals of securing the highest standards of efficiency, the Director-General together with any competence and integrity. Due regard shall be recommendations of the Programme and Budget paid to the importance of recruiting staff on a Committee and adopt the programme of work, the regular budget and the operational budget, with such modifications as it deems necessary, for submission at all meetings of the Conference, of the Board and of to the Conference for consideration and approval. objectives and policies of the Organization.

- 4. (a) The Conference shall consider and approve the programme of work and the corresponding regular budget and operational budget submitted to it by the Board, by a two-thirds majority of the Members present and voting.
- (b) The Conference may make amendments in the programme of work and the corresponding regular budget and operational budget, in accordance with paragraph 6.
- 5. When required, supplementary or revised estimates for the regular budget or operational budget shall be prepared and approved in accordance with paragraphs 1 to 4 above and the financial regulations.
- 6. No resolution, decision, or amendment involving expenditure, which has not already been considered in accordance with paragraphs 2 and 3, shall be approved by the Conference unless it is accompanied by an estimate of expenditures prepared by the Director-General. No resolution, decision or amendment in respect of which expenditures are anticipated by the Director-General shall be approved by the Conference until the 2. #### ARTICLE 15

#### ASSESSED CONTRIBUTIONS

1. Regular budget expenditures shall be borne by scale of assessment established by the Conference by a two-thirds majority of the Members present and voting, upon the recommendation of the Board adopted by a two-thirds majority of the members present and voting, on the basis of a draft prepared by the Programme and Budget Committee.

#### [H: NOTE: THE COST SHALL BE VERY AS YOU ARE FORCED TO SURRENDER YOUR SOVEREIGNTY AND **YOUR FIREARMS.**]

2. The scale of assessments shall be based to the extent possible on the scale most recently employed by the United Nations. No Member shall be assessed more than twenty-five percent of the regular budget of the Organization.

#### ARTICLE 16

#### **VOLUNTARY CONTRIBUTIONS** TO THE ORGANIZATION

Subject to the financial regulations of the shall require a two-thirds majority of the Organization, the Director-General, on behalf of the Organization, may accept voluntary contributions to the Organization, including gifts, bequests and subventions, made to the Organization by governments, intergovernmental or non-governmental organizations or other non-governmental sources, provided that the conditions attached to such voluntary contributions are consistent with the

#### ARTICLE 17

#### INDUSTRIAL DEVELOPMENT FUND

In order to increase the resources of the Organization and to enhance its ability to meet promptly and flexibly the needs of the developing countries, the Organization shall have an Industrial Development Fund which shall be financed through the voluntary contributions [H: This will simply strengthen the system for "world conquering".] to the Organization provided for in Article 16, and other income as may be provided for in the financial regulations of the Organization. The Director-General shall administer the Industrial Development Fund in accordance with the general policy guidelines governing the operations of the Fund that are established by the Conference, or by the Board acting on behalf of the Conference, and in accordance with the financial regulations of the Organization.

#### CHAPTER V—CO-OPERATION **AND CO-ORDINATION**

#### ARTICLE 18

#### RELATIONS WITH THE UNITED NATIONS

The Organization shall be brought into relationship with the United Nations as one of the specialized agencies referred to in Article 57 of the Charter of the United Nations. Any agreement concluded in accordance with Article 63 of the Charter shall require the approval of the Conference, by a two-thirds majority of the Members present and voting, upon the recommendation of the Board.

#### ARTICLE 19

#### RELATIONS WITH OTHER ORGANIZATIONS [H: \*\*\*NOTE!\*\*\*: NOW ENDOWED WITH THE "RIGHT" TO OVERTHROW U.S. entered into by the Organization. **GOVERNMENT!**]

- 1. The Director-General may, with the approval of the Board and subject to guidelines established by the Conference:
- (a) Enter into agreements establishing appropriate relationships with other organizations of the United Nations system and with other intergovernmental and governmental organizations. [H: Direct alteration of the U.S.A.]
- (b) Establish appropriate relations with nongovernmental and other organizations the work of which is related to that of the Organization. When establishing such relations with national organizations the Director-General shall consult with the governments concerned.
- 2. Subject to such agreements and relations, the Director-General may establish working arrangements with such organizations.

#### **CHAPTER VI—LEGAL MATTERS**

#### ARTICLE 20

#### **SEAT**

- 2. The Organization shall conclude a to a conciliation commission. headquarters agreement with the Host Government.

#### ARTICLE 21

#### LEGAL CAPACITY, PRIVILEGES AND IMMUNITIES

- 1. The Organization shall enjoy in the territory of each of its Members such legal capacity and such privileges and immunities as are necessary for the exercise of its functions and for the fulfillment of its objectives. Representatives of Members and officials of the Organization shall enjoy such privileges and immunities as are necessary for the independent exercise of their functions in connections with the Organization.
- 2. The legal capacity, privileges and immunities referred to in paragraph 1 shall:
- (a) In the territory of any Member that has acceded to the Convention on the Privileges and Immunities of the Specialized Agencies in respect of the Organization, be as defined in the standard clauses of that Convention as modified by an annex thereto approved by the Board;

(a) Any dispute among two or more members concerning the interpretation or application of this Constitution, including its annexes, that is not settled by negotiation shall be referred to the Board unless the parties concerned agree on another mode of settlement. the dispute is of particular concern to a member not represented on the board, that Member shall be entitled to be represented in accordance with rules to be adopted by the Board.
- (b) If the dispute is not settled pursuant to paragraph 1(a) to the satisfaction of any party to the dispute, that party may refer the matter: either, (i) if the parties so agree:
- (A) to the International Court of Justice; or [H: NOTE: WORLD COURT IS COMPOSED OF COMMUNISTS AND OTHER SOCIETAL DIFFERENCES. YOUR FATE IN AMERICA, 1. The seat of the Organization shall be FOR INSTANCE, WILL BE WHOLLY

- 1. At any time after the second regular session of the Conference any Member may propose amendments to this Constitution.   - (b) It is approved by the Conference by a two-thirds majority of all Members; and

#### ARTICLE 24

#### SIGNATURE, RATIFICATION, ACCEPTANCE, APPROVAL AND ACCESSION

- 1. This Constitution shall be open for signature by all States specified in subparagraph (a) of Article 3, until 7 October 1979 at the Federal Ministry for Foreign Affairs of the Republic of Austria and subsequently at United Nations Headquarters in New York until the date this Constitution enters into force.
- 2. This Constitution shall be subject to ratification, acceptance or approval by signatory States, Instruments of ratification, acceptance or approval of such States shall be deposited with the Depositary.

3. After the entry into force of this Constitution in accordance with paragraph 1 of Article 25, States specified in subparagraph (a) of Article 3 that have not signed this Constitution, as well as States approved for membership pursuant to subparagraph (b) of that Article, may accede to this Constitution

#### ARTICLE 25

#### **ENTRY INTO FORCE**

1. This Constitution shall enter into force when at least eighty States that had deposited instruments of ratification, acceptance or approval notify the Depositary that they have agreed, after consultations among themselves, that this Constitution shall enter into force.

- 2. This Constitution shall enter into force:
- (a) For States that participated in the notification referred to in paragraph 1, on the date of the entry into force of this Constitution:

#### ARTICLE 26

#### TRANSITIONAL ARRANGEMENTS

- 1. The Depositary shall convene the first session of the Conference, to be held within three months following the entry into force of this Constitution.
- 2. The rules and regulations governing the organization established by the <u>United Nations General</u> Assembly resolution 2152 (XXI) shall govern the Organization and its organs until such time as the latter may adopt new provisions.

#### RESERVATIONS

No reservations may be made in respect of this Constitution.

This Constitution shall be authentic in Arabic, Chinese, English, French, Russian and Spanish.

Unless otherwise agreed by all the Members parties to a dispute that has not been settled purusant to paragraph 1(a) of Article 22 and that has been referred to an arbitral tribunal pursuant to subparagraph 1(b)(i)(B) of Article 22 or to a conciliation commission pursuant to subparagraph 1(b)(ii), the following rules shall govern the procedures and operation of such tribunals and commissions:

#### 1. Initiation

1. - (a) The parties to the dispute shall, by their [The lists of States to be included by the unanimous decision, appoint, as appropriate, three arbitrators or three conciliators, and shall designate one of these as President of the tribunal or commission.
- (b) If within three months of the notification referred resolution 2152 (XXI), as in effect on the date this to in paragraph 1 above one or more members of the tribunal or commission have not been so appointed, the Secretary-General of the United Nations shall, at the request of any party, within three months of such request designate any members, including the President, then still be required to be appointed.
- (c) If a vacancy arises on the tribunal or expenses of the Organization shall be deemed to include: commission, it shall be filled within one month in accordance with paragraph (a) or thereafter in accordance with paragraph (b).

#### 3. Procedures and Operation

- (a) The tribunal or commission shall determine its own rules of procedure. All decisions on any question of procedure or substance may be reached by a majority of the members.
- (b) The members of the tribunal or commission shall receive remuneration as provided in the financial regulations of the Organization. The Director-General shall provide any necessary secretariat in consultation with the President of the tribunal or commission. All expenses of the tribunal or commission and its be borne by the Organization.

#### 4. Awards and Reports

- (a) The arbitral tribunal shall conclude its proceedings by an award, which shall be binding on all the parties.
- (b) The conciliation commission shall conclude serious consideration.

from other California cities which show the existence of three Satanist groups in Berkeley, two of them communes, one in Big Sur, one in Venice, five in San Francisco and one in San Diego. The number of Satanist circles gathering in Los Angeles County is indeterminate." (This was before 1972. I shall cease giving Mr. Lindsey's references, for you can easily obtain his book and look them all up for yourselves. I would, however, prefer you wait until you finish this document and really get busy and find supportive information.)

"Some of the churches of Satan are brazenly open, such as LaVey's establishment, an impressive three-story Victorian home, while others are camouflaged by storefronts or meeting halls.

"In Europe, Satanic masses are held in ruined churches and monasteries, but we should not be deceived by creaking castles or shadowy figures in musty rooms. Satanism is not just an Old World phenomenon.

"Arthur Lyons says, 'Satanism is not only present in Europe, but in the United States as well. In fact, the United States probably harbors the fastest-growing and most highly organized body of Satanists in the world." (Indeed, for you preserve your right to worship as you please under the protection of your *Constitution*.)

"In the 'churches' entangled in Satan worship, the rites are opposite from those of a Christian church. Every desecration of Christianity is emphasized, from the upside-down cross to the flagrant use of sex and sexual stimuli. In Hollywood the altar was a glass tank filled with formaldehyde, containing the body of a dead baby. Lyons reported that the 'high priest' had a hypnotic effect upon a teen-age girl. The ritual in which she became involved was so debasing he could not finish the describing of it.

"We are reminded of the sordid spectacle of the girls who were mesmerized by Charles Manson. In a personal interview with a former Manson family member, I found they indulged in all types of Satanism and witchcraft. Manson was said to have had visions and magic powers. There were stories of his being physically transported from one end of the Spahn Ranch to the other. Group sexual experience, an indulgence of some witch covens, was commonly practiced by the Manson cult. The twisted reversal of Christianity was evident; Manson was called 'God', 'Jesus' and 'Satan' by his followers.

"After Manson's conviction for the seven Tate-LaBianca murders, five members of his 'family'—girls with their heads shaved to prove their loyalty to their leader—led a trek through Hollywood on their knees 'in witness to the second coming of Manson'."

Its holdings include 23 percent of High River Gold, 26 percent of Claimstaker Resources, 22 percent of Cambior, a significant option to purchase shares in Harmony Gold of South Africa, as well as interests in other junior golds.

Nick Ferris and Don Whelan are enthused about Japangu's endorsement of their operations, and for good reason.

I had the pleasure of sitting next to Whelan during dinner, and it was most enjoyable. The Bush crowd is recruiting Australia to participate in a confrontation with China.

The countdown is on. In confirmation hearings before the U.S. Senate during Jan. 12 and 18, cabinet nominees of U.S. President George W. Bush repeatedly raised the specter of a U.S. war with China. Both Secretary of State Gen. John Warner (R-Va.) about "our valued ally, Australia", Rumsfeld linked Australia to Bush's China strategy: "As you look at what's happening in that part of the globe and periodic difficulties the People's Republic of China has had with its neighbors—whether it's the Spratley Islands, or difficulties with India, or Russia, difficulties with Vietnam—there's no question but that Australia is a truly important nation," he said.

On Jan. 18, Powell echoed Rumsfeld, in remarks Australia's role in helping to contain "a new and

"In the Pacific, we are very pleased that Australia, our firm ally, has played a keen interest in what's been happening in Indonesia," he said. #### BUSH BACKS BANNED BILDERBERGER By Clayton Potts

You heard it here first. Bush's new pick for deputy secretary of state—a seasoned Washington power broker—is deeply embroiled in international crime.

President Bush has chosen an unsavory character as deputy secretary of state who was forced out by Bush's father in 1989 to avoid embarrassing the White House.

President Bush the Elder had chosen Richard Armitage as secretary of the Army but, to keep the lid on a boiling national security scandal, the president told him to "forget it", the Spotlight reported exclusively on June 12, 1989.

Armitage had become deputy to Fred Ikle, under secretary of defense for policy, in the early 1980s.

"We used to call them 'Fred and his three stooges'-that is Ikle and his three closest aides in the

the best-informed Administration on Australian Pentagon: Richard Perle, Stephen Bryen and Armitage," an Army officer was quoted at the time. Perle was also a Bilderberg regular during those years.

As Mrs. Kopp was placed under criminal investigation, the trail led to the Pentagon, Swiss investigators told the Spotlight. Mrs. Kopp reportedly held frequent meetings in Washington with her cousin: Under Secretary Fred Ikle, during the late 1980s.

When Swiss Vice President Achille Casanova admitted at a press conference that Kopp had been a key figure in the international drug scandal, he also said the same drug banks were used by the CIA and "other secret American authorities" to provide sanitized cash and other covert financing.

He was referring to the Pentagon policy office headed by Ikle and Armitage, the Spotlight learned from Swiss sources.

The Swiss investigation determined that Ikle and Armitage were in command of major covert action programs in, among others, Afghanistan, Iran, Nicaragua and Cambodia. Funding for these projects was reportedly processed by Ikle and Armitage while Ikle's cousin was in charge of both policy and justice, Swiss sources reported.

Funding was arranged through the private bank headed by Kopp's husband, Hans.

Despite the mainstream media blackout in the United States, investigators working for Sen. John Kerry (D-Mass.) picked up the scent. Several senators were reportedly eager to question Armitage when he appeared for confirmation hearings.

## Henry may someday be called to answer

On May 18, 1999, in Toronto, Canada, 40 demonstrators marched into the Sheraton to interrupt a Diners Club luncheon honoring former Secretary of

Despite the wary Kissinger changing his venue at the last minute, the demonstrators found their way into the Sheraton lobby carrying large pictures of Kissinger with a huge bloodstained banner reading: "Remember Kissinger's crimes: Cambodia, Laos, Iran, Kurds, Vietnam, Chile, Greece, Argentina, East Timor, Brazil, Apartheid."

The demonstrators read aloud testimonies of torture victims, shouting: "Has anybody seen this man?" They leafleted the startled luncheon guests while blocking the escalator to the grand ballroom.

Soon, police arrived to remove the demonstrators.

#### CITIZENS' ARREST

Amidst the ensuing pushing, shoving, dragging and throwing of the protesters by police and security guards, the leaders repeatedly pleaded with the officers to act on their "citizen's arrest" of Kissinger under the Canadian War Crimes Act.

The police dragged leaders Matthew Behrens, Mandy Hiscocks, Brent Patterson and William Taylor up an escalator and into a police van.

At 52 Division headquarters the four were stripsearched and held for several hours. Meanwhile, Kissinger skipped the country.

In court on March 8, 2000, the four members of Toronto Action for Social Change were repeatedly frustrated in their defense by Justice of the Peace Madam Napier. Napier interrupted their testimonies, insulted them, questioned their competence and stated that "evidence of war crimes is irrelevant."

In the court's split decision, Behrens and Taylor were found guilty and given one year's probation. Hiscocks and Patterson were found not guilty.

Weeks before the attempted arrest, Canadian activists had written Lloyd Axworthy, Canada's minister of foreign affairs, regarding Kissinger's impending visit.

Axworthy replied months later on Nov. 26, 1999: "Your support for the cause of human rights is highly commendable... however, Mr. Kissinger has never been indicted for such actions and the Government of Canada does not regard him as a war criminal."

#### THE COLLAPSING STOCK MARKET

What was the real trigger that caused the U.S. stock market to take the current dive that's wiped out the index gains made in the markets for the past three years? Is there a story behind the story that we are simply not hearing? If there is, is it an important one? And, in the end do we really need or want to know the truth?

For months now I have waited for a better journalist than I, and for those better informed and at the source, to tell the story behind the headlines of the recent market slump. I have spoken with the presidents of banks and other financial institutions from Switzerland, Canada, Sweden, the Caribbean and so forth, and they all know the answer and openly discuss it amongst themselves.

For those of us who live and work offshore it is hard to understand how it is possible that a story this big has not been reported. The U.S. media and their international counterparts are either ignorant of the moves made by the U.S. Internal Revenue Service and the subsequent disastrous effects it has had on the markets, or they are simply afraid to engender retribution from this monolithic and oppressive institution of which even the U.S. Congress appears completely intimidated. Either way, it does not bode well for an informed and free press.

Of course there are many legitimate reasons for the securities markets to slip—aside from the huge negative slam for which the IRS is recently responsible, but on balance virtually all the senior financial players with whom I've spoken tend to agree that the current market downturn was triggered by the Final Withholding Regulations and the Qualified Intermediary (QI) rules distributed in 2000 and implemented by the IRS effective January 1, 2001.

These onerous regulations require that foreign financial institutions provide the IRS with extensive information about foreign investors in the United States and require full reporting on activities of U.S. persons' banking and investing activities outside the United States—or else!

No other country has ever displayed the outright conceit and deceit of the United States government and the IRS on a magnitude of this order. Can one even imagine the reaction of a U.S. financial institution to the government of South Africa for example, were they to require the same thing from them?

The great myth of the stock markets is that they are so complex that only insiders and the talking heads on the financial newscasts and the expert journalists of specific newspapers can make sense of market movements. It is, however, axiomatic that individual stocks and entire markets move up when there are more buyers than sellers and they move down when there are more sellers than buyers. With this in mind consider the following.

Many in the international marketplace now feel compelled to reduce their positions in U.S. markets because of the overwhelmingly powerful IRS and other U.S. regulators and their devil-maycare attitude about foreign investment.

Former chief economist for the U.S. Chamber of Commerce, Richard Rahn, says these regulations "have caused a massive withdrawal of foreign investment from the United States over the last few months, further depressing our stock markets."

It is all too obvious that anything that discourages foreign investment is going to have a seriously adverse effect on prices and this in turn will effect the entire economy right down to Johnny Lunchbucket and Susie Homemaker. In recent years, foreign capital inflows have been perhaps the important factor in bidding up stock prices. Now, this capital is moving elsewhere. And why is that? Because of an overreaching and draconian IRS.

From January 1, 2001, financial institutions in countries which haven't had their know-yourcustomer rules "approved by the IRS" won't be able to be Qualified Intermediaries and may incur U.S. sanctions if they don't identify all their customers to the IRS. The King of Nations has thus spoken and everyone is in a dither.

If a country and an institution is deemed to be a Qualified Intermediary they must identify its U.S. customers to the IRS and must withhold tax from payments to U.S. citizens if required to do so by the IRS.

The IRS procedure for obtaining approval is set out in Revenue Procedure 2000-12. It states: "The IRS will not enter into a qualified intermediary (QI) withholding agreement that provides for the use of documentary evidence obtained under a country's know-your-customer rules if it has not received the know-your-customer practices and procedures for opening accounts and responses to 18 specific questions listed in the revenue procedure."

So what is the reaction of foreign governments to these new overwhelmingly unfair U.S. requirements? They are simply faced with doing what the U.S. wants them to do or their U.S. dollar correspondent accounts may be frozen. Now this is a particularly curious development since the International Monetary Fund, the puppet of the Federal Reserve, has convinced the majority of the governments around the world to get rid of their worthless gold reserves in favor of those valuable U.S. dollars. And, were the ability to trade in U.S. currencies withheld, many foreign economies could simply collapse. At the present time it is estimated that as much as 2/3rds of the reserves in central banks around the world are held in U.S. dollars! An incredibly scary thought—many or most of the world's economies are hanging on U.S. policy and its fiat currency. (Money backed by nothing other than the "good faith" and integrity of the U.S. government.)

So is it bad to have U.S. regulators and the securities at the rate of \$2 billion a day in order to reduce IRS in quasi control of much or most of the

#### CHINA'S QIAN WARNS U.S. NOT TO FUEL 'FLAME OF WAR' OVER TAIWAN

Washington—U.S. advanced-weapon sales to Taiwan would heighten tensions with China and may spark "a great flame" of hostility in the region, China's foreign policy chief warned.

While Vice Premier Qian Qichen praised the U.S. desire for a peaceful solution to tensions across the Taiwan Straits, he said the Bush administration should not provide Taiwan with weapons that would better equip the island to defend itself.

"If weapons were sold to that region, it would be like adding fuel to the flame," Qian told the U.S.-China Business Council in Washington. "There's already a spark there. If you pour oil and fuel over the spark, the spark will turn into a great flame. We don't want to see the flame of war there."

The Bush administration has signaled it may sell Taiwan destroyers equipped with the Aegis missiletracking system, over Beijing's objections.

China considers Taiwan a renegade province, and Qian questioned the U.S. commitment to a "one-China" policy.

He said the U.S. "has reiterated time and again that it adheres to the one-China policy; in other words, Taiwan is part of China."

"Therefore, to sell weapons to part of the territory of another sovereign state, whether the weapons are defensive or offensive, won't stand," he said to the business council, a group promoting greater commercial integration.

President George W. Bush yesterday pledged to Qian the U.S. will respect a 20-year-old covenant to reduce weapons sales to Taiwan, although Bush said he hasn't decided whether to sell Taiwan the advanced destroyers

whose radar can detect cruise missiles.

#### ANALYSIS: U.S., CHINA DON'T NEED TO CLASH

WASHINGTON (UPI)—The dynamics of domestic politics in China and the United States are intersecting in grim ways, putting both countries on a collision course over Taiwan.

Chinese Vice Premier Oian Oichin visited President George W. Bush in the White House seeking to dissuade him from selling state-of-the-art U.S. weapons, including Aegis radar-system destroyers, to Taiwan. He looks unlikely to succeed.

Meanwhile, China is pushing ahead rapidly with a massive build up of ground-to-ground, ground-to-air, and ground-to-sea missiles to establish its own military superiority over the 100-mile wide Taiwan Strait. The clear aim of such forces is to threaten or intimidate the offshore island of 23 million people from declaring full independence....

The United States is the dominant nation of the Western Hemisphere and within NATO, the Atlantic Alliance. China is the rising superpower in East Asia.

In the short term, the rise of China looks likely to bring it into conflict with Vietnam, its historic enemy of the past millennium, and eventually with Russia. There are no such inevitable conflicts demanded by geography or centuries of history with the Untied States. Russia's vastly under-populated and underdeveloped Siberian and Far East regions are the obvious eventual area of expansion for China's mushrooming population of more than 1.3 billion, which is desperate to find adequate energy resources, other raw materials and living area. And Siberia is rich in all of them.

Both views are simplistic, moralistic and based on That possibility has raised Beijing's ire because the ignorance of the complexities of life in the other nation. technology would render its offensive weapons trained But as relations between the two Pacific Rim giants deteriorate, especially over Taiwan, they are already being embraced as obvious truth on both sides. The Chinese find themselves facing loud, moralistic and—in their eyes—unfair criticisms from the United States government, Congress and private pressure groups on a whole range of issues. The Chinese believe that Americans lecture them endlessly about their record on human rights, about their repression of Christian Churches that do not accept state authorization and about their policies in Tibet.

It is hard for many Chinese policy makers to accept that many of these issues are not official U.S. policy but are often pursued by private groups in defiance of the wishes of previous U.S. administrations. Not long ago, hundreds of thousands of people turned out in Central Park in New York City to hear the Dalai Lama, the spiritual leader of Tibetan Buddhists. Chinese analysts knew that no meeting on such a scale would be feasible anywhere in the entire vast area of China without the approval of the Beijing government.

Therefore it was hard for them to avoid the conclusion that the U.S. government deliberately approved the meeting to stir up anti-Chinese popular sentiment.

An even more sinister conclusion, apparently reached by some, was that powerful and wealthy political, military and business elements in the United States orchestrated such activity and that the U.S. government of the day—the Clinton administration—was powerless to stop them. Similarly, U.S. expressions of concern over the environmental costs of the gigantic Three Gorges Dam project are not taken seriously by virtually any senior Chinese official....

Americans in general are ignorant of the details and subtleties of the 1972 Shanghai Communiqué that has been the bedrock of good Sino-American relations over the past quarter century.

Americans overwhelmingly see Taiwan as a longestablished U.S. ally and independent democracy. They do not realize that Chinese see it instead as an integral part of historic China that was artificially cut off from the rest of the country by Japanese aggression in 1895 and by the politics of the Cold War over the past half

China does not have a national ideology comparable In the long run, only India in Asia—almost as to Soviet Communism after 1917—or even, of Mao's Communist regime after 1949. For their part, the American people show no interest or appetite for foreign wars or conquest. The Korean and Vietnam wars—now respectively over for close to half a century and a quarter of a century—removed any desire they had for any serious military adventures on the Asian mainland.

In Beijing too, international tensions can serve domestic political—and other—interests. Prime Minister Zhu Rongji has championed China's entry into the World Trade Organization and continuing free market economic policies. The United States and China could still settle their differences over Taiwan, as Britain led by Margaret Thatcher secured the future status of Hong Kong under Chinese sovereignty. Once that issue was out of the way, China could grow in power and influence for 50 or 100 years without coming into conflict with any significant U.S. interest in Asia.

But if Beijing and Washington cannot defuse their differences and misunderstandings over Taiwan, then the warnings and military planning options developed by hard-liners on both sides could rapidly become selffulfilling prophecies. Both the Chinese and American peoples would pay a fearsome price for those mistakes. #### U.S. TOLD TO MAKE CHINA ITS NO. 1 ENEMY

A historic shift of emphasis in United States military deployment from Europe to Asia, with China supplanting Russia as America's principal foe, is at the heart of the Bush administration's long awaited defence strategy review, according to reports in Washington.

Outlines of the potentially epochal rethink of the U.S.'s global strategic priorities were given to President George Bush by his defence secretary Donald Rumsfeld at a private meeting at the White House on Wednesday, the Washington Post reported yesterday.

"The president was complimentary, he appreciated the policy discussion, and gave the indication that the topics were indeed what he had in mind," a Pentagon official told the paper.

More than 50 years after the struggle to deter the Soviet Union in Europe became the centrepiece of U.S. military strategy in the aftermath of the Second World War, the Rumsfeld review has concluded that the Pacific Ocean should now become the most important focus of U.S. military deployments, with China now perceived as

The review says, in effect, that Washington should abandon the long-standing doctrine that the U.S. military must always be prepared to fight two major world conflicts simultaneously, the reports quote officials as saying.

By elevating China to the status of global enemy number one, the review clearly foreshadows an American turn away from Europe, or at least from the levels of U.S. engagement and attention which have existed for the lifetime of most Europeans.

Mr. Bush ordered the strategy review immediately on taking office. It is the most important of three complementary reviews intended to shape U.S. military priorities in the 21st Century. The other two are on nuclear weapons and missile defence options, and on service pay and conditions.

This means putting fresh resources into airlift capacity to enable the U.S. to move troops, vehicles and is the greatest threat," it said. weapons many thousands of miles from bases in America to the frontline in Asia at short notice.

The report says the threat from hostile missiles is likely to become so serious that the U.S. can no longer afford to risk its largest and most expensive ships, the Nimitz-class aircraft carriers, in forward positions. As a result, the navy will be told to stop building big ships and to concentrate on speed and maneuverability, including a new generation of smaller carriers, to avoid them becoming targets.

The threat from weapons of mass destruction, such as nuclear, chemical and biological weapons, against American military targets means that U.S. allies may begin to question the advisability of allowing Washington to have bases in their countries, the Pentagon suggests. The report says this is another reason why long-range supply capacity needs to be increased.

The review does not make recommendations about particular weapons systems, but there is no doubt in Washington that missile defence shields will form a central part of the new strategy.

Other key elements of what would be, in effect, a rearming of the U.S. military are likely to include a greater role for long-range bombers and for unmanned aircraft. The F-22 fighter programme is likely to face cutbacks, though there is speculation that it will not be scrapped.

The sweep of the review is so comprehensive and its conclusions so radical that the publication of the final report later this year is likely to set off a whole series of turf wars within the U.S. military, as the armed services scrabble for influence and funding in the new era.

Washington's decision to turn more of its guns and missiles towards China came as it was confirmed that a senior colonel in the Chinese people's liberation army has defected to the U.S. while visiting as part of a military delegation. The defection, which apparently took place at the end of last year or in January, involved an unnamed officer in the foreign affairs department of the army general staff.

#### WATER, THE LOOMING SOURCE OF WORLD CONFLICT

GENEVA (AFP)—Demand for clean water, caused by surging population growth, environment abuse and poor water management, is becoming a dangerous source of friction in many parts of the world, especially the Middle East, experts say.

The peril is being spelt out for World Water Day, a UN-sponsored event Thursday that is appealing for better international cooperation and smarter use of a precious and declining resource.

"Just as war over fire sparked conflict among early prehistoric tribes, wars over water may result from The huge distances involved in the Pacific mean that current tensions over this resource in the next few years," says a report by the consultancy PricewaterhouseCoopers.

"The Near and Middle East are the zones where there

"Two-thirds of the water consumed in Israel comes from the occupied territories, while nearly half of the Israeli water installations are located in areas that were not part of its pre-1967."

Friction between Lebanon and Israel rose sharply last week after the Jewish state accused its northern neighbour of seeking to divert water from a river that feeds the Sea of Galilee, Israel's prime source of fresh water.

Other big flarepoints in the region are Turkey's plan to build dams to store the waters of the Tigris and Euphrates rivers, a scheme that is strongly opposed by Syria and Iraq; the Iraq-Iran row over the Shatt al-Arab waterway; and disputes over the use of water from the Nile, embroiling Egypt, Sudan and Ethiopia.

UN figures suggest there are around 300 potential conflicts over water around the world, arising from squabbles over river borders and the drawing of water from shared lakes and aquifers.

In southern Asia, the biggest problem is the India-Pakistan dispute over the Indus, while in central Asia "there are high risks of conflict" between Uzbekistan, Kazakhstan, Kyrgyzstan and Tajikistan over the Amu Daria and Syr Daria rivers and the already depleted Aral Sea, the PricewaterhouseCooper study said.

In Africa, the Chobe, a tributary of the Zambesi, has become a cause of tension between Botswana, Mozambique, Zambia and Zimbabwe, while there have Ljubco Georgievski, whose second largest city is been border incidents between Mauritania and Senegal over control of the Senegal River.

The forces behind such disputes are clear, according to the World Health Organisation (WHO), which pinpoints fast-growing population in poorer countries and water resources that are often squandered or polluted.

"Around one-sixth of the 6.1 billion people in the world lack access to improved sources of water, while 40 percent are without access to improved sanitation services," it says. Each year, 3.4 million people, mostly children, die from water-related diseases.

A UN-backed panel, the World Commission on Water, estimated last year that investment in water will have to double to \$180 billion a year to meet targets. Only the private sector can muster capital on this scale, it said.

#### RUSSIA: NATO HAS TURNED KOSOVO INTO 'A BREEDING GROUND OF TERRORISM'

Warning that the military clashes occurring in the small Balkan nation of Macedonia could "spill over... into the rest of the Balkan Peninsula," Russian President Vladimir Putin sent a letter of support to Yugoslav President Vojislav Kostunica, promising diplomatic and military cooperation.

Putin's letter was delivered by Russian Foreign Minister Igor Ivanov, who is currently visiting heads of state in the Balkans, the area of the world known as the "powder keg of Europe".

Putin declared that "decisive political action-and, if necessary, the use of force" can avert a wider Balkan war. He also said that Russia would be willing to join "Europe and the United States in diplomatic—and possibly military—efforts" to end the crisis in the region.

Putin's remarks were carried by the Voice of Russia World Service, the official broadcasting service of the Russian government.

On Monday, Ivanov blamed NATO for the present instability in the region, stating that NATO had turned Kosovo—the nominally Yugoslav province which it has occupied since the end of the 1999 air war—"into a breeding ground of terrorism".

The prime minister of the Republic of Macedonia, currently under attack by ethnic Albanian separatists, declared in a recent press interview that the current round of bloodshed in the Balkans is part of an "organized and long-planned aggression".

The ethnic Albanian guerrilla forces operating in Macedonia refer to themselves as the National Liberation Army. Their numbers are estimated to range from 500 to 2,000 fighters.

Many observers consider the fighters in Macedonia to be linked to separatists in Kosovo and the south of Serbia, who are bound in a common struggle for the eventual goal of a "Greater Albania."

The National Liberation Army's source of support is Kosovo, according to Georgievski.

"The international community hesitates to admit that fact," Georgievski stated, "because it would mean... its policy has failed."

The probability of NATO or the international community coming to Macedonia's aid with troops is, at present, slight. Both the EU and NATO are loath to intervene in the Macedonian struggle, and there is even disagreement as to the analysis of the strength of the ethnic Albanian forces in Macedonia.

According to the Radio Bulgaria report, UN special envoy for the Balkans Carl Bildt expressed disagreement with NATO Secretary General George Robertson over the numbers and organizational structure of the separatists. While Robertson sees the separatists in Macedonia as a small, relatively isolated group, Bildt warns of a "fairly well-organized" force that controls "an entire region" of Macedonia.

Bildt also observed that Macedonia's army is "badly armed," and heavily dependent upon the Albanian minority for manpower. Approximately 40 percent of the Macedonian army is comprised of ethnic Albanians. Those opposed to IMF bailouts, such as DeRosa, see Turkey as an indication that the new administration will not resort to bailouts so opposed by Republican conservatives.

They are also encouraged by a White House announcement that law professor Kenneth Dam who has been critical of the IMF and its bailouts, will be nominated to the U.S. Treasury Department's number two position as deputy secretary.

Another key nomination in the Treasury is that of John Taylor as under-secretary for international affairs. He once called for the scrapping of the IMF and has indicated his dislike of bailouts. Critics of bailouts charge that they undermine one of the fundamentals of a free economy by overriding market mechanisms.

They say bailouts are expensive, bureaucratic and cut investors' losses rather than allow them to bear full responsibility for their bad decisions leaving the obligation to repay the subsequent debt to that country's taxpayers. They say bailouts also hinder free-market reforms.

"To the extent that the IMF steps in and provides money, reform will not be forthcoming," notes the Cato

Much of the attention of the critics is focused on the Institute, a pro-free-market think tank. "Indeed, despite giant rescue packages that the IMF recently extended to a post-crisis recovery in some Asian countries, Turkey and Argentina, which are still to produce fundamental structural reform has not taken place in any of the Asian countries."

#### IN BED WITH SHARON

Ariel Sharon's success in Washington is a setback for the Palestinians and a challenge for next week's Arab summit in Jordan. The Israeli prime minister, once ostracised by the U.S. and famously described as "an obstacle to peace" by James Baker, was given a statesman's reception this time around. President George Bush and Colin Powell, his secretary of state, agreed that Israel's security concerns must come first, that a Clintonstyle comprehensive Middle East peace deal was not worth pursuing, and even perhaps that Yasser Arafat not be given a White House audience until he definitively halts the intifada violence.

Mr. Sharon astutely pressed all the Bush buttons. He stressed the importance of regional stability (to Mr. Bush this means U.S. oil supplies). He underlined the need to counter international terrorism (another Bush priority). He worried about weapons proliferation, particularly in respect of Iran (a developing Bush fixation). He gave a big thumbs-up to Mr. Bush's pet project, missile defence (and prospectively procured a share of the hardware). And, echoing Dubya's briefing papers, he warned of the continuing dangers posed to all by Saddam Hussein's

Iraq. Mr. Sharon's message was both clear and clever. In all these key areas of U.S. concern, Israel was not only America's ally. It was, to adapt Madeleine Albright's phrase, America's indispensable friend. Lost amid this deft flummery was unambiguous U.S. insistence that Mr. Sharon end the military and economic blockade of the Occupied Territories, hand over tax receipts due to the Palestinian Authority, halt further settlement expansion (as in Har Homa now), and resume the dialogue. Instead, Mr. Bush says he will not "force peace". That suits Mr. Sharon just fine.

Arab leaders must act quickly, if that is not too absurd a concept, to set aright this diplomatic capsizal. One immediate step should be the disbursement of the \$1 billion in aid promised to the Palestinian Authority last hygiene, where people are collecting whatever water is autumn but largely still withheld. Another is concerted pressure for a UN stabilisation force in the Territories, a proposal Israel wants the U.S. to veto. The Arab summit might ask the EU to take the lead in the peace process. And, turning Israel's argument around, it could warn that if the U.S. truly expects Arab support for revised "smart" sanctions on Iraq and an end to regional connivance in Baghdad's oil smuggling, it had better take a harder look at the remoulded Mr. Sharon.

#### UN REPORTS ONLY PLASTIC BOTTLES, SUNLIGHT NEEDED TO PURIFY WATER

GENEVA-A do-it-yourself technique of disinfecting water with sunlight and soft-drink bottles could save hundreds of thousands of lives a year, federal grants now gushing out in the name of the World Health Organization said Thursday.

In a campaign to reduce deaths from unhealthy water in developing countries, the UN health agency is promoting a nearly cost-free process called Solar Water Disinfection, or SODIS.

Requiring only sunlight, empty plastic soft-drink bottles and a black surface, it costs almost nothing, said Martin Wegelin, a researcher at the Swiss Institute for Environmental Science and Technology.

The process is simple: Transparent bottles are filled with water and placed horizontally on a flat surface for about five hours. The heat and ultraviolet rays of the Sun kill illness-causing microorganisms in polluted water.

"Some 2.5 million people die from drinking unsafe water every year," said Richard Helmer, WHO's director of health and environment.

"They are unnecessary deaths since this method could provide them with safe drinking water. This is a highly reliable method that has been proven to work," he said.

bottom half of the bottle is painted black or placed on a black sheet of corrugated iron or plastic, which absorbs more heat and kills more pathogens.

The simple process kills most microorganisms,

officials said.

More than a billion people drink unsafe water, the agency said in a report to mark World Water Day. A total of 3.4 million people, mostly children, die every year from water-related diseases from drinking, swimming in or washing clothes in polluted water.

Diseases include malaria, diarrhea and guinea worm.

WHO urged the use of SODIS, chlorination and better hygiene as immediate means of improving water quality in developing countries. It said chlorination is another simple method that costs just a few cents a day.

"Even in conditions of very poor sanitation and available for their household supply, if the water is chlorinated [it] is improved," said Mark Sobsey, explain, however, where some of this country's professor of environmental microbiology at the therapeutic obsessions or prosecutorial crusades originate. WHO said chlorine could be added to both home and city reservoirs and was essential in refugee camps.

We took note, a few weeks back, of all the recently discovered good causes ("The Funding Fount," February 27). > Proponents may argue that these are all good and worthy causes. The problem, however, is that each cause soon becomes an industry from which individuals derive their incomes. And when that happens, something like the Mondale Act's funding for sex crimes metastasizes into monstrous abuses of prosecution and therapy by people who need to keep the funding stream flowing from Washington.

> So with the bully industry aborning, we commend this phenomenon to the new Administration's budget investigators, or anyone seriously interested in delivering us from the madder aspects of the ever flowing funding fount. [JR: These federal grants that study the patterns of destructive behavior come right from such think tanks like the Stanford Research Center, established by the Tavistock Institute of England. These are the masters of mind control who manipulate our reactions and form our opinions. Our government has been studying the effects of school violence for over three years, yet these shootings continue. Is this a coincidence that this particular California school district has been the recipient of government grants and studies and has now had two school shootings in the past two weeks? Most responsible adults believe that the bullying and targeting of students is due to failed parenting and school administrators that are indifferent to the problems and concerns of their students. This can't continue because this lack of attention, love and concern is affecting all our children. It's time to get government-financed psychological studies and promotion of mind-altering drugs out of our schools.]

#### "GLOBAL TAX POLICE" UNDER SCRUTINY

House Majority Leader Dick Armey (R-Texas), says Organization for Economic Cooperation and Development is trying to initiate a "global network of tax police" with an initiative that the organization believes will stop "harmful tax competition".

Armey wrote to Treasury Secretary Paul O'Neill requesting that he "re-evaluate" America's involvement in the initiative—which was supported by the Clinton administration. Confusinng

"It is my understanding that career personnel are urging you to support the Clinton administration viewpoint on the grounds that the OECD initiative is needed to reduce tax evasion. This is a red herring. A global

network of tax police is the wrong approach. Instead, the U.S. should shift entirely to a territorial system, the common sense notion that countries only tax income that is earned within their borders and also eliminate the double taxation of income that is saved and invested." Armey said in his letter to O'Neill.

"Bad economic policy is not the only reason to reject the OECD's initiative. Countries that are being persecuted for having attractive tax policies will have little incentive to cooperate in the prosecution of drug dealers, terrorists and other international criminals. Indeed, the OECD proposal likely will cause an increase in crime since some people may seek illegal income from things like money laundering," Armey said.

OECD contends it is trying to crack down on tax evasion.

"The OECD project has been mischaracterized as seeking to harmonize taxes at a high rate, as forcing countries to alter their tax structures, and as attacking legitimate tax planning undertaken through legal means. These characterizations of the project are not correct. The project does not challenge legal tax planning," according to an OECD statement.

Armey also believes the Paris organization's effort is "misguided."

"It is designed in effect to create a tax cartel for the benefit of a small handful of high-tax nations. These countries are seeking to impede the flow of global capital, and the U.S. economy with its comparatively attractive tax system will suffer if they succeed," Armey said.

But OECD contends that "the project seeks to impede tax cheating, to prevent wealthy taxpayers from illegally avoiding their share of the cost of infrastructure and public services in their country residence imposed by the tax law. The project is concerned primarily with the illegal tax practice [from a civil or criminal perspective] of failing to report income, and accordingly with regimes that facilitate this practice."

A Treasury Department spokesman said Monday that O'Neill had no comment on Armey's letter.

Daniel Mitchell, an economist with the Heritage Foundation, thinks OECD's initiative is "a direct threat to America's economic interests" and believes "international bureaucrats are seeking control of U.S. tax law."

"The United States is a low-tax country by industrial-world standards and our favorable tax treatment of foreign investment has made America a magnet for world capital. Needless to say, any effort to hinder or restrict tax competition between nations would undermine our competitive advantage," Mitchell said.

OECD, according to spokesman Nick Bray, does not want to dictate the tax policy of the United States.

"The claim that the OECD wants to dictate the United States tax policy is preposterous, ridiculous and absolute rubbish," Bray told *CNSNews.com* in a statement from Paris.

The United States is the largest member of OECD. [JR: The OECD sounds like another subversive ploy by the UN to get us all under its taxing net. - Use nominee service so that there is no link to you personally;
- Open a (preferably no-fee) bank account for the corporation;
- File "zero income" (non-activity) tax returns every year;
- DO NOT TRANSACT ANY BUSINESS WITH THE CORPORATION.

A shelf corporation maintained in this manner typically carries a premium of \$1,000 to \$1,500 PER YEAR OF AGE, in addition to the initial costs of setting it up. As the maintenance costs are typically (at least, through Budget Corporate Renewals) less than \$500 per year, everything included, you just might find investing in shelf corporations to be a very rewarding enterprise!


