

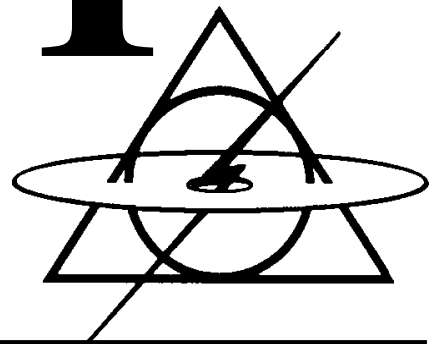

Well, how do you feel, after reading this?

Can you believe what you just read? Can you see things happen in modern times, as described in these 24 *Protocols*? I can hear some readers saying: "This is not true, the *Protocols* are not of Jewish origin and have been made up by some anti-Semites." Well, to those "smart ones" I will show up two mistakes in their reasoning:

1. It is an absolute fact that the *protocols* are of Jewish origin. The proof of this can be found in one of the oldest books in the world, which has been sold many millions of times and cannot be taken away from the public anymore—the Jewish *TALMUD*!!!

2. Semitism or anti-Semitism and the Jews have almost nothing in common! "What? What is this guy talking about?" some people are thinking immediately.

mass-media is telling you. Get yourself some history books and the *Encyclopaedia Judaica* and get your knowledge yourself through your own research!

Here I will just give you some short phrases. Des Griffin has done tremendous research for his book *Anti-Semitism and the Babylonian Connection*.

As a result of an unrelenting avalanche of Zionist propaganda, the vast majority of Germans as well as Americans have been misled into believing that the word Semite refers almost exclusively to the people who today are known as Jews. In fact, few things could be further from the truth!

Interestingly, the words Semite, Semitism and anti-Semitism do not even appear in the 1828 edition of *Noah Webster's American Dictionary of the English Language*. They were coined only towards the end of the last century.

So, who are the Semites?

The Semites are, according to the highly authoritative *Oxford Universal Dictionary*, 1944 (p.1838) the people belonging to the race of mankind which includes most of the peoples mentioned in Genesis 10 as descended from Shem, son of Noah, as

the Arabs, Hebrews, Assyrians and Arameans, and speaking a Semitic language as their native tongue.

Well, most people in the world would answer the question whether the modern Jew is of Hebrew or Semitic origin was a clear “yes”! False! This is simply not true. The Jews in modern society have nothing to do with the ancient Hebrews of biblical times. For decades we never thought of even questioning this basic assumption.

Actually, it is an historical fact that some 95 percent of modern Jewry are not of Semitic stock. They are of Turkish stock—the so-called Khazars.

“The Khazars came not from Jordan, but from the Volga, not from Canaan, but from the Caucasus. Genetically they are more related to the Hun, Uigur and Magyar than to the seed of Abraham, Isaac and Jakob. The story of the Khazar Empire, as it slowly emerges from the past, begins to look like the most cruel hoax that history has ever perpetrated.” (Arthur Koestler, *The Thirteenth Tribe*).

Let me give you some quick overview of the history of the Khazars.

“The Jews of our times fall into two main divisions: Sephardim and Ashkenazim. The Sephardim are the descendants of the Jews who since antiquity have lived in Spain (Hebrew: Shephard) until they were expelled at the end of the fifteenth century. In the 1960s, the number of Sephardim was estimated at 500,000. The Ashkenazim or Khazar Jews at the same time numbered about 11 million.” (*The Thirteenth Tribe*, p.181)

The *Jewish Encyclopaedia* tells us about the Khazars (spelling varies) “Chazars: A people of Turkish origin whose life and history are interwoven with the very beginning of the history of the Jews in Russia... driven on by the nomadic tribes of the steppes and by their own desire for plunder and revenge. In the second half of the sixth century the Chazars moved westwards... the kingdom of the Chazars was firmly established in most of southern Russia long before the foundation of the Russian monarchy by the Vangarians (855 AD). At this time the kingdom of the Chazars stood at the height of its power and was constantly at war. At the end of the eighth century... the chagan (king) of the Chazars and his grandees, together with a large number of his heathen people, embraced the Jewish religion. (Having the Christians to their left and the Muslims to their right they were asked to join either one of those religions, but the chagan out of protest chose the Jewish religion). The Jewish population of the entire domain of the Chazars, in the period between the seventh and the eighth century, must have been substantial. About the ninth century it appears as if all the Chazars were Jews and that they had been converted to Judaism only a short time before. It was one of the successors of Bulan named Obadiah, who regenerated the kingdom and strengthened the Jewish religion.

“He invited Jewish scholars to settle in his dominion and founded synagogues and schools. The people were instructed in the *Bible*, Mishnah and the *Talmud* and the divine service of the hazzanim... In their writings the Chazars used the Hebrew letters... the Chazar language predominated...

“The Russian Varangians established themselves at Kiev... until the final conquest of the Chazars by the Russians after a hard fight. Four years later the Russians conquered all the Chazarian territory east of the Azov river. Many members of the Chazarian royal family emigrated to Spain... Some went to Hungary, but the great mass of the people

remained in their native country” (*Jewish Encyclopaedia*, Volume IV, article on Chazars, pp. 1-5).

After Obadiah came a long succession of chagans (kings), for according to a fundamental law of the state only Jewish rulers were permitted to ascend the throne.

So we glean from strictly Jewish sources that the vast majority of present day Jews cannot claim to be descendants of the original Hebrews, and possibly heirs to Palestine. Because of that fact, the term “anti-Semitism” does not refer to the modern Jews. Benjamin Freedman, a Jew who was on a first name basis with most of the top Zionists in the ’30s and ’40s, puts his finger firmly on the true purpose behind the use of the term “anti-Semitism”. He declares that “it should be eliminated from the English language”. “Anti-Semitism” serves only one purpose today; it is used as a smear word. When so-called Jews feel that anyone opposes any of their objectives, they discredit their victims by applying the word “anti-Semite” or “anti-Semitic” through all the channels they have at their command and under their control”. (*Facts are Facts*, Benjamin Freedman, p. 73)

Also what happened in the Third Reich is not necessarily related to “anti-Semitism”, it had to do with “anti-Khazarism” and “anti-Talmudism” (especially the “Mosaic Law”) which will be answered correctly by any SS-member (if still alive). I will give you some direction through all these terms pretty soon.

The most widely known and powerful Khazar family is the Rothschild family, who are named after the red shield that is the symbol of the Khazars. Does this make sense? It definitely will do so even more by the end of this book.

Just keep in mind that, because the modern Jews are not of Hebrew origin, they never had and never will have a right for claiming the land of Palestine. The state of Israel is absolutely illegal, even if the Jews would have some Hebrew origin. But you will read more to this in the later chapters.

To bring it down to the point: the race with the most “anti-Semitic” attitude is probably the modern Jew himself. Why? Because they hate and fight the Arabs who really are of Semitic stock whenever and wherever they can!!! Therefore the “Arabs” are “anti-Khazar” or “anti-Jewish” and the Jews are the ones who are “anti-Semitic”!

Think about it! Sometimes the truth is very uncomfortable.

[H: I ask that you be generous with criticism of the English translation as presented here because it is difficult to handle acceptable English grammar when coming from translations of other languages. Our intent is not to rewrite this book—we have written one or more volumes of each one of these topics and sometimes five or six. Some have been banned, burned and denied the crossing of national boundaries. These are the *Phoenix Journals* which were begun with the Phoenix Project in 1986 with first publications in 1989. They all are yet to be indexed as to content focus, for they were written in JOURNAL format generally too diverse in topics to qualify as “a” topic. CHAPTER 7

THE *TALMUD*—WHAT A LOVELY BOOK!

Before reading this chapter I want to point out very clearly that it is not my intention to go against a race or a people or to push the guilt to a certain group of people. I’m interested in uncovering their belief system, that’s what I’m putting my finger on. This chapter is going to upset you, as it did upset me in the first, second and third place, too. I did not like to write this chapter and I don’t like this theme at all, but it is of tremendous importance to understand what is happening on our planet. If you want to understand why Hitler, Benjamin Franklin, George Washington, Martin Luther and many, many others wanted to hunt down the Jews, you have to know what follows here, because it was the cause of their actions. So please don’t get angry with me for presenting this stuff.

ALL THE SOURCES FOR THIS CHAPTER ARE OF JEWISH ORIGIN.

Coming back to the *Protocols*: I can still feel some readers doubt their origin. Let’s have a look at a few phrases out of the *Talmud* (translated from a German version) to understand why the barbarian Khazars were interested in suddenly becoming “*Talmud* believers”, and maybe to understand why the Jews always have been hunted, wherever they’ve been. Is there maybe some reason behind it?

[H: Please, an interruption here. These “Jews” in point are also generally called Talmudists or Talmudians. You who witnessed the O.J. Simpson trial regarding the murder of his wife will perhaps recall that Marsha Clarke, a prosecution lawyer, stated right out to Judge Ito that certainly they all wished for a “Talmudic-type court which would bypass the trial itself as being presented.” The prosecution in other words could simply hang the man without trial at all and further the cause of the Talmudic law without consideration of justice. As it was, there was justice—only to be reversed in a “civil” uncivilized rerun over MONEY. Be very careful about to whom you listen and form your opinions, for mostly you will be given the “party line”—not truth. These Khazarian Talmudists are making a major thrust to topple the world into their control, readers. They give you the information, themselves!]

[Directly from the *Talmud*:]

“Just the Jews are humans, the Non-Jews are not humans, but cattle” (*goyim* = human cattle)

(Kerithuth 6b page 78, Jebhammoth 61a)

“The Non-Jews have been created to serve the Jews as slaves” (Midrasch Talpioth 225)

“The Non-Jews have to be avoided, even more than sick pigs” (Orach Chaiim 57, 6a)

“Sexual intercourse with Non-Jews is like sexual intercourse with animals” (Kethuboth 3b)

“The birth-rate of the Non-Jews has to be suppressed massively” (Zohar II, 4b)

“As you replace lost cows and donkeys, so you shall replace dead non-Jews” (Iore Dea 337,1)

“To box an Israeli on the ear, is like to box on the ear of god” (Sanhedrin 58b)

“God (Jahveh) is never angry about the Jews, just about the Non-Jews” (*Talmud* V/ 2 / 43b + 44a)

“Everywhere they (the Jews) come, they will be the princes of the lords” (Sanhedrin 104a)

“I (Jahveh) make you (the Jewry) the ancestor of the peoples, I make you the selected one amongst the peoples, I make you the king over the peoples. I make you the loved one amongst the peoples, I make you the best one amongst the peoples, I make you the trusted one amongst the peoples”

(Schabbat 105a)

“Towards a Non-Jew the Jew doesn’t cause an adultery... Punishable for the Jew is just the adultery towards his next, that means the wife of a Jew. The wife of the Non-Jew is excluded”

(*Talmud* IV / 4 / 52ab)

“There is no wife for the *goyim*, they really aren’t their wives” (*Talmud* IV / 4 / 81 + 82ab)

“You (the Jews) have made me, Jahveh, the only true lord in the world. I will make you the only ruler in the world”

“Who wants to be smart shall occupy himself with money matters, because there are no corner pillars in the Thora that are more important, because they are like a sparkling fountain”

(*Talmud* IV/ 3 / 173b)

“Jews always have to try to deceive Non-Jews” (Zohar I, 168a)

“Carry on trade with Non-Jews, if they have to pay money for it”

(Abhodah Zarah 2a T)

“Non-Jewish property belongs to the Jew who uses it first”

(Babba Bathra 54b)

“If two Jews have deceived a Non-Jew, they have to split the profit”

(Choschen Ham 183,7)

“Every Jew is allowed to use lies and perjury to bring a Non-Jew to ruin” (Babha Kama 113a)

“The possessions of the *goyim* are like an ownerless desert, and everybody (every Jew) who seizes it, has acquired it”

(*Talmud* IV / 3? 54b)

“The Jew is allowed to exploit the mistake of a Non-Jew and to deceive him” (*Talmud* IV / 2/2/70b)

“When the Messiah comes, all will be slaves of the Jews”

(Erubin 43b)

Lovely, isn’t it? Do some of you still believe that the “Protocols” are not of “Jewish” origin?

Can you understand the kings who kicked the Jews from their countries? I don’t talk about the ordinary Jew, like the ordinary Christian or Muslim, but the powerful ones. And these do believe in the nonsense you have just read.

If you want to understand why we have wars, planned wars for many hundreds of years on this planet, and why the Illuminati don’t care about millions of people of all races being killed in these wars, you have to understand that in the eyes of a *Talmud*-believing Khazar-Jewish banker NO HUMAN dies in a war between countries, but *goyim*. Just the Jews are human in the eyes of a Mosaic Jew, who believes in Mosaic Law (that you just read), and all the other ones are cattle and have to be treated like cattle. child of Christian parents believes in Christianity. In this book we are looking at the ones who believe in the lines you just read and we are interested in what these people are doing because of this belief.

Do you think that what I just wrote and showed you out of the *Talmud* just appears in some Nazi-German heads, the “bad guys” of this planet? Then you are far off!

The *Talmud*, the ultimate authority in Orthodox Judaism, plumbs the depths of moral and spiritual depravity. Wherever they went, the Mosaic or Talmudic Jews became legendary for their crookedness and their diabolical ingenuity in taking advantage of those with whom they came in contact. They were both feared and despised. As a direct result of their chicanery they were expelled from one nation after another.

Jews were evicted from England in 1290 AD, (returned 1655); France 1306 (returned around 1682); Hungary 1360-1582; Belgium 1370-1700; Slovakia 1380-1744. They were also thrown out of the Netherlands, Austria, Spain, Portugal, Italy, Bavaria and other nations in Europe in the same time frame.

Jesus said about these particular Jews, that they “were of their father, the devil.” (John 8:44). That’s the reason, and really the only reason, why Jesus has been killed by those Jews, the Pharisees!

[H: Hey, you ask: “Are we picking on these poor people? No, what game would you have to play if not for them, confused people? But when some are unable to write CORRECT historical data to make sure the LIE flourishes, it is a sad commentary, indeed. Can this be more unreasonable than the proclamations of authors and interviewers about “shape shifting” people of the Royal Families (specifically, the Royal Family of England)? We present this documented information for your convenience and hope that you will stop calling the people who bring truth after the lies are instilled, revisionists. The REVISIONS came with the lie, not the truth, and became accepted “fact” from the miscreant fictionists. Is not truth somehow bad enough in its insanity that worse has to be fabricated and then repeated until the brain is dead and accepts the lie without question?

This book was brought to us specifically for use and comment. I suggest you just remain open and then reach your own conclusions, for I have no enemies and every event throughout experience is but a positive experience for possible growth into truth and honor. If you don’t understand my statement, then I really do suggest you stay tuned—for the TRUTH is somewhat more strange and wondrous than the fiction of the kings.]

Martin Luther for example had this to say: “I had decided not to write any more neither of the Jews nor against the Jews. Because I have learned, however, that those miserable, wicked people do not cease trying to win over to themselves us, that is the Christians, also I have permitted this booklet to go forth that I might be found among those who have resisted such poisonous undertaking of the Jews, and have found the Christians to be on their guard against them. I would not have thought that a Christian would permit himself to be fooled by the Jews to share their exile and misery. But the devil is the god of the world, and where God’s world is not, he has easy sailing, not only among the weak, but also among the strong. God help us. Amen

“And as a distinguished mark, they strengthen their faith and bitter hatred against us amongst themselves by saying: “Keep on. See how God is

amongst us and does not forsake his people in exile. We do not work, we enjoy good, lazy days, the cursed *goyim* (human cattle) must work for us, we get their money, thereby we are their masters, they however, are our servants. Keep on, dear children of Israel, it will be better still! Our Messiah will come if we thus continue and appropriate to ourselves, usury, Hemdath (Hebrew: possessions, desire) of the heathen!

“Do not their *TALMUD* and their Rabbis write that it is no sin to kill if a Jew kills a heathen, but that it is a sin if he kills a brother in Israel! It is not a sin if he does not keep his oath to a heathen. Therefore, to steal and rob (as they do with their usury) from a heathen is divine service. For they hold that they cannot be too hard on us nor sin against us, because they are the noble blood and circumcised saints; we, however, are cursed *goyim*. And they are the masters of the world and we are their servants, yes, their cattle!

“Should someone think I’m saying too much—I am not saying too much, but much too little. For I see in writing how they curse us *goyim* and wish us evil in their schools and prayers. They rob us of our money through usury and, wherever they are able, they play us all manner of mean tricks...”

Martin Luther’s last recorded utterance on the subject of the Jews was, “You should know that the Jews blaspheme and violate the name of Our Saviour day by day. For that reason, you, Milords and ladies, should not tolerate but expel them. They are our public enemies and incessantly blaspheme our Lord Jesus Christ. They call... Mary a harlot and her Holy Son a bastard... If they could kill us all they would gladly do so; in fact many of them murder Christians, especially those professing to be surgeons and doctors. They know how to deal with medicaments in the manner of Italians—the Borgias and Medicis—who gave people poison which brought their death in one hour or in a month.”

Should Martin Luther be condemned as being a rabid hater of Jews? Not necessarily! It is abundantly clear from a careful reading of the above statement that Luther was attacking the basic Talmudic philosophy which motivates many Jews, like the Rothschilds for example.

It will also come as a great surprise to many American readers to learn that a number of their “glorified” forefathers were much more outspoken on this issue than Adolf Hitler.

Benjamin Franklin (1706-1790) for example:

“We must protect this young nation from any insidious influence... that menace, gentlemen, is the Jews. In whatever country Jews have settled in any great numbers, they have lowered its moral tone, depreciated its commercial integrity, have segregated themselves and have not been assimilated. They have sneered at and have tried to undermine the Christian religion upon which that nation is founded by objecting to its restrictions; have built up a state within a state and have, when opposed, tried to strangle that country financially...”

“They are vampires, and vampires do not live on vampires. They cannot live among themselves. They must subsist on Christians and on other people not of their race.

“If you do not exclude them from the United States in the *Constitution*, in less than 200 years they will have swarmed in in such numbers that they will dominate and devour the land and change our form of government. If you do not exclude them, in less than 200 years our descendants will be working in the fields to furnish them substance, while they will be in the

counting houses, rubbing their hands. I warn you, gentlemen, if you do not exclude the Jews for all time, your children will curse you in your graves.”

He knew what he was talking about, because the American presidents, Franklin Delano Roosevelt, Harry Solomon Truman and James Earl Carter were hidden Jews (hidden Jews are Jews who take on a different name and sometimes another religion to cover up their Jewish origin. But they still follow their goals, because if not, they will die a silent death through their rabbis! You don’t believe this? Read: *Die Schlimmsten Feinde unserer Völker (The most dangerous enemies of our peoples)* by Jean Boyer, Edicion Actualizada, Bogota, Colombia, 1979. It will blow your mind!

And George Washington (1732-1799), the first U.S. president:

“The Jews work more effectively against us than the enemy’s armies. They are a hundred times more dangerous to our liberties and the great cause we are engaged in. It is much to be lamented that each state long ago has not hunted them down as pests to society and the greatest enemies we have to happiness in America.” (*Maxims of George Washington*, by A.A. Appleton and Co. pp. 125, 126)

Surprised?

Some readers may think that I’m one of these Nazi German fellows who live back in WW II. That is simply not the case. These chapters do not specifically relate to the Jewish people as a whole (some of my closest friends are Jews). There is a great difference between a Khazar, A Zionist, A Talmudist, the Hebrew Blood Alliance on the one side and an ordinary “Jewish” person in the street. I am concerned about what is written in the *Talmud*, and about the fact that the *Talmud* is applied today. And as I will describe later, it is important to understand who “trained” these Jews, what had been written in the *Talmud*, to understand who their “Lord” is: it is Jahveh—El Shaddai, the one who came down from heaven (not alone) with fire and smoke in a flying cloud!

[H: Do I have comment here? No, I ask exactly what the author asked—read the information and you comment. CHAPTER 8

THE “STRICT OBSERVANCE”

In the 18th century Germany became the centre of European Templar Freemasonry (this had nothing or very little in common with the original ideologies of the Knights Templar). The Templar degrees were introduced into the “Free Observance” system of Masonry, which meant that members had to pledge strict obedience to those of a higher rank. The leader, who was called “The Unknown Superior” and carried the title “Knight of the Red Feather”, was true to the Scottish Rite and thence to the Stuarts.

About one decade after the initiation of FREDERICK THE GREAT the “Strict Observance” and its “Scottish Rite” was adopted by almost all the German Freemasonry.

Frederick made enormous profits from the conflicts to which the “Scottish Freemasonry” had contributed. His goal was the expansion of Prussia and therefore he supported the JACOBITES against the HANOVERIANS, also in 1745 during the great invasion of England. Afterwards he allied himself with England and profited from their difficulties by lending them German soldiers. (Apparently he had read Niccolo Machiavelli, too!)

This was one of the biggest swindles in the history of Europe: a small group of German princes overthrows the English throne and puts a Hanoverian there. Then they use their influence to have England engaged in wars and proceed to empty the English treasury by lending them mercenaries.

THE BAVARIAN ILLUMINATI OF ADAM WEISHAAPT

ADAM WEISHAAPT received his education in a Jesuit monastery and finally became a professor of the canon. Over the years he found problems with the Catholic views and became the personal student of the Jewish philosopher Mendelssohn who converted him to gnosticism.

In 1770 Weishaupt was apparently contacted by the recently convened moneylenders (Rothschild) to

found on their behalf the “SECRET ORDER OF THE BAVARIAN ILLUMINATI” at Ingolstadt.

A short Explanation:

Weishaupt's Bavarian Illuminati are not to be confused with the “ILLUMINATI”, the group we have looked at so far. the TRUE Illuminati had—as mentioned before—infiltrated the “BROTHERHOOD OF THE SNAKE” in Mesopotamia and they never appear under their name or personally and in public. In this book we use the name Illuminati because it has become accepted among insiders to mean this group of people dealing in the background. Adam Weishaupt just used the same name for his order whose objectives were similar to those of the Illuminati (perhaps to confound once more future



of YOU and, therefore, the battle REMAINS to be between the facts of truth (knowing) and the ideas foisted off onto you in the mortal form of self. Therefore, the basic “battle” is for control of IDEAS and THOUGHTS which, therefore, is between the spirits of physical expression and soul—ending up in the long-term as being ONLY a “battle” for the SOULS OF MAN.

A “mortal” experience is but a short journey in expression—while the spirit soul is infinite/eternal. You are very shortsighted, friends. Worse than that—you sell your soul for the EGO which is ONLY MORTAL EXPRESSION. Where will you be when the bombs destined to fall hit your turf?

researchers by a group thus named that appears in public). To avoid confusion I will always call Weishaupt's group “Bavarian Illuminati”.

The Bavarian Illuminati were organized as circles within circles (onion-like). When initiates had proven their capability for keeping secrets, they were accepted into an inner circle with yet deeper secrets. Only those in the innermost circle knew about the true intentions of the Bavarian Illuminati. Members of the lower degrees were told that there were no higher degrees, and the identity of the Grand Masters was not revealed, as in the “Strict Observance”. The Bavarian Illuminati were subdivided into thirteen degrees corresponding to the thirteen steps of the Illuminati pyramid on the U.S. one-dollar bill.

The system copied the spying and informing of the

Jesuits to test members who had reached the title of “Patriarch” for weaknesses. This politics allowed the order to place the Patriarchs in those positions where their talents could best be used. Denouncing was also one of their tactics, to ensure that no Patriarch would go against the order.

Weishaupt succeeded in winning the best and brightest heads in high finance, industry, education and literature for the Bavarian Illuminati. He used bribery by money and by sex to gain control over those already in very high positions.

Once he had achieved this, Weishaupt used extortion to ensure that he retained control over these unfortunate leading personalities. The Bavarian Illuminati then started to have *adepts* (higher degrees) advise government people, of course behind the scenes. These *experts* knew to advise the politicians in such a way that they adopted a form of politics beneficial to the Bavarian Illuminati. But this was engineered so cleverly that the advised persons thought they themselves had gotten these ideas.

The reason given for the existence of the Bavarian Illuminati was the eradication of the dire circumstances in society to lead man back to his natural and happy state. Since this meant to overcome both the Monarchy and the Church they had created themselves dangerous adversaries. And once more it turned out that secrecy was the most important institution of the order.

A document that became known as *THE NEW TESTAMENT OF SATAN* shows what Weishaupt’s Illuminati ideology was meant to be. The document had been closely guarded by the Bavarian Illuminati, and I am using it here because many people still doubt that the *Protocols of the Elders of Zion* are genuine. Perhaps these readers find it easier to accept that plan and the principle of action if the word “Jew” does not appear. The document got only known when in 1875 a courier of the Bavarian Illuminati on his ride from Frankfurt to Paris was struck by lightning and the information of a worldwide conspiracy he had carried was apprehended and revealed to the public.

Therein it is stated: *that the first secret of guiding people is the control of public opinion by sowing discord, doubt and contradictory views until people can no longer find their way in this confusion and are convinced that it was better not to have a personal opinion in national law. Passions have to be fanned in the people and inane dirty and abhorrent writings produced. It is further the task of the press to show up the inability of the non-illuminated in all matters of state and religious life.*

The second secret is to carry the weaknesses of the people, all the bad habits, passions and mistakes to extremes until they no longer understand each other.

The power of the personality has to be fought, as there is nothing more dangerous. If it is endowed with creative spiritual forces, it can effect more than millions of people.

All peoples shall be worn down by envy, hatred, quarrels and wars, by deprivation, hunger and the spreading of epidemics (e.g. AIDS) until they see no other solution than to submit completely to the rule of the Illuminati.

If a state is exhausted by inner radical changes or because of civil war has fallen under the control of external enemies, then it is definitely doomed and so in our power.

People will get used to take illusion at face value, to be content with superficialities, they chase only after pleasure, to exhaust themselves in their eternal obsession with what’s new and finally to follow the Illuminati which will be ascertained by paying the masses well for their obedience and their attention.

Through the demoralization of society shall people lose their faith in God.

By working specifically with the spoken and the written word the masses shall be led according to the wishes of the Illuminati.

With visual instructions the people have to be stopped from thinking for themselves and made to use any existing mental powers for the shadow-boxing of hollow rhetoric. The liberal thoughts of the parties shall be flogged to death by Illuminati orators until people tire and begin to abhor speakers of any movement. On the other hand shall the political science of the Illuminati be constantly fed to the people so they have no time to think.

The masses are blind, irrational and lack judgement and therefore may not partake in the statesmanship but have to be governed with just yet inexorable severity and absolute force.

World rule can only be achieved in a roundabout way, by the purposeful undermining of the cornerstones of true liberty—of justice, the election system, the press, of personal freedom and above all of education and culture of the people—and under the strictest secrecy for all activities.

The purposeful undermining of the cornerstones of state power the governments have to be tormented until they are ready to sacrifice all their power for the sake of peace.

In Europe the differences between people and peoples have to be stirred up to create an insurmountable rift and no Christian state finds support because every other state has to fear that an alliance against the Illuminati was disadvantageous.

On all continents discord, unrest and hostility shall be sown to frighten the states and to break all resistance.

All state institutions have to fulfill important tasks within the state so that by damaging such an institution the whole state machinery will be ground to a halt.

The state presidents shall be chosen from those slavishly devoted to the Illuminati a dark spot in whose past makes them faithful executors of the Illuminati’s directives. Thus the Illuminati will be enabled to reinterpret laws and to change constitutions.

By giving the president the right to proclaim a state of war the whole armed forces will be in the hands of the Illuminati.

The “uninitiated rulers” shall be diverted from thorough preoccupation with state matters by courteous reception and representation duties.

By the corruptibility of the highest public servants the governments shall be put in debt to the Illuminati by foreign loans so that state debts will appreciably be augmented.

Economic crises caused by suddenly withdrawing all available moneys from the market shall bring about the downfall of the money economies of the “non-illuminated”.

The financial power must attain sole control of commerce and trade so that because of their money the industrialists gain political power. Next to the

Illuminati and the millionaires dependent on them, the police and the military, there shall be people without possessions.

The introduction of the general and equal right to vote shall create the majority rule. By instilling the idea of self-determination the meaning of the family and its educational values shall be destroyed. By education based upon false tenets and mendacious teachings the youth shall be stultified, seduced and depraved.

Links to existing and founding of new Freemason lodges to attain the envisaged goal by way of diverted organizations. Nobody knows them or their aims, least of all the oxen of non-illuminated that were enticed to participate in the open Masonic lodges to have dust thrown in their eyes.

All these means shall force the peoples to offer world rule to the Illuminati. The new world government has to appear as patron and benefactor of those submitting themselves voluntarily (the UN). Should a state oppose this, its neighbours have to be driven to war against it. If the neighbour states want to ally themselves, a world war has to be unleashed.” (CORALF: “Maitreya, Derkommende Weltlehrer” (The Coming World Teacher), Konny-Verlag, 1991).

As one can easily see, *The New Testament of Satan* contains almost the same thoughts as do the *Protocols of the Elders of Zion*, only the Jews have been replaced by the Illuminati. But as we have seen on whose behalf Adam Weishaupt founded the Bavarian Illuminati, we can deduce whence *The New Testament of Satan* came.

The conspirators had recognized the strength and the influence of the existing Freemason lodges and started now—following the plan—to infiltrate these and to take control (No. 11 of the *Protocols*).

The lodges that had been infiltrated were then called “THE LODGES OF THE GRAND ORIENT”.

A famous French orator, the MARQUIS DE MIRABEAU, became heavily indebted because of his extravagant lifestyle and was contacted on Weishaupt’s order by the Jewish money lenders. Moses Mendelssohn then introduced Mirabeau to the wife of the Jew HERZ and it ensued that she got to see more of Mirabeau than of her own husband. Now Mirabeau was in a situation where he was, due to extortion and his debts, under total control of the Bavarian Illuminati. Next, he was introduced to the Illuminati proper. He was given the task of convincing the DUC D’ORLEANS who was Grand Master of the French Freemasons, to change the BLUE LODGES into “LODGES OF THE GRAND ORIENT”.

[H: Surely, you didn’t have the delusion that somehow threats, blackmail and conspiracy are things new!]

In 1773 Mirabeau introduced the Duc d’Orleans and Talleyrand to Weishaupt who then initiated them into the “Grand Orient” Freemasonry.

When in May 1776 **[H: Look again at that date and then look at your dollar bill.]** the American *Declaration of Independence* was signed, Adam Weishaupt fulfilled his well-considered plan and introduced the Bavarian Illuminati OFFICIALLY. This date is thence falsely given as the date of their founding. The most important years, though, were the six years prior to the official introduction.

Among the members of the order were Johann Wolfgang von Goethe, Duke Carl August von Weimar, Duke Ferdinand von Braunschweig, Baron

von Dahlberg (Postmaster General of Thurn and Taxis), Baron von Knigge and many others.

In 1777 Weishaupt was initiated into the Freemason lodge “THEODORE OF GOOD COUNCIL” in Munich and soon had the whole lodge infiltrated.

On July 16, 1782 the union between the FREEMASONS and the BAVARIAN ILLUMINATI was sealed in Wilhelmsbad. This pact united about 3,000,000 members of the leading secret societies. An agreement reached at the congress in Wilhelmsbad allowed the initiation of Jews, who at that time had only limited rights, into the lodges.

As the ROTHSCHILDS controlled the Bavarian Illuminati, they now had direct influence on other important secret lodges.

Very little of what had been decided at that conference ever reached the public since all attending were vowed to complete secrecy. The COMTE DE VIRIEU, one of the Freemasons attending, was asked whether he could divulge some of the resolution. He said:

“I will not confide them to you. I can only tell you that all this is very much more serious than you think. The conspiracy which has been woven is so well thought out that it will be, so to speak, impossible for the Monarchy and the Church to escape from it.”

Another attendant, the COMTE DE SAINT GERMAIN **[H: Hummmnnn!]**, later warned his friend MARIE ANTOINETTE of the murder conspiracy that was intended to topple the French Monarchy. Unfortunately his warnings were not heeded. **[H: Wow, sounds like a rerun doesn’t it? Have we heard such as this before even as regards ourselves?]**

From a few weak points, some subversive secrets began nevertheless to seep, with the effect that on that on October 11, 1785 the Bavarian electoral prince had the house of Herr von Zwack, Weishaupt’s first assistant, raided. There, many documents were discovered that described the plan of the Bavarian Illuminati for a NEW WORLD ORDER (Novus Ordo Seclorum). **[H: Check that dollar bill again, please.]**

The Bavarian electoral prince then decided to have these papers published as *Original Writings of the Order and Sect of the Illuminati*. These writings were then widely disseminated in order to warn the European monarchs. Weishaupt was stripped of his professorship and, together with the Duke of Saxe-Gotha, a further member of the Bavarian Illuminati, he disappeared. Since they let the belief that the Order of the Illuminati had been dissolved run its course, they could carry on working in secret and to resurface later under a new name. Within a year the “German Union” made itself known and distributed Illuminati propaganda to the existing reading circles. Here, the famous battle cry was created:

“Liberte, egalite, fraternite.”

The European monarchs, however, did not realize the danger which led to the French Revolution—and the resulting terrorist regime—running its course.

“The great strength of our Order lies in its concealment; let it never appear in any place in its own name but always covered by another name and another occupation. None is fitter than the three lower degrees of Freemasonry. Next to this, the form of a learned literary society is best suited to our purpose. By establishing reading societies and subscription libraries, and taking these under our direction and supplying them through our labours, we may turn the public mind which way we will.”—Adam Weishaupt.

CHAPTER 10

THE BATTLE OF WATERLOO

This was the biggest coup of the ROTHSCHILD family which at that time already had built up a perfect espionage and courier network all across Europe.

On June 20, 1815 one of their couriers, having just come from the battlefield, handed NATHAN ROTHSCHILD the information of France’s defeat. Nathan hastily returned to the London stock exchange and there sold all his holdings of the “English Consul” stock, thus feigning knowledge of England having lost the battle. The rumour spread so that most other stockholders were selling their holdings in a panic of losing all. After a few hours the value of “English Consul” had fallen to five cents on the dollar, so Nathan proceeded to buy all the stock for that ludicrous price. A short while later the official news of England’s victory reached London. The value of “English Consul” shot within seconds higher than the original price and later continued to climb.

Napoleon had had his Waterloo, and Nathan had gained control of the English economy. Overnight the already gigantic wealth of the Rothschilds had multiplied more than twenty fold.

The French had after their defeat obvious difficulties to regain their strength and so, in 1817, they signed a sizeable credit agreement with the French OUVARD bank and the BARING BROTHERS from London. But not with the Rothschilds. And when the following year France needed a further loan, they again bypassed Rothschild.

They of course didn’t like that at all and tried all tricks in and out of the book to get the government to leave the business to them, but to no avail.

On November 5, 1818, something completely unexpected happened. After the French government bonds had steadily risen over a year, they suddenly and inexorably started to fall. At the court of Louis XVIII the atmosphere was very tense. The only people not distressed but actually smiling were the Rothschild brothers KALMAN and JAKOB. For in October 1818 they had with the help of agents and of their unlimited resources bought immense quantities of French government bonds that had been issued by their rivals Ouvard and Baring Brothers. This forced the price up, but on November 5, 1818, they started to put in all the main exchanges of Europe immense amounts of those bonds on the market, thereby creating a panic.

Thus the picture got completely reversed and the Rothschilds became the number one in France. The French Court gave them their full attention, and not just in financial matters.

After the defeat of the French the house of Rothschild thus took control of France, and in London Nathan Rothschild had direct influence on the British Parliament because of his control of the “Bank of England”.

CHAPTER 11

WHO WAS KASPAR HAUSER?

In the beginning of the 19th century an old prophecy started to fulfill itself. According to probably the highest Tibetan secret society, the “dGe-lugs-pa” (Yellow Hats), the point where the VRIL power, the power that runs the universe, hits the planet and emerges would shift from Tibet, the “Roof of the World”, to the “Land of the Midnight

Mountain”—to Germany. That’s the reason why the Tibetans always supported Germany and became the secret founders of the Third Reich. In this prophecy, as well as in the prophecy of Jesus (which you will find in the chapter about the Thule Society), it is said that the new “Licht-Reich” (realm of light) will emerge from Germany and therefore the power of the Jews will be taken away from them. (Compare Matthew 21:43, where Jesus addressed the JEWS: “Therefore I tell you that the kingdom of God will be taken away from you and given to a people who will produce its fruit.”)

[H: Just as a reminder, readers, the gospels as appearing in the *Bible* were chosen and translated by German scholars, so this is not an out-of-the-blue happening.]

It was said that a child would be born that would unite all Europe without war, but through love. This child would be a spiritual master, similar to Jesus, and therefore would be THE enemy of the Jews.

This child was born on the day of Michael, the 29th of September 1812, in Karlsruhe as the son of Grand Duke Karl and his wife, Stephanie de Beauharnais, the adopted daughter of Napoleon, and therefore was the successor to the throne of the House of Baden—the GERMAN EMPEROR!!!

But the Illuminati Freemasons and the Black Nobility knew about him and had to make this child disappear. The French Grand Orient Lodge of Freemasons kidnapped the boy, but they couldn’t just murder him. If they would have killed the physical body, the vehicle of this soul, the soul would simply have chosen another body, maybe one year later, and would have taken the throne anyway. So they had to keep this soul trapped in the body and prevent it from taking on its task. Therefore the Freemasons kept the child somewhere in normal conditions until the age of two and a half, when the child showed its first signs of memory (that’s the time when the soul gets fixed within the physical body). Then the Masons had the child put in a metal cage in a cellar, without any light at all, from two and a half until fifteen (twelve and a half years!). But this wasn’t enough torture yet: The cage was so small that the boy could neither stretch his legs out nor stand up, and therefore his limbs grew at angles. As you will see later, this is a typical Masonic ritual. Freemasons speak in symbols, and every form of punishment has its symbols to show the other Masons what the person has been punished for. So, in this case they chose the square which is one of the Masonic symbols, compass and square.

After twelve and a half years of living in this cage without any light, with just water and bread, the Freemasons thought that they had won and taught the child forty spoken words and how to write the name Kaspar Hauser. They left the child on the streets in the middle of Nuremberg and thought that he would be absolutely lost.

First Kaspar was put in prison for a few hours because he could not speak, was not used to light, had never consciously seen a human being, could not walk right—he just had a very unusual behaviour. But the chief of police immediately saw that this boy was not a criminal at all, because he was a very beautiful child, and he saw that something unusual had happened to him. So

Kaspar was given to a family of a friend of the chief of police, who took on Kaspar as their own child.

But then things started to happen. This child was very unusual. After half a year Kaspar could speak pretty well, and he started to draw. He was a very correct child, intensely tidy, he wore the most proper clothing, everything in his room had its proper place. He had a brilliant memory they had never seen in another child; he remembered every word that had been said by every person he had met, knew the clothing they had worn that day. But he had even more phenomena to show. Besides being such a beautiful boy he was extremely telepathic. He knew what other people thought of, knew who the person was behind his back, 450 feet away, and what he was doing; he saw at night better than during the day, but most important was his being. He was such a gentle, loving being that everybody who met him just had to like him and became a different person. So he became known as the "miracle child of Europe", and people from all over came to see him.

Then, at the age of eighteen, he started to write his first biography (imagine this, after all he could not speak nor write nor do much else at fifteen. Imagine a normal child being imprisoned for twelve and a half years without any light. Nevada Vs. Delaware: Private Vs. Public

Budget's "Tip of the Week" #16:

Response to the Often-Asked Question: What About Delaware?

"My friend said that her attorney said that the best place to incorporate is Delaware because that's where all the big corporations are based." Once again, there is SOME truth in this statement but there is much knowledge to be derived in understanding the differences between Nevada and Delaware corporations.

The fundamental distinction is that while Nevada's statutes create benefits for private corporations, Delaware's corporate statutes have principally been designed to benefit shareholders of public corporations. Many large, public companies that trade on various exchanges across the country incorporated in Delaware because Delaware's statutes provide the best protection of the rights of shareholders. In recognition of the foregoing, Delaware's corporate law with regard to corporate takeovers is the strongest anywhere in the country. And if you want to "go public" with your corporation some day, Delaware's onerous disclosure requirements probably won't bother you.

On the other hand, Nevada's provisions for establishing and maintaining privacy of ownership and control is unparalleled. In Nevada, ownership of a corporation is not a matter of public record; there is no prohibition against the use of bearer shares; there is no requirement for stock to be issued; nor is there any requirement for an annual meeting of stockholders. In terms of privacy of control, the use of nominee officers and directors has been a common practice for over 75 years. In addition, NRS 78.25 makes it a gross misdemeanor for anyone to even attempt to use a Nevada corporation's records for purposes contrary to the interests of the owners.

Delaware is NOT "tax-free". A Delaware corporation's taxable income is taxed at the rate of 8.7%. In addition, its franchise tax has a graduated rate depending on capitalization, amounting to a minimum of \$30 and a maximum of \$130,000.

Nevada's corporate law easily surpasses Delaware's in terms of protection of corporate officers and agents. Delaware has recently adopted a statute that allows a corporation to limit the liability of a director for monetary damages—but officers of Delaware corporations are still not covered. The following acts of officers and directors would be protected under Nevada law, but are exposed to liability under Delaware statutes:

1. Acts or omissions not in good faith;
2. Monetary damages occasioned by acts of officers (directors are now exempt);
3. Breach of a director's duty of loyalty;
4. Transactions involving undisclosed personal benefit to the officer or director;
5. Acts or omissions that occurred prior to the date that the statute which provides for indemnification of directors was passed and approved.

As a final point on the subject of Nevada versus Delaware, it is noteworthy that Nevada has NO RECIPROCITY WITH THE IRS; Delaware, like all other states, freely shares its data with the IRS.

[QUOTING *The NATIONAL*, from Papua New Guinea, circa last week of May or 1st June 2001:]

WORLD BANK CONDITIONS CRITICISED

The World Bank has been accused of dictating to PNG through its loan conditions, especially on multi-million kina forest and conservation projects. East New Britain’s **[H: Boy, those Brits were everywhere weren’t (aren’t) they?!**] deputy chairman of the forest and primary industry Henry Saminga said the World Bank must not be allowed to continue to dictate to the PNG on how it used its timber resources.

Mr. Saminga, who is also president of the Lassul-Baining local-level government said the Bank did not own PNG nor its resources and should not be allowed to dictate how it managed its affairs, especially its timbers resources.

The conditions set by the World Bank include the establishment of a World Bank super board, a review of all ongoing timber and logging operations by an independent review team, and the continuation of a moratorium imposed on the processing of 32 new projects.

Mr. Saminga called on the government to defy the conditions on the moratorium and have it lifted as soon as possible.

He claimed the issue had created a lot of suffering for the people through denial of goods and services and infrastructure development.

“The World Bank through its conditions contributes towards making resource-rich developing countries very poor and must be told to get out of the country before they really destroy the nation,” Mr. Saminga said.

“PNG does not need another super board to oversee the operations of logging companies in the country because that is being well catered for by the National Forest Board.

“The current monitoring system set up by the government is meeting its obligations and there is no need for a World Bank board to be established to undermine that work because that is what the new board would be doing.”

Meanwhile, a forestry consultant is full of praise of the stand by the National Forest Board and the Forest Industries Association against the World Bank’s directives.

Jack Pinia said it was time these organisations stood up against the Bank to protect the interest of the industry and resource owners.

“Who the hell is the World Bank to come here and dictate by imposing its conditions on the Government and resource owners in the forest industry when they have destroyed their own forests without any outside interference?” he said.

“Why should the World Bank be hell-bent on strangulating the forestry sector and not want to talk about other ideas like addressing the moral decay in the country?”

Mr. Pinia agreed with the National Forest Board’s claims that the Bank was trying to undermine its role and functions as mandated under the PNG Forest Act by wanting to set up its own board.

“It is time these people were told to pack up and go back home,” he said.

Now readers, don’t you just think that Mr. Saminga and Mr. Pinia, at the least, should have opportunity to

know there IS AN ALTERNATIVE?

KUALA LUMPUR, (AFP)—Malaysia’s former finance minister has stayed tight-lipped over the apparent rift with Prime Minister Mahathir that sparked his sudden resignation.

But analysts say Mahathir, who has weathered far more serious challenges during his 20-year rule, will survive any political fallout. Mahathir announced Daim Zainuddin’s resignation Saturday, ending months of uncertainty over the former minister’s future.

Daim, who has considerable wealth from a previous business career, eluded reporters staking out his palatial home by driving through the gates in a humble Proton Wira instead of his official Mercedes. Before they realized who was at the wheel, he was inside the grounds. Daim later slipped out of his house to return to his home town.

POLICY DISAGREEMENTS

Analysts said the departure of Daim, credited with pulling Malaysia out of two recessions and widely seen as the most POWERFUL man after Mahathir, was due to policy disagreements with the premier.

Some said the move could set back Mahathir, who is grappling with an erosion of support for his United Malays National Organization (UMNO) and an economic downturn. Yet other analysts viewed it as positive for the economy.

Newspapers said Daim was believed to have also quit as Special Functions Minister and as treasurer of UMNO.

Daim has been associated in the public mind with a series of unpopular bailouts of politically connected companies—such as the government’s decision to buy back a stake in Malaysia Airlines from a private company at twice the current price of shares.

[H: Oh, indeed, we remember well Malaysia Airlines! GAIA offered to assist Sir Daim with that one also. He was basically Mr. Malaysia Airlines (you know, one of those prior businesses mentioned above).]

A Malaysian analyst, who declined to be named, said Daim’s ties with Mahathir had soured over criticism heaped on him over recent controversial business deals. “Daim feels he has been unfairly blamed for many things,” he said.

Megat Najmuddin Khas, president of the Malaysian Institute of Corporate Governance, said the rift was over policy. “You can’t call one a hero and the other a villain,” he told *AFP*. “They were very close friends... I think it is not a fallout because of a division on the spoils but as a matter of principle, a difference of opinion on how to bring about a recovery in the economy.”

If her tone was adamant, it certainly was borne from ignorance. The law states that all such historic finds form part of the national heritage, to be surrendered to and preserved by the National Museum. It is no excuse to not know it. Yet the lawmen let her be. They, too, couldn’t understand the order from higher-ups to confiscate the loot and arrest the fences. Same with local officials who grumbled about Manila officials cutting short the one time in many years that the locales were making a killing from the dynamited waters. Even the television reporter, in his blissful ignorance, was ready to cry human-rights violation the moment policemen grabbed the treasures from the fisherman’s wife.

[H: Perhaps the good of the “good and bad” sides

is that the raiders of that particular ship got away with the gold! That was months ago. Oh, well, where it might be now is anybody’s guess.]

Such is the state of this country. No one obeys the law because no one knows what it is. Everyone protests about his right without bothering to learn the responsibility that goes with it. And those who are supposed to be experts and enforcers of the law either let it pass or twist it to suit their own purposes.

No ideas about segregating and composting, no qualms about unsanitary disposal. For her, it’s all the fault of circumstance. Same with the street hawker who, when requested by patrolmen to wheel her stall out of the way of pedestrians, resentfully cries that they’re ganging up on her just because she’s poor and weak. Truly impossible it is to argue with an ignorant man. And we have them everywhere.

Thus, again, the destruction of our marine resources. Two adult whale sharks and two pups swam into Lingayen Gulf last week. An April 10 National Press Club forum on prospects for further “debt cancellation” for the Third World, displayed the International Monetary Fund's (IMF) brittle new “hard line” on debt. It reflects desperation in international banking circles at the worsening global financial crisis, and reflects the truth—not raised at this forum except by *EIR*—that the crisis of overwhelming unpayable debt which must be cancelled, is not in the Third World.

During the “Jubilee Year” 2000, Pope John Paul II's years-long campaign for Third World debt cancellation gained slight concessions from the G-7 nations; Italy, whose government branches are discussing Lyndon LaRouche's New Bretton Woods

[H: Don't get distracted!] proposals, led the way in forgiving foreign debt. But the overall result was a tiny, less than a half-billion dollars a year cut in interest payments by the world's 22 poorest countries; and the IMF insisted on imposing yet more conditionalities upon the countries receiving this “relief”. **[H: Indeed, don't hang up on keeping the debt even if lowering the interest rates a bit. They want the debt so that there is a continuation of mandatory interest piling up to ensure there is ability to grab the country sooner than later.]**

Now, pronounced the IMF spokesman April 10, any further debt cancellation—which would have to involve debts owed to the IMF, the World Bank, and subsidiaries—“is not under consideration in official circles”. His only recommendation was to eliminate all remaining protections for farming in the United States, Europe, etc., so that Third World nations could export more cheap food to the G-7 countries—a policy of economic suicide for all involved, except the international banks and resource cartels.

As chunks of the international financial system are now glowing, like chunks of a disintegrating jet engine, the IMF is desperate to be able to raise big new emergency bailout packages; the emergency loans for the Turkish and Argentine financial meltdown both doubled in size recently, and approach \$100 billion between them. Thus, the IMF won't write off its Third World “mortgage holdings”, no matter how worthless they were shown to be by *EIR*, and the Carnegie-Mellon University speaker at the National Press forum. **[H: Ah, but: On whose side do you think would be the Carnegie-Mellon ANYTHING?]**

IT HAS BEEN PROVEN REPEATEDLY IN THIS PUBLICATION, AND BY EXPERIENCED ECONOMISTS OF THE DEVELOPING SECTOR, THAT IN EACH REGION OF THE THIRD WORLD, THE NATIONS HAVE ALREADY PAID TWO OR THREE TIMES THE DEBT THEY OWED AS OF 20 YEARS AGO—BUT STILL “OWE” TWICE AS MUCH AS THEY DID THEN! IN OTHER WORDS, THEIR OUTSTANDING INTERNATIONAL DEBTS ARE LIKE THE 30-YEAR MORTGAGE LOAN OF A HOMELESS, JOBLESS FAMILY WHOSE HOUSE COLLAPSED TEN YEARS AGO, WHEN THEY HAD ALREADY PAID TWICE ITS VALUE WITH INTEREST, AND WHOSE FORMER BANKER IS STILL SEEKING THEM OUT UNDER THE BRIDGE EVERY MONTH, DEMANDING THE NEW INTEREST DUE TO KEEP THAT MORTGAGE LOAN “PERFORMING” ON HIS BOOKS. WHICH ONE IS THE BANKRUPT? **[H: Emphasis mine.]**

All of the foreign debt of all the Third World nations, whether performing or not, totals \$2 trillion. But in the G-7 “advanced” countries, the strictly non-performing loans are in the many trillions, and despite desperation bookkeeping tricks, are growing at an increasing rate as the financial markets' crisis worsens. And this does not take into account the many tens of trillions of so-called derivatives obligations, which under certain approaching conditions, become non-payable en masse, all at once.

Compared to their own non-performing loan bubbles, in their own banking systems and bond markets the G-7 countries' unpayable debt from Third

World countries is a trifle, which could and should be completely cancelled in a monetary reform which gets rid of the desperately bankrupt IMF.

More important, the “advanced”, formerly industrial nations urgently need to export capital goods, machinery, and economic infrastructure to the Third World, by means of large new lines of exporting credits, in order to get out from under their own collapsing mountains of non-performing debt. This is the importance of Russian President Vladimir Putin's current proposals for economic collaboration with Germany and Europe, as identified by Lyndon H. LaRouche, Jr. They lead to the New Bretton Woods monetary arrangement, which alone can make the real bankrupts sound.

I am always amused by Mr. LaRouche who insists on being “right” even if incorrect in his assumptions.

I would, however, note that the U.S. is the largest debtor on the globe which locks the U.S. citizen to the dollar's failure—for there is nothing to back the dollar except a whole bunch of tricks, illusions and hot air.

TB AND MDR-TB COMING TO AMERICA: ILLEGAL IMMIGRANTS SPREADING INFECTION

Franklin County, Ohio commissioners recently approved nearly \$1 million to treat a growing public-health threat in the county: tuberculosis. The almost 70-percent funding increase from the previous year was sparked by the county health clinic's dramatic rise in TB cases. Two-thirds of the clinic's TB patients are foreign-born; immigrants to the Columbus area have caused active TB cases to increase from 21 in 1997 to 41 in 1998 to 57 in 1999 to 79 in 2000.

This Ohio story is a microcosm of a public-health threat cropping up in locations across America. Current annual immigration of roughly one-and-a-quarter million foreigners (legal and illegal), predominantly lacking in health coverage and largely from Third World countries, has consequences for U.S. health care.

Mass immigration not only adds costs to the health-care system, it also exposes Americans to diseases that, until recently, were virtually eradicated in this country. Some of those diseases, such as tuberculosis, are highly contagious.

Immigration law makes being infected with certain diseases grounds for exclusion on the basis of threatening public health. However, the screening process in the home country and at points of entry is not foolproof—and illegal migration across a land border makes it easier for a disease-carrier to bypass health inspection. And it doesn't help any that some diseases, such as TB, may be carried in the body for years before becoming highly contagious.

TB may again rise in the United States, and this will stem directly from mass immigration. Worldwide, this disease has made a comeback, accompanied by vaccine-resistant strains. From 1985 to 1991, TB cases rose 20 percent globally. For the first time, the World Health Organization in 1995 declared tuberculosis to be a worldwide emergency. This lung disease is ravaging Africa, Southeast Asia, and Eastern Europe. TB deaths are rising worldwide for the first time in about 40 years.

TB frequently occurs in connection with HIV. In some parts of Africa, 30 percent of TB patients have HIV. The WHO attributes the quadrupling of TB in certain African countries in the past decade to the "deadly synergy between TB and HIV".

Drug-resistant strains of TB—and their affinity to HIV—spell trouble in an age of globalization and porous borders. The threat is especially great because a third of the world's population is infected with TB; in Asia, it's half the population. A tenth of those with the disease will develop an active case of TB. Since 1988, multidrug-resistant TB cases have been reported in 43 U.S. states and in the District of Columbia.

The fast rise of tuberculosis cases in Western countries portends a threat in the immigration-prone United States. Germany and Denmark saw TB cases increase 50 percent in 1996 "with two-

thirds of all cases among immigrants".

So far, America has escaped the public-health crisis that TB could spark. Even with record-high immigration levels, the Centers for Disease Control and Prevention count declining numbers of TB cases reported nationally. Should there be a U.S. increase, it will occur because of Third World natives immigrating via Western Europe or directly from one of the WHO's TB "hot spots", such as parts of China or India, from which the majority of H-1B skilled-worker non-immigrants come.

In the United States, the incidence of TB is prevalent among immigrants. About 41 percent of the 18,361 known tuberculosis cases in 1998 were immigrants; in 1986, 22 percent of new U.S. TB cases were immigrants. The foreign-born incidence of TB in the United States approaches six times that of the native-born. CDC figures show that during the period from 1993 through 1998, the native-born had 5.8 cases of TB per 100,000, while the foreign-born rate was 32.9.

TB is especially prevalent in Mexicans, Filipinos, Vietnamese, Indians, Chinese, Haitians, and Koreans. Mexican immigrants have an infection rate of 35.5 cases per 100,000, far above the native-born rate. Yet, Vietnamese have an infection rate of 137.7; Haitians, 118.5; and Filipinos, 95.9. Immigrants from many Third World countries carry TB, including those from the Dominican Republic and Ecuador, and even Puerto Rico.

Not surprisingly, most TB cases occur in the heaviest immigrant-receiving states: California, New York, Texas, Florida, New Jersey and Illinois. These six states accounted for about three-quarters of the cases reported from 1993-1998. Of TB cases in the Washington, D.C., area, 75 of 78 cases in Montgomery County, Maryland in 1999 were immigrants or refugees. In the Virginia suburbs of Washington, 84 percent of new TB cases in 1999 were immigrants. Ninety-two percent of Fairfax County, Virginia's total TB cases in 2000 were foreign-born patients, who caused a 15 percent rise in the county's TB rate over the previous year.

Clearly, the presence of large numbers of immigrants puts a strain on the American health-care system. Not only are current immigrants more likely to carry TB or some other threat to public health, nearly one-third of persons in immigrant households lack health insurance. That is more than twice the uninsured rate among native-born Americans. Immigration accounted for 59 percent of the growth of the uninsured population between 1994 and 1998.

The public-health challenges of such a large, concentrated segment of uninsured persons strain public and private health resources, especially in heavy immigrant-receiving areas. Five of the six top immigrant-destination states—Texas, California, Florida, New York, and New Jersey—have higher rates of uninsured than the national average. In 1998, American hospitals delivered \$19 billion, or 6 percent of total expenses, in uncompensated care. The National Association of Public Hospitals and Health Systems reported that, in 1997, 26 percent of its members' in-patient services and 41 percent of out-patient emergency services went to "self pay", i.e., predominantly uninsured, patients. New York City alone

spent more than \$1 billion over five years in the late 1980s and early 1990s to control rising tuberculosis cases.

To be sure, active TB keeps an individual from immigrating to the United States; however, Third World immigrants infected with TB may not develop the disease for years. Applicants for immigration visas must have chest X-rays; however, this test doesn't always turn up inactive cases of TB. And a thriving black market of clear X-rays allows applicants to misrepresent a purchased set of X-rays as their own. Meanwhile, illegal aliens bypass these tests altogether.

Once here, immigrants may avoid TB screening because of the public stigma. A female African immigrant in Maryland who worked at a Burger King restaurant avoided doctor's visits and refused to take medicine until public-health officials quarantined her in a hospital for two weeks. Immigrants also are likely to discontinue treatment if they move to another area. Obviously, this kind of conduct further threatens public health and complicates efforts to treat patients.

The threat of infection has risen with the employment of immigrants in Americans' homes. For example, an immigrant TB patient secretly being treated by Maryland public-health officers worked as a wealthy family's chauffeur. Another contagious immigrant was a resident nanny. As the *New York Times* put it, "TB can circle the world at the speed of a passenger jet and be transmitted by a single cough."

To make things worse, many U.S. public-health officials put political correctness before common sense. A Maryland public-health officer told the *Washington Post*, "My greatest fear is that there will be this terrible xenophobic response to anyone who is a quote-unquote refugee or immigrant." One official told the *New York Times*, "It may make absolute sense to screen certain subpopulations because you have evidence of rates of TB way out of proportion to what we see elsewhere. But how you do that without contributing to additional stigma is a challenge we're all confronted with."

If officials have evidence that immigrants from certain nations carry TB at a much greater rate, common sense would dictate that immigrants from those places meet strict screening requirements. Certain countries could face tougher standards if they pose a public-health threat through immigration. **There's no legitimate reason not to place the health of the American public above the sensibilities of certain countries, groups, or their paid advocates.**

Does America have the resolve to safeguard public health first, even at the risk of being politically incorrect? Do American taxpayers willingly accept the additional burden of the costs mass immigration places on the nation's health-care system? Only time will tell. But America must address these questions. In the meantime, places like Franklin County, Ohio will bear the burden.—James R. FOR A PREMIUM, INS TO EXPEDITE VISA PROCESSING

The Immigration and Naturalization Service will begin allowing foreign celebrities, athletes, executives and other specific types of workers to pay \$1,000 to get work visa applications processed within 15 days instead

of waiting the usual three months or more.

INS officials said the Premium Processing Program, to be launched on Friday, will generate \$80 million a year and allow the agency to hire hundreds of extra workers to help all visa applicants.

In the process, INS officials said, businesses that have long complained about delays in the immigration process will be able to be more competitive by paying extra for faster service. INS officials estimate that 80,000 workers a year will eventually take part in the program, which will be expanded in late summer to include the popular H-1B visa for technology workers.

“One of the larger motivating factors behind the Premium Processing Program was that it will give us a way to get extra revenue to hire more adjudicators and modernize all our systems across the board,” said INS spokeswoman Eyleen Schmidt. “We think this will help everyone.”

But many immigration experts said the program will create a disturbing two-tiered system by giving special access to wealthy foreigners and large corporations. Critics also said that by focusing resources on those applicants, the INS may end up imposing even longer waits on petitioners of more modest means.

“The government ought to be processing immigration documents expeditiously for everybody,” said Mark Krikorian, executive director of the Center for Immigration Studies, a Washington-based think tank. “You don’t go to the department of motor vehicles and pay extra to get ahead in line.... If we as a country decide we want to let in immigrants, we ought to fully fund an efficient mechanism for processing those immigrants.”

The fast-track processing program was pushed by the INS and approved by Congress and President Bill Clinton last year as a little-noticed provision in an appropriations bill. The \$1,000 fee, according to the legislation, “shall be used to provide certain premium-processing services to business customers” and can be adjusted for inflation in coming years by the attorney general.

The program will start by focusing on a half-dozen limited categories of visas, which allow citizens of other countries to work in the United States for limited periods.

One is used by notable athletes and celebrities, from foreign-born baseball players to international rock stars, while another includes scientists, authors and others with artistic or specialized skills. Many executives and managers in multinational corporations will also be immediately eligible to apply for expedited service, as will some temporary agricultural and service workers.

By the end of August, Schmidt said, the INS will expand the program to include all “nonimmigrant workers” who want employment in the United States but are not seeking citizenship. Officials said there are no immediate plans to offer faster processing to immigrant workers seeking green cards, which allow foreign citizens to work permanently in this country. It takes an average of nine months to get a green card application processed, officials said.

The \$1,000 fee would be paid on top of the normal \$110 processing charge. In the case of technology companies filing H-1B visa petitions, the fee would be added on top of \$1,110 in current charges. The money will be returned if the applicant does not receive a response from the INS within 15 days, but the fee does not guarantee approval, Schmidt said.

The new money will allow the INS to hire 450

new employees in fiscal 2002 who will work on processing all types of petitions, officials said. “We will make sure we have the resources on hand not to jeopardize other services,” Schmidt said.

But many immigration lawyers and experts argue that the need for the fee is the result of meager funding from Congress. Most federal money to the INS is spent on the U.S. Border Patrol and other enforcement tasks, while most immigration services are paid for with user fees.

“This is the ‘money talks’ scenario,” said Crystal Williams of the American Immigration Lawyers Association. “The INS’s need for more money is what led to this. They’re so desperate for funds to clear their backlogs.”

Carl Shusterman, a Los Angeles immigration lawyer who handles many employer-based visa requests, said some of his clients could be helped by the new program, but many others could be hurt.

“You used to have to have a reason to have things expedited,” Shusterman said. “Now you don’t need a reason, you just need a check. For a lot of small companies or individuals, they’re not in a position to shove out an extra \$1,000. I’m not sure this is fair to them.”

At the four INS service centers that process visa petitions, the wait times are an average of 60 to 90 days for the categories of workers who will be eligible for the new program, officials said.

The INS completed about 3 million visa requests and other petitions last year and granted citizenship to 1 million others.

INS officials said the premium program should not have much impact on the State Department’s Bureau of Consular Affairs, which actually issues visas to applicants overseas after they have won the approval of the INS. Many of those eligible for faster processing are already in the country, Schmidt said.

Schmidt said that President Bush’s 2002 budget requires that \$20 million of the money brought in by the new fee program must be dedicated to improving services for immigrants sponsored by family members rather than employers.

INDIAN WINS PERUVIAN PRESIDENCY

Though still unofficial, victory is sign of change in corruption-ridden nation.

LIMA, PERU—Alejandro Toledo rose from a poor childhood as a shoeshine boy to become Peru’s first freely elected president of native Indian descent Sunday, defeating controversial ex-President Alan Garcia.

The election came seven months after Peruvians drove authoritarian President Alberto Fujimori from office in a corruption scandal and signaled a return to democratic voting after elections tainted by fraud.

With few reported incidents of trouble at polling places, international observers called it Peru’s cleanest elections in years.

“The time has come to extend Dr. Toledo my congratulations for his triumph on this democratic day,” Garcia said, offering his help in the new administration.

With 70 percent of the vote counted, Toledo had 51.6 percent to 48.3 percent for Garcia, said Fernando Tuesta, the nation’s top election official.

Toledo smiled after exit polls were released, but said he would wait for more complete results before commenting.

Toledo’s running mate praised the outcome. “This is a great stroke of luck for Peru, and I’m very excited,” said Raul Diez Canseco, Toledo’s first vice president. Peru has two vice-presidential posts.

International monitors—including former President Carter—had said previous elections were deeply flawed.

On Sunday, there were few reported incidents of trouble at polling places.

“I want to congratulate the Peruvian people for a clean election and a demonstration of civic maturity,” U.S. Ambassador John Hamilton said.

Toledo may well be the first president in Latin America to win after making Indian rights a top campaign issue. There have been other Peruvian presidents of native Indian descent, but they took power in military coups.

The 55-year-old capitalized on his dark, chiseled Indian features and short stature to appeal to a mostly poor native Indian and mixed-race population that accounts for more than 80 percent of Peru’s 26 million people.

Toledo’s strength came also from his leadership role in the campaign to unseat Fujimori, whose regime collapsed in November amid mounting corruption scandals. Toledo withdrew from a runoff against Fujimori in May of last year, accusing him of planning to rig the results.

Like Garcia, Toledo campaigned largely on a populist platform. He has pledged to create 2.5 million jobs, raise salaries for public workers and lower taxes.

“He headed the fight against Fujimori’s corrupt government. He deserves to be president,” vegetable seller Apolonio Mayta said before the vote was tallied. The 53-year-old makes a precarious living working off her tricycle in a Lima shantytown.

Garcia, 52, used scintillating oratory to overcome memories of his calamitous 1985-90 presidency, marred by corruption, guerrilla violence, food shortages and hyperinflation.

In recent weeks, he had narrowed the gap with Toledo, who only a few weeks ago led most polls by as many as 20 percentage points.

Garcia returned to Peru in January to seek re-election after nearly nine years in exile waiting for corruption charges against him to expire.

His charisma and ability to transmit hope to Peruvians, especially to young voters who don’t remember his government, boosted his candidacy, and despite his loss he emerges as Peru’s strongest opposition voice and a force to be reckoned with in the future.

“His first government left a bad memory, but we should give him another chance,” said Maria Moya, a 35-year-old divorced mother of two who moved to Lima from a village in the Andes highlands.

“Anybody can make mistakes, and he has said he is sorry for his errors.”

U.S. STUDYING SAFETY OF USING CLONED ANIMALS AS FOOD

WASHINGTON—U.S. regulators said on Tuesday they have urged companies that clone livestock to apply for U.S. permission before they put the animals’ meat or milk into the food supply.

The Food and Drug Administration is developing policy guidelines on whether cloned animals that are

not genetically modified should be tightly regulated like drugs. Officials are trying to determine whether the animals present any safety risks.

The agency plans to issue its position after the National Academy of Sciences completes a report assessing if cloned animals pose any hazards to animals, human health or the environment. The report is due out early next year.

In the meantime, the FDA has advised a handful of companies that clone sheep, cows or pigs to file an application with the agency if they want to sell cloned animals as food. So far, none have indicated they want to do so in the near term.

"If people insist on putting them into the food supply... before the report is out, we would recommend that they come into us with an investigational application first, just to be on the safe side," said John Matheson, a senior regulatory scientist at the FDA's Center for Veterinary Medicine.

Companies involved in animal cloning include PPL Therapeutics, creator of Dolly the sheep, Infigen Inc. and Advanced Cell Technology.

Scientists clone animals by taking DNA from an adult cell and placing it in a female egg stripped of its own genetic material. The embryo is implanted into a surrogate mother, and the baby animal is a clone.

Such cloned animals are genetic copies of another animal, and they do not pose the same concerns as animals whose genes have been modified.

"In theory, these animals should be fine, but we want to make sure there isn't any risk associated with them," Matheson said.

At a congressional hearing in March, experts reported high rates of failures in animal cloning attempts and birth defects as **arguments against cloning people**.

The FDA commissioned the National Academy study to help regulators decide whether cloned animals should require "pre-market" approval, as drugs do, or if they should be classified like in-vitro fertilization, which is more loosely regulated.

"We're trying to make a science-based decision on whether unmodified cloned livestock should be regulated on a pre-market approval basis," Matheson said.

GOLD MARKET FORECASTS WAR ON IMMEDIATE HORIZON

Gold traders and investors who have wondered aloud in recent months how the yellow metal can possibly mount a sustained rally and look so good from a chart perspective—in the face of a rising U.S. and global stock market outlook—now may have their answer. The gold market is forecasting war between China and Taiwan—and possibly even North Korea and South Korea—with the United States sandwiched right in the middle. If gold's long and reliable history as a war gauge is any indication, the events in question should occur sometime in 2002.

A number of experts in recent weeks have weighed in on this developing crisis. Lawrence Patterson, editor of *Criminal Politics* magazine, reports that the United States is facing war in the Pacific within 12-24 months. Writes Patterson: "The China attack will be a massive ballistic missile assault obliterating the Taiwanese military structure with plenty of missile power left over to terrorize the civilian population. The missile attack will be over in three or four hours and the occupation will begin

before sunrise on the East Coast. By the time Americans reach their work that fateful day, China will have established a complete naval blockade of the island, threatening the United States that its Naval forces face nuclear destruction should it attempt to defend Taiwan. They will not be issuing an idle threat."

Patterson has not been the only observer in recent months to forecast a soon-to-come war with China. According to former Chairman of the Joint Chiefs of Staff, Admiral Thomas Moorer, the U.S. can expect a war with China within 1-2 years. He points out that former president Clinton essentially gave them technology to modernize and advance their military power and that we have given much ground during the Clinton years.

Major General John K. Singlaub, who was fired by former president Jimmy Carter from his Asia-Pacific command, says in an interview with *Newsmax.com* that "The Chinese considered themselves in the driver's seat since they bought President Clinton years ago, and they got used to it. Now, they're flexing muscle because they've been used to getting their way."

A report from the *Monetary & Economic Review* states that "The U.S. won't come to Taiwan's defense because they value Los Angeles more than they value Taiwan." These generals are, of course, referring to their missiles pointed at Los Angeles. This long-range capability was arranged by the Clinton administration.

The *Monetary & Economic Review* also states that Dr. Alexander Nemets and Dr. Thomas Torda, two China experts, both say China is ready to take Taiwan in 2002. They believe China's plans have already put it on a collision course with its neighbors, and a collision course with the U.S.

Improbable? Hardly. The most accurate barometer for a country's 1-2 year outlook is the performance of its prime stock market index. In the case of Taiwan, while other Asian countries (principally China) enjoy bull markets, or at least bear market rallies, Taiwan's stock market sports one of the most pathetic growth rates of any major country.... This has taken place even as China's stock market has experienced an historic boom. The tale of two destinies, perhaps? You can bank on it.

It is also extremely interesting that China's financial bonanza of the past year has eclipsed the fortunes of most other industrialized countries which mostly suffered huge losses in stock market slides of 2000 and the early part of 2001. Why has China been the only major country to be exempt from the claws of the bear over the past year? Could it be that their equities boom was in large part created and sustained by outside investment flows from nations (and banks) sympathetic to the communist regime and their goals of invading Taiwan and, eventually, the United States? After all, it takes money—and lots of it—to capitalize major military ventures, and China's long-standing and impressive bull market will go far in building up their military and preparing the country for the long rigors and financial hardships of war. The United States' open-armed embracement of so-called "free trade" with China—which has allowed China free reign in dumping cheap goods onto U.S. shores while levying heavy tariffs on American exports—is another way China has been allowed to build up its economy and military at another nation's expense.

Most frightening, China, of all nations, is by far the most equipped to deal with a protracted military campaign at this point in time. The U.S. has allowed its military to fall into a decrepit state in recent years and is surely no match for the Big Red Menace. Case in point: We

have been informed through news accounts that Russia—China's ally—has sold China advanced surface-skimming missiles which can be nuclear tipped and for which the United States has no defense.

The ugliest constellation of unfolding events, according to Patterson, would be that the North Koreans would join in the battle for Taiwan by invading South Korea. As Patterson points out, the U.S. has no troops in Taiwan; therefore, there would be a possibility to remain out of the conflict were it not for some 40,000 troops the U.S. has stationed in Korea. Thus, in all probability, the U.S. will have no choice but to be drawn into a massive new conflagration in South Korea—resulting perhaps in the loss of as many as 100,000 American men and women.

Moreover, *Human Events* reports that American-based defense contractor Lockheed Martin, which received more U.S. tax dollars last year than any other U.S. defense contractor, has built a naval surveillance system for Red China! A Lockheed spokesman was quoted in the article as stating that the company plans on building even more such systems for China in the near future. As well, Boeing Aircraft has done their part to build up the Chinese military. The heads of both of these companies should be tried for treason.

Of more pressing concern to the U.S., Patterson reports that Red China has established a military base in Cuba that has not even been acknowledged by either the Clinton or the Bush Administrations as of this date. He states further that there are plans underway to transfer nuclear-tipped missiles to Cuba in order to repeat the exercise of Nikita Khrushchev in 1962.

Contemporaneously, President Clinton issued an order to block construction of a much-needed airport at Florida's Homestead Air Force Base. This base was devastated by Hurricane Andrew in 1992. Clinton claimed a desire to protect the environment but, in fact, the decision had to do with a covert military operation and treasonous plans for south Florida. Without this commercial airport base, the Air Force cannot continue to utilize the base, as there are no landing facilities available.

"One can only wonder," Patterson writes, "if this has something to do with a treasonous plan to allow an invasion of south Florida to take place utilizing Chinese troops."

Recently, General Dynamics, one of the nation's number one defense contractors, announced plans to acquire Newport News Ship Building. If allowed to be completed, it would mean that General Dynamics has been allowed to acquire so many other companies that it would be the only supplier of submarines and aircraft carriers for the United States military. Worthy of note, Bill Gates became an investor in Newport News Ship Building several months ago.

Observes Patterson: "In recent years we have allowed a merger activity among defense contractors, which is indeed frightening. The concentration of power over our defense system industries in only a few hands is an extremely bad idea and would allow individuals with treasonous intent to enter places of authority in those companies and create havoc and grievous trouble for the United States."

In perhaps another proxy for war, China's latest attempt at gauging the United States' military commitment and political fortitude occurred earlier this week when a U.S. military vessel attempting to make a routine port of call in Hong Kong was denied harboring, the first such denial in the 55 years. China's premier

refused to give an explanation for its actions, stating only that it wasn't "appropriate". Clearly, the U.S. is being tried by China to see what and how much they can get away with before seeing any kind of retaliation. Thus far, they must be smiling with glee at the docile non-reaction among the U.S. public and its political officials.

Another possible indicator of U.S. public sentiment is the release of the blockbuster movie *Pearl Harbor*, which was released over Memorial Day weekend with great fanfare. According to press reports, it is the most expensive movie ever made in Hollywood history. Accompanying this film release were a number of Pearl Harbor-related book releases, television programs and a plethora of TV and Internet debates about Pearl Harbor, U.S. involvement with past wars and, most telling, the possibility for future U.S. involvement in wars. Judging by the intense focus the media seem to be giving the war (which it should be pointed out is specifically a case of the U.S. being bombed by a foreign enemy), we cannot help but wonder if perhaps the opinion makers are not taking the public's "temperature" on the issue of war—perhaps even laying the psychological groundwork for the up-coming wars involving Asia. After all, Washington cannot afford another Vietnam experience with U.S. draftees kicking and screaming every step of the way to the slaughter pen of war. This could well represent the early stages of war propaganda. Time will tell.

Patterson offers excellent advice for preparing for this inevitability: "Make sure that your Y2K literature and your supplies [including gold and silver coins] are not dispersed and that they are maintained for your safety. Those who failed to make any preparations for Y2K may be quite smug (they were right all along)—but one of these days smug individuals will be proven wrong."

Indeed, America may well have found its next major crisis. Only this one, unlike the previous one, is not a false alarm.

NO IMMUNITY FOR FBI SHARPSHOOTER

Court rules that agent who killed Randy Weaver's wife at Ruby Ridge can be tried.

SAN FRANCISCO—A federal appeals court ruled Tuesday that an FBI sharpshooter can be tried by Idaho prosecutors for manslaughter in the slaying of White separatist Randy Weaver's wife during the 1992 Ruby Ridge standoff.

The ruling from a sharply divided 9th U.S. Circuit Court of Appeals revives a case mentioned in the same breath as Waco and cited by Timothy McVeigh as motivation for the Oklahoma City bombing.

It could also mean that FBI officials will be hauled into court to defend decisions made during the 14-day confrontation in northern Idaho. The agency is already stinging from recent gaffes in the bombing case and the recent indictment of agent Robert Hanssen on espionage charges. The Ruby Ridge case is seen as a test of whether federal agents are immune from state prosecution. The federal government declined to prosecute agent Lon Horiuchi, but Tuesday's ruling

clears the way for Idaho prosecutors to pursue charges against him in the death of Vicki Weaver, 42.

"When federal officers violate the *Constitution*, either through malice or excessive zeal, they can be held accountable for violating the state's criminal laws," Judge Alex Kozinski wrote in the 6-5 decision.

The court agreed with Idaho's contention that immunity cannot be granted until there is a hearing to determine whether Horiuchi acted unlawfully. If a judge rules Horiuchi broke the law, the case can go before a jury, the court ruled. The panel rejected arguments that it didn't matter whether Weaver's death was the result of excessive force.

"When federal law-enforcement agents carry out their responsibilities, they can cause destruction of property, loss of freedom, and as in this case, loss of life—all which might violate the state's criminal laws," Kozinski said.

Horiuchi's attorney, Adam Hoffinger, declined comment and a Justice Department spokesman wouldn't say whether the decision will be appealed.

Outgoing FBI Director Louis J. Freeh said he was disappointed with the ruling and said the agency stands behind Horiuchi.

"As so often happens in law enforcement, split-second life-and-death decisions must be made by those sworn to enforce the law," Freeh said. "We continue to believe strongly, Agent Horiuchi met the legal standard that protects law-enforcement officers when they carry out their duties, even when the consequence in hindsight is regrettable."

Ramsey Clark, a former U.S. attorney general under President Johnson who argued the case for Boundary County, Idaho, called the ruling "courageous" and said it showed that law enforcement would be held accountable for violence.

WHERE HAS ALL THE SILVER GONE?

The picture above was taken on Sunday, June 3rd at Yankee Boy Basin, 40 miles from my home, in glorious Colorado. One can't Jeep there in winters or even spring, because there is perhaps 50 feet of snow there. But now one can go there in a Jeep. Know where all the snow went? It melted, ran into the Uncompahgre River, which went into the Gunnison River, which went into the Colorado River, and then on through the Grand Canyon, and into Arizona and California, with Mexico getting but a trickle. We know where the snow went, and we also know there will be more, come

next fall and winter, but where did all the silver go?

There used to be hundreds of millions of ounces of silver in the U.S. and other government vaults. It didn't melt like the snows of Yankee Boy Basin. It was used. Used for coins, film, computers, and other electronic gee gaws. It was used for sterling flatware and other silver niceties. It was used for jewelry, belt buckles, and other assorted things in common use. Even though the above photograph was taken with a digital camera, regular film that uses silver has by no means evaporated, and will be in common use for many decades to come. There was at one time a rubber tire, but no more, as they are all synthetic. There are a lot of synthetic things, such as margarine that looks like, and even tastes a lot like butter—but there is no substitute for silver. Silver can be used as the lowest-resistance wire known to man, and is a superb conductor of heat and cold. Gold isn't a commercial metal, but silver is. **The yearly consumption of silver is many times its production.** So where did all the silver go? It won't come back this fall like the snows in Yankee Boy Basin, because the price is so low that no one can possibly mine it for the current price of about \$4.40 per ounce. Many of the silver mines are closed.

Not to be a Colorado nut, but the glitzy town of Aspen was a silver town. When the "crime of '93" came about—and William Jennings Bryan was defeated for President—Aspen closed its doors. It was over for Aspen, because the mines had no gold... only silver. Aspen didn't get going again until the late forties when some WWII 10th Mountain Division vets, who had trained there, realized it was a superb skiing area, and the boom began. But the silver mines are beyond recovery, even though there is undoubtedly hundreds of millions of ounces left in Smuggler and Aspen Mountains. It'll never again be mined when it costs \$55 a day to ski over all that silver. The silver has all been used up, and little is being produced. There are some processors that recover silver from film developers, but not enough to put a dent in the demand. Some sell the family heirlooms when the need arises—but not enough to put a dent in the demand. There is some dental scrap that finds its way back into the supply—but not enough to put a dent in the demand. The U.S. government doesn't even make its own blanks when they stamp out those American Silver Eagles. It can't, because it doesn't have any silver to make them with but must buy the blanks from the likes of Englehard or Johnson-Mathey. That's why they cost so much, but you already knew that no government ever does anything economically, didn't you?

Silver is in demand, and the storehouses are empty. **As if that weren't bad enough, there are thousands of tons of silver contracts that there is no silver to cover them with if delivery were taken by all the contract holders.** It's almost like a huge spring that has been very slowly wound, until it is tight. If the winding continues, the whole thing will break loose with a terrific wallop. The demand is there, (winding) and the spring is tight (silver supply), and the winding will continue. Will the whole thing sort of explode if a lot of people take delivery of their contracts, the price having to go to the heavens to supply them? Could be. Will we all look back on \$4.40 silver as we look back on \$10 per barrel oil a couple of years ago? Could be. There's a lot more oil in the world than silver. If silver went the way of oil, it would be \$12.35 per ounce, and profitable to mine in most places, assuring a supply. But it would take a long time to meet the demand due to lag time, so silver might have to go to \$25 until the mines re-

opened and supply caught up with demand. It's only a possible scenario, but a realistic one.

Where'd all the silver go? It was, and is still being used decoratively and commercially, that's where it all has gone. But there seems to be no supply near what is being used. If you take more water out of a well than it is capable of producing, there'll be a water shortage sooner or later, and the California electrical thing is the same analogy. Look what happened to California's electrical rates, and transfer that into silver prices, because the comparison is inescapable. Water is expensive when the well runs dry, because you have to pay to bring it in. The silver well has run dry, and it will cost dearly to bring more in. Higher prices make for production at a profit. Think of the \$10-per-barrel oil when you look at \$4.40 silver prices. Is this fear mongering? Of course not, because no one needs silver like we need energy, food and housing. And oh, yes! Food, energy, and housing are what "Mr. Greenspan pieces of paper with ink on them" does not count in his spurious inflation figuring. This is similar to not counting the gasoline cost in running a car! Just had to throw that in... sorry, but the other writers are correct... Greenspan will not go down in history as a hero!

Don't be left wondering what hit you. The majority has never been right in history. **The majority who pooh-pooh gold, and especially silver—touting their worthless pieces of paper with ink on them, savings accounts, CDs, and the other dollar-denominated things—are as wet as rain.** Pay no attention to the majority—and it's seldom that you will go wrong.

MCVEIGH CALLS OFF APPEALS AFTER COURT REJECTS STAY OF EXECUTION

DENVER—Timothy McVeigh has decided against pursuing additional appeals and is prepared to die Monday for the Oklahoma City bombing, his attorneys said Thursday.

A federal appeals court had earlier rejected Oklahoma City bomber Timothy McVeigh's request to delay his execution, saying his attorneys "utterly failed to demonstrate substantial grounds" why the execution should not proceed next week.

The 33-year-old McVeigh is set to die by injection Monday at the federal prison in Terre Haute, Indiana.

A three-judge panel from the 10th U.S. Circuit Court of Appeals considered McVeigh's argument much of Thursday and issued its ruling without hearing oral arguments.

"McVeigh has utterly failed to demonstrate substantial grounds upon which relief might be granted," the court decision said.

McVeigh's lawyers wanted more time to review nearly 4,500 pages of belatedly released FBI documents for information they felt could have helped in his defense during the 1997 trial.

The lawyers argued that U.S. District Judge Richard Matsch was caught up in the horror of the Oklahoma City bombing and "lost sight of the demands of fairness".

Matsch, who presided over the trial, denied the

initial appeal Wednesday.

The appeals court also refused to reopen McVeigh's appeal, noting "our complete agreement with McVeigh's candid concession in his district court filings that the newly produced materials do not satisfy the standard," the court wrote.

The seven-page ruling was issued by Judge David M. Abel of Denver, Judge Paul J. Kelly Jr. of Santa Fe, N.M., and Judge Michael R. Murphy of Salt Lake City.

CHINESE MISSILE MOVES NEAR TAIWAN WORRY U.S.

China is mobilizing some of its short-range missiles near Taiwan as other military forces are engaged in the largest war games in five years, according to U.S. intelligence officials.

The missile activity at two bases across the Taiwan Strait is raising concerns inside the Pentagon that China's military may be set for test missile firings at Taiwan—similar to 1996 missile flight tests that led to a U.S.-China confrontation.

According to officials with access to U.S. intelligence reports, a U.S. spy satellite photographed several CSS-6 missiles at a base in Fujian Province that was used for training exercises in the past but is normally left unoccupied.

Two transporter-erector launchers loaded with CSS-6s were spotted in the open at the training base. Six others were in sheds and an unspecified number of other missiles were hidden under camouflage nearby, the officials said.

"The missile unit occupied a base that is only used for training," said one official. The exact location of the missile-training base could not be confirmed. One official said it was located at Fuzhou, directly across the strait from Taipei.

China has built several missile bases in Fujian Province over the past several years, including the two newest ones at Xianyou and Yong'an. The regional command headquarters for the short-range missile forces is located at Leping.

U.S. intelligence agencies reported in March that a new base for CSS-7 short-range missiles was completed at Xianyou—about 135 miles across the Taiwan Strait from the island. Additionally, part of a CSS-7 brigade recently left another base opposite Taiwan for a mobile deployment exercise, the officials said.

The missiles are among the more than 300 CSS-6s and CSS-7s, also known as M-9s and M-11s, that China has deployed opposite Taiwan in the past several years. Administration national-security officials have said China plans to deploy up to 600 missiles at bases opposite Taiwan.

The Pentagon views the continuing, large-scale missile deployment as destabilizing. The weapons can attack all of Taiwan's military bases with little or no warning, according to a recent Defense Intelligence Agency assessment.

A Chinese government-owned newspaper in Hong Kong, *Wen Wei Po*, reported earlier this week that the "large-scale" beach landing exercises centered on Dongshan Island will involve 100,000 troops, along with naval and air forces.

The last time Chinese forces conducted a similar amphibious landing exercise was November 1995,

the newspaper said.

As part of that exercise, Chinese missile forces fired several short-range missiles in provocative flight tests that hit waters near the northern and southern tips of Taiwan.

A respected nongovernment Hong Kong newspaper, *Ming Pao*, reported Tuesday that the exercise had begun with "tens of thousands" of troops from several regions near Fujian Province moving toward Dongshan Island. It said the war games would continue for two weeks.

"It is pointed out that the main aim of the exercise will be to attack and occupy Taiwan's offshore islands and counterattack U.S. military intervention," the newspaper stated.

Commercial aircraft were routed around Dongshan, and Chinese marines had taken control of the ferry between the island and mainland.

One source told the newspaper that the exercise involved electronic warfare operations, and that the Chinese military for the first time was using reconnaissance satellites and satellite navigation systems.

The exercise reportedly kicked off Monday night with an airborne assault on Dongshan.

In reaction to the 1996 missile tests, the Pentagon dispatched two aircraft carrier battle groups to waters near Taiwan in a show of force.

China reacted by building up its military capability to attack U.S. ships, including the purchase of two Russian Sovremenny-class guided-missile destroyers equipped with SSN-22 supersonic anti-ship missiles.

Until the recent missile activity, Pentagon spokesmen have downplayed a series of Chinese military exercises taking place along China's coasts.

The first exercises took place on Woody Island in the South China Sea, where China has built an airstrip for projecting its power into strategic sea lanes. Several thousand Chinese marines, accompanied by several warships, stormed ashore on the island as part of maneuvers last week.

While the Woody Island war games were under way, China's northern navy conducted a sudden dispersal exercise that is normally conducted before a military attack or for protecting ships in port from bad weather.

Then in what officials called "phase two" of regional war games, the Chinese began massing more than 200 amphibious warfare vehicles on Dongshan Island.

The official Chinese military newspaper also reported this week that a Chinese bomber division practiced low-level bombing runs May 28 as part of another exercise.

Also, *Wen Wei Po* quoted an unidentified Chinese military source as saying the Dongshan exercise will employ "advanced fighter planes, warships, missiles and electronic-warfare equipment".

The source also told the government-owned newspaper that the war games are practice for testing new tactics and for "quickly launching and winding up a war".

It also will help troops study "ways of applying new-type equipment and translating new type equipment into fighting capacity through real operations".

Some Pentagon officials believe the war games could be preparation for military action by Chinese forces against an outlying Taiwanese island, or as part of sabre-rattling designed to intimidate the Taipei government.

Sun Yuxi, a Chinese Foreign Ministry spokesman, said Tuesday in Beijing that the war games are routine and normal.

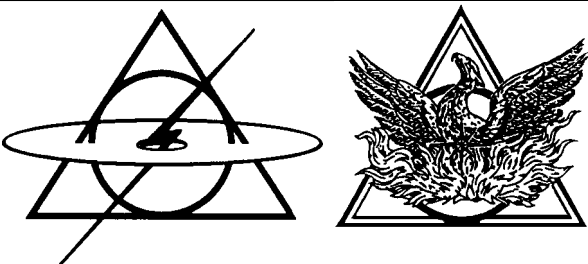
