theme with an uncountable number of people from all walks of life and have also not neglected the inner search. And from my own experiences and from personal proofs I came to the view I summarized in this last chapter. It is my personal view, and nobody has to abide by it. Please look at these statements just as critically as you will in the future look at everything. This has been done for longer than most can imagine. But even time travel does not change the inner side of a person. If someone is destructive, he will also be destructive in the time to which he travels, because he still has the same thoughts, feelings and motives as before. his machine away, he is exactly as weak as before, and when the next tight situation comes along, he will look anew for a machine, or he will finally be ready to overcome his fear and to face the problem. Now comes the part I consider most important. It is of utmost importance to know that the cosmos, but also our subconscious, is absolutely without prejudice. What is positive or beautiful to you does not have to be so for somebody else.

Without them there would be no Ferrari. Or the cleaning lady. There are women who consider themselves too good to do the cleaning themselves, so they hire a cleaning lady. Can you imagine how the world would look if there were no cleaning ladies?

The favourite food of one may be disgusting to another. A plant can be a remedy to the homeopath or the herbalist, to the hobby gardener it is but a weed that he pulls. Spiders are "terrible beasts" to some and they tread on them, but the same people are all fed up about the flies that now thrive because the spiders that would have caught some are now dead.

As you can see the terms good or bad, valuable or worthless are not justified and at best are expressions of our own subjectivity.

It is easier still to understand if we learn to think in Again when an unenlightened person examines energies. Energy is unbiased. It is up to us to make the energy positive or negative, to use it constructively or destructively. This means that whatever we wish for we are entitled to and we will get. Creation has bestowed upon us the free will so we can experience life in its entirety. Life does not tell us that we may experience only what is *pleasant* and *beautiful*. It is up to us what we want to experience. But whether we still want what we wished for once we get it is another matter. At least we had the free choice. The energy created by this thought is a command to the subconscious and the cosmos, and it will be complied with 100%. The cosmos can perhaps be likened to a large computer with its perfect laws that you can program with your thoughts (INPUT), and the computer (COSMOS) will print out the result (OUTPUT). Your subconscious does not know fear, it does not distinguish between positive and negative. It receives energy, a command, and works accordingly. You will get what you were afraid of. #### SECOND LAW

THE LAW OF ANALOGY (AS ABOVE, SO BELOW)

Hermes Trismegistos (Thrice Greatest Hermes) is the Greek name for the Egyptian god Thoth who wrote the "Hermetic literature" concerning e.g. a Gnostic cosmogony and the redemption of humanity, and he was thought to be the greatest magician who could render treasures and vessels impenetrable (hermetically sealed). He taught the hermetic law: "As above, so below." In the macrocosm the same laws apply as in the microcosm.

As example: The smallest known building block of matter is the atom. The atom consists mainly of protons, neutrons and electrons. Protons and neutrons form the nucleus of the atom, the immensely fast oscillation of the electrons create the shell. The whole is kept together by electromagnetic force.

The difference between the atoms is determined by the number of protons and electrons. There are 92 natural elements, each existing only because it has a differing number of protons and electrons. If we enlarge the nucleus of a hydrogen atom to the size of a marble, its single electron would be about 400 metres away. This shows that an atom is mainly empty space and matter actually quite tenuous.

Seen this way, a block of lead is mainly space surrounded by atomic particles. The distances between the solid particles correspond to the distances between the planets in our solar system. The distances between the planets correspond to the steps of the musical scale.

A photograph of the atomic nucleus (1 picometre) corresponds to a photograph of Earth from a distance of one million kilometres and to one of the galaxy from a distance of 10,000,000 light-years.

The rotating human magnetic field looks exactly like our rotating galaxy (GEO-Wissen No. 2, 1990, Chaos and Kreativitat, shows beautiful pictures of the examples just given).

As you see, everything is created according to a perfect system which perhaps is not recognizable at first glance, but on closer inspection becomes obvious. Life itself—as macrocosm and microcosm—is subject to perfect laws.

system, in the blood cells, in electricity and in magnetism. Since matter is held together and determined by electromagnetic forces and we humans consist also law of attraction and repulsion for instance.

Thorwald Dethlefsen writes in *The Challenge of Fate*: "The analogy 'as above so below' is applicable only if we are willing to recognize this universe in its entirety as a cosmos (Greek: kosmos = order). A cosmos, however, is governed by laws and there is no room for chance occurrences.

"Chance occurrence, being something unaccountable and random, would transform every cosmos into chaos (Greek: Khaos = disorder). When we build a computer it represents in itself a small cosmos: it is built according to laws and its functioning is dependent on the observance of such laws. If we solder into its circuit a few transistors, condensers and resistors which are not in accordance with the laws governing the circuit design, then these built-in random elements will transform its entire cosmos into chaos and the computer will stop working properly. The same applies to our world. With the very first random event our world would cease to exist.

"...If you drop a stone from a certain height it does not fall at random but in accordance with law. If the

stone hits Mr. X on the head, Mr. X has not been hit at random by a stone, but also in accordance with law. Neither the fact that a stone falls on Mr. X's head nor is no good or bad here. Both candidates have received the time when this happens is accidental..."

Have you not noticed that never did a star "accidentally" fall from its orbit, did a blood cell swim against the current, did a summer plant bloom in winter? Perhaps you know of an electron that "accidentally" during its obit around the core darted sideways? All matter consists of the 92 elements which in turn all consist of neutrons, protons and electrons and their absolutely perfect and rhythmic movements. Since all life in us and around us is subject to a great, regular rhythm, why then should man alone be subject to "accidents"?

...There is no accident! Behind every event there is a law in operation. We may not always recognize the existence. Stones fell even in the days when people had not yet discovered the law of gravity.

...Man is a faithful reflection of the macrocosmic universe... Therefore above the temple of Delphi it is written: "Know thyself in order to know God."

#### THE THIRD LAW

THE LAW OF RESONANCE

(LATIN: RESONARE = RESOUND)

Man is subject to the law of resonance just as is the tuning fork or a radio receiver. A receiver set to FM cannot receive AM or long wave transmissions. The same goes for human beings. If a person is aggressive and full of hatred, he or she is not responsive to love. Everyone can only receive those parts of reality with which he or she is resonating. The adage: "He sees only what he wants to see" is based on this.

An example: You read a book. Five years later you reread it and you will gather completely different things from it, although it is still the same book. Why? Because you have become another person. Your horizon has changed or your viewpoint. You see things differently now.

People tend to be with like people. Like We can find these laws everywhere, in our solar attracts like, and you will notice that, if some time you are in a bad mood or angered, your surroundings will give you reason for anger.

Take a person who is constantly moaning about of matter, we, too, are subjected to these laws, to the everything. He will 100% always find something to go on about. In contrast someone who enjoys life and finds other people interesting and beautiful—life has no other option than to show this person nice people.

> Another example: There is this man who criticizes everyone: "He is just an idiot, and this one is a failure and anyway, everything just makes me sick." Most things to him appear negative and he shows this clearly with his evil eye and the dropping corners of his mouth. You cannot believe that anyone will have anything nice to say about him. It is no pleasure to be with him, and the friendly and sensitive people will soon withdraw. Still he will find people of a like mind and from them get confirmation for his experiences.

#### Like attracts like.

A person however, who is always helpful, always good for a joke and spreads a good atmosphere smile and shares what he or she has. This person, I can be sure, will be surrounded by many happy, pleasant and also funny people. This person will always be invited as he or she is used to share.

You see, this sentence is absolutely unbiased. There as they had given. #### "Your environment is a mirror of yourself."

Our environment will always represent what we communicate. If I lie, I will be lied to. Am I fearful, I will be confronted by my fears. Am I a bully, I will constantly be involved in brawls. If I am resonating love, I will attract love. If I live in happiness, I will always find something that gives me joy, if I change my viewpoint, my surroundings will mirror it.

Be aware of the fact that if you daily see horror and violence on TV (in films, or on the news), your life will be strongly affected. Over millennia people have let loose immeasurable amounts of energy by their destructive actions, thinking and all the murdering, energies that we not only feed with negative thoughts and suggestions (and violent movies are part of this) but that we also attract. It is not just the large-scale political events, but all the small unkindnesses of daily life that make up the total. If I am dealing with destructive reading, writing, thinking, acting, speaking, I am attracting destructiveness. If I live the opposite, destructiveness has no meaning for me and I will therefore not attract it. Here, too, the law of resonance is acting perfectly. This was what Umberto Eco meant in the paragraph I quoted in the introduction. If I think of Satan, I am in contact with that energy, it has meaning for me and I will get confirmation of my belief system. If I don't grant it significance, if I laugh at it, it has no effect on me. That energy field cannot move towards me of its own free will. It only obeys the law of resonance.

This assigning of guilt no longer functions, however, with the spiritual-cosmic laws we have looked at. According to those laws everything as it is today is so as a consequence of the causes we ourselves had set. It does not matter whether it is an inner or an outer state, an illness, an accident or the situation upon this Earth with its inhabitants. We caused it and therefore are responsible. Some will say no: "What have I got to do with it, I've only been here for thirty years?"

Another question that might have arisen: "When I was a child something happened to me, but I can't remember the cause, perhaps child molestation or rape. How did I earn that?"

have earned it means that in your fate you get a just reward for the work you have done. You have worked for that stroke of fate, i.e. at some time you have set the cause for it, but you don't remember it. It is possible that the cause was set in early childhood, in the prenatal phase or in one of your previous lives. The fact that you can't remember does not mean that you did not have any pre-incarnations (former lives). The Earth was round before we could prove it. #### THE FOURTH LAW

#### THE LAW OF REINCARNATION

The Church Christians among you will say that reincarnation is not taught in the Church teachings. That is correct, the teaching of reincarnation is no longer in the Bible TODAY, and I will tell you why!

In the year of the Lord 553 the Roman emperor Justinian I. called for the second council of Constantinople to convene (please note that it was not called by Church people) where an edict was passed that dismissed the teaching of former lives, or reincarnation, despite the fact that Jesus attached great importance to the soul body leaves the physical body. In the so-called it. Due to this decree all references to a pre-existence with the exception of some obscure passages disappeared from the Bible. Thus the early Christians were robbed of one of the most important pillars of their religion. To make up for it, the clergy taught that they would experience their resurrection only on "Doomsday" in the flesh. What a swap!

I would like to ask the biblically inclined Christians among you to take the trouble and check for yourselves the truth of the above statements about the council of Constantinople. And while you're at it, check into the council of Nicaea 375 AD, too. I hope you can stand the truth, for you will find proof that the New Testament in its formation and compared to the original teachings of Jesus has been drastically changed.

Let's look at reincarnation in more detail. We have stated at the outset of this list of the laws that we live in matter in which all is subject to the law of polarity and that the constant change between two poles creates rhythm and oscillation, the basis for all living matter. The sages of old always knew that nothing ever rests, that all is in movement, in vibration. Modern physics

where the swing to the right determines the swing to the left. This rhythm we find everywhere there is life, e.g. the breathing in and out or the waking and sleeping rhythm. Just as breathing in is 100% surely followed by breathing out, waking follows sleeping. We now know the laws "as above so below", "as within so without", "you reap what you sow". In the same way winter is followed by summer and sunset by sunrise. And just as there is positive and negative (electricity and magnetism), man and woman, life is followed by death and death in turn is followed by life. You see, this rhythm is allpervading, only in the belief systems of certain religions and of those trusting science above all, life itself should not be subject to these laws. You see the contradiction?

Thorwald Dethlefsen puts it this way:

"This rhythmic movement of the soul between life In the question is already part of the answer: You and death has, since time immemorial, been called transmigration of souls or reincarnation (literally a 're-entry into flesh'). Plato knew about it just as Goethe did. I deliberately say 'knew' and not 'believed', for reincarnation is not a matter of belief but rather a matter of philosophical insight. Everyone is free to believe something other than reincarnation, but it should be borne in mind that any hypothesis without reincarnation has the stamp of absurdity, since only reincarnation is in harmony with all universal laws." (The Challenge of Fate)

> An astonishing number of people remember former lives or at least parts thereof. Perhaps you are one of them, or you experienced coming to a place where you had never been, but you recognized it and knew that just around that corner is a little shop. If you have ever experienced something along those lines then you have had a personal realization, i.e. you "know" what you've experienced and don't have to "believe" anymore.

> Just as we have to separate life in matter into two polarities, life itself separates into "here-and-now" and the "beyond". When we die in this life, we are born in the beyond and experience the beyond as reality. When we die in the beyond, we are born again here. Once you manage to separate a bit from the subjectivity of appearances, you recognize that birth and death, or the "here-and-now" and the "beyond", are but two sides of the same coin.

> The same with sleep, "death's little brother", where dream we experience a totally different reality, where again there are people who can remember every detail of their dreams, while others pretend that they don't dream at all. These latter just don't remember, but they dreamed, too, as can be easily proved today by technical means. And just as we are happy to wake up, we are happy to go to bed and to sleep, for we know that after the sleep we will be rested and refreshed. Neither sleeping nor being awake can be termed positive or negative, they are both unbiased.

> Applying this again to death, we find that we don't have to fear death, since what happens is like sleeping, only the intervals are longer and not so easily discernible. Thus death becomes the peak of life, after which we can rest and recuperate to embark upon another "adventure of bodily existence".

> If you have no recollection of earlier lives, perhaps you can ask somebody who you know had a "near-death experience" and let them tell you how they view death now. You will see that more than 90% of them have had positive (pleasant) experiences that took away their fear

of death, for they have personal cognition, they know.

The spiritual evolution of man then is a long process of learning and development for which we use several, innumerable bodies. The true self of an individual is not the physical body, but the so-called soul, also known as the energy body or the body of light. This part, our self, has the memory of all experiences and is immortal. The energy body (the aura) is what the clairvoyants see and from where they draw information.

The evolutionary path of the human soul is the path of learning. The objective of this learning process is the experience of life in its entirely, and it is a long path strewn with errors and correlations. These incarnations can be likened to classes in a school. Life on Earth corresponds to classes, with exercises, problems, tests, difficulties and success. The difference between school and life is though that life has infinite patience with us and allows and gives us—or our souls—ever new possibilities yet to understand what we have not yet learnt.

Back then to the questions ready to be answered. Somebody was raped or perhaps was born handicapped. Why did this happen?

Dethlefsen explains:

"To live means to learn, regardless of whether the individual accepts this or not. Fate, with undeviating justice, ensures that each individual learns the very thing that he least willingly accepts and against which he has the greatest resistance.

Fate as a totality only makes sense against the background of reincarnation. If one looks at a life in isolation it is easy to doubt that there is any coherent sense behind fate—and this often causes despair. It is evident that in this life not all men start with equal advantages, and that is certainly not the fault of society! Whether one is arguing from a religious or from an atheistic standpoint, it is difficult, without reincarnation, to explain to someone why he of all people should have been born dumb, lame, disfigured or mentally handicapped into this 'best of all possible worlds'. Even pointing to the unfathomable decisions of God does not help much in such cases to impart any sense of meaning.

"Yet without meaning life would be unbearable for pain, grief, fear, happiness etc. are also extant. And human beings. The search for the meaning of life is a fundamental need. Only when we are prepared to let go of the notion that each life is an isolated event and to recognize it as a link in a long chain—only then will we learn to comprehend the sense and justice of fate. For a life's destiny is the result of the learnt and unlearnt lessons of the past." (The Challenge of Fate)

#### **FIFTH LAW**

#### THE LAW OF SIMILARITIES

To make all this easier to understand, let us introduce two new terms: karma and dharma. The law of karma (Sanskrit: the created, the deed) is the law of balance which ensures that man is confronted with the same problem until he has solved it. Thus any thought, any emotion and any deed becomes immortal and returns to us like a boomerang. It demands of man full responsibility for his fate. Again it is obvious that most people today refuse this. The rejection of the teaching

of reincarnation is understandable, since the Illuminati among others—have with a lot of time and energy life offers. Thus it is absolutely futile to judge fabricated and disseminated, with the help of science, the western religions and the universities, perfect sounding theories relieving man from personal responsibility and projecting the blame onto society, germs, satanic influences or evil chance.

Because of the karmic law of similarities the same problem will be present itself again. If in one life you have raped someone, you will be also raped in the same or a future life, or you will karma, what you created. Adolf Hitler, Joseph Stalin, Genghis Khan, they all have to relieve their karma, as any other human being on this planet.

The Buddhists call those constructive and rather pleasant experiences which you have accrued in your many previous lives and which balance your karma that you brought along to lead a successful life, in it is always a little bit larger than your karma, so that karmic experiences may be erased. Suicide is always escaping the task we have set ourselves before we entered this life. This task will therefore be presented again in a new incarnation. There is no remission. We are only burdened with what we caused ourselves, nothing more and nothing less. Jesus said: "...to the last farthing..."

To a person who can see the aura of another, or to so-called clairvoyants (they see the bright body of light that glows around the physical body), karma and dharma are discernible. A clairvoyant does not necessarily see the future of a person; he or she sees what that person has caused so far and can foretell the resulting consequences. And these will surely follow if those thus examined don't change something in their lives. Fate can be changed. Absolutely. Fate means that what you have sent out will fall back onto you. (The German word for accident, chance is "Zufall", Zu-fall means "falling towards you".) The clairvoyant only sees what we have caused or sent out until that point in time when the clairvoyant perceives it. If the person makes a life-changing decision towards constructiveness and love the next day, the ratio between karma and dharma will have changed. From what we send out our fate is formed.

An example: In a former life a man had worked at a concentration camp and following his then ideology had killed many handicapped persons. This deed now forms his karma that one time will catch him up and will have to be cleared. Now the soul of this man is in a new body, in another country, in another time, and one day he goes to see a clairvoyant. She recognizes what he had done in his previous life and tells him that he will face a difficult fate, since she sees what he had caused and that perhaps he will end up in a wheelchair. If he continues to live as before this would surely come to pass. He now consciously decides to clear off what he caused and will perhaps take a job in a home for the handicapped in order to help himself as well as those in his care by a future life of gentleness and selfless love. Or he consciously begins to change his way of thinking and acting at the roots. Thus he can change his own fate by making new decisions.

According to the law of reincarnation one is reborn in many different bodies, always perfectly fitted to deal best with the tests of this particular life. Once as a black person, once as a Jew, once as Christian, as a Satanist, as a rich person, as a pauper, as woman, as man, as homosexual, as murderer, as

victim etc., to be able to make all those experiences someone because of his colour, his creed or his fate, or will one day be allowed to do so.

[H: No, please, this is not my perception nor my input. This is the opinion offered by AN AUTHOR who concludes these options. I disagree here more strongly than in any portion of this book yet offered. He is giving you "possibilities"—YOU CAN AND SHALL BE THAT WHICH YOU CHOOSE TO BE experience to build upon. But most people do not experience something equivalent, to relieve your AND EXPERIENCE. I certainly do not, however, disagree in any way whatsoever that you certainly shall reap that which you sow and what you send out SHALL COME BACK-UNLESS YOU MAKE RESTITUTION. THAT DOES NOT SAY "FORGIVENESS"—IT SAYS "RESTITUTION" IN SINCERE EFFORT AND confirmation for your present belief system, then I dharma. It consists of your abilities and your talents WITHIN TRUTH—NOT JUST ANOTHER GAME TO FURTHER DEEPEN YOUR PROBLEMS.]

> You can see that according to the teaching of reincarnation any kind of judgement, hatred and war is absolutely stupid since it will all fall back on us. If in one life I had been a slave-trader, I will some time be allowed to be a slave, to understand how the slaves felt before under my whip. The law of reincarnation is absolutely fair and is the only absolutely logical and just principle. If you kick a ball against a wall, it bounces back according to the power of your kick. A boomerang returns as fast as you threw it. If I shout loudly, the echo will be loud, too. Is my voice soft, then the echo is also soft. If I am a brute, life will be brutal for me. Have I lived a life as a miser, sitting on my wealth and living off others, I probably will have nothing in the next life. If in this life I have pinched the wives of many a man and thus cheated on my wife, I will probably not find love in a future life, and if I do find a partner, I will probably lose her, or him. Thus I am given the chance of reliving the pain and sorrow I caused others in the same intensity.

[H: Oh, dear ones, stop pushing off the inevitable to some conjured last or next experience. You are IN YOUR REALITY OR DREAM "NOW". People who present evil—live in evil—NOW! What they call happiness is not joy, it may well be power or justification or whatever they choose—but it is possibilities and the conclusions are erroneous in lies told to oneself. When you project evil and hate, you already experience the reward (return) of that standard of behavior. Souls must grow and they must learn wisdom—no more or less. Punishment is not the object, for learning is always the goal and to assume (for that is all that is offered to the physical being) that the projections are true for every reader or experiencer is, indeed, foolish. What may "seem" correct to this writer is NOT **NECESSARILY SO in FACT.**]

This law of similarities can be found in Nature everywhere, in physics and chemistry, all around us, and in our bodies, too. If I ingest many and strong poisons (cigarettes, drugs, alcohol) this will probably start a strong reaction. And nobody is to blame than the one ingesting. Have you ever had a drastic personal experience, like an apparition (perhaps when you were still a child), like origins, since we all have already experienced that hearing voices, dreaming about the future or about your own past, a near-death experience, astral travel, deja vus, clairvoyance, premonitions, telepathy, spontaneous healing, or did you as a child see nature spirits, did you know before that something was going to happen (all without drugs or other aids, of course)?

> If so, you have a valid reason and personal have personal experiences, they also have never invested any energy in finding out whether what they believe is true and whether they can actually support it.

#### INDUSTRIAL DIAGRAMS

An ideal industry is defined as a device which receives value from other industries in several forms and converts it into one specific product for sales and production, distribution, consumption, and investment. distribution to other industries. It has several inputs and one output. What the public normally thinks of as one industry is really an industrial complex where several industries under one roof produce one or more products.

The flow of product from industry #1 (supply) to industry #2 (demand) is denoted by 112. The total flow out of industry 'K' is denoted by 1 k (sales, etc.).

A node is a symbol of collection and distribution of flow. Node #3 receives from industry #3 and distributes to industries #1 through #3. If industry #3 manufactures chairs, then a flow from Industry #3 back to industry #3 simply indicates that industry #3 is using part of its own output product, for example, as office furniture. Therefore, the flow may be summarized by the equations:

#### THREE INDUSTRIAL CLASSES

Industries fell into three categories or class by type of output.

Class #1—Capital (resources)

Class #3—Services (action of population)

Class #1 Industries exist at three levels

- (1) Nature—sources of energy and raw materials.
- (2) Government—printing of currency equal to gross national product (GNP), and extension of currency in excess of GNP.
- (3) Banking—loaning of money for interest, and extension (counterfeiting) of economic value through deposit loan account—inflation.

Class #2 industries exist as producers of tangible or consumer (dissipated) products. This sort of activity is usually recognized and labeled by the public as an 'industry'.

Class #3 industries are those which have service rather than a tangible product as their output. These industries are called (1) capital, (2) goods, and (3) services. The problem with this representation is that it would not show the influence of, say, the textile industry on the ferrous metal industry. This is because both the textile industry and the ferrous metal industry would be contained within a single classification called the 'goods industry' and by this process of combining or aggregating these two industries under one system block, they would lose their economic individuality.

#### **AGGREGATION**

The whole economic system can be represented by a three-industry model if one allows the names of the outputs to be (1) capital, (2) goods, and (3) services. The problem with this representation is that it would not show the

influence of, say, the textile industry on the ferrous metal industry. This is because both the textile industry and the ferrous metal industry would be contained within a single classification called the 'goods industry' and by this process of combining or aggregating these two industries under one system block, they would lose their economic individuality.

#### THE E-MODEL

A national economy consists of simultaneous flows of If all of these elements including labor and human functions are assigned a numerical value in like units of measure, say, 1939 dollars, this flow can be further represented by a current flow in an electronic circuit, and its behavior can be predicted and manipulated with useful precision.

The three ideal passive energy components of electronics, the capacitor, the resistor, and the inductor correspond to the three ideal passive energy components of economics called the pure industries of capital, goods, and services.

Economic capacitance represents the shortage capital in one form or another.

Economic conductance represents the level of conductance of materials for the production of goods.

Economic inductance represents the inertia of economic value in motion. This is a population phenomenon known as services.

#### ECONOMIC INDUCTANCE

An electrical inductor (e.g., a coil of wire) has an Class #2—Goods (commodities or use—dissipative) electric current as its primary phenomenon and a magnetic field as its secondary phenomenon (inertia). Corresponding to this, an economic inductor has a flow of economic value as its primary phenomenon and a population field as its secondary phenomenon of inertia. When the flow of economic value (e.g., money) diminishes, the human population field collapses in order to keep the economic value (money) flowing (extreme case—war).

buying habits, expected standard of living, etc., and is generally a phenomenon of self-preservation.

#### INDUCTIVE FACTORS TO CONSIDER

- (1) Population
- (2) Magnitude of the economic activities of government.
- (3) The method of financing these government activities (see Peter-Paul Principle—inflation of the currency).

#### **TRANSLATION** (A few examples will be given.)

CHARGE—coulombs—dollars (1939).

FLOW/CURRENT—amperes (coulombs per second)—dollars of flow per year.

MOTIVATING FORCE—volts—dollars (output) demand. CONDUCTANCE—amperes per volt—dollars of flow per year per dollar demand.

CAPACITANCE—coulombs per volt.—dollars of production inventory/stock per dollar demand.

#### TIME-FLOW RELATIONSHIPS AND SELF-DESTRUCTIVE OSCILLATIONS

An ideal industry may be symbolized electronically in various ways. The simplest way is to represent a demand by a voltage and supply by a current. When this is done, the relationship between the two becomes what is called an admittance, which can result from three economic factors: (1) hindsight flow, (2) present flow, and (3) foresight flow. [H: This describes the flow of LIFE pretty well, doesn't When you have learned that the same principle applies to ALL facets of expression, you have moved a long way toward graduation.]

Foresight flow is the result of that property of living entities to cause energy (food) to be stored for a period of low energy (e.g., a winter season). It consists of demands made upon an economic system for that period of low energy (winter season). In a productive industry it takes several forms, one of which is known as production stock or inventory. In electronic symbology this specific industry demand (a pure capital industry) is represented by capacitance and the stock or resource is represented by a stored charge. Satisfaction of an industry demand suffers a lag because of the loading effect of inventory priorities.

Present flow ideally involves no delays. It is, so to speak, input today for output today, a 'hand to mouth' flow. In electronic symbology, this specific industry demand (a pure use industry) is represented by a conductance which is then a simple economic value (a dissipative element).

Hindsight flow is known as habit or inertia. In electronics, this phenomenon is the characteristic of an inductor (economic analog = a pure service industry) in which a current flow (economic analog = flow of money) creates a magnetic field (economic analog = active human population) which, if the current (money flow) begins to diminish, collapses (war) to maintain the current (flow of money-energy).

Other large alternatives to war as economic inductors or economic flywheels are an open-ended social welfare program, or enormous (but fruitful) open-ended space program.

The problem with stabilizing the economic system is that there is too much demand on account of (1) too much greed and (2) too much population.

This creates excessive economic inductance which The public inertia is a result of consumer can only be balanced with economic capacitance (true resources or value - e.g. in goods or services). The social welfare program is nothing more than an openended credit balance system which creates a false capital industry to give non-productive people a roof over their heads and food in their stomachs. This can be useful, however, because the recipients become state property, in return for the 'gift', a standing array for the elite. For he who pays the piper, picks the tune. Those who get hooked on the economic drug must go to the elite for a fix. In this, the method of introducing large amounts of stabilizing capacitance is by borrowing on the future 'credit' of the world. This a fourth law of motion—onset, and consists of performing an action and leaving the system before the reflected reaction returns to the point of action—a delayed reaction. The means of surviving the reaction is by changing the system before the reaction can return. By this means, politicians become popular in their own time and the public pays for it later. In fact the measure of such a politician is the delay time. The same thing is achieved by a government by printing money beyond the limit of the

gross national product, an economic process called hands of the public and maintains a balance against not easily predictable and the technical coefficients of their greed, creates a false self-confidence in them and, for a while, stays the wolf from the door.

They must eventually resort to war to balance the account, because war ultimately is merely the act to keep the responsibility and blood off the public conscience. (See section on consent factors and social-economic structuring.)

If the people really cared about their fellow man, they would control their appetites (greed, procreation, etc.) so that they would not have to operate on a credit or welfare social system which steals from the worker to satisfy the bum.

Since most of the general public will not exercise restraint, there are only two alternatives to reduce the economic inductance of the system.

- (1) Let the populace bludgeon each other to death in war, which will only result in a total destruction of the living Earth.
- (2) Take control of the world by the use of economic 'silent weapons' in a form of 'quiet warfare', and reduce the economic inductance of the world to a safe level by a process of benevolent slavery and genocide.

The latter option has been taken as the obviously better option. At this point it should be crystal clear to the reader why absolute secrecy about the silent weapons is necessary. The general public refuses to improve its own mentality and its faith in its fellow man. It has become a herd of proliferating barbarians, and, so-tospeak, a blight upon the face of the Earth. They do not care enough about economic science to learn why they have not been able to avoid war despite religious morality, and their religious or self-gratifying refusal to deal with earthly problems renders the solution of the earthly problem unreachable by them. It is left to those few who are truly willing to think and survive as the fittest to survive, to solve the problem for themselves as the few who really care. Otherwise, exposure of the silent weapon would destroy our only hope of preserving the seed of future true humanity.

#### THE HOUSEHOLD INDUSTRY

The industries of finance (banking), manufacturing, and government, real counterparts of the pure industries of capital, goods, and services, are easily defined because they are generally logically structured. Because of this their processes can be described mathematically and their technical coefficients can be easily deduced. This, however, is not the case with the service industry known as the household industry.

#### HOUSEHOLD MODELS

When the industry flow diagram is represented by a 2-block system of households on the right and all other industries on the left, the following results.

The arrows from left to right labeled A, B, C, etc., denote flow of economic value from the industries on the left to the industry on the right called 'households'. These may be thought of as the monthly consumer flows of the following commodities. A—alcoholic beverages, B-beef, C-coffee,... U-unknown, etc.

any one household tend to be a non-linear, very complex, and variable function of income, prices, etc.

Computer information derived from the use of the Universal Product Code (UPC) in conjunction with credit card purchase as an individual household identifier could change this state of affairs. But the UPC method is not yet available on a national or even a significant regional scale. To compensate for this data deficiency, an alternate indirect approach of analysis has been adopted known as economic shock testing. This method, widely used in the aircraft manufacturing industry develops an aggregate statistical sort of data.

Applied to economics, this means that all of the households in one region or in the whole nation are studied as a group or class rather than individually, and the mass behavior rather than individual behavior is used to discover useful estimates of the technical coefficients governing the economic structure of the hypothetical single-household industry.

Notice in the industry flow diagram that the values for the flows A,B,C, etc., are accessible to measurement in terms of selling prices and total sales of commodities.

One method of evaluating the technical coefficients of the household industry depends upon shocking the prices of a commodity and noting the changes in the sales of all of the commodities.

In the shock testing of an aircraft airframe, the recoil impulse of firing a gun mounted on that airframe causes shock waves in that structure which tell aviation engineers the conditions under which parts of the airplane or the whole airplane or its wings will start to vibrate or flutter like a guitar string, a flute reed, or a tuning fork, and disintegrate or fall apart in flight.

studying the behavior of the economy and the probability that a person would experience a headache, consumer public by carefully selecting a staple commodity such as beef, coffee, gasoline, or sugar and then causing a sudden change or shock in its price or availability, thus kicking everybody's budget and buying habits out of shape.

They then observe the shock waves which result by monitoring the changes in advertising, prices, and sales of that and other commodities.

The objective of such studies is to acquire knowhow to set the public economy into a predictable state of motion or change, even a controlled selfdestructive state of motion, which will convince the public that certain "expert" people should take control of the money system and reestablish security (rather than liberty and justice) for all. When the subject citizens are rendered unable to control their financial affairs, they of course, become totally enslaved, a source of cheap labor. [H: READ IT AGAIN!]

Not only the prices of commodities, but also the availability of labor can be used as the means of shock testing. Labor strikes deliver excellent test shocks to an economy, especially in the critical service areas of trucking (transportation), communication, public utilities (energy, water, garbage, collection), etc.

By shock testing, it is found that there is a direct relationship between the availability of money flowing in an economy and the psychological outlook and response of masses of people dependent upon that availability.

For example, there is measurable, quantitative Economic engineers achieve the same result in relationship between the price of gasoline and the feel a need to watch a violent movie, smoke a cigarette, or go to a tavern for a mug of beer.

> It is most interesting that, by observing and measuring the economic modes by which the public tries to run from their problems and escape from reality, and by applying the mathematical theory of Operations Research, it is possible to program computers to **predict** the most probable combination of created events (shocks) which will bring about a complete control and subjugation of the public through a subversion of the public economy (by shaking the plum tree).

#### INTRODUCTION TO THE THEORY OF ECONOMIC SHOCK TESTING

Let the prices and total sales of commodities be given and symbolized as follows.

Let us assume a simple economic model in which the total number of important (staple) commodities are represented as beef, gasoline, and an aggregate of all other staple commodities which we will call the hypothetical miscellaneous staple commodity 'M' (e.g., M is an aggregate of C,S,T,U, etc.).

#### INTRODUCTION TO ECONOMIC AMPLIFIERS

Economic amplifiers are the active components of economic engineering. The basic characteristic of any amplifier, (mechanical, electrical, or economic) is that it receives an input control signal and delivers energy from an independent energy source to a specified output terminal in a predictable relationship to that input control signal.

The simplest form of economic amplifier is a device called advertising.

If a person is spoken to by a TV advertiser as if he were a twelve year old, then, due to suggestibility, he will, with a certain probability, respond or react to that suggestion with the uncritical response of a twelve year old and will reach into his economic reservoir and deliver its energy to buy that product on impulse when he passes it in the store.

5. political suggestibility, he will, with a certain probability, respond or react to that suggestion with the uncritical response of a twelve year old and will reach into his economic preferences:

An economic amplifier may have several inputs and outputs. Its response might be instantaneous or delayed. Its circuit symbol might be a rotary switch if its options are exclusive, qualitative, 'go' or 'no go', or it might have its parametric input/output relationships specified by a matrix with internal energy sources represented.

Whatever its form might be, its purpose is to govern the flow of energy from a source to an output sink in direct relationship to an input control signal. For this reason, it is called an active circuit element or component.

Economic Amplifiers fall into classes called strategies, and in comparison with electronic amplifiers, the specific internal functions of an economic amplifier are called logistical instead of electrical.

Therefore, economic amplifiers not only deliver power gain, but also, in effect, are used to cause changes in the economic circuitry.

In the design of an economic amplifier we must have some idea of at least five functions, which are:

- (1) the available input signals,
- (2) the desired output control objectives,
- (3) the strategic objective,
- (4) the available economic power sources,
- (5) the logistical options.

The process of defining and evaluating these factors and incorporating the economic amplifier into an economic system has been popularly called game theory.

The design of an economic amplifier begins with a specification of the power level of the output, which can range from personal to national. The second condition is accuracy of response, i.e., how accurately the output action is a function of the input commands. High gain combined with strong feedback helps to deliver the required precision. Most of the error will be in the input data signal.

Personal input data tends to be specific, while national input data tends to be statistical.

#### DIVERSION, THE PRIMARY STRATEGY

#### [H: PAY CLOSE ATTENTION BECAUSE HERE COMES THE M.O.]

Experience has proven that the simplest method of securing a silent weapon and gaining control of the public is to keep the public undisciplined and ignorant of basic systems principles on the one hand, while keeping them confused, disorganized, and distracted with matters of no real importance on the other hand.

This is achieved by:

- (1) Disengaging their minds, sabotaging their mental activities, by providing a low-quality program of public education in mathematics, logic, systems design, and economics, and by discouraging technical creativity.
- (2) Engaging their emotions, increasing their self-indulgence and their indulgence in emotional and physical activities, by:
- (a) unrelenting emotional affrontations and attacks (mental and emotional rape) by way of a improve, the lower-class elements of the social labor constant barrage of sex, violence, and wars in the media—especially the TV and the newspapers.
- (b) giving them what they desire—in excess—"junk food for thought' and depriving them of what the really need.
- (3) Rewriting history and law and subjecting the public to the deviant creation, thus being able to shift their thinking from personal needs to highly fabricated outside priorities.

These preclude their interest in and discovery of the silent weapons of social automation technology.

The general rule is that there is profit in confusion; the more confusion, the more profit. Therefore, the best approach is to create problems—and then offer the solutions.

#### **DIVERSION SUMMARY**

#### CONSENT, THE PRIMARY VICTORY

A silent weapon system operates upon data obtained from a docile public by legal (but not always lawful) force. Much information is made available to silent weapon systems programmers through the Internal Revenue Service. (See "Studies in the Structure of the American Economy" for an IRS source list.) This information begins, at the time of the birth of the individual.

Furthermore, the number of such its every effort is directed toward building, forms submitted to the IRS is a useful indicator of public consent, an important factor in strategic decision making. Consent Coefficients: numerical feedback indicating victory status. Psychological basis;

When the government is able to collect tax and seize private property without just compensation, it is an indication that the public is ripe for surrender and is consenting to enslavement and legal encroachment. A good and easily quantified indicator of harvest time is the number of public citizens who pay income tax.

#### AMPLIFICATION ENERGY SOURCES

The next step in the process of designing an economic amplifier is discovering the energy sources. The energy sources which support any primitive economic system are, of course, a supply of raw materials, and the consent of the people to labor and consequently assume a certain rank, position, level, or class in the social structure; i.e., to provide labor at various levels in the pecking order.

Each class, in guaranteeing its own level of income, controls the class immediately below it, hence preserves the class structure. This provides stability and security, but also government from the top.

As time goes on and communications and education structure become knowledgeable and envious of the good things that the upper-class members have. They also being to attain a knowledge of energy systems and the ability to enforce their rise through the class structure.

This threatens the sovereignty of the elite.

If this rise of the lower classes can be postponed long enough, the elite can achieve energy dominance, and labor by consent no longer will hold a position of an essential economic energy source.

Until such energy dominance is absolutely established, the consent of people to labor and let others handle their affairs must be taken into consideration, since failure to do so could cause the people to interfere in the final transfer of energy sources to the control of the elite.

It is essential to recognize that, at this time, public MEDIA: Keep the adult public attention diverted consent is still an essential key to the release of energy to the process of economic amplification.

#### **LOGISTICS**

The successful application of a strategy requires a careful study of inputs, outputs, the strategy connecting the inputs and the outputs, and the available energy sources to fuel the strategy. This study is called logistics.

A logistical problem is studied at the elementary level first, and then levels of greater complexity are studied as a synthesis of elementary factors.

This means that a given system is analyzed, i.e., broken down into its sub-systems, and these in turn are analyzed, until, by this process, one arrives at the logistical 'atom', the individual.

This is where the process of syntheses properly

#### THE ARTIFICIAL WOMB

From the time a person leaves its mother's womb, maintaining, and withdrawing into artificial wombs, various sorts of substitute protective devices or shells.

The objective of these artificial wombs is to provide a stable environment for both stable and unstable activity; to provide a shelter for the evolutionary processes of growth, and maturity—i.e., survival; to provide security for freedom and to provide defensive protection for offensive activity.

#### THE POLITICAL STRUCTURE OF A NATION—DEPENDENCY

The primary reason why the individual citizens of a country create a political structure is a subconscious wish or desire to perpetuate their own dependency relationship of childhood.

Simply put, they want a human god to eliminate all risk from their life, pat them on the head, kiss their bruises, put a chicken on every dinner table, clothe their bodies, tuck them into bed at night, and tell them that everything will be alright when they wake up in the morning.

This public demand is incredible, so the human god, the political, meets incredibility with incredibility by promising the world and delivering nothing. So who is the bigger liar?, the public?, or the 'godfather'?

This public behavior is surrender born of fear, laziness and expediency. It is the basis of the welfare state as a strategic weapon, useful against a disgusting public.

#### ACTION/OFFENSE

Most people want to be able to subdue and/or kill other human beings which disturb their daily lives, but they do not want to have to cope with the moral and religious issues which such an overt act on their part might raise. Therefore, they assign the dirty work to others (including their own children) so as to keep the blood off their own hands. They rave about the humane treatment of animals and then sit down to a delicious hamburger from a whitewashed slaughterhouse down the street and out of sight. But even more hypocritical, they pay taxes to finance a professional association of hit men collectively called politicians, and then complain about corruption in government.

#### [H: READ IT AGAIN, PLEASE!]

#### RESPONSIBILITY

Again, most people want to be free to do things (to explore, etc.) but they are afraid to fail.

The fear of failure is manifested in irresponsibility, and especially in delegating those personal responsibilities to others where success is uncertain or carries possible or created liabilities (law) which the person is not prepared to accept.

They want authority (root word: 'author'), but they will not accept responsibility or liability. They hire politicians to face reality for them.

#### **SUMMARY**

The people hire the politicians so that the people can:

- 1. obtain security without managing it,
- 2. obtain action without thinking about it,
- 3. inflict theft, injury, and death upon others without having to contemplate either life or death,

- 4. avoid responsibility for their own intentions,
- 5. obtain the benefits of reality and science without exerting themselves in the discipline of facing or learning of these things.

They give the politicians the power to create and manage a war machine to:

- 1. provide for the survival of the NATION/WOMB,
- 2. prevent encroachment of anything upon the NATION/WOMB,
- 3. destroy the enemy who threatens the NATION/WOMB, and
- 4. destroy those citizens of their own country who do not conform for the sake of stability of the NATION/WOMB.

Politicians hold many quasi-military jobs, the lowest being the police which are soldiers, the attorneys and the CPAs next who are spies and saboteurs (licensed), and the judges who shout the orders and run the closed union military shop for whatever the market will bear. The generals are industrialists. The 'presidential' level of commander-in-chief is shared by the international bankers. The people know that they have created this farce and financed it with their own taxes (consent), but they would rather knuckle under than be the hypocrite.

Thus a nation becomes divided into two very distinct parts, a DOCILE SUB-NATION and a POLITICAL SUB-NATION. The political sub-nation remains attached to the docile subnation, tolerates it, and leaches its substance until it grows strong enough to detach itself and devour its parent.

#### SYSTEMS ANALYSIS

In order to make meaningful computerized economic decisions about war, the primary economic flywheel, it is necessary to assign concrete logistical values to each element of the war structure—personnel and material alike.

This process begins with a clear and candid description of the sub-systems of such a structure.

#### THE DRAFT (As military service)

Few efforts of human behavior modification are more remarkable or more effective than that of the sociomilitary institution known as the draft. A primary purpose of a draft or other such institution is to instill, by intimidation, in the young males of a society the uncritical conviction that the government is omnipotent. He is soon taught that a prayer is slow to reverse what a bullet can do in an instant. Thus, a man trained in a religious environment for eighteen years of his life can, by this instrument of the government, be broken down, be purged of his fantasies and delusions in a matter of mere months. Once that conviction is instilled, all else becomes easy to instill.

Even more interesting is the process by which a young man's parents, who purportedly love him, can be induced to send him off to war to his death. Although the scope of this work will not allow this matter to be expanded in full detail, nevertheless, a course overview will be possible and can serve to reveal those factors which must be included in some numerical form in a computer analysis of social and war systems.

We begin with a tentative definition of the draft.

The draft: (selective service, etc.) is an institution of compulsory collective sacrifice and slavery, devised by the middle aged and the elderly for the purpose of pressing the young into doing the public dirty work. It further serves to make the youth as guilty as the elders, thus making criticism of the elders by the youth less

likely (Generational Stabilizer). It is marketed and sold to the public under the label of "patriotic national" service.

Once a candid economic definition of the draft is achieved, that definition is used to outline the boundaries of a structure called a Human Value System, which in turn is translated into the terms of game theory. The value of such a slave laborer is given in a Table of Human Values, a table broken down into categories by intellect, experience, post-service job demand, etc.

Some of these categories are ordinary and can be tentatively evaluated in terms of the value of certain jobs for which a known fee exists. Some jobs are harder to value because they are unique to the demands of social subversion, for an extreme example: The value of a mother's instruction to her daughter to put certain behavioral demands upon a future husband, ten to fifteen years hence, thus, by suppressing his resistance to a perversion of a government, making it easier for a banking cartel to buy the State of New York in, say, twenty years.

Such a problem leans heavily upon the observations and the data of wartime espionage and many types of psychological testing. But crude mathematical models (algorithms, etc.) can be devised, if not to predict, at least to predetermine theme events with maximum certainty. What does not exist by natural cooperation is thus enhanced by calculated compulsion. Human beings are machines, levers which may be grasped and turned, and there is little real difference between automating a society and automating a shoe factory.

These derived values are variable. (It is necessary to use a current Table of Human Values for computer analysis.) These values are given in true measure rather than U.S. dollars, since the latter is unstable, being presently inflated beyond the production of national goods and services so as to give the economy a false kinetic energy ('paper' inductance).

The silver value is stable, it being possible to buy the same amount with a gram of silver today as could be bought in 1920. Human value measured in silver units changes slightly due to changes in production technology.

#### **ENFORCEMENT**

#### FACTOR I

As in every social system approach, stability is achieved only by understanding and accounting for human nature (action/reaction patterns). A failure to do so can be, and usually is, disastrous. So his complaint? [QUOTING:]

#### **COMPLAINT**

1. This is a complaint for damages and injunctive relief arising out of manipulative activities in the gold market from 1994 to the present time orchestrated by government officials acting outside the scope of their legal or constitutional authority and certain large bullion banks active in the over-the-counter gold ("BIS"), frequently described as "the central bank's derivatives markets and on the Commodities Exchange ("COMEX") in New York. The complaint alleges horizontal price fixing in violation of Section 1 of the Sherman Act, securities fraud in violation of Section 10(b) and Rule 10b-5 of the Securities Exchange Act of 1934 ("Exchange Act"), common law fraud and breach of fiduciary duty by the directors of the Bank for International Settlements with regard to holders of its American issue, and violations of the Constitution by federal officials acting under color of federal law but wholly outside the scope of their legal or constitutional authority. Subject matter jurisdiction of the federal claims is based on 15 U.S.C.s. 15(a) (antitrust) and s.78aa (violations of the Exchange Act), 28 U.S.C.s.1331 (federal question, s.1337 (commerce and antitrust) and s.2201 (declaratory relief), and 12 U.S.C.s.632 (international banking and financial transactions). Supplemental jurisdiction of the common law claims is based on 28 U.S.C.s.1367.

#### II. PARTIES, VENUE AND STANDING

2. The plaintiff, Reginald H. Howe, is an American citizen, residing currently and at all times material hereto at 49 Tyler Road, Belmont, Massachusetts 02478. He is suing in his individual capacity as: (1) the duly registered holder of six shares of the American issue of the Bank for International Settlements; and (2) the holder of 1200 depositary shares of Gold-Denominated Preferred Stock, Series II, of Freeport-McMoran Copper & Gold, Inc. The plaintiff is the proprietor of The Golden Sextant (www.goldensextant.com), an internationally recognized Website containing commentaries, essays and analyses relating to gold, and a member of Golden Sextant Advisors LLC. The plaintiff has engaged in research and analysis on gold derivatives, which are instruments such as forward contracts, futures, options and swaps whose value is tied to—or derived from—the price of gold, and in this connection has uncovered considerable evidence of their use to manipulate gold prices.

[H: Now go back up a bit and note the "first derivative offered..." and recognized SOMETHING ELSE QUITE BIG AND BAD: By statement of the Philippine Central Bank, Governor Buenaventura stated a few weeks back that 96% of the Philippines' gold had been shipped OUT to be used as swaps and "money making" use of foreign banks. Try that one again: 96%! And, guess where he sent it all? Doesn't take either a rocket scientist, mind-washing expert or even a dimwit to figure this out—does it?]

- 3. While the plaintiff has not assigned any part of this action to others and retains full control thereof, he has received and expects to continue to receive support, both financial and informational, from the Gold Anti-Trust Action Committee Inc. ("GATA"), a civil rights and educational organization formed under Delaware law in January 1999 to expose manipulation of the gold market by certain bullion banks. The plaintiff was a contributor to GATA's study on the gold market, Gold Derivative Banking Crisis, which is posted at its Website (www.gata.org) and has been downloaded in full PDF format more than 20,000 times. The plaintiff was also a member of the GATA delegation that met with the Hon. Dennis L. Hastert, Speaker of the U.S. House of Representatives, in May 2000 to present to him the conclusions of the GATA study. Much of the evidence cited in this complaint comes from GATA's many friends and supporters worldwide.
- 4. The defendant Bank for International Settlements central bank", describes itself as an international organization but has not been so designated under the International Organizations Immunities Act, 22 U.S.C.s.288 et seq. The BIS is headquartered at CH-4002 Basle, Switzerland. Its principal owners and customers are the central banks of the major industrial nations. The BIS accepts gold deposits, makes gold loans, holds approximately 200 metric tonnes of gold for its own account, and is an active participant in the gold market. Its manager responsible for foreign exchange and gold, Giancomo Panizzutti, received the "Man of the Year Award" from the COMEX at its annual gold dinner in New York recently. Under the auspices of the BIS, gold derivatives (along with foreign exchange, interest rate, equity and other derivatives) are subject to significant regulation and reporting, including: (1) the Basle Capital Accord, which sets minimum bank capital adequacy requirements for off-balance sheet derivatives; and (2) protocols for disclosure of information

- regarding derivatives, both in the financial statements of individual firms and through reports prepared by national regulatory authorities as well as by the BIS from country data submitted to it.
- 5. The defendant Alan Greenspan is Chairman of the Board of Governors of the U.S. Federal Reserve System ("Fed"), 20th Street and Constitution Avenue, NW, Washington, D.C. 20551. Mr. Greenspan has served ex officio as a director of the BIS continuously since September 1994. When the BIS was formed in 1930, 15% of its original capital—the so-called American issue or tranche—was subscribed publicly in the United States, thereby giving the Fed the right to vote these shares when, as and if it assumed the two seats allocated to the American issue on the BIS's board. However, by a public pronouncement issued May 15, 1929, Secretary of State Henry L. Stimson forbade "any officials of the Federal Reserve system either to themselves serve or to select American representatives as members of the proposed International Bank." In fact, the two American seats on the BIS's board remained vacant until July 1994, when Mr. Greenspan, without any formal authorization by Congress, the President or the Secretary of State, acted to assume them for the Fed. Since September 1994, the FED'S two nominees have participated fully in the affairs of the BIS and voted the shares of the American issue.
- 6. The defendant William J. McDonough is President of the Federal Reserve Bank of New York ("N.Y. Fed"), 33 Liberty Street, New York, New York 10045. Mr. McDonough has served as a director of the BIS continuously since September 1994, occupying the second seat allocated to the American issue under the BIS's original plan of organization. As of August 2000, approximately 7127 metric tonnes of "earmarked" gold belonging to foreign official institutions, mostly central banks, were held in custody accounts at the N.Y. Fed, down from 8621 tonnes at the end of 1995. At the end of 1999, the N.Y. Fed held gold certificates covering over 40% of the total U.S. gold stock, far more than any other Federal Reserve Bank, and up from 30% ten years previously.
- 7. The defendant J.P. Morgan & Co. Inc. ("Morgan") is a global financial services firm with its head office at 60 Wall Street, New York, New York 10260, and a usual place of business at 2 International Place, Boston, Massachusetts. Morgan is a major international bullion bank. Its wholly-owned commercial bank subsidiary, Morgan Guaranty Trust, is required to provide regular quarterly reports on its gold derivatives to the U.S. Controller of the Currency ("OCC"). As of June 2000, Morgan reported U.S.\$29.7 billion notional amount of gold derivatives, up from \$18.4 billion one year earlier.
- 8. The defendant Chase Manhattan Corp. ("Chase") is a bank holding company with its head office at 270 Park Avenue, New York, New York 10017, and a usual place of business at 101 Federal Street, Boston, Massachusetts. Chase is a major international bullion bank and recently often a heavy seller of gold on the COMEX. Its wholly-owned commercial bank subsidiary, Chase Manhattan Bank, is required to provide regular quarterly reports on its gold derivatives to the OCC. As of June 2000, Chase reported U.S.\$35 billion notional amount of gold derivatives, up from \$20.5 billion one year earlier.
- 9. The defendant Citigroup, Inc. is a diversified financial services holding company with its head office at 153 East 53rd Street, New York, New York 10043, and a usual place of business at 1 International Place, Boston, Massachusetts. Citibank N.A. ("Citibank"), Citigroup's wholly-owned commercial bank subsidiary, is a major international bullion bank, and is required to provide regular quarterly reports on its gold derivatives

U.S.\$11.4 billion notional amount of gold derivatives, up from \$7.2 billion one year earlier. Together, Morgan, Chase and Citibank accounted for about 83% of all gold derivatives reported to the OCC in June 2000, and 75% one year earlier. In combined notional amount, the gold derivatives of these three banks increased by over \$30 billion, or by over 65%, during this one year period while those of all other reporting U.S. commercial banks remained virtually flat at slightly over \$15 billion.

10. The defendant Goldman Sachs Group, Inc. ("Goldman") is a global investment banking and securities firm with its head office at 85 Broad Street, New York, New York 10004, and a usual place of business at 125 High Street, Boston, Massachusetts. Goldman is a major international bullion bank and recently often a heavy seller of gold on the COMEX. Goldman is generally regarded as a major purveyor of gold derivatives. However, not being a commercial bank, Goldman does not report its gold derivatives to the OCC.

11. The defendant Deutsche Bank AG ("Deutsche Bank") is an international bank with its head office at Taunusanlage 12, D-60262, Frankfurt am Main, Germany, and a usual place of business at One Federal Street, Boston, Massachusetts. Deutsche Bank is a major international bullion bank and recently often a heavy seller of gold on the COMEX. In June 1999 annual report, Deutsche Bank reported approximately U.S.\$51.2 billion notional amount of gold derivatives at year-end, up from \$16.2 billion one year earlier. Most of this increase came in the last half of the year.

12. The defendant Lawrence H. Summers is the Secretary of the Treasury. Pursuant to 31 U.S.C. s. 5302, the Secretary of Treasury has exclusive control of the Exchange Stabilization Fund ("ESF") subject only to the approval of the President. The ESF and the Fed are the only instrumentalities of the federal government with broad statutory authority to trade in gold. This authority was conferred at a time when the dollar was officially defined by Congress as a specified weight of gold, and when maintenance of the dollar's official gold value was a matter of substantial legal and practical concern. Public financial statements of the ESF provide evidence of its intervention in the gold market, particularly since 1998.

13. Collectively the defendants represent all the principal parties required for a just and complete adjudication of the price fixing claims. The publicly reported gold derivatives of two other major international banks engaged in this business, UBS AG and Credit Suisse Group, do not show the same extraordinary growth patterns over the past two years as the gold derivatives of the defendant bullion banks, nor have these two Swiss-based banks recently been reported as frequent heavy sellers of gold on the COMEX. An examination of the gold hedging activities of the world's two largest gold mining companies, AngloGold Ltd. based in South Africa and BARRICK GOLD CORP. [H: (George H.W. Bush Sr.)] based in Canada, suggests that both companies have material non-public knowledge of the gold price-fixing scheme which they have used to their advantage, but neither company appears to play a critical role in implementing the scheme.

14. The plaintiff purchased his BIS shares, which then traded over-the-counter in Basle but now trade on the Swiss Exchange, in 1989 through an American brokerage firm. The shares were held in street name until 1997, when the plaintiff registered them in his name on the books of the BIS and soon thereafter received share certificate No. 031419 inscribed to him at his U.S. address, where the certificate remains. The plaintiff purchased his 1200 depositary shares of Gold-

to the OCC. As of June 2000, Citibank reported Denominated Preferred Stock, Series II, of Freeport-McMoran Copper & Gold, Inc., at various times from 1995 through 1999. By its terms, each depositary share pays a quarterly cash dividend equal to the value of 0.0008125 ounce of gold and will be redeemed in February 2006 for the cash value of 0.1 ounce of gold. The quarterly dividends are cumulative, but to date all payments have been timely made based on the arithmetic average of the London PM gold price over the relevant preceding five-day period.

> 15. By a "Note to Private Shareholders" dated September 15, 2000, mailed to the plaintiff at his U.S. address, the BIS gave notice that its board planned to vote at a meeting on January 8, 2001, to compel all private holders of the American, Belgian and French issues to surrender their shares against a payment of SwF16,000 (approx. U.S.\$9280) per share notwithstanding an opinion from J.P. Morgan & Cie SA, a wholly-owned French-based subsidiary of Morgan, setting the per share net asset value at U.S.\$19,099, or more than twice what the BIS proposes to pay for the shares that it plans to take.

> 16. Venue is based on 28 U.S.C. s. 1391(b)(2) as to all defendants, s. 1391(c) with respect to the corporate defendants having usual places of business in Boston, Massachusetts, s. 1391(e)(2) and (3) with respect to Messrs. Greenspan, McDonough and Summers, all of whom are acting "under color of [federal] legal authority" with respect to the matters alleged notwithstanding that their conduct falls wholly outside their legal and constitutional authority. Venue of the claims under the Exchange Act is also based on s. 27 thereof, 15 U.S.C. s. 78aa. The federal appeals judges likewise refused Judge Matsch and the higher court judges could easily be intimidated by the American CIA, reminding the judges about how, several years prior, Judge Matsch's daughter, Elizabeth, was apparently murdered.

Judge Matsch was the one who covered up the billions of dollars of purported embezzlement done by Neil Bush, son of the Elder Bush. The rip-off was done of and through a Denver savings and loan, Silverado. "Her WASHINGTON INTERNSHIP ended on April 23. ON THE EVENING OF APRIL 30, she turned in her membership at a local health club, and the authorities say THAT WAS THE LAST TIME SHE WAS SEEN IN PUBLIC. ON MAY 6, her frantic parents, unable to

reach her, REPORTED HER MISSING." (New York Times for June 22, 2001; emphasis added.)

May 6, 2001, was ten days prior to the original date set for McVeigh's execution. From their unit Los Angeles Times, the Chicago Tribune ran the following story, Thursday, May 10, 2001: "Washington-Federal lawenforcement officials revealed Thursday that they had found some 3,000 pages of FBI materials that had been mislaid in the Oklahoma City bombing case, and defense attorneys for Timothy J. McVeigh immediately said they hope to win a stay of his execution scheduled in just five days."

As the New York Times states in referring to Ms. Levy's parents meeting with the District of Columbia's police chief: "The Levys, wearing yellow ribbons, looked dazed and tired as they met with reporters in the sweltering summer Sun, both before and after their session with the chief. They said little, leaving most of the talking to THEIR LAWYER, BILLY REPRESENTED MARCIA LEWIS, MOTHER OF MONICA S. LEWINSKY, during the inquiry into Ms. Lewinsky's relationship with President Bill Clinton." (New York Times, 6/22/01; emphasis added.)

TOGETHER, THEY SHARED BILLIONS AND BILLIONS OF DOLLARS OF KICKBACKS AND "PROTECTION" FUNDS, FROM THE WEAK OIL SHEIKDOMS OF THE PERSIAN GULF. ### IRAQ SAYS IT CAN BEAT ANY U.S. MILITARY ATTACK

BAGHDAD (*Reuters*)—A leading Iraqi newspaper said on Monday Iraq could defeat any U.S. attack after Washington threatened to step up use of military force in response to Baghdad's attempt last week to shoot down a U.S. U-2 spy plane.

"Iraqis' resistance against the American and British aggression is growing, which will secure a final defeat to the aggressors and force them to leave our national air space," the ruling Baath Party newspaper *al-Thawra* said.

"The Iraqis... now have the capability, power and will to contain any new aggression and foil its aims," it said.

In Washington, a senior U.S. official said on Sunday Iraqi President Saddam Hussein was on the U.S. "radar scope" and the Bush administration would use military force against his government in a "more resolute manner" than in the past.

Iraqi anti-aircraft defenses came close to hitting a high-altitude U-2 spy plane with a missile last Tuesday. According to a U.S. account, the modified Russian-made missile just missed the plane in a "no-fly zone" over southern Iraq.

Iraq denied on Saturday that its defenses had fired a missile at the U-2, saying U.S. officials wanted to create a pretext for a fresh military attack against Iraq.

U.S. National Security Adviser Condoleezza Rice declined on Sunday to speculate on when President George W. Bush might order an attack against Iraq.

"But I can be certain of this and the world can be certain of this: Saddam Hussein is on the radar screen for the administration," she said on *CNN's* "Late Edition" program.

The administration was working with friends and allies to craft a broad policy toward Iraq that among other things looked at the use of "military force in a more resolute manner and not just a manner of tit-for-tat with them every day," she said.

Bush said last week Saddam remained a menace and a threat to U.S. and international security a decade after the Gulf War.

U.S. and British warplanes have been patrolling no-fly zones over northern and southern Iraq since the 1991 Gulf War, when Iraqi troops were ousted from Kuwait by a U.S.-led coalition.

Iraq was banned from using all aircraft, including helicopters, in the zones, set up by Western powers to protect minority Kurds and Shiites from attack by Saddam's forces.

No allied aircraft have been lost, although the Iraqi military has repeatedly fired anti-aircraft guns and missiles at the warplanes, which have responded by dropping bombs and firing missiles at Iraqi air defense sites.—http://www.turkishdailynews.com

#### "IT'S LIKE A TRAIN WRECK IN SLOW MOTION"

So said David V., a client of mine who, if there ever was someone in the thick of the financial world, it is he. David, on a daily basis, trades the big stuff, for a large New York company. He's sharp, experienced, and savvy. He's buying gold and silver as he watches the economic situation decline on a daily basis.

My first piece for *GOLD-EAGLE* was titled, "Diary of a Depression" and can be accessed by clicking on it at the end of this column. It all is coming down just like a train wreck in slow motion. In that first piece, I noted the failure of a Heilig Meyers furniture store in a nearby town of Delta. Now the entire outfit, with all their hundreds of stores is

kaput. I said that it would be a chain of events that no one would know how to stop, and just look at the latest figures:

- (1) Earnings at Dow-Jones fall by half
- (2) Knight Ridder's newspapers are on a huge decline because of lack of ads.
  - (3) Kodak sees no signs of recovery.
- (4) Cummins diesel engine sales in Dodge trucks and RecVees fall by 41%.
- (5) Gateway's sales down 21% last year and 16% so far this year.
- (6) Denver's office vacancy rate is 32.6%, as opposed to 3.8% before.
  - (7) Hundreds of thousands laid off.
- (8) European business is in a huge slump as are their stock markets.
  - (9) Japan's economy is a shambles as is its stock market.

As I said previously, when hundreds of thousands of employees are laid off, they simply cease buying consumer goods such as furniture, automobiles and appliances. They cease taking vacations, or if they do, they stay in the cheapest motels. Tourism here in my beautiful Colorado is way off, some say by 40%, but at least by billions of dollars, regardless of the percentages. Tourism is off everywhere because of the layoffs, stock market fizzle, and just plain uncertainty. The slow-motion train wreck is the gradual layoffs of more and more job holders, because of no purchases of the things they provide or manufacture. What will stop the progress of a depression on the make? FDR did it with World War II. Will we do it with a Middle-East war? The rumor is that Saddam's troops are headed for Israel. Will American troops being used as cannon fodder, be the 2001 method of getting out of a depression?

Smart people pay their debts, look for work, and attempt to survive, rather than buy. With the entire world's economic system on the brink of deep depression, if it is not already there, the various currencies will surely bite the dust, with the "buck" being the last to go... maybe... but its ultimate demise is as sure as is tomorrow. When the buck inflates like the Reichsmark did in 1924, all those mortgages and debts will be paid off in virtually worthless pieces of paper with ink on them—and then we can begin again.

How else could there be a new beginning, until the old system is gone? How can any economic system survive with printing presses around the world running night and day? The M3 money supply is careening upwards right now at over 18% so far this year, and M1 is not far behind, in spite of the false re-assurances by CNBC. Even Alan Greenspan is not too hopeful.

The Ruskies now have dragged out their "Chervonet" gold coin, and made it legal tender. This means that the dollar, in Russia, may be over the hill. Russians who save, if there are any, I am certain would rather save in legal gold coins, than paper dollars. I have been unable to get them so far, and am not certain I even want to, any more than I would sell a Chinese coin.

So what are we to do? We must protect ourselves by NOT SAVING IN CURRENCY-DENOMINATED DEVICES. If your savings are in currencies, and the currencies continually lose their purchasing power, you are self-destructing. Also, with six rate cuts already, and some say a seventh is coming, the interest you get on your savings is cut also. Savings accounts now pay less than 2% interest in many cases, thanks to the interest rate cuts. Cutting interest rates was supposed to help the economy by making money for business and investments cheaper and more available. However, the reverse is true for savers in currency-denominated devices such as

CDs and passbook savings accounts. Meddling and lowering rates has helped borrowers and harmed savers. The predictable result is, more and more are withdrawing their savings, thus harming the banks. It is a vicious circle, which contradicts itself at every turn. Spend in currencies immediately, or long term, with 30-year mortgages. Pay them off in candy bars in fifteen, probably.

If we make more than we spend, what are we to do with the extra? You know as well as I do what to do, but do not save dollars, francs, yen, pounds, or lira. Spend them as soon as you get them! Take a trip. Go to a movie. Buy a book. Enlarge your land holdings. Add to your home. Buy gold and silver. Buy antiques. But don't accumulate currencies, as they are going down at the same rate as their numbers are increasing. Did you know you can buy things with gold? I ordered a new Mercedes with gold, way back in 1980, when I was living in Phoenix.

I wanted a new turbo diesel, which would take six weeks to get. I was about to leave on a six-week precious-metals speaking trip up the Pacific Coast. I wanted to order, and brought out Krugerrands as a deposit. The salesman showed them to his boss, who was delighted to accept them as a deposit. When I got back, the shiny new turbo diesel was waiting, and I got my Krugs back. He wanted to apply them to the purchase price of the car, but I declined, as at that time I wanted a fully tax-deductible lease for the car. One should always take the road in which one pays the least taxes.

As the economy continues its decline, gold and silver will become more and more usable—and even requested for purchases. A couple of countries are now making silver coins for trade as this is being written.

I continually get the question asked of me, "What if the government seizes all the gold and silver like they did in the thirties?" First of all, the government didn't seize anyone's gold, it merely ordered it all to be turned in, under threat of a fine. Many foolishly did, but I would imagine most didn't. How would government know who has gold, any more than they would know who has silver flatware and candlesticks, a garden, antique furniture, or a TV set? Gold and silver carry no deed or title—and certainly are not "registered" with any government. The law, at one time, foolishly said that the maximum speed was 55MPH. Did anyone drive 55MPH? No, they bought radar detectors. The dollar is eventual bathroom material, and smart savers don't save in it. Just because all the other paper currencies in the world bite the dust, can the dollar be immune? When the flu spread around the world in 1918, killing hundreds of millions, was America exempt? The tiny town of Silverton, Colorado, high in the mountains, and sheltered and isolated from every other community by sheer cliffs and high mountains, lost 30% of its population from the flu. No village or sheltered area was immune from the flu. No worthless, unbacked piece of paper with ink on it will be exempt from ultimate degradation.

Learning that God's delays are not denials, we who give our time and effort to help GAIA's wondrous program unfold, practice our patience in nursing income to cover out-go.

We again ask you of the "away" crew to help if you can, as you can. Whatever you can spare to share when accumulated here helps.

#### CHINA CAN'T INVADE TAIWAN

G2mil—The Magazine of Future Warfare (Editorial), 8/1/01

One of the biggest lies heard in the American media is that China may invade Taiwan. China has 1300 million people, so how can Taiwan with only 22 million people possibly defend itself? The simple answer is 100 miles of water, known as the Taiwan Straits. A Chinese invasion would require an amphibious force larger than the Anglo-American force which landed at Normandy in 1944. China has only 10% of the naval power needed just to attempt a difficult invasion against Taiwan, which has only three practical landing sites, all heavily fortified. Anyone who performs some quick research will find that no expert believes China is capable of invading Taiwan, nor that it is building the naval force needed. All major powers acquire new warships every year, but every new Chinese warship is treated as proof of growing Chinese power by the American media.

The air forces among these two nations are considered an even match. China has more aircraft, but Taiwan has more sophisticated fighters with pilots who are much better trained. In addition, Taiwan's fighters operating in a defensive role would have the advantages of Taiwanese ground radar, E-2C airborne radar, and surface-to-air missile support. The Chinese Air Force could inflict damage on Taiwan—but would lose most of its Air Force in the process. It could fire some 300 missiles at Taiwan, but they are not precision-guided and would have no military effect. In short, a massive Chinese air and missile attack could kill a thousand Taiwanese and cause some damage, but China's airpower would be sacrificed.

Likewise, the larger Chinese Navy could attempt to blockade Taiwan, but would be gradually sunk by sophisticated Taiwanese anti-ship and anti-submarine weaponry. Last May, Professor Bernard Cole of the U.S. Naval War College appeared on *C-Span* and informed America that China cannot invade Taiwan and would be hard-pressed to blockade the island. The American media ignored this news, but made the U.S. offer to sell Taiwan "new" weapons a major story. Taiwan's lukewarm reaction confused most reporters. What happened is that the Pentagon was asked to develop a list of weapons to offer Taiwan, so the Generals and Admirals recommended that Taiwan buy used American weapons which they plan to retire. Most of these weapons are unsuitable for Taiwan's needs and are overpriced considering their age.

Despite the image of a growing China superpower portrayed in the American media, China's military remains

second class. Estimates of Chinese military spending range from the CIA's \$12.6 billion a year, to \$37.5 billion by the respected Institute of Strategic Studies, whose latest "1999" data will be cited throughout this article. Interestingly, both China and Taiwan (which spends \$10.7 billion annually) devote a smaller percentage of their GDP to their military than the U.S.A.—which spent a whopping \$305.4 billion in 1999. President Bush has also proposed a two-year increase in military spending that will exceed China's entire military budget. In contrast, news reports of China's "big military build-up" over the past two years fail to note that it just matches its economic growth, and amounts to only \$4 billion more each year. China does have nuclear weapons, but the U.S.A. has many times more and would use them to retaliate if Taiwan were nuked.

The most ignored aspect of the China-Taiwan conflict is China's other national security concerns. It has a long disputed border with unstable Russia (which spends \$55.0 billion each year on its military). China also has a disputed border with India (\$10.7 billion) which resulted in a short war in 1962 and a 1986 border clash. India's population will surpass China's by 2020—and Indians are irritated by Chinese military sales to their archrival Pakistan. Tensions with Vietnam (\$0.9 billion) remain since 1979 when China invaded to teach them a lesson about invading Cambodia, resulting in a stalemate which killed 55,000 Chinese. Finally, China is wary of the Japanese, who killed millions of its citizens during World War II. Japan spends more on its military than China (\$41.1 billion in 1999) and possesses the most powerful air and naval force in the Western Pacific. Japan may seem docile today, but politicians change quickly, and all Asian nations worry since Japan has begun building amphibious ships.

China's leaders have profited from better relations with the West. They are modernizing and enjoying the benefits of technology and trade. Starting a winless war with Taiwan would result in trade embargos and increased internal unrest among China's diverse cultures. The billions of dollars in new Taiwanese and American investment in China would end forever. China's unfriendly neighbors would support Taiwan and deploy forces to their borders in protest. Meanwhile, China's Air Force and Navy would suffer devastating losses fighting Taiwan, leaving the entire nation vulnerable to land grabs by hostile neighbors and internal revolts. A senseless war with Taiwan would cause China to lose everything it has gained over the past 20 years.

The Chinese seek no tension with the U.S.A. They have learned to exploit the corrupt American political system for their own gain. American defense contractors are happy to sell them anything that can be excused as a commercial venture—and classified American military technology can be acquired indirectly; click Israeli sales to China for details. The Chinese have talked tough about taking control of their "renegade" province for over 50 years, but remain far too weak to take action. However, these facts are ignored as the U.S. Navy pretends that its aircraft carriers protect Taiwan from invasion—and whenever the U.S. military establishment points to potential enemies to justify spending increases. China will not attack Taiwan—and even if they do, Taiwan can defend itself.— http://www.g2mil.com/Aug2001.htm

#### OLD BOARD GETS NetSol CONTROL FOLLOWING SPAT

CALABASAS, CALIFORNIA—A confrontation that sent armed guards to the offices of NetSol International Inc. has ended with the <u>original</u> management team being restored to power.

A Nevada judge ordered that the firm, which had been placed into receivership, be returned to the controls of its former board of directors. According to the board, the rival slate, which operated under the name NetSol Shareholders Group, LLC, dissolved itself Tuesday. [MM: Yes, NetSol International Inc. is a Nevada corporation—their Resident Agent, PARACORP INCORPORATED (RA to 3495 corporations as of 8/4/01), is no small-time player—doing business in California.]

"Any problems we've accumulated in the last four months as a result of that unfortunate distraction we'll address and get back in business," said Naeem Ghauri, NetSol's chief financial officer and one of the reinstated board members. "We haven't lost any customers, and they've expressed satisfaction that the original management is back in control."

The dispute for control of the high-tech firm came to a head in early June, when NetSol alleged the dissident shareholders illegally entered offices, escorted by armed security guards. Management [original] obtained a restraining order against the shareholders, who confidently asserted their right to the company's helm. [MM: Doesn't this actually sound similar to the March 1999 theft/takeover of CONTACT, INC. (legal owner of CONTACT newspaper) by the Spectrum Groupie?]

"We voted to throw out the old management and put in our new management," John C. Kirkland, the shareholders' attorney, said at the time. "They're like Al Gore. They won't accept defeat."

Kirkland was traveling Friday and unavailable for comment, and his associates were unable to field calls on his behalf.

During the dispute, the shareholders were unable to maintain a viable operations model, according to Ghauri.

"Even when they took control forcibly, they failed to deliver a plan," he said. "After all, we're shareholders too, so if they'd had a plan that could work, we wouldn't have resisted this at all."

During the imbroglio, control of the company was placed in the hands of receiver Gary Swarts.

"He's no longer in control," Aviva Gordon, Swarts' attorney, said. "He took over in May and we tried to mediate a solution between the two parties. The control issue was resolved such that no solution was needed, however."

With the old regime back in place, NetSol has one open slot on its board. A former member, Cary Burch, resigned. During the impasse, he had switched allegiances to the shareholders' side. His slot will now be filled next week by a new member of the board's choosing. Regular elections will proceed in November, Ghauri said.

The troubles have shaken up business somewhat, but NetSol expects to return to normal operations in coming weeks and will deliver its annual report at the end of September.

"The impact is on the new-business side," Ghauri said. "We were distracted and there is some effect to the business in terms of development. Since we just got control, we're assessing and evaluating all options available. In the next few weeks, we'll decide what to do in the long term. In the meantime, it's business as usual." [MM: CONTACT'S real-life, in-your-face, what-goesaround-comes-around restitution scenario, rapidly unfolding in the very immediate future, doesn't bode too well for the Spectrum "Kiddies of the Rainbow". #### TAVISTOCK—THE BEST KEPT SECRET IN AMERICA

The insidious propaganda and public opinion manipulations (including mind-control agendas) orchestrated by London's Tavistock Institute is covered at length in the books of David Icke and Dr. John Coleman, but this recent article adds fresh insights and historical perspective. Formed in 1947, the Tavistock Institute is an independent not-for-profit organization which seeks to combine research in the social sciences with professional practice. Problems of institution-building and organizational design and change are being tackled in all sectorsgovernment, industry and commerce, health and welfare. education, etc.—nationally and internationally, and clients range from multinationals to small community groups. A growth area has been the use of a developmental approach to evaluation of new and experimental programs, particularly in health, education and community development. This has also produced new training events alongside the regular program of group-relations conferences. The Institute owns and edits the monthly journal Human Relations (published by Plenum Press) which is now in its 48th year and has recently launched (in conjunction with Sage Publications) a new journal Evaluation.

Three elements combine to make the Institute unusual, if not unique: it has the independence of being entirely self-financing, with no subsidies from the government or other sources; the action research orientation places it between, but not in, the worlds of academia and consultancy; and its range of disciplines include anthropology, economics, organizational behavior, political science, psychoanalysis, psychology and sociology.

The ideology of American foundations was created by the Tavistock Institute of Human Relations in London. In 1921, the Duke of Bedford, Marquess of Tavistock, the 11<sup>th</sup> Duke, gave a building to the Institute to study the effect of shellshock on British soldiers who survived World War I. Its purpose was to establish the "breaking point" of men under stress, under the direction of the British Army Bureau of Psychological Warfare, commanded by Sir John Rawlings-Reese.

Tavistock Institute is headquartered in London. Its prophet, Sigmond Freud, settled in Maresfield Gardens when he moved to England. He was given a mansion by Princess Bonaparte. Tavistock's pioneer work in behavioral science along Freudian lines of "controlling" humans, established it as the world center of foundation ideology. Its network now extends from the University of Sussex to the U.S.

through the **Stanford Research Institute**, Esalen, MIT, Hudson Institute, Heritage Foundation, Center of Strategic and International Studies at Georgetown, where State Dept. personal are trained, U.S. Air Force Intelligence, and the Rand and Mitre corporations. The personnel of the corporations are required to undergo indoctrination at one or more of these Tavistock-controlled institutions. A network of secret groups, the Mont Pelerin Society, Trilateral Commission, Ditchley Foundation, and the Club of Rome is conduit for instructions to the Tavistock network.

Tavistock Institute developed the mass brainwashing techniques which were first used experimentally on American prisoners of war in Korea. Its experiments in crowd control methods have been widely used on the American public, a surreptitious but nevertheless outrageous assault on human freedom by modifying individual behavior through topical psychology. A German refugee, Kurt Lewin, became director of Tavistock in 1932. He came to the U.S. in 1933 as a "refugee", the first of many infiltrators, and set up the Harvard Psychology Clinic, which originated the propaganda campaign to turn the American public against Germany and involve us in World War II.

In 1938, Roosevelt executed a secret agreement with Churchill which in effect ceded U.S. sovereignty to England, because it agreed to let Special Operations Executive control U.S. policies. To implement this agreement, Roosevelt sent General Donovan to London for indoctrination before setting up OSS (now the CIA) under the aegis of SOE-SIS. The entire OSS program, as well as the CIA, has always worked on guidelines set up by the Tavistock Institute.

Tavistock Institute originated the mass civilian bombing raids carried out by Roosevelt and Churchill purely as a clinical experiment in mass terror, keeping records of the results as they watched the "guinea pigs" reacting under "controlled laboratory conditions". All Tavistock and American foundation techniques have a single goal—to break down the psychological strength of the individual and render him helpless to oppose the dictators of the World Order. Any technique which helps to break down the family unit, and family inculcated principles of religion, honor, patriotism and sexual behavior, is used by the Tavistock scientists as weapons of crowd control.

The methods of Freudian psychotherapy induce permanent mental illness in those who undergo this treatment by destabilizing their character. The victim is then advised to "establish new rituals of personal interaction", that is, to indulge in brief sexual encounters which actually set the participants adrift with no stable personal relationships in their lives, destroying their ability to establish or maintain a family. Tavistock Institute has developed such power in the U.S. that no one achieves prominence in any field unless he has been trained in behavioral science at Tavistock or one of its subsidiaries.

Henry Kissinger, whose meteoric rise to power is otherwise inexplicable, was a German refugee and student of Sir John Rawlings-Reese at SHAEF. Dr. Peter Bourne, a Tavistock Institute psychologist, picked Jimmy Carter for President of the U.S. solely because Carter had undergone an intensive brainwashing program administered by Admiral Hyman Rickover at Annapolis. The "experiment" in compulsory racial integration in the U.S. was organized by Ronald Lippert of the OSS and the American Jewish Congress, and director of child training at the Commission on Community Relations. The program was designed to break down the individual's sense of personal knowledge in his identity, his racial heritage. Through the Stanford Research Institute, Tavistock controls the National Education Association. The Institute of Social Research at the National Training Lab brainwashes the leading executives of business and government.

Such is the power of Tavistock that our entire space program was scrapped for nine years so that the Soviets could catch up. The hiatus was demanded in an article written by Dr. Anatol Rapport, and was promptly granted by

the government, to the complete mystification of everyone connected with NASA. Another prominent Tavistock operation is the Wharton School of Finance, at the University of Pennsylvania. A single common denominator identifies the common Tavistock strategy—the use of drugs. The infamous MK-ULTRA program of the CIA, in which unsuspecting CIA officials were given LSD—and their reaction studied like "guinea pigs"—resulted in several deaths.

The U.S. Government had to pay millions in damages to the families of the victims, but the culprits were never indicted. The program originated when Sandoz AG, a Swiss drug firm, owned by S.G. Warburg Co. of London, developed Lysergic Acid [LSD]. Roosevelt's advisor, James Paul Warburg, son of Paul Warburg who wrote the Federal Reserve Act, and nephew of Max Warburg who had financed Hitler, set up the Institute for Policy Studies to promote the drug. The result was the LSD "counterculture" of the 1960s, the "student revolution", which was financed by \$25 million from the CIA.

One part of MK-ULTRA was the Human Ecology Fund; the CIA also paid Dr. Herbert Kelman of Harvard to carry out further experiments on mind control. In the 1950s, the CIA financed extensive LSD experiments in Canada. Dr. D. Ewen Cameron, president of the Canadian Psychological Association, and director of Royal Victorian Hospital, Montreal, received large payments from the CIA to give 53 patients large doses of LSD and record their reactions; the patients were drugged into weeks of sleep and then given electric shock treatments.

One victim, the wife of a member of the Canadian Parliament, is now suing the U.S. companies who provided the drug for the CIA. All the records of the CIA's drug testing program were ordered destroyed by the head of MK-ULTRA. Because all efforts of the Tavistock Institute are directed toward producing cyclical collapse, the effect of the CIA programs are tragically apparent. R. Emmett Tyrell Jr., writing in the *Washington Post* August 20, 1984, cites the "squalid consequences of the 60s radicals in SDS" as resulting in "the growing rate of illegitimacy, petty lawlessness, drug addiction, welfare, VD and mental illness".

This is the legacy of the Warburgs and the CIA. Their principal agency, the Institute for Policy Studies, was funded by James Paul Warburg; its co-founder was Marcus Raskin, protégé of McGeorge Bundy, president of the Ford Foundation. Bundy had Raskin appointed to the post of President Kennedy's personal representative on the National Security Council, and in 1963 funded Students for Democratic Society, through which the CIA operated the drug culture.

Today the Tavistock Institute operates a \$6 Billion a year network of Foundations in the U.S., all of it funded by U.S. taxpayers' money. Ten major institutions are under its direct control, with 400 subsidiaries, and 3000 other study groups and think tanks which originate many types of programs to increase the control of the World Order over the American people. The **Stanford Research Institute**, adjoining the Hoover Institution, is a \$150 million a year operation with 3300 employees. It carries on program surveillance for Bechtel, Kaiser, and 400 other companies, and extensive intelligence operations for the CIA. It is the largest institution on the West Coast promoting mind control and the behavioral sciences.

One of the key agencies as a conduit for secret instructions from Tavistock is the Ditchley Foundation, founded in 1957. The American branch of the Ditchley Foundation is run by Cyrus Vance, former Secretary of State, and director of the Rockefeller Foundation, and Winston Lord, president of the Council on Foreign Relations.

One of the principal but little-known operations of the Rockefeller Foundation has been its techniques for controlling world agriculture. Its director, Kenneth Wernimont, set up Rockefeller-controlled agricultural programs throughout Mexico and Latin America. The independent farmer is a great threat to the World Order, because he produces for himself—and because his produce

can be converted into capital—which gives him the Carnegie Endowment for International Peace. independence. In Soviet Russia, the Bolsheviks believed they had attained total control over the people; they were dismayed to find their plans threatened by the stubborn independence of the small farmers, the Kulaks.

Stalin ordered the OGPU to seize all food and animals of the Kulaks, and to starve them out. The Chicago American. February 25, 1935 carried a front-page headline "SIX MILLION PERISH IN SOVIET FAMINE: Peasants' Crops Seized, They and their Animals Starve". To draw attention from this atrocity, it was later alleged that the Germans, not the Soviets, had killed six million people, the number taken from the Chicago American headline by a Chicago publicist.

The Communist Party, the Party of the Peasants and Workers, exterminated the peasants and enslaved the workers. Many totalitarian regimes have found the small farmer to be their biggest stumbling block. The French Reign of Terror was directed, not against the aristocrats—many of whom were sympathetic to it—but against the small farmers who refused to turn over their grain to the revolutionary tribunals in exchange for the worthless assignats. In the United States, the foundations are presently engaged in the same type of war of extermination against the American farmer.

The traditional formula of land plus labor for the farmer has been altered due to the farmer's need for purchasing power, to buy industrial goods needed in his farming operations. Because of this need for capital, the farmer is especially vulnerable to the World Order's manipulation of interest rates, which is bankrupting him. Just as in the Soviet Union in the early 1930s—when Stalin ordered the Kulaks to give up their small plots of land to live and work on the collective farms—the American small farmer faces the same type of extermination, being forced to give up his small plot of land to become a hired hand for the big agricultural trusts. The Brookings Institution and other foundations originated the monetary programs implemented by the Federal Reserve System to destroy the American farmer, a replay of the Soviet tragedy in Russia, with one proviso that the farmer will be allowed to survive if he becomes a slave worker of the giant trusts.

Once the citizen becomes aware of the true role of the foundations, he can understand the high interest rates, high taxes, the destruction of the family, the degradation of the churches into forums for revolution, the subversion of the universities into CIA cesspools of drug addiction, and the halls of government into sewers of international espionage and intrigue. The American citizen can now understand why every agent of the federal government is against him; the alphabet agencies, the FBI, IRS, CIA and BATF must make war on the citizen in order to carry out the programs of the foundations.

The foundations are in direct violation of their charters, which commit them to do "charitable" work, because they make no grants which are not part of a political goal. The charge has been made, and never denied, that the Heritage-AEI network has at least two KGB moles on its staff. The employment of professional intelligence operatives as "charitable" workers, as was done in the Red Cross Mission to Russia in 1917, exposes the sinister political, economic and social goals which the World Order requires the foundations to achieve through their "bequests".

Not only is this tax fraud, because the foundations are granted tax exemption solely to do charitable work, but it is criminal syndicalism, conspiracy to commit offenses against the United States of America, Constitutional Law 213, Corpus Juris Secundum 16. For the first time, the close interlocking of the foundation "syndicate" has been revealed by the names of its principle incorporators—Daniel Coit Gilman, who incorporated the Peabody Fund and the John Slater Fund, and became an incorporator of the General Education Board (now the Rockefeller Foundation): Gilman, who also incorporated the Russell Trust in 1856, later became an incorporator of the Carnegie Institution with Andrew Dickson White (Russell Trust) and Frederic A. Delano. Delano also was an original incorporator of the Brookings Institution and

Daniel Coit Gilman incorporated the Russell Sage Foundation with Cleveland H. Dodge of the National City Bank. These foundation incorporators have been closely linked with the Federal Reserve System, the War Industries Board of World War I, the OSS of World War II and the CIA. They have also been closely linked with the American International Corporation, which was formed to instigate the Bolshevik Revolution in Russia. Delano, an uncle of Franklin Delano Roosevelt, was on the original Board of Governors of the Federal Reserve System in 1914. His brother-in-law founded the influential Washington law firm of Covington and Burling. The Delanos and other ruling families of the World Order trace their lineage directly back to William of Orange and the regime which granted the charter of the Bank of England.

#### **Tavistock Institutions In The United States**

- \* Flow Laboratories—Gets contracts from the National Institutes of Health.
- \* Merle Thomas Corporation—Gets contracts from the U.S. Navy, analyzes data from satellites.
- \* Walden Research—Does work in the field of pollution control.
- \* Planning Research Corporation, Arthur D. Little, G.E. "TEMPO", Operations Research Inc.—Part of approximately 350 firms who conduct research and conduct surveys, make recommendations to government. They are part of what President Eisenhower called "a possible danger to public policy that could itself become captive of a scientific-technological elite".
- \* Brookings Institution—Dedicates its work to what it calls a "national agenda". Wrote President Hoover's program, President Roosevelt's "New Deal", the Kennedy Administration's "New Frontiers" program (deviation from it may have cost John F. Kennedy his life), and President Johnson's "Great Society". Brookings has been telling the United States Government how to conduct its affairs for the past 70 years and is still doing so.
- \* Hudson Institute—This institution has done more to shape the way Americans react to political and social events, think, vote and generally conduct themselves than perhaps any except the BIG FIVE. Hudson specializes in defense policy research and relations with the USSR. Most of its military work is classified as SECRET. (One idea during the Vietnam War was to build a moat around Saigon.) Hudson may be properly classified as one of the Committee of 300's BRAINWASHING establishments. One of its largest clients is the U.S. Department of Defense which includes matters of civil defense, national security, military policy and arms control.
- National Training Laboratories—One of the key institutions established for this purpose in the United States was the National Training Laboratories (NTL). Founded in 1947 by members of the Tavistock network in the United States and located originally on an estate in Bethel, Maine, NTL had as its explicit purpose the brainwashing of leaders of the government, educational institutions, and corporate bureaucracies in the Tavistock method, and then using these "leaders" to either themselves run Tavistock group sessions in their organizations or to hire other similarly trained group leaders to do the job. The "nuts and bolts" of the NTL operation revolves around the particular form of Tavistock degenerate psychology known as "group dynamics", developed by German Tavistock operative Kurt Lewin, who emigrated to the United States in the 1930s and whose students founded NTL.

In a Lewinite brainwashing group, a number of individuals from varying backgrounds and personalities, are manipulated by a "group leader" to form a "consensus" of opinion, achieving a new "group identity". The key to the process is the creation of a controlled environment, in which stress is introduced (sometimes called dissonance) to crack an individual's belief structure. Using the peer pressure of other group members, the individual is "cracked" and a new personality emerges with new values. The degrading

experience causes the person to deny that any change has taken place. In that way, an individual is brainwashed without the victim knowing what has taken place.

This method is the same, with some minor modification, used in all so-called "sensitivity groups" or "T-groups", or in the more extreme rock-drug-sex counterculture form, "touchyfeely groups", such as the kind popularized from the 1960s onward by the Esalen Institute, which was set up with the help of NTL. From the mid-1950s onward, NTL put the majority of the nation's corporate leaderships through such brainwashing programs, while running similar programs for the State Department, the Navy, the Department of Education, and other sections of the federal bureaucracy. There is no firm estimate of the number of Americans who have been put through this process in last 40 years at either NTL, or as it is now known the NTL Institute for Applied Behavioral Sciences, which is based in Rosslyn, Virginia, or its West Coast base of operations, the Western Training Laboratories in Group Development, or in various satellite institutions. The most reliable estimate is in the several millions.

One of the groups that went through the NTL mill in the 1950s was the leadership of the National Education Association, the largest organization of teachers in the United States. Thus, the NEA's outlook has been "shaped" by Tavistock, through the NTL. In 1964, the NTL Institute became a direct part of the NEA, with the NTL setting up "group sessions" for all its affiliates. With funding from the Department of Education, the NTL Institute drafted the programs for the training of the nation's primary and secondary school teachers, and has a hand as well in developing the content of educational "reforms", including OBE.

Also known as the International Institute for Applied Behavioral Sciences. This institute is a brainwashing center in artificial stress training whereby participants suddenly find themselves immersed in defending themselves against vicious accusations. NTL takes in the National Education Association, the largest teacher group in the United States. While officially decrying "racism", it is interesting to note that NTL, working with NEA, produced a paper proposing education vouchers which would separate the hard-to-teach children from the brighter ones, and funding would be allocated according to the number of difficult children who would be separated from those who progressed at a normal rate. The proposal was not taken up.

\*University of Pennsylvania, Wharton School of Finance & Commerce. Founded by Eric Trist, one of the "brain trusts" of Tavistock, Wharton has become one of the more important Tavistock institutions in so far as "Behavioral Research" is concerned. Wharton attracts clients such as the U.S. Department of Labor—which teaches how to produce "cooked" statistics at the Wharton Econometric Forecasting Associates Incorporated. This method was very much in demand as we came to the close of 1991 with millions more out of work than was reflected in USDL statistics. Wharton's ECONOMETRIC MODELING is used by every major Committee of 300 company in the United States, Western Europe, the International Monetary Fund, the United Nations, and the World Bank.

\*Institute for Social Research. Among its clients are The Ford Foundation, U.S. Department of Defense, U.S. Postal Service and the U.S. Department of Justice. Among its studies are "The Human Meaning Of Social Change", "Youth in Transition" and "How Americans View Their Mental Health".

\*Institute For The Future. This is not a typical Tayistock institution in that it is funded by the Ford Foundation, yet it draws its long-range forecasting from the mother of all think tanks. Institute for the Future projects what it believes to be changes that will be taking place in time frames of fifty years. So called "DELPHI PANELS" decide what is normal and what is not, and prepare position papers to "steer" government in the right direction to head off such groups as "people creating civil disorder". (This could be patriotic groups demanding abolition of graduated taxes, or demanding that their right to bear arms is not

liberalizing abortion laws, drug usage and that cars entering an urban area pay tolls, teaching birth control in public schools, requiring registration of firearms, making use of drugs a non-criminal offense, legalizing homosexuality, paying students for scholastic achievements, making zoning controls a preserve of the state, offering bonuses for family planning and last, but most frightening, a Pol Pot Cambodia-style proposal that new communities be established in rural areas, (concentration camp compounds). As can be observed, many of their goals have already been more than fully realized.

#### INSTITUTE FOR POLICY STUDIES (IPS)

One of the "Big Three", IPS has shaped and reshaped United States policies, foreign and domestic, since it was founded by James P. Warburg and the Rothschild entities in the United States. Its networks in America include the League for Industrial Democracy. Lead players in the League for Industrial Democracy have included Jeane Kirkpatrick, former U.S. Ambassador to the United Nations, Irwin Suall of the ADL, Eugene Rostow, Arms control negotiator, Lane Kirkland, Labor Leader, and Albert Shanker. IPS was incorporated in 1963 by Marcus Raskin and Richard Barnett, both highly trained Tavistock Institute graduates. The objectives of IPS came from an agenda laid down for it by the Tavistock Institute, one of the most notable being to create the "New Left" as a grass roots movement in the U.S. It's been said that Barnett and Raskin controlled such diverse elements as the Black Panthers, Daniel Ellsberg, National Security Council staff member Halprin, The Weathermen Underground, the Venceramos and the campaign staff of candidate George McGovern. No scheme was too big for IFS and its controllers to take on and manage.

Capitol Hill, IPS relentlessly used its "Big Stick" to beat Congress. IPS has a network of lobbyists, all supposedly operating independently but in actual fact acting cohesively, so that Congressmen are pummeled from all sides by seemingly different and varied lobbyists. In this way, IPS was, and is still, able to successfully sway individual Representatives and Senators to vote for "the trend, the way things are going". By using key pointmen on Capitol Hill, IPS was able to break into the very infrastructure of our legislative system and the way it works.

IPS became, and remains to this day, one of the most prestigious "think tanks" controlling foreign policy decisions, which we, the people, foolishly believe are those of our law makers. By sponsoring militant activism at home and with links to revolutionaries abroad, by engineering such victories as "The Pentagon Papers", besieging the corporate structure, bridging the credibility gap between underground movements and acceptable political activism, by penetrating religious organizations and using them to sow discord in America, such as radical racial policies under the guise of religion, using establishment media to spread IPS ideas, and then supporting them, IPS has lived up to the role which it was founded to play.

#### STANFORD RESEARCH INSTITUTE

Jesse Hobson, the first president of Stanford Research Institute, in a 1952 speech made it clear what lines the institute was to follow. Stanford can be described as one of the "jewels" in Tavistock's Crown in its rule over the United States. Founded in 1946 immediately after the close of WWII, it was presided over by Charles A. Anderson, with emphasis on mind-control research and "future sciences". Included under the Stanford umbrella was Charles F. Kettering Foundation which developed the "Changing Images of Man" upon which the Aquarian Conspiracy rests.

Some of Stanford's major clients and contracts were at first centered around the defense establishment but as Stanford grew, so did the diversity of its services: Applications of Behavioral Sciences to Research Management Office of Science and Technology; SRI

infringed.) At present Stanford's computers are linked with 2500 "sister" research consoles which include the CIA, Bell Telephone Laboratories, U.S. Army Intelligence, The Office of Naval Intelligence (ONI), Rand, MIT, Harvard and UCLA. Stanford plays a key role in that it is the "library", cataloging all ARPA documentation.

> 'Other agencies"... one can use one's imagination here, are allowed to search through SRI's "library" for key words, phrases, look through sources and update their own master files with those of Stanford Research Center. The Pentagon uses SRI's master files extensively, and there is little doubt that other U.S. Government agencies do the same. Pentagon "command and control" problems are worked out by Stanford. While ostensibly these apply only to weapons and soldiers, there is absolutely no guarantee that the same research could not, and will not be turned to civilian applications. Stanford is known to be willing to do anything for anyone. MASSACHUSETTS INSTITUTE OF TECHNOLOGY (MIT),

#### ALFRED P. SLOAN SCHOOL OF MANAGEMENT

This major institute is not generally recognized as Through its many powerful lobbing groups on being a part of Tavistock U.S.A. Most people look upon it as being a purely American institution, but that is far from the truth. MIT-Alfred Sloan can be roughly divided into the following groups:

#### MISSING INTERN CHANDRA LEVY SPOTTED IN ISRAEL

Los Angeles (ACN)—La Voz de Aztlan has just received a report that missing Washington D.C. intern Chandra Levy was seen yesterday afternoon entering an Israeli government building in Tel Aviv which reliable sources believe houses the "Institution for Intelligence and Special Assignments". 
