We will still have most calls through the hotel because they are our "answering' service and "find E.J." for callers, etc.

I also am pretty confident that the reason we are maintaining in this place is that the loving things you all back home have sent to clean air, sanitize water, etc., have performed their magic.

The nation itself is desperate and my heart goes out in appreciation to YOU and sorrow for those around us who work here, as in hotel staff, who make so little income as to mostly NOT EVEN HAVE ELECTRICITY IN THEIR HOUSES. MOST SHARE HOUSING WITH AT LEAST 10 OTHER PEOPLE, MINIMUM.

Meanwhile, there sits the pool of deuterium in the bottom of the "trench" while the oil barons force this crude poison off onto everyone. They can't live without it—nor can they live long with it.

Bank notes #4: My, my. Even those Ph.D.s at the International Monetary Fund can be occasionally wrong after all.

Early this month, the IMF publicly announced it was correcting (finally, amen) its formula for the computation of the reserve adequacy ratio of countries like the Philippines.

The formula now is: gross international reserves minus short-term (or less than one year) liabilities minus contingent liabilities (or guarantees that are only activated in case certain projects cannot meet their foreign-denominated payments).

Before the correction, the IMF included pre-pledge assets or those backed by gold in determining whether a country had enough dollars to meet its maturing foreign

debts. In effect, the IMF made a double deduction since these gold-backed assets were already included in the computation of both short-term and contingent liabilities.

Said another way, the IMF has been understating the country's net dollar reserves by \$1.6 billion, the amount of our pre-pledged assets. [END OF QUOTING]

You might also be surprised to realize that the Central Banks everywhere have been supported handsomely to ship out a nation's gold reserves to London for leasing, trading, manipulation, etc. In the Philippines alone, 96%, by published word of the **CB Governor, is GONE—SHIPPED AWAY**.

The Central Banks have also been handsomely PAID to discourage all purchasing of gold by said banks. This, while the IMF totally controls the records and operations of said banks. In the Philippines there is a separate building for the World Bank—BUT the IMF is contained in and controls the Central Bank.

BENIGN PARANOIA AND THE DRAMA OF PERVASIVE SURVEILLANCE

[QUOTING:]

THE DOOR TO PARANOIA OPENS BENIGNLY— AND EARLY. JUST THINK OF SANTA. HE KNOWS WHEN YOU ARE SLEEPING. HE KNOWS WHEN YOU'RE AWAKE. HE KNOWS IF YOU'VE BEEN BAD OR GOOD, SO BE GOOD FOR GOODNESS' SAKE.

And, he knows these things all the time, even though you can't see him. Millions of kids all over the world happily and wholeheartedly believe in ubiquitous surveillance as a de facto piece of the annual Christmas present-getting machine. Parents just shake their heads in adoring wonder.

But those same parents might be shocked to learn how short the journey is from the pleasant surveillance fantasy of Santa to the freedom-squashing invasion of Big Brother. In the world detailed by George Orwell in the novel 1984 surveillance cameras follow every move a person makes, and the slightest misstep, or apparent misstep, summons the authorities. Now, similarly, police departments, government agencies, banks, merchants, amusement parks, sports arenas, nanny-watching homeowners, swimmingpool operators, and employers are deploying cameras, pattern-recognition algorithms, databases of information, and biometric tools that when taken as a whole can be combined into automated surveillance networks able to track just about anyone, just about anywhere.

While none of us is under 24-hour surveillance vet [H: Perish that thought!], the writing is on the wall. As Scott McNealy, CEO of Sun Microsystems, starkly told reporters in 1999, "You already have zero privacy. Get over it." The techno-entrepreneurs who are developing and marketing these tools anticipate good things to come, such as reduced crime rates in urban environments, computer interfaces that will read eye movements and navigate the Web for you, and fingerprint or facial-recognition systems and other biometric technologies that guarantee your identity and eliminate the need for passwords, PIN numbers and access cards—even identifying potential terrorists before they can strike. [H: Frankly, our people welcome such security if at all possible to achieve. It certainly is NOT safe on the streets or in your home, NOW.]

But privacy advocates paint a far dimmer picture of this same future, accepting its reality while questioning whether it can be managed responsibly. technology is developing at the speed of light, but the privacy laws to protect us are back in the Stone Age," says Barry Steinhardt, associate director of the American Civil Liberties Union which is among several groups that have tried, so far almost universally unsuccessfully, to introduce legislation aimed at protecting privacy. "We may not end up with an Orwellian society run by malevolent dictators, but it will be a surveillance society where none of the detail of our daily lives will escape notice and where much of that detail will be recorded."

THE FIFTH UTILITY

In many ways, the drama of pervasive surveillance is being played out first in Orwell's native land, the United Kingdom, which operates more closed-circuit cameras per capita than any other country in the world. This very public surveillance began in 1986 on an industrial estate near the town of King's Lynn, approximately 100 kilometers north of London. Prior to the installation of three video cameras, a total of 58 crimes had been reported on the estate. None was

surveillance cameras—and things took off from there.

Most of these closed-circuit TV systems are installed in business districts or shopping centers by British Telecommunications (BT), the national phone network, and jointly operated and managed by law enforcement and private industry. In addition, some townships are using BT to hook up video telephony, a technology that allows transmission of video images via telephone lines but in a monitor-friendly network that provides officials quick and easy remote access to the images. On another front, the U.K. Home Office, the government department responsible for internal affairs in England and Wales, is starting construction of what promises to be the world's biggest road and vehicle surveillance network, a comprehensive system of cameras, vehicle and driver databases, and microwave and phone-based communications links that will be able to identify and track the movements of vehicles nearly nationwide. All told, the country's electronic eyes are becoming so prevalent that Stephen Graham of the Centre for Urban Technology at the University of Newcastle upon Tyne has dubbed them a "fifth utility", joining water, gas, electric and telephones.

The United States and many other parts of the developed world are not far behind in video surveillance. Just look at the cameras looking at you. They're in ATMs, banks, stores, casinos, even side streets. And those are the cameras you can see. Companies like All Security Systems of Miami, Fl., advertise Clock Cameras, Exit Sign Cameras, Smoke Detector Cameras, and Covert Tie and Button Cams, as well as Nanny Cams and other easily hidden eyes, some of which send video signals wirelessly to a recorder located elsewhere.

Do you not want to know who is breaking your laws and disallowing you to even walk on the streets in safety or carry a bit of cash for a lunch on your person? PRIVACY IS ALTOGETHER DIFFERENT, PRIVACY IS THAT WHICH IS ABOUT YOUR PERSON AND THE MINUTE YOUR PRIVACY INVADES THAT OF ANOTHER, YOU NEED TO ATTEND HONOR AND INTEGRITY. WHEN YOU COMMIT NOTHING THAT REQUIRES QUESTION ABOUT YOUR ACTIVITIES, PERHAPS YOU WON'T MIND A CAMERA ON YOUR ACTIONS QUITE SO BADLY. AND, YES, I AM VERY SERIOUS—THINK ABOUT THESE THINGS. WOULD IT NOT BE WONDROUS TO FEEL SAFE AND SECURE IN PERSON AND PROPERTY?]

But cameras seem relatively benign when compared to new technology being developed and deployed. Until recently, closed-circuit systems have fed video signals to monitors, which human beings had to watch in real time, or sent the images to recording media for storage.

In 1995, buoyed by that Now, however, the job of spotting suspicious people and success, the government made matching grants available to behavior in this stream of electronic imagery is becoming other cities and towns that wanted to install public automatic, with computers programmed with special algorithms for matching video pixel patterns to stored patterns associated with criminals or criminal actions—and the machines themselves passing initial judgment on whether a behavior is normal.

> For example, last January at the Super Bowl in Tampa, Florida, law enforcement agencies, without announcement, deployed a face-recognition system from Visage Technology of Littleton, MA. Cameras snapped face shots of fans entering the stadium. Computers instantly extracted a minimal set of features from each captured face, a so-called cigenface, and then compared the cigenfaces to those of criminals, stored in a database. The system purportedly found 19 possible matches, although no one was arrested as a result of the test. Less than six months later, in mid-July, Tampa police sparked public protests after deploying a face-recognition system from Visionics, of Jersey City, NJ, to scan city sidewalks for suspected criminals and runaways.

> And this is just the beginning of the technology being piloted and prototyped to watch you—and judge your behavior. Beginning in 1997, the U.S. Defense Advanced Research Projects Agency (DARPA) funded some 20 projects under a three-year program called Video Surveillance and Monitoring. That effort has just gathered new momentum under a \$50 million follow-up program known as Human ID at a Distance. The aim is to determine if it's feasible to identify specific individuals at distances up to 150 meters.

> Under the program, researchers at Carnegie Mellon University in Pittsburgh are investigating whether a remote sensing technique known as "hyperspectral imaging"—a technology typically used by satellites to find minerals or peer through military camouflage—can be adapted for identifying specific human beings by measuring the color spectrum emitted by their skin. Skin absorbs, reflects and emits distinct patterns of color and those patterns are specific enough to individual people to serve as spectral signatures. Such systems already work. But according to Robert Collins, a computer scientist at Carnegie Mellon's Robotics institute, the process currently requires a person to sit stiffly in a chair as a sensor sweeps through hundreds of emitted wavelengths over a period of about five seconds. "Ideally, what will happen is we'll find some small group of wavelengths that we can use to distinguish people," explains Collins. That could reduce the scan time to a fraction of a second.

> Another approach being developed involves a videobased network of sensors that would automatically measure such characteristics as leg length and waist width to provide, as Collins says, "the measurements you give to a tailor." The idea here, he says, is that those numbers should be able to serve as a kind of body fingerprint for identifying specific individuals.

> There is no shortage of cleverness when it comes to building the surveillance state. At the Georgia Institute of Technology, scientists are developing sensor-riddled "smart floors" that can identify people by the "force profiles" of their walking feet. Meanwhile, Princeton, NJ-based Sarnoff is working toward an antiterrorist technique that uses a special camera to identify individuals from a hundred meters off by the patterns of color, striation and speckles in their irises. This isn't easy, since the iris and its elements move so quickly relative to a distant camera that the technical task bears some resemblance to "tracking a ballistic missile," says Norman

technology company. Still, the technology is coming.

Beyond identity is intention—and there are technologies in the works for divining that as well. IBM has introduced a software product called BlueEyes that's currently in use at retail stores to record customers' facial expressions and eye movements, tracking the effectiveness of in-store promotions. And psychologist Jeffrey Cohn of Carnegie Mellon's Robotics Institute and colleagues have been trying to teach machines an even more precise way to detect facial expressions.

From video signals, the Carnegie Mellon system detects and tracks both invariant aspects of a face, such as the distance between the eyes, and transient ones, like skin furrows and smile wrinkles. This raw data is then reclassified as representing elemental actions of the face. Finally, a neural network correlates combinations of these measurable units to actual expressions. While this falls short of robotic detection of human intentions, many facial expressions reflect human emotions, such as fear, happiness or rage, which, in turn, often serve as visible signs of intentions.

Cohn points out that this particular work is just part of the team's more encompassing "goal of developing computer systems that can detect human activity, recognize the people involved, understand their behavior, and respond appropriately." In short, the effort could help lead to the kind of ubiquitous surveillance system that can automatically scan collective human activity for signs of anything from heart-attackinducing Type-A behavior to sexual harassment to daydreaming at the wheel to homicidal rage.

THE GOOD, THE BAD AND THE WELL-INTENTIONED

The list of emerging technological wonders goes on and on, which is why many observers argue it's no longer a question of whether ubiquitous surveillance will be applied, but under what guidelines it will operate—and to what end.

"Like most powerful technologies, total surveillance will almost certainly bring both good and bad things into life," says James Wayman, a former National Security Agency contractor who now directs human identification research at San Jose State University in California. Specifically, he notes, it will combine laudable benefits in convenience and public safety with a potentially lamentable erosion of privacy.

These contradictory values often trigger vigorous debate over whether it will all be worth it. The glasshalf-full crowd contends that the very infrastructure of surveillance that conjures fears of Big Brother will actually make life easier and safer for most people. Consider the benefits of the "computer-aided drowning detection and prevention" system that Boulogne, France-based Poseidon Technologies has installed in nine swimming pools in France, England, the Netherlands and Canada. In these systems, a collection of overhead and in-pool cameras relentlessly monitors pool activity. The video signals feed into a central processor running a machine perception algorithm that can effectively spot when active nonwater objects, such as swimmers, become still for more than a few seconds. When that happens, a red alarm light flashes at a poolside laptop workstation and lifeguards are alerted via waterproof pagers. Last November, a Poseidon system at the Jean Blanchet Aquatic Center in Ancenis, Loire-Atlantique, France, alerted lifeguards in time to rescue a swimmer on the verge of drowning. Pulled from the water unconscious, the Winarsky, president of nVention, Sarnoff's venture swimmer walked away from a hospital the next day.

Similarly, when cell phones and other mobile gadgetry start coming embedded with Global Positioning System transponders, it will be possible to pinpoint the carrier and quickly come to his or her aid, if necessary. Such transponders are already built into many new cars. A click of a button or the triggering of an air bag sends a call to a service center, where agents can then direct emergency personnel to the vehicle, even if the occupants are unconscious. A public ubiquitous surveillance system could also enhance safety by noticing, for example, if a car hits you or if large, unauthorized crowds start congregating around an accident or altercation. As with the car rescue systems, a person's plight could be recognized and help dispatched almost instantly, sort of how air bags are now immediately deployed on impact.

And not many argue about surveillance's ability to deter crime. Recent British government reports cite closed-circuit TV as a major reason for declining crime rates. After these systems were put in place, the town of Berwick reported that burglaries fell by 69 percent, and in Glasgow, Scotland, crime slumped by 68 percent. Public reaction in England has been mixed, but many embrace the technology. "I am prepared to exchange a small/negligible amount of privacy loss so I don't have to be caught up in yet another bomb blast/bomb scare," wrote one London computer programmer in an online discussion of the technology.

Do the developers of this controversial technology weigh the pros and cons of their creations? Robert Collins of Carnegie Mellon concedes that much of the work that might fall into the surveillance category conjures an Orwellian quease, but he joins a veritable chorus of colleagues who say it's not their station to be gatekeepers looking out for how the technology ultimately is used. "We who are working on this are not so interested in applying it to surveillance and Big Brother stuff," Collins says. "We're making computers that can interact with people better." Indeed, Collins notes that he and his colleagues are motivated by the notion of "pervasive computing", in which the techno-environment becomes aware of its human occupants so that computers and other gadgets can adjust to human needs. The way it is now, he says, humans have to accommodate the limitation of machines.

Jonathan Pilips, manager of DARPA's Human ID at a Distance program, puts it another way: "We develop the technology. The policies and how you implement them is not my province."

So who is watching the gate? Well, the courts are slowly getting involved. A U.S. Supreme Court decision last June determined that in the absence of a search warrant, the government's use of a thermal-imaging device to monitor heat coming off the walls of a suspected marijuana grower's private residence in Florence, Oregon, violated the Fourth Amendment prohibition against "unreasonable searches and seizures". The ruling could have far reaching consequences for how new, more powerful surveillance technologies can be deployed. Overall, however, the responsibility of surveillance technology management and regulation is up for grabs in the United States, even as the technology proliferates. And so whether society goes Orwellian or not could well hinge on how responsibly the databases, biometric details and all the rest are managed and protected. After all, notes the ACLU's Steinhardt, it's a small step from a technological advance to a technology abuse.

Take the fact that the faces of a large portion of the driving population are becoming digitalized by motor

vehicles agencies and placed into databases, says Steinhardt. It isn't much of a stretch to extend the system to a Big Brother-like nationwide identification and tracking network. Or consider that the Electoral Commission of Uganda has retained Visage Technology to implement a "turnkey face-recognition system" capable of enrolling 10 million voter registrants within 60 days. By generating a database containing the faceprint of every one of the country's registered voters—and combining it with algorithms able to scour all 10 million images within six seconds to find a match—the commission hopes to reduce voter registration fraud. But once such a database is compiled, notes John Woodward, a former CIA operations officer who managed spies in several Asian countries and who's now an analyst with the **Rand Corporation**, it could be employed for tracking and apprehending known or suspected political foes. Woodward calls that "function creep".

Function creep is where things get really dicey for privacy advocates. Several grass-roots efforts now under way seek to rein in surveillance technology through more responsible privacy legislation. The Privacy Coalition, a nonpartisan collection of consumers, civil liberties, labor and family-based groups is trying to get federal and state lawmakers to commit to its "Privacy Pledge", which contains, among other things, a vow to develop independent oversight of public surveillance technology and limit the collection of personal data. And several organizations, including the AFL-CIO, Communications Workers of American, 9 to 5, National Association of Working Women and the United Autoworkers, are supporting legislation to restrict electronic monitoring of employees. As Steinhardt declares, "We can't leave this to systems designers or the marketplace."

In spite of these broad efforts, a number of factors, not the least of which is disagreements in Washington about what form such legislation should take, are making it difficult to put words into action. Last year Congress debated the Notice of Electronic-Monitoring Act, which would have required companies to notify employees if they were being watched. Although that legislation died in committee, it will probably resurface again this year. As far as individual state laws are concerned, only Connecticut requires employers to tell employees if they are being monitored.

Which leads to the question of what exactly constitutes "Private" activity. As former spymaster Woodward observes, a total surveillance society will not actually expose individuals that much more than ordinary public circulation does now. "Once you leave your house and enter public spaces," he says "just about everyone you can see can see you right back." In other words, you do not walk around most of the day with an expectation of privacy. Your face is not private, so if a camera sees you, it's no big deal. What's more, asks Woodward, even if rich and powerful entities, such as the government or megacorporations had sole access to a system capable of watching everyone all the time, why would they bother? "The bottom line is that most of us are very boring. We flatter ourselves to think that someone is building a multibillion-dollar system to watch us," he says.

Even if public opinion does manage to slow down the deployment of surveillance infrastructure, no one involved in the debate thinks it will stop some form of Big Brother from arriving eventually. In his 1998 book The Transparent Society, which is well known in the privacy advocacy community, science fiction author and technology watcher David Brin argues that society inevitably will have to choose between two versions of

ubiquitous surveillance; in one, only the rich and powerful use and control the system to their own advantage, in the second, more democratic future, the watchers can also be watched. Brin concedes that the latter version would mean everybody's laundry hung out in public view, but the transparency would at least be mutual. Rent a porn video and your wife knows it; but if she drives to your best buddy's house four times a week while you're at the office, you'll know that also.

Whether or not the coming era of total surveillance fits neatly into one of Brin's scenarios will be determined by a complex equation encompassing technological development and the decisions that local, state and federal governments choose to make. The question largely boils down to this: Is privacy a right or a privilege? Most American assume it is a right, as in our "right to privacy". But the truth of the matter is that privacy isn't guaranteed by the Constitution. It is implied, certainly, but not assured. This subtle difference is being tested right now, within our own neighborhoods and workplace.

Timothy McVey was one of the decoys used to cover the destruction of federal records held in the Murrah Federal Building in Oklahoma City, Oklahoma. These records were soon to reveal the real Bill Clinton, and his and Hillary's evil deeds. To prevent this, Clinton ordered the building destroyed. The truck bomb was only a decoy-a joke on the public, no less. Prior to McVey's death (murder), 3600 FBI files were strangely discovered. In any case Timothy McVey has been silenced as a source of Truth, and Chandra Levy is quite "missing."

[Since it appears that there is little of value in any of these "news items", we wonder if maybe they are not, as they have seemed in prior "Bellringer Updates", hastily snatched potpourri intended as "carriers" of the invective aimed at GCH, GAIA, and Ekkers.]

5. Human Cloning/Stem-Cell Research

The lies about human cloning are again part of the controlled media lies. The question is being raised today of whether or not to clone humans. Such a question becomes ludicrous when it is human clones that are asking the question. Humans have been doing human genetic alterations since the time of Noah, and human cloning has been done for centuries. [How do you suppose BR defines human cloning?] Human cloning

took a most evil turn in the late 1970's when humans began to clone other humans en-masse. It is amazing to me how the controlled media is used to portray story after story, from Clinton's concubine to Condit's adultery, from Elian Gonzolas to the U.S. election fraud, to missile defense and stem-cell research, all to keep the U.S. public mesmerized and focused on negativity; while the real tricks and life-shaping events on Earth Shan go totally unnoticed. My friends, George Herbert Walker Bush was in his clone number thirtyfour [By whose count?] when he left the office of the U.S. presidency. Bill and Hillary Clinton among thousands of our other politicians are human clones walking around and laughing at you, the public, today.

A cloned human has no God-Spirit and, thus no God connection, but does that really matter? Does this fact help to explain why we have such evil in our world today? These cloned human controllers are but puppets, who dance to their snake-head shape-shifting puppet masters, who in turn answer to the most evil energy at the top—God Jehovah Satan himself. The only international space station that exists is in NASA's Hollywood studio, where they "create" the fake U.S. space programming for the controlled U.S. television media. Any time you see a TV news picture of astronauts floating in some space capsule, know that you are looking at a lie. They are floating in an assimilator [?] with man-made vacuum [??] for special effects to fool the people. By Cosmic Law there is gravity in outer space and on all celestial creations of Creator, God Aton of Light. [Which "Cosmic Law" is that, BR?]

7. A Gold-based World Economy

The countries of the world have been slowly but steadily moving back to a hard currency system. They are demanding economic security and a recovery of their wealth and natural resources stolen from them by the World Bank, the International Monetary Fund and the paper system of the Federal Reserve Bank. [Which "countries of the world" are those, BR, we would **like to talk with them.**] The Islamic nations have never been disloyal to the Koran's teachings of a monetary system based upon gold with no usury. The European Union nations established the Euro dollar with partial gold backing. The Euro is the currency to watch because the Euro with its increasing [Really?] gold backing is planned to go on line and trade internationally against the Fed dollar on January 2, 2002. This is pushing the Fed to replace the paper Federal Reserve note with gold/silver certificates. Not until recently could one walk into any Federal Reserve bank and find the tellers knowledgeable of a hard currency change in process. They also are quite aware of their bank having or not having [Which is it?] a gold charter in place.

Banking changes back to a gold/silver standard, as required by our U.S. Constitution, are slowly coming, but the movers and shakers are seldom found within the U.S. banking system. The Controllers are totally angry and have fought hard to stop the change to a gold standard system again. With their passage of the Federal Reserve Act of 1913, they thought they had won the gold war

People constantly ask about the various funding programs. The Farm Claims and various roll programs were valid, legal programs established by many good people with good intent to bring back the wealth stolen from the little people over time by the darkside bankers, attorneys, doctors, politicians, etc. [My Goodness, he has now decreed "various roll programs... valid, **legal...**".] The KZB controllers managed to obtain the invested monies and use them to gain enormous wealth for themselves, but not for the little people. George Bush, Sr., while U.S. President was forced by the legal Congress to provide a way for the Farm Claims to be paid. [Is that in the Federal Register?] Before leaving office he managed to destroy that payment process and steal the money for the Queen of England. Remember that George Bush, Sr. was knighted by the Queen, along with his crony, Colin Powell and they are working for the "Realm." [Guess we were misinformed. We thought it had to do with oil.]

Will these funding programs ever pay out? That is certainly possible. Anything is possible with good intent guided by the wisdom of the Lighted Realms. The right people are needed to work in sequence with the coming banking changes to accomplish the awesome task of funding these many programs. Yes, it can be done. [BR is right about this and, of course, he is helping all he can. Besides GAIA, is there some other program working to accomplish it?]

I ask you, are you deserving of such wealth? What would you do with it? Would you blow the money on your ego, your desire for things, to do and to be "somebody"? Would you use the money to help your family, your neighbors, those whose lives have been destroyed by the darkside forces? Only if you are willing to use such wealth for its intended purpose of bringing balance and harmony to Earth Shan and her people prior to Shan's axis shift, will you be allowed to have it. This wealth is destined for Hatonn's ground crews for Hatonn's people. Ponder that! [We will keep it in mind.]

8. The GAIA Asset Fraud

I have written on this subject before but it is now time to set forth facts once again to clear the smoke screen of words. [That should bring comfort to anyone who might feel confused.]

GAIA, also known as Global Alliance Investment Association, is claimed by E.J. and Doris Ekker to be their Nevada based corporation and to hold legal right to the Russell Herman/V.K. Durham Certificate of Indebtedness of Peru Bonus 3392-181 of May 1, 1875. [Ah, the connections are clicking into place. We have finally arrived at the real message they want to convey. Bad start, however. Have E.J. and Doris Ekker ever claimed GAIA or 3392? How many readers who learned their corporation technology from (the real) Hatonn would believe that? If she took time to consider it, even V.K. Durham would not make that mistake—although perhaps she is not so careful when someone else is doing the dirty work.] The new twist is that now they do not need this "Certificate" (they never had it) and it can be thrown into the garbage because they have "established" direct connections to the gold in the U.S. Treasury. [Most readers will immediately see the problem with that statement—except we have a new allegation re. U.S. Treasury. Actually, what information we have on the subject seems to indicate that there is NO GOLD in the UST.] In the August 1, 2001 issue of Contact: program in the Philippines is based upon this sequence

The Phoenix Project Journal is published an article by Ekker/Hatonn entitled "Rantings and Ravings Are Truly Enjoyable." In this article is reproduced a four page fax from V. K. Durham, signatory-CEO, The Durham Holding Trust, which states V.K. Durham's (Grandma Herman) claims of fraud by the Ekkers in basing the GAIA program upon "Bonus" 3392-181. [Does CONTACT'S publishing V.K.'s claims make them true?]

The present saga originates with George Bush, Sr., Russell Herman, and others, who at that time were involved with the CIA shenanigans in Southeast Asia, some twenty plus years ago. Herman gained legal possession of "Bonus" 3392-181 [How?] and agreed to hold it for later "government" use. [What a naïve and misinformed statement. V.K. will have a fit over that one. It was a BEARER BOND. This poor child has no idea of what he is pontificating upon.] Realizing that this "government" use was for evil intent, Herman had a change of heart and with the help of his wife, Katherine (V.K. Durham) created a will which designated the gold of "Bonus" 3392-181 for use by their home state of Illinois, all 50 states of the U.S.A., and also to all countries of the world to counter the One World Order. George Bush, Sr. and Company were furious and quickly laid plans to destroy Russell Herman and V.K. Durham and take back [How could they "take back" something they never had?] "Bonus" 3392-181. As you will recall George Bush, Sr. was head of the CIA and later by treacherous means became U.S. President. [What happened to 3392 in 1989?]

The *Contact* newspaper became involved because at that time it was an instrument of Truth and was revealing the lies of George Bush and Company, the Truth about Sadam (sic) Hussein, the Gulf War, arms running, drug dealing, oil stealing, gold stealing, etc. At that time the Hermans were on friendly terms with the Ekkers and the Contact staff and included 40 million dollars in their "Bonus" will for the *Contact* newspaper. [Now it begins to look as if V.K. wants to "hang her hat" on the "will". Strange that both she and BR underline the word for emphasis. The "Certificate" was declared "lost or stolen" by Russell Herman in August 1989 and the Peruvian Consulate in Los Angeles reissued it as a contract/jurat of **IDENTIFIABLE OWNERSHIP to Cosmos Seafood** Energy Marketing Ltd. End of Certificate. Doesn't anybody remember Cosmos? Seems to me V.K. was the one who started all the Farm and Land Claim stuff—at least she was proud enough about it at the time. I thought all of those marvelous deals, Green Light and so forth, were based upon her "constitutional studies". How come she is trying to distance herself from all of that now?]

Russell Herman died a horrible death at the hands of George Bush, Sr. and Company. During this same time George Bush, Sr. laid plans to destroy the Contact newspaper to stop the Truth being put against him and his "New World Order" by one receiver for Gyeorgos Ceres Hatonn, namely Doris Ekker, of Tehachapi, California. George Bush, Sr. knew that Contact needed money badly to survive. While Russell Herman was an invalid under the care of his nurse/wife V.K. Durham, Bush had Herman cloned. Arrangements were made for cloned Herman to meet with Rick Martin of Contact and to sign over Russell's "portion" of the "Bonus" 3392-181 to Martin. This was done and Martin signed such responsibility immediately over to GAIA held by the Ekkers. Ekker's claim to fame for funding of the GAIA

cloned. That does not matter because they have purposely ignored other important facts. I shall state some of them as follows. [Now there is a paragraph that is a challenge to straighten out. If you think Russell was ever "under the care of his nurse/wife V.K. Durham" you are misled. When Russell needed care he was hauled off to the VA hospital. That is not hearsay. If Bush had Herman cloned it would have been to keep the real Herman alive. The assignment from Cosmos to Rick was dated August 5, 1993; Herman was in good shape at that time and died more than a vear later. True to his authoritative affectation. BR uses the word "immediately" referring to Rick's assignment to GAIA. That assignment is dated April 28, 1998. That is a pretty good example of the accuracy of the rest of BR's (or V.K.'s) self-serving pontification. Since BR is such an authority on cloning, we would be curious to know his conclusions regarding the validity of the dozens of signatures of George HW Bush affixed to legislation, treaties, and executive orders in any one or more of his purported 34 clonings. It appears the legal expert, V.K. Durham, wishes to cast doubt on the Cosmos assignment to Rick by saying it was done by the clone of Russell. Should we not ask, then, which George Bush owns Barrick and most of Bahrain? Does she not claim that Bush used 3392 to get the money to buy those?]

Fact One: Russell Herman was legally married and remained so until his death. His legal wife, V.K. Durham, holds the original marriage certificate in her possession, even though George Bush, Sr. and Company had such records expunged from the Illinois courthouse. [Really? She told us a lot of different stories about their marriage certificate but what about Social Security and his many pensions? Bush must have sheepdipped him while he was cleaning out the "Illinois courthouse". Illinois courthouse? Where is that? Do you suppose Bush could find it?]

Fact Two: The Russell Herman/V.K. Durham will was created with two signatures and four seals. No part of the will ("Bonus" 3392-181) could be executed by one signatory until the death of one of the two signatories, at which time the entire will transferred to the remaining signatory by power of attorney. [The assignment to Rick was from the corporation by Russell Herman, the original incorporator of Cosmos Seafood Energy Marketing Ltd., more than a year prior to the taking effect of the will. Russell could have changed his will up to August 29, 1994—so what was done by the corporation was in no way dependant upon two signatures, four seals, or a partridge in a pear tree. Those are simply wishful thoughts of V.K. Durham. In our investigations over several years (since 1993) we have come across some anomalies—all on the part of Ms. Durham. We can save them for later.]

Fact Three: At no time prior to Russell Herman's death did the Hermans legally execute any part of the will involving "Bonus" 3392-181 with both signatures and the four required seals. Therefore, any dealings that Russell Herman (cloned or otherwise) may have had with Contact and GAIA via Rick Martin is moot. The Ekker's claim that GAIA has legal access to the wealth of "Bonus" 3392-181 is absolutely groundless. [Have we ever made such a claim?] The Ekker/Hatonn energy keeps assuring everyone who will listen that GAIA's connection to the "Bonus" 3392-181 wealth has been validated by George Bush, Sr. and verified by the "Fed",

of events, though they do not believe that Herman was CIA, IMF, and World Bank. Guess what? my friends. These are all darkside entities and all working together to trick the Ekkers. Let us send Love and Light to Doris and E.J. that they awaken to Truth and act in wisdom before they and their GAIA program are destroyed by George Bush, Sr. and the One World Order Company. [Well, maybe we are getting somewhere. I seem to see a crack in the Bell. Sounds to me like a bit of waffling to make sure that if he is wrong, or has had bad advice, he might have a chance at recovery.]

> GAIA is like the train in the following analogy. You can build a train-track and you can build a train to run on it, but unless you also build a bridge across the canyon and make proper connections to the main line, neither your train nor your train-track will do you much good. The Ekkers never made the proper connections to legally fund their GAIA program. Yes, George Bush, Sr. proved the value of "Bonus" 3391-181 by using it for his "Super-fund", illegally! Do the Ekkers anticipate doing the same thing? George Bush, Sr. accomplished his goal of stopping the publishing of Truth through the Contact newspaper from Gyeorgos Ceres Hatonn via the fake GAIA funding. The receiver, Doris Ekker and her husband, E.J. Ekkers (sic) were enticed to go to the Philippines in search of unsuspecting goyim, who desperately needed the financial assistance that the GAIA program claims to have available. [As Dale Carnegie would say, "Fantastic!"]

> Fact Four: V.K. Durham/Grandma Herman as sole signatory, now holds the complete authority for any funds to be legally released from "Bonus" 3392-181. She is not helpless and powerless and living in some nursing home as claimed by Ekker/Hatonn, nor is she a mean and miserly old woman. [Where from would come such drivel as that?] At one time Ekkers via Rick Martin had asked V.K. Durham for financial help for the Contact newspaper and for their some fifteen survival projects. [Was that at the same time that we were gathering money from any corporation that had some to support V.K. to the tune of some \$3000 per month?] V.K. responded by making an assignment to them of \$10 billion. They sent Rick Martin back to V.K. with a request for five additional assignments of \$10 billion each. This V.K. granted with the stipulation to use the money for the intended purposes within one year. Greed and power-playing on the part of Ekkers and Company burned up the year, so that all six assignments of \$10 billion each were lost to them when V.K. withdrew them at the end of the stated year. [The people that witnessed the V.K. Durham assignments to Hellenic Express would not agree with the above but we will not make corrections at this time.] Needless to say, those of us who read the fax exchanges between V.K. Durham and Doris Ekker during that period of time were quite shocked at the ability of these two women to exchange such hostility, vulgarity, and hatred for each other. This was a grand demonstration of how the ego can take control and allow greed to demand power and control over another. [Show us one, just one, such fax from Doris. We have saved a lot of them from V.K. that practically drip venom but you will not find one such from Doris. That is just one more manufactured-from-nothing lie for which you, BR, will some day be obliged to answer.]

> George Bush, Sr. and Company have failed to "take out" V.K. Durham, and have also failed to gain legal authority over "Bonus" 3392-181. So what is all the fuss about "Bonus" 3392-181? Suffice it to say that the U.S. Treasury, under the Marshall plan, agreed to assume Peru's

plan? When was the Marshall plan? When was the assumpsit? With boners like that, how can anybody believe anything this guru proclaims?] The accrued interest back to 1875 on "Bonus" 3392-181 amounts to many trillions of dollars, payable only in gold. To demand such payment would break the Federal Reserve Bank and crash the world's economy. What connection does all this have to the plan to move the international banking system onto a hard currency by year's end? [Which year?]

Financial authorities [What Financial authorities would those be? Ed Young and Rick Martin hardly qualify—and neither does V.K.. If you cannot identify the source, you will have to withdraw the accusation. (We might as well consider it withdrawn, BR would not have the intestinal fortitude to admit an error.)] within the U.S. claim that the Ekkers fled to the Philippines to avoid the fraud charges and arrest warrants brought against E.J. and Doris Ekker for their misuse of Phoenix Institute funds. Should some "sucker" or "gold fish" swallow the GAIA gold fish line—"hook, line, and sinker"—, there could be additional fraud charges brought against the Ekkers. It is fraud to deliberately and illegally use someone else's money. [What does that statement have to do with anything? Here we see another of BR's authoritarian 1/3 truths. Does he speak of fraud or theft? He really doesn't know, does he? But the attempt to cast aspersion and vilification remains hanging in the air. Well, this time let's see if we can blow it away. Corporations made loans to Phoenix Institute. Repayment depended upon two conditions: gold doubling in price from the time of the loan, and repayment being asked for ("demand" made). How would it be possible for Phoenix to use the money, for which it has become solely responsible, illegally in relation to the Lender?] If the game is stopped, the Ekkers could become people without a country, and as Doris loves to say, with no place to go and no where to hide.

My intent is not to bash the Ekkers or their GAIA program per se, but to give warning to unsuspecting participants and to those waiting at home for their "carrot on a string" to chose wisely. The Ekkers claim that there are more than 1500 GAIA Assignment of Deeds against "Bonus" 3392-181 for various projects by individuals, organizations, and countries around the world. If this be true, there are probably many good people and projects that will be seriously hurt or destroyed should funds fail to arrive. [What a generous and altruistic attitude. Perhaps we have misjudged BR. All this time we presumed that he was writing all of these rotten things about us in an effort to make sure we could not succeed. Now it turns out he is only trying to protect all those many good people, organizations and countries around the world that might be hurt if the funds do not arrive. Now if we should, despite all of his efforts to derail us, succeed, should he not be included in that success? After all, his intent was not to bash us.] Why do you suppose that after more than two years of offering the miracle GAIA program to the world, not one person has yet stepped forward and taken the prize presented by the Ekker's GAIA program? [BR's bashing and trashing has, of course, been very helpful in establishing the kind of sterling reputation needed to accomplish this job. The Spectrum group have been helpful, too. The real reason, however, and this will not be lost on our loyal supporters all over the world, debts, including "Bonus" 3392-181. [Under the what is that God is doing his sorting and we are

adversary's team expose yourselves. We are freezing to death. What do you believe? not under any pressure—but you are.]

Contact and be interrupted by the Ekker/Hatonn energy comments which skew the Truth to focus upon yet another attack against the Spectrum paper or staff, some past associate, or attorney or judge or Bellringer, etc. Someone asked, "Should you not forgive what is past and move on?" The Ekker/Hatonn energy answered (paraphrased), "No forgiveness, never! We must constantly confront these evil ones." [Just who was it that asked the question? BR's "paraphrase" takes a lot of license. The answer, as I recall, was the same as it always has been: No forgiveness without restitution. Restitution would include apology and a restoration of reputation, if that were the situation.] Judge not, lest you become both judge and jury. The way you judge others is the way you will be judged. You shall most certainly reap that which you sow. [Wow! I sure wish I knew a word bigger and stronger than PONTIFICATE.]

A bridge must be built across the canyon to legally connect GAIA and the Ekkers to V.K. Durham's "Bonus" 3392-181 or to some other source of funding. Without legal connections to adequate funds with good intent, the Ekkers/GAIA gold train is going nowhere. Let us petition the Lighted Realms and God Aton of Light that help arrives in time to bring balance and harmony to the GAIA fiasco. 9. Earth Changes

The lying media today is keeping the people focused upon the supposed environmental problem of global warming due to the Green House Effect. The theory is that air pollution from industry and internal combustion engines; etc. causes a layer of gases and pollutants to form high in our earth's atmosphere. Our earth is warmed by sunlight energy which changes to heat energy when it strikes the surface of an object which does not reflect the light or allow it to pass through. Heat generated in this manner warms our earth and its atmosphere, and gradually dissipates into outer space. Air pollution, supposedly, traps heat from being dissipated (like greenhouse windows, thus the "Greenhouse Effect) causing a warming of our atmosphere and earth climate. This warming supposedly causes greater evaporation of water, increasing the expansion of desert areas and the melting of our polar ice caps, among other effects. The melting ice "creates" more water, which supposedly will cause the ocean level to rise and inundate our coastlines. Scientists claim the end result to be our drowning or being cooked to death by the heat. Other scientists claim just the opposite effect. The layer of pollutants and gases high in our atmosphere will reduce the amount of sunlight passing through and reaching our earth's surface. Less sunlight results in less heat being generated and again the end

There are a couple of things we noted about these entries: 1) on the writing of "Catherine" there is very definitely a writing of a "C" OVER what was begun as a "K".

2) It also appears that "Russell" was accidentally started with a "D" and corrected by a downstroke into an "R".

This was then copied and recorded with the Office of County Clerk & Recorder, Washington County, Nashville, Illinois by Thomas Ganz, County Clerk & Recorder and on Ganz stationery is the following: "October 17, 1994. This is a true and correct copy taken from the Family Bible of Russell Herrmann/Herrman/Herman and V. Catherine Bible date showing October 27, 1987 witnessed by A. Nicholaw. [Exact copy]

"The marriage was reconfirmed on December 2, 1998 in Washington Co."

These documents were faxed to us at CONTACT of there not being a certificate of marriage. This was to somehow prove that Russell and Catherine (where comes from the "K"?) were actually married. She said she could not prove that she was married long enough to collect on his Social Security—for that would require over nine months married. It gets crazier.

Hello, my friends, this is Dr. Beter. Today is May 28, 1977 and this is my monthly Audioletter No. 24. This issue concludes the second year of the Audio-letter. But only if we are blessed by a true miracle, will the third year ever be completed, because as I speak to you today a tragedy has already been set in motion that is beyond human comprehension. Not since last July and August, 1976 when the Soviet Union began planting underwater bombs and missiles in our own territorial waters, has the situation been so grave and urgent as it is now. For that reason I will dispense with any further introduction today in order to discuss these three topics: Topic #1—The Fall of Babylon Revisited; Topic #2—The Handwriting On The Wall For America; and Topic #3—WATER, THE ULTIMATE WEAPON.

Topic #1—We live today in a world that grows more complex and more confusing with each passing day but, in spite of that, we Americans are fond of praising ourselves for the great man-made wonders of our age. And whenever the obvious dangers to our continued existence as a nation prey on our minds, we are always reminded that we, the great United States, have already survived fully two centuries since our Republic was founded. And scarcely a day goes by that we are not reassured by our rulers, elected and otherwise, that we are the mightiest nation on Earth. Our technology, we are told day in and day out, is so wonderful that it is impossible that any other nation on Earth, especially the poor, backward Soviet Union, might surpass us in any important way. In other words, we are technologically impregnable. And lest we become prematurely concerned over the impact of the recent radical changes in our weather, certain news reports recently have told incredible lies to the effect that the United States has a two-year surplus of grains in our storage bins. In all of this, the behavior of the United States today is like that of countless civilizations before us—just before they perished. And in some respects the greatest similarity of all is with that of ancient Babylon just before its abrupt fall from power. The origins of the United States, unlike Babylon, were strongly moral and spiritual in content, and the system of government set forth in the United States Constitution, which freed men in a way unparalleled in human history, was conceived by men who understood man's place within God's Creation. This heritage still lives today in the hearts of many Americans, but it's rapidly being snuffed out under the bondage of rulers who are superimposing the pattern of ancient Babylon on our beloved land. The Babylonian pattern is totally evil, and those who choose to bow down to such Satanic rule thereby make themselves part of it. The origins of ancient Babylon are lost in the midst of time, perhaps 5,000 years ago, but

it reached its peak around 600 B.C., at which time it was undisputed as the most powerful empire the world had ever seen. The City of Babylon was the Rome of its day, the most important trading center, the most powerful military force, the greatest cultural influence, and even a center of tourism because of its remarkable hanging gardens and other man-made wonders. The huge city of Babylon was surrounded by city walls so high and so thick that they were impregnable by any military technology of that day; and inside the city there was a two-year supply of food, making any attempted siege against Babylon unattractive. And there was no lack of water either, because no less than the mighty river Euphrates ran through the city. Yes, Babylon was powerful, wealthy, and so secure in material terms that potential adversaries were hardly even taken seriously. Even when it became clear that the increasingly powerful joint empire of the Medes and the Persians had designs on Babylon, there was no real concern. With all their means of protection against invasion and their unrivaled prosperity, the Babylonian attitude was simply "It couldn't happen here." And so when the Medo-Persian army of Cyrus and Darius laid siege to Babylon, the only response of the ruler of Babylon was debauchery, feasting, drunkenness, and mocking any real power greater than himself. At this point, we're told, the Babylonian feast was interrupted by the appearance of a hand in midair writing words on the wall that said Babylon's rule was at an end, that its ruler had been weighed in the balances and found wanting, and that the kingdom would be divided and given to the Medes and Persians. The handwriting on the wall said the impossible was about to happen—Babylon, the impregnable city, was about to fall. How could this be? No one in Babylon had ever had experience with invasion and so could not imagine such a thing; and yet, within a few short hours, before the drunken feast even ended, the impossible happened. First, the water level in the mighty Euphrates River, flowing through the middle of Babylon, started dropping rapidly. It dwindled to a trickle, and soon stopped altogether. Cyrus, the Persian, had worked out of sight of Babylon and had diverted the Euphrates out of its normal channel. Now the great impregnable walls of Babylon were left with huge openings—namely, the river bed no longer filled with water, and in marched the Medo-Persian army, conquering Babylon without resistance. And today, the United States is under siege by the Soviet Union with the cooperation from within of quislings. We are threatened by the joint Rockefeller/Soviet empire just as Babylon was besieged by the joint Medo-Persian empire. And now, as then, we are told there is nothing to worry about, "It just couldn't happen here." But, my friends, just as happened in ancient Babylon, the handwriting is now on the wall for America. The America we know today is a perversion of the pattern originally laid down for our beloved land—and America as we know it is about to come to an end. And as with ancient Babylon, WATER is our Achilles heel and the means by which we are to be reduced to surrender without a fight.

Topic #2—Not long ago the Carter administration's Ambassador to the United Nations, Andy Young, made the remarkable statement that: "Communism has never been a threat to me." He also has a habit of patting Cuba on the back for the so-called 'stabilizing influence' of Cuban troops in Africa, and otherwise has repeatedly shown a very amiable attitude toward World Communism. Many Americans have wondered why Andy Young is allowed to go on saying such things without being restrained in any way by Jimmy Carter. But Carter has now answered that, in a major foreignpolicy speech given at the University of Notre Dame on May 22, 1977. This speech is as important as the famous Iron Curtain Speech of Sir Winston Churchill a generation ago at Fulton, Missouri. White House aides stated that the Carter speech at Notre Dame was specifically intended to "send some messages to foreign governments"—and it did. The foreign press is filled with headlines about the major turn that has just been taken in American foreign policy. Yet, here at home, many Americans have not grasped what has happened. The most basic theme of that Carter speech is an elaborate echo of Andy Young's statement, that is: "We are no longer afraid of Communism." Is this because Communism is withering and dying? One need only look at a map to see how fast Communism is eating up the world. What Jimmy Carter is telling us and the world, is 'We can get along with Communism'; and just to prove it, one of America's most important, efficient intelligence operations to keep an eye on Soviet naval movements and other important matters is being closed down. This intelligence unit, known as Task Force 157 and run by the United States Navy, has a budget of well under 1/10 of 1% of that of the CIA, and yet it is being shut down—supposedly for budgetary reason. Meanwhile, the signs of war to come are all around us. So great are the dangers facing us that military men are speaking up in increasing numbers in an effort to warn America before disaster arrives. Since they are subject to military law and subordinate to civilians who do not want them to speak up, it's no small thing to speak out in this way. So, consider what Major General John K. Singlaub said in an interview on May 19, 1977. General Singlaub, the third-ranking U.S. Army General in Korea said: "If we withdraw our ground forces on the schedule suggested, it will lead to war." And why did General Singlaub speak up? His answer was: "The question asked after United States setbacks in Korea and Vietnam was: 'Did the military people in the know express themselves loudly and clearly enough that the decision-makers understood?' We want to make sure." In speaking this way, General Singlaub was doing no more than expressing the consensus of practically every knowledgeable military man about the Korean situation. For example, the same Washington Post article that quoted General Singlaub also quoted another headquarters Army officer in Korea as saying about the Carter plan to withdraw our troops: "I don't know anybody who is not staggered by it. There's no military or strategic logic for withdrawal." The plan to withdraw from South Korea, in other words, is strictly political—in line with the newly-announced American foreign policy that it is no longer afraid of Communism. The reason General Singlaub's words had such an impact in this country is that his name was attached to his warnings. The words I just quoted from the other anonymous Army officer are just as startling as what General Singlaub said. But people will just read those words once, frown, and then forget about it. But everyone knows about General

he allowed himself to be identified as the source of the warnings; and, for daring to warn us, he was promptly relieved of his Korean command by Jimmy Carter. The situation in Korea illustrates the direction in which events are now moving, but other events are due to occur long before the pullout of our troops from South Korea. The real threat to our security is no longer in Korea or in Europe but right here in our own backyard.

Another military man who is actively trying to warn America is Major General George Keegan, who retired at the beginning of this year as Chief of Air Force Intelligence. General Keegan is one of the West's greatest intelligence analysts—and the story he has to tell should be continuous headline news throughout our nation. General Keegan has been speaking on radio and television talk shows, giving speeches, accepting interviews—in short, using every channel open to him in an effort to wake up America before it is too late. One of his most comprehensive and important speeches was the one delivered on March 11, 1977, at a press conference sponsored by the American Security Council here in Washington, D.C. To find out in more detail what General Keegan had to say, I would urge every American to obtain a copy of that speech. Write to the American Security Council, Boston, Va., 22713 for information. It was published as the April 1977 Washington Report of the American Security Council.

We're frequently told by syndicated columnists that the CIA is our first line of defense, but General Keegan said in his speech: "The ultimate function of a nation's intelligence is to render carefully assessed judgments and forecasts regarding the threat. When I look back upon my experience with this nation's highest estimating body, I have the impression of having taken part in a Charles Dickens novel. The sense of make-believe and unreality has to be experienced to be believed." Further on he says: "The intelligence estimators, heavily dominated by the CIA and the State Department, have been wrong about Soviet purposes in pursuing detente. They have been shockingly deficient in their estimates of the risks and the advantages to the United States and the free world of the so-called technology exchange with the Soviet Union." And he adds: "If there has been a Watergate in this country, and there has been, but ignored, it has been in the monumentally incompetent judgmental processes of this government regarding the nature, character, and growth of the Soviet threat as it has evolved from year to year." General Keegan goes on to make crystal clear that the deficiencies in our intelligence estimates are not due to any lack of our ability to collect information or to analyze it technically. The problem, instead, has to do with what is done with that information. To begin with, the intelligence estimation process at the highest levels in America today is not objective, but is manipulated to fit political purposes. In General Keegan's words, and I quote: "The United States intelligence estimative process cannot be understood unless it is first appreciated that national intelligence estimates must perform three functions. First, they must support the decisions of the President, both for the record of history and for the avoidance of impeachment. Second, they must substantiate or help to justify the decisions of the White House 'Office of Management and Budget'. Finally, the intelligence estimates must, whatever other purpose they may serve, rationalize the foreign security policy initiatives of the Secretary of State." Continuing, General Keegan says: "I appreciate that those are extremely important allegations

Singlaub's warnings because, deliberately or otherwise, to make, but I submit to you today that it is not possible that I discussed with General George S. Brown, to understand the workings of the United States intelligence community unless one is willing to open his mind to the influence of those three factors." This situation is illustrated vividly by General Keegan's discussion of the controversy over the Soviet Back-Fire Bomber. As I've told you for many months, the Supersonic Back-Fire is an inter-continental strategic bomber, capable of striking the United States with nuclear weapons. General Keegan says: "The central issue all along has been whether this bomber posed a threat to the United States. The Soviets argued that it did not and the CIA and State Department rather consistently accepted the Soviet point of view." General Keegan proceeded to acquire analysis of the Back-Fire's capability from "the most competent analysts in the free world". The available intelligence information was provided to three American aircraft companies with than there is time to discuss in this tape, and they're all experience building strategic bombers—plus, for good measure, the Royal Air Force and the Royal Aircraft establishment in England—and the results: "every single one of these organizations independently agreed that the Back-Fire had an intercontinental capability. Yet my word was not good enough, nor was that of the American and British heavy-bomber designers and builders. CIA and State chose to believe the Soviets." General Keegan is not in a position to express it this way, my friends, but his description of the Back-Fire controversy illustrates what I've been trying to tell you over the months—that the Rockefeller cartel has more faith in the Soviet Union than in our own United States. Finally, General Keegan explains, the sheer weight of analysis made it more and more apparent that the Back-Fire was truly intercontinental: "However, CIA and State now judged that the Soviet Union had no intention of using the Back-Fire as an intercontinental bomber"—this in spite of the fact that the second model of the Back-Fire has been given even greater range. The history of the Back-Fire controversy up to this point is very disgraceful, and still generally unknown to the American people. But listen now to the final chapter in General Keegan's words, and I quote: "Seemingly undaunted by the most extensive analysis of a foreign bomber ever performed in the United States, the CIA, in one final, super-secret, uncoordinated effort, proceeded over a period of 18 months to undertake an analysis designed to prove that the Back-Fire Bomber could not reach the United States. This effort, in which small bits and pieces of controlled information were provided to McDonnell-Douglas Aircraft, designer and builder of fighters, represents one of the most artful contrivances I have ever observed. It is one which I suspect may have been designed to salvage a SALT accord. Finally, when the CIA surprised everyone by surfacing its new analysis, months of painful and extensive analysis were required to show that the books had been rigged. Artificially high G-loadings had been assigned to the design of the Back-Fire along with excessive engine-drag and other factors which were designed to reduce range." And this, my friends, is how our so-called first line of defense, the CIA, looks after America's national security to the tune of over twenty billion dollars a year.

> Elsewhere in his talk General Keegan also spells out the dangerous manner in which our military intelligence capabilities have been progressively over-centralized, compartmentalized, and taken over by civilians "who understand little about the horrors of war—and these are people who understand even less about military doctrine, strategy, and weapons". The product of all these trends described by General Keegan is the very intelligence gap

Chairman of the Joint Chiefs of Staff, when I met with him last September (1976). For years General Keegan has tried in vain to obtain a series of post-mortem audits on the predictive and estimative record of the United States intelligence community. The audit would be performed by qualified but disinterested outsiders with no links to the intelligence community so that their work would be unbiased. Quoting General Keegan again: "Such audits would record scrupulously where we had been wrong, where we had been right, where we had fallen short of the mark or where we had exaggerated. Yet, every such suggestion had been met with disdain and has been resisted in the most resounding vocal and emotional way." He might as well have asked for an honest audit of Fort Knox.

General Keegan's speech contains many more things important. He reveals many things about the military capabilities of both the Soviet Union and the United States that you will never hear through the usual news channels—but they all boil down to just two major conclusions, backed up by many, many facts. One conclusion is that Soviet military capabilities vastly exceed what we are being led to believe, both in terms of quantity and quality. The other conclusion is that the Soviet Union is firmly convinced that a nation can fight a nuclear war and continue afterward as a functioning society; and based on that conclusion from a Soviet study undertaken after World War II, the Soviet Union has for more than 20 years been preparing militarily to fight and win a nuclear war. The American approach, on the other hand, is only to deter such a war, even though General Keegan says: "I am unaware of a single definitive effort ever conducted by the United States to determine precisely and in great detail what it would take to deter."

General Keegan also explains another very important principle—it has to do with official judgments of the strategic balance and carries over into public pronouncements by the Pentagon. This is the tacit rule requiring the use of so-called 'agreed national intelligence'. Says General Keegan: "Agreed national intelligence is derived by committee, contains little that is controversial except in some footnote or dissent; and it rarely contains meaningful reference to the dynamics of strategic competition in terms of the new weapons, new forces, and new capabilities being evolved by the Soviet Union." Thus, whatever new threats are involved, whether it be the awesome particle-beam weapon warned about by General Keegan or the Soviet underwater missiles I've been warning about for nearly a year, Pentagon disclaimers dare not be accepted at face value today without challenge. Those who accept these denials are playing straight into the hands of our nation's deadliest enemies.

Meanwhile, the build-up toward the start of Nuclear War One is gaining momentum. Two months ago Nelson Rockefeller visited Israel to help speed up the preparations for a Middle East war. By mid-April, Israeli troops had begun massive maneuvers in the Sinai with live ammunition, reserves had been called up, and Egyptian maneuvers were soon underway as well in the western Sinai. These maneuvers, headline news in Europe and Britain, have gone unmentioned in the United States except for the crash in the Sinai of a huge helicopter killing 56 Israeli soldiers. Then just a few days ago the extremists came to power by way of the recent Israeli elections. The Middle East is now a powder keg as a result—and the Carter administration is

So, when the nuclear strike from the Sinai against Arab oil wells takes place, it will not be recognized by the world or by most Americans for what it really is. Perhaps General Keegan was also right about one other thing he said in his speech: "We have reached a point in America where I believe we are almost incapable, culturally, of being warned." If so, my friends, it is we, the United States of America, who will have been weighed in the balances and found wanting, like ancient Babylon.

Topic #3—When the Sun came up on southeastern Idaho one day almost a year ago, it looked like the start of just another beautiful late spring day. It was Saturday, and two fishermen were looking forward to a relaxing day in the shadow of the new Teton Dam. The dam, over 300 feet high, had been completed the previous fall except for a few finishing touches that remained, and had been gradually filling up with water during the winter. Now, due to the run-off of melting snow in the mountains, it was almost full. Further down stream from the dam, tens of thousands of people were going about their business. Some puttered around their houses doing weekend chores, while others were at work at businesses or on farms; but for the construction crew who arrived for work on the Teton Dam site that morning of June 5, 1976, it was a different story. At about 7:30 A.M. it was discovered that a sizeable leak had sprung, not through the dam itself but through the section of mountain on one side where the dam was anchored. This was reported immediately to the proper authorities, who directed that steps be taken immediately to start lowering the water level behind the dam. Why the leak had appeared so suddenly was a puzzle, since inspection of the dam by personnel around nine o'clock the previous evening had turned up nothing wrong. But there was no time to solve this puzzle, because soon a second leak developed. Like the first, this second leak also appeared to break through the anchoring mountain side, rather than the dam itself. Now the situation began to deteriorate at an alarming rate. Soon a leak found its way through the earthen dam itself, and a growing torrent of water gushed from it. Two bulldozers raced to that location to try to stop the flow by moving more earth into position, but the leak grew so fast that the bulldozers were lost, the operators leaping and scrambling to safety barely in time to save themselves. Like a nightmare come true, the Teton Dam crumbled, collapsed, and released tons of water into the valley below. The day ended abruptly in tragedy for the two fishermen and others who lost their lives as well. For two days, floodwaters from that ruined dam continued to spread, ultimately covering an area of 300 square miles, including several towns and 50,000 acres of farmland. One of the major purposes of the Teton Dam, like many others around our country, had been flood control. Now the man-made flood unleashed by the collapsed dam had caused damage estimated to be in the range of \$350- to \$500,000,000 in addition to the loss of life. The bursting of the Teton Dam provided America with a preview, on a very small scale, of what the Soviet Union plans to do to our entire country.

Last month in Audioletter No. 23 I reported hard intelligence I had received to the effect that 21 major lakes and dams in 10 Western states have Soviet hydrogen bombs planted in them. But the information I gave you then, my friends, was only the beginning. Since recording Audioletter No. 23, I have been under an avalanche of ongoing intelligence reports concerning the ongoing Soviet program of planting nuclear weapons in our inland lakes and reservoirs. I can now reveal that

pace as much as 18 months ago. For example, a Soviet nuclear device was planted over a year ago at a dam known as The Dalles on the Columbia River east of Portland, Oregon, and it is still there now. The Teton Dam disaster appeared to be just a great big accident, but it brought to everyone's attention the fact that dams can be made to collapse under certain conditions and that the consequences are devastating. Meanwhile, the border of Idaho with Canada has become an important entry point for Soviet agents who are bringing nuclear bombs into this country. On Monday, May 16, I received an alert from my intelligence sources that Soviet agents were at that time in the process of transporting nuclear weapons into the Northern United States by truck through several entry portals along the Canadian border. The greatest focus of that activity was at the Idaho entry points of Porthill and Eastport. For the next several days I was in frequent contact with my intelligence contacts in Canada who were taking very definite action to find and stop these Soviet intruders; but here in the United States our attention is being focused on our border with Mexico by the manufactured distraction of illegal immigrants. At the same time, we are undergoing a wholesale invasion along our border with Canada by the Soviet Union and not one thing is being done about it by the United States. By late that first day, May 16, at least 16 Soviet vehicles carrying nuclear weapons were known to have crossed into the United States from Canada through entry portals into Idaho and Montana; meanwhile, 7 more were on Canadian Highway 3 from Vancouver, British Columbia, Canada, heading toward Porthill and Eastport, Idaho, to enter the United States. By that time the origination point in the Vancouver area had been narrowed down to a barge in Horseshoe Bay. The Canadians took care of the situation on their side of the border by stopping and inspecting trucks in the appropriate area—and by early May 18 all seven trucks driven by Soviet agents had been stopped and rounded up just short of the border. At that point, however, their next step was to wait for further instructions from Ottawa—and I have not yet been informed as to what further action was taken. Meanwhile, the only public hint of what was going on was contained in a short item printed in Vancouver newspapers on May 19. It stated that trucks were being stopped and searched along Route 3 but did not give the reason. For my Canadian friends, now you know! But Soviet Union empires, the Rockefeller brothers still want it was a different and sad story here in the United States.

The Federal government is taking no action whatsoever, proving that there is a continuing collusion between the Rockefeller empire and the Soviet empire. At the State level, one would hope that the chances of obtaining action would be a little better, but so far that has not been the case. Concerned citizens who have tried to bring my warnings to the attention of their Governors and other high State officials have encountered basically two reactions—one is that "This is something for the Federal government, so we'll refer it to them"; and of course there it ends. The other main response is to the effect: "Naturally, even if we did find a bomb in the lake next to the dam, we would not make it publicafter all, we don't want to excite the people." But, my friends, that is like an air raid warden refusing to turn on the siren during an attack because it might frighten people. At the local level though, one would hope that some action could still be expected, but no; during the period of May 16 I tried in every possible way to get local and state police in northern Idaho to simply check out some very specific reports I had been given, but to

rapidly disengaging and disassociating itself from Israel. this Soviet program began at a relatively slow, careful no avail. Several Soviet trucks were known to be heading southward in northern Idaho toward the town of Sandpoint—and I was informed of the approximate positions where it should have been possible to intercept them on the highway; but when I relayed these reports to State and local police in the area, both directly and through a brave local citizen in that area, it turned out to be impossible to persuade them to take action. As one police sergeant told me, "We're wondering why the Federal government hasn't stepped in on this." And since they had not, even after being notified, the assumption was that there must not be anything to it; therefore, it was not even going to be investigated. And so there, my friends, is a part of the handwriting on the wall for America.

Most all Americans have been tricked into accepting the idea that only the Federal government counts or is able to do anything, even though this idea is totally alien to our Republic as originally founded. All the Federal government has to do is not act—or to remain silent about a matter, such as Soviet missiles in our watersand people conveniently leap to the conclusion that there must not be any missiles. As General Keegan says, we're becoming incapable of being warned; and, my friends, if we don't snap out of it, we will suffer horribly. The fact that something was afoot in the area of our nation's water supplies should have been realized four years ago when Nelson Rockefeller started his "National Commission on Water Quality". This he started at the same time as his much-better-known "Commission on Critical Choices for Americans". And just as the Commission on Critical Choices was absorbed into the Federal government in everything but name, the same was done with Rockefeller's Commission on Water Quality. But even if it was clear that water was to become a political tool in some way, I doubt that anyone in his worst nightmares imagined what was actually afoot. Over the past several years, Federal and State water quality control boards have built up a comprehensive and up-to-date picture of our nation's water resources and requirements—and all this data has been turned over to the Soviet Union! So now, the Soviets know exactly where and how to strike at us through our Achilles' heel of water, just as the Medes and Persians were able to calculate how to attack ancient Babylon through its water source.

In the alliance between the Rockefeller and the to rule the American continent under complete dictatorship; and the Soviets still want America to become their complete satellite—a nation of slaves. But the Rockefellers realized long ago that this country could not be brought under the total control they desire without the benefit of crushing disasters to force us into that mold. And the Soviets for their part realize that to extract the benefit from America that they seek, it is not enough simply to conquer us in war. Afterward, there must be a core of turncoat managers, quislings, to run America for them. Soon, the Rockefellers expect to obtain the "Declaration of National Emergency" that they want in response to events which can be triggered by the Soviets. The Declaration of National Emergency, they believe, will make their dictatorship all but complete. At the present time the Soviet Union has at least 158 underwater missiles in our territorial waters along our coastlines. In addition, the Great Lakes now bristle with smaller, single-warhead Soviet underwater missiles—a total of 53 as of my latest information. The fact that the Soviet Union has been able to invade the Great Lakes and place missiles there is shocking; and it is even more

over the United States, unhampered, to sow seeds of nuclear disaster throughout our land. It's hard for most people to imagine how such things are possible; but as I know from my own sources, they are being facilitated from within our country. For example, one of the key steps which has been taken by the Carter administration to permit these things recently was publicly confirmed by former Congressman John Rarick of Louisiana. Congressman Rarick publishes a very informative monthly newsletter entitled You've a Right to Know, about which you might write to him at: Drawer E, Saint Francisville, La. 70775. Quoting from his March 1977 issue, "The Soviets are hauling United States cargo in intra-coastal shipping illegally against the provisions of the Jones Act. Russian vessels can be seen in the river loading from barges, and also unloading on two barges, as if they constitute an integral arm of the United States Maritime Service. Barges loaded by Soviets have been followed up the river through inland waterways and small canals to where their cargoes have even reached the Chicago market." Congressman Rarick further reports that the Soviets are able to get away with this because Secretary of the Treasury Blumenthal waived the provisions of the Jones Act as applied to Soviet vessels. Thanks to such generous help from within, the United States has been thrown wide open to offensive Soviet actions. As a result, the planting of nuclear devices in our inland waters—rivers as well as lakes and reservoirs—is mushrooming at a tremendous pace. To begin with, additional bombs have been planted in some of the huge dammed-up lakes that I named last month. For example, Hoover Dam had one bomb when I recorded Audioletter No. 23, but now it has 3—one next to each end of the Dam itself, the third upstream some distance from the dam. Another example is Oroville Reservoir in California. Last month it had one bomb, now it has 4. But more serious than this overkill of a few dams is the vast number of targets throughout America where Soviet bombs have been and are being planted. City water reservoirs of any significance throughout America are targeted. Many already contain bombs, while others are scheduled to receive bombs from the many trucks fanning out across America with Soviet agents at the wheel. Flood control, irrigation, and hydroelectric dams of all kinds are targets as well; and major rivers are also being seeded with bombs at strategic points.

To indicate the magnitude of the Soviet attack plan, I will report the current status of just one state—Texas, which is a major target. As of my latest intelligence, over 100 bombs have already been planted in Texas; and I have been provided so far with a partial list that specifies 33 of the lakes involved. These are: Toledo Bend Reservoir, Sam Rayburn Reservoir, Steinhillyers Reservoir, Lake Vernon, two lakes northeast of Houston which provide water for the city, Conroe Lake, Somerville Reservoir, Lake Waco, Lake Whitney, Malakoff Lake, Frankston Lake, Lake Livingston, Millwood Reservoir, Lake Texarkana, Lake O' the Pines, Cedar Lake, Lake Tawakoni, four water reservoirs for Dallas and Fort Worth, Lake Texoma, Arbuckle Reservoir, Lake Bridgeport, Hubbard Creek Reservoir, Lake Kemp, Lake Arrowhead, O'Folla Reservoir, San Angelo Reservoir, Twin Buttes Reservoir, Lake Thomas, and White River Reservoir.

A number of rivers around the country are also known to be involved already. These include the Mississippi, the Missouri, the Illinois, the Ohio, the Columbia, the Potomac and the Susquehanna. In the Mississippi River alone there are already 31 bombs located near dams, and locks, and

But a horrendous new capability is now in place as an alternate means for creating our national emergencyand, my friends, there are ominous signs that this capability is going to be used, very soon. Lurking deep in the waters around the Philippine Islands there are now 7 fission-fusion-fission bombs planted there by the Soviet Union. Such a bomb is essentially a hydrogen bomb with a jacket of uranium 238. When it's set off, the nuclear reaction converts much of the jacket material to plutonium 239, which in turn explodes as well. The Soviet Union is the only nation that has ever set off such a bomb—16 years ago on October 30, 1961. In doing so, they set an ugly record that still stands—the biggest nuclear weapon ever fired in the atmosphere. Its yield was something over 50 megatons—that is 50 million tons of TNT-2,500 times as large as the atomic bomb dropped on Hiroshima. Theoretically, there's no limit to the yield of such a bomb, but for 16 years it has been thought of in the West as unusable because it produces such vast quantities of fall-out that it would endanger the country that used it. But the Soviet Union has found a way to use it—deep under the ocean for geophysical warfare in an environment where the radioactive products are relatively confined, producing little fall-out. The Philippines sit like a keystone among a long arch of sub-sea trenches and faults that comprise the most earthquake-prone areas on Earth. Starting just north of New Zealand, a band of geological instability runs northwestward toward the Philippines, then northeastward past Japan to the Kamchatka Peninsula, eastward along the Aleutians to Alaska, and then southward along the West Coast of the United States, Mexico, Central America, and onward all the way to Chile. This long, irregular zone around the Pacific Rim is often called the "Ring of Fire". The 7 Soviet bombs planted in Philippine waters are there for the purpose of triggering major earthquakes, which, thanks to the peculiar convergence of faults and trenches in that area, are intended to work their way by chain reaction all around the Pacific Rim, devastating Washington State, Oregon, and California in the process. The 7 bombs in the Philippines are in the so-called gigaton range—that is, each one is equivalent to a billion tons of TNT—50,000 times more powerful than the Hiroshima bomb and, therefore, big enough to trigger massive earthquakes. And the Soviets believe they can safely use such warfare, treaties or no treaties, because most of the Soviet Union has no history of earthquakes. The Soviet gigaton

bombs in the Philippines are located at navigational coordinates which I will now reveal: No. 1 is at 17-23-23 north, 117-7-23 east; No. 2 is at 14-48-48 north, 119-2-18 east; No. 3 is at 14-0-40 north, 118-23-53 east; No. 4 is at 13-0-0 north, 117-42-8 east; No. 5 is at 12-0-54 north, 126-4-55 east; No. 6 is at 13-50-36 north, 125-21-45 east; No. 7 is at 19-48-3 north, 123-51-57 east. But to make sure that our West Coast is devastated by the effects of a seeming natural disaster erupting in the Philippines, a series of 7 conventional but large hydrogen bombs have been planted off our West Coast by the Soviet Union. These can be set off in conjunction with those in the Philippines, and at the right moment to produce tidal waves which would sweep in from the Pacific with devastating effect along our West Coast. Bomb No. 1 west of Seattle is at 48-0-0 north, 127-50-0 west; No. 2 west of Eugene, Oregon is at 43alliance plan to lay the groundwork for a Declaration 29-18 north, 127-55-5 west; No. 3 west of San Francisco is at 37-8-45 north, 125-42-30 west; No. 4 west of Monterey is at 36-31-0 north, 125-26-30 west; No. 5, also west of Monterey, is at 36-26-30 north, 124-56-0 west; No. 6 west of Los Angeles is at 33-25-15 north, 122-23-50 west; and No. 7 southwest of San Diego is at 31-45-35 north, 120-36-0 west. In my Audioletter No. 20 for January 1977, I referred to a warning document issued in December 1975 by Mr. Tony Hodges of Hawaii. In that document Mr. Hodges presented evidence of the feasibility of underwater missiles. He also warned of the dangers of bombs on or in the seabed designed to generate earthquakes or tidal waves. Soon thereafter, with the Rockefeller dictatorship in place, Nuclear War One itself is planned to come. Dams and reservoirs all over America are to be destroyed at one blow by the Soviet Union—and the quislings from the Trilateral Commission, who now control the Federal government, will use their control over what little remains of our water supplies to make their domination of us total. The saddest thing about all of this is that only when it happens will people believe. By total exposure there is a chance to prevent the West Coast disaster but without exposure, there is no chance whatsoever.

BUSH MISSILE DEFENSE PROGRAM— A PATTERN OF DECEPTION

In their campaign to sell a missile defense system to the American public and a skeptical world community, President Bush, Defense Secretary Donald Rumsfeld and the Pentagon have engaged in a disturbing pattern of deception.

The dangers posed by breaking international treaties or igniting a new arms race in space—not to mention the cost or the effectiveness of this new weapons system—require a thorough and forthright debate. Yet so far, there is growing evidence that the Bush administration is not presenting the full picture to the American people.

SILENCING THE CRITICS

Consider, for example, what happened to Nira Schwartz, a physicist and engineer who accused TRW, a military contractor, of faking tests and evaluations for the Pentagon's missile defense program. TRW fired her the next day.

Schwartz then shared the information with Professor Theodore A. Postol, a Massachusetts Institute of Technology physicist, who has long argued that flawed software currently prevents a missile system from distinguishing between decoys and enemy warheads. Postol gained fame in defense circles in the 1990s for exposing the fake claims made by the military about Patriot missiles during the Gulf War.

For months, Postol has been circulating a government-commissioned independent report that supports his criticism of the missile defense system. Although the report was labeled an "unclassified draft" when Postol obtained it, the government has retroactively ruled that it includes secret information.

Now the Pentagon has accused Postol of circulating classified information.

In early July, the Pentagon asked MIT to investigate Postol's activities—a request that has pitted academic freedom against the Department of Defense's effort to silence one of its most credible critics. For MIT, the stakes are high: The university could lose \$319 million in missile defense contracts unless it aggressively investigates the professor.

AVOIDING CONGRESS

For six months, dozens of members of Congress repeatedly asked the Defense Department and Secretary Rumsfeld to release an unclassified Pentagon report that criticized the missile defense testing program. The Pentagon finally released the Coyle Report, compiled by the Pentagon's chief civilian test evaluator, in June 2001. It concluded that the tests have become progressively easier so that they can be counted as a "success".

RIGGING THE TEST

After the Defense Department suffered two widely publicized "misses", Pentagon officials knew they had to prove they could hit a bullet with a bullet. On July 14, a "kill vehicle" launched from the Pacific smashed into a rocket hurled from Vandenberg Air Force. Photographs of the vaporized target strengthened the Pentagon view that critics are just cranky curmudgeons.

What most people didn't know, however, was that the Defense Department had rigged the \$100 million test. As Joe Conason reported in *Salon* magazine, "The rocket fired from Vandenberg was carrying a global positioning satellite beacon that guided the kill vehicle toward it." But this fact didn't surface until the Pentagon confirmed the presence of a GPS device to *Defense Week* magazine.

A Pentagon official then conceded that "real warheads in an attack would not carry such helpful beacons".

ARMING THE HEAVENS

The Bush administration has tried to cast the missile defense shield as a defensive weapon, a kind of giant umbrella that will prevent enemy missiles from attacking the American people. But the truth is more complicated.

The missile defense system is just the first step in a much larger plan to transform the military. The *Rumsfeld Space Commission Report*, presented to Congress just before Bush took office, proposed an offensive U.S. Space Corps that would dominate and control space by military means. The U.S. Space Commission's mission statement, "Vision 2020", even argues that the United States should "control and dominate" space and "deny other countries access to space".

Bruce Gagnon, international coordinator of the Global Network Against Weapons and National Power in Space, says that "This whole missile defense program is ultimately a Trojan Horse. Pentagon officials understand that they can't come before the American people and say 'Give us hundreds of billions of dollars so we can have offensive weapons in space.' We are talking about creating a new arms race in space that will make the aerospace corporations richer than one could imagine."

THE SECRET IS OUT

In a recent CBS News program, Dan Rather scrutinized the allegations made by Schwartz and Postol and seemed to find their testimony quite credible.

And in a recent *New York Times Magazine* article, "The Coming Space War", Jack Hitt described the elaborate facilities at which plans for a future Space Corps and space-based weapons are being conceived.

(The next day, coincidentally, came the news that a coalition of conservative organizations and defense-industry labor unions have launched an intensive lobbying campaign to ensure passage of Bush's proposed \$8.3 billion missile defense budget for next year.)

THE NEXT STEP

It's time for the American people to understand what's at stake. The development of a missile defense system violates the 1972 ABM Treaty, which outlawed missile defense systems. If the United States prepares to launch space-based weapons, it will also violate the 1967 Outer Space Treaty that banned the militarization of space.

We also need to shed the illusion that there is such a thing as a perfect defense. Someone, someday, will inevitably find a way to pierce supposedly impenetrable defenses.

This debate is not just about whether it is possible to protect Americans from incoming missiles. It is about the desirability of transforming the military into a space-based fighting force and deploying weapons in outer space.

This may sound like science fiction, but it is what's passing as serious military policy in the Bush White House.

WHITE FARMERS IN ZIMBABWE SUFFER INCREASING VIOLENCE AND PLUNDER

White farmers in Zimbabwe suffered a fresh round of plunder and violence yesterday as more than 250 pro-Government militants ransacked properties in the northwest. Ninety families, totalling about 300 men, women and

children, have been evacuated from the farming district around the town of Chinhoyi, 75 miles north of Harare.

Nearly £2.8 million-worth of tractors, vehicles and other farming equipment was stripped from a number of farms in the area.

"My farm was one of the first to be trashed," one farmer said. "A 250-strong mob arrived at the farm on tractors stolen from other properties.

"They went through my house from top to toe, smashing everything in their sight. Six of my dairy cows were butchered with axes," he said.

"They made our workers join in. Anyone who refused was beaten up. My foreman was left with a broken arm. Then they set fire to the bush behind my house. The police made no arrests for destruction of property or stock theft. About 28 of the 90 farms in the area have been trashed so far. There is tonnes of farm equipment lying about all over the place. It's complete chaos."

Another farmer said that scores of Black workers had been assaulted by the war veterans. Farm documents were scattered or burnt in what appeared to be an attempt to prevent the owners from resuming production. "What couldn't be loaded on to tractors, trucks and even donkey carts was destroyed or set on fire in an orgy of banditry," he added.

The Rev. Deon Van Dyk, a local clergyman, inspected four of the farms belonging to his parishioners in the Mhangura area, near Chinhoyi. "Not a single piece of furniture is left. Combine harvesters have been trashed. Seed and fuel has been scattered everywhere," he said. "Twenty-eight houses in the area have totally gone—just gone.

"The farmers are completely traumatised by what has happened to them. Yet not one has fired a shot in anger."

More than 100 of the 400 farms in the Chinhoyi-Mhangura-Doma area have been abandoned in the week since 21 farmers were detained for coming to the aid of a besieged neighbour. Fresh approaches will be made to judges today for their release.

Nearly all of Zimbabwe's 5,500 White-owned farms, totalling 30 million acres, have been designated for seizure.

COMING OF EUROPE'S NEW CASH FEEDS JITTERS LARGE AND SMALL

PARIS—Will chaos reign when much of Europe starts changing over to euro coins and notes on Jan. 1? Will lines clog the aisles of supermarkets as cashiers fumble trying to figure out euro change? Will citizens hoard their new euro coins as collectors' items? Will people feel so ill at ease with the new prices that they just won't buy anything beyond the basics?

If all goes well, the conversion to euro notes and coins could give new power and legitimacy to the common currency being adopted by 12 of the 15 European Union countries.

Trade could grow, and investment from abroad rise. Some see the move to the euro, now worth about 90 American cents, as a major turning point in the unification of Europe.

But even as the European Central Bank gets set to unveil the final design of the new notes and coins next month, exactly what will happen on "E-day"—one of the Continent's biggest peacetime undertakings—remains a subject of intense debate. After years of planning for the switchover, European Union and Central Bank officials say they are counting on an orderly transition. Still, they admit to worries.

"Concerns, there are lots of them," said Benjamin L. Angel, the European Union official in charge of the practical aspects of the transition. "You can't help but have them when you have such a massive, historic event."

and anxiety is growing, much as it did with the Year 2000 computer scare. The logistics of the conversion are mind-boggling, and leave room for any number of disasters from a rise in money laundering, counterfeiting and bank heists to inflation set off by retailers rounding up prices as they convert to euros three years after banks and stock exchanges adopted the currency.

Worries range from banks that are offering employees free gym time to get them fit enough to haul extra sacks of money, due to the shortage of armored trucks in Finland—a large and sparsely populated country that has only 150 such vehicles to convey the new coins and notes to outlying stores and A.T.M.s.

As of Jan. 1, about 50 billion new coins and 14.5 billion euro notes are to be pumped into circulation. If the bank notes were laid end to end, one bank official said earlier this year, they would reach to the Moon and back twice. Another said that trying to distribute the new money was the equivalent of sending 500,000 trucks out onto the roads of Europe to transport 24 times the weight of the Eiffel Tower.

Some psychologists have warned that impact of the transition may send people into a kind of economic hibernation. Consumers and retailers could decide to strike? Dutch and French drivers have be infuriated if they see the wide discrepancies in prices between countries. Even charities and religious organizations could suffer.

A front-page article last month in the French daily Le Figaro said that French churches were fretting. Most parishioners apparently put either 5- or 10-franc pieces into the collection plate. But no equivalent exists in euros. Depending on whether they choose bigger or smaller coins, the churches could be facing a 30 percent drop in revenue.

Increasingly, consumer groups and retail associations are complaining of a lack of readiness. "I think we are headed for catastrophe," Christian Huard, the president of a large group representing French consumers, said last month. On Aug. 9, Holger Wenzel, the director of the German Retail Association, attacked the German government on much the same grounds and denounced banks for taking advantage of the situation by planning exchange fees.

Europeans appear ill-informed about their new currency. A recent European Union survey showed that support for the changeover was growing in the 12 affected countries—France, Italy, Spain, the Netherlands, Portugal, Ireland, Belgium, Germany, Finland, Luxembourg, Austria and Greece. (Three European Union members—Britain, Sweden and Denmark—voted not to join.) But about half those surveyed in France, Italy and Portugal did not know that the euro was destined to go into circulation in four months.

Surveys show that few consumers have any idea of the value of a euro, despite a growing amount of dual price ticketing. A European Union report issued at the end of March said that 80 percent did not remember a single price in euros.

One in five did not understand that their old national currencies would disappear when the euro was introduced. One in four did not understand that euro notes and coins issued in their own countries would be legal tender elsewhere in Europe.

European Union officials think that this lack of information may change quickly in the next few months. As of September, the European Central Bank will start a major media blitz. Through the fall, most European banks will start sending their customers checkbooks in euros. Until now, euros have been used only in electronic payments and in bookkeeping.

The switchover is complex: Not only do the new bills and coins have to be distributed—but the old notes and coins have to be collected. By most estimates there are even more of them—though no one knows for sure how much cash people have had squirreled away in cookie

Across the European Union doomsayers abound, jars and under mattresses. Some banks have even taken steps to reinforce their floors because of the additional weight of money in their vaults.

> Most of the conversion will take place as citizens withdraw new money from the bank and get euro change back from stores when they make purchases. But will the stores be willing to keep more cash than usual on hand? And what will happen when transactions become burdened with two currencies?

> Mr. Angel, the European Union official, said that McDonald's had found that waits doubled or tripled when their employees had to handle two currencies and that mistakes in change were rampant. He said the fast-food chain was planning to double personnel at cash registers.

> A major supermarket chain, he said, found its lines increased from an average of 5 people to 20, a situation that crippled movement in its stores. To ease the transition, the chain has decided to offer a rare service in Europe—baggers.

> But surveys show that the vast majority of smalland medium-size businesses have yet to do anything to prepare. Even sales of calculators to convert the currency have been extremely slow, Mr. Angel said.

> And what if European armored-car drivers should already threatened to do so.

> The situation could vary widely depending on the country and how it prepares. The European Central Bank will start a \$90 million television and print campaign to inform the public starting next month. But some countries-Portugal has even enlisted the church to help educate older people—have already embarked on publicity campaigns aimed at easing the changeover.

> National habits could also play a part in how things go. In some countries, such as Ireland, consumers go often to A.T.M.s and take out small amounts. In others like Austria, they tend to take out large bills.

> The impact of the change will reach far beyond the 12 countries using the euro. In Poland, for instance, distrust of the banking system remains strong, especially among older and rural people. Some experts estimate that Poles may hold as much as \$2 billion in cash hoarded at home, much of it in German marks—the hard currency of choice in many parts of formerly Communist Europe. The Polish central bank has already kicked off an information campaign.

> Bank officials fear the exchange of national currencies will offer criminals a convenient opportunity to introduce counterfeits and launder money. A report by the European Union's fledgling police agency, Europol, recently warned that the high value of the notes may make financial crime easier by enabling criminals to cram more cash into their briefcases when they cross borders. The report warned that the high denominations of the euro bills—an 500 euro bill is worth about \$425—could ease money laundering.

> In most Eurozone countries, the highest value euro bank note will be worth far more than the current biggest domestic note. In Greece, for instance, the note will be worth 17 times the highest drachma note.

> Meanwhile, some experts say the changeover may have a powerful effect on the psyche of Europeans. Some say that the unfamiliar prices may so discombobulate people that they put off buying anything but immediate necessities, leading to an economic slowdown.

> Others say that the euro might help forge a new political awareness. "The euro may be a real catalyst for change," Jacques Birouste, a professor of psychology who studied the psychosocial impact of the new money on European citizens. "This may be the moment where many Europeans for the first time really look at what the European Union means and the transfer of sovereignty, which actually happened years ago. And this may have a lot of impact on the political world."

COSMIC LAWS LIKE SPEED OF LIGHT MIGHT BE CHANGING, A STUDY FINDS

A Small Change, With Huge Implications

An international team of astrophysicists has discovered that the basic Laws of Nature as understood today may be changing slightly as the universe ages, a surprising finding that could rewrite physics textbooks and challenge fundamental assumptions about the workings of the cosmos.

The researchers used the world's largest single telescope to study the behavior of metallic atoms in gas clouds as far away from Earth as 12 billion light years. The observations revealed patterns of light absorption that the team could not explain without assuming a change in a basic constant of Nature involving the strength of the attraction between electrically charged particles.

If confirmed, the finding could mean that other constants regarded as immutable, like the speed of light, might also have changed over the history of the cosmos.

The work was conducted by scientists in the United States, Australia and Britain and was led by Dr. John K. Webb of the University of New South Wales in Sydney, Australia. It is to be published on Aug. 27 in the field's most prestigious journal, Physical Review Letters.

Scientists who have examined the paper have not been able to find any obvious flaws. But because the consequences for science would be so far-reaching and because the differences from the expected measurements are so subtle, many scientists are expressing skepticism that the discovery will stand the test of time, and say they will wait for independent evidence before deciding whether the finding is true.

On the other hand, the finding would fit with some theorists' new views of the universe, particularly the prediction that previously unknown dimensions might exist in the fabric of space.

Even scientists on the project have been deliberately cautious in presenting their result. Describing the implications of what his team observed, Dr. Webb said, "It's possible that there is a time evolution of the laws of physics."

Dr. Webb added, "If it's correct, it's the result of a lifetime."

Dr. Rocky Kolb, an astrophysicist at the Fermi National Accelerator Laboratory who was not involved in the work, said the finding could not only force revisions in cosmology, the science of how the universe began and later evolved, but also add credence to an unproven theory of physics called string theory, which predicts that extra dimensions exist.

"The implication, if it is true, would just be so enormous that it's something people should look at and take seriously," Dr. Kolb said. "This would upset the apple cart."

The magnitude of the change apparently observed by the group is minute, amounting to just 1 part in 100,000 in a number called the fine structure constant over 12 billion years. That constant, also referred to as alpha, is defined in terms of more familiar quantities like the speed of light and the strength of electronic attractions within atoms.

But even that small change would rock physics and cosmology, said Dr. Sheldon Glashow of Boston University, who received a Nobel Prize in physics in 1979. The importance of such a discovery, Dr. Glashow said, would rank "10 on a scale of 1 to 10."

Considering the unexpected nature of the finding, both Dr. Glashow and Dr. Kolb said the chances were high that some more mundane explanation for the results would turn up.

Dr. John Bahcall, an astrophysicist at the Institute for Advanced Study in Princeton, N.J., said the complicated analysis that was required to infer the tiny changes from the observations could—in principle, at least—be obscuring possible errors.

"The effect does not scream out at you from the data," Dr. Bahcall said. "You have to get down on all fours and claw through the details to see such a small effect.'

But others said that the team had been very careful and that any unknown source of error would have to be extremely subtle to be missed.

"If they were claiming anything less dramatic, probably most people would find their work very careful and believable," said Dr. Massimo Stiavelli, an astrophysicist at the Space Telescope Science Institute in Baltimore.

"Exceptional results deserve extraordinary proof," Dr. Stiavelli said, adding that he was reserving judgment until further evidence became available.

The work relied on observations of light from distant beacons called guasars, which shine with a brightness equivalent to billions of suns. The light is probably emitted by matter torn from young galaxies by the powerful gravity of a black hole.

Besides Dr. Webb, the team included three other scientists at the University of New South Wales, Michael T. Murphy, Dr. Victor V. Flambaum, and Dr. Vladimir A. Dzuba; and one physicist at Cambridge University in Britain, Dr. John D. Barrow. Three American astronomers who are experts on quasars were also members of the team: Dr. Christopher W. Churchill of Pennsylvania State University; Dr. Jason X. Prochaska of the Carnegie Observatories; and Dr. Arthur M. Wolfe of the University of California at San Diego.

The observations, made by the 30-foot-wide Keck Telescope on Mauna Kea in Hawaii, looked in detail at the absorption of quasar light by gas clouds in deep space between Earth and the quasars. Metal atoms like zinc and aluminum are often present in trace amounts in the clouds.

The absorption of light by such atoms creates dark spikes at various wavelengths in the quasar's spectrum, with a pattern so well defined that it is often likened to a fingerprint. The value of those wavelengths is directly related to the value of the fine structure constant.

But the fingerprint seemed to change in time, Mr. Murphy said, indicating that the constant grows larger as

"What we have found is that, statistically, there is a difference between the fine structure constant a long time ago and here on Earth," he said.

Far from being of interest only in understanding atomic behavior, said Dr. Barrow of Cambridge University, the effect would be important "because it gives you such a feedback into fundamental physics".

String theory, for example, could accommodate changes in quantities that accepted physics theory considers immutable. String theorists postulate that the size of those dimensions—much like the expansion of the universe in the space we are familiar with—could change quantities like the fine structure constant, said Dr. Paul Steinhardt, a physicist at Princeton University.

Dr. Steinhardt said most theorists would have expected those changes to have occurred in the first seconds of the universe's life and be virtually unobservable by astronomers today. Still, he pointed out that several years ago, other astronomers unexpectedly found that the present universe is apparently filled with a mysterious kind of energy that counteracts gravity on large scales. Perhaps the two effects are somehow related, Dr. Steinhardt said.

Other scientists pointed out that geologic processes, like naturally occurring nuclear fission, have been used to determine that the fine structure constant has probably changed little over the past two billion years on Earth. But researchers on the new paper point out that their results reach back much farther in time, and that interpreting the geological results is also a complicated matter.

But a few physicists, like Dr. Jacob D. Bekenstein of Hebrew University in Israel, noted that some theories have long been predicting a change in some of Nature's apparent constants. Dr. Bekenstein called the findings "potentially revolutionary" and said he was inclined to believe them.

"After much thinking about this issue," Dr. Bekenstein said, "I think the quasar observations may have found the real variation.'

LIVERMORE LAB UNVEILS SUPERCOMPUTER

LIVERMORE, CALIFORNIA—After keeping the world's most powerful supercomputer to themselves for a year, government researchers showed off the \$110 million wonder Wednesday and said it might help save the world from nuclear war.

With the ability to perform 12.3 trillion calculations a second, the supercomputer at Lawrence Livermore National Laboratory mainly will be used to simulate how the nation's aging nuclear weapons arsenal would function if launched.

because the United States suspended underground nuclear tests in 1992.

Gen. John Gordon, the Department of Energy's under secretary for nuclear security, called the supercomputer the "key to the country's mission of maintaining the stockpile" and assuring nuclear deterrence.

The supercomputer—known as Accelerated Strategic Computing Initiative White, or ASCI White has a mind-boggling amount of other uses, say researchers who use it.

ASCI White is roughly as powerful as 50,000 desktop computers. It can store the equivalent of 300 million books, or six Libraries of Congress.

It has 8,192 microprocessors, housed in a series of black refrigerator-sized boxes linked together by 83 miles of wiring in a room the size of two basketball courts.

A giant air-conditioning system that cools ASCI White requires three megawatts of electricity, enough to power a small city.

ASCI (pronounced ASK-ee) White was designed one goes nearer to the present and was not really constant. for the government by IBM Corp., which delivered it to Livermore last year in 28 tractor-trailers. The mammoth computer is 1,000 times more powerful than Deep Blue, which defeated chess grand master Garry Kasparov in 1997.

> The machine is networked to researchers at Livermore and the Sandia and Los Alamos national labs in New Mexico via an encrypted line. It went through months of testing and debugging before being dedicated Wednesday.

Tomas Diaz de le Rubia, a materials program space contains tiny, unseen dimensions. Any change in leader at Livermore, marveled at how ASCI White has enabled his team to create three-dimensional models that can track the behavior of 1 billion atoms at once.

> "It opens up a whole new way of studying how materials behave, how they perform under different conditions, how they age," he said. "It's beautiful."

> It's also just the beginning. The government says that to certify the nuclear arsenal with full confidence, it needs a supercomputer that is 10 times as powerful as ASCI White by 2004.

ACCUSED DRUG RINGLEADER INDICTED

LOS ANGELES-An Israeli man awaiting extradition to the United States for allegedly operating an international drug-trafficking ring was indicted by a federal grand jury along with 11 alleged associates.

Oded Tuito was accused by the grand jury Tuesday of running an organization that smuggled millions of Ecstasy pills into various U.S. cities. Federal agents estimate that 100,000 pills reached Los Angeles every month.

Tuito faces numerous charges, including operating a continuing criminal enterprise, which is punishable by 20 years to life in prison. He is also sought by Israel, where a 16-year drug sentence is pending against him.

Tuito was arrested earlier this year in Spain, where he awaits extradition. Federal grand juries in Brooklyn, N.Y. and Pittsburgh have indicted him on similar charges.

Authorities said Tuito's group primarily used young women to smuggle the pills from Northern Europe to the United States. Recently, the ring was shipping Ecstasy in larger quantities by putting the pills into hollow picture frames, investigators said.

SOME BOTTLED WATER NOT AS PURE AS TAP

"That represents a level of chromium 6 that would not be expected to pose any health threats to someone drinking two liters of water a day for 70 of Congress asking them not to extend the current ban years," said Allan Hirsch, spokesman for the office. on taxes on e-commerce unless states are given a "If you are only drinking water with that level occasionally, any risk would be a lot less."

Tests of the bottled water for arsenic found 11 brands, or 19 percent, with levels above 1 ppb.

Vittel brand bottled water had the highest concentration of arsenic at 10.5 ppb. In January, the federal Environmental Protection Agency reduced the standard for arsenic to 10 ppb, but President George W. Bush put the order on hold and the EPA later withdrew the lower standard and returned it to 50 ppb.

"I'm not going to say drink it or don't drink it," said Wasfy Shindy, deputy director of the county toxicology bureau, who led the county study. "If the state has a public health goal and the bottled water exceeds that goal, I think people would have some concern. It's up to the public to decide what they want to do.'

Currently, the federal government allows 100 ppb for total chromium, the state allows 50 ppb for total chromium, and there are no standards set by either the state or federal governments for chromium 6.

With all the uncertainties, the report notes that no conclusions can be made about the safety of bottled water.

said it's clear the largest problem is the absence of uniform standards.

"We need to encourage the state and federal government to move as quickly as possible to set those standards so we know exactly what is safe and what isn't," Fiksdal said.

Tarzana resident Cornelia Hansen said the bottled water report shows the nation is "run by greed".

"The only time I drink bottled water is when city water is not available," he said.

GOVERNORS RENEW PUSH FOR INTERNET SALES TAX

WASHINGTON-In a renewed push for Internet sales taxes, 40 state governors will take their case to Congress this week in a letter urging rejection of a ban on other Internet taxes, The Washington Post reported on Wednesday.

The governors will send a letter to every member chance to develop an initiative that would allow them to tax online sales, the report said.

The Post quoted a draft of the letter as saying: "If you care about a level playing field for main street retail businesses, and local control of state's governments and schools, extend the moratorium on taxing Internet access only with authorization for the states to streamline and simplify the existing sales tax."

October. A U.S. House of Representatives panel voted Aug. 2 to bar states from taxing Internet access and extend for five years a ban on other Internet-specific taxes, declining to approve legislation that would help states tax online commerce.

Under a 1992 Supreme Court decision, states cannot require out-of-state retailers such as catalog companies to collect sales taxes unless they have a physical presence in the state. Many state and local officials fear a loss of revenues as constituents increasingly shop online, while Internet retailers say it would be impossible to comply with the maze of state and local tax codes across the United States.

A coalition of states is in the process of simplifying County Agricultural Commissioner Cato R. Fiksdal tax codes with the hope that Congress would then allow them to collect sales taxes on remote sellers. Several bills introduced in Congress would give states the green light to collect sales taxes once enough of them sign up.

U.S. ECONOMIC SLUMP PUMMELS FOREIGN-OWNED PLANTS IN MEXICO

TIJUANA, MEXICO—Owners of foreign-owned advantage of its cheap labor are laying off tens of thousands of people in the wake of a U.S. slowdown.

After years of strong economic growth and a booming job market spurred by the North American Free Trade Agreement, Mexico's dynamic industrial region is sputtering.

On a scruffy hill dotted with shacks, Jose Luis Cuadras, 50, struggles to eke out a living after losing his job sewing U.S. baseball hats at a maquiladora, one of the thousands of assembly plants that have characterized Mexico's border.

He now works at a stand that sells garage doors in Scotland made 500 people ill and killed 20.

The maguiladora industry has lost 100,000 jobs so far this year, mostly along the 2,100-mile northern border, officials say. [MM: Really breaks your heart, doesn't it?!]

Since January, Baja California, home to Tijuana, has lost 23,100 jobs, while Chihuahua state has lost 59,100 jobs, Mexico's Labor Secretary Carlos Abascal said. The two states have the largest number of maquiladoras.

The U.S. downturn "has had a huge impact," said Manuel Gonzalez, assistant director of the northern Mexican border sector for the National Manufacturing Chamber.

More than 3,500 plants employ 1.2 million people along the border.

COPPER KILLS E. COLI QUICKLY

Copper—the metal used by ancient Egyptians to keep water fresh—could be the answer to tackling modern food poisoning viruses such as E. coli, research released today has found.

British scientists working as part of an international drive to develop the bacteria-killing properties of copper has found the metal can kill harmful bugs other materials cannot.

A team from the University of Southampton has The moratorium on Internet taxes is set to expire in shown E. coli O157 can survive for more than a month on stainless steel, the work surface used in most commercial kitchens.

> But tests showed that copper killed the virus in just four hours at room temperature. If cooled to a typical chill temperature of 4C (39F), it killed the virus in 14 hours.

> At room temperature of 20C (68F) the bacteria survived on stainless steel for 34 days and on brass for four days.

> If the properties of the metal can be used, then new copper surfaces for food preparation in factories, shops, hospitals, restaurants and the home could help reduce the risk of infection by potentially fatal food bugs.

> Professor Bill Keevil, who is leading the British research, said: "The goal is now to find the appropriate copper alloys that are acceptable for food use, easy to maintain, economical to fabricate and which retain the ability to kill bacteria.

> "If this work is successful, it may be possible to achieve important public health benefits just by changing the surface material commonly used in food processing.

> "Stainless steel is used throughout the world because of its perceived hygienic properties. It always looks like a nice, clean and bright surface," he added.

> "But a closer look reveals scratches and marks which, on a microscopic scale, are more like valleys.

"It is very easy for pathogens to get into these crevices—and rubbing a cloth or brush across the surface may not be sufficient to get them out. Unless a good disinfectant is used to get to the bottom of the valley, you can't kill them off."

"The research we have already done has shown that E. coli O157 is a very robust pathogen and that very rigorous cleaning techniques are needed to try and keep it out of the food chain."

BREAST IS BEST FOR BETTER BRAINS

Mothers who breastfeed for less than three months may be holding back the intellectual development of their children, according to research published today.

Children who are breastfed for such a short period tend to have lower IQs than peers who receive their mothers' milk for more than six months, a team of Scandinavian scientists concludes.

At 13 months, children who benefited from extended breastfeeding had developed superior mental skills and by the age of five that group had an average IQ eight points higher than their peers', the study finds.

Significant differences remain even after the results are adjusted for maternal age, intelligence and education. However, the researchers acknowledge that influences such as genetics and the child's environment remain much more important and less well understood factors in a child's intelligence.

This is the first research to examine in detail breastfed is important. Earlier work compared breastfed children with those fed on formula milk.

The researchers say the results indicate that all mothers should, if possible, breastfeed their children for between six months and one year.

Nutrients found in large quantities in human milk, including a neural growth factor that helps brain development, are probably behind the effect, they suggest. Long-term breastfeeding may also help babies to bond intimately with their mothers, further improving their mental progress.

journal Archives of Disease in Childhood, emerge from a study of 345 children in Norway and Denmark, where almost all mothers breastfeed their children for at least a few weeks after birth.

Researchers then tested the children's mental and physical skills at 13 months and conducted a full IQ test at five years. At both ages, the children breastfed for a shorter time were more likely to record below-average scores.

Torstein Vik, of the Norwegian University of Science and Technology in Trondheim, who led the study, said: "Even once you adjust for factors like high maternal IQ, which makes (a mother) more likely to breastfeed, you still see an advantage."

THE POWER TO DESTROY— TAX ACTIVISTS REFUTE IRS CLAIMS

"We're confiscating property now. That's socialism."—Former Revenue Chief

Editor's note: Brought about by the successful hunger strike of tax activist Bob Schulz, a historic meeting between the federal government and leaders of the "tax honesty movement" will take place in Washington, D.C., on Sept. 25 and 26. WorldNetDaily will be there to cover the proceedings.

Leading up to this high-profile confrontation over the legality of the income tax, the following is the second in a series of reports discussing an internal document from the Internal Revenue Service's own Website. The document is intended to guide the agency's employees in how to deal with what the IRS calls "frivolous tax arguments". Tax experts, including one who spent a year researching whether enough states properly ratified the 16th Amendment which authorizes Congress to collect income taxes—are as insistent as ever that Americans are not mandated to pay Uncle Sam a portion of what they earn every year.

"I've read all of the cases the IRS mentions" in its 25page document entitled "The Truth About Frivolous Tax Arguments," said Bill Benson, author of The Law That Never Was, a book many believe debunks the government's claim that the income tax is legal and that the IRS is faced lie," Kidd said. a properly authorized government agency.

"They must have a law in order to have any of this [the income tax] to apply," Benson told WND. "They must have a law from its inception—and they don't have that."

A former criminal investigator for the Illinois Department of Revenue for nearly a decade, Benson said he has "17,000 certified and notarized documents showing that the 16th Amendment is an absolute, complete and total fraud."

But the problem, as WND's TalkNetDaily radio host and staff writer Geoff Metcalf points out, is getting the federal government to cite the legal chapter and verse of the law that requires mandatory payment of income taxes.

> "I have often noted that if in fact we are compelled by law to pay income tax and the 16th Amendment was in fact properly and legally ratified (and it wasn't), then the government should be able to conclude their response in less than five minutes by merely stating, stanza and verse, where the law is, and how it applies: 'See here? Page such and such, paragraph such and such, subparagraph such and such. Now shut up and go home," said Metcalf.

> One of the most compelling arguments of income tax opponents is the claim that the 16th Amendment was never even properly ratified, although understandably the IRS refutes that.

"This argument is based on the premise that all federal income tax laws are unconstitutional because the Sixteenth Amendment was not officially ratified, or because the State of Ohio was not properly a state at the time of ratification," says the IRS document. "This argument survived over time because proponents mistakenly believe that the courts have refused to address this issue."

However, the IRS says the amendment was properly ratified by "forty states, including Ohio, and issued by proclamation in 1913. Shortly thereafter, two other states also ratified the [A]mendment."

There were enough states & even without Ohio to complete" the required three-fourths of the states to ratify the amendment, said the IRS document. "Furthermore, the U.S. Supreme Court upheld the constitutionality of the income tax laws enacted

subsequent" to the ratification of the amendment.

In his research, however, Benson found that only four states ratified the amendment "without changing the wording". He maintains that, constitutionally, states cannot change words or punctuation when voting to accept or reject a constitutional amendment.

The only thing the states can do is accept or reject the wording (of an amendment) as is," Benson told WND. "The legislatures of each state cannot change any of it. Otherwise, we'd have 48 different versions of the law."

"What is stated [in the IRS document] is a bald-

"Since it was never ratified—and we can prove it wasn't— Very simply, he says there is no actual law then apportionment is still in effect and again, everything else is moot," she said. The government's "progressive, unapportioned tax is, and always has been, unlawful."

Rather than dicker over IRS codes, legal impressions and court cases, Kidd and other "tax-honesty" proponents believe the key to discovering the legality of income tax lies in proving these contentions:

- * That the IRS is not an authorized agency of the government and has no authority to conduct business;
 - * That the government's jurisdiction is not valid;
- * The fraudulent ratification of the 16th clause of the Constitution;
- * That an individual is, without question, forced to involuntarily surrender his Fifth Amendment right against self-incrimination by filing any income tax form under penalty of perjury.

Another area of concern, Kidd says, is that the courts themselves can't even decide, in a universal manner, what constitutes an income tax or what the income tax really is—direct or excise.

"That's a fact and it creates what is known as a problem [IRS] document," she said.

Even former IRS commissioners have questioned the legitimacy of the very agency they serve.

"We're confiscating property now. That's socialism. It's written into the Communist Manifesto. Maybe we ought to see that every person who gets a tax return receives a copy of the Communist Manifesto with it so he can see what's happening to him," lamented T. Coleman Andrews, the Democratic commissioner of the IRS during the first 33 months of the Republican administration of President Dwight Eisenhower.

But the one fact dogging nearly every tax honesty advocate is this: Regardless of the actual legitimacy of their arguments, the courts, Congress and most of the American public don't see it their way.

The IRS can point to dozens of rules, regulations and court cases—many decided by the U.S. Supreme Court—backing the agency's position that it has a right to tax all of the income earned by American workers.

Also, even critics of the agency acknowledge that it must collect the amount of money Congress approves in the federal budget every year. And once passed, Congress expects the Treasury Department to fill the nation's coffers.

Finally, most states have agreements with the IRS to provide the agency with information. Under these agreements, individual states and the IRS notify each other about taxpayers that failed to file returns. The only state that does not have such an agreement is Nevada. [MM: Of course, any information not required—that is voluntarily provided will also be happily accepted and shared, even in Nevada.]

Nevertheless, tax activists say the September meeting in Washington, D.C., will once and for all provide them with an opportunity to address their concerns face-to-face with government and, hopefully, IRS representatives.

"We intend to prove our points at the hearings next month," Kidd said.
