#### **CHEMTRAILS** COVERT CLIMATE CONTROL?

Under the banner of some top-secret scientific agenda, the U.S. military continues to weave chemicalladen contrails in the skies, causing health problems for unprotected people on the ground.

For nearly three years, chemtrail observers have hoped an official would step forward to explain the origin and purpose of broad white plumes criss-crossing the skies above a dozen allied nations. Their wait is over....

It was nearly noon when S.T. Brendt awoke and entered the kitchen of her country home in Parsonsfield, night reporter for WMWV radio could not have guessed that her life was minutes away from drastic change.

Her partner Lou Aubuchont was already up, puzzling over what he had seen in the sky a halfhour before. The fat puffy plumes arching up over the horizon were unlike any contrail he had ever seen, even during his hitch in the Navy.

Like breath exhaled on a winter's day, the contrails he was used to seeing would flare briefly in the stratosphere as hot moist engine exhaust flashfreezes into a stream of ice-crystals. These pencilthin condensation trails are pretty to watch but shortlived, subliming into invisibility as exhaust gases cool quickly to the surrounding air temperature.

But in late 1997, Aubuchont started observing thicker trails extending from horizon to horizon. Hanging in the sky long after their creators had flown from view, these expanding white ribbons would invariably be interwoven by more thick lines left by unmarked jets, Air Force white or silver in colour.

On this March 12th morning in 2001, Lou did not mention his sighting as S.T. indulged in caffeine. Sipping gratefully, she glanced out the window. It looked like another gorgeous, cloudless day.

But not quite. Brendt balked at several chalk marks scrawled across the crystalline blue sky. "Contrails or chemtrails?" she jokingly remarked.

exactly side by side in a straight line? he wondered. It's just too perfect to happen naturally. When he said he wasn't sure, S.T. stopped smiling and went outside.

[H: Well, they come up with all sorts of "lame-duck excuses" for such cloud formations. There are even some really technical names for condition of strict anonymity, our "Deep Sky" those that look exactly like "space-ships" and hang around all day or days—while they are supposed to have been formed by high winds, which do blow clouds right on by, viewers.]

Looking up towards the southeast over West Pond, she spotted the first jet. A second jet was laying billowing white banners to the north. Both aircraft appeared to be at over 30,000 feet. Turning her gaze due west, Brendt saw two more residents began complaining to the provincial environment lines extending over the horizon. She called Lou. Within 45 minutes the couple counted 30 jets.

This isn't right, S.T. thought. We just don't have that kind of air traffic here. While Lou kept counting, she went inside and started calling airports. One official she reached was guarded but friendly. He had relatives in West Pond.

The Air Traffic Control manager told Brendt her sighting was "unusual". His radars showed nine commercial jets during the same 45-minute

span. From her location, he said, she should have petitioned Parliament. Addressing the Canadian government been able to see one plane.

And the other twenty-nine? The FAA official confided off the record that he had been ordered "by a petition raising concern over possible government higher civil authority" to re-route inbound European airliners away from a "military exercise" in the area. "Of course, they wouldn't give me any of the particulars and I don't ask," he explained. "I just do my job."

Excited and puzzled by this information, S.T. and Lou got into their car and headed down Route 160. Looking in any direction they could see five or six jets flying at over 30,000 feet. Never in the dozen years they'd lived in rural Maine had they seen so much aerial activity.

A former U.S. Navy Intelligence courier, Maine. As she poured her first cup of coffee, the late Aubuchont was used to large-scale military exercises. But he told S.T. he had never seen anything this big. "It looked like an invasion," he later recounted.

> As Lou and S.T. completed their errands, the jets kept them company, leaving lines and even circles that resembled smoke rings. Even living near Kennedy, LaGuardia and Newark jetports, Aubuchont had never seen so many big jets performing identical manoeuvres in the same sky. Then they returned to Parsonsfield around four, the lines were starting to merge into a dingy haze.

> Richard Dean called back. After receiving S.T.'s message, the assistant WMWV news director had gone outside with other news staff and counted 370 lines in skies usually devoid of aerial activity.

Brendt put in another call to the FAA official. He had never heard of chemtrails. In their first face-toface interview, the chain-smoking controller Lou got up and looked. What kind of clouds run responsible for air traffic over the northeastern seaboard repeated his earlier statements on tape. reflect one or two percent of incoming sunlight. Similar military activities were ongoing in other Computer simulations by Ken Caldeira at Lawrence tankers flying north into Canadian airspace.

> Speaking before witnesses at WMWV on source answered a series of yes/no questions I helped Brendt prepare when she contacted me.

> After nearly three years on this case, I wanted to corroborate extremely high levels of aluminum [aluminium] powder found in samples of rainwater falling through thick sky plumes over Espanola, Ontario, in the spring of 1998.

> The Espanola lab tests were conducted after ministry. Severe headaches, chronic joint pain, dizziness, sudden extreme fatigue, acute asthma attacks and feverless "flu-like" symptoms over a 50-square-mile area coincided with what they termed "months of 'spraying" by photo-identified U.S. Air Force tanker planes.

> Another Espanola resident told me that mental confusion and short-term memory loss were so prevalent that forgetting where their cars were parked had become "a standing joke" in the tiny town.

on their behalf, defense critic Gordon Earle explained:

"Over 500 residents of the Espanola area have signed involvement in what appears to be aircraft emitting visible aerosols. They have found high traces of aluminum and quartz in particulate and rainwater samples.

"These concerns combined with associated respiratory ailments have led these Canadians to take action and seek clear answers from this government. The petitioners call upon Parliament to repeal any law that would permit the dispersal of military chaff or of any cloud-seeding substance whatsoever by domestic or foreign military aircraft without the informed consent of the citizens of Canada thus affected."

The Ministry of Defense eventually replies: "It's not us." Which was true. While the U.S. Air Force counts 650 four-engine KC-135 Stratotankers and 50 KC-10 Another driver almost went off the road as he Extenders in its active inventory, Canadian Forces do not fly armadas of tankers. But they do operate the biggest radar installation in Canada at CFB Comox on Vancouver Island, easily capable of tracking the American formations coming up from the south.

> "Was the classified operation a radar experiment?" we wanted to know. The barium spread in exercises conducted out of Wright-Patterson Air Force Base acts as an electrolyte, enhancing conductivity of radar and radio waves. "Wright Pat" has also long been deeply engaged in HAARP's electromagnetic warfare program.

#### A SKY SHIELD

#### TO COMBAT GLOBAL WARMING?

The puzzle pieces fell into place with Deep Sky's revelation that ATC radars were being "degraded" by tanker-released particles showing up as a "haze" on their screens. This radar characteristic matched the high concentrations of aluminum powder found along with a preponderance of quartz particles in Espanola's chemical-contaminated rainwater.

The tankers' aluminum powder emissions also matched the Welsbach patent. Issued in 1994 to the Hughes aerospace giant "for Reduction of Global Warming", the sky shield blueprint calls for dispensing microscopic particles of aluminum oxide and other reflective materials into the upper atmosphere to regions, he added. On his 'scopes' he could track the Livermore National Laboratory calculated that this would be enough to stop warming over 85 percent of the planet, despite an anticipated doubling of carbon in the atmosphere within the next 50 years.

> [H: Ah yes, but indeed, harmless colloidal silver which CAN'T turn anyone blue (at best ONLY silver salts might have limited ability to do so)—is called "possibly dangerous" to your health! My goodness, there is not an inch of the United States or populated Canada that has missed being sprayed in chemtrails clouding. And yes indeed, it IS dangerous to your health: physical and mental.]

> Lawrence Livermore priced the aerial spray program at U.S.\$1 BILLION a year—a cheap fix to maintain massive petroleum profits in the face of Kyoto's internationally agreed carbon cutbacks.

Livermore's founder, Edward Teller, lobbied hard for another chance to play with planetary processes. At the 1998 International Seminar on Planetary Emergencies, the Father of the H-bomb presented his Next Big Idea. Having earlier pressed for detonating nuclear bombs to carve new harbours out of On November 18, 1998, the people of Espanola American coastlines, Teller now called for reflective

chemicals to be spread like mirror-shades over the Earth. Or at least over allies who could agree in secret for this unprecedented geoengineering experiment to be carried out over their unsuspecting constituents.

In a draft report leaked to me soon after it appeared for peer review in May 2000, an expert panel chosen among 3,000 atmospheric scientists looked at Caldeira's computer simulations and agreed that Teller's scheme might work. But the IPCC warned against unpredictable upsets of the atmosphere, as well as against angry populaces reacting to "the associated whitening of the visual appearance of the sky".

Caldeira was so concerned he went public, warning that deflecting sunlight would further cool the stratosphere, concentrating icy clouds of ozone-gobbling CFCs that could destroy Earth's solar radiation shield.

Was the sky shield experiment already underway? Deep Sky hinted that it was.

Were the tankers involved in weather responding. "That approximates what I was told."

For the third interview we rephrased our key question. Were the tankers repeatedly observed on ATC radars involved in climate modification? I caught my breath as Deep Sky confirmed that this is what he was told was the object of the mission.

Here at last was our "smoking nuke" admission. After years of "airliner" double-speak, we could now corroborate Deep Sky's report of military aircraft dispensing reflective materials with an earlier report by a Canadian aviation official.

On December 8, 2000, Terry Stewart, the Manager for Planning and Environment at the Victoria International Airport, had broken this story wide open when he responded to a caller's complaint the previous day of Xs, circles and grids being woven over the British Columbia capitol. Leaving a message on an answering machine tape, later heard by more than 15 million radio listeners, the public servant explained: "It's a military exercise, U.S. and Canadian Air Force exercise that's going on. They wouldn't give me any specifics on it."

Stewart added that he found the incident—one of hundreds reported over Canada's West Coast since the fall of 1998—"very odd".

Tasked with defending Canadian airspace in the region, CFB Comox chose instead to defend a classified collaboration. "No military operation is taking place," the base information officer tersely told me when I called for details. But Stewart later told the Vancouver Courier that his information had come directly from CFB Comox.

#### CONTRAILS vs. CHEMTRAILS

Across the strait from the island air base, a concerned mother of three children was noticing that people in Gibsons were coming down with ailments that coincided with constant chemtrail activity. Suzanne Smart's husband contracted asthma; their children were always sniffling and coughing. Smart ended up in the small coastal town's Emergency unit with a sore throat, "super-stiff" neck, pounding headache and ears "ringing like crazy". Even her teeth hurt.

It was all very nerve-wracking. Smart contacted a Transport Canada investigator who had noticed the jet trails too and was convinced it was normal contrail activity. Why he took special notice of normal contrails was not explained. But the TC official told Smart he hoped the Canadian equivalent of the FAA would be notified of any military exercises taking place.

plumes over Gibsons, Smart checked with aviation authorities and found that no airline flight plans had been filed for that airspace at that time. Official weather data showed that when her photos of multiple white plumes were taken, the 30 percent humidity at 30,000 and 35,000 feet was less than half that needed for contrails to form.

As NOAA meteorologist Thomas Schlatter explains, for even short-lived condensation trails to form, "We're talking temperatures lower than about minus 76 degrees Fahrenheit, and humidity at jet altitudes of 70 percent or more".

Smart sent her findings to Transport Canada with a request for an explanation of how contrails could form when they couldn't. "It is my understanding," she wrote, "that the only way to form jet trails at yesterday's low humidity is to introduce very fine particulates into the atmosphere."

Smart's homework hit like hardball. According to modification? Our FAA source hesitated before the National Center for Atmospheric Research in Boulder, Colorado, the only way to form artificial clouds in warm dry air is to introduce enough particulates into the atmosphere to attract and accrete all available moisture into visible vapour. If repeated often enough, the resulting rainless haze can lead to drought.

> Following standard procedure to ignore all evidence contradicting the official line, Transport Canada's Rany Phillips responded by advising Smart to check out the "urban legends" Website ridiculing chemtrails.

> Col. Walter Washbaugh, Chief of the Congressional Inquiry Division for the Secretary of the Air Force in Washington, D.C., also calls chemtrails "a hoax". In an April 20, 2001, letter to a U.S. senator, Washbaugh blamed the increased number of contrails on "significant civil aviation growth in the past decade. [H: Wow, next they will blame the "aliens"!]

> He was right. A National Science Foundation study has found that, in certain heavy traffic corridors, artificial cloud cover has increased by as much as 20 percent since the jet age took off. Dr. Patrick Minnis, a CERES [H: Now there's a good name for you.] atmospheric researcher and ardent chemtrails critic at NASA's Langley Research Center, reports that cirrus cloud cover over the United States is up five percent overall because particulates in engine exhaust are acting as cloud-forming nuclei. As the number of flights currently exceeds 15 million annually worldwide, the NSF, NASA and EPA predict artificial clouds will intensify as air travel continues climbing sharply.

> What about chemtrails? Colonel Washbaugh ascribed widely reported grid patterns to overlapping aircraft flying north-south, east-west airways. The only thing wrong with this explanation, an air traffic controller told me in Texas, is that U.S. airways do not run north-south.

> The biggest laugh came when the Colonel told the senator: "The Air Force is not conducting any weather modification and has no plans to do so in the future."

> In fact, attempts to steer hurricanes by spraying heat-robbing chemicals in their paths began in the 1950s. The recipe for creating "cirrus shields" was outlined in an unusually arrogant U.S. Air Force study. Subtitled "Owning the Weather by 2025", the 1996 report explained how "weather force specialists" were dispersing chemicals behind high-flying tanker aircraft in a process the Air Force calls "aerial obscuration". [H: Aerial obscuration? (???)]

Official denials reached new altitudes of absurdity when another colonel claimed: "The U.S. Air Force does not conduct spraying operations the U.S. Navy's Kitty Chastain sat on her hotel

On June 17, 2001, after photographing massive over populated areas." USAF spokeswoman Margaret Gidding told a Spokane newspaper: "The Air Force doesn't do anything that emits anything other than a normal contrail, which is vapor."

> So were their replies. Apparently Anderson and Gidding had forgotten how U.S. Air Force spray planes crippled a country and a culture by dispensing over Vietnam thousands of tons of "Agent Orange" defoliants containing dioxin toxins as hazardous as plutonium.

#### SEEING IS BELIEVING?

In the end, it has proved impossible to continue skywriting giant billboards advertising government duplicity, while insisting they are not there. By the summer of 2001, the controversy entered a new phase. Pictures of contrails were being distributed to newspapers by the Associated Press, and "chemtrails" could be overheard in coffee shop conversations across an entire continent.

When it comes to chemtrails, seeing is disbelieving official disinformation. As public awareness grows, people like war veteran David Oglesby are looking up. The 11 fat plumes fanning out over his Coarsgold, California home did it for Oglesby last June.

"The trails formed a grid pattern," he told WorldNetDaily News. "Some stretched from horizon to horizon. Some began abruptly-and others ended abruptly. They hung in the air for an extended period of time and gradually widened into wispy clouds resembling spider webs."

A retired U.S. Air Force radar tech named Shimera called a colonel responsible for all military operations in central California. "What would you say if I said there are three aircraft up there right how?" Shimera asked. "Are they there?"

"No," the colonel replied. "They are not there."

The Houston study is not so easily dismissed. Mark Steadham was looking for contrails when he started observing the skies over this busy Texas hub last winter. Using FAA tracking software called Flight Explorer to identify each aircraft, Steadham clocked contrails trailing from Boeing, McDonnell-Douglas and Airbus airliners. All but two of these condensation trails sublimed into invisibility with five to 20 seconds; the only exception persisted for two hours and 25 minutes. (?)

Flight Explorer does not show altitudes for military jets, but according to the FAA, tankers and transports usually transit continental airspace at around 30,000 feet to ensure safe separation from airliners flying between 35,000 and 39,000 feet. Military "heavies" flying below 30,000 feet should not have contrails at all. Major-General Gregory Bartow confirms that Air Force tankers do not perform refueling missions at contrail-forming altitudes.

But Steadham found just the opposite in his study. While observing air traffic for 63 days, the Houston skywatcher found that thick white plumes laid by similar-sized military aircraft—at the same time, in the same airspace as 20-second airliner contrails—lingered for four to eight hours.

#### GLOBAL CHEMTRAIL REPORTS

Sightings of oddly lingering plumes sometimes resembling rocket trails are not confined to North American skies.

While on leave in Italy in the summer of 1999,

just offshore over the Bay of Naples. "People quarter-million Americans who have died were coughing all over Naples," she wrote. On the bus ride in from the base, Chastain explained chemtrails to many sailors with hacking coughs.

On October 12 that same year, a Paris correspondent reported "... heavy activity from all directions, X upon X. The pilots here seem to like to play chicken; they fly right at each other and then one will swerve, their trails forming pitchforks and Xs." No contrails were being left by "normal planes" in the same skies. But the next day, planes flying with more Xs that continued into the evening.

In Spain on April 27, 2000, American tourist John Hendricks dashed off a quick e-mail from El Cafe de Internet: "Were we surprised to see that the chemtrails Mallorca and in Barcelona." He and his wife "took plenty of pictures" before noticing a postcard they'd bought captured a perfect chemtrail.

"Add Sweden to the list," a Swedish resident wrote after spotting eight to 10 parallel trails and contracting flu for the first time in years. Weather conditions at the time were not conductive to contrail formation. "I know the commercial routes, and we have a bunch of them, but not where these trails were."

Chemtrail activity has been reported in at least 14 allied nations including Australia, Belgium, Britain, Canada, France, Germany, Holland, Ireland, Italy, New Zealand, Scotland, Sweden and the United States. Croatian chemtrails began the day after that country joined NATO.

#### ATMOSPHERIC ORGANISMS

Many chemtrails observers note that chemtrails are often laid down at the leading edge of approaching frontal systems. While rare "sundogs" form ice-crystal circles around the Sun in advance of strong winds, much more common "chemdogs" create prismatic solar halos during stable weather.

Are we worried yet? An August 2001 WorldNetDaily poll asked Americans: "Do you think 'chemtrails' are anything to worry about?" Forty-three percent answered "Yes"; another 30 percent wanted more information on chemtrails—a total 73 percent of U.S. respondents are concerned about chemtrails.

#### BIN LADEN NETWORK PROFITED FROM DIAMOND TRADE

WASHINGTON (Reuters)—Saudi-born militant Osama bin Laden's al-Qaida network has collected millions of dollars in the past three years from the illicit sale of diamonds mined by rebels in Sierra Leone [Africa], The Washington Post reported.

Quoting unnamed U.S. and European intelligence officials and two sources with direct knowledge of the diamond sales, the Post described an operation that has helped finance al-Qaida.

The paper said diamond dealers working with men identified by the FBI as important al-Qaida figures bought rebel diamonds at below-market prices and sold them for big profits in Europe.

The Post quoted unnamed sources [H: I'm sure of that unnamed part.] as saying that since July, these diamond dealers have bought far more diamonds than usual, paying premium prices for them.

The rebel Revolutionary United Front (RUF) hit back, saying the report was "malicious, diabolical and sinister" and denying any link with the group blamed by Washington for the Sept. 11 suicide attacks on the United States.

"The RUF has no business with any terrorist organization. Nor has it done any business transaction with terrorists," said a statement in the Sierra Leone capital Freetown from the group, which has condemned the September attacks.

The Post said investigators believe the increased purchases suggest that al-Qaida, perhaps anticipating its accounts would be frozen after Sept. 11, strove to protect its money by sinking it into diamonds, which can be hidden easily, hold their value and are hard to trace.

"I now believe that to cut off al-Qaida funds and laundering activities you have to cut off the diamond pipeline," the Post quoted an unnamed [H: There you go again...!] European investigator as saying, "We are talking about millions and maybe tens of millions of dollars in profits and laundering."

The diamonds were mined by RUF rebels, known from Sierra Leone's decade-long civil war for hacking off the limbs of civilians and abducting children and forcing them onto the battlefield, the Post said. [H: Probably had a holocaust as well.]

The country's main diamond fields have been under RUF control for four years, but UN peacekeepers have deployed there in recent months and disarmed thousands of rebels under a peace plan.

Quoting sources, the Post reported that small packets of diamonds are transported across the Liberian border to Monrovia by senior RUF commanders.

At a Monrovia safe house protected by the Liberian government, the diamonds are then exchanged for briefcases filled with cash brought by diamond dealers who travel several times monthly from Belgium to Monrovia, the Post said.

In Chicago, home of the Chicago Board Options Exchange (CBOE), the largest of the five options If, in addition, anyone who turned blue from exchanges in the nation, brokers and speculators a stock price will do. In options trades there are winners and losers regardless of the outcome.

> The catastrophic events of Sept. 11 were no different; the devastation at the World Trade Center resulted in some speculators winning millions of dollars from options purchased at the CBOE—while others lost their lives.

A \$2.5 million winning that resulted when the United Airlines share price fell after two of its planes crashed remains unclaimed more than six weeks after the tragedy.

Investigations into the unusually high number of "put" options, betting that the price of United Airlines (UAL) and American Airlines shares would fall, have revealed that Alex Brown Inc., an investment banking firm, purchased many of these option contracts.

Alex Brown Inc. was, until 1998, managed by the man who is now the executive director of the Central Intelligence Agency, A.B. "Buzzy" Krongard.

Krongard, 64, former head of Baltimore-based Alex Brown, America's oldest investment bank, joined the CIA three years ago as a counselor to Director of Central Intelligence George Tenet.

Krongard switched careers shortly after helping engineer the \$2.5 billion merger of Alex Brown and Bankers Trust New York Corp., gaining \$71 million in Bankers Trust stock in the process.

President Bush appointed Krongard executive director of the Central Intelligence Agency on March 26. From February 1998 until March 2001, Krongard served as COUNSELOR TO THE DIRECTOR OF CENTRAL INTELLIGENCE. Until 1997 Krongard was chairman of the investment bank A. B. Brown, having previously worked in various capacities of Alex Brown.

Krongard was quoted on the relationship between Wall Street and the CIA in an article by The Washington Post, "The whole OSS was really nothing but Wall Street Bankers and lawyers."

#### **OPTIONS SPIKES**

Between Sept. 6 and 7, the CBOE saw a dramatic spike in the purchases of "put" options on United Airlines stock compared to "call" options.

A "put" option increases in value when the stock price falls, while a "call" option increases if the share price rises. The ratio of "put" options to "call" options was 12 to 1, with 2,372 "put" options purchased, betting that UAL stock would fall compared with 198 "call" options. The winners on these options deals walked away with untold millions of dollars in profits.

On Sept. 10, speculators in Chicago purchased "put" options on American Airlines, the other airline involved in the hijackings, at a ratio of 6 to 1 against "call" options. Traders bought 2,258 "put" options as compared with 374 "call" options the day before the crashes.

There were similar spikes in "put" option contracts on the shares of the investment firms of Morgan Stanley Dean Witter & Co. and Merrill Lynch & Co., major tenants of the World Trade Center, occupying 22 floors each, who were both devastated by the terror attacks.

In the three days of trading prior to Sept. 11, Morgan Stanley "put" options spiked dramatically.

According to figures provided by Options Clearing Corp. of Chicago, during the two trading days before the attacks the total number of "put" options jumped to 7,647 compared with a daily average of 2,384 during the month of August. Morgan Stanley's shares fell from \$48.96 to \$42.50 in the aftermath of the attacks.

Likewise, Merrill Lynch "put" options jumped to 64,445 in the three days before the attacks. On Sept. 10, 28,960 "put" options were purchased on Merrill Lynch compared with a daily average of 5,430 during the month of August. Merrill's shares fell from \$46.88 to \$41.50.

Hidden subsidies are frequently listed under innocuous budget titles in a "budgetary sleight of hand," said a report by William D. Harting of the World Policy Institute.

Congress routinely approves about \$3 billion in foreign aid to Israel.

Next year's Foreign Operations FY 2002 Appropriations legislation (H.R. 2506), which passed the House, 381-46, on July 24 and the Senate, 50 to 46, on Oct. 15, publicly details a portion of the economic and military assistance—called "grants"—slated to be given Israel.

In the section of the appropriations bill, titled "Foreign Military Financing," Congress provides:

[H: In the article this is quoted in inset smaller print. I ask, please, that we capitalize it, bold it and italicize it:]

...NOT LESS THAN \$2,040,000,000 SHALL BE AVAILABLE FOR GRANTS ONLY FOR ISRAEL, AND NOT LESS THAN \$1,300,000,000 SHALL BE MADE AVAILABLE FOR GRANTS ONLY FOR EGYPT: PROVIDED FURTHER, THAT THE FUNDS APPROPRIATED BY THIS PARAGRAPH FOR ISRAEL SHALL BE DISBURSED WITHIN 30 DAYS OF THE ENACTMENT OF THIS ACT OR BY OCTOBER 31, 2001. WHICHEVER IS LATER: PROVIDED FURTHER. THAT TO THE EXTENT THAT THE GOVERNMENT OF ISRAEL REOUESTS THAT FUNDS BE USED FOR SUCH PURPOSES, GRANTS MADE AVAILABLE FOR

> The money is placed into bank accounts, which Israel can draw upon to purchase equipment. Meanwhile, bankers garner huge profits from interest on the "grant money" at the expense of U.S. taxpayers.

> However, another \$2.5 billion "loan" is often made so Israel can purchase additional arms from American companies. This "loan" is quietly forgiven in an amendment to an obscure piece of legislation each year.

> "Forgiveness" legislation is a popular foreign policy weapon. The other giveaways are carefully hidden from the public and many of the legislators who vote for the \$15.6 billion foreign aid package and other legislation that transfers tax dollars to Israel.

> Many more billions are given away by selling "surplus" modern military technology at steep discounts. Some such "surpluses" are discounted by 85 percent of market value.

> A 1996 report by the Arms Sales Monitoring Project of the Federation of American Scientists found that the United States gave away or sold at a steep discount weaponry that cost taxpayers \$8.7 billion.

> So taxpayers paid twice: once for the forgone proceeds from the sale of still-useful weaponry to foreign nations and again for the cost of replacement items.

> Another conduit of American tax dollars to Israel is the "economic support funds" administered by the Agency for International Development. It is funded by the "international affairs" budget. In fiscal year 1999, Israel received \$1 billion from this source, which is typical. Next year Israel will receive \$750 million.

#### HOW ABOUT AMERICA?

Another means of secret funds for Israel was reported by David P. Yohanna of Chicago in March 1993. He wrote in the Chicago Tribune:

"The true total aid to Israel in 1993 is as follows: on American taxpayers give Israel at least \$10 billion budget, \$3 billion; off-budget, \$1.2 billion; interest paid by U.S. on above, \$50 million; U.S. loan guarantees to Israel, \$2 billion: compound interest on previous grants. (1951-1992). \$5 BILLION. [H: And you doubt the GAIA interest growth?]

> "Total 1993 grants, interest, loan guarantees and compound interest: \$11.3 billion," Yohanna wrote.

> This accounting does not take into consideration Israeli bonds that are widely sold, not only to supporters but to unsuspecting taxpayers in every state.

> American Free Press has no detailed studies but it appears that 40 years ago most states outlawed state purchases of securities from outside the country. But apparently such laws were repealed or are being ignored in all 50 states, benefiting Israel by even more billions.

> But much of the disguised funds for Israel come from "petty cash" operations that go undetected. For example, during fiscal year 1997, the Pentagon gave Israel \$68 million worth of weaponry under something it calls the "excess defense articles program".

> Obviously, \$10 billion a year, if spent at home instead of going to fuel Israel's war machine, could benefit Americans handsomely. Two examples:

- \* Only a fraction of the \$10 billion could offset the \$300 million in annual "savings" the administration wants to accomplish by reducing muchneeded benefits given to disabled veterans and families of those killed in war by 10 percent.
- \* A modern transportation system, with fast, on-time trains, efficient airline service and unclogged highways could quickly emerge if funded by \$10 billion a year.

Probably the most difficult task in this work will be to get across to the reader what is really an elementary observation: that the objective of The Order is neither "left" nor "right". "Left" and "right" are artificial devices to bring about change, and the elements in a process of controlled change.

The answer to this seeming political puzzle lies in Hegelian logic. Remember that both Marx and Hitler, the extremes of "left" and "right" presented as textbook enemies, evolved out of the same philosophical system: Hegelianism. Today this process can be identified in the literature of the Trilateral Commission where "change" is promoted and "conflict management" is termed the means to bring about this change.

In the Hegelian system conflict is essential. Furthermore, for Hegel and systems based on Hegel, the State is absolute. The State requires complete obedience from the individual citizen. An individual does not exist for himself in these so-called organix systems but only to perform a role in the operation of State. There was no freedom in Hitler's Germany, there is no freedom for the individual under Marxism, neither will there be in the New World Order. And if it sounds like George Orwell's 1984—it is.

So who or what is the State? Obviously it's a self-appointed Elite. It is interesting that Fichte, who developed these ideas before Hegel, was a Freemason, almost certainly Illuminati, and certainly was promoted by the Illuminati. #### **EMERGENCY BANKING REGULATION**

As put forth by Robert B. Anderson,

[QUOTE:]

- (a) As used in this Regulation, the term "banking institution" shall include the following banking and financial institutions: every commercial bank, trust company, private bank, savings bank, savings and loan association, building and loan association, cooperative bank, homestead association, credit union, and United States Postal Savings depository office authorized under the laws of the United States or of any State to subject to its jurisdiction, or any receiver or conservator for any of the foregoing.
  - (b) As used in this Regulation, "operations and owner in another banking institution.

> Section 1. Temporary Curtailment of Operations and Functions. Any Federal Reserve Bank, Federal Home Loan Bank, banking institution, or branch may temporarily curtail, place of business separate and apart from the head office of a Federal Reserve Bank, Federal Home Loan Bank, or banking institution in which any of its operations and functions are carried out.

#### CHAPTER V: RESTRICTIONS ON CASH WITHDRAWALS AND TRANSFERS OF CREDIT

Section 1. Cash Withdrawals. (a) Withdrawals checks or drafts, the making of loans in cash, or any other form of cash disbursement are prohibited except for those purposes, and not in excess of those amounts, for which cash is customarily used.

- (b) Banking institutions are further authorized to restrict and ration cash withdrawals to the extent necessary in the event a sufficient amount of cash should not be available.
- (c) Banking institutions shall prohibit withdrawals of cash in any case where there is reason to believe that such withdrawal is sought for the purpose of hoarding.

Section 2. Transfers of Credit. (a) No depositor or share or savings account owner may transfer in any manner or by any device whatsoever any balance to his credit on the date on which this Regulation becomes effective, except for the payment of (i) expenses or reconstruction costs vital to the war effort, (ii) essential living costs, (iii) taxes, (iv) payrolls, or (v) obligations incurred before the date on which this Regulation becomes effective, to the end that the best interests of the war effort and the public will be served.

- (b) Banking institutions shall prohibit the transfer of credit in any case where there is reason to believe that such transfer is sought for any unauthorized purpose.
- (c) After this Regulation becomes effective, banking institutions shall retain until released by Federal authority the original or a photographic copy (face and reverse sides) of each check and other evidence of transfer of credit in the amount of \$1,000 or more.

Section 3. Exceptions to Restrictions. (a) transact business in the United States or any place Balances in deposit or share or savings accounts may be transferred from one banking institution to a deposit or share or savings account of the same

- Chapter shall not apply to any check or draft negotiated for value prior to the time this its "rulers" and the States, as well as the cartel Regulation becomes effective.

#### CHAPTER VI: LENDING AND EXTENDING CREDIT

Section 11 (original printing error). Making Loans and Extending Credit. No banking institution may make any loan, extend any credit, or discount or purchase any obligation or evidence of debt, unless it is established and certified in writing by the borrower and a banking institution that the purpose is to pay (i) expenses or reconstruction costs vital to the war effort, (ii) essential living costs, (iii) taxes, or (iv) payrolls, to the end that the best interests of the war that he was trained through his individual experiences effort and the public will be served.

Section 2. Exceptions to Restrictions. #### IN DEFENSE OF THE NORTHERN ALLIANCE

Here is what we know about the Northern Alliance, the main military opposition to the Taliban in Afghanistan: Its soldiers are mostly <u>Tajiks</u> and <u>Uzbeks</u>, though other ethnic groups have joined the alliance as well. The military unit has a motley collection of weapons. Its soldiers are famously brave and famously unreliable. The alliance has been funded by the Russians, the Uzbeks and Iran. Ex-members of the Clinton administration say the alliance helped the CIA try to kill Osama bin Laden.

Here is what we don't know: Is the Northern Alliance our ally in Afghanistan? Should it be?

Just before the bombardment of Afghanistan, Defense Secretary Donald Rumsfeld made it sound as if he was already in contact with the group. They "know the land," he said at one point about alliance soldiers. "They can be a lot of help."

As the bombing campaign began, however, our new friendship with the alliance lost its bloom. In the early days, American planes did not bomb Taliban frontlines, apparently on the grounds that the administration did not trust the alliance and did not want its commanders to march into Kabul too quickly. The press changed its tone as well. Salon, among others, accused the alliance's leaders of "shocking human-rights records, thievery and sheer governing incompetence." A more recent *Washington Post* report described the alliance as "tired, hungry and ill-equipped to face the Taliban."

Recently, however, we seem to have returned to Square 1: The most optimistic scenarios for the war have been abandoned. Weeks have passed but we haven't found bin Laden and haven't forced the Taliban leaders to make mistakes. Fewer Taliban soldiers have defected than expected. Perhaps this explains why we have begun to bombard Taliban artillery that threatens the alliance. Like it or not, the Northern Alliance is the only serious fighting force in the country. Like it or not, it still is our only potential friend in Afghanistan.

For many, this will seem like bad news: The Afghan conflict has been extremely brutal and there have indeed been abuses, thuggery and theft on all sides. No Northern Alliance faction is exempt from criticism. In this conflict, there are no men in white hats.

There is, however, some good news. Here are a few reasons to feel a sliver of optimism:

\*They aren't fanatics. While many of the Northern Alliance are devout and even orthodox Muslims, its members have a very different reputation from the Taliban. When the Northern Alliance leader Ishmael Khan was in charge of Herat, girls went to school. When the Taliban took over, the girls were sent home. Generally speaking, the alliance culture is the culture of pre-Sovietinvasion Afghanistan: easygoing, relatively liberal. The alliance has never had any ambition to export Islam.

\*Contrary to some reports, not all of the Northern Alliance's commanders are semiliterate, drug-dealing, cavedwelling guerrillas. While this may be an accurate description of some of their soldiers, the Northern Alliance still is the only Afghan government widely recognized around the world. Its foreign minister, Abdullah Abdullah, is well-spoken, well-regarded and well-traveled (particularly of late). These are people that the West has dealt with before.

They are meritocrats. By this, I mean that Tajik military commanders have become military commanders on the

grounds of military ability, not on the grounds of their tribal or clan position. During the war against the Soviet Union, not all ethnic groups followed this rule. A great deal of mysterious infighting still takes place among alliance factions but faction members do seem to be capable of making some compromises and following leaders of other ethnicities.

They are adaptable. In the 1980s, the Northern Alliance fought the Russians. Now Russia has changed, the war has changed and the Northern Alliance seems happy to accept Russian support. This is a small point but it does reveal something about the alliance's mentality. Unlike bin Laden, who hates all Americans—bankers, postmen, politicians—the Northern Alliance can distinguish between Russia and the Soviet Union. This speaks well for the ability of its leaders to work with us.

More important, the Northern Alliance has been our ally before. Many of its commanders did fight, successfully, with the U.S. against the Soviet Union. The alliance's murdered leader, Ahmed Shah Masoud, perhaps tragically, was not the main recipient of U.S. aid during the Afghan-Soviet war—that was in part because the U.S., relying on the advice of the ISI, the Pakistani secret service, had been talked into backing more fanatical groups. We shouldn't allow the ISI, which deeply opposes the Northern Alliance, to mislead us on Afghanistan again.

Even more important, we haven't got a choice. There simply isn't another large, organized, native military force that is prepared to fight the Taliban on the ground in Afghanistan and it would be madness for us to consider fighting the Taliban in any other way. As things stand right now, the alliance may not be the best ally but it's the only one we've got.

## REBELS ILL-EQUIPPED FOR BATTLE, POORLY TRAINED AND ARMED, THEY AWAIT U.S. HELP

KURUK, AFGHANISTAN—Commander Daoulad didn't have enough fingers to tick off the wish list of gear he said he needed to finally counterattack his old enemy, the Taliban.

Crouched with his tattered band of Northern Alliance fighters in a muddy trench only 170 yards from Taliban frontline positions, he ignored the racket of nearby gunfire to list everything from more bullets to new shoes, from fresh mortar rounds to unbroken tea glasses, from heavy machine guns to bottles of cooking oil.

"America needs to help more," insisted Daoulad, who like many Afghans uses one name. "So far they have done nothing for us."

Even the previous day's ferocious B-52 strikes on the Taliban lines facing him did not change his view. "Unless there is more," he said, surrounded by freshly dug graves marked with handfuls of rocks, "I wait."...

Pentagon officials promised to supply the troops the gear they need, while Defense Secretary Donald Rumsfeld on Saturday sought more assistance from Tajikistan and Uzbekistan that would help supply

Northern Alliance-held areas along their borders.

President Bush defended the progress of the U.S.-led bombing campaign, which now is four weeks old, saying that it's a "different kind of war".

But it seems very familiar to the Northern Alliance, an army that does not appear ready to risk a dangerous step forward.

Badly trained, badly armed, badly equipped, the Northern Alliance seems to be no challenge for the Taliban today and perhaps for months to come. Its formal name is the United Front, but that is a misnomer. Its forces are an amalgam of warlord militias and troops loyal to the exiled Afghan government. The independent-minded warlords pretty much do what they like.

Until U.S. bombs began raining down on the Taliban on Oct. 7, the Northern Alliance was squirreled away in one-tenth of Afghanistan, desperately trying to hold on to a mostly mountainous, poverty-stricken stretch of land.

"We were not attacking, we were defending," said Commander Hasan, a widely respected leader of one of the militias in northern Afghanistan.

Some analysts suggest that if the U.S. is not cautious, it could end up making decisions in Afghanistan similar to those it made during the Afghan uprising against the Soviet Union in the 1980s. During that conflict, Washington decided to support Gulbuddin Hekmatyar, a radical Afghan freedom fighter whose movement attracted a young Saudi exile named Osama bin Laden. The result was the flowering of militant Islam worldwide and the birth of bin Laden's al-Qaida network.

The Northern Alliance's problems are many. To begin with, the rebels lack almost everything an army needs to fight.

"If we get some ammunition, some weapons, some wheat, some shoes, some oil and gas, then we can fight," said Gen. Mohiballah Khan, one of the exiled government's commanders in northern Afghanistan, repeating a refrain heard among opposition military leaders.

Despite loud appeals to the world, leaders of the Northern Alliance complain that few nations have come to their rescue. "The Russians gave us meat, milk and wheat and some ammunition. That is all," Commander Hasan said.

Although Moscow promised to send heavy equipment to match that of the Taliban, nothing has shown up, said Bariyola Khan, deputy minister of defense.

Except for coordinating their own bombing runs, the U.S. military has offered little help, said Gen. Khan. As for Washington's promise to send U.S. Special Forces personnel to provide technical assistance on the ground, Khan said none has shown up in northern Afghanistan, where the Northern Alliance has been talking about launching an attack.

"If [Americans] are here, I have not seen them," he said. Daniel Byman, an expert on Afghanistan with the Rand Corp.'s Center for Middle East Public Policy, agreed that the Northern Alliance's troops are unlikely to race soon toward the capital, Kabul. "They need to learn to mobilize for major operations again, and now winter is biting at their heels," he said.

"Bringing in sufficient supplies for a major assault before winter seems pretty unrealistic," Byman said. "Given the tasks before them, I think the Alliance will need the entire winter to get themselves into shape, or maybe even more time than that."

At most, Northern Alliance officials say they can muster about 15,000 armed and trained fighters. They figure the Taliban can call up to 60,000 fighters, at least half from Pakistan, Chechnya, China and the Arab world.

The number of Taliban fighters also appears to be growing as bands of new fighters travel across the high mountain passes linking Pakistan with Afghanistan, according to Northern Alliance officials. Word of these new arrivals last week quickly deflated Alliance leaders, who were counting on the U.S. bombing to weaken the spirit of the Taliban soldiers.

Instead, they believe the fresh soldiers bolstered the Taliban's morale. Now, rather than planning their own

attack, some rebel commanders have shifted into thinking about how they can defend themselves.

'It is a very difficult situation," said Commander Hasan. "If we don't do something soon, all of the terrorists in the world will be fighting with the Taliban."

But the chances of the Northern Alliance doing something soon seem slim.

Afghanistan's much-vaunted winter only adds to the opposition's tactical disadvantage. The craggy peaks where the Taliban fighters are based are difficult to assault....

The rebels' supply lines are another weak point inhibiting a full-scale assault on Taliban positions. A single enemy artillery shell could knock out the coalition's sole road link to Tajikistan, a crucial back channel for food and ammunition. A rickety ferry, exposed to Taliban fire, chugs across the border river there, hauling one dilapidated truck at a time.

The first key test of the rebels' military viability, by almost all accounts, will be the battle for Mazar-i-Sharif, a crucial crossroads that dominates much of northern Afghanistan. The Taliban wrenched the city from Northern Alliance troops in bloody fighting in 1998. In recent weeks, opposition forces have tried to take it back but were repelled by powerful Taliban counteroffensives.

If the reactions of civilians in Mazar-i-Sharif are a Northern Alliance has reason to worry.

Phone calls last week to inhabitants of the key city revealed few signs of hardship or panic. Stores still were well-stocked with food, and life was orderly, residents said. They added that the city was packed with Taliban reinforcements, many of them Arab and Pakistani volunteers.

"Nobody is leaving the city," said a merchant reached by cellular phone. "Business is still good."

With the news from the fronts so discouraging, opposition warlords increasingly seem to be taking a passive, wait-and-see attitude about greater U.S. military action before committing their own bedraggled troops to further ground operations.

In the meantime, their fighters polish their ancient Russian-made AK-47 Kalashnikovs for the benefit of foreign journalists...

#### **DELTA FORCE MET** HEAVY TALIBAN RESISTANCE—REPORT

WASHINGTON (Reuters)—Twelve elite U.S. Delta Force commandos were wounded by Taliban troops in an Oct. 20 raid in southern Afghanistan and some American officers were angered by the Pentagon's film show of a separate parachute strike that night, according to a report released on Saturday.

Despite comments by the chairman of the Joint Chiefs of Staff that resistance to the two raids was light, author Seymour Hersh wrote in The New Yorker magazine the Taliban surprised U.S. forces with a fierce firefight at one target.

Hersh reported in the Nov. 12 issue the fight erupted as members of the elite and secret Delta Force emerged from a house in a compound near Kandahar sometimes used by Taliban leader Mullah Mohammad Omar, who was not there.

"It was like an ambush," he quoted one senior officer as saying. "The Taliban were firing light arms and either RPGs (rocket-propelled grenades) or mortars."

It was "a tactical firefight, and the Taliban had the advantage," the officer told Hersh, who reported that 12 U.S. commandos were wounded, three of them seriously.

Defense officials declined to comment on the good indicator of the tides of the war, then the Hersh report or discuss further details of last month's raids in response to questions from Reuters.

> But Hersh, who earlier was the first to report that the United States was using missile-armed unmanned reconnaissance drones over Afghanistan, said some U.S. officers were furious because the Pentagon showed reporters dramatic films of a separate parachute raid that night by Army Rangers on an airfield near Kandahar.

> Some officers and Delta Force troops viewed with disdain showing combat films of the jump and of Rangers on the ground instead of keeping such operations from public view, according to the report.

> Hersh said the raids prompted bitter internal debate in the U.S. military and caused the Central Command based in Tampa, Florida, to revisit plans for such strikes in Afghanistan.

> Air Force Gen. Richard Myers, chairman of the Joint Chiefs of Staff, told reporters only hours after the Special Operations forces left Afghanistan last month that the raid was a success.

"There were casualties on the other side," said Myers, Afghanistan's ruling Taliban military to the raids.

"Special Operations forces including U.S. Army Rangers deployed to Afghanistan. They attacked and destroyed targets associated with terrorist activities and Taliban command and control," Myers said. He refused to say exactly how many troops were involved, but U.S. officials said privately at the time the raids involved well over 100 soldiers.

Although the main purpose of the two raids was to seek intelligence information on the Taliban and al-Qaida network of fugitive Osama bin Laden, defense officials later acknowledged privately that documents and other material seized by the American troops provided little of major intelligence value.

Hersh noted that Britain's Sunday Telegraph reported on the day after the raids the United States had requested the immediate assignment to Afghanistan of the entire regiment of Britain's elite Special Air Service commandos.

Although Britain has openly committed several hundred special forces troops to the region, there has been no indication that such a large contingent might be sent.

One senior U.S. military officer was quoted by Hersh as criticizing the planning for the Oct. 20 attacks as "Special Ops 101".

"I don't know where the adult supervision for these operations is," the officer added.

#### U.S. LOSING BATTLE TO DISLODGE TALIBAN

PESHAWAR, PAKISTAN—The Taliban is emerging from four weeks of U.S. air strikes with its political control over Afghanistan intact and its stature enhanced, both among ordinary Afghans and beyond Afghanistan's borders among Muslims who opposed the bombing campaign from the very beginning.

Efforts to forge a political alternative to the Taliban regime from the many exiled Afghan opposition leaders and movements have been paralyzed by personal, political and regional rivalries, while hoped-for splits within the Taliban leadership have failed to materialize.

Instead, a U.S. strategy predicated upon hopes that a Taliban force weakened by the bombing would fall prey to internal rifts and rebellion by disgruntled Afghans appears to be having the opposite effect, say Afghan analysts and Pakistani officials.

Mounting reports of civilian casualties and the failure to capture or kill a significant Taliban leader or Osama bin Laden associate are starting to convince many ordinary Afghans that the Taliban is right and that America's war is aimed not at eliminating terrorism but at destroying Afghanistan and Islam.

The Pentagon said Friday that there had been defections from among the Taliban leadership and reports of uprisings involving tribesmen in the south of the country. The U.S. military assault began Oct. 7 after the Taliban refused demands to turn over bin Laden, the alleged mastermind of the Sept. 11 terrorist attacks in the United States.

But those monitoring developments inside Afghanistan from the border town of Peshawar are skeptical about news of growing unrest.

"I don't see it," said Pakistan's former charge d'affaires in Kabul in referring to the alleged defections. "If it's happening, I don't know where and I don't know who," said Syed Fida Yunes, who remains in close contact with Afghan officials.

On the contrary, he said, after the initial confusion unleashed by the start of the bombardments, the Taliban has now moved to reassert its control over those provinces considered most likely to rebel. The regime has replaced some local administrators suspected of plotting against it and has won back the loyalties of tribal elders who had considered switching their allegiance.

Afghan refugees arriving in Peshawar to escape the bombing also say support for the Taliban has surged in recent weeks.

"There was some support for America before the bombing started, but since these attacks there is a wave of sympathy for the Taliban," said Ubaid Ullah, 28, who left Kabul last week. "The Americans are crushing the entire Afghan nation for the sake of one man."

The increased level of U.S. military support to the Northern Alliance is bolstering the Taliban's support among ethnic Pashtuns, who dominate the great majority of Afghanistan under Taliban control. Although there are serious doubts about the military capabilities of the opposition, the reports of significant U.S. military aid and boasts that an alliance victory at the strategic town of Mazar-i-Sharif are imminent, fill many Pashtuns with alarm.

Western diplomats say they recognize that a Northern Alliance victory could be counterproductive. They also say there is no intention of allowing opposition forces to take the capital, Kabul, at least not before a political agreement is worked out involving all the rival factions.

Rather, the Northern Alliance force will be used to wear down Taliban defenses and force the regime to

divert resources from elsewhere, say the diplomats.

But a political settlement could be weeks, months or even years away. The only alternative option currently under consideration focuses on exiled former King Mohammed Zahir Shah, who lives in Rome, and a proposal to convene a gathering of leaders and elders under his authority.

But Afghan's opposition leaders have been talking about such a gathering for nearly 10 years, without result. There are currently at least six initiatives under way, with each promoter refusing to acknowledge the other's effort.

In the absence of any clear alternative and without any assurances of support from the outside world, there is no appetite to challenge the Taliban even among those who might have otherwise welcomed the regime's downfall.

Pakistani intelligence sources say a fledgling uprising by tribesmen in three provinces along the border fizzled as the bombing campaign got under way and sympathies swung back toward the Taliban.

An uprising cannot be precluded, say opposition leaders and Pakistani officials.

But the longer the bombing continues without dislodging the Taliban or producing signs of progress toward a political alternative, the harder it will be to challenge the current Afghan regime, analysts say.

"It's a race against time," said Yunes. "The greater the damage in Afghanistan, the more support there will be for the Taliban and the longer they will survive."

## U.S. TAXPAYERS SEND BILLIONS TO OUR ENEMIES IN AFGHANISTAN

Even before September 11th, most Americans were well aware of the hostility that many Middle Eastern nations have for the U.S. Our experiences with Iran, Libya, Iraq, and now Afghanistan have understandably soured many Americans on the entire region. Indeed, the majority of anti-American sentiment in the post-Cold War era originates in the Middle East. What many Americans don't realize, however, is the extent to which their own foreign aid tax dollars are spent funding our current and future enemies in the region.

We should recognize that American tax dollars helped to create the very Taliban government that now wants to destroy us. In the late 1970s and early 80s, the CIA was very involved in the training and funding of various fundamentalist Islamic groups in Afghanistan, some of which later became today's brutal Taliban government. In fact, the U.S. government admits to giving the groups at least \$6 billion in military aid and weaponry, a staggering sum that would be even larger in today's dollars.

Bin Laden himself received training and weapons from the CIA, and that agency's military and financial assistance helped the Afghan rebels build a set of encampments around the city of Khost. Tragically, those same camps became terrorist training facilities for bin Laden, who uses some of the same soldiers our military once trained as lieutenants in his sickening terrorist network. Our heroic pilots are now busy bombing the same camps we paid to build, all the while threatened by the same Stinger missiles originally supplied by our CIA. Once again, the stark result of our foreign aid, however well-intentioned, was the arming and training of forces that later become our enemy.

Our foolish funding of Afghan terrorists hardly ended in the 1980s, however. Millions of your tax dollars continue to pour into Afghanistan even today. Our government publicly supported the Taliban right up until September 11. Already in 2001 the U.S. has provided \$125 million in so-called humanitarian aid to the country, making us the world's single largest donor to Afghanistan. Rest assured the money went straight to the Taliban, and not to the impoverished, starving residents that make up most of the population. Do we really expect a government as intolerant and anti-west as the Taliban to use our foreign aid for humane purposes? If so, we are incredibly naive; if not, we foolishly have been seeking to influence a government that regards America as an enemy.

Incredibly, in May the U.S. announced that we would reward the Taliban with an additional \$43 million in aid for its actions in banning the cultivation of poppy used to produce heroin and opium. Taliban rulers had agreed to assist us in our senseless drug war by declaring opium growing "against the will of God". They weren't serious, of course. Although reliable economic data for Afghanistan is nearly impossible to find (there simply is not much of an economy), the reality is that opium is far and away the most profitable industry in the country. The Taliban was hardly prepared to give up virtually its only source of export revenue, any more than the demand for opium was suddenly going to disappear. If anything, Afghanistan's production of opium is growing. Experts estimate it has doubled since 1999; the relatively small country is now believed to provide the raw material for fully 75% of the world's heroin. How tragic that our government was willing to ignore Taliban brutality in its quest to find "victories" in the failed drug war.

U.S. taxpayers have a right to know exactly what we're getting for our foreign aid dollars. Have we helped bring peace and prosperity to Afghanistan? Have we eased suffering there? Have we added to stability in the region? Have we earned the love or respect of the Afghan people? Have we made an ally of the Taliban government? The answer to all of these entirely reasonable questions is a resounding NO. Afghanistan is in chaos, its people starving, and its government is now an outright enemy of the United States. As we yet again find ourselves at war with forces we once funded and supported, the wisdom of foreign aid must be challenged. Peaceful relations and trade with every nation should be our goals, and the first step in accomplishing both should be to stop sending taxpayer dollars overseas.

## ENVOY URGES EXCLUSION OF U.S. IN AFGHAN PEACEKEEPING ROLE

TEHRAN (*AP*)—The UN should exclude the United States and Afghanistan's neighbors from any possible post-Taliban peacekeeping mission or risk even more instability across central Asia, Iran's foreign minister argued Monday.

Such a position risks increasing friction with Washington, which may seek some continued military oversight in Afghanistan if attacks succeed in toppling the Taliban and ending Osama bin Laden's command of the al-Qaida terrorist group.

However, Foreign Minister Kamal Kharrazi insisted Monday that any U.S. presence on a post-Taliban peacekeeping force "would have a negative impact on the whole region."

"Central Asian countries are always sensitive to the presence of Americans and American soldiers," Kharrazi said, adding that any peacekeeping force "should be composed of countries that do not have any specific interests in Afghanistan."

That also would mean excluding Iran, which shares a porous 450-mile border with Afghanistan.

Kharrazi, who plans to discuss Afghanistan next

week as part of a United Nations-backed group that includes the U.S., also warned that Muslim extremism fed by bin Laden and others could lead to a "more dangerous" world if not subdued quickly.

Kharrazi is considered one of the few politicians able to bridge the ideological rifts between Iranian conservatives and moderates seeking Western-style reforms.

He has strong revolutionary credentials, including a key role in the state media during the 1980-88 war against Iraq. Later, he served as Iran's envoy to the UN and is considered close to reformist President Mohammad Khatami.

"We are facing a new chain of developments in the Islamic world, facing a new extremism," Kharrazi said. "If wrong policies are taken, naturally it would be more dangerous and there would be more [of a] gap between the Islamic world and the Western world, and it could lead to clashes."

Iran has attempted to juggle various aims since Sept. 11: It has snubbed the U.S.-led coalition against terrorism and opposed military action, even as it shares the common goal of bringing down the Taliban regime in Afghanistan.

Iran believes the Taliban has warped Islam, and it has helped arm the anti-Taliban opposition in hopes the U.S. air strikes will clear the way for toppling the Taliban.

DUBAI (*Reuters*)—Following is the text of parts of a videotaped statement made by Saudi-born dissident Osama bin Laden and broadcast on Qatar-based al-Jazeera television on Saturday (11/3/01):

"Those who refer our tragedies today to the United Nations for solutions there are hypocrites who are deceiving God, his prophet and the believers. Are any of our tragedies not the making of the United Nations? Who issued the resolution for the division of Palestine in 1947 and surrendered the land of Islam to the Jews? It was the United Nations in its resolution in 1947.

"Those who claim to be Arab leaders and are still (cooperating) with the United Nations are infidels in the eyes of the message of Mohammad—God's blessings and peace be upon him. Those who refer issues to international law (for a solution) have abandoned the law of (Islam's) holy book and the teachings of the prophet.

"We have suffered because of this United Nations, so no Muslim should resort to it under any circumstance. The United Nations is a tool of crime. We (Muslims) are being slaughtered every day and it does not move.

"Our brethren in Kashmir have been, for more than 50 years, subjected to torture. They have been slaughtered, killed and their honor, blood and homes have been violated. And the United Nations does not move.

"Today, without any evidence, the United Nations is pedaling resolutions in support of America, the oppressive despotic tyrannical (country) against the weak who have just emerged from a massive war (waged) by the Soviet Union.

"All the West, with rare exceptions, supports this oppressive campaign, for which no evidence links what happened in the United States to the people of Afghanistan. The people of Afghanistan have nothing to do with this matter but the campaign continues annihilating villagers, women and children, without right."

#### DEATH CERTIFICATE REQUESTS SEEM LOW

NEW YORK (AP)—More than a month after the city made it easier for families of World Trade Center victims to obtain death certificates, city attorneys say they are surprised at how few have applied for them.

"They're not coming in," said Lorna Goodman, a spokeswoman for the corporation counsel, the city's legal arm. "It's an absolute mystery."

Families with a death certificate can immediately receive life insurance and other benefits, process wills, distribute property and access bank accounts.

Beginning Sept. 26, the city streamlined the process of getting a death certificate without a body, a process that typically takes up to three years. Now only a few days are required.

Paperwork has been submitted for about 1,800 individuals out of the more than 3,900 people city officials believe were killed in the Sept. 11 terrorist attack.

The number of applications could indicate that the city's tally of the missing is too high, but lawyers involved in the process also suggest other reasons related to human nature: Some families are emotionally unprepared to take the step of declaring their loved one officially dead, especially without physical remains. Others, especially families of immigrants or undocumented workers, may fear dealing with authorities, lack the required paperwork, or be ineligible for benefits such as private insurance and therefore view the process as pointless, the lawyers say.

Anthony Crowell, director of the New York City Law Department's World Trade Center Unit, has seen many families who just are not ready.

"We have had an instance where the husband has come in to file for his wife and then he'll call and say, 'Can you take it back? Can we withdraw the application? Because my wife's parents just don't want to go through the process," Crowell said.

#### SECRET NEW YORK CIA OFFICE DESTROYED IN SEPTEMBER 11 ATTACK

WASHINGTON (AFP)—A secret CIA office in the World Trade Center complex that spied on UN diplomats and handled "anti-terrorism" cases was destroyed in the September 11 terror attack, the New York Times reported Sunday, citing government officials.

The Central Intelligence Agency office, which operated behind a false front, was located at 7 World Trade Center, one of the smaller office towers destroyed when the twin towers collapsed after being hit by hijacked passenger planes, officials told the Times.

All agency employees were evacuated safely, the officials said.

A CIA spokesman contacted by AFP declined to comment. "We never confirm the location of CIA offices other than our Virginia headquarters," the spokesman said, speaking on condition of anonymity.

The office also recruited United Nations diplomats, and debriefed friendly U.S. business executives and others after returning from overseas, according to the Times.

#### SUPERGERMS ARE DARK SIDE OF ADVANCES IN BIOLOGY

Scientists who wish to help cure disease, they say, must consider how their work could be misused and how to fight back with new medicines or other techniques.

> There is "an increasing tide of concern, among revolution in biology could be misused in offensive biological weapons programs directed against human beings and their staple crops or livestock," according to a commentary in the latest Nature Genetics journal.

> The National Institutes of Health have set up urgent meetings with biologists, drug makers and government officials to begin addressing the bioweapons threat, and the National Academy of Sciences will hold special forums this month to begin assessing the dangers posed by bio-terrorism.

> Scientists warn that technology has made it possible to manipulate the genes of viruses and bacteria to the point where a competent molecular biologist could make supergerms that could be far more lethal and disruptive than naturally occurring pathogens.

> "Ironically, the very same technology that can insert good genes and fix you can insert bad genes and hurt you," said Steven Block, a Stanford University molecular biologist. "As we proceed with this technology, there is inevitably a dark side, but it's the white side of biology that's going to save us."

> For biologists the attacks have been an agonizing awakening to the reality that science can be misused, raising moral and ethical questions about how far science should go, what kind of research should be permitted and who should be allowed to conduct it.

> Scientists paint a scenario that, until a few months ago, seemed more like science fiction—undetectable superbugs; "stealth viruses" that invade a person, lie dormant and are triggered on command to cause infection; "designer diseases" that affect specific organs, such as the brain.

> The Soviets were the first to attempt to bioengineer natural pathogens into more virulent ones when, in the 1980s, they secretly produced anthrax spores to be resistant to some antibiotics. They also unsuccessfully tried to combine smallpox with the Ebola virus to make a hardier killer.

> These efforts, however, are considered primitive compared with the sophisticated technology available today, which can not only identify all the genes that make up disease-causing germs but also manipulate the genes to give the bugs chilling new properties.

> Some biotech companies are developing the technology to take individual genes apart and reassemble them in different ways that give the genes new capabilities. This technology has been hailed as a possible important development in curing genetic diseases, but it is now also seen as a way to make genes with incredibly efficient killing powers.

The genetic blueprints of plague, smallpox, cholera and other pathogens, for example, are already identified and posted on the Internet and in scientific journals for anyone to see.

"Many of the genomes for agents that could be used in biological warfare are now matters of public knowledge. They are available to anybody in the world," said Barry Bloom, dean of the Harvard School of Public Health. "If they want to mutate genes, or splice them and take them out, all they need is a couple of DNA primers, some DNA and a little skill, and that can be done."

In the next two years genetics laboratories around the world are expected to complete the genetic makeup of more than 70 major bacterial, viral, parasitic and fungal germs that infect humans, animals and plants.

"The ever-expanding microbial genome databases now provide a parts list of all potential genes involved in pathogenicity and virulence, adhesion and colonization of host cells, immune-response evasion and antibiotic resistance from which to pick and choose the most lethal combinations," said the Nature Genetics commentary, which was written by Claire M. Fraser, president and director of the Institute for Genomic Research, and Malcolm R. Dando of the department of peace studies at the University of Bradford in Britain.

If a terrorist builds an antibiotic-resistant germ, then science must develop new drugs to overcome the resistance, and a thorough understanding of all disease genes will make it possible to develop faster methods of diagnosing and then disabling them. Harvard researchers, for example, recently found a gene that makes mice resistant to anthrax, a discovery that could lead to better vaccines and drugs.

"The same technology that can bring us these potential weapons of devastation is precisely the technology that we'll need to counter them," Block said.

A greatly expanded offensive against bioweapons is also expected to pay dividends in improved health. As scientists increase their mastery of germ genes to defeat bio-terrorists, they will also be gaining the knowledge to develop anti-microbials, vaccines and other compounds to tame the infections that are the second-leading cause of death in the world.

The ethical dilemmas in biology recall those that have arisen with other great scientific accomplishments. Most of the physicists who built the first atomic bombs, for instance, opposed their use on population targets, and many became involved in campaigns to ban nuclear weapons.

The first molecular biologists who learned how to transpose genes from one species into another in the mid-'70s called a moratorium on their research until it could be shown that such genetic engineering would not accidentally create dangerous organisms.

"How do you keep new bio-weapons from happening?" Bloom said. "You have to... create a very strong moral culture of scientists that worry about the uses of science."

For universities, that means facing critical issues about bio-terrorism as they train people to do molecular science.

"We need to create a culture where students know what the accepted norms are," Bloom said. "Just as doctors need to know what are the accepted ethical norms for human subjects in research, we need the same for biological knowledge."

[JR: When will science develop a moral conscience that will question and set in place ethical standards to police themselves? Molecular biologists are treading the same dangerous road that the nuclear physicists did when they developed the atomic bomb, hydrogen bomb and the neutron bomb. We have more superbugs today and no vaccines to fight them. Science has gone beyond playing God and it's time we hold scientists accountable who engage in research that is unethical or detrimental to man and his environment. Add to that our governments who fund this type of psycho-scientific weapons research.]
