1) The "terrorist" attacks were completely predictable and, in fact, predicted. Forewarnings were issued by many patriotic and heroic individuals to government and military officials well in advance of Sept. 11, 2001. For instance, in August, Dr. Garth Nicolson, Ph.D., and his wife Nancy Nicolson, Ph.D., among the world's most esteemed Mycoplasma researchers and Gulf War Syndrome investigators, reported to Pentagon officials that they had confirmed intelligence that on Sept. 11, 2001 a terrorist strike against the Pentagon would be made. Their sources included individuals in key intelligence positions, the mob, and one high-level African diplomat. Their "information was passed on to the Director of Policy of the Department of Defense, the inspector General of the U.S. Army Medical Corps and the National Security Council," Dr. Nicolson wrote. "Unfortunately, it was ignored."

[H: As we go along I might mention that I find some of the resources quite questionable, having found that in several instances, i.e., with the Nicolsons in fact, there are truly some very contradictory actions to their full "patriot" causes, especially regarding the Gulf War Syndrome. We have been blessed with input from others equally qualified, and formerly associated in the scientific research programs dealing with the Gulf War Syndrome. I will leave those parties unnamed for their own protection.]

Likewise, Dr. Leonard Horowitz, the award-winning author of the prophetically titled book, Death in the Air:

Globalism, Terrorism and Toxic Warfare, released three months before the attacks on Washington and New York, correctly predicted such a first strike on New York. For three years, based on government documents and intelligence reports, he had been warning "Metropolis" residents, "It's time to move."

- 2) On Friday, September 7, Florida Governor Jeb Bush, brother to the President, issued an Executive Order in which members of the Florida National Guard were activated, "for the purpose of training to support law-enforcement personnel and emergencymanagement personnel in the event of civil disturbances or natural disaster". Perhaps the president and his brother received Dr. Nicolson's warnings or were the source of the warnings?
- 3) On Sunday night, September 17, CBS's 60-Minutes revealed that President Bush's close associates had suddenly, and inexplicably, sold all their airline stock just days before the terrorist attacks. The story was completely overlooked by mainstream newspapers thereafter.
- 4) FEMA sent the Urban Search and Rescue Team to New York City THE NIGHT BEFORE the attacks occurred! One FEMA official, Mr. Tom Kennedy, told Dan Rather on Sept. 11, "We're currently one of the first teams that was deployed to support the City of New York in this disaster. We arrived on late Monday night [that is, on September 10, the NIGHT BEFORE] and went right into action on Tuesday morning." [H: How's that for being prepared and efficient?]
- 5) Osama bin Laden and his band of "Terrorists" could not have pulled off the "sophisticated" operation of four simultaneous air hijackings, and precision directed attacks without the support of one or more "intelligence organizations". This was the expert testimony provided by past CIA Afghanistan operations director and bin Laden's American intelligence aficionado, Milt Bearden, interviewed by Dan Rather to endorse the theory of bin Laden's culpability, Mr. Bearden stated, "if they didn't have an Osama bin Laden, they would invent one."
- 6) On October 31, 2001, the French daily Le Figaro reported that Osama bin Laden had met with a high-level CIA official in July 2000. At that time, bin Laden was already being sought for trial for his involvement in two U.S. embassy bombings and the USS Cole attack. The meeting was held in bin Laden's private suite in a Dubai hospital. Though he was eligible for elimination, according to President Bill Clinton's intelligence findings, on July 14th he was let go and left Dubai on his private jet.
- 7) Every expert in the field of terrorism, up until Sept. 11, 2001, routinely explained the fact that certified terrorist organizations operate in an effort to garner worldwide attention and support for their political cause(s). In the case of pro-Palestinian terrorist organizations, their attacks had been traditionally against American military facilities and personnel. This was obviously neither the intent nor outcome of the attacks on the World Trade Center.
- 8) For weeks preceding September 11, 2001 international opinion regarding Israel and the United States had plummeted to an all-time low. Alternatively, pro-Palestinian attitudes had rapidly increased to an all-time high, particularly following the United Nations Conference on Racism wherein the U.S. and Israel had been chastised for their racist policies. Any intelligent pro-Palestinian terrorist group, such as Osama bin Laden's legions, or intelligence organization(s) supportive to the Palestinian cause, would not have jeopardized the heralded a bizarre anthrax outbreak at the National

significant gains achieved at that time.

9) Osama bin Laden took his direction and money from the CIA for ten years. During this time, approximately \$5 billion was funneled to his organization through hijack op-budgets into a CIA operation known as Maktab al-Khidamar—the MAK. It is clear, as a MAK mercenary army leader, bin Laden's fortune vastly increased during that time. It is said that, "Once in the CIA, always in the CIA." Could this be one of the intelligence organizations about which Milt Bearden was speaking? (See #5 above.)

[H: Gee, wouldn't it be interesting if this whole "WAR" is staged to actually catch the guilty in their own trap? Perhaps it is the war forming against the true terrorists: the Pharisees. It is obvious that the trap has been tripped and perhaps the true guilty players will get so entangled they can't find a way out of the mess they have made. Either bin Laden was betrayed or he knew exactly what was coming down IN CONJUNCTION WITH COUNTERPARTS. TIME WILL PRESENT ITS CLUES.]

10) On Tuesday evening September 12, 2001 previous Secretary of Defense for the Clinton administration, William S. Cohen, explained to CBS News anchorman Dan Rather that the terrorist attacks on New York and Washington were an aberration. He fully expected there to be a full-scale deployment of biological and chemical "weapons of mass destruction" very soon. This reinforced his earlier statements as Defense Secretary that a five-pound bag of anthrax bacteria in the hands of terrorists would likely cause the deaths of hundreds of thousands of Americans. We were particularly vulnerable to this "imminent" threat, he said. Many critical military observers considered these statements treasonous. Reason? At no time in American military history has a top-level official broadcast internationally the country's greatest attack vulnerability. In effect, his statements were akin to giving anti-Americans their marching orders.

11) A sincere U.S. government, truly concerned about the health and safety of American citizens, would be doing everything in its power to advance public health and preparedness. Instead, such critical policy and advice has been left entirely to independent, often ill-trained "experts" at best, and special interests and media producers at worst. The mainstream media has completely neglected the simple things people can do to guard loved-ones, such as natural medicines (e.g., garlic) to ward off infections such as anthrax. [H: I obviously favor silver colloid or whichever of the colloids is appropriate.]

12) In July 2000, the Food and Drug Administration (FDA) endorsed one single, largely untested and highly risky antibiotic, Bayer Corporation's Cipro, for anthrax prophylaxis and treatment. Following September 11, 2001 demand for this drug skyrocketed 1,000 percent, according to Peter Jennings in an ABC News report broadcast September 27. Pharmacies charged \$700 per person for a mere two-month supply of Cipro. It is well established that far less expensive antibiotics, including the penicillins and tetracyclines, are highly effective against Anthrax. The Bayer Corporation during and following World War II had been blacklisted by the U.S. Government for being the principle profiteer, in partnership with the Rockefeller Standard Oil Company, for funding the Third Reich, their terrorist organizations, and Germany's war machine.

13) During the first week of October, the media

Enquirer near Ft. Lauderdale, Florida. By October 11, military installations in Germany with bombs. Hepp A woman's testimony followed: "I got stuck on the stairs. three cases of reported "criminal" anthrax infections had occurred. This form of anthrax—a classic biological weapon strain—is not easily acquired. It is distributed mainly by the American Type Culture Collection (ATCC) of Rockville, Maryland. The curator there is Dr. Joshua Lederberg, who is also the president of Rockefeller University. Preceding the Gulf War, the U.S. Congressional Record (May 25, 1994, commonly called the "Don Riegle Report") exposed the ATCC for shipping to Saddam Hussein's Ministry of Higher Education and the Ministry of Trade, nineteen shipments of various strains of Bacillus Anthraces from 1978 to 1988.

14) According to investigators at the FBI, the Enquirer anthrax attack was not likely done by typical "terrorists", but rather one or more "criminals". For what motive? Obviously, whoever did this had a motive, and had access to weapons-grade anthrax. That virtually leaves typical blue-collar "criminals" out entirely, since skill in handling and shipping live anthrax would be required for this crime. The fact that, of all places, America's best-selling tabloid was first attacked, then other mainstream media outlets, speaks volumes about the criminal motive. Since no one has claimed responsibility for this act, they obviously did not do it for personal publicity. Obviously, then, the attack was a white-collar crime by one or more "white-collar bioterrorist(s)". At least one Rockefeller-linked U.S. biological weapons official, Dr. Lederberg, and Rockefeller-partnered corporation, Bayer (aspirin) that largely financed the Third Reich, and Hitler's rise to power, had obvious white-collar (financial) motives for these contemporary "terrorist" attacks. This deserves critical consideration and further investigation.

15) On October 1, 2001, Dr. Leonard G. Horowitz sent the FBI, as well as half the members of the U.S. Congress, an urgent request to investigate this matter. Included in this letter was the following statement concerning the links between contemporary terrorist organizations, the global neo-Nazi movement, and possible Bayer Corporation involvement:

The Bayer Company [also linked to AIDS-viruscontaminated blood products during 1980 investigations] evaded U.S. Government controls during and following the holocaust in which millions of mostly Jewish people were used as experimental subjects in medical atrocities overseen by I.G. Farben's president Hermann Schmitz, who also directed the German-multinational Bayer A.G. [H: I certainly find it interesting, however, that these companies are very definitely Jewish-owned corporations. Please remember that Adolf Hitler [MM: Born as Adolf Schicklgruber] was half Jew. Let's not just continue the blind-man's bluff lest you get yourself deaded.]

Of urgent pertinence to the FBI's current investigation into terrorism's money trail, a recent investigation into terrorist group funding, issued by The Oklahoma Bombing Investigation Committee (OBIC) directed by Representative Charles Key, found "Neo-Nazi figures have actually been implicated in Middle Eastern special weapons procurement and terrorist activity." For example, the group reported, "since the 1960s, an old Swiss Nazi named Francois Genaud has reportedly masterminded several airplane hijackings for the PLO." The now defunct "Odessa" organization, the post-war successor to Hitler's S.S., according to OBIC, "had numerous documented meetings with representatives of various Arab organizations; and, during the early 1980s, a Neo-Nazi named Odfried Hepp attacked several U.S.

was later found to have been financed by Al Fatah." Hepp, OBIC reported, did his Ph.D. on "Neo-Nazi/ facilities in Germany." Given these facts alone, an FBI investigation into this matter is critical.

[H: Without making a fuss here I think you readers must remember something which is often overlooked. There are TWO (2) SEGMENTS of Jewish recognition: Sephardic and AshkeNAZI. When will you STOP accusing the Germans of killing off the Jews? You will note that the Nazis did that so-called holocaust and, if Jews were involved at all, it was in the deathing—and even in Israel today the Sephardic "Jews" are the persecuted. Until you get the players straight, you can't possibly KNOW TRUTH.]

I am also contacting congressional leaders at this time urging an immediate U.S. General Accounting Office (GAO) investigation into the FDA's "advisory committee" that sponsored the unprecedented sole endorsement of Bayer's Cipro for anthrax. Nowhere in the *Physician's* Desk Reference (2000) is it claimed that Cipro is especially indicated for anthrax. In fact, Bacillus anthracis is not even mentioned. What is mentioned is that, "although effective in clinical trials, ciprofloxacin is not a drug of first choice in the treatment of presumed or confirmed pneumonia secondary to Streptococcus pneumoniae." This organism, like anthrax, is an aerobic gram-positive microbe. (Likewise, Bacillus anthracis causes pneumonia in the form of commonly terminal hemorrhagic bronchopneumonia.) Furthermore the PDR states: "WARNINGS—THE SAFETY AND EFFECTIVENESS OF CIPROFLOXACIN IN PEDIATRIC PATIENTS AND ADOLESCENTS (LESS THAN 18 YEARS OF AGE), PREGNANT WOMEN, AND LACTATING WOMEN HAVE NOT BEEN ESTABLISHED." Alternatively, numerous bioweapons experts have consistently recommended far less costly and time-tested antibiotics to fight anthrax, including the natural and synthetic penicillins, erythromycin, cephalosporings, and the tetracyclines.

As with Dr. Nicolson's forewarning to military leaders concerning the Sept. 11 Pentagon attack, the above urgent request by Dr. Horowitz for FBI investigation into this matter, to date (Nov. 5, 2001) has gone ignored. This strongly suggests, if not evidences, a conspiracy within our own governmenta conspiracy of silence at minimum.

16) Aaron Swirski, one of the architects of the World Trade Center, said they designed the towers to withstand airplane collisions. "I designed it for a 707 hit," he said. The collapse of the buildings came as a complete "shock" to him and his colleagues.

Van Romero, a demolition expert, former director of the Energetic Materials Research and Testing Center, and current vice president for research at New Mexico Institute of Mining and Technology said that the manner in which the twin towers collapsed resembled those of controlled implosions used in planned demolition. "My opinion is, based on the videotapes, that after the airplanes hit the World Trade Center there were some explosive devices inside the buildings that caused the towers to collapse," Romero said.

ABC News interviewed people who had escaped "ground zero" on September 11, 2001. One unidentified man said: "We were stuck on the stairs for a while. I came down from the 85th floor. When we were just about to leave the building, there was a blast."

When we got to the lobby there was a blast," she said.

17) On September 11, 2001 President Bush was PLO bombings of U.S. housing, cars and military in Sarasota, Florida, "reading to children" in a classroom at 9:05 a.m. when his chief of staff, Andrew Card, whispered into his ear, according to the Associated Press (Sept. 12). The president briefly turned somber before he resumed reading... [Next] President Bush listened to 18 Booker Elementary School second-graders read a story about a girl's pet goat... before he spoke briefly and somberly about the terrorist attacks. Many are curious as to why the 'Commander-in-Chief" of the U.S. took about a halfhour before he responded to the national security urgency, or even addressed the tragedies.

> 18) Pentagon officials had been tracking the second two hijacked planes for almost an hour following the WTC attacks because they simply "didn't know what to do". Regarding the plane that crashed into Pennsylvania "Paul Wolfowitz, the deputy defense secretary, said... that the Pentagon had been tracking that plane and could have shot it down if necessary; it crashed about 35 minutes after the Pentagon crash.'

> Many are wondering why, if they could have shot that plane down, did they not shoot the plane down that flew into the Pentagon?

> 19) Vice President Dick Cheney was interviewed on Sept. 12, 2001. When asked where he was when he learned of the attacks, many were surprised to learn that he was alerted by his secretary who was "watching television" in his Washington, D.C. office. In essence, though the FAA had known at least four planes were veering far off their course, while the Pentagon, too, had been tracking at least two of the hijacked planes, Mr. Cheney received his initial intelligence report by way of television through his clerical secretary.

> 20) "Drugs and terrorism go hand in hand," wrote investigative journalist and retired LAPD officer Michael C. Ruppert. "Conveniently ignored in all of the press coverage since the tragic events of Sept. 11," Mr. Ruppert wrote, "is the fact that on May 17 Secretary of State Colin Powell announced a gift of \$43 million to the Taliban as a purported reward for its eradication of Afghanistan's opium crop this February. That, in effect, made the U.S. the Taliban's largest financial benefactor according to syndicated columnist Robert Scheer writing in the Los Angeles Times on May 22."

> 21) "Now U.S. military action will replace the Taliban government and fresh crops will be planted in Afghanistan," Mr. Ruppert continued, "the slack in cash flow will assuredly be replaced by dramatically increased opium production in Colombia; the revenues from that effort being needed to maintain the revenue streams into Wall Street. Prior to the WTC attacks, credible sources, including the U.S. government, the IMF, Le Monde and the U.S. Senate placed the amount of drug cash flowing into Wall Street and U.S. banks at around \$250-\$300 billion a year."

> 22) Mr. Ruppert also revealed that an Executive Director at the CIA named A. "Buzzy" Krongard is suspected of Wall Street profiteering from foreknowledge of the Sept. 11 attacks. Formerly with Bankers Trust catering to the world's wealthiest clients of the Deutsche Bank. (The Deutsche Bank is heavily implicated in Dr. Len Horowitz's book Death in the Air: Globalism, Terrorism, and Toxic Warfare released in June, 2001) In 1999, Mr. Krongard left Deutsche Bank for his present high-level job in the C IA. Enormous quantities of "Put" options were handled through the

Deutsche Bank, which allowed the options buyers to earn profits in the event the value of airline stocks went down. The appearance of advance knowledge of Sept. 11 is so strong that to date \$2.5 Million of the \$20 Million in profits earned on those unusual trades remains unclaimed, possibly by Mr. Krongard, or other affiliates of the CIA.

23) Many journalists have reported that the bombing of Afghanistan, allegedly intended to punish the Taliban for affiliations with bin Laden, is simply a cover for that government's reneging on support for an oil pipeline through Afghanistan from the vast Caspian Sea oil fields. Sept. 11 provided a great excuse to pursue this petrochemical, economic, and "national security" objective.

24) On December 20, 1997, the international newspaper CONTACT: The Phoenix Project, published an interview on anthrax biowarfare threats and "about the government's pressure to vaccinate [using the anthrax vaccine] and the bioweapons scare tactics, etc." He responded: "Look at the motive behind the persuasion, and what is it? They're preparing to blame it on the Muslims, Christian patriots, and militia groups. The militia groups are already dysfunctional because they're penetrated by agitators."

This is precisely what followed in the wake of the 9-11 attacks. Muslim groups were blamed for the 9-11 attacks. Christian patriots were blamed for the anthrax mailings. Militia groups were entirely silenced and even implicated. And false patriotism in which Americans welcome the destruction of basic constitutional liberties with CIA command over the entire U.S. military and Government has come to pass.

#### A LOOK AT U.S. MILITARY ADVISERS

Having just experienced the full-bore attention of these special advisers in the Philippines, let us consider what these forces actually are and what they do.

[QUOTING "WHAT U.S. MILITARY ADVISERS DO", by Roland G. Simbulan:]

In 1987, the Pentagon inaugurated an independent command to consolidate Special Operations Forces of Army Green Berets, Rangers and the covert Delta Force, Navy SEALS, Special Boat Units, and the Covert Team 6 and Air Force Special Operations and Internal Defense Squadrons.

As a consolidated, composite command, they are now part of what is called the Central Command of the U.S. Armed Forces. These Special Forces command units now operate globally in exercises known as "Joint Combined Exchange Training" (JCET), an indispensable part of key post-Cold War foreign policy.

from the 25-member Joint U.S. Military Advisory Group or JUSMAG which were never removed and in fact are, today, still attached to the U.S. Embassy in Manila at the "James Rowe Compound".

The U.S. has had JCET operations in various parts of the world for many years, but for the past nine years, they have been almost invisible, free of virtually any U.S. congressional oversight. A 1991 law, Section 2011 of Title 10 of the U.S. Code, which governs money spent on overseas troop deployments, bypasses oversight requirements by giving commanders of Special Operations Forces the authority to deploy and pay for training of U.S. and foreign troops, if "the primary purpose of the training... shall be to train the Special Operations Forces of the Combat Command." The law also allows unreported financing of the foreign country's participation in training by buying fuel, food and ammunition, etc.

Today, there are 47,000 personnel belonging to this most elite unit of the U.S. armed forces—the U.S. Special Forces.

'Special operations' have evolved functions which were formerly the sole purview of the CIA or diplomatic officers, such as collective strategic information on foreign countries, including everything from topography, backgrounds of foreign leaders, evaluation of readiness of foreign troops, potential landing sites, and the like. [H: This, in the Philippines, includes full mapping and strategic information on gold holdings, especially integration with satellite mapping systems, natural resources from ground level and access needs.]

Officially, the justification is that such operations are to facilitate the training of U.S. troops, though deployments appear to hold direct benefits for U.S. troops. U.S. officials maintain that by training foreign troops, U.S. forces are learning how to train foreign troops, one of their main official missions.

The Special Operations Forces advisers may in fact be contributing to counterinsurgency and human-rights violations. But there is definitely a political card played by the JCET adviser. They are a direct instrument of U.S. foreign policy, in fact, they may be the most involved, tangible, physical part of U.S. foreign policy in certain countries.

They have definitely become a leading force in exerting U.S. influence abroad, revising the rules of U.S. engagement with scores of foreign countries where U.S. economic, security and political interests are affected.

JCET operations which are also functioning as Mobile Training Teams have been operating around the world. In Africa, they were in Benin, Botswana, Kenya, Rwanda, Senegal, to name a few. They have also been training special forces units in Colombia, Guatemala and other Central and Latin American countries under the auspices of an "anti-narcotics war campaign and operations".

But the program has been criticized in the past in various South American countries and Africa for contributing to counter-insurgency operations by the trained troops and parliamentary units and providing yet another mechanism for channeling U.S. military training and equipment to favored regimes.

In Indonesia during the Suharto regime, U.S. Special Operations Forces advisers trained the notorious Kopaussus troops, accused by Amnesty International of involvement in kidnappings and torture of anti-government activists. In the case of Colombia and Guatemala, the U.S. role in organizing the death squads and torture squads began with the Special Operations Forces advisers in 1991, when they set up "intelligence networks" under a secret Colombian military high command. The excuse then was officially the war against narcotics. Now it is the war against terrorism.

Small mobile training teams composed of U.S. Special Operations Forces usually train local units in "camouflage techniques, small-unit movement, troop leading procedures, soldier-team development, rappelling, mountaineering, marksmanship, weapon maintenance, and day and night These are different and should be differentiated navigation". Also included are "small unit leader training,

intelligence, interrogation techniques, rifle marksmanship, first aid, land navigation, and tactical skills, such as patrolling".

Of course, U.S. military training goes beyond purely military advice as it includes counterinsurgency techniques, according to a senior U.S. Special Operations and Low-Intensity Conflict official who was interviewed by the Washington Post (July 12, 1998 issue).

In many countries, despite mounting evidence that U.S. SOF-trained troops are in the thick of atrocities upon civilian populations, this form of U.S. military support continues.

Sananda in Light, that we might resume our Journal. Greetings on this wondrous day within Creation. Let it be a most beauteous celebration of life. Blessings be in the truth of our words that we might touch the heart places of our brothers and lift the lamp of knowledge that freedom might abound.

#### LET US SPEAK OF ANIMALS

You have a heavy load in the past several pages, therefore, let us turn to the beginnings of sacrifice. As long as the Christians utilize rituals which are the same as the Satanists, you shall have this horrendous practice continued. When the Christians become Christians who celebrate life instead of death, so shall your peoples.

Satanic cults are most careful about calling attention to themselves. Your law enforcement officials and others have come upon physical evidence of their activities, however. The most commonly found evidence is mutilated animals, ritual sites, and robbed graves. This is "hard" evidence, dear friends—not something you call UFO demons from cosmic sectors.

Where UFOs actually do enter the picture is that your government realized that soon they would have to confront the cosmic alien cover-ups and presence. A mass attempt was made to play on the Satanic influence to bring panic and fear into an already anxious community of people. What you miss is that that which is perpetrated by the Satanic humans is so much more terrifying than anything you conjure, that you simply do not understand the problem. Brothers from the heavens would not have need of leaving residue or "bodies" lying about. I will say, however, that there have been many craft landings for the purpose of studying the practice of mutilations. There is great anxiety in the cosmic councils that your Earth problem is all but out of hand as to control-and I am sorry, but you are not a species which the cosmic people desire as integrated neighbors. You have been under most careful attention and monitoring. Remember, to correct a problem, the problem must be identified and your cosmic friends and relatives do not understand your fascination with either drugs or your brother's blood-leastly do they understand your fascination with a Christ's blood and flesh and intaking thereof. They see little difference in the practice of those who are of anti-Christ proclamation. Quite frankly, neither do we of the Lighted Brothers. The Christ of 2,000 years past came to show you truth and prove there is no death-

tend the cycling of a planet. So be it.

Let us look at facts—historical facts—regarding animals for cult use. You must remember the definition of "cult" which simply means sect, family, band, group, congregation. members, flock, etc. Do not single out Satanists and mystics as cults, for you will be missing the point. Any Christian unit under a given doctrine is a cult; no more and no less.

During your 1970s is an excellent place to begin this portion because mutilations sightings became most epidemic, most especially in your country's Midwestern geographic location.

Usually the victims were dairy cows, but horses and beef cattle were also found dismembered. The theories flew; everything from UFOs to natural predators such as wolves, to pranksters doing it just to drive the local sheriff crazy. Part of the mystery was that in many cases footprints of the perpetrators were never found. In other cases, the animals were found miles from where they belonged.

Some things, however, must be quite clear in retrospect. The animals were killed and mutilated in a deliberate and skillful manner. Judging by what was done to the animals-what body parts were taken, the fact that blood was drained-Satanic cults must surely have played a major roll. The propersized organs to be utilized in cult rituals would of necessity be from your larger animals. A penis, for instance, from a small cat would not be proper for the ceremonies.

You will find that mutilations of animals hardly are considered news in this present time, although they continue today in great numbers. To put this in perspective, I must name some names for your ability to research.

Near Elkhart, Indiana, a farmer lost five head of cattle; someone had gone in and cut the vaginas out. He had one cow left, and he was guarding that cow with a shotgun.

Why would anyone cut out the sex organs? In Satanic religion, the sex organs are supposed to contain power. Satanism is a religion based on the hedonism and the belief that the release of sexual energy is one way for you to reach a higher consciousness. You want anything that can add power to your rituals. By taking the sexual organs of an animal, you have some of that energy for your own use.

After understanding what evidence to seek out, the local enforcement officers set about an intense search of the scene. They were able to build up indicators that there was a traditional occult group in the area. As it turned out in this instance, the animal mutilations occurred a couple of days before an important cult holiday.

#### METHOD OF OPERATION

Autopsy reports from the mutilated animals and informers' reports give the following picture: The occultists will stun the animal on his back with a high-powered electric probe which incapacitates the animal. Then they will spray freon on the animal's throat. The animal is living, but unable to respond. The heart continues to function. They then use an embalming tool (pump) to get the blood out. It is fast and most efficient. Often a farmer can make it to the scene within a few minutes, for there is often noise and cries from the animals. Within a matter of some three minutes a body can be evacuated of blood.

Do not be quick to consider UFOs, for you will be incorrect in your conclusions. Neither is the actual mutilation predominantly the work of Satanists. It is most often deliberate in nature, perpetrated by very

human entities for a specific purpose.

Consider a report made to Sheriff Carl Stobaugh on 8-14-79 from Sheriff Gus Anglin (Van Buren Co.) Arkansas, chief investigator, Jerry Bradley (Falkner Co.), Sgt. King (ASP), and this officer, Ray Coffin, Chief Investigator, met with and interviewed a 23-year-old W/F whose identity must remain confidential for safety reasons, in reference to recent cattle mutilations in the area. The following story was related to the officers:

That for five years she was a higher echelon member and you have partaken of a great lie from onset. I and the of a Satanic-worshipping cult which was headquartered hordes of heaven come again to repeat the declaration and in Tulsa, Oklahoma. During her five years there she was involved numerous times in trips to outlying remote areas where cattle were killed and the blood drawn out by use of an old embalming machine, which they had converted to battery power. They also removed the cow's eyes, tongue, sex organs and sometimes the udder.

> She related the cult she belonged to was quite wealthy and had a helicopter and several van-type trucks which were used in obtaining the organs and blood needed from the cows to be used in their rituals. She also stated that doctors, lawyers, veterinarians and other prominent persons belonged to this cult and were all taught by doctors and vets how to precisely cut the parts needed and exactly where to stick the needle to draw out the blood.

> The blood was put into gallon jugs and kept cool for baptizing new cult members. They were baptized in the same manner in which most churches do except the baptismal vat would be filled with blood which had been extracted from the animals. The eyes taken were boiled and eaten by the cult members at rituals. The sex organs were used in the rituals, also, because the cult believes in free sex to everyone.

> When using the helicopter, they sometimes picked up the cow by using a homemade, belt-type sling—and one man would go down and fasten it around the cow, and they would move it and drop it further down from where the mutilations occurred. This would account for there being no footprints or tracks.

> When using the van trucks they would also have a telescoping lift which was about 200 feet in length mounted outside the truck and would use that to extend a man out to the cow, and he would mutilate it from a board platform on the end of the boom and would never touch the ground. The apparatus would telescope back into the vehicle much as a wheelchair lift and not be noticed.

> She stated that they love the publicity that surrounds the mutilations—and as long as the publicity is in one area they will keep returning because they like to baffle law enforcement.

> She stated that they would repeatedly go back to one farm if there were a number of roads coming into the area which would be accessible for a quick get-away route. If not, they usually hit one time and then moved on to another location. They sometimes did three or four cows a night.

> The cult usually prefers the dairy cattle but will mutilate any type of cow when no dairy herds are easily found. They will also mutilate cattle which have died if they are still fresh and haven't started to deteriorate. They have mutilated bulls, horses, and dogs to get blood for their rituals. She left the cult about a year prior because one couple sacrificed their 15-month-old baby. They placed the little girl on a table at one of the rituals and placed oil on her body and cut her up with a large knife to prove their love for Satan. She said that after seeing this she realized that the cult was not for love and left. She was beaten by some cult members—a few months after being located—and was apparently left for dead.

> She has agreed to cooperate in any way she can as long as her identity is kept a secret, because she fears for her life.

#### **SITES**

Locating an actual site used in Satanic rituals is not easy. First, sites are well hidden in out-of-the-way places. Second, if Satanists believe they have been discovered, they will destroy the site and move to another area. This is especially true of buildings that have been utilized for rituals. Some Satanists will move their sites on a regular basis. Third, many of the more prosperous Satanic cults ensure that their actions will not be detected by using private lands owned by members.

Many law enforcement agencies don't report Satanic sites in such a way that the information can be accumulated. If the site is in a park, for instance, it may be recorded as "vandalism" or "destruction of public property". Also, because not all police officers know what a site looks like, they may simply describe it as an area where people congregate.

The following is a direct quote from one officer, Tim Boyle: "We run across a great number of sites because we patrol the parks. The most impressive site we've run across was in 1985 off Little Falls Parkway (Montgomery County, Maryland). One of our officers stumbled upon it. Very often our officers get out and walk around. They're encouraged to do that. He saw warning signs and walked in a little farther and found this circled area where the trees had been cut out. He just stopped there. He didn't want to deal with it. We tell our officers, now, if your don't want to deal with it, you don't have to. Cordon off the area like a crime scene, and call someone who can deal with it.

"We don't want to interfere with any police officer's religious beliefs, but you don't screw up a crime scene because of your beliefs.

"We don't belive this area was compromised. I asked the officer if he checked the ashes and he said, 'I got the hell out of there.' He got back and filed his report. (published herein).

MARYLAND NATIONAL CAPITAL PARK POLICE
MONTGOMERY COUNTY DIVISION
TUES. 12-31-85, 1013 HOURS
CRIME: VANDALISM

On 12-31-85 at about 1013 hours, Lewis on routine patrol observed a worn foot path leading up a steep hill from the B&O railroad tracks (see area map). At the top of the hill, Lewis observed where suspect(s) unknown had cut about twenty sapling trees, value \$10 each (\$200 total), dug a pit about five feet by five feet by four feet, covered the pit with wood and metal and had spray-painted numerous messages and warnings. Some of the messages were "beware" "Go Back" "You're next" "DEATH 2 YOU" "BURN IN HELL" "SAC RELM RULES". (Investigators don't know what this phrase means.) There were numerous references to demonic and satanic matters such as "LUCIFER", "666", inverted crucifixes and a five-pointed star in a circle. There is also indication of burning and cages for animals.

Lewis left the scene as it was; there was evidence of suspect(s) being there within a few days (Jan. issue of *Open University* catalog) and no maintenance order has yet been submitted, pending development of suspect(s).

\* \* \*

Officer Boyle went and investigated the scene. "They had cleared the trees. They had two fire pits and warnings all along the outside to keep people away. There was a stone altar with candle wax on it, pentagrams and "666" written on it. It had a perfectly done circle, exactly nine feet across. It was done by the book. A lot of work had gone into it. There were cages that were the right size to hold small animals. There were nooses off the trees. (Nooses are often found at Satanic sites because they contribute to the macabre ambience. They are not necessarily used to hang anything.) It was a good way in the woods off some railroad tracks.

"It was two miles from Secretary of State Shultz's house in an affluent area of Montgomery County. There was a large public outcry. People wanted to know what was going on. People called on us for the answers, and quite frankly we didn't have all the answers.

"At the time I said, 'Gentlemen, we don't know what we're doing. I know we have something serious, but I don't know exactly what, so let's handle it like a regular crime scene'.

That's what we did. We dug it out; we used metal detectors.

"We called some priests, but they didn't want to

"We called some priests, but they didn't want to talk. The said to call the archdiocese, because they weren't permitted to talk about it.

"We're very fortunate that we had a good administration. The chief is former U.S. Park Police. He worked in Washington, Boston and New York. He was well traveled and understood that there was an upswing in this kind of crime. Although these aren't his exact words, he basically said that if we wanted to find out about it, we should get our ass in gear and find out about it. We were very fortunate that we had him. Our previous chief would have said, 'Screw it. I don't want to hear about that devil shit.'

"There was evidence that people had been there recently, but we didn't find any trace of bones, human or otherwise, in the pits. The site was fairly new.

"We now hold classes on occult crimes. We tell our officers that we have information from agencies in other states that people have been murdered in these kinds of areas so don't screw it up. We tell our officers that when they're investigating a site, especially one that's being used, be careful of radio communications. They sometimes put guards on the outside of the site who are supposed to have powers to know when the police are coming. We call the power 'Radio Shack scanner'. We have special procedures for radio communications when handling these incidents.

"We're not overwhelmed by Satanic activity, just like Montgomery County isn't overwhelmed with a lot of murders either, but you have to know how to investigate them.

"We did finally work up a suspect who has since moved out of the area. We believe he's practicing his religion elsewhere."

I will not do too much more quoting but I will name names, for you ones must know it is an Earth matter and stop dreaming fantasies of fairies and goblins. These are very real human beings and most dangerous indeed. There is nothing too horrendous to prevent their activities. Be most cautious if you find evidence—most cautious indeed—and NEVER go into any area of action without a group of well-armed persons. They will not hesitate one moment to kill and destroy all evidence—ALL. A person will simply have vanished with all traces wiped away—it happens many times EVERY DAY.

#### ANOTHER CASE, GOLDEN GATE PARK, CALIFORNIA

Police officers from the Richmond station, which takes in some of the Golden Gate Park, received a report of a woman screaming at Julius Kahn playground. This park sits at the edge of the Presidio (you should have chills about now!). When they responded they didn't find anything at first. They saw a gardener's shed that had a light on, and they could hear music coming from inside. There was nobody inside, but they found a pentagram on the floor with a circle

perfectly drawn around it and another circle around that. There was also some foreign writing in the circle. There was nothing else that would have suggested anything occult except this circle that was obviously used for some workings.

Later the gardener was queried and was most cooperative—he claimed to be a "hippie" which was most unusual since this incident took place in the 1980s. The gardener claimed to have no knowledge of any activities.

Pay careful attention to what your Park Rangers report, for they are the ones in a perfect position to see results of Satanic activities. Some will even be on patrol while actual rituals are underway or at the breaking up of such ritual services. One such officer encountered a group just leaving the park and later found where they had gathered around a fire, candles were all around and a pentagram was cut into the ground. All participants vanished and were never located.

By the Pasadena Freeway there are drainage ditches that drain into the arroyo. If you walk there, be most careful indeed, you'll see Satanic graffiti, evidence of red and black candle wax as well as the usual white. You will almost always find evidence of sacrificial offerings. There will be bones of animals about the area.

Use your intelligence and think where you would go to honor the devil. You would go where you can either be as he or where you can more heinously desecrate. So you would most surely hold your services in places that are moldy, slimy and that stink of rottenness and dung. Or you would work your way somehow within a group that can function within a given "house or temple of God". You would certainly go nowhere to honor the beauty of God, only to desecrate.

This activity is most wondrous to kids who are bored and out for a lark; therefore, information is often obtained from them regarding these meetings.

A couple of kids were picked up for shoplifting (Thou shalt not steal!), and one told all about a site where he and his friends would hold rituals. This was right in the middle of things in California.

The site was about a quarter of a mile into the woods right off a main avenue. There was a clearing where there had once been a building, for there was a large cement slab. There was a pentagram inside a circle of exactly nine feet in size, painted in white: therefore, someone knew the rules.

There was a brick wall that was used as an altar. You could tell because there was candle wax all over everything. Officers investigating these places are following these incidents because they have had to face the unbelievable "stuff" the kids are into.

In the Golden Gate National Recreation Area a case incident record shows that there was observed a place set up for devil worship in an open bunker area. The area had a figurine painted on the floor. Someone had also drilled holes in the ceiling and plugged them with wooden dowels which had ropes attached which appeared to be for restraining people. There were also numerous candles, athames and other artifacts. This particular place also had bedding in an adjacent room.

Many instances are reported on Mount Lemmon and Saguaro National Monument West. Mostly the sites are crude with inverted crosses and fire pits, but other ritual objects are carefully removed.

Reports at Saquaro National Monument West are constant. Due to the heavy cactus growth and more lenient entrance requirements, local witches find it is a good place to have ceremonies. Further, it becomes most difficult for monitoring because some Native American groups have ceremonies there also.

One site was found which had cremated bones. However, according to a local pathologist, they appeared like commercial cremation remains.

HOW CAN YOU ONES OVERLOOK THE OBVIOUS SO OFTEN? RECENT CASES OF IRREGULARITIES IN CREMATORIUMS IN LOS ANGELES ARE SO OBVIOUS THAT YOU MISS IT. A MOST PROPITIOUS PLACE FOR OBTAINING HUMAN REMAINS IS FROM A

CREMATORIUM—AND YOU ONES TURN AWAY Catholic mass, that unless you HEAR the words involved, you FROM IT AS IF IT WERE NOT PRESENT.

ALSO, CLOSED-COFFIN BURIALS ARE WONDROUS OPPORTUNITIES FOR BODY ACQUISITION AND FRANKLY, OFTENTIMES THE BODY IS REMOVED FROM A COFFIN BEFORE (OR FOLLOWING) BURIAL—MOST OFTEN BEFORE THE DIRT IS REPLACED.

Now let me point out something most important to you who desire to honor things such as that which you called "Harmonic Convergence". In the above-named park, following the gatherings to hold hands and chant beauteous words of love, there were found many areas containing cremation remains. It becomes most difficult for the dedicated officers to discern which is in love and which is placed there in destructive hate.

Making it most difficult for the Native Americans is an incident which I will relay to you now.

Mount Lemmon is a prominent landmark. In 1988, for instance, a group of middle-teenagers from Catalina City just north of Tucson gathered at that place. There was a professor at the university who teaches religious studies, and he had built a full-scale Sioux sweat lodge. They located that and thought it would be a good place to have their meetings. They ended up sacrificing a few goats and some chickens at the least. No one will admit to anything and no one will even reveal whether or not there were adult advisors present. Do you see how painful this is to the Native American who is practicing his honor to God?

#### **CEMETERIES**

Cemetery thefts and desecrations are considered one of the most heinous crimes by your society. Often, youngsters who want to express their anger in the most destructive and provocative way will vandalize cemeteries and mausoleums. Sometimes the destruction is done for a different reason, however, by adults as well as teenagers for the express purpose of obtaining human remains—especially skulls—for ritual use.

In the Hollywood Mausoleum, where your revered Rudolph Valentino is buried—and after causing over \$6,500 worth of damage—someone crawled two hundred feet down a dark, damp corridor to steal a head. Now why wouldn't the cemetery report such? Obviously, it would ruin business wouldn't it?

Every Saturday the 14th, all poorly-guarded cemeteries are looted and vandalized. There will always be found opened graves, often with the left hand missing from the corpse. The left hand in Satanic circles is called "the hand of glory". In your old days a part of the rituals included the taking of the left hand, drying it and then lighting the fingers on an altar. This is supposed to pay homage to the devil, because the left hand is the path of the devil and the right hand is the path of righteousness. This supposedly gave the devil absolute domain. This represents "his" light. This is exactly what these people are doing these days.

would think it the beginnings of the same. Also, you might tend to relegate it to the corner of "Native" reverence. Do be most observant of symbols, especially as the children bring them forth—for no child will "accidentally" draw such pictures. So be it. Let us discuss a few of the rituals that you might know of that which you tend and items of which to be aware.

#### **RITUALS**

Let us speak first of the "Baptism" ceremony for children. It will be good, Dharma, just to quote it as we want to get this Journal laid aside within the week, please.

Let us just explore the opening statement of the ritual which will be sufficient:

"In the name of Satan, Lucifer, Belial, Leviathan and all the demons, named and nameless, walkers in the velvet darkness, harken to us, O dim and shadowy things, wraithlike, twisted, half-seen creatures, glimpsed beyond the foggy veil of time and spaceless night. Draw near, attend us on this night of fledgling sovereignty. Welcome a new and worthy brother, creature of exquisite magic light. Join us in our welcome. With us say: Welcome to you, child of joy, sweet passion's son, product of the dark and musk filled night, ecstasy's delight. Welcome to you, sorcerer most natural and true magician. Your tiny hands have strength to pull the crumbling vaults of spurious heavens down and from their shards erect a monument to your own sweet indulgence. Your honesty entitles you to well deserved dominion o'er a world filled with frightened, cowering men."

Let us further quote from Det. Pat Metoyer of California (Van Nuys), for the description of a baptism ceremony is quite picturesque and then we can pass it by.

"I got introduced to a lady whose name was Dia, from the Church of Satan in Van Nuvs. I went to a ritual where a six-week-old baby was baptized into the Church of Satan. They tried to find one (a ritual) to show me that Satanism was a real religion. They came up with the baptism. They wouldn't let me attend any other meetings that they had.

"It started at midnight. I got there; it was at a small home. One of the bedrooms had been converted into a sacristy. The walls, ceiling and floor were in matte black. Iridescent paint had been splattered on the ceiling and walls. Even if you put an eight-thousand-watt bulb in that room it would have been dark. There was a huge mural of Satan on the wall. It was a person with human features, red, with horns. There was an altar made of wood, painted matte black. There was the Satanic Bible, black and white candles, a bell and a chalice. They told me not to touch the altar because I was unclean.

"The north wall had effigies of persons who had turned on the organization or who had been brought to the group's attention by one of the members. There was someone's supposed liver in wax with pins in it.

"The only part that got to me initially was that they insisted on taking my photograph. No picture, no come in. So they took my picture. I smiled for them, really no big deal. The reason they wanted my picture was in the event I turn on them at some point they can use that in lieu of fingernail clippings or something else.

"Then they tried to frighten me by saying, 'In the past I request that these things of the writings be we've had people who didn't believe us so we took their photograph and put it in the freezer, and they would get cold chills. Then we would put it in the oven and they would get hot flashes.' I said 'Okay' to all this bullshit.

> "Then Dia said, 'I don't think you believe us.' I said, 'That's true. I don't.' She says, 'If my aura were to attack you, would that make you a believer?' I said, 'No, it wouldn't.' She said, 'Turn your back to me, and you will feel my power.' I turned around and faced the wall. My back was to her. She said, 'Can you feel anything?'

'No.'

'How about now?'

'No.'

'Now I'm sure you can feel something.' She was getting frustrated—and I could tell she was getting frustrated. The people there were getting a little antsy. So I said, 'Ah yes, I can feel it,' even though I didn't.

"She said, 'Thank you. You have a little stronger will than I thought,' as if I was trying to play some mental head game with her.

"You have to equate that with you going to my church, St. John's, and during the course of the mass you get up laughing or screaming. The parishioners are not going to take very kindly to that. It's inappropriate behavior. I felt that my action of not feeling her power was inappropriate to their church, so I said I did. They performed the baptism which seemed like a lot of mumbo-jumbo as they did the opening (stated above).

"At the end they had this meeting where they sit around and talk about what Satan had done for them. People would tell what happened to them since the last meeting. They would tell about the demands they had made to Satan. You never ask Satan, you demand. In other religions you make a petition, you ask for something. Here you demand it. That's what they say they like about Satanism. You never get on your knees. You say, 'Satan, give me this!"

Satan has been granted power over the Earth, according to your Old Testament. Therefore they will pay him homage because he is closer to them than God up in heaven somewhere. They are highly "religious" people. Their rituals are precise in intent and the people most devout.

It is here that you come into conflict, for as we observe your Catholic Mass, you will find a most spiritual ceremony, too. By praying and chanting, the congregation and priest are bringing into the church the spirit of Christ. You have the drinking of wine which symbolizes the blood of Christ and the host which symbolizes the taking of mine flesh. Can you even begin to understand how horrendous this is unto mine senses?

The use of blood in Satanic rituals is very important. According to the beliefs, blood contains the life force. If you have it, you have power. They drink it in their rituals and pour it over themselves. You see, man thus far, seems to be unable to isolate and revere the true life source which is totally separate from any physical manifestation.

The same is true in the sacrificing of people. When they sacrifice someone, for the instant just before they die, they supposedly emit their life energy. That power, Satanists believe, can be harnessed for their use. They believe babies are best because babies are pure; they haven't sinned or been corrupted yet. They possess a higher power than adults. When you sacrifice a baby, you get greater power than if you sacrificed an adult. One of the most prized possessions of a Satanist is a candle made from the fat of an unbaptized baby.

They believe that with specific body parts they can use the power contained therein. The head may contain the spirit, and the heart may contain the soul. These are the things that would allow them to be in control. They like to have a finger of the left hand. It is a small symbol of the "left path" which can easily be kept on their person.

#### A LITTLE CASE STORY OF KIDS AT WORK

This story comes from an officer, Darlyne Pettinicchio: "This one kid told me about something that happened to her when she was thirteen years old. She's fifteen now (1988). Her parents were divorced. Neither one is really interested in the kid. The mother is involved in some lesbian relationship, and the kid is always running off. From her house, she would look down the hill and see a bunch of kids. They looked like they were always having fun. So, she ended up running away and meeting up with them.

"They had a little cult. The cults I deal with are not formal

Satanic cults. They're kids who get together, take a little from this book and that book, and add a little of their own. They get a nineteen-year-old to be the high priest, and they dabble. In this instance they had a twenty-one-year-old high priest.

"She said one night they brought in three kids who were loaded, and they were going to have a ritual. She said that she was always loaded when she these types of people prior to 1969? was with this group. She couldn't stand to do it otherwise. I asked how loaded they were. I was trying to get an idea. She said they had to carry them in.

"They brought them in and apparently these three had ripped off the little Satanists in a dope deal. They started the ritual; they rang the bell, they did an invocation to Satan. Then they went out to the hills—she drew me a map—where there was a chain and some trees. They had cans of gasoline, and they did the ritual and brought one guy out and threw him in the middle. They all had candles, and the high priest threw the candle on him and he was torched like that. The girl said he wasn't that loaded that he wasn't screaming and yelling. They just let him burn.

"She said they brought another kid out, a girl, and one of the boys was feeling her up, she got sick and left. She said, 'I knew the same thing was going to happen to me.'

"I tried to get the Los Angeles Sheriff's Office to talk to the kid. Two officers were willing to talk to her-but the public defender stepped in and said no. They would not let her talk. They represented her in another case, and they were afraid that they were going to press charges on her. That wasn't the case, but they wouldn't believe it. The police weren't going to file charges, they just wanted the information. (The case is still under investigation.)"

#### SATANIC MURDERS: A GREAT STORY THAT JUST WASN'T THERE

TOLEDO—Hanging from a tree branch next to a rural Lucas County road was what for all the world appeared to be a piece of red string, perhaps six inches long.

It wasn't knotted or arranged in any way. It just hung there about eye level, waiting for the wind to carry it to the ground or for an expert on Satanism to call it a tool of devil worship and possible evidence of ritual murders.

Some 50 people gathered around the string last week and listened as Dale Griffis, a Tiffin, Ohio, police investigator who has a reputation as an expert on Satanism, told them that red string is used to mark boundaries of Satanic ceremonies.

Then Griffis, whose public-relations polish shows his experience in dealing with the news media, did something police investigators rarely do. He led this pack of journalists back into the woods to what is known in the trade as a crime scene and displayed some gay pieces of evidence gathered.

This makes great tape for television and great pictures for newspapers.

The tramp through the woods resembled a nature hike, with Griffis pointing out the sights. Investigators rarely do this sort of thing for fear of disturbing evidence.

Griffis has played a big role in investigating what Lucas County Sheriff James Telb described as the possibility of 50 to 75 ritual murders, many of them supposedly involving newborn infants in a wooded area west of Toledo.

Telb sought Griffis' advice during the three-month investigation marked by reports from several informants who said they were members of a 200-person cult. Telb had Griffis flown in by helicopter Thursday to view suspected sites.

Telb still has no bodies and no other physical evidence that any murders took place, except the reports from informants, none of whom actually witnessed any killings. He stopped digging Friday but said he is still investigating.

What Telb does have is a collection of objects, some odd and some commonplace, that Griffis says are evidence of Satanic rituals.

Take the knife for example. It was found in the trash-littered, ramshackle vacant house a few hundred yards from the alleged mass grave sites.

The 6-inch blade has a somewhat unusual shape, slightly curved and tapering at the point. The handle is wooden. To someone unfamiliar with Satanic cults it looks like an odd kind of kitchen knife. Griffis said it was an athame, a ritual dagger.

When asked what made this knife an athame, Griffis said, "Any kind of knife can be an athame, even a steak knife."

Griffis said he has studied Satanic cults for about his advice when confronted with examples of mutilated animals and desecrated graves as well as related drug or sex activities, he said.

At one point, Griffis led the journalists to a small plot ground set off by several stakes with red string attached.

To the uninitiated, it might have been a failed vegetable garden, but Griffis said it was a ceremonial ground used by the Satanists. A small metal can stood in the center. Griffis said it was used for burning, but there was nothing in it.

In a vacant cinder-block house near the staked area, investigators found a sheet of tin with several lines of letters written backwards. Sheriff's deputies said these are Satanic symbols, but they can't decipher them.

Also found in this area was a headless doll with its feet nailed to a board and a five-pointed metal star tied to its wrists with red string. The star, Griffis said, is a Satanic symbol. A rag and a toy telephone receiver also were attached to it. Griffis said the doll is used in a death ritual.

As for the rag and telephone, he said, "I'm still trying to work that out."

For the skeptical who say that Satanic ritual murders are more rumor than substance. Griffis points to a highly publicized case in Riverhead, New York, in which a teenager was stabbed to death by another teen in what was billed as a Satanic ritual.

Further quoting from the article by Mr. Breiner of an article excerpted from a previous publication:

"On July 4, 1984, police found the body of Gary Lauwers, seventeen, in a shallow grave in a wooded area of Northport on New York's Long Island. According to a statement to police, Ricky Kasso, seventeen, admitted killing Lauwers by stabbing him in the face and cutting out his eyes." (I have already referred to this incident prior to this.) "Kasso said he screamed at Lauwers, 'Say you love Satan', before the boy was killed in a Satanic ritual.

"Kasso and at least twenty other people had belonged for several years to a Satanic cult called 'Knights of the Black Circle', which had previously held rituals in which they sacrificed animals. In 1981, police found the burned carcass of a baby goat on a picnic table in a park where the group often congregated. The group also had painted pentagrams, inverted crosses, and other Satanic symbols in the park. Kasso had an inverted cross tattooed on his arm and had been arrested the previous April for digging up graves for use in rituals. He had stolen a skull and left hand from a corpse.

"Also arrested with Kasso was James Trojano. eighteen, who police say held the victim down while he was being murdered. Kasso told police that Lauwers had stolen ten bags of angel dust from him.

"Kasso committed suicide by hanging himself in his cell several hours after his arraignment. Troiano was acquitted of second-degree murder charges less than a year later in a highly publicized trial in Riverhead. A third youth, Albert Quinones, witnessed the murder and had been granted immunity for his testimony."

The other example Griffis used was the Charles Manson gang which committed a series of murders in 1969 in Southern California.

So far, there is no physical evidence that anything of this type has happened in Toledo.

Although Telb called off the search, he defended his action in executing a search warrant for a suspected cultist and the unsuccessful search for bodies.

#### **BUSH: OPPOSITION SHOULD AVOID KABUL**

NEW YORK (AP)—President Bush said Saturday that northern alliance forces battling the Taliban in Afghanistan should steer clear of the capital city of Kabul, part of an effort to assure that power is eventually shared among the various tribes of the country.

"We will encourage our friends to head south... but not into the city of Kabul itself," Bush said at a news conference one day after northern alliance forces claimed the strategic city of Mazar-e-Sharif about 200 miles from the Afghan capital.

Bush made his comments in a session with Pakistani President Pervez Musharraf, who swiftly agreed that the northern alliance must not move into Kabul. The Pakistani leader said if they do, "we'll see the same kind of atrocities being perpetuated against the people there" as after the Soviet Union left Afghanistan more than a decade ago.

With his remarks, Bush acknowledged for the first time what aides said has been the military strategy from the start to keep the northern alliance from taking Kabul without some kind of post-Taliban governing arrangement being in place that would involve various segments of Afghan society. The policy underscores concern with nation's long history of infighting and tribal animosities.

bombing and other assistance in the successful push against Mazar-e-Sharif, and presumably would need assistance to move successfully against the capital.

Bush said he didn't know whether Osama bin Laden has nuclear weapons, as the terrorist mastermind claimed in a recent interview with a Pakistani journalist. "The only thing I know for certain about him is he's evil" and that is "all the more reason to pursue him diligently," the president said.

Bush lavished praise on Musharraf after a private meeting, and opened the news conference with an assistance to Pakistan, as well as debt relief.

"In our hour of need just after the terrorist attacks on Sept. 11, President Musharraf quickly condemned the evildoers," Bush said. "He has shown even greater courage in the weeks since." He added that Musharraf is "committed to restore democracy in Pakistan".

For his part, Musharraf said the two men had discussed "Pakistan's difficulties from the fallout of whatever is happening in our region," an apparent reference to the anti-American sentiment evident among Taliban supporters, particularly along the Pakistan-Afghanistan border.

The words of support and pledge of funds were fresh indication of the favor that Musharraf—shunned two years ago by President Clinton—has gained since leading his country firmly into the coalition against terrorism being waged in next-door Afghanistan.

Bush was asked about the status of Kabul one day after Secretary of State Colin Powell said the capital should be an "open city" in the post-Taliban era.

He said he and Musharraf share the view that "any power arrangement must be shared with the different tribes within Afghanistan, and a key signal of that will be how the city of Kabul is treated."

Afghanistan is comprised of numerous ethnic tribes, all they are battling to bring about. Northern alliance groups include Uzbeks, Tajiks and others, while the Pashtun are predominant in the southern part of the country.

Bush passed up an opportunity to comment on Musharraf's assertion that atrocities might follow if the northern alliance forces moved into Kabul, which is largely Pashtun.

Kashmir, a disputed border region claimed by both Pakistan and India, and that the United States "will do what we can to bring parties together."

Bush stressed that the United States can still accomplish its war aims if the northern alliance does not enter Kabul.

The two presidents met in conjunction with a United Nations General Assembly session, delayed in the aftermath of the Sept. 11 terrorist attacks. Bush addressed the world body earlier in the day, warning all nations they are possible targets of terrorism and urging them to join in the worldwide battle to prevent more attacks.

Heading into the session with Bush, Musharraf had sought military and economic assistance from the United States—and also made clear he opposes any move by the northern alliance opposition forces to enter Kabul.

In addition, he has warned that scenes of civilian suffering—the result of wayward American bombsbeamed by satellite television throughout the world are hurting the coalition's cause.

Among the concessions sought by Musharraf was Northern alliance fighters relied heavily on American the release of 28 American F-16 fighters sold to Pakistan in the 1980s, when it was an ally against the Soviet Union. The planes were withheld by Congress because the Pakistan developed nuclear weapons. Bush did not address the issue at the news conference, but aides said he did not intend to release the planes.

> Prior to the meeting, Bush had waived the last remaining sanctions put in place against Pakistan in the 1990s, including some imposed after Musharraf took power in a 1999 military coup.

#### ARAB SATELLITE CHANNEL AL-JAZEERA'S OFFICE IN AFGHAN CAPITAL DESTROYED BY MISSILE

KABUL, Afghanistan (AP)—An office of the Arab of them maneuvering for position in the post-Taliban era channel Al-Jazeera, which has been criticized by the United States for its coverage of the Afghan conflict, was hit early Tuesday during an air raid. The United

States said it targeted the al-Qaida network and didn't know the television channel was located there.

No one was in the two-story building housing the office when it was hit before dawn, as columns of Taliban soldiers poured south out of the capital, said Ghulal Mohammed, a guard at the office in Kabul's Wazir Akbar Khan neighborhood.

"It was a rocket, but everyone is OK," he said. He said the missile did *not* explode.

But an American official said two 500-pound bombs were dropped on the site, which the U.S. military believed was an office of Osama bin Laden's al-Qaida network.

The building was "a known al-Qaida facility in Bush also said the two leaders had discussed central Kabul," said Col. Rick Thomas, a spokesman for the U.S. Central Command.

> "We had no indications this or any nearby facility was used by al-Jazeera," Thomas said. "We had identified two locations in Kabul where al-Jazeera people worked, and this location wasn't among them."

> Al-Jazeera's managing director, Mohammed Jassim al-Ali, said the office was hit before dawn and that nobody was there at the time. He said its 10 staffers were believed to be safe but their whereabouts were unknown.

> Asked if he thought Al-Jazeera's office was deliberately targeted, al-Ali said: "They know where we are located and they know what we have in our office and we also did not get any warning."

> Al-Ali told The Associated Press in a telephone interview from Qatar, where the channel is headquartered, that the equipment was destroyed but staffers were safe.

> "We don't know where our crew members are. We are trying to see how we can communicate with them."

> The nearby offices of The Associated Press and the British Broadcasting Corp. in Kabul were damaged by an explosion that rocked the neighborhood at the same time that Al-Jazeera's office was hit. Windows in both offices were shattered.

> There were no injuries among the BBC and APstaffers in the offices.

> Several houses in the neighborhood were targeted by U.S. jets late Monday and early Tuesday. Arabs who apparently belonged to al-Qaida, as well as Pakistani, Chechen and Uzbek warriors who fought alongside the Taliban, occupied houses in the neighborhood.

A Taliban government ministry was across the Administration officials said in advance the street from the office, and Taliban anti-aircraft positions were located on a hill nearby.

> After the Taliban fled Kabul overnight, fighters from the anti-Taliban northern alliance marched in from the north.

> Afghan workers of the International Committee of the Red Cross in Kabul said a rocket fired from a U.S. jet hit a pickup truck, killing four Arabs. The charred bodies of the four unidentified men were taken by the Red Cross.

> Al-Jazeera has aired taped statements said to be made inside Afghanistan by bin Laden and his aides, and its reporter Tasir Alouni became familiar to Arab viewers around the world, providing live reports from Taliban-controlled areas barred to most Western reporters.

> He often described U.S. missiles hitting civilian areas and killing women and children. The United States has disputed Taliban claims of widespread civilian casualties.

> American officials have criticized Al-Jazeera's coverage of the bombing campaign as inflammatory propaganda.

> But the 24-hour station reaches more than 35 million Arabs, including 150,000 in the United States, and the Bush administration has acknowledged its significance lately.

> The station recently interviewed Secretary of State Colin Powell, National Security Adviser Condoleezza Rice and Air Force Gen. Richard Myers, chairman of the Joint Chiefs of Staff.

> On Tuesday, Al-Jazeera showed CNN footage from Kabul and live coverage Tuesday from its five-member crew in the Taliban's home base, the southern city of Kandahar.

#### <u>U.S. AGENTS WERE TOLD</u> TO 'BACK OFF BIN LADENS'

London (Sapa-AFP)—Special agents in the United States probing relatives of Saudi-born terror suspect Osama bin Laden before September 11 were told to back off soon after George W. Bush became president, the BBC reported on Tuesday.

The *BBC's Newsnight* current affairs programme said that Bush at one point had a number of connections with Saudi Arabia's prominent bin Laden family.

It added there was a suspicion that the U.S. strategic interest in Saudi Arabia, which has the world's biggest oil reserve, blunted its inquiries into individuals with suspected terrorist connections—so long as America was safe.

Newsnight reported it had seen secret documents from a FBI probe into the September 11 terror attacks on New York and Washington which showed that despite the reputation of Osama bin Laden as the black sheep of the family, at least two other U.S.-based relatives are suspected of links with a possible terrorist organisation.

The programme said it had obtained evidence that the FBI was on the trail of bin Laden family members living in the United States before, as well as after, the September 11 terrorist attacks.

*Newsnight* said Bush made his first million 20 years ago with an oil company partly funded by the chief U.S. representative of Salem bin Laden, Osama's brother.

Bush also received fees as director of a subsidiary of Carlyle Corporation, a little-known private company which in just a few years since its founding has become one of America's biggest defence contractors, and his father, George Bush senior, is also a paid advisor, the programme said.

The connection became embarrassing when it was revealed that the bin Ladens held a stake in Carlyle, sold just after September 11, it added.

*Newsnight* said it had been told by a highly-placed source in a U.S. intelligence agency that there had always been "constraints" on investigating Saudis, but under President George W. Bush it had become much worse.

After the elections, the intelligence agencies were told to "back off" from investigating the bin Laden family, and that angered field agents, the programme added.

The policy was reversed after September 11, it reported. The former head of the American visa bureau in Jeddah from 1987 to 1989, Michael Springman, told *Newsnight*: "In Saudi Arabia I was repeatedly ordered by high-level State Department officials to issue visas to unqualified applicants.

"People who had no ties either to Saudi Arabia or to their own country. I complained there. I complained here in Washington... to the Inspector General and to Diplomatic Security and I was ignored."

He added: "What I was doing was giving visas to terrorists—recruited by the CIA and Osama bin Laden to come back to the United States for training to be used in the war in Afghanistan against the then-Soviets."

Newsnight also said it had seen a document that showed U.S. special agents were investigating a close relative of Osama bin Laden, identified only as Abdullah, because of his relationship with the World Assembly of Muslim Youth (WAMY), which the programme said was a suspected terrorist organisation.

The programme reported it had found where he used to live with another close relative, Omar, also an FBI suspect, in Falls Church, Virginia, a suburb of Washington.

The house was conveniently close to WAMY, it said, and just a couple of blocks down the road was a place listed by four of the alleged September 11 hijackers as their address.

The U.S. Treasury has not frozen WAMY's assets, and insists it is a charity, the programme said, yet Pakistan had

expelled WAMY "operatives" and India claimed WAMY was funding an organisation linked to bombings in Kashmir.

The FBI did look into WAMY, but for some reason agents were pulled off the trail, *Newsnight* said.

# BIN LADEN 'MET CIA AGENT BEFORE TERROR ATTACKS'

A French newspaper claims a U.S. intelligence agent met Osama bin Laden in a Gulf hospital two months before the terror attacks on New York.

Le Figaro said the meeting took place between July 4 and 14, while bin Laden was being treated for a serious kidney ailment at the **American Hospital in Dubai**.

During his stay at the hospital, bin Laden was visited by members of his family and the local representative of the CIA, said *Le Figaro*.

The newspaper claims the CIA agent later boasted to several friends that he had visited the Saudi terror mastermind who at that time was wanted for the bombings of U.S. embassies in Africa and the attack on the destroyer *USS Cole* in Yemen.

In Dubai, he was reportedly treated by Dr. Terry Callahan, a specialist in kidney ailments and male infertility. He refused to comment.

The American Hospital in Dubai denies that bin Laden had ever been a patient.

Quoting "a witness, a professional partner of the administrative management of the hospital", the newspaper said the man suspected by the United States of being behind the September 11 terrorist attacks had arrived in Dubai on July 4 by air from Quetta, Pakistan.

Several sources had reported that bin Laden had a serious kidney infection. He had a mobile dialysis machine sent to his Kandahar hideout in Afghanistan in the first half of 2000, according to "authoritative sources" quoted by *Le Figaro* and French radio.

#### ALIENABLE RIGHTS

In the U.S. and elsewhere, the fallout from 11 September may include the end of the era of civil liberties and human rights.

We all knew it was coming. Last Friday, U.S. President George W. Bush signed an anti-terrorism bill that proposes sweeping new powers for the FBI, extending the agency's ability to search citizens, wire-tap telephone lines and eavesdrop on the Internet. The period of detention allowed for a foreign citizen suspected of terrorist activities has also been increased. The bill—which has raised concerns over the meaning of civil liberties in the post-11 September age—came as no

surprise to rights advocates in the U.S. and elsewhere.

The U.S.-led alliance's "war on terrorism", now in the fourth week of its offensive against Afghanistan, bypassed internationally-recognised channels of legitimacy such as the United Nations and its Security Council. The result: hundreds or perhaps thousands of Afghan civilians may have been killed (no accurate numbers have been released because the Pentagon says it still doesn't know). But the "war on terror" has meant more than the loss of innocent lives: It has included a myriad of other measures. The blocking of information and images from the war in Afghanistan from reaching the American public, for example. There has also been widespread discrimination against Arabs (and other people of Middle Eastern appearance) both by officials (at Western airports and airlines) and by the Western public. Approximately 900 "suspects"—most of whom are Arabs— have been arrested in relation to the 11 September attacks. In the struggle against "terror", several laws have been bypassed, leading to what civil liberties advocates have described as a serious threat to human rights.

The media debate on the choice between "freedom" and "security"—which is raging in Germany and elsewhere—reflects the chilling options now facing Western societies. But has the choice been made already?

FBI and Justice Department investigators, frustrated by their failure to extract confessions from four suspects, are contemplating resorting to "pressure" according to a report in the *Washington Post* on 21 October. Among the alternative strategies under discussion are extracting information using drugs or other pressure tactics, such as those occasionally employed by Israeli interrogators, according to the article. Another idea is to extradite suspected terrorists to U.S.-allied countries in which security services can employ threats to family members or resort to torture. And last Sunday, the same newspaper reported that the CIA is contemplating pursuing an assassination policy of individuals—a policy that could extend beyond bin Laden and members of al-Qaida.

Meanwhile, the U.S. State Department—taking advantage of the frenzy and confusion that followed the terrorist acts—endorsed the American Service-members Protection Act (ASPA) on November 5. The legislation authorises the U.S. to use force to "liberate" any U.S. or allied persons detained on behalf of the proposed International Criminal Court (ICC), which will be based in The Hague, Netherlands. It also prohibits U.S. military assistance to those states that ratify the ICC treaty except for NATO members and some major non-NATO allies.

The New York-based Human Rights Watch described the new law as an attempt to undermine the establishment of a permanent war crimes court. "The United States is forging a global coalition against terrorism, and the State Department has just endorsed a bill that authorises an invasion of the Netherlands," said Richard Dicker, director of the International Justice Programme at HRW. "This makes no sense. It hardly seems like a good moment for the U.S. to be threatening sanctions against dozens of countries simply because they want to bring to justice the perpetrators of crimes against humanity."

For many, it is difficult to find any sense in this new reality. The U.S. Coalition's use of force, for example, appears to be contrary to established international law.

This is the case according to William Schabas, director of the Irish Centre for Human Rights. "The use of force is prohibited by the *United Nations Charter* (art. 2(4)), except in two circumstances: self defence (art. 51) and Security Council action under Chapter VII (art. 42)," says Schabas. "It does not allow the use of force for the purpose of "retaliation". Schabas told *Al-Ahram Weekly* that "the U.S.-led alliance seems to find support for its action by invoking the right of self-defence rather than the right to retaliate. This is a broad and exaggerated interpretation of the right of self-defence."

Normally, he argued, a person (or a state) acting in genuine self-defence is very clear in explaining and justifying its behaviour on this basis. "But the U.S. and UK, with their talk of retaliation, reprisal, 'bringing terrorists to justice' and so on, invoke grounds that are not really compatible with the concept of self-defence."

Schabas acknowledged that the U.S. does enjoy selfdefence rights but pointed out that its actions must be conditioned by "proportionality" and by what is necessary to protect itself from attack. In his words, "the U.S. seems to be taking a view that in the name of the war on terrorism it has the right to attack (or 'counterattack') any country it suspects of being insufficiently unsympathetic to terrorism. In effect, this is the legal window dressing of the pax Americana, a justification to attack any country that the U.S. doesn't like, and at any time." To Schabas, one of the unfortunate consequences of all of this is the "marginalisation of the United Nations, which should in fact be taking the lead according to its noble role under the UN Charter."

Perhaps it was with this super-power mentality in mind that the U.S. Congress adopted the anti- terrorism bill. According to the American Civil Liberties Union Freedom Network (ACLU), "the bill was adopted in near record time with only one public hearing and little debate."

"All this will have terrible repercussions," was the response of International Law Professor Kamal Abul-Magd. "If the law doesn't give you protection, you are more likely to take the law in your hands."

To observers in the Middle East, the new U.S. laws seem to be a glaring paradox. In this part of the world, the anti-terrorism bill sounded like all-too-familiar a tune. "It's almost identical to the 'emergency laws' faithfully adopted by Third World regimes," says Dawoud Al-Shoryan, a columnist for the London-based Arabic daily Al-Hayat. For many years, the U.S. State Department's Human Rights desk has itself issued annual reports clearly condemning such governments and their "freedom tying' policies, human rights abuses and violations in the name of seems like the U.S. is now taking such "backward regimes" as their role model. #### **ISRAEL PERSISTS WITH DEATH SQUADS**

They have blown up cars and kitchens. They have fired missiles from combat helicopters hovering several miles away. They have picked off their victims from afar with high-powered snipers' rifles. There are even plausible claims that they—or their collaborators—have planted explosive devices in telephone receivers and car headrests that blow off a man's head in an instant.

the manner in which they have pursued their government's policy of assassinating suspects in the 14-month war with the Palestinians.

Exactly a year has elapsed since Israel first restored extra-judicial killings to its repertoire of military tactics in its efforts to suppress what began as a popular uprising, turning slowly into an armed conflict.

The exact numbers of the victims vary—the Israeli Prime Minister, Ariel Sharon, who personally approves all such killings, admitted to 20 to 30 in a recent Newsweek interview. But he has stated in the past that Israel will sometimes deny its undercover operations, and refuse to comment on others.

There is little doubt the figure is larger. Statistics collated by the Palestinian Human Rights Monitoring Group (PHRMG) show that at least 59 Palestinians have been assassinated in the past year, including 21 passers-by. Even this may be an underestimate.

The international community has repeatedly condemned the killings, saying they are illegal and that, in the long run, they increase violent resistance to Israel's occupation.

Human rights groups have raised many urgent concerns, from the manner in which Israeli intelligence selects targets—which is not open to scrutiny by any judiciary—to evidence that some victims could have been arrested, instead of killed.

"State enforcement of a policy of assassinations the emergency law. To El-Shoryan and many others, it is in direct contravention of international human rights law, and especially of the right to life and the right to fair trial," a statement from the PHRMG said yesterday, "People suspected of illegal activities must be arrested and brought to trial, even in a situation of armed conflict."

After emptive strikes against attacks on Israelis—notably suicide bombers, who have killed 56 people in Israel since this intifada began. On 8 November last year, in Beit Sahour, a Palestinian town on the edge of Bethlehem, Israeli combat helicopters blasted missiles into a pick-up truck. They got their man—Hussein Abayat, 34, a gunman from Fatah, the movement nominally controlled by the Palestinian leader, Yasser Arafat.

Posters of Abayat in paramilitary fatigues posing with a large machine-gun still adorn the walls of Bethlehem, where he—like all Israel's victims considered a martyr. But the assassins also killed two middle-aged women who happened to be passing, murders that did not discourage the Israel army from congratulating itself on a successful "targeted killing". A monument to the two woman stands where they died.

But the most notorious assassination came at the end of August when Israeli helicopters hovering over the West Bank town of Ramallah fired two missiles through the windows of the leader of the Popular Front for the Liberation of Palestine, Abu Ali Mustafa, 64, decapitating him as he sat in his swivel chair. As the leader of an established PLO faction—who according to Palestinians was a politician rather than a member of the PFLP's military wing—he was the most senior figure to be picked off by the Israelis.

Seven weeks later, the PFLP sought revenge, by infiltrating a Jerusalem hotel and assassinating Israel's Tourism Minister, Rechavem Zeevi, whose support for ethnically cleansing the West Bank and Gaza of Arabs had long made him an enemy of the Palestinians.

Israel's counter-attack—the largest invasion of Palestinian-run areas in West Bank towns since the Oslo process began—is still unfinished; Israeli troops were still in Jenin and Tulkarm last night. The evidence suggests Israel will now step up the pace of extra-judicial killings.

The pressure from the United States has diminished, Israel's death squads have not lacked ingenuity in not least because America will surely resort to similar tactics in its "war on terror". This week, Raanan Gissin, a spokesman for Mr. Sharon, said Israel will now "be using, when necessary, guerrilla warfare against terrorism rather than large-scale forces moving into the area ... We'll rely more on [military] intelligence." Even Shimon Peres, the Israeli Foreign Minister, who is routinely portrayed in the press as a Nobel Peace Prize-winning 'dove", makes no apology for Israel's methods.

#### THERE IS NO NEW PEACE PLAN

"I am willing to bet my good name that there is no joint Peres-Sharon peace plan," declared Reuven Rivlin yesterday. "Even the statements made by Dr. Sari Nusseibeh about conceding the right of return and the hints of changes in the Palestinian positions on other subjects have not made the prime minister consider a new plan," said the communications minister.

Rivlin, to whom the prime minister's door is always open, sounded completely confident of his diagnosis. "The gaps between Sharon and Peres concerning the final status settlement are unbridgeable. The difference between them is like the difference between the Oslo Agreement and Sharon's security approach."

Rivlin is convinced that all the yarns about a diplomatic plan are mere inventions intended to "save Peres's face". In his view, the only thing Sharon and Peres agree on is that Israel must insist on every comma in the Tenet plan and the Mitchell recommendations. "When that happens, Israel will have to consider entering into negotiations that will require painful concessions."

What concessions is he referring to? A Jordan Valley strip, 20-25 kilometers wide will remain in Israeli hands, and the same goes for the mountain ridge and area south of Ma'aleh Adumim toward Arad. Jerusalem will not be divided.

And no one is saying anything about dismantling settlements. That is exactly the map Sharon used to present to his guests when he was head of the opposition. Claiming this map to be the basis of a new peace plan is an insult to the public's intelligence and memory.

#### **ISRAEL USES TORTURE** IN DEFIANCE OF COURT BAN, REPORT SAYS

Israel has resumed systematic torture of Palestinian detainees even though the Israeli Supreme Court banned the practice two years ago, three human-rights groups said in a joint report.

The document cited affidavits from detainees, including a 16-year-old who said he was soaked in freezing water, made to carry a heavy wooden beam

An Israeli government report on the issue said the ban on torture was still in effect and an official added that alleged violations were being investigated. The government has said that, sometimes, security forces needed to extract information quickly from suspects who might have knowledge of an impending attack.

The Israeli report and the response by the humanrights groups will be submitted to a meeting of the United Nations Committee Against Torture.

The joint document by the Public Committee Against Torture in Israel, the Palestinian rights group Law and the Swiss-based World Organisation Against Torture contends that the September 1999 High Court ruling has been regularly flouted, particularly since the intifada began in September of last year.

The report cites nine affidavits by Arab detainees saying they were interrogated using methods expressly forbidden under the 1999 ruling or by existing Israeli or international law. The groups say they have received about 20 reports of violations since the ruling was passed.

Among these are sleep deprivation, shackling a prisoner to a chair in painful positions for prolonged periods, use of smelly hoods, the playing of deafening sounds and beating, slapping and kicking.

Rami Zaul, 16, who was interrogated in October and November 2000, described how freezing water was poured on to him. He said he was then forced, while handcuffed, to drag a wooden beam with one of his interrogators standing on it. "When I got tired and dropped it I was beaten hard," he said.

An Israeli official, speaking on condition of anonymity, said that in many instances such complaints were unjustified, exaggerated and unsupported by medical evidence and in some cases they formed part of a disinformation campaign by Palestinian groups.

#### TURKEY'S ISLAMISTS MOVE TO OUST ECONOMY MINISTER OVER CRISIS

ANKARA—Turkey's pro-Islamic Felicity Party (SP) on Friday submitted a censure motion demanding the dismissal of Economy Minister Kemal Dervis for worsening a severe economic crisis and bringing the country to the point of bankruptcy, parliamentary officials said. The motion accused Dervis of pressuring the government into taking every decision he wished for and nonetheless failing to meet any of the targets foreseen in a tight economic recovery program.

"Foreign currency exchange rates, inflation and state debt have multiplied, businessmen have gone bankrupt and thousands of workers have been laid off," said the motion. a copy of which was obtained by AFP.

A banking sector crisis forced the government in February to abandon a pegged exchange rate regime, disrupting a disinflation program backed by the International Monetary Fund.

Since then, the lira has lost more than 50 percent of its value against the dollar.

In May, Prime Minister Bulent Ecevit's three-party coalition put into force a program of tight reforms to bring the economy back on track with multi-billion dollar aid from the IMF and the World Bank.

The Felicity Party also claimed that the government's decision to send soldiers to Afghanistan upon a request by key ally Washington was a deal in return for cash.

The motion claimed that the entire government one of the reasons why it was chosen to host [the meeting]. was responsible for the economic crisis, but said that Despite that, we will face the challenge and have a presence the primary guilt lay on Dervis.

Meanwhile, thousands of demonstrators began to gather in one of the Turkish capital's main squares Friday to protest against government policies aimed at tackling the country's economic crisis.

The demonstrators came from all over Turkey as part of a march lasting several days under the slogan 'No to Poverty, Corruption and Unemployment".

Routes into the city's Sihhiye Square taken by the march—organized by the country's main trade unions—are being heavily policed with a helicopter flying overhead.

Turkey has been laboring under a severe economic crisis since February which has seen steep inflation, business closures, and thousands of job losses.

Unrelenting inflation has been a major problem for the Turkish economy over the past two decades.

#### **GLOBALISING OPPOSITION**

The newly-founded Arab Forum for Resisting Globalisation held its first conference in Beirut last weekend. The coming WTO meeting in Doha was a constant theme.

BEIRUT—Last weekend, almost five hundred people took part in a two-day conference held in Beirut by the Arab Forum for Resisting Globalisation. Those who attended were treated to lectures on the role the Arab world can play in resisting globalisation, the impact of 11 September on anticapitalist movements and a call to take action at the upcoming conference of the World Trade Organisation (WTO) which takes place in Doha this month.

The organisers of the anti-globalisation conference, a group of Arab NGOs, held meetings last August and September in Beirut to prepare a new Arab and international movement against globalisation policies. Those meetings involved Lebanese and Palestinian activists in Lebanon, as well as activists from Iraq, Tunis, Morocco, and Sudan. As a result they founded the Arab Forum for Resisting Globalisation.

The forum's goal, as defined by its founders, is to create a permanent Arab network resisting globalisation. The network aims to coordinate the exchange of information and expertise among concerned groups in Arab countries. It will also liaise with the international anti-globalisation movement.

The forum also seeks to represent a unified Arab "voice" criticising globalisation from the standpoint of Arab world grievances.

The forum has already decided to act: one of its first engagements will be the WTO ministerial meeting in Doha. As a result of the Beirut conference, a forum subcommittee approved the tactic of holding popular meetings and sit-ins to protest globalisation, mentioning the Doha conference specifically. Rallies will also be organised to support Palestinians in South Lebanon.

The initial meeting of the new forum won interest from around the world, not just the region. Among the lecturers at the initial meeting was French farmer Jose Bove, who shot to fame by wrecking a McDonald's restaurant. Arab delegates came from Morocco, Algeria, Tunisia, Jordan and Palestine.

Bove's statements were particularly rousing. He said, "Popular demonstrations will be banned [in Doha], which is

in Doha." He also applauded the involvement of the Arab world in the anti-globalisation movement.

Bove also discussed the challenges raised by globalisation in the wake of 11 September. "We cannot consider what happened on 11 September a setback to the anti-globalisation movement," Bove said. "But we can say that what happened...was one of the results of globalisation, in that it has ostracised large parts of humanity."

Bove then moved his thoughts to the region. He argued that "one of the first manifestations of globalisation was the war against Iraq and the siege imposed upon it."

He also accused the North Atlantic Treaty Organisation (NATO) of being an instrument of globalisation. "It imposes the hegemony of certain states over other states. Those whose interests conflict with the interests of the United States get punished.'

Bove then denounced Israel as a "bridge for neoliberalism", saying his visit to the Palestinian territories last June had opened his eyes to the economic dimension of the conflict in the occupied territories.

Mufid Qteish, a founding member of the forum, spoke, too. He argued that the U.S. has used the events of 11 September to inaugurate a campaign of revenge against the rest of the world. He said America was using international organisations, including the United Nations, to legitimise aggression.

"11 September will mark the beginning of a new, more dangerous and more sombre history," he said.

Oteish also discussed regional issues. Referring to both the Palestinian and Iraqi "tragedies", he said that in the Arab world "all types of oppression" take place, "including embargoes, the confiscation of resources, and an increase in the technological gap between countries here and the countries of the developed world".

Many speakers remarked that, wealth, not religion, was the main thing dividing peoples. Abu Ahmed Fouad, a member in Syria of the Popular Front for the Liberation of Palestine (PFLP), said globalisation "divides humanity into a great majority of poor, marginalised, and oppressed people on one hand, and a few capitalists on the other."

Dr. Fawaz Trabulsi, speaking on behalf of the National Gathering for Salvation and Change, said the world was not divided between Islam and Christianity, but between "the rich and poor and the arrogant and the oppressed".

Bove concluded that "our slogan is that we must globalise the [anti-globalisation] struggle in order to globalise hope".

Meanwhile, opposition to the Doha meeting is coming from across the region, as well as Beirut. In Egypt, 355 intellectuals and other Egyptians signed a petition aimed at the WTO meeting in Doha. The petitioners expressed their opposition to "liberal globalisation in view of its violation of all peoples of the world and the pressures it exerts on governments to give up their social commitments to their citizens." The petition charged the WTO with being one of the organisations responsible for such policies.

It also warned that "the anti-globalisation movement all over the world is preparing for a new confrontation with the WTO [during its meeting in Doha]," hoping to cause the meeting to fail, as it managed at Seattle.

It is also a victory for certain members of the International Federation of Red Cross and Red Crescent Societies in Geneva-and apparently certain American Red Cross board memberswho objected to Dr. Healy's strong and principled stance against the anti-Israeli feelings that have kept Magen David Adom (MDA), Israel's equivalent of the Red Cross, excluded from full federation membership for 50 years.

The denial of unconditional recognition to MDA in the worldwide family of national Red Cross societies because it employs a Red Shield of David as its symbol rather than the Red Cross or Red Crescent is an abomination. Bernadine Healy thought so too. At her request, and with strong bipartisan backing in Congress, the American Red Cross decided to delay payment of its dues to support the federation until bigotry gave way to tolerance. Former secretary of state and American Red Cross ambassadorat-large Lawrence Eagleburger indicated in an Oct. 30 oped piece that Dr. Healy's opposition to the federation's policies of exclusion and intolerance ran afoul of some American Red Cross board members and led to pressures that caused her to conclude she had no choice but to resign. There may be other factors that helped contribute to Dr. Healy's abrupt departure. But surely her decision to withhold American Red Cross dues from an international organization that won't admit Israel on a full and equal basis is one the American Red Cross board should have steadfastly supported. Some members evidently were prepared to cut and run.

The extent of the federation's willingness to give in to the worst instincts of some of its member governments, especially Arab relief agencies, is clear in a letter we publish today from Denis McClean, a spokesman for the International Federation of Red Cross and Red Crescent Societies in Geneva. He writes with evident pride that the federation's member governments "are now preparing to adopt an additional emblem with no religious or national connotations to stand alongside the Red Cross and the Red Crescent as emblems universally recognized as providing protection in time of conflict." In other words, under the proposed deal, the Red Cross and Red Crescent symbols are in, the Red Shield of David is out, and Israel's humanitarian aid society can join—as long as it hides its face. The international outrage goes on. All the more reason, as Dr. Healy courageously maintained, that the American Red Cross should withhold its dues.

WTO officials see resolving it as essential to correcting the image that freer trade favors the rich over the poor.

Developing countries, led by Brazil and India, are guarantee 20-year patents on medicines.

They say they cannot afford costly Western drugs to treat scourges such as malaria that affect millions and must be able to make or import cheap generic versions without fear of litigation from drug companies or the WTO.

Led by the United States, industrialized countries are reluctant to provide a waiver, fearing its impact on other patents and a threat to the \$300 billion-a-year drugs industry.

One U.S. official reported a "better sense of convergence" on the crucial issue but a European envoy said he doubted there would be a deal until the last minute. "We're not out of the woods yet," he said.

#### **VAST QUARANTINE ROLE ADVOCATED FOR STATES**

WASHINGTON—In the event of a bio-terrorist attack using a deadly and contagious disease such as smallpox, public health officials want to be able to close roads and airports, herd people into stadiums, and, if necessary, quarantine entire infected cities.

> The proposed Model State Emergency Health Powers Act may be months or years away from enactment by state legislatures. It may be amended beyond recognition. But health officials say major new legislation is crucial to keep smallpox, plague or hemorrhagic fevers such as Ebola from spreading in the event of a terror attack. Unlike anthrax, they are highly contagious.

> As a general principle, the draft law says authorities could "require isolation or quarantine of any person by the least restrictive means necessary to protect the public health."

Broad quarantines envisioned in the draft have seeking a waiver on public health grounds of rules that never been invoked in the United States. They raise all sorts of logistical, political and ethical questions in a mobile society, public health experts concede. But such quarantines also may save lives.

"If we don't do it, what would happen? I don't think we've got any choice but to quarantine," said Dr. Lew Stringer, medical director of North Carolina's special operations response team that handles disasters and bio-terror.

"The first thing you do is shut down the roads," he said. "Then you shut down the interstates, you shut down the schools, you shut down the businesses. You're shutting down essential services, not just nonessential ones."

Local governments need to practice plans for quarantines like fire drills to ensure they work in an emergency, said Dr. Scott Lillibridge, the bio-terrorism assistant to Health and

Thompson said Tuesday: "If we did have an outbreak of smallpox," a possible quarantine "would certainly be one of the avenues we'd have to explore."

CDC authorities and a state's governor would exercise their authority using mobilized National Guard units, said James Lee Witt, former director of the Federal Emergency Management Agency.

Lawyers and public health professors at Hopkins University in Baltimore drafted the plan, in collaboration with representatives of governors, state and local health officials and state attorneys general.

Congress "should give public health authorities strong powers to be able to isolate or quarantine people if necessary for the public health," said the proposal's chief author, Lawrence Gostin, professor and director at the two universities' Center for Law and the Public's Health in Washington.

Many states already have quarantine laws, but they may not be constitutional, Gostin said. He said his proposal would probably pass constitutional muster because it lets detainees ask a judicial-medical board to get them out of quarantine.

In Michigan, there are legal provisions for the governor to declare a medical emergency and for state agencies to issue a quarantine, said Geralyn Lasher, spokeswoman for the state Department of Community Health.

Between the Public Health Code, she said, and the Emergency Management Act, "we have about all the areas covered" in case of a bio-terrorism attack and the need to issue a quarantine.

Gostin said the question of quarantines "is probably the biggest issue because it involves liberty of individuals in the public." He said the proposal would give officials authority to take control of hospitals or stadiums to house quarantined people.

But in the event of a quarantine, some people would likely evade restrictions and spread the infection elsewhere, experts said.

In one simulation, involving a fake plague that struck quarantine, said Randy Larsen of the AnserInstitute, a security think-tank in Arlington, Va.

Would a National Guardsman, he asked, shoot grandmother trying to evade quarantine?

Maybe, Gostin said. "You have to use all reasonable force." Sometimes, he added, that could mean lethal force. [JR: These quarantine proposals are ominous in structure and in planning. #### **BUSH ISSUES ORDER CURBING RELEASE OF PRESIDENTIAL PAPERS**

WASHINGTON-President Bush signed an executive order Thursday night allowing either the White House or former presidents to veto release of their presidential papers, drawing criticism from President Clinton and several historians.

The order reinterprets the Presidential Records Act of 1978, which put papers of future presidents in the public domain, following a court fight over President Nixon's papers. It envisioned the release of most sensitive records

12 years after a president had left office.

Administration officials said Bush's order was prompted in part by a request for 68,000 pages of records of President Reagan, the first president whose records are subject to the act. Under the order, either the incumbent president or the former president—and in some cases, the family of a deceased president-could withhold documents requested by scholars, journalists or others. It also provides that if a former president says the records are privileged, they will remain secret even if the sitting president disagrees. If the sitting president says they are privileged, they will remain secret even if the former president disagrees.

White House counsel Alberto R. Gonzales said any decision to withhold documents could be challenged in court, and that the administration would lose if a particular decision did not have solid constitutional grounding.

The order also covers the records of vice presidents. "There's a recognition of the importance, for historical reasons, of releasing as much information as we can, being mindful of the fact that there may be reasons that it's inappropriate or harmful to this country not to release certain information," Gonzales said. "I think we would err on trying to release as much information as we possibly can."

Gonzales said the administration plans to "give a lot of deference to the former president." But he said the incumbent president "will be in a better position to decide whether or not the release of documents of a former president do, in fact, jeopardize, say, the national security of this country."

Critics, however, said national security is protected by the 1978 act and other laws and regulations.

The order, citing a 1974 Supreme Court ruling, would also require members of the public seeking particular documents to show "at least a 'demonstrated, specific need" for the records. The Presidential Records Act, enacted in 1978, does not require any showing of need.

"This is a real monster," said Vanderbilt University historian Hugh Graham.

A Clinton aide said a representative of the president objected to the decision in a recent letter to the White year-old girl was raped, allegedly by her grandfather, House, arguing that sufficient protections are on the books.

#### RAPES OF CHILDREN RISE IN SOUTH AFRICA

JOHANNESBURG, South Africa—A recent surge in rapes of children and babies has sparked national outrage as rights activists, medical professionals and others accuse the government of not doing enough to stem the tide of sexual abuse.

According to police statistics, almost 32,000 cases of rape and attempted rape of children were reported from January 2000 to June this year. At least a dozen recent high-profile cases, including the gang rape of a 9-month-old girl in Northern Cape province, have stirred disgust and shock nationwide.

South Africa has the world's highest incidence of rape, with an estimated 58 child rapes a day and the rape of a woman every 26 seconds, according to statistics gathered by rights groups. But activists say the recent flurry of attacks points to an increasingly troubling moral disintegration among South Africans, and many are calling for reinstatement of the death penalty for child rape.

"It seems to be getting worse," said Glenys van Halter, vice president of South Africa Stop Child Abuse, a nongovernmental organization. "The children are getting younger, and the men are getting more callous about it."

Six men, 24 to 66 years old, have been charged with the rape and indecent assault of the 9-monthold, who is in a hospital in serious condition and may have been exposed to HIV.

When the men appeared in court Monday, about 3,000 protesters demonstrated outside, demanding the death penalty for the alleged attackers.

Days before the 9-month-old was attacked, a 3and a 14-month-old was reportedly assaulted by two uncles. Child welfare activists say that most attacks against children are committed by male relatives and that a significant number go unreported.

In 1998, the South African National Council for Child and Family Welfare reported that five children were abused every hour and that child rape had increased 74 percent since 1994. Since 1998, the figure for sexually abused children has risen 16 percent, the council says.

Some say that widespread poverty, unemployment and alcoholism are fueling the increase in child abuse.

Exacerbating the problem is the widespread Historians said vast troves of documents offering myth in some communities that sex with a virgin will protect one from contracting AIDS.

#### **NEW SETBACK IN MACEDONIA PEACE**

SKOPJE, Macedonia (AP)—A key ethnic Albanian party demanded revision Monday of a part of the Western-brokered peace agreement for Macedonia, causing a new setback in the Balkan country's difficult peace process.

The Party for Democratic Prosperity said it could not accept one of the 15 constitutional amendments called for in the Aug. 13 peace accord meant to end clashes between ethnic Albanian insurgents and government forces.

Lawmakers representing the rival sides had been expected to pass the amendments in Parliament this week. The reforms could be passed without the support of the dissenting party, but a wide consensus is considered essential for long-term peace.

Naser Ziberi, a top official of the dissenting party, said the group could not accept the draft amendment defining status of Macedonia's ethnic groups, saying it favors Macedonians.

"There must be a new effort to find a new solution" on the amendment's phrasing, Ziberi said. The draft of the disputed amendment was changed last month after protests by hard-line Macedonians, who said it unfairly favored minorities.

The draft text defines Macedonia as a country of "all citizens... the Macedonian people as well as citizens living within its borders, who are part of the Albanian people," and others.

Alan Le Roy, the European Union envoy to Macedonia, met Imer Imeri, leader of the Party for Democratic Prosperity, and tried unsuccessfully to persuade him to support the amendment, Imeri said.

Ziberi's comments, which came as Parliament convened in yet another attempt to try to ratify the accord, drew immediate criticism from other lawmakers who said they were ready to adopt the reforms.

Nikola Popovski, of Macedonian Social Democrats, said that dissenting party's opposition is "unacceptable... reneging on what has been agreed."

Popovski also complained of a weekend meeting between Ziberi, several other ethnic Albanian politicians and the officially disbanded ethnic Albanian guerrillas.

Macedonians negotiated with ethnic Albanian politicians only, and not with the rebels, whom they call "terrorists" bent on dividing Macedonia. The rebels, which recently surrendered 3,800 weapons to NATO troops, said they fought to improve rights for the ethnic Albanian minority, which makes up a third of Macedonia's 2 million population.

Ziberi confirmed the meeting but declined to comment on it.

The peace accord was signed by Macedonia's four largest political parties, two Macedonian and two ethnic Albanian parties, including the Party for Democratic Prosperity.
