INSTRUMENTS OF PUBLIC POWER; INVISIBLE GOVERNMENT

During WW I, Mr. William Gibbs McAdoo, Secretary of the Treasury expressed his loathing for the "instruments of public power":

There was a conspiracy between England, France and Russia to slap the Germans down. There isn't one valid historian in the world who can find a valid reason why those three countries decided to wipe Germany off the map."

Nor is there one single valid historian who can find Roosevelt breathed new life into the British in a valid reason why the United States went to war against Germany, why we attacked Iraq, why we attacked Serbia, why we put down the civilized government of South Africa, why we put the Sandanista Communists in power in Nicaragua and so on and so on ad-infinitum. > The armed forces of the United States, the billions of dollars, were not expended to make the world "safe for democracy", nor for the preservation of the mythical "Four Freedoms" (yet another Tavistock invention), nor in the patriotic motives which Churchill and Roosevelt were so good at incorporating into their speeches. If it were true, then why did we not remove the most ruthless dictators the world has ever known, Lenin and Stalin? Far from trying to remove them we were the first to recognize the bloody Bolshevik state they had set up in Russia. Worse than that, after WW II the United States destroyed nearly every anti-Communist government in the world and replaced them with Communist or Socialist regimes, of which Rhodesia, South Africa, and Nicaragua, are just a few examples.

Roosevelt and his War Cabinet knew the approximate time the Japanese strike against Pearl Harbor would take place. They knew that their policies had backed Japan into a corner from which it would probably have to fight its way out. They

approaching Pearl Harbor and that an attack was less than a week away. They knew after the final October 27, 1941, widely covered by press and 14-page coded message from Tokyo to its foreign radio, Roosevelt held the map aloft and in ringing embassies was decoded, there was a very strong and stentorian tones, declared: probability that an attack was imminent.

Yet, the commanders at Pearl Harbor, Admiral Kimmel and General Short, were not immediately warned. Notwithstanding the pleading of the ONI naval officer who decoded the message, Admiral Stark and General Marshall refused to give the order that a warning be transmitted to the commanders at Pearl Harbor. Why? Because Roosevelt did not want to take the risk that the Japanese might intercept the signal and then cancel the attack, knowing that the key element of surprise was lost.

Roosevelt had another agenda. He desperately needed "a cleverly sprung trick" to overcome the strong opposition of 87 percent of the American people, who up to the December 7, 1941 the day of the Japanese attack on Pearl Harbor, were adamantly opposed to war with Germany, even if it meant that Hitler defeated Great Britain and USSR!

Did the American people have any knowledge of these events? We answer, "No, they did not have any indication of what was going on. They were deliberately kept in ignorance because thwarted by the American people who were solidly desire to be involved in a war against Japan. It is worth repeating, they opposed "trust me" Roosevelt by a margin of 87 percent. It was a repeat of the solid opposition to Wilson's attempts to get the United States "in on the side of the Allies", to quote the sinister and treacherous Mr. House.

All that changed after December 7th. On December 8th, 1941 a joint session of the House and Senate gave Roosevelt the declaration of war they had refused so many times before to give him, and conferred upon him the title of commander in chief of the armed forces of the United States. To his credit, at least Roosevelt recognized that he needed a constitutional declaration of war and did not go off to war on his own volition. He knew, although it galled him, that he was not the commander in chief until such times as war was declared and the Congress called him into service and conferred the title upon him.

Would that the current crop of politicians get this fact implanted in their numskulls; that they are obliged to obey this vital provision of our Constitution, instead of trampling it underfoot in their unseemly scramble for causes alien to the welfare of America. Whereas the American people had been resolutely opposed to war right up to December 7th, they now gave Roosevelt their wholehearted support. It appeared that "enlightened terrorism" had been a great success.

One of the stratagems used by Roosevelt was the uttering and publishing of false information in the hope that it would stampede the American people into giving him the unconstitutional power he had so avidly sought. Perhaps of the most infamous was a map purporting to be a genuine Abwher (German intelligence) document showing how Hitler was planning to invade South

"I have in my possession a secret map made in Germany by Hitler's Government. It is a map of South America and Central America as Hitler proposes to organize it. After America was in the war, Roosevelt told Roosevelt wanted war and not peace. (For further details see Pearl Harbor Revisited by Dr. John Coleman.) The Canadian authorities undoubtedly knew about these things but did nothing to expose the criminals in their midst.

MISSION IMPOSSIBLE? HOW COULD THEY ...?

We mention this because we have noticed that since September 11, there has been a steady stream of "reports", "warnings" and "information" coming from Canada, all purporting to be this, that or the other "evidence" about terrorist activities and possible future terrorists activities, and nearly always couched in the vaguest of terms. We urge our readers to be skeptical of all such information originating from Canada, lest we might be seriously hoodwinked once again as we were when Roosevelt held aloft his "made in Germany"

forged map. Our question to those in Canada issuing these "reports" is this: "How is it possible that you are now able to give America these "warnings" when you were unable to provide even the smallest vestige of information prior to Sept. 11th?"

The latest "alarm" and "excursion", on the strength of which a new "high alert" with new draconian measures was imposed, came in a television announcement by Attorney General Ashcroft who said the warning came from Canada. We thought it vaguely worded, unless the version delivered by Ashcroft was not the full message allegedly intercepted by Canadian authorities, and if it is not, why are we not entitled to a full and proper account of the alleged "message"?

It has taken almost sixty years of relentless digging to come up with what really happened in the years of "rule by secrecy" before Pearl Harbor, and even now, we still don't know the full extent of Roosevelt's treasonous conduct. As always happens when governments make secret deals they wish to conceal from their people, no mention of what they are doing appears in the press. Those who imagine that the United States and Britain have open governments should think again. The tens of thousands of secret deals made by these two governments (always for the good of the people, we suppose!) have yet to be recounted, and if ever even a small percentage should be chronicled, decent men everywhere would be deeply disturbed.

The seeds of a permanent state of war in Palestine were sown by one such secret deal, known as the Balfour Declaration which we mentioned earlier. Did the American people know anything about this secret deal that was to bring America into the First World War? Of course not! While they were going about their daily business, little did they know that there were people trying to circumvent the Constitution, working around the clock to destroy the peace and equanimity and enjoyment of the life they had?

They had no inkling of the plots being hatched, the secret deals, and the treacherous betrayals that would soon snatch their sons away from home and family to pull the British Empire back from the very brink of resounding defeat. Where in the Constitution is it written that President Wilson or any other U.S. President is authorized to make secret deals? There is a distinct probability that even now, eighty-six years later, more than 85 percent of the American people still do not know what those secret deals comprised, or how or why America was dragged into WW I and WW II for no valid reasons and against its national interests.

Then the agreement was extended after the death so that in the end it turned out that all the "trespass" cattle would be removed by December 14, 2001. Now that was a long time and no problem except that lawyers couldn't seem to quite agree on anything nor would they file a timely complaint to get things moving.

> NOW, here on December 11, 2001 those cows have to be OFF BLM property (seized in the first place) or very heavy FINES would be put against the ranch company for "trespass".

> According to a BLM spokesman, in 1994 the federal agency made changes to how cattlemen could graze their herds on public lands in parts of Nevada because of drought and stress caused by OTHER WILDLIFE.

> However, ranchers and citizens' rights advocates argue that federal bureaucrats are mismanaging the land by allowing a population explosion among protected wild horses and burros to devastate areas in Nevada.

> When the ranchers tried to dispute the BLM's claim, their herds were seized to cover fines levied by the BLM.

> Other cattle seized by the BLM at the time Colvin's herd was removed, however, had to be released to a third party who held ownership in the name of a security interest.

Will that change the status of the Corporation auctioned them off at a discounted price on Nov. 13.

In addition, Colvin says federal bureaucrats gathered his cattle without a court order or due process.

They acted "before due process of law can own land," Colvin said.

It has pretty good occupancy in spite of the bad times, and rates are not particularly good or better—but the others in the hotel "chain" are in such bad shape that just to hold on the owner has to transfer funds to the other four establishments around Manila. In fact, the rates are high in my estimation but we are able to have office space, a kitchen and other space available as in an apartment. And combining the costs of all of the needs we feel pretty good about the arrangements. At least the thought of moving is overwhelming at this point. So, if this hotel is keeping the others alive in the chain, let us pray for this one enduring for a while longer because we finally were able to get a phone and fax for the office.

We have office "expenses" for copy work having to be done across the street commercially and some done here by the hotel but at a higher cost in addition to tip-cost, etc.

We are continually grateful to Teri York who somehow turned up this place before we got here in 1998. We have moved three times to larger rooms to facilitate the office space which we have to have to function at all.

We are tired and "wanna go home" but, after all, even that is not a pull since we HAVE NO HOME BACK HOME. BUT, think of it this way; our "house" (here) is fully decorated with outside decorations and lights, we have a 15-foot Christmas tree beautifully decorated in our lobby "living room" and in the dining room (coffee shop) and our entryway downstairs has trees, wreaths, lights and smiling faces. Meanwhile on every Friday, Sat. and Sun. evening there are ten minutes of glorious fireworks right outside our windows. And yes indeed, I would give it all up to simply get to hold one grandbaby for 5 seconds. Or know that my Ringo, Billy, Tilly, etc. still remember me.

If we get weary of our own space, we can walk over to the Penn Hotel where they have a 40-foot tree in the lobby. We note, however, that there are not nearly as many buildings, hotels or other things decorated this year. FORD SEEKS TO BURY ISSUE OF NAZI LABOR

DEARBORN, Mich.—Ford Motor Co., whose founder was admired by Adolf Hitler and notorious for his anti-Semitic views, sought Thursday to lay to rest long-standing claims that it profited from the Nazi war machine and use of forced labor in Germany during World War II.

Ford has long denied allegations that it maintained contact and control over its Ford-Werke subsidiary in Cologne, Germany, during the war and that it knowingly profited from forced and slave labor there.

"The statement that Ford profited from the activities of Ford Germany during World War II is just not true," Ford Chief of Staff John Rintamaki said Thursday as the company issued a report on what Rintamaki called "a time that many of us would like to forget".

An innovator of mass production and the assembly line, Henry Ford was also the author of a pamphlet titled "The International Jew: The World's Foremost Problem" and other anti-Jewish writings that drew Hitler's admiration in the 1920s.

The Ford report supports the company's earlier claims that it lost effective control over the Ford-Werke plant under the Nazis and cannot be held responsible for the plant's operations during the war.

"We didn't learn any new information that changes our view of history," Rintamaki said.

The Ford-Werke plant was never formally confiscated by the German government, and Rintamaki acknowledged that Ford held a controlling stake in it throughout the war. He also said the plant employed about 2,000 forced and slave laborers, or about 45 percent of its total workforce, during the war.

"Ford-Werke's linkages with the Dearborn headquarters became increasingly attenuated during the course of the decade of the 1930s," Simon Reich, an expert on Germany's wartime auto industry, wrote in a prologue to Ford's report, on which he was commissioned to work.

Once at home, I set about investigating a bit, and the more I investigated the more I found to substantiate what the Jews had told me. I determined that the situation should be made clear to the people of the United States through publicity. But do you think I could get a newspaper to print it? Not on your life. It seemed that there was no newspaper in the United States that dared print the truth.

THE WAR IN AFGHANISTAN IS A MEANS TO ANOTHER END

It is becoming more apparent that the war in Afghanistan has nothing to do with terrorism, Osama bin Laden, the Taliban or the World Trade Centre.

Realpolitik, the need and greed for oil and gas are, once again, the source of misery and tragedy. This time it is happening in central Asia, just as it was in Iraq.

John K. Cooley reveals the intentions of the United States and multinational oil companies to establish pipelines to route the oil and natural gas of Central Asia and the Caspian Basin to the West.

To this end the aims of the generals of the Pakistani ISI (Inter-Services Intelligence) and their American counterparts, the CIA, converged. They saw in the Taliban the means by which they could achieve their objectives.

In 1993 Pakistan and Turkmenistan signed an agreement to jointly develop their energy resources and build a pipeline between the two countries. A company called Unocal, based in California, signed a protocol with the Turkmen government to explore the feasibility of building this pipeline.

The one-year study cost \$10-million for a huge energy project worth \$18-billion, to transport Turkmen oil and gas by pipeline to the Indian Ocean. This trade and energy would run through Pakistan, America's ally, rather than through Iran, her adversary ever since the overthrow of the Shah in 1979. This will also bypass Iranian ambitions to channel Turkmen energy.

A further objective of both the Taliban and Pakistan is the recovery of natural gas from northern Afghanistan's Shibergan province, pumped northward to Russia through Uzbekistan. Afghan estimates of the resources in the Shibergan gas fields run from 1 to 100billion cubic meters. Export of the gas continued throughout the war between 1979 and 1989, despite periodic sabotage orchestrated by the CIA and ISI.

Corroborating Cooley's findings, a book has just been published in Paris entitled Bin Laden, La Verite Interdite (Bin Laden, the Forbidden Truth). The book claims that the Bush administration held extensive talks with the Taliban regime from February to August this year with the aim of securing control over the vast oil and gas reserves in Central Asia through the construction of an oil pipeline from the rich oil fields in Turkmenistan, Uzbekistan and Kazakhstan, to Afghanistan, Pakistan and on to the Indian Ocean.

The authors, Jean Charles Brisard and Guiliaume Dasquie—who have long experience in intelligence analysis—claim that if the Taliban had facilitated the construction of the pipeline and U.S. control over Central Asian oil and gas reserves, the U.S. would have paved the way for economic assistance to, and political recognition of, the Taliban.

The Taliban's unwillingness to accept U.S. conditions frustrated the Americans. According to the author: "At one moment during the negotiations the U.S. representatives told the Taliban 'either you accept our offer of a carpet of gold, or we bury you under a carpet of bombs'.'

> Not surprisingly U.S. Secretary of State Colin Powell is now referring to the "moderate" Taliban, who will join a U.S.-sponsored "loose federation" to run Afghanistan. The "war on terrorism" is a cover for this. It is a means of achieving strategic aims that lie behind the flag-waving facade.

> If the allegations and arguments contained in Unholy Wars and Bin Laden, The Forbidden Truth are true, it raises some fundamental questions about the U.S. bombing of Afghanistan, and indeed, about the September 11 tragedy itself. Is oil the ulterior motive, the hidden agenda, behind the assault upon Afghanistan? Is the attack a vile attempt to gain control of the country and establish a pliant regime in Kabul, which will enable Washington to extend its tentacles over Central Asia and its oil wealth?

> The world has the right to know the truth—for the sake of the innocent people who are being slaughtered in Afghanistan, and for the sake of the thousands who were killed in New York and Washington on September 11.

RUSSIAN AIRLIFT TO AFGHANISTAN HIGHLIGHTS <u>UNDERLYING U.S.-EUROPE TENSIONS</u>

The sudden arrival of 12 Russian military cargo aircraft at Bagram airfield just north of Kabul last week has underscored the intense behind-the-scenes rivalry now underway between the U.S. and other major powers for a stake in Afghanistan. Having supported Washington's military intervention, each is now seeking, under the guise of humanitarian concern, to establish a presence inside the country to further its interests in resource-rich Central Asia.

According to Russian President Vladimir Putin, the purpose of the airlift was to provide relief aid, including a field hospital, and to rebuild the Russian embassy in Kabul. The huge Ilyushin-76 aircraft, each capable of transporting 40 tonnes of equipment and supplies, landed at Bagram on November 26 and unloaded construction equipment and materials, Health Ministry officials and uniformed relief workers from the Emergencies Ministry.

While Russian officials denied any soldiers were involved, the Emergencies Ministry is a paramilitary body with its own military wing of 70,000 troops. It was formed as a split-off from the Defence Ministry after the collapse of the Soviet Union in 1991. The landing operation is reported to have taken five hours. A fleet of trailer trucks, supported by fuel tankers and other vehicles, ferried the cargo and personnel into Kabul.

Putin has played down the operation simply saying that it was the first "in the past few years". But no one missed the political significance. Russian officials were back in Kabul for the first time since the Soviet military pulled out in 1989 after a decade of brutal war against various Mujaheddin groups backed and financed by the U.S.

Putin noted pointedly that Russia's actions had been carried out "on the request and with the assistance of the Islamic State of Afghanistan"—a reference to the Northern Alliance that now controls Kabul. By mounting the operation on the eve of talks in Bonn over the political future of Afghanistan, Moscow signalled Russian support for the Northern Alliance and its leader Burhanuddin Rabbani, who is still recognised by the UN as the Afghan head of state.

While Russia stopped short of officially recognising the Northern Alliance as the Afghan government, the move threatens to cut across Washington's demand for a "broad-based" administration. The U.S. is insisting that others, including the former king Zahir Shah and various ethnic Pashtun tribal leaders, be part of any new regime alongside the Northern Alliance. Russia, Iran and India have been supporting the Northern Alliance against the Pakistani-backed Taliban since the mid-1990s.

U.S. officials reported that Secretary of State Colin Powell had telephoned Russian Foreign Minister Igor Ivanov after the Russian airlift to warn Moscow against any abrupt diplomatic or military moves that might undermine trust between the U.S. and Russia. Powell urged Moscow to avoid promoting Rabbani as the official leader of Afghanistan. Both Washington and Moscow have attempted to minimise the differences.

Putin gave his backing to the Bush administration's "global war on terrorism", including the go-ahead for the stationing of U.S. military in the Central Asia, as a means of securing Russian interests on other issues, including in Chechnya where Washington had previously criticised

Moscow's war against Islamic militants. But support for terms on which other countries would deploy troops. the U.S.-led war has provoked opposition in ruling circles, particularly among the military top brass, who this time. You take them up on their offers at the have warned of the dangers to Russia of the U.S. intervention in the strategic Central Asian region. The airlift is at least in part Putin's answer to his critics.

A U.S. official quoted in the Washington Post noted that last week's airlift was to demonstrate that Moscow wanted "to play some sort of role in post-Taliban Afghanistan". Then, in a remark that is more revealing about Washington's plans, he added: "The Russian are smart enough to know that the important thing is not what happens in Bonn, but what happens on the ground."

The comment bluntly sums up the Bush administration's strategy: to control the military campaign and monopolise the deployment of troops in order to dictate the terms of any political settlement. Washington's refusal to allow other countries to send soldiers in substantial numbers to Afghanistan is already leading to frictions with its European allies, particularly Britain.

Two weeks ago, British Prime Minister Tony Blair announced that up to 6,000 troops would be dispatched to Afghanistan, ostensibly to assist in providing humanitarian aid. Around 100 British commandos landed at Bagram airfield to secure a bridgehead but immediately ran into opposition from the Northern Alliance, which insisted that foreign troops were not necessary.

It became clear from subsequent statements that it was not simply the Northern Alliance but the Bush administration which was opposed to any large-scale deployment of foreign troops—other than from the U.S. While Blair insisted that there was still "complete agreement" with Washington, his Secretary of State for International Development, Clare Short, publicly attacked the U.S. for neglecting Afghanistan's humanitarian needs. Blair was subsequently forced to reverse his decision and stand down the troops.

The Guardian was quick to point out that while Russian officials were welcomed in Kabul, the Northern Alliance, with the support of the U.S., had shown "the cold shoulder to the 100 British soldiers shivering at Bagram airbase". Reflecting concerns in the political establishment that Britain was gaining little from the war, the newspaper complained: "Blair's aid-and-rebuilding agenda elicits only tepid American backing, suggesting that his instant and full-throated support for Bush has not quite won the clout he hoped for."

France faces a similar situation. Its first detachment of about 60 troops left the Istres airbase for Mazar-e-Sharif in northern Afghanistan in mid-November. They landed in Uzbekistan, where they have been cooling their heels for two weeks, waiting for transport by U.S. helicopter. The group was the advance guard for up to 2,000 French troops being sent to create "favourable conditions" for humanitarian relief. The first French unit was finally airlifted into Mazar-e-Sharif last weekend.

Last Friday, White House spokesman Ari Fleischer made clear that the Bush administration considered the sending of an international "peacekeeping" force as premature. He described the conditions in Afghanistan as "difficult and dangerous" and implied that other foreign troops would only get in the way of U.S. operations. The president "looks forward to the day" that "peacekeepers will be able to arrive," he blandly concluded.

ASHCROFT DEFENDS ANTI-TERROR EFFORT HE ACCUSES CRITICS OF SPREADING FEAR

WASHINGTON—In his first appearance before Congress to defend the Bush administration's antiterrorism tactics, Atty. Gen. John Ashcroft lashed out Thursday at his harsher critics, accusing them of spreading fear, dividing the country and helping the enemy.

"We need honest, reasoned debate, not fearmongering," Ashcroft said during a four-hour hearing of the Senate Judiciary Committee. "To those who would pit Americans against immigrants and citizens against non-citizens, to those who scare peace-loving people with phantoms of lost liberty, my message is this: Your tactics only aid terrorists, for they erode our national unity and diminish our resolve."

Democrats did not hesitate to hit back, criticizing an array of administration actions. Sen. John Edwards (D-N.C.) noted that President Bush's proposed military tribunals could in theory sentence someone to death by Craig Quigley confirmed that the U.S. would dictate the a mere 2-1 vote. Sen. Russell Feingold (D-Wis.) asked

Ashcroft to guarantee that everyone now in custody in connection with the terror investigation would get a lawyer, and Ashcroft said he could not.

AFGHAN FARMERS RESUME GROWING VALUABLE CASH CROP

JALALABAD, Afghanistan—Poppy seedlings were peeking up through the earth of Ali Khan's three acres of land in eastern Afghanistan this week. He planted them the day after the Taliban surrendered Jalalabad and the surrounding territory to opposition forces, and now he's awaiting a bountiful crop that he hopes can improve his family's meager circumstances.

AND WHY NOT-the yield from his three acres of opium poppy—sold to one of the "businessmen" who inevitably show up at harvest time—will feed his extended family of 16 for one year.

Khan expects his take to be around \$3,500, an astounding figure in a country where the annual per capita income is about \$300.

The farmer was proud of his crop, showing how he has diverted precious irrigation water from his eggplants and wheat to nourish his poppies, the key ingredient in heroin.

Until the Taliban ordered a halt to opium production in July 2000, Afghanistan produced 3,900 tons a year—75 percent of the world's crop.

According to the United States, poppy was cultivated at the expense of wheat and other food crops desperately needed by the people of Afghanistan.

After the Taliban crackdown, only about 10 percent of the growers defied the prohibition ordered by the hard-line Taliban regime.

But there was still plenty of money to be made from the crop for the Taliban and its principal money launderer, Osama bin Laden, the prime suspect in the Sept. 11 terrorist attacks on the United States. Tons of the drug's raw material had been warehoused and was shipped to the thriving consumer markets in Pakistan, Europe and beyond.

A new supply stream is now likely. Farmers have wasted no time returning to the crop since the Taliban was driven from most of the country by opposition forces backed by U.S. military might.

In one village, farmers have already procured a new supply of seed. One 6-year-old boy proudly carried 3 kilos of seed in a battered pan while men turned the ground with ox-drawn tiller boards.

Others danced barefoot across the softened earth as they drew the seed from a pouch created from their upturned robes and fanned it over the ground with a practiced motion.

"If [new government officials] tell us not to grow poppy, they must know it's their responsibility to pay us to grow other crops," said one village elder. "I would rather grow tomatoes and carrots.

"I know what heroin is and what it does to people, but I have to take care of my family."

EU CONSIDERS PLANS TO OUTLAW RACISM

RACISM and xenophobia would become serious crimes in Britain for the first time, carrying a prison sentence of two years or more, under new proposals put forward by Brussels yesterday.

Holocaust denial or "trivialisation" of Nazi atrocities would be banned, along with participation in any group that promotes race hate.

The plans, drafted by the European Commission, define racism and xenophobia as aversion to individuals based on "race, colour, descent, religion formerly the weak successor to the defunct Soviet or belief, national or ethnic origin".

Ordinary crimes would carry heavier penalities if they are motivated in any way by racism or xenophobia, or if the culprit is carrying out "professional activity", such as a police officer. Some of the crimes listed are, broadly speaking, offences under British law already, such as public incitement to violence.

But the list also a covers a wide range of activities that sometimes fall into the sphere of protected political speech, such as "public insults" of minority groups, "public condoning of war crimes", and "public dissemination of tracts, pictures, or other material containing expressions of racism of xenophobia"—including material posted on far-Right Internet Websites.

It was not clear yesterday how the law would affect radical Islamic groups that openly promote anti-Semitic and anti-Christian views.

Nor was it clear how it would apply to political parties opposed to mass immigration, such as Austria's Freedom Party, Belgium's Vlaams Blok, and the Danish People's Party, all of which have become serious political forces.

The law could potentially cover many standup comedians, and even Anne Robinson, who, during an appearance on BBC television this year, described the Welsh as "irritating".

The proposals, which will require the unanimous backing of all 15 states, are aimed at ending the patchwork of different laws across the European Union and establishing a common definition that can be used by all judges. The Commonwealth of Independent States, or CIS— Union—is beginning to assert itself as "an authoritative international organization and an important factor in global stability," according to official Russian sources.

All republics of the former Soviet Union—except for the Baltic States of Latvia, Lithuania and Estonia—are members of the CIS, with Russia as the dominant partner.

The CIS's declaration of power in world affairs follows a newfound unity among the organization's leaders.

"Today we all realize we just can't live apart from each other, neither economically, nor politically and socially," Ukrainian President Leonid Kuchma proclaimed.

The statements were reported by the Voice of Russia World Service, the official broadcasting service of the Russian government.

The CIS has already affected the lives of American citizens directly. With Moscow's permission, CIS member states in Central Asia, including Tajikistan and Uzbekistan, are providing logistical assistance to U.S. troops operating in Afghanistan.

ZIMBABWE COURT OKS MUGABE'S LAND GRAB NEW APPOINTEES ENDORSE SEIZURE OF WHITE-OWNED FARMS

HARARE, Zimbabwe (AP)—Zimbabwe's top court ruled the government's plan to seize White-owned farms is legal, overturning its own previous decision that the seizures were unconstitutional.

Supreme Court justices appointed to hear the new seizure case said they were satisfied the government's "fast track" land nationalization program was lawful and "sufficiently complied" with the constitution.

Last year's Supreme Court ruling declared the government's methods of land seizures illegal and in breach of constitutional ownership rights and government land laws.

Some of the judges who made that ruling have been replaced in recent months.

including Chief Justice Godfrey Chidyausiku, were appointed recently by President Robert Mugabe. All four voted to uphold Mugabe's land seizure program.

The Supreme Court traditionally had only five judges until Mugabe expanded the bench to eight in July, adding three judges considered loyal to the ruling party. The chief justice usually appoints small panels of judges to hear each case.

The opposition Movement for Democratic Change has described the court's expansion as a political ploy designed to turn the court into a Mugabe regime puppet.

Armed ruling-party militants have occupied more than 1,700 White-owned farms since March 2000, demanding they be redistributed to landless Blacks. The government has listed some 4,500 propertiesabout 95 percent of farm land owned by Whites—for nationalization without compensation and last month warned about 800 farmers they had three months to vacate their land and homes.

The U.S.-government-released Osama bin Laden videotape was dismissed as unconvincing propaganda in many parts of the Arab world, with some blasting it as a complete fabrication.

Viewers throughout the Mideast were able to see the videotape on both Al-Jazeera and CNN. And while state-run Arab networks didn't air the video, commentators angrily denounced it and questioned its authenticity.

Part of the problem was the poor sound quality of the footage and the reliance on U.S. translations, Arab commentators said.

Egyptian stockbroker Sherif Abdelkhalek questioned whether bin Laden actually appeared.

"I don't know if it's bin Laden or not," he said. "This is not evidence for [the] U.S. to say bin Laden did this. The tape was not clear... the voice of all the sentences bin Laden said did not sound the same."

Abdul Latif Arabiat, head of Jordan's Islamic Action Front—considered a "mainstream" party called the footage "shameful".

"Do Americans really think the world is that stupid to think that they would believe that this tape is evidence?" he asked.

"Of course, it is fabricated," said Dia'a Rashwan, a Cairo-based expert on Islamic movements.

"If this is the kind of evidence that America has, then the blood of thousands who died and were injured in Afghanistan is on [President] Bush's head."

In Bahrain, a viewer who accepted the video as real shrugged off its significance, claiming, "It only adds that bin Laden was aware of the incident but not necessarily that he had planned it."

SCIENCE CAN'T YET EXPLAIN **NEAR-DEATH EXPERIENCES**

NEW YORK (Reuters Health)—While no one "near-death" experiences may not be explainable 3. I compared his head size next to the flag. by science alone, according to researchers.

Their study of 62 patients who said they had a near-death experience after going into cardiac arrest found that factors such as medication and the duration of unconsciousness did not explain the phenomenon.

"Our results show that medical factors cannot account for occurrence of near-death experiences," Dr. Pim van Lommel and colleagues from the Netherlands report in the December 15th issue of Lancet.

A small number of people who survive lifethreatening circumstances like cardiac arrest report having had "an extraordinary experience", note van Lommel, of Hospital Rijnstate in Arnhem, and his colleagues. These so-called near-death experiences often involve visions of a light or a deceased relative, flashbacks of life events or an "out-of-body" sensation.

Researchers have come up with a number of explanations for these experiences. Some believe that brain cells dying from a lack of oxygen help trigger the episodes, while others point to psychological factors such as fear of death, or to the changing state of consciousness people may go through in a life-threatening condition.

In the initial interviews, 62 of 344 survivors (18%) 5. This was a clear message from the reported near-death experiences. All 344 had been clinically dead, meaning they were unconscious due to a lack of blood and oxygen to the brain.

> The patients' near-death experiences varied, with 41 having a deeper, or "core", experience. The rest reported more "superficial" events, van Lommel's team notes. Two years later, 6 of these individuals were deemed to not have had a near-death experience.

> But those patients who did have one were able to recall the experience "almost exactly" 8 years later, the researchers found. And in contrast with cardiac-arrest survivors who did not have such an experience, these patients showed less fear of death and a stronger belief in an after-life.

> What the researchers could not find was any clear explanation for why a small percentage of patients had a near-death experience while most did not. If "purely physiological factors" like a cutoff of oxygen to the brain were at play, they note, most of the study patients should have had such an experience.

> "We did not show that psychological, neurophysiological, or physiological factors caused these experiences after cardiac arrest," the researchers write.

> But these findings are hard to interpret, according to an editorial published with the report. For one, writes Dr. Christopher C. French of the University of London, UK, "it seems that at least some near-death experiences may be the result of false memories."

> In addition, he points out, it is unclear when—during what state of consciousness—the patients had their experiences.

French calls for more research to overcome is sure exactly what they are or why they occur, the limitations of most studies into near-death experiences, while calling the current one a "major advance" over past studies.

SECRET NAVAL WAR OF THE SOUTHERN HEMISPHERE

As we move along and to make things clear, we shall discuss the referred-to "PROJECT Z" I mentioned in the previous chapter. It is the new Bolshevik threephase strategy for NUCLEAR WAR ONE. However, since it didn't come off on schedule, I feel we will not be misleading if we stick with references to the area of the Antarctic. The most skeletons to arise from the dead to "getcha" are all parading around "under" and "within" the Southern Hemisphere and that, after all, was the subject of this Journal. I do have trouble keeping to one subject for all facets are so intertwined.

The plan in 1982 was that of an elite group of American Bolshevik military planners by which the U.S. would strike the first nuclear blow, followed by all-out thermonuclear war with Russia.

After having set off the holocaust, the Bolsheviks in the U.S. and in certain other countries planned to ride it out safely in comfortable war bunkers already in place and well stocked with luxuries. Finally, after NUCLEAR WAR ONE fizzled out in stalemate, they planned to leave behind the ashes of the U.S. and her allies. Activating Phase #3 of their grand strategy, they planned to unveil their secret weapons, especially their secret naval fleets. With these they planned to conquer and rule what would be left of the world. The United States as you know it would be long dead and gone; but in the eyes of the Bolsheviks themselves, this outcome would constitute victory for many reasons.

Up to April of 1982 the nuclear war timetable was still on track. They were still shooting for nuclear war to begin by September of that year. Actually this continued right to the date set of September 17, 1982.

What saved you is that the Bolsheviks were running as fast as they could toward war; but, the Bolsheviks are not the only runners in the race. They have two deadly enemies, both of whom are equally determined to trip up the Bolsheviks. One enemy of the Bolsheviks in the U.S. is the Rockefeller cartel; the other enemy is the new anti-Bolsheviks ruling class in Russia: And now these two mutual enemies of the Bolsheviks are pooling their efforts in certain ways.

The new anti-Bolshevik coalition is now much more firmly established—but in 1982 it was still quite new and was working between the Rockefeller cartel and the Russians. The January 26, 1982 meeting between Haig and Gromyko in Geneva, Switzerland, was a turning point in the formation of this coalition. It is now a reality, and is responsible for the so-called "Falkland crisis" which dominated the headlines in April and May of that year. It should be emphasized that the new relationship between the Rockefeller cartel and Russia fell far short of a true alliance, at least at that time. They have very major disputes to be settled between them, but they called a truce between themselves to deal with the mutual deadly enemy—the Bolsheviks in America.

The first priority of the Russians and the Rockefellers is to slow down the Bolshevik preparations for imminent nuclear war. If they could do that, time would be on the side of the Rockefeller cartel in certain political movements. A slow-down in the nuclear war timetable will also give more breathing space for additional anti-Bolshevik actions to be implemented.

The joint Rockefeller-Russian planners decided by mid-February of 1982 that military action against the Bolsheviks was essential very quickly. No other type of action had any hope of taking effect fast enough to prevent nuclear war by the end of the summer.

were not known to either the Rockefellers or the Russians, but the general outlines were known to be pretty well outlined and set up.

It was decided that military action should be devised that would undermine Phase #3 of the Bolshevik war plan—that is, the Bolshevik-controlled secret naval installations and fleets in the Southern Hemisphere should be attacked and crippled. By working together, the Rockefeller cartel and the Russians were able to devise an attack plan which neither could have carried out alone. The Rockefeller group, who built and originally controlled these bases, provided detailed intelligence about the best way to attack them. The Russians with their enormous military machine provided the muscle to actually carry out the attack.

It was essential to devise a scheme that would enable both secret fleets in the South Atlantic and South Pacific to be attacked. Survival intact of either fleet would leave the Bolshevik war plan still workable.

Military analysts concluded very quickly that a direct assault on the New Zealand facilities was out of the question. There was no combination of commandos, frogmen, or other military force which could possibly keep an attack secret from the outside world. Any attack on the New Zealand bases would set off the very war which the of pay-off in the joint Rockefeller-Russian attack plan. Rockefellers and Russians wanted to prevent.

But the situation in the South Atlantic was a different matter. In a way, the greatest asset of South Georgia Island was also its Achilles' heel. The extreme isolation which protected the secrecy of the South Georgia base also made a covert military assault feasible. The key lay with Argentina and her long-standing claims to the Falkland Islands.

THE FALKLAND ISLAND WAR

The Rockefeller cartel had dominated all of Latin America for decades. Cartel operatives were sent to Argentina to work out a deal with the government military junta there. The historic dispute over the Falkland Islands was to be used to provide a ruse, a military cover, to enable the South Georgia base to be attacked. The Argentine generals were not told everything about the situation by any means, but they were told enough to make clear what they were to do.

As an inducement to cooperate, the Argentine leaders were promised handsome rewards. They were guaranteed that after the shooting was over, the Falkland Islands would remain in Argentine hands. This guarantee included the promise of covert military assistance as needed against the Royal Navy. And, to bolster the troubled Argentine economy, it was promised that the Rockefeller cartel would help develop the immense offshore oil reserves. With those combined promises of military glory and financial rewards, the Argentine military junta agreed to the plan.

So, backing up to March 19th, Argentina carried out Act One in the joint attack plan. A group of Argentine scrap-metal merchants, of all things, landed at the abandoned old whaling station on South Georgia Island. Supposedly they were there to dismantle the old buildings and carry them off to sell. While they were at it they also raised the Argentine flag over the work-site. The British, always nervous about South Georgia Island, promptly reacted exactly as expected. The British Antarctic survey ship Endurance put 22 Marines ashore to clear up that little misunderstanding.

They drove off the scrap merchants and promptly The exact details of the "PROJECT Z" war plan tore down the Argentine flag. The incident provided the exact desired excuse for the Argentine Junta to bring the simmering 150-year-old Falklands dispute to a boil. From time to time in the past, Argentina claimed that South Georgia was part of the Falklands because it is administered that way by Britain. That argument was very flimsy but it then came in most handy indeed. It was nothing new to hear that claim from Argentine leaders, so there was no hint of what was really afoot.

> During late March, Argentine military forces started assembling for an assault on the Falklands. The British command thought there was nothing new, for Argentina had carried out threatening maneuvers in the past many times. It was believed that they were about to do it again; but on April 2 Argentine forces did the unexpected. After many past false alarms, this time they actually invaded and seized the Islands. All Argentine public statements emphasized the long-standing historical claims to the Falklands themselves; but just for good measure, the next day a small Argentine force also seized far-off South Georgia Island. The force was so small that it gave the appearance initially that it was just a side show from Argentina's point of view; however, the small contingent of 22 Royal Marines were overpowered and bundled off the Island along with a group of 13 alleged scientists. That was a moment

"SPUDDING IN"

Thanks to the elaborate distraction staged by the Argentine forces, a special commando team got onto the Island totally undetected. Based on the detailed Rockefeller information about the base, the team moved to the location on the mountain directly above the

cavernous secret base. Special high-speed drilling equipment was set up by the Rockefeller members of the team while the Russian members concentrated on military defense. By late that same evening, April 3, the military high command in London finally learned what was really taking place. The secret South Georgia base was under attack by virtually the only means possible. The joint Rockefeller-Russian team were drilling a shaft down through the mountain toward their hollowed-out cavern inside. It was only a matter of time until their drill would break through the ceiling of the giant hidden naval base. Once the hole was made, the next step was obvious. The Rockefeller-Russian team would put a weapon of some kind through the hole. The best guess was that it would be probably nerve gas—it just doesn't pay to "guess".

The shock waves that went through the highest levels of British government on the evening of April 3 can hardly be described. The Thatcher government, like the so-called Reagan Administration in America, is Bolshevik controlled. Well, the Russians told you they would rule the world and it might very well be done without firing a shot!

That was why Margaret Thatcher always said, "Me, too." any time the Reagan Administration said it would do anything to Russia. Please note that it hasn't changed very much. What of the Stinger missile "sting" in Florida and the "I agree and support the U.S." in Panama this past December? Both governments are party to the secret nuclear war plan in complete betrayal of the people of their respective countries, and on the evening of April 3 they suddenly discovered that their precious war plan was in deep, deep yogurt, I believe you call it—amongst other terms.

Immediately the Thatcher government started assembling a naval armada to sail for the South Atlantic. Haste was their order of the day. The drilling on South Georgia Island was proceeding around the clock. The best estimates were that the drilling would break through into the roof of the of the naval base in about three weeks, on or about April 24—but it is a very long drive from England to Antarctica on the best of ships. If help did not reach South Georgia by then, the secret installation might be doomed. The forces stationed at the installation itself were unable to defend themselves under the circumstances. Their mighty naval ships were ships in a bottle. They did not dare open the bottle to sail out and fight because the Russian commandos were armed with far superior technical and nuclear weapons. (Who do you think might be the closest allies to the Nazi undercover workers?) We are talking about ones who do not care greatly for the Jewish element, much less the Zionist-affiliated Jews. To open the blast-proof entrance doors would be suicide.

On April 5, just two days after South Georgia Island was seized, some 40 naval ships began moving out of British ports. The same day Lord Carrington was sacked as Foreign Minister. He was forced to resign because he had assisted the Rockefeller attack plan by downplaying the Argentine attack preparations. Even the evil don't have any way to count on their own.

That same day, April 5, New Zealand, the home of the other secret naval fleet, broke diplomatic relations with Argentina. The two hidden New Zealand facilities had been placed on "Red Alert" (no pun intended). As a precautionary measure, all submarines at the twin base were ordered to sea. Several surface ships were already at sea undergoing "sea trials", but that still

On that busy day of April 5, Argentina's Foreign Minister, Costa Mendez, was at the United Nations in New York. Come on, readers, go look it all up in the records—don't just stand off and accuse me of insanity—go look and find for yourselves.

Mendez was alarmed by the deployment of such a large part of the Royal Navy. Costa Mendez hurried to Washington to seek reassurances from certain U.S. officials. Of course he got them!

For the next two weeks or so the news was filled with stories about the allegedly slow movement of the British fleet, while negotiations went on. That was only a cover story. The Royal Navy was actually joining up and paddling as rapidly as possible toward South Georgia Island. If the task force arrived in time to save the secret base, a major battle was likely. The official stories about "slow movement" of the British armada were intended to give a cushion of time for that battle. If need be, the fleet would have several days to retake South Georgia Island, then it could move on to arrive near the Falklands on the announced schedule. In that way the crucial importance of South Georgia Island would be hidden and the big secret preserved.

It was initially expected that advance elements of the British fleet would reach the vicinity of South Georgia Island within two weeks. That would have been soon enough to attack the joint Rockefeller-Russian commando team and stop the drilling before it was completed. But Russian Cosmospheres and submarines made a shambles of the plan.

A KEY SHIP DESTROYED

Key advance elements of the South Georgia attack contingency left Ascension Island early April 14, two days before it was announced officially. Shortly after they did so, they ran into trouble. Russian Cosmospheres and attack submarines closed in on a single ship which was critical to the planned counterassault on South Georgia Island. The Cosmospheres bombarded the bridge and combat information center of the ship with neutron radiation. In moments the ship was without any command, its communications and radar silenced. Then a Russian "sub" closed in and quickly finished off this key British ship with torpedoes. It broke apart with secondary explosions and sank rapidly. So far as was known, there were no survivors.

That unexpected shock in the mid-Atlantic produced two results, both very important: First, it caused a slowdown in the race toward the South Atlantic by the British armada. The task force had to be regrouped into a configuration better suited for an enroute defense, but that cost valuable time. Public announcements from London about the progress of the fleet reflected the slowdown. The timetable for arrival on battle stations near the Falklands started stretching out longer and longer. All this bought extra time for the joint commando team on South Georgia Island. And so the drilling continued.

The other result of the sinking was equally important. Word was flashed to the South Pacific Stealth navy to prepare for possible action. It was obvious that the Russian Navy was getting involved in the Atlantic, which meant that the Royal Navy could be in big trouble. During the dead of night, early April 15, the seven Stealth ships put to sea from their twin secret bases in southern

New Zealand. They deployed to a secret operational headquarters area in the Antipodes Islands, 450 miles southeast of New Zealand. Their electromagnetic shields were operating to provide protection from attack. These shields make it impossible to communicate with the outside world or even to see it. But once they arrived at the Antipodes, the Stealth ships hooked up to buoys equipped with shielded communication cables to the Island headquarters. The Island headquarters, in turn, was in constant touch with the South Georgia base by way of a transoceanic cable around the tip of South America. The deployment of the available ships of the South Pacific Stealth fleet was exactly what the joint Rockefeller-Russian planners had hoped for. The ships had been flushed out from their essentially invulnerable hiding place in New Zealand!

The British ship's sinking of April 14 was also followed by other events. On April 15 the Argentine Navy started moving out of port. The same day, Alexander Haig arrived again in Buenos Aires. Supposedly he was there as a diplomat, but in reality he was there as a General, dealing with Generals. Haig was the top Governmental operative of the Rockefeller cartel. He was making sure that the Argentines did not get cold feet and back down at that critical moment. Four days later, April 19, Haig left for Washington. As he boarded his plane, Haig somberly told reporters, "Time is running out." And so it was, my friends, for the secret South Georgia base. We shall also have a lot more to say about General Haig in future writings.

NOT EXACTLY A DRY HOLE

The very next day, April 20, the drill broke through into the hollowed-out cavern of the naval base. Bolshevik military analysts in London had not expected that it could be completed until at least the following weekend. The British fleet was still out of range.

THE WEAPON WHICH THE COMMANDO TEAM INSERTED DOWN THROUGH THE LONG HOLE WAS A SMALL, COMPACT RUSSIAN NEUTRON BOMB. When it was detonated inside the confines of the huge artificial cave, the effects were, of course, totally devastating. The intense radiation instantly killed everyone inside the base. Also the heat and blast effects of the bomb are believed to have damaged all of the ships inside sufficiently to badly disable them.

Meanwhile, Russian Cosmospheres and submarines were converging on the Stealth ships which were near the Antipodes Islands awaiting orders. From a distance, the ships were invisible to the eye due to their protective shields, which also protect against beam-weapon attack; but they were sitting ducks for the tactics which the Russians employed.

THE COUP-DE-GRACE

Floating overhead, the Cosmospheres located the seven ships using their Psychoenergetic Range-Finding equipment known as PRF. There is no method known by which PRF can be jammed. The Cosmospheres radioed the exact locations of the ships to the attack submarines. The "subs" were armed with special non-homing, non-nuclear torpedoes designed to explode on impact. More sophisticated torpedos would have been thrown off course or detonated prematurely by the protective shield of each ship; but these simple torpedoes just cruise right through each invisibility field to strike the ship and explode. Within 15 minutes after the attack

began, all seven Bolshevik Stealth ships were on their way to the bottom, and with them went their **Bolshevik Commanders and mercenary crews** collected from around the world.

The South Pacific action took place just after sunset local time. The time in Washington was around 2:00 P.M. April 23. That evening Secretary of State Haig was seen briefly in public with the new British Foreign Minister, Francis Pym. Pym was wearing the typical artificial pseudo-smile which diplomats are taught always to display in public. But not Haig. Haig was grinning from ear to ear-and no wonder. The joint Rockefeller-Russian military operation had been a brilliant success. The secret Bolshevik South Atlantic fleet had been virtually wiped out, bottled up inside South Georgia Island; and the South Pacific fleet, while not totally wiped out, had been badly crippled. By working together, the Rockefeller cartel and the Russians had won the secret naval war of the Southern Hemisphere.

Former U.S. Army 2nd Lt. Arthur W. GERMAN SURVIVORS: Some of the reports now surfacing from German survivors of the death camps add further evidence to support Bacque's gruesome findings.

Here are some examples: "I, too, was in one of those massive camps on the Rhine, in Ludwigshafen Rheingoenheim, from late April to early June 1945," Heinz Merkel, now of Gaggenau, Baden Wuertemburg, explained. "I can confirm everything that was told about the camp. I wondered at the time why food was not being provided at all. But I never dreamed that there was a deliberate effort being made to that end, at the top.

"I am sadly disillusioned. For me, who was 18 I had been brought up in an anti-Nazi spirit, and for that reason had completely different expectations from the other side."

A DEATH CAMP: Rudolf Binder of Freiburg explained: "I arrived in 'Bad Kreuznach', which can be characterized without further ado as a death camp, on May 1, 1945.

"Gradually over 100,000 men were gathered there," Binder continued. "During the first four days, there was absolutely nothing to eat. On the fifth day, we received raw potatoes that the German populace had collected. We ate them raw and got diarrhea. After that, once or twice a day, we got a watery soup with some turnip scraps. We also ate the green leaves that grew on the barbwire fence.

"The guards in the towers fired on everyone who "It was cold and misty, and I saw nothing in lingered in the vicinity of the fence, regardless. On Pentecost, we got bread, which had to be divided into 25 out of the camp in stretchers—about 200 a day."

Bernhard Gildemann of Wolfsberg explained: "From late April 1945, I was in the notorious U.S. death camp in Rheinberg and was an eyewitness to the daily mass deaths. We would have perished had not the camp been taken over by the English in June 1945. I shall be thankful to the Brits to the end of my life for the fair treatment they gave us."

Nor was the policy of starvation that the defeated German people suffered confined to just the military.

"Well into 1946," Bacque recently wrote, "the Red Cross was prevented from helping any Germans. Over 13 million food parcels taken by the Army from the Red Cross were still unused in U.S. Army warehouses in November 1945, according to the Adjutant Section of UFSET in November 1945."

Bacque continues that "millions of German civilians had fled West to escape the Russians." He explains further that "it was agreed policy of the Allies to expel from their homes over 15 million Germans, chiefly women and children. Wandering the roads of Eastern

Europe, they died in droves. More than 2 million died, while the U.S. Army was both sending food out of Germany and preventing others from sending it in."

Gen. Lucius D. Clay, deputy military governor of U.S.-occupied Germany, said: "In July 1945, the ration for the normal consumers was set at levels varying from 950 to 1,150 calories per day. This allowance was only about half the caloric content deemed essential by nutritional experts to support a working population....

"Actually only about 950 calories per day were distributed," Clay admitted.

HOW ABOUT YOUR POLICE-STATE IRS AND THE **CONSTITUTION OF THE U.S. AND INCOME TAX?**

[OUOTING:]

Because of the protection accorded all Americans $\underline{\boldsymbol{b}}\underline{\boldsymbol{y}}$ the U.S. Constitution, it is impossible to establish an effective and legal individual income tax affecting citizens in this country. However, the sections of the U.S. internal revenue code dealing with income taxes are written so cleverly and deceitfully that the great majority of the American people believe these taxes are at least potentially required under law to be paid by everyone in the private sector, as well as in the public sector, and that everyone must file an income tax return.

prosecuting attorneys and members of Congress should be asked the following:

collect an income tax from almost all U.S. citizens when there is no authority to do so under the very law which governs it? How is it that the statute technically observes the Constitution while those given the chore of enforcing it violate it by their procedures?

If anyone can obtain a definite answer to these questions, he is more persuasive than anyone I know.

The code lists those employees who are subject to withholding in Section 3401(c) "an officer, employee, and elected official of the United States, a state, or any political subdivision thereof, or the District of Columbia, or any agency or instrumentality of the foregoing. The term 'employee' also includes an officer of a corporation." (How many of those categories do YOU fit?)

Notice that the wording here—as throughout the IR code—makes it obvious that the term 'United States' has reference only to the general government and never to the union of the states. Sec. 6331(a) lists those whose property or income may be seized if income taxes are NOT paid. For the most part, those mentioned are the

> Jurisdiction is NOT GRANTED to the general government over any other territory, but is accorded to the states in which it is located.

> Sec. 61(a) lists 15 categories of income subject to taxation; however, neither wages nor salaries are mentioned, which seems to imply that even the pay received by government employees or those living in the District of Columbia is not subject to withholding or seizure.

NO POWER TO ENFORCE COLLECTIONS:

- 3) IT SEIZES PROPERTY WITHOUT DUE PROCESS OF LAW, IN VIOLATION OF THE FIFTH AMENDMENT;
- 4) IT ARROGATES TO ITSELF LEGISLATIVE, JUDICIAL AND EXECUTIVE POWERS, WHICH IS IN **VIOLATION OF THE ENTIRE CONSTITUTION;**
- 5) BY REFUSING A JURY TRIAL EVEN WHEN SUMS FAR IN EXCESS OF \$20 ARE IN DISPUTE, IT **VIOLATES THE SEVENTH AMENDMENT;**
- 6) BY IMPOSING EXCESSIVE FINES, IT **VIOLATES THE EIGHTH AMENDMENT.**

Perhaps the only way out of this Constitutional

quandary is to realize that these seeming violations apply only to the "taxpayer". And there is nothing in the code that makes the citizen liable for the tax. One who is not a taxpayer not only does NOT pay the income tax but need not even file a Form 1040. The ONLY WAY FOR A CITIZEN TO BECOME A TAXPAYER IS BY **VOLUNTEERING** INTO THAT STATUS, THEREBY WAIVING HIS RIGHTS. HOWEVER, THIS FACT IS CAREFULLY HIDDEN BY THE <u>INTERNAL REVENUE SERVICE AND ITS ALLIES!</u>


