It promises to be one of the great historic wars for economic privilege. Time and youth appear to be on the side of the upstart Euros. Combat experience and initial overwhelming number appear to be on the side of Hannibal and his elephant. Some believe that this worldwide war for foreign exchange reserve supremacy will continue indefinitely until one side is decisively defeated. Yet, either side could score a quick decisive victory.

THE EURO IN EUROPE

January 1, 2002 is E-Day. For the first time since the Roman Empire, E-Day will see Europeans of many languages use the same currency as a medium of exchange. On E-Day, twelve nations of the European Union (EU), through the European Central Bank (ECB), will launch the existing electronic euro currency into a tangible medium of exchange. The euro has seven denominations of banknotes and eight denominations of coins.

More than 300 million people in Austria, Belgium, Finland, France, Germany, Greece, Ireland, Italy, Luxembourg, The Netherlands, Portugal and Spain will march as one with the euro currency. They constitute the second most powerful economic market in the world. Increasingly, stocks and bonds will become priced in euros. Additionally, twelve more nations from Europe are talking with the EU about membership.

Euro use is not limited to nations who have officially adopted the euro currency. English corporations such as British Petroleum and Rover have already set up euro bank accounts for business in euros. Many Swiss industrial and tourist businesses are pricing products and services in euros. Yet, neither the English nor Swiss have yet made the euro their national currency. Many businesses worldwide, that trade with Europe, are establishing euro bank accounts for business in euros. We can expect the euro to have a major and increasing worldwide impact as an invoicing currency.

The euro is already the de facto currency of Eastern Europe. Currencies from nations such as Estonia and Poland track the D-Mark on the euro. And, the D-Mark has a fixed exchange rate with the euro, so currencies that track the D-Mark also track the euro. Trade relationships closely tie the currencies of eastern Europe with the euro.

THE EURO WORLDWIDE

Asian businesses will reduce exchange rate risks and transaction costs by using the euro for European trade. There is talk that China may evenly split its foreign exchange reserves between euro and dollars. Russia seems intent on shifting its foreign-exchange reserves from the dollar to the euro, instead of dollars, for oil. On January 29, 2001, the President of Mexico met with the President of the ECB and other ECB Executive Board members. We should think of the euro in worldwide terms.

At this point in time the euro is poised to strongly challenge the role of the dollar as THE reserve currency of the world. Across many geographic, political, business and finance fronts the worldwide expansion of the euro can be expected to greatly reduce the worldwide demand for dollars. Will an explosion of euros trigger the collapse of the exponential curve of dollar creation? Or, will Hannibal and his elephant stamp out the euro?

"THE FIRST INTERNATIONAL TRANSACTION BENEFIT"

The currency, trade, banking and finance ripples from E-Day will escalate the worldwide euro/dollar war for the economically privileged role of THE reserve currency of the world for nations, banks, businesses and individuals. For decades the United States standard of banknotes, euro settlements for trade, euro foreign living has been artificially increased by our having a pure fiat currency as THE reserve currency of the world. For example those hundreds of billions of greenbacks overseas were printed at negligible cost. And, the explosion of trillions of overseas electronic dollars were created at essentially no cost. Yet, their first international transaction was to purchase natural resources, finished goods or labor services for Americans and the American economy. I call this unearned, unmerited and secretive economic windfall "the first international transaction benefit". As long as those fiat dollars remain overseas, as public or private reserves, the United States economy has in effect received 'something for nothing' for decades from each of billions of "first-time international transactions". This creates a potential disaster waiting to happen.

One might even speculate that the Fed/Treasury assassinated the 30-year Treasury Bond in order to lower long-term rates; AND, as a pre-emptive strike before the public humiliation of euro bonds killing the 30-year Treasury. If so, then expect more Fed/Treasury preemptive strikes, especially as we approach E-Day, January 1, 2002. A possible strike that might temporarily strengthen the United States monetarily would be a change to a two-tier (domestic and foreign) currency. Then, selectively, domestic and foreign dollars could be repudiated as part of the war on terrorism and the war on drugs. The current intense presidential and establishment news media focus on money laundering and the financial funding of terrorism against the U.S. certainly seems to be setting the table for public acceptance of this two-tier currency change as a pre-emptive strike of selective dollar repudiation. Why not? After all, the United States repudiated its gold certificate and silver certificate banknotes and, the dollar survived those repudiations.

"THE INTERNATIONAL TRANSACTION **RETURN IMPLOSION**"

> An exploding worldwide demand for euro exchange reserves, and euro-denominated debt instruments, creates a worldwide contracting demand for dollar banknotes, dollar settlements for trade, dollar foreign exchange reserves, and government or private dollar-denominated debt instruments including bills, notes, and bonds. As demand for dollars contracts, foreign dollars purchase less; and, those foreign dollars start imploding home to the states in order to stake their original claim on American natural resources, goods and services. That is how the euro threatens to trigger the world's historically largest, and first true "International Transaction Return Implosion". With a worldwide, longstanding fiat reserve currency we are in historically unprecedented circumstances. But, logic tells me that dollars overseas are debts and, as they return, the debts either have to be repaid, or repudiated. If the overseas dollars are debts to be repaid (repurchased) by American resources, goods and labor services, then the United States standard of living declines severely, beyond imagination. Our central bankers may well get forced on to the horns of a dilemma: An economically-created violent revolutionary civil war at home, or dollar repudiation abroad.

THE EURO TALKS GOLD

Euro advertisements in Europe stress the importance of gold reserves for the euro. First, euro advertisements tout the European public perception that the gold reserves of the Euro-zone nations strengthen the euro and also strengthen Europe's economy. The euro ads also proclaim that most Europeans believe that gold reserves create confidence for strong economies. Thirdly, the euro ads proclaim that the vast majority of Europeans believe that the ECB should have gold reserves equal to the national gold reserves. And, the euro ads proclaim that the gold reserves of the Euro-zone central banks are the world's largest and they create public confidence in the euro. The euro advertisements are simple, yet cleverly testimonial. Their effective simplicity is to bind together three ideas; the euro, gold reserves, and economic strength.

By treaty, euro nations must comply with two However, the third consequence, "gold will resume its debt limitations. First, each euro nation must have an annual budget deficit of less than three percent of gross national product. Secondly, the total national debt of each nation must remain less than sixty percent of gross national product. Euro nations proclaim that their budget deficits are strictly limited each year and also limited in total amount for each nation. The ECB will conduct a single, more politically independent, monetary policy for all twelve euro nations. Gold, fiscal limitations, and monetary restraint-it sounds pretty good!

THE GOLD/DOLLAR CURRENCY EXCHANGE RELATIONSHIP

From its creation by Nixon, the primary adversary of the fiat dollar has been gold. The true weakness of supporters' war against gold in order to prop up the weak dollar and artificially lower the gold/dollar currency exchange relationship. Central bankers [IBC] have in desperation had to resort to increasing the supply of physical gold available in the marketplace by frequent auction sales from their own gold reserves. Such sales of physical gold reserves are akin to desperately slowly sawing off one's arms and legs in order to keep the trunk of the body appearing to be strong and healthy.

Bankers, and their surrogates, have also attacked the gold/dollar currency exchange relationship by irrational and financially dangerous massive shorting of gold in paper gold markets. The massive selling of paper gold derivatives, backed by apparently unlimited legal tender dollars, has been used to artificially suppress and control the gold/dollar currency exchange relationship. This is akin to the historic medical practice of cutting and bleeding ill patients in order to restore them to health.

The dollar forces in Washington and Wall Street have also attacked gold as money/currency by publicly ridiculing the "barbarous relic". As part of institutionalized white-collar crime, the 'experts' and the establishment media have shamelessly manipulated markets and promoted investments that are either financially unsound dollar debt instruments or businesses awash with dollar debts and unrealistic manipulated accounting. All of these manipulative fraudulent actions have served to artificially lower the gold/ dollar currency exchange relationship and to thus create the false perception of a 'strong dollar'.

THE DOLLAR AND THE DE FACTO FRACTIONAL RESERVE SILVER MARKET

dollar faces a major challenge by physical silver. The dollar forces have attacked silver in much the same way that they have attacked gold: shorts backed by apparently unlimited dollars, paper derivatives and ridicule. However, the bankers have spent their ammunition of physical silver. For years an annual production supply/ demand shortfall of silver has used up most of the above-ground supplies of physical silver.

Year by year, paper silver has expanded, while available physical silver stocks have contracted. This has created an overextended, unstable and unsound de the dollar is documented by the nature of the dollar facto fractional reserve silver system. We are now seeing the beginnings of a shortage of physical silver. One-, ten- and hundred-ounce silver bars have been bought and melted into good delivery, one-thousandounce silver bars. Now, many coin dealers and bullion dealers who have traditionally sold one-, ten- and hundred-ounce silver bars to the public, often have none and are apparently unable to order them at a realistic price. This increasingly apparent shortage of physical silver now threatens runaway bull markets for silver and gold. A lack of physical silver causing a runaway silver bull market would probably set gold free in a parallel runaway gold bull market. Gold is also bogged down in a manipulative de facto fractional reserve gold system. However, the central banks still have substantial reserves of gold that threaten the gold market with more central bank auction sales. That fear for gold investors will likely turn to greed if silver breaks free.

THE GOLD ISLAMIC DINAR, THE SILVER ISLAMIC DIRHAM AND BANKS BASED ON ISLAMIC LAW

There are over a billion Moslems. Most, with wealth, are Westernized in monetary and banking matters. The Islamic Dinar is a gold coin that weighs 4.3 grams. The Islamic Dirham is a silver coin that weighs 3.0 grams. Traditional Islamic banking, based on Islamic Law, excludes fractional reserve banking and interest-bearing debt. The coins are minted as mediums of exchange, based on metallic content. Rebirth of these historic Islamic practices is in its infancy. Yet, considering the size of the Muslim population, even a partial return to historic Muslim banking and currency practices would severely impact all fiat currencies and fractional reserve banks. world's Monetary Emergency Room. Fiat currencies, like people, become feeble and old—and die. The killing cancer for the fiat dollar is debt. For nothing except cancer grows and consumes like debt. Dollar-

Unpayable dollar-denominated debts have to be liquidated by currency inflation or by default. And those debts are so pervasive worldwide that either way, the dollar probably fights its last desperate and powerful "Battle of the Bulge" before it too runs out of gas and dies.

What shall be the new fiat reserve currency to replace the dollar for the next K-Wave cycle? The Currently, for the second time, the modern fiat Euro-Euroland central banks have gold; but in reality the euro, as presently constituted, is just another fiat currency like the dollar. The ECB 'talks the gold talk' in its advertisements promoting the euro currency. However, the ECB and the euro do NOT 'walk the gold walk'. Neither domestic European euros nor foreign euros are redeemable for the token gold reserves of the ECB; or for the substantial gold reserves of the national member central banks. The chief 'asset' of the euro is its extreme youth and the absence of many years of accumulated euro-denominated debts around the world. However, [it] is highly questionable as to whether euro creation within a fractional reserve banking system can in the long run be controlled by the ECB. I personally think that such a notion of possible restraint of euro creation within a fractional reserve banking system is delusional. So, an uncontrollable fractional reserve banking system is a fatal flaw for the euro. There is semantically deceptively implied gold backing for the euro within euro advertisements. But the euro, as presently constituted, has no meaningful gold backing.

I sense the appearance of another deliberate grand deception so that central bankers can, with another fiat currency, again evade the discipline and honesty of gold as a medium of exchange. With another fiat currency waiting in the wings (the euro) the central bankers keep control of covert criminal and political theft of purchasing power by the printing press and by the computer, after the anticipated death of the dollar.

I see the old law enforcement 'good guy/bad guy' routine. The dollar, overextended in debts and collapsed in terms of purchasing power, is the 'bad guy'. The fiat euro currency, draped in a sheepskin of advertising with 'gold' words is the 'good guy'. However, neither European citizens nor foreign trade partners can redeem their euros for gold at Euroland central banks.

The euro as presently constituted is 'Fiat Reserve Dollar #2'. With time the euro will become overextended in debts and collapse in terms of purchasing power, and die. But that will probably not be until the debt-liquidation phase of a new K-Wave cycle, more than a half century from now. In the next K-Wave debt liquidation the euro may be the 'bad guy' and 'fiat Reserve Dollar #3', draped in fool's-gold rhetoric, will be the new 'good guy'.

I fear that in every K-Wave cycle the 'sheeple' will get sheared by another fiat reserve currency like the dollar or the euro-draped in fool's-gold rhetoric; but not redeemable for gold. Even before its banknotes circulate, the euro currency suffers from six long-term fatal flaws. The first fatal flaw is that an abundance of gold or silver coins will not circulate as a euro currency The dollar resides in the Trauma Section of the medium of exchange. The second fatal flaw for the euro is that euro paper bank notes are not redeemable for gold or silver. The third fatal flaw for the euro is that euros acquired by foreign trade with the euro nations are not redeemable for gold or silver. The denominated debts have 'Hannibal' and the dollar fourth flaw is that the overwhelming majority of the bankers desperately 'pushing on a string'. Dollar holders 14,400 metric tons of gold belongs to the individual

that for many euro nations to turn their gold reserves over to the ECB in order to back euros would require most unlikely constitutional amendments. And the sixth fatal flaw for the euro is that it operates within an uncontrollable fractional reserve banking system. With these six flaws it is self-evident to me that the euro is NOT gold-backed and its growth is not controllable.

And most importantly, the euro may quickly and decisively dethrone the mortally wounded dollar as THE world's government and private reserve currency. The euro may even live for the next thirty to sixty years. But the euro as presently constituted is nothing more than a newborn Fiat Reserve Dollar #2 that is not entangled with over a half-century explosion of euro debt creation.

For at least a half-century, we American 'sheeple' have been financially sheared of purchasing power each year. I remember what it was like about fifty years ago. I would take a dime to the corner. For five cents I would buy a large Coke. For another five cents I would buy a large chocolate Hershey bar with almonds. Today, that same ten-cent purchase would cost me over two dollars. And to add insult to injury, I would now have to pay at least a thirteen-cent sales tax on that Coke and candy bar. That thirteen cents of sales tax is more than my total original purchase cost of ten cents. By the Coke/Hershey Bar measure, the circa 1951 dollar has lost more than 95% of its purchasing power

I also remember that circa 1951 that I got my haircut in a downtown Coral Gables barbershop for twenty-five cents. Today I pay twelve dollars for a lesser haircut (no straight-razor trim around the ears). Also today I am expected to tip. Forget the tip; but because of the less thorough haircut, by my haircut measure, the circa 1951 U.S. dollar has lost about 98 percent-the 'wool' (purchasing power) has been sheared from the 'sheeple's' dollars. Now they are coming for our 'hides'-the homes that we return to each night. Have you ever seen 'sheep' with no 'wool' and no 'hides'? Yes! Of course you have! They are the homeless beggars that abound in the cities across America. They are the Americans that you do not wish to make eye contact with. They are the Americans that you pretend do not exist. Many of us, to our dismay, shall soon personally experience that pain, suffering and humiliation-as the loss of purchasing power caused by fiat-dollar debt repudiation, economically skins great numbers of the American people alive in a severe and prolonged economic depression. And if the euro as presently constituted replaces the dollar as the world's reserve currency, then our grandchildren shall be sheared for decades and then finally economically skinned alive by the euro. For the euro is a Trojan Horse. As it is presently constituted the euro is gold paint on the outside and another band of criminal, conquering and looting white-collar barbarian central bankers on the inside. The euro is simply a de facto young stepchild of the dollar. The euro as presently constituted is simply Fiat Reserve Dollar #2.

The imperialistic central bankers shearing of the 'sheeple', with their white-collar crimes, shall not cease unless physical gold, silver and copper currency are DEMANDED as daily mediums of exchange—independent of a fractional reserve banking system—for purchases large and small. The euro, because of its youth and relative lack of debt, is a vast improvement over the dollar with its overextended debts. But the euro is still just fool's gold and 'Fiat Reserve Dollar #2'.

THE WHITE-COLLAR BARBARIANS

Forget all the polite, friendly and co-operative public rhetoric between the Fed and the ECB. The stakes of the war between the dollar and the euro are much more than substantial. At stake is the privilege to continue performing the greatest historical criminal plundering and looting of purchasing power in the history of the world. At stake is the ownership right to the greatest criminal financial con game in the history of the world: the worldwide use of a fiat currency as a reserve currency. If the euro wins, then the Europeans receive the financial privilege and economic gains of selling to the world essentially cost-free computer entries and paper fiat currency reserves-for tangible goods and real labor services. If the euro wins, then the Europeans would become the ruling white-collar barbarians, able to do as the Americans have done for more than a half-century. (Nixon closing the gold window turned all outstanding previously created dollars into fiat dollars.) If the euro wins, then the Europeans will in due course replace the Americans as the most hated people in the world.

If the dollar loses the war with the euro, then the United States privilege of criminally plundering and looting the purchasing power of the world—via the sale of essentially cost-free, fiat-dollar reserves for natural resources, tangible goods and real labor services—stops. If the dollar loses, then the criminal practice of the United States plundering and looting the purchasing power of the world via dollarization, stops. If the dollar loses, then the decades-long use of the dollar in order to artificially raise the standard of living in America by monetarily looting and plundering foreign purchasing power—stops. Hence, an even longer and more severe economic depression will occur in the United States, more than likely with increased domestic violence and increased risk of revolution.

My, how modern imperialism has evolved. We no longer send armies to plunder and loot foreign lands of their gold and silver [MM: Say what?!]. Now we send bankers. Instead of sending our armies we now send the peoples of the world our bankers and our computer entries (with no intrinsic value) and with no tangible substance. We demand that foreigners pay for the "reserve" of our computer entries (with no intrinsic value) with their natural resources, their finished goods and their labor. And our trading partners who use the dollar as a "reserve" asset must accept this 'exchange' thankfully and humbly even while we plunder and impoverish them to pervasive hunger. Just look at our cumulative trade deficit. We export our bankers and our computer entries to lie dormant as their public and private "reserves". In exchange for exporting our computer entries with no intrinsic value to lie dormant as "reserves", we import their valuable raw materials and finished products.

It is the biggest criminal con game in the history of the world. And the marks go along with this exploitation while a deep worldwide festering hatred of America and everything American builds and builds. All the while the bankers are criminally plundering their purchasing power and creating decades of countless deaths by starvation throughout the world.

What usurper central bank shall wear the illegitimate crown of the king of the moneychangers? What central bank shall wear the papier-mâché crown of the king of the white-collar barbarians? Due to obvious superiority, the outcome of ongoing wars often seems obvious. Due to obvious superiority, the United States had to win in Viet Nam. Due to obvious superiority, the USSR had to win against the Afghans. But neither did. Our best guess is that the euro will defeat the dollar. However, what will actually happen in the euro/dollar clash of white-collar barbarians is anyone's guess.

GOLD

The imperial Fed has evolved into a desperate and paranoid adversary of gold since Nixon stole the rightful crown of king of the money changers from gold. Although the ECB itself is a fiat currency, white-collar barbarian, the ECB *talks* gold with the reality that a euro psychologically coupled with gold in a positive way, has the best chance of winning the euro war with the dollar for the status of THE reserve currency.

Thus gold is the major battlefield in the euro war with the dollar. It is a battlefield carefully selected by the euro as the best available high ground. Gold is the pivot of the seesaw. The plank on one side of the seesaw pivot represents the dollar at war with gold. The plank on the other side represents the euro as a pronounced gold advocate. If the dollar plank goes down on a sustained basis, the euro and gold should go up in relative purchasing power.

The white-collar barbarians at the Fed and the U.S. Treasury made a self-destructive and fatal error when they psychologically and falsely coupled [a] low dollar/gold currency exchange rate with the pronounced health and prosperity of the United States economy. The ECB is vulnerable to many self-destructive mistakes. But that is one Fed mistake that the ECB is unlikely to make any time soon.

Hope springs eternal. Some may hope that the euro will in time evolve into a true gold-backed currency with eventual redemption of all euro currency units for gold. My view is that this is highly unlikely. First, I do not see this possibility as pragmatic or long-lasting, because the EU banks function within a fractional reserve banking system. Eventually the ECB would have to close its domestic and foreign gold windows (like the dollar did) because of euro multiplication within a fractional reserve banking system; or the ECB would continuously have to severely devalue the euro in the gold/euro currency exchange rate because of the constant increase of euros due to a fractional reserve banking system; and due to the dominant reserve status of the euro. The blowback from that would eventually be the people of the world having a constantly growing mathematical index (the gold/euro currency exchange rate) of how the bankers were defrauding them. Under such circumstances, one would hope that the people of the world would demand that governments reinstate gold itself as the moneychanger currency (reserve currency) for all other currencies.

[H: READ IT AGAIN!]

Secondly, actual euro/gold redemption is to the severe economic disadvantage of the ECB and its nations because a redeemable gold euro would essentially foreclose the opportunity for ECB nations to criminally loot and plunder the purchasing power of the nations of the world through the use of fiat euros as public and private foreign reserves. Payments between nations in

physical gold keeps international trade relatively honest. Gold as the international moneychanger currency assures 'something for somethin'. A worldwide empire of a primary fiat currency for the payments between nations, criminally defrauds the world and enriches without merit the fiat reserve currency creators. A fiat currency as the primary international moneychanger currency (reserve currency) assures the fabulous riches of worldwide 'something for nothin' exchanges. We Americans (our bankers) could not resist that temptation. I do not expect European bankers to resist that temptation. I do not expect any peoples of the world to resist the temptation of fabulous worldwide riches for nothing. That is why we the people must demand a return to circulating physical gold and silver currency, without fractional reserve banking.—"Atocha", November 26, 2001

IRAO DEPLOYING 'SUPER-CANNONS' 7 NATIONS INVOLVED IN INVASION PLANS SET FOR FEBRUARY

American preparations for a major offensive against Iraq are massive and continuous, set in place layer by layer-but sources say a seven-nation attack on Saddam Hussein is not likely before mid- to late-February.

Military sources disclose that over the coming weekend, U.S. fighter plane and bomber squadrons will be flying into three air bases: Kuwait, Egypt's Sinai Desert and the Israeli Negev. Call-ups issued in early December have mobilized 10,000 U.S. military personnel, air crews and Air Force intelligence officers and technicians, who were ordered to report for duty after New Year's Day. Last month, the U.S. Third Army command, led by Lt. Gen. Paul Mikolashek, transferred to Kuwait from its peacetime headquarters in Fort McPherson.

When the attack comes, high on the coalition's agenda will be targeting Iraq's newly discovered super-cannons, which now number three or four, according to intelligence sources.

U.S. Army, Navy and Air Force might is being assembled in Israel. In the central and southern regions, U.S. emergency stores of armor, artillery, combat helicopters and military vehicles have been opened up. Equipment has been readied for war, fitted with sensitive electronic communications systems and loaded with ammunition. From early December, ships of the U.S. Sixth Fleet have been entering the Israeli Mediterranean port of Haifa. They carry large quantities of drugs to counter poison gas, chemical and biological attacks, as well as protective equipment against nuclear radiation for Israelis and for American personnel in Israel and the Sinai.

The Third Army, now on the move toward the Middle East, numbers nine divisions, among them the 82nd Airborne, 101st Air Assault, 24th Infantry (Mechanized), 1st Infantry (Mechanized), 1st Cavalry, 1st Armored and 3rd Armored. By early February, 75,000 U.S. troops will be positioned on the Iraqi front.

This high concentration of military personnel means that Washington's concept of the Iraqi campaign is quite different from its approach to the war in Afghanistan, where few U.S. servicemen were deployed outside the Air Force. The Iraqi theater will be broad and multinational, involving at least seven countries-Saudi Arabia, Kuwait, Bahrain, Jordan, Israel, Lebanon and Turkey. The ultimate line-up will be determined by political and military developments in the region. But U.S. military planners are counting the armies of three nations—Turkey, Israel and Jordan-as combatant alongside U.S. forces.

Military sources sketch the following preliminary blueprint for the yet-to-be finalized U.S. assault plan. It will come in the form of a simultaneous three-prong offensive:

Target One: Iraq's political power centers and military headquarters—most of which have already been moved to safe underground quarters—will be hit mustard gases onto a battlefield, where they explode and from the air by bombs and missiles.

Target Two: Turkish armor and infantry, backed by local Kurdish tribes, will lead off the ground likely to cause delays in U.S. scheduling of its war campaign in northern Iraq. Negotiations to co-opt the local Kurds are still going on.

Target Three: U.S., Israeli and Jordanian elite infantry

and Special Forces will raid army concentrations and convoys and hit Iraqi warplanes and missile batteries in their bases in an area stretching from central Iraq to the north, including the Iraqi Western Desert. These essentially hit-and-run forays will aim to destroy command centers, anti-aircraft systems, artillery and tanks, without miring the troops in lengthy skirmishes.

This tactic was prompted by the latest intelligence reaching U.S. military planners whereby Saddam Hussein was reported to be taking a leaf out of the 1991 Gulf War manual and the Afghanistan War guidelines, to institute a new strategy. He has ordered the breakup of the large Republican Guard armored divisions, formerly the backbone of Iraq's main fighting force, into small mobile units, capable of autonomous operation for long periods over broad stretches of territory.

By this fragmentation of its military strength, Iraq hopes to: 1. Confound U.S., Israeli and Turkish air forces by compelling them to chase fast, small, low-profile units that are hard to find, attack and destroy.

2. Level the playing field by drawing them into pursuing units that challenge U.S., Turkish, Israeli and Jordanian crack ground forces and divert them from strategic Iraqi forces and facilities.

Those newly formed Iraqi units are designed to move out swiftly, rendezvous, return to base or revert to their old configuration as large armored divisions-whatever is required by the exigencies of battle. U.S. spy satellites have followed recent Iraqi exercises, in which contingents were split up, scattered in new positions within four hours of receiving their orders, then regrouped into their former large mold less than six hours later.

These small units will be rendered self-sufficient by the hundreds of underground fuel, ammunition and food stores dispersed around the center and north of the country. The Iraqis have also formed small mobile technical units for backup service.

Accepting that U.S., Turkish and Israeli warplanes will command the skies, Iraqi military planners have equipped the new mobile units with state of the art weaponry. According to military intelligence sources, the Republican Guard units were recently handed out the locally manufactured longrange, hand-held laser sidearm, capable of inflicting severe burns and total blindness. This space age system, fitted with a laser rangefinder, can damage its target's retina and other parts of his body, as well as causing severe internal hemorrhaging. Iraqi forces have been spotted by intelligence practice-firing these devices against low-flying warplanes and helicopters. Their object is to incapacitate pilots and cause enemy aircraft to crash....

Additional intelligence information suggests the new Iraqi units are also equipped with tactical chemical weapons, whose precise nature and mode of operation are unknown. Iraq is thought to have prepared large stocks of anti-tank missile tubes, converted to the propulsion of small canisters of Sarin, Tabun and VX nerve and spread their deadly contents over a wide area.

Iraq's tactical preparations for a major assault are offensive. The Americans, Turks and Israelis may well with Iraqi's new unit structure and vicious weaponry.

According to military sources, the Pentagon has picked northern Iraq as its first ground target for good reason. Intelligence information shows that Saddam and his immediate circle of Baath party leaders have already moved their offices and families to an underground city near the northern oil city of Kirkuk. It is located between the three cities of Tepe Zardic north of Kirkuk, Taq south of Koi Sanjaq, and Chwarta north of Sulmeniyeh. Several intelligence reports place the secret city on the banks of the Lesser Zab River, protected from the east-the border with Iran-by the Dukan Dam and Iraq's largest artificial lake.

According to sources, this subterranean complex was first built as a storage facility for nuclear bombs and explosives. But since 1995, under Saddam's direction, it has expanded into a network of tunnels, roads, living quarters, offices, communications centers and radio and television facilities, from which the Baath regime expects to continue ruling the country under a U.S. attack.

Members of private Italian engineering firms who sold Iraq industrial components for uranium enrichment in 1993 and 1994 are the only foreigners known to have visited the buried city. After U.S. Special Forces locate its whereabouts, U.S. military tacticians plan to destroy it with the help of the same airborne missiles and bunker-blasting bombs that were fired against Afghanistan's cave systems-especially the AGM-86 B cruise missile. Following the aerial assault, ground forces will storm the tunnels leading into the secret city.

Their hope is that the capture and fall of his underground metropolis will suffice to bring Saddam's regime crashing down. On the other hand, the Iraqi leader will certainly have had the foresight to build an extensive system of escape tunnels to take him in safety to central and southern Iraq if his secret city comes under attack.

Saddam's super-cannon of pre-Gulf War fame is making a comeback. In its newly adapted form, the fabled monster gun has been designed to fire nuclear, chemical and biological shells at U.S. military targets in the Gulf, Middle East, Red Sea and Mediterranean, as well as targeting Kuwait, Bahrain, Turkey and Israel.

In its original form, the gun was capable of firing a warhead at Tehran or Tel Aviv, having a range of 1,500 miles or more, if boosted by a rocket.

In 1985, in the closing days of the Iraq-Iran War, Saddam hired the super gun's inventor, Canadian astrophysicist Gerald Bull, arguably the most prominent scientist in the missile and artillery field in the 1970s and 1980s. Bull helped improve the accuracy of Iraq's self-propelled artillery and Scud missiles, but he mainly dealt with constructing a 424-mm cannon that could fire quarter-ton shells more than 1,700 miles.

Bull was murdered in Brussels in 1990. Newspaper reports said Israel's Mossad killed him to foil the super gun project. Another theory said he fell victim to Iraqi intelligence assassins because of Saddam's suspicion that he was cooperating with Israel through South African contacts. The real story is still unknown. After Bull's death, Iraq was left with the scientist's plans but without the manpower or technical know-how to complete the project.

But Saddam never gave up his grandiose plans for the super gun. One was to blast into orbit the military satellites he was building just before the 1991 Gulf War. In 1992 and 1995, experiments were made to launch spacecraft that would collide with enemy satellites making surveillance passes over Iraqi territory. On impact, the spacecraft was to explode and spray the satellites with an adhesive substance that would render their cameras and surveillance equipment useless.

Touting his super gun, Saddam once boasted a need more time than they thought at first to contend missile could be launched only once but a cannon could be used repeatedly to fire projectiles.

were surprised to discover not one but three or four Israel's worries are a possible ground-to-ground missile super guns just turned up in Iraq's arsenal—weapons attack, with chemical or biological payloads. far more advanced and effective than the cannon Bull developed. It comes in two versions.

The largest has a 1,000 mm diameter barrel, 260 meters (248 yards) long and a maximum range of 2,000 miles. The barrel of the smaller version is 350mm in diameter and 30 meters (32 yards) long. Its range is up to 250 miles. The Iraqis may have two of each, hidden in Saddam's underground city. They remained undiscovered for so long because they were dismantled and concealed in segments—the barrel of the biggest super gun is made up of 35 separate pipes. It was only when the Iraqis started assembling the super guns that U.S. and Israeli satellites spied them out.

Since most intelligence experts concede Iraq has been capable of building radiological weapons since 1991, its super guns-which can deliver a nuclear payload over great distances-will be one of the first goals of the U.S.-led campaign. Killing the super gun could be the boldest move in Washington's global war against terrorism.

ISRAEL ASKS AMERICA TO STRIKE WESTERN IRAQ FIRST, IF IT DECIDES TO FIGHT SADDAM

Defense Minister Benjamin Ben-Eliezer paid a visit to the secretive Ness Ziona Biological Institute yesterday.

The defense establishment here believes that the Bush administration has given up trying to find an Iraqi version of Afghanistan's Northern Alliance, so Washington is busy studying intelligence profiles of top Iraqi army commanders who could take control in Baghdad concurrent with or immediately after the start of an American campaign.

In a U.S. attack, Saddam won't hurry to attack Israel, say defense sources, because, among other reasons, he won't want to expose the weaponry that he managed to hide-and deny he had-over the past decade.

EU IN POSITION TO BE WORLD'S NEXT SUPERPOWER

While U.S. media focus on Europe's transition to the euro, Washington doesn't seem to understand the full implication of a unified continent across the Atlantic.

The adoption of the euro by 12 European countries signals something far more important than anyone on this side of the Atlantic seems to realize.

Europe is gradually emerging as the world's new superpower. Within a couple of decades, the European Union will equal-if not surpass-the United States as the dominant economic force on the world stage.

Consider the arithmetic. The U.S. dollar is used by about 285 million Americans. The euro is beginning to be used by 304 million Europeans with comparable levels of prosperity. When remaining EU members Great Britain, Sweden and Denmark join the euro zone, as now seems inevitable, that sum will rise to 378 million.

And that is just the beginning. Another 12 European countries are preparing to join the EU. Their accession in the next decade will bring the total to 483 million, in current figures.

Taking a longer view, Turkey, the Balkans and eventually Russia enter the picture. Turkey is already in a customs union with the EU, and German Chancellor Gerhard Schroder is advocating bringing Russia into the fold.

For his part, Russian President Vladimir Putin is likewise tilting toward Europe. Russia is already a member of the Council of Europe. It is only a matter of time before it joins the EU. Together with the remaining holdouts, that will bring the total to roughly 800 million people in current terms, almost equal to the population of India or China.

But the EU is qualitatively different from India and China. It is enormously more prosperous and technologically advanced. It encompasses four of the Big Seven economic powers: Germany, Great Britain, France and Italy.

Geopolitically, it includes a unified Germany in further union with its historic rivals, France and Great Britain. Add Russia to the mix and the implications are mind-boggling. Never before has Europe been united through peaceful means. The emergence of the continental superpower raises the prospect of a union more formidable than the United States, stretching from the Atlantic across Eurasia to the Bering Sea.

So why aren't we hearing more about it? Because Washington still doesn't believe Europeans will be able to overcome linguistic and cultural barriers.

Yet border checks have vanished, so that crossing from one country to another is about as eventful as crossing a state line in the United States.

The EU already has a functioning parliament, courts, capital city, flag, license plates, passports and now a common currency.

Despite all of this, Washington still isn't taking the EU all that seriously. Where, after all, is the European president? The current European executive has 15 heads, a recipe for gridlock that can only get worse with the admission of more countries.

ATTACK FUND OFFERS MILLIONS IN PAYOUTS

WASHINGTON-The federal government, taking on the role of insurer of last resort, will offer families of people killed in the Sept. 11 terrorist attacks an average of \$1.6 million in tax-free compensation, the program's administrator said Thursday.

Payments will depend on the age and income of the person who died. Families who lost workers who were younger or at higher income levels will receive more, but each claimant will receive at least \$300,000. Life insurance and pension benefits will be subtracted from the total awarded.

In a key decision, Kenneth Feinberg, the Washington lawyer named special master of the compensation fund, said money received from charities will not be a factor in the awards.

However, Feinberg said, "whatever we do is of be lost in the U.S. campaign in Afghanistan but that small comfort" to those who lost a loved one in the attacks. He promised a fast, fair and reliable system for offering money to survivors' families, as well as those who were physically injured.

The program could cost the government as much as \$6 taxpayer generosity" on behalf of the victims.

ARGENTINA: BLAME THE IMF CROWD THE ONE-SIZE-FITS-ALL GLOBALIZATION MODEL JUST DIDN'T WORK

Throughout the 1990s, Argentina dutifully carried selling them off to foreigners. It embraced free trade "Some families will get nothing at all. I and pegged its national currency, the peso, to the U.S. for most of the decade-former President Carlos Menem was only recently released from house arrest for his role in an international gun-running scheme-seemed to matter little to world bankers. As long as it remained a lucrative investment for mobile international capital, as long as it churned out double-digit profits for wealthy overseas bondholders, Argentina was the darling of globalization. But after bloody civil unrest drove President Fernando de la Rua from power earlier this month and Argentina suspended payments on its international debts, the global money managers acted as if they had nothing to do with the country's economic contributing factors. Yet the men who run the Kriendler represented families of victims of the International Monetary Fund, the World Bank and other multilateral financial agencies have some explaining to do, too. Argentina obeyed to the letter the nostrums the IMF routinely prescribes for the poorer half of the world: It cut social spending, reduced wages, raised prices and balanced the budget to attract foreign investment. Even as default loomed, the IMF pumped billions of dollars more into Argentina in return for its obedience-and the economy still collapsed.

That experience should be enough to throw into question the free-market globalization model that has increasingly been forced on Latin America countries as the only way to grow economically. A study released last summer by the Center for Economic and Policy Research in Washington provides further support for such a break. Of the world's 116 poorest Feinberg promised to act quickly on processing countries, most are worse off after the last 20 years

The IMF also pursued a money-for-austerity strategy in Russia in 1998 and in Brazil a year later, to similar disastrous effect. But the outcome in Argentina has been catastrophic. Pegging the peso to the dollar resulted in a vastly overvalued national currency. Argentine exports ceased to be competitive. Cheap imports smothered national production. As the value of the dollar rose 35% over the last five years, Argentine wages were depressed an equal amount. Interest rates soared. The foreign debt mushroomed to more than \$130 billion. Unemployment floats near 20%. Argentina's four-year recession pushes an estimated 2,000 people a day below the poverty line. Accounting rules to boost earnings, investor confusion

The holidays may be the time for goodwill toward men, but next month it's shareholders' turnand this kind of goodwill may bring little joy.

A new accounting rule goes into effect for scores of companies Jan. 1 that will goose corporate profits by allowing companies to keep some big acquisition costs out of the equation when calculating their quarterly earnings.

The change will mean billions of dollars more each year in corporate profits, with only the stroke of a pen, because companies will no longer have to write off over several years their goodwill-the difference between what a company paid for an acquisition and what its hard assets are actually worth.

For many companies, this will bring a substantial jump in 2002 quarterly earnings. For many investors, it could bring a healthy dose of confusion.

AOL Time Warner Inc. announced its reported net income would surge by nearly \$6 billion because of the change. The media and entertainment powerhouses completed one of the largest corporate mergers in history early this year.

Chicago-based insurer Aon Corp. expects annual earnings to rise at least 36 cents a share. Tax preparer H&R Block Inc. said it will boost first-quarter earnings by \$12.3 million. Indiana-based financial services firm Conseco Inc. expects the change will increase net income by \$110 million, or 29 cents a share.

But the new provision requires companies to regularly test whether goodwill on the books has substantially declined in value. If it has, they must write down its value, which in many cases runs into billions of dollars.

In the wake of the dot-com and telecommunications meltdowns, it could mean some stunning admissions by corporate managers that they vastly overpaid for acquisitions in the boom period.

It's happening to some already. JDS Uniphase Corp. has already announced a huge writedown of \$38.7 billion in goodwill for its acquisitions. Similarly, Nortel Networks Corp. took a \$12.3 billion after-tax charge in the second quarter, primarily to write down goodwill from acquisitions.

The new accounting rule could also mean more scrutiny for the accounting watchdogs, already reeling from some highprofile errors. The goodwill rule requires companies to make a fairly subjective call about whether their assets have declined in value-potentially a big boon to valuation experts and a big headache for corporate executives.

"A number of companies will attempt to do this inhouse, but there's always the fear that the SEC will come in and ask why they didn't have an independent third party verify it," said Douglas Rogers, executive vice president of CBIZ Valuation Counselors in Chicago.

Rogers is predicting a last-minute corporate dash to comply with the new rules, and sees a potential minefield ahead.

"The whole point [of the new rules] is to accurately reflect the impact of deals. If you overpay and have a lot of goodwill in one unit of your company, chances are you're going to have a big impairment charge," he said.

The change requires companies to test business units separately to assess their fair value, which gets complicated for companies in several lines of business, Rogers and others said. That could lead to differences in recording values among companies, which makes it more difficult in the end for shareholders to decipher as well.

"Some companies may have 20 or 30 reporting units to test," Rogers said. "It becomes a morass."

Firms are also realizing that these reviews will be costly at a time when revenues are also slower, essentially adding another layer of auditing onto the company's docket.

"A year ago people said this was going to be great," said Jim Somers, a partner in Chicago with accounting firm Ernst & Young. "Now they realize this impairment review is going to be costly and it's one more thing to audit."

Corporate executives had been salivating over the change because it allows them to consummate big mergers without having to tell shareholders to expect big charges for amortization. Now, it could trigger some pretty stunning confessions about the deals recently done.

'The timing could have been better," Somers said. "There are a lot of companies out there with a lot of goodwill and little market capitalization."

As such, a floating gold price is not in the best interest of the current U.S. monetary policy, and possibly other countries as well (the UK?). It is this issue that the monetary policy makers take free reign in using ESF and other regulatory loopholes to secretly deal in gold to maintain a steady price of gold. The secrecy, they likely feel, is required so as to not have public policy become a determinating market factor, if such trades were to be discovered.

The U.S. strong dollar policy, when all is said and done, is really a weak gold policy. The unstated dollar vs. gold relationship is the heart of the GATA matter, as this is what has resulted from the policy makers' desire to stabilize currencies. It is this desire and subsequent secret market actions (alleged) that puts the stranglehold on the gold price, which is the crux of the GATA mission.

In short, current official monetary policy can not allow gold-the monetary asset-to rise in the gold commodity marketplace. To do so, would destroy or weaken the strong dollar policy. I believe it is this juxtaposition that GATA is concerned about. U.S. policy does not recognize gold as an official monetary asset, it appears to use its considerable influence with media and Wall Street to take the media heat off of gold so as to not create an investment demand. In the meantime, they must contend with a monetary asset that as much as they may not like it, has the ability to weaken the dollar beyond their desire or control. As such, they appear to have pulled the stops on their alleged secret campaign against a rising gold price.

Unfortunately, such a policy can not be carried out in a vacuum. Such policy requires coordination with Wall Street and the media. Here maybe is where GATA's efforts should lie. This coordination unfairly tips the government's hand such that insiders are privy to a policy that the rest of us are not. As such, thousands and perhaps more unwitting investors have been duped by this secret policy against gold. Gold, the commodity, remains on all of our radar screens. It is fair game to investment capital, as such. Gold, the monetary asset, is not fair game for investment capital. The alleged strong dollar policy therefore allows gold to trade as a commodity but seeks to suppress the price of gold secretly in order to stabilize the dollar and to protect an alleged 14,000-ton, naked-short position that has been amassed worldwide in the effort to keep the dollar strong. The purveyor of this policy is allegedly the public Gold Auctions of the UK and the ESF (Exchange Stabilization Fund) of the U.S. Department of the Treasury. In addition, certain Bullion Banks have been let in on the secret as the agents of this policy, since they are the agents of commodity gold exchange.

The GATA mission should be to educate the public as to the dual role of gold in the world economy today; expose the strong dollar policy for what it is (a secret campaign against commodity gold); expose the secret policy against gold and the large short position this has caused and the risk this creates for the dollar. Expose the participants in this scheme and push for an open market in gold. This is not without consequences since a free-trade gold market will undoubtedly change U.S. monetary policy, since the dollar will be devalued against gold, the monetary asset—something that may not play well in Washington. In fact, such a policy may actually be harmful to an already weakened economy.

ARGENTINA IS FLUSH!

From time to time we are told scary stories of than I can recount offhand, although the Mexican economic problem sticks in my mind. There, disaster was immanent, but along came the IMF and the World Bank, and now everything is just fine. Or perhaps perfectly miserable, but either way, our attention is taken from Mexico by the news from Argentina. It's bad!

Argentina owes \$141 billion and can't pay it. The IMF pumped \$8 billion into the country last August and that 'restored confidence" for a millisecond or two. But tax revenues have fallen 14 percent from last year, which wasn't a good year either. In fact, Argentina's economy has been in a slump for more than three years. And Argentina is Latin America's third largest economy. If Argentina tumbles, can the rest of Latin America be far behind?

The country's economists are concerned about a possible run on the banks, which would present the single biggest danger to the central bank's liquidity. In that case, according to cabinet chief Chrystian Colombo, Argentina might be willing to adopt the U.S. dollar, as Ecuador has recently done. At present, Argentina is operating under a "convertibility plan", by which it keeps a reserve of dollars to match every peso in circulation, maintaining the peso on par with the dollar. In practice, pesos find little use in the economy, with 85 percent of private and corporate debt denominated in dollars. With the world economy faltering after September 11, the chances of a quick Argentine recovery seem dim indeed.

Well, not to worry! It's all a misunderstanding. In actuality, Argentina is doing just fine. Not being an economist, I do not make this cheery statement on my own authority—but on our own nation's monetary authority, the Federal Reserve. In the Chicago Fed's publication Two Faces of Debt we discover that situations like Argentina's are hardly cause for alarm. "Debts are assets," we read on page 5. "While debt is a claim on the assets and earnings of those in debt, it is also part of the assets of their creditors." In other words, that \$132 billion in debt held by Argentina's creditors is an asset-worth \$132 billion! Of course, the holders of that \$132 billion could, at least in theory, claim Argentine assets worth \$132 billion, but it works both ways. We read further, "For example, such a debt as a savings bond, a DEPOSIT ACCOUNT, or a corporate bond is as much an asset to its owner as a stock certificate or title to real estate." (Emphasis added) Government bonds, and checking accounts, are debts/ assets. I assume that the loans to Argentina were in the form of deposit accounts, or debts/assets. In return, the creditors received Argentine bonds, or debts/assets. The "loans", therefore, were in the form of IOU swaps. We read, on page 4, "Technically, however, Federal Reserve notes are liabilities of the U.S. government." Whether Argentina received bushels of Federal Reserve Notes-or a few checks with very large numbers-it still received debt instruments. But wait—"Currency is so widely accepted as a medium of exchange that most people do not think of it as debt." Money is debt! Argentina has scads and scads of debt! Moreover, whether in the form of cash loans or deposit account loans, that debt is money. Argentina, in other words, paid for its \$132 billion loan with \$132 billion worth of government bonds. Where is the debt? American debt (i.e., money) was swapped for Argentina debt (i.e., money). Who owes what to whom?

True, the holders of Argentina's bonds may

should have foreseen it when accepting them as payment for their loans of dollars. Moreover, all of the many Goldbugs feel about the gold mining industry. dollars in Argentina's pockets or bank accounts are debts of the U.S. government, or U.S. banks. Are U.S. banks, or the U.S. government, liable for anything with regard to their debts? Of course not. No, certainly not. And even a child knows that a private person or corporation does not have to sell goods or services for Argentine pesos if he doesn't want to. If Argentina had borrowed gold, or silver, or pork bellies, or wheat, the holders of its notes would expect payment in kind, or in something of equal value. But that isn't the case. Argentina borrowed debt, or credit, or money (or inflation?). The borrower received Argentina's notes, which are, as we have been told by the Fed, money, or credit (or inflation?). It's all over, IMF. You swapped your promise (never to be paid, and created out of thin air) for an imaginary mess of pottage, for a similar promise (never to be paid, and created out of thin air) for an imaginary batch of gazpacho. Live with it! That's the way modern money works. It demands everything-and delivers nothing. Freedom and fiat, we repeat, are incompatible! — pahein@email.com

Is the price of gold being manipulated?

As ridiculous as this story sounds this is how that the Allies had broken the German Navy's secret code. They thought this because of the eerie way in which, when they surfaced to radio their position home, warplanes promptly arrived to drop depth charges on them. But the High Command dismissed the idea as crazy. Just a little more lateral thinking might have brought them to the truth: The Allies had in fact been reading all Axis codes since the beginning of the war.

> Goldbugs, notoriously obsessive, have been muttering this for some time as the price of the metal has fallen to inflation-adjusted levels not seen since 1971. Similarly, Reginald Howe, the of investment proprietor the Website Goldensextant.com and a lawyer, is suing the Bank for International Settlements (BIS), as well as Alan Greenspan, the chairman of the U.S. Federal Reserve, and financial institutions for colluding to suppress the price of gold.

> Hathaway says that what got his attention was trading action at New York's COMEX on June 27. Gold had been rising on the growing perception that the authorities were panicking in the face of gathering recession. Suddenly, a massive unidentified seller broke the gold rally. A few minutes later the Fed announced one in its series of cuts in the interest rate, which normally would have sent gold soaring. But in the thin gold market, Hathaway explains, carefully timed interventions can have long-lasting reverberations. Gold continued to slump.
