They promised lower fuel prices with Petron's privatization but instead prices have run out of control; Fort Bonifacio's proceeds were intended for the Armed Forces of the Philippines' modernization, now it is nowhere to be found; the NSC was mothballed after it was sold to Malaysians; they promised lower water rates from the MWSS privatization; now water rates will be hiked by 100 percent to 500 percent. They promised lowered power rates after the NAPOCOR privatization, but they have now doubled the power rates.

Investors' Greed And Ignorance: Decimation Of Paper "Fortunes"

IMPENDING GOLD FUTURES DEFAULT

The coming default on gold futures contracts by the short sellers and large bullion banks will surprise many (because they don't know what it is and therefore cannot anticipate it) and will most likely act to catapult gold prices into 4, 5, or even 6 figures per ounce.

I have written this article for several audiences. First, for those people new to the gold market, who might be thinking about getting into gold somehow, but are not sure what to buy. Second, I'm writing to those already in the gold market, so that they know what's coming—and so that they don't sell out too soon.

Third, I'm writing for seasoned gold investors and/ or a few very wealthy individuals who believe that gold futures contracts represent a sound investment vehicle. There are about 90 of these wealthy people according to Andy Smith, who was quoted in Thom Calandra's CBS Marketwatch report of May 24th, as saying, "Large-account speculators who are "long" gold futures on the COMEX in New York have surpassed 90 in number." (Up from 77) These 90 people, or funds, or entities, desperately need to get this article into their hands. I don't know who they are, nor do I know how to contact them, but I hope that the publication of this article at gold-eagle.com will help to reach them. Readers, if you know anybody who might be one of these 90 large-account speculators, or if you know anybody who might know somebody who might be one of these 90, please forward this article to them.

If these wealthy people are convinced, and stop playing paper games, and start buying gold bullion instead, the price will really take off, and will cause the default on the futures contracts to happen that much sooner. But if they are not convinced, it won't matter much to the world, because at this point we don't have that long to wait until the default. Yes, even big elephants succumb to the forces of Nature and can die during droughts just like any other animal—and the current market forces that are draining away the last bit of liquid (gold) will not be denied.

By default, I mean that promises to pay in gold will be broken. Don't start arguing with me yet, because I'm not implying that we are on a gold standard, and I'm not implying that the U.S. dollar is backed by gold, and I'm not saying that the government will default. Not exactly, but that's because the story is a bit complicated.

In 1933 the default was on the gold contract known as the U.S. dollar held by American citizens. The default in 1971 was the default on the gold contract known as the U.S. dollar held by foreigners. Each event was The coming gold default will be on gold futures contracts which are issued by various private and quasi-governmental entities such as the private banks who are the shareholders of the Federal Reserve.

Some readers will stop me right there, thinking to themselves, "Don't fight the Fed." In other words, if the Fed is on the short side of the gold market, then don't take the opposite side. Here's a better rule, "Don't fight the market."

The market is bigger and stronger than the Fed.

The point I am making in this article is that investors should avoid buying a gold futures contract, and avoid buying gold call options, because these investment vehicles are paper promises that are prone to default. That's a fact. My opinion is that default on these contracts is both inevitable and increasingly *imminent*. I believe that those gold industry watchers who have access to key information are saying that when gold crosses \$354/oz., that most of those who have written the bulk of the gold contracts of today will be severely hurt financially. Thus, perhaps a default may happen if it is feared that this price level will be surpassed, or soon thereafter.

Gold futures contracts are speculative side bets on the dollar price movements of gold; they are not legitimate investment options, because nothing is purchased but somebody's vain promise to deliver gold, and most of these contracts are settled in dollars. And if an entity who writes the futures contract does not have the ability or intention of paying gold under the conditions that would be most favorable to the speculator (say for example when the gold price per ounce really takes off) then what is that speculator really getting for his money? Buying insurance does no good if the insurance company goes bankrupt. The main reason for investing in gold is to shield one's wealth from the dangers of default by another. Therefore, the benefits of owning gold are simply not there for the owner of a gold futures contract, which can be defaulted on.

Additionally, speculators who buy gold futures contracts or options are hoping to use varying degrees of leverage. Only a fool would think he could beat the banks at their own game, borrowing money from the bank, to speculate in a paper-instrument-derivative creation of that bank, that, if it appreciates in value, would cause that bank's downfall.

Options and futures contracts are speculative investment creations, derivatives. I believe they are created specifically to separate a man from his money. They are mere gambling devices designed to siphon off capital that would otherwise be employed in direct investment opportunities.

Investment demand for gold, that normally would flow into gold and push the price of gold up, is instead diverted into paper contracts of limited time duration that can expire worthless if price manipulations are successful, and can be defaulted on if not.

One of the most controversial documents in the world, known as The Protocols of the Learned Elders of Zion, was written over 100 years ago. Although it is often disregarded by critics as a forgery [MM: Proof that an "original" legitimately exists.] designed only followed by an explosion in the price of gold. to stir up racial hatred, it reveals the purpose of speculative investments in Protocol #6:

> "At the same time we must intensively patronize trade and industry, but, first and foremost, speculation, the part played by which is to provide a counterpoise to industry: The absence of speculative industry will multiply capital in private hands and will serve to restore agriculture by freeing the land from indebtedness to the land banks.

land both labor and capital and by means of speculation transfer into our hands all the money of the world, and thereby throw all the [world] into the ranks of the proletariat. Then the [world] will bow down before us, if for no other reason but to get the right to exist."

Personally, I don't think it's any secret who these families are who intend to rule the world-and I don't see how the fulfillment of biblical prophecy is anything to worry about.

Deuteronomy 15:6: "For the LORD thy God blesseth thee, as he promised thee: and thou shalt lend unto many nations, but thou shalt not borrow; and thou shalt reign over many nations, but they shall not reign over thee."

Deuteronomy 28:12: "The LORD shall open unto thee his good treasure, the heaven to give the rain unto thy land in his season, and to bless all the work of thine hand: and thou shalt lend unto many nations, and thou shalt not borrow."

It is rather obvious to me that bankers who lend to the nations rule over those nations, and that they siphon off money (gold) from the world and maintain their rule through the processes of lending money at interest, and by creating paper dollars and other gold derivatives.

If gold futures contracts are so bad, how in the world are investors fooled into buying them in the first place? Greed is the main reason, because these derivatives promise leverage, and promise a much greater return on investment—note that tricky word "promise". I believe futures contracts are designed mostly to fool those with the largest pockets, because today, most of the small investors have already been swindled out of their gold. It is said that less than 1 in 1,000 or even 2,000 investors hold any gold-related investments today. If the paper dollar was designed to plunder the common man with a few ounces of gold, the gold futures contract was designed to plunder the wealthy man with millions of dollars.

On occasion, I have had the opportunity to discuss, at length, the issues of investing in gold with very wealthy people, so I know a few of their concerns, and why they tend to think of gold futures contracts as a viable investment alternative to buying physical metal.

Buying gold in hand gets to be a risky and difficult proposition for people with more than a million dollars to invest. (\$1,000,000 / \$320/oz. = 3,125 oz. = 195 lbs.). This is particularly troublesome for the wealthy, because they are among the older generation. Some would not feel comfortable with too much physical wealth in their home. Not even with a safe or panic room. Many of those who could invest might not be physically capable of loading up 200 pounds of gold in the family car. What if you had \$10 million to invest, or \$100 million to protect against dollar devaluation? Could you find a car that could carry a ton, or ten tons? There is a community of thousands of people who all have this much wealth to protect or more. If you couldn't carry or load that much, could you trust the hired help to keep their mouths shut about what they are lifting? Oh, the problems of the truly wealthy. If you don't want to store that much gold near where you sleep, then there is the problem of storage fees. The bankers will want to charge 1% each year. One cannot think about saving wealth for time periods lasting generations under such conditions.

Just for fun, let's consider what would happen to the gold market if one man, Bill Gates, wised up, and decided that Microsoft would be better off to keep its \$38.7 billion in appreciating gold instead of devaluing U.S. currency. At \$320/oz., that would be almost 121 million troy ounces, or 4146 tons. Why does Bill Gates trust bankers and the Federal Reserve with the value of his savings? Bill should have started his What we want is that industry should drain off from the gold buying program long ago, because he probably

default. For a guy who claims to have a company built on intellectual capital, what does that say?

The truly wealthy, for the most part, feel as if they are forced to trust the banks and/or investment institutions already. After all, they are not protected by the mere \$100,000 of FDIC insurance per account.

These extremely wealthy individuals and institutions are even presented with the so-called opportunity of writing (selling) their own gold futures contracts. In theory, if they sell a gold futures contract, they don't even have to have the gold on hand to sell, but only enough cash to buy the gold in a margin account, plus a comfortable cushion of perhaps 50%. This means that if a very wealthy lay person wants to short 100 oz. of gold, he needs to have the money to be able to buy perhaps 200 oz.—thus having enough capital on hand to fulfill the contract even if gold were to double in price. Because of this so-called standard business practice, they may be fooled into thinking that gold contracts are relatively default proof. How so? Because they might assume that all who sell a gold contract must have more than enough money on hand to be able to buy the gold that the contract calls for. But this is NOT a standard practice—and the rules are not the same for all entities who would write a gold contract. The large quasigovernmental investment houses tend to make up and change the rules as they go along, so who will guarantee that they have the ability to come up with the gold that they, or their subsidiaries, or patsies, have promised?

The objective of the original gold contract, the paper dollar, was to separate a man from his gold, and it worked exactly as intended. As long as the "open interest" in the gold futures contracts goes up as the price of gold goes up, it appears as if this new gold contract is continuing to do the job for which it was designed; that is to say, it siphons investor demand away from gold—and into paper promises that are more easily created than fulfilled.

We also have to remember that the "open interest" in the gold futures market is not the total amount of gold promised. The vast majority of gold contracts are not on any books that are open to inspection by anyone, so there is no ability of anyone to truly judge when or at what price the next gold default might occur. In the past two gold defaults, the default came early, well before the price rose to any significant extent. The defaults occurred only when it became apparent that more and more gold was being demanded by the holders of the paper contracts. Again, the default came well before the ultimate issuers ran out of gold.

Unlike many other gold market writers, I don't believe we need any market transparency or increased regulation of gold market contracts. I'm perfectly content with letting private traders create private contracts, and do business in private, without government interference. It's called freedom—and it's what gold represents. Freedom is good.

If people want to buy promises, they should be free to do so.

If the gold bulls want to take on the forces who are keeping the gold price down, the last thing they should do is trust the enemy and buy their promises and gold contracts. They need to take on their enemy by buying gold in the spot market, not by buying futures contracts. Let others buy the futures contracts and attempt to stand for delivery.

The gold contract (dollar) defaults of the 1930s and 70s were preceded by bank runs; when people in the 30s, and then nations in the 70s, demanded gold for their

in line, because those at the end of the line simply do not get paid. The coming rush into gold will be like another bank run that precedes the next gold contract default. Waiting for the delivery date of a gold futures contract that is two months away would be as foolish as standing in the line that's two months long during a bank run that you are betting on will occur. Why put yourself at the end of the line of a hoped-for bank run, when you can get in front of the line by buying gold in the spot market? Literally, that's what gold-futures-contract longs do. They bet a bank run will happen, and then they get at the very end of the line. And if and when the time and opportunity comes that they get near the bank window and they might be next, they jump right to the end of the line again as they roll over their contracts. I believe it's total insanity to do such a thing. But investors get what they deserve, don't they? [MM: Greed kills!]

We have already been given a preview of a modernday, precious-metals-futures contract default. Most gold bugs remember the TOCOM default in platinum in 2000. All longs were forced to settle for cash. I assume that since there was not enough of a major outcry from investors around the world, that a similar method of default will happen with gold contracts; namely, a cash settlement, with perhaps a quick resumption of new gold contracts being issued.

Those games worked in platinum where there was relatively little investment demand and an actual supply crunch. But will those games work to stem the tide of massive investor demand in the face of declining currencies?

Clearly there is danger in making promises that cannot be kept, but that's the entire game the bankers play with their practice of fractional-reserve lending. In other words, don't assume that they will play it safe and not take undue risks and avoid making promises they can't keep; that's their standard method of operation. So, in a sense, gold futures contracts are nothing new; but they are new—they originated as a plan to cap the runaway gold price of the early 1980s, and they succeeded.

The only way we will experience a true gold bull market—and a truly free gold market—is if these gold contracts of our modern era fail and, inevitably, they will.

In order to understand what will happen in the next gold bull market, we need to understand what happened in the last one. It makes sense only in a superficial manner to look at the last high of \$850/oz. and adjust for inflation (either the money creation type of inflation which would give us a new high of a \$6,000/oz. gold price, or the consumer price increase type of inflation which could give us a new high of a \$1,700/oz gold price), because the high of \$850/oz. was artificial and unnatural—it was lower than it should have been!

Many gold bulls of 1980 strongly believed gold would soon be worth many thousands of dollars. I believe the price of gold would have reached those much higher prices if it were not for the introduction to that market of gold futures contracts, which siphoned investor demand away from real, tangible, physical gold. Perhaps a lack of moral conviction—and greed for a gain as measured by the unjust weight and measure of the dollar-killed the gold rally of 1980.

The price of gold rose both in the 30s and 70s because of inflation, the fraudulent paper-printing, money-creation kind of inflation. If that inflation were fully reckoned with, the gold price should have risen to a level where the total amount of fraudulent dollars that had been issued would be equal in value to the gold held by their issuing authority. This never happened. If it did, gold would have been worth about \$5,000/oz. back

could not even buy 300 tons before the next gold paper dollars. In a bank run, you want to be the first in 1980—based on the number of dollars that had been fraudulently created by that time. Therefore, in that sense, what happened in the 30s and 70s was not yet a complete and full gold contract default—but merely a series of minor gold bank runs in comparison to what we may now be facing. Today, since more dollars have been created since 1980, gold may well rise to \$35,000/ oz.—and that's if not even one more dollar is printed or created on a computerized ledger somewhere.

But we have to remember that every dollar in existence is a potential claim on gold, because every holder of a dollar has the option to go and buy some gold with his money. Investment demand (monetary demand) is potentially infinite, and not limited to the number of dollars in existence, nor even to the number of yen in existence. Investment demand is limited only by men's greed and desire—and those levels are infinite. As we all know, if the value of paper money goes to zero, as it must someday do, then the dollar price of an ounce of gold reaches to infinity.

The last remaining factors holding back the meteoric rise in the price of gold are fear and **ignorance**. Fear of holding physical wealth personally on hand—and the ignorance of thinking that one's wealth is safe in the hands of people who have proven themselves to be crooks. Hopefully this article has helped to dispel some ignorance. Fear is overcome by bravery and faith in knowing your knowledge is correct—and bravery and knowledge both lead to freedom and wealth.

I can't conclude an article without writing something brief about silver. Everything that I've written about gold also applies to silver-but silver has more favorable supply-and-demand dynamics for the investor. In the silver market, the same schemes are being played out, but in different relative amounts. The silver market is tiny in comparison. The silver market could explode upward even without a dollar devaluation. And the silver futures market is massive in comparison. In other words, the physical price of silver is more highly influenced by the paper futures markets, which are also prone to default. With silver, nobody knows how large private hoards might be. With silver, existing known reserves are much smaller than gold. We have about 3,500 million ounces of gold in the world, and only 100 million ounces of "known & official" silver. You can buy a \$1,000 face-value bag of 90% silver coins for about \$3,500 today. For most of human history, a bit of silver the size of a silver quarter was worth about a day's wage. In the early 1980s—when silver hit \$30-50/oz.—you could buy a nice house in California for a \$1,000 face-value bag of 90% silver coins.

Silver has an ongoing supply-and-demand gap that has run 12 years, and drawn down the known silver available at the COMEX from about 1,500 million ounces to 100 million over that time. ...

At that time, the British did not shrink from sacrificing millions of its youth in a war set up to make profits for the bankers. The first suspected use of bacteriological weapons took place at the close of that terrible war. It happened in the following manner: After four years of stalemate with neither side gaining the ascendency, the Germans finally broke through the French lines and were less than 37 miles from Paris when SUDDENLY disaster struck them. Practically the entire front-line German units went down instantly with what is now known as Type A Influenza. This was in April of 1918.

Far from the Germans being defeated as General German army was actually on the offensive in their march on Paris. The Germans were briefly checked by the green and untried American forces. The Americans laid down an artillery barrage. Now surely there was nothing new in that, but at this point the events went into underground secrecy. The entire army of Germans was simultaneously smitten with virulent influenza. Prior to the American artillery barrage, there were no cases of influenza amongst the German troops. Suddenly, as if a cloud burst over them, the Germans went down with such virile flu that it laid low the entire Division. In some sectors along the front, Companies were down to as little as ten men. So violent was this epidemic that the British and Americans, for the very first time, were able to break through the German lines. That proved to be the turning point of the war. Thereafter, the Germans rapidly retreated and virtually gave up the fight.

Bacteriological experts in England, Germany and Switzerland believe that the Americans brought with them shells containing the influenza virus which were then unleashed on the Germans. This was the only "credible" explanation for the sudden and instantly deadly outbreak of what was later known as The Spanish Flu epidemic—which first raged through the German lines and later marched right across the world, killing millions of people. In fact, more people died from the influenza than died in the actual war.

It is to avoid what is known as an "outburst" of this kind that the Council on Foreign Relations/Club of Rome biologists are working on right now. The Global Plan 2000 provisions cannot be implemented if it means that the indiscriminate spread of an epidemic, that will not be a respector of persons, cannot be contained in some way.

> No one knows for sure where the influenza virus originated but the first-known cases occurred in 1580 in Asia—and there were sporadic appearances of the disease until 1890. Even in the non-epidemic outbreaks of influenza, more people died from the flu than have from any known nuclear-related causes. Note we do qualify by the word "known". Where are all the Peace Demonstrators against the flu? The firstknown, induced epidemic began on the battlefield at the close of the First World War. It was utilized directly as a chemical/bacteriological weapon.

WHAT OF CHEMICALS?

The tide of gas washed over the struggling men and their faces turned blue from the strain of trying to breathe; some coughed so violently they ruptured their lungs. Each man, as the British casualty report was later to put it, was "being drowned in his own exudation". That one attack could have cost the war, but the German soldiers dug in.

This little game was called "Falkenhayn's experiment", for the German commander, Falkenhayn, was as startled as were his opponents by the overwhelming effect. It had cost the Allies 5,000 men dead and 10,000 wounded.

Thirty-six hours later, while the British and French still struggled to fill the breach, the Germans struck again. Wave after wave of gas flowed over the Allied troops and soon the gas was accompanied by Germans wearing strange masks with glass eyes and large hoods.

Weinstein has done a brilliant publication on that pandemic. His work is in the British Museum in London.

> He stated, "The influenza pandemic occurred in three waves starting in the spring of 1917/1918. It was characterized by a high attack rate and 50 percent of the world's population was affected. An even more lethal wave began in Scotland and then in Massachusetts on September 12, 1918. It spread over the world in a very short time. Epidemiological behavior was most unusual. Although person-to-person spread occurred in local areas, the disease appeared on the same day in widely separated parts of the world, on one hand, but on the other took weeks to spread relatively short distances. It was detected in Boston and Bombay, India on the same day but took three weeks before it reached New York City despite the fact that there was considerable travel between the two cities. It was present for the first time in Joliet in the State of Illinois four weeks after it was detected in Chicago only 38 miles away. Death rates in various cities in America from respiratory diseases during the second wave show that the Joliet-Chicago incidence was not unusual. Pittsburgh and Toledo with almost identical death rates in normal times, and with similar population groups, and similar occupations, showed a remarkable difference. The death rate in Pittsburgh exceeding that of Toledo by 400 percent."

> This next also comes from Dr. Weinstein. In 1948 there was another outbreak of influenza and studies were made by Dr. F. Magressi which show that it started among shepherds in Sardenia in isolated areas. Dr. Magressi said, "We were able to verify the appearance of influenza in shepherds who were living, for a long time, alone—in solitary, open country and far from inhabited centers. This appeared absolutely contemporaneously with appearance of influenza in the nearest inhabited cities." Magressi says that the speed in the spreading of the disease was inconsistent with any possible person-to-person transmission.

ELITIST HANDS IN THE COOKIE JAR

In this writer's February 27th article this year, "Enronitis—A Communicable Disease" the following statement was made. "If the Enron practices are as widespread in other companies, as some believe, we may be seeing a domino effect with Enron and Global Crossing only the beginning."

At that time, only Enron and Global Crossing, along with their mutual auditor/consultant Arthur Andersen, were under the microscope of public and Security and Exchange Commission (SEC)) scrutiny. At this writing there are at least thirty (and counting) companies that have admitted "accounting irregularities" and/or which are the subject of formal investigations by the SEC.

These disclosures should by no means be considered "voluntary mea culpas". The Federal Energy Regulatory Commission (FERC) along with the SEC seem to have awakened from a decades-long slumber and are giving the perception of vigorously pursuing accounting irregularities and other questionable corporate practices. The FERC compiled a list of suspect practices gleaned from testimony by Arthur Anderson and Enron officials and sent out a questionnaire to 150 energy companies. The companies were required to answer, under penalty of perjury, whether or not they were engaging in any of those practices. Ergo, a flood of disclosures.

Wall Street analysts estimate that over one trillion dollars in the value of those companies' stocks has vanished and that doesn't count the billions (perhaps hundreds of billions) of dollars in bonds for which an accounting is yet to be made. Enron has notified the SEC that it may have overstated its assets last year by as much as \$24 billion and that its financial statements as far back as 1997 are not reliable. The company did not even attempt to file the required reports for the quarter ended in March.

The "problems" are not limited to energy producing and trading companies. Implicated in the scandals are retailers like K-Mart (a FBI criminal investigation), security analysts, brokerage houses, insurance companies, auditors and consultants, large investment banks and even bond rating services. Banks like CitiGroup, Credit Suisse, First Boston and J. P. Morgan Chase find themselves victims of their own greed in participating in the scams as well as targets of lawsuits and investigations by hapless investors and regulatory agencies. It almost seems like a game of musical chairs where there were not enough chairs when the Ponzi schemes collapsed. Companies like Enron and Global Crossing, although in bankruptcy, ended up with most of the money for which an accounting has not yet been made.

The maze of sham transactions has set insiders against each other in a scramble to cut losses and point fingers. We are treated to the spectacle of a subsidiary of the Rockefeller-controlled CitiGroup (Travelers' Insurance) suing its own parent company for losses on transactions it insured between CitiGroup and Enron. CitiGroup is refusing to pay, claiming it was misled.

Along with the regulatory agencies, corporate boards of directors seem to have been asleep at the switch. Some very powerful and well-connected directors are now claiming they were misled by company executives and/or auditing firms. Many are members of the premiere U.S. organization pushing world government, the

Council on Foreign Relations (CFR). Others are associated with one of the CFR's many spin-offs or organizations controlled by CFR members i.e. The Trilateral Commission (TLC) and the Business Roundtable.

Boards of directors are not necessarily controlled by their chairmen. If the chairman himself does not fill the role, we usually find on the board someone from an investment bank or a high-powered law firm. What counts is who controls or influences the voting stock of the company.

So let's take a brief tour of some of those powerful men (and women) on boards of companies who were so easily "misled". We shall start and end with Enron. Enron's (former) Chairman and CEO, Ken Lay, was a close associate of both Bill Clinton and the George Bushes. He is a member of Rockefeller's Trilateral Commission.

Wendy Gramm is a member of the audit committee of Enron's board. Just prior she was a Reagan appointee as chairman of the Commodity Futures Trading Commission, the powerful regulatory agency which oversees the nation's commodities and futures exchanges. Her husband is Senator Phil Gramm who sponsored legislation providing partial protection of professional firms like Arthur Andersen from class action suits. Gramm has decided not to run for reelection.

In our neighbor to the north a large bank got caught with huge losses when the Enron music stopped. The Canadian Imperial Bank of Commerce (CIBC) has on its board Lord (Conrad M.) Black. An unabashed globalist, Black on his official biography lists memberships in the Council on Foreign Relations and the Bilderbergers (evidently that's what they call themselves).

Canada's largest energy company EnCana, which engaged in sham "round trip" transactions with Reliant Energy lists on its board T. Don Macy. Macy is the former Chairman and President of Amoco Eurasia Petroleum Co. In 1996 he signed an oil development deal with the Azerbaijan government joining a consortium for exploitation of Caspian Sea oil. Amoco and Unocal control 55.5% of the consortium.

Returning to the U.S., Rockefeller-controlled CitiGroup (including subsidiaries CitiBank and Traveler's Insurance) is a major player in the Enron scandal. Director Robert Rubin (CFR) is chairman of the firm's executive committee that runs the group between annual board meetings. Rubin is the former U.S. Secretary of Treasury and a former CEO of Goldman Sachs.

CitiGroup director C. Michael Armstrong (CFR) is chairman and CEO of AT&T Corporation. He is the former chairman and CEO of Hughes Electronics. During his tenure there, Hughes and Loral illegally furnished classified rocket technology to the Communist Chinese government.

Another CitiGroup director is John M. Deutch (CFR), former head of the CIA. Deutch resigned his CIA position after he was caught with unauthorized classified information on his laptop computer. He is also a director on the board of CMS Energy, which has admitted to sham transactions with several other energy companies.

CitiBank was caught laundering hundreds of millions of dollars in cocaine money through the private account of the brother of the Mexican president. The only consequence was the resignation of a vice president.

The Security and Exchange Commission (SEC) played a large role in enabling the Enron scams. Arthur Levitt, the New York Democrat fund-raiser was appointed chairman of the commission by Bill Clinton. During his tenure, the SEC

Although Levitt claims he can't recall the exemptions, a former SEC regulator told Insight Magazine Levitt was involved in the decision. Experts say the exemptions allowed Enron to set up its sham offshore partnerships that played such a large role in the meltdown. Levitt is now a senior analyst for the Carlyle Group.

A book could (and probably should) be written about corporate governance through former government officials and titans of industry on corporate boards, of which most are committed globalists. Space considerations have only permitted a brief sampling of the phenomenon here.

No list would be complete without examining the connections of Herbert S. (Pug) Winokur, not exactly a household name. Winokur was chairman of the Enron finance committee. He is a former chairman and CEO of Dyncorp and currently chairs its compensation committee.

Catherine Austin Fitts has authored a devastating expose of Winokur and his influence. Fitts is a former managing director of the Wall Street firm Dillon, Reed & Co., a former assistant secretary of HUD and president of the (some of it paraphrased) is from her exposé titled, "Damage Control at Dyncorp—Harm at Harvard".

Harvard Corporation and Harvard Management Company. His investment firm, Capricorn Holdings, is a lead investor in Dyncorp.

Winokur claims he and other Enron directors were misled by Arthur Andersen and Enron management and it legal counsel as to the true nature of its financial structure. Yet Highfields Capital which manages a large portion of Harvard's \$19 billion endowment, reaped a quick profit of somewhere between \$50-120 million through short sales (puts) of Enron stock. WHY THE DOLLAR WILL DIVE AND WHAT THAT WILL COST US

More than two years ago, economist Dean Baker wrote a paper about the "double bubble" in the United States. One bubble was stock-market prices. That one has burst.

> The reason is the nation's huge deficit in its current account—its international payments balance. The red ink was \$430 billion last year, or almost \$1.2 billion per day. That's 4.3 percent of gross domestic product (GDP), the nation's total output of goods and services. Without any change, the trade deficit will soar to \$800 billion, or 7 percent of GDP, by 2006, notes C. Fred Bergsten, director of the Institute of International Economics in Washington.

> So when an American spends a dollar, foreigners will provide 7 cents worth of the goods and services in excess of what Americans would otherwise have earned from selling their goods abroad. Up to now, foreigners have been glad to do that. The extra dollars they earn have been invested in U.S. Treasury securities, stocks, bonds, firms, or properties that have offered good returns. Foreigners, in effect, finance the massive U.S. trade deficit.

> But the size of the deficit is now reaching the "danger zone" where the U.S. and other industrial countries have traditionally seen their currencies dive, making exports easier and imports less competitive, Mr. Bergsten maintains.

"It's a cascading matter," Baker says. Foreigners falling under the avalanche of the scandals and the not only acquire extra dollars through their trade surplus with the U.S.; they earn more interest and dividends on their U.S. investments.

Baker thinks Americans should be allowed to hedge currency tumbles, trips abroad and imported goods against a plunge in the dollar by opening checking accounts in the U.S. denominated in Japanese yen, euros, or pounds. Europeans can open dollar accounts.

> But at election time, a strong dollar sounds better than a weaker dollar. So don't count on the Bush administration changing its dollar policy any time soon.

> [JR: The only reason the dollar has sustained its strength this long is because the U.S. government (et al.) props it up by suppressing the price of gold. Also, the U.S. government, along with the Federal Reserve has convinced most foreign central banks to use the almighty U.S. dollar as their national reserves to back their own fiat currencies. This trend however is changing as several countries have already shifted to the Euro or to gold as a reserve for their currencies. Fiat currencies are beginning to become unstable as people are losing confidence in the inflated values of all fiat currencies, even the U.S. dollar. What do you think happened to Argentina? The U.S. dollar is already on a slippery slope and everyone, especially foreigners, are now looking for an alternative to the sliding U.S. dollar. To me the only solid alternative to any fiat currency is personal investments in physical gold, which has increased 20% in just the last year, closing at \$322.50 an ounce on 05/23.02. What other investment in today's market is doing that well? Some investor "goldbugs" are projecting gold to more than triple in value in the next few years.]

SHARON BEATS BACK **ULTRA-ORTHODOX CHALLENGE**

Upon hearing of their rejection, Sharon fired the party's members in his Cabinet, reducing his coalition's hold on government to a one-vote majority. Wednesday, he ignored the Shas bloc before the Knesset vote and later indicated that victory had not softened his resolve to oust the renegade coalition members.

Sharon's dismissal remained in effect late Wednesday despite back-door appeals from Shas to remain a coalition partner, media reported. Sharon already was talking to other suitors, reports said.

The showdown with Shas makes Sharon the first prime minister to stare down the ultra-right and survive.

It came 10 days after Sharon rebuffed his own political party leadership over a vote to reject the idea of a Palestinian state. Sharon opposed the vote; he lost within the Likud's central committee but turned the loss to his advantage by portraying himself as more concerned about the country's image and negotiating integrity rather than his personal popularity among the hard-line voter bloc.

The back-to-back challenges to Sharon and the perception that he deftly muscled them generated acclaim and something much more rare in Israeli political circles: respect.

'Sharon didn't blink. No prime minister has done that before," said Jonathan Rosenblum, director of an Orthodox media group in Israel and a columnist for the Jerusalem Post. "He's going to get maximum mileage out of this. He has strengthened himself, in internal political circles, and to the outside world."

Sharon, a former general, reaped widespread public support in the past two months as he pursued a military solution to terrorist attacks by Palestinian militants. Shas, which appeals to a religious constituency that largely eschews military service, angered the Israeli public with demands to maintain welfare privileges despite budget shortfalls.

Wednesday morning, an opinion poll by the newspaper Yedioth Ahronoth indicated that 70 percent of Israelis thought Sharon was right to dismiss the Shas ministers.

"He's showing when it comes to fighting, he knows how to fight," said Efraim Inbar, a political science professor at Bar-Ilan University. "He's patient. And he's become an astute politician."

The scene at the Knesset was a reflection of the political reality. Sharon sat confidently in the center of the chamber during the roll call while Shas members stood nervously at the entrance to avoid casting their ballots.

Meanwhile, Finance Minister Silvan Shalom loudly appealed for passage of the bill that he said was necessary for economic survival.

"If this government does not take these hard and painful steps now, we will have to take harder ones in the future," Shalom said prior to the vote.

The budget cuts passed, 65-26, without the ultra-Orthodox casting a vote. The secular Shinui Party also abstained, accounting for seven votes.

"For the first time, a prime minister has stood up to the blackmail of the Haredim," the ultra-Orthodox, said Shinui leader Tommy Lapid, who approached Sharon minutes before the vote for a private chat. Lapid, using Sharon's nickname, said his party had held back from voting against the budget cuts to "give a sign that we appreciate Arik Sharon's bravery."

'HIGH PROBABILITY' OF SUICIDE BOMB ATTACKS IN U.S., **ISRAELI EXPERTS SAY**

JERUSALEM—Israeli experts concurred on Tuesday with American assessments that it is only a matter of time before the U.S. will experience suicide bomb attacks like those in the Middle East.

FBI Director Robert Mueller told the National Association of District Attorneys on Monday that the prospect of suicide bombers hitting the U.S. was "inevitable".

"There will be another terrorist attack. We will not be able to stop it. It's something we all live with," Mueller said.

A day earlier Vice President Dick Cheney said the possibility of future attacks was "almost certain... not a matter of if, but when."

Israel has led the war against terrorism since it became a nation more than 50 years ago. Israeli experts were equally as confident on Tuesday about the probability of future attacks in the U.S.

Boaz Ganor, director of the International Policy Institute on Counter-terrorism near Tel Aviv, said he would prefer not to use the word "inevitable", but he believes there is a "high probability, possibility" that Islamic radicals will target Western societies.

The terrorists will use "suicide bombing as a more effective method," Ganor said. The groups that support those actions are bound to have supporters and activists on American soil, he said.

Their primary motive would be revenge for the American campaign in Afghanistan, he said.

U.S. on Sept. 11, when 19 men killed themselves in carrying out attacks on landmarks in New York and Washington, said Prof. Eytan Gilboa of Bar-Ilan University in Tel Aviv.

It stands to reason that if American officials are predicting more attacks, they will occur in a similar way, said Gilboa, who is currently a visiting professor at Harvard University in Massachusetts.

"Since I've been here, it's my impression that security measures at the airports are pretty good, improved," Gilboa said by telephone. Therefore, terrorists are likely to hit other targets such as malls or subway stations, he added.

Gilboa said the terrorists would likely choose targets where "the damage goes beyond the destruction of a place."

"America is the most consumer-oriented society in the world," Gilboa said. If a mall were struck, "It would close the society for six months... and considerably damage the economy."

According to Gilboa's assessment, security said, is not better equipped to defend itself, but it does have more experience.

Israel has suffered from suicide bombings for years but has been particularly plagued during the last 20 months, in a series of attacks that have killed hundreds of Israelis.

American security officials were invited by Israel's secret service this week to attend a closed conference on anti-terror measures. Israeli officials were very secretive about the conference and would not give any details or interviews about it.

In Bethlehem, Arafat was sent a message that support had eroded. Fatah failed to organize a welcome, and when Arafat visited the once-besieged Church of the Nativity, the crowd was small and lackluster.

One Fatah leader said privately that the Palestinians no longer can survive on the whims of a "one-man show". "We need a political system that can changeand change is crucial right now," he said.

Hamas leaders in Bethlehem and Ramallah also said pressure had reached a breaking point and that Arafat was aware of internal Palestinian demands.

But all were questioning whether militants would be allowed to play any role in forging a new government.

The United Nations health agency called for further clinical research to establish the safety and efficacy of such products, consumed by up to 80 percent of people in developing countries.

> "We hope to strengthen recognition of traditional medicines and their integration into national health systems," Jonathan Quick, director of WHO's essential drugs and medicines policy, told a news briefing.

> "We need to get evidence and information so people can make a choice between different therapies," Quick said.

In 1945, at the founding of the United Nations, "we were just left out," Deer said.

At a host of UN conferences through the 1990s, indigenous peoples voiced their demands to protect the environment, use their languages and preserve their cultural heritage.

In 2000, the UN Economic and Social Council, one of the world body's six primary organs, agreed to create a troops, including 120 military observers. BRITISH SCIENTISTS SQUARE OFF OVER EVOLUTION TEACHING

London (CNSNews.com)—A group of about 30 scientists has written to the British Department of Education, arguing that scientific study into the origins of man should not be limited to Darwin's theory of evolution.

The group—including eminent scientists in biology, physics, geology and chemistry—is calling for active debate in the country's schools.

The scientists were motivated by recent reports that a top British school, the Emmanuel City Technology College, was teaching creationism in biology classes.

But several scientists and academics favoring Darwin's DILI, EAST TIMOR (AP)—A surprise deployment theory wrote letters of complaint to the education department and argued evolution should be the only hypothesis about man's origins taught in schools.

The pro-evolution scientists demanded that the school Foreign Minister Jose Ramos-Horta of East Timor be re-inspected by education officials, despite glowing

The argument then caught the attention of leading politicians. Prime Minister Tony Blair defended the non-denominational Christian school, hailing its results and saying reports that it was promoting creationism were "somewhat exaggerated".

'How to think'

Andrew McIntosh, a professor at the University of Leeds and a spokesman for the group advocating free debate,

"We should not try to teach people what to think, but rather we should teach students how to think," he said by phone from the university. "Rigorous examination of a number of theories of origin needs to be allowed. It would be quite inappropriate to put just one theory over."

McIntosh said Darwin's theory has trouble explaining "molecule-to-man evolution" and that the ultimate origin of life is still a mystery to science.

"To immediately discount the possibility of design is unscientific," he said. "It is not right to exclude alternatives right from the word 'go'. What one should do as a scientist is leave those options open."

"Let there be an open debate in the schools and universities of England," he said.

The National Curriculum—a set of rules setting out what should be taught in all British schools—stipulates that Darwinian evolution should be taught as the dominant scientific theory. But the curriculum also requires that students are shown "how scientific controversies can result from different ways of interpreting empirical data".

HOME-SCHOOLERS FIND INTACT DINOSAUR SKELETON

A dinosaur fossil expedition for home educators has excavated a large, rare, intact allosaurus, a discovery that organizers say helps debunk the theory of evolution.

The fossil measures more than 22 feet in length and 10 feet in height, with a complete skull more than a yard long. Allosauruses are believed to be a close relative of the tyrannosaurus rex, differing from the T-rex primarily in size and cranial capacity.

Under the leadership of Doug Phillips, president of Vision Forum and an adjunct professor of apologetics with the Institute for Creation Research, and Peter DeRosa, a veteran archaeologist and paleontologist with Creation Expeditions, the team of 30 home schoolers spent a week earlier this month hunting for and excavating fossils in a privately owned location in the Skullcreek Basin of northwest Colorado. ...

"Most people do not realize that there is a tremendous paucity of dinosaur bones available to scientists," said Phillips. "Ninety-five percent of all the fossils in the world are marine invertebrates; 95 percent of the remaining 5 percent are plants. The vast majority of the rest of the fossil record are fish and insects. Only a fraction of a percent of the remaining fossil record includes land vertebrates, and those finds usually consist of less than one bone. To find a complete allosaur is simply historic."...

"The evidence strongly points to a relatively recent and catastrophic event similar to that described in the Bible as the flood of Noah's day," he said.

"We found a complete section of vertebrae more than 12 feet in length, which was fully articulated. The dinosaur appears to be in much the same position as he was at the time of his death and burial, which must have been virtually instantaneous, and caused by a catastrophic event. Not only was this fully articulated dinosaur found lying in a bed of leaves and plant debris, but there is wood from trees mixed in among the bones, some of which contains petrified and unpetrified elements in the same piece of wood. If this creature were millions of years old, the evidence would look quite different."

Phillips contends that the discovery of such a valuable dinosaur by creation scientists may well send shockwaves through the scientific community.

"Up to now, a well-funded and insular community of evolutionary theorists have dominated the field of paleontology, directing most of the large dinosaur finds to research and museums committed to interpreting the fossil evidence through the faith-driven assumptions of

the creation model is nothing short of a coup d'etat."...

Last week, DeRosa brought in a fresh team of professional excavators to remove the skull from the ground for preservation. It is not yet known when the skull will be available for viewing.

Added DeRosa, "The story behind the location of this site is perhaps the greatest miracle. Through a series of remarkable events, more than 120 acres fell into the hands of the current owners, a Christian homeschooling couple committed to biblical creationism."

The owners have been approached by museums, television networks and leading evolutionists who have expressed a strong interest in the fossils found on the property.

"I am sure the evolutionists would love to get their hands on these bones. Who can blame them," Phillips said. "It is like a gold mine for paleontologists."

Creation Expeditions, which believes the land may contain dozens of more fully articulated dinosaurs, hopes to be excavating the site for years.

PRINTING OFFICE MONOPOLY IS ENDING

WASHINGTON (AP)—The Bush administration said Friday that it is ending a 141-year monopoly by the Government Printing Office, ordering competitive bids on about \$500 million a year in federal printing and copying contracts.

The Office of Management and Budget estimated that the government would save at least \$50 million to \$70 million annually. That's the amount in special fees that the Government Printing Office charges when it acts as a middleman by contracting out printing jobs to private companies, the office said.

The White House directive, sent to all executive branch agencies, would eliminate the middleman role and allow the government office and private firms to bid for the work.

"The time has come for the executive branch to liberate its agencies from a monopoly that unfairly penalizes both taxpayers and efficient would-be competitors," OMB Director Mitchell E. Daniels Jr. wrote in the memo.

Andrew Sherman, spokesman for the Printing Office, said the proposal would increase costs by 50 percent because companies would have to hire large sales forces to search for government contracts.

The plan also would mean an end to the Printing Office program that deposits federal records in 1,300 libraries, he added.

"The costs and the threat to public access to government information are so significant that Congress rejected this in 1987 and in 1994," he said.

Sherman said the office currently collects \$33 million in fees, not \$50 million to \$70 million, and pointed out the

Charges the government agency that is ordering the work a 7 percent premium above the cost of private printing. The figure increases to 14 percent if the lead time is 10 or fewer days. The premium decreases to .5 percent after GPO recovers \$20,000.

Tacks on a processing fee of \$7.50 to \$15 per order.

Retains all discounts for prompt payment (usually around 5 percent) offered by private printers, rather than passing the savings on to the government agency.

Even when Printing Office performs the work, it charges government agencies a 35 percent premium if the lead time is 10 or fewer days.

"Printing is a very competitive business," Daniels said. "We have thousands of companies. The history of competition is that, often, the incumbent public employees shape up and get most of the business they got before." [JR: This sounds like the creative accounting used by Enron and Anderson. Currently the GPO is contracting out many of its printing services. What will be interesting is how the government will centralize the knowledge of all the titles that Agencies have available as they move towards a more decentralized system. Every year the GPO issues new computer guidelines to help depositories (1300 Federal libraries nationwide in Congressional Districts) maintain what is needed to access the ever-changing electronic environment. Depositories are beginning to drop out of the program, as it becomes more difficult to keep abreast of the technology changes—which includes training staff and patrons. Agencies can then choose to distribute their funds as they evaluate the need. I can just see the Defense Department's technical manuals contracted out to private foreign-owned printers employing minimumwage illegal aliens. Analysis

Nothing was more predictable than the crisis that blew up in Washington last week when it was revealed that the CIA had warned President George W. Bush prior to Sept. 11 that members of al-Qaida appeared to be plotting a series of airline hijackings. At the same time it was revealed that an FBI agent in Phoenix, Arizona, had written a memo stating that members of al-Qaida were receiving flying instructions in the United States.

Then, to show that such information was available during the Clinton years as well, a 1999 study was released asserting that al-Qaida might try suicide attacks on U.S. installations. Washington, which had grown torpid over the war, was suddenly galvanized. The question was, as Sen. Hillary Clinton put it: What did Bush know and when did he know it?

On Sept. 16, shortly after the attacks, *STRATFOR* wrote: "We have no doubt that, after the databases have been searched, it will be found that U.S. intelligence had plenty of information in some highly secure computer. The newspapers will trumpet, 'CIA knew identity of attackers.' That will be only technically true. Buried in the huge mounds of information perhaps once having passed across an overworked analyst's desk, some bit of information might have made its circuit of the agencies....

We expect that, over time, it will be discovered that far more was "known" about al-Qaida and its intentions than what has been released so far. It is difficult to blame Bush for not noticing a vague report on potential hijackings amid the almost limitless stream of other warnings. He cannot be blamed for not seeing the Phoenix FBI field report that never left the FBI. Nor can Clinton be blamed for not reacting to the highly speculative report on the possibility of suicide bombers. Bush has taken a great deal of flak about issuing vague alerts against which no practical action can be taken.

What Bush can be blamed for is that, over the eight months following one of the worst intelligence failures in U.S. history, fundamental changes in how the United States carries out its intelligence mission have not even begun. Certainly some senior officials in the counterterrorism area have been dismissed, but the failure that led to Sept. 11 was not personal; it was systemic. It flowed directly from the fundamental architecture of American intelligence.

The Central Intelligence Agency, as the name suggests, was founded to centralize the intelligence function of the United States. It was a good idea then and it is a good idea now. Unfortunately, it is an idea that has never been truly implemented and from which, over time, the government has moved intractably away. A centralized intelligence capability is essential if the United States is to have a single, integrated, coherent picture of what is happening in the world. A bureaucratically fragmented intelligence community will generate a fragmented picture of the world. That is currently what we have.

Image intelligence—from satellites to U-2s—is handled by the National Reconnaissance Office (which operates the satellites) and the National Imagery and Mapping Agency (which interprets images and also now makes maps). The latter organization is the result of a merger between the National Photographic Interpretation Center and the Defense Mapping Agency, which were integrated into a single structure because... well the reasons aren't clear, but it seemed like a good idea at the time.

And still the list goes on. The Defense Department has its own intelligence service, the Defense Intelligence Agency, which focuses primarily on military matters. Of course, the CIA also has a unit focused on military intelligence, but that's fair enough since the DIA also runs Defense Human Services—which is a human intelligence organization doing what the CIA is supposed to be doing. On top of this, each of the armed services maintains their own intelligence services, replete with signal, image and human intelligence.

Given this incredible tangle of capabilities, jurisdictions and competencies, it is a marvel that a finished intelligence product is ever delivered to decision makers....

As STRATFOR has said before, the U.S. intelligence community is obsessed with the collection of data. Apart from the Directorate of Intelligence at the CIA and sections of the DIA, the rest of the U.S. intelligence system is overwhelmingly geared toward the collection, rather than the analysis, of information. The result is inevitable: a huge amount of information is gathered, but it is never turned into intelligence.

To turn information into intelligence, it must be collated with other information, integrated into a coherent picture, interpreted and used to forecast actions. The current architecture of the intelligence community makes collation and integration structurally impossible. It is not merely a matter of sharing but also a matter of culture.

The FBI collects huge amounts of human intelligence. It has an extremely small analytical staff. Its administrators evaluate the significance of intelligence. Some administrator in the FBI decided that the Phoenix report was not worth pursuing....

Between the labyrinthine structure of the intelligence community and its obsession with collection over analysis, it is inevitable that vast amounts of information never coalesce into intelligence. The collection capacity of the United States, both technical and human, is vast. But it is deliberately and institutionally compartmentalized in such a way that prevents a coherent perspective from emerging.

Even more important, the analytic capability is dwarfed by the collection efforts. Information collected never existed. TAYLOR ON U.S. DOLLAR & GOLD

Drowning in U.S. Dollars

The last time we had a secular bull market in gold, starting at the end of the 1960s and through the entire decade of the 1970s, its arrival was signaled and to a certain extent triggered by foreign selling of the dollar. With one ounce of gold unrealistically fixed at \$35 per ounce, cracks and strains began to develop in the international monetary system from about the-mid 1960s onward. Why? Because to fund the Marshall Plan, the U.S. began to create massive amounts of money out of thin air with increasingly less concern about holding the ratio of paper money constant to the amount of gold in the U.S. Treasury.

So, even before he U.S. began to print more money to fund Vietnam and the Great Society programs, our trading partners were already becoming saturated with dollars. Our elected officials, from President on down, did not possess the political courage or moral fiber to finance these enormous programs honestly, namely by raising taxes. So they set out to impose an invisible tax on the American population in the form of inflation. Rather than raise taxes to pay for Vietnam, President Johnson began to run the U.S. into debt. To ensure a sufficient amount of currency was in circulation to fund this debt and thus obscure the cost of these programs from the American people—and to allow the private sector to survive along side a continuously more dominant socialist government—the Federal Reserve Bank created huge amounts of money out of thin air.

After the financing of two World Wars, in 1970 the U.S. money supply as measured by M-3 stood at approximately \$615 billion. Thanks to the funding of Vietnam and the Great Society programs, by the end of the 1970s our money supply had tripled to \$1.82 TRILLION! but not analyzed is the same as information that Thus the money supply grew by a compounded rate of just under 10% while GDP during the stagflation 1970s grew at an anemic rate of around 2%. In other words, the U.S. was free to increase its policy of deceit and theft via the printing press. And it did!

With gold no longer convertible into paper at a fixed rate, it became free to trade on the international markets. As Americans opted for gold over paper money, that presented a huge problem for the Federal Government because people opting out of dollars made it increasingly difficult for the U.S. government to fund its socialist policies.

So the U.S. government tried first to talk down gold and then to manipulate its price by announcing its intent to dishorde it—and then by actually dumping it on to the market. That policy did not work for long. What is most concerning to your editor is the fact that globalization—on top of these problems, along with huge supply-side excesses—continues to put downward pressure on the profit margins of American companies at a time when share prices remain extremely inflated. There is in fact no way you can paint a realistic picture of growth in the U.S.

economy required to generate profit levels sufficient to justify current equity prices for stocks listed in the major U.S. indexes. At the end of this week, the S&P 500 had an EARNINGS YIELD of only 2.25% (same as last week). WILL CONSUMERS SOON CAPITULATE?

Morgan Stanley's Stephen Roach voiced more concerns last week about anemic corporate profits. He worries that companies will, for the sake of their survival, soon need to aggressively cut back on labor costs. This factor along with extensive indebtedness, he worries may well finally lead the consumer to stop his spending binge in which he has been living well beyond his means. With the consumer so important in the U.S. economy finally cutting back out of concern for his own balance sheet and survival-and with corporate profits not permitting a revival of the capital goods sector of our economy—Roach worries that we will enter into a double-dip recession.

He also worries about the weak dollar and the global imbalances we spoke of above. He seems deeply worried about increasing trade wars, such as those gleaned from the following headlines of this past week:

*"China Puts Stiff Tariffs on Imports of Steel" (Financial Times 5/23/02).

*"Four More Nations Join Attack on U.S. Restrictions" (Financial Times—5/23/02). (Japan, South Korea, Brazil, New Zealand, and the European Union are all fighting the U.S. on this issue. WTO sanctions will kick in automatically in three years if the U.S. does not remove steel tariffs).

*"Central Bank in Japan Acts to Put Brake on Rising Yen" (Financial Times—5/23/02).

As we continue to look at the headlines and read between the lines, rather than rely on CNBC for our information, we see that the Kondratieff winter outlined by Ian Gordon for our readers back in 1999 is coming more clearly into focus every week. Excessive debt, global economic imbalances and "beggar-thy-neighbor" currency devaluations were a major part of the economic landscape of the 1930s as was an attempt to expand the money supply to avoid a depression. And despite the knowledge of all this, it seems we are inevitably falling back into the same pit as Hoover and Roosevelt fell into in the 1930s. In fact, rather than a double-dip as expressed by Stephen Roach, we may be in for something more akin to a dip and a plunge into a replay of the 1930s. And amid signs of growing global tension, we can only hope and pray to our Creator that these economic imbalances will not lead to another World War.

Gold Summary

The stock market is definitely in a primary bear market that still has many years to run. Stocks remain hugely overpriced and there are signs now that foreign interests are finally getting their fill of an enormous supply of dollars that were created out of thin air during the Clinton years and before. In my view, there just isn't enough economic justification for foreign wealth to keep pouring into the U.S. That means the dollar is likely to weaken—and as that happens, gold is likely to become the most important store of value for international investors.

NEVADA CORPORATIONS:

When Is A Corporation NOT "Doing Business"?

Budget's "Tip of the Week" #15:

Operating in a Foreign Jurisdiction Without Having to Qualify the Corporation

Since most people who form Nevada corporations reside in jurisdictions other than Nevada, one of the first questions that needs to be addressed is how to properly use the corporation while they themselves operate from within their home state (or country). Is it necessary to register or qualify the Nevada corporation to do business within their jurisdiction? Often it is—especially if there is a physical presence involving employees—but there are often many useful exceptions to the rule.

Let's look at the exemptions from qualification in the State of California—which is generally known for both its stringent regulations and its repressive taxation—to see what "loopholes" exist. You should look up the regulations in your own particular jurisdiction but as a general rule they will tend to be quite similar.

Business Exempt from Qualification in the State of California

Without excluding other activities which may constitute transacting business, a foreign corporation shall not be considered to be transacting business solely by reason of carrying on any one or more of the following activities:

- 1) A foreign corporation shall not be considered to be transacting intrastate business merely because its subsidiary transacts intrastate business.
- 2) Maintaining or defending any action or suit or administrative action.
- 3) Holding meetings of its board or shareholders or carrying out other activities concerning its internal affairs.
- 4) Maintaining bank accounts.
- Maintaining offices or agencies for the transfer, exchange or registration of its securities.
- 6) Effecting sales through independent contractors.
- 7) Soliciting or procuring orders either by mail or through employees or agents or otherwise where such orders require acceptance without this state before becoming binding contracts.
- 8) Creating evidences of debt or mortgages on real property.
- 9) Conducting an isolated transaction within a period of 180 days and not in the course of a number of repeated transactions of like nature.

We have highlighted number 6 because this provision is used by an increasing number of businesses in the area of consulting. When the consultant is an independent contractor and the income is earned by a Nevada corporation, the corporation has no presence in the foreign jurisdiction, only the contractor does. So, the contractor must pay home-state tax on his income but the corporation earns its income in Nevada. There can be tremendous tax savings if the contractor lives modestly and draws only what is needed to meet living expenses.

Where the business is more product-related rather than service-related, provision number 7 can come into play. Just ensure that the orders generated require acceptance from Nevada before becoming binding contracts!


