Before discussing the military impact of the covert "beam" systems, I want to lay a heavy load upon you as "you the people". I have spoken on this subject in depth verbally and in prior Journals, but you must now pay great attention, for these are

the weapons of choice set up to "take you out".

I have previously suggested you might wish to obtain ELECTRIC POWER LINES AND CANCER, a compilation of research reports which can be gotten through Dr. Sutton's FTIR. Also, THE BODY ELECTRIC, by Robert O. Becker, M.D. and Gary Selden who describe the effects of ELF (Extra Low Frequency) fields.

Now, I am not going to give you "lab results" to toy with—get the material and check it out—I am going to tell you how it IS!

Let us speak first of a simple 1-gauss magnetic field, which is the strength found near high-voltage power lines. In this field the memory and ability to do simple arithmetic declines. There is a substantial interruption of thought flow through the synapses within the brain. There is almost always hyperactivity and disturbed sleep patterns found in persons within these fields. The first perception is that of upgraded feeling of well-being and even euphoria. Even mild pulsed beams of this low frequency change brain cell "firing" rates. For relative measurement, that would be about the influence of a light bulb at 10-feet distance. This is most specifically the basis of Confusion Beam Weaponry.

The Soviets developed such Confusion Beam Systems and are now utilizing them in satellites and spy ships to influence the behavior of military personnel and airline crews while in flight. This ability, coupled with Cosmospheres (I will discuss later), can sink any ship or pull down any aircraft.

These fields are also found around underground power lines which are also related to increased suicide incidents. These weapons are widely used against submarine crews, surface ship crews and airline crews to induce slowed mental and motor reaction times and other "unalert" behavior experienced by your own U.S. sailors and officers. We shall speak of the U.S. Naval accident rate in 1989.

Microwave weapons are also widely in use. These are similar to the type utilized by the Soviets against the American Embassy in Moscow and can cause Microwave Sickness. The manifestations are chronic excitation of the sympathetic nervous system which is called "stress syndrome" and high blood pressure. This would also include headache, dizziness, eye pain, sleeplessness, irritability, anxiety, stomach distress, nervous tension and INABILITY TO CONCENTRATE!

U.S.S.R. MIND-CONTROL DEVICES

The KGB runs a mind-control program which is given unlimited funding. They have some of the world's best minds to perfect a new ability to subdue and control the Western world. People in your sector simply are not prepared to think about these things, but you are already victims of widespread mind control for you see, your government also has this ability.

However, the Soviets are a long way out in front of you and the techniques are already in functioning ability and use. attacks in victims, to creating thoughts of depression

and fear and confusion implanted at will. The thinking process can be "jammed" in the same manner that signals coming in from a radio transmitter can be jammed. By scrambling a targeted victim's thinking, you can make the enemy commander do something totally contrary to his training and his loyalty to his own country. A patriot can easily and instantly be turned into a traitor—IT IS THE ULTIMATE IN THE **PENETRATION** OF WESTERN Α GOVERNMENT BY A COMMUNIST POWER.

You ask, "Why haven't we been told of these things?" You have! Back in Nikola's (Tesla) time, he told you of these things and had an operational beam system. That warning has been continually updated to the point that the "tellers" are called crackpots and radicals. Therefore, few are aware of recent research establishing that brainwaves and other biological functions can be entrained from a distance, by magnetic waves of critical frequencies.

The psychotronic patterns/effects can be modulated onto electromagnetic signals, even of very low intensity, and still affect living systems because of the kindling effect; i.e. the psychotronic virtual state modulations are stripped off by a living system in the acupuncture points near the surface of the skin and introduced onto the human nervous system where they begin to superpose coherently as time passes. Such collections eventually reach the quantum threshold and observable physical changes result. Then, by modulating psychotronic signals onto electromagnetic carriers, visible light squelching can be overcome. Light photons pass through other photons without interaction except in the most extreme cases—and activate the acupuncture points. The cancer deaths of Romanian exiles employed by Radio Free Europe are now under investigation by your FBI because informants have given information that this was the work of agents of the Communist Bucharest government—by directed beam waves! BUSH DEMANDS ARAFAT OUSTER

WASHINGTON-President Bush issued a new ultimatum Monday in the quest for peace in the Middle East, demanding that Palestinians vote Yasser Arafat out of power as the key step to creating a democratic Palestinian state within three years. ...

In the sweeping Middle East proposal, the most aggressive and detailed Mideast proposal of his presidency, Bush outlined an approach that set some conditions on the Israelis. But he placed the lion's share of the burden on the Palestinian people to swiftly reform their government. Bush demanded features more common in Western democracies than Middle Eastern nations, such as an independent legislature, separation of powers, new economic institutions and a string of other reforms. ...

The speech drew mixed reactions from Palestinian leaders, while Israelis generally applauded the address. ...

The implications of the demand for Arafat's removal were not clear, however, as Bush also called for free elections, and a great majority of Palestinians and Arab leaders appear to support Arafat.

Even as Bush spoke, events in the Middle East appeared to work against his peacemaking efforts. The Israeli army expanded its incursion into the West Bank in the aftermath of deadly Palestinian suicide bombings and shootings.

Despite Bush's stern words for the Palestinians, Arafat, commenting briefly after the speech, said the president's proposal was a "serious contribution" to the peace process, and appeared to welcome his call for international involvement in the Middle East conflict. Arafat called for "direct and bilateral meetings with the American administration" in addition to talks with the European Union, Russia and the United Nations.

The reaction from other Palestinian officials was less measured, with Saeb Erekat, the chief Palestinian negotiator, saying Bush's call for new leadership was unacceptable.

"Palestinian leaders don't come from parachutes from Washington or from anywhere else," Erekat told CNN. "Palestinian leaders are elected directly by the Palestinian people. President Yasser Arafat was directly elected in a free and fair election."

The White House speech came hours after the Palestinian leadership sent a detailed reform plan to U.S. and European envoys, the first concrete outline of how the Palestinian Authority would be revamped to fall in line with democratic principles.

Some Palestinian officials expressed dismay that Bush did not seem to recognize the Palestinian Authority's reform efforts so far.

"I have difficulty accepting that the president did not understand the very serious effort put into this plan," said Ghassan Khatib, the newly appointed labor minister. "I think [President Bush] is making this a personal problem with Arafat and is not looking beyond that."

Others in the Arab world found the Bush plan heavy on demands for Palestinian reform and light on a detailed timetable.

"You cannot put his speech down on the negotiating table and make a plan out of it—we will implement this tomorrow and this the next day," Jamal Khashoggi, an editor at The Arab News in Saudi Arabia, told the New

York Times. "He just completely adopted the Israeli analysis of the situation, that it is terror forcing them to maintain the occupation, not that occupation is leading to terrorism."

Few in the Arab world believed Bush's speech went far enough in offering the kind of incentives needed to stem the rising violence and death toll on both sides. ...

The Bush administration said if Palestinians meet conditions outlined in the plan, an interim state could be created first and a fully independent state could be achieved in three years—after the completion of Bush's term.

In a far less demanding tone, Bush also urged Israel to abide by the United Nations resolution that calls for Israel to withdraw from territories it occupied during the 1967 Arab-Israeli war, including the Gaza Strip, the West Bank and East Jerusalem. Israel's only path to peace, he added, is through a stable, democratic Palestinian state. ...

[JR: Pres. Bush is parroting Sharon's demands and not the U.S. in his proposals for a peace settlement. It will take years for the Palestinians to fulfill the conditions of the Bush administration and Bush knows this. Sharon is buying time for his Palestinian land grab and to build his walls around his new settlements. In the meantime he will be busy orchestrating acts that will provoke and incite further violent reactions from his captives. Bush has never attempted to meet with Arafat so for him to demand his removal shows that his intentions are dishonest and deceitful. The reasons for the Palestinian acts of violence have not been addressed or been a part of our deliberations or discussions. We have given Israel much latitude and have not demanded accountability as to her own acts of violence. Unless the EU, Russia or the UN takes a strong position to bypass the U.S. proposals it will be a sellout of all the Arab/ Muslim people of the Middle East as the Zionists mean to gain all even if it means a holocaust. PRESIDENT BUSH THE MARTYR

Last night's long-awaited speech by President Bush was to set the pace for the Palestinians and Israelis to step back from the vicious and bloody cycle of violence that has gripped them for nearly two years. Instead, President Bush and his administration have publicly adopted the Israeli agenda of battering the Palestinians into submission. President Bush's illusion that the Palestinian-Israeli conflict may be 'talked away' in a series of speeches is not only a poor example of leadership but seriously places U.S. interests in the region at high risk.

President Bush's administration has utterly failed to comprehend the Palestinian-Israeli conflict and in particular the Palestinian predicament today which is an Israeli reoccupation of the small parcels of land that were transferred to the Palestinian Authority under the Oslo Peace Accords. To add insult to injury, President Bush continues to mismanage U.S. policy with unprecedented unaccountability to the U.S. Congress or the world community. Bush's chronological attempts to address the crisis are as follows: ignore the conflict-failed; send Powell to the regionfailed; the Mitchell Report-failed; the Tenet Plan-failed; all take the brunt of his misaligned and ill advised

Bush's UN speech—failed; Secretary of State Powell's policy speech in Kentucky—failed; send General Zinni on multiple missions-failed; and the most recent call for an international conference (completely ignored in Bush's latest speech)—failed. If the creativity applied to avoiding real U.S. action were used to put an implementation mechanism in place to end the Israeli occupation, the region would be well out of the conflict by now.

To a naive audience President Bush's speech may have sounded like a sensible framework for progress, but for anyone with any understanding at all of the Middle East, it was clearly a shallow attempt in diplomacy that amounts to U.S. surrender of its Middle East foreign policy to the ranks of Israeli Prime Minister Ariel Sharon and Israel's lobby in the U.S. Indeed, the speech was praised by Israel's right, which has rejected Palestinian statehood outright.

President Bush continues to be blinded by the events of 9-11 and refuses (or deceitfully avoids) to see the Palestinian issue outside the framework of the yet undefined phenomena of "terrorism". Palestinians were stripped of their national, civil and human rights decades before the word terrorism became a buzzword. By placing the Palestinian struggle for freedom and independence in a 9-11 mold, the U.S. is only prolonging a solution and feeding the bloodshed, exactly as Israel has been doing for 36 consecutive years now. Today the U.S. is ideally positioned to finally take real action and use its global leverage to end Israeli occupation, instead it has succumb to an extremist Israeli government that views the fate of illegal Israeli settlements the same as it views the fate of Tel Aviv.

By reducing the entire conflict in the region to the existence of an individual Palestinian leader, or set of leaders, the Bush Administration has fallen for the red herring that was designed, produced and marketed by Israeli Prime Minister Ariel Sharon. President Bush needs to remember that Former President Carter was part of the international election monitoring team that gave the Palestinian Presidential elections a stamp of approval. Furthermore, the Palestinians are fully aware of the weaknesses in their leadership and have been working to correct it for many years now. Instead of supporting Palestinian reformists the U.S. has chosen to make their efforts more difficult by making them look as if they are aligned to an Israeli strategy of reform before freedom. A U.S.-led international campaign to meddle in internal Palestinian politics will only set back the efforts of those Palestinians that have already started making concrete steps for change.

FLASHING YELLOW ON ASSET-BACKED DEBT

Seeking shelter from balance sheet "perfect storms", skittish investors have been flocking to companies with lots of visible assets and regular revenue streams. Just don't get too comfortable under the umbrella.

Like so many cash-strapped consumers who take payday loans or hock the Rolex for cash, companies are loading up on debt backed by future sales and hard assets. Now at record levels, these asset-backed securities ratchet up risk levels for investors, some observers are warning.

U.S. companies in the first quarter had a record \$1.3 trillion in outstanding debt backed by specific assets like receivables, loans owed to them and inventory, according to the Bond Market Association. The total has more than quadrupled since 1995.

In some respects, asset-backed borrowing has been a good thing.

Unlike the egregious fees of consumer payday loans, the debt is cheaper for companies because it is guaranteed with huge, specific assets. The guarantee also means a generally higher credit rating than unsecured bonds, a big plus for institutional investors like pension and mutual funds that buy them. With several companies imploding bankruptcy process have obvious attractions.

But it also means that as investors seek safety in the brick and mortar of the old economy, those companies are surrendering ownership of what would seem to be their bedrock assets.

BUSH PUSHES LAW HELPING INSURERS ON TERRORISM

WASHINGTON—Although legislation to help insurers pay for terrorist attacks passed the Senate earlier this week, crucial differences remain between the House and Senate versions, and President Bush on Wednesday urged Congress to quickly resolve them and send the legislation to his desk....

The president strongly endorsed a measure in the House version, which unlike the Senate bill would prevent victims from suing companies for punitive damages after terrorist attacks....

The legislation was passed after months of intense carrying out an alleged "reconnaissance" for potential lobbying by business and insurance groups. After Sept. 11, businesses began clamoring for government help in obtaining insurance coverage in the event of terrorist attacks. Insurance companies said they could not offer such high-risk coverage without government backing.

> On the other side, the Consumer Federation of America objects to the cost, potentially \$100 billion, portraying the effort as an unnecessary government bailout of insurance companies and businesses....

The chairman of GMAC, a company that lends money for commercial mortgages, has turned down more than \$1 billion in new loans this year because projects were not insured against terrorism, Bush said....

"The bill has got to make sure that the insurance companies remain engaged in covering terrorism losses, that the government will help, but not help all the way," he said.

Under the Senate bill, the government would help insurers by covering 90 percent of claims for the rest of this year after costs to the insurance companies exceed \$10 billion. There would be a \$100 billion cap

The treasury secretary could extend the program through 2003. At that point, the government would cover 90 percent of claims after the first \$15 billion.

The House bill, on the other hand, would require not be "just dismissed as noncombatants," said insurance companies to ultimately repay the federal assistance. Unlike the Senate bill, the House would have the government pay 90 percent of claims from terrorist acts after the first \$1 billion in damage.

EU LEADERS TIGHTEN BORDER CONTROLS

SEVILLE (AP)—European Union leaders, after watching a string of far-right politicians elected across the continent, agreed Saturday to tighten border controls in an effort to reduce the flow of migrants trying to enter the EU illegally every year.

But leaders backed away from threatening poor countries with sanctions for failing to stop the illegal migration of about half a million people every year.

Instead, EU members agreed to boost border defenses along land frontiers with Eastern Europe and the Balkans and in the Mediterranean Sea near Spain, Italy and Greece. That effort will include strengthened border patrols, joint training and shared intelligence.

"Europe must no longer be the victim of uncontrolled flows of migrants," French President Jacques Chirac said.

The EU also will accelerate plans to tighten visa regulations, use common rules for handling asylum requests, quicken deportation procedures and toughen immigrants as cheap labor or sex workers.

Immigration topped the summit agenda after a number of election scares or gains by far-right politicians such as France's Jean-Marie Le Pen and Austria's Joerg Haider.

"People know there is a serious problem in Europe," British Prime Minister Tony Blair said. "Moderate people of the center-left or center-right have to tackle this issue or the extremists will exploit it."

But radical proposals threatening cuts in aid or trade privileges for countries with lax controls on migrants were landmark event in Russian corporate disclosure. opposed by France and Sweden, who argued they only would increase the poverty spurring people to emigrate.

The softer approach was welcomed campaigners concerned about human rights.

CDC RULES OUT NATIONAL SMALLPOX VACCINE

ATLANTA— Concluding that the medical risks of hearings for people arrested after Sept. 11, arguing the smallpox vaccine outweigh the threat of a biological attack, an advisory panel for the Centers for Disease Control and Prevention decided Thursday not to recommend reinstating a national immunization program to vaccinate the general public.

> As the federal government moves to safeguard the country against a potential smallpox attack, the panel recommended vaccinating up to 20,000 medical workers, such as ambulance drivers, emergency room workers, epidemiologists, lawenforcement personnel and others designated the first to respond to any outbreak....

> Smallpox, a highly communicable and deadly disease, has not been detected in the United States since 1949 and was declared eradicated worldwide in 1980. Smallpox kills about 30 percent of its victims, according to doctors.

> The vaccinia vaccine, a live virus that is the only inoculation available against smallpox, has not been administered routinely in the U.S. since 1972. The vaccine can cause severe rashes and brain swelling, and is estimated to cause at least one death among every 1 million people vaccinated. The risk is greater among people with skin disorders and immune diseases such as HIV-diseases that make administering the vaccine to the public much riskier than it was 30 years ago, officials said....

> The panel did not address the current "ring" strategy of isolating and vaccinating only those closest to the outbreak. Under that plan, a patient diagnosed with smallpox would be isolated while investigators rounded up and vaccinated others who might have been exposed. Such a search-and-contain method was essential in eradicating the disease globally.

> According to health officials, the government has begun to expand the stockpile of smallpox vaccine. In addition, research is being conducted on newer vaccines that would pose fewer health risks, officials said....

> Health officials are split over whether widespread vaccinations should be restarted. However, there seems to be support among the public for making the vaccine available to those who want it. During two weeks of public hearings across America, medical professionals and others urged the CDC to change its policy and give more people the option of being inoculated....

> In case of an outbreak, a stockpile of vaccine could be delivered to the affected area in 12 to 24 hours, the CDC said.

> "But once it gets there, the question is how do we get it into the arms of the people who need it? This is the next step," said Dr. Julie Gerberding, the CDC's acting deputy director. "We're hoping that by the end of July every state will have a plan for immunization in place."

> [JR: If there are medical risks with the smallpox vaccine, what does that say about all the other vaccines the CDC gives its approval to for the trusting public. 
