#### **ULTRAVIOLET RADIATION (UV):**

Studies are ongoing in Antarctica for measuring amounts of ultraviolet radiation. Ozone is not the possible effects of the warming of Earth's climate in only thing that affects UV reaching the ground. Glacial ice, for instance, reflects as much as 95 percent of UV back to the sky. The ocean reflects 5 to 30 percent, depending on the amount of ice cover. One of the important goals of this study is to determine to what extent clouds block UV. With the opening in the higher ozone levels, the UV levels are showing up in amounts in October which would normally be measured in December. This means that months longer in duration. Remember, however, that glaciers be melting? And so it goes. it is almost impossible to actually measure these the incorrect perception regarding the ozone layer.

Changes, however, are becoming more and more evident and that point is indisputable. Even your rather crude studies of heightened UV effects on sea organisms have used artificial light. Conditions in the real world are radically different.

It is extremely difficult to accurately measure these rays but it is a pretty close estimation that red light penetrates 10 to 20 meters, blue as deep as 90 meters into the ocean and ultraviolet is undetectable at 20 meters or there-about. Ice-laden cloud movements also make impact on true readings.

When you effort at determining the effect of these factors on life, e.g. phytoplankton, one finds that temperature, salinity, and light all determine whether the lifeform makes a good living, a bad living, or no living at all.

To base, scientifically, results set in concrete is impossible. Phytoplankton, for instance, change desirable about an ice-laden piece of landmass? depth as water layers are mixed by wind and heat.

absorbing compounds and, therefore, it is reasonable to hypothesize that these can also limit UV damage.

#### LOOK AT POSSIBLE MINERALIZATION **IN ANTARCTICA**

There are many minerals. There is a lot of coal in the Transarctic Mountains. Geologists have found traces of copper, gold, and silver on the Antarctic Peninsula. But these wouldn't be economic even if you found them in Minnesota or Montana.

Petroleum is still in great question as the U.S., Brazil, France, Norway, West Germany, Poland, Japan, Australia, Britain, Italy and Russia have all done seismic research. The Japanese have been surveying for eight or nine years. Only the U.S. and Australia have released hard data, as required by the Antarctic Treaty. But at any rate, you need a five-to-ten-billion-barrel field, something like Alaska's Prudhoe Bay, to make it pay, even at a price of \$70 to \$80 a barrel.

#### UNCERTAINTY

Uncertainty plagues your scientists about the general. Glaciologists know that Antarctica's ice sheet, which covers 98 percent of the continent, moves toward the sea in the form of glaciers and ice streams. But they can't conclude as to whether it is shrinking, growing, or remaining pretty much balanced.

The world sea levels show definite signs of rising as much as six millimeters a year, but that is thought to be caused by a combination of thermal expansion of the water plus a melting of Northern Hemisphere the Antarctic summer has become approximately two glaciers—but why would Northern Hemisphere

It is pretty well established that ocean currents variances due to short monitoring and you ones have carry warmer water under the seaward edge of the ice shelf and melt it from the bottom at about three meters each season. Now it is planned to bore through the ice shelf down to water level and place 40 permanent temperature, current and salinity sensors. Those should tell you whether warming currents you know nothing about are causing melting a hundred kilometers "inland" from the ice edge.

Why was the Earth 2 degrees centigrade warmer between 5,000 and 8,000 years ago? There is no answer for you and if you can't model the past, you can't model the future, can you?

South Pole by the constantly moving ice sheet. Now the dome of the present facility, completed in 1975, is being slowly buried by snow as well.

A large snowdrift has formed on the downwind part of the dome, and its weight has depressed and torn portions of the dome's base. First the snow must be removed and then the entire base must be "jacked" up and the base repaired. Next, it is considered that a solution might be to build an artificial snowdrift using lightweight polystyrene foam, shaped aerodynamically to allow real snow to be blown away. That would extend use of the dome for about six additional years. I am continually appalled at conclusions and unreasonable solutions reached by supposedly educated and intelligent people; further, is there no limit to funds you ones will pour into foolishness?

As many as a hundred scientists and support workers occupy the South Pole station during summer months. During winter only 20 people inhabit the end of the Earth. The reason? To monitor the planet's air quality. The South Pole, it is said, has the cleanest air on Earth because prevailing winds blow 98 percent of the time from of James Bond Goes Beyond Sanity. I suggest you the so-called "Clean Air Sector"—between 20 degrees west and 110 degrees east. By the time the air reaches the pole it is well mixed and there are no remaining sources of air pollution.

Air-quality monitoring has been going on since 1957 and has found constantly increasing carbon dioxide levels. Recently, a new sophisticated laser device has been installed by the University of Rome to measure the height and thickness of polar stratospheric clouds, which form during winter darkness over Antarctica.

In 1986 scientists discovered that molecules of chlorine compounds adhere to ice crystals in the clouds. This makes possible a catalytic reaction, triggered by the Sun's first springtime rays, in which chlorine atoms destroy as much as half the ozone over Antarctica between September and November.

Scientists believe most of the destructive chlorine comes from chlorofluorocarbons, or CFCs, which find their way from the industrial areas of the world to the stratosphere and are then carried south over Antarctica, there to be trapped by an annual atmospheric phenomenon called the polar vortex.

While chlorine in the atmosphere was found to have increased by about 10 percent in three years, some scientists thought the change so dramatic that they wondered if other factors might be involved. And so on and on it goes. Chelas, I simply cannot go on with this foolish dissertation.

The so-called Falklands crisis was just the visible tip of a giant military operation. During the month of April 1982, fierce naval battles were taking place, not only in the South Atlantic but also in the South Pacific.

The hostilities were very effectively kept under arrest by wartime censorship on all sides of the dispute The (and yes, the U.S. was most certainly in the dispute).

On April 30, a total naval and air blockade of the Falklands by the Royal Navy began. At the I now quote Bryan Hodgson's reading of a same time a counterblockade had been declared by Argentina in the same area.

To be effective, a blockade must be imposed over a period of time, but the Royal Navy didn't have sufficient time. Winter was coming on in the South Atlantic, and the British supply lines were overextended. Having traveled so far, however, Her Majesty's Navy could not simply drop the blockade and sail away in a few weeks time without drawing blood from Argentina. As a result the British would be forced to undertake military operations very quickly no matter how risky they might turn out to be.

There was also another reason why the Royal Navy had no choice but to engage the Argentine forces in combat. That reason was that the Royal Navy had already suffered losses in secret combat that same month. Only when publicly admitted fighting erupts would the British dare to admit that they had already suffered great battle losses. And further, to obtain that cover-story, the British had no choice but to sail into combat; but in so doing, they would be risking even heavier losses on top of those already sustained. In short, Her Majesty's Navy sailed directly into a trap.

The events which unfolded in the South Atlantic carried strange, ironic echoes of your past. For weeks you had been hearing countless commentators referring to the British task force as an "armada". The British of all people ought to have been very uneasy with that description. The original Spanish Armada some 400 years ago was renowned as a seemingly invincible fighting force, but it came to grief in a naval disaster so complete that it changed the course of history—and it was none other than the English Navy that destroyed the Spanish Armada.

The original Spanish Armada put to sea in 1588 during the reign of England's Queen Elizabeth I. The Armada was an invasion fleet carrying thousands of crack fighting men to invade England. They were met by the daring sea dogs of Sir Francis Drake. Drake and his small fast ships turned the tables on the Spanish Armada by changing the rules of battle. The English fleet was equipped with new longer-range guns, and it stayed upwind and out of reach. From there the English pounded, smashed, and shattered the big ships of the mighty Armada. When it was all over, barely half the Spanish fleet was left to limp back to port. Drake's defeat of the Spanish Armada was a shock to the world. It opened the door for England under Queen Elizabeth I to start its expansion into a truly global empire.

Four hundred years later, history seemed to have come full circle. Queen Elizabeth II witnessed the dismantling of the world empire whose heyday began under Queen Elizabeth I, and now the cultures of England and of Spain were once again in confrontation. Once again a so-called armada was preparing for invasion, but this time the armada was British, not Spanish. Four hundred years past Sir Francis Drake was the hero of the day; today, the ghost of Francis Drake would once again be on the scene.

Please note that the South Atlantic war zone was at the eastern end of the Drake Passage around the southern tip of South America. The defeat of the Spanish Armada four centuries ago broke the back of Spain's naval supremacy, and now it appeared that the defeat of the new British armada might very well break the back of what remained of the once glorious Royal Navy.

#### MILITARY SECRET OF SOUTH GEORGIA ISLAND

When the Falkland Islands crisis began in early April it looked at first like a mere tempest in a little teapot. For a century and a half since 1833, the Islands had been controlled by Great Britain. During that entire time, British sovereignty over the Falklands had been disputed by Argentina. There had been countless threats by Argentina to seize the Islands, which it called the Malvinas, but the threats had always come to nothing in the past and Britain had never even gotten very concerned over them.

The Islands are four times as distant from Argentina as Cuba is from the United States, and they are not much of a prize, it would seem, under any circumstances. After over 150 years of occupancy, the Falklands are home to fewer than 2,000 British settlers and a great number of sheep and some lovely penguins. look like something to fight over, and yet there you were watching another crisis take place. You watched as literal gun-battle war erupted between Great Britain and Argentina and further, without much more than fanfare on your news media presentations.

The Thatcher government was acting as if it had forgotten all about its usual preoccupation with the Soviet threat at NATO's doorstep. Instead, Britain was throwing almost everything it had at Argentina—aircraft carriers, cruisers, destroyers, submarines, assault ships—you name it and if they had it they used it. Luxury cruise ships were even commissioned and turned into troop carriers overnight. Wave after wave of additional assault troops were activated and sent to join the fleet even after it sailed. Ships and submarines were pulled off station from normal NATO duty and sent to reinforce the task force. The initial 40-ship force grew steadily over the ensuing weeks into an armada numbering over 70. Over two-thirds of the entire Royal Navy was already deployed to the South Atlantic off Argentina.

As this was watched in the unfolding, a lot of people were asking: What's this fight really all about? The most popular answer suggested in the major media was "oil". Vast deposits of oil were known to exist under the continental shelf between Argentina and the Falklands (or so it was projected) and that had been espoused for well over a decade. In no way could it explain the timing of the sudden military offensive by Argentina—and oil explained even less about the Argentine seizure of South Georgia Island.

South Georgia Island is some 800 miles east of the Falklands with no known oil deposits anywhere near it; and compared to South Georgia, the Falklands are quite an island paradise. South Georgia Island is covered with rugged mountains, treacherous valleys, glaciers and semi-permanent snow. Most of it is uninhabitable. On top of all that, Argentina had absolutely no legal or historical claim to South Georgia Island. In that respect it stood in sharp contrast to the Falklands.

In your early 1830s the Falklands were occupied for a while by Argentine colonists. In 1833 the British expelled them and took over the Islands. For that and other historical reasons, Argentina argued that the Falklands actually belonged to Argentina, not Britain.

But no such argument was possible for South Georgia Island. It was always controlled by Britain, never by Argentina or Spain. The Argentine seizure of Government by the Bolsheviks. Since that time the the Rockefellers.

from a military point of view. Argentina's leaders were military men and they thought in military terms and this should be a great clue to you readers. They were well aware ahead of time that far-off South Georgia Island could not possibly be held for long. By seizing it they were setting themselves up to absorb a military defeat, as the Island was retaken by Britain. So the question was: Why did Argentina's military junta bother with the seemingly worthless South Georgia Island at all?

The answers to all those questions were, of course, military, not political or economic. South Georgia Island possesses an enormous military secret! It is a giant underground installation buried under the mountains at the northwest end of the Island. The real reason for the so-called Falkland crisis was this secret installation, together with two other similar installations which I will also describe in a moment.

The secret military complexes had been in In short, the remote Falkland Islands would hardly existence for many years; they were not new. What was new was an accelerated nuclear war timetable of the American Bolshevik war planners in Washington D.C. For the prior two months reports of details of that war plan were leaking out as quickly as they could be verified.

> The plan called for NUCLEAR WAR ONE to erupt by September of the year 1982. It was that fast-approaching nuclear war threat that caused the socalled Falklands crisis to erupt when it did.

> What was actually taking place was a coordinated effort to spoil part of the Bolshevik grand strategy for the coming nuclear war. The mutual enemies of the American Bolsheviks in the U.S.—namely, the Rockefeller cartel—and Russia's new rulers in the Kremlin were behind the crisis. They were trying to ruin Phase #3 of the "PROJECT Z" war plan which has since been revealed—go look it up, please.

> That phase was to be world domination by the American Bolsheviks after both Russia and the United States had been destroyed in NUCLEAR WAR ONE. The key to this plan was the existence of secret weapons stockpiles in various places around the world!

> The American Bolshevik military planners in America were working with other Bolshevik agents in key military positions of other countries to set off war. Having done that, they intended to ride out the nuclear holocaust they had caused, safe and cozy in Government war bunkers! When the warring nations would finally lie smoldering and exhausted, the Bolsheviks would leave the shattered remains of their host countries. They would rendezvous at the secret weapons installations and bring their weapons into the open. They would confront the world with the only remaining fresh, up-to-date powerful military force on Earth; and using that military power, they would become the undisputed rulers of the world. They planned to do all that, and they planned to pave the way for world domination by setting off NUCLEAR WAR ONE within mere months of that April—remember, September!

> The Rockefeller cartel and Russia's new anti-Bolshevik rulers were working together in a race against time to try to head off the Bolshevik war plan.

The Bolsheviks in the U.S. were already benefitting from war preparations which were started by the Rockefellers long before. It had only been about three years since the Rockefellers were dislodged as the prime movers of the United States

South Georgia Island looked even more unreasonable United States Government had been a house divided, torn by internal power struggles between rival Bolshevik and Rockefeller factions. But prior to that, the United States had been dominated for decades both economically and politically by the four Rockefeller brothers.

> In 1961 the Brothers launched a new long-range plan for world domination. It was a two-pronged strategy, half visible and half secret, which has been described prior to this writing. It was a plan for the United States to arm to the teeth in secret while appearing to disarm gradually. Without repeating all the details, the basic idea was grandiose indeed, yet simple. By deliberately appearing weak, the Rockefellercontrolled United States would maneuver itself into a nuclear war with Russia. Then the secret weapons, including superweapons, would be unleashed to smash Russia and take over the world.

> When they set the grand plan in motion in 1961, the Rockefeller Brothers were looking ahead to a nuclear war by the late 1970s. Their military analysts concluded very early that the war being planned would have very different effects on the Northern and Southern Hemispheres. Both superpowers, the United States and the Soviet Union, are located well up in the Northern Hemisphere; so are the other full-fledged nuclear powers-Great Britain, France, Red China and India. By contrast, the strategic targets for nuclear war in the Southern Hemisphere are relatively few and far between. In other words, it was expected that the coming nuclear war would be essentially a Northern Hemisphere war.

> In an all-out nuclear holocaust it is known that serious radioactive fallout would gradually spread to affect even areas not initially hit by war. But there are limits to how far the war clouds can spread. It was discovered long ago that there is very little mixing between the air of the Northern and Southern Hemispheres. In the northern half of your planet, cold air from the North Pole works its way southward toward the equator, then it works its way back to the north as warm air. A mirror image of this process takes up the southern half of the planet. Northern and Southern Hemisphere air meet in the equatorial zone, but very little of the air changes places.

> The military conclusion is this: The coming nuclear war could ruin vast areas of the Northern Hemisphere for generations forward; but if the calculations are correct, the Southern Hemisphere could escape virtually unaffected by the war. This was surely music to the ears of the four Rockefeller Brothers. A quick look at the globe of the world shows why this would be a reasonable calculation. The Rockefeller cartel has dominated Latin America ever since World War II. As discussed in prior publications, Nelson Rockefeller solidified the cartel grip on Latin America during the war. He accomplished this as so-called "Coordinator of Hemispheric Defense" for then-President Franklin D. Roosevelt. So that takes care of the South American continent and its natural resources.

> Then let us turn to the African continent. There, too, Rockefeller control was already in effect over wide areas of Black Africa, especially south of the Equator. All this was thanks to the efforts of John D. Rockefeller III, as previously detailed elsewhere.

Looking around the globe, the most important remaining landmasses from the standpoint of world domination are AUSTRALIA AND NEW ZEALAND. Thanks to World War II, both were wide open to

military installations in the Southern Hemisphere for use after the coming war. By this means they expected to become the masters of the surviving southern half of planet Earth—after the Northern Hemisphere gradually recovered from the nuclear holocaust, the Rockefeller empire would be able to pick up the pieces. In this way the third-generation Rockefeller Brothers expected their family dynasty to inherit the Earth.

In order to control the Southern Hemisphere militarily after the war, some means would have to be available to project military power onto any landmass. For example, revolts against Rockefeller domination would require troops—not a blast from the beam weapons on the Moon (another very interesting story).

The most critical factor for postwar military domination of the world was found to be a NAVY! A minimum of two secret naval fleets would be required—one based in the South Atlantic, the other in the South Pacific. Since the reserve naval fleets Hemisphere nuclear war, they could not be built in existing shipyards. New construction facilities had to be built and they had to be hidden. To hide an entire shipyard is no small task; they take up a lot of space. On top of that, it was essential that the ships remain hidden after they were built. The best way to achieve that was to combine the shipyard and naval base into one over-all secret installation. Finally, the secret naval installation had to be invulnerable to nuclear attack; otherwise if its existence were ever discovered prematurely, the secret navy might be wiped out.

The combined requirements for secrecy, space, and protection against attack were formidable; but one day in 1959, while all these plans were still in the early stages of development, the answer presented itself. During a so-called banking trip to Sweden, David Rockefeller was given a tour of a unique hidden naval port. The port is hollowed out from solid granite cliffs which come right down to the water. The entrance to the port is a gigantic hole in the side of the cliff which can be sealed off with enormous steel doors. Inside this big doorway on the water a huge cavity has been hollowed out to accommodate ships.

The Rockefeller Brothers and their military advisers decided that a bigger, more secret, better-protected version of the Swedish hidden port was just what they wanted. A survey of candidate sites was then initiated. The site survey covered coastal areas throughout the Southern Hemisphere. Many areas were rejected very quickly because the topography was wrong. Other areas were rejected because they were too close to the Equator. Still others had to be ruled out because there were too many people living nearby, making the desired level of secrecy impossible. Finally, it was essential that the sites chosen for the secret naval installations be totally secure politically.

At last the sites for the secret naval installations were selected. In the South Pacific extreme southern New Zealand was selected. New Zealand would be extremely important during a coming war.

New Zealand naval installation had to be divided up into two sites located close together. One is at the extreme southwest tip of South Island where the mountain range known as the Southern Alps comes down virtually to the water's edge. The other part of the installation is built into the northwest tip of Stewart Island, which is duplication facilities to reproduce certain ships and "ENLIGHTENING" WHICH YOU ARE ABOUT IN

The location is far from the Equator—and the installations are buried deep under mountains, protected from nuclear attack. They are also too deep to be reached by particle-beam-weapon attacks, and the New Zealand site is well situated to command the entire South Pacific.

In the South Atlantic an even more perfect site was found. That site, my friends, is South Georgia Island. It is located perfectly for naval domination of the entire South Atlantic. The tall rugged mountains provided a perfect location for the secret installation at the northwest tip of the 100-mile-long island. It is controlled by Great Britain whose government, like that of New Zealand, was willing to cooperate; and South Georgia Island was virtually uninhabited were to be kept secret until after the Northern except for a whaling station on the northeast coast. The whaling station was some 50 miles away from was closed down. Since that time there have been no inhabitants on South Georgia Island except for a few dozen alleged Antarctic scientists.

> Construction of the secret naval facilities—two in New Zealand, one on South Georgia Islandbegan in the early 1960s. The techniques were adapted from those used previously to build other invisibility shielding. This technique makes an large underground facilities, such as the NORAD installation inside Cheyenne Mountain, Colorado (there are others well protected underground but we shall not go into those presently). However, these installations and techniques were adapted in radically new ways to achieve construction access directly from the sea instead of overland. In this way, the sheltering mountain was left undisturbed in appearance both during and after construction.

The cuts in the mountainside—which were necessary to let ships in and out—were kept as small as hidden naval port arrangement, the entrances to the secret installations can be sealed. When sealed, the entrance is virtually impossible to detect unless large construction projects, there are no tailings or piles of leftover rock lying round to attract undue attention. The man-made caverns which house the rock and debris was disposed of at sea.

Once the secret naval facilities were built, they had to be outfitted for ship construction and dockside storage. The fake disarmament of the United States during the 1960s contributed greatly to this task. From 1961 to 1968 one man played a pivotal role in this elaborate Rockefeller scheme. He was then-Secretary of Defense Robert McNamara. All through the 1960s McNamara presided over the public paring back of America's visible military power. The secret naval installations have been used as

submarines designed and built here in the United States. As Defense Secretary Caspar Weinberger told Congress, "It is cheaper to build two ships at a time." That is most especially true if the second ship is an exact duplicate of the first. This has become even more true in recent years through the use of computerized manufacturing techniques.

The secret naval fleets which have been built at the secret installations are made up of duplicates— EXACT DUPLICATES of certain other ships and submarines. They are all nuclear powered—nuclear "subs"; nuclear cruisers; nuclear destroyers; and yes, nuclear aircraft carriers, at least three of them. A secret twin was built for the USS Nimitz, for the USS Eisenhower, and for the USS Carl Vincent. All have been financed through the gigantic cost overruns, so called, that you constantly hear about in the Defense Department and can't find anything about due to abovetop-secret designations; all three carriers have been provided with a full complement of aircraft whose manufacture was financed in the same manner.

#### SECRET NAVAL WAR OF THE SOUTHERN HEMISPHERE

Finally, after NUCLEAR WAR ONE fizzled out in stalemate, they planned to leave behind the ashes of the U.S. and her allies. Activating Phase #3 of their grand strategy, they planned to unveil their secret weapons, especially their secret naval fleets. With these they planned to conquer and rule what would be left of the world. The United States as you know it would be long dead and gone; but in the eyes of the Bolsheviks themselves, this outcome would constitute victory for many reasons.

What saved you is that the Bolsheviks were running as fast as they could toward war; but the Bolsheviks are not the only runners in the race. The January 26, 1982 meeting between Haig and Gromyko in Geneva, Switzerland, was a turning point in the formation of this coalition. It is now a reality, and is responsible for the soin April and May of that year. It should be emphasized that the new relationship between the Rockefeller cartel and Russia fell far short of a true alliance, at least at that time. They have very major disputes to be settled between them, but they called a truce between themselves to deal with the mutual deadly enemy—the Bolsheviks in America.

The first priority of the Russians and the Rockefellers is to slow down the Bolshevik preparations for imminent nuclear war. If they could do that, time political movements. A slow-down in the nuclear war timetable will also give more breathing space for additional anti-Bolshevik actions to be implemented.

The joint Rockefeller-Russian planners decided by mid-February of 1982 that military action against the Bolsheviks was essential very quickly. No other type of action had any hope of taking effect fast enough to prevent nuclear war by the end of the summer.

The exact details of the "PROJECT Z" war plan were not known to either the Rockefellers or Bolshevik three-phase strategy for NUCLEAR WAR the Russians, but the general outlines were known

It was decided that military action should be devised that would undermine Phase #3 of the Bolshevik war plan—that is, the Bolshevik-controlled secret naval installations and fleets in the Southern Hemisphere should be attacked and crippled. By working together, the Rockefeller cartel and the Russians were able to devise an attack plan which neither could have carried out alone. The Rockefeller group, who built and originally controlled these bases, provided detailed intelligence about the best way to attack them. The Russians with their enormous military machine provided the muscle to actually carry out the attack.

It was essential to devise a scheme that would enable both secret fleets in the South Atlantic and South Pacific to be attacked. Survival intact of either fleet would leave the Bolshevik war plan still workable.

Military analysts concluded very quickly that a direct assault on the New Zealand facilities was out of the question. There was no combination of commandos, frogmen, or other military force which could possibly keep an attack secret from the outside world. Any attack on the New Zealand bases would set off the very war which the Rockefellers and Russians wanted to prevent.

But the situation in the South Atlantic was a South Georgia Island was also its Achilles' heel. The extreme isolation which protected the secrecy of the South Georgia base also made a covert military assault feasible. The key lay with Argentina and her long-standing claims to the Falkland Islands.

#### THE FALKLAND ISLAND WAR

The Rockefeller cartel had dominated all of Latin America for decades. Cartel operatives were sent to Argentina to work out a deal with the government military junta there. The historic dispute over the Falkland Islands was to be used to provide a ruse, a military cover, to enable the South Georgia base to be attacked. The Argentine generals were not told everything about the situation by any means, but they were told enough to make clear what they were to do.

As an inducement to cooperate, the Argentine called "Falkland crisis" which dominated the headlines leaders were promised handsome rewards. They were guaranteed that after the shooting was over, the Falkland Islands would remain in Argentine hands. This guarantee included the promise of covert military assistance as needed against the Royal Navy. And, to bolster the troubled Argentine economy, it was promised that the Rockefeller cartel would help develop the immense offshore oil reserves. With those combined promises of military glory and financial rewards, the Argentine military junta agreed to the plan.

So, backing up to March 19th, Argentina carried out would be on the side of the Rockefeller cartel in certain Act One in the joint attack plan. > They drove off the scrap merchants and promptly tore down the Argentine flag. The incident provided the exact desired excuse for the Argentine Junta to bring the

simmering 150-year-old Falklands dispute to a boil. South Georgia was part of the Falklands because it is administered that way by Britain. That argument was very flimsy but it then came in most handy indeed. It was nothing new to hear that claim from Argentine leaders, so there was no hint of what was really afoot.

During late March, Argentine military forces started assembling for an assault on the Falklands. The British command thought there was nothing new, for Argentina had carried out threatening maneuvers in the past many times. It was believed that they were about to do it again; but on April 2 Argentine forces did the unexpected. After many past false alarms, this time they actually invaded and seized the Islands. All Argentine public statements emphasized the long-standing historical claims to the Falklands themselves; but just for good measure, the next day a small Argentine force also seized far-off South the appearance initially that it was just a side show from Argentina's point of view; however, the small contingent of 22 Royal Marines were overpowered and bundled off the Island along with a group of 13 alleged scientists. That was a moment of pay-off in the joint Rockefeller-Russian attack plan.

#### A KEY SHIP DESTROYED

Key advance elements of the South Georgia attack contingency left Ascension Island early April 14, two days before it was announced officially. Shortly after they did so, they ran into trouble. Russian Cosmospheres and attack submarines closed in on a single ship which was critical to the planned counterassault on South Georgia Island. The Cosmospheres bombarded the bridge and combat information center of the ship with neutron radiation. In moments the ship was without any command, its communications and radar silenced. Floating overhead, the Cosmospheres located the seven ships using their Psychoenergetic Range-Finding equipment known as PRF. There is no method known by which PRF can be jammed. The Cosmospheres radioed the exact locations of the ships to the attack submarines. The "subs" were armed with special non-homing, non-nuclear torpedoes designed to explode on impact. More sophisticated torpedos would have been thrown off course or detonated prematurely by the protective shield of each ship; but these simple torpedoes just cruise right through each invisibility field to strike the ship and explode. Palestinians has been allowed to become a blood feud rather than a territorial quarrel susceptible to diplomatic solutions, Americans who would like to see Israel in the most favorable light may be tempted to dismiss the missile attack in Gaza City as the kind of inevitable accident that accompanies a cycle of Palestinian defense because the target of the attack, Salah terrorism and Israel's antiterrorist retaliation.

The best antidote to that temptation ought to be criticism of the missile attack from Israeli voices. The Israeli human rights organization B'Tselem said: "Those who gave the orders to bomb a residential neighborhood must have considered the fact that many civilians would be hurt." The tacit suggestion of this condemnation is that those who gave the order to fire the missile were willing to risk killing innocent Palestinians.

The government's defense is that it had aborted a recent plan to assassinate Shehadeh because at the time he was among the civilian bystanders, and hence it would have aborted Tuesday's attack had it known that he was again surrounded by noncombatants; that Shehadeh was the mastermind of some of the worst terrorist atrocities; and that he was on the verge of commanding a terrible large-scale murder of Israelis.

This rationale ignores Sharon's evident willingness to disregard the danger of firing a missile at night into a house in Gaza City on the basis of shaky real-time intelligence. Even after the human toll of the attack was known, Sharon told his Cabinet ministers: "This operation was in my view one of our biggest successes. We hit perhaps the most senior Hamas figure on the operational side."

At best, this is the thinking of a tank commander with no grasp of the art of statecraft. At worst, it is the boasting of a hawk in power who deliberately launched his missile attack at a moment when high-level Israeli and Palestinian officials were meeting to discuss security cooperation and after Hamas leaders spoke publicly about stopping suicide bombings. ...

The White House said the attack went too far.

"This was a deliberate attack against a building in which civilians were known to be located," White House spokesman Ari Fleischer told reporters. "This president has been and will continue to be a lead defender of Israel around the world, and will speak out about Israel's right to self-defense. This is an instance in which the United States and Israel do not see eve to eve."

Officials said the U.S. ambassador delivered Washington's message of displeasure to the Israeli government.

"The president has said repeatedly that Israel needs to be mindful of the consequences of its actions in order to preserve the path to peace in the Middle East," Fleischer said. "The president views this as a heavy-handed action that is not consistent with dedication to peace in the Middle East."...

But Tuesday's condemnation, coming amid recent signs of progress in the administration's efforts to revive peace talks, was the strongest so far of the government of Prime Minister Ariel Sharon, whose policies Bush has repeatedly endorsed.

The use of American-made weapons in the attack prompted some Palestinian and Arab groups to call on the State Department to investigate whether Israel had violated provisions of the U.S. Arms Export Control Act, which requires countries that obtain weapons from the United States to use them only for selfdefense or internal security. ...

Under the law, the State Department is required to report violations of the act to Congress. But State Department spokesman Richard Boucher said no specific review of the Gaza attack was planned.

"Should we determine that the terms and conditions of sale or the terms and conditions of the act have been The tragedy in all of this is that the U.S. remains exceeded, then we would make the report," Boucher said. But Palestinians scoffed at such assertions, noting that the rocket attack took place in a densely populated civilian neighborhood in the middle of the night. Israeli officials acknowledge that their forces have killed Palestinian civilians over the past 22 months of the intifada and have expressed regrets at the deaths, calling them unintentional casualties. Palestinians allege that Israelis have killed hundreds of civilians and accuse Israeli forces of acting with disregard toward non-combatants.

"Israel is exempt in the eyes of this administration from abiding by legal considerations, American law or international law," said Hassan Abdel Rahman, the Palestinian Authority's chief representative in Washington. ...

#### CONGRESS AGREES TO GIVE BUSH MORE TRADE AUTHORITY

WASHINGTON (AP)—Urged on by President Bush, House and Senate negotiators agreed late Thursday on a bill that would give the president broad powers to negotiate new trade agreements while extending more benefits to Americans hurt by foreign competition.

Sen. Finance Committee Chairman Max Baucus, D-Mont., said it would become "the most historic trade legislation" ever passed by Congress.

The trade bill has been at the top of Bush's legislative agenda since he took office, and in recent days he has urged Congress to move quickly to give the nation's faltering business communities a needed jolt of good news. ...

The package combines the "fast track", or trade promotion, authority the president says is vital if the United States is going to take a leading role in future world trade negotiations. The authority, which Congress has failed to renew since it expired in 1994, allows the president to negotiate trade agreements that Congress can approve or reject but cannot change.

Baucus said the compromise also contains 85% to 90% of the language in the Senate bill that provides extensive new benefits, costing up to \$12 billion over 10 years, to workers who are dislocated as a result of foreign competition. ...

The Trade Adjustment Assistance part of the bill provides a 65% tax credit to help workers dislocated by trade buy health insurance. It also extends existing financial and training benefits for those affected by trade to secondary workers such as suppliers to plants hit by foreign competition. The Senate bill had a 70% credit, while Thomas had asked for 60%.

#### GRANTING POLICE POWERS TO MILITARY CALLED 'TERRIBLE IDEA'

Any changes to the 124-year-old law that prevents the U.S. military from exercising police powers is a "terrible idea", according to a policy expert from a Washington think tank. Gene Healy from the Cato Institute was reacting to the comments made Sunday by Senate Foreign Relations Committee Chairman Joseph Biden (D-Del.).

During an appearance on Fox News Sunday, Biden said the Posse Comitatus Act of 1878, which prevents the military from arresting civilians, should be re-examined and "has to be amended" in light of the dangers of terrorism that exist today.

Last year, following the Sept. 11 terrorist attacks on the Pentagon and New York City's World Trade Center, Sen. John Warner (R-Va.), the ranking Republican on the Senate Armed Services Committee expressed similar concerns.

In a letter to Secretary of Defense Donald Rumsfeld, Warner asked whether the 1878 law should be repealed. "Our way of life has forever changed," Warner wrote.

"Limited use [of military forces] beyond that permitted by existing law might strengthen the nation's ability both to protect against and to respond to events of the sort which we have recently undergone," Warner's letter stated.

But Healy, an attorney and policy analyst with Cato, thinks having the military performing civilian law enforcement duties would be a "disaster".

"I think it's a terrible idea. Soldiers are trained to shoot to kill. Civilian police officers, ideally are trained to use force as a last resort," said Healy.

"One of the reasons we have this (Posse Comitatus) restriction in the law is to avoid the collateral damage and military style rules of engagement that can come into play when you get the army involved in tasks it's not trained for. I think it would be a real disaster if they went down this road of normalizing military involvement in law enforcement," Healy said.

Michael Scardaville, a homeland security analyst with the Heritage Foundation, thinks law enforcement should be left to civilians in almost all cases.

"In an extreme situation, I could understand where something like that would be warranted," Scardaville said. "However, the primary role of the military in homeland security should be one of supporting the civilian agencies that are going to be responsible for our preventive measures. But they (the military) should not be our lead element.

The Posse Comitatus Act was enacted in 1878 to eliminate military enforcement of civilian law. Many historians think the act effectively ended civil war reconstruction of the South.

No prosecutions have ever taken place under the law, and exceptions have occasionally been allowed, such as the deployment of troops to end rioting in Chicago in 1919 and to control the protests of angry World War I veterans in Washington, D.C. in 1932.

Homeland Security Director Tom Ridge said Sunday on CNN that using the military for law enforcement hasn't even been discussed within the administration. [JR: YEA, RIGHT!]

"There's been absolutely no discussion with regard to giving military authorities the ability to arrest in their support of civilian authorities," said Ridge. Asked whether he believes the military should have the power to arrest Americans, Ridge said, "no."

#### U.S. LOSES BID TO ALTER UN PRISON CHECK PLAN

NEW YORK—The United States lost a bid on Wednesday to rewrite a UN plan designed to reinforce the 1989 convention against torture. The Bush administration, continuing to review international agreements, feared the new plan would lead to monitors demanding access to prisoners and others detained by the United States, including suspected al-Qaida members held at Guantanamo Bay, Cuba.

The U.S. delegate to the UN Economic and Social Council had called Wednesday for a vote to set aside a council plan to establish a system of regular inspections of prisons and detention centers worldwide to check for abuses. The United States wanted to create a committee in the General Assembly to write a new plan more acceptable to Washington.

The American proposal was defeated Wednesday evening, and the council's plan approved.

The plan the United States objects to is contained in a protocol or side-agreement to the international convention against torture, which also bars "other cruel, inhuman and degrading treatment or punishment".

Diplomats say, and American officials do not dispute, that the United States is sensitive about this issue because of potential demands for access to the detention camp at the U.S. naval base in Guantanamo Bay, where more than 500 suspected al-Qaida members and other prisoners seized in Afghanistan are being held, as well as to others being held prisoner in the United States as "enemy combatants".

An American official at the United Nations said the concern in Washington was that the current draft of the plan would be unconstitutional in the United States because it does not recognize states' rights.

Adherence to the protocol would be voluntary. He predicted that many other countries would object to its demands and refuse to cooperate because of its intrusiveness.

The official said the United States did not wish to withdraw support for the convention on torture itself, which he called "an important human-rights instrument".

In the past, efforts by UN monitors to visit American prisons met with mixed results, with some states or localities refusing entry to foreign inspectors. American officials have said that the federal government cannot force states to open their prisons.

#### **U.S. CHIEF JUSTICE SIGNALS SUPPORT** FOR WHITE HOUSE ASSAULT **ON CONSTITUTIONAL RIGHTS**

William Rehnquist, chief justice of the United States, on June 15 gave a speech before a gathering of federal judges in which he condoned the suppression of democratic rights in wartime.

Virginia, "One is reminded of the latin maxim, inter arma silent leges. In times of war, the laws are silent."

The Supreme Court justice said he was offering "only a historical perspective", but his choice of topic and what he had to say about it were obviously intended to bolster the Bush administration's attack on constitutional guarantees of free speech, assembly, privacy and due process, which is being carried out under the cover of the government's "war on terrorism".

Rehnquist's speech elaborated on themes developed in his 1998 book All Laws But One: Civil Liberties in Wartime. The title refers to President Abraham Lincoln's 1861 speech to Congress justifying his suspension of habeas corpus, a legal procedure for a person in custody to obtain court review of the detention. Rehnquist's seizing on this historical precedent to justify the current attacks on civil rights turns history upside down.

Article 1, Section 9 of the U.S. Constitution provides that "the Writ of Habeas Corpus shall not be suspended, unless when in Cases of Rebellion or Invasion the public Safety may require it". After the Confederate states seceded and commenced an armed insurrection with an attack on Fort Sumter, Lincoln suspended the writ along the Philadelphia-Washington railroad line in response the efforts by Baltimore public officials to bomb the railroad so that federal troops could not arrive to defend the U.S. capital. ...

After the Confederacy's attack on the North, Taney interfered with Lincoln's efforts to suppress the rebellion by issuing a habeas corpus writ ordering the release of a Maryland official arrested Congress why "all laws" were rendered ineffective by federal judiciary; the two other branches the corrupted virtue of the rebellion "but one", i.e., habeas corpus. ... instruments." His remarks could only have the effect of intimidating those judges more inclined to uphold constitutional liberties.

By making such a speech while many important cases are working their way through the federal judiciary and are ultimately headed for his court, Rehnquist violated American Bar Association Code of Judicial Conduct Canon 4, which prohibit judges from "extrajudicial activities" that "cast reasonable doubt on the judge's capacity to act impartially as a judge". ...

#### 'SILVER TUBES' MAY CUT INFECTIONS

The number of infections acquired by patients in were coated in silver, say doctors.

A study carried out by doctors at the University of Michigan, in the U.S., says infections could be reduced if hospitals bought more expensive catheters.

Catheters are used in patients who are unable to urinate or need to have their urine monitored. They are inserted into the urethra where they collect urine.

But catheters cause thousands of infections in patients. In the U.S. they account for more than one in three hospital-acquired infections.

These include painful urinary tract infections.

The risk of infection increases depending on the amount of time the catheter is inserted into the urethra.

Some patients, like women who have just given birth, use them for a couple of hours but other patients, such as those who have undergone surgery or are in intensive care, can use them for days at a time.

#### Silver kills bacteria

But the U.S. doctors say the number of infections could be cut by using silver-coated catheters.

These catheters are covered with a thin layer of silver alloy, which can kill bacteria.

They say that while the silver catheters are more expensive than the ordinary uncoated models, they can reduce the chances of urinary tract infection and the associated costs to both patients and hospitals.

decline of the physical economy of the United States, and the world. The real economy has fallen out from under the markets, which have been artificially propped up by accounting tricks, enormous and unpayable debt loads, and mass delusion on the part of the markets and the public.

Reality is now breaking through the delusion. Some people respond by closing their minds and asserting that the market will come back "because it always does". A more extreme version of this neurosis is the type who views the market slide as an opportunity to buy, forgetting that the "buy low and sell high" philosophy of J.P. Morgan and his parasitic peers made them rich not because they could read the markets, but because they could manipulate them. Then there are those who respond to the crisis by reexamining the axioms which caused them to fall under the spell of the delusions, to figure out why Lyndon LaRouche could see so clearly what they did not. It is the latter group upon which the future of mankind depends.

#### The Shape of Things To Come

We are now two years into the worst market crash in world history, with the major stock markets already down some 50% from their peaks in 2000. The markets are now back to their 1997-98 levels, but carrying half a decade's more debt, leverage, and speculation. In market terms, we have crossed the peak and are now headed down the back side of a very steep mountain. How far and how fast we fall is largely a matter of actions taken, or not taken, on fundamental economic policy. As long as the Bush Administration and the Federal Reserve maintain their Hooveresque "the economy is fundamentally sound" stance, we can expect sharp plunges, punctuated by futile attempts to bail out fictitious and unsalvageable market values.

A graphic example of how fast the markets can fall is the sharp plunge in the Dow from a high of 381 in September 1929, to the low 40s in June 1932, a fall 100 points again until mid-1933, and did not rise above 300 points until early 1954.

The rise and fall of the Dow since the 1980s bears a striking similarity to the period of the Great Depression, as can be seen in Figure 1. This was produced by matching up the peaks in 1929 and 2000, using weekly closings. The run-up in both periods reflects the process shown in LaRouche's Typical Collapse Function triple curve, in which financial aggregates rise hyperbolically to the point they become unsustainable, and collapse (Figure 2).

A similar process can be seen in the rise and fall of WorldCom (Figure 3), whose stock soared in the late 1990s and then plunged back to earth in the largest bankruptcy filing ever.

This sharp rise-and-fall curve can be seen in numerous other stock market indices, corporate stock charts, and other economic statistics, though it is often disguised by statistical manipulations and fakery. The pattern can already be seen in the stock prices of the energy pirates and the telecom and computer companies, and is nearly fully formed at semi-industrial companies such as General Electric and some of the big financial institutions. Absent the implementation of LaRouche's emergency policies, it is the shape of things to come for the United States and the world.

The comparison between now and the Great Depression can only be taken so far, however, because the danger is much greater now. Not only is the bubble relatively much larger than it was then (the Dow increasing by a factor of five in the two decades leading up to the 1929 peak, versus a factor of 15 in the current period), but a much smaller percentage of the population is engaged in farming and manufacturing, and a much higher percentage urban services and distribution chains. The population is targetting one Tiger after another, generating billions of

would flow from a full-scale economic crash. The potential political and cultural breakdowns following a crash could rapidly lead to a new Dark Age, particularly in the cities.

#### Vaporization

The rise and fall of the global stock markets since 1997-98 can be compared to the volcanic eruption of Mount St. Helens, where the top of the mountain simply vaporized; in the case of the market, trillions of dollars of market capital have disappeared. This process is reflected in the Dow Industrials (Figure 4), the S&P 500 (Figure 5), and the Wilshire 5000 (Figure 6), all of which show a similar peaking curve. The process is more pronounced in the S&P 500 and the Wilshire 5000, which are significantly broader indices than the 30-stock Dow.

In recent years, the Dow has become more of a psychological manipulation tool than an economic index, as old-economy companies were cast out and replaced by "New Economy" entertainment, information, and services firms. Today's Dow includes such "industrial" titans as derivatives giants J.P. Morgan Chase and Citigroup; American Express; computer firms Microsoft, Intel, IBM, and HP; Walt Disney Co., Wal-Mart, Home Depot, and McDonald's. Even the firms which do have industrial components have large financial operations; General Electric, for example, makes about half its profit from its financial operations, including a sizable derivatives business.

Because it contains just 30 stocks, the Dow is also relatively easy to manipulate, and the Plunge Protection **Team** has intervened with increasing frequency when sharp declines threaten to escalate into major panics. Though its actions are semi-secret, the Plunge Team's interventions are easily spotted by the classic "V" pattern in which the market plunges during the morning, then suddenly rebounds sharply during the afternoon.

Such interventions can be effective in dealing with of some 90% over two years. The Dow didn't break anomalous events within an otherwise sound system, and can even provide a temporary boost during a systemic decline—but no amount of financial stimulus can prevent a systemic collapse when the economic underpinnings of the physical economy have crumbled. There are larger forces at work than can be dealt with by Federal Reserve Chairman Alan Greenspan's bubble-blowing apparatus, especially since the money thrown into the bubble is looted from the underlying economy, making the bubble less supportable with every intervention.

#### Wall of Money

The nature of Greenspan's dilemma can be seen in the sharp run-up in the markets in the 1997-2000 period, which itself is the result of an attempt to save the system in 1997. In early 1997, British fund manager Tony Dye issued warnings of an imminent disaster in the global derivatives markets, warnings which coincided with reported but downplayed reports of derivatives problems at National Westminster Bank. Dye's warnings echoed those of LaRouche, who had warned since 1993 that derivatives speculation would indeed blow up the system.

In the over-the-counter derivatives markets, it is relatively easy to keep giant derivatives disasters hidden, because no one knows unless the counterparties tell them. Other market participants and the regulators might find out in short order, but the public is rarely told, especially when the problem is serious. Still, actions taken in the wake of a crisis can provide tell-tale signs.

In the case of the derivatives crisis of 1997, the telltale sign was the mid-1997 emergence of the so-called "Asian crisis", which was actually a currency-warfare attack on the Asian Tiger economies by Anglo-American financial interests. In typical form, the bankers were attempting to postpone their own bankruptcy by stealing lives in cities, where they are much more dependent upon from the Asians. This assault continued into 1998,

of a deeper and much more ominous process—the sharp also culturally less prepared to handle the hardships that dollars in loot and sending funds fleeing to the relative safety of the U.S. financial markets. The result can be seen in the rise of U.S. stock markets during the period.

> The game came to an abrupt halt in September 1998, when looting-target Russia caught the markets off-guard with a default on its GKO bonds and a devaluation of the ruble. The prospect of a sovereign default—the "debt bomb" policy advocated by LaRouche-sent the financial markets into panic, with investors fleeing speculative paper in favor of more secure U.S. and German government bonds. This, in turn, caused many derivatives speculators to hemorrhage money, with the markets moving in the opposite direction from their bets. Long-Term Capital Management (LTCM), the giant Nobel Laureate hedge fund, went bankrupt and was bailed out by the banks at the urging of the Fed. Many other derivatives players, some considerably bigger than LTCM, were also grievously wounded.

> In response, Greenspan and his central-banking peers launched what speculator George Soros later called the "wall of money", flooding the markets with liquidity and promises, and a cover-up of the extent of the damage. Only later would the players admit what LaRouche said at the time: that the global financial system came within a hair of melting down in 1998.

> It was this "wall of money" approach, combined with a liquidity injection under the guise of preventing potential Y2K problems and a regulatory blind eye to "creative bookkeeping", which led to the sharp rise in U.S. financial markets from late 1998 into early 2000.

> The attempt to bail out the system in 1997 led to the blowup in 1998, at which point another bailout was launched which blew up in 2000. Since then, global markets have plunged, major corporations have collapsed, pensions and retirement funds have evaporated, and the financial system is disintegrating. But don't worry, because a bailout is in the works. After all, the markets always rebound, don't they?

#### **Systemic Crisis**

The U.S. stock market bubble was actually a global phenomenon, financed in part by huge flows of investment capital into the country. Money poured into the United States during the go-go 1980s, though that flow ebbed a bit when the U.S. banking system went under (the Fed secretly took control of Citicorp and arranged shotgun marriages for the big banks) after the real estate market collapsed. To save the day, the financiers unleashed the derivatives market, unpayable debt was rolled over, and financial deregulation escalated. Changes in the tax codes allowed money that previously would have been paid in taxes to instead be gambled in the markets, and corporations used money that should have been invested in their business activities to support their stock price. The bubble soared, but the physical economy suffered, as health care, education, transportation, goods production, and research and development were all choked back in order to feed the bubble.

As the bubble grew, the cash poured in, but that process abruptly reversed after the market peaked in 2000 (Figure 7). The decline in U.S. stocks led to a decline in the inflow of foreign capital, which in turn further depressed stocks. This process was ameliorated by the strong dollar, because the rising dollar increased the profits of foreign investors as the markets rose, and reduced their losses as the markets fell. However, in 2002, the weakness of the U.S. economy has caused the dollar to fall, including a sharp fall against the euro (Figure 8).

The process defined by a falling stock market, a falling dollar, and reduced foreign capital inflows spells doom for the U.S. financial bubble—and when the United States falls, the world falls with it. Add to that the outbreaks of this systemic disease in Japan, Argentina, Brazil, Turkey, and other nations, including growing problems within Europe, and you have a prescription for disaster.

#### **Sinking Banks**

In all the corporate disasters breaking out in the uncanny regularity: J.P. Morgan Chase & Co. and Citigroup. Both were major lenders to Enron, and according to a report by the U.S. Senate Permanent Subcommittee for Investigations, both banks were active participants in Enron's fraud, using offshore affiliates to help Enron disguise loans as energy trades. Both banks lent heavily to the energy-pirate and telecom sectors, and are undoubtedly facing losses in the billions of dollars as those sectors vaporize.

J.P. Morgan Chase is the result of the acquisition of J.P. Morgan & Co. by the bigger Chase Manhattan. The deal, which closed on the last day of 2000, has been an absolute disaster as measured in ordinary-and therefore misleading—market terms. The market capitalization of the combined Morgan Chase is now less than that of Chase alone on the day before the merger, with Morgan (or at least its equivalent value) having simply vaporized (Figure 9). This is not surprising, as it was likely a bankruptcy at Morgan, and perhaps Chase as well, which led to the takeover of the aristocratic Morgan by the commoners at Chase.

The merger only bought a few months. Indications are that Morgan Chase blew up in mid-2001 and was secretly taken over by the Fed, similar to the way Citigroup's predecessor, Citicorp, was in 1989. During the fourth quarter of 2001, Morgan Chase combined its two lead banks, Chase Manhattan Bank and Morgan Guaranty Trust. As part of that process, \$125 billion in assets and \$7 trillion in derivatives simply disappeared from the combined banks' books, suggesting major financial problems. Still, with \$24 trillion, Morgan Chase has more derivatives than any other bank in the world, and more than enough to make a spectacular explosion.

Citigroup may be under Fed control as well, as rumors of major derivatives losses circulate. Citigroup is the result of the 1998 takeover of Citicorp by Travelers Insurance, creating what is now the largest bank in the United States, with just over \$1 trillion in assets and \$9 trillion in derivatives. On July 18, Saudi Prince Alwaleed bin Talal, Citigroup's largest individual shareholder, said that he had invested another \$500 million in the bank, raising his holding to \$10 billion. Alwaleed, a nephew of Saudi King Fahd, obtained his initial stake in the bank shortly after the Fed took it over in 1989 and began arranging a bailout. The latest cash infusion raises suspicion that Alwaleed is performing a similar service for Citigroup.

Not to be left out is Bank of America, whose \$620 billion in assets puts it third behind Citigroup's \$1 trillion and Morgan Chase's \$713 billion. Bank of America's \$10 **trillion in derivatives** puts it solidly on the hot seat in any financial crisis, and it has also loaned heavily to bankrupt companies. Rumors are flying that Bank of America has applied to the Fed for a secret bailout.

If the Fed winds up running the three biggest banks in the country, who's going to bail out the Fed?

Mutual funds, pension funds, and insurance companies are also big holders of stocks and have been hard hit by the decline. There's a lot more damage out there than has been admitted so far, and the hemorrhaging is continuing.

#### **Pompous Pundits**

Those tempted to listen to the siren calls of "recovery" and "sound fundamentals" emanating from the canyons of Wall Street and the nation's capital would do well to recall the comforting assurances given by the pundits and politicians in the period immediately before and just after the crash of 1929:

#### "CONSPIRACY THEORY" GAINS NEW CREDIBILITY

You didn't hear about this on the national news, CNBC, or in your local newspaper. After all, most of these controlled/scripted sources of "news" are still trying to keep us all believing that all is well with the world, even as the stock market and economy show new cracks. For all its obvious faults, "the system"—i.e, the fractional reserve monetary system administered by the Federal Reserve—is still sound, according to these pundits. Thus, and in spite of the rally in gold and gold stocks in 2002, the press will usually go out of its way to dismiss gold as either a viable investment alternative or as having any relevance to today's financial and monetary structure.

With this mindset, our press saw fit NOT to cover a news story that broke recently which should have made the front pages of at least every financial publication. It's a story that has much more to do with the financial markets generally than one merely of interest to "gold bugs". And it's one which—if the warnings inherent in it ever come to pass—could lead to the insolvency of a number of major institutions, and devastate global financial markets.

From time to time in my newsletter The National *Investor* (www.nationalinvestor.com), I have commented on the ongoing efforts of GATA (the Gold Antitrust Action Group-www.gata.org) to bring to the light of day their contention that gold prices have been artificially controlled by a cabal which includes our own Federal Reserve. In short, GATA has assembled considerable evidence that various financial institutions have made a bundle of money in recent years by betting on the decline in the gold price. This was done in a variety of ways; "short sales" of borrowed gold from central banks, hedging on the part of some major mining companies and the creation of complex derivative transactions among them (to understand the intricacies of this, I suggest you visit the above-referenced Websites). Until recently, these bets paid off handsomely, as gold went from over \$400 per ounce in January 1996 to lows around \$250 per ounce more recently.

The trouble now is that, with gold prices having institutions face potential disaster. It has been reported, for

related derivative contracts; these instruments could destroy Morgan's overall financial health in the event the gold price were to spike considerably higher. Thus, to protect Morgan and certain other financial houses in the same boat to one extent or another, it has been claimed that the world's central banks—led by the Fed—are now conspiring to keep the gold price from rising too much. Further, the way this effort is being conducted has opened up the entire financial system to a potential meltdown if the bankers fail in their suppression efforts.

Meanwhile, a financial time bomb with possible ramifications extending well beyond the gold market itself continues to tick.

However, the recent publication of a March 2002 report obtained by GATA has given significant new credibility to the group's claims. It has also made some people in the financial world extremely nervous.

It seems that well-regarded mutual fund manager John Embry of Royal Bank of Canada authored a report on the gold market for his peers at the bank early this Spring. In it, he offered his viewpoint that—among other things there has indeed been a "conspiracy" to suppress the gold price, the suppression has been engineered chiefly by the U.S. Federal Reserve—and that the Fed is scared to death that it could lose control and have tens of billions of dollars worth of gold-related derivatives to clean up one day. Somehow, this report made its way outside the four walls of RBC, and ended up in the hands of Bill Murphy at GATA. Needless to say, Murphy has spread Embry's report far and wide. I would too, if I were him; after all, Embry is one of the most highly regarded money managers in North America. His firm is not some local coin shop where local militia members come to talk conspiracy over coffee all day long, nor is it the publisher of one of the many sales-oriented newsletters that hawk gold come Hell or high water. It is one of the biggest financial companies in Canada.

For their part, embarrassed (and quite angry) Royal Bank officials were quick to claim that Embry's report does not represent the bank's views. Instead, this was a report meant for other managers and big shots at RBC, and was not intended for public consumption, they say. Bottom line, the bank is hopping mad that, of all the people who got their hands on this, it was Bill Murphy. (NOTE: Murphy claims that this report also went to some of the "biggest and best" clients of the bank, one of whom forwarded it to him.)

Embry cannot be dismissed, however—and he is respected enough that this report is turning some heads as more people read it. As Matthew Ingram of Toronto's Globe and Mail put it in one article on this crazy story, getting such a well-regarded money manager from a major bank to essentially agree with what GATA has been saying for a few years now is, "... a bit like the U.S. government admitting that yes, there was a top-level CIA plot to assassinate former president John F. #### U.S. INTEREST RATES 'COULD HIT 1930'S DEPRESSION LEVELS'

Wall Street rallied dramatically yesterday on hopes that the U.S. Federal Reserve will deliver a shot in the arm to the American economy next week with an interest rate cut.

The Dow Jones index finished the day up 230 points at 8,274. In London, the FTSE 100 index of leading shares also rallied, closing up 134.6 at 4131.0. Major U.S. investment banks are queuing up to forecast cuts in U.S. interest rates.

Lehman Brothers said yesterday it had seen "enough economic and financial pain" and was changing its forecast. "The precise dimensions of such a move are hard to pinpoint, but our main scenario is a quarter point cut at the September, November and December meetings, pushing the funds rate down to 1%," said Lehman.

That would leave U.S. rates at their lowest since the Depression era of the 1930s. Goldman Sachs also believes U.S. rates could be cut next Tuesday, when the U.S. Federal Reserve's open market committee meets.

However, at 1.75%, U.S. interest rates are already at a 40-year low and Peter Dixon, an economist at Commerzbank, said some traders were guilty of wishful thinking yesterday. "There could be another cut in U.S. rates," he said, "but I am not expecting one until October. You must remember that this is August and markets are very thin."

Mr. Dixon cited the U.S. Federal Funds Futures contract, which is traded at the Chicago Board of Trade. The contract for September was trading at 98.33 yesterday, indicating that no change is expected by a market that watches the Fed's moves very closely. However, the October contract is forecasting a cut.

The dollar also had a strong day against most major currencies as funds flowed into the U.S. stock market. The dollar's strength struck a blow against the pound, which dropped sharply against the U.S. currency in its worst day's trading for more than five years.

By the close in London the pound had fallen 3 cents against the dollar, to end at \$1.5383. Some currency analysts said that although there is a growing view that the U.S. economy will suffer a so-called "double-dip" recession, it could recover faster than the UK as the U.S. authorities have taken swifter action.

"Today's situation is because of the dollar and interest rates," said Ryan Shea of Bank One. "The U.S. recovery will be quicker than in the UK economy." The International Monetary Fund produced its latest forecast for the U.S. economy yesterday and said it expected growth to accelerate from 2.5% this year to 3.25% next year.

However the trade-weighted index, which measures the pound against a basket of currencies, showed it almost unmoved, dropping from 106.8 to 106.7, as it gained slightly against the euro to 62.69p. The euro was also weak against the dollar, slipping more than two cents to 96.43.

Today, the Bank of England releases its quarterly inflation report. The minutes for this month's meeting of the monetary policy committee, when rates were left at 4%, will also be published.

Economists will be watching to see if Mervyn King, deputy governor of the Bank, repeated his lone stance of July when he voted for a rate rise.—http://www.telegraph.co.uk/money/main.jhtml?xml=/money/2002/08/07/cndow07.xml&s

# What They Don't Say Can Really Help You

Budget's "Tip of the Week" #5:

Key provisions NOT included in Nevada's corporate statutes

In the first four installments of "Tip of the Week" we took a close look at several very interesting provisions of Nevada's corporate statutes. Sometimes, however, what is NOT mentioned in the statutes is just as important.

In Nevada, as many readers may be aware, there is no statute mandating the issuance of stock. (Nevada is not unique in this regard; several other states' corporate statutes similarly ignore this key issue. What makes Nevada unique is the combination of statutory provisions, non-addressed key issues and actual practices, all of which add up to make Nevada the ONLY state that allows for privacy of ownership and control of a corporation.)

As if to underscore the non-necessity of stock issuance, there is no requirement to hold an annual meeting of stockholders. Yes, there are many references to the stockholders' meeting but nowhere is it stated that any such meeting must be held.

Similarly, Nevada is one of a few states that does not nullify the use of "bearer" shares. It is not that there is a statutory provision endorsing the use of bearer shares or even addressing the issue; it is that the issue goes entirely unmentioned, whereas in most other states the use of bearer shares is statutorily denied.

A major, major issue that is not addressed anywhere in the *Nevada Revised Statutes* is that of **nominee officers and directors**. The use of nominee officers and directors has been common in practice in Nevada for more than 75 years and yet this issue, which is the key to privacy of control of a Nevada corporation, is simply not mentioned. Doesn't that make you wonder why not?

Other states (Wyoming comes to mind) have directly addressed the issue of nominee stockholders. In Nevada, however, there seems to be more power granted by not restricting the use of this technique even by defining it.

Nevada only requires a corporation's primary officers to be listed annually but does not abridge the key roles that can be afforded to **secondary officers**, such as a vice president, who may exercise all of the powers of the president in the president's absence; an assistant treasurer, who may be empowered to sign checks and otherwise fulfill the role of treasurer; or an assistant secretary, who may perform all of the duties of the secretary. When nominee service is used, the primary officers are assuredly absent, empowering these secondary officers, who are never listed in the public records with the Secretary of State.

Finally, since only an annual list of officers needs to be filed, a corporation may change its officers and directors at any time through a proper resolution (a PROTECTED "internal" record of the corporation) without notifying the state to modify the public record.

This listing is, of course, by no means all-inclusive. We trust, however, that it provides the reader with a lot of serious "food for thought" as to possibilities for private control and ownership of Nevada corporations.


