The program would evolve a highly complex, very effective, ever-improving science and technology of mind and behavior control and engineering mechanisms, complete with finished database and developed applications

Summing up his paper Bearden speculates on [H: I would comment on this statement, what the actual situation the science of secrecy with which this knowledge has been kept from the public has led to the current farce of the "government" pretending it all does put us at great risk.

> "The implication is that in the West one or more highly classified, sustained, heavily funded developments in advanced mind-control programs probably exists and probably has existed for some time. Due to loose formation of rogue groups inside such programs, they may have dual or triple purposes, may not operate under very much legitimate government control at all, and may operate specifically for the purposes of the rogue group or groups that have gained control.

They are always seeking to increase their power, control, influence, prestige, etc. Nothing else. Patriotism and mission are—to rogue groups—often just idle words. They have their own agendas. ECOLOGIST SNAGS RELIGION AWARD— **NOBEL PRIZE!**

Religion's "Nobel Prize" goes to an ecologist, Charles Birch, an Australian "eco-philosopher" (I knew all of you knew that!). He is a co-winner of one of the world's biggest cash prizes: the Templeton Prize for Progress in Religion.

To save the planet, says Professor Birch, people's perception of God and creation need to change.

"There's something wrong about the way we're operating in the world. Industrialization is despoiling the planet. We're annihilating 1,000 species a year. When you ask what is wrong, it comes down to there's something wrong about our values."

As a maverick biologist, Birch was an early prophet of environmental degradation. His pioneer work, The Distribution and Abundance of Animals, outlined in 1954 the implications of unfettered population growth.

He is touted as one of the two or three most distinguished ecologists in the world. He is the son of a Methodist minister and has a less-trumpeted reputation as a radical Christian theologian. For almost as long as he has been a scientist, Birch has engaged in the "adventurous reflection", of questions relating to God and biological science. Oh my, no wonder you people have problems.

Humanity's "flawed" values stem from a general view of the Earth as a material stage filled with objects created for man's comfort and advancement, is his projection, and so good so far. "Ever since the rise of science in the 17th Century, the model of the universe that people have tended to support is a very materialistic, mechanical model." The universe is seen as "an object made in the past, out of material building blocks, now running itself", with God outside it.

"But modern science is starting to see that it can't reproduce our world with a building-block model, there's something mental in existence—in our life—which we let slip through our fingers in the past. From protons to people, you have to look at them more as subjects rather than objects. Then you can see much more easily the relationship of God, not just human beings, but to all of Creation. That is because God can be incarnate in life, but God cannot be incarnate in machinery."

This perspective, it would seem, gives all life forms, not mankind alone, inherent worth. And while Birch welcomes the recent upsurge in public awareness of environmental issues, he chastens conservationists for continuing to campaign on the anthropocentric ethic: "Look after Nature, then Nature will look after us."

"I want them to be concerned for animals whether or not they're useful to us. They are subjects, not just objects.

"The \$64,000 question is: 'Where did subjectivity begin in the whole of cosmic evolution?' Most biologist would say, 'Oh somewhere below mammals. Birds, maybe. Certainly not frogs...!' There's a big problem in that approach, because you're saying mind and consciousness and all the characteristics of life have come out of something which is totally non-living, totally non-mental. The alternative approach is to say in some form or another the mental or the sentient was right there from the beginning. That's a different perspective."

MAJOR TARGET

The Guyana missile base was one of the major own personality and become what your Unseen Rulers targets of the revised planning. This meant that joint special armed forces could be set down near the perimeters of the missile base and later recovered, along with casualties, with relative ease. And as the reporters at the Temehri Airfield watched helicopters leaving to the northwest and return from the same direction, they were led to assume that all were going to and from Jonestown some 150 miles away. They had no way of knowing that many of the flights were to and from the Russian missile base, which lay in the same direction but only half as far distant.

IN THE BEGINNING OF THE SCHEME

When it was decided to use mass deaths at Jonestown as a cover for the missile-base attack, Jonestown was functioning only as an outpost of the People's Temple. There were not enough people there to provide a sufficiently major incident to serve the intended purpose, and so, through both direct and indirect means, Jim Jones was persuaded to go to the Guyana kibbutz himself, taking as many of his flock as would follow him. That turned out to be about 25% to 30%, and by following him they automatically identified themselves as the group most highly dependent upon Jones personally. They were also most susceptible to the combined influences of exhaustion, intimidation, and isolation from outside help—in other words, just right for thorough brainwashing.

Ever since the days of the Korean War it had known conclusively that brainwashing techniques can cause many people to do all kinds of things. Even hardened American GIs in Korea fell victim to brainwashing in surprising numbers because they did not understand what they were up against. But, of course, the Jonestown victims were anything but hardened soldiers.

In August 1977 Jim Jones left for Guyana with his large sacrificial flock. That same month, United Nations Ambassador Andrew Young carried a message to Prime Minister Forbes Burnham of Guyana. He said that under certain conditions the United States and the World Bank would increase its aid to Guyana-that is, line Burnham's pocket by a factor of ten times more than previous levels. THE BATTLE: THANKSGIVING DAY 1978

Close aides of the late Congressman Leo Ryan have reported publicly that his ill-fated decision to go to Guyana was triggered by a State Department report to him that he found totally unsatisfactory. This reaction of Ryan's had been correctly predicted and, in fact, deliberately encouraged. With elections coming up, Congressman Ryan decided to schedule the trip after the election during the congressional recess.

This was a quite natural decision, and had also been anticipated by the planners behind the scenes. No politician would miss the opportunity to campaign right up to election day.

As the time approached for his trip, the false issue of the Cuban MIG-23 crisis erupted. The Carter Administration had learned nearly a year prior that the Russians were going to send the MIG-23s to Cuba and decided that it would be a perfect pretext for a fake crisis. The MIG-23 can carry certain types of nuclear weapons as claimed; but even in this role it is a tactical weapon best suited for support of ground or naval forces.

The MIG-23 in and of itself does not threaten America in the same way that the 1962 Cuban missiles did; and so when the United States began playing up the MIG-23s, it was very obvious to the Kremlin that this was a deliberate effort to stir up public tension over Cuba. Instead, many witnesses were left alive, and a smaller plane managed to take off right after the airport massacre and report the attack in the capital, Georgetown.

Immediately world attention was focused on Guyana, and meanwhile the mass murder at Jonestownwrongly called a mass suicide—was underway.

COUNTERS AFRAID OF DISEASE

The Guyanese troops were afraid of possible disease but counted the bodies as accurately as possible without close handling or moving the bodies. The total they reported was 409 on that Sunday night. The initial impression of a mass suicide was seized upon by the controlled major media of the United States. Without waiting for an investigation, the media drummed away at the suicide image of Jonestown as if it were a proven fact. After a few days a few people did begin to raise questions, but by then the initial image of suicide had served its purpose of opening Guyana's doors to the United States.

For example, on Tuesday, November 21, Jim Jones' surviving son, Steven, said in a Georgetown press conference, "There's no way it could have been mass suicide." And that same day, according to the Washington Star, a Guyanese source pointed out a serious medical discrepancy in the Jonestown kibbutz death scene. He said, "If you die of cyanide, which seems to have been the poison, your body goes into spasm and contortion death, but at Jonestown everyone looked totally relaxed."

The reason for this discrepancy was that by the time the Guyanese troops arrived, all the bodies had been rearranged. They were also placed face down for the most part. This was so that the widely publicized news photos would not ruin the desired impression of calm by letting you see the victims' final expressions of agony.

THE NIGHTMARE CONTINUED

Russians, the United States at first publicly urged Guyana in to give the bag a reasonable appearance. to collect and bury the hundreds of bodies. As arranged, and that America should take the bodies back to the United States—just as planned. To facilitate this huge and hideous task, Guyana obligingly agreed to waive the usual Guyanese law that requires any body to be autopsied before removal from the country. With this arrangement, the United States achieved the carte blanche military access to Guyana that was needed.

Russian intelligence realized what was afoot by early Monday, November 20, but it was already too late to stop it. Russia could hardly announce to the world that, "We have a secret nuclear missile base in Guyana and the United States is getting ready to destroy it." That would have rallied world opinion behind America; and, although Russian Cosmospheres quickly converged over Guyana, they, too, were useless in the covert conditions of battle there. Their Charged Particle Beam Weapons could have made short work of the commando-style forces, but in the process they would have wiped out the Russian base itself. The Guyana missiles have become only a minor factor in Russia's military power since the Battle of the Harvest Moon the year prior. They were not valuable enough to Russia to declare open war on their account. And so under these conditions, Russia was powerless to act once the Jonestown tragedy had been staged.

As Thanksgiving Day approached, huge American transports, helicopters, troops, and medical teams swarmed into Guyana. In a remote corner of the huge Temehri Airfield a command post was established for the twin operations of Jonestown and at the Russian missile base.

As some of the troops began the nauseating task Meanwhile, day after day the death count reported at Jonestown remained unchanged at 409.

Then on Thanksgiving Day itself, the Battle of Guyana took place. Crack military forces experienced in jungle and surprise warfare moved in on the Russian complex, striking all the dispersed sites simultaneously. Like the Entebbe raid, the battle itself did not last long. It had to be over quickly to be successful.

First the small crews on site near each missile were overwhelmed, and then killed. The missiles themselves converged on the Missile Command and Control Center, where a bloody pitched battle took place.

When the smoke cleared, every single person manning the missile base had been killed, including the Russian commanders.

When the battle was over, American helicopters from Temehri Airfield began landing within the ruined missile complex and flying out the wounded. Then the remaining attackers were left with two more jobs before they could retire from the area. First, they were under strict orders to leave no bodies in the attacking forces on Guyanese soil, and so the entire area was scoured until every single member of the attacking force had been accounted for. Their bodies, like those of the victims at Jonestown, were sealed in Vietnam-type body bags and collected in clearings where helicopters could land to pick them up.

Finally, the combined forces were under orders to remove the nuclear warheads from the missiles and take them back to Georgetown for airlift to the United the initial attacks on the missile crews.

had been removed. They, too, were placed in body To continue the nightmare charade to fool the bags, one per bag, with some jungle foliage stuffed

Of course none of this was apparent to the reporters Guyana replied in effect that it was America's problem at Temehri Airfield, whose access to the American Command Post there was carefully controlled. When wounded members of the attacking force were flown back to the Airfield, after the Battle of Guyana on Thanksgiving afternoon, they were kept out of sight of the reporters. Otherwise, when reporters occasionally saw body bags being moved from place to place they just naturally assumed that all contained victims from Jonestown. They had no way of knowing that some contained slain Commandos and that others contained Russian nuclear warheads. The continual cargo of death from the Jonestown kibbutz made the perfect cover for the aftermath of the Battle of Guyana.

WHERE COULD THEY TAKE ALL THOSE BODIES?

Many reporters were totally puzzled at the choice of Dover Air Force Base in Delaware for the Guyana airlift. Most of the Jonestown victims were from California, and there is a mortuary facility, similar to the Dover facility, at Oakland Air Force Base in California. Dover was chosen to facilitate transfer of the Russian nuclear warheads to the nearby Aberdeen Proving Ground and Arsenal. This was done by means of shallow flights from Dover to Phillips Air Force Base.

Originally the Guyanese count of 409 had been had raised questions as to where the rest of the one thousand or so residents reported to be in Jonestown had gone. Finally, on Thanksgiving Day, with the body cleanof cleaning up the Jonestown kibbutz, other joint up operation well under way, a military spokesman told attack forces were taking up positions around the reporters, "The evaluation that we have made is simply that which was designed to prevent his being followed; but missile base in preparations for the surprise raid. there were not many more people in Jonestown at the time of the suicide." There were larger adults that were grouped together, and under their bodies were found the bodies of smaller adults and children."

> Badgered by incredulous reporters, the Government embellished the cover story later on. The Washington Star quoted the same spokesman as saying Friday night: "Near the center of the pile of bodies, near the assembly hall they were three deep in some areas. They were in layers with blankets between them." Wasn't it just nice of all those people to fall over in well orchestrated and neat rows?

This story was so unbelievable that within two days the United States Government dismissed its own story about the blankets as a "rumor". Still the basic idea of bodies on top of bodies had to be maintained, so on Saturday, November 25, another Air Force spokesman tried to make States. AND HOW DID JONES MANAGE TO GET OUT?

The plans for removal of Jones were laid well in advance. An ocean-going boat, well stocked with supplies and money, was waiting for him near the river town of Bartica, 35 miles southwest of Georgetown. In order to make his way to Bartica from Jonestown, Jones had a Safe Conduct Pass.

In the early morning of Thanksgiving Day, as the accepted as firm by United States officials in Guyana. That Battle of Guyana was beginning, Jones headed down stream toward Georgetown. Shortly after noon Guyana time his boat left the mouth of Essequibo River into the Atlantic Ocean.

His route took him eastward to Tambacounda (Senegal); from there onward into Mali with stops at Segou, Mopti and Gao; then onward to Agadez (Niger) and Largeau (Chad). From there his plane continued to Atbara (Sudan), and then a short final hop to Port Sudan where he arrived shortly after 4:00 A.M., November 30, local time. When he arrived at Port Sudan, Jones found a Turboprop Executive Transport waiting for him which was owned and operated by Israeli Intelligence. Within 20 minutes the plane took off with Jones and headed up the middle of the Red Sea toward the Gulf of Agaba. At 6:30 A.M. local time on November 30, Jones' plane landed briefly at Elath, the back door to Israel; then on to a private airport outside of **Jerusalem**, arriving at 7:20 A.M. local time. From there he headed to a nearby location for an intelligence debriefing.

HOW COULD THIS HAPPEN TO AN EVANGELIST?

After being transformed gradually into a conscious agent of the Intelligence Community over the prior six years, Jones had taken part in a joint operation by American and Israeli Intelligence in Guyana. The village administration provides all their needs. The adults eat together in a dining hall, but married couples and single persons have private sleeping quarters. All children are raised together in a separate home. Parents visit their children for an hour or two before supper."

U.S. FORCES GET OK TO USE CIA METHODS

American commandos hunting Taliban and al-Qaida guerrillas in Afghanistan have gained permission to employ new clandestine tactics that typically are confined to the CIA in the shadows of war.

recent weeks the covert warriors received authority from commanders in the United States to conduct "source operations", a special-operations term for a number of classified war tactics.

maintaining spies within the enemy's camp. In Afghanistan, it will mean finding Afghans and Arabs, possibly within the Taliban and al-Qaida network, who would supply intelligence to U.S. special-operations forces.

But source operations also refers to a number of other classified tactics that can be employed in the Afghanistan-Pakistan theater. The U.S. military estimates there may be 1,000 or more of Osama bin Laden's terrorists still on the loose in the region.

The authorization is part of a much broader plan to toughen the war against terrorists by allowing commandos to do more clandestine missions in more places overseas.

In July, Defense Secretary Donald H. Rumsfeld ordered U.S. Special Operations Command in Tampa, Fla., to accelerate the war against al-Qaida and other terror groups by devising a new war plan. Mr. Rumsfeld, who wants al-Qaida members captured or killed at a faster rate, desires a mechanism for the United States to identify and locate terrorists, then dispatch covert warriors in a matter of hours, not days or weeks.

"They are going to use some special-forcesunique skills to track them down," said a military officer involved in war planning who asked not to be named. "There are certain skills and capabilities that are not publicly associated with special forces."

An administration source said, "There are some initiatives that are very, very sensitive."

Source operations may involve finding spies or using a released detainee to spread disinformation.

A second military officer said in an interview that source operations mean that Army Special Forces soldiers, the Green Berets, will shift from informal contacts with local informants to a more structured relationship that could involve exchanging money for information and regular meeting times and places.

"It's making friends and giving them a tip for a tip," the officer said.

Any significant information would be turned over to the CIA, which has officers and paramilitary people deployed throughout the region.

Commandos in Afghanistan are part of the Combined Joint Special Operations Task Force that has headquarters near Bagram air base north of Kabul, with camps near Kandahar in the south and Khost in the east.

The task force is a combined force of Army Green Berets, Delta Force and Navy SEALs, including its crack counterterrorism unit, the naval special-warfare development group that used to be known as SEAL Team Six. Foreign nations, including New Zealand and Australia, also assigned some of their best "hunters and killers" to the group.

SEN. GRAMM SET TO JOIN UBS WARBURG

NEW YORK (Reuters)—Sen. Phil Gramm (R-Tex.) will soon become vice chairman of UBS Warburg, the investment banking arm of Switzerland's biggest bank, UBS Warburg said on Monday.

Gramm, who will take up the private sector post when his Senate term ends later this year, follows a well-trodden path of key legislators who join top Wall Street firms. A member of Congress for the past 24 years, Gramm has specialized in financial issues and co-authored historic legislation in 1999 that repealed a prohibition on companies offering banking, brokerage and insurance operations under one roof.

Known as the Gramm-Leach-Bliley Financial Services Modernization Act, the legislation gave rise to the "one stop shopping" model adopted by such financial powerhouses as Citigroup Inc. C.N and J.P. Morgan Chase & Co. JPM.N. The results of those diversification efforts have been mixed however, and critics charge that such breadth engenders damaging conflicts of interest.

Gramm, 60, will split his time between Washington, D.C. and New York, and will work closely with Vice Chairmen Lord Brittan and Ken Some units have complained they are not getting good Costa, who are based in London, UBS Warburg said.

UBS Warburg is part of UBS AG UBS.N UBSZn.VX, which has more than 70,000 employees worldwide and does which formally installed Bush into the Presidency, and business in more 40 countries. As an investment bank, UBS Warburg specializes in areas such as stock and bond offerings, corporate lending and merger advisory.

"Having spent my professional life working on financerelated issues, I look forward to bringing that experience and knowledge to bear on behalf of UBS Warburg clients worldwide," Gramm said in a prepared statement.

A UBS Warburg spokeswoman, Christine Walton, declined to comment on Gramm's compensation package, citing firm policy. The senator's starting date depends on the Senate schedule, but will come before year-end, Walton said.

Global banks seeking to enhance their cachet often court top U.S. political figures, whose knowledge and contacts can widen their scope.

Last December, Citigroup named Stanley Fischer, former deputy managing director of the International Monetary Fund (IMF), as vice chairman. Fischer reports to former U.S. Treasury Secretary Robert Rubin in that position.

In another example, John Kasich, former chairman of the U.S. House Budget Committee, went to investment bank Lehman Brothers LEH.N early last year. And Vernon Jordan, a well-known Washington lawyer and confidant of former U.S. president Bill Clinton, took a job at private investment bank Lazard Freres & Co. in 2000.

Gramm plans to meet in coming months with heads of various investment banking sectors at UBS Warburg to develop strategy, Walton said.

"We hired him for what he knows, not who he knows," Walton said. "It's very much a full-time job."

IN THE 2002 ELECTION, THE ISSUE IS UNCHECKED POWER

Is this the most important election in U.S. history? With his TV talk of war, George W. Bush has blown smoke over what's really at stake today: the future of democracy. Not in Iraq—here in the United States.

Never in U.S. history have we ever been closer to an unchecked one-man one-party rule than right now. And as the world's sole military super-power, we have made the crisis truly global.

The reality is simple: the right wing of the Republican Party controls three of the four branches of government, and is just a single vote away from taking the fourth. The Executive, the Judiciary, the media and the House of Representatives are all in Republican hands. The Senate teeters on the edge. And the USA Patriot Act, passed in the wake of September 11, has obliterated most of the Constitutional guarantees that made this country a democracy in the first place.

Should Congress go Republican in November, there will be no institutional check or balance left to guarantee that the democracy born here two centuries

First, the Republicans control the Executive Branch, which it took with the first losing candidate in 120 years. agenda that's kept the opposition off balance.

which is currently dominated by right wing appointeesmany for life—dating back to the Nixon Era.

Third, the Republicans control the "fourth branch of government". Virtually all major U.S. media is now owned by six corporations. With precious few exceptions, there is no serious debate on the core issues that define American life, and no mainstream coverage of the movements for peace, social justice, environmental, labor, or minority rights to balance the constant blare of right wing pundits.

All that remains in play—barely—is the Congress. The U.S. House is firmly in control of the Republican Right. The minority Democratic opposition is feeble, without strong leadership or direction.

Thanks to the defection of Jim Jeffords of Vermont, the Democrats hold a one vote majority in the U.S. Senate. And that's all that now keeps the Republican far right from total and unchecked control of every branch of the United States government.

To this lethal mix has been added the USA PATRIOT Act, approved after September 11, virtually obliterating the once-sacred guarantees of the Bill of Rights. Put simply: the Executive Branch now has the power to arbitrarily brand anyone a "terrorist" with no tangible evidence, and to have that person imprisoned without formal indictment, access to a lawyer or even public notification. Hundreds of unnamed alleged terrorists are thus being held indefinitely in Cuba and perhaps elsewhere with no recourse. If unchecked, such openly contemptuous disregard for the human rights guaranteed in the U.S. Constitution will inevitably spread like a cancer to the core of American liberty and dissent.

The structure of our basic rights is as tenuous story of one who did all he could to sell out this under George W. Bush as under many of the Third World dictators installed by his father when he was head of the CIA.

> Any shreds of counter-balance left in the system will disappear if the Republicans keep control of the U.S. House and retake the Senate.

BRITAIN RE-IMPOSES DIRECT RULE ON NORTHERN IRELAND

HILLSBOROUGH, Northern Ireland (Reuters)— Britain seized back the reins of government in Northern Ireland on Monday amid a crisis in the peace process provoked by a spying scandal, but vowed to try and restore home rule early next year.

After halting the province's power-sharing government with a stroke of his pen, Britain's Northern Ireland Secretary John Reid said he regretted the return of direct rule from London and hoped it would be "a short-lived impasse".

"I hope the decision...marks a breathing space and a chance in a sense to gather strength and to regather confidence," Reid said at his Hillsborough Castle residence outside Belfast.

Both the British and Irish governments will now be working frantically behind the scenes to edge Northern Ireland's politicians toward a compromise that will allow them to restart the stalled process.

British Prime Minister Tony Blair and his Irish counterpart Bertie Ahern, who have both invested much personal and political capital in the 1998 Good Friday peace agreement, said their governments were 'saddened" by Monday's events.

In a joint statement, they promised to seek a restoration of devolution before Northern Ireland Assembly elections next May, and sent a message to the Irish Republican Army, against whom allegations of spying precipitated the current crisis. ...

The hard-line Protestant Democratic Unionist Party, led by preacher-politician Ian Paisley, declared the Good Friday deal over. Britain should start over again rather than trying to "pump oxygen into a failed process," Paisley told reporters. ...

At the other end of the political spectrum, Gerry Adams, leader of the IRA's political ally Sinn Fein, accused Reid of pandering to unionists who wanted to see the power-sharing arrangement set up under the 1998 deal fail.

"It is a serious crisis," he said. "What he (Reid) is doing is accommodating resistance to the Good Friday agreement."

This was the fourth suspension in three years of the assembly and other Catholic/Protestant power-sharing institutions, and the feeling was widespread that it will take longer this time to get the bickering factions back together.

The longest prior freeze of the institutions was three months and was resolved by an IRA move toward decommissioning.

IMF MAY CREATE COURT TO SHIELD NATIONS FROM CREDITORS

GENERAL TAKES SHOT AT SMART BOMB USE

WASHINGTON-Nothing was more comforting to U.S. troops scrambling over the slopes and ravines of Afghanistan's Shah-e-Kot Valley in March than the explosive arrival of American precision-guided bombs hitting enemy positions.

"We knew that until we could demonstrate facts and figures, the people wouldn't believe it," Mr. Kyl said, pointing to the border study. "The losses are staggering and more people are beginning to recognize that a problem exists."

The lawmakers, in arguing for financial assistance from Washington, said that because the federal government had mandated that illegal aliens must be treated at emergency facilities and because it had failed to control the border, allowing illegal immigrants to flood into the United States, the government was responsible for the rising costs.

"The obligation here falls on the federal government," Mr. McCain said. "The states do not control the border, the federal government does and it has failed to do so-causing a financial and human crisis."

Hospitals in Arizona are among the hardest-hit by the uncompensated care for illegal immigrants. Last year, University Medical Center in Tucson provided nearly \$8 million in emergency medical care to illegal aliens and the Copper Queen Hospital in Bisbee was net operating income of \$300,000.

The root of the problem, Mr. Kolbe said, is "an unreasonable" policy of the U.S. Immigration and Naturalization Service, which oversees the U.S. Border Patrol.

"The Border Patrol has an existing health care delivery system for illegal immigrants; however, illegal immigrants must be in the custody of Border Patrol to qualify for reimbursement," he said. "To complicate matters, Border Patrol has an explicit policy of not taking injured illegal immigrants into custody, so they do not have to reimburse the hospitals."

WHEELS COME OFF U.S. WAR PLANS FOR IRAQ

Administration Making Riskier, More Volatile Moves To Begin 'All or Nothing' Gamble For Iraqi Oilfields

(FTW)—All over the world, both internationally and here at home, the wheels are coming off of the Bush Administration's plans for the invasion and occupation of Iraq. And Bush Administration responses to recent events appear to be moving a tense international situation into a new phase where chaotic, scattered and increasingly bloody violence may spread risk to civilian populations and the estimated 80,000 to 100,000 U.S. troops that have been forward-deployed in anticipation of the attacks for months. U.S. troop deployments in Kuwait, Qatar, Saudi Arabia, Jordan, Egypt, Kyrgyzstan, Uzbekistan, Georgia, Djibouti, Yemen, Afghanistan, Pakistan and a Kurdish-controlled region of northern Iraq—once offensive staging points or strategic postings—are now becoming vulnerable defensive liabilities as world sentiment mounts against the U.S. invasion. Britain is also reported to have troop deployments in Oman on the Southeast tip of the Arabian Peninsula.

At stake is a nation which holds 11 percent of the world's oil and which is one of only two nations capable of quickly increasing production in time to avert a major economic collapse for the U.S.

A recently reported coup attempt in Qatar, perhaps the most vital country to a successful U.S. invasion plan, has raised serious questions about whether the administration can afford to wait much longer without risking the entire collapse of both its prestige and a plan which has recently been shown to be years in the making.

The assassination today of the head of the U.S. Agency for International Development (USAID) in Amman, Jordan follows on the heels of recent attacks in Kuwait, the Philippines, South Korea, Pakistan, Afghanistan and Bali, most of which have been reportedly linked to terrorist organizations sympathetic with Osama bin Laden's al-Qaida An interpretation not offered by the network. administration—but which has been voiced by some Islamic foreign nationals contacted by FTW—is that the flimsy justification for invasion offered by the U.S., along with minimal or no connections to al-Qaida.

Washington Post story, "Timing is everything when you do this. If you launched [a public campaign] too far in readiness test of the headquarters facility. advance and nothing followed, that would raise questions for months, you pay a worse price." Perle's prediction is coming true just two months after he made it.

In spite of routine denials USAID has regularly been linked to the Central Intelligence Agency and has reportedly served as a cover for CIA operations. Jordan remains a particularly sensitive country for the U.S. because of its geographic position between Israel and Iraq, its perceived status as a U.S. ally, and the fact that as many as 6,000 U.S. troops have been positioned in Jordan since late-August in anticipation of the U.S. invasion. FTW reported on Aug. 21 that the total number of U.S. troops, as reported by the Jordanian news agency Petra and other Mid East news sources had topped 6,000 and included light armor, medical detachments and Special Forces troops. An on-the-record eyewitness statement confirmed visual sightings of U.S. troops in the country.

Jordan, like many other countries in the region, has been sending ambiguous signals about the role it will or will not play in the U.S. invasion. These mixed and often changing positions, shifting like the sands of the desert, clearly reflect the tectonic pressures that are mounting in the region each day that an invasion is not executed. A Reuters story on Aug. 12 indicated that Jordan was being considered as a launch point for the Iraqi invasion at a time when the Jordanian military was engaging in joint exercises with U.S. troops. However, a July 10 Associated Press story indicated that Jordan would not participate in any U.S.-led invasion.

Amid repeated stories that the U.S. intends to "Balkanize" the region, splitting Iraq and possibly Saudi Arabia into several kingdoms divided between Hashemite, Sunni Arab, Kurdish and Shiite ethnic groups, tensions between Muslim countries in the region have been steadily mounting. On Oct. 22 Reuters reported that a Jordanian journalist had been sentenced to death in Qatar for allegedly spying for Jordan and reporting on U.S. troop deployments in that country. Oatar is home to the multibillion-dollar, state-of-the-art Al Udeid air base. According to numerous press reports and published photographs, Qatar is virtually sinking under the weight of U.S. military equipment, including M1A2 Abrams main battle tanks, which have been positioned there for the Iraqi invasion. That move came after Jordan recalled its ambassador in August from Doha, the Qatari capital, and closed the Amman offices of Al Jazeera, the feisty Arab news organization based in Qatar.

A COUP ATTEMPT IN QATAR?

On Oct. 16 the *Arabic News* issued a story stating that reports from Cairo and several Persian Gulf states had resulted in the Oct. 12 arrest of "scores of Qatari army officers" after an attempted coup by pro-Taliban elements against Qatari leader Sheikh Hamad bin Khaleifah al-Thani. The coup was reportedly suppressed with the assistance of "American personnel in civilian costumes". An Oct. 24 New York Times story clearly stated the Qatari position. It carried the headline: "A Tiny Gulf Kingdom Bets Its what is perceived as successful international opposition Stability on Support for U.S." Stories about the massive encouraged attacks from some quarters that have had headquarters of the U.S. Central Command for the Iraqi

These events are reminiscent of a warning issued by 12th, the Washington Post's Vernon Loeb reported that Pentagon hawk Richard Perle, who stated in an Aug. 18 Central Command had announced a plan to send 600 personnel in November from Florida to Qatar for a

While making no mention of the coup attempt the story did state that, "The Gulf region is bristling with U.S. troops and weaponry."

Upon learning of the coup attempt, FTW made an immediate request to the White House asking for comment. In a rare return call, which took place within two hours, a spokesperson for the National Security Council stated, "We [the NSC] are not even aware of a coup attempt. No comment." A spokesman for the Department of Defense said, "We don't know anything about any coup attempt, and U.S. forces were not involved."

The subscription intelligence service Stratfor stated in an Oct. 24 story that it received confirmation of the coup attempt from Qatari and Russian intelligence sources. It also added some twists which indicate the quicksand-like nature of Middle Eastern alliances. Translating from the Egyptian daily al-Joumhoreyah, Stratfor reported that members of the Qatari ruling family had been taken into custody and that that they had recently expressed opposition to the regime's pro-U.S. policy. As it turns out Sheikh al-Thani took power in a bloodless coup in 1995 from his father who remains a good friend of Saudi Arabian elements that oppose the invasion of Iraq.

Tensions between the two countries reached a high point in September when Riyadh recalled its ambassador from Doha. Saudi Arabia remains the ultimate ambiguity in its support for the U.S. invasion on a measure equal with glaring recent contradictions in stated U.S. support for the kingdom which contains 25 percent of all the oil on the planet. Withdrawal of support for the U.S. invasion in Qatar would most likely make the invasion of Iraq an impossibility. The support offered by other Middle Eastern nations, already under intense pressure from their populations, would likely evaporate completely. Even Turkey, a staunch NATO ally has been strongly signaling its reservations in recent weeks, and it is not capable of single-handedly hosting the invasion.

DIPLOMATIC POWER PLAYS DEEPEN CRISIS

Moves by Russia, France and China to delay a U.N. vote favorable to the U.S. plan have been extremely successful on the world stage. Prolonged negotiations and a delayed vote in the U.N. Security Council on a resolution needed by the Bush Administration to keep its fragile alliance together are producing responses from the administration that sound more like whining than leadership. Over the weekend, Chinese Premier Jiang Zemin arrived late—a major diplomatic snub—for a summit at President George W. Bush's Crawford, Texas ranch and failed to give him the endorsement for action against Iraq that Bush so desperately needs. This move apparently gave strength to continuing opposition from France and Russia in the U.N. Security Council.

And the backroom arm-twisting, carrot-offering, wheeling and dealing of the administration to divide the spoils of an Iraqi conquest has also failed to produce the desired outcome: a global blessing for the Empire to do what it wants to do. AT HOME AND ABROAD

In the meantime major demonstrations took place on Oct. 26 all over the United States and around the world protesting the U.S. invasion of Iraq. In Washington, D.C. a crowd estimated by police at in excess of 100,000 loudly protested the war on which the administration is betting all of its political chips. In San Francisco an estimated 75,000 people turned out while other large demonstrations were reported in cities all over the country. Following on the heels of previous anti-war crowds of 400,000 in London and more than 1 million in Italy, protestors filled the streets in Berlin, Frankfurt and Amsterdam to establish that the U.S. and the world are anything but united over this war.

This is the first time in modern American history that there has been a vocal anti-war movement before the war even started.

In Brazil yesterday, former Marxist and Workers' Party candidate Luis Inacio "Lula" da Silva scored a landslide victory with 61 percent of the vote, becoming president of the largest democracy in South America. Da Silva's victory, another political slap in the face to the Bush Administration, follows on the heels of a second recent, failed coup attempt against Venezuela's independent President Hugo Chavezan often vocal critic of many U.S. policies in South America.

It is clear that global and domestic opposition to the invasion of Iraq is growing. But it is not a given that these developments have rendered the administration impotent or weakened its resolve. As FTW has been saying consistently since the administration took office—and especially since 9-11 the degree of criminal, unconstitutional and aggressive behavior by the administration only serves to guarantee that its future moves will only be more illegal, more dangerous and more costly of human lives.

Some activists and analysts have openly speculated that the recent tragic death of Sen. Paul Wellstone, perhaps the administration's most vocal and committed critic in the Senate, was a murder perpetrated by a ruthless regime capable of stealing a presidential election and complicit in allowing the attacks of 9-11 to take place in order to provide it with a pretext for what is happening now. [FTW will have a story on a number of major inconsistencies in the Wellstone tragedy sometime this week.] Last week this writer had conversations with two Democratic Party members of the House of Representatives and both unhesitatingly expressed their belief that Wellstone was probably murdered.

Recently an anti-war activist was asked why no one was making a point of the now documented and glaring inconsistencies in the Bush Administration's actions, statements and conduct since the attacks of 9-11. "It's irrelevant," the activist said. An angry response came from the Internet, "If you had paid attention to all the warnings and evidence of administration complicity in 9-11, we would not be looking at the coming murder of tens of thousands of people in the Middle East."

The point, well taken, was that the people in control of the U.S. government are capable of anything. And while these recent developments show that the administration is not omnipotent, it does not make it any less dangerous, any less capable of horrific actions, either overseas or right here at home. And the rest of the world, following the U.S. example, is showing increasing signs of instability that could unleash a variety of conflicts, the outcomes of which cannot be predicted.—http://www.fromthewilderness.com/ $free/ww3/102802_wheels.html$

Nevada Vs. "Offshore": Working With Your Capital

Budget's "Tip of the Week" #17:

What About "Offshore"?

"What about setting up a corporation 'offshore'? I've heard that offshore corporations don't have to pay any tax and that I can move my money offshore to shelter it." Up front, there is little that can be done offshore that cannot be accomplished in and through the shelter of Nevada corporations. But let's look at just a few things that this questioner should consider before moving in this direction.

There CAN BE tax advantages, particularly in cases where the offshore entity earns its income in a tax-free jurisdiction from activities in locations that do not tax the income. Such opportunities can be hard to find. On the other hand, if the offshore entity (sometimes called an IBC, for International Business Corporation) is OWNED by U.S. stockholders, the stockholders are still subject to tax on capital gains and on any income derived from the IBC. In most cases offashore shareholding is NOT private, unlike in Nevada. Further, the United States has developed MLATs (Mutual Legal Assistance Treaties) with virtually all offshore locations, allowing for the extension of U.S. law-and the powers of the I.R.S.-into those jurisdictions, at will.

One good solution might be for the offshore entity to be owned by a private Nevada corporation. Just keep in mind that the Nevada corporation would still be subject to taxation on any income or capital gains derived from the IBC. In many cases, however, it might be better to simply extend the structuring of Nevada corporate shelters than to try to operate offshore. The main reasons for this are more immediate control and, of course, privacy. The Nevada Corporation Manual sums it up like this:

"Nevada is unique in that it not only offers a high degree of privacy but ready access to your capital that is not likely to be denied in even the most extreme turmoil that COULD develop in the world's financial markets. In these highly uncertain economic times, long-range planning should take into consideration the possibilityeven the probability—of extreme turmoil. In that event, there could be some real shock felt by those whose strategies are oriented around offshore structures. It is entirely possible that in a real emergency offshore funds would be totally inaccessible, depriving the owners of those assets the use of their own capital when they need it the most. For any situation where ready access to one's capital is required, and especially if you wish to work with your capital, Nevada corporations are THE answer."

In September 2000, the globalist OECD (Organization for Economic Cooperation and Development) proposed the total elimination of any and all offshore tax advantages. The Bush Administration has withdrawn its support for the time being—from this initiative, probably allowing time for repositioning by at least some of the Big Boys. Ultimately, though, it seems likely that offshore jurisdictions will be precluded from offering tax advantages to foreigners. When that happens, it will leave the shelter of Nevada corporations as one of the very few true "havens".


