The Bellona Report: "The Russian Northern Fleet: Sources of Radioactive Contamination" gives a thorough overview of the sources of potential releases of radioactivity which could harm the public health and the environment. The problems of nuclear waste and disused nuclear submarines are products of the arms race and the Cold War. Russia continues to build new nuclear submarines, but there are very few provisions being made to properly store old nuclear submarines and develop sufficient storage facilities for spent nuclear fuel and other radioactive waste.

There is a minimum of 21.067m³ of radioactive waste and at least 7.523m³ of liquid radioactive waste at the naval bases and shipyards that are described in this report. More than 24,000 fuel assemblies and nine reactor cores are stored at the temporary storage facilities. In addition to this, there is a minimum of 5,040 spent fuel assemblies stored on board service ships. A total of 88 Northern Fleet nuclear submarines have been taken out of service, of which at least 52

HISTORY

At the end of World War II the United States Navy was considerably larger and more powerful than its Soviet counterpart. To catch up with this head start, the Soviet Union built a large number of nuclear submarines and a series of new naval bases and shipyards on the Kola Peninsula. The Kola Peninsula is of particular strategic interest and importance due to its coast is free of ice in the winter. The first Soviet nuclear submarine was taken into use by the Northern Fleet in 1958. A number of larger naval bases and shipyards were established to service the growing fleet of Soviet nuclear-powered vessels. This fleet grew rapidly to become the world's largest fleet.

NUCLEAR SUBMARINES IN SERVICE

The former Soviet Union built a total of 247 nuclear submarines and five military nuclear-powered battle ships. The nuclear submarines were built at four different shipyards. Today, only Sevmash Shipyard in Severodvinsk builds nuclear submarines. At the present time, there are 67 operational nuclear submarines with the Northern Fleet. A total of 88 submarines have been taken out of service. However, due to economic difficulties, a number of the operational vessels remain

NAVAL BASES

The Northern Fleet has five naval bases on the Kola Peninsula, and some of these have several base facilities. The westernmost of these is Zapadnayya Litsa, while Gemikha is the easternmost. Radioactive waste is stored at most of the naval bases. There are several closed towns in connection with the naval bases, making up a population of over 100,000 inhabitants on the Kola Peninsula. The establishment of the supporting infrastructure at the naval bases has often been delayed compared to the rate of delivery of new nuclear submarines. This is particularly true with regards to storage and treatment facilities for radioactive waste which continues to present significant technological problems.

SHIPYARDS

There are five shipyards for repair and maintenance and one yard for constructing new counties. Three shipyards are subject to the Northern facility for spent nuclear fuel in northwestern Russia.

Fleet, while another three of these yards fall under the auspices of the Ministry of Shipbuilding. Due to the cutbacks in the number of operative submarines, drastically reduced, leading to some serious economic problems. A few of the shipyards now also accept civilian commissions, and it is also they who are largely responsible for the decommissioning of nuclear submarines. Radioactive waste is stored at all of the shipyards, at times in large amounts.

SOLID RADIOACTIVE WASTE

Solid radioactive waste is stored at 11 different places along the coast of the Kola Peninsula and in submarines that have been taken out of service, of Severodvinsk. All of the facilities are full, and at a number of them solid radioactive waste is also stored outside the storage building in the open without any kind of protection. There is no regional storage facility for solid nuclear waste.

LIQUID RADIOACTIVE WASTE

Liquid radioactive waste is stored at almost all of the proximity to the Atlantic Ocean and the fact that its naval bases, either in land-based tanks, or on board service ships or floating tankers. Most of the storage tanks for liquid radioactive waste are full, and a number of them are in very poor condition. The storage crisis is precipitated by the lack of treatment plants. The processing capacity is too small at the existing civilian treatment plant at the nuclear icebreaker base Atomflot in Murmansk while the costs to the Fleet. Most of these have happened while the Northern Fleet are too high.

STORAGE OF SPENT NUCLEAR FUEL

The Northern Fleet's largest temporary storage facility for spent nuclear fuel lies at Zapadnaya Litsa in Andreeva Bay, about 40km from the Norwegian border. Approximately 21,000 spent nuclear fuel assemblies are stored here, corresponding to 90 nuclear reactors. The fuel assemblies are stored in three concrete tanks (also in very poor condition). In the 1980s, there were inactive and tied to the pier for large parts of the year. large leaks of radioactivity from an old storage pool. Fuel assemblies are also stored in rusty containers transferred to the Northern Fleet in real terms. In 1995 outside without any form of protection from runoff. There is also a smaller storage facility for spent nuclear fuel in Gremikha. Here too the fuel assemblies have been stored outside, and there have been leaks of radioactive waste from the storage pool. The reactor cores from submarines running with liquid-metal-cooled reactors are stored in Gremikha.

TRANSPORTING SPENT NUCLEAR FUEL

Spent nuclear fuel is transported on board ships that do not satisfy safety regulations. The spent nuclear fuel is transported between the shipyards, temporary storage areas and loading point of the railroad in Murmansk and in Severodvinsk. From these points, the spent nuclear fuel is transported further to the reprocessing facility RT-1 in Mayak. There is a serious lack of capacity of rail transportation, and reprocessing at Mayak is quite expensive for the Northern Fleet. The amounts of spent nuclear fuel will dramatically increase if the transport problem is not solved. Another solution under

SERVICE SHIPS

The Northern Fleet has four special tankers for the the amount of work for these yards has been storage and transport of liquid radioactive waste. None of these ships are in satisfactory condition, and all of them are over 25 years old. On one ship, the equipment on board for treating liquid radioactive waste does not work. The Northern Fleet also has two larger ships for transporting spent nuclear fuel as well as two smaller barges for this purpose.

DECOMMISSIONING NUCLEAR SUBMARINES

At this time, there are over 130 Russian nuclear which 88 vessels belong to the Northern Fleet. These submarines have been laid up at Severodvinsk and nine other locations on the Kola Peninsula. The greatest risk to safety is presented by the 52 submarines that have not yet been defuelled. The submarines are not brought into dock, and are in very poor condition. The vessels still containing their nuclear fuel are undermanned. If the work of decommissioning these submarines is to proceed in the proper fashion, a significant infusion of funds either from the state or from some other source will be necessary.

ACCIDENTS ON NUCLEAR SUBMARINES

From 1961 until the present, there have been many accidents involving nuclear submarines of the Northern submarine was on patrol, although some have also occurred during refueling or repair operations. Three nuclear submarines belonging to the Northern Fleet have sunk. There have been loss-of-coolant accidents in 10 submarines and four serious fires on board these vessels in which human life has been lost. There have also been a number of large and small leaks of radioactive coolant in operational vessels.

ECONOMIC PROBLEMS

In 1994 only 35% of allocated funds were the Northern Fleet did not receive in real terms the 600 billion rubles allocated to it in the Russian budget. What money was transferred went largely for paying salaries and welfare benefits for Northern Fleet personnel. Resources for maintaining storage facilities for radioactive waste have been sharply cut back, and in the last two years, hardly any work at all has been done in securing radioactive waste. On two occasions, unpaid electricity bills resulted in the shutoff of power at a shipyard and a naval base. The Northern Fleet is now investigating alternative possibilities for earning income, including selling naval vessels to foreign countries and leasing its nuclear submarines for other than military purposes.

REDUCED COMPETENCE

Eighty percent of all naval specialists and operators of naval nuclear reactors in the Soviet Union were trained at the naval college in Sevastopol. Since the dissolution of the Soviet Union, the school has not been used, since Sevastopol is located in Ukraine. Economic nuclear submarines in Murmansk and Arkhangelsk consideration is building a large, long-term storage problems also result in less operational training for the crew than earlier; furthermore, worsening social

conditions result in ever fewer officers choosing to renew their five-year contracts with the Russian Navy. The turnover of officers undermines the safety.

It was in terrible shape with even the pole-barn ready to I about fell apart yesterday as I realized that being topple over. But it appeared that it was useable

Now KNOW, please, that one of the reasons Leon Fort loaned funds to the Institute was so that he could help get the farm under a plan that would actually pay him back abundantly and he could put in some tinkering hours there and actually create a place for the Ence (Enz) family to come farm and cast miracles.

Turner gave us a song and dance about renting the house for some atrocious price that nobody in a right mind would even consider. Then there was the incredibly BAD (OLD, OLD, OLD) single mobile home in terrible condition but he also said we could rent it for an equally obscene price. Then thirdly, there was "an apartment" consisting of a sink, an old non-working stove and two tiny rooms with a shower.

We knew at the time it was a dud for estate lots (his plan and the basis of his pricing) BUT he also had a plan that could work FOR US. It was that he would lease it and funds we paid could go to the option to buy. He didn't want to be bought out at the time because of tax liabilities at that outrageous price.

that place was both EXPENSIVE and directly research farm and an actual "show-place" for visitors and agricultural students.

we would actually start with lease payments of what I considered totally obscene and outrageous but with recognition that anything we put into that place would be OURS and the arrangement would fit everyone's needs.

We were working with a "builder" (Donahue) from Florida (by the way, a personal friend of none other than George H.W. Bush—but that is another story too long for here but well worth the telling, believe me). Donahue moved to California, to Hemet, with a friend, and we paid him to work on these prefab houses and buildings for which he was "famous". He built "forms" for the panels for both square and dome buildings that would be light in weight but very strong and fast to assemble. Two of his buildings are at the farm, one under the Red Barn and the other on the pole-barn slab. We planned to have the big Arena now used by was stopped when George Green got Schroepfers to come to Carson City and demand their money back because the first dome home was being built for them.

At that time we also had a "compressed-dirt-blockmaking machine" and several people had wonderful experience and fun making compressed-earth blocksmost of which would melt in the first rain-BUT PROPERLY COVERED WOULD LAST FOREVER even for retaining walls. The big retaining wall and generator house on the Adam Drive property were both made from the blocks with a simple stucco coating.

Leon Fort had a ball UNTIL Ann Beam came drifting through to "experience" Cmdr. Hatonn. She and a friend happened to camp next door to Leon and his mother, Esther, in the campgrounds at Indian Hills. Within one week Ann had moved into Leon's trailer and into Leon's bed, yet. This was fine, I suppose, but it was NOT "fine" with Esther. Soon Ann took over Leon's business, wrote nasty letters to and about me, and even took over his corporation.

You have to realize that Leon IS a Wallenda of circus fame and did/does(?) train Circus of the Stars people to walk the tightwire. He would have been involved in the movie-making with Wally Gentleman, etc. Turner OUT FROM UNDER US.

Visitors came from Ann's old stomping grounds in Arizona where they had literally experienced her equipment that we could salvage and tried to sell participation in a Witches' Coven. If she was a part of "our group", they would never return. When this came public Leon had a fit, Ann lied her way through the most incredible tales ever heard and Charles demanded that Ann NOT be allowed on the "farm" but Leon would still be welcome. He soon quit coming, however, after Ann announced that Leon was a "slave" and repeated that to Tuten and the game was off and that started more problems.

Meanwhile, the place was "fixed up" enough for Ence to move there with his family of nine. The first year, Ence and family went right to work and it looked like we had a winner. He found Leon xxx who knew all about raising spelt in Ohio and who talked him into applying some 20 tons of "Nutricarb" (ground highquality anthracite coal) to the entire (farmable) 150 acres. We had no farm equipment so we had to hire a neighbor to spread and disc in the Nutricarb and then Everything we did from then forward about plant the spelt. By that time it was quite late to plant so the crop was only about 50% of "advertised" geared to having it and turning it into a full-blown (by xxx) but it had wonderful flavor and "we" had grown it. Ence and Charles hauled it about 100 miles to a grain mill that could clean it (not "hull" it—that takes We agreed to the program to the extent that a special machine which we later bought to become the wells had to be cleaned and the pumps re-worked. only spelt processor west of the Mississippi).

> Rod Ence's wife, Sandy, had a sister named Tammy who moved into the Trailer (mobile home). Instead of rent she carpeted it and after we had redone the water, electric and septic system, repaired and fixed the roof, she lived there rent-free. Her husband "loaned" Sunshine Valley Farms \$1500 which would have covered her rent for several months. When they were divorced he sued in Small Claims Court and got a judgment for \$1500. You think we have not had "opposition"?

As to the apartment, Gene Dixon had been kicked out by his wife and he had blown the entire Sacramento program for the Constitutional Law Center—yea even to criminal diversions of money from the Institute—with the able assistance of George Green who had moved by then to Nevada—so we moved Gene to Tehachapi. [While a consummate and incorrigible liar, Gene Dixon Grimway Farms to fabricate the buildings. That project had a legal mind—backed by experience—probably on a par with any of the current "greats", including Beli and Bailey. After getting out of the Navy in the late '40s, he worked his way through college and law school as a bailiff in the San Jose, California court system. That alone would be an education. He had lost his Bar License in an S & L scam but he knew the law. It was upon his advice that we successfully sued Tips for screwing up and losing the Adam Drive house case.]

> Dixon made sure that no inconvenience was ever rested on any of HIS COLLEAGUES, including Ence to whom he became quite attached while LIVING in the apartment, with furnished auto, offices and staff. Oh, these things can be easily confirmed as Valerie worked IN THAT OFFICE, as did Karen Singer-White.

> When we bought out the Jojoba operation at the airport near Bakersfield, we had grand plans for "colloids", Bob James' working center and thus and so. The place had a train-track terminal for shipping and really fitted some of our other needs, for the biggest grain shipper/bagger around was NEXT DOOR. Well, we had all that wondrous old equipment and bigger and better offer) and pulled a regular Bob

We had to empty the building and move the the rest. Bob rescued some dandy lab equipment and E.J. sold some of the equipment for a good price so we "made wages"—just barely.

While there we were exposed to a Dole plant going out of business and for a good price we could get the "granaries". It meant tearing them down, moving them and reconstructing them. We then got permits, laid foundations and paid dearly to have the ones constructed for use at the farm. Two or three others are waiting to be put up in addition.

EVERYTHING WE DID, WE DID WITH FULL INTENTION (AND PERMISSION OF TURNER) FOR PERMANENT OWNERSHIP OF THE FARM ITSELF.

We got paint and Gregg and Debbie from Yucca Valley came and together we did the entire house inside and out. There were giant cottonwoods around the house and when the wind howled, as it often did, and broke off limbs, they usually pierced holes in the tarpaper roof. E.J. decided we needed a steel roof and several thousand dollars later we had one. Now Mr. Turner says Rod Ence overcharged us? Ence was gone by then.

When we first got ready to irrigate we learned the Turner "didn't have money for that" so we paid for it. In retrospect we should have deducted it from the rent but we were trying to "get along" so we let it go. [After all, it was only about \$8,500 and it was "our" wells.] We dug an entire shelter which was reinforced and insulated inside the Red Barn while insulating [18" of spelt hulls in the walls and ceiling] the barn itself for "cold room" facilities and putting in a bathroom in case of emergency-and for convenience of anyone working in that area.

Charles had a crew put in toilet facilities for both "men" and "women" in a separate building, again, for the convenience of Ence so that nobody would have to "bother" or inconvenience them to use the facilities in the house. Charles needed "freezer" capacity to freeze the grain flour and mixes to make sure there were not insects surviving. So, that came from an orchard going out of business and it became part of our inventory.

We bought a humongous irrigation system for, obviously, irrigation. That went the typical way of good management in a big windstorm where Ence had tethered the system only on the DOWNWIND side and of course the wind just blew the system to smithereens against the pole-lines. After leaving the farm, Ence came back with family helpers and vandalized the system AGAIN by breaking off the valves. Nice people?!

We bought a huge tractor with all of the wonderful accessories that go with tractors, like swathers, bailers, multiple discs, etc., etc., and two Combines (one to be used for parts to fix the other). [We later heard the neighbors were green with envy at all the stuff Ence had to work with.] It seems Ence considered farming a part of child-rearing and Charles came in seething one night. Seems he had caught the oldest boy doing "donuts" in the driveway with the big tractor. After yanking the kid off the tractor (forever), he confronted Ence who said, "Boys will be boys." Later, after E.J. fired Ence, there was vandalism to the NEWLY REPAIRED tractor with "aviation gas" dumped in the suddenly the Airport wanted the land back (for a nearly empty diesel fuel tank—worse by far than either sugar or sand as a sabotage item [blew the head gaskets and broke some cylinders].

farm went in the "hole" by thousands and thousands of dollars because nobody wanted to weed or keep the equipment in repair. The millet and sunflowers went for bird feed—literally, as we went forth and gathered what we could by hand— ME INCLUDED, while Al made his turn as well mostly year number two was a total waste.

kind of experience because we did have someone wanting to come and make it work—from Canada. This was a wonderful experience except that Stan and Deanna could not get clearance from immigration to be able to stay more than six months. They are among the most wonderful people we have ever encountered and remain totally good friends to this very day—even with us in Manila.

other than full intentions of—even if everything else failed—holding on to that FARM.

When we knew Dingmans were coming we personally bought BRAND NEW appliances for the house—including stove (range), refrigerator, microwave, kitchen center and even a custom-made small dishwasher to fit the broken one in the kitchen. We outfitted the house with curtains where appropriate and set it up enough that it could be used by people able to BRING NOTHING across the border from Canada because of immigration restrictions.

In addition we paid farm helpers to be there EVERY DAY. They also ran the mill, cleaners, etc. It was definitely NOT SHABBY.

While Stan's family was still there, Ray Bilger asked to use the trailer. He was doing some research and writing for Gene Dixon and the Law Center so we said OK. He then wanted to invite a lady to move in with him but, in the face of the two precious little Dingman girls, WE SAID "NO".

Then, when Janet had her accident and we saved her life and a couple of her kids, she eventually ended up with Ray and THEY took possession (free of charge) of the house and, yes, supposedly the farm. Just as Mark P. promised, it was all downhill from there.

However, not one payment was missed to Bob Turner—NOT ONE. A few were LATE and he being in Manila, the payment was late and he did condescend to its being a bit late and I, Doris, personally wrote and thanked him for the "favor". In return I got a scathing letter that friendship was one thing and business and payments were another and never the twain would ever be considered a second time. The only other time a payment was late he "evicted" us in "three days", Charles and all. He was having a bad day, he claimed.

So, what of NOW?

Let me point out some of the ways this is not a good deal-this dump us out and run: In the beginning the lease was outrageous but would be put to buy-out—so it was "OK", I guess, since it would all go to the proper end in the long run. Turner never "cut" the payment but did increase it on at least two occasions to "more outrageous".

He received some kind of government payments of which he gave us no portion. He also was able to collect on some storm damage to the planted fields (ours) of which we got NOTHING. He also was able to recover for the damage and new roof to the with Bob Turner, et al.

The crops were not planted properly and the trailer home when the wind blew off the roof—but "luck" would have it—the furniture was a set of Narra wood furniture (Philippines prime). It just went to the dump and since we were not there to even howl about it, so be it. By then, Rex and Margie were in charge of everything there.

WAS **NEVER** THERE When Ence left we were facing a different MISUNDERSTANDING ABOUT THAT FARM AND OUR INTENDED USE OF SAME—PERIOD AND END OF DEBATE.

> We do know that Bob Turner called us about two months ago, after no contact for at least these three years, and announced that he was dying and had buyers for the farm. He said he would send us a fax.

E.J. was caught totally by surprise and gave him a The effort continued, however, and never with lot of sympathy over his condition which consists of being probably 300-plus pounds overweight and which has destroyed his heart and legs. He said he had two good offers for the farm "on the desk" in front of him. a million dollars OFF OF US under manipulative That was, now realized, a blatant lie as was the presentation on the "health" aspect of his condition.

> He said HIS SON AND DAUGHTER (of seven or eight children) were there and that "Thad" (the son) wanted to get things cleaned up, into a Trust, and prepare for Bob's demise.

After Dingmans had to go home, we decided to "lease out" the land—since it was organically certified (at the expense of thousands and thousands of hours and dollars)—to the Duncans, who were at that time one of the largest organic farms around the country. We knew the Duncans and like them—they even planted some test-spelt on their property elsewhere. Bob Turner "hated" (his words) "those Duncans" and didn't want any part of it. We subsided and we grew weeds. We did run some sheep from which, next season, we grew even a larger variety of weeds from the broadcast sheep-seeding.

Duncan's had rented us space in their big arenasized barn to store our beans, lentils, some spelt hulls and equipment. However, they needed to finish the paving of the floor and Charles had agreed, without our WITH CHARLES! So, long distance and far away, we for dumping the beans and the equipment.

We never knew exactly what happened but E.J. tried to manage it from here while Pablo and brothers shifted everything and disked the "hulls" into the ground—using our fork-lift as tractor with the discs pulled behind. Dave and Kathy finally TOOK (borrowed) the "lift" (via arrangements with Charles?)—and that was the end of that story. We still have a small "lift" at the farm and we wonder constantly of its position or storage and just hope that Gene perhaps took it home once he located it.

When E.J. terminated Ed Young in March of 1999, and Rick Martin and Charles Neil refused to pick up his keys and enforce the termination, Ray Bilger joined the rebels and stripped the farm house of all of the appliances, dishes, bedding, etc., etc., he could carry off. The rest of that story is not appropriate here.

Rex Smith immediately "came to the rescue" and moved into the farm-house. He and Margie got along well and that story also needs no further dialogue HERE—but—he took up the interchange

When Bob refused to sublease to Duncans, E.J. all furniture and contents were lost TO US and as asked Rex to see if Bob would reduce the lease to a fair amount for the buildings in use and he could lease the land elsewhere but keep it to "ORGANIC" for obvious reasons—then we would take it back when appropriate. Bob said he had had inquiries to use the big well so he would lease what we needed for \$1800 per month and reduce the payment another \$300 when he could sell the water. Bob didn't sell the water so we were stuck with \$1800 per month.

THERE IS NO EARTHLY WAY WE WOULD Now what happened? We don't know, really. EVER HAVE EVEN PAID A DIME FOR THAT "DUMP" IF WE DIDN'T HAVE ULTIMATE PLANS ONGOING; AND TO ACCOMPLISH OUR PLANS WE WANT AND NEED THAT FARM—OR "A" SUITABLE FARM. NOW THERE ARE HUNDREDS OF THOUSANDS OF DOLLARS IN IMPROVEMENTS AND STORAGE UP FOR TOTAL LOSS UNDER THESE CURRENT CONDITIONS.

> Bob Turner has lied to us, used us, made over half circumstances, been insulting, overpriced everything and has never in over a decade put one dime into that property while we provided everything—and I mean EVERYTHING—even to the labor. Now he says that at one time he offered E.J. that farm at half price? BS squared. He never did anything except increase the lease payments on "cost of living" (his) basis. [Why would he now say he offered it at half price? To protect himself from his promise (not in writing, of course) to credit us with our lease payments when we purchased the property? Makes one wonder: Can Lucifer make one forget things?]

> He has a bunch of totally bad properties, such as OLD motels and that old outrageously-priced Talmark building which I'm surprised has not been condemned already. He has given faulty "eviction" demands to the ones living at and attending the farm as caretakers while it remains our (Ekkers) only local and permanent legal address in the U.S. Is this game fine and wondrously OK with me? NO. Not even to Ellen spending five minutes more in address changes.

Bob did NOT consult with us-he pronounced knowledge, to empty the area by "December"-you to us his intentions, while trying to gain sympathy know, that first December we spent in Manila over his imminent and impending death and then claims to have sold out from under us and even promptly raised hell, but we made them all. Once, after had to clear out that place and make places at the farm upping the deadline dates by over a month as if he hadn't written his dates and faxed it to us. NO! It certainly is NOT acceptable with me.

> Frankly, at first it hit that what a relief it would be to be free of that THING and just get our job done. But no, it is NOT alright and people "invested" both funds and hours to make that place work and have it and hold it for development—and this was all along the way.

> People, Two-by one of them, even offered to mortgage their own homes to hold that farm (this month) but the price is so outrageous as to have a thing worth \$250,000 at most be claimed at \$1.2 million. All improvements used by Bob Turner to advertise that place—ARE OURS! Even to the "organic" status of certification. AND THAT IS THE ONLY REASON GRIMWAY FARMS WANTS IT.

> Turner could have LEASED the growing fields to them—but you see, it is more cash he needs to clear his debts before he dies and that wouldn't serve his personal needs or wants. Furthermore, he could have leased out the water for nearby irrigation systems, even to the sod farmers, but didn't. The Golden Rule works both ways.

NO-TO MR. TURNER'S "ANYTHING".

Turner does NOT make suitable "offers" he manipulates everything and expects to have HIS way—count on it. We did EVERYTHING "TOO MUCH" for me to bear.

It was on this basis that the U.S., France, the United Kingdom and the USSR signed an agreement in 1945 that established the Nuremberg International Military Tribunal, which included a provision for "crimes against peace".

In 1946, the U.S. also proclaimed the Tokyo multilateral use of force. Charter for the prosecution of Japanese leaders. There, too, "crimes against peace" were included.

At Nuremberg and Tokyo, the U.S. insisted that an unprovoked attack by one state against another was such a crime. Arguments by the accused concerning preventative self-defense were categorically rejected.

The U.S. correctly wants to make sure that, in the first resolution there would be no question that such a finding would be made if the Iraqi regime materially breaches the inspections. This is not an unreasonable position.

But the final judgement should be made by the Security Council.

In following this approach the U.S. would be champion world order and world peace, and not its bully.

In the meantime, if arms inspections clears Iraq of its weapons of mass destruction, and the U.S. continues its containment policy, the victory would be complete and without bloodshed.

What's more, the article went on, "Similarly Only such a finding can confer legitimacy on troubling issues are raised by a host of other American firms staffed with former soldiers who are landing jobs training and advising foreign militaries... contractors are even training the United States military itself."

U.S. CIVILIANS WAGE DRUG WAR FROM COLOMBIA'S SKIES PROGRAM STRIVES TO ERADICATE COCA

LARANDIA, Colombia—They are private U.S. citizens but work on the front lines of America's war on drugs.

Under a little-known program, more than 100 pilots, mechanics and others work for the U.S. State Department in Colombia as part of a program to eradicate Colombia's coca and opium poppy fields.

Some of the Americans fly planes that spray herbicides on the illicit crops. Others fly gunships that accompany the spraying missions. Still others fly hulking transport aircraft or work as aviation mechanics, logistical experts and medics.

A leading Colombian news weekly last year ran a cover story describing the American pilots as "gringo mercenaries" and "lawless Rambos". Some U.S. critics say the private contractors are proxies for the U.S. military in a place where the public would not allow a more direct American military involvement.

"It creates a space for further involvement without putting U.S. soldiers on the ground," said Ingrid Vaicius, a Colombia expert at the Center for International Policy, a Washington think tank. "The contractors are not watched as closely as U.S. military personnel would be."

But others say private contractors are needed because the U.S. military is stretched thin and attention is focused on Iraq and other hot spots.

The U.S. Congress, concerned about private citizens only up to 400 U.S. contractors be allowed in Colombia. U.S. officials say there are on average about 120 American pilots and other private contractors in Colombia's anti-narcotics program at any one time.

The pilots, interviewed on the condition that they not perhaps overthrow or assassinate leaders connected be identified, downplayed their cowboy image and characterized themselves as regular guys with wives, kids to take its fight, and its advanced military technology, and mortgages—even if their job is anything but ordinary.

> From dawn until dusk, 16 American spray planes take off from Larandia's dusty airstrip heading south to the coca fields.

> Once there, they swoop down and drop the herbicide glyphosate, making pass after pass just over the tree line, often as they are shot at by leftist rebels and drug traffickers.

The work is endless. Colombia has hundreds of what a citizen is and does and should be to a national thousands of acres of coca—the raw material for cocaine—planted along steep ravines and in recently cleared jungle terrain.

> The fumigation, part of the \$1.5 billion U.S.financed program known as Plan Colombia, has accelerated under recently elected President Alvaro Uribe, who agrees with U.S. officials that fumigation is the fastest way to get rid of the illicit crop.

> Some Colombians say the herbicide causes severe skin rashes and other illnesses. The American pilots at Larandia, a sprawling Colombian military base in a swampy plain, say it's safe. ...

Some of the pilots are two decades removed from their military careers. Many have had second careers flying for the United Nations and other organizations. They say Colombia is a great place to work, despite being at war. ...

If a plane does go down, the pilots are in serious armed helicopter gunships and a third rescue helicopter. Pilots carry pistols and receive survival training.

YEMEN ATTACK SIGNALS U.S. IS EXPANDING WAR

> State Department spokesman Richard Boucher, while not acknowledging U.S. involvement in the attack, said it differed from Israel's killing of Palestinian militants.

> "If you look back at what we have said about targeted killings in the Israeli-Palestinian context, you will find that the reasons we have given do not necessarily apply in other circumstances," Boucher said.

> He apparently was referring to the fact that the Israelis and Palestinians represent two legitimate powers involved in occasional peace talks, while the U.S. government considers al-Qaida an illegitimate, murderous terrorist organization.

White House spokesman Ari Fleischer also But the FARC, which has designated the Americans declined to discuss the CIA role but said that "sometimes the best course is a good offense."

U.S. SLAMS TORTURE CONVENTION REFORM

WASHINGTON (AP)—The State Department criticized proposed changes in a United Nations convention to combat torture because they fail to provide for inspections of detention centers without notice.

Spokesman Richard Boucher said the changes require advance notice of inspections, enabling authorities to "clean everything up" before the inspectors arrive.

Boucher spoke as the UN General Assembly began final debate on the measure. The changes are designed to permit enforcement of a 1989 UN treaty on torture.

A Geneva-based committee receives reports from alleged torture victims and issues policy recommendations to countries.

Boucher said the United States opposes provisions requiring that all members of the United Nations finance the cost of the reforms, including an international oversight body charged with inspecting detention facilities.

The United States is proposing that the costs be shared exclusively among countries that become parties to the accord.

Some human rights groups contend that the U.S. actions will dilute the effectiveness of the revised system.

Under present rules, countries are supposed to enforce the convention on their own, but rights groups say monitoring is needed because torture is still prevalent.

The protocol, which has been under negotiation for a decade, would be an optional supplement to the 1989 treaty. Its objective is "to establish a system of regular visits undertaken by independent and national bodies to places where people are deprived of their liberty, in order to prevent torture."

Boucher rejected any suggestion that the U.S. position implies a more tolerant attitude toward torture.

"We abhor the despicable practice of torture," he said. "The United States has been one of the most forceful voices against torture."

U.S. MAY CARRY OUT YEMEN-LIKE KILLINGS IN ASIA: OFFICIAL

A controversial CIA-led missile strike which killed six suspected al-Qaida members in Yemen was "legal and necessary" and may be emulated in Southeast Asia to crush terror groups, a top U.S. counterterrorism official said Saturday. "We will use whatever is necessary and legal to attack this (terrorist) threat, to interdict it and eliminate it," Francis Taylor, the U.S. State Department coordinator for counterterrorism, told a media briefing in Manila. Asked whether the covert and lethal Yemeni missile strike a week ago was necessary and legal, Taylor said: "Sure, the answer is yes. "Both legal and the appropriate tool given the circumstances," said Taylor, here to attend a counterterrorism conference after visits to Australia, Indonesia and Singapore. In Washington, Pentagon spokeswoman Victoria Clarke told a press conference Friday that even if local governments don't agree, American forces may launch assaults into lawless or poorly governed areas around the world to go after terrorists hiding there.

'We make every, every effort to work with countries, most of whom are very eager to get rid of the al-Qaida," she said. "But... without speculating where, there may be circumstances when we go into an ungoverned area in pursuit of al-Qaida," she said on the question of getting local permission first. "I'll just leave it at that." In the yearold so-called "war on terror", there have been no known instances of the U.S. military capturing or killing a terrorist suspect without the prior consent of the government where the operation occurred. It also is not known if such operations have been performed by the CIA, which works under different rules and greater secrecy than the military. Six suspected al-Qaida operatives were killed by a Hellfire missile launched from a remote-controlled CIA Predator aircraft as they rode in a vehicle 160 kilometers east of the Yemeni capital Sanaa, reports have said.

U.S. Deputy Defense Secretary Paul Wolfowitz had implicitly confirmed that the United States was behind the Yemeni missile strike. While Wolfowitz called it a "very successful tactical operation", some groups have raised questions about the legality, effectiveness and ethics of using a tactic outwardly akin to assassination. Assassination is banned by a presidential executive order. To another question, Taylor said the United States would keep its options open in launching a Yemen-style strike against terror groups in Southeast Asia—regarded as the second front in the U.S.-led coalition's battle against terrorism after Afghanistan. "For Yemen, perhaps that is a military operation and for the Philippines, it may be a law enforcement option," Taylor said. "But all of those options are on the table, that are available to governments and regional coalitions to fight against the threat and find the right tool and right time to get the result we are looking for," he explained.

U.S. President George W. Bush had asked the international coalition against terrorists to put "all kinds of power together" to take on the threat and "to use what is appropriate given the nature of the threat we face," Taylor said. Taylor dismissed suggestions by some groups that the CIA was behind the Bali carnage, saying "it is absolutely ludicrious to think that the United States government or any element of the United States government will be involved in such a crime against innocent people. These (the attackers) are terrorists, people who want to use political violence against innocent people to reach their political goals," he said. The U.S. State Department is the lead federal agency dealing with international terrorism and Taylor's office has primary responsibilities for developing, coordinating and on Monday and Tuesday with counterparts from implementing U.S. counterterorism policy, officials said.

[JR: The more our U.S. State and Defense Dept. officials talk the more they sound like war council members in the Israeli Knesset. Pres. We now use coercion and intimidation to extract agreements from foreign governments to allow us to infiltrate their countries to get after our enemies. You have to wonder if the bombing in Bali was a gift sent by the gods of war because it has opened up many inroads for the U.S. to involve itself in Southeast Asia. Maybe Americans would not be deliberately involved in the killing of innocent people but the powers that control our government certainly would and are. SOUTHEAST ASIAN LEADERS TO SHOW WORLD THAT THEY CAN CONTROL TERRORISM

Breakthrough in Spratly Issue Hailed

Southeast Asian leaders prepared Saturday for an annual summit at which they hope to send a clear message to the world that the region is capable of controlling terrorism. Only a day earlier, the U.S. State Department warned that terrorist groups may be planning attacks at Southeast Asian restaurants, hotels, beaches, and other sites visited by Westerners. Cambodian Prime Minister Hun Sen has promised that the 10 leaders of the Association of Southeast Asian Nations-plus heads of government from China, Japan, South Korea, India and South Africa—will be safe during the summit. The meetings are being billed as the largest international gathering in modern Cambodian history. Cambodian officials hope they will symbolize the country's return to a respected position in international society after nearly three decades of war, Khmer Rouge revolution and civil conflict. Festive banners are strung across Phnom Penh's cleanly swept streets, potholes have been repaired, and colonial-era government buildings have been given a fresh coat of paint....

Some members were disgruntled then that the organization—founded in 1967 to improve economic ties had become preoccupied by terrorism. "ASEAN does not want terrorism to dominate the organization," said its spokesman, M.C. Abad. But recent bomb blasts in Indonesia and the Philippines have inexorably intertwined economics with terrorism, endangering both tourism and foreign investment. ASEAN officials said their leaders will push for a clear signal from the summit that the region is capable of handling terrorism and still safe for tourists.

Officials expect greater pressure on Indonesia—largely in private—to rein in radical religious groups that have already infiltrated other parts of the region. But it will be hard for the summit to find tough new anti-terrorism initiatives, coming less than two weeks after a summit of the Asia Pacific Economic Cooperation forum—which includes many ASEAN members—pledged "concrete steps" against terrorism. Those steps include tighter security for shipping containers, fortified cockpit doors in airliners and strengthened customs cooperation. Human-rights groups also warned ASEAN governments not to respond to terrorism by curtailing civil liberties. ...

CRITICS FEAR SINGAPORE USING TERROR WAR TO DUCK REFORMS

SINGAPORE—This paternalistic city-republic, where spitting on the sidewalk or failing to flush a public toilet is against the law, has embraced America's war against terrorism with such enthusiasm that some people here suspect the war is being used to stifle the clamor for a more open and democratic society.

Often criticized for its anachronistic ways, including caning, Singapore-like neighboring Malaysia and Indonesia—has welcomed Washington's initiative against global terrorism. The republic aims not only to crack down on militants calling for an Islamic state in the region but also, critics say, to shift attention from overdue reforms.

The arrests this month of 21 suspected Islamic terrorists shocked Singaporeans. The city, which has thrived on commerce, banking and the service industry, is often described as an Asian oasis of tranquility. But some fear this community, which lives under the vigilant eye of a Big Brother government, is infected by the terrorism virus.

The first warning came last December with a similar wave of 15 arrests. Police said the suspects, members of the fundamentalist Islamic group Jemaah Islamiyah, had planned to target U.S. interests, possibly Singaporean naval and air bases that have become important maintenance facilities for the U.S. Navy and Air Force.

Last year alone, 100 U.S. warships docked in Singapore. A U.S. 7th Fleet manual to servicemen advises: "The people of the Republic of Singapore are conservative in their dress and their demeanor. They consider unkempt personal appearance to be offensive. It is important that the hospitality of the Singaporeans not be abused."

Said a senior European diplomat: "Everyone knows, including Singapore's Asian neighbors, that both the new Changi Naval Base with its deep-water pier and the Paya Lebar Air Base have become de facto U.S. bases for warships and planes shuttling between U.S. bases in Korea and Japan and the Persian Gulf. Singapore wants to save face by calling the bases facilities for visiting ships and planes."

BOSNIA-HERZEGOVINA STILL STUBBORNLY SEPARATE

BANJA LUKA, Bosnia-Herzegovina—Before going to the polls early this month, Bosnians got a lecture from Paddy Ashdown, the feisty former British politician who rules this Balkan land with the powers of a colonial viceroy.

"The question is simple," Ashdown told voters. "Will you join Europe or will you be left behind in the stagnant pool of the Balkans?"

The ballots have been counted and the results were announced during the weekend. The verdict was unanimous. Bosnia's Serbs, Croats and Muslims all rejected the moderate politicians who have been working toward the unified, multiethnic state envisioned by the 1995 Dayton peace agreement.

Instead, they voted overwhelmingly for the hard-line ethnic politicians who signaled their respective constituencies that they would go along with the Dayton rules just enough to keep the international aid pumps primed, but not so much that a genuine pluralistic society could take root here again.

In the Serb half of Bosnia, known as the Republika Srpska, the big winner was the Serbian Democratic Party (SDP), the party of the Serbs' wartime leader, Radovan Karadzic, an indicted war criminal who remains in hiding.

Similarly, Bosnia's Muslims and Croats, whose forced cohabitation in the so-called Muslim-Croat Federation was the result of a U.S.-imposed shotgun marriage, voted for the same nationalist parties that led them into a fratricidal civil war a decade ago.

Ashdown, whose official title is High Representative for Bosnia-Herzegovina, called the election results "a cry for help", but political leaders and analysts from the region are asking what further proof the international community needs to understand that the Dayton formulas do not work.

Yugoslav President Vojislav Kostunica, who led the democratic opposition that ousted his predecessor, Slobodan Milosevic, has said repeatedly that the future of Bosnia's Serbs lies with Serbia. He praised the SDP for its

"wise" policies and congratulated the party on its victory. Milan Protic, a former Belgrade opposition leader who "It is no secret Singapore believes that the recently completed a tour as Yugoslavia's ambassador to the U.S., does not share Kostunica's enthusiasm for the

SDS, only his skepticism about Bosnia's future.

"I don't know of a single politician—Croat, Muslim or Most of them have learned that mimicry is the best way to deal with the West. They parrot the lines the international community expects to hear," Protic said. ...

The Dayton agreement stopped Bosnia's war, but it has not been able to rebuild a real peace. As a nation, Bosnia-Herzegovina exists only in the minds of the European and American bureaucrats who run the place as a kind of international protectorate. For local inhabitants, it's a convenient fiction they sometimes play along with, sometimes not. ...

Economically, the country remains a basket case, with unemployment estimated at 40 percent to 60 percent. In the Republika Srpska, factories are working at 10 percent of prewar capacity.

The only business that has flourished across ethnic boundaries is organized crime. Bosnia has become a European hub for cigarette smuggling, drug smuggling and human trafficking. This week, 11 UN police officers assigned to a special squad that was supposed to crack down on human trafficking and prostitution were fired for aiding and abetting those crimes.

The politicians take their cut too. According to the latest official report, \$150 million to \$300 million in state revenues for the last fiscal year are "missing" through fraud and mismanagement.

But saddest of all is that seven years after Dayton, the brutal "ethnic cleansing" project of Karadzic and his cohorts appears to be irreversible.

According to official figures, about 300,000 refugees have gone back to live in areas where they are the ethnic minority. This has been the major accomplishment for Bosnia's international administrators. But the war created 1.8 million refugees, and it is now clear that most of them will remain in ethnically separate zones. ...

Bosnia's international overseers have done a good job of restoring property rights to refugees. Of 256,312 claims for the return of property, the High Representative's office has been able to restore legal title to 150,984. But the owners are not returning to their properties; they are selling them. ...

An estimated 14,500 international peacekeeping troops, including 2,000 U.S. soldiers, are still stationed in Bosnia. They maintain a fairly low profile, and continue to be stymied in their efforts to track down the elusive Karadzic.

There is no feeling that any of the sides is ready to return to a state of war, but there also is a consensus that it is still too soon to withdraw the peacekeepers.

Ashdown, the high representative, dressed down local political leaders in Sarajevo last week, telling them that the international community is losing interest in Bosnia.

"Time," he warned, "is not on our side."

CALIFORNIA PHYSICIAN TIED TO GERM WARFARE, STOCKPILED WEAPONS, DEADLY PATHOGENS

IRVINE, Calif.—On the morning of Feb. 28, 2000, a man wearing a black hood ran up to Patrick Riley in front of his office, shot him flush in the face and fled.

Riley, a biotechnology entrepreneur, survived. But two days later, his business partner, a doctor named Larry C. Ford, killed himself with a shotgun after learning he was suspected of being behind the shooting.

Then police began receiving phone calls saying Ford had left something behind: a cache of weapons and anthrax.

Police and federal investigators began to unearth evidence that Ford had another life—that he was not just a brilliant, if somewhat geeky, gynecologist who hoped to develop a device to protect women from AIDS.

Buried next to his swimming pool they found canisters containing machine guns and C-4 plastic explosives. In refrigerators at his home and office were 266 bottles and vials of pathogens, including salmonella, cholera, botulism and typhoid. The deadly poison ricin was stored, with a blowgun and darts, in a plastic bag in the family room. A compartment under the floorboards held medical files on 83 women.

What the searchers did not find was anthrax, and the fear of what remained unfound prodded the investigation on.

Around Irvine, most people knew Ford, 49, as a committed Mormon and a family man.

Trained as a gynecologist and microbiologist, he taught scholarly articles on diseases.

said Ford had intentionally made them ill. Epidemiologists investigated but said they found nothing suggesting deliberate infection.

Then there were the suggestions that Ford was working for the CIA. Several people said he sometimes told them so. Others said they simply assumed it.

One thing that is clear is that Ford was involved with the apartheid government of South Africa.

Authorities learned that Ford had been a consultant to Project Coast, which has been accused of creating weapons for use against opponents of apartheid. Ford's laboratory assistant, Valerie Kesler, said he once traveled to South Africa with a vial in his vest pocket. That the vial held lethal bacteria, she said.

Ford met with scientists from South Africa's Project Coast in the 1980s to discuss chemical and biological warfare, said Wouter Basson, who headed the project.

Project Coast, which has been accused of trying to create deadly bacteria that would only affect blacks, poisoning opponents' clothing and stockpiling cholera, HIV and anthrax, opened an offshore bank account to pay Ford.

He also passed a bag filled with cholera, typhoid, botulism, anthrax and bubonic plague to a South African military doctor during a meeting at the house of the South African trade attaché in California, former FBI informant Peter Fitzpatrick told 60 Minutes.

[JR: The enigmatic Dr. Ford is a puzzle but his inferred involvement with the plagues of South Africa and his connections with the CIA are less ambiguous. The real mystery, apart from his suicide, is why he was stockpiling pathogens and weapons around his home. One could speculate that he was about to sell these items or he was connected to or engaged in some upcoming nefarious covert operation here in the U.S. or abroad. Unless and until some intrepid investigator looks into this strange shooting and mysteries and secrets are kept dead and buried.]

LEGALLY DRUGGING OUR CHILDREN JUST GOT EASIER

promoting the legal drugging of America's children also known as the good folks of the pharmaceutical industry. Earlier this month, a federal judge struck down a Food and Drug Administration regulation that required drug makers to test medicines routinely given to children.

As a result, America's legal drug pushers are once again free to offer their potent concoctions for our kids' consumption without having to prove that they are safe or effective for pediatric use.

This is no small matter, given the skyrocketing number of children being prescribed heaping helpings of powerful mood-altering drugs. For instance, 1.5 million kids are currently taking Prozac and its equivalents even though the FDA hasn't approved these drugs for use by anyone under 18.

In making his ruling, U.S. District Judge Henry Kennedy, Jr. made it clear that the problem wasn't the FDA's attempt to protect our kids, but Congress' failure to authorize them to do so. He pointed out that earlier this year Congress considered but passed on the chance to require drug companies to make sure that products designed for grown-ups but regularly given to kids are, in fact, safe for children to take.

Instead, our elected representatives—legislating at University of California campuses and wrote dozens of under the influence (LUI) of the \$18 million drug companies have donated to congressional campaigns After his suicide, former patients came forth and this election cycle—approved an industry handout, offering "financial incentives" to companies willing to take the trouble to find out if their products are dangerous for kids. Rewarding companies that bother to behave with ordinary civic responsibility is becoming a bad habit for Washington and it reveals their scary baseline assumption that, left alone, big business can never be expected to do the right thing.

> Sens. Christopher Dodd, Mike DeWine, and Hillary Clinton are cosponsoring a new bill that would supersede the federal court's ruling and give the FDA legal authority to require drug testing for children. "Children will be harmed if we don't pass this legislation," warns DeWine. So far, the troika's efforts to bring the bill to a vote have been thwarted by the drug companies' loyal beneficiaries in the Senate.

> But Capitol Hill is not the only pharmaceutical industry-friendly place in Washington. The drug companies also appear to have found an ally inside the highest echelons of the FDA.

> In keeping with the White House's habit of assigning foxes to guard the henhouses they used to stalk—including the tres-vulpine Harvey Pitt and Gale Norton—last summer the president appointed lawyer Daniel Troy as the FDA's general counsel. While in private practice, Troy had successfully challenged the agency's power to regulate drug companies—particularly the companies' ability to freely promote and market their products.

It probably shouldn't come as too much of a surprise then that, from his lofty post, Troy has overseen a dramatic decrease in the number of drug companies that have been reprimanded for running false or misleading commercialseven as the drug ads filling our TV screens and magazines have multiplied. Of course, it could just be that the drug companies have all joined the Boy Scouts and are now being meticulously honest and trustworthy.

One of the pharmaceutical industry's weapons of suicide, it will become shrouded in a wall of silence choice in its fight to free itself from federal oversight and then disappear into a place were all such has been the First Amendment, a tactic once favored by none other than Daniel Troy. Groups aligned with

the industry have successfully used free speech arguments to convince courts to strike down regulations barring drug companies from advertising so-called "compounded drugs" and from telling doctors about unapproved uses for its products such as giving adult drugs to children. The founding Chalk up another profitable victory for those fathers would have had to pop a lot of pills to conceive of this perversion of the Bill of Rights.

> Reeling from these rulings and under increasing pressure from the drug industry, this spring the FDA invited interested parties to comment on whether any of its other rules raise "First Amendment issues". Among the flurry of feedback the agency received was a suggestion from the ever-helpful gang at Pfizer that the FDA do away with those pesky rules requiring drug companies to list a product's side effects and replace them with a cheerful reminder that since all medications come with some risks, patients should always check with their doctor before taking them.

> Makes sense. Why bother letting consumers know that downing a brightly colored, widely advertised little pill might cause nervousness, anxiety, insomnia, restlessness, suicidal thoughts, self mutilation, manic behavior, and bad breath when a simple and direct "Consult your doctor"—or rather 'consult your overworked, underpaid, HMOtormented physician"—will suffice? Who on earth takes a prescription drug without consulting their doctor? It's not like patients can prescribe the drugs for themselves, although now that I've said it, I fear I've given drug companies and Daniel Troy an idea for the ultimate regulatory rollback.

> This kind of self-serving, the-public-be-damned thinking is precisely why we need strong drug industry oversight in Washington, not appointees and politicians beholden to their deep-pocket patrons. Especially when our children's health and well-being are at stake.

[JR: It has been reported, and naturally denied, that many of the children involved in the numerous school shootings: Columbine, CO; Santee, CA; West Paducah, KY; Pearl, MS; Jonesboro, AR and Springfield OR were on mood or mind-altering medications. Any child that fits a profile as to what teachers might recognize as "abnormal", are instructed to recommend psychological examinations, which usually results in the prescribing of mind or mood-altering drugs that could cause violent behavior in some children. Another example of improper oversight in the administering of unsafe prescription drugs and their side effects is other dangerous "compounded" drugs that are intermixed in common injections. On July 7, 1999, the American Academy of Pediatrics (AAP) issued, with the U.S. Public Health Service (USPHS) a joint statement alerting clinicians and the public of concern about thimerosal, a mercury-containing preservative used in many vaccines. The reason for the warning is that himerosal contains a related mercury compound called ethyl mercury. Mercury is a toxic metal that can cause immune, sensory, neurological, motor, and behavioral dysfunctions. Symptoms of mercury toxicity in young children are extremely similar to those of autism. Why, in eighty years, they have never ordered one clinical test on the effects of thimerosal in vaccines is beyond me. Although it has now been "recommended" that thimerosal be removed from many vaccines it is still contained in ALL influenza vaccines and the CDC just announced a major increase of influenza nationally and is recommending everyone get influenza shots. Doesn't this make you feel safe in rushing out to get your flu shots? Some might say you are probably already brain dead to follow the advice of the CDC so a little more mercury poisoning shouldn't matter, and just maybe the flu shot

might actually prevent you from getting the flu.]


