WATER DEPTHS IN MALACCA STRAITS ALTERED The Hindu News Service, 1/12/05

Kuala Lumpur, Jan. 12. (PTI): The northern section of one of the world's busiest shipping channels, the Straits of Malacca, may have had its draught altered by several metres in the aftermath of the December 26 sub-sea earthquake, according to reports.

The reports said water depths in parts of the Straits of Malacca could have dropped from 4000 feet before the quake to as low as 100 feet.

Thousands of navigational aides, such as buoys held in place by mushroom-shaped anchors were carried off to new locations by 50-100-foot waves following the quake, a report in shipping journal Portsworld quoted by the Star newspaper

According to the U.S.-based National Geospatial-Intelligence Agency it may take months if not years to re-chart altered coastlines throughout the region.

Old shipwrecks marked on charts had been relocated, joined by new wrecks that would have to be salvaged, moved or charted, Portsworld said.

The U.S. agency, which analyses spy satellite imagery and produces maps and charts for the Defence department, has received an unconfirmed report that one area of the Straits of Malacca, which separates peninsular Malaysia from the Indonesian island of Sumatra had its depth cut from 4060 feet to 105 feet, the Star said.

In another area of tsunami-affected waters, a merchant marine ship had logged that the depth was cut from 3855 feet to just 92 feet, the Star

The U.S. Navy would be sending two ships to begin efforts to re-chart the waters, it said.

A tsunami is a natural phenomenon consisting of a series of waves generated when water in a lake or the sea is rapidly displaced on a massive scale. Earthquakes, landslides, volcanic eruptions, and the impact of extraterrestrial bodies such as meteorites, can generate tsunamis which can rapidly and violently inundate coastlines, causing devastating property damage, injuries, and loss of life.

The term "tsunami" comes from the Japanese language meaning harbour ("tsu") and wave ("nami"). The term was created by fishermen who returned to port to find the area surrounding the harbour devastated, although they had not been aware of any wave in the open water. A tsunami is not a sub-surface event in the deep ocean; it simply has a much smaller amplitude (wave heights) offshore, and a very long wavelength (often hundreds of kilometers long), which is why they generally pass unnoticed at sea, forming only a passing 'hump" in the ocean.

Tsunamis were historically referred to as tidal waves because as they approach land they take on the characteristics of a violent onrushing tide, rather than the sort of cresting waves that are formed by wind action upon the ocean (with which people are more familiar). However, as they are not actually related to tides, the term is considered misleading, and its use is discouraged by oceanographers.

The Real Scandal: No Alert Notifications

As journalist-at-large Soltec wrote in the lead article for this issue, telecommunications technology is such that an email message can be received half a world away in a matter of four minutes—and the telephone is even faster. So why, oh why, was there no warning of the tsunami spawned by the "megathrust" earthquake on December 26, 2004?

We appreciate permission to reprint the following article by Austrian Academic Director of the European University Center for Peace Studies, Dietrich Fischer, who poses some hard questions and points to other excellent sources of information on this subject.

These reports confirm that the U.S. military base on Diego Garcia in the Indian Ocean received a warning of the impending tsunami, but civilians did not. As we know now, the warning was not passed on.

This is a crime of unprecedented proportions and should be exposed.

Diego Garcia, as a U.S. Navy Base, is a member of the PACIFIC tsunami warning system, even though it is located in the Indian Ocean. Its members were informed by the National Oceanic and Atmospheric Administration (NOAA) in Colorado that there is a tsunami in the Indian ocean, but that there is no danger in the Pacific. (There is a 56-minute video by John Pilger about Diego Garcia, Stealing a Nation. The island has been central in the military operations against Afghanistan and Iraq).

This exposes the military's justification of itself as "protecting lives" as a sham. Someone who shoots a policeman receives the death penalty in the United States. But if someone bears responsibility for a large portion of the estimated 200,000 who died in the tsunami by withholding life-saving information from those who need it, that is not now considered a crime, even though it is far more serious.

Someone who lost a relative or friend in the tsunami ought to file a lawsuit against those who knew but failed to inform the people in danger, including the commander of the military base in Diego Garcia, and perhaps the Pentagon.

There is little chance that they could win the case, but it would get a lot of publicity and help invigorate the debate about the role of the military in our world.

The following column argues that even without an official tsunami warning system in place in the Indian

Ocean, a warning could have been given in time to many of those who were affected.

THE LESSONS FROM THE TSUNAMI Inter-Press Service, 1/4/05

In an interview on CNN on January 2, the head of the National Oceanic and Atmospheric Administration (NOAA) in Colorado was asked the question on everyone's mind: Why was no warning issued to the countries that were hit by a tsunami after NOAA detected the strong earthquake off the west coast of Sumatra on December 26? He responded that first of all, there was no warning system in place, there was nobody in those countries to receive the message. Second, NOAA did not have a precise model of the tsunami and could not have known how many need to evacuate.

It does not take an expensive warning system to suspect that this magnitude 9 earthquake under the sea might be followed by a tsunami, and that thousands of people's lives along the densely populated coast lines facing the epicenter could be in danger. A magnitude 8.3 earthquake in Lituya Bay off the Alaskan coast in 1958 generated a wave sweeping up to 516 meters altitude, washing trees off mountain slopes, fortunately in an unpopulated area. True, not every earthquake under the ocean generates a tsunami, but the precautionary principle tells us to prepare for the worst in case of uncertainty.

Even if the job description of the scientists who detected the earthquake did not include warning those whose lives were in danger, it was their moral responsibility to do so. They may not have had phone numbers of government agencies in charge in the affected countries. But if they had informed anyone who could pass on the warning, even at night, including friends and relatives, they may have been able to reach some people in the affected areas who could have forwarded the information to others. If someone called ten others, and those in turn each called ten more, and so on, a billion people could be reached in principle in only nine steps. Even if some fail to pass on the warning, others will.

People without telephone can be warned by neighbors. Radio broadcasts and Internet messages will also be picked up by some, who can inform others in person and by phone. Helicopters could have beamed warnings by megaphone along the endangered shorelines.

Why nothing of that sort was done is incomprehensible.

The U.S. State Department could have contacted its foreign embassies in the region, and governments directly. Some governments did have information, but failed to act on it, fearing its adverse effect on tourism. It took the tsunami 3 hours and 52 minutes to reach Sri Lanka, less for Thailand, but plenty of time for a warning. There is enough blame to be shared.

It is not necessary to know precisely what areas are in danger and need to be evacuated. What mistake is more serious: going to higher ground when in retrospect it may turn out unnecessary, or to stay and drown?

For the people on the West Coast of Sumatra, time

for a warning was short, only about 20 minutes for Banda above, on the Richter scale, are recognized as "rare great LOCATION - OFF W COAST OF NORTHERN Aceh, one of the most affected areas. Moreover, some phone lines were destroyed. But people should have been educated that strong earthquakes are often followed by destructive waves. Those who were not seriously injured by the quake itself could have reached safer ground.

...It is welcome that many governments and individuals have made available over \$1 billion for the rescue effort. But that still represents only 1/10 of 1 percent of the world's annual military budget. Much more will be needed, and can be made available before more lives are lost to thirst, hunger, injuries and disease.

In this enormous tsunami disaster, over 155,000 people are already known to have died, tens of thousands are missing, and many more could die from diseases caused by contaminated drinking water. This immense suffering, which has been covered widely by the media, has for once vividly shown the magnitude of the structural violence that goes on unreported: an estimated 125,000 people per day, or 45 million per year, mostly children and the elderly, die needlessly from hunger and preventable diseases in our world of plenty. What consumers in the West spend for ice-cream, cosmetics and pet food would suffice to cover adequate nutrition and health care for all the people in the world who now lack it!

Let us redouble our efforts to end this horrible injustice.

DISCREPANCIES IN THE TSUNAMI WARNING SYSTEM

We are dealing with one of the most serious humanitarian disasters in recorded history. It is therefore essential that any failure or recorded discrepancy in the Tsunami warning system be the subject of careful analysis and investigation.

Magnitude of an earthquake is defined as:

"...a measure of the strength of an earthquake or strain energy released by it, as determined by seismographic observations. This is a logarithmic value originally defined by Charles Richter (1935). An increase of one unit of magnitude (for example, from 4.6 to 5.6) represents a 10-fold increase in wave amplitude on a seismogram or approximately a 30-fold increase in the energy released. In other words, a magnitude 6.7 earthquake releases over 900 times (30 times 30) the energy of a 4.7 earthquake—or it takes about 900 magnitude 4.7 earthquakes to equal the energy released in a single 6.7 earthquake!" (USGS http://neic.usgs.gov/ neis/general/glossary.html>)

"A Major Earthquake", according to the U.S. Geological Survey (USGS), has a magnitude of 7.00 to 7.99 on the Richter scale.

When an earthquake has a magnitude of 8.0 or more, it is categorized as "a Great Earthquake".

The magnitude 9.0 earthquake off the coast of Northern Sumatra on the 26th of December 2004, belongs to the category of "Great Earthquakes".

earthquakes" capable of causing major damage over an area in excess of 1000 km (Chile 1960, Alaska 1964, and west coast of British Columbia, Washington, Oregon, 1700) <www.pgc.nrcan.gc.ca/seismo/eqinfo/richter.htm>.

In this regard, the USGS has categorized the 26 December earthquake as "a megathrust earthquake": the fourth largest earthquake in the world since 1900.

This categorization of earthquakes is an integral part of the tsunami warning system, applied by different national and international bodies, including the Pacific Tsunami Warning Center (PTWC) based in Hawaii. The latter categorizes earthquakes according to their magnitude and bases its "evaluation" of the danger of a tsunami on the recorded magnitude on the Richter scale. It then emits a "bulletin", which includes an

Discrepancies in the Tsunami Bulletins

Although the complete archive of PTWC bulletins is not available, recent bulletins exhibit a consistent pattern in the evaluation of earthquakes in the Pacific basin as well as in regions adjacent to the Pacific. The "danger of a tsunami" is based on the parameters of the earthquake, namely its magnitude on the Richter scale, with one significant and noteworthy omission: the evaluation on the 26th of December 2004 constitutes an exception to this routine procedure, when compared to the pattern of reporting and evaluation of recent earthquakes, each of which is carefully categorized for the purpose of establishing a tsunami warning.

In other words, one would expect that the danger of a tsunami associated with an earthquake of magnitude 9.0 (i.e. 26 December 2004) would be evaluated according to the same criteria / standards as those pertaining to previous and subsequent earthquakes, all of which were of lesser magnitude.

But this is not what happened!

The fourth largest earthquake since 1900 was neither subject to routine categorization nor to "evaluation" with a view to establishing the "danger of a tsunami".

It is worth noting, in this regard, that three days prior to the M-9.0 earthquake, a M-7.9 earthquake was recorded with an epicenter off the South Pacific MacQuarie islands on the 23rd of December. The PTWC issued the following routine advisory:

THIS EARTHQUAKE HAS THE POTENTIAL TO GENERATE A WIDELY DESTRUCTIVE TSUNAMI IN THE SEA NEAR EARTHQUAKE. AUTHORITIES IN THAT REGION SHOULD BE AWARE OF THIS POSSIBILITY.'

Bear in mind that a M-9.0 earthquake is ten times greater in magnitude than a M-8.0 earthquake, to the extent that one would at least expect a similar statement to that provided in relation to the MacQuarie islands earthquake.

According to Columbia University's Earth Institute, the M-9 earthquake of December 26 released energy equivalent "roughly to the energy released in 700 million Hiroshima bombs. An event of this type and of this size is known as a 'megathrust' and occurs in this location approximately every few hundred years." Ironically, for earthquakes of significantly lesser magnitude (6.8 and above), the PTWC had, as a matter of routine, issued a tsunami warning, with the notorious exception of the M-9.0 earthquake of December 26.

Why?

December 26, 2004: Omission and Exception in the Pattern of Reporting

The following pattern can be observed in recent PTWC bulletins, for earthquakes in the Pacific Basin or in a region adjacent to the Pacific:

1. For an earthquake of M-6.6 on the Richter scale, the following advisory was issued:

ORIGIN TIME - 0626Z 01 JAN 2005 However, earthquakes with a magnitude of 9.0 or COORDINATES - 5.0 NORTH 92.2 EAST

SUMATERA MAGNITUDE - 6.6)

THIS EARTHQUAKE IS LOCATED OUTSIDE THE PACIFIC. NO TSUNAMI THREAT EXISTS TO COASTLINES IN THE PACIFIC.

EARTHQUAKES OF THIS SIZE DO NOT **PRODUCE USUALLY DESTRUCTIVE** TSUNAMIS. HOWEVER SMALL SEA LEVEL CHANGES MAY BE OBSERVED IN THE VICINITY OF THE EPICENTER.

2. for an earthquake of M-6.8:

ORIGIN TIME - 1415Z 06 DEC 2004 COORDINATES - 43.0 NORTH 144.9 EAST LOCATION - HOKKAIDO JAPAN REGION MAGNITUDE - 6.8

NO DESTRUCTIVE PACIFIC-WIDE TSUNAMI THREAT EXISTS BASED ON HISTORICAL EARTHQUAKE AND TSUNAMI DATA.

HOWEVER - EARTHQUAKES OF THIS SIZE SOMETIMES GENERATE LOCAL TSUNAMIS THAT CAN BE DESTRUCTIVE ALONG COASTS LOCATED NEAR THE EARTHQUAKE EPICENTER. AUTHORITIES IN THE REGION OF THE EPICENTER SHOULD BE AWARE OF THIS POSSIBILITY.

Note: The same phrase has been used in previous warnings: "EARTHQUAKES OF THIS SIZE SOMETIMES GENERATE LOCAL TSUNAMIS THAT CAN BE DESTRUCTIVE ALONG COASTS LOCATED **NEAR** THE **EARTHQUAKE** EPICENTER" is a standard evaluation of the U.S. Geological Survey (USGS) applied to earthquakes of M-6.8 - 7.3 (see <www.fema.gov/emanagers/2004/ nat050304.shtm>)

3. for an earthquake of M-7.9 (subsequently revised to 8.1):

In other words, there was no routine statement in the case of a M-9.0 earthquake, which had originally been identified as an 8.0 on the Richter scale. As mentioned earlier, the routine statement should have been similar to the MAGNITUDE- 7.9 of 23 DEC recorded North of MacQuarie.

Moreover, the bulletin was released at 01.14 GMT after the Tsunami had already hit the Sumatra coastline.

There were two subsequent bulletins released by the PTWC, the second did not acknowledge the existence of a Tsunami in the Indian Ocean.

The second bulletin was issued at 02.04 GMT on the 26th. It revised the Magnitude to 8.5 and stated that there "is the possibility of a Tsunami near the Epicenter". This statement is mistaken. By 02.00 GMT, the Tsunami was no longer in the realm of "possibility", it had already hit the coasts of Indonesia, Malaysia, Thailand and Myanmar.

MAGNITUDE - 8.5

The third bulletin issued the following day on the 27th at 15.35 GMT acknowledges the tsunami and revises ex post facto the Magnitude from 8.5 to 9.0.

We Did Not Know!

...Nine (9.0) on the Richter scale: The Director of the Hawaii Warning Center stated that they did not know that the earthquake would generate a deadly seismic wave until it had hit Sri Lanka, more than one and a half hours later, at 2.30 GMT (see Timeline below).

Not until the deadly wave hit Sri Lanka and the scientists in Honolulu saw news reports of the damage there did they recognize what was happening... 'Then we knew there was something moving across the Indian Ocean,' said Charles McCreery." (quoted in the NYT, 28 Dec 2004).

It is impossible that the movement of the seismic wave could have gone unnoticed following the initial devastating impact of the tidal waves in Aceh and North Sumatra immediately after 1.00 GMT on the 26th.

Moreover, according to expert opinion, known to the scientists who were monitoring seismic activity, an earthquake of more than 6.5 on the Richter scale has the potential of triggering a tsunami. In other words, there should have been no hesitation by scientists or government officials on the likely impacts of an earthquake which was initially assessed at 8.0 on the Richter scale.

Moreover, the Hawaii Center's statement is at odds with the Timeline of the seismic wave disaster, which no doubt was also being monitored on a continuous basis, once it hit the Indonesian and Thai coastlines by satellite imaging using the Global Positioning System (GPS). These satellite images are available to a number of agencies including the U.S. military and intelligence. It should be noted, however, that the energy of a tsunami is transferred through open water, it is therefore not easily detectable in the Ocean.

It is the extreme seismic activity which provides advance warning prior to the tsunami reaching the coastline. But as pointed out above, the tsunami had already hit the Indonesian coast shortly after 01.00 GMT:

...Thailand was hit almost an hour before Sri Lanka and the news reports including photographic evidence were already out. Surely, these reports out of Thailand were known to the scientists in Hawaii, not to mention the office of Sec. Colin Powell, well before the tidal wave reached Sri Lanka.

We wanted to try to do something, but without a December? plan in place then, it was not an effective way to issue a warning, or to have it acted upon," Dr. McCreery said. "There would have still been some time-not a lot of time, but some time—if there was something that could be done in Madagascar, or on the coast of Africa."

The above statement by Director of the Hawaii Center is also inconsistent.

The seismic wave reached the East African coastline several hours after it reached the Maldives islands. According to news reports, Male, the capital of the Maldives was hit three hours after the earthquake, at approximately 4.00 GMT. By that time everybody around the World knew.

It is worth noting that the U.S. Navy was fully aware of the deadly seismic wave, because the Navy

.."We didn't have a contact in place where you could just pick up the phone," Dolores Clark, spokeswoman for the International Tsunami Information Centre in Hawaii said. "We were starting from scratch."

The Issue of the Ocean Sensors Is a Red Herring

...We are not dealing with information based on Ocean sensors: the emergency warning was transmitted in the immediate wake of the earthquake (based on seismic data). The earthquake took place at 00.58 GMT on the 26th of Dec. The report was transmitted to The State Department and the U.S. Navy following the earthquake.

With modern communications, the information of an impending disaster could have been sent around the World in a matter of minutes, by email, by telephone, by fax, not to mention by live satellite Television.

In Lev. 17:7 and II Chron. 11:15 the word "devils" is sair, in Hebraic. It is nothing more than a hairy goat.

In conclusion, the devils in Rev. 16:14 and 18:2 are damons, defiled spirits.

(Note: I believe the author is wrong on Revelation 18:2 as "foul spirit" and "unclean and hateful birds" are idioms meaning tangible "Jews". Many times in Scripture, "Jews" are referred to as "birds".)

Those in 16:14 are Anarchistic-Bolshevism, Communistic-Socialism and Fabianism which came out of the mouth of the Red Dragon, or Serpent, of Jewry, out of the mouth of the Jew Beast System and out of the mouth of the False Prophet who is Jewry's current god, Prince Abdul Baraba Baha, who is prophesying that, before the end of 1953 he will destroy God's Kingdom

The unclean defiled spirits in Rev. 18:2 are the above evilness born, hatched and reared in the spiritually-dark belfry of the upside down Synagogues of Satan, namely Jewry's head. Perhaps one will also point to Eph. 4:9 which says Christ Jesus descended into hell after death in order to conquer the Devil, then after gaining the victory He preached to the imprisoned spirits of the people drowned in the deluge in 2345 B.C., which I Peter 3:19, 20 tells about. Again one may point to Eph. 2:2 and declare there is proof positive that the Devil is the prince of the air above the Earth whose power Christians are wrestling with as recorded in Eph. 6:12. Again, one may go back to the Serpent in Gen. 3 and declare Adam named the tempter of Mother Eve, serpent, because he was more subtil [sic?] than any beast of the field which the Lord had created. The word "any" makes him a BEAST of the field. He (Nachash), therefore, was named after the Serpent, the Devil, because of his craftiness. Therefore, the serpent in Gen. 3 is a snake given the faculty of talking in human voice. Thus, the original translation of *Eph.* 4:9 is: "Now that He ascended, who is it if not (He) that also came down at the beginning unto that lowest portion of the world? He who descended (came down) is the same also that ascended up far above all heavens, that He might fill all things" (verse 10).

For it is better, if the will of God be so, that ye suffer for well doing, than for evil doing. For Christ also hath once suffered for sins, the just for the unjust, that He might bring us to God, being put to death, in the flesh, but quickened by the spirit: By which also He passed on a herald unto these lives within protection (of God). Which even yet are disobedient, which once the longsuffering of God waited in the days of Noah, while the ark was a preparing, wherein few, that is, eight souls were saved by water."

Thus, we observe instead of Christ Jesus descending

Cloud is nephele, fine mist. It is synonymous with the cloud in Rev. 10:1 and the "heaven" (shachaq) in Psalm 89:6, 37 and the "cloud" (shachaq) in Job 35:5 meaning fine dust. In other words, it is the atomical construction of the microcosmical order of things material.

> Thus, I Thess. 4:16, 17 says: "For the Lord Himself shall descend from heaven (the dimension of spirit) with a shout, with the voice of the archangel, and with the trump of God: and all spiritually-dead unto Christ (will) be at (the) point (of) rising before (the return of Christ): Then we which are active around (in the National Rule With God) shall be ordained to spring into (spiritual illumination—changed in the twinkle of an eye, *I Cor*. 15:51, 52) together with them into the changed atomical construction of our bodies to meet the Lord in the Mind:

It is the rapture (but not as taught by present day churches). It will be the consummation of father Jacob's dream of the ladder extending from the dimension of spirit to the dimension of the material with angels walking up and down on it as recorded in Gen. 28:12-15. It is also the city of God symbolized as coming down from heaven in Rev. 21.

INDONESIA WANTS FOREIGN TROOPS OUT, DEFENDS RESTRICTIONS ON TSUNAMI AID AFP, 1/13/05

Indonesia told foreign troops helping tsunami victims to get out of the country soon and defended tough new restrictions on aid workers, while rich nations prepared to freeze Jakarta's debt repayments.

Vice President Yusuf Kalla said foreign troops should leave tsunami-hit Aceh province on Sumatra Island as soon as they finish their relief mission, staying no longer than three months.

"Three months are enough. In fact, the sooner the better," Kalla was quoted by the state Antara news agency as saying.

The armed forces of Australia, Japan, Malaysia, Singapore and the United States have all rushed task forces to Aceh in the wake of the December 26 disaster, which killed at least 106,500 Indonesians out of a total of more than 159,000 deaths in Asia.

United Nations officials struggling to coordinate a massive relief operation have welcomed their participation, particularly to deliver aid to isolated coastlines accessible only by sea or air.

But their presence in Indonesian territory has been a sensitive issue for the world's largest Muslim-populated nation, which has traditionally kept foreign military, particularly the United States and Australia, at arm's

Lavrov said that Russia continues "firmly but in a constructive spirit and without sliding back to confrontation" to pursue its line in the international

He said that it is the tasks facing the entire world community that are preventing a slide towards confrontation.

..."Economic growth is giving this country more opportunities to develop political dialogue, which we back with concrete projects," the minister told the news conference.

He said this concerns Russia's relations both with its closer partners—CIS member-countries—and most of the European states, countries of the Asia-Pacific region, the Middle East, and Latin America, and the U.S. whose administration, Lavrov is firmly convinced, will not depart from its course of strengthening partnership relations with Russia.

"Our policy rests on real possibilities," the minister gave an assurance.

Those possibilities could be quite real—IF they hinge on "the" solution presented through the Global Alliance Program. Note that Mr. Lavrov includes the U.S. in Russia's "strengthening partnership relations". Meanwhile, however, Russia does not appear afraid to back one of the countries on the U.S. "hit list":

THROUGH ARMS TO SYRIA, PUTIN CHALLENGES U.S. MIDDLE EAST GAME RULES *DEBKAfile*, 1/12/05

Disturbing reports were coming out of the Russian capital Wednesday, January 12 about Russian president Vladimir Putin's plan to accede to Syria's request for advanced weaponry during president Bashar Assad's visit to Moscow on January 24. DEBKAfile's U.S. and Israeli security sources quickly contradicted reports that 18 Iskander-M or SS-X-26 surface-to-surface missiles were on the table. The items for sale, they revealed, are advanced SA-10 air defense systems of the type that protects Moscow and shoulder-held SA-18 anti-air missiles, whose transfer to the Hizballah and/or Iraqi guerrillas would move at least two sets of goal posts in the Middle East balance of strength.

The SA-10 is an effective defense against Israeli warplanes and missiles, including cruise missiles. Its presence in Syria would therefore knock a serious hole in Israel's deterrent ability against Assad and the Hizballah.

The Kremlin's willingness to sell these items to Israel's northern neighbor and backer of Iraqi insurgents is a rocket from the Putin to the White House in Washington, a declaration that he has had enough of sitting on the sidelines and watching U.S. move the January 30 election pieces around the Iraq board and tilt the Palestinian ballot in favor of Mahmoud Abbas (Abu Mazen) as Yasser Arafat's successor.

The Russian president's exasperation boiled over when he saw Washington's hand in the Ukraine presidential election stirring up the anti-Moscow Orange Revolution that brought opposition leader Viktor Yushchenko to office, and, again, in the sale of the Russian oil concern Yukos. The Russian leader felt he had been made the target of a wellorchestrated campaign for undermining him personally

Israeli prime minister Ariel Sharon is also put on notice that Washington's backing alone does not lend him the status of unilateral player for disengagement in the Palestinian arena.

CHERTOFF NOMINATED FOR **HOMELAND SECURITY CHIEF**

<u> AUSCHWITZ: THE FINAL COUNT</u>

A thought-provoking new anthology edited by English historian Vivian Bird casts stark new light on II. As the evidence shows, the official "facts" just don't add up.

...Auschwitz is central to the Holocaust legend. If it can be proved that the official stories we have been told about Auschwitz are not true, the entire fabric of the Holocaust ultimately has to unravel. What, then, did happen at Auschwitz?

On April 18, 1945, in the immediate aftermath of World War II, the New York Times reported that 4 million people died at Auschwitz. This "fact" was reported over and over again during the next halfcentury, without being questioned.

However, on January 26, 1995, commemorating the 50th anniversary of the Auschwitz liberation, both the Washington Post and the New York Times itself reported that the Polish authorities had determined that, at most, 1.5 million people (of all races and religions)—not "4 million"—died at Auschwitz of all causes, including natural causes.

Yet this was not the first time this drastically We recently ran a copy of the United States reduced figure appeared in the major media. Almost five years previously, on July 17, 1990, the Washington Times reprinted a brief article from the London Daily Telegraph. That article stated:

> 'Poland has cut its estimate of the number of people killed by the Nazis in the Auschwitz death camp from 4 million to just over 1 million ... The new study could rekindle the controversy over the scale of Hitler's 'final solution'"

> "Franciszek Piper, director of the historical committee of the Auschwitz-Birkenau Museum, said yesterday that, according to recent research, at least 1.3 million people were deported to the camp, of whom about 223,000 survived.

"The 1.1 million victims included 960,000 Jews, between 70,000 and 75,000 Poles, nearly all of the 23,000 Gypsies sent to the camp and 15,000 Soviet prisoners of war.

Shmuel Krakowsky, head of research at Israel's Yad Vashem memorial for Jewish victims of the Holocaust, said the new Polish figures were correct: 'The 4 million figure was let slip by Capt. Rudolf Hoess, the death camp's Nazi commander. Some have bought it, but it was exaggerated.'... [P]laques commemorating the deaths of 4 million victims were removed from the Auschwitz museum earlier this month."

This detail of history was intriguing since, after all, history books had said for a generation that of the 6 million Jews who died during the Holocaust, 4 million died at Auschwitz alone. Thus, if the new facts were correct, the actual overall number of Jewish Holocaust victims had to be considerably less than the muchtalked-about figure of 6 million. Put simply: subtract the former 4 million Jews dead at Auschwitz from the popular 6 million, and that leaves 2 million Jews dead. press releases about criminal suspects added the Simple math—and a controversial conclusion indeed.

More recently, Walter Reich, former director of the U.S. Holocaust Memorial Museum in Washington, jumped into the debate over Auschwitz. On September 8, 1998, the Washington Post published an article by Reich in which he addressed Jewish outrage over a group of elderly Polish nuns who wanted to place crosses in memory of Christians who died at Auschwitz. Reich was responding to what he described as a "well-meaning" August 31, 1998 editorial in the *Post* about the affair.

Reich commented that the editorial "illustrates how old fictions about Auschwitz have been accepted as facts—fictions that have been used repeatedly to distort the camp's history". Evidently, the Post had forgotten its own report on the Auschwitz numbers that it had published three years previously and chose, instead, to repeat "old fictions... accepted as facts". What, then, were those "old fictions ... accepted as

The Post identified Auschwitz-Birkenau as the death camp "where 3 million Jews and millions of others were murdered by the Nazis". Recent scholarship by a Polish historian has put the number of deaths there conservatively at about 1.1 million, with other estimates ranging to about 1.5 million. Approximately 90 percent of the dead were Jews.

The Post's numbers may have been derived in part from the inflated estimate—originally of Soviet origin and endorsed by Polish authorities after the war-of about 4 million dead. This number, and other numbers of similar magnitude, were repeated so often that they came to be accepted by many as true, even though historians in Poland and elsewhere have revised this number down considerably.

Honest people find no problem with Reich's call (in the essay) for "only words of accurate history" in reportage about Auschwitz. Today, a major first step toward "only words of accurate history" is the release of a new anthology on Auschwitz, assembled by English writer Vivian Bird.

Auschwitz: The Final Count examines the "new" reports in the mainstream media (outlined above) and provides essential additional facts that must be considered in order for the full story of Auschwitz to finally be told. Bird's 109-page book is a compendium (supplemented with commentary by Bird) of four complete, previously published works relating to Auschwitz and the Holocaust.

The book features a fascinating introduction by Bird exploring the little-known but thoroughly documented phenomenon in which the numbers of the official Auschwitz "death toll" have plummeted from a "high" of 9,000,000 dead to a rock bottom of 73,137 (of whom 38,031 were Jews). And readers will note that of the 26 widely varying figures cited by Bird, all come from a variety of "responsible" and mainstream sources. No figure Bird cites comes from any source accused of "denying the Holocaust", whatever that means.

Nevada Vs. Delaware: Private Vs. Public

Budget's "Tip of the Week" #16:

Response to the Often-Asked Question: What About Delaware?

"My friend said that her attorney said that the best place to incorporate is Delaware because that's where all the big corporations are based."

The fundamental distinction between Nevada and Delaware is that while Nevada's statutes create benefits for **private** corporations, Delaware's corporate statutes have principally been designed to benefit shareholders of public corporations. Many large, public companies that trade on various exchanges across the country incorporated in Delaware because Delaware's statutes provide the best protection of the rights of shareholders. In recognition of the foregoing, Delaware's corporate law with regard to corporate takeovers is the strongest anywhere in the country. And if you want to "go public" with your corporation some day, Delaware's onerous disclosure requirements probably won't bother you.

On the other hand, Nevada's provisions for establishing and maintaining privacy of ownership and control is unparallelled. In Nevada, ownership of a corporation is not a matter of public record: There is no prohibition against the use of bearer shares; there is no requirement for stock to be issued; nor is there any requirement for an annual meeting of stockholders. In terms of privacy of control, the use of contract ("nominee") officers and directors has been a common practice since 1925. In addition, NRS 78.257 makes it a gross misdemeanor for anyone to even attempt to use a Nevada corporation's records for purposes contrary to the interests of the

Delaware is NOT "tax-free". A Delaware corporation's taxable income is taxed at the rate of 8.7%. In addition, its franchise tax has a graduated rate depending on capitalization, amounting to a minimum of \$30 and a maximum of \$130,000.

Nevada's corporate law easily surpasses Delaware's in terms of protection of corporate officers and agents. Delaware has recently adopted a statute that allows a corporation to limit the liability of a director for monetary damages—but officers of Delaware corporations are still not covered. The following acts of officers and directors would be protected under Nevada law, but are exposed to liability under Delaware statutes:

- 1. Acts or omissions not in good faith;
- 2. Monetary damages occasioned by acts of officers (directors are now exempt);
- 3. Breach of a director's duty of loyalty;
- 4. Transactions involving undisclosed personal benefit to the officer or director;
- 5. Acts or omissions that occurred prior to the date that the statute which provides for indemnification of directors was passed and approved.

In summary, Delaware cannot match Nevada in providing shelter for small, private corporations.
