#### MASSIVE "BURNS"





In this regard, note that more than 50 years ago—in the more broad-ranging purposes than "regime change" or early days of the Cold War-that ex-CIA man William F. Buckley, Jr., the soon-to-be self-appointed "leader" of the American "conservative" movement, laid it on the line. Writing in Commonweal on January 25, 1952 Buckley said that he was willing to support "Big Government" for "the duration [MCP: of the Cold War] because—he proclaimed—only "a totalitarian bureaucracy within our shores" could assure total victory over the communist menace. The anticommunist Cold War is now over, but the anti-Islamic (so-called "anti-terrorist") Hot War is now under way. And here on American shores we have a new strength diminishing. #### JAPAN DRAWN INTO CHINA-RUSSIA-INDIA ALLIANCE?

Easily the most fascinating diplomatic development of the week is the story on the evolving relationship between Russia and Japan and how, as the title of the story put it, the "China factor brings" two former foes (Russia and Japan) together.

The story was written by James Brooke of the Times News Service and the main theme is best expressed by a remark attributed by the story to Toshiyuki Shikata, a military analyst at Tokyo University.

According to Shikata, as quoted by Brooke: "As The reported source of the story was no less than long as Japan and Russia are in cooperation, China will not be able to move against us (Japan)." The story then proceeds to observe that Shikata's view is "echoing a rapidly emerging view in Tokyo".

> It's no secret that Japan—a nation bereft of natural resource—salivates over prospects of exploiting the immense oil and gas deposits in Eastern Russia and, as the story reports it, "Japan has lobbied Moscow successfully to build an oil pipeline in the Sea of Japan, skirting China."

> No secret either that Russia is in great need of the kind of capital and technology that Japan can contribute to Russia's overall development, particularly of the latter's immense but untapped natural wealth. So the need is mutual and that's what has finally drawn the two former "foes" to each other.

What intrigues is the interpretation given to that drawing together by the Tokyo University military analyst Shikata as well as by Prof. Michael Austin of Yale University.

Shikata, as mentioned, welcomes the growing economic cooperation between his country and Russia as something of an assurance that China won't move against Japan. The interpretation reinforces the theme advanced by this writer in a piece he wrote Monday ("The New Cold War...") to the effect that Russia and China, together with India, are now in a "strategic alliance". That being so, an ally of Russia, as Japan is turning out to be, could then translate into an ally of China, which would then make the "strategic alliance" one that would include Japan.

In brief, what started out as a strategic alliance between the three nuclear powers that are Russia, China and India would seem to be evolving toward a strategic alliance that would include the most powerful economy in Asia, and the second-largest in the world.

That this is bound to create panic in Washington can't be doubted. At least, if the "thinkers" of the Bush administration are really thinking, they should see in the remarks of Tokyo University's Shikata one more evidence of the increasing isolation of the United

Recall that Russia, China, India and Japan share a common experience in terms of their relationship with the U.S. All four have had turbulent and even traumatic relationships with the United States. If it's difficult to imagine, "Moscow forgiving Washington" for having engineered the dissolution of the Soviet Union, it's just as difficult to imagine Tokyo forgiving Washington for the atomic holocaust that was dropped on Hiroshima. In the case of India, one doubts whether that country will easily forget the way its great leader Jawaharlal Nehru was demonized by the U.S. throughout the Cold War for the alliance that he struck with the Soviet Union. And as for China, well, we all know the state of that country's relationship with the U.S.

So panic there is bound to be in Washington and nowhere is that state of panic more evident than in the interpretation given by Prof. Austin of Yale University.

Prof. Austin, as quoted by the story, attributes the growing cooperation between Russia and Japan as a function or result of what he describes as "China's effort to achieve regional supremacy".

The trouble with that analysis is it assumes, rather unconvincingly, that Russia is disturbed and therefore opposed to China's "effort to achieve regional supremacy" in Asia. The analysis seems farfetched and because it is farfetched, it suggests an effort to sow intrigue between Russia and China, and that, this piece takes it, is convincing indication enough that there, indeed, is panic in U.S. circles over the evolving character of the strategic alliance between the foes of the U.S.

A strong China in the region could translate into something positive for its strategic allies and the U.S. would only have itself to blame for that.

Leaders of the fractious Jewish community in Russia are taking opposing positions on whether a vote last week by the lower house of Russia's parliament to condemn an overtly anti-Semitic statement signed by 19 of its members amounts to progress in the fight against anti-Jewish bigotry.

Yet four major Jewish leaders—Chief Rabbis Berel Lazar and Adolf Shayevich; Vladimir Slutsker, president of the Russian Jewish Congress; and Mikhail Chlenov, secretary general of the Eurasian Jewish Congress—agreed in separate phone interviews that the recent upsurge of anti-Semitism in Russia is more intense than anything since the mid-1990s. They said it has caused deep worry among the estimated 500,000 Jews living in Russia.

Rabbi Lazar and Slutsker, the two pre-eminent Jewish leaders in the country, praised Russian President Vladimir Putin as a staunch and indispensable ally of the Jewish community in the fight against anti-Semitism. But Rabbi Shayevich, a bitter rival of Rabbi Lazar, said Slutsker is "too close" to Putin to be an effective advocate for Jewish concerns or in the struggle for human rights and democracy, which many in Russia and abroad believe Putin himself to be imperiling.

About 500 individuals signed the letter, which appeared Jan. 13 on the website of the St. Petersburg newspaper Rus Pravoslavnaya. The 19 Duma deputies who signed were all from the Communist Party and the nationalist, pro-Putin party Rodina.

The letter asked Prosecutor General Vladimir Ustinov to launch proceedings "on the prohibition in our country of all religious and ethnic Jewish organizations as extremist".

Its publication and repudiation by the Duma come amid a series of events over the past month that have made anti-Semitism a hot story in Moscow. The events include the brutal beating of a leading Jewish religious activist, Rabbi Alexander Lakshin, while walking on the street near Chabad's Marina Rosche synagogue, and two television discussion programs aired in the past week that allowed several signers of the letter to propound anti-Semitic theories to millions

After the first program, K'Baryer, a Crossfirestyle debate, was shown Feb. 3, some 53 percent of the more than 100,000 viewers who called the station maintained that Albert Makashov, a Communist Party deputy who has long revelled in unabashed anti-Jewish rhetoric, got the better of his debate opponent, Aleksei Leonov, a former cosmonaut who denounced Makashov for ethnic incitement.

Under pressure from the Putin administration, the Duma voted Feb. 4 by 306-58 to adopt a declaration stating that the "clear anti-Semitic intent" of the Jan. 13 letter "prompts indignation and sharp condemnation". The Duma declaration said it was "particularly sorrowful" that the letter came as the world mourned the victims of Auschwitz, adding that the consequences of such initiatives "could be extremely dangerous for a multiethnic state like Russia".

Yet the night before the vote, Makashov staunchly defended the letter on K'Baryer. The show's host, Vladimir Solovyov, who is Jewish, defended the invitation to Makashov by contending that it is important to expose the issue of anti-Semitism instead of allowing it to fester.

Yet Chlenov, the founder of the Vaad, the first official Jewish organization in the Soviet Union back in 1989, said the TV debate helped Makashov spread his anti-Jewish libels before an audience of millions.

"The fact that 53 percent of viewers felt Makashov won the debate does not necessarily mean they are all anti-Semites, but also reflects the fact that Makashov is a dynamic debater, whereas Leonov was quite weak," Chlenov said.

On Vremina, with veteran talk show host Vladimir Posner, Slutsker countered Krutov's attack on the Shulchan Aruch. #### THE CONTROVERSIAL LETTER: 'JEWISH GOOD FORTUNE—RUSSIAN TEARS'

Representatives of Russian society demand from the Procurator General of the Russian Federation the suppression of illegal propagation of Jewish national and religious extremism.

Dear Mr. Procurator General:

On 18 December 2003 the President of the Russian Federation, Vladimir V. Putin, brought up the following statistics in the course of a televised address: In 1999 there were four convictions under article 282 of the Russian Federation Criminal Code on inciting inter-ethnic hatred. In 2000 there were 10. And in 2003 "more than 60 criminal investigations were made into cases of inciting inter-ethnic discord. Of these, 20 cases went to court and guilty verdicts were handed down in 17-20 cases."

#### Who is shouting, "Stop, thief!"?

The overwhelming majority of these cases are initiated by Jewish activists or organizations, who charge their defendants with the "anti-Semitism". But the overwhelming majority of those accused and convicted are Russian patriots. Now they have been joined by the well-known independent politician and pamphleteer, the former head of Goskompechat (the State Publishing Commission) B. S. Mironov.

We recognize that the statements of Russian patriots regarding Jews frequently have a sharply negative and excessively emotional character, unacceptable in public discussion, and constitute what the law regards as extremism. None of the abovementioned trials, however, ever examined the reason for this sharpness, the original source of this extremism in the given inter-ethnic conflict.

Indeed the chief problem that must be elucidated in investigations and trials is: Do the sharply negative assessments of the Jews by Russian patriots correspond in essence to the truth about the Jews (against whom they are directed) or do they not? If they do not correspond to the truth about the Jews, then the discussion can deal with the defamation of Jews and with the incitement of religious and interethnic discord. But if they do correspond to the truth, then such assessments, apart from and independent of their emotionalism, cannot be qualified as defamatory, as incitement to discord, and the like. (For example, to say a decent person is a criminal is defamatory to him; but to name someone who has committed a crime a criminal—this is a truthful statement of facts.)

Furthermore, since there are two sides in this interethnic conflict (the accuser and the accused), it follows and 48) that one must clear up: which of the sides actually started this conflict in the first place and was responsible for it, and whether the actions of the accused might not be acts of self-defense in response to acts of aggression by the accusing side?

This is a condensed version of the Jewish law code, the Sulkhan Arukh, compiled several centuries ago on the basis of the *Talmud* and required in practice to this day. In the introduction to the book the head of KEROOR, Rabbi Zinoviy Kogan makes the frank were no italics in the copy as received. "The editorial council of KEROOR considered it necessary in this translation to omit some instructions of the *halakha* [Jewish law] ... whose inclusion in the publication in the Russian language would be perceived by the population of Russia, which does not adhere to Judaism, as an unprovoked insult. > We would suppose that already on the basis of this one official Jewish publication the law-enforcement agencies should, in accordance with article 282 of the Criminal Code of the Russian Federation, suppress the propagation of a religion that kindles hatred among the Jews for the rest of the "population of Russia". All the more, if we take a glance at "the ideally complete volume of the unsurpassed monument of Judaic morals"—the Shulkhan Arukh, that is studied in the yeshivas.

We will use translations of it from the Amsterdam (i.e., place of worship) is to pronounce this curse upon Judaic publication, made by a judicial expert, the Hebrew scholar Dr. K. We will cite below characteristic extracts from the text as corrected by him, together with the references to specific Jewish sources (drawing confidence from both the qualifications of the German Hebrew scholar and the authority of the German law court).

> -"His [the non-Jew's] seed is considered like the seed of cattle." (Tosefta—an addition to the Talmud. Ketubot, 3 b). "For [dead] servants and maids ... words of comfort should not be said to their relatives, but it is necessary to say to him [the Jewish master]: 'may God compensate you for your loss', just as one says to a man whose bull or donkey has died." (Iore

-"It is forbidden to save them [non-Jews, akums] when they are close to death. For example, when you see that one of them has fallen into the sea, do not rescue him, even if he wants to pay.... It is permitted to test medicine on an akum to see whether or not it is effective." (*Iore de'a* 158-1)

-"The money of *akums* is essentially like goods with no owner, and the one who arrives first may take possession of them." "With respect to an akum there is no fraud." (Khoshen ha-mishpat 156-5, Khaga; 227-26; 348-2, Khaga).

-"When a Jew has robbed an akum and they force him [the Jew] to take an oath, then he must in his heart proclaim his oath invalid, because he has been forced to take it." (*Iore de'a* 329-1, *Khaga*). Note: This again concerns the behavior of Jews during investigations and trials!

-"When it has been established about someone that he has betrayed a Jew or his money three times to an akum, then it is necessary to seek out ways and means to squeeze him out of the world." "As to expenditures needed for squeezing a traitor from the world, all the inhabitants of a locality are obliged to contribute." (Khoshen ha-mishpat 388-15 and -16).

-"It is permitted to kill a traitor in any place, even in our time. It is permissible to kill him early, before he manages to make a denunciation [powerful enough to cause 'bodily or monetary loss, no matter how small'] ... and everyone who is the first to kill acquires merit." (Khoshen ha-mishpat 388-10)

-"The Jew-free-thinker, i.e., he who carries out the divine service of akums ... to kill all such people is a good deed. When there is authority to kill them publicly by the sword, then let this be carried out; but if there is not, then they must be entangled in every way possible in order to cause to them death. For example, when you see that one of them has fallen into a well and in the well there is a ladder, then hurry to take out it, saying: 'I have a major concern; I need to get my son down from the roof, and I will bring it right back to you,' or something like that." (Khoshen ha-mishpat 425-5)

for killing—are to this day is not only theory, but also practice. Thus, the former chairman of Kharkov Jewish community E. Khodos published proofs ("An Axe above Orthodoxy, or who killed my father", Chabad movement carried out the 1990 murder of priest-Jew Father Aleksandr Men' (who "carried out the divine service of the Akums" and dreamed about the creation of a "Jewish Orthodox Church", something that is considered a criminal offense according to the laws of the state of Israel). But the authorities in the Russian Federation have not been interested in such evidence. Criminals are supposed to be sought only among "Russian anti-Semites".

From recent cases it is possible to mention a strange series of reports of vandalism that took place in 1998 and 1999. On the night of 13 May 1998, an explosion occurred at a synagogue in the Mar'inaya grove in Moscow damaging a wall. During the same day "a burning canister of gasoline" was placed not far from the synagogue in Otradny. In Irkutsk "a Jewish cemetery was desecrated"-of course the uproar in the international media was loud and all of them put the blame, without any evidence, on some sort of Russian Nazis (Nezavisimaya Gazeta, 15 May 1998).

But when shortly after that, in 1999, a synagogue in Birobidzhan was destroyed, it was established in court that the Jews themselves hired a man to do this (Radonezh, 1999, No. 15-16), but the democratic mass media were silent about this.

On the basis of the rules and practices of Jewish behavior that have been cited above, it is not difficult to understand why a constant companion of Jews among all peoples has been notorious "anti-Semitism", i.e., the non-acceptance of Judaic morality. For this very reason Jews did not have an equality of rights in the Christian states and attained it only as a result of anti-monarchist bourgeois revolutions.

NEW FINDINGS SUPER-SIZE OUR TSUNAMI THREAT By Tom Paulson, Seattle Post-Intelligencer, 2/7/05

Scientists studying the Indian Ocean tsunami have discovered startling evidence that the killer waves, at least for one coastal area in northern Indonesia, were much larger than earlier believed.

The new findings, of keen interest worldwide to researchers seeking insights into the mechanics of this disaster, also translate into a disturbing suggestion that the experts have significantly underestimated the magnitude of the tsunami threat in the Pacific Northwest and perhaps to coastal communities around the Pacific Ocean.

'It's just staggering," said Andrew Moore, a scientist at Kent State University who was on a research team, led by Yoshinobu Tsuji of the University of Tokyo, that recently returned from studying the wave's trail of destruction on the west coast of Sumatra.

Moore, Tsuji and their colleagues found preliminary evidence the tsunami's height along an extensive section of shoreline south of the city of Banda Aceh averaged about 80 feet above sea level, with "run-ups" on inland slopes often reaching well over 100 feet. They estimated the wave's average velocity on shore at 45 feet per second.

'It's mind-boggling to think about," said Vasily Titov, a mathematician and tsunami computer modeler at the Pacific Marine Environmental Laboratory in Seattle. The lab, operated by the National Oceanic and Atmospheric Administration, is host to some of the world's top tsunami scientists.

These findings, Titov said, will almost certainly prompt significant revisions to basic theory and the tsunami models—as well as a serious upgrade in the predicted size of the tsunami expected from a major quake off the coast of Washington and Oregon.

"Our worst-case scenario may not be the worst-case scenario," acknowledged Titov.

height above sea level (sometimes referred to as "flow depth" to distinguish it from onshore "run-up" heights) had put it at 30-35 feet—primarily in parts of Indonesia nearest the undersea earthquake.

Scientists studying the Indian Ocean tsunami, which killed at least 160,000 people, had heard the reports of higher waves—of branches and bark stripped off the first 80 feet of trees, of water marks and roof damage found at or beyond the height of six- or seven-story buildingsbut most figured these were the results of the wave running up slopes or isolated instances of "focusing".

A tsunami wave can get "focused" or boosted suddenly in one location as it comes on land by undersea canyons or other near-shore geographical features or structures that squeeze the massive surge of water into a narrower outlet-much like a nozzle increases the force of the water coming out of a hose.

But Moore said his team's wave-height measurements were consistent over a long stretch of coastline and found well back from any slopes, indicating these were direct measurements of the overall elevation of this massive wall of water as it came on shore.

"It's just so far beyond what any of us have ever dealt with before," said Moore, who before moving East pursued tsunami research at the University of Washington.

Our first focus article reinforces Soltec's comments experts have been predicting will arise from the ocean depths the next time the Cascadia Subduction Zone erupts.

The Cascadia zone, encompassing western Washington and Oregon, is where two "tectonic" plates that make up the Earth's fractured crust collide. The offshore Juan de Fuca Plate runs into and dives under, or "subducts", the North American plate.

The plates move in a slow, subterranean collision at an average speed of four centimeters per year. It wasn't until the mid-1990s that it was widely recognized that Cascadia was an active subduction fault, capable of producing the planet's most massive kind of earthquake, centered some 100 miles offshore.

Since then, NOAA scientists have been working with the state Department of Natural Resources and others to create "hazard maps" that quantify the height and reach of a tsunami in certain communities at highest risk.

But the maps are based on a tsunami with a maximum wave height of about 30 feet.

"That was the best evidence available at the time," said Tim Walsh, chief hazards geologist with the state agency.

'That's already a huge, incredibly destructive wave,' noted Titov. Until the Indian Ocean tsunami, he said, most experts would have thought it absurd to suggest a tsunami with an overall wave height greater than this.

But the tectonics of Cascadia and the undersea subduction fault near Sumatra that spawned the Dec. **26 tsunami are alarmingly similar**, Walsh said. "We look a lot like the Indian Ocean," he said, which means they may need to incorporate some new, bigger numbers in the hazard maps.

...Another finding that may be of critical importance to communities farther from the coast, on the Strait of Juan de Fuca and in Puget Sound, was the Dec. 26 tsunami's ability to retain its force even when going around corners. Scientists studying the waves' behavior in Sri Lanka were stunned to see what happened on the leeward side of the island nation.

It was fairly large in many locations on the west side, bigger than the numerical models predict," said Phil Liu, the Cornell University scientist who led an American survey team in Sri Lanka.

#### NEO-CONS, ISRAELI LOBBY DECLARE WAR ON PUTIN

America's neo-conservative elite and their collaborators in the pro-Israel lobby in Washington have fired a first shot in the opening guns of a new Cold War being launched against Russian Premier Vladimir Putin.

Although it hasn't been reported widely in the America mass media, Senators John McCain (R-Ariz.) and Joe Lieberman (D-Conn.), two of the Israeli lobby's leading congressional stalwarts, introduced a resolution in the Senate on February 19, condemning Putin and urging President Bush to push for suspending Russia's membership in the G-8 group of industrial nations.

Latching on to the president's emphatic declaration in his January 20 inaugural address of a new global campaign by the United States for the promotion of "democracy", Lieberman announced that "President Putin's assault on democracy in Russia violates the spirit of the industrialized democracies and the letter of Russia's obligations to the Group of Eight. We must openly confront anti-democratic backsliding in Russia for the sake of all those who look to the United States as a beacon for freedom."

The resolution was designed to put President Bush on the spot, coming just as President Bush was preparing for his scheduled meeting with Putin in Slovakia on February 24. [JI: Yes, right after Mr. Putin returns from his scheduled trip to IRAN.]

The motivation for the effort by the neo-conservatives and their congressional spokesmen to undermine Putin is quite clear, inasmuch as Putin recently challenged Bush and Israel by daring to say publicly that he (Putin) does not believe that Iran is seeking to build nuclear weapons of

Although the burgeoning hostility against Putin by the neo-conservatives has been widely hashed over in smallcirculation pro-Israel publications and American Jewish community newspapers on a regular basis, it has only been of recent date that mainstream publications such as The Washington Post and the New York Times, to name the most prominent, have begun to echo those concerns about Putin, almost as if the big-name dailies were taking the lead from the other journals. Reflecting on the fact that the media was increasingly promoting hostility to Putin, American Free Press noted on October 25, 2004 that the media's primary concern about Putin stems from the fact that he has been moving against the handful of billionaire plutocrats in Russia (many of whom also hold Israeli citizenship) who grabbed control of the Russian economy with the open-connivance of then-Russian-leader Boris Yeltsin, following the collapse of the old Soviet Union.

One American hard-line pro-Israel publication, *The* New Republic, raised the question on September 24, 2004: "Is Russia going fascist?" asserting that whether Putin personally remains in power or not, there is a growing movement "nationalist in nature" that holds great sway among the Russian population. TNR expressed concern that "a fascist revolution" could be in the offing, meaning a movement hostile to the Israeli oligarchs (with international criminal connections) who rule the Russian [economy]. Likewise, much earlier, in his 1995 book, Russia: A Return to Imperialism, Boston-University-based Israeli academic Uri Ra'anan sounded the concern that post-Soviet Russia may pose a threat to the West.

These works echo such writers as Jonathon Brent and Vladimir Naumov who, in their 2003 book, Stalin's Last Crime, published evidence that longtime Soviet leader Josef Stalin was almost certainly murdered in 1953 after he began moves toward exorcising Zionist influence in Soviet circles of power. They concluded by saying that "Stalin is a perpetual possibility", leaving open the theoretical proposition that Putin, or other would-be Russian leaders, may ultimately emerge as heir to Stalin's anti-Zionist

Essentially, with the American neo-conservatives (whose ideological godfathers are widely known as admitted ex-Trotskyite communists) now moving against Putin, it is as if we are seeing a rejuvenation of the war against Russian nationalism by the Trotskyites, retooled for 21st Century geopolitical considerations. Now—unlike in the first half of the 20th Century prior to the founding of the state of Israel—the central role of that Middle East state in the neo-conservative worldview cannot be understated, for the concern about Israel is a front-line consideration in the neo-conservative campaign against Putin.

Although Russia joined the G-8 nations (which includes Britain, Canada, Japan, France, Italy and Germany) in 2002, the companion resolutions in the Senate and the House ask the president to enlist the other G-8 countries to join with the United States in suspending Russia's G-8 membership until such time as President Bush decides that Russia is supposedly committed to so-called "democratic principles".

This is the second time that McCain and Lieberman introduced such a measure, although their last effort, in 2003, failed in committee. At that time, two other members of Congress, California Reps. Tom Lantos-Democrat—and Christopher Cox—a Republicanintroduced a companion resolution in the House of never voted upon.

Speaking of neo-conservatives and supplementary to our focus on Michael "Diablo" Chertoff in the previous issue of CONTACT: John Dimitri Negroponte, who oversaw the death squads in Honduras and went on to serve as U.S. Ambassador to the United Nations before becoming U.S. Ambassador to Iraq in the not-so-old Abu Ghraib-coverup days, is now the nominee for Director of Central Intelligence, the one man through whom all intelligence information from 15 separate agencies will flow and the man who will decide who is an "enemy of the state" and subject to "legal" humanrights abuses. #### JOHN NEGROPONTE Wikipedia, the free encyclopedia

John Dimitri Negroponte (born July 21, 1939) is the current United States ambassador to Iraq and the nominee as the first U.S. Director of National Intelligence. A career diplomat who served in the United States Foreign Service from 1960 to 1997, Negroponte served as the



U.S. ambassador to the United Nations from September of 2001 until June 2004. As ambassador to Iraq, Negroponte oversees the largest American diplomatic facility in the world....

#### **Ambassador to Honduras**

From 1981 to 1985 Negroponte was the U.S. ambassador to Honduras. During his tenure, he oversaw the growth of military aid to Honduras from \$4 million to \$77.4 million a year. At the time, Honduras was ruled by an elected but heavily militarily-influenced government. According to the New York Times, Negroponte was allegedly involved in "carrying out the covert strategy of the Reagan administration to crush the Sandinistas government in Nicaragua". Critics say that during his ambassadorship, human rights violations in Honduras became systematic.

Negroponte supervised the construction of the El Aguacate air base where Nicaraguan Contras were trained by the U.S., and which some critics say was used as a secret detention and torture center during the 1980s. In August 2001, excavations at the base discovered 185 corpses, including two Americans, who are thought to have been killed and buried at the site.

Records also show that a special intelligence unit (commonly referred to as a "death squad") of the Honduran armed forces, Battalion 3-16, trained by the CIA and the Argentine military, kidnapped, tortured and killed hundreds of people, including U.S. missionaries. Critics charge that Negroponte knew about these human rights violations and yet continued to collaborate with the Honduran military while lying to Congress.

In May 1982, a nun, Sister Laetitia Bordes, who had worked for ten years in El Salvador, went on a fact-finding delegation to Honduras to investigate the whereabouts of thirty Salvadoran nuns and women of faith who fled to Honduras in 1981 after Archbishop Óscar Romero's assassination. Negroponte claimed the embassy knew nothing. However, in a 1996 interview with the Baltimore Sun, Negroponte's predecessor, Jack Binns, said that a group of Salvadorans, among whom were the women Bordes had been looking for, were captured on April 22, 1981, and savagely tortured by the DNI, the Honduran Secret Police, and then later thrown out of helicopters alive.

In early 1984, two American mercenaries, Thomas Posey and Dana Parker, contacted Negroponte, stating Representatives which reached the House floor, but it was they wanted to supply arms to the Contras after the U.S. Congress had banned further military aid. Documents show that Negroponte brought the two together with a contact in the Honduran armed forces. The operation was exposed nine months later, at which point the Reagan administration denied any U.S. involvement, despite Negroponte's introductions of some of the individuals. Other documents detailed a plan of Negroponte and then-Vice President George H. W. Bush to funnel Contra aid money through the Honduran government.

> During his tenure as U.S. ambassador to Honduras, Binns, who was appointed by President Jimmy Carter, made numerous complaints about human rights abuses by the Honduran military and claimed he fully briefed Negroponte on the situation before leaving the post. When the Reagan administration came to power, Binns was replaced by Negroponte, who has consistently denied must be confirmed by the Senate.

having knowledge of any wrongdoing. Later, the **Honduras Commission on Human Rights accused** Negroponte himself of human rights violations.

Speaking of Negroponte and other senior U.S. officials, an ex-Honduran congressman, Efrain Diaz, told the Baltimore Sun, which in 1995 published an extensive investigation of U.S. activities in Honduras:

"Their attitude was one of tolerance and silence. They needed Honduras to loan its territory more than they were concerned about innocent people being killed."

The Sun's investigation found that the CIA and U.S. embassy knew of numerous abuses but continued to support Battalion 3-16 and ensured that the embassy's annual human rights report did not contain the full story.

The question of what John Negroponte knew about human rights abuses in Honduras will probably never be answered definitively, but there is a large body [of] circumstantial evidence supporting the view that Negroponte was aware that serious violations of human rights were carried out by the Honduran government, with the support of the CIA, if perhaps not with its direct approval. Senator Christopher Dodd of Connecticut, on September 14, 2001, as reported in the Congressional Record, aired his suspicions on the occasion of Negroponte's nomination to the position of UN ambassador:

"Based upon the Committee's review of State Department and CIA documents, it would seem that Ambassador Negroponte knew far more about government perpetuated human rights abuses than he chose to share with the committee in 1989 or in Embassy contributions at the time to annual State Department Human Rights

Among other evidence, Dodd cited a cable sent by Negroponte in 1985 that made it clear that Negroponte was aware of the threat of "future human rights abuses" by "secret operating cells" left over by General Alvarez after his deposition in 1984.

#### Appointment to the UN

When President Bush announced Negroponte's appointment to the UN shortly after coming to office, it was met with scattered protest. Some critics asserted that the administration intentionally arranged the deportation from the United States of several former Honduran death squad members who could have provided damaging testimony against Negroponte in his Senate confirmation hearings.

One of the deportees was General Luis Alonso Discua, founder of Battalion 3-16. In the preceding month, the U.S. government had revoked the visa of Discua, who was Honduras' Deputy Ambassador to the UN. After returning to Honduras, Discua stated that, in 1983, he had been brought to the United States to spend two months organizing Battalion 3-16.

#### Negroponte in Iraq

On April 19, 2004, Negroponte was nominated by U.S. President George W. Bush to be the U.S. ambassador to Iraq after the June 30 handover of sovereignty. He was confirmed by the United States Senate on May 6, 2004, by a vote of 95 to 3, and was officially sworn in on June 23, 2004, replacing L. Paul Bremer as the U.S.' highest ranking American civilian in

In the months Negroponte spent as U.S. Ambassador to Iraq he received plaudits, even from Bush administration critics such as Fred Kaplan, for his removal of corruption, graft and sycophants from the U.S. civilian presence in Iraq.

#### **National Intelligence Director Nominee**

On February 17, 2005, President George W. Bush named Negroponte as the first Director of National Intelligence, a position created due to recommendations made by the 9/11 Commission completed late in 2004. As with many presidential appointments, Negroponte

# Stay Small Or Increase Substance In Nevada

**Budget's "Tip of the Week" #18:** 

More on "Nexus" and "Substance"

Two legal issues crop up when operating a Nevada corporation which might have some activities in a foreign jurisdiction: "nexus" and "substance". Without getting into a full-blown legal definition for the purposes of this discussion, nexus can be considered equivalent to the related word, "connection". And for purposes of this discussion we can consider the legal issue of "substance" to mean "physical presence".

We have previously pointed out a list of conditions under which a Nevada corporation is not considered to be "doing business" in a foreign jurisdiction. It may, for instance, use an independent contractor to effect sales outside of Nevada, as long as each sale is not considered final until accepted in Nevada. If, however, a Nevada corporation has significant nexus in (connection to) another jurisdiction, in many cases the tax-hungry foreign state will seek to extend its tax laws to compel the Nevada corporation to pay some home-state taxes. A Nevada corporation with little presence in Nevada but which provides all sorts of equipment to an independent contractor working in, say, California could find itself under attack from the California Franchise Tax Board.

So far, at least, there are very few examples of small, private situations undergoing such scrutiny. However, in cases where the amounts of revenue derived from the foreign jurisdiction are large enough to present a "target of opportunity", various states are becoming increasingly aggressive in extending their tax tentacles. In auditing such a situation the home-state taxation authority will pose many questions relating to the "substance" (physical presence) of the Nevada corporation in Nevada.

Actual audit questions in establishing the substance of the Nevada corporation in Nevada can be very detailed and probing, including but not limited to thr following: employees (compensation, responsibilities, payroll returns); identification of officers and compensation; copies of phone bills; actual payments made on notes; list of suppliers and professional-service providers; where decisions are made regarding investments; copies of corporate records including minutes and resolutions; banking (copies of all bank statements, checks and deposit slips).

The Nevada Department of Taxation uses the following criteria to evaluate nexus in Nevada: use of an office, distribution house, warehouse, service enterprise or other place of business; maintenance of a stock of goods; solicitation of orders by employees or independent contractors; regular engagement in the delivery of property in this state, other than by common carrier or United States mail; or regular engagement in any activity in connection with the leasing or servicing of property which is located within this state.

From the foregoing it should be obvious that it is always best to remain small in order to keep the bureaucrats out of your private business affairs whenever possible. And if and when your business grows to become a substantial potential target, it may become necessary to broaden its Nevada base, in order to retain more "substance" in Nevada relative to "nexus" in the foreign jurisdiction.
