#### NEW WORLD ORDER/ONE WORLD **GOVERNMENT**

...The name, New World Order, is seen as something that developed as a consequence of the Gulf War in 1991, whereas the One World Government is recognized as being centuries old. The New World Order is not new, it has been around and developing under one or another guise for a very long time but it is perceived as a development of the future which is not the case; the New World Order is past and present. > The Committee appears to base much of its important decisions affecting mankind on the philosophy of Polish aristocrat, Felix Dzerzhinsky, who regarded mankind as being slightly above the level of cattle. As a close friend of British intelligence agent Sydney Reilly (Reilly was actually Dzerzhinsky's controller during the Bolshevik Revolution's formative years), he often confided in Reilly during his drinking bouts. The Club of Rome also has its own private intelligence agency and also "borrows" from David Rockefeller's INTERPOL. Every U.S. intelligence agency cooperates very closely with it, as does the KGB and the Mossad. The only agency that remained beyond its reach was the East German intelligence service, the STASI. The Club of Rome has its own highly organized political and economic agencies. It was they who told President Reagan to retain the service of Paul Volcker, yet another important Committee of 300 member. Volcker stayed on as Federal Reserve Board chairman, notwithstanding the faithful promise of candidate Reagan that he would dismiss him as soon as he, Reagan, was elected.

The Club of Rome, after playing a key role in the fundamentally from what Malthus and Von Hayek

management" (the forerunner of FEMA) program to President Kennedy. Several Tavistock scientists went to see the president to explain what it meant, but the president rejected the advice they gave. The same year Kennedy was murdered, Tavistock was back in Washington to talk with the National Aeronautical and Space Administration (NASA). This time the talks were successful. Tavistock was given a contract by NASA to evaluate the effect of its coming space program on American public opinion.

The contract was farmed to the Stanford Research Institute and the Rand Corporation. Much of the material produced by Tavistock, Stanford and Rand never saw the light of day and remains sealed until this day. Several Senate oversight committees and sub-committees I approached to obtain information told me they had "never heard of it", nor did they have the slightest idea where I might find what I was seeking. Such is the power and prestige of the Committee of 300.

In 1966, I was advised by my intelligence colleagues to approach Dr. Anatol Rappaport who had written a treatise in which the administration was said to be interested. It was a paper intended to bring an end to NASA's space program, which Rappaport said had outlived its usefulness. Rappaport was quite happy to give me a copy of his paper which basically claimed that NASA's space program should be scrapped. NASA has too many scientists who were exerting a bad influence on America because they were always eager to lecture school and university audiences on how rocketry worked, from construction to propulsion. Rappaport claimed that this would produce a generation of adults who would decide to become space scientists, only to find themselves "redundant", as no one would need their services by the year 2000.

No sooner had Rappaport's profiling report on NASA been presented to NATO by the Club of Rome, than the Committee of 300 demanded action. NATO-Club of Rome officials charged with urgent anti-NASA action were Harland Cleveland, Joseph Slater, Claiborne Pell, Walther J. Levy, George McGhee, William Watts, Robert Strausz-Hupe (U.S. ambassador to NATO) and Donald Lesh. In May 1967, a meeting was organized by the Scientific and Technological Committee of the North Atlantic Assembly and the Foreign Policy Research Institute. It was called "Conference on Transatlantic Imbalance and Collaboration", and it was held at Queen Elizabeth's palatial property in Deauville, France.

The basic purpose and intent of the conference at Deauville was to end U.S. technological and industrial progress. Out of the conference came two books, one of which is mentioned herein, Zbigniew Brzezinski's Technotronic Era. The other was written by conference chairman, Aurellio Peccei, entitled The Chasm Ahead. Peccei largely agreed with Brzezinski, but added that there would be chaos in a future world not ruled by a one world government.

In this regard, Peccei insisted that the Soviet Union must be offered "a convergence with NATO", such a convergence ending in an equal partnership in a New World Order with the United States. Both nations would be responsible for future "crisis management and global planning". The first Club of Rome's "global planning contract" went to the Massachusetts Institute of Technology (MIT), one of the premiere Committee of 300's research institutes. Jay Forrestor and Dennis Meadows were placed in charge of the project.

What was their report all about? It did not differ

natural resources to go around. The Forrestor-Meadows Report was a complete fraud. What it did not say was that man's proven inventive genius would in all likelihood work its way around "shortages". Fusion energy, the DEADLY enemy of the Committee of 300, could be applied to CREATING natural resources. A fusion torch could produce from one square mile of ordinary rock enough aluminum, for example, to fill our needs for 4 years.

Peccei never tired of preaching against the nationstate and how destructive they are for the progress of mankind. He called for "collective responsibility". Nationalism as a cancer on man, was the theme of several important speeches delivered by Peccei. His close friend, Ervin Lazlo, produced a work in 1977 in a similar vein which was called "Goals of Mankind", a landmark study for the Club of Rome. The entire position paper was a vitriolic attack on industrial expansion and urban growth. Throughout these years, Kissinger, as the designated contract man, kept in close touch with Moscow on behalf of the RIIA. "Global modeling" papers were regularly shared with Kissinger's friends in the Kremlin.

With regard to the Third World, the Club of Rome's Harland Cleveland prepared a report which was the height of cynicism. At the time, Cleveland was United States ambassador to NATO. Essentially, the paper said it would be up to Third World nations to decide among themselves which populations should be eliminated. As Peccei later wrote (based on the Cleveland Report):

"Damaged by conflicting policies of three major countries and blocs, roughly patched up here and there, the existing international economic order is visibly coming apart at the seams... The prospect of the necessity of the recourse to triage deciding who must be saved is a very grim one indeed. But, if lamentably, events should come to such a pass, the right to make such decisions cannot be left to just a few nations, because it would lend themselves to ominous power over life of the world's hungry."

In this is found the Committee policy to deliberately starve African nations to death as evidenced in the sub-Sahara nations. This was cynicism at its worst, because the Committee of 300 had already abrogated decisions of life and death unto itself, and Peccei knew it. He had previously so indicated in his book Limits of Growth. Peccei completely dismissed industrial and agricultural progress, and in its place, demanded that the world come under one coordinating council, to whit, the Club of Rome and its NATO institutions, in a One World Government.

Natural resources would have to be allocated under the auspices of global planning. Nation states could either accept Club of Rome domination, or else survive by the law of the jungle and fight to survive. In a first "test case", Meadows and Forrestor planned the 1973-Arab-Israeli War on behalf of the RIIA to sharply bring home to the world that natural resources like petroleum, in the future come under global planners control, meaning of course, under the control of the Committee of 300.

Tavistock Institute called for a consultation with Peccei, McGeorge Bundy, Homer Perlmutter and Dr. Alexander King. From the London meeting, Peccei traveled to the White House where he met with the president and his cabinet, followed by a visit to the State Department, where he conferred with the Secretary of State, the State Department's intelligence service and the State's Policy Planning Council. - (10) To weaken the moral fiber of the nation and to demoralize workers in the labor class by creating mass unemployment. As jobs dwindle due to the post industrial zero growth policies introduced by the Club of Rome, the report envisages demoralized and discouraged workers resorting to alcohol and drugs. The youth of the land will be encouraged by means of rock music and drugs to rebel against the status quo, thus undermining and eventually destroying the family unit. In this regard, the Committee commissioned Tavistock Institute to prepare a blueprint as to how this could be achieved. Tavistock directed Stanford Research to undertake the work under the direction of Professor Willis Harmon. This work later became known as "The Aquarian Conspiracy".
- (11) To keep people everywhere from deciding their own destinies by means of one created crisis after another and then "managing" such crises. This will confuse and demoralize the population to the extent where faced with too many choices, apathy on a massive scale will result. The four nuns were Communist subversive agents and their activities were widely documented by the government of El Salvador. The United States press and news media refused to give any space or coverage to the mass of documentation possessed by the Salvadorian government, which proved what the Mark Knoll Mission nuns were doing in the country. Mary Knoll is in service in many countries, and played a leading role in bringing Communism to Rhodesia, Mozambique, Angola and South Africa.

#### MALTHUS, VAN HAYEK, CLUB OF ROME

Malthus maintained that man's progress is tied to the Earth's natural ability to support a given number of people, beyond which point Earth's limited resources would rapidly be depleted. Once these natural resources have been consumed, it will be impossible to replace them. Hence, Malthus observed, it is necessary to limit populations within the boundaries of decreasing natural resources. It goes without saying that the elite will not allow themselves to be threatened by a burgeoning population of "useless eaters", hence, culling must be practiced. As I have previously stated, "culling" is going on today, using the methods mandated in the "Global 200 Report".

All economic plans of the Committee meet at the crossroads of Malthus and Frederick Von Hayek, another doom and gloom economist who is sponsored by the Club of Rome. The Austrian-born Von Hayek has long been under the control of David Rockefeller, and Von Hayek theories are fairly widely accepted in the United States. According to Von Hayek, the United States economic platform must be based on (a) urban black markets, (b) small Hong-Kong type industries utilizing sweat-shop labor, (c) the tourist trade, (d) free enterprise zones where speculators can operate unhindered and where the drug trade can flourish, (e) end of all industrial activity, and, (f) close down all nuclear energy plants.

Von Hayek's ideas dovetail perfectly with those of the Club of Rome, which is perhaps why he is so wellpromoted in right-wing circles in this country. The mantle of Von Hayek is being passed to a new, younger economist, Jeffrey Sachs, who was sent to Poland to take up where Von Hayek left off. It will be recalled that the Club of Rome organized the Polish economic crisis, which led to political destabilization of the country. The exact same economic planning, if one dare call it that, will be forced upon Russia, but if widespread opposition is encountered, the old pricesupport system will quickly be restored. The whole idea behind this is to curb Poland, and then Russian industrial expansion.

The Committee of 300 ordered the Club of Rome to use Polish nationalism as a tool to destroy the Catholic Church and to pave the way for Russian troops to reoccupy the country. The "Solidarity Movement" was a creation of the Committee of 300's Zbigniew Brzezinski, who chose the name for the "trade union" and selected its office holders and organizers. Solidarity is no "labor" movement, although Gdansk shipyard workers were used to launch it, but rather, it was a high-profile POLITICAL organization, created to bring forced changes in preparation for the advent of the One World Government.

Most of "Solidarity's" leaders were descendants of former Bolsheviks from Odessa, who were not noted for hating Communism. This helps to understand the saturation coverage provided by the American news media. Professor Sachs has taken the process a step further, ensuring economic slavery for Poland, only recently freed from the domination of the USSR. Poland will now become the economic slave of the United States. All that has happened is that the master has changed.

Brzezinski is the author of a paper that should be read by every American interested in the future of this country. Entitled "The Technotronic Era", it was commissioned by the Club of Rome. The paper is an open announcement of the manner and methods to be used to control the United States in the future. "This will encourage tendencies through the next several decades toward a technotronic era, a dictatorship leaving even less room for political procedures as we know them. Finally, looking ahead to the end of the century, the possibility of biochemical mind control and genetic tinkering with man, including beings which will function like men and reason like them as well, could give rise to some difficult questions."

Brzezinski was not writing as a private citizen, but as Carter's National Security Advisor, a leading member of the Club of Rome, a member of the Committee of 300, a member of the CFR, and as a member of the old Polish Black Nobility. His book explains how America must leave its industrial base behind and enter into what he called "a distinct new historical era".



### 'Bushonomics' Part II

...[P]eople need to understand the startling level of fiscal deterioration of the nation's public finances ... and the future consequences of this deterioration.

In the past, we have used a variety of statistics to point this out, but we have never put all of these together in one piece.... [O]n the day this Bush Cheney regime came to power, the total U.S. debt-to-GDP ratio was 78%. Now it is 308%. To put that into some context, the IMF considers a nation-state whose total debt-to-GDP ratio is 200% or more to be a "de-constructed Third World nation-state".

"De-constructed" in IMF terms simply means "collapse[d]". But the IMF, for political reasons, doesn't want to use the word "collapse[d]". Therefore they use the word "de-constructed".

What "de-constructed" actually means is that a political regime in that country, or series of political regimes, have, through a long period of fraud, abuse, graft, corruption and mismanagement, effectively collapsed the economy of that country. This is precisely the definition of Bushonomics I and II.

It should also be pointed out that on the day that the regime came to power, the income dispersion index of the United States, which is nothing more than the ratio between the total income of the top and bottom 10% of the population, was a factor of 129x, meaning that the total income of the top 10% of the nation was 129 times that of the bottom 10% of the nation. To date, that statistic stands at 319 times.

Further, it should be noted that, on the day the regime came to power, the top 1% of this nation owned 61.9% of all the private wealth of the nation. That number will have grown to 70% by the end of fiscal '05 in September; also, this regime will have been the first regime in the history of the nation to run trade deficits of an average 5% or more of GDP for 3 consecutive years.

All of theses statistics are the classic numbers used by Thomas Malthus in the Malthusian economic theorem, first published in 1822, wherein Malthus pointed out that in all nation-states in the last 2,000 years, when the above-referenced statistics and numbers were reached, those nation-states first underwent a political revolution, then underwent an economic collapse. Indeed, all of the numbers now have reached that magic Malthusian level, economic numbers that have never been seen before in the history of the American republic. [ED: Emphasis

> This fiscal deterioration has gone on not only at the federal level, but also in all levels of government. So, whereas the aggregate unsecured public debt of the nation, states, counties and municipalities on the day this regime took power was \$3.8 trillion, today that number is \$5.8 trillion.

> This level of fiscal deterioration in the nation's public finances, occurring at the governmental level, has also been seen throughout business and industry. For example, on the day this regime came to power, aggregate U.S. corporate pension account deficits were \$263 billion; today those deficits are \$1.5 trillion.

> In the arena of public pension systems, most notably those systems of the states, there has been marked credit quality deterioration in the assets that the state, public employee, pension plans own. An example of this can be seen in last year's State of Louisiana default within its teachers' pension system. This is due, primarily, to the fact that high-quality assets that had been bought by state pension funds in the 1990s have largely been substituted by assets of questionable value; the state, county and municipal pension systems having bought some \$2 trillion of these questionable assets during the time in which this regime has been in power, principally from the firm of Hicks, Muse and Tate, which is a major reseller in Carlyle investment group deals.

> Indeed, the General Accounting Office had noted in September 2003 that the nation, state, county and municipal pension systems were increasingly being filled with junk investments from those with political connections to the Bush Cheney Regime, and that this has—in the GAO's own words— 'dynamically imperiled' the future viability of the nation, state, county and municipal public pension systems. That's the GAO terminology.

> ...We have seen no effort .. to control health-care cost. Indeed, the Kaiser Family Foundation pointed out, in its September 2004 study, that under the Bush-Cheney regime aggregate health-care costs had risen 45%. Furthermore, under this regime, some 42 million citizens have lost their medical insurance.

> Also, as another tangential effect of Bushonomics, U.S. individual personal bankruptcy filings have more than doubled under this regime and will, indeed, reach a record 2.5 million in 2005, bringing the total number of personal bankruptcy filings having occurred under the Bush Cheney regime at that time to 10 million.

> Small business bankruptcy filings, which had been averaging 350,000 a year when this regime first came power, will exceed 800,000 in 2005.

And this is what I think is the most startling statistic of all. If one asked me, What is the most startling economic statistic which points to the magnitude of the deterioration of the public finances of this nation that have occurred under the scourge of Bushonomics redux, I would point out that: On the day that the current regime came to power, the United

States was contributing 16% to the planet's total net savings rate; today we are consuming 83% of the planet's total net savings rate, in order to continue to service Bushonian triple deficits—current account, budget and trade-and to otherwise service aggregate U.S. national debt.

That is simply an astounding number: to go from representing a positive 16% of the planet's net savings rate to now representing a minus 83% of it.

How is that possible? What skews the number a little bit is that this regime came in inheriting 4 years of fiscal surpluses, and then promptly, within the first year it was in office, proceeded to deplete the \$158billion fiscal surplus it had inherited from its predecessor. That's what skews those numbers.

We have gone from a position, in the year 1999, of a \$263-billion fiscal budget surplus to now, 6 years later, the year 2005, what will be, on a real basis, a federal budget deficit of \$500 billion plus, on a real basis. This is a ¾-of-a-trillion-dollar budgetary turnaround. It is almost inconceivable.

The consumption in the nation is now falling, as can be seen in the personal income and spending numbers. Another astounding statistic that bespeaks of the economic deterioration that Bushonomics has visited upon the nation is the fact that on the day this regime came to power, the national personal savings rate was 6.9%.

Now it is a negative number -.3% (minus .3%) the first time in the history of the republic that the nation has had a negative net savings rate. This has been primarily due to the enormous buildup in what is called 'consumer non-mortgage installment debt', which, when this regime first took office, was \$863 billion, and, as of now, is \$2.25 trillion.

Consumption, now falling, is likely to continue to fall; in that the nation's real wages, i.e., wages ex of inflation, have fallen in the last 13 months and will most likely continue to fall. Record consumer debt levels combined with falling real wages does not auger well for the maintenance of consumption.

The dangerous loose-money policy of Bushonomics has also created numerous speculative bubbles. Loose-money policy means "accommodative". The Feds' accommodative monetary stance under this regime has helped create numerous speculative bubbles in asset classes, most notably real estate.

We would note that one of the most dangerous statistics we find in real estate is one that is oftentimes overlooked because pro-Bush-net financial media doesn't like to remind the citizens of what they themselves have done; namely, under this regime, there has been a \$500-billion draw-down in equity of residential property via home lines of credit or the placement of additional mortgages. Indeed, it has been this bleed-out in equity, although median national real estate prices, residential real estate prices, have increased 53% under this regime.

Although there is a 53% increase in property prices under this regime, the national median homeowner debt-to-equity ratio has actually fallen by

That gives you an idea of just how much money has been bled out of real estate in order to support consumption, and how dangerous a bubble this actually is, this speculative bubble in real estate. It is much more dangerous than was the speculative bubble in real estate of 1989, wherein, from the 4th quarter of 1989 to the second quarter of 1991, median real estate values in the nation fell 17%.

When this speculative bubble in real estate breaks, the decline will be greater than it was in 1991. And, indeed, no reliable estimates of a potential decline can be made; in that we are now faced with a situation of falling consumption, rising interest rates, rising inflation, a diminished home-equity-to-mortgage value, compounded by record foreclosure rates, wherein now one out of every 16 pieces of privately owned residential property in the nation is either in foreclosure or in the process thereof.

Combined with this is yet another dangerous real estate statistic, as we mentioned, released by the National Association of Realtors recently; namely, that a record 23% of all privately owned property in the United States is now held by speculators.

And that is a record number. For instance, in the real estate bubble of 1989, when the speculative bubble in real estate peaked in the 4th quarter of that year, the percentage of real estate held by speculators was 16%. Now it's 23%, which, in itself, is a dangerous fraction, so much held by speculators that have financed it with zero-down, interest-only mortgages.

These are all dangerous signs. For instance, in the speculative bubble in the 4th quarter of 1989, the average down payment being made by a new homeowner at that time was 7.4% of the value of the

The average down payment being made by a homeowner today is 3.6%. Furthermore, we have a new factor that we didn't have in 1989 in the mortgage business, and that is a whole genre of interest-only mortgages, which, although they were available in 1989, they were really a custom feature. Today they're actually being marketed.

Indeed, 14% of all residential real estate in the United States, purchased within the last 5 years, has been purchased with a long-term interest-only mortgage wherein no principle is being paid down, where, further in, no down payment was made to begin with, and the lender lent more than was the value of the home.

It eventually goes into a balloon payment, but not in 30 years. They are 30-year mortgages with a 7-year balloon.

In other words, by the end of this year, we'll begin to see property being lost to the market because of these balloon mortgages.

Another startling statistic, I thought, of this speculative bubble, released by the NAR, National Association of Realtors, was the percentage of residential property purchased in the last 5 years that has been overfinanced, wherein a mortgage lender wrote a mortgage for more than what the property was worth.

commercials? "We'll lend you 125% of what your home is worth."

It's a scam to increase the size of your mortgage, thus increasing the points and the flow to the lender. This is what it's all about. But, in the last analysis, in terms of a healthier, sound real estate [market], it is not. Because, of all new residential property purchased in the last 5 years, 14.9% of that property (not through market action, but on origination of loans) currently had an average value-to-mortgage ratio of 117%.

These are all the creation of new factors that are comprising what I am now calling—and I'll be the first one to coin this term—a new Real Estate Super Bubble.

You can't just call this another speculative bubble; it's a Super Bubble. After all, with Bushonomics, do not things get super-sized?

Debt numbers that were previously quoted in the billions now quoted in the trillions, with Bushonomics. Just like the President said: Oh, it's just a function of adding more zeros.

Bush actually said this at his ranch in Crawford, Texas, when he was running for reelection that time when he was drunk. He stands up in this makeshift little podium thing. And someone had asked him a question about the enormous buildup of debt in his regime and how what used to be billions is now trillions under these

Bushes. And he looked at the person and he says, "It's just a question of adding more zeros."

Hey, let's kiss it. Keep it simple, stupid, for the American people. They understand the concept: Simply add more zeros.

This is the Bolivianization of the American dollar. Just add more zeros.

...Beside the real estate bubble, we, of course, have another speculative bubble in stock prices and price earnings ratios. For example, the S&P 500 continued to be approximately 26% above long-term averages at a time when interest rates and inflation are both rising, and productivity slowing, with per-unit labor cost, at the same time, rising. This is not the stuff of higher stock market

So where is this leading us? If one puts together the remarks of Comptroller General David Walker, Chief of the GAO, and former Treasury Secretary Paul O'Neill, you can see the either/or option going forward—the U.S. dollar must continue to depreciate, in order for the Bush-Cheney regime to continue to finance U.S. debt.

In other words, the depreciation of the U.S. dollar is a conscious decision by the Bush administration, even though John Snow has consistently said that the regime still maintains a strong dollar policy. Obviously, that is nonsense since the dollar has lost about 35% of its tradeweighted value under this regime. Therefore, to maintain this nonsense of a strong dollar policy, the market isn't bearing that out.

It is also nonsense to maintain this idea, when, in fact, a weaker dollar and dramatically weaker dollar, no less, will be necessary, in order for this regime to continue to service U.S. debt. A cheaper dollar and higher interest rates is the only way the regime can attract the ever-growing amount of foreign capital it needs at a time when it is already consuming 83% of the planet's savings.

And speaking of the falling dollar and shorting the dollar, it was reported in the New York Sun, (March 7, 2005): "Warren Buffet says he hopes his bet against the American dollar fails. Berkshire Hathaway Inc., Warren Buffet, who made \$1.63 billion on foreign currencies in the 4th quarter said he'd prefer if his bet against the American dollar failed. 'Berkshire resources remain heavily concentrated dollar-based assets, and both a strong dollar and a low inflation environment are very much in our interest.""

So here is Warren Buffet talking out of both sides How many times a day do you see the Ditech of his mouth. It should be noted that \$1.63 billion is more money, by the way, than was the operating profits of Berkshire Hathaway in the 4th quarter.

> In other words, the short position he had in the dollar generated more income than did the operating profit of Berkshire Hathaway Corporation. So, obviously, it is disingenuous of him to say that.

> Moving forward, there are two potential scenarios. Under the weight of ever-expanding Bushonian triple deficits and ever-increasing aggregate U.S. national debt combined with falling GDP, the U.S. dollar continues to depreciate.

> For instance, the Treasury, in that infamous March 2001 study that Secretary O'Neill referred to (remember the Bush-Cheney regime attempted to deny it authorized, then was forced to say it did authorize, then attempted to suppress it) had calculated that the U.S. dollar, from where it was trading in March of 2001, no less, would have to lose 80% of its exchange weight-traded value by 2009 in order for the United States to continue to service

> Therefore, based on where we are now, it can be extrapolated that the U.S. dollar still has another 40% to fall over the coming 4 years against the so-called tradeweighted basket, which we could put in as a so-called 'basket' of foreign currencies weighted to the amount of trade that we conduct with those countries.

Remember what O'Neill kept saying, that we would need the dollar to be at a certain point in 2009 that would be 40% less than it is now. Combine this with a 65% marginal personal income tax rate in the nation by 2013.

We would need a combination of those two factors in order to continue to service U.S. debt into, as O'Neill said, the latter part of the second decade of the century.

The other scenario is that the Bush-Cheney regime simply cannot monetize U.S. debt quickly enough; that is, despite what is certainly to be a continually falling dollar, that falling dollar can still not attract enough capital into the U.S. Treasury in order for the regime to continue to service U.S. debt.

I think that is more likely, since we are already consuming 83% of the planet's net savings rate. Also the percentage of debt that we finance internally, it should be pointed out ('we' meaning the American people wearing their hats as investors in U.S. Treasury instruments) has fallen from 32% when this regime came to office, to 24% now. And that is directly related to the depleted national savings rate.

In fact, what I think is more likely is the so-called second scenario that was proffered by Comptroller General Walker in September 2003 when he said that should the Bush-Cheney regime be re-ensconced into power for a second term and, hence, the fiscal deterioration of Bushonomics continue, then by 2009 the United States could no longer service its debt.

This would mean the United States would declare a force majeure on debt service payments, which would be interpreted by the planet's capital marketplaces as a de facto repudiation of debt, because that's what it is, wherein the economy of the United States would collapse. The economy of the rest of the planet would collapse five days later.

The reason why I think that scenario is more likely is because of the little changes that the regime is making now, which I have pointed out before but will do so here again.

For instance, the dusting off the shelf of the Gold Confiscation Act of 1933, the changing in the monetary status of U.S. and other gold bullion coins to make them force redeemable at their stated face value instead of the bullion value, increasing restrictions on citizens who are attempting to move gold out of the United States, increasing restrictions on citizens moving any form of assets out of the United States.

Interestingly enough, these restrictions are particularly concentrated on citizens moving out of the nation less than \$100,000, when, in fact, people expatriating assets or monies or gold above \$1 million has become easier. This has been done to accommodate the capital flight that we are now seeing from the United States from within the ranks of the top 10% of the nation, the so-called high net worth individuals.

...What is interesting is that, for the first time, we are seeing an added phenomenon. Not only is the capital fleeing, but the people themselves are fleeing. In other words, record expatriation of persons within the top 10% income and/or asset bracket.

Approximately 20,000 of said citizens per month are now quietly expatriating from the United States and purchasing property in discreet non-taxable, nonreportable, non-attachable, non-attackable, nonextraditable offshore jurisdictions.

That's an interesting phenomenon, the expatriation. And also a new record that we haven't seen before that's been set under this regime, another interesting statistic, and, I think, very telling.

Record sales of residential real estate worth \$1 million or more by the top 10% of the nation has occurred under this regime. In short, the top 10% are not simply getting money out; they're selling property, they're selling chattels, they're getting everything out.

It should be noted what the Bush Cheney Regime is

using the Patriot Acts as cover to invade American citizens' foreign safe deposit boxes, and now forced declaration of gold bullion when you're trying to take it out of the country.

What the nation is attempting to do is to gradually denude the citizens' rights to own gold. This, combined with an unlawful depletion of some 2900 metric tons of gold from the U.S. national stockpile, and further, the unlawful exhaustion of U.S. silver inventories under this regime in its desperation to raise money, as we've mentioned before, of the U.S. Treasury Emergency Protocol 253, which called for the issuance of an emergency gold-backed dollar for domestic circulation to maintain a medium of exchange in a posteconomically collapsed environment.

What this says is that the Regime knows that the nation's economy is going to collapse. It is attempting to denude citizens of their gold in order to prevent those citizens from having economic power, thereby forcing those citizens to continue to use as a medium of exchange what is going to be an ever-softer dollar, even in a post-economically collapsed environment.

The only way the government can maintain control in a post-economically collapsed environment is through currency and through military might, or internal military power. That's the only way they can maintain control.

If we had too many citizens holding gold, that would empower them. It would suddenly give those citizens political power wherein they would not necessarily need to transact commerce in soft dollars. That would be a direct challenge to governmental authority.

As this Regime continues in its efforts to Bolivianize the U.S. dollar by adding endless zeros to the end of it, it is also going to make sure that citizens are forced to use that Bolivianized dollar in a posteconomically collapsed environment.

And that's what U.S. citizens are left with-Bushonomics, Supersized bubbles and really scary economic numbers. This is like a Reality Show, coming to your doorstep.

#### BUSHONOMICS II (PART 2): THE FINAL CHAPTER By Al Martin, 4/18/05

People ask—what about the future? What are the aggregate consequences of more than 13 years of Bushonomics—with more to come? The short answer is that there are only two possible scenarios moving forward. There only two possible outcomes: One is that U.S. Comptroller General David Walker is correct in the GAO analysis which reports that with the Bushonian regime and its policies of Bushonomics here to stay, the United States will no longer be able to service its debt beginning in the second quarter of 2009.

What does this scenario mean for the nation, to further Walker's comments, to paint a picture? This original GAO report was not widely disseminated, although Walker did make comments about it before the House Banking Committee. Walker, interestingly enough, of all government officials, is usually only covered on CSPAN-3, which, I'm sure, is being done on purpose. Obviously, the Bush Cheney regime does not want mainstream media coverage of a government official that consistently tells the truth about Bushonomics.

Very simply put, this would mean that the United States government would no longer have the ability to service its debt by Q-2 2009, in that, under the would by that time be consuming more than 100% of continues to imperil creditors, in that Bushonomics and against the euro and the yen through interest rate

alluding to is that the planet's economy could no longer generate a sufficient net savings rate to lend to the U.S. Treasury in order to continue to service Bushonian triple deficits—current account, budget, and trade—as well as aggregate U.S. national debt.

Therefore the United States Treasury would have no option but to declare a force majeure on continuing service of U.S. debt. A force majeure is simply an economic term used by governments to declare that they are suspending servicing their debt for circumstances beyond their control. This is odd because, although the United States Treasury has no choice but to declare such a force majeure, it is as if the U.S. Treasury is saying that "we can no longer service something that, indeed, occurred within a regime with purposeful intent."

Therefore, it brings up the larger question: Would other creditor nations—principally China, Japan, Saudi Arabia—potentially go to the World Court (here's an interesting twist) and claim that the U.S. Treasury cannot declare a force majeure?

...The World Court, after all, is not controlled by the United States. It's an interesting legal question....

The reason they would be moving into the World Court would be in order to claim 'debtor in possession', wherein senior creditor nations, which would have a combination of military and economic capability, could unite, go to the World Court, and say to the World Court: "File a 'debtor in possession" claim, saying that the U.S. Treasury does not have the lawful ability to declare a *force majeure*." Then they could make the argument into the World Court that: "We, the leading creditor nation-states, have formed a pact to represent all other U.S. creditors.'

...Obviously, in 1981, when the Reagan Bush regime came to power, they took over the United States, which, at that time, was the world's largest creditor nation-state. The rest of the world were all debtors to the United States at that time. But by 1992, their economic policies had turned the United States into the planet's largest debtor nation.

Fast forward, July 2009 petition to the World Court. "Therefore, World Court, a Bushonian regime and Bushonomics must not be allowed to continue to persist in the United States." Otherwise the creditors would never be paid. Therefore the World Court could grant the petition by a group of senior creditors for them to effectively take economic administrative management control of the United States in order to preserve the position of creditors, since the continuing practice of Bushonomics, post-2009, would only lead to still further economic deterioration of the United States.

Is this too far-fetched? No, not at all, because the United States would be continuing to imperil evermore U.S. creditors from that date forward.

The United States is a power in decline. The IMF has stated so. Russia and China are the rising power. The United States still controls or has great influence over international institutions like the World Bank. But you would note that the institutions that they control are institutions that are loaded with debt.

...What would happen, and I think it's a real possibility is that the Chinese, Japanese and Saudi governments would go to all other U.S. creditor nations and say, "Look. Appoint us as your representatives, the three of us as your representatives. We will get Russia to back us." Russia comes in and backs the the whole conspiracy that has been Bushonomics from the beginning, it's exposed: that it was a massive scheme to defraud the American people to continuously transfer wealth and power into the hands continuing scourge of Bushonomics, the United States of the higher, tighter and righter; and that this

doing with its policies on gold, with its currency policies, the planet's net savings rate. Hence, what Walker is Bushonian regimes conspire to create this fraud to benefit a cabal which they control.

"Thus, we, the creditors, cannot allow such a cabal to remain in the United States. We must therefore take economic administration of the United States"—here's the double argument—"not only to preserve creditors' positions, but to preserve the United States as a continuing viable economic entity."

...Then the only way this could end would be military confrontation. Why do you think the Bush Cheney regime keeps talking about the construction of an American military empire in the 21st century?

... The ongoing construction of the new American military empire is like a global test move to preclude this possibility of being exposed! It has nothing to do with securing commoditized resources for the future; it is to prevent the Bushonian Cabal from being exposed.

...I would maintain the Patriot Acts have nothing to do with politics or security. They are neither political nor security measures. They are, in the last analysis, economic measures to allow the regime the lawful authority it would need to continue the process of converting the United States from a democracy into a dictatorship.

This would be a dictatorship that will be necessary to control the nation in an economically collapsed environment, or in a military confrontation, which may be necessary for the cabal to remain in power.

The second alternative is what Paul O'Neill was referring to—that the U.S. dollar continues to fall over the next 3 to 4 years, continues to lose value against the exchange-weighted basket of currencies, that the U.S. dollar continues to fall against that basket sufficiently to allow the United States to continuously monetize debt.

'Monetization of debt' sounds like a big word. It literally means nothing more than the continuous issuance of debt and the ability to service that debt in the future in ever-cheaper dollars. Otherwise this could be called "Bolivianization", to use the IMF term. In order to accomplish this, what O'Neill said, and this was recently not when he was still Treasury Secretary. (You notice he's been on the stump recently.)

What O'Neill said, pointing to the March 2001 Treasury study that the U.S. dollar, which has fallen against the trade-weighted basket of currencies approximately 40%, since the Bush Cheney regime first came to power—the U.S. dollar, from where it is now, would need to lose a further 40% of its exchange-weighted trade value by 2009 in order for the United States to successfully monetize its debt and thus keep the USA Incorporated in business as a viable entity.

... That's what's happening to the U.S. dollar, despite John Snow's constant strong dollar comments, which no one believes anymore because the U.S. dollar must continue to fall in order for this regime to continuously monetize debt. Therefore it must act to cheapen the dollar.

And it is a risk to try to create inflation for the purposes of debasing one's own currency in order to monetize that currency so a fiscally reckless policy can continue. This is exactly what this regime is attempting to do when the rest of the planet is experiencing deflation.

The measures that the regime would have to undertake to create inflation domestically, which is being suppressed by a global debt deflation, would be such that they would have to literally start printing money like no tomorrow.

How soon? Very soon. Why do you think the Fed has raised money supply so much, particularly the M-3 money supply?

..[An] unholy alliance has been created, wherein the Fed is now forced to support the continuing practice of Bushonomics, like it or not, in order to create the requisite amount of inflation and the requisite decline in the U.S. dollar necessary to allow them, the Fed, to monetize U.S. debt, a condition which the Fed did not create, but a condition that Bushonomics is creating for them.

So what is the final chapter of Bushonomics II? The final chapter would be, in this Plan B: the successful monetization of debt would allow the United States to remain as a viable economic entity, to remain in business, as it were, to allow the regime to continue. It would depend, ultimately, on how much inflation can be created relative to the rest of the planet.

The 'final chapter' means that it could not be sustained, that even through debt monetization and sharply increased domestic tax rates, the United States by 2013, as Paul O'Neill pointed out in that Treasury report, would create a hyper inflationary scenario that the Fed would no longer have the ability to control.

...So what the Treasury said in that study was that debt monetization could keep the United States in business until 2017. After that, the United States would collapse.

The reason why they use that date is because that is the date when the bulk of the baby-boom generation will begin to draw Social Security benefits. What the U.S. Treasury envisions is that the demand for money against the U.S. Treasury would tip the balance that.' wherein monetization would no longer work.

...The Russians and the Chinese have not acted to dramatically increase their own military spending, despite the fact they could afford to do so.

#### AMERICA'S LIKUD: THE NEO-CONSERVATIVES

What remains the guiding force behind the "neo-conservative" philosophy that sponsors this dream of American imperialism is perhaps the most "controversial" topic in America today—the role of hard-line Israeli Likud-style Zionism in shaping the policies of the "neo-conservatives" who direct policy in the Bush administration.

To recognize that the neo-conservative policy makers operating the engine of power in Washington are indeed largely Jewish and, in addition, wedded to "right wing" Zionism, is crucial to understanding the course of world affairs today.

Author Michael Lind, a harsh critic of neoconservative principles, sums up the "three pillars" of the globalist doctrine being pursued:

"American unilateralism, pre-emptive war, and the alignment of American foreign policy with that of Israel's right-wing leader Ariel Sharon. Each of these elements of George W. Bush's grand strategy represented a dramatic break with previous American foreign policy."

Notably, one American Jewish writer summed up the Zionist dreams guiding the Bush policy, particularly *visà-vis* Iraq, for *Time* magazine, a publication that is controlled by Jewish financial interests revolving around the powerful family of Edgar Bronfman, longtime head of the World Jewish Congress. In an essay entitled "How Israel is Wrapped Up in Iraq", *Time* columnist Joe Klein wrote with candor:

A stronger Israel is very much embedded in the rationale for war with Iraq. It is a part of the argument that dare not speak its name, a fantasy quietly cherished by the neo-conservative faction in the Bush Administration and by many leaders of the American Jewish community.

The fantasy involves a domino theory. The destruction of Saddam's Iraq will not only remove an enemy of long-standing but will also change the basic power equation in the region. It will send a message to Syria and Iran about the perils of support for Islamic terrorists.

It will send a message to the Palestinians too: Democratize and make peace on Israeli terms, or forget about a state of your own. In the wackiest scenario, it will lead to the collapse of the wobbly Hashemite monarchy in Jordan and the establishment of a Palestinian state on that nation's East Bank. No one in the government ever actually says these things publicly (although some American Jewish leaders do). Usually, the dream is expressed in the mildest possible terms: "I have high hopes that the removal of Saddam will strengthen our democratic allies in the region," Senator Joe Lieberman told me last week.

That the war against Iraq, and the overall policy guiding it, is founded in the philosophy of the hard-right Likud elements in Israel and their neo-conservative allies in America at the levers of power in the Bush administration is now becoming an open topic of discussion.

At the same time, the neo-conservative warmongers began driving a wedge between the United States and its European allies.

#### NEO-CONSERVATIVES ASSAULT EUROPEAN CRITICS

The leading voices of the pro-Israel "neo-conservative" movement in the United States began waging (and continue to wage) a relentless and unabashed campaign promoting "anti-Europeanism" among Americans. Few Americans, however, probably understood the geopolitical forces behind this campaign.

This "anti-Europeanism" came at precisely the time when European governments and massive numbers of European citizens were loudly rejecting the demand by the U.S.-Israel-Britain axis for war against Iraq and raising questions about Israel's brutal policies toward the Palestinians. This caused great dismay for the neoconservatives.

The anti-European campaign by the neoconservatives reached such a fever pitch that even the February 13, 2003 issue of *The New York Review of Books*, a leading "liberal" organ known for its sympathies for Israel, published a detailed article outlining the neoconservative attack on Israel's European critics.

In an article entitled "Anti-Europeanism in America", author Timothy Garton Ash assembled a growing list of neo-conservative writers who have aimed their guns at Europe. Leading the list was Richard Perle who claimed that Europe has lost its "moral compass".

In case anyone might fail to understand the reason why the neo-conservatives have this newfound antipathy toward Europe, Ash's article explained the bottom line: that "The Middle East is both a source and a catalyst of what threatens to become a downward spiral of burgeoning European anti-Americanism and nascent American anti-Europeanism, each reinforcing the other."

In other words, quite simply: Israel and its powerful American lobby are at the center—really, the cause—of the conflict, although Ash doesn't quite put it that way.

Anti-Semitism in Europe and its alleged connection to European criticism of the Sharon government, has been the subject of the most acid anti-European commentaries from conservative American columnists and politicians.

Some of these critics are themselves not just strongly pro-Israel but also "natural Likudites", one liberal Jewish commentator explained ...

In a recent article Stanley Hoffman writes that

they seem to believe in an "identity of interests between the Jewish state and the United States".

Almost as if on cue, one of Richard Perle's and William Kristol's collaborators in the new "anti-Europeanist" drive, Robert Kagan, vocally joined the harsh chorus to promote anti-Europeanism to the reading audience of *The Washington Post*, the influential daily published in the nation's capital. Kagan's Jan. 31, 2003 opinion column was a veritable textbook of the neoconservative "Hate Europe" crusade. Kagan wrote:

In London ... one finds Britain's finest minds propounding, in sophisticated language and melodious Oxford accents, the conspiracy theories ... concerning the "neo-conservative" (read: Jewish) hijacking of American foreign policy ... In Paris, all the talk is of oil and "imperialism" (and Jews). In Madrid, it's oil, imperialism, past American support for Franco (and Jews).

At a conference I recently attended in Barcelona, an esteemed Spanish intellectual asked why, if the United States wants to topple vicious dictatorships that manufacture weapons of mass destruction, it is not also invading Israel.

Yes, I know, there are Americans who ask such questions, too ... But here's what Americans need to understand: In Europe, this paranoid, conspiratorial anti-Americanism is not a far-left or far-right phenomenon. It's the mainstream view.

So it was that America's traditional European allies had now allied against the United States and the neoconservative policy dictators who were spearheading a drive for a new imperialism. It was a formula that many American critics of the neo-conservatives believed would ultimately spell disaster, for not only America but the world.

#### THE ALLIANCE BETWEEN BUSH AND SHARON

So although traditional American policy has been thrown out the door—to the dismay of many articulate critics of the neo-conservative philosophy—there is yet another factor regarding the foundation of the neo-conservative point of view that must be considered: the resulting impact on the specific aspect of the U.S. "special relationship" with Israel.

Although American governments—ruled by both Democrats and Republicans alike—have always been heavily partial to Israel, no secret to anyone, the fact is that the ascendance of the neo-conservatives in the Bush administration has led to a virtual merger of U.S. foreign policy with the point of view of the hard-line "right wing" Likud bloc of Ariel Sharon and Israel.

Writing in *The Washington Post* on February 9, 2003, Robert G. Kaiser laid out the parameters of the Bush administration's unswerving alliance with the "right wing" of Israel. Kaiser's article, titled "Bush and Sharon Nearly Identical on Mideast Policy", was a forthright assertion of the power of the "neo-conservatives" in directing the administration's approach to Israel and the Arab world. The article said, in part:

For the first time, a U.S. administration and a Likud government in Israel are pursuing nearly identical policies. Earlier U.S. administrations, from Jimmy Carter's through Bill Clinton's, held Likud and Sharon at arm's length, distancing the United States from Likud's traditionally tough approach to the Palestinians. But today ... Israel and the United States share a common view on terrorism, peace with the Palestinians, war with Iraq and more.

The Bush administration's alignment with Sharon delights many of its strongest supporters, especially

evangelical Christians, and a large part of organized American Jewry, according to leaders in both groups, who argue that Palestinian terrorism pushed Bush to his new stance.

"The Likudniks are really in charge now," said a senior government official, using a Yiddish term for supporters of Sharon's political party.

Some Middle East hands who disagree with these supporters of Israel refer to them as "a cabal", in the words of one former official. Members of the group do not hide their friendships and connections, or their loyalty to strong positions in support of Israel

Richard Perle, chairman of the Pentagon's Defense Policy Board, led a study group that proposed to Binyamin Netanyahu, a Likud prime minister of Israel from 1996 to 1999, that he abandon the Oslo peace accords negotiated in 1993 and reject the basis for them—the idea of trading "land for peace". Israel should insist on Arab recognition of its claim to the biblical land of Israel, the 1996 report suggested, and should "focus on removing Saddam Hussein from power in Iraq".

Besides Perle, the study group included David Wurmser, now a special assistant to Undersecretary of State John R. Bolton, and Douglas J. Feith, now undersecretary of defense for policy. Feith has written prolifically on Israeli-Arab issues for years, arguing that Israel has as legitimate a claim to the West Bank territories seized after the Six Day War as it has to the land that was part of the U.N.mandated Israel created in 1948.

An internal debate split the administration and invited the lobbying of think tanks, Jewish organizations, evangelical Christians and others who take a fierce interest in the Middle East ...

Over the past dozen years or more, supporters of Sharon's Likud Party have moved into leadership roles in most of the American Jewish organizations that provide financial and political support for Israel.

Writing shortly thereafter in The Washington Times—the neo-conservative oriented daily "rival" to the more "liberal" Washington Post-well-known journalist Arnaud deBorchgrave echoed Kaiser and elaborated on the topic of the new alliance between the Bush and Sharon regimes. In an article entitled "A Bush-Sharon Doctrine", deBorchgrave wrote, in part:

The strategic objectives of the U.S. and Israel in the Middle East have gradually merged into a now cohesive Bush-Sharon Doctrine. But this gets lost in the deafening cacophony of talking heads playing armchair generals in the coming war to change regimes in Baghdad.

Mr. Sharon provided the geopolitical ammo by convincing Mr. Bush that the war on Palestinian terrorism was identical to the global war on terror. Next came a campaign to convince U.S. public opinion that Saddam Hussein and Osama bin Laden were allies in their war against America. An alleged secret meeting in Prague in April 2001 between Mohamed Atta—the lead suicide bomber on September 11—and an Iraqi intelligence agent got the ball rolling. Since then stories about the Saddam-al Qaeda nexus have become a cottage industry.

Bin Laden clearly hopes to use a U.S. invasion of a Muslim country to recruit thousands more to his cause. But the Saddam-bin Laden nexus was barely Step One in the Bush-Sharon Doctrine. The strategic objective is the antithesis of Middle Eastern stability.

The destabilization of "despotic regimes" comes next. In the Arab bowling alley, one ball aimed at Saddam is designed to achieve a 10-strike that would

discombobulate authoritarian and/or despotic regimes in Iran, Syria, Saudi Arabia and the other Gulf Emirates and sheikhdoms.

The roots of the overall strategy can be traced to a paper published in 1996 by the Institute for Advanced Strategic and Political Studies, an Israeli think tank. The document was titled "A Clean Break: A New Strategy for Securing the Realm" and was designed as a political blueprint for the incoming government of Benjamin Netanyahu, a superhawk in the Israeli political aviary.

Israel, according to the 1996 paper, would "shape its strategic environment", beginning with the removal of Saddam Hussein and the restoration of the Hashemite monarchy in Baghdad. The Iraqi monarchy was overthrown in a military coup in 1958 when young King Faisal, a cousin of Jordan's late King Hussein, was assassinated.

The strategic roadmap—which has been followed faithfully thus far by both Mr. Netanyahu and his successor Mr. Sharon—called for the abandonment of the Oslo accords "under which Israel has no obligations if the PLO does not fulfill its obligations". Yasser Arafat blundered by obliging

"Our claim to the land [of the West Bank]-to which we have clung for 2,000 years—is legitimate and noble," the paper continued. "Only the unconditional acceptance by Arabs of our rights, especially in their territorial dimension, is a solid basis for the future."

And what is notable is that Israel's "strategic roadmap" referred to by deBorchgrave (and also referenced by Kaiser) was not just the product of an Israeli institution alone. The authors, as pointed out by Kaiser, were Americans—namely Richard Perle, Douglas Feith, John R. Bolton, and David Wurmser, all key "neo-conservative" policy makers guiding the Bush administration.

#### OPINION IN ISRAEL . . .

While all of this may have been a "revelation" to readers of The Washington Post and The Washington *Times*—which generally vary only by degree in pandering to the policy demands of the Israeli lobby in Washington, it was no surprise to the people of Israel.

Israeli press that noted comments by Israeli leaders demonstrates that the motivations of the "neoconservative" policy makers were indeed part of a grand design very much in sync with Israel's fanatic Likud bloc:

... "In the [occupied] territories, the Arab world, and in Israel, Bush's support for Sharon is being credited to the pro-Israel lobby, meaning Jewish money and the 'Christian' right."-Israeli writer Akiva Eldar, Ha'aretz, April 26, 2002

"Sharon is finding it hard to show any achievements during his 20 months in power ... an American attack on Iraq is seen as the lever which can extricate Israel from its economic, security and social quagmire ...."—Israeli correspondent Aluf Benn, Ha'aretz, November 18, 2002

Despite all this, the one independent American newspaper that has consistently dared to criticize the "neo-conservatives" and the Israeli lobby for Israel and to focus on their activities—American Free Press—was perhaps less circumspect than the "big name" elite publications such as The Washington Post and The Washington Times in summarizing the new alliance of the Bush administration with the Sharon regime.

#### **BUSH POLICY—"GREATER ISRAEL"**

MAY 11, 2005

Long before the major Washington dailies enunciated the Bush-Sharon alliance, American Free Press stated flatly that the Bush policies were part of a plan to establish the Zionist dream of a "Greater Israel". According to the report from American Free Press:

In league with the fanatic force of militant imperial Zionism, Big Oil was planning an all-out offensive to grab control of the oil riches of the entire Middle East. The international Anglo-American oil companies dream of shedding their partners in the oil rich Arab dynasties that control the oil fields. The oil barons want the oil all to themselves. At the same time, Zionist fanaticsboth Christian and Jewish—dream of dismantling the Arab states and expanding Israel's borders to a "Greater Israel" reaching "From the Nile to the Euphrates".

With such a convergence of interests—based on a deadly mixture of ideology, profits and geopolitical power—Zionism and Big Oil had found common ground. As such, they were now moving to establish a Middle East hegemon over the oil riches of the Arab world. The campaign against Iraq was simply the opening gun.

The fact that the other Arab states of the Middle East had firmly declared their opposition to the proposed U.S. assault on Iraq set these states up as other enemies to be dispatched. The age-old Zionist aspiration for a "Greater Israel" is now no more than a cover for the oil conglomerates to seize absolute control of Arab oil, once and for all. The first step was eliminating Saddam

Iraq is just the first domino slated to fall. The other Arab states are next in line. Knocking out the ruling Arab regimes will satisfy the demands of Israel's hardliners, but also set the stage for the oil conglomerates to control Middle East oil.

It is no accident that the administration of George W. Bush should be the engine to achieve this goal. The scion of a family long a part of the intrigues of the Anglo-American oil elite, Bush—like his father—has been both allied with Israel and, when the circumstances required, standing in opposition to the Zionist state.

American Free Press pointed out that in the book Friends In Deed: Inside the U.S.-Israel Alliance, Just two (of many) representative reports in the Israeli-based writers Dan Raviv and Yossi Melman wrote frankly of Israel's hostility to the senior Bush during his one term in office—a point of which few Americans are aware, even including many stalwart Republican admirers of the Bush family.

As such, the Israelis have little trust for the family Bush. However, a Bush is in the White House in control of America's military arsenal. Israel recognizes American military power is the only thing that can assure Israel's survival in a world increasingly hostile to Israel's aims. Thus, Bush and his allies in Big Oil find an alliance with Israel a necessity. Zionist influence in American affairs—particularly in the realm of media control—has reached a zenith. In addition, the pro-Israel "Christian Right"—dominated by the likes of Jerry Falwell, Pat Robertson, Tim LaHaye, etc-is extremely influential in Republican Party ranks, positioning Bush's GOP base firmly in Israel's camp. At the same time, ironically, Israel's position has never been so precarious. However—fortuitously, for Israel—the events of Sept. 11 brought the uneasy alliance between political Zionism and the plutocratic Big Oil forces full circle. As former CIA analyst George Friedman-a supporter of Israel-put it early on Sept. 11 on his widely cited website, www.stratfor.com, just hours after the tragic attacks: "The big winner today, intended or not, is the state of

geopolitical consortium in which U.S. military might can be used to "tame" the Arabs and grab control of their oil. In so doing Bush has the full propaganda might of the Zionist-dominated media behind him.

Open Secrets by the late Israeli scholar and critic of Zionism, Israel Shahak, frankly exposes Israel's foreign policy as a menace to world peace. Shahak contends it is a myth that there is any real difference between the supposedly "conflicting" policies of Israel's "opposing" Likud and Labor blocs, both of which advocate expansion aiming toward consolidating "Eretz Israel"—an imperial state in control of practically the entire Middle East. Israel, he asserts, is a militarist state: its policies are dictated by fundamentalist religious fanatics who now dominate Israel's military and intelligence elite.

If American forces destroy Saddam and occupy Iraq, American Free Press predicted, Israel would be a key partner in the consortium, by virtue of Israel's influence in Washington and over the media. Occupation of Iraq—even installation of a puppet regime—would be effective expansion of Israel's borders, fulfilling a considerable portion of the dream of "Greater Israel". But at what cost to the American people?

#### 'CREATIVE DESTRUCTION' OF THE ARAB WORLD

Lest anyone chalk up these comments to "Arab paranoia" or "anti-Israel bigotry", note that one of Israel's most consequential advocates in official Washington—veteran pro-Israel intelligence community bureaucrat Michael Ledeen, a longtime close friend and associate of Richard Perle—has put out a propaganda screed titled The War Against the Terror Masters in which he writes of what he calls "creative destruction".

Ledeen says that this "creative destruction" is "entirely in keeping with American character and the American tradition"—an assertion that will surprise many Americans. Ledeen says that Iraq, Syria, Saudi Arabia and—for good measure—the non-Arabic Islamic Republic of Iran—should all be targets of "creative destruction" by U.S. military might.

"Creative destruction," writes Ledeen, is "our middle name,"—the term "our" referring to Americans, whether or not they share his imperialist views. According to Ledeen:

We tear down the old order every day, from business to science, literature, art, architecture, and cinema to politics and the law.

Our enemies have always hated this whirlwind of energy and creativity, which menaces their traditions (whatever they may be) and shames them for their inability to keep pace. Seeing America undo traditional societies, they fear us, for they do not wish to be undone.

They cannot feel secure so long as we are there, for our very existence—our existence, not our policies—threatens their legitimacy. They must attack us in order to survive, just as we must destroy them to advance our historic mission.

While his rhetoric is stilted and ponderous, what Ledeen is promoting is the idea that it is not U.S. support for Israel that engenders Arab hatred for the United States. Instead, he claims, it is the very existence of the United States-the "American way of life"—that inflames Arab passions. (What utter lies! What nonsense!)

Yet, these words are the propaganda line of the Israeli lobby which hopes to distract the attention of

Junior Bush has driven American military forces the American people away from the causes of Arab to suggest that anyone who stands in opposition to allout war against the Arab world needs to be removed from positions of authority. He writes:

> The president has to rid himself of those officials who failed to lead their agencies effectively, along with those who lack the political will to wage war against the terror masters.

> The top people in the intelligence community need to be replaced, and those military leaders who tell the president that it can't be done, or they just aren't ready, or we need to do something else first, should be replaced as well, along with the people in the national security community who insisted that we must solve the Arab-Israeli question before the war can resume and the top people in agencies like the FAA, the INS, and so

In fact, aside from other political considerations, President George W. Bush had good personal reason to do the bidding of the hard-line hawks in promoting their imperial schemes on behalf of Israel.

former member of Congress, Pete McCloskey (R-Calif.), McCloskey conveyed a warning to the U.S. Secret Service. In his 1994 book, The Other Side of Deception, Ostrovsky revealed the specifics of what assassinate Bush during an international conference in Madrid.

The Mossad had captured three Palestinian "extremists" and leaked word to the Spanish police that the terrorists were on their way to Madrid. The plan was to kill Bush, release the "assassins" in the midst of the confusion—and kill the Palestinians on the spot. The crime would be blamed on the Palestinians—another Mossad "false flag".

So it is that the George W. Bush administration is now fostering and nurturing the ancient dream of a Greater Israel. But to achieve that aim, the neoconservative Zionist elements that achieved power in the Bush administration began laying the groundwork many years before. An initial step in that scheme was the enunciation of a theory known as "rogue states rollback".

#### "ROGUE STATES ROLLBACK" PART OF THE PLAN

A close study of the war-mongering policies of the neo-conservatives would not be complete without an examination of the policy of "rogue state rollback"a plan, originating at the highest levels of the Zionist lobby in America—that has now seen the first drive toward its fulfillment.

"Rogue states" is an inflammatory term that has been used by Israel and its lobby in America—as well as by those who tout the imperialist propaganda line to describe such largely Islamic countries as Iran, Iraq, Libya, Syria, Sudan, Afghanistan, and other countries that are perceived as threats to Israel. However, in light of current claims that the moderate oil-rich regime in Saudi Arabia is somehow "supporting terrorism", it can only be concluded that the neo-conservative warmongers likewise consider the Saudi kingdom a saw the possibility of better relations with Iran. "rogue" state as well.

The war against "rogue states" is all part of the into the heart of the Arab world, to establish a hostility to the United States stemming from effort to set in place a "new world order" in which no unswerving U.S. support for Israel. Ledeen goes on nation can retain its national sovereignty in the face of American military might held in the hands of a warlike "Israel-centric" combine of influence at the highest levels of the American government and supported by the major media.

> A leading advocate of "rogue states rollback" is Sen. John McCain who, during his bid for the 2000 Republican presidential nomination, declared that as president, he would launch an all-out effort to destroy the "rogue" states.

What McCain didn't tell people was that "his" policy was, in fact, part of a long-range plan by higherups in the international policy-making elite, specifically the hard-line supporters of Israel.

This plan for "rogue states rollback"—then specifically targeting Iraq and Iran—was first enunciated on May 22, 1993 in a then-secret speech by a former Israeli government propagandist, Martin Indyk before the Washington Institute on Near East Affairs, a private, pro-Israel pressure group. At the time, the small, maverick American newspaper, The Spotlight, was the only publication to reveal this plan for aggression.

What made Indyk's strategic plan for war so explosive was that when Indyk outlined the policy, he was serving as President Clinton's hand-picked Middle East policy "expert" on the National Security Council.

Born in England and raised in Australia, Indyk took up residence in Israel but was later given "instant" U.S. citizenship by special proclamation of President Clinton just hours after Clinton was sworn After Ostrovsky provided the details to another into office on Jan. 20, 1993—one of Clinton's first official acts. (Later this former Israeli propagandist was appointed to serve as U.S. ambassador to Israel, his obvious conflict of interest notwithstanding.)

Within a year, the thrust of Indyk's plan for war he had learned of the plot: the Mossad planned to against Iraq and Iran was formally promoted by the powerful New York-based Council on Foreign Relations. It was also publicly announced, at the same time, as an official policy of the Clinton administration (although it had been in the making for over a year).

#### GERMANY PRESSURES U.S. OVER NUKE REMOVAL Deutsche Welle, 5/2/05

Germany is using a meeting to review the effectiveness of the nuclear Non-Proliferation Treaty on Monday to urge the United States to remove its nuclear missiles from German soil.

Germany will take the opportunity of a meeting in New York on Monday on the nuclear Non-Proliferation Treaty (NPT) to officially increase pressure on the United States to remove its Cold War-era nuclear weapons from German soil.

The meeting of some 190 nations, convened to address how seriously the world's fight against the spread of atomic weapons has been imperiled since the NPT went into effect in 1970, will give Germany the chance to directly air its concerns over the 150 or so land-based U.S. nuclear weapons still deployed on German soil.

"The nuclear weapons still housed in Germany are a relic from the Cold War," said leader of the Green Party Claudia Roth in Monday's Berliner Zeitung newspaper. "There is no need for them to be there. They should be removed and destroyed.'

Roth was not alone in calling for the missiles to go. Social Democrat Gert Weisskirchen from the German foreign ministry and Liberal Democrat leader Guido Westerwelle echoed the call for the missiles, mostly based at the Rammstein and Büchel air bases, to be removed. The removal of the missiles would "add credibility and strengthen negotiations with other countries," Westerwelle said....

# What They Don't Say Can Really Help You

**Budget's "Tip of the Week" #5:** 

#### **Key provisions NOT included in Nevada's corporate statutes**

In the first four installments of "Tip of the Week" we took a close look at several very interesting provisions of Nevada's corporate statutes. Sometimes, however, what is NOT mentioned in the statutes is just as important.

In Nevada, as many readers may be aware, there is no statute mandating the **issuance of stock**. (Nevada is not unique in this regard; several other states' corporate statutes similarly ignore this key issue. What makes Nevada unique is the combination of statutory provisions, non-addressed key issues and actual practices, all of which add up to make Nevada the ONLY state that allows for privacy of ownership and control of a corporation.)

As if to underscore the non-necessity of stock issuance, there is no requirement to hold an **annual meeting of stockholders**. Yes, there are many references to the stockholders' meeting but nowhere is it stated that any such meeting must be held.

Similarly, Nevada is one of a few states that does not nullify the use of "bearer" shares. It is not that there is a statutory provision endorsing the use of bearer shares or even addressing the issue; it is that the issue goes entirely unmentioned, whereas in most other states the use of bearer shares is statutorily denied.

A major, major issue that is not addressed anywhere in the *Nevada Revised Statutes* is that of **nominee officers and directors**. The use of nominee officers and directors has been common in practice in Nevada for more than 75 years and yet this issue, which is the key to privacy of control of a Nevada corporation, is simply not mentioned. Doesn't that make you wonder why not?

Other states (Wyoming comes to mind) have directly addressed the issue of **nominee stockholders**. In Nevada, however, there seems to be more power granted by not restricting the use of this technique even by defining it.

Nevada only requires a corporation's primary officers to be listed annually but does not abridge the key roles that can be afforded to **secondary officers**, such as a vice president, who may exercise all of the powers of the president in the president's absence; an assistant treasurer, who may be empowered to sign checks and otherwise fulfill the role of treasurer; or an assistant secretary, who may perform all of the duties of the secretary. When nominee service is used, the primary officers are assuredly absent, empowering these secondary officers, who are never listed in the public records with the Secretary of State.

Finally, since only an annual list of officers needs to be filed, a corporation may change its officers and directors at any time through a proper resolution (a PROTECTED "internal" record of the corporation) without notifying the state to modify the public record.

This listing is, of course, by no means all-inclusive. We trust, however, that it provides the reader with a lot of serious "food for thought" as to possibilities for private control and ownership of Nevada corporations.
