### PIMENTEL TELLS ARROYO: RESIGN

Senate Minority Leader Aquilino "Nene" Pimentel Jr. yesterday sounded a call for President Gloria Macapagal-Arroyo's resignation, saying she should step down for the sake of the nation.

Pimentel said that because "they were both President Noli de Castro should resign along with Ms Arroyo, after which Senate President Franklin Drilon should serve as "acting President".

Drilon will then be "duty-bound" to call for the election of a new president and vice president, he said, adding:

"The country cannot go leaderless even for a week, much less for the next five years."

Malacañang rejected Pimentel's call as wishful thinking, saying the President would not resign.

Pimentel issued the call in the middle of the Senate inquiry into the "jueteng" scandal, in which witness Sandra Cam claimed to have personally handed payoffs to the President's son, Pampanga Representative Juan Miguel "Mikey" Arroyo, and brother-in-law, Negros Occidental Representative Ignacio "Iggy" Arroyo.

He said the President had "no credibility left in her whole body from head to toe" in view of testimony linking the First Family, including her husband, to jueteng, as well as an audio tape suggesting that Ms Arroyo had rigged the results of the 2004 presidential election.

"The *jueteng* scandal has reached the ramparts of Malacañang. While there is no direct evidence as yet linking her to jueteng, the web of evidence is fast closing in on her," Pimentel said in a statement.

He said the "smoking gun" on the alleged poll fraud had "demolished whatever claims to legality she had to a new electoral mandate".

He added that resignation was the only "honorable course of action" left for Ms Arroyo and De Castro "to clear the way for the holding of new elections".

But Ms Arroyo put up a brave face.

"I will not allow those who are out to topple [me to] succeed in bringing down my government, and I will not allow them to weaken my ability to govern," she calmly said over radio station dzRH.

She said there was no reason for her to doubt the loyalty of the military and police to the *Constitution*, and added: "I expect our citizens to maintain their cool heads to keep the democracy that they have fought hard to protect.'

She appealed to the people "not to allow themselves to be used by those who want to return to power after they have been ousted, or who want to seize power and run the government through undemocratic means".

De Castro said he would not resign because he had a mandate from the people.

Why hold a snap election when there is no vacancy? I will not resign and have no intention to resign," he told the Inquirer.

He also said he did not believe that the President should resign because there was no concrete evidence linking her to any misconduct or controversy.

### 72 hours

Malacañang was rife with rumors that the government was bracing for a critical 72-hour period beginning yesterday and culminating with Saturday's "national day of mourning" rally by religious and militant groups.

A Palace insider said intelligence officials had gotten wind of a takeover plot on Saturday.

The source said the administration had taken precautionary measures to avert the supposed plot, including doing the rounds of military camps for discreet loyalty checks and select media outlets to emphasize how critical the 72-hour period was to the survival of the government.

Allies of the administration scrambled to make light of Pimentel's call for Ms Arroyo's resignation.

"It is expected of the opposition to claim that the President has lost her credibility," Drilon said in a phone interview. "It's an opinion that is not shared by the critical mass of the people. The President has continued credibility to govern this country."

Drilon also said that Pimentel's call was "expected in a politically charged situation" and that "the jueteng inquiry] is beside the point."

Warning that "the next few days [were] difficult Jose de Venecia called for a "united front" of Malacañang allies in the Senate and the House to 'strengthen constitutional democracy".

He said all political parties, especially in the House, should issue "a ringing condemnation of any attempt to bring about the fall of the government and put an end to constitutional democracy in the country".

Senator Miriam Defensor-Santiago said Ms Arroyo could not be held liable for the *jueteng* scandal and could not be "punished for the crimes of others".

"Assuming, *arguendo*, that the President's family is on the take, this does not necessarily impact [on evidence that she had knowledge and consent, her family's wrongdoing cannot be attributed to her," Santiago said in a statement.

Going forth without all the data you can get—even if you have to go research a bit—is equally as absurd a standard for basing

To assume these particular topics to be non applicable and boring, to you CONTACT readers, is a GROSS ERROR IN JUDGMENT.

Scientists and philosophers over the years have

truth of what they know. Not all of these tests though are by themselves sufficient in distinguishing truth from falsehood, and sufficiency is not always a guarantee for the tests of truth that enjoy wide acceptance despite the relative inadequacies of some. However, knowing the relative value of each test will help us make a choice as to what test we will trust and employ in judging the truth or falsity of our beliefs especially in these days when disinformation, black propaganda, and falsehood have become pervasive in the country's political scene.

[H: Be careful for this is written in and presented for the Philippines. It is, however, applicable EVERYWHERE so please do not be put off by the fact that it comes from the Philippines and not Harvard School of Law or Medicine.]

There are 12 tests of truth widely used by scientists and philosophers. These are sense perception, feeling, instinct, intuition, customs, traditions, majority decision, authority, correspondence, pragmatism, consistency, and coherence.

### SENSE PERCEPTION:

There are realists who wish to simplify how to know the truth. To them, truth is precisely what their senses sight, smell, sound, taste and touch—depict them to be.

For example, the water is hot to your touch; the ball is round as you see it; sugar is sweet to your taste; and the sound of music is pleasant to your ears. All these you experienced through your senses.

Doubling the evidence of your senses is to make a fool of yourself and to make yourself appear strange to other people who might even question your sanity. This is so because sensations are facts of experience; they are a "stable factor in life, independent of your will or whim and gives you contact with outside reality".

Without sensations there can be no experience and without experience there can be no thinking, for thinking has to start with what is given by your senses to your consciousness.

But can we really trust our senses? The answer is yes and no. As was already pointed out, our senses at times failed to give us the true meaning of things and that there are realities that are beyond our sense perception. Ideals and values, for example, cannot be tested by sensations. In short, our sense perceptions are not a good test of truth.

### **FEELING:**

Many of us would rather follow the dictates of our feeling than listen to our rationalizing mind. Instead of being guided by logical connections or by cause-and-effect relations, we are easily swayed by our hunches or premonitions, which are NOTHING but a strong feeling of something that is bound to happen or may not happen at

While feeling is important to our existence, it cannot be used as a test of truth. For it is neither clear nor precise and is easily influenced by the condition of our health, our mood, our environment and many other factors

### **CUSTOMS AND TRADITIONS:**

Customs are described as behavioral and are commonly practiced by members of a social group while traditions are defined as customs which have been preserved for generations and have greater influence of one's own ways of thinking.

For instance, to meet the desire of a social group such as families and religious congregations, certain beliefs had been developed to regulate and control the behavior of its members in order to have unity, stability, and security, e.g., how to behave in solemn occasions, how to greet foreign guests, what to do when disasters occur, and how to treat children.

In fiesta celebrations, it is traditional to be hospitable to anyone who will come to your house. It is also customary and traditional in some societies for the host to offer his daughter as bedmate. Customs and traditions then, although they served certain needs of individuals and groups, are not valid tests of what is true or false.

### **INSTINCT:**

There are two kinds of instincts. One is limited to the inborn behaviors of animal species. The other is inherited and acquired. But both can be modified through intelligence and experience. Though sometimes instinct gives us some semblance of truth, it cannot be trusted as a reliable source of truth. As with feeling, instinct is not precise and is usually in conflict with feeling. Love and hate are both instincts; so is jealousy. To rely therefore on instinct is to undermine the progress of philosophical and scientific studies most of which are beyond what is instinctive.

### **INTUITION:**

Some people say intuition is a test of truth. Actually, it is only a source of truth. Granting for the sake of argument that intuition is a test of truth, as others would insist, then, we have to contend with two major problems.

First, we will have difficulty in checking the validity of our intuitive experience. Second, relying on intuition as a test of truth will mean a very slow progress for humankind because intuition can only be verified through a cumbersome laboratory test. It may even happen that while we wait for the test result, misfortune such as disease, hunger, or war may have already overtaken us. **MAJORITY DECISION**:

The practice of allowing the majority of the members of a social group to make decisions is an important feature of a democratic way of life. By "majority" we mean the greater part or more than half, even if the difference between the two parts is a matter of one point.

The majority's decision is used in determining the many issues, e.g., what form of government a society should have, who should manage the state, the province and other political units, what laws to pass, which regions and which agencies will get this much support from the government, etc.

Some individuals and social groups may not be satisfied with just a majority's opinion. They may insist that majority decision or unanimous decision should be reached before any move or action is made. To them, allowing the majority opinion to prevail may not be a desirable way of resolving issues.

Past experiences will tell us that in many instances the majority opinion, as well as the unanimous decision, was wrong. For instance, people from the ancient times were wrong about the shape and size of the earth. Governments encounter serious budgetary deficits because of a majority decision on wrong revenue collection estimates

And would it not be ridiculous to allow the majority to decide on scientific issues that they are not in a position to do so for lack of training? Just because everyone believes something by the majority or does not necessarily mean that it is right or true. A majority decision, therefore, is not a good test of truth.

### AUTHORITY:

Relying upon authority in resolving issues is a widespread practice by individuals or groups in every society. For instance, religious persons cite the *Bible* as the authority of their lives; confronted with a legal problem, we get the services of lawyers; to solve our medical problems, we depend on doctors; and to cope with drug addiction and prostitution, we get the opinion of sociologists or other social and behavioral scientists.

It is fact, however, that authorities often conflict and contradict each other. Medical doctors are known to have differed in their diagnosis of certain illnesses such as cancer. Sociologists have disagreed on the major motivation for the runaway population growth in third world countries. Judges confuse us with their different opinions as to when human life begins or whether abortion is a crime or not. Whose word then, shall we trust?

Another consideration that weakens authority as a test of truth is the fact that there are persons who masquerade as authorities, and there are writings, which later on are discovered to be spurious. A well-publicized case is the so-called "Hitler's Diary".

### **CORRESPONDENCE:**

Truth has been defined as "that which conforms to fact, which agrees with reality, which corresponds to the actual situation". On the basis of this definition the correspondence theory of truth was formulated: an idea or description is true if it agrees with the object described or referenced to.

As a definition of truth, correspondence is no doubt beyond question. But as a test of truth, correspondence is, in many instances, not useful. Its user will be faced with the difficulty of comparing ideas with reality since, unlike the former, the latter may not be immediately available to him.

One immediate idea of the object and our idea of it when we experienced it may be compared for a correspondence check. But is the object still the same as when we experienced it? It is wise then to take correspondence for what it is—a definition of truth, but not as a test of truth as other people would insist.

### PRAGMATISM:

The origin of pragmatism is Charles Sanders Pierce (1839-1914), a philosopher who was influenced by the principle of Jesus' statement: "By their fruit you shall recognize them." On this basis, Pierce formulated the pragmatic theory of truth, thus:

An Idea is true if it is workable and has practical and satisfactory consequence. Any theory or hypothesis, however beautiful it may sound, if it will not work or does not have any concrete, practical, and satisfactory result is meaningless or without any value.

It goes without saying that it is the satisfactory workability and usefulness of the idea, which not only gives it worth and significance but also validates it as well. If, for example, peaceful negotiation by the government with the rebels is believed to be the best means to ensure a lasting peace, then this hypothesis is true only after it has been seen to work according to expectations.

As a test of truth, pragmatism has deficiencies, the more prominent ones being: First, it is difficult to determine what is meant by the terms "workable", "practical", "satisfactory", and "consequence". Even if we were able to provide definitions for those words, from whose viewpoint should its results be judged as satisfactorily workable and useful?

On the basis of the pragmatic test, would these ideas be considered true despite their inconsistent workability and usefulness? Third, there are ideas which seem to serve a need but which are not necessarily true. A good case is that of a man who firmly believes that offering gifts to the spirits works and, therefore, is true. This encourages him to continue practicing the idea. He only discarded this belief when an agriculturist demonstrated to him that it is not the spirits but the use of irrigation, fertilizer, and pesticides that give him bumper crops.

### CONSISTENCY:

Ideas are consistent if their meanings do not contain contradictory terms, which mutually exclude each other. Propositions like "A dog is an animal", "Trees are plants", and "Computers are machines" are all consistent statements since the terms used in each sentence do not contradict each other.

Examine, however, the following assertions: "Men are immortal", "Stones are soft". The first assertion is a contradictory one since immortal means "living forever", which is not true of men who will eventually die. Contradiction also exists in the second statement since stones are, in reality, hard objects.

While consistency helps us detect falsehood due to contradiction, its meaning is not quite clear because it does not tell us if statements which in themselves are true are related or connected with each other.

A "rigorous" form of consistency was developed to check the inadequacy of the "loose" or "mere" type discussed above. In rigorous consistency, all statements in an argument must necessarily follow one another. Basically, this is the principle underlying the Aristotelian logic as the following classic in syllogism examples: All

men are mortal; Socrates is a man; therefore Socrates is mortal

While rigorous form of consistency is effective for the static or closed system, it rests on certain assumptions—such as assuming all men as mortal beings—which truth needs to be verified. Moreover, it was pointed out that consistency could be easily disrupted by mere introduction of new unrelated data. On this basis even rigorous consistency is not an adequate test of truth. **COHERENCE:** 

The coherence of truth originated with G.W.F. Hegel (1770-1831) and is associated with rationalistic philosophers. It is a view that an idea, opinion, or belief is true if it has intelligible, systematic, and consistent connection with the body of knowledge that we possess. It is not enough that a statement is consistent; it must have a clear and logical link with all other facts of our experience. [H: READ IT AGAIN!]

Since we have to consider all the facts of our experience and provides us with a more complete view of life, it is more adequate and therefore superior to any of the tests that have been examined above.

[H: Moreover, it should be added that you must also acquire all facts relative to any circumstance before you can make AN INFORMED JUDGMENT of TRUTH.

I would point out as an example of absurd presentation of spurious information that you consider that those with Doris and E.J. Ekker, later put onto international Internet and on to being published in a Philippine paper that "Doris was tainted by 'dark energies' and therefore....."

Well, in the ensuing four years I believe that EVIDENCE has PROVEN otherwise.

### WAS 9-11 THE 'NEW PEARL HARBOR'?

Writing in Britain's New Statesman on December 12, 2002, journalist John Pilger described, in disturbing terms, how William Kristol's Project for the New American Century had determined that America needed a "new Pearl Harbor" as the pretext for launching a bid for global dominance. The theme laid forth by Kristol and his associates was that should such a catastrophic event take place, it would give America the opportunity to once again build up its military forces.

On June 3, 1997—three years before George W. Bush assumed the presidency and installed the neoconservatives in power—a host of neo- conservatives including Donald Rumsfeld, Dick Cheney and Paul Wolfowitz signed their names to a "statement of principles" issued by Kristol's organization.

The statement laid forth a goal of building up American military might to ensure that the United States could pursue global hegemony, unfettered by any nation or nations that might dare to resist the agenda of America's ruling elite—unquestionably a declaration of imperial aims.

A subsequent design—dated September 2000—by Kristol's Project for the New American Century, entitled "Rebuilding America's Defenses: Strategies, Forces and Resources for a New Century", laid forth a plan for the United States to take military control of the Gulf region whether Saddam Hussein was in power or not. It stated frankly that the American need for a presence in the Persian (i.e. Arabian) Gulf transcended the question of whether or not Saddam Hussein remained in power.

In order to fulfill that dream, Kristol and his associates said, the United States must be prepared to be able to do battle in multiple places, at one time, around the globe. To achieve that ability, they declared, America must engage in a major transformation of its military, accompanied by massive arms buildups. However, they concluded, "The process of transformation is likely to be a long one, absent some catastrophic and catalyzing event—like a new Pearl Harbor.'

Given that the tragic events of September 11, 2001 provided precisely the "new Pearl Harbor" that sparked a massive build-up, accompanied by the "war on terrorism" that transformed—through neoconservative influence—into an imperial war, first targeting Iraq and thence the rest of the Arab and Muslim world, there are many Americans and others who question whether the 9-11 attacks were either instigated and/or sponsored by the United States and/ or the government of Israel, acting either together or alone. Such people are denounced as "conspiracy

and/or as "hatemongers"—facts notwithstanding.

(The special report from American Free Press gracious permission to serialize the book for our [AFP]—entitled "Fifty Unanswered Questions About 9-11"—contains a wealth of information in this regard that has otherwise, quite notably, gone unmentioned in the mainstream media in America. The work of AFP's international correspondent, Christopher Bollyn, has been frequently cited as among the most forthright in challenging the official U.S. government scenario as to what happened on that tragic day.)

### ONE SCENARIO FOR CREATING TERRORISM . . .

Many Americans who suspect such a scenario point out that there is evidence that, in past years, American officials seriously pondered the possibility of carrying out acts of terrorism on American soil. Most frequently cited is the book by respected veteran journalist James Bamford, Body of Secrets, released in 2001—just prior to the 9-11 attacks.

In that book Bamford revealed that as early as January of 1961, top U.S. policy makers were considering a horrific scheme to launch terrorist attacks on American citizens and point the finger of blame at Fidel Castro's communist Cuba.

Although Bamford's book received some media play, Bamford's shocking revelations regarding the terror campaign proposed by then-Joint Chiefs of Staff Chairman, Army General Lyman Lemnitzer, were largely suppressed.

Lemnitzer, reportedly Jewish, later emerged as part of the neo-conservative Committee on the Present Danger, the public advocacy group for the policies put forth by Richard Perle's Team B experiment which was described earlier in these pages. In any case, here's what Bamford wrote:

According to documents obtained for Body of Secrets, Lemnitzer and the Joint Chiefs proposed secretly to stage an attack on the American naval base at Guantanamo Bay, Cuba—and then blame the violent action on Castro. Convinced that Cuba had launched an unprovoked attack on the United States, the unwitting American public would then support the Joint Chiefs' bloody Caribbean war. After all, who would believe Castro's denials over the word of the Pentagon's top military commanders? The nation's most senior military leadership was proposed to launch a war, which would no doubt kill many American servicemen, based solely on a fabric of lies. On January 19, just hours before [then-President Dwight] Eisenhower left office, Lemnitzer gave his approval to the proposal. As events progressed, the plan would become only the tip of a very large and secret iceberg.

A self-described "imaginative planner", Lemnitzer kept his initial plan in cold storage. However, after the new Kennedy administration's Bay of Pigs fiasco which left Fidel Castro stronger than ever before, Lemnitzer reinvigorated his scheme under the name "Operation Northwoods". Bamford reports that:

The plan, which had the written approval of the chairman and every member of the Joint Chiefs of Staff, called for innocent people to be shot on American streets; for boats carrying refugees fleeing Cuba to be sunk on the high seas; for a wave of violent terrorism to be launched in Washington, D.C., Miami and elsewhere. People would be framed for bombings they did not commit; planes would be hijacked. Using phony evidence, all of it would be blamed on Castro, thus giving Lemnitzer and his cabal the excuse, as well as the public and international backing, they needed to launch their war.

What makes this so additionally disturbing is that this was not some wild scheme by "mad bombers" inside the military. In Bamford's estimation, "the idea may actually have originated with President Eisenhower in the last days of his administration."

Bamford reports that Eisenhower was determined to invade Cuba and that if Castro did not provide an excuse prior to the inauguration of newly-elected President John F. Kennedy, Eisenhower suggested that the United States "could think of manufacturing something that would be generally acceptable."

What Eisenhower was suggesting, writes Bamford, was "a bombing, an attack, an act of sabotage carried out secretly against the United States by the United States. Its purpose would be to justify the launching of a war. It was a dangerous suggestion by a desperate president." Lemnitzer, Eisenhower's protege, was eager to carry out the plan.

Lemnitzer also had in mind the possibility of terrorism on American soil by Americans against Americans—but blamed on Castro. This terrorist conspiracy against his fellow Americans was also offered up by Lemnitzer and his advisors who

We could develop a Communist Cuban terror campaign in the Miami area, in other Florida cities and even in Washington. The terror campaign could be pointed at Cuban refugees seeking haven in the United States .... We could sink a boatload of Cubans en route to Florida (real or simulated) .... We could foster attempts on lives of Cuban

refugees in the United States even to the extent of wounding in instances to be widely publicized.

Bombings and, notably, even airplane hijackings, were all suggested. Whether Lemnitzer's proposals ever actually reached President Kennedy is unknown, writes Bamford, but it is clear that the president was not enamored with the war-mongering general to whom he denied a second term as chairman of the Joint Chiefs.

Yet, following in Lemnitzer's tradition, like-minded "intellectuals" in the defense establishment continued to formulate plans passed on to the military leadership that were designed to provoke a war through a staged terrorist attack. In the end, however, no such plan ever seems to have gone beyond the planning stages, at least as far as Cuba was concerned.

The question arises as to whether—on September 11, 2001—another such insidious scheme was carried through to its conclusion. Many Americans will continue to wonder if that is precisely what happened and evidence continues to emerge that suggests that was indeed the case.

### A MUCH BIGGER GAME BEING PLAYED?

As far back as 1975, top imperialist policy makers such as Henry Kissinger were viewing a potential Middle East war as the means by which an imperial world hegemon could be set in place.

In fact, the scenario seems to suggest that the whole Arab-Israeli conflict over Palestine was instigated—from the beginning—for the very purpose of sparking a global war.

This eye-opening scenario was presented in the stunning final (and probably little-read) paragraphs of a now long-forgotten 1975 book, The Arabs: Their History, Aims and Challenge to the Industrialized World by American pro-Zionist writer, Thomas Kiernan.

Although Kiernan did not name the top policy maker who outlined this amazing geopolitical scheme, Kiernan did describe the individual asserting this worldview as "a senior American State Department official who has played a central role in the mediatory efforts of Henry Kissinger during the past two years".

This description, of course, could include Kissinger himself and, if truth be told, the speaker was probably Kissinger. If not, the speaker certainly reflected Kissinger's thinking as a key player in Kissinger's global machinations.

Responding to a question by Kiernan as to whether the Middle East conflict could be resolved without world war, the speaker (perhaps Kissinger) asserted:

The evolution of events in the Middle East during this century can be likened to the construction, if you can imagine it, of an inverted pyramid.

The capstone, which in the case of such a pyramid turns out to be its base, was formed out of the inevitable conflict between foreign Zionists' need and ambition on the one hand, and local Arab pride and aspiration on the other.

resulting from the insertion of the Zionist state into have been those who have said, for a generation, that this was the whole purpose of the provocative establishment of Israel in the first place. The speaker continued:

As the pyramid grew, the stones in each of its successively widening tiers had added to them further elements—the passions and needs of other foreign interests, the passions and aspirations of other national groups within the Arab world. Each succeeding tier sucked more of the world into it. Now the pyramid is finished. And there it stands, incongruously balanced on its point, its four sides reaching up and out into every corner of the

In other words, the crisis in the Middle East began drawing in the rest of the nations of the worldsimilar, precisely, to what is now happening with the ongoing struggle today between the United States and traditional allies such as France and Germany, not to mention the opposition of Russia and China, over the issue of war with Iraq—an outgrowth of the Israel-Palestine conflict itself. The scenario painted continues:

We all know that it is impossible for a pyramid to stand freely in such an upside-down manner. So far, it has been supported on its four corners by the rest of the world.

Although it has precariously tipped now and then, it has managed to remain more or less upright. But the effort to keep it upright has imposed greater and greater tension on those who

Tension is resolved in two ways, our psychologists tell us. One way is through outburst.

The other is through withdrawal. The fight-or-flee mechanism which is part of every human being's reaction system.

Now, you tell me. Will it be resolved peacefully? Or will it take a world war to bring about a resolution?

If my analogy is correct, there can be no question of the ultimate outcome.

In other words, a world war must result as a consequence of the Israeli-Arab conflict. The scenario proceeds:

One way or the other—whether one side or the other relaxes its support of the pyramid and withdraws, or whether one side or the other chooses to eradicate its tension through outburstthe pyramid will lose its balance and come tumbling down.

Either way, the resolution of the situation will come out of the dust and rubble of the collapsed pyramid. The Israeli-Arab conflict, the very thing that started it all, will be forgotten.

Again, note the suggestion that the Israeli-Arab conflict is indeed central to the world war described in this frightening outline. The scenario concluded:

East and West will be left to pick over the remains like buzzards dining on carrion. That is, if there still is an East and West.

Note the closing words: "if there still is an East and West." What nations will be allied as "the East" and which as "the West"?

Are new alignments emerging—taking the place of Note that the speaker admits that the conflict the traditional Cold War era of "USA vs. USSR"?

### A FINAL WORD . . .

Who will be ruling America . . . when America is ruling the New World Order?

An examination of "the secret agenda behind the agenda" of the High Priests of War

The United Nations—as we have known it—can effectively be considered a ghost of the past. The UN has been shelved, sidelined, consigned to the trash heap—at least temporarily—by the one world dreamers who once saw the global body as the means of establishing a world hegemon. Today's imperialists now envision Uncle Sam as their officially-designated world policeman or, in their more academic terms "the center of a new international system". The goal is "a world that looks like America, and is therefore safe for all".

However, despite the rhetoric—which might please the ears of many grassroots American patriots (or those who fancy themselves that)—it's not quite so simple. There's more to this agenda than meets the

What might be described as The Grand Scheme for a New World Order-in the wake of America's new "imperial" role—was imparted in quite candid fashion in a major two-part policy paper in the Summer 2003 and Winter 2004 issues of The Journal of International Security Affairs, house organ of the definitively influential Jewish Institute for National Security Policy (JINSA), which has been referenced repeatedly in the pages of The High Priests of War.

Once a previously little-known Washington think tank, JINSA is now often publicly acknowledged as perhaps the most specific guiding force behind Bush administration foreign policy today. So when something appears in a JINSA publication, there's a lot of weight behind it.

The author, Alexander H. Joffe, a pro-Israel academic, has been a featured writer in the pages of this JINSA publication, and that he was given so much space to tout his theories certainly reflects the high regard in which his views are held.

Joffe's two-part series was entitled, "The Empire first declared "victory" in Iraq, things have only gotten That Dared Not Speak Its Name". In his essay, Joffee frankly admitted that "America is an empire" and asserts that, yes, this is a very good thing.

> Joffe says that when the UN dared to take on Zionism, that marked the demise of the UN in the minds of the internationalists. Joffe writes:

> "The end of the General Assembly as a credible body may plausibly be ascribed to the infamous 'Zionism is Racism' resolution in 1975." The JINSA author contends that the world should be "grateful" that the UN has been "discredited, reduced to farce and ultimately ground to a halt", referring, of course, to UN positions that the Zionists and their allies in the world empire movement find offensive.

> As a result of the UN being shelved as a world government vehicle, writes Joffe, "We now have the opportunity, and obligation, to begin again." However, he warns that the emerging European Union (EU) is a threat to the dream of a global empire.

The JINSA writer asserts that the EU is an "alternative vision for the international community", one that, as he puts it, frankly is "the authentic countervision to an American Empire". According to the Zionist writer, the biggest problem with Europe and problems. Nationalism was a doctrine born in Europe, as were its vicious mutant offspring: fascism and communism."

(Note: A fervent advocate of Israeli supernationalism, the writer, Joffe, doesn't seem to see the lack of logic in his attack on other peoples' nationalism—but then, again, honesty has never been integral to the hard-line Zionist point of view.)

Joffe complains that although "the new European Empire is multi- cultural in theory ... in reality it is dominated politically and culturally by France and economically by Germany." Today, in the EU, he says, "driven by a sense of postcolonial guilt and postwar *ennui* the door have been thrown open to all ideas. At the most sinister levels it has permitted and even legitimized a vast explosion of unhinged thought and action, namely anti-Americanism, anti-Semitism, and a wide variety of conspiracy theories."

(The so-called "conspiracy theories" that so alarm this Zionist theoretician are those that dare to challenge the "official" views of what really happened on September 11, 2001. He is inflamed that millions of people in Europe and the Muslim world—not to mention the United States—have raised questions about Israeli foreknowledge and/or involvement in those events.)

In any case, what Joffe describes as "the other kind of liberal internationalism" is what the Zionist movement favors and Joffe defines it:

The American Empire has no real or theoretical competitors. The goal of the American Empire in the 21<sup>st</sup> century is not territorial control or the exploitation of resources but political and economic leadership which defends and advances American interests, and which promotes the development and well being of all nations. Given our history and our values, that future lies in leveraging the American Empire in such a way that it becomes the basis of a new democratic international system.

Ultimately the only answer for a stable and prosperous planet will be a global system that is structurally and morally similar to the American union—semi- autonomous states with secular, liberal democratic systems; where states have both prescribed rights and agreed upon responsibilities in a larger secular, liberal democratic framework; one equipped with checks and balances and meaningful institutions; with governance based on rule of law and tolerant and pluralist values.


In the second-part of his extended essay, published in the Winter 2004 issue of JINSA's journal, Joffe pursued this line of thought further, expanding on his call for what he described as "an empire that looks like America"

Amazingly, Joffe frankly talks about the United States engaging in massive imperial conquests in the trouble-torn regions of Africa—presumably after the United States has already made havoc in the Arab countries of the Middle East:

The conditions under which America and its allies would simply take over and restore African countries are far from clear. What are the thresholds for intervention? What are the

procedures and outcomes? Who will fight and who will pay? The restoration of Africa would involve long-term commitments and immense costs, of the sort that could only be paid for by Africa itself. That is to say, it would probably require American economic control, to go along with political and cultural control. Colonialism is

always pay as you go, and it is not pretty. The question is both whether Africa can pay the price (or afford not to) and whether America has the stomach.

Of course, Africa is not the only target of Joffe

and his like-minded schemers (and that is precisely what they are, however, "extreme" that term may be perceived). In fact, Joffe talks of a wide-ranging global agenda—well beyond the African continent.

In the end, however, Joffe lets the cat out of the bag, about the real intentions of those who are using United States military power as the mechanism for a

bigger agenda. "New arrangements," he says, "must come into being under American leadership to provide an alternative for states that are willing to accept rights and responsibilities." Joffe dreams of a United Nations that has been re-made under the imperial force of the United States. And ultimately, he predicts the possibility of a world government, writing:

Possibly, after a period of chaos and anger, which in any event would simply intensify existing states of being, the institution [the United Nations] might be bludgeoned into changing. [Note his use of the term "bludgeoned".—MCP]

Rather than a club that admits all, the 21st century United Nations might—someday, somehow—be remade into an exclusive, by invitation, members-only group, of free, democratic states, sharing similar values. Or in the end, replaced by one. That day, however, may be decades off.

Should there be any doubt that he is talking about world government, note Joffe's concluding words:

The best way to preserve the American empire is to eventually give it up. Setting the stage for global governance can only be done with American leadership and American-led institutions of the sort schematically outlined here.

So it is. Despite all the high-sounding rhetoric about "democracy", what it all comes down to—in the words of this pro-Israel ideologue—is the use of America's military power to advance another (secret) agenda altogether. Even many of those grassroots American flag-wavers (who may be genuine patriots) who relish the concept of an American empire may find Joffe's concepts somewhat different from what they otherwise might perceive.

But here, in the pages of a devotedly pro-Zionist journal, we learn precisely what the "story behind the story" actually happens to be. It has nothing to do, really, even with a "strong America" or, for that matter, even with America itself.

The United States of America is simply a pawn—albeit a powerful one—in the game, being ruthlessly shifted about in a scheme for world dominance by an elite few operating behind the scenes.

And, in the end, this does tell us very much about who The High Priests of War really are and what their agenda is really all about. There's no mystery at all.

What remains to be determined is what the American people—and all other real patriots in nations around the globe—intend to do about it.

The question is this: will the world finally decide it is time to declare war on The High Priests of War?

### **GOLD'S RISE IN EURO TERMS** MAY SIGNAL BROADER RALLY

By John Parry and Zachary Howard, Reuters, 6/7/05

NEW YORK—Gold prices may be about to benefit from both volatility in and a lack of confidence in several of the world's major currencies, with gold's price in euros a key indicator, analysts said.

Gold, as a classic hedge against global investors' worries about inflation or geopolitical instability, was a beneficiary of the dollar's three-year decline through the end of 2004.

Gold is priced on international bullion markets in dollars, and the precious metal has a tight inverse price correlation with the U.S. currency.

The dollar has rallied so far in 2005, lifted mainly by rising U.S. interest rates, and gold prices in dollar terms proportion. have fallen by 3.2 percent.

This month, however, gold prices have begun to rebound, even although the dollar has remained strong, and with the euro down more than 9 percent this year, some analysts are tracking the price of gold in euros as an indicator of demand for hard assets.

On Tuesday, spot gold was trading at around \$425 per ounce and gold in euros was at 346.40.

"If gold breaks above 350 euros per ounce, that will signify the market is shunning all paper currencies", said Jes Black, hedge fund manager, with Black Flag Capital Partners LLC, Hoboken, New Jersey.

If gold were to rise above that level "what you would see is a mad rush into gold. ... It could very well spark a very large rally in gold," Black said.

The euro has come under pressure this month after both France and the Netherlands voted against the proposed EU constitution in referendums.

...Meanwhile, the dollar remains strong, supported by higher interest rates in the U.S. than in Europe or

But Asian currencies could attract some investment if China revalues the yuan, removing its peg to the dollar, and a weaker dollar would again provide support for gold prices.

'Gold is starting to firm up against all the currencies. Technically, that is looking very good," said one metals broker at a futures commission merchant.

"Investigators are trying to find the source of mysterious fumes that overpowered several children in Queens. The children were in school at the time. Those kids should be fine but it was a tough day at school because of this strange odor. This is a real mystery and on the record right now authorities are still telling us they're having a hard time pinpointing the exact source of this odor."

The next documented attack occurred in the United States North Carolina Region on June 1<sup>st</sup>, and as we can read as reported by the WXII Television News Service in their article titled "Mystery Remains In Asheboro Mall Evacuation" and which says;

"Authorities in Asheboro are still wondering what sickened five people at a local mall, forcing the building to be evacuated for about an hour Wednesday. Shoppers complained of a weird smell in the Randolph Mall's central court around lunchtime. But police say people in other areas of the mall noticed nothing out of the ordinary. Several people were checked at the scene, and five more—including two pregnant women—went released after a little while. Fire Department Capt. Keith Seabolt said everything in the area seemed fine to him, and air quality sensors turned up nothing. He said the case is kind of a mystery."

"The Wal-mart in Biddeford was evacuated late Monday afternoon when a strange odor was detected in the building. Fire officials say between 150 and 200 people were in the store at the time. They all got out safely, but at least two people had to be treated for breathing difficulties. The ventilation system was checked and several tests were done but fire officials say nothing dangerous was found in the air."

The first paragraph reads: "This special minute of the separate group meeting in special proviso, was called by the Group Chairman President of the Republic of the Philippines, Ferdinand E. Marcos presented a position paper, as holder owner, and counsel of Tallanos family clan sole owner of the 617,500 AU metals in metric tons, 500,000 pieces of diamond precious stones and 16,500 metric tons of Platinum previously deposited in old vault at the old Sentral bank Intramuros, Manila during Spanish time, transfer to Vatican during Worldwar No II, and transfer back to the Philippines the Atty. Ferdinand E. Marcos, in the year 1949, to help the establishment of the required gold reserves of the newly installed central bank of the Philippines, the family of Tallanos Clan approved of the central bank lent of 400,000 tons only.

# Lawful Avoidance Of Key IRS Designations

**Budget's "Tip of the Week" #8:** 

**Avoiding the IRS Designations of:** 

"Personal Service Corporation", "Personal Holding Company" and "Controlled Group"

The tax advantages of properly operated Nevada corporate shelters may be secondary to the benefits of liability protection, asset protection and privacy but they are worth discussing all the same, especially since many tax professionals don't seem to "get it".

The IRS will tag a corporation as a "Personal Holding Company" and assess a surcharge of 39.6% on undistributed earnings in cases where more than 60% of the corporation's income is derived from "passive" sources such as dividends, interest and rental income. The IRS applies a designation of "Personal Services Corporation", assessing all income at a flat rate of 35%, in cases where a C corporation is engaged in the performance of personal services (consulting-type work) and where such services are performed by employee-owners. Yet another IRS designation is that of "Controlled Group", based on complicated rules for determining allowable cross-ownership of corporations, whereby the IRS seeks to lump all of the income into a single, consolidated return—resulting in the highest possible tax rate, of course.

Each of these designations is based on the corporation's OWNERSHIP. How very fortunate, then, that ownership of Nevada corporations is statutorily permitted to be very PRIVATE: It is not a matter of public record, only of the protected (by *NRS* 78.257) internal records of the corporation.

To be considered a "Personal Holding Company" a corporation must be owned by five or fewer stockholders. It is totally permissible for a corporation to earn 100% of its income from passive sources, as long as it is owned by six or more stockholders. It is similarly easy to avoid the designation of "Personal Services Corporation": Don't own the stock! "Controlled Group" status is also very easily avoided with Nevada corporations: Simply ensure that no entity owns 80% or more of any other entity and that in brother-sister corporate relationships there are six or more stockholders. As no liability is attached to stock ownership, surely you could find a trustworthy friend or six who wouldn't mind holding stock in the corporation? If not, give us a call—we know of hundreds of corporations in similar circumstances.

With regard to "Controlled Group" status, the IRS has from time to time invoked *Section 482* of the *Infernal Revenue Code*, which lumps together income from corporations if they APPEAR to act out of a unity of interest. To our knowledge, however, even this blanketing regulation is relatively easily overcome, as long as the corporations act in their own, separate, well-documented self-interest.
