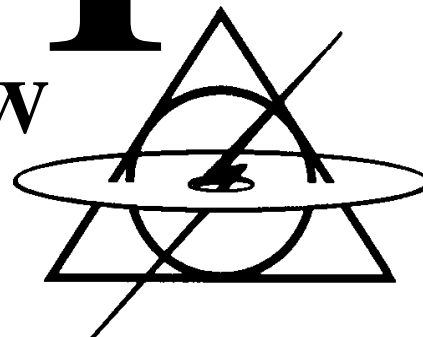

It will be noted that our Nevada Corporate Headquarters, Inc. was the agent and on request did send the form to her in Illinois—AFTER ALL FEES AND REGISTRATIONS WERE FULLY QUALIFIED.

ONE-QUARTER OF THE RICHEST AMERICANS;
30% OF ALL BILLIONAIRES ARE JEWISH.

Beginning in the early 1980s, *Forbes* magazine published an annual compilation of the four hundred richest Americans. Strictly based on their percentage of the general population, there should have been about twelve Jews on this list. Instead, there were over one hundred. Jews, who constituted less than 3 percent of the American people, made up over one-quarter of the richest Americans. They were over-represented by a factor of nine. By contrast, ethnic groups that greatly outnumbered Jews—Italians, Hispanics, blacks, and eastern Europeans—had few representatives on the list. The higher the category of assets listed by *Forbes*, the greater the percentage of Jews. Over 30 percent of American billionaires were Jewish. The same phenomenon was also found in Canada, where the three most prominent business families were all Jewish—the Belzbergs of Vancouver, the Bronfmans of Montreal, and the Reichmanns of Toronto. It was possible that *Forbes* even underestimated the number of America’s super-rich Jews, since many of them had become wealthy in real estate, the most difficult of fields to gauge assets and the easiest in which to hide wealth.

An even more impressive list appeared in the [July 22] 1986 issue of *Financial World*. It numbered the one hundred Wall Street executives—investment bankers, money managers, arbitrageurs, buyout specialists, speculators, commodities traders, and brokers—who had earned at least \$3 million in 1985. The list began with Ivan Boesky, who supposedly made \$100 million ... Boesky’s earnings were dwarfed by the \$500 million Michael Milken earned in a following year ... Milken and Boesky were Jewish, as were half of the people mentioned by the *Financial World*. Wall Street’s Jewish heavy hitters included George Soros (\$93.5 million), Asher Edelman (\$25 million), Morton Davis (\$25 million), and Michael Steinhardt (\$20 million).

REAL ESTATE MAJOR SOURCE OF JEWISH WEALTH

Jewish fortunes were to be found in many areas. Russell Berrie manufactured teddy bears, Paul Kalmanovitz owned breweries, and Arthur Sackler published medical magazines.

But in no field were Jewish entrepreneurial talents more evident than real estate. Perhaps half the Jews on the *Forbes* list made their fortunes in real estate, particularly in New York City. “The Jew runs to real estate as soon as he can save up enough for a deposit to clinch the bargain,” Jacob A. Riis had written in *How the Other Half Lives* (1890). Except for a few Gentile interlopers ... the most successful New York real estate developers were Jews. They included Laurence and Preston Tisch, Leonard Stern, Samuel LeFrak, and Sol Goldman.

Other cities had their own Jewish real estate barons: Jerry Moore in Houston, A. Alfred Taubman in Detroit, Walter Shorenstein in San Francisco, Guilford Glazer in Los Angeles, Melvin and Herbert Simon in Indianapolis, Monte and Alfred Goldman in Oklahoma City, Frank Morgan and Sherman Dreiseszun in Kansas City, Mortimer Zuckerman and Harold Brown in Boston, Stephen Muss in Miami, Harry Weinberg in Baltimore, Neil Bluhm and Judd Malkin in Chicago, and Charles E. Smith in Washington.

JEWS OVER 11% OF ‘AMERICAN ELITE’

On the basis of income and education, Jews by the 1980s were in the upper strata of American society and had moved into positions of political, economic and social power.

Beginning in the 1960s, Jews had headed some of the most important branches of the

federal government, including the Federal Reserve System and the labor, commerce, state, and treasury departments ... The social system was sufficiently open to enable Jews to become an important part of the American elite.

‘DOMINANT ROLE’ BY JEWS
IN ‘NEW LEFT CULTURE’

Jewish academics and other intellectuals played the dominant role in the fashioning of the New Left culture of the 1960s and 1970s. Sometimes, as in the influential writings of the historical sociologist Immanuel Wallerstein, this New Left theory was only a modestly updated version of mainline Marxist-Leninism. More often it was a blend of the imaginative cultural Marxism of Benjamin, Adorno and the Frankfurt School of the 1930s with the more radical side of the Freudian tradition. The leader in this direction was Herbert Marcuse, a product of the Frankfurt School and the highly visible guru of the Jewish-sponsored Brandeis University in the 1950s and 1960s. [Norman F. THE FEMINIST MOVEMENT

The highly successful American feminist movement of the 1970s and 1980s involved Jewish leadership as well. Jewish women had played no role in the first American feminist movement in the first three decades of the twentieth century. It was different this time around. Perhaps the two most prominent personalities in the women’s movement, Gloria Steinem and Betty Freidan, were Jewish. A third leading feminist theorist, Elizabeth Fox-Genovese, was half-Jewish. The author of the all-time best-selling novel, translated into twenty-seven languages, celebrating feminine sexuality, was an upper-middle-class, New York Jewish woman, Erica Jong. [Norman F. JEWS ON WALL STREET
‘SKIRT LIMITS OF THE LAW’

Jewish investment bankers played a major, perhaps predominant role in the frenetic Wall Street speculative ventures of the 1980s. In “the Predator’s Ball” of the 1980s, as a best-selling journalistic account of these fiscal ventures termed it, the Jewish dance card was full, although when a Gentile novelist, Michael Thomas, made the Jewish presence in Wall Street speculative ventures a prominent theme in a novel, he was denounced in the *New York Times Book Review* for anti-Semitism. BUYING INTO PROFESSIONAL SPORTS

Jewish billionaires in the 1990s demonstrated that they had arrived at the pinnacle of social prowess and cultural importance by buying professional sports teams, hitherto the proud preserve of WASP and Irish magnates. By 1993 the New York football Giants, the most honored name in professional sports, two other National Football League teams, and two of the major league baseball franchises were in Jewish hands. One of these Jewish owners carried so much weight with the other owners that he engineered the firing of the baseball commissioner and took over as acting commissioner, representing the owners before a congressional committee. In the 1930s American Jews had thought they were doing well when they produced a couple of boxing champions. The Jews did not have to show their sweaty bodies anymore; they owned the teams. THE POWER OF THE PRESS

As in Berlin and Vienna before Hitler, the Jewish role in publishing was an important one. By 1950 Jewish families owned two of the

three most influential newspapers in the United States, the *New York Times* and the *Washington Post*. Furthermore, both families were directly involved in the daily operation of the papers and in setting their editorial policies. [Norman F. Cantor, The Sacred Chain: The History of the Jews, p. 405]

‘THE POWER OF THE WORD’

It is true that Jews are represented in the media business in numbers far out of proportion to their share of the population. Studies have shown that while Jews make up little more than 5 percent of the working press nationwide—hardly more than their share of the population—they make up one fourth or more of the writers, editors, and producers in America’s “elite media”, including network news divisions, the top newsweeklies and the four leading daily papers (*New York Times*, *Los Angeles Times*, *Washington Post*, *Wall Street Journal*). In the fast-evolving world of media mega-corporations, Jews are even more numerous. In an October 1994 *Vanity Fair* feature profiling the kingpins of the new media elite, titled “The New Establishment”, just under half of the two-dozen entrepreneurs profiled were Jews. In the view of the magazine’s editors, these are America’s true power elite, “men and women from the entertainment, communications and computer industries, whose ambitions and influence have made America the one true superpower of the Information Age”. And in a few key sectors of the media, notably among Hollywood studio executives, Jews are so numerically dominant that calling these businesses Jewish-controlled is little more than a statistical observation. “If there is Jewish power, it’s the power of the word, the power of Jewish columnists and Jewish opinion makers,” says Eugene Fisher, director of Catholic-Jewish relations at the National Conference of Catholic Bishops, and one of the Jewish community’s staunchest defenders in religious Christian circles. “The Jewish community is a very literate community, and it has a lot to say. And if you can shape opinion, you can shape events.” [J.J. Goldberg. Jewish Power: Inside the American Jewish Establishment, p. 280]

MEDIA CLOUT MEANS POLITICAL INFLUENCE

For all of the rank anti-Semitism lurking in the Jewish-conspiracy theories, the notion of Jewish influence in the media is not necessarily anti-Semitic in and of itself. The awkward fact is that, indeed, “the Jews invented Hollywood,” as historian Neal Gabler put it in the unfortunate subtitle of his 1988 historical study, *An Empire of Their Own*. The movie camera was invented by non-Jews, but the Hollywood dream factory was created by a handful of immigrant Jewish entrepreneurs. They saw the motion picture’s potential as a storytelling device, and they built the studios, distribution systems, and movie theaters to promote it nationwide. These few ... turned a technological curiosity into a multibillion-dollar industry. A generation later, a young group of Jewish entrepreneurs did the same thing with the radio

transmitter, the microphone, and the television camera. ...

Hollywood at the end of the twentieth century is still an industry with a pronounced ethnic tinge. Virtually all the senior executives at the major studios are Jews. Writers, producers, and to a lesser degree directors are disproportionately Jewish—one recent study showed the figure as high as 59 percent among top-grossing films.

The combined weight of so many Jews in one of America’s most lucrative and important industries gives the Jews of Hollywood a great deal of political power. ... But the same could be said, to a much greater degree, of other industries with significant concentrations of Jews: Wall Street, New York real estate, or the garment industry.

In each of those industries, Jews make up a significant bloc—an important minority on Wall Street, near majorities in clothing and commercial real estate—and have translated their clout into a visible presence on the political scene.

‘BETTER OFF’ THAN ‘MOST OTHER’ GROUPS

... If the stereotype of Jews as uniformly wealthy is wide of the mark, they are nonetheless better off on average than members of most other ethnic and religious groups. In 1984, for example, fewer than one American Jewish family in six had an income of less than \$20,000, compared to one in two among non-Hispanic whites.

At the other end of the income pyramid, 41 percent of Jewish households had incomes of \$50,000 or more—four times the proportion among non-Hispanic Whites.

One reason for this differential is that Jews are better educated than other Americans. Three Jewish men in five are college graduates—nearly three times the proportion among non-Hispanic whites; one in three have graduate or professional degrees—three and a half times the proportion in the population at large.

Much the same disparities exist among Jewish and non-Jewish women: the former are twice as likely as the latter to have college degrees and four times as likely to have graduate or professional degrees. Today, moreover, college attendance is almost universal among young Jews. A 1980 national survey of male and female high school students found that 83 percent of the Jewish students planned to go to college and fully half expected to go on to graduate or professional schools; among white non-Jewish students, half were planning on college and fewer than one-fifth expected to go to graduate or professional schools.

The difference is qualitative as well as quantitative. Jews not only receive more schooling, they get a better education ... Since the 1950s or 1960s, when Ivy League institutions shifted to meritocratic admissions policies, Jews have made up about a third of the undergraduate student population and about the same in law and medicine.

WHO DOMINATES ‘THE AMERICAN ELITE’?

According to a study of the ethnic and racial backgrounds of people listed in the 1974-75 edition of *Who’s Who in America*, Jews were two and a half times more likely to be included than members of the population at large.

Relative to population, moreover, there were more than twice as many Jews as there were people of English heritage, the group that once dominated the American elite. The change over the preceding half-century was striking: in 1924-25, people of English descent were nearly two and half times as likely to be listed as American Jews ... In a 1971-72 analysis of a much smaller group of leaders in some eight fields of endeavor, the sociologists Richard D. Alba and Gwen Moore found an even greater concentration.

Of the 545 people studied, 11.3 percent were Jews—four times their proportion in the population as a whole ... The phenomenon is not limited to the United States. Jews make up about one percent of the population of Great Britain, but 6 to 10 percent of the British elite; in Australia, where Jews are 0.5 percent of the population, they constitute 5 percent of the elite. ...

The Jewish representation among successful entrepreneurs is considerably higher than among corporate chief executives: some 23 percent of the people on the *Forbes* 1984 list of the four hundred richest Americans were Jews. ... The precise proportion varies somewhat from year to year.

In 1982, the first year the *Forbes* 400 was published, 105 of the group, or 26 percent, were Jews. The number dropped to 98 (25 percent) in 1983, when a stock market boom catapulted a number of newcomers onto the list, and 93 (23 percent) in 1984.

AMERICA’S ‘ACADEMIC ELITE’

Whatever the precise proportion (and one person’s elite is another’s coterie) there can be no doubt that Jews play a large role in American intellectual life.

In 1975, for example, Jews constituted 10 percent of all faculty members but 20 percent of those teaching at elite universities; nearly half of the Jewish professors—compared to 24 percent of Episcopal and 17 percent of Catholic professors—were teaching at the top-ranked institutions.

Jewish professors are also far more likely to publish articles in scholarly journals than their non-Jewish peers; thus Jews make up 24 percent of the academic elite—those who have published twenty or more articles.

‘PROFESSORS AT ELITE SCHOOLS’

The wave of Jewish college academics is a relatively recent one. In 1940, only 2 percent of American professors were Jewish. By 1970 the number had increased fivefold, to 10 percent. Restrictive quotas from the first half of the century had ended, and a new generation of Jews was being educated in larger numbers.

By the 90s, Jews made up 35 percent of professors at elite schools—and a Jew has now served as president of nearly every elite institution, including Harvard, Yale, Penn, Columbia, Princeton,

MIT and the University of Chicago.

Because Jews in general attend more prestigious institutions and choose positions in the professional schools of law, medicine, science and business, their compensation is well above the average professor’s.

KEY DECISION MAKING’ IN TV NEWS; NEARLY ONE-THIRD OF THE ‘MEDIA ELITE’

All told, the once-scruffy vocation [of journalism] has become an intellectually exciting, reasonably well-paid, prestigious profession in which Jews play an increasingly important role. In 1982, for example, Jews made up a little less than 6 percent of the national press corps as a whole but 25 to 30 percent of the “media elite”—those working for *The New York Times*, *The Washington Post*, and *The Wall Street Journal*; for *Time*, *Newsweek*, and *U.S. News & World Report*; and for the news divisions of CBS, NBC, ABC, and the Public Broadcasting System and its leading stations. (A 1971 study put the number of Jews in the media elite at 25 percent.)

When one looks at the key decision-making positions, the Jewish role appears to be even larger.

Jews are equally influential, if less well known, in the management of television news. It is the network correspondents, of course, who have become household names, among them Jews ...

The greatest concentration of Jews, however, is at the producer level—and it is the producers who decide which stories will go on the air, and how long, and in what order they will run.

In 1982, before a shift in assignments, the executive producers of all three evening newscasts were Jewish, as were the executive producers of CBS’s *60 Minutes* and ABC’s *20/20*.

And Jews are almost equally prominent at the “senior producer” and “broadcast producer” levels as well as in senior management.

POLICE ‘HAD ROLE’ IN BALI BLASTS

Indonesian police or military officers may have played a role in the 2002 Bali bombing, the country’s former president, Abdurrahman Wahid has said.

In an interview with SBS’s *Dateline* program to be aired tonight, on the third anniversary of the bombing that killed 202 people, Mr Wahid says he has grave concerns about links between Indonesian authorities and terrorist groups.

While he believed terrorists were involved in planting one of the Kuta night club bombs, the second, which destroyed Bali’s Sari Club, had been organised by authorities.

Asked who he thought planted the second bomb, Mr Wahid said: “Maybe the police ... or the armed forces.”

“The orders to do this or that came from within our armed forces, not from the fundamentalist people,” he says.

... “There is not a single Islamic group either in the movement or the political groups that is not controlled by (Indonesian) intelligence,” he said.

Abduh has written a book on Teungku Fauzi Hasbi, a key figure in Jemaah Islamiah (JI) who had close contact with JI operations chief Hambali and lived next door to Muslim cleric Abu Bakar Bashir.

He says Hasbi was a secret agent for Indonesia's military intelligence while at the same time a key player in creating JI.

... "The first Jemaah Islamiah congress in Bogor was facilitated by Abu Jihad, after Abu Bakar Bashir returned from Malaysia," Mr Mempri said.

"We can see that Abu Jihad played an important role. He was later found to be an intelligence agent. So an intelligence agent has been facilitating the radical Islamic movement."

Hasbi was disembowelled in a mysterious murder in 2003 after he was exposed as a military agent and his son Lamkaruna Putra died in a plane crash last month.

Another convicted terrorist, Timsar Zubil, who set off three bombs in Sumatra in 1978, told the program intelligence agents had given his group a provocative name Komando Jihad and encouraged members to commit illegal acts.

"We may have deliberately been allowed to grow," he said.

Abduh also told the program his terrorist organisation, the Imron Movement, was incited to a range of violent action in the 1980s when the Indonesian military told the group that the assassination of several Muslim clerics was imminent.

Another terrorism expert, George Aditjondro, said a bombing in May this year that killed 23 people in the Christian village of Tentena, in central Sulawesi, had been organised by senior military and police officers.

"This is a strategy of depopulating an area and when an area has been depopulated both becoming refugees or becoming paramilitary fighters then that is the time when they can invest their money in major resource exploitation there," he said.

BRITISH TERRORISM IN IRAQ

It had been long known to the Iraqis, to the Arabs, and to all Moslems in countries bordering Iraq that the majority of the terrorist attacks in Iraq, especially car bombings, are perpetrated by covert British, American, and Israeli operatives. It is also well known to them that the terrorist Abu Musab Al Zarqawi and his "Al-Qaeda in Iraq" are just inventions of the coalition forces to justify their existence. More and more evidences are coming out of Iraq to support this fact. The arrest of two undercover British SAS operatives last week, disguised as Arabs trying to plant a car bomb in the middle of Basra during the Karbala Festival, which draws as many as 3 million pilgrims to the city, is just the latest of such revelations.

In a previous article, "American Terror Strategy in Iraq", (published first week of last August) I wrote about the American covert terrorist activity in Iraq aimed at inciting civil war and alienating Iraqi resistance. The good citizens of Great Britain and U.S., including their troops fighting in Iraq, would not believe that their governments would do such terrible acts. After all these two countries are sacrificing the lives of their young troops to liberate Iraqis and not to murder them. The article was criticized harshly by American troops, who served in Iraq, and claimed that they were helping Iraqis rebuilding their lives. Yet many other Americans and Britons—troops as well as independent reporters—speak loudly about the African, Latin American, American and British

mercenaries operating in Iraq and are paid thousands more than the regular troops to perpetrate the terror attacks. British and American leaders had lied their troops into the war in Iraq. Studying history one discovers a long history of these leaders deceiving their people and leading them to terrorize other countries.

The two British operatives, arrested by Basra police and later freed by a British military operation, were identified by the BBC as "members of the SAS elite special forces" <news.bbc.co.uk/2/hi/middle_east/424614.stm>. They were disguised by wigs and Arab dress. Iraqi sources reported that the Iraqi police were watching the two, and when they tried to approach them they shot two policemen and tried to escape the scene. The Iraqi police chased and captured them, to discover a large amount of explosives planted in the car, which apparently was planned to be remotely detonated in the busy market of Basra. The SAS involvement in Iraq was discovered on the 30th of January 2005 when an RAF Hercules plane crashed near Baghdad killing then British servicemen after dropping off fifty SAS members north of Baghdad to fight Iraqi guerillas.

SAS (Special Air Service) is a secret regiment in the British Army. It was formed in 1941 to conduct raids behind the German lines in North Africa. At the present it forms part of the United Kingdom Special Forces alongside the Special Boat Service and the Special Reconnaissance Regiment. The role of the SAS includes intelligence gathering, behind enemy lines target attacks, counter revolutionary warfare, guarding of senior British dignitaries, conducting military missions without official British Government involvement, training special forces of other nationalities, and counter-terrorism operations.

... The SAS was deeply involved in the British conflict in Northern Ireland since its start in 1969. At the beginning they operated openly in their own uniform, and later on they planted moles in the IRA, who were involved in terror bombing. The well known August 15th, 1998 Omagh bombing attack, which killed 29 civilians was done by an SAS double agent as reported by the *Sunday Herald* <sundayherald.com/17827>. The paper also reported the confession of another SAS member, who operated as an IRA mole from 1981 to 1994 while on full British army pay. He helped to develop a new type of bomb activated by photographic flashes to overcome the problem of IRA remote-control devices being signal jammed by army radio units <sundayherald.com/print25646>. Another mole, known by his codename "Stakeknife", was still active in December of 2002 as one of Belfast's leading provisionals. His military commander "allowed him to carry out large numbers of terrorist murders in order to protect his cover within the IRA" <sundayherald.com/29997>. In late 2002 the paper reported reliable evidence that the British army had used its moles in terrorist organizations to "carry out proxy assassinations", such as the case of the human rights activist Pat Finucane, who was murdered in 1989 by the Protestant Ulster Defense Association (UDA). The mole supplied the UDA with necessary information to assassinate Finucane <sundayherald.com/29997>.

Car bombings in Iraq started a few months after the occupation. The first attacks were directed against the U.N. Headquarters in Iraq prompting the U.N. to withdraw its employees. The Red Cross and the Jordanian Embassy were also initially targeted. Later on car bombing targeted several mosques and religious leaders, and lately the fragile Iraqi Police became the main target. Oddly enough the common denominator in these attacks is that they targeted exclusively Iraqis rather than the occupying forces. It does not make any sense for Al-Qaeda and Al-Zarqawi, [who] allegedly came to Iraq to fight Americans, to attack Iraqi civilians and Iraqi police. In doing so the occupying forces find excuses to stay longer in Iraq. As Bush and Blair

continue to remark that since the Iraqi Forces are very weak and could not defend the Iraqi against terrorist, it is imperative for the British/American troops to stay in Iraq in order to fight terrorists and help Iraqis defend themselves.

There is a common belief that these car bombings are orchestrated by foreign forces (Americans, British, and Israelis) in Iraq to spread chaos. Imad Khadduri, the Iraqi-exile physicist, reported of Arab drivers discovering bombs planted in their cars after being stopped and interrogated at an American checkpoint. Baghdad Burning blog reported in May 2005 of eyewitnesses to American patrols planting bombs in Ma'moun area in west Baghdad. Abdel Hadi Al-Daraji, Al-Sadr's top official in Sadr City, accused Britain of plotting to start an ethnic war by carrying out car bombings targeting Shia civilians and then blaming the attack on Sunni Arabs. He said: "Everyone knows the occupiers' agenda. They are in bed with the Mossad (the Israeli secret service) and their intention is to keep Iraq an unstable battlefield so they can exploit their interests in Iraq". Sheik Hassan Al-Zarqani, a spokesman for Mahdi Army militia, described the two British SAS operatives as terrorists. He stated that the Iraq police found weapons, explosives and remote control detonators in their car. He explained, "We believe these soldiers were planning an attack on a market or other civilian targets". The quick fierce action of the British army to release the two SAS operatives before being interrogated tends to support the view that this incident has deeper implications beyond what appears on the surface.

The general attitude of many Iraqis could be summarized in a statement made by a Shiite man. He said: "I believe it is the Americans who are doing this, pretending it is Sunnis, so there will be a civil war and they can control our wealth." International reporters, such as the American journalists Dahr Jamail and Juan Cole, started viewing car bombings through the Iraqi point of view.

When asking the important question of who benefits from these car bombings, we discover that the only beneficiaries are the occupying forces. Blaming car bombings on Iraqi resistance the Americans are trying to drive a wedge between the resistance and the sympathetic Iraqis. By bombing Shiite mosques in one day and Sunni mosques in another they are trying to incite hatred between the two religious factions. Civil war and division of Iraq is the ultimate goal of the occupation. Bush's and Blair's speeches are geared towards planting seeds of religious conflict. Corporate-owned media on both sides of the Atlantic seem to cultivate these seeds and repeatedly report that car bombing attacks causing casualties among Iraqi civilians are pushing Iraq towards a civil war between Sunnis, Shiites, and Kurds. To incite more religious hatred between the groups the corporate media report of "alarming ethnic cleansing" of Shiites in the predominantly Sunni Baghdad neighborhoods. To exacerbate the situation the American army has been deploying Kurdish Peshmerga troops and Shiite militias in their attacks on Iraqi cities, lately in Tal Afar and Ramadi, killing Sunnis and destroying their houses in a manner designed to inflame ethnic hatred. The policy is to divide in order to conquer, and the ultimate plan is to partition Iraq into three warring three ethnic sections; Sunni, Shiite, and Kurdish. Such division entails civil war and ethnic cleansing on a massive scale to weaken any merging Iraqi government, so that it could not demand the withdrawal of the occupying forces. The division of the Yugoslav Federation in the 1990s into smaller weaker states has been taken as a model to slice Iraq. This plan falls perfectly within the Israeli strategic goal, proposed in 1982, of dividing Iraq, the strongest Arab nation, into three warring ethnic states. ...

World News Insights

Given the preceding focus on “false flag” operations in Iraq and Indonesia, we begin with an article describing such government-managed terrorism in the Philippines.

WAVING ‘FALSE FLAGS’

Alarm bells are being rung by Gloria’s security chiefs about a possible terrorist attack in Metro Manila, attributing the intention to the Indonesia-based Jemaah Islamiyah (JI). Meanwhile, the Bush administration ratchets up the agitation over the al-Qaeda to justify the campaign against JI. Last week, U.S. authorities alleged that JI and al-Qaeda are already in Mindanao and local PNP intelligence echoed the line that JI is training in Mindanao and several of its elements will be engaged in terror in Manila. Are these factual?

JI is an Indonesia-based religious movement, the Indonesians should know a little more about them than the rest of us. So I was very surprised to read late this week in one international news Web site, *Asia Times*, this item saying: “Indonesian President Susilo Bambang Yudhoyono has said he needs more proof to outlaw the al-Qaeda-linked Jemaah Islamiyah.” The Western writer, Bill Guerin, was skeptical of President Yudhoyono’s view and implies that Yudhoyono is fudging. Is Yodhoyono equivocating or is the JI-al-Qaeda link another Western “false flag” operation?

Bill Guerin says, “Maybe now, after more bombs in Bali, he’ll get the evidence he needs.” There is no proof, however, that the Bali bombings are by JI elements although reports attribute them to two Malaysian JI members. The fact is, Indonesians generally do not believe such reports, believing more that it is the handiwork of covert operations of those who want to destabilize and Balkanize Indonesia. The prosecution of JI leader Abu Bakr Bashir reflects this tug-of-war between the Western line and the Indonesians’ real sentiment about it.

Bashir has been blamed for the first and more devastating bombing in October 2002 in a Bali nightclub district, killing 200 persons, and another bomb near the United States consulate in Sanur, Bali. There’s been a bitter dispute over Bashir’s sentencing by the Indonesian courts. The West says his sentence is too light, but Indonesia recently reduced it even more. Bashir has always denied involvement and Indonesians continue to support him. Yet, international reporters such as Maria Ressa continue to insist the Western line about him.

Western sources have set as gospel that the JI is linked to al-Qaeda, allegedly of Osama bin Laden, which Indonesia doubts. A look at al-Qaeda in non-mainstream Western media also shows skepticism. On July 10, 2005, former British Foreign Secretary Robin Cook said “al-Qaeda” was the name of a U.S. intelligence database, implying that it had no reality. The *Guerrilla News Network* reports more: “phony (Mossad) al-Qaeda Cell in Palestine ...plus more documented examples of intelligence agents impersonating and setting up al-Qaeda cell groups strategically.”

There’s more: “Operation Northwoods”, a U.S. government plan to stage the assassination of civilians and blame it on communist Cuba to create justification for U.S. military intervention in Cuba, based on National Security Archive documents. The U.S. and Israel’s Mossad are not the only ones suspected of engaging in false-flag terrorism. The *GNN* reports FSB (former KGB) were behind Russia’s apartment bloc bombings in

September 1999, according to Boris Berezovsky, a former Kremlin insider who has since fallen out with the Putin government.

John Kaminski writes about American military in Iraq planting car bombs on unwitting Iraqi civilians and recently two British soldiers were caught allegedly posing as “terrorists” and shooting Iraqi civilians and intending to plant a car bomb. Like the authors of the *GNN* reports, I have only one intention in sharing these false-flag reports, “It is time to seriously share this vital information ... in hopes that an informed public might just refrain from rallying to the war cries of the weapons/military/industrial complex.”

The classic false-flag terror act was the Reichstag fire, the burning of the German parliament building in Berlin on Feb. 27, 1933, a month after Nazi leader Adolf Hitler became chancellor. The fire was used as a justification for the suspension of many constitutional guarantees and also as an excuse to attack the communists. Three Bulgarians and a German were all indicted and tried in Leipzig, Germany, but only a Dutch communist, Marinus van der Lubbe, was convicted. Their belief that has persisted the past 72-years is that the Nazis were involved and were the main beneficiaries.

In the Philippines, Gloria and her power mongers are waving the specter of false-flag terrorism and taking advantage of Bush’s “anti-terror” war, collaborating in spreading the false-flag panic to justify repression to solidify her tenuous hold on power. We should know by now that the F-I-D-E-L bombing in 2000 was really a series of false-flag bombings by GMA’s operators, targeting Estrada. These same elements are just waiting for the timing and order to commit the same gruesome crime—to justify some form of emergency rule.

Those unconvinced about the “clear and present” danger of false-flag terrorism should recall how effective it has been in justifying the removal of the elected President Estrada. Also, how 9/11 (with all the questions, such as the inexplicable non-scrambling of U.S. defense jets) opened the way to Bush’s Iraq War. PLAN FOR MILITARY TAKEOVER
OVERTAKEN BY EVENTS?

It might look that way now that the move for the reinstatement of Erap has formally begun. The opening salvo was made in last Friday’s Plaza Miranda rally. For the first time since the GMA Resign movement started, the battlecry has shifted from a demand for GMA to resign to a demand for the reinstallation of Erap.

There’s reason to expect that the rallies for Erap’s reinstallation will get bigger and increasingly clamorous in the weeks ahead. The reason for this is that GMA’s considerably diminished support is bound to take on accelerated momentum. This in turn means that the search for an alternative to her will take on a correspondingly accelerated momentum and at the moment there isn’t any plausible alternative other than Erap.

This writer has been long on record that he prefers

to see a junta of idealistic and nationalist junior officers take over temporary helm of government and the supreme moment for that event came on the day that the House of Representatives killed the impeachment complaints. Those who had shared this writer’s option for a nationalist Nasser-like military solution to the political and economic crisis in fact more than half-expected that the much talked about class of patriotic-nationalist junior officers would finally move immediately after the impeachment complaints were killed. After all they have been making noises of their existence and resolve for the last five years.

But no such takeover came and to many that’s proof enough the idealistic elements in the military on whom they had pinned their hopes and expectations for change simply don’t exist or, if they exist, have neither the capability nor the resolve to do what had been expected of them.

But this is perhaps all for the better. After all, a takeover of the government by the military isn’t a simple matter. A military government would at this time be confronted by a social crisis whose intensity and magnitude are without precedent in this nation’s history and unless those who stage the takeover have a thorough grasp of the essential nature of that crisis, they are bound to be devoured by it. And they can’t sidestep the problem by appointing civilian experts and non-military technicians to run the government for them because unless they, the military, understand the essential nature of the crisis, they are bound to appoint the wrong civilian experts and technicians for the job. And that can only make the mess created by GMA and her experts even messier, for which the military will of course have to take responsibility.

And so, if those in the military planning a takeover of the government aren’t sure that they can handle the problems of a government enveloped and overwhelmed by the social crisis, the better part of wisdom would be to simply reinstall Erap and let him handle the problem; and if he should bungle the job, then simply remove him. But that’s for the future and we don’t need at this moment to think that far ahead.

But to return to the title of this piece. With the formal launching of the move to reinstate Erap, any plan entertained by the military to take over and run the government has, to this writer, received a great setback. The public mood supportive of a military takeover of the government, which reached its height on the day that the impeachment complaints were killed, has been suddenly blunted by the demand for Erap’s reinstallation. With that cry, a clear, concrete and definite alternative to GMA has suddenly emerged, triggered by the U.S. Embassy report that Erap commands the highest popularity rating among all the alternatives and therefore is the most acceptable alternative to GMA.

Erap’s followers adroitly seized and pounded on the window of opportunity presented by that embassy report by staging a protest rally that replaced the cry for GMA’s ouster with the cry for Erap’s return.

Following the development in last Friday’s rally, military rebels, whether of the idealistic or opportunistic variety, will have to think twice, or perhaps more than twice, before daring a takeover of the government. Because if they do decide to take over and establish a military government, they will meet with a formidable civilian opposition made formidable by the fact that it now has, unlike before Friday’s Plaza Miranda rally, its own defined alternative and an alternative which no less than the U.S. Embassy has publicly pronounced to be the most acceptable alternative to GMA.

Which is another way of saying a military takeover of the government, if one had in fact been planned, should have been made before the release of the U.S. Embassy report and before Erap’s followers decided to come out openly with a demand for his reinstallation. ...

OIL PRICES AND RUSSIA’S RETURN TO SUPERPOWER STATUS

MOSCOW—International oil prices have scaled heights not seen in 25 years and there are many reasons to believe that they are here to stay.

Forecasting long-term oil prices is a hazardous exercise at best. In the past, geopolitical instability has wrecked the most carefully designed petroleum price projections. In the 1970s, the Arab-Israeli conflict sent crude prices soaring. Much closer to the present, the Iraq war and instability in the Greater Middle East, worker unrest in Nigeria and a confrontational Venezuelan leadership toward the United States have also strongly influenced how economists forecast future oil prices.

Dealing with geopolitical instability will always be part of the equation when making oil price projections, but there may be an issue in play today that makes the present and near-term very different from the past 25 years: a structural shift recasting the balance between supply and demand. For most of the last quarter century the unpredictability of supply drove oil prices; for the next quarter century the driver will be supply dynamics that could see the price stay higher for longer than it has before—and Russia the key player in this new arrangement.

Higher and sustained oil prices should be expected based on the combination of uncertainty about supply (geopolitical instability), projections of continued long-term strong demand from China and India with huge populations of more than one billion people apiece and experiencing robust growth, as well as the inevitable weakening of OPEC. Add to this the petroleum reserve growth has appeared to plateaued over recent years even as prices have soared and global inventories have consistently declined as a percentage of consumption, making petroleum a more volatile, and by implication more expensive, commodity.

What does this mean for Russia?

Assuming a sustained oil price regime of \$50 a barrel over the next decade, President Vladimir Putin’s aim of doubling the country’s GDP by 2012, considered by most Russia watchers and economists in 2002 (when the target was announced) as delusional, would not be possible—but will actually occur a year later. During the next decade, Russia’s average monthly income would rise from the current \$300 to \$1,386, bolstering strong support for the current consumption boom; the country’s nominal dollar-based GDP would be \$2.8 trillion (this year’s figure is expected at \$743 billion), surpassing Spain’s; and Russia’s per capita GDP would be \$20,073, chasing Portugal’s \$25,658.

Trade and budget numbers look just as attractive at \$50 a barrel. Revenue from crude oil and gas exports (price-wise closely tied to crude prices, but not in terms of demand) would total to almost \$200 billion in 2015 for oil and gas exports of \$343 billion. For this year, Russia is forecast to export about \$123 billion worth of oil and gas for total exports of \$230 billion. At the same time, Russia would continue to sustain a robust fiscal surplus and the stabilization fund is projected to hold \$557 billion in 2015, an increase from 2005 estimate of \$48 billion.

The international investment house major Goldman Sachs has upgraded its long-term oil price from \$45 a barrel to \$60 a barrel and the highly respected

International Bank Credit Analyst publication now estimates the price of crude will average \$50 a barrel over the next five years. Other industry sources have even suggested the sky-high price at \$100 a barrel.

While \$100 a barrel appears to be over the top as forecast, changes in the world’s geopolitics and structural changes in related to petroleum demand are not. Under a regime of \$100 a barrel, the world appears to be a very different place, particularly for Russia.

Putin’s aim of doubling GDP by 2012 would be achieved in 2011. Russians would be recognized as being among the world’s great consumers with disposable an income for new all kinds of products, including cars, mobile phones, computers and other big-ticket items. At \$100 a barrel, the average monthly income of the average Russia would increase from \$300 in 2005 to \$2,270 in 2015. Russia’s dollar-denominated per capita GDP would be \$33,061 and its nominal dollar-denominated GDP ahead of the UK and Germany.

At \$100 a barrel, export revenue from crude oil and gas would be in the area of \$400 billion in 2015 and totaling all exports at \$570 billion. The total fiscal budget surplus would be projected at an average 7.4% of GDP 2006—2015, and the stabilization fund could conceivably accumulate a breathtaking \$1.5 trillion by 2015.

The figures mentioned above are impressive, if not simply amazing. There are many issues related to government policy directives, inflation, taxes on mineral tax resources, and currency appreciation, use of the stabilization fund, and balance of trade that could dent the above numbers to one degree or another. Nonetheless, Russia’s key role in global demand of petroleum products cannot be ignored.

Like it or not, Russia is on the path of reconstituting the power and influence of the former Soviet Union in world affairs. There is an important difference though—Russia will regain this influence and power under 21st century terms: instead of a threatening conventional military and nuclear arsenal, it will take advantage of its vast oil and gas resources to regain its international prominence. Clearly a \$100 barrel a dollar oil regime is not immediately in the cards, but it does demand the world to take pause. Even the conventional wisdom of a \$50 a barrel should be a wake up call.

This notice will be construed as a continuation of compliance with provisions necessary to establish presumed fact (Rule 301, Federal Rules of Civil Procedure, and attending State rules). If all interested parties fail to rebut any given allegation or matter of law addressed herein, the position will be construed as adequate to requirements of judicial notice, thus preserving fundamental law. A true and correct copy of this Public Notice is on file with and available for inspection at the newspaper CONTACT (P.O. Box 27800 Las Vegas, NV 89126, USA) which is responsible for publishing the instrument as a legal notice. In the Republic of the Philippines, comments and objections may be filed in writing by addressing Global Alliance Investment Association at 6751 Ayala Avenue, Makati City, Metro Manila, Philippines. Others may be addressed to Global Alliance Investment Association, 3132 West Post Road, Las Vegas, Nevada, 89118 USA.

The purpose of this Public Notice is to clarify an issue that has been used for more than three years to delay the litigation of the Motion for Annulment of Judgment filed April 9, 2002 by the government's Solicitor General and numbered CA G.R. SP. NO. 70014 in the Court of Appeals. It is in the interest of GAIA to bring this matter to the attention of the public since it impedes the use of the 400,000 metric tons of gold leased by the government, which lease has now expired, making the gold available for the GAIA Program worldwide. The value of the gold at current prices is approximately five trillion dollars, an amount that could greatly alleviate poverty in Southeast Asia.

One of the ploys used by the government was to declare the person appearing in court an "imposter" and not the "real" Julian Morden Tallano, the Court Appointed Administrator of the Tallano-Acop estate. It has required more than one year for the National Bureau of Investigation to decide: "Agent-on-case concluded that based on the above-findings, Subject JULIAN MORDEN TALLANO, the intervenor in the case of Republic of the Philippines vs. Regional Trial Court, Pasay City, Branch 111, et al., and Prince JULIAN MORDEN TALLANO, the alleged Real Party-in-interest in the above case, are one and the same person."

In his Clarificatory Order of January 19, 1976, Judge Enrique A. Agana clarified that a false or fictitious person allegedly represented by attorneys but not appearing in person was attempting to usurp the position and property of Acop by using the name Acopiado and bribing someone in the Court to change the name on his Decision dated November 4, 1975. The above report of the NBI contains the following comment: "As to the identity of

ANACLETO MADRIGAL ACOPIADO, the only available evidence to establish his alleged existence is the altered Death Certificate issued by the Local Civil Registrar of Taguig, Metro Manila on 28 November 1994."

Subsequent to filing its Motion for Annulment of Judgment April 9, 2002 the Solicitor General obtained a Temporary Restraining Order (TRO) to stop the Estate from doing any further business. The TRO expired on June 6, 2002 and GAIA entered into a Letter of Intent (LOI) with Tallano June 7, 2002. To preserve the ability to conduct business for the Estate/Foundation in a different venue, GAIA formed the FOUNDATION FOR THE TALLANO ESTATE, INC. in Nevada June 17, 2002 and subsequently formed the DON ESTEBAN BENITEZ TALLANO & DON GREGORIO MADRIGAL ACOP FOUNDATION, INC. in Nevada July 29, 2003. With the participation of the Court Appointed Administrator, Prince Julian Morden Tallano and Founding Trustee, Cenon C. Marcos, the DON ESTEBAN BENITEZ TALLANO & DON GREGORIO MADRIGAL ACOP FOUNDATION, INC. was also formed in the Philippines October 14, 2003 to administer that 50% portion of the assets of the Royal Family for the benefit of the Filipino PEOPLE.

Although the Foundation was ordered to be set up by Judge Agana in 1976, the Order was not obeyed by the Administrator until the necessary funds were furnished by GAIA. Since ALL of the funds to support the Foundation were furnished by GAIA, even to hiring and paying the necessary consultants and attorneys, GAIA has insisted upon the exclusive control of the statutory 40% of the assets and has met with no objection. The Court Appointed Administrator has frequently offered and paid "commissions" as much as 70% of the funds received for sale of properties, which establishes a precedent far above the requirement of GAIA.

In the Letter of Intent of June 7, 2002 GAIA committed to assist in the recovery of fines, penalties and Royalties due the Royal Family, real properties, and the gold leased to the government in 1949. On June 25, 2002 the Court of Appeals issued a Writ of Preliminary Injunction, ostensibly to "maintain the status quo" and "enjoining respondents from enforcing the Orders dated July 7, 1997, July 11, 2001, and October 8, 2001 in Civil Case No. 3957-P and from conducting further proceedings in said case." Since those listed cases were land-related and contained no reference to the Royalties, fines, penalties, or gold, it is presumed that there are no impediments to terminating the lease and proceeding with the inventory of the assets of the Estate/Foundation as required by law.

Sworn testimony was recorded in the court of Judge Agana in 1972 of the fact that Fr. Diaz (aka Colonel Santa Romana) and Tallanos had just conducted an inventory of the 617,500 tons of gold leased to the Central Bank and had found only 400,000 metric tons to be there. Other documents have been located that confirm that President Quirino leased the gold for the government in 1949 as the reserve for the Philippine money supply. These are documented facts, not fictitious stories concocted by creative con-men.

In an unconfirmed (yet) related story, the two presidents, Ferdinand Marcos and Ronald Reagan, created a plan to leave as their legacy to the world a gold-based money they named Ang Bagong Lipunan (ABL) and President Marcos shipped thousands of tons of gold to other nations to serve as their reserves or gold base. When the shipments were completed and a signal given, all of those nations would shift to the new currency which they could then use in international trade as well as domestically.

In the case of the backing of the ABL, it is clear that the gold came from that being leased by the Republic of the Philippines from the Estate/Foundation, the ownership of which has now reverted to the Estate/Foundation at the expiration of the lease. Although not sufficiently yet documented, there is evidence that 217,500 metric tons was transported to the U.S., which gold would be subject to the claim of GAIA pursuant to the debt of the US Treasury to GAIA that is expressly payable in gold. Regardless of where it may be located, it is likely that much of the gold in the world is or could be subject to a legal and legitimate lien by the Joint Venture Partnership created by GAIA and the Foundation.

In the case of "natural" or "treasure" gold located in the Philippines or its territorial waters, the Land Title OCT No. T-01-4 gives ownership of most of the land and sea area of the archipelago to the Royal Family since 1764. As a percentage of the total land area, the so-called "public" lands are very small, being restricted to those lands occupied by government buildings and facilities and only during occupation by those facilities, reverting to Estate/Foundation stewardship for "The Royal Family" when no longer so occupied. Thus, mining and treasure hunting will come under the management of the Estate/Foundation at the proper time.

"The Royal Family" (of the Philippines) consists of all of those persons that might trace their ancestry to King Luisong Tagean (who died in 1764) and/or to his ancestors, which should include virtually all Filipinos. It is important that Filipinos understand that the Estate/Foundation does not claim

"ownership" of these assets (the land, gold, minerals and other natural resources); it acts as the Trustee or STEWARD of these assets for the benefit of the Royal Family, i.e., all Filipinos, and deserves their support and participation in the development of the nation. As such, it can, and should, act to accomplish objectives privately that are normally expected of governments.

Among its objectives should be the establishment of a bank to monetize its gold and the retirement of the national debt thru the purchase of the government interest in all of the public utility, transportation, and infrastructure corporations and projects. This alone will initiate so much economic activity that everyone that wants to work and earn can have a good-paying job to quickly eliminate poverty and its companion, hunger.

Do It Right And Do It For LESS

Budget’s “Tip of the Week” #1:

NRS 78.105—Maintenance of Records at the Registered Office

According to NRS 78.105 (restated, emphasis added): A corporation has a responsibility to maintain certain corporate records at its registered office *for inspection by stockholders*, including a State-certified copy of its Articles of Incorporation, a copy of the Bylaws and the stock ledger (or a statement naming the ledger’s custodian, including the address at which the ledger is kept).

It is hard to see why such records should be maintained in any case where no stock has been issued, as the expressed intent of NRS 78.105 appears to be to ensure that **stockholders** should have access to these corporate records. Of course, a court order may compel production of the corporate records and in that event, failure to produce them within a “reasonable” time could result in State penalties of \$25 per day for each day of refusal. In such an instance you would have up to five days to produce the records, which, of course, would be in perfect order.

If you choose to leave such records on file at the registered office of the corporation, you might want to take an extra measure of caution regarding privacy of those records and insist upon a **non-disclosure agreement** with the resident agent. Such an agreement should prevent the resident agent from casually identifying you with the corporation and from sharing the corporation’s filed records with anyone other than the corporation’s stockholders. (Otherwise, those records are potentially accessible by anyone making an inquiry.) And hopefully such an agreement would give the resident agent pause to consider additional security against those who might “snoop around”.

Here is one more thing you can do to protect your privacy: Contact your resident agent and ensure that there are NO documents on file that connect YOUR NAME to the corporation. Have the resident agent expunge and shred any old memos, order forms and any other such information that could adversely impact your desire for privacy.

The next “Tip of the Week” will discuss Nevada’s statutory sanctions against anyone who would even *attempt* to access the corporation’s records for purposes contrary to those of its stockholders.

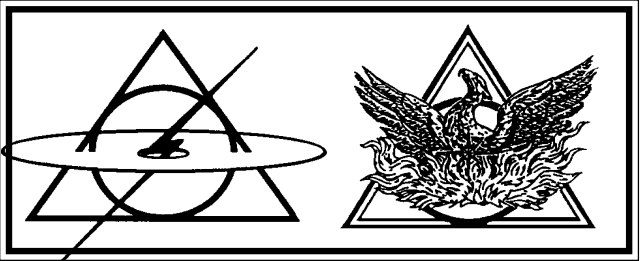

Soul is attached “to” not “integrated with” any manifest physical body on any dimension. That is the very meaning of SOUL. When you get serious about who and what YOU ARE, you just might find some interesting things happening to, specifically, YOU.
