Three New Hampshire communities are making plans to give out a single blast of flu shots—5,000 in one day—as part of a drill to prepare for a widespread epidemic. The effort is being undertaken to test the state's ability to render emergency mass inoculations as the threat of avian flu unfolds. The drill will test the ability of health officials to issue mass vaccinations, the capacity of the state health laboratory, surge capacity of hospitals, internal operations at the state level, and judicial issues involving quarantine and isolation, officials said.

New Hampshire will be the first state in the country to undertake such a drill, he said. The U.S. Department of Homeland Security is paying for the flu shots, and an outside firm will monitor the drill and report on it. Logistics, crowd control and traffic problems will be tested, Portsmouth officials said at a news conference yesterday. Fifty hospital staffers will be on hand for the practice session, in addition to numerous volunteers.

"Most hospitals around the country are at close to capacity right now," said Dr. Don Albertson at Portsmouth Regional Hospital. "The reality is, with a larger number of people that would come with a disaster, we have to learn to think out of the box."

[See also the Associated Press article of October 28, 2005 entitled "Exxon-Mobile employees Got Fake Flu Shots". The story says that approximately 1,000 employees at a health exposition were injected with something that was "definitely not the flu vaccine" by an unidentified doctor in what was termed "the first use of an outside contractor" instead of company medical staff. Make no mistake: The plans for dealing with this next crisis are well advanced and being tested already.]

> Keating runs the U.S. Northern Command based in Colorado Springs, which provided the military response to Katrina. He told a homeland defense conference in the Springs that the proposal calls for the president to give clear command-andcontrol to the active-duty military in responding to the most devastating catastrophes.

The new plan, which the Food and Drug Administration had begun to implement over the past six months, called for companies to conduct studies for as long as half a year before seeking approval of new drugs. Like many other medications, psychiatric drugs are typically approved on the basis of positive results from two short-term studies, each of which may last only eight weeks.

Beta was the 23rd named tropical cyclone of the unrelenting and record-breaking Atlantic-Caribbean hurricane season. No. 22, named Alpha, broke the record for the number of storms set in 1933 and made 2005 the most active hurricane season since records began 150 years ago. Weather forecasters switched to the Greek alphabet for storm names after using up their annual list of 21 names for the season with Wilma, which was at one point the most intense hurricane ever recorded in the Atlantic basin.

To the exactitudes of the United States being able to technologically manipulate hurricanes has long been suspected as the technologies for achieving such goals is attainable, and to which one American dissident group has reported on, and as we can read as reported by the <CuttingEdge.Org> News Site in their article titled "A Terrifying Look at the Control of Weather Warfare: A Look at HAARP" and which says:

In a nutshell, this is the nucleus of the expertise just recently acquired to control the weather. By pouring measured energy that has been focused into certain parts of the ionosphere, scientists can create all kinds of storms like hurricanes, thunderstorms, floods, tornadoes and drought. In NEWS1198, "U.N. Treaty Proves Weather Control Is Real", we report news articles that Malaysia actually contracted with a Russian Weather Modification company to create a hurricane that would be directed close enough to clear the smoke and smog from Malaysia's cities without actually coming on to land to create devastation. This Russian company delivered, and Malaysia had clear skies.

Our information also tells us that, not only can

hurricanes be created, they can be dismantled should scientists so desire. And, they certainly can be driven on the ocean much like we drive our cars on roadways. Therefore, one has to ask why American scientists have allowed unprecedented hurricanes, like Andrew, to ever come on shore. Why are American scientists allowing extensive damage and lives lost to recent unprecedented storms, since they have the capability to keep these storms away from us?

To the United States' current confrontation with Mexico we can read as reported by the *Knight Ridder* News Service in their article titled "U.S. aid threatened by global court pact" and which says:

Mexico's declared intent to join the International Criminal Court is setting up a potentially critical showdown with the Bush administration, which refuses to subject U.S. personnel to the ICC's powers.

Washington has informed Mexico that joining the ICC would lead to the cut of an \$11.5 million program to help its justice system deal with drug trafficking, according to human rights groups that support the Dutch-based court, designed as the prime venue for trying war crimes. That amounts to almost 40 percent of the U.S. economic aid Mexico receives.

Mexico could avoid the loss if it signs an immunity agreement with Washington, but has so far refused to do so. Widely known as an Article 98 agreement, such a deal bars a country from handing U.S. nationals to the ICC without U.S. permission. Mexico is hardly alone. Washington already has cut aid to 11 Latin American nations for refusing to sign the immunity agreements, making it the region of the world hardest hit by ICC-related sanctions.

But Mexico's ratification of the court is being monitored especially closely by human rights groups and members of Congress because the country is so critical to Washington's strategic interests. It ranks as the second biggest U.S. trading partner and the biggest entry point for illegal migrants and cocaine. A growing number of U.S. defense and congressional officials fear such a move will cost Washington influence in a region already vulnerable to political instability and are pushing President Bush to issue a first-ever waiver of the sanctions.

Human rights activists say most nations probably would agree to Article 98 deals if they covered only U.S. military personnel, but reject the broader pacts the State Department is pushing to cover all U.S. citizens and even third-country foreign contractors working for the U.S. government. "We respect the right of other nations to become parties to the Rome Statute, but ask other countries (to) respect our right not to do so," said a State Department official who asked for anonymity in keeping with department rules.

So far, 101 nations have inked such deals, including Colombia and the Dominican Republic. But other Latin Americans have responded angrily to the U.S. pressures. Costa Rican Foreign Minister Roberto Tovar last month called the U.S. immunity proposals "offensive" [LITERALLY, in the case of guided storms] and added: "One can be poor, but dignified."

Following Mexico's refusal to bow to the pressure being exerted upon them by the United States Military Leaders there 'appeared' this most strangest of Hurricanes, Wilma, and which became the strongest such storm to ever form in the Atlantic and Caribbean Regions and intensified at a rate never before seen by research scientists and defied all normal behaviors of storms of its type ...

In an even greater humiliation to the Mexican Nation by the U.S. Military Leaders has been the United States' refusal to assist with the humanitarian evacuation of thousands of mostly American tourists, and even though Mexico was one of the first countries to rush aid to America after Katrina had struck, and as we can read as reported by the *Associated Press* News Service in their article titled "Tourists frantic to leave Cancun" and which says:

Thousands of desperate tourists stranded by Hurricane Wilma besieged airports and tour offices Wednesday as officials faced the challenge of evacuating 22,000 visitors with only 6,000 airline seats available out of Cancun. Though most of the flooding had receded and electricity was slowly returning, frustrated tourists who had gone nearly a week without showering said they could relate to those who survived Hurricane Katrina.

"Now I know how those people in New Orleans felt," said Angela Benites, 48, Mexico City. "Several days of desperation is no way to live." As Cancun's half-million people struggled to clean up their flooded and wind-smashed homes and workplaces, crowds of tourists surrounded airline offices. Some wept for joy when told they could leave.

To the question of if these latest events will be changing the position of the Mexican Government it is not to our knowing. What is to our knowing though is the United States Military Leaders continuing plan to fend off the growing power of China in their South America Regions by the planned invasion of many of that Region's sovereign nations, one of which, Bolivia, has reported yet another outrage by American Military Forces' destruction of their air-defense capability, and as we can read as reported by the *Prensa Latina* News Service in their article titled "Doubts Persist on Removal of Missiles from Bolivia" and which says:

[Bolivian] Military experts, who asked not to be identified, denied Gen. Marcelo Antezana's assertion that the missiles were obsolete, and maintain that the weapons are similar to those used in present conflicts, including by U.S. forces in Iraq and Afghanistan, and were the only ones of this type to defend Bolivian airspace.

Presidential candidate Evo Morales, of MAS (*Movimiento al Socialismo*), Evo Morales, declared he had been informed by patriotic soldiers about the removal of the missiles by air to the United States on October 2, in what he denounces was an illegal operation with U.S. troops in violation of national sovereignty and dignity. The missiles were supplied by the People's Republic of China in 1993, with other materiel at a cost of four-and-a-half billion dollars, which still has not been paid.

MAS has demanded clarification of the case from Defense Minister Gonzalo Mendez, who met Wednesday with Antezana and President Eduardo Rodriguez before the general's press conference. Morales declared this could result in an eventual treason trial against the president in his condition as Captain General of the Armed Forces, whose approval should have been necessary for withdrawing the missiles.

Evo Morales said the operation directed by the U.S. Embassy is a provocation and threat against MAS, which leads the polls for the December

elections. Bolivia's major union (COB) leader, Jaime Solares, went further, warning of the danger of a military coup to prevent progress of social forces. A few days ago news commentator Amalia Pando revealed premature changes in army units and staffing, which she said was worrying given the serious national-political situation.

Long has it been known that the United States' preferred plan for South American nations not bowing down to them has been to use the tactics of assassination of popularly elected leaders and the installation of puppet dictatorial regimes [see the John *Perkins book*, Confessions of an Economic Hitman], but to which the nation of Venezuela has stopped with the help of both Russian and Chinese Intelligence sources, even to the capturing of American-backed Columbian rebels, and as we can read as reported by the United Press International News Service in their article titled "Venezuela sentences Colombian conspirators" and which says:

Venezuela has sentenced 27 Colombians to six years in prison for conspiring to overthrow the Venezuelan government, El Nacional reported Wednesday. More than 100 Colombians were arrested last year at a farm outside Caracas, where they maintained they were there to work. However once they got there, the defendants claimed, they were forced to take part in an anti-Chavez plot. The Venezuelan leader has repeatedly accused the United States of trying to usurp his authority by aiding ant-Chavez opposition groups. The White House has denied the accusation.

As events from the United States show their peoples' attention once again riveted to those events inside of their country, they remain not knowing, or even not caring, about the most important events critical to their future. For as history has often shown to those who see, a brutal Fascist Military Regime such as exists in the United States is never more dangerous, to the world or its own people, than when it is wounded. And today the Military Leaders of the United States are indeed wounded, who knows where they will strike next?

In an October 19, 2005 article entitled "Massive Underwater Landslide Reported off California Coast as Volcanic Activity Increases in American Northwest, World's Oceans Continue Heating at Record Pace and Methane Level Rise Continues Unabated", Sorcha Faal reminds us to pay attention to Mother Earth's birthing pains. May we all do what we can to mitigate the intensity of the "contractions", for Mother SHALL have relief.

Russian Scientists are expressing concern today over reports from North America showing that the island regions off the California coastline have experienced a massive underwater landslide due to volcanic pressures increasing in this plate-boundary region, and was so powerful that it registered as a moderate earthquake, and as we can read as reported by the Associated Press News Service in their article titled "Temblor Hits off San Diego

Coast" and which says:

An earthquake has struck off the Southern California coast more than 70 miles off the coast of San Diego. An underwater earthquake struck off the Southern California coast on Sunday more than 70 miles off the coast, according to the U.S. Geological Survey and the California Institute of Technology. The 4.9 magnitude temblor was centered about 17 miles southeast of San Clemente Island and 74 miles west of San Diego, according to the agencies' preliminary report. It hit at 2:11 p.m. PDT.

Volcanic forces in this California Region have also continued this week, and as we can read as reported by the Washington Post News Service in their article titled "Second Quake Rattles Palm Springs Area" and which says:

A light earthquake rattled the desert around Palm Springs early Tuesday just hours after a smaller temblor hit the area, authorities said. There were no reports of damage from either quake, police said. The 4.4 magnitude quake struck at 12:31 a.m. PDT about 19 miles northwest of Palm Springs, according to the seismology lab at the California Institute of Technology. The rolling quake lasted about 30 seconds, said Sgt. Dan Rose of the Palm Springs Police Department. A 4.0 magnitude quake occurred at 9:08 p.m. Monday in the same location, according to CalTech.

But to the greatest danger, and according to these reports, facing the North American Continent remains their Northwest Regions, where American Scientists are becoming increasingly alarmed over their Oregon Region, and as we can read as reported by the Los Angeles Times News Service in their article titled "Geologists say 'bulge' may turn into volcano: 100 square miles of Oregon terrain rising 1.4 inches each year" and which says:

Half an hour west of this mountain town in central Oregon, in an area covered by forest, is a growing bulge in the terrain that scientists say could be the beginnings of a volcano. The bulge covers 100 square miles and is rising at a rate of 1.4 inches a year. The shape resembles a dome, with the highest point about three miles west of the South Sister volcano in the Cascades.

[At this point, repeating the contents of prior advisories, Sorcha Faal reminds us of the thousands of small earthquakes experienced just last month in the Cascade Mountains; the many reports of smelly 'outgassing' experienced at numerous locations around the North American tectonic plate and the tens of thousands of small quakes registered in the New Madrid fault zone recently. Due to space constraints and to avoid repetition we will not detail these phenomena again at this time.] ...

While Russian Scientists, and Government Officials, have been preparing for more catastrophic earth upheavals, Western Scientists continue their changes to our world occurring now on an almost daily basis, and as we can read as reported by Australia's Mail & Guardian News Service in their article titled "Scientists to search for greenhouse evidence" and which says:

An Australian scientific team set off for Antarctica on Tuesday to search for definitive

proof in the polar ice cap that human activity is responsible for rising levels of greenhouse gases. The team from the Australian Nuclear Science and Technology Organisation will drill 250m below the surface to obtain cylinders of ice containing trapped bubbles of methane dating back to 1750. Expedition leader Andrew Smith said while there was no doubt that levels of methane were rising, there was considerable debate over whether the increase was naturally occurring or linked to human activities that have taken place since the industrial revolution.

These actions by Western Scientists also stand in contradiction to their own scientific studies, and which also accurately describe the underwater landslide that occurred off of California's coastline and as we can read as evidenced by the United States Geological Survey Marine and Coastal Geology Program's report titled "Gas (Methane) Hydrates—A New Frontier" and which states:

USGS investigations indicate that gas hydrates may cause landslides on the continental slope. Seafloor slopes of 5 degrees and less should be stable on the Atlantic continental margin, yet many landslide scars are present. The depth of the top of these scars is near the top of the hydrate zone, and seismic profiles indicate less hydrate in the sediment beneath slide scars. Evidence available suggests a link between hydrate instability and occurrence of landslides on the continental margin. A likely mechanism for initiation of landsliding involves a breakdown of hydrates at the base of the hydrate layer.

The effect would be a change from a semicemented zone to one that is gas-charged and has little strength, thus facilitating sliding. The cause of the breakdown might be a reduction in pressure on the hydrates due to a sea-level drop, such as occurred during glacial periods when ocean water became isolated on land in great ice sheets. Methane, a "greenhouse" gas, is 10 times more effective than carbon dioxide in causing climate warming.

Methane bound in hydrates amounts to approximately 3,000 times the volume of methane in the atmosphere. There is insufficient information to judge what geological processes might most affect the stability of hydrates in sediments and the possible release of methane into the atmosphere. Methane released as a result of landslides caused by a sea-level fall would warm the Earth, as would methane released from gas hydrates in Arctic sediments as they become warmed during a sea-level rise. A British banker who has lived in the U.S. since 1978, Mr. Bennett has been released on bail of \$50m secured on a house in New Jersey, a Park Avenue penthouse apartment, \$5m in cash and funds raised by six co-signers of the bail bond.

The implications of the 15-day trading moratorium on the company's Refco Capital Markets subsidiary may be felt across the world financial system, depending upon the size of the funds caught up inside Refco and the types of institutions which are unable to remove their money from the operation.

101 Arch St. is a multi-tenant, class A, high rise, 21-story, 389,000 square foot (36,000 m²) office building located in the Boston financial district that houses a number of law firms, though there was no visual indication of Brewster Jennings being centered there. "All it was, a telephone and a post office box," a former intelligence official was quoted as saying, although the company was listed in an online database of law firms. Intended to infiltrate ties between groups involved in smuggling nuclear weapons, it was apparently named after the late Brewster Jennings, who served as president of a predecessor company to Exxon Mobil Corporation.

> Total collapse of well-constructed buildings is not as likely as is falling debris shaken loose within the units themselves. In schools, however you find that you are dealing with, usually, single story buildings with some having two floors. SURVIVING AN EARTHQUAKE

My name is Doug Copp. I am the Rescue Chief locations of Manila, Makati and places where and Disaster Manager of the American Rescue Team existed next to my brother's motorcycle. I was the United Nations expert in Disaster Mitigation (UNXO51-UNIENET) for two years. I have worked for simultaneous disasters.

> In 1996 we made a film, which proved my survival methodology to be correct. The Turkish Federal Government, City of Istanbul, University of film this practical scientific test. We collapsed a school and a home with 20 mannequins inside.

> mannequins I used in my "triangle of life" survival method. After the simulated earthquake collapse we crawled through the rubble and entered the building to film and document the results.

> The film, in which I practiced my survival techniques under directly observable, scientific conditions, relevant to building collapse, showed there would have been zero percent survival for those doing duck and cover. There would likely have been 100 percent survivability for people using my method of the "Triangle of Life". Millions of viewers on television in Turkey and the rest of Europe have seen this film, and it was seen in the USA, Canada and Latin America on the TV program Real TV.

The first building I ever crawled inside of was a

school in Mexico City during the 1985 earthquake. Every child was under its desk. Every child was crushed to the thickness of its bone. They could have survived by lying down NEXT TO THEIR DESKS IN THE ISLES. It was obscene and unnecessary, and I wondered why the children were not in the aisles. I didn't at the time know that the children were told to hide under something.

Simply stated, when buildings collapse, the weight of the ceiling falling upon the objects or furniture inside crushes these objects, leaving a space or void next to them. This space is what I call the "triangle of life." The larger the object, the stronger, the less it will compact. The less the object compacts, the larger the void; the greater the probability that the person who is using this void for safety will not be injured. The next time you watch collapsed buildings on television, count the "triangles" you see formed. They are everywhere. It is the most common shape, you will see, in a collapsed building. They are everywhere.

I trained the Fire Department of Trujillo (population Tuscany 750,000) in how to survive, take care of their families, and to rescue others in earthquakes.

The chief of rescue in the Trujillo Fire Department me everywhere. He gave personal testimony: "My name is Roberto Rosales. I am Chief of Rescue in Trujillo. When I was 11 years old, I was trapped inside of a collapsed building. My entrapment occurred during the earthquake of 1972 that killed 70,000 people. I survived in the "triangle of life" that who got under the bed and under desks were crushed to death (he gives more details, names, addresses, etc.). I am the living example of the "triangle of life". I have crawled inside 875 collapsed buildings, My dead friends are the example of "duck and cover".

TIPS FROM DOUG COPP:

- 1. Everyone who simply "ducks and covers" WHEN BUILDINGS COLLAPSE is crushed to death—every time, without exception. People who get under objects, like desks or cars, ARE ALWAYS CRUSHED.
- 2. Cats, dogs, and babies all naturally often curl Istanbul, Case Productions and ARTI cooperated to up in the fetal position. You should, too, in an earthquake. It is a natural safety/survival instinct.

You can survive in a smaller void. Get next to an Ten mannequins did "duck and cover" and ten object, next to a sofa, next to a large bulky object that will compress slightly but leave a void next to it.

- 3. Wooden buildings are the safest type of construction to be in during an earthquake. The reason is simple: the wood is flexible and moves with the force of the earthquake. If the wooden building does collapse, large survival voids are created. Also, the wooden building has less concentrated, crushing weight. Brick buildings will break into individual bricks. Bricks will cause many injuries but less squashed bodies than concrete slabs.
- 4. If you are in bed during the night and an earthquake occurs, simply roll off the bed. A large void will exist around the bed. Hotels can achieve a much greater survival rate in earthquakes simply by posting a sign on the back of the bottom of the bed

during an earthquake. [Yes, we are still carefully quoting.]

- 5. If an earthquake happens while you are watching television and you cannot easily escape by getting out the door or window, then lie down and curl up in the fetal position next to a sofa, or large chair.
- 6. Everybody who gets under a doorway when buildings collapse is killed. Why? If you stand under a doorway and the doorjamb falls forward or backward you will be crushed by the ceiling above. If the door jam falls sideways you will be cut in half by the doorway. In either case, you will be killed.
- 7. Never go to the stairs. The stairs have a different "moment of frequency" (they swing separately from the main part of the building). The stairs and remainder of the building continuously bump into each other until structural failure of the stairs takes place. The people who get on the stairs before they fall are chopped up by the stair treads. They are horribly mutilated. Even if the building doesn't collapse, stay away from the stairs. The stairs are a likely part of the building to be damaged. Even if the stairs are not screaming, fleeing people. They should the building is not damaged.

[H: THIS IS NOT TRUE IN TORNADO OR HURRICANE DISASTERS BECAUSE THE INNER CENTER STAIRS ARE THE BEST PLACE ABOVE GROUND PROTECTION IN SUCH STORMS. IN SUCH STORMS YOU NEED AS MUCH SPACE, WALLS AND DISTANCE FROM FLYING WINDOW-GLASS AS IS POSSIBLE. IT IS ALSO WHERE THE STRUCTURE HAS THE MOST SUPPORT IN ALMOST ALL INSTANCES.]

- 8. Get Near the Outer Walls of Building or Outside of Them if Possible: It is much better to be near the outside of the building rather than the interior. of the building the greater the probability that your escape route will be blocked. [Use your head, though, in case the shaking causes the walls and "sidings" to topple "off".]
- 9. If anecdotal evidence is to be believed, the DNC could take in \$5 to \$30 million (up to 75 percent more Jewish rich are the full partners of their Christian than Jews have given in previous election cycles) above its anticipated fund-raising goal of at least \$130 million. An additional \$30 million would equal almost the entire sum the Democrats spent on advertising this summer [of the year 2000].

In a tight race where Republicans enjoy a slight financial edge, extra Democratic money could make a difference, probably more of a difference than even the most dramatic swing by Jewish voters

Potentially more significant is the way the Connecticut senator's selection is turning fund-raisers for Jewish causes into fund-raisers for Gore-Lieberman ... Will the Jewish community's remarkable financial effort on the Democratic ticket's behalf make a difference? Not, it hardly needs saying, in the way Pat Buchanan might imagine.

Gore and Lieberman's Jewish donors are not trying to make the ticket beholden to "Jewish interests", whatever those are. They disagree among themselves on many questions of policy, and their support is more an act of communal pride than an investment in future behavior. But the donations could affect the election nonetheless.

And so, in an odd historical footnote, the most important electoral effect of Joe Lieberman's selection may remain largely hidden from a public that seems otherwise obsessed with his candidacy's every detail.

KEEPING JEWISH AFFLUENCE A SECRET

Max Geltman, a reactionary identified with the National Review, revealed in his book, The Confrontation, that: "It's by now an open secret that in 1957 the American Jewish Committee interceded with the Bureau of the Census in Washington and besought it not to ask questions about income related to national groupings in the 1960 census, for fear that the comparatively high income levels of the Jewish minority would lead to anti-Semitic outrages. The Bureau complied."

If [the Jews] are 2.54 percent of the population, they take in approximately 5 percent of the national income. Jews are almost 7 percent of the country's middle and upper classes, taken together. In 1972, almost 900,000 Jewish families out of two million were middle and upper class, while only 13.5 million out of 53 million American families were so classified. According to [Gerald Krefetz, writing in Jews and Money], 43 percent of all Jews earned \$16,000 plus, in contrast to only 25.5 percent of all Americans.

VOTING POWER NEARLY TWICE THE NUMBERS

Jews are 10.6 percent of New York State's population. They are 5.9 percent of New Jersey with 100,000 in Bergen County and another 95,000 in Essex County. Jews are 4.8 percent of the District of Columbia. They are 4.7 percent of Florida, with 225,000 in Miami alone. They are 4.6 percent of Maryland with 100,000 in Montgomery and Prince Georges County and 92,000 in Baltimore, 4.3 percent of Massachusetts with 170,000 Jews in Boston.

there are 500,870 Jews in the Los Angeles area and 75,000 Jews are roughly 10 percent of San Francisco. There are 295,000 Jews in metropolitan Philadelphia and 253,000 in greater Chicago.

As the Jews are the most educated stratum of the electorate, they vote in greater proportions than any other ethnic or religious grouping. Ninety-two percent of all Jews vote in national elections compared to only 54 percent of the people as a whole. Jews may only be 10.6 percent of New York State, but they are between 16 percent and 20 percent of the voters.

More important, they were 30 percent of the voters in the April 1984 New York State Democratic primary, when they made up an estimated 41 percent of Mondale's vote. They are customarily nearly 50 percent of the Democratic primary voters in mayoral

JEWS 'MAGNIFY THEIR VOTING POWER'

Although Jews are a small minority, they exercise their right to vote and thus magnify their voting power. About 80 percent of eligible Jews in the United States are registered to vote, compared to about 50 percent of all voting-age adults. In addition, registered Jews are twice as likely to vote. Combining the two multiplies Jewish voting power by a factor of three. Furthermore, 81 percent of Jews live in only nine states, making them a significant political bloc, especially on the national level. In presidential elections, those nine states cast 202 of the 535 votes in the Electoral College. Thus, the Jewish population could provide the swing vote in any close presidential election.

Maintaining Privacy Of Corporate Records

Budget's "Tip of the Week" #2:

NRS 78.257—Right of stockholders to inspect and audit financial records; exceptions

Last week we discussed *NRS* 78.105 and how it appears to have been written specifically to provide access to the corporation's records by the corporation's *stockholders*. What about a case where the stockholder's interest in accessing the records has nothing to do with the stockholder's interest in the corporation? And what about other parties who might want to access the corporation's private records? *NRS* 78.257 holds the answer to those questions, though the answers are, no doubt, NOT what such parties might wish to hear!

After defining who is entitled to inspect the corporate records and the notice that must be given for doing so in paragraph 1, then specifying that the inspecting party bears the costs of extracting such in paragraph 2, *NRS* 78.257, paragraph 3, states (emphasis added):

3. The rights authorized by subsection 1 may be denied to any stockholder upon his refusal to furnish the corporation an affidavit that such inspection, extracts or audit is not desired for any purpose not related to his interest in the corporation as a stockholder. Any stockholder or other person, exercising rights under subsection 1, who uses or attempts to use information, documents, records or other data obtained from the corporation, for any purpose not related to the stockholder's interest in the corporation as a stockholder, is guilty of a gross misdemeanor. ...

A gross misdemeanor conviction is punishable by incarceration for up to one year in the county jail and a \$2,000 fine. Note that this statute spells out rights of the *stockholders* to inspect corporate records—the *stockholders*, not "just anyone". There is no mandate of any kind for non-stockholders to ever inspect any corporate records. It is a gross misdemeanor for any non-stockholder to even attempt to use information from the corporate records in any way contrary to the interests of the stockholders.

Next week, we'll look at a method of owning a corporation without owning its stock—and yes, the answer to that riddle can also be found built right into the *Nevada Revised Statutes*!
