

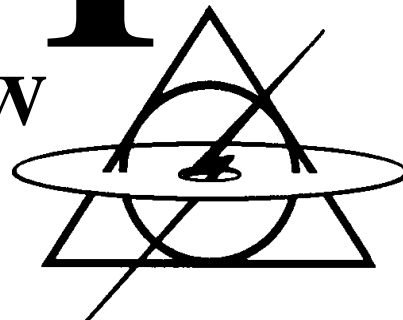

Anomalous Tectonic Event & Strange Gas Emissions

TOO SERIOUS TO OVERLOOK TECTONIC EVENT

I refer to “an event” (non-plural) because the event to which I refer was global, registered and recorded, and you might well pay attention.

On January 1, 2006 at least sixty-one stations reported seismograms showed rapid, single bipolar signals.

gives us a bit more focus on events. We cannot cover all areas but examples are used where they exist in the most visible form.

As you release more and more of the natural gases from your deeper layers and core strata you will become more and more oxygen depleted as you move toward a more heavily contaminated “methane” (general use here for methane will be your most prevalent gas now in focus) atmosphere. If those faults all fail, friends, you cannot survive the contamination. With natural gas ruptures you can easily turn into a fireball because your oxygen atmosphere will turn the gas fires into infernos beyond belief.

Serious? I would guess just about as serious as you can ever find are these events headed your way.

We can stabilize the central equatorial belt to some degree but some 15-years ago we were required to remove the belt electro-magnetic stabilization. This was at a time when it was already seen that a shifting of magnetic poles was “dead ahead” and now you are experiencing a very weak magnetic field and it WILL shift. The only consideration is HOW MUCH SHIFT WILL COME.

It was “contained” and therefore did not create major tsunami activities. That will not work well with a second rupture because of the nearby San Andreas Fault. Now, in speaking of San Andreas activities as expected, it is not in my issues here today as such.

I noted that we needed to prepare for some tidal wave activities recently as to be expected in the coastal areas across from, for instance, San Luis Obispo. No, we DO NOT expect an incredible wave to hit that place but it could reach inland that far quite easily. Ah BUT, San Luis Obispo is so

near the Parkfield area as to expect a major San Andreas shaking.

Now, please, let us just consider the area involved in that one point of location. This can be “generalized” anywhere you find yourself for there will be rifts off every main fault—mostly that are unrecognized to most of you.

The San Andreas fault runs INLAND in the southern area of California so obviously it won’t cause a tidal wave along the California Coast but would rather trigger something across the Pacific opposing coasts if a BIG ONE opens a major rift in a high magnitude fracture.

The tidal wave activity in that area of California will most likely come from a joint-rupture (simultaneous) or singular major event on the Santa Lucia Banks Fault off shore. It is the proper distance to present a MAJOR wave in only minutes.

The massive 100-ft waves expected to the north are of course from the expected San Andreas Fault which moves offshore around the San Francisco area. A fracture will also likely trigger other faults to shift as in Hayward, etc. You can look those up quite easily.

On to the north beware of the Eaton Roughs Fault and the Grogan Fault for they are caught in that San Andreas annual slippage pressure building of some 3 INCHES A YEAR.

Now, to you a bit further inland and located around another PERSONAL attention-getter, Tehachapi—be ALERT! You have a White Wolf fault that destroyed the town in the early ‘50s so is nearing another pressure release. Bakersfield is in direct line of fire as is the area across to the coast.

Several minutes into the year 2006, a worldwide tectonic event occurred that defies what is understood as normal earthquake activity.

how long a near surface P wave takes to travel from its source to the antipode point on the other side of the earth via the poles.

The diameter of the earth at the equator is 7,926.41 miles, and 7,901 miles through the poles. The P wave of a significant earthquake radiating downward would take less time than a surface wave to arrive at its antipode point on the other side of the Earth.

Note that at 00:14:30 the event was simultaneous at Yakutsk, Russia - Black Hills, South Dakota - Mudanjiang, China - Kevo, Finland - Albuquerque, New Mexico.

At 0015:50 the event was also simultaneous at Lusaka, Zambia - Riachuelo, Brazil - Matsushiro, Japan - Garni, Armenia.

No ordinary earthquake does this. With a variance of eleven minutes total, the events are far too close in their time of occurrence to be from a near surface source. In order to achieve the arrival times shown in the list above, an event would have to take place deep in the Earth's mantle, or more likely in the outer or inner core, an area not known for seismic events. The problem with this concept is that the mantle is believed to be mainly molten lava on which the outer crust is floating. The core is thought to be mostly iron, with the outer core being liquid and the inner being solid. Thus there could be no "earthquake" in these regions unless some massive external magnetic force was applied that could momentarily disturb the position and movement of the liquid iron in the outer core. That might do the trick.

Many of those who are aware of the HAARP network have the concept that this device is an "atmospheric heater" as described by various information and disinformation sources. Some may have the notion that scalar weaponry such as HAARP works by radiating upwards just as in radio communications. This may certainly be true in the case of weather manipulation or mind control, but the antenna devices used by HAARP can radiate in many directions—down included.

Regardless of the source, on the first of January a scalar tectonic weapon left a record for all to view.

Of even more ominous portent is the possibility that the devices that caused this event are located in space.

While the USGS web page for the time frame in question is long gone and difficult to access by the common person, a PDF file of the complete page for January 1 is available on request for those who are either interested or skeptical.

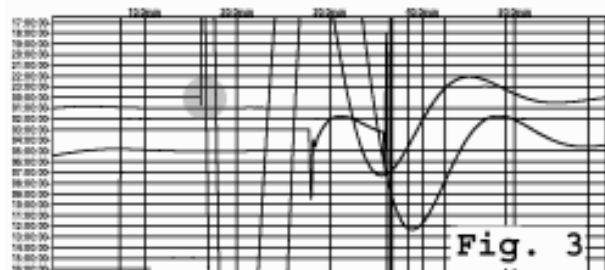
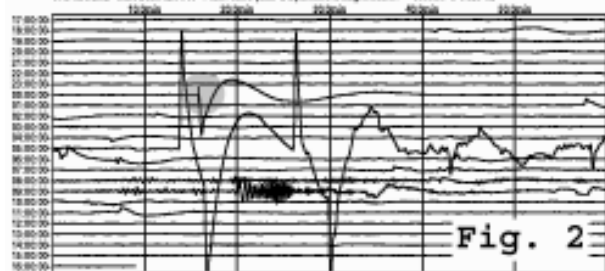
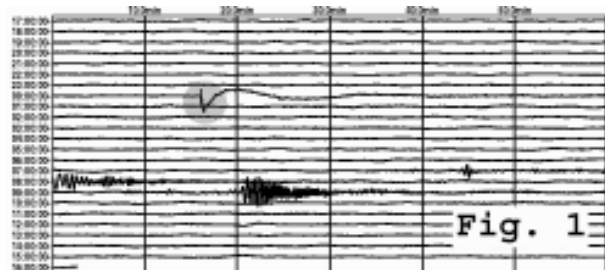
In the three days following the anomalous event, several significant earthquakes occurred, including:

website. Of these, fifty-six seismogram displays showed a rapid, single bipolar signal between 00:10:11 and 00:21:00 hours. The range of appearance of this event can be seen in the image:

Three seismograms are shown in this image. They are CASY (Casey, Antarctica,) LSZ (Lusaka, Zambia,) and PMG (Port Moresby, New Guinea.) The most commonly observed event, being a small, sharp bipolar pulse, is shown in fig. 1. A more disturbed signal is shown in fig. 2. In fig. 3, the most dynamic of the seismograms, the signal moves completely off scale at the onset of the event. What is so unusual about these three events is that they are all essentially synchronous.

Earthquakes produce what are call[ed] body waves, which travel through the interior of the Earth. These consist of two types, P (primary) waves and S (secondary) waves.

In water, P waves travel at 1.45 km/s (3,243 MPH). In sediments, P waves travel up to 5 km/s (11184.68 mph). In granite layers, P waves travel between 5.5-6.4 km/s (12303- 14316 MPH). S waves travel at about 58% of that of P waves for a given material.

The earth's circumference around the poles is 24860 miles. At the equator, the circumference is slightly larger. Some minor math will tell the reader

Now, if men’s sense of honor is great, they will be able to campaign....” So, too, it follows that if the sense of honor of the men of a country is defamed, denigrated, and destroyed, then they will not be able to campaign or defend that country. **[Other than to make himself feel important, what would be the point of that paragraph?]**

For several weeks, in a series of postings and opinions published here on Rumor Mill News, the CEO of the Durham Trust has related the story of how E.J. and Doris J. Ekker of Tehachapi, California and Las Vegas, Nevada, have created fraudulent financial instruments based on the mammoth Peruvian Commodity Contract known as the Bonus 3392-181.

[Bonus 3392-181 was a Peruvian bearer bond in the form of a “gold certificate”, meaning that its principle and interest were payable in gold. It was issued and sold in New York City in May, 1875; it was not redeemed as scheduled

in 1885 and so continued to compound its interest at the “bonus” rate of 44%; it was “assumed” by the U.S. Treasury in 1906 along with the other debts of Peru, Bolivia, and Chili to avoid going to war with Germany and England pursuant to the Monroe Doctrine; it was “guaranteed” by the Federal Reserve System in 1913 as required by the *Federal Reserve Act*; in 1977 it was obtained by Russell Herman who retained Attorney Ernesto Arias Schreiber in Lima, Peru to ascertain whether it had been redeemed and where its “domicile” (for collection) should be, the answer to which was New York; it was translated from Spanish to English and certified by a professor of linguistics at Ohio State University August 24, 1984; it was photographed and the photograph certified on or about May 15, 1985 by professional photographer Michael C. Walcutt; its assignment to Cosmos Seafood Energy Marketing, Ltd. was acknowledged by corporate resolution October 10, 1988; the photograph of 1985 was used as evidence of its existence and the corporate resolution as proof of its ownership to reconfirm and reissue it as having identifiable ownership (rather than a bearer bond) as confirmed by the Jurat issued by the Peruvian Consulate in Los Angeles August 21, 1989. NEVER has it been called a “commodity contract” by anyone other than VK Durham, and only recently by her when it became obvious she had no legitimate claim to the Bonus 3392 bearer bond. Lately she has added another hoax by calling it the “One Time Only Commodity Contract Bonus 3392 and Certificate of Debt 181”, perhaps on the theory that someday she can get away with one or the other.]

V.K. Durham, also known as Granny Herrman or the widow [surely by now even Patriotlad knows VK was never married to Russell Herman] of Colonel Russell Herrman [who never used any spelling of his last name other than Herman—another of VK’s hoaxes] of the OSS and CIA, is that CEO and is the lawful signatory to the [nonexistent] Bonus Contract. In the series of articles entitled the Texas Two Step & The Billionaire Boys’ Club, she detailed the ways in which a select group of corporate leaders and politicians tried to create an “insiders’ only” club for doing business in the whole of the western world. She has given precise details of the murder of her husband, Colonel Herrman. [Does Patriotlad refer to her theory that he was asphyxiated as proven by the fact that he had “a erection”? What a travesty!]

V.K. Durham has provided extensive documentation and made the links to show that the Ekkers’ scams have netted them something in excess of \$17 million in gold and that they left behind some \$5 million in gold coins, when the [sic] skedaddled out of the United States in late 1997. She and others have provided information linking the Ekkers to scams run on elderly U.S. Citizens, like Betty Tuten of Nevada, who lost \$402,000 to one of their “investment” plans. [The facts are that VK has never provided ANY documentation or evidence whatsoever to show that Ekkers scammed anyone out of money or gold. The Overton gold was a gift to Ekkers that was taken by George Green and buried in his back yard when he moved from Tehachapi, California to Minden, Nevada. Ekkers sued George Green to force him to return the gold and Mr. Overton came from Texas to testify that it was intended as a gift to Ekkers. The Nevada Court decided to return the gold to Mr. Overton in Texas so that he could dispose of it as he desired. Mr. Overton died soon thereafter and

the Texas court awarded one-half the gold to Ekkers—sans, of course, attorneys’ fees and the court’s expenses—and the rest to local friends of Mr. Overton who had befriended him over the years. He had no heirs. Ms. Tuten was convinced by George Green to join with him to help him keep the gold and so she lost when he lost the case.]

An article published in the Sunday Telegraph of London in 2001 revealed that the Ekkers took a fortune in gold coins from a retired mathematician in Austin, Texas, one Dave Overton, by selling him on the reality of their spaceship commander—Hatonn. He was a mathematical genius and a notable eccentric, and a Nevada court determined in 1994 that Mr. Overton had been swindled by the Ekkers and George Green, their one-time business agent. [Wrong. If true, none of the gold would have been awarded to Ekkers.] After he died, his estate was probated and some of the money they took from him was returned to it. Through it all, these two Ekkers have conducted their business—which is nothing more than scamming, selling mythologies and dreams of interstellar glory, and falsified gold bonds and instruments—with the help of a bewildering variety of corporations and partnerships. The Ekkers even founded a church and then used that Church to sue themselves!! Why? It was done in order to get publicity, to create a ‘victim status’, and to keep the readers of their publications “involved”, that is to say—using “Ritual.” [Wrong again. Ekkers have never been sued by a church. Where are the documents? They should not be difficult to produce if they exist.] Throughout it all, they have somehow won and held the allegiance of a variety of people with many talents. [Ekkers use no ritual; we wouldn’t know how. We simply tell the truth and the “real” people can understand that. Further, Ekkers did not “skedaddle” out of the U.S. in 1997. In August of 1998 we brought with us four people on the strength of the representations that meetings with the newly inaugurated president, Joseph Estrada, and the former First Lady, Imelda Marcos were tentatively arranged pending our arrival.]

The latest and deadliest scam, based on yet another improbable mythology, is the “secret law” called NESARA or the National Stabilization And Reformation Act [Oh whoa, shades of the arrogant inaccuracies of VK Durham (which often causes us to wonder if “Patriotlad” is not a *nom de plume* of VK used for the purpose of sneaking her venomous posts onto sites that would not ordinarily accept them). The second letter of NESARA is “E”. What (missing) word in Patriotlad’s “National Stabilization And Reformation Act” would correspond to that “E”? Should not such an authoritative and erudite author as Patriotlad at least correctly identify the Act about which he speaks? Apparently there are at least two “NESARA” entities: one is a bill to be submitted to congress called “The National Economic Stabilization and Recovery Act”, and the other is called “The National Economic Security and Reformation Act”. Our Patriotlad guru seems to have left out a word and mixed the others so that no one can tell, for sure, whereof he speaks.] which has been ceaselessly propagated by one who calls herself “the Dove of Oneness”. The mythologies of NESARA all revolve around the legitimate losses and the truly tragic swindles of the Savings and Loan crisis of the late 1980s. Hundreds of thousands of farm and ranching families and rural businesses were drawn into the whirlpool of bankruptcy and foreclosures, and from that long-running tragedy was generated a movement which has

been called The Farm Claims. [When we first became acquainted with Russell Herman, and later VK Durham, in 1992 we noted that the address to which people were directed to send their “Farm Claim Applications” was VK’s address in Okawville, Illinois. Ms. Durham has quite a reputation of starting scams, creaming them and getting out before she is implicated. How long has it been since she claimed to be the inventor of NESRA (her version of the spelling), Greenlight, and half a dozen others? For those interested in Dove, Nesara, and any relationship with Ekkers, please see <http://www.tribnet.com/news/crime_safety/story/5318019p-5255837c.html>.]

The Dove of Oneness, who claims to receive messages from the Ascended Master St. Germain, has taken many opportunities to link the origin of NESARA as a secret law reforming the whole of the United States’ tax code, abolishing the income tax, to then moving the country into a gold standard. Whether this individual knows it or not, the so-called Master is none other than Doris J. Ekker, who has registered the alias of St. Germain. [Sure, and it was Doris that stood up and convinced the Founding Fathers to sign the CONSTITUTION. Poor Pitiful Patriotlad must not have heard of the large “I AM” group headquartered in their beautiful facility at Mount Shasta, or any of the other dozens of groups all over the world.]

NESARA is not just a mythology. It is not just a scam designed to build an e-mail list for later use by other confidence men, fraud experts and flim-flam artists!! It is an incredibly dangerous and insidious trap, a psychological warfare tactic, designed to ensnare thousands of good and patriotic Americans, and to taint and sully the whole of a group of people who have become known as “the Children of Light.” [We wonder if the Guru Patriotlad can explain who are “the Children of Light”, what are their attributes and qualifications, and who is it that decides whether they are “light” or “dark”.]

This message arrived just two days ago, while the Rumor Mill Forum was still down, and it comes from an impeccable source: [VK has been floating this one for years. Finally found a fish that would bite on it.]

“E.J. Ekker has been a Navy intelligence asset for almost 30 years.” [Wrong. EJ Ekker served his two years rising to the lofty rank of corporal in the Army during the Korean war.]

But isn’t Naval Intelligence the soul of Faction Two?

Talk about turning on the lights!! The plan is to destroy the Children of Light, before they ever see one dollar of prosperity from any program or any fund of any kind!!

Talk about selling out the Children of Light, for the benefit of the Dark Agenda, as Dove calls it! The question immediately redounds—how can a man who is a Naval Intelligence asset operate in the clear, as a scam artist, working both traditional forms of confidence and creating an entire “spaceship mythology” with a virulently anti-Israel and anti-Federal Reserve System bias, continue to enjoy his success while in exile?? Who is protecting him?? Is it Faction 1, the New World Order and the Satanists?? Is it Faction 2, the principled opposition to the New World Order and the advocates of a return to lawful money, the gold standard and the Constitution?? Why does E.J. Ekker seem to have complete and absolute immunity, even as he and Doris J. Ekker float their false instruments to leverage gold and funnel monies to the Al Qaeda network of terrorist groups?? Which side are they on?? [Could it be that Ekkers are not on any of Patriotlad’s “sides”, that their

“immunity” comes from being law abiding, and that they have not funneled money to any terrorist group?]

The answer is shocking and shockingly obvious:

The Ekkers are on both sides. They are Triple Agents, the most skilled and skilful operatives ever known, and they have very nearly succeeded in selling their entire NESARA—Farm Claims—Prosperity Programs mythology to a monster-sized audience. **[If Poor Pitiful Patriotlad read the CONTACT he would know that Ekkers do not believe in the “something for nothing” Prosperity Programs so we have to question his motives in blathering this baloney.]** But why?? Why pull a Triple Cross on the people of the United States and Canada, and all the others who have put money into prosperity programs like the Bergavine, the SBC, the Treasurygate and the mighty Omega?? What is the purpose??

DISSIDENT LISTS, FINANCIAL CRIMES AND THE AL QAEDA

Enter another piece of the puzzle, courtesy of V.K. Durham. In questioning her about the creation and evolution of these prosperity programs, and the Farm Claims, certain facts came to light. Colonel Russell Herrman and V.K. Durham first heard of the Farm Claims in 1993, when they were contacted by Rick Martin who was inquiring about the supposed participation of Cosmos Seafood Energy in providing the funding for this redress of grievances. **[Ms. Durham has lied to PPPlad again and he has swallowed the bait. In December 1991 Ekkers were invited to listen in on a big conference call alleged to have been put together by VK to talk about the Farm Claims and Treasurygate. To our knowledge Russell was not in on the call, which turned out to be mostly about how to send money to pay the phone bill. At that time Rick Martin was working as an investigative reporter for CONTACT. Also please note the discrepancy in the timeline of the next sentence.]** The problem was made clear at that time: V.K. and Colonel Herrman, the CEO, had suspended the operations of their Cosmos Seafood Energy corporation in April of 1992, precisely because there had been so many look-alike and sound-alike groups registered in Nevada!! After several inquiries by different persons, it was made clear to all that the true Cosmos Seafood Energy and the true signatory of the Bonus Contract 3392-181 were not involved with the Farm Claims and had not started them. **[How convenient for VK to be able to slip in a denial through someone else. PPPlad could well wind up in jail before he is dry behind the ears.]**

Over the next few years, the constant stress and struggle between the powers that be in Washington, D.C., and the people of the western States, and especially in the northern midwest, grew more acute. The massacre of Branch Davidians at Waco was not in any way helpful. The passage of the Brady Bill with its draconian structure for making gun ownership a trap for criminal penalties, further alienated the rural population. And after the disastrous Tesla weapon strike on the Murrah Building in Oklahoma City, the Clinton administration tried to paint all right-wing talk show hosts and their listeners as being “the enemy”. It had the opposite effect. More and more people began to ask about the Savings And Loan crisis, more and more people began to read about the militia movement, more and more people began to feel that everything about the federal government was corrupt and crooked.

V.K. Durham helps to connect the dots. In

asking about the Bergavine and the Omega and the Farm Claims, she remembered seeing some important documents. Created for President Bill Clinton—with the connivance of Senator Arlen Specter of Pennsylvania—the participants in the Farm Claims and the various prosperity programs were all put on dissident lists. This is the infamous “watch” list assembled by Janet Reno and her minions in the wake of the Oklahoma City fiasco and cover-up.

The people who are most closely associated with the Omega and the Bergavine have been identified as being “potentials” for domestic terrorism. Never mind that the threat of terror activity has been—for over a year—centered on the Al Qaeda and their supposed network of training camps in the ruined landscape of Afghanistan!! The events of the last six months, and the micro-nuclear blast **[Really? PPPlad has just gone one up on VK—a nuclear blast without radiation!]** which destroyed that nightclub in Bali, on the island of Java, shows clearly that the hub of the Al Qaeda operation is in southeast Asia and the islands of Indonesia, Malaysia and the Philippines!! And where are the Ekkers now ensconced, where is their headquarters?? In the P.I. [?] at Makati City, where they have actively supported the Moro insurgencies and other Muslim fundamentalists!!

The linch-pin (sic) for understanding this triple cross and the devilish planning it has required is the fact, proven in an almost constant stream of propaganda and messaging over the last nine months, that the purpose of the Dove of Oneness has been to build her list. Build the list! Build the list! Why? **[Please be reminded that there is no connection between Dove and Ekkers, or between any prosperity program and Ekkers.]**

More than 300,000 people are said to be registered participants in the Bergavine, the SBC, the Omega and other prosperity programs. They have been anxiously awaiting news of the funding of these programs for years, some for more than ten years. The key to understanding the motives of the Dove is to know that the Ekkers’ are now irretrievably tied to the Al Qaeda terrorist **[Where is the LINK, PPPlad? Where is your proof? Even evidence? Your inane repetition of VK’s alcoholic prattlings do not qualify as even hearsay.]**, and Muslim fundamentalist movements, by their actions and by their false deeds of assignment. They have floated trillions of dollars in phony financial instruments, with the Bank of China, with the Saudi bankers, and with Islamic banking groups in Malaysia and Indonesia. **[More inane prattlings.]** The Ekkers are providing the intelligence which “the Dove” has been using to build her lists. **[Not long ago the Webmaster of VK’s antechamber website crowed that VK had some 186, 000 “trustees” for her “trust”. We have to wonder if there are any cross-overs or whether VK and PPPlad are taking care of Faction 1 while Dove wraps up Faction 2.]**

TRIPLE CROSS, TRIPLE THREAT, TRIPLE PLAY

The impeccable source **[VK Durham?]** also informs Rumor Mill News **[The word is around that Rayelan won’t talk to VK about anything—especially that gold shipment supposedly flown in from the Philippines by Gunther Russbacher and Russell Herman that was forced down in Midland, Texas at the same time that Russell was in the hospital dying of colon cancer.]** that E.J. Ekker was one of the most brilliant operatives ever to appear in the world of “cloak and daggers”. When connecting the dots, it now appears clear, very clear, that he is a Triple Agent:

*** the Ekkers, and E.J. in particular, are Triple Agents and the NESARA mythology is a scam, but more than that, it is a Triple Cross—

1. The first purpose of Faction 2 has been, we are told, to bankrupt and destroy the Federal Reserve System, which is the private banking cartel and the oppressor holding sway over these United States (and Canada, too). What E.J. Ekker was conniving to do, was to bring in those gold-backed bonds and gold certificates and to bring the cash that the phony Deeds of Assignment were used to create, to whack the Fed Res Sys into pieces. No doubt some of what Ekker has assembled in the portfolio of GAIA is legitimate. But most of it is a forgery. **[Doesn’t that sound Swashbuckling? Almost envious, isn’t he?]**

2. The Faction opposing the New World Order has been linked to Naval Intelligence, and to men who are loyal to the Constitution and the organic united States: now it is clear that the Ekkers were tripling-up—working their bona fides as F-1 agents and representing themselves to Faction 2 as having ‘defected in place’. V.K. Durham confirms that Doris Ekker has often represented herself as “working for a higher authority” than the President!! In reality, the Ekkers have been working for F-1, the Satanic New World Order at a much higher level!! **[Could there be a third “faction” that PPPlad doesn’t know about?]**

3. The drive for nine months or more, with the Dove, et al., has been to build the list, build the list, build the list. Clearly, the goal of F-1 was to allow F-2 to use those false Deeds of Assignment, along with many legitimate instruments and other gold assets, to bring those Trillions said to be in the prosperity programs back into play. To do what is right and proper in making “whole” the great tragedy of the farm and ranch foreclosures and the ruined lives that spawned the Farm Claims. **[Now that is a typical VK conclusion—taking a nothing piece of information and making nothing out of it. This Lad is showing that he is mentally challenged and out of his dimension.]**

4. Now, to bring these assets into the country as financial instruments convertible into monies, would be a good thing if they were not based on the fraudulent Deeds of Assignment written by the Ekkers and using—among other things—their false front Cosmos Seafood Energy groups. **[What is a “false front Cosmos Seafood Energy group”?]** But the money is coming in from abroad, that does make it subject to federal oversight, and so what happens next?? **[Nothing. Ekkers are not involved.]**

THE EKKERS ARE SACRIFICED

The Bush administration has done what the Clinton administration could not or would not do, which is to establish that the Al Qaeda network of terrorist and fundamentalist groups is a serious threat to the safety of the United States. And that it is specifically a threat to the security of “infrastructure”, and that the Al Qaeda has been laundering money in a variety of ways around the world and inside of the United States. So what comes next??

The Ekkers will be revealed in the mass (controlled) media as being the Sugar Daddy and the Sugar Momma of the Al Qaeda!! **[Wow! Do you think we will get a kiss on each cheek from Dubya?]** Then, just when the Trillions of dollars which the Ekkers have ginned up by selling falsified gold instruments, actually move into position and the program recipients are given access??

Then—the Children of Light would be tarred with the brush of having taken money directly from the Al Qaeda Headquarters in Manila, and by way of Islamic

banking operations which are holding debentures!! [There is our confirmation as to the bona fides of Poor Pitiful Patriotlad. Only a certified idiot would make that last statement of his. We will not explain; our readers will all see the *non sequitur*.] The Federal Reserve System would be tasked to seek out and seize or freeze all of these funds (thus, sacrificing the Ekkers), and federal law enforcement and Anti-Terrorist units would then proceed to use the Dove list!! We could also show, if useful, the full registration documentation and SEAL of the Durham-claimed "TIAS" corporation, Inter-American Investment Corporation, as long ago secured. [See Secretary of State printout on page 9.] WE HAVE NO COMMENT ON ANYTHING "BUSH" MIGHT HOLD AS TO THE SAME IDENTITY OF CORPORATE STANDING OR NON-STANDING. VK Durham has misused and abused that entity by laying claim to it on which to base her non-existent TRUST.

Therefore, good practice dictates that we establish our position publicly since VKD holds records belonging to Cosmos Seafood Energy Marketing Ltd., which she has refused to turn over to the corporation that was established by Russell Herman and Cecelia Xalis in 1985 TO HOLD THE ASSET. In 1989 the corporation converted the bearer bond to a corporately owned "contract". VKD had and has no standing with CSEML even though she constantly and loudly claims that she "retired" it and "put" it in her non-existent "trust", The Durham (Intl. Ltd;) Holding Trust (TIAS 12087). We find it most interesting that Ms. Durham has stopped identifying her "trust" as TIAS 12087—apparently she has had to accept the fact that there is no such thing. She has also had to stop claiming the gold certificate (bearer bond) Bonus 3392-181, substituting her new version: "One Time Only Commodity Contract Bonus 3392 and Certificate of Debt 181".

In her post of 11/18/05 on her website we note that Rayelan Russbacher Allen of Rumor Mills is withdrawing and denying association with those who impose their sneaked information onto her website on her pretext of

not wanting to be the transmitter of "triggers" of mind-controlled assassins and terrorists. VK hops on this to mean that Rayelan is finally at long-last endorsing VK's position that *CONTACT* is the transmitter of "coded messages" from "Hatton". We also helped them financially when he came to live in California with Rayelan after he was released.

While there were many “escapades” involving Gunther that would be interesting to recount, they were quite well chronicled in the Journals and *CONTACT* at the time and can be passed over here. In recent years Rayelan has posted a lot of scurrilous accusations, trash really, that we will, however, take the opportunity to correct. First she alleged that we were the cause of Gunther’s incarceration in Austria because, as his CIA financiers, we withdrew our support at a critical time, costing Gunther and her their commission on a gold deal we knew little or nothing about. EJ had to decline and also to withdraw the authorization for further charges. What we didn’t know and didn’t learn until Father Ed returned a few days later was that Gunther had got on drugs and was out of control of either he or Rayelan. Father Ed said that when Gunther somehow got to swinging on the giant crystal chandelier and broke it, he decided it was time to pack up and come home.

A few days later we heard from Rayelan that she had become frightened that she might be put in jail so she took a train to Germany and came home from there. Since we had not heard from Gunther, EJ called the hotel in Vienna to ask about him and was told that he had been arrested. EJ got the Police Officer’s name and telephone number and called him. He spoke good English and explained that Gunther would be held without bail until he was tried for fraud upon the hotel. If found guilty he would probably serve at least one year, maybe more. The next we heard from Gunther he said he was in Mexico trying to get his “new English wife” across the border into the U.S. and needed some more money. EJ had to tell him that we couldn’t help him this time; that we were having to be conservative. He called from England once after that just to say “hello”—EJ said he might have been drinking.

SEGMENT #1: MARTIN LUTHER KING JR.

"We're all caught in an inescapable network of mutuality, tied in a single garment of destiny. And whatever affects one directly, affects all indirectly. John Donne coined it years ago and placed it in graphic terms: 'No man is an island entirely of itself, every man is a piece of the continent, a part of the main.' And then he goes on toward the end to say: 'Any man's death diminishes me, because I'm involved in Mankind; And therefore never send to know for whom the bell tolls; it tolls for thee.'"

Voice of Iraqi woman crying: "Why!? Children! Girls! Boys! Man, woman! Why!? Why!?"

Voice of Narrator: "The invasion was swift, intense and merciless."

Martin Luther King, Jr.: "And I oppose the war in Vietnam because I love America. I speak out against it, not in anger but with anxiety and sorrow in my heart and above all with a passionate desire to see our beloved country stand as the moral example of the world. I speak out against this war because I am disappointed with America. There can be no great disappointment where there is no great love."

"For those who say to me, 'stick to civil rights,' I have another answer. That is that I've fought too long and too hard now against segregated public accommodations to end up segregating my moral concerns. I'm not going to do that. Others can do what they want to do. That's their business. Other civil rights leaders for various reasons refuse or can't take a stand or have to go along with the administration, that's their business! But I must say tonight that I know that justice is indivisible; injustice anywhere is a threat to justice everywhere."

Martin Luther King was assassinated on April 4, 1968, in Memphis, Tennessee, exactly one year after delivering his famous "Beyond Vietnam" speech at the Riverside Church in New York City, April 4, 1967.

SEGMENT #2: JOHN STOCKWELL Former CIA Station Chief Angola Task Force

"My expertise, as you know, is CIA, Marine Corp, three CIA Secret Wars. I had a position in the National Security Council in 1975 as the Chief of the Angola Task Force running the Secret War in Angola. It was the third CIA Secret War I was part of.

"The National Security law creating the National

Security Council and the CIA, as you know, was passed in 1947. The CIA was given its charter to perform such other duties and functions as might be necessary to national security interests and given a vague authority to protect its sources and methods. I think it was in the mid '80s that I coined this phrase the 'Third World War' because in my research I realized that we were not attacking the Soviet Union in the CIA's activities, we were attacking people in the Third World. And I am going to just quickly, in the interest of time, just give you a little sense of what that means, this Third World War.

"Basically, it's the third, I believe in terms of loss of life and human destruction, the third bloodiest war in all of history. They undertake to run operations in every corner of the globe. They also undertook the license of operating just totally above and beyond U.S. laws. They had a license, if you will, to kill, but also they took that to a license to smuggle drugs, a license to do all kinds of things to other people and other societies in violation of international law, our law, and every principle of nations working together for a healthier and more peaceful world.

"Meanwhile, again, they battled to convert the U.S. legal system in such a way that it would give them control of our society. Now we have massive documentation of what they call the secret wars of the CIA. We don't have to guess or speculate. We had the Church committee investigate them in 1975 which gave us our first really in-depth powerful look inside this structure.

"Senator Church said in the 14 years before he did his investigation that he found that they had run 900 major operations and 3000 minor operations. And if you extrapolate that over the whole period of the 40 odd years that we've had a CIA, you come up with 3000 major operations and over 10,000 minor operations. Every one of them illegal. Every one of them disruptive of the lives and societies of other peoples and many of them bloody and gory beyond comprehension, almost.

"Extensively, we manipulated and organized the overthrow of functioning constitutional democracies in other countries. We organized secret armies and directed them to fight in just about every continent in the world. We encouraged ethnic minorities to rise up and fight. People like the Mosquito Indians in Nicaragua, the Kurds in the Middle East, the Hmongs in Southeast Asia.

"And of course, we have organized, and still do, fund death squads in countries around the world. Like the Treasury Police in El Salvador which are responsible for most of the killing of the 50,000 people just in the '80s and there was 70,000 before that. An orchestration of CIA secret teams and propaganda led us directly into the Korean War. We were attacking China from the islands of Quemoy and Matsu, Thailand, Tibet, (a lot of drug trafficking involved in this by the way) until eventually we convinced ourselves to fight the Chinese in Korea and we had the Korean War and a million people were killed. Same thing for the Vietnam War and we have extensive documentation of how the CIA was involved at every level of the national security complex because it's a very cooperative thing into manipulating the nation into the Vietnam War. And we wound up

creating the Golden Triangle in which the CIA Air America airplanes were flying in arms to our allies and flying back out with the heroin.

"We launched the largest; this is something that Jimmy Carter did, Admiral Turner brags about it, the operation in Afghanistan. The biggest single operation I am told in the history of CIA secret wars and sure enough very quickly we produced the Golden Crescent which is still the largest source of heroin perhaps in the world today.

"Trying to summarize this Third World War that the CIA, the U.S. National Security Complex with the military all interwoven in it in many different ways, has been waging, let me just put it this way, the best heads that I coordinate with studying this thing, we count at least, minimum figure, six million people who've been killed in this long 40-year war that we have waged against the people of the Third World.

"These are not Soviets, we have not been parachuting teams into the Soviet Union to kill and hurt and maim people, especially not since 1954 when they developed actually the capability of dropping atomic weapons on the United States. They aren't British, French, Swedes, Swiss, Belgians, we don't do bloody gory operations in the countries of Europe. These are all people of the Third World. They are people of countries like the Congo, Vietnam, Kampuchea, Indonesia, Nicaragua, where conspicuously, they nor their governments, do not have the capability of doing any physical hurt to the United States. They don't have ICBMs, they don't have armies or navies. They could not hurt us if they wanted to. There has rarely been any evidence that they really wanted to. And that, in fact is perhaps the whole point. If they had had ICBMs we probably wouldn't have done the things to them for fear of retaliation.

"Cheap shots, if you will, killing people of other countries of the world who cannot defend themselves under the guise of secrecy and under the rubric of national security."

John Stockwell is the highest-ranking CIA official ever to leave the agency and go public. He ran a CIA intelligence gathering post in Vietnam, was the Task-force commander of the CIA's secret war in Angola in 1975 and 1976, and was awarded the Medal of Merit before he resigned. This speech was given in 1988. Stockwell's book *In Search of Enemies* is an international best-seller.

SEGMENT #3: COVER-UP: Behind the Iran-Contra Affair

Ambassador Robert White (El Salvador 1976-1980): "What we saw in the Iran-Contra Hearings, was the exposure of the beginnings of a National Security State which believes it has the right to override the Constitution of the United States in the name of security."

Rep. Jack Brooks (Democrat - Texas.): "I think that there was a substantial shadow government trying to run foreign affairs for the United States."

Marilyn Clements (Center for Constitutional Rights): "In any other country it would have been called a coup. And they seem to have gotten away with it."

David MacMichael (former CIA Analyst): "These are modern-day pirates, these guys. They have escaped, essentially, the control of national governments, but they are available for use by national governments. Sometimes they move under color of—and defend themselves as advancing U.S. national interest in this. But I think that is very secondary with these guys. They're out to make a buck."

Oliver North (Lieutenant Colonel): "I did do it. I am not, as I said in my statement, at all ashamed of any of the things that I did. I was given a mission and I tried to carry it out."

Elizabeth Montgomery, Narrator: "The Iran-Contra Hearings, convened in May, 1987, by a special joint committee of the United States Congress to investigate

the sale of U.S. weapons to Iran and the illegal diversion of money to the Contras. Often, the official explanation seemed inadequate, and contradictory.”

President Ronald Reagan: “Our government has a firm policy not to capitulate to terrorist demands, that no concessions policy remains in force. In spite of the widely speculative and false stories about arms-for-hostages and alleged ransom payments, we did not, repeat, did not, trade weapons or anything else for hostages. Nor will we.”

Narrator: “Despite Reagan’s denials, investigations soon revealed that arms had been traded for hostages held in the mid-East.”

President Ronald Reagan: “A few months ago, I told the American people I did not trade arms for hostages. My heart and my best intentions still tell me that’s true. But the facts and the evidence tell me it is not.”

Narrator: “Only days later, it was further revealed that the arms to Iran had been severely marked up. Some of the profits had been illegally diverted to support the Contras, a guerrilla force organized by the CIA, fighting the Nicaraguan government. The Reagan administration had a major scandal on its hands. The use of U.S. government money for supporting the overthrow of the Nicaraguan government was specifically prohibited when Congress enacted the Bolland Amendment in 1984. Even though it remained in effect until 1986, millions of dollars in profits from Iranian arms sales were secretly diverted to the Contras during this period through contacts through middlemen such as Manucher Gorbaniyar. Did these hearings uncover the full story behind the Contra-gate scandal? Or was it merely an attempt to keep the real truth hidden from public view?

“Peter Dale Scott, Professor at the University of California at Berkeley has conducted extensive research on covert action and CIA activities. The results are detailed in his book *The Iran-Contra Connection*.”

Professor Peter Dale Scott: “I think that the real issue was that both the administration and the majority of the people in the committees were frightened that the real scandals, the drug scandals for example, would really threaten any future conduct of covert operations on the scale that they had been handled in the past. And so they were trying very deliberately to limit the damage. This was damage control.”

John Stockwell (former CIA covert specialist): “And so they were pulling the punches on all the major questions and issues of what really happened in this thing, what the CIA’s role was. Any time they got into anything that was really sensitive about exactly that, exactly what the CIA’s role was and exactly what laws were broken and when, they went into secret session.”

Narrator: “There was a lot of talk during the hearings about covert operations, national security, the necessity of secrecy in conducting foreign policy. But some experts claim that covert action does not work in the interest of the U.S. National Security, nor does it create a more stable world.”

Peter Dale Scott: “To think of the democratic governments that have been overthrown in the last 30 years by military coups, it is almost like giving a capsule history of CIA covert operations in the last 30 years. I mean there was the overthrow of Prime Minister Mosaddeq in Iran in 1953; there was the overthrow of Arbenz in Guatemala in 1954; there was the overthrow of the Brazilian government in 1964; there was the overthrow of the Ghana government in 1966. A lot of the governments I just mentioned got into trouble with the international oil companies because they tried to assert their national prerogatives over their own resources. Time after time the CIA has come in on behalf of those multi-national companies.”

Jonathan Kwitny (Author – Journalist): “You start a huge covert war that you intend is going to be secret. It’s not secret from the Russians. Certainly not secret from the Laotians who are getting shot at or the Angolans, and Nicaraguans or whoever it is. It is covert from the American taxpayer and voter. And a lot of

people make a lot of money off of it. And it attracts criminals. And it has every single time.”

Narrator: “Who are the names, the faces, behind these covert activities? Some, like Oliver North, General Secord, Albert Hakim, are practically household names. But Daniel Sheehan, Chief Legal Counsel for the *Christic Institute*, a public interest law firm, believes there are other influential players involved.”

Daniel Sheehan: “There exists in operation now, a secret team of some two dozen men, former Central Intelligence Agency covert operatives, former U.S. Pentagon arms suppliers, who have joined together in a private enterprise outside of the control of the American government, either the Congress or the President, who are mounting their personal wars around the world.”

Narrator: “Whether there is actually an organized secret team, or simply a loose association of individuals, it is clear that there are a number of people who have been working actively behind the scenes in these covert operations. Some of the names are Theodore Shackley, who was Assistant Deputy Director of Operations for the Central Intelligence Agency as of 1976 under George Bush, who was CIA Director at the time. Thomas Clines, who worked as a case officer under Shackley in Miami and in Laos. General John Singlaub, who worked with Shackley and Clines in Vietnam and was in charge of the CIA’s special operations over the border into Laos. General Richard Secord, who supervised the air operations into Laos and was later assigned to the Pentagon where he was put in charge of arm sales to Iran. Albert Hakim, who was a salesman for the U.S. weapons companies and a middle man in the Iran-Contra Affair.”

Sheehan: “These are the men who have been stirring the pot around the world to instigate these wars on the side of the Right-wing. And that’s the group we are dealing with right here—who’re making war around the world for their own personal profit.”

Newsreader: “Cuban Revolutionary troops such as these have invaded Castro’s leftist island fortress. Reportedly rallied by a mysterious coded radio message: Alert! Alert!”

Narrator: “It was after the failed invasion of Cuba at the Bay of Pigs in 1961, that Theodore Shackley, as CIA station chief in Miami, and his assistant Thomas Clines began working with Raphael Quintaro and other right-winged Cubans to overthrow the Castro government. In 1965, Shackley and Clines were transferred to Laos where Shackley became CIA Station Chief, Clines, his assistant, once again. It was here, in Southeast Asia, that they teamed up with General Secord and Singlaub.”

Sheehan: “And they there began running the secret war in Laos and Cambodia and Thailand. Everybody in the United States basically thought the war was going on in Vietnam. In fact, it was a major dirty war, a covert war that was fought primarily through assassinations of people that were suspected sympathizers of the Pathet Lao, or other people who were not terribly sympathetic to the Western powers.”

Narrator: “When Theodore Shackley was promoted to Director of the CIA Western Hemisphere Operations, he supervised the plans to overthrow the democratically elected President of Chile, Salvador Allende. Allende, a Socialist, had promised to nationalize the copper mines and other industries and posed a threat to U.S. business interests in Chile. After a bloody coup, Allende was replaced by a right-wing military dictator Augusto Pinochet, whose security forces brutally murdered and tortured thousands of political dissidents. Shackley moved on, returning to Southeast Asia.”

Sheehan: “By that time, the writing was on the wall. The United States was going to be pushed out of Southeast Asia. It was clear that the Viet Cong were going to prevail under Ho Chi Minh. And so what these men began to do? They began to pilfer hundreds of tons of ammunition and military equipment out of Vietnam. They began to construct a covert war capacity that was unknown to the United States Congress, that didn’t require supervision by the President but would pursue the mission that they viewed as their ultimate

mission. That is, to attempt to vanquish any people who didn’t support the United States foreign policy and who were Socialists, Communists, anywhere in the world.”

Narrator: “As private businessmen and government operatives, Shackley, Clines, and Secord, along with Wilson, and middleman Albert Hakim, turned their attention to the Mid-East. They supplied arms to Mid-East governments while skimming off huge profits into hidden bank accounts around the world. They secretly supplied weapons and military intelligence to Nicaraguan dictator Anastasio Somoza and helped the Shah of Iran eliminate his enemies.”

Sheehan: “There is an early bond between Iran and Nicaragua. The bond is this secret team of men. So throughout that period from October of 1977 to December of 1978, this secret team has two major operations: One, to support the Shah, the other to support the right-wing dictator Anastasio Somoza in Nicaragua. This was their world at that time. The Shah collapses in December of ’78, and Anastasio Somoza collapses in July of 1979.”

Narrator: “After the overthrow of Somoza, many of his former national guardsmen fled to Honduras where they were organized and trained by the CIA as a counter revolutionary force to fight against the new government in Nicaragua.”

Sheehan: “They began to create the Contras to try to do the identical thing that was done by the supporters of Batista against the Cuban revolutionary government back in 1959. Not an indigenous force inside Nicaragua that they had any support from any of the population in Nicaragua. It was a total artifice that was created by these men.”

Narrator: “One of the original Contra political leaders was Edgar Chamorro. He joined the Contras in 1981.”

Edgar Chamorro: “Yeah, I became involved with the Contras because the CIA using people from the White House, they invited me to be one of the Contra leaders. I was told that this was just a war for a year. That the United States wanted to put this pressure on Nicaragua, but then after a year or so, I found out that this was not the case. We were being used to deceive the American people. We were being used to lie to Congress. The tactics used by the Contras were tactics of terrorizing civilians, making situations where civilians were getting killed.”

John Stockwell: “In Nicaragua, under President Reagan, they are, in fact, giving the Contras written instructions in violence and destabilization. The target is the people, the social and economic infrastructure is what you are hitting at. It is not a bloodbath. It is like you are going in a village and you kill a few people to make your point. The purpose is to disseminate terror, traumatize the people. We’re not killing Sandinistas in the capital. We’re not blowing up their homes and terrorizing them. We are hitting at the people throughout the interior of the country.”

Narrator: “In the early 1980s, when the CIA was working to establish a southern front in Costa Rica in the war against Nicaragua, a relationship was established with John Hull, an American rancher living in Costa Rica. There is mounting evidence that the air strips on Hull’s ranch became not only a delivery point for illegal contra weapon shipments from the U.S., but were also used for transporting cocaine into the United States.”

Stockwell: “You have CIA bases in Costa Rica and Honduras. You have airplanes flying back and forth continuously, landing at bases in the United States, where they don’t have to go through regular customs with the CIA escorting the people in and out and a certain *laissez-faire* in the attitude at best at the customs if there is any customs representation there. So it is a dream situation for drug smugglers.”

Narrator: “But CIA involvement in the drug business did not start in Central America. It dates back at least as far as the Vietnam war.”

Professor Peter Dale Scott: “The three men, Shackley and Singlaub and Secord, were all working together from different countries on the huge CIA secret

war in Laos. Our allies were the opium-growing tribesmen and this meant that we continued in a very large way, not only to support, but really to augment a flow of heroin. This had to be run with the knowledge and the approval of the people who were in charge of these air operations. And these air operations had been controlled in the '66-'68 period by General Secord."

Daniel Sheehan: "The weapons trade and the narcotics trade in the world are two of the top five major money-making transactions in the whole world. These two major commodities in the world are hundreds of billions of dollars that go on. So the amount of money we are talking about here is absolutely gargantuan! In all of the intelligence community these guys have gone outside the governmental structures [and] are tapping into hundreds of millions, which they need to run their operations."

Street interview: "Do you think the Iran-Contra scandal will have an effect on future government operations?"

Reply: "No. I think it will be more of the same."

Reply: "I don't think it is going to have much of an effect at all. I just think they will be more careful next time."

Reply: "They will continue to carry on covert operations. I think this has been going on forever."

Reply: "They make laws which are for us that they don't seem to apply to themselves very often."

Reply: "And who was going to inhibit them? The gangsters that are running this country is going to inhibit somebody!"

Sheehan: "What's happening here my friends, is a major deception, a major deception which is in process as we stand and talk tonight. A major deception in the same way that the Warren Commission was a major deception worked upon the American people. The same way that the Watergate investigation was a major deception worked upon the American people. Just like the bombing, the secret bombing of Cambodia was kept secret and was a deception worked upon the American people. How long, how long, are we going to stand for being deceived in this manner?"

John Stockwell: "Assassination, drug smuggling. If they had pursued that line of questioning they would have soon gotten themselves into a position where they would have had to impeach someone. They could track that right back into the White House. They could put it at least right under the nose of Ronald Reagan."

Rep. Henry Gonzalez (Democrat – Texas): "This is the major constitutional crisis since the Civil War. You have a president who is unaccountable and says that it's his interpretation of what laws he'll select to obey. When you have that, you have a constitutional crisis."

Peter Dale Scott: "Covert operations have never done this country any good. They may be of momentary advantage to the people who are in power at a particular moment, but in terms of the interest of this country as a whole, they have proven disastrous. There isn't a single one in 30 years that you can point to and say, 'well, that was one that we are now more secure, better off and happier as a result of.' Every one of them has in its own way contributed to the deterioration of security in the world that we live in. And so it is really time to stop them."

Rep. Jack Brooks (Democrat–Texas): "Instead of operating within rules and law, we have been supplying lethal weapons to terrorists nations. Trading arms for hostages. Involving the U.S. government in military activities in direct contravention of the law. Diverting public funds into private pockets and secret unofficial activities. Selling access to the President for thousands of dollars. Dispensing cash and foreign money orders out of a White House safe. Accepting gifts and falsifying papers to cover it up. Altering and shredding national security documents. Lying to the Congress. Now I believe that the American people understand that democracy cannot survive that kind of abuse."

CHAVEZ INFLUENCE GROWING

The economic reforms and nationalist policies being advanced by Hugo Chavez, the populist president of Venezuela, are liberating Latin American nations from the suffocating grip of the international financial oligarchy. The wide-ranging reforms promoted by Chavez are being financed by the immense oil wealth of Venezuela, the world's fifth-largest exporter of oil. The year 2006 brought increased state control of Venezuela's oil production.

Venezuela, with the largest proven oil reserves outside of the Middle East, produces more than 3 million barrels of oil per day. On Jan. 1, Venezuelan Oil Minister Rafael Ramirez announced that 32 privately operated oil fields had come under state control with the start of 2006. ...

The soaring price of crude oil has allowed Chavez to support other nations and economic reforms across the region. From Argentina, for example, Venezuela purchased more than \$1 billion in bonds in 2005 and may buy as much as \$2 billion more.

"Venezuela has been supporting Argentina in freeing it from International Monetary Fund debt, and we will continue, as much as we can, to help Argentina end its dependence on the IMF," Chavez said.

The Venezuelan investment allowed Argentina's President Nestor Kirchner to completely pay off its \$9.8 billion debt to the IMF on Jan. 3. ...

Many Argentines believe that the IMF was responsible for the disastrous economic policies that caused the financial crisis of 2001 and then abandoned the country to recover on its own.

Chavez has proposed the creation of a new multilateral bank to free the region from IMF influence and the increasing "dollarization" of the region. He called on Brazil and Argentina to contribute some of their international reserves to help fund the new regional bank.

... Chavez said South American countries should disinvest from rich countries that "manipulate, lend and make a lot of money off our resources." Venezuela's central bank, for example, sold \$10 billion of U.S. bonds and other U.S. assets in the first half of 2005.

"How stupid we've been," said Chavez.

The Bolivian president-elect, Evo Morales, met Chavez in Caracas as he began a seven-nation world tour. Morales said he and the Venezuelan president were united in a "fight against neo-liberalism and imperialism".

Morales and Chavez represent a growing number of Latin American leaders who are opposed to U.S. attempts to impose a "free trade" agreement on the region.

Morales, a Socialist, is the first Bolivian politician to be elected with an absolute majority having won 54 percent of the vote. Morales is also the first Indian to come to power in Bolivia where 85 percent of the population is indigenous.

During the trip, Morales discussed his plans to nationalize Bolivia's vast natural gas holdings, the second largest in South America. "Hydrocarbons and their nationalization—we're going to talk about that," Chavez said as he met Morales at Caracas's international airport.

If the United States "wants bilateral diplomatic and commercial relations, it will have them, but without submission, without subordination, without conditions and without blackmail," Morales said in Cuba. ...

EXECUTIVE SUMMARY

The only savior of the Philippine and its citizenry in this time of economic difficulty in the middle of disunity of Filipino people and destabilization threat against the present government is the termination of the lease contract of 617,500 metric tons of gold lent to the government in 1949 by the Royal Family to serve as gold reserves required in the establishment of the new Central Bank of the Philippines. Other corroborating evidences on this can be found on the Monetary Board Meeting last January 3, 1949 at the new office of CB at 6th floor of PNB, Manila were it was mentioned on its 2nd page that 217,500 M.T. of gold was assigned, exported and

distributed for the benefit of Asian Pacific Nations while the 400,000 M.T. were deposited in trust with SKR No. A & B 51263 CR. 1950 to back up Victory Notes where the beneficiaries are the Filipino people.


Further to these, the said quantity of gold (617,500M.T.) is owned by the Royal Family or Tallano clan, however only 400,000 M.T. was lent and approved by the CB. Said document was signed by the then late Gov. Miguel Cuaderno, Sr., Pres. Elpidio Quirino, Pres. Harry S. Truman, Dwight D. Eisenhower, Atty. Ferdinand E. Marcos, Fr. Jose Antonio Diaz, Jose Bautista Cruz & Jesus Antonio Cruz.

The CORPORATION (CSEML) rejects hereby any association whatsoever at any time, past or present, claimed by Vina Katherine Durham, V.K. Durham, and all other of her affected self-designations. With that foundation, we will quote (again, exactly) from her recent writing of 11/28/05:

"USAF, USCG, UST, CIA, COL. RUSSELL HERRMAN-HERMAN was a ARMS DEALER for THE PRESIDENTS OF THE UNITED STATES. I did not know that at first, but I know it now! His operation was based in Chicago, with offices in the NW Corner of the Pentagon, and Curacao. It had never had a bank account nor had it filed a tax return because it had done no taxable transactions.

Ms. Durham makes the further allegation by innuendo that "the Boatmen's Bank Account would be used for laundering money in what is called a pass through or in and out account and used by THE CONTRAS men to launder the fall out on the two \$120 Billion Dollar Gold 10 year term transactions beginning 9/12/91..."

More malicious, baseless lies. The whistle was blown on Iran-Contra in November 1986, long before VK learned of 3392 and during a period when she was in a coma or at least in a wheelchair and unable to speak--injured in 1983 and "rescued" by Russell Herman in 1987-88--according to her own story which was written in 1994, more than 10 years closer to the time now being "recalled". She continues to attempt to represent that the so-called "Brady Bonds" issued 9/12/91 were destroyed in the World Trade Towers 9/11/2001 and thus became somehow "lost" and would not be paid. That is complete nonsense and confirms the lack of knowledge of the woman. Now she even further bends the truth by referring to them as "Gold 10 year term..." No, they are not, and never were "gold" anything. Neither is it possible that the Boatmen's bank account would be "used by THE CONTRAS men to launder the fall out on the two \$120 Billion Dollar Gold 10 year term transactions beginning 9/12/91". THE CONTRAS men were fighting to stay out of jail in 1991 and were not pardoned by Bush until December 24, 1992. The stories and pronouncements from Ms. Durham become ever-increasingly bizarre but most readers of her material have no other facts with which to compare.

As a signatory of the contract confirmed by jurat of the Peruvian Consulate in Los Angeles, California, V.K. Durham has been unable to deny that the Peruvian bearer bond 3392-181 was reconfirmed and reissued as a contract of identifiable ownership to Cosmos Seafood Energy Marketing, Ltd. on August 21, 1989. Neither can she deny that, in the same document, it is recorded that ownership had been transferred to the

Fortress-Like Shelter Or House Of Cards?

Budget’s “Tip of the Week” #7:

Checklist for Adherence to Corporate Formalities

Proper operation of a corporation can make the difference between having a fortress-like shelter or a precariously balanced “house of cards”. If you are operating a Nevada corporation, you might want to review this checklist to determine for yourself which you are building:

- Read and understand the Articles of Incorporation and Bylaws and act in conformance with them.
- Read the governing law for the corporation: *Nevada Revised Statutes (NRS), Chapter 78.*
- Include reports of officers and committees in the corporate records.
- Record all major decisions of Directors in corporate resolutions or meeting minutes.
- Document contracts, even (perhaps especially) verbal ones, within the corporate records.
- Correctly handle and document corporate loans, making interest payments as required.
- Properly maintain the corporation’s books and accounting records.
- Whenever signing on behalf of the corporation, indicate title; do not sign personally or you may forego the inherent liability protection normally afforded by Nevada’s statutes.

Additionally, if stock is issued:

- Hold annual meetings of stockholders.
- All actions of stockholders must be done by vote and duly recorded.
- Give proper notice or use appropriate waiver of notice (usually specified in the Bylaws) for stockholders’ meetings.
- Elect directors as necessary and conduct other business in appropriate meetings, duly recorded.
- Hold regular meetings of the Board of Directors, at least annually.
- Give proper notice or use appropriate waiver of notice (usually specified in the Bylaws) for directors’ meetings.
- Elect officers and conduct other business in the manner specified in the Articles of Incorporation and the corporation’s Bylaws.
- Record proper minutes of such meetings.
- Maintain the stock ledger properly.

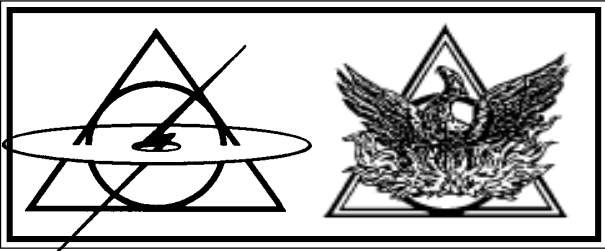
