

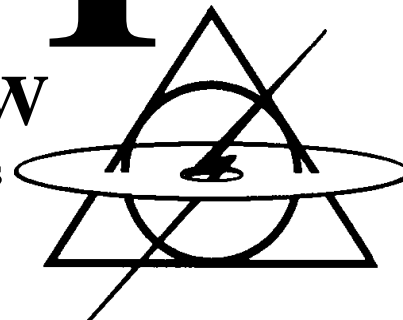

'Showdown with Iran' Due To Euro-Driven Oil Bourse

The drums of war are beating loudly as the U.S. seeks to block Iran from developing its nuclear capability. While Russia, China and other countries are taking a moderate approach aimed at non-proliferation of nuclear weapon technology, they would not deny Iran the ability to develop nuclear power-generating facilities.

What is NOT being presented is the real reason for U.S. belligerence: Iran is starting up an oil bourse in March 2006 which will accept payment in euros instead of dollars, threatening the dollar's status as THE world reserve currency.

I. Economics of Empires

A nation-state taxes its own citizens, while an empire taxes other nation-states. The history of empires, from Greek and Roman, to Ottoman and British, teaches that the economic foundation of every single empire is the taxation of other nations. The imperial ability to tax has always rested on a better and stronger economy, and as a consequence, a better and stronger military. One part of the subject taxes went to improve the living standards of the empire; the other part went to strengthen the military dominance necessary to enforce the collection of those taxes.

Historically, taxing the subject state has been in various forms—usually gold and silver, where those were considered money, but also slaves, soldiers, crops, cattle, or other agricultural and natural resources, whatever economic goods the empire demanded and

the subject-state could deliver. Historically, imperial taxation has always been direct: the subject state handed over the economic goods directly to the empire.

For the first time in history, in the twentieth century, America was able to tax the world indirectly, through inflation. It did not enforce the direct payment of taxes like all of its predecessor empires did, but distributed instead its own fiat currency, the U.S. Dollar, to other nations in exchange for goods with the intended consequence of inflating and devaluing those dollars and paying back later each dollar with less economic goods—the difference capturing the U.S. imperial tax. Here is how this happened.

Early in the 20th century, the U.S. economy began to dominate the world economy. The U.S. dollar was tied to gold, so that the value of the dollar neither increased, nor decreased, but remained the same amount of gold. The Great Depression, with its preceding inflation from 1921 to 1929 and its subsequent ballooning government deficits, had substantially increased the amount of currency in circulation, and thus rendered the backing of U.S.

dollars by gold impossible. This led Roosevelt to decouple the dollar from gold in 1932. Up to this point, the U.S. may have well dominated the world economy, but from an economic point of view, it was not an empire. The fixed value of the dollar did not allow the Americans to extract economic benefits from other countries by supplying them with dollars convertible to gold.

Economically, the American Empire was born with Bretton Woods, NH in 1945. The U.S. dollar was not fully convertible to gold, but was made convertible to gold only to foreign governments. This established the dollar as the reserve currency of the world. It was possible, because during WWII, the United States had supplied its allies with provisions, demanding gold as payment, thus accumulating significant portion of the world's gold. An Empire would not have been possible if, following the Bretton Woods arrangement, the dollar supply was kept limited and within the availability of gold, so as to fully exchange back dollars for gold. However, the guns-and-butter policy of the 1960s was an imperial one: the dollar supply was relentlessly increased to finance Vietnam and LBJ's Great Society. Most of those dollars were handed over to foreigners in exchange for economic goods, without the prospect of buying them back at the same value. The increase in dollar holdings of foreigners via persistent U.S. trade deficits was tantamount to a tax—the classical inflation tax that a country imposes on its own citizens, this time around an inflation tax that U.S. imposed on rest of the world.

When in 1970-1971 foreigners demanded payment for their dollars in gold, the U.S. Government defaulted on its payment on August 15, 1971. While the popular spin told the story of “severing the link between the dollar and gold”, in reality the denial to pay back in gold was an act of bankruptcy by the U.S. Government. Essentially, the U.S. declared itself an Empire. It had extracted an enormous amount of economic goods from the rest of the world, with no intention or ability to return those goods, and the world was powerless to respond—the world was taxed and it could not do anything about it.

From that point on, to sustain the American Empire and to continue to tax the rest of the world, the United States had to force the world to continue to accept ever-depreciating dollars in exchange for economic goods and to have the world hold more and more of those depreciating dollars. It had to give the world an economic reason to hold them, and that reason was OIL.

In 1971, as it became clearer and clearer that the U.S. Government would not be able to buy back its dollars in gold, it made in 1972-73 an iron-clad arrangement with Saudi Arabia to support the power of the House of Saud in exchange for accepting ‘only’ U.S. dollars for its oil. The rest of OPEC was to follow suit and also accept only dollars. Because the world had to buy oil from the Arab oil countries, it had the reason to hold dollars as payment for oil. Because the world needed ever increasing quantities of oil at ever increasing oil prices, the world's demand for dollars could only increase. Even though dollars could no longer be exchanged for gold, they were now exchangeable for OIL.

The economic essence of this arrangement was that the dollar was now backed by OIL. As long as that was the case, the world had to accumulate increasing amounts of dollars, because they needed those dollars to buy oil. As long as the dollar was the ONLY acceptable payment for oil, its dominance in the world was assured, and the American Empire could continue to tax the rest of the world. If, for any reason, the dollar lost its oil backing, the American Empire would cease to exist. Thus, Imperial survival

dictated that oil be sold only for dollars. It also dictated that oil reserves were spread around various sovereign states that weren't strong enough, politically or militarily, to demand payment for oil in something else. If someone demanded a different payment, he had to be convinced, either by political pressure or military means, to change his mind.

The man that actually did demand EURO for his oil was Saddam Hussein in 2000. At first, his demand was met with ridicule, later with neglect, but as it became clearer that he meant business, political pressure was exerted to change his mind. When other countries, like Iran, wanted payment in other currencies, most notably Euro and Yen, the danger to the dollar was clear and present, and a punitive action was in order. Bush's ‘Shock-and-Awe’ in Iraq was NOT about Saddam's nuclear capabilities, about defending human rights (please), about spreading democracy, or even seizing OIL fields; it was about defending the dollar, ergo the American Empire. It was about setting an EXAMPLE that anyone who demanded payment in currencies other than U.S. Dollars would likewise be punished.

Many have criticized Bush for staging the war in Iraq in order to seize Iraqi oil fields. However, those critics can't explain why Bush would want to seize those fields—he could simply print dollars for nothing and use them to get all the oil in the world that he needs. He must have had some other reason to invade Iraq.

History teaches that an empire should go to war for one of two reasons: (1) to defend itself or (2) benefit from war; if not, as Paul Kennedy illustrates in his magisterial *The Rise and Fall of the Great Powers*, a military overstretch will drain its economic resources and precipitate its collapse. Economically speaking, in order for an empire to initiate and conduct a war, its benefits must outweigh its military and social costs. Benefits from Iraqi oil fields are hardly worth the long-term, multi-year military cost. Instead, Bush must have went into Iraq to defend his Empire. Indeed, this is the case: two months after the United States invaded Iraq, the Oil for Food Program was terminated, the Iraqi Euro accounts were switched back to dollars, and oil was sold once again only for U.S. dollars. No longer could the world buy oil from Iraq with EURO. Global dollar supremacy was once again restored. Bush descended victoriously from a fighter jet and declared the mission accomplished—he had successfully defended the U.S. dollar, and thus the American Empire.

II. Iranian Oil Bourse

The Iranian government has finally developed the ultimate “nuclear” weapon that can swiftly destroy the financial system underpinning the American Empire. That weapon is the Iranian Oil Bourse slated to open in March 2006. It will be based on a euro-oil-trading mechanism that naturally implies payment for oil in EURO. In economic terms, this represents a much greater threat to the hegemony of the dollar than Saddam's, because it will allow anyone willing either to buy or to sell oil for Euro to transact on the exchange, thus circumventing the U.S. dollar altogether. If so, then it is likely that almost everyone will eagerly adopt this EURO oil system:

a.. The Europeans will not have to buy and hold dollars in order to secure their payment for oil, but would instead pay with their own currencies. The adoption of the euro for oil transactions will provide the European currency with a reserve status that will benefit the European at the expense of the Americans.

c.. The Chinese and the Japanese will be especially eager to adopt the new exchange, because it will allow them to drastically lower their enormous dollar reserves and diversify with EUROS, thus

protecting themselves against the depreciation of the dollar. One portion of their dollars they will still want to hold onto; a second portion of their dollar holdings they may decide to dump outright; a third portion of their dollars they will decide to use up for future payments without replenishing those dollar holdings, but building up instead their euro reserves.

e.. The Russians have inherent economic interest in adopting the Euro—the bulk of their trade is with European countries, with oil-exporting countries, with China, and with Japan. Adoption of the Euro will immediately take care of the first two blocs, and will over time facilitate trade with China and Japan. Also, the Russians seemingly detest holding depreciating dollars, for they have recently found a new religion with gold. Russians have also revived their nationalism, and if embracing the Euro will stab the Americans, they will gladly do it and smugly watch the Americans bleed.

g.. The Arab oil-exporting countries will eagerly adopt the Euro as a means of diversifying against rising mountains of depreciating dollars. Just like the Russians, their trade is mostly with European countries, and therefore will prefer the European currency both for its stability and for avoiding currency risk, not to mention their jihad against the Infidel Enemy.

Only the British will find themselves between a rock and a hard place. They have had a strategic partnership with the U.S. forever, but have also had their natural pull from Europe. So far, they have had many reasons to stick with the winner. However, when they see their century-old partner falling, will they firmly stand behind him or will they deliver the *coup de grace*? Still, we should not forget that currently the two leading oil exchanges are the New York's NYMEX and the London's International Petroleum Exchange (IPE), even though both of them are effectively owned by the Americans. It seems more likely that the British will have to go down with the sinking ship, for otherwise they will be shooting themselves in the foot by hurting their own London IPE interests. It is here noteworthy that for all the rhetoric about the reasons for the surviving British Pound, the British most likely did not adopt the Euro namely because the Americans must have pressured them not to: otherwise the London IPE would have had to switch to Euros, thus mortally wounding the dollar and their strategic partner.

At any rate, no matter what the British decide, should the Iranian Oil Bourse accelerate, the interests that matter—those of Europeans, Chinese, Japanese, Russians, and Arabs—will eagerly adopt the Euro, thus sealing the fate of the dollar. Americans cannot allow this to happen, and if necessary, will use a vast array of strategies to halt or hobble the operation's exchange:

a.. Sabotaging the Exchange—this could be a computer virus, network, communications, or server attack, various server security breaches, or a 9-11-type attack on main and backup facilities.

c.. *Coup d'état*—this is by far the best long-term strategy available to the Americans.

e.. Negotiating Acceptable Terms & Limitations—this is another excellent solution to the Americans. Of course, a government coup is clearly the preferred strategy, for it will ensure that the exchange does not operate at all and does not threaten American interests. However, if an attempted sabotage or *coup d'état* fails, then negotiation is clearly the second-best available option.

g.. Joint UN War Resolution—this will be, no doubt, hard to secure given the interests of all other member-states of the Security Council. Feverish rhetoric about Iranians developing nuclear weapons undoubtedly serves to prepare the course of action.

i.. Unilateral Nuclear Strike—this is a terrible strategic choice for all the reasons associated with the next strategy, the Unilateral Total War. The Americans will likely use Israel to do their dirty nuclear job.

j.. .

k.. Unilateral Total War—this is obviously the worst strategic choice. First, the U.S. military resources have been already depleted with two wars. Secondly, the Americans will further alienate other powerful nations. Third, major dollar-holding countries may decide to quietly retaliate by dumping their own mountains of dollars, thus preventing the U.S. from further financing its militant ambitions. Finally, Iran has strategic alliances with other powerful nations that may trigger their involvement in war; Iran reputedly has such alliance with China, India, Russia, known as the Shanghai Cooperative Group, a.k.a. Shanghai Coop and a separate pact with Syria.

Whatever the strategic choice, from a purely economic point of view, should the Iranian Oil Bourse gain momentum; it will be eagerly embraced by major economic powers and will precipitate the demise of the dollar. The collapsing dollar will dramatically accelerate U.S. inflation and will pressure upward U.S. long-term interest rates. At this point, the Fed will find itself between Scylla and Charybdis—between deflation and hyperinflation—it will be forced fast either to take its “classical medicine” by deflating, whereby it raises interest rates, thus inducing a major economic depression, a collapse in real estate, and an IMPLOSION in bond, stock, and derivative markets, with a total financial collapse, or alternatively, to take the WEIMAR way out by inflating, whereby it pegs the long-bond yield, raises the Helicopters and drowns the financial system in liquidity, bailing out numerous LTCMs and hyperinflating the economy.

The Austrian theory of money, credit, and business cycles teaches us that there is no in-between Scylla and Charybdis. Sooner or later, the monetary system must swing one way or the other, forcing the Fed to make its choice. No doubt, Commander-in-Chief Ben Bernanke, a renowned scholar of the Great Depression and an adept Black Hawk pilot, will choose inflation. Helicopter Ben, oblivious to Rothbard’s America’s Great Depression, has nonetheless mastered the lessons of the Great Depression and the annihilating power of deflations. The Maestro has taught him the panacea of every single financial problem—to inflate, come hell or high water. He has even taught the Japanese his own ingenious unconventional ways to battle the deflationary liquidity trap. Like his mentor, he has dreamed of battling a Kondratieff Winter. To avoid deflation, he will resort to the printing presses; he will recall all helicopters from the 800 overseas U.S. military bases; and, if necessary, he will monetize everything in sight. His ultimate accomplishment will be the hyperinflationary destruction of the American currency and from its ashes will rise the next reserve currency of the world—that barbarous relic called gold.

SEGMENT #4: SCHOOL OF THE AMERICAS, SCHOOL OF ASSASSINS

Susan Sarandon, Narrator: "In the late afternoon of December 4th 1980, an unmarked grave was found in a field in El Salvador. When it was opened in the presence of the U.S. Ambassador, it revealed the bodies of four women: Maryknoll Sisters Maura Clark and Ita Ford, Ursuline Sister Dorothy Kazel and lay missionary, Jean Donovan. Of the five officers later found responsible for the rape and murder of these women, three were graduates of the United States Army School of the Americas. The School of the Americas originated in 1946 in Panama. Now it is located on the grounds of Fort Benning, Georgia. The school teaches commando operations, sniper training, how to fire an M16 and psychological warfare. Since no major declared war between Latin American countries has occurred in decades and the communist threat has vanished, why provide this kind of training?"

Representative Joseph Kennedy: "If you look at the course ranges that are offered to these individuals, they, in fact, are a dedicated way of teaching military leaders in foreign nations how to subvert their local communities."

Narrator: "Since it opened, over 55,000 military officials from 23 Latin American and Caribbean countries have trained at the school. About 2,000 students a year. As facts have emerged about the school and its graduates, it has drawn the attention of a growing number of human rights activists such as Maryknoll Father Roy Bourgeois."

Father Roy Bourgeois: "Just down the road here is a school, the School of the Americas. It's a combat school. Most of the courses revolve around what they call "counter-insurgency warfare". Who are the insurgents? We have to ask that question. They are the poor. They are the people in Latin America who call for reform. They are the landless peasants who are hungry. They are health care workers, human rights advocates, labor organizers, they become the insurgents, they're seen as "*El Enemigo*", the "Enemy". And they are those who become the targets of those who learn their lessons at the School of the Americas."

Narrator: "What has been learned about the lessons taught at the school? In the 1980s, the civil war in El Salvador became a focal point for human rights activists throughout the world. Death squads operated freely,

often killing 50 people a night. There [were] so many cases that on March 23rd. 1980, Archbishop Oscar Romero in San Salvador, made a plea to the military leaders of his country."

Archbishop Oscar Romero (translated from Spanish): "I would like to make an appeal in a special way to the men of the army. In the name of God, in the name of the suffering people whose laments rise to the heavens each day more tumultuous. I beg you! I ask you! I order you! In the name of God, stop the repression!"

Narrator: "While celebrating mass the next day, Archbishop Romero was assassinated. A number of years later, the National Security Archives in Washington, D.C., made an important discovery when they obtained a copy of a declassified cable."

Kate Doyle: "These two cables are both from the American Embassy in El Salvador. One is from Dean Hinton who was then Ambassador to El Salvador in 1981, and it discusses a meeting during which Roberto D'Aubuisson plans the murder of Archbishop Romero. During the meeting, there is described a lottery that the people who are attending the meeting hold to see who would draw the right to kill Romero himself."

Narrator: "D'Aubuisson was trained at the School of the Americas. Also trained at the school were two of the three officers directly responsible for the assassination. December 11, 1981, El Mazote, a small village in El Salvador."

Rufina Amaya – El Mazote: "First, they forced everyone out of their houses and made us all lie face down in the street, both men and women. There were soldiers on both sides. Then they moved away to see the women kneeling down on the ground to pray. They killed all of them. Not a single one of them survived, just me by the grace of God. I hid under a tree. When I heard the screams of the children, and I knew which ones were mine, they were crying, "Mommy! They're killing us!"

Narrator: "Over 900 men, women and children were massacred. Virtually the entire population of the village and the area surrounding El Mazote. Out of 143 bodies identified in the laboratory, 131 were children under the age of 12, including three infants under the age of 3 months. Ten of the twelve officers cited as responsible for the El Mazote massacre were graduates of the School of the Americas. They were members of the Atlacatl Battalion, a part of the El Salvador army. November 16, 1989, San Salvador: Six Jesuit priests, their housekeeper and her 15 year-old daughter, were slaughtered. To get the facts about this incident, a U.S. congressional investigation began, led by Representative Joseph Moakley."

Representative Joseph Moakley: "I went down, talked with the Embassy, talked with the military, talked with the unionists. The killing was done by the Atlacatl Battalion which is the crack battalion in that country. And these are the people, some of them had just returned from the United States where they were taught a course in Human Rights, amongst other things."

Narrator: "Nineteen of the 26 officers implicated in the Jesuit murders were graduates of the school. The United

Nations Truth Commission Report released on March 15th 1993, cited specific officers for committing atrocities during the El Salvador civil war. At School of the Americas Watch, just outside Fort Benning, Georgia, Vicky Immerman matched the names cited in the UN report with names in the United States government document."

Vicky Immerman: "What I did was, I took these officers, all the officers listed in the report, and I took their names and looked them up in this list of graduates of the School of the Americas, which we received through the *Freedom of Information Act*. What I found were 49 of the 60 some officers listed were graduates of the School of the Americas."

Narrator: "El Salvador is only part of the school's story. In the entry area of one of its main buildings are photographs of those the school honors. Its so-called "Hall of Fame". At the top of list, Hugo Bonzer, former dictator of Bolivia, a graduate of the school. Some of the others similarly honored are the former dictators of Honduras, Ecuador and Argentina and Generals from eight other Latin and Caribbean nations, many cited by human rights groups of involvement in human rights abuses in their own countries. Among other graduates, Manuel Noriega, former President of Panama, currently in prison in the United States. Four of the five ranking Honduran officers who organized death squads in the 1980s as part of Battalion 316, are graduates. Half of the 250 Colombian officers cited for human rights abuses attended the school. The three highest ranking Peruvian officers convicted in February 1994 of murdering nine university students and a professor, were all graduates. During the dictatorship of the Somoza family, over 4,000 National Guard troops graduated from the school. Many of them later became known as the Contras responsible for the deaths of thousands of Nicaraguan peasants in the 1980s. The General in charge of Argentina's so-called "dirty war" was a school graduate. During that internal conflict in the late 1970s and early 1980s an estimated 30,000 people were tortured, disappeared and murdered. General Hector Gramajo of Guatemala was the featured speaker at the school's graduation ceremonies in 1991. Human rights groups claim he is the architect of strategies that legalized military atrocities in Guatemala, resulting in the death of over 200,000 men, women and children."

Father Roy Bourgeois: "As a Catholic priest, as a U.S. citizen, I really feel a responsibility to speak out against that because of this. This does not lead to healing. It leads to death and suffering. In a way, this is a death machine. And this I want to say is very close to home because it's in our backyard. It is not out there in El Salvador. This is not in South Africa. We are talking about a school of assassins right here in our backyard being supported and financed through our tax money. It's being done in our name."

Narrator: "On September 30, 1993, the School of the Americas was debated by Congress for the first time in its history. It happened when an amendment to the Defense Department budget was introduced by Congressman Joseph Kennedy."

Congressman Joseph Kennedy: "Mister Speaker, my amendment would reduce the army operation and maintenance account by \$2.9 million. The amount dedicated to running the Army's School of the Americas at Fort Benning, Georgia. The intent of this amendment is to close the school. We're only 30 or 40 votes short of winning. That means that if people around the country hear about this and write their congressman, we can win. This is an issue that we can win on."

Father Roy Bourgeois: "What's very important right now, I feel, is to let our voices be heard. Bishop Romero said it best before he was killed, before he was assassinated by someone who trained at the School of the Americas. He said, "We who have a voice, we have to speak for the voiceless." And I realize that we here in this country, we have a voice. We can speak without having to worry about being disappeared, or

tortured, or being picked up. We *can* speak. And I just hope that we can speak clearly and boldly on this issue.”
Voice of translator (woman speaking Spanish): “I am not very educated but in my simple words I think that the only thing the School of the Americas has accomplished is the destruction of our countries in Latin America. Don’t give us any more of that military aid. It would be better to help the poor who are in need.”
Father Roy Bourgeois: “We need the voices of others and we also need those letters to congressional leaders to let them know that we will not allow them to use our money to run a school of assassins.”

SEGMENT #5: GENOCIDE BY SANCTIONS

Voice of Iraqi doctor: “For now, the diagnosis is not settled for this child. He has had prolonged fever and he is wasting.”

Leslie Stahl (CBS *Sixty Minutes* interview, 11 May 1996): “We have heard that a half a million children have died. I mean, that’s more children than died in Hiroshima. And, you know.....is the price worth it?”

Madeleine Albright (US Secretary of State): “I think this is a very hard choice. But the price, we think the price is worth it.”

Narrator: “Worth it, because she believes the sanctions are working.”

Narrator: “In November 1997, former U.S. Attorney General Ramsey Clark headed a delegation of the International Action Center on his seventh trip to Iraq to investigate the continued effects of the United Nations’ sanctions on the population. We were shocked by what we saw. An almost total absence of medicines, medical supplies and spare parts for the equipment. Despite the heroic efforts of medical personnel, babies, children and the chronically ill continued to die in vast numbers. The United States government claims that Saddam Hussein is to blame for the crisis. What is the real cause of the suffering? The sanctions. They are an extension of the 1991 United States war against Iraq. The goal was to cripple Iraq’s infrastructure and make civilian life unsustainable.”

Ramsey Clark, former U.S. Attorney General: “We demonstrated the capacity of technology to cripple a country without ever setting foot on it in the Persian Gulf. It’s important to recognize that because it goes hand in hand with the sanctions. When we merely say that we flew 110,000 aerial sorties in 42 days, one every 30 seconds on the average, 24 hours a day, we ignore what we really did.”

Bill Blakemore, ABC News correspondent: “The officials said the death toll was now 288 with many more to come. The trucks kept filling up and driving away past waiting relatives who knew they might never be able to identify the bodies of their loved ones. The community of Ameriyah filled one of the first of many funerals with gunfire in signs of grief and fury, and with angry words aimed through foreign journalists. ‘My mother, she’s gone!’ shouted this young man.”

Voice of Iraqi woman crying: “Why!? Children! Girls! Boys! Man, woman! Why!? Why!?”

Blakemore: “This woman asked, ‘‘Could not all your modern technology tell you that there were children and women here? Bill Blakemore ABC News in the Ameriyah district of Baghdad.”

Ramsey Clark: “We destroyed every silo for grain or anything else storing food in the whole country. We destroyed all the storage and processing of food plants throughout the country. Even dates, the world’s biggest exporter of dates. Famous processing and packaging plants in Baghdad, deliberately destroyed. We didn’t want them to be able to feed themselves for a long, long time. We’re all aware of the famous little powdered milk plant.”

Unknown voice: “The United States government says

that in this factory here you were making chemical weapons. Is that true?”

Iraqi man: “No that’s not true. They are lie because this is milk for children. This powder – milk of children.”

Unknown voice: “Nothing else is made only this in the factory?”

Iraqi man: “Yes, and you can see in yourself.”

Ramsey Clark: “The only factory in the Middle East to produce powdered milk, they were producing about 17 per cent of their powdered milk requirements. We destroyed that. Cut off all the milk. The malnutrition of the mothers immediately jeopardized all of the infants. Seventy per cent of the pregnant women even today in Iraq suffer anemia.”

Caption: “Death rate under 5 years of age: Monthly average in 1989: 593, September 1997: 4,578 = 672% increase.”

Narrator: “The death rate for children has soared compared to 1989, the last year before sanctions. One of the biggest causes of death in Iraqi children today is diarrhea and dysentery due to the untreated drinking water. Iraq’s water purification plants were heavily bombed in the war and many that were repaired have broken down. The United Nations bans the import of spare parts and chlorine into Iraq to purify water. We saw the effects of this policy in the hospitals.”

Voice of Iraqi doctor examining child: “This is the second attack for him of acute bloody diarrhea and amoebic dysentery. Most of them are due to contamination of water. He is malnourished, anemic, underweight, with a developmental delay.”

Voice of Iraqi man: “Diarrhea and vomiting.”

Ramsey Clark: “Do you have tap water there?”

Voice of Iraqi man: “No.”

Ramsey Clark: “You can see the conditions of these children shouldn’t happen anywhere and is caused by the sanctions the United States government insists upon.”

Narrator: “The U.S. military used 800 tons of depleted uranium weapons in the war, causing a rise in cancers among the population. Why does the United States government spend \$50 billion a year to patrol the Persian Gulf and keep Iraq locked down?”

President Bill Clinton: “There are those who would like to lift the sanctions. I am not among them.”

Tariq Aziz: “Our main objective, our main objective is lifting the sanctions which has been very, very cruel on our people.”

Larry King: “Why do you think Americans want to keep the sanctions?”

Aziz: “That’s their policy.”

King: “Why do you think?”

Rania Masri, Iraq Action Coalition: “Starvation of civilians as a method of warfare is prohibited by international law! The sanctions are a violation of the *Geneva Convention*, the *United Nations Charter*, the *Constitution of the World Health Organization*, the *Universal Declaration of Human Rights*, the *Charter of Economic Rights and Duties of the States*.”

Brain Becker, International Action Center: “It’s not France, it’s not Russia, it is the United States which is imposing these sanctions which are killing their children by the hundreds of thousands, and we believe that the right policy for the United States government is to stop the sanctions. And that the people of this country, who are paying—having our tax dollars used to impose hunger and starvation, are not really being spoken for in this current crisis.”

Woman, Fox News television interview: “But the UN has backed these sanctions.”

Brain: “The United Nations for the last six or seven years has become virtually a plaything for U.S. policy. And that’s because of U.S. dominance in the aftermath of the collapse of the Soviet Union. That doesn’t mean that the people of the Middle East or the people of the world really support U.S. policies.”

Sara Flounders, International Action Center Coordinator: “Today’s march, that we’re beginning now, is a procession to commemorate the more than half a million children in Iraq who have died from the sanctions policy. WHY PUTIN IS UNDER ATTACK

Because of the ongoing escalation of anti-Russian rhetoric both by the American press and President Bush, I have undertaken a short trip to Moscow to interview Russian leaders in an effort to gain a deeper understanding of the real policies of Russian President Vladimir Putin. I plan to write about this issue extensively and incorporate some of the research into my next book. Over the past few days I have met with members of the Duma, some nationalist newspaper editors, and some leaders of the Russian anti-globalist, nationalist community. I even put on my journalist cap and interviewed some of the Jewish publishers! Here is my personal analysis of the conflict that looms between the Anglo-American-Israel Axis and Putin's Russia.

President Vladimir Putin is no perfect man. He reached his political coming of age in the shadowy intelligence services of the old Soviet Union. In that milieu he learned the highest arts of any spy; subterfuge and camouflage. But in truth, the talents of deceit are honed to a much higher degree in the American political system than in any autocratic nation. In a nation where the government has some influence over media rather than being at the mercy of the unelected, self-appointed media elite, the public official can speak somewhat frankly.

Contrarily, a politician in the United States or Britain must be careful never to speak his mind honestly or he might find himself eviscerated by media which are always on the lookout for the slightest political incorrectness.

The Anglo-American politician must be judiciously careful not to say anything that could even be remotely construed as criticizing even the lowest echelons of Jewish power. For instance, look at the huge flap in London right now over the comments of the Mayor of London, Ken Livingstone, to an obnoxious Jewish reporter who was hounding him. For simply retorting to the reporter that he was acting like a concentration camp guard you would have thought Livingstone to be a friend of Hitler. The Jewish Board of Deputies and a score of Jewish columnists accused him of denying the realities of Jewish suffering and trivializing the Holocaust—all for simply criticizing a single Jewish reporter. Now they threaten to actually remove this man who was elected by the overwhelming majority of Londoners because of his trivial statement.

Of course one must understand, a Jewish reporter is in effect the enforcer of political correctness. He is the policeman and inquisitor of Jewish supremacism. To criticize one of them is equated in the minds of the media to assaulting a member of the police, the thought police.

Putin has committed a far greater crime in the minds of the Jewish media. He is Russian. A real Russian. Although he came to power with back-door political manipulation and with the aid of some Jewish allies, underneath he has always had a Russian soul waiting for the chance to assert itself.

So he played the game. In some ways Stalin was his model. Although Stalin fit comfortably into the Jewish milieu of the early Bolshevik revolution with his Jewish wife and many Jewish friends, Stalin was Georgian and he always knew that he could never fit in with the coterie of Jews who upon Lenin's death circled like vultures around the Russian throne of power. Trotsky, Radek, Kamenov Sverdlov, they were all of the Hebrew cut. They never saw Stalin coming, after all, what could this one lone *goy* among them do to

challenge them? When they finally saw the true face of this utterly ruthless man, it was too late.

The story is now legend. As the Jewish Bolsheviks fought it out ferociously among themselves for power, with Trotsky (Bronstein) as the leading contender, and since Stalin wasn't Jewish he was the one they felt was no real threat so that they could give some reins of police power. In fact, Stalin helped them literally eliminate each other and he ultimately emerged as the strong man. The purges of the 1920s and 30s eliminated many of the Jewish cliques that dominated the Bolshevik government. Stalin was careful not to completely purge all the Jews from the government and many powerful Jews remained in very important posts, one of the most prominent being Lazar Kaganovich. But Stalin began a policy of re-Russifying the Russian government, after all, he knew the war could not be fought and won without rekindling the Russian patriotic spirit. But he always kept at hand compliant Jews so that the world-wide Jewish love affair with the Soviet State would not be severed.

Some powerful and perceptive Jews in the United States saw the sea change occurring in Russia, and a process began that has ultimately culminated in the very weird reality of former Trotskyite communists, the neocons, becoming the dominators of the American conservative movement! The one thing that mitigated early overseas Jewish opposition to Stalin was that they needed Stalin and Russia if they were to overcome what they considered the greatest threat to Jewish supremacism: National Socialist Germany.

The Bolsheviks had installed the Internationale as the national anthem. Stalin replaced it with an old Russian hymn. Advancement once again became based mostly on abilities and not Jewish tribal loyalties and connections. Russians rapidly advanced and occupied the leading positions in the military and other government structures and by the end of the war the bulk of the Jewish power, although still far greater than their population percentage, was greatly diminished. Russians were motivated by appeals to protect Mother Russia rather than international worker solidarity. However, Russia was still crippled and saddled by the inept and corrupt system of Jewish communism, and although some improvements in Russian life occurred, this Marxist, flawed economic system could never give the Russian people either real freedom or prosperity.

Most mainstream Jewish sources now claim that Stalin planned a 'final solution' to the Russian Jewish problem by the resettlement of the Jews into a their own republic, much like the Czarist Pale of Settlement created in earlier centuries. The same Jewish authorities actually boast in the idea, whether real or fanciful, that Stalin's Jewish doctors along with Lazar Kaganovich murdered Stalin on the very eve of his new pogrom. Kaganovich himself claimed to his nephew that he and his sister Rosa, a doctor, poisoned Stalin by switching Stalin's pills with ones that would cause a stroke (from which he died).

When the Gentile communist Nikita Khrushchev accused Kaganovich in 1957 at a Soviet Party Congress of having murdered 20 million Russians during his career, Kaganovich didn't even deny it. He only accused Khrushchev of being a murderer too. "Your hands are blood-stained too," Kaganovich told him. Khrushchev pointed out that the difference was that he, Khrushchev, had merely followed Kaganovich's orders, while it had been Kaganovich who had formulated the policies of mass murder and had given the orders for carrying out those policies.

It is impossible that Vladimir Putin is not aware of all these things. Every knowledgeable Russian is aware of them. And with the fall of Communism and the new state that emerged, Jews reasserted their power as they

not had since the time of Lenin and Trotsky. In the two years following the fall of the Soviet State, through international Jewish capital and massive bribery, threats, murder and gangsterism, Jews seized control of most of wealth of Russia in undoubtedly the greatest series of criminal thefts in the history of mankind.

The Jewish Oligarchs (10 of 11 of the most powerful were Jews) grabbed control of at least 65 percent of the wealth of Russia. The most politically active of the leading oligarchs was a vicious gangster and murderer named Boris Berezovsky. At one point Putin aligned with him in his quest for power. There was even an article in the *Moscow Times* newspaper about how Putin used to vacation in Berezovsky's summer house in Spain.

Berezovsky had risen under Boris Yeltsin as the head of National Security for Russia. But, a firestorm of justified anger broke out in Russia against him when it was learned that Berezovsky, the head of Russian security, was also a citizen of Israel.

As Putin gained more and more power in the Russian hierarchy he began to assert himself and eventually broke with Berezovsky and Gusinsky and a number of the Jewish Oligarchs. Since that time [there] have been thousands of sympathetic articles about Berezovsky and Gusinsky and articles about the lawlessness of Putin for daring to prosecute these men. Recently, Berezovsky's biggest critic was gunned down on the streets of Moscow. Now this is the kind of man that the Jewish-dominated media loves!

Putin has not acted against all of the Oligarchs. He was too much of a cold war chess player to do that, but he went against any of them who tried to assert power over him, much like Stalin did decades earlier. Berezovsky and Gusinsky (the gangster Gusinsky who was head of the Russian Jewish Congress) are now Putin's most bitter enemies. No other leader in the western world would dare to go after such powerful Jewish supremacists.

The latest case is that of Michael Khodorkovsky of Yukos Oil. Through graft and corruption Khodorkovsky obtained billions of dollars of oil leases for a pittance in the mid-nineties. But as he amassed his incredible wealth he decided he had the right to determine the political fate of Russia. In fact, he had the *chutzpah* to boast of that fact he will buy the Russian Duma. Putin, feeling threatened, and rightfully so, questioned why a man who stole billions of dollars from the Russian people then would have the right to corrupt government the same way as he obtained his oil leases. Khodorkovsky and almost all of the principle stockholders of Yukos are not only Jews but are in fact Israeli citizens, and many of the major stockholders (criminals) are now hiding out in Israel with the blessing of the Israeli government.

Putin and his government initiated prosecutions of these Jewish supremacist gangsters that have committed the worst thievery in history.

The reaction from the Jewish-dominated press in America and around the world is quite predictable. There has been a crescendo of criticism of Putin and universal defense of the 'persecuted' Jewish oligarchs. Putin has even been accused of 'anti-Semitism' for prosecuting these criminals.

Because Putin believes that the Russian people should own the press rather than citizens of Israel, he is called an enemy of a free press. Yet, how can any press be free when it is controlled by a people who view themselves more Jewish than Russian and have their own clear international agenda? And today, as Bush calls for Russia to have a free press (translated: the Jewish criminal oligarchs such as Jewish mafia leader Berezovsky should control the press) they call on Russia to pass laws and prosecute Russians who dare to simply criticize the Jewish criminal oligarchs and the their allegiances to Israel and Jewish supremacism rather than to Russia and Russians.

Bush has even had the hypocrisy to criticize Putin

for consolidating Russian federal power. In America the federal government literally spends one thousand times more money on the federal government than does Russia. As shocking as that might sound for most Americans to read, it is fact. America spends about 4 trillion on government; Russia spends less than 40 billion! And Bush has the *chutzpah* to talk about consolidation of power in Russia!

The American government has become the epitome of everything we once opposed. Russia is not communist any more, but the American government, under the domination of the Jewish neocons (who are former communists) acts more and more like the communists have acted for decades.

Bush criticizes Putin and Russian freedom while he works to take away American constitutional freedoms with the *Patriot Act*.

The oligarchs and the Zionists want total supremacy over the Russian nation, and that's why they have made Putin a target. Their puppet George Bush, just as in the Iraq war, is happy to serve these masters of the American political landscape. It is not just leaders of AIPAC that are being investigated for spying who should wear the yellow coat of treason, George Bush has surrendered his presidency completely to this foreign power and shames every real American who has pride in our country.

World News Insights

All around the world countries are stepping on the toes of the ruling Money Masters. If the new Asian currency is backed by VALUE, it almost certainly will succeed in a big way.

SINGLE ASIAN CURRENCY COMES A STEP CLOSER TO REALITY

The Asian single currency, which so far only exists in the minds of economists and officials with international organizations, will take on more concrete reality soon. The Asian Development Bank plans to publicize the Asian currency unit (ACU), a notional unit of exchange based on a “basket” or weighted average of currencies used in the 10 ASEAN member countries plus South Korea, China and Japan, the *Yomiuri Shimbun* and others reported Friday.

But that does not mean that any bills or coins will circulate any time soon. The ACU is only the first step toward the integration of Asian currencies, a “virtual currency” that takes into consideration GDP and trade volume of each of the 13 nations and serves as a gauge for governments to implement foreign exchange policies. So far, Japan and China have tried to make their own national currency into the Asian currency, but their jostling in effect cancelled out the efforts of the other. That is why the ACU is gaining support on the road to a single currency.

Given that it took more than 30 years for Europe to launch its single currency, the euro, Asians also probably have a long road ahead until the ACU or its successor chinks in their pockets. However, it could take less time than in Europe since internal trade volume in the region is increasing faster than external trade volume with the U.S. or Europe, according to Yun Deok-ryong, a researcher with the Korea Institute for International Economic Policy.

Still, many obstacles lie ahead. **The U.S. above all is likely to worry that it will lose its influence over Asian economies and use the International Monetary Fund (IMF) to block the introduction of the ACU. The launch of the Asian Monetary Fund, which is to coordinate monetary policies in the region, faces objections from the U.S., which does not want to see an Asian single currency emerge as another key currency along with the dollar and euro in the global financial market, an official with the Ministry of Finance and Economy said.**

The role of the IMF is being recognized in the Philippines, too. HUNGER, TREASON AND MILITARY TAKEOVER

The most powerful factor arguing for a military takeover is the fact that the rising hunger and massive poverty which engulf the land can be attributed only to the chain of civilian governments that took over from the Marcos dictatorship in 1986.

While mass poverty was a prominent aspect of the [Marcos] dictatorship, it never assumed the dimension that it has taken since Edsa I. There was extensive poverty during the dictatorship, yes, but hardly anyone

spoke of hunger. Today, 20 years after what has passed for civilian democratic governance, the problem of hunger has taken center-stage in any discussion of the economic situation. Two years ago, the Food and Nutrition Research Institute of the Department of Science and Technology found that eight out of 10 households are hungry.

There isn't any way that civilian government can possibly escape responsibility for the radical deterioration of the hunger problem. It is civilian government that has been in charge for the last 20 years. But this isn't what makes the case against government conclusive. What does make the case conclusive is the fact that **the hunger problem is the direct consequence of the treasonous policies pursued by the chain of civilian governments that took charge of the economy after Edsa I. What those governments did was to hand over the economic sovereignty of the state to the International Monetary Fund-World Bank (IMF-WB) Group and it is that Group which has, through its so-called conditionalities, dictated the economic policies and programs of the country since then.**

The core of these conditionalities has been the deadly mix of free trade and devaluation, one, as we all know by now, devastated our industry and agriculture and the other systematically debased the purchasing power of the peso. The result has been massive unemployment and skyrocketing prices and you can't conceive of a surer formula for hunger than that.

Monday night 4 of his companions also “escaped” and yesterday another one got away—this is from the maximum security prison in the middle of the nation's military HQ. Anyway, this is heating up and we could be in a new, and unknown at this time, environment.]

The number 544,765 is the number on the counter of www.pilipino.org.ph, Faeldon's Web site. I am the 544,766th to log in. I have instantly become a Faeldon fan after visiting the site because I like what I read on it, and the actions Faeldon suggests are very practical and doable that every Filipino can feel they can take action—and the actions are very visible when done. The basic symbols Faeldon uses are the Flag (raised to half-mast) and Pilipino. ...

Faeldon's “civil disobedience” starts very simply. He calls on all Filipinos to “... fly the Philippine flag at half-mast—in your school, your office, or your town. Remember to take pictures of the flag flying at half-mast (the pictures must be dated, of course) and send it to us; we'll post it here. Better yet, have pictures of you and your friends taken as you hoist down the flag.” This looks like fun and we can get thousands of campuses all over the country to start doing this, and even if the school authorities try to stop it the fun will just increase. Great idea, really!

We should start printing and selling little Philippine flags-on-a-stick for jeepneys, cars, buses and other vehicles to display. We can also have them on poles for building facades and residential frontyards. Decals and bumper stickers with the half- mast Philippine flag with bold words “Civil Disobedience Now, for Faeldon” can be printed and sold at cost to the public. The stickers could also be underscored by the slogan “No to e-VAT and Gloria...” or “Down with Gloria-FVR insults to our intelligence...”

Faeldon suggests: “If you can't fly a flag at half-mast, do the next best thing: Wear a shirt with a flag flying at half-mast, or a button. Print out a sticker of a flag at half-mast and put it on your car, your gate, your bag. During his time in the government's underground vaults, Loftus said he read a file on an organization known as the Muslim Brotherhood. In the file was information about a man named Hasam al-Banna who founded the organization in 1920. "Mr. al-Banna was a devout admirer of a young Austrian writer named Adolph Hitler. His letters to Hitler were so supportive that when Hitler came to

power in the 1930s he had Nazi intelligence make contact with al-Banna to see if they could work together," Loftus said. Hitler had al-Banna establish a spy network for Nazi Germany throughout Arabia.

"Just as Russia was using Communist Arabs during the cold war, we would use Arab Nazis as a counterweight to oppose them," Loftus said. "When the Soviets invaded Afghanistan in 1979 the Arab (neo) Nazis were let out of the closet. "Because of the combination of Wahhabi fanaticism and Nazi ideology, waves of people came pouring into Afghanistan to kill the Communists," Loftus said. The Soviets were defeated and the United States left. And, according to Loftus, Osama bin Laden took control and his entire army of neo-Nazi theological cultists were left there alive in the field. Bin Laden drew up a list of those who he knew he could rely on and called this list 'the base'. Loftus said the Arabic translation of 'the base' is 'al Qaeda'.

Upon President Putin warning the President of France about this impending terrorist attack, President Chirac ordered his Military Forces to be prepared to use Nuclear Weapons should his nation be targeted, and as we can read as reported by the *Reuters* News Service in their article titled "France defends right to nuclear reply to terrorism", and which says:

France said on Thursday it would be ready to launch a targeted nuclear strike against any state that carried out a terrorist attack on French soil. In a speech defending France's costly nuclear deterrent and toughening policy against terrorism, President Jacques Chirac said Paris must be able to hit back hard at a hostile state's centers of power and its "capacity to act".

"The leaders of states who would use terrorist means against us, as well as those who would consider using in one way or another weapons of mass destruction, must understand that they would lay themselves open to a firm and adapted response on our part," Chirac said during a visit to northwestern France, where France's nuclear submarines are based. "This response could be a conventional one. It could also be of a different kind." Chirac said all of France's nuclear forces had been configured with this strategy in mind and the number of nuclear warheads on French nuclear submarines had been reduced to allow targeted strikes.

Not being understood by the American people about this frightening new warning from the French President is

that it is not directed towards any Middle Eastern nation, but against the United States who harbors and protects with its Saudi Arabia allies the terrorists who would be most responsible for an attack, and again which is no secret to the world, only to the American people themselves.

But to the greatest true understanding of these events the American people need look no further than to the ideological mentor of their War-Faction called the Neo-Cons, and named Leo Strauss, one of the most secretive men in all of American history, but whose disciples include practically all present top government officials in the United States today. Rule One: Deception

... Not only did Strauss have few qualms about using deception in politics, he saw it as a necessity. While professing deep respect for American democracy, Strauss believed that societies should be hierarchical—divided between an elite who should lead, and the masses who should follow. But unlike fellow elitists like Plato, he was less concerned with the moral character of these leaders. According to Shadia Drury, who teaches politics at the University of Calgary, Strauss believed that "those who are fit to rule are those who realize there is no morality and that there is only one natural right—the right of the superior to rule over the inferior."

Second Principle: Power of Religion

According to Drury, Strauss had a "huge contempt" for secular democracy. Nazism, he believed, was a nihilistic reaction to the irreligious and liberal nature of the Weimar Republic. Among other neoconservatives, Irving Kristol has long argued for a much greater role for religion in the public sphere, even suggesting that the Founding Fathers of the American Republic made a major mistake by insisting on the separation of church and state. And why? Because Strauss viewed religion as absolutely essential in order to impose moral law on the masses who otherwise would be out of control.

At the same time, he stressed that religion was for the masses alone; the rulers need not be bound by it. Indeed, it would be absurd if they were, since the truths proclaimed by religion were "a pious fraud". As Ronald Bailey, science correspondent for *Reason* magazine points out, "Neoconservatives are pro-religion even though they themselves may not be believers." ...

Third Principle: Aggressive Nationalism

Like Thomas Hobbes, Strauss believed that the inherently aggressive nature of human beings could only be restrained by a powerful nationalistic state. "Because mankind is intrinsically wicked, he has to be governed," he once wrote. "Such governance can only be established, however, when men are united—and they can only be united against other people."

Not surprisingly, Strauss' attitude toward foreign policy was distinctly Machiavellian. "Strauss thinks that a political order can be stable only if it is united by an external threat," Drury wrote in her book. "Following Machiavelli, he maintained that *if no external threat exists then one has to be manufactured* (emphasis added)." ...

Lawful Avoidance Of Key IRS Designations

Budget's "Tip of the Week" #8:

"Personal Service Corporation", "Personal Holding Company" and "Controlled Group"

The tax advantages of properly operated Nevada corporate shelters may be secondary to the benefits of liability protection, asset protection and privacy but they are worth discussing all the same, especially since many tax professionals don't seem to "get it".

The IRS will tag a corporation as a "Personal Holding Company" and assess a surcharge of 39.6% on undistributed earnings in cases where more than 60% of the corporation's income is derived from "passive" sources such as dividends, interest and rental income. The IRS applies a designation of "Personal Services Corporation", assessing all income at a flat rate of 35%, in cases where a C corporation is engaged in the performance of personal services (consulting-type work) and where such services are performed by employee-owners. Yet another IRS designation is that of "Controlled Group", based on complicated rules for determining allowable cross-ownership of corporations, whereby the IRS seeks to lump all of the income into a single, consolidated return—resulting in the highest possible tax rate, of course.

Each of these designations is based on the corporation's OWNERSHIP. How very fortunate, then, that ownership of Nevada corporations is statutorily permitted to be very PRIVATE: It is not a matter of public record, only of the protected (by *NRS 78.257*) internal records of the corporation.

To be considered a "Personal Holding Company" a corporation must be owned by five or fewer stockholders. It is totally permissible for a corporation to earn 100% of its income from passive sources, as long as it is owned by six or more stockholders. It is similarly easy to avoid the designation of "Personal Services Corporation": Don't own the stock! "Controlled Group" status is also very easily avoided with Nevada corporations: Simply ensure that no entity owns 80% or more of any other entity and that in brother-sister corporate relationships there are six or more stockholders. As no liability is attached to stock ownership, surely you could find a trustworthy friend or six who wouldn't mind holding stock in the corporation? If not, give us a call—we know of hundreds of corporations in similar circumstances.

With regard to "Controlled Group" status, the IRS has from time to time invoked *Section 482* of the *Infernal Revenue Code*, which lumps together income from corporations if they APPEAR to act out of a unity of interest. To our knowledge, however, even this blanketing regulation is relatively easily overcome, as long as the corporations act in their own, separate, well-documented self-interest.

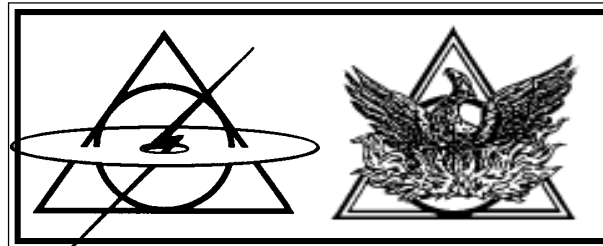
