

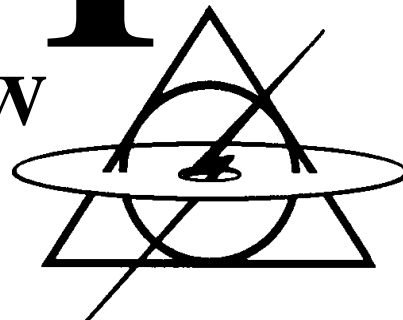

U.S. Rep. Ron Paul on End of Dollar Hegemony

The following speech by Congressman Ron Paul in the House of Representatives on February 15 of this year makes it abundantly clear that the primary goal of U.S. militarism is to sustain the value of the U.S. DOLLAR and its preeminence as "the world's reserve currency".

The Iranian oil bourse scheduled to start up in March will denominate sales in eurodollars which are—at least nominally (15%)—backed by gold. If the Iranian oil bourse opens on schedule, it spells the end of dollar hegemony and the end of trading away value for mere paper.

We find it more than a little interesting how the premises of "honest commerce" as described by Ron Paul mesh tightly with the Shariah principles of Islamic—"style" banking—and thus very nicely with the Global Alliance program for value-backed currency. At some point surely someone must see the obvious benefits of working with God's Plan, which is THE (only) solution.

THE END OF DOLLAR HEGEMONY

A hundred years ago it was called "dollar diplomacy". After World War II, and especially after the fall of the Soviet Union in 1989, that policy evolved into "dollar hegemony". But after all these many years of great success, our dollar dominance is coming to an end.

It has been said, rightly, that he who holds the gold makes the rules. In earlier times it was readily accepted that fair and honest trade required an exchange for something of real value.

First it was simply barter of goods. Then it was discovered that gold held a universal attraction, and was a convenient substitute for more cumbersome barter transactions. Not only did gold facilitate exchange of goods and services, it served as a store of value for those who wanted to save for a rainy day.

Though money developed naturally in the marketplace, as governments grew in power they assumed monopoly control over money. Sometimes governments succeeded in guaranteeing the quality and

purity of gold, but in time governments learned to outspend their revenues. New or higher taxes always incurred the disapproval of the people, so it wasn't long before Kings and Caesars learned how to inflate their currencies by reducing the amount of gold in each coin—always hoping their subjects wouldn't discover the fraud. But the people always did, and they strenuously objected.

This helped pressure leaders to seek more gold by conquering other nations. The people became accustomed to living beyond their means, and enjoyed the circuses and bread. Financing extravagances by conquering foreign lands seemed a logical alternative to working harder and producing more. Besides, conquering nations not only brought home gold, they brought home slaves as well. Taxing the people in conquered territories also provided an incentive to build empires. This system of government worked well for a while, but the moral decline of the people led to an unwillingness to produce for themselves. There was a limit to the number of countries that could be sacked for their wealth, and this always brought empires to an end. When gold no longer could be obtained, their military might crumbled. In those days those who held

the gold truly wrote the rules and lived well.

That general rule has held fast throughout the ages. When gold was used, and the rules protected honest commerce, productive nations thrived. Whenever wealthy nations—those with powerful armies and gold—strived only for empire and easy fortunes to support welfare at home, those nations failed.

Today the principles are the same, but the process is quite different. Gold no longer is the currency of the realm; paper is. The truth now is: “He who prints the money makes the rules”—at least for the time being. Although gold is not used, the goals are the same: compel foreign countries to produce and subsidize the country with military superiority and control over the monetary printing presses.

Since printing paper money is nothing short of counterfeiting, the issuer of the international currency must always be the country with the military might to guarantee control over the system. This magnificent scheme seems the perfect system for obtaining perpetual wealth for the country that issues the *de facto* world currency. The one problem, however, is that such a system destroys the character of the counterfeiting nation’s people—just as was the case when gold was the currency and it was obtained by conquering other nations. And this destroys the incentive to save and produce, while encouraging debt and runaway welfare.

The pressure at home to inflate the currency comes from the corporate welfare recipients, as well as those who demand handouts as compensation for their needs and perceived injuries by others. In both cases personal responsibility for one’s actions is rejected.

When paper money is rejected, or when gold runs out, wealth and political stability are lost. The country then must go from living beyond its means to living beneath its means, until the economic and political systems adjust to the new rules—rules no longer written by those who ran the now defunct printing press.

“Dollar Diplomacy”, a policy instituted by William Howard Taft and his Secretary of State Philander C. Knox, was designed to enhance U.S. commercial investments in Latin America and the Far East. McKinley concocted a war against Spain in 1898, and (Teddy) Roosevelt’s corollary to the *Monroe Doctrine* preceded Taft’s aggressive approach to using the U.S. dollar and diplomatic influence to secure U.S. investments abroad. This earned the popular title of “Dollar Diplomacy”. The significance of Roosevelt’s change was that our intervention now could be justified by the mere “appearance” that a country of interest to us was politically or fiscally vulnerable to European control. Not only did we claim a right, but even an official U.S. government “obligation” to protect our commercial interests from Europeans.

This new policy came on the heels of the “gunboat” diplomacy of the late 19th century, and it meant we could buy influence before resorting to the threat of force. By the time the “dollar diplomacy” of William Howard Taft was clearly articulated, the seeds of American empire were planted. And they were destined to grow in the fertile political soil of a country that lost its love and respect for the republic bequeathed to us by the authors of the *Constitution*. And indeed they did. It wasn’t too long before dollar “diplomacy” became dollar “hegemony” in the second half of the 20th century.

This transition only could have occurred with a

dramatic change in monetary policy and the nature of the dollar itself.

Congress created the Federal Reserve System in 1913. Between then and 1971 the principle of sound money was systematically undermined. Between 1913 and 1971, the Federal Reserve found it much easier to expand the money supply at will for financing war or manipulating the economy with little resistance from Congress—while benefiting the special interests that influence government.

Dollar dominance got a huge boost after World War II. We were spared the destruction that so many other nations suffered, and our coffers were filled with the world’s gold. But the world chose not to return to the discipline of the gold standard, and the politicians

applauded. Printing money to pay the bills was a lot more popular than taxing or restraining unnecessary spending. In spite of the short-term benefits, imbalances were institutionalized for decades to come.

The 1944 Bretton Woods agreement solidified the dollar as the preeminent world reserve currency, replacing the British pound. Due to our political and military muscle, and because we had a huge amount of physical gold, the world readily accepted our dollar (defined as 1/35th of an ounce of gold) as the world’s reserve currency. The dollar was said to be “as good as gold” and convertible to all foreign central banks at that rate. For American citizens, however, it remained illegal to own. This was a gold-exchange standard that from inception was doomed to fail.

The U.S. did exactly what many predicted she would do. She printed more dollars for which there was no gold backing. But the world was content to accept those dollars for more than 25 years with little question—until the French and others in the late 1960s demanded we fulfill our promise to pay one ounce of gold for each \$35 they delivered to the U.S. Treasury. This resulted in a huge gold drain that brought an end to a very poorly devised pseudo-gold standard.

It all ended on August 15, 1971, when Nixon closed the gold window and refused to pay out any of our remaining 280 million ounces of gold. In essence, we declared our insolvency and everyone recognized some other monetary system had to be devised in order to bring stability to the markets.

Amazingly, a new system was devised which allowed the U.S. to operate the printing presses for the world reserve currency with no restraints placed on it—not even a pretense of gold convertibility, none whatsoever! Though the new policy was even more deeply flawed, it nevertheless opened the door for dollar hegemony to spread.

Realizing the world was embarking on something new and mind-boggling, elite money managers, with especially strong support from U.S. authorities, struck an agreement with OPEC to price oil in U.S. dollars exclusively for all worldwide transactions. This gave the dollar a special place among world currencies and in essence “backed” the dollar with oil. In return, the U.S. promised to protect the various oil-rich kingdoms in the Persian Gulf against threat of invasion or

domestic coup. This arrangement helped ignite the radical Islamic movement among those who resented our influence in the region. The arrangement gave the dollar artificial strength, with tremendous financial benefits for the United States. It allowed us to export our monetary inflation by buying oil and other goods at a great discount as dollar influence flourished.

This post-Bretton Woods system was much more fragile than the system that existed between 1945 and 1971. Though the dollar/oil arrangement was helpful, it was not nearly as stable as the pseudo-gold standard under Bretton Woods. It certainly was less stable than the gold standard of the late 19th century.

During the 1970s the dollar nearly collapsed, as oil prices surged and gold skyrocketed to \$800 an ounce. By 1979 interest rates of 21% were required to rescue the system. The pressure on the dollar in the 1970s, in spite of the benefits accrued to it, reflected reckless budget deficits and monetary inflation during the 1960s. The markets were not fooled by LBJ’s claim that we could afford both “guns and butter”.

Once again the dollar was rescued, and this ushered in the age of true dollar hegemony lasting from the early 1980s to the present. With tremendous cooperation coming from the central banks and international commercial banks, the dollar was accepted as if it were gold.

Fed Chair Alan Greenspan, on several occasions before the House Banking Committee, answered my challenges to him about his previously held favorable views on gold by claiming that he and other central bankers had gotten paper money—i.e. the dollar system—to respond as if it were gold. Each time I strongly disagreed, and pointed out that if they had achieved such a feat they would have defied centuries of economic history regarding the need for money to be something of real value. He smugly and confidently concurred with this.

In recent years central banks and various financial institutions, all with vested interests in maintaining a workable fiat dollar standard, were not secretive about selling and loaning large amounts of gold to the market even while decreasing gold prices raised serious questions about the wisdom of such a policy. They never admitted to gold price fixing, but the evidence is abundant that they believed if the gold price fell it would convey a sense of confidence to the market, confidence that they indeed had achieved amazing success in turning paper into gold.

Increasing gold prices historically are viewed as an indicator of distrust in paper currency. This recent effort was not a whole lot different than the U.S. Treasury selling gold at \$35 an ounce in the 1960s, in an attempt to convince the world the dollar was sound and as good as gold. Even during the Depression, one of Roosevelt’s first acts was to remove free market gold pricing as an indication of a flawed monetary system by making it illegal for American citizens to own gold. Economic law eventually limited that effort, as it did in the early 1970s when our Treasury and the IMF tried to fix the price of gold by dumping tons into the market to dampen the enthusiasm of those seeking a safe haven for a falling dollar after gold ownership was re-legalized.

Once again the effort between 1980 and 2000 to fool the market as to the true value of the dollar proved unsuccessful. In the past 5 years the dollar has been devalued in terms of gold by more than 50%. You just can’t fool all the people all the time, even with the power of the mighty printing press and money creating system of the Federal Reserve.

Even with all the shortcomings of the fiat

monetary system, dollar influence thrived. The results seemed beneficial, but gross distortions built into the system remained. And true to form, Washington politicians are only too anxious to solve the problems cropping up with window dressing, while failing to understand and deal with the underlying flawed policy. Protectionism, fixing exchange rates, punitive tariffs, politically motivated sanctions, corporate subsidies, international trade management, price controls, interest rate and wage controls, super-nationalist sentiments, threats of force, and even war are resorted to—all to solve the problems artificially created by deeply flawed monetary and economic systems.

In the short run, the issuer of a fiat reserve currency can accrue great economic benefits. In the long run, it poses a threat to the country issuing the world currency. In this case that's the United States. As long as foreign countries take our dollars in return for real goods, we come out ahead. This is a benefit many in Congress fail to recognize, as they bash China for maintaining a positive trade balance with us. But this leads to a loss of manufacturing jobs to overseas markets, as we become more dependent on others and less self-sufficient. Foreign countries accumulate our dollars due to their high savings rates, and graciously loan them back to us at low interest rates to finance our excessive consumption.

It sounds like a great deal for everyone, except the time will come when our dollars—due to their depreciation—will be received less enthusiastically or even be rejected by foreign countries. That could create a whole new ballgame and force us to pay a price for living beyond our means and our production. The shift in sentiment regarding the dollar has already started, but the worst is yet to come.

The agreement with OPEC in the 1970s to price oil in dollars has provided tremendous artificial strength to the dollar as the preeminent reserve currency. This has created a universal demand for the dollar, and soaks up the huge number of new dollars generated each year. Last year alone M3 increased over \$700 billion.

The artificial demand for our dollar, along with our military might, places us in the unique position to “rule” the world without productive work or savings, and without limits on consumer spending or deficits. The problem is, it can't last.

Price inflation is raising its ugly head, and the NASDAQ bubble—generated by easy money—has burst. The housing bubble likewise created is deflating. Gold prices have doubled, and federal spending is out of sight with zero political will to rein it in. The trade deficit last year was over \$728 billion. A \$2 trillion war is raging, and plans are being laid to expand the war into Iran and possibly Syria. The only restraining force will be the world's rejection of the dollar. It's bound to come and create conditions worse than 1979–1980, which required 21% interest rates to correct. But everything possible will be done to protect the dollar in the meantime. We have a shared interest with those who hold our dollars to keep the whole charade going.

Greenspan, in his first speech after leaving the Fed, said that gold prices were up because of concern about terrorism, and not because of monetary concerns or because he created too many dollars during his tenure. Gold has to be discredited and the dollar propped up. Even when the dollar comes under serious attack by market forces, the central banks and the IMF surely will do everything conceivable to soak up the dollars in hope of restoring stability. Eventually they will fail.

Most importantly, the dollar/oil relationship has to be maintained to keep the dollar as a preeminent currency. Any attack on this relationship will be

forcefully challenged—as it already has been.

In November 2000 Saddam Hussein demanded Euros for his oil. His arrogance was a threat to the dollar; his lack of any military might was never a threat. At the first cabinet meeting with the new administration in 2001, as reported by Treasury Secretary Paul O'Neill, the major topic was how we would get rid of Saddam Hussein—though there was no evidence whatsoever he posed a threat to us. This deep concern for Saddam Hussein surprised and shocked O'Neill.

It now is common knowledge that the immediate reaction of the administration after 9/11 revolved around how they could connect Saddam Hussein to the attacks, to justify an invasion and overthrow of his government. Even with no evidence of any connection to 9/11, or evidence of weapons of mass destruction, public and congressional support was generated through distortions and flat out misrepresentation of the facts to justify overthrowing Saddam Hussein.

There was no public talk of removing Saddam Hussein because of his attack on the integrity of the dollar as a reserve currency by selling oil in Euros. Many believe this was the real reason for our obsession with Iraq. I doubt it was the only reason, but it may well have played a significant role in our motivation to wage war. Within a very short period after the military victory, all Iraqi oil sales were carried out in dollars. The Euro was abandoned.

In 2001, Venezuela's ambassador to Russia spoke of Venezuela switching to the Euro for all their oil sales. Within a year there was a coup attempt against Chavez, reportedly with assistance from our CIA.

After these attempts to nudge the Euro toward replacing the dollar as the world's reserve currency were met with resistance, the sharp fall of the dollar against the Euro was reversed. These events may well have played a significant role in maintaining dollar dominance.

It's become clear the U.S. administration was sympathetic to those who plotted the overthrow of Chavez, and was embarrassed by its failure. The fact that Chavez was democratically elected had little influence on which side we supported.

Now, a new attempt is being made against the petrodollar system. Iran, another member of the “axis of evil”, has announced her plans to initiate an oil bourse in March of this year. Guess what, the oil sales will be priced Euros, not dollars.

Most Americans forget how our policies have systematically and needlessly antagonized the Iranians over the years. In 1953 the CIA helped overthrow a democratically elected president, Mohammed Mossadeqh, and install the authoritarian Shah, who was friendly to the U.S. The Iranians were still fuming over this when the hostages were seized in 1979. Our alliance with Saddam Hussein in his invasion of Iran in the early 1980s did not help matters, and obviously did not do much for our relationship with Saddam Hussein. The administration announcement in 2001 that Iran was part of the axis of evil didn't do much to improve the diplomatic relationship between our two countries. Recent threats over nuclear power, while ignoring the fact that they are surrounded by countries with nuclear weapons, doesn't seem to register with those who continue to provoke Iran. With what most Muslims perceive as our war against Islam, and this recent history, there's little wonder why Iran might choose to harm America by undermining the dollar. Iran, like Iraq, has zero capability to attack us. But that didn't stop us from turning Saddam Hussein into a modern day Hitler ready to take over the world. Now Iran, especially since she's made plans for pricing oil in Euros, has been on the receiving end of

a propaganda war not unlike that waged against Iraq before our invasion.

It's not likely that maintaining dollar supremacy was the only motivating factor for the war against Iraq, nor for agitating against Iran. Though the real reasons for going to war are complex, we now know the reasons given before the war started, like the presence of weapons of mass destruction and Saddam Hussein's connection to 9/11, were false. The dollar's importance is obvious, but this does not diminish the influence of the distinct plans laid out years ago by the neo-conservatives to remake the Middle East. Israel's influence, as well as that of the Christian Zionists, likewise played a role in prosecuting this war. Protecting “our” oil supplies has influenced our Middle East policy for decades.

But the truth is that paying the bills for this aggressive intervention is impossible the old-fashioned way, with more taxes, more savings, and more production by the American people. Much of the expense of the Persian Gulf War in 1991 was shouldered by many of our willing allies. That's not so today. Now, more than ever, the dollar hegemony—it's dominance as the world reserve currency—is required to finance our huge war expenditures. This \$2 trillion never-ending war must be paid for, one way or another. Dollar hegemony provides the vehicle to do just that.

For the most part the true victims aren't aware of how they pay the bills. The license to create money out of thin air allows the bills to be paid through price inflation. American citizens, as well as average citizens of Japan, China, and other countries suffer from price inflation, which represents the “tax” that pays the bills for our military adventures. That is, until the fraud is discovered, and the foreign producers decide not to take dollars nor hold them very long in payment for their goods. Everything possible is done to prevent the fraud of the monetary system from being exposed to the masses who suffer from it. If oil markets replace dollars with Euros, it would in time curtail our ability to continue to print, without restraint, the world's reserve currency.

It is an unbelievable benefit to us to import valuable goods and export depreciating dollars. The exporting countries have become addicted to our purchases for their economic growth. This dependency makes them allies in continuing the fraud, and their participation keeps the dollar's value artificially high. If this system were workable long term, American citizens would never have to work again. We too could enjoy “bread and circuses” just as the Romans did, but their gold finally ran out and the inability of Rome to continue to plunder conquered nations brought an end to her empire.

The same thing will happen to us if we don't change our ways. Though we don't occupy foreign countries to directly plunder, we nevertheless have spread our troops across 130 nations of the world. Our intense effort to spread our power in the oil-rich Middle East is not a coincidence. But unlike the old days, we don't declare direct ownership of the natural resources—we just insist that we can buy what we want and pay for it with our paper money. Any country that challenges our authority does so at great risk.

Once again Congress has bought into the war propaganda against Iran, just as it did against Iraq. Arguments are now made for attacking Iran economically, and militarily if necessary. These arguments are all based on the same false reasons given for the ill-fated and costly occupation of Iraq.

Our whole economic system depends on continuing the current monetary arrangement, which means recycling the dollar is crucial. Currently, we borrow

over \$700 billion every year from our gracious benefactors, who work hard and take our paper for their goods. Then we borrow all the money we need to secure the empire (DOD budget \$450 billion) plus more. The military might we enjoy becomes the “backing” of our currency. There are no other countries that can challenge our military superiority, and therefore they have little choice but to accept the dollars we declare are today’s “gold”. This is why countries that challenge the system—like Iraq, Iran and Venezuela—become targets of our plans for regime change.

Ironically, dollar superiority depends on our strong military, and our strong military depends on the dollar. As long as foreign recipients take our dollars for real goods and are willing to finance our extravagant consumption and militarism, the *status quo* will continue regardless of how huge our foreign debt and current account deficit become.

But real threats come from our political adversaries who are incapable of confronting us militarily, yet are not bashful about confronting us economically. That’s why we see the new challenge from Iran being taken so seriously. The urgent arguments about Iran posing a military threat to the security of the United States are no more plausible than the false charges levied against Iraq. Yet there is no effort to resist this march to confrontation by those who grandstand for political reasons against the Iraq war.

It seems that the people and Congress are easily persuaded by the jingoism of the preemptive war promoters. It’s only after the cost in human life and dollars are tallied up that the people object to unwise militarism.

The strange thing is that the failure in Iraq is now apparent to a large majority of American people, yet they and Congress are acquiescing to the call for a needless and dangerous confrontation with Iran.

But then again, our failure to find Osama bin Laden and destroy his network did not dissuade us from taking on the Iraqis in a war totally unrelated to 9/11.

Concern for pricing oil only in dollars helps explain our willingness to drop everything and teach Saddam Hussein a lesson for his defiance in demanding Euros for oil.

And once again there’s this urgent call for sanctions and threats of force against Iran at the precise time Iran is opening a new oil exchange with all transactions in Euros.

Using force to compel people to accept money without real value can only work in the short run. It ultimately leads to economic dislocation, both domestic and international, and always ends with a price to be paid.

The economic law that honest exchange demands only things of real value as currency cannot be repealed. The chaos that one day will ensue from our 35-year experiment with worldwide fiat money will require a return to money of real value. We will know that day is approaching when oil-producing countries demand gold, or its equivalent, for their oil rather than dollars or Euros. The sooner the better.

We must undo that which is most precious to them—and indeed, it is within that which is the banking system where they have gained first control. Not only CAN WE DO IT—we SHALL do it.

So, scribe, to continue—as much for your information as for any other’s let us move on to:

IJARA

Ijara means a lease contract as well as a hire contract. Therefore look at the many various way we can function and do so all within the laws of Allah and RIGHTEOUSNESS. In other words, the contract of ijara is the sale of usufruct. Therefore, the rules relating to a contract of sale such as those of khiyar al ru’ya (the right of rescission at the time at which he sees the object which he has bought), khiyar al-‘ayb (the right of rescission because of lack of stipulated quality), khiyar al-shart (the stipulated right to cancellation), faskh (cancellation), and ikala (reversal) apply to it too. For the Malikis, ijara resembles a sale contract whereby the price and use (manafa’a) are exchanged and the contract should specify a manafa’a either by the duration or by its subject matter. The contract is invalid if the object of ijara is used for the purposes which are prohibited by Shariah, e.g., renting a premises to use as a night club, bar or other vice activity, or the activity is a mandatory duty in nature, e.g., hiring a mother to feed her own baby. Hanbalis has described ijara as being a contract where the subject matter is lawful and defined as manafa’a, of a lawful and determined corporeal object (‘ayn), for a specific period of time. To the Shafiis, ijara is a contract where the subject matter is the determined, legitimate, assignable and lawful use of an object against a fixed consideration. Finally, Hanafis describe ijara as a contract intended to give ownership of a determined and legitimate manafa’a of a rented corporeal object (‘ayn) against the consideration.

All schools of thought have agreed that ijara is a binding (lazim) contract. However, they disagree about the reasons which could cause the cancellation of ijara. Malikis and Shafiis opined that ijara is cancelled only by a material defect (‘ayb) affecting the corporeal object (‘ayn) leased or hired. Another situation which terminates the contract is in the event where the purpose of the lease or hire has disappeared, such as when a person asked a butcher to slaughter cattle, and before the slaughtering began the cattle died. To the Hanafis, ijara is cancelled by any reasonable excuse that the lessee may invoke, while Hanbalis believes that ijara is cancelled if the rented object is destroyed or affected by a material defect.

There are two kinds of ijara, i.e., for a period and for carrying out of a task. The period must be determined; it is not possible to hire or rent for a stated amount per month. A special case of ijara for a period is the lease of agricultural property. It is forbidden to stipulate that the lessee should undertake work from which the lessor, too, derives advantage, such as dredging canals. If the crop has not yet been harvested when the lease expires, it continues for a fair rent until the crop has ripened. The lease of one agricultural property for another is forbidden because it would amount to riba. There are, however, some principles which are permitted by Shariah in this area. With regard to agricultural property, the related

principles are muzara'ah and mosaqat, and under these principles the lease payment consists of a percentage of the produce.

Another concept of ijara is ijara wa-igtina. It is a combination of leasing movable or immovable properties which grants the lessee and option of eventually acquiring the object of the lease. In Malaysia, the concept of ijara is expanded further by the principle of al-ijara thumma al-bai or hiring followed by sale and purchase. This concept refers to two contracts undertaken separately—the contract of al-ijara (hiring/renting) and the contract of al-bai (sale and purchase). Under the first contract, the hirer hires the goods from the owner at an agreed rental over a specified period. Upon expiry of the hiring period, the hirer enters into a second contract to purchase the goods from the owner at an agreed price. (Now this came from Bank Negara Malaysia)

I have bothered to put this section into the writing to point out that our DEEDS OF ASSIGNMENT can be leased or rented under “the law”. This allows for additional reserves which can shore up banks instantly.

We can utilize our assets in almost any way desired—without consideration of having to use interest and yet, can fit within the ongoing system—even to the supporting funds (for fees) to such as the IMF, if you have a great sense of humor and a sense of JUSTICE.

QARD HASAN

(No, dharma, you don't have to do banking—just the typing.) This is benevolent loan that obliges a borrower to repay the lender the principal sum borrowed on maturity of the loan. The borrower, however, has the discretion to reward the lender for this loan by paying any sum over the above amount of the principal. This kind of arrangement is the only loan permitted by Shariah and the objective of this loan is socio-economic justice and equity. Islamic banks are advised to make use of qard hasan in the following circumstances:

a. In the case of musharaka (partnership or participation financing) between the institution and the client, it often happens that not all of the institution's shares in the project can be earmarked for the right to participate in profits; otherwise no substantial share would be left to another partner, namely the client. Therefore the institution's participation is split into two parts. One part constitutes a share in the partnership capital and the other is working capital provided through qard hasan.

b. A qard hasan can also be provided to a client of the institution who has cash flow problems, either in order to protect the institution's investment, or, when the client is reliable, to boost the institution's image and reputation at no great risk.

c. A third use of qard hasan may occur when a client who has a blocked savings account with the financial institution which generates no interest, encounters an urgent need for short-term finance, making resources to the mudaraba concepts useless. The necessary funds can be provided to him by the institution through qard hasan. There are probably other circumstances where qard hasan has its value for the lender, and these circumstances will gradually develop with the day-to-day business of the Islamic financial institutions.

WADIAH

Wadiah means trusteeship and under this principle the owner will commission others to hold his property in safe custody. It is a fiduciary relationship (amana). The safekeeping must be assured by the owner himself or by a member of his family. The custodian's refusal to return the deposit or his denials that a deposit exists, or its confusion with his own property, are usurpation and engender liability. To the Islamic banks, wadiah is an agreement where the owner will deposit cash or other movable assets in the custody of the banks. The banks obtain the authority of the depositors to utilize the deposit at the bank's risk and bank's benefit. The depositor is free to withdraw the money at his own convenience. In Malaysia, the principle is further extended and renamed as wadiah yad dhamanah (safe keeping with guarantee). This concept refers to deposits which have been deposited with another person, who is not the owner, for safekeeping. As wadiah is a trust, the depository becomes the guarantor and, therefore, guarantees repayment of the whole amount of deposits, or any part thereof, outstanding in the account of the depositors when demanded. The depositors are not entitled to any share of the profit but the depository may provide returns as a gift (hibah) to the depositors as a token of appreciation.

RAHN

Rahn means pledge or pawn. It is a contract of pledging a security and becomes binding when possession of the pledge takes place. In this principle the ownership of the security is not transferred to the pledgee. The transfer of ownership occurs only under certain conditions as an effect of the contract. The pledgee is liable for the pledge, to the amount either of its value or of the debt secured, whichever is less, or if it gets lost through his fault, to the amount of its value; he is also obliged to return it when the debt is paid. The pledgee, however, has the right to sell the security when the debt is due in order to pay himself out of the proceeds. The pledge is in principle a collateral security; the debt remains in existence in so far as it is not covered by the sale of the pledge, and any credit balance which remains after the sale of pledge is held by the pledgee in trust for the pledgor.

Besides the above-mentioned principles, there are many other Shariah principles governing the operations of existing Islamic banks. These principles sometimes are either used by a limited number of Islamic banks or by the Islamic banks in specific Islamic countries. Among the principles within this category are bai mua'zzal, bai al-dayn, al-wakalah, al-ujr, al-kafalah, al-hiwalah, and joalah. I would rather not take time or space in distraction of focusing on each of these principles.

Now, I could break these principles as into categories of countries, terminology, etc., but I prefer to not do that for each is available in many places for research.

My full intent here is to point out that we have the asset and you have the people and the plan whereby the assets can best be used within the laws of Allah (and the land). It must be that we can present to our people a better way in honor and integrity. And, please, receivers of this, you must realize that only Allah could have such gifts. Make no mistakes about who is behind this program and offering or how well

it can flow because of same.

We have ones in Muslim places of the Middle East waiting to see what you will do—that they might either join this alliance or at least participate in the conceptual program in their own nations and banks.

I would also again point out that there may well be variances in the presenting language and spelling of words here for I remind you that my secretary-scribe only speaks English and this becomes most tedious. So, please, be gracious and allow for any errors in presentation.

Dharma is also my translator when I choose to have a verbal conversation with you. We have a rather tedious tonal frequency which has to be translated for most receivers into a language. We can share if you like but I prefer to keep the business to business and then let us share our real (soul) purpose.

Thank you for inquiring about the topic referenced. No, there are no “contra-indications” as to suggested use as drops in the eyes. I will, however, caution you as to a couple of things which are non-medically questionable and at the same time remind some of my “neighbors” that “oversaturation” is not preferable in colloidalization of silver, gold, etc. You are getting off into INVENTING a new wheel that is not going to run “true” for some particular “carts”. If that is not cautious enough then consider it encrypted as would VK suggests are all our presentations.

How this can be noted in the face of the garbage coming out about aliens, royal crowns, reptilians and dragons is beyond any comprehension.

DRIAS and DRIOS ARE MITACHONDRIAL/CELLULAR CHONDRIANA. The individual cells are extremely similar in form to what you generally refer to as “stem”-type cells as they are carriers for DNA and RNA in basic format. When presented in a fluid and fed nutrients in ionized form you have a very useful and NATURAL substance for which NO CLAIMS ARE OFFERED OTHER THAN TECHNICAL DESCRIPTIONS OF THE PRODUCT ITSELF. THE PROCESS IS DONE BY THE DRIAS THEMSELVES SO IF PEOPLE KEEP THEIR INVENTIVE HANDS OUT OF THE MIX YOU WILL HAVE A PERFECTLY BALANCED PRODUCT.

As to age-related macular degeneration as now the more interesting focus of Ophthalmologists usually hoping for a bit of repair surgery, we can generally discuss the problem itself.

Macula (OR MACULAE [depending on who is impressing you with great intelligence]). A small “colored” area or a spot. It may be permanent. For example, the *macula lutea is a small, oval, yellow area of the retina of the eye. Near the optic nerve, it has special cones at its center. Accurate sight occurs when an image is focused on this special part of the macula lutea.*

Now, we can let that go but not effectively without its co-operator usually present in any “macular-papular” reference and certainly is not going to flow from me as one without the other in any discussion. To do that you simply have to know that a papule is a small, solid, raised ‘bump’. In the eye they will appear in the same area and one has quite a lot to do with the other in any discussion about correction of anything gone apparently, or possibly, wrong with vision. An ophthalmologist or optometrist can see either but

more often than not the beginning of a papular presence is missed. Be especially careful about this possibility when you as a person also have had a history of ANY “fever blisters” (herpes virus origin, shingles, and/or simple warts). Warts are caused by one or more viruses known as papillomavirus and often have a rather-like cancer-causing virus called papovavirus, or at the least can be misidentified as, actually, the same little bugger.

Therefore, it would appear to we who simply “observe” that it would be better to attempt something which might clear up the viral potential.

In the discussion we have to look at “papular scaling”. If papules are present they are often the cause of “scaling” which in turn can present as “floaters” which are usually trapped in eye membrane and can be very annoying but otherwise quite harmless in most instances. Floaters do become a point in a discussion such as this because you don't want to do anything that presents more “floaters” and that is one thing that can certainly be expected in early treatment or in the case of colloid use can actually BE a tiny particle of whatever is the colloidal ion.

So, if you are going to use something like a dria solution, which is certainly highly recommended, then make sure you have uncontaminated solution. Remember that other things can live nicely in Gaiandriana. This is why we always made sure that there was food-grade hydrogen peroxide and equal drops of OxySol added to the “bath”. In a case of older, but used solution, depending on amount available, you will not need more than 7 drops for a full gallon so cut down in relative amounts.

Now that you have that clean solution I suggest a dropper bottle for ease of use and to, say, an ounce of liquid add a “simple colloid” (silver only is fine) up to equal amount of Gaiandriana.

Here is where our “overwhelm” chemists err most often. In an attempt to get good strong colloidal particulate readings particles are often small enough to be colloidalized but also large enough for causing “floaters”. Make sure your colloid is diluted sufficiently but certainly strong enough to get at least one drop of colloid in each eye combined with the Gaiandriana. This should clear any chronic infection from the eye surface and conjunctiva as you go. The point HERE is not to clear up eye surface infections, friends, but rather, to get the silver ions CARRIED to the retinal area to act on the possibly present virus(s). If there comes papular-scaling you may well LATER show some additional floaters while the body takes care of the “debris”.

Now, to people like EJ who will go gung-ho, I suggest the most transparent solution of colloids that you can have register and that with the most minute particulate. MORE IS NOT BETTER. Use it many times per day but overdoing each use is not only a waste but actually quite foolish.

Yes, we SHALL have to get back to having these drias available to our friends but we will not do any such thing while we have loose cannons shooting us from every direction. THIS is not a “treatment” program; it IS what is used here for the problem described by Grace and Hans.

Will this “regenerate” cells? Probably not if the cells are actually sloughed and gone. It probably would stop the degeneration process, especially if a virus is presently causing the degeneration. It may very well REPAIR a damaged macular cell. Other improvements need reporting.

I can tell you now that one immediate response to use of this liquid bath is first a stinging sensation somewhat like simply getting water in the eyes. YOU WANT THIS because the stinging indicates a production of blood flow triggering to the eyes and the eyes along with the eye conjunctiva becomes one of the most effective and direct capillary “carriers” as is “under the tongue” application of any medication you want absorbed as quickly as is possible. The redness indicates dilation of those capillaries which, with a “carrier”, can haul assets very, very quickly.

Also please remember that with use of Gaiandriana there is often an early “killoff” syndrome which sometimes needs a couple of days to cease irritation (annoyance is a better term used here). You don’t have to be a rocket scientist and over-analyzing is surely an error.

There is certainly no wisdom in telling your eye specialist about anything you do outside the chemical loop or surgical repair potential. If this helps, for it will not harm, then is soon enough to enjoy your improved condition and leave us to do our “first” job.

I believe this is far more than anyone ever wanted to hear about the subject when the answer was obviously: No, Gaiandriana will NOT harm anything, including the eye. Will it repair degeneration? Extent of any repair or regeneration is yet pending. It is very likely to clear up the accompanying problems, sharpen up those cones and even polish those “rods” for peripheral improvement. These are component parts of vision itself.

If you want to try this and don’t want that “stinging” sensation which can cause you to appear to be crying for a minute, then mix with a simple saline-wash offered for the eyes and which may, after all, come in a dropper bottle for convenience. I suggest the “red-eye” for effectiveness but if you are going “out” where you prefer no redness—do this latter. DO NOT USE VISINE REDNESS REMOVER. You want those capillaries, not remove them. The eyeball itself will clear rapidly and the conjunctiva will follow shortly but will usually offer a “red rim” for a bit in direct response to anything.

I mention these things because I don’t wish to give too little discussion to a topic involving anything touching on more than soap and water—of which, of course, we could write volumes.

What I've Learned About U.S. Foreign Policy The War Against the Third World Part Four

SEGMENT #7: AMY GOODMAN: GENOCIDES IN INDONESIA AND EAST TIMOR

"In Indonesia, you may well know the story about what the military regime has done to East Timor. But by chance, if even one of you doesn't know it, I'll tell it again because that is really what it is going to take for the situation to change, is that story told from one person to another, from one community to another, until people simply say they are not going to take it any more. They're not going to let the U.S. government support these kind of regimes that are responsible for some of the worst genocides in the 20th century.

"Indonesia, under Suharto, the military regime came to power in '65 in an incredible bloodbath. Perhaps a half a million to a million people killed in Indonesia with the support of the U.S. Central Intelligence Agency. Because of the reporting of one crusading journalist named Kathy Kadane, who went to journalism school simply to write this article. She had met a CIA agent who had been working in Indonesia and he talked about how the U.S. CIA made up lists of dissidents in Indonesia and gave them over to the military under Suharto as he rose to power. And the military would go out and kill these people as the U.S. CIA would strike their names off the list. And in this way they killed between a half a million and a million people from 1965 to 1967. That was how the Suharto regime rose to power.

"In 1975, Indonesian military regime under Suharto, the dictator, (and we mustn't confuse the Indonesian people with the Indonesian military), the Indonesian military invaded East Timor. East Timor is a small country about 300 miles north of Australia, it had been occupied by Portugal for more than 400 years. Portugal went through a democratic revolution in 1974, was disbanding its empire in Africa as well as East Timor and East Timor was going through a decolonization process. At the end of November 1975, they declared independence. And then on December 7, 1975, just more than a week later, Indonesia, the fourth largest country in the world, invaded East Timor.

"But they didn't invade before Suharto sat down with then U.S. President, Gerald Ford, and Secretary of State, Henry Kissinger, who had come to visit Suharto, and got the go ahead for that invasion. Suharto was concerned that if he launched this clearly offensive invasion that the U.S. would cut off military sales to Indonesia because we have a bilateral agreement with Indonesia that their weapons that they use will not be used for offensive purposes. But once assured that that would not happen, Indonesia invaded by land, by air, by sea, East Timor. First, they went after the capital Dili and thousands of people who lived there dragging thousands of people down to the sea and shooting them into it as their loved ones counted them off.

"Just before the invasion there were six journalists who were covering the events leading up to the invasion

as the Indonesians came over from West Timor, the military and then ultimately had their full scale invasion on December 7th, and there were five journalist in a small town called Balibo and they lined them up against a house and they executed them. They cut off their genitals, shoved them in their mouths and they suffocated to death as they shot them. Indonesia full well knows how serious it is when word gets out and so they tried very hard not to let word get out about what was happening. In fact, after the invasion of December 7th 1975, they closed East Timor to the outside world for more than a decade as they killed the Timorese inside, killing more than a third of the population. One of the worst genocides in the late 20th century, proportionately worse than Cambodia.

"You might wonder why we have heard a lot about Cambodia but almost nothing about East Timor until recent years. And that's because the U.S. government was official enemy of Pol Pot and Cambodia and so the President, Secretary of State would constantly speak out against it and the U.S. press would print what the President and Secretary of State would say. And that was good in terms of Cambodia because Pol Pot did commit a genocide there.

"But, in the case of Indonesia, Indonesia was an official ally of the United States and so Ford, and then Carter, Reagan, Bush and then Clinton are not going to speak about the atrocities that Indonesia has committed in East Timor. And because they didn't and because the U.S. corporate media rarely diverges from the Washington agenda, the U.S. media hardly covered it at all. One report, the day after the invasion, by Walter Cronkite, for 40 seconds, announced that Indonesia had invaded East Timor. And then in the corporate press in the broadcast networks NBC, ABC, CBS, even PBS there was not a mention of East Timor for the next 17 years."

SEGMENT #8: THE PANAMA DECEPTION

Panamanian woman crying: "My daughter did not belong to any group! She had nothing to do with Noriega! She was innocent! She had nothing to do with all of this! And they killed her!"

Elizabeth Montgomery, Narrator: "On December 19th 1989, while Panamanians were getting ready for the Christmas holidays, the United States was secretly mobilizing 26,000 troops for a midnight attack.

"The invasion was swift, intense and merciless.

"When it was over, thousands lay dead and wounded and the country was in shambles.

"Millions of U.S. tax dollars were swallowed up in three days of brutal violence.

"In many ways, the invasion served as a testing ground for the Persian Gulf War one year later. It is also an indication of the kinds of intervention the United States may undertake in the years to come. But still, big questions remain. What exactly happened during the invasion of Panama? And why?

"As the invasion unfolded, Americans stayed glued to their TVs and newspapers for coverage. But how much of the real picture did the media give them?"

Michael Parenti, Author / Professor: "The performance of the mainstream news media in the coverage of Panama, has been just about total collaboration with the administration. Not a critical murmur, not a critical perspective, not a second thought."

Mark Hertsgaard, Author / Journalist: "The story that the White House was pushing, was getting this so-called Narco-terrorist in a net. And that was the thrust of all of the coverage. When are we going to get Noriega? Have they let Noriega get away?"

American news segments: "By late today, they had taken control of much of the country but their chief target, General Manuel Noriega, escaped."

"Manuel Noriega belongs to that special fraternity of international villains. Men like Qaddafi, Idi Amin, and the Ayatollah Khomeini, whom Americans just love to hate."

Valerie Van Isler, International journalist: "They focused on Noriega to the exclusion of what was happening to the Panamanian people, to the exclusion to the bodies in the street, to the exclusion of the number dead, to the exclusion of what happened to the women and children in that country, during this midnight invasion."

Narrator: "Noriega was head of Panama's military intelligence and had a long standing relationship with the United States. He had been on the CIA payroll since the '60s. When George Bush became Director of the CIA in 1976, under President Ford, he inherited Noriega as a contact. Despite evidence that Noriega was involved in drug trafficking, Bush kept Noriega on the payroll. In fact, he increased Noriega's salary to more than \$100,000 a year and eliminated a requirement that intelligence reports on Panama include information on drug trafficking.

"With support from the CIA, Noriega was able to outmaneuver his rivals and in August of 1983, he became Commander of the Panamanian Military. As the Reagan administration expanded its covert war against the Sandinista government in Nicaragua, Noriega became increasingly helpful. Working with the CIA, and with Israeli arms dealers, Noriega helped coordinate an arms supply network to provide weapons to contra bases in northern Costa Rica."

Professor Peter Dale Scott, Author / Professor: "Noriega's involvement in the drug traffic really increased his importance as a source for the CIA and as someone who was able to conduct dirty tricks in the region for the CIA. So it's no accident that the CIA became the most prominent defenders of Noriega against the drug charges, because that's the sort of thing which CIA clients tend to do."

Narrator: "Despite Noriega's collaboration with many U.S. covert operations, he was becoming increasingly uncooperative with U.S. objectives in Central America. In 1984, he angered the Reagan administration by hosting Latin American leaders at the Contadora Peace Talks. The talks called for an end to U.S. intervention in Central American affairs."

American news segments: "But relations with Panama are under a new cloud tonight because of news reports alleging...."

"Senator Jesse Helms charged today that the military strongmen of Panama, Manuel Noriega, is the number one drug trafficker in the Americas."

Narrator: "The Reagan administration now openly called for his removal."

Former President Ronald Reagan: "We do want Noriega out of there and a return to a civilian democratic government."

Narrator: "The U.S. now undertook a systematic effort to overthrow Noriega. Economic sanctions were stepped up and additional troops were dispatched to Panama."

American news segment: "The United States tonight declared in effect that Panama's General Manuel Noriega is a threat to this country's national security."

Former President George Bush, Sr.: "Mr. Noriega, the drug indicted, drug-related, indicted dictator of Panama. We want to bring him to justice. We want to get him out and we want to restore democracy to Panama"

Narrator: "Sabina Virgo, a national labor organizer, was in Panama just weeks before the invasion.

Sabina Virgo, National Labor Organizer, U.S.: “Provocations against the Panamanian people by the United States military troops were very frequent in Panama and they had several results and in my opinion probably a couple of different intents. One, I think, was to create an international incident, was to have United States troops just hassle the Panamanian people until an incident resulted and from that incident the United States could then say that they were going into Panama for the protection of American life, which is in fact exactly what happened.”

Narrator: “On December 20th, U.S. troops invaded Panama. The invasion was code-named Operation Just Cause. Shortly after midnight, U.S. troops simultaneously attacked 27 targets, many of which were in densely populated areas. One of the primary targets in Panama City was the headquarters of the Panamanian Defense Forces, located in the crowded neighborhood of El Chorrillo. U.S. troops shelled the area for four hours before moving in and calling for surrender.”

Voice of U.S. soldier: “We ask you to surrender..... If you do not, we are prepared to level each and every building.....”

Narrator: “It soon became clear that the objectives were not limited only to military targets. According to witnesses, many of the surrounding residential neighborhoods were deliberately attacked and destroyed.”

Unknown person describing what they saw: “They shot at everything that moved, without mercy and without thinking whether there were children or women or people fighting. Instead, everything that moved they shot.”

Woman speaking in Spanish (Voice of translator): “The North Americans began burning down El Chorrillo at about 6:30 in the morning. They would throw a small device into a house and would catch on fire. They would burn a house and then move to another and begin the process all over again. They burned from one street to the next. They coordinated the burning through walkie-talkies.”

Narrator: “The Pentagon used Panama as a testing ground for newly developed high tech weapons such as the Stealth Fighter, the Apache Attack helicopter, and laser guided missiles.”

Rear Admiral Eugene Carrol, Center for Defense Information: “President Bush wanted to make certain that this was going to be a success. This was going to be his vindication, denial of the wimp factor in spades. So they sent down a force that wasn’t going to encounter any effective resistance but simply overwhelm the opposition and the fact that it would cause tremendous peripheral damage, damage to innocent civilians on a wide scale, was not of concern in the planning.”

Mark Hertsgaard, Author / Journalist: “My God, we were sending in artillery and air strikes against a very heavily populated urban area. There was absolutely no question that there were going to be immense numbers of civilian casualties.”

Narrator: “During the days and weeks following the invasion, the U.S. policy of applying overwhelming deadly force continued. There were many reports of indiscriminate killings and executions of unarmed civilians.”

Gavrielle Gemma: Independent Commission of Inquiry: “We have eye witness accounts on the part of a number of Panamanians where soldiers took Panamanians who had been captured after the invasion and executed them on the street.”

Gavrielle Gemma: “They arrested close to 7,000 Panamanian individuals. They arrested almost every trade union leader, the leaders of the nationalist parties, of progressive parties, of Left parties in Panama. They arrested people who were cultural leaders.”

Narrator: “As a result of the U.S. invasion, an estimated 20,000 Panamanians lost their homes. Hardest hit were residents in the poor neighborhoods of San Miguelito, Colon, Panama Veijo, and El Chorrillo.

“How many people were killed in Panama? And who were they? These questions may never be answered because the United States military undertook elaborate efforts to conceal the number of dead, how they died, and the location of their bodies.”

Robert Knight, journalist: “What happened in

Panama is a hidden horror. Many of the bodies were bulldozed into piles and immolated in the slums where they were collected. Other bodies were left in the garbage shoots of the poor projects in which they died from the shooting, from the artillery, from the machine guns, from the airborne attacks. Others were said to have been pushed into the ocean.”

Representative Charles Rangel (Democrat, New York): “The truth of the matter is that we don’t even know how many Panamanians we have killed. But we should have more information on what happened. How many civilians were killed?”

Narrator: “The National Human Rights Commission of Panama interviewed hundreds of people in an effort to determine how many had died.”

Olga Mejia, (National Human Rights Commission): “What we have is different testimonies that help us to arrive to the conclusion that for sure, there were more than 4,000 people who died.”

Jeff Cohen, Fairness and Accuracy in Reporting (www.fair.org): “The U.S. military said 250 civilians were killed. I mean, there isn’t a credible source in Panama that believes that’s true. Whether it’s ambulance drivers, human rights monitors, doctors who worked in hospitals, neighbors of bombed out blocks. It’s just clearly false. That story would be so easy to tell for any journalist worth his or her salt. But they’re not telling it.”

Michael Parenti: “When they interviewed people in Panama about what they thought of it, they invariably were interviewing white, middle class people, who could speak English. They didn’t really go into the poor neighborhoods where people had been bombed. Did you see one media actually go into the bombed areas and talk to people who had lost a family or lost everything they had in the bombings? They focused totally on the invasion as a tactical event. Was it effective? Did it work well? Are we losing many American lives?”

American news segments: “While another unit moved in by helicopter”..... “15 American servicemen have died”..... “Gertrude Candy Haland, from Dixon, Illinois, is the twentieth American to die.”

Parenti: “They focused with utter ethnocentrism only on American lives. The only life that was precious, the only life that one could report on, the only life that one could consider as a serious loss was an American life.”

Narrator: “In the months following the invasion, Panamanians were shocked to discover the existence of mass graves where hundreds, perhaps thousands, of bodies were hastily dumped into pits and buried by U.S. troops.”

Jose Morin (Center for Constitutional Rights): “To date, there have been 15 mass graves that have been identified throughout Panama. The United States military was directly responsible for the killings of the men, women and children that are in these mass graves and for their burial. These mass graves exist throughout Panama and some are believed to be on U.S. military bases which creates a difficulty in terms of access to these mass graves.”

Voice of translator: “We found many young people, 15, 16, 18 years old. We found people in their 60s, and in their 70s. We found people killed by a shot to the back of their heads. Dead with their hands tied. Dead with casts on their legs or arms.”

Narrator: “Although the U.S. media created a perception of support for the invasion within the United States, the invasion was overwhelmingly condemned in the international community.”

Jeff Cohen: “If you look at any document in international law, any of numerous treaties, it’s clear that this invasion was illegal. It’s not debatable.”

Mark Hertsgaard: “The four biggest most important papers in this country all endorsed the rightness of the Panama invasion. That’s the *Washington Post*, the *Los Angeles Times*, strong endorsements, the *New [York] Times* and the *Wall Street Journal*. Every one of them. Now, a little body known as the United Nations had a vote about this. On December 29th they voted by an overwhelming majority to condemn the invasion as, in their words, “a flagrant violation of international law”.

Michael Parenti: “The media was so cooperative with the government because the media are owned by the same interests that are being defended in Central America by that government policy. The media are not close to corporate America. They are not favorable to corporate America. They are corporate America. They are an integral part of corporate America.”

Ramsey Clark: “We are a plutocracy. We ought to face it, a country in which wealth controls. May be true of all countries more or less but uniquely true of ours because of our materialism and the concentration of wealth here. Even our democratic processes are hardly that because money dominates politics and we know it. Through politics, it dominates government, and it dominates the media. We really need desperately to find new ways to hear independent voices and points of view. It’s the only way we are going to find the truth.”

Former President George Bush Sr.: “The goals of the United States have been to safeguard the lives of Americans, to defend democracy in Panama”

Rear Admiral Eugene Carrol: “Then President Bush said we had to go to restore democracy in Panama. How in the world do you restore that which has never existed? Panama has never been a democracy since we created Panama for our own purposes in 1903. And all we did was go down to restore American control and dominance in Panama.”

Narrator: “The new government installed by the invasion, was headed by the U.S.-backed candidates from the aborted national election, Endara, Calderon and Ford. Hours before the invasion, they were taken to a U.S. military base where they were sworn in as the President and Vice Presidents.”

Esmeralda Brown, (United Nations Methodist Office): “Of course he is not going to say that Panama is occupied. In fact, he might not even call it an invasion. It wasn’t his kind that were killed or massacred. He lives in the nicer area in the oligarchical area and you know his interest is protected. He is not running Panama, he is a puppet of the U.S. government. The U.S. government is running Panama. They are running all of the ministries in Panama. He’s only abiding by what he’s told to do.”

Robert Knight, (Investigative Journalist): “The invasion sets the stage for the wars of the 21st century in South America. The 2,000-mile invasion from Washington to Panama City took place primarily with bases from the United States. The essential value of the Southern Command is to get another 2,000 miles of intervention capability which takes us right into the heart of the Andean cocoa producing region, where the wars of the next decade are entirely likely to take place.”

Peter Kornbluh, (National Security Archive): “Panama is another example of destroying a country to save it. And it’s another case of how the United States has exercised a “might makes right” doctrine among smaller countries of the Third World. It has long been U.S. practice to invade these countries, get what we want, and leave the people that live there to kind of rot.”

Angry woman, (Voice of translator): “George Bush, may his children be spared what my daughter has been subjected to. My daughter, who doesn’t want to live! May his generation be spared what our generation is living through! He should ask God for forgiveness for all the damage caused to many families down here!”

Former President George Bush, Sr.: “One year ago the people of Panama lived in fear under the thumb of a dictator. Today, democracy is restored. Panama is free.”

Narrator: “In March 1991, President Guillermo Endara proposed a constitutional amendment that would forever abolish Panama’s right to have an army. Later that year, a law was passed by the United States Congress to renegotiate the Panama Canal Treaties to ensure continued U.S. military presence in Panama, on the grounds that Panama was no longer capable of defending the canal.”

GEORGE GREEN IN COUER D'ALENE, IDAHO

3. Document your skills and abilities relative to the U.S. corporation's needs.

In addition to the L-type visa, foreign nationals may be able to avail themselves of E-type visas, which typically involve investment in U.S. businesses. We suggest you consult with an immigration attorney.

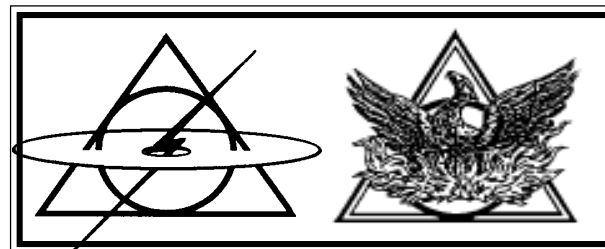
