

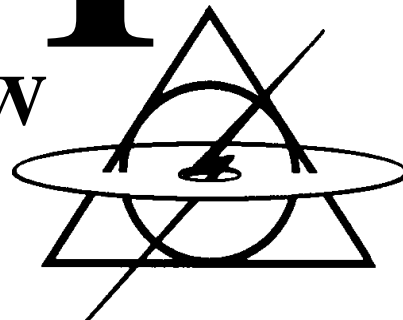

# Courts & Church Conspire To Keep 'Yamashita' Gold

*Many years have now passed since Don Esteban Benitez Tallano & Don Gregorio Madrigal Acop Foundation, Inc. first pressed the courts for a ruling on the issuance of fraudulent land titles against the legitimate Original Certificate of Title, OCT 01-4 (see the January 18, 2006 issue headlined, 'The Factual History of the Philippines' for details).*

*The de facto "powers that be" continue to stonewall every attempt to have this matter resolved in favor of the Filipino people, who continue to starve despite having ownership, through the Foundation, of at least 400,000 tons of gold. ### CUT TO THE CHASE

I don't need to go into all of that other than for the interest involved. We will offer extractions from writings now compiled by other authors while being quite honored to note that much of it was first offered by us in the first place but now proven to be truth.

### PHILIPPINE ACTIVISM AND THE VATICAN

The social unrest in the Philippines in the 70's and 80's was largely planned, funded and implemented by foreign and Filipino Roman Catholic churchmen and Cardinals from the **CITY OF SEVEN HILLS**, the Vatican City in Rome. Taking advantage of the much-publicized human rights violations during the Marcos Administration, the Roman Catholic Church, with 2,000 years of experience on how to **MANIPULATE MAN** and his **DESTINY**, promoted **ideological subversion and fomented political unrest** in the remote barrios, in Catholic schools, convents, seminaries and right on the city streets.

Countless seminarians, nuns and priests left the security of their convent walls to give teach-ins, distributed subversive materials, marched on the streets, rallied and demonstrated in front of government offices and many, tragically, went to the mountains to

join the militant armed struggle. Some of them were killed during encounters with government forces.

All this idealism and sacrifice by "sincere" people was inspired by the Roman Catholic Church to bring **justice and relief** to the **SUFFERING POOR** of the Philippines, putting the blame on the government. What unwitting pawns to a **FOREIGN POWER**: the **VATICAN CHURCH**, still obsessed in playing the oldest game in the world called **DOMINATION!**

If the Vatican indeed shed tears over the sufferings of the Filipino people, they were nothing but crocodile tears. As boldly exposed throughout this book, it was the **HOLY ROMAN CATHOLIC CHURCH** that, for 1,500 years, **perpetrated injustice, oppression and exploitation** on those people it **LORDED OVER** with unequalled banditry and thievery, and how it squeezed and drained their wealth, dignity and future.

Observe what happened in the **Latin American** countries we quoted earlier. "The Indians always offered their labor without any payment whatsoever, as part of their contribution. This was not confined to the construction of church buildings; it became the rule in the Church's vast tracts of land. The result was that the Church, in the long run, became one of the main instruments through which the impoverishment of the native races continued, until these were **reduced to complete destitution**... By the end of the colonial period, the Church owned an estimated **one half of the total wealth of Mexico, Peru, Colombia, Paraguay and Ecuador, and almost that proportion in ALL the other Latin American countries, while most of the remaining half** (of their wealth) **was 'controlled by the clergy through mortgages'.**"

Is it any wonder, then, that those countries "evangelized" and colonized for centuries by the Roman Catholic Spain and Portugal, after having ravaged them, like young maidens, have **evolved into unjust societies and poverty-stricken nations?**

After the tractors and chainsaws of greedy and irresponsible loggers have gone through virgin forests, what do we see? Eroded forests, swollen rivers and flooded valleys! When the **TWO SWORDS OF POPE BONIFACE VIII**, brought here (Philippines) by the Spanish conquistadors, accomplished their centuries-long spiritual, cultural and material "rape" of the Philippine islands, (exactly as was wreaked upon all the Latin American countries) **the ROMAN CATHOLIC CHURCH left the Filipinos nothing but a desolate economy, a desolate society, a desolate system of worship, a desolate self-image and a desolate spirit.**

As a **THIRD WORLD** country today, brought by **this Church** to the wretched status of **beggars**, knocking at the doors of affluent nations for measly morsels of food and other amenities. Thanks, but no thanks, to the **HOLY Roman Catholic Church** with its 'Liberation Theology'.

### **WHAT IS THEOLOGY**

The Roman Church's preaching of the Liberation Theology was supposed to redeem downtrodden Filipinos from poverty and oppression caused by the 'unjust and oppressive Marcos dictatorship'. The ills of this country during the Marcos regime were not all caused by him. He merely inherited those same ills that were inflicted here by the Roman Catholic Church during the 377 years of lease to Spain for so much 'pound of flesh' by Pope Leo X. And even as this country celebrated its 100 years of independence from Spain (the **LESSEE**), Filipinos are still dependent on the Vatican (the **LESSOR**) as evidenced by the manipulation of the country by the Roman Catholic Church's leftist indoctrination of the 70's and 80's. With that many blind followers (**Romano Katoliko Sarado**), the Liberation Theology gospel spread fast, far and wide.

If the Roman Catholic Church really means what it teaches in its Liberation Theology, this is what it should do. Instead of just making the suffering poor aware of their miserable condition (they called this "conscientization") and organizing them to put pressure on the rich to distribute its wealth, this new theology should **first** acknowledge, confess and apologize that it was this Roman Church that put them in this pitiful condition in the first place. **Second**, it should rehabilitate the psychologically damaged Filipinos much like a traumatized child before a psychiatrist. In this case, it will be the offender (Roman Catholic Church) rehabilitating the victim (Filipino people) by promising to make amends. **Third**, this church, as an example to the rich, should dig into its overflowing coffers and distribute its enormous surplus wealth to the poor, thereby empowering them to start a new and dignified life.

This is the decent thing to do. **THIS IS TRUE LIBERATION THEOLOGY.** It is liberating to the church that confesses its sins and makes amends for them. It is liberating as well to the poor who will benefit from the honesty of that church.

Instead, what the Roman Church does today is to give pittance from its coffers to help the poor and drumbeat the rich to give to its charitable programs. A perfect example is here in Manila. Everyday on television a plea is heard showing street children and scavengers in the garbage dumps and asking generous souls to give to **CARITAS**. This program belongs to the billionaire Archdiocese of Manila and the announcer belongs to one of the super, super rich religious congregations in the world.

### **THE VATICAN POLITICS AND INTRIGUES**

In the early 1930's, Europe was in a depression and Germany was financially bankrupt. An unknown party leader promised the German people that he could create jobs and boost its economy. The Germans dared him and put him in power. His name was Adolf Hitler. In June of 1933 the Vatican and Roman Catholic Hitler signed a concordat for mutual protection and enhancement. Shortly after that, Hitler was loaded with money. He built a massive army and manufactured weapons for war. Then Hitler took Poland. Before 1918 there was no Poland. That land was a buffer zone to separate Germany from Russia. But when Hitler reclaimed it, England declared war on Germany.

In 1934 under Pope Pius XII, the Vatican negotiated with a member of the Royal Family of the now defunct Madjapahit Empire, the Moslem-Christian Tallano clan in the Philippines. An agreement was reached that 617,500 metric tons of gold would be lent to the Pope. This was the same gold accumulated by the Southeast Asian Srivijayan and Madjapahit Empires during their glorious reign for 900 years that we treated in chapter IV of this book. In 1939 John Hay, accompanied by two members of the Tallano family and a certain Antonio Diaz, brought the gold to the Vatican.

Antonio Diaz, a man from Cabanatuan, was the 'alter ego' and trusted man of the Papal Nuncio in Manila. After World War II, in 1949, Diaz facilitated the safe return of 400,000 metric tons of that gold to the Philippines. It was received by Manuel Roxas, a certain Mrs. Camacho and a priest from La Union, Fr. Sobrepena.

A lease agreement was made between the Tallano clan and the Philippine government. The Central Bank of the Philippines became the **HOLDER** of that gold. That lease agreement will end in 2005.

For this purpose Diaz hired the services of Ferdinand E. Marcos. He was then a highly recommended brilliant young lawyer having attained notoriety when he successfully defended himself in the "Nalundasan Case" in 1939. For being Diaz's lawyer, Marcos was paid 5% from the principal. This

was a hefty US\$23 billion. Marcos also facilitated and arranged for the 217,500 metric tons of the Tallano gold to be deposited outside the Philippines. They are now in the various banks of Southeast Asia, U.S.A., the Bahamas, London, Switzerland and the Middle East.

### **[H: PAY ATTENTION! (!)]**

In Kuwait Marcos deposited 16,000 metric tons of the Philippine gold. Kuwait used to be part of Iraq but was made a separate and independent country by the English. In 1990 Saddam Hussein invaded Kuwait and carted away all the 16,000 tons of gold that belonged to the Philippines. The Americans came to the rescue of Kuwait in the Operation Desert Storm. President Bush, short of finishing the war and declaring victory over Iraq, withdrew his army. That was because Saddam Hussein gave Bush 4,000 metric tons of the Philippine gold. The American Hollywood movie about that war, *The Three Kings*, and its drama over the gold is not far from the truth.

In the future the remaining 12,000 metric tons of gold in Iraq will have to be wrested away from Saddam Hussein. This will need to be done by intimidation, blackmail or even war. But one thing is sure. This will not be done by Filipinos. They have a million more where those came from. **[H: Perhaps it will now make more sense why Bush needed Russell Herman's signature on the papers for the funds represented by all THAT gold! Moreover, there was that substantial need for over \$35 TRILLION to cover the little transfer.]**

The 400,000 metric tons of TALLANO gold, and 950,000 tons of the Japanese loot around Southeast were all brought to the Philippines. This country then became the holder of 1.8 million tons of gold bars, including the 217,500 tons deposited abroad. Some of the "Yamashita" gold buried in the Philippines has been found. But the bulk of it is still buried to this day.

Marcos reminted all these gold bars in the Central Bank Minting Plant in East Ave., Quezon City. In the 3<sup>rd</sup> floor basement of the Minting Plant there are 400,000 metric tons of reminted gold bullions, 170,000 metric tons under the swimming pool of a hotel in Manila and 50,000 metric tons in front of a building in the Ortigas Center.

Twenty years ago, a New York journal wrote that two thirds of all the gold in the world is in the Philippines. The one third is divided among the rest of the countries in the world.

When Marcos took over the government in 1965, the Philippines had a foreign debt of US\$13.5 billion. In 1986, when the Americans FORCIBLY BROUGHT Marcos TO Hawaii, President Aquino inherited a foreign debt of US\$24 billion. But, of these, US\$7 billion was incurred by the private sector. At his ouster, Marcos left US\$2.5 billion IN THE Central Bank reserve. This means that Pres. Marcos during his 20 years of absolute rule only incurred a measly US\$1 billion foreign debt to build up this nation with its fast growing population and numerous infrastructure projects.

How did President Marcos manage this government financially? Besides the annual national budget of P35 billion from the national treasury, he had all this gold at his disposal for building the infrastructure projects that today stand unequaled by all the four succeeding presidents put together. Today, this country has a foreign debt of around US\$75 billion. From 1986 to 2000, the Philippine government under three presidents incurred a debt of US\$51 billion on top of its original US\$24 billion—in just 14 years!

In 1953, there developed a whirlwind romance between Marcos and the daughter of Antonio Diaz by Remedios Trinidad. Her name was Miss Imelda Romualdez. In 1954 she became Mrs. Imelda R. Marcos. In 1974, Antonio Diaz, who had changed his name to Colonel Severino Sta. Romana, died at

the San Juan de Dios Hospital. He left behind a wife, Luz Romano.

### **THE AFTERMATH: EDSA REVOLUTION**

In the restive 70's and 80's, "blood money" from the Roman Catholic Church, channeled into the Philippines via the Vatican Bank (and another foreign power) fueled the flames of dissension in the countryside and on the streets of Manila. All of that gold in the hands of one man like Marcos gave the chill to those who have been so long used to so much money and power.

A concerted church and foreign civil destabilization campaign against Marcos was intensified in the second half of 1983. To make things worse for Marcos, in June that year he appeared before the First World leaders in Toronto. There he announced his grand plan of boosting the economy of the Southeast Asian region by creating the ASIAN DOLLAR, backed by the 400,000 metric tons of gold in the Central Bank of the Philippines. This was his vision to raise Southeast Asia to be at par with the rest of the First world countries. Next, the U.S. Secretary of State, Henry Kissinger, was replaced by James Baker III, the head of the CIA. **[H: WONDERS JUST NEVER SEEM TO CEASE.]**

Two months later in August 21, Sen. Ninoy Aquino, who was given by his U.S. doctors three weeks to live because of cancer, came back to the Philippines and was "assassinated" (with consent) by a foreign agent at the Manila International airport. The blame was placed on Marcos.

It reached the climax on the eve of February 22, 1986 when the Roman Catholic Cardinal told the people to come out of their homes to rally at EDSA. Priests, nuns and seminarians in their clerical robes could be seen everywhere. Radio Veritas, the Roman Catholic radio station, controlled by another foreign civil power, monitored and encouraged the people, without any let up, to continue rallying against the 'corrupt' regime of Marcos. On the third day, the ailing President Marcos was drugged and dragged to Hawaii by the U.S. Marines.

In 64 AD, Emperor Nero played [fiddled perhaps?] with his harp while he watched Rome go up in flames that he himself set ablaze. The blame was placed on the Christians. Intense persecution of Christians ensued. It seems history repeats itself.

### **THE GOLD AND THE GREEDY**

To this day, the 400,000 metric tons of Philippine gold are still in East Avenue, Quezon City. But the Philippine government does not acknowledge their existence. The agents of the International Monetary Fund are watching that gold now so nobody could move them. **[H: The author obviously refers to this gold as "these" or "them" because of the fact that they are in bars of various sizes. It is cause for debate as to whether or not all the gold is STILL available at the address given. To us it matters not for gold ANYWHERE is suitable for our purposes no matter where the idiots have stashed it—especially the IMF/WB/Fed Reserve.]**

In 1993 President Fidel Ramos abolished and privatized the Central Bank of the Philippines. It is now KNOWN as the Bangko Sentral ng Pilipinas (BSP). Its present owner is unknown. There is no record of it at the Securities and Exchange Commission. Definitely, the Philippine government does not anymore own it. Except for Rafael Buenaventura, whose present tenure as puppet governor of the bank is confirmed by a foreign power, nobody can poke his nose into the affairs of the BSP. Not even the President of the Philippines can touch him. That would be interference and trespassing in a

foreign-controlled bank, the BSP.

The American magazine, *WEEKLY WORLD NEWS*, June 12, 2001 issue, printed this: "FORT KNOX, KY.—America's current financial crisis is far more dire than President Bush has been telling us, says a leading economist—who charges that Fort Knox is empty and the country has gone bankrupt! Insiders in the U.S. Treasury warn that a complete collapse of the U.S. economy, which is already sinking into a recession, could be just weeks or even days away. 'There isn't a nickel's worth of gold in Fort Knox anymore—what you see now are **lead bricks painted gold** to fool visitors,' claims Harold Goldbloom, a highly respected professor of economics. 'That's because our treasury is utterly depleted and the situation is so desperate we've had to tap into our gold reserve—the nation's emergency 'nest egg'—as a last resort.'

"President Nixon took America off the gold standard in 1971, but even so, U.S. citizens have rested secure in the knowledge that we had about 147 million ounces of gold in the heavily guarded depository to fall back on in the event of a national emergency. But that sense of security is false, the D.C.-based economist warns. 'The reality is that over the decades our leaders have dipped into this 'piggy bank' from time to time, whenever they needed fast cash for pet projects,' says Goldbloom. 'In their minds, all that gold was just sitting there and the temptation was impossible to resist.' The missing gold has been quietly sold off over the years to oil-rich nations such as Saudi Arabia.

"During the Clinton years, the gold sell-off accelerated, the expert reveals. 'Didn't you ever wonder how we 'miraculously' went from a budget deficit to a budget surplus overnight?' Goldbloom asks. 'But that surplus is only an illusion. 'The truth is, our economy has been in a downward spiral for many months now.' President George W. Bush, in a desperate, last-ditch bid to save the economy, has sold off the rest of the nation's gold supply 'at fire-sale prices' to fund his \$1 trillion-plus tax cut, Goldbloom says. This has left us with no way to pay the monstrous national debt.

"Now our nation is buried under a mountain of \$5.7 trillion in debt. It's like when you've maxed out all your credit cards and pawned off all your jewelry,' says the expert. 'You can only keep faking it for so long—the wolves are at our door now. Our foreign creditors are concerned that we won't be able to pay them back and they're lining up to call in their loans so they don't get stuck holding the tab.' When that happens, he says, the major U.S. banks will collapse, then the smaller ones. According to insiders, Federal Reserve Board Chairman Alan Greenspan is urging President Bush to 'declare a national emergency now.'—By Mike Foster.

FORT KNOX IS EMPTY! But the U.S.A. still keeps on printing dollars. In every dollar bill it says, "This note is legal tender for all debts, public and private." As a guarantee to that promise, the U.S. government uses the Filipinos' 400,000 metric tons of gold in East Avenue, Quezon City to back up the printing of more U.S. dollars. This would make one wonder 'Who is now the real owner of that gold in the Minting Plant of the BSP?'

Marcos, who descended from the Madjapahit Royal Family, wanted to establish a Maharlika for the region of Southeast Asia and one strong currency backed up by the gold bullions in the Philippines. But some Church and First World countries did not want this.

Dr. Jose Rizal said, "There are no masters where there are no slaves." For the First world countries to stay in power and continue dominating the majority of the population of the world, the Third World countries must

stay as they are. The masters cannot be masters unless there are slaves they could dominate and exploit.

To the fiendish satisfaction of the Vatican, her millions of subversive dollars for the Philippines were well spent. NERO in the past—the VATICAN in the present—and both ROMANS! Their style is the same, yesterday and today. Create an embarrassing and uncompromising situation and blame it on the unwitting intended victim. In this case the victim was Marcos. They flex their muscles and deliver the message: “We are a power to contend with. We can do or undo governments. We can do or undo peoples.” Thus says the ‘VICAR OF CHRIST’, who is well entrenched and perched in splendor atop the CITY OF SEVEN HILLS, Rome.

The world-famous EDSA revolution of February 23-25, 1986 was the Roman Catholic Sword with a foreign civil power (the two swords of Pope Boniface VIII) executing its judgment on the ‘wayward’ Roman Catholic subject, President Ferdinand Marcos. Marcos must not be allowed to upset the balance of power in the region and in the world. The status quo must remain. Marcos must be removed.

In the future, the late President Marcos will share his crime. All this long while, Filipinos have been barking at the shorter and lesser tree. It was (sic) ‘confirmed and established’ by President Cory Aquino that Marcos was corrupt and emptied the coffers of the Philippine government. Then she and the Presidential Commission on Good Government (PCGG) kept on mouthing that the Philippine government must get back the hundreds of billions of dollars that Marcos stole and stashed abroad. Naturally, the foreign banks and governments must freeze all the ‘Marcos money’ because the Philippine government, to this very day, keeps on saying that that is ‘stolen money’. If only this government would acknowledge that it made a mistake and that the ‘Marcos money’ was, after all not stolen, then all those frozen dollars of Marcos would be released in favor of the Philippine government and the Filipino people. But it is all a devilish scheme of some foreign powers with the cooperation of some money and power-starved Filipinos. ## FOUNDATION

A Foundation in the Philippines is given a date for its Annual Meeting. Ours is April 7. Last year we had to survive a “take-over” attempt by some dissident Member/Trustees which included the then President and Treasurer. They had tried to load in some new members at the last minute so that they could vote in their own exclusive management. They actually failed to submit applications and fees for their new members and, realizing that they were too late, pretended that the meeting was scheduled for 2 PM instead of 10 AM. At 10 AM they boycotted the meeting with the idea that we would not have a quorum but they miscalculated that Professor Jaime Ramirez would go with them; instead, he showed up at 10 which gave us a quorum of 5 members. We held the meeting and elected all five members as Trustees and dropped them from the membership roster for non-payment of their dues.

This year they planned to pretend that they were still members and would attend the meeting, which they presumed would be at 10 AM. Through the Prof we got wind of their scheme so we noticed and held the meeting at 8. We had a quorum and Tom Taylor had agreed to be a member and Trustee, at least temporarily, so we inducted him as a member and then elected him as a Trustee. While he is still confined to his home, he gave his proxy to me so it all went clickety-click and we adjourned the meeting at 9:15.

I had asked John the Bellman to let me know if any, and who, showed up. He knows them from the many meetings we have held there with them before. About noon he called to say that they had come in and asked him where we might be holding the meeting. He told them the meeting was over and we had all left. He said they seemed a bit upset but they ordered a sandwich, talked awhile and left. Hours later I received a text from the Prof that they had sent him a text, “See you next year.”

On Friday a week ago I wanted them to file a “Petition” for a Temporary Restraining Order with the Supreme Court. We had decided to do it a month ago and the Foundation attorney, Estepa, had been getting things together and sending Cenon thither and yon to gather documents, or get them certified, and they got the last one in late Monday. When we met Tuesday morning I asked Estepa how many copies they would need, what was the filing fee going to be, etc., so that I could put enough money in Cenon’s envelope to cover it all, including the filing fee of some \$200. The GAIA attorney (Judge Reyes) was there also and between them they decided to make 15 copies. I said, “There are 15 Supreme Court Justices, do they not all have to have one? We are asking them for a decision in 3 days on the TRO so they won’t have time to pass it around and they won’t go to the expense of copying it themselves.” Well, came back the answer that only a few of the Justices would look at it and the others would rely on their opinion. To shorten up the story, it turned out that the SC required 16 copies, I insisted on a copy so everybody wanted a copy and we wound up having to have 26—but with interim counts of 19 and 21, each requiring another trip to the “xerox store”. It turned out to be a

magnificent, monumental piece of work. A typical ream of paper is a bit less than two inches thick and these two documents, the Petition and its supporting Appendix, are 4 ½ inches thick, more than 1100 pages. Very late on the Friday afternoon that it was supposed to be filed I got a text from Cenon: “We have only 16 finished and it is too late to file. Can I come by and show it to you?”

The last time I heard from him was earlier in the day and they were nearly on their way to do the filing at the Solicitor General and the Court of Appeals, which had to be done before they could deliver it to the Supreme Court. Cenon had hired his son to help tote the bundles totaling by this time some 60 reams of paper and of course they were having to take taxis wherever they went. Needless to say, when I learned they had missed filing Friday, costing us not 1 but 3 days as far as the date-stamp is concerned, I nearly fell out of my tree.

So I called Cenon on the cell phone and answered him thusly: No, Cenon, I am so disappointed and angry that I really do not want to see you until after you have it filed. He protested that Estepa said it [would] be OK to file Monday. I said, “The justification we have for asking for the TRO is that the Court of Appeals has scheduled a hearing Friday, April 7 and we are alleging that we are disadvantaged not to be allowed (by the CA) to intervene and to be heard in that hearing. Do you think the Supreme Court Justices will be favorably impressed when we rush in Monday morning with this monstrous Petition for a Temporary Restraining Order that has to be acted upon by Thursday? I would be surprised if they do not censure Attorney Estepa; for sure we cannot expect a positive ruling on our Petition.”

When they finally got to the Supreme Court to file the Petition on Monday afternoon, it was discovered that a 50-some page document was missing from 7 of the appendices—must have been left out of the copying when the count was 19. The nice person at the SC said they could bring it in the following morning before 8 AM and insert it. They sent the son, BongBong, to do that and he got it done before noon on Tuesday.

We held our usual Board of Trustees meeting Tuesday morning and spent the time planning for the Annual Meeting on Friday. The Prof went from the Foundation meeting Friday directly to the CA to see what we were missing by not having had a ruling from the SC, which would have stopped the CA hearing on Friday but obviously didn’t. Tallano had 35 people there, some attorneys and the rest “supporters” and nothing was said about the Foundation.

Some day we will get something from the SC. No matter what it is, as long as it recognizes the Foundation as a litigant, we will be able to use it in all of the other courts around when we have to have an Order issued to confirm the sale of a property. We are slowing [Ed: slowly?] getting the Foundation in the position of being able to “sign off” as the legitimate owner and seller of properties and there are a number of potential transactions that would realize some income when we can conclude a proper sale.

I need to get on to bed—it is after 11. My “physical” has gone alright so far. Hypertension is not so bad as to require medication—just lose 1 pound a week for 10 weeks (who’s he think he’s kidding—I weigh 205 and his chart says I should weigh 170. Must be an OIP chart?) Well, 10-pounds-at-a-time is probably what he has in mind but, hell, anybody can tackle 10 pounds. I am to see a cardiologist Monday afternoon to see if they can figure out why my pulse is slow (50s & 60s) but elevates to near 100 after eating. Right now my BP is 138/88, pulse 54. More tomorrow—EJ

As we move back now to the topic of Non-Usury Banking, let us continue with Objectives and Philosophy of same. This is NOT exclusively Islamic but "unfortunately" those who could give "impressions" to the public have labeled this type of banking in honor, integrity and goodness, to be Islamic. Well, I consider that a compliment to the Muslims—for this is THE way all business and banking should be structured. The concepts of Power Elite "takers" are what has brought the world to its knees, made cheating, theft, lying and trickery the accepted norm of the day.

#### THE OBJECTIVES AND THE PHILOSOPHY OF ISLAMIC BANKING

Profit maximization is usually considered the most important objective of commercial banks, especially privately owned banks. Contrary to this objective, Islamic banks exist to promote, foster and develop banking services and products based on Islamic principles. Islamic banks are also responsible for promoting the establishment of investment companies or other business enterprises as long as the activities of these companies are not forbidden by Islam (Khan, 1983).

The main principles of Islamic banking comprise of prohibition of interest in all forms of transactions, and undertaking business and trade activities on the basis of fair and legitimate profit. Islamic banks are

also to give zakat (wealth or alms tax) and to develop an environment which benefits the whole society.

Nevertheless, like any other business entity, Islamic banks are expected to make a profit from their operations. It is considered an injustice for Islamic banks if they are unable to provide sufficient returns to the depositors who entrusted their money to them (Mirakhor, 1987). Therefore, while ordinary business institutions are likely to place profit as their primary objectives, Islamic banks have to incorporate both profit and morality into their objectives.

[H: WHY? THIS IS A TERRIBLE CONCEPT FOR A BANK IS FOR THE HOLDING OF PROPERTY TO KEEP IT SECURE. THERE IS

FOR YOUR ACTIONS, AS THE OLD SAYING GOES, SPEAK FAR LOUDER AND TELL MORE TRUTH—THAN ALL THE WORDS IN A DICTIONARY.

NO "BUSINESS" OTHER THAN PAYMENT FOR STORAGE AND OPERATING CONVENIENCE THAT SHOULD INVOLVE BANKS. THIS IS A MYTH THAT HAS CONVENIENTLY COME FORTH AND IT IS A GROSSLY TERRIBLE CONCEPT. If you have hired a guard for your business, say to guard your inventory in a drug-store, is that guard now responsible for making a profit off the products, use the products for gain for self or WHAT? No, he is hired to protect another's property. THIS IS THE PURPOSE OF A BANK—IT IS A SECURITY STORAGE SERVICE WHICH, AT MOST, KEEPS ACCURATE BOOKS AND HAS "YOUR" DEPOSIT SAFE AND READY FOR YOUR USE AT ANY TIME YOU ASK—PERIOD.]

For example, Dar Al-Maal Al-Islamic Trust, i.e., the holding company for FIBB and another 25 financial and business companies operating on the basis of Shariah in 15 countries around the world, established the following objectives for its group of companies:

1. To put before to all Muslims, contemporary Islamic financial services, helping to execute their financial dealings in strict respect of the ethical individual and social values of Islamic Shariah, without contravening the heavenly imposed prohibition of dealing in *riba* (interest or usury).
2. To serve all Muslim communities in mobilizing and utilizing the financial resources needed for their true economic development and prosperity within the principles of Islamic justice assuring the right and obligations of both the individual and the community.
3. To serve the 'Ummat Al Islam' (Islamic communities) and other nations by strengthening the fraternal bonds through mutually beneficial financial relationships for economic development and the enhanced environment for peace.

(Faysal Islamic Bank of Bahrain (FIBB), 1993)

Further examples of the objectives of selected Islamic banks in various Muslim countries are presented below.

BANK ISLAM MALAYSIA BERHAD (BIMB), MALAYSIA:

"To provide banking facilities and services in accordance with Islamic principles, rules and practices to all Muslims as well as the population of this country. The Islamic principles, rules and practices are essentially those belonging to the body of Islamic principles on commercial transactions (*ahkam al-muamalah al-Islamiah*) that relate to banking and finance. The bank's efforts to provide these banking facilities and services are undertaken within the framework of its viability and capability to continuously grow and expand." (BIMB, 1985)

DUBAI ISLAMIC BANK (DIB), THE UNITED ARAB EMIRATES:

"The main objective of an Islamic bank is to prohibit the Muslims from dealing with interest or usury which has been strictly prohibited by Allah and to protect them from one of the biggest sins." (undated DIB information leaflet)

ISLAMI BANK BANGLADESH LIMITED (IBBL), BANGLADESH:

"Our aims are to introduce a welfare-oriented banking system and also establish equity and justice in the field of all economic activities." (ibbl, 1993)

KUWAIT FINANCE HOUSE (KFH), KUWAIT:

"To conduct all banking operations and services for its own account, or for the account of third parties, without practicing usury, whether in the form of interest or in any other form.

"To carry out direct investments or purchase or finance projects or activities owned by others, on a non-usurious basis." (KFH, Memo and Articles of Association, 1977)

FAYSAL ISLAMIC BANK OF BAHRAIN (FIBB), BAHRAIN:

"To promote, foster and develop the application of Islamic principles, laws and traditions to the transaction of financial, banking and related business affairs including the investment of funds for the purpose of compensation for the financial consequences of defined risks or losses, and to promote investment in companies, enterprises and concerns which shall themselves be engaged in business activities as are acceptable and consistent with Islamic principles, laws and traditions and in no event engaged in the alcoholic beverage trade, the business of borrowing and lending money at interest, the gambling industry or the pork meat industry." (FIBB, undated Memo and Articles of Association)

JORDAN ISLAMIC BANK, JORDAN:

"The Bank aims at meeting the economic and social needs in the field of banking services, financing and investment operations on a non-usurious basis. In particular these objects shall include:

- a. Expanding the extent of dealings with the banking sector by offering non-usurious banking services with special emphasis on introducing services designed to revive various forms of collective social

responsibility on a basis of mutual benefit.

b. Developing means to attract funds and savings, and channeling them into participation in non-usurious banking investment.

c. Providing the necessary financing to meet the requirements of the various sectors, particularly those which are not likely to benefit from usurious banking facilities.” (Jordan Islamic Bank for Finance and Investment Law, 1978)

As an institution whose foundations are based on religious doctrines, the establishment and operation of Islamic banks has raised many theoretical and conceptual considerations. As mentioned by Ali (1988):

“The Islamic economic order is based upon a set of principles found in the *Qur’an*. No matter what aspect of the Islamic economic order is introduced, for practical operations it has to base itself on the Qur’anic concept of social justice. The Islamic financial system, therefore, cannot be introduced merely by eliminating *riba* but only by adopting the Islamic principles of social justice and introducing laws, practices, procedures and instruments which help in the maintenance and dispensation of justice, equity and fairness.”

The objectives and philosophies of Islamic banks are thus in line with the revelations in *Al-Quran*. As an entity that is established within the ambit of Islamic law, an Islamic bank is expected to be guided by these philosophies. Establishing the right philosophies is important for any Islamic bank for two reasons. Firstly, these philosophies will be used by the management or policy makers of Islamic banks in the process of formulating corporate objectives and policies. Secondly, these philosophies serve as an indicator as to whether the particular Islamic bank is upholding true Islamic principles. Islam permits and encourages its followers to become involved in trade activities. As stated in *Al-Quran* in verse 275 of chapter 2:

“But Allah hath permitted trade and forbidden usury...”

The Prophet (*pbuh*) in his early life used to be a trader and, similar to many of his eminent companions, was a businessman. From the religious prospective, the establishment of an Islamic bank is considered a righteous move for two reasons. Firstly, its existence is in line with the divine revelation, i.e., to involve in trade. Secondly, Islamic banks provide an avenue for Muslims to perform banking business in the Islamic way, i.e., free from any element of usury.

Eliminating the element of usury in the banking system is only part of Islamic business principles. Islamic banks are expected to conduct their business with the objective of making profit and at the same time must conform to Islamic business principles. They must also observe the rules and laws which are directly imposed on individual Muslims. Otherwise, they should not define themselves as Islamic entities. Nevertheless, whatever law is imposed on Muslim individuals is indirectly applicable to Islamic banks. This relationship leads to the philosophical questions: “What should the Islamic banks do, and what should the banks believe?” For Muslims, the answers to these questions were given by the *Al-Quran* in many of its verses. For example, verse 132 of chapter 3 says:

“Obey Allah and the Messenger, that ye may obtain mercy.”

Verse 59 of chapter 4 of *Al-Quran* also highlights: “O ye who believe! Obey Allah, and obey Messenger...”

Therefore the foundations of the philosophy of Islamic banking are those principles which have been revealed in the *Al-Quran* and the Hadith or traditions of the Prophet (*pbuh*). Revelations which directly or indirectly require Muslims to uphold justice and virtue are used by Islamic banks as guiding principles in their business affairs.

The principles of Islamic business include honesty and the belief that trade is to be conducted in a faithful and beneficial manner. Islam conceives trade as an honest effort, an earnest endeavor, and a human striving for earning one’s rightful livelihood. Trade manipulations and malpractices aimed at earning undue profit through operations like hoarding, black-marketing, profiteering, short-weighting, hiding the defective quality of merchandise, and adulteration cannot be regarded as honest trade (Siddiqi, 1986). [H: Wow, now just who would do these things? Do you see, chelas, HOW FAR MAN HAS COME DOWN THE ROAD “AWAY” FROM GOD?] The Prophet (*pbuh*) was once conferred the title of “Amin” or trusted because of his honesty in all dealings. The operations of Islamic banks, therefore, are based on the concepts of honesty, justice and equity as practiced by the Prophet (*pbuh*).

[H: Can you see what our REAL problem is, chelas? It doesn’t matter what you “call” yourself. Unless mankind comes back into the righteous behaviors as are decent, honest, filled with total integrity and can be TRUSTED, there is no point in just getting a lot of money just to continue in the greedy system of greedy industry and, frankly, banking is only a part of the whole. Concepts must be changed and PROVEN TO BE BETTER or you will just get something like: “Oh well—that is just those strange Muslims and Islamic strange people.” I repeat something very important: PEOPLE SIMPLY HIDE BEHIND RELIGIOUS IDEAS TO COVER THEMSELVES WITH THE “APPEARANCE” OF GOODNESS while they continue in their corruption and ill-begotten dishonest behaviors. And I will ask you again: “Who has the reputation for these corrupted and greedy traits—in EVERY INSTANCE?” I certainly do not claim that everyone doesn’t try to hop on the grafting bandwagon but how can you CHANGE A WORLD if your corruption is simply carried forth in all “new” possibilities? If allowed to be established the better and honorable way, THIS WILL BECOME THE LAW AND THE PRACTICED METHOD OF INTERCHANGE—BUT SOMEONE SOMEWHERE HAS TO LAY A FOUNDATION—AND KIDDIES, THAT IS “US”. The structure is present but is getting destroyed in the manipulations as people begin to believe there is no “other” way to function. And along comes some new Guru who says the new realization is that there was wrong interpretation by the Messenger and it really meant... whatever is decided serves the best purpose for the new “revelator”. NO, we go back to God in righteous practice or GOD WILL NOT LONG SHELTER US. GOD GIVES AND GOD TAKES

AWAY—WHEN WE FAIL TO KEEP OUR PROMISES UNTO HIM. WE CAN TURN THE WORLD OF CITIZENS INTO THE RIGHT DIRECTIONS BUT UNLESS WE DO AND PRESENT BETTER WAYS—WE WILL HAVE ACCOMPLISHED NOTHING.]

The meaning of righteous trade can best be understood from the metaphorical content of chapter 35, verse 29 of *Al-Quran* which says:

“Those who rehearse the Book of Allah, establish regular prayer, and send (in charity) out of what We have provided for them, secretly and openly, hope for commerce that will never fail.”

This verse teaches Muslims that the godly man’s business will never fail or fluctuate because Allah guarantees him the return, and even adds something to the return out of his own bounty. Analogically, honest trade will lead to the earning of profit in this world as well as in the hereafter. Tarmidzi (circa. 892) reported that the prophet (*pbuh*) mentioned that, “The truthful, honest merchant is with the Prophet, truthful and martyr.” (Siddiqi, 1986).

In the process of conducting business, Islamic banks seek to bring about a lasting balance between earning and spending in order to achieve the target of the betterment of the whole community. Islam has always emphasized the lawful earning of livelihood. All unlawful means of acquiring wealth are prohibited. Chapter 4, verses 29 and 30 of *Al-Quran* states:

“Oh ye who believe! eat not up your property among yourself in vanities; but let there be amongst you traffic and trade by mutual goodwill; Nor kill (or destroy) yourself: for verily Allah hath been to you most merciful. If any do that in rancor and injustice—soon shall we cast them into fire: and easy it is for Allah.”

In terms of spending, Islam demands that its followers spend money for the welfare of the people and not for wasteful or pleasurable activities. This directive is given in verse 219 of chapter 2 of *Al-Quran* which says:

“They ask thee concerning wine and gambling. Say, ‘In them is great sin, and some profit, for men; but the sin is greater than profit.’ They ask thee how much they are to spend; say, ‘What is beyond your needs.’ Thus doth Allah make clear to you his sign; in order ye may consider.”

Verse 36 of chapter 4 of *Al-Quran* also outlines the right conduct for Muslims which is applicable to Islamic banks in conducting their business. It says:

“Serve Allah, and join to any partners with Him; and do good to parents, kinsfolk, orphans, those in need, neighbors who are near, neighbors who are strangers, the companion by your side, the wayfarer (ye meet) and what your right hands possess; for Allah loveth not the arrogant, the vainglorious.”

In dealing with their customers, Islamic banks are expected to conduct the transactions for the benefit of both, i.e., the banks and the customers, and to uphold the concept of justice. Besides what was revealed in chapter 4 verse 29, chapter 4 verse 135 of *Al-Quran* says:

“O ye who believe! stand out firmly for justice, as witnesses to Allah, even as against yourself, or your parents, or your kin, and whether it be (against) rich or poor: for Allah can best protect both. Follow not the lusts (of your hearts), lest ye swerve, and if ye

distort or decline to do justice, verily Allah is well-acquainted with all that ye do.”

Again in chapter 16 verse 90, it is stated:

“Allah commands justice, the doing of good, and liberality to kith and kin, and He forbids all shameful deeds, and injustice and rebellion: He instructs you, that ye may receive admonition.”

These two verses require Muslims to uphold justice irrespective of any blood relationship or status. Applying these verses to a business context, Islamic banks should treat their customers equally. This concept of justice is extended by Islamic banks when imposing charges on customers and also when fixing profit-sharing ratios, either with their investors or with their business partners. This philosophy is also reinforced by verse 87 of chapter 5 of *Al-Quran*:

“O ye who believe! make not unlawful the good things which Allah hath made lawful for you, but commit no excess; for Allah loveth not those given to excess.” [H: Please do not misread the meaning of this last statement. It does not mean that Allah doesn’t love the man who might be given to excess—but he does not approve excess intent or actions. “Love”, as in God’s absolute LOVE, is as a just “Father” who will allow and as that Father will allow in Love. But the children will also make errors in good judgment and do that which is not worthy of God’s perfect children—and it is THAT which is not “loved” by Allah. Can you further see how errors are made in simple “translations”? If a mistranslation is then perceived as absolute you have found something right here that MEANS: God does not appreciate him who is excessive nor does HE approve of such intent or actions. Isn’t it sad, however, that mankind will actually go to WAR over such simple errors? Well, it is a manipulated world and you have all the answers as to WHY there would be deliberate mistranslations in addition to simple errors in languages. YOU AS A CHILD OF ALLAH—ARE NEVER WITHOUT HIS LOVE.]

Mannan (1986) is of the opinion that, in an Islamic social system, welfare is maximized within the framework of *Al-Quran* and Hadith but is consistent with the spirit of the same may be styled as Islamic. Mannan (1986) believed that it is not harmful for Islamic banks to carry out business activities as long as these activities are not prohibited in *Al-Quran* or Hadith.

In Islam, Allah retains absolute ownership of everything. As stated in verse 189 of chapter 3 of *Al-Quran*:

“To Allah belongeth the dominion of the heavens and the earth; And Allah hath power over all things.”

This absolute ownership does not reflect that Allah has created everything for Himself. On the contrary, it is stated in verse 29 of chapter 2 that:

“It is He who hath created for you all things that are on earth; then He turned to the heaven and made them into seven firmaments. And of all things He hath perfect knowledge.”

Mannan (1986) claimed that the above verse emphasizes that what Allah has created belongs collectively to the whole of human society. Legal ownership by the individual, that is to say the right of

possession, enjoyment and transfer of property, is recognized and safe guarded in Islam, but all ownership is subject to the moral obligation and even animals have the right to share. This moral obligation is stated in verse 19 of chapter 51 of the *Al-Quran*:

“And in their wealth and possessions (was remembered) the right of the (needy), Him who asked, and him who (for some reasons) was prevented.”

As for Islamic banks, while making profit from the business is allowable in Islam, the accumulation of profit without utilization for the betterment of the community is forbidden. Because of this revelation,

Islamic banks are expected to be more sensitive to the needs of society, promote more social programs and activities, and make contributions towards the needy and poor families.

Islam prohibits accumulation of wealth or its unrestricted possession by individuals EXCLUSIVELY IN THEIR SELF-INTEREST. Besides that, Islam commands that even wealth which is earned by the right means should not be HOARDED in selfish interest because it would impede the growth of the economy, thus creating social imbalance. Verse 3 of chapter 180 of *Al-Quran*, says:

“And let not those who covetously withheld of the gifts which Allah hath given them of His Grace, think that it is good for them; nay it will be the worse for them; soon shall the things which they covetously withheld be tied to their necks like a twisted collar.”

Again in verses 1 to 4 of chapter 104 it is repeated:

“Woe to every (kind of) scandal monger and backbiter, who pileth up wealth and layeth it by, thinking that his wealth would make him last forever! By no means, he will be sure to be thrown into that which breaks to pieces.”

Three vices mentioned by the above verses are condemned in the strongest terms: 1) scandal mongering, talking or suggesting evil of men or women by word or innuendo, or behavior, or mimicry, or sarcasm, or insult; 2) detracting from a person’s character behind their back, even if the things commented are true, where the motive is evil; 3) accumulating wealth, not for use and service to those who need it, but in miserly hoards, as if such hoards can prolong the miser’s life or give him immortality; miserliness is itself a kind of scandal (Ali, 1989). The revelations in Chapter 104 serve as a reminder to those who manage Islamic banks to be cautious in managing the assets of the banks. Islamic banks are prevented from accumulating wealth without any purpose. The wealth should be spent on the needy and for the betterment of the whole society. Failing to

conform with the instructions of Allah means there is a great possibility that the wealth accumulated by the banks will be destroyed. The destruction may be in the sense that the bank will not be able to make profit and ultimately have to cease business.

*Al-Quran* in many of its verses indicates the principles which serve to guide Islamic banks in their practical affairs. To become involved in business is highly encouraged by Islam, but the business must be conducted on the basis of equity and justice. Islamic banks are prevented from engaging in business activities forbidden by Islam. During the course of conducting a business, every customer must be treated equally and lavish spending is not allowed. Islamic banks are also expected to make a profit from their business. This profit, however, is not to be accumulated without any specific reasons. Instead, Islam encourages its followers to spend for the needy and for other socially permitted activities.

It appears this is a good place to interrupt this writing and perhaps we can finish this chapter in the next session.

Do not err by saying that “unconditional” LOVE and “absolute” LOVE are the same thing for GOD IS ABSOLUTE LOVE—BUT HE PLACES GUIDELINES AND “CONDITIONS” ON YOUR ACTIONS TO BE WITHIN “PERFECT” LOVE WITHIN HIM. HE will always ALLOW for you are manifest on a free-will planet of lessons in choices. And HE will not interfere in those allowances for even “bad choices”—however, he expects the whole of HIS people to not condone or allow the evil actions of others without confrontation. THIS IS WHY YOUR PLANET IS MOVING TOWARD DESTRUCTION. AN UNBELIEVABLE NUMBER OF THINGS ARE ‘CONDONED’ THAT ARE TOTALLY EVIL. “What do you think of David Icke?” was the question in the e-mail from Linda.

Icke (rhymes with Mike) is the wildly popular author of a bevy of mind-wrenching books, most recently *Tales from the Time Loop*, *Alice in Wonderland and the World Trade Center Disaster*, *Children of the Matrix* and another book subtitled *The Robots’ Guide to Freedom*. A former British soccer star turned sociopolitical guru, his most controversial thesis is that the world is ruled by a heartless band of elite lunatics he is predisposed to label as Reptilians.

I must admit for the longest time I dismissed him out of hand as simply another New Age charlatan. Notwithstanding my knowing about the triune brain in humans (and that the inner core is, in fact, the reptilian brain), I simply don’t like flip categorizations of human groups, like calling Jews chiselers, Blacks lazy or Poles lightbulb changers.

I first became snagged by his website by the things he reprinted from other sources. What got me was the legendary essay “Report from Iron Mountain,” which everyone in the world should read. Then I scouted out some [of] his works and realized what he was up to. And what he is up to is probably the most important task in the world—how to identify those who control us.

Here’s how I responded to that e-mail.

I think Icke may be closer to the truth than anybody else, Linda.

At the very least he is metaphorically accurate.

It’s undeniable there is a genetic grouping of “relatives” who dominate the elitist group that runs the planet. This is how people can trace the relationship of the Sabah family that runs Kuwait to be cousins, somewhat far removed, of both Queen Elizabeth and President Bush

That Icke calls them “Reptilian” may be a little

unnerving and perhaps melodramatic (although there is nothing melodramatic about how our planet is being destroyed by them), but apparently this genetic link does exist.

Many of these rich psychos believe they are part of the bloodline of Jesus (or Thoth, or Abraham, or Enlil), and even though it’s proven that none of these characters were actual human beings, the pseudo-legitimacy of the claims have nevertheless been exploited to accrue great power over the centuries. Oh that supernatural sanction! The main hurdle we now face as a species is to realize that all these gods we’ve created are merely projected shadows of our own fears, and that cynical manipulators have been using them against us for centuries.

A lot of people regard Icke’s synopses of history as spurious pseudoscience, but let me tell you, the official histories used by credentialed academics, who look down their noses at alternative versions, really have no more credibility than Icke’s assertions, maybe less.

You only have to consider what mainstream media has told us about the war in Iraq and about 9/11 to realize that if this kind of cynical manipulation of the true story by the powers behind the scenes has been going on throughout history, then we don’t really have any idea what happened at any time because we only have the tailored version the power elite used to cover up their various crimes.

When you consider this, Icke becomes credible and prescient. And everything you ever learned about the world becomes open to question. I believe that’s the way it is, for real. I believe Icke produces a useful template for understanding events. Nobody ever gets all the little details right.

[*Emphasis added:*] **The top priority for humanity has become how to identify those who are really running things, because the planet is being ruined and they are clearly the reason.**

Another e-mail I received that same day, this one from Lucille, took me to task for blaming the Dark Ages on the newly formed Roman church running amok. She rightly pointed out that the Dark Ages occurred because Rome had to that point controlled most of the civilized world, and when Rome fell apart, so did the world it controlled. All the channels of authority disintegrated and chaos ensued. When I read her note, I had an inkling that this is what is about to happen to America and our whole world. A new Dark Ages, ruled by chaos and mass death.

Then my friend Pieter from Holland wrote and said he couldn’t cope with his e-mail volume, and even though he loved my essays, he asked me to stop sending them. He also explained he’d had trouble dealing with pronouncements about the formation of Christianity, and while he appreciated my political perspectives, the value he’d gotten from his beliefs and the truths he had read in Christian literature (and Pyramid inscriptions) prevented him from acknowledging the structure of his belief system as false. The proof, as it were, was in the pudding.

I replied:

I know exactly what you mean about the inbox problem. Once a week or so I have to throw away about 500 e-mails I wanted to ponder and respond to simply because I can’t deal with the volume, and I spend all day almost every day processing them. In a way, it’s a happy problem, but frustrating. I’m sure I offend a lot of people by not answering.

One quick note about those tantalizing historical portents, which can be likened to the warmth of the

accepted Christ vs. the flaws in the dogma of established churches. You don’t need to give up the former by rejecting the latter. The awesome joy of accepting one’s inclusion in the divine plan is in no way nullified by discovering that many priestly scholars are manipulative savages. This is true even if we are merely Nibiruan dogfood. The dream is the thing that’s real, even if many of the structural directions to get us there are just so many celestial Ponzi schemes.

That’s why people who are really solid in their faith don’t get upset when I set a match to the fantastic fabrications of religious dogma. They know who their God is, and the validity of their allegiance to goodness and the life force. Sure, they may loosen their collars a bit when I start going into how Jesus the historical character is largely a work of fiction, but academic repartee of that nature is not going to shake the emotional foundations of what they know in their bones to be true, that acknowledging you only work for the higher plan is a far stronger force than some clumsy catechism based on ancient and confabulated fictions.

It’s only the poseurs who are NOT sure of their faith who get upset when I start trashing the criminal manipulators who attended the Council of Nicea, or the psychotic propagandists who spasmodically insist exactly six million Jews died in the German gas chambers. When I say with conviction there were NO German gas chambers, those whose faith is based on a febrile fealty to their ethnic group rather than certainty in the ground of their being, instantly go mad and start arguing that freedom of speech must be curtailed and we may not talk about this topic.

In this same vein I believe that those who evangelize and desperately try to get others to accept their chosen path are really nonbelievers who are so insecure about their own beliefs that [they] have to put bandages on their own doubts by getting others to accept the very thing they are not sure about.

So I copied this response to Pieter (and the one to Linda) to my friend and beloved Rense columnist Jude Moriarty. She was thankful and replied:

“John...thanks for sending. I had never seen the ICKE site ...its humor is really something. In my many readings of documents/reports from various gatherings of the “elite” it is notable that they really do have this delusionary mindset that they are the appointed guardians/gatekeepers/special bloodline: Mad yes, but they believe it ... so remarks like “we have to rid the world of 4 billion people” can be made without any semblance of humanity .... I don’t know how many times in conversations with some pretty credentialed astute writers-poets-engineers-etc., that I’ve heard the same remarks/observations—that so-and-so appears human, has the mannerisms of a human, but something is missing, there’s an empty or chaotic nothingness in the eyes (windows to the soul) ... stands to reason if someone is soulless the eyes have it. But then who would believe — and that’s the charm of it ... but one knows madness-inhumanness when in the presence of it. If one has any semblance of discernment that is. Most people don’t.”

We see the world around us being poisoned, prostituted, destroyed. Who are the soulless people responsible for such a crime against God?

Is it really us, or is someone else? Sure we’d like to blame someone else, but many of us are genuinely doing the best we can to stop the murderous madness. Who are those who don’t?

Yesterday morning, the very first e-mail I received,

from Greg, contained the excellent recommendation to read a chapter of Carlos Castaneda's *The Active Side of Infinity*, the one called "Mud Shadows." As it happened, I had it in my bookcase. It was an excellent way to start the day.

Carlos the perpetually puzzled student was listening to his guru, the sage Indian nagual don Juan Matus, who told him (and I am condensing greatly):

The ancient sorcerors of Mexico discovered we have a companion for life. "We have a predator that came from the depths of the cosmos and took over the rule of our lives. Human beings are its prisoners." don Juan said this was "the topic of topics."

You might notice I have chosen to date this writing using "Mayan Calendar" (Cosmic) time as used by Commander Hatonn and the higher energies. In my opinion, this method of counting time is a pre-requisite to the straight thinking we will experience in the dawning Golden Age.

My understanding of the Mayan Calendar system (aka "Zoltkin") has been built on the lifelong studies of Jose Arguelles. In the article by John Kaminski on the facing page the question is posed, "How did the Elite get such a successful grip on the mass consciousness?" In my opinion, the answer to this question is revealed through understanding real time (Zoltkin) versus crooked time (such as the Gregorian calendar we follow today).

The natural cycles we used to follow were lost from our consciousness by the manipulation of the Elite Controllers (aka Predators, Reptilians, Khazars), who superimposed a false reckoning of time. The result: Confusion in the minds of men and their subconscious recordings at a very fundamental level.

awkwardly call it 365.25 days "on average" in the Gregorian system.

In the Gregorian count of each annual cycle the days of the week do not fall on the same number each year. They simply can't because of the crooked number of days in each month.

In the Zoltkin every day of every year falls on the same number and day of the week because the cycle is based on Nature.

Everything in the Zoltkin is based upon harmonics of the universe. The 26-year period just mentioned, for instance, is one-tenth of the larger, full 260-year "wheel" and it is half of a 52-year period, which in turn is four 13-year periods (remember the 13 tones mentioned above). The 52-year cycle is extremely significant in all aboriginal counting of time and in many aboriginal societies it is the point at which one would be considered an "elder".

In the Zoltkin all months are even with 28 days in each month times 13 months, which equals 364 days. The 365th day is known in the Zoltkin as the 'Day out of Time': a day of pause, celebration, renewal of the yearly Earth cycle, and synchronizing with the galactic clock. We might also consider it the day of birthing of the new cycle.

In a similar manner, the 26-year period from 1987 to 2013 could be viewed as synchronizing with a larger "wheel" of the galactic clock—and the time of birthing of the New Age. We could also refer to it as the birthing of the Phoenix. **During this time period we form in our minds what will be manifest in the next cycle. Do you understand the significance of that statement? Your thoughts during this period are creating the form of the next Age!**

Possibly one of the most conscious methods and useful tools to overcome the false mind of "crooked time" is consciously living the Zoltkin. ## BANK CRISIS PUSHES HAMAS GOV'T TO FINANCIAL BRINK

**The reluctance of banks to risk U.S. sanctions and lawsuits** by dealing with a Hamas-led government has pushed the Palestinian Authority to the brink of financial collapse sooner than donors had expected, diplomats said.

The rapid onset of a banking crisis—within days of Hamas's swearing-in on March 29—could further depress Palestinian incomes, fuel political unrest and speed the arrival of a humanitarian crisis with which donors are not yet prepared to cope, according to diplomats and Palestinian officials.

Western diplomats and private-sector experts said Hamas's troubles finding a bank has for now eclipsed Western aid cuts as the biggest immediate threat to the new government's viability.

"This is by far the biggest crisis facing the Palestinian Authority and the Palestinian economy. It could have profound long-term consequences," said Gidi Grinstein, president of the Reut Institute, an independent Israeli think tank.

Hamas cabinet members and other Palestinian officials have accused the Bush administration of sparking the crisis by pressuring Amman-based Arab Bank to stop managing the Palestinian Authority's main treasury account.

Diplomats and Palestinian officials said the account was effectively shut down, jeopardizing Hamas's ability to carry out basic functions like securing foreign aid and paying vendors.

"Even if you get emergency money together, there's no way to bring it in," without banks to make the transfers and hold the money, said a Western diplomat monitoring the crisis.

Hamas is already more than a week late paying March salaries to 140,000 Palestinian Authority workers and it was unclear when the government will be able to secure the funds to meet payroll.

In addition to pressuring the Arab Bank, **"the Americans informed (other) Palestinian banks that if they deal with the Hamas government they could risk legal and political measures against them,"** a senior Palestinian official said.

... A U.S. official, who spoke on condition of anonymity, said the Treasury did not tell the Arab Bank to freeze the Palestinian Authority's account. The official did not elaborate on what the embassy told the bank about its legal exposure *[the old getcha game so familiar to the Predators]*.

Experts said the banks's legal concerns stemmed from provisions of the Patriot Act and other U.S. laws which give the Bush administration sweeping powers to crack down on individuals and companies that provide any "material support" to Hamas *[or any perceived enemy of the Jewish homeland]*.

The Arab Bank is already under particular scrutiny from U.S. regulators. It was fined \$24 million last

year over alleged failures to comply with anti-money laundering laws aimed at blocking funding for banned "terrorist organisations."

... Grinstein said: **"The irony is that it is driven not by the state of Israel, but by the United States."**...

## PALESTINIANS TO GET RUSSIAN AID

Russia has said it will grant the Hamas-led Palestinian Authority urgent financial aid, in opposition to the policy of the EU and the US.

## JUDAS: THIS IS WHAT REALLY HAPPENED

After being reviled for almost 2,000 years as the embodiment of treachery, Judas Iscariot's side of the story was finally published yesterday. Thanks to a newly discovered gospel in Judas's name, we now know what his excuse was: Jesus made me do it.

In the days before the fateful Passover holiday, Jesus also told Judas: "You will exceed all of them. For you will sacrifice the man that clothes me." *[This is ONLY understandable if the Judas referenced is the betrayer, Judas Iharioth.]* The line, according to biblical scholars, suggests that Jesus chose Judas to help him achieve his destiny by liberating him from his earthly body.

"It's a striking contrast with the negative portrayal of Judas as the quintessential traitor," said Marvin Meyer, a biblical scholar from Chapman University in California who helped translate the gospel. We fail to see how Marvin Meyer arrives at 'a striking contrast' between the 30-years-long "translation" and "classical" stories, although there is such a "striking contrast" between either of those fables and the TRUTH. # The Myth And Reality Of Dividend Double-Taxation

Budget's "Tip of the Week" #13:

## Getting Money Out of a Corporation Avoiding Double Taxation on Dividends

"You don't want to take income into a corporation because there is double-taxation on dividends." This statement is only partly true and a half-truth is almost always intended to mislead. The truth is that a corporation earns money on which it is taxed; then, IF it pays out a dividend, the dividend is taxable in the hands of the recipient. Perhaps a better way to express the truth of the matter would be: You don't want to pay dividends out of a corporation because they are subject to double taxation. But there are many other ways of taking money out of a corporation, so the real question is why you would ever take it out in the form of dividends.

The primary method for taking money out of a corporation is in the form of payments for services rendered. Any such payment is a deductible expense to the corporation, reducing its taxable income. At the same time, however, such a payment becomes taxable income for the recipient. You don't want to receive much income personally because in all likelihood you will pay more in taxes on income received personally than the corporation would pay in retaining that income itself. On the other hand, if an individual keeps living expenses moderate and takes out only what he needs, his personal tax rate is often not much higher than that on corporate income, resulting in an effective income split and reduced overall taxation.

Keep in mind that a corporation can pay wages to any number of persons for services rendered, so it can be quite practical to have your spouse or children on the payroll, as long as they do, indeed, provide some sort of valuable service. And before you dismiss the possibility of payments to your children, consider the potential value of intellectual property. Yes, a good idea for developing the business is compensatable as "intellectual property". No spouse and no children and still need some income splitting? Perhaps you could acquire or pay for the "intellectual property" of another private corporation?

Don't forget that a corporation may hold assets in the form of retained earnings. Without stating a specific plan of development, it is considered reasonable for any corporation to keep up to \$250,000 in retained earnings for future business development. Earnings may still be retained above this level without triggering the accumulated earnings surcharge prescribed by *Internal Revenue Code 531-537* provided there is a plan for expansion of the business (this could include, for instance, the acquisition of another business); for paying off debts; for product liability loss reserves; for supplying loans to either customers or suppliers to maintain the viability of the business; or for the need for increased working capital (say, to acquire additional inventory for the business).

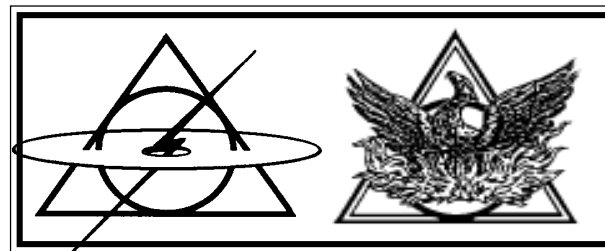
