

FINAL WARNING: A HISTORY OF THE NEW WORLD ORDER

INTRODUCTION

Since the Persian Gulf War, the term 'New World Order' has become well known. However, there has never really been an explanation as to what the term actually meant, only that it represented a new spirit of cooperation among the nations of the world, in order to further the cause of peace. And peace is good, so therefore the New World Order is good and should be accepted. Not so fast. Like the old saying, you can't tell a book by its cover, there is more here than meets the eye.

In regard to the term, William Safire wrote in the *New York Times* in February, 1991: "... it's Bush's baby, even if he shares its popularization with Gorbachev. Forget the Hitler 'new order' root; F.D.R. used the phrase earlier."

The term 'New World Order' was actually first used many years ago.

In an address delivered to the Union League of Philadelphia on November 27,

1915, Nicholas Murray Butler said: "The old world order changed when this war-storm broke. The old international order passed away as suddenly, as unexpectedly, and as completely as if it had been wiped out by a gigantic flood, by a great tempest, or by a volcanic eruption. The old world order died with the setting of that day's sun and a new world order is being born while I speak, with birth pangs so terrible that it seems almost incredible that life could come out of such fearful suffering and such overwhelming sorrow."

In a 1919 subscription letter for the magazine *International Conciliation*, M. C. Alexander, the Executive Secretary of the American Association for International Conciliation wrote: "The peace conference has assembled. It will make the most momentous decisions in history, and upon these decisions will rest the stability of the new world order and the future peace of the world."

In August, 1927, Dr. Augustus O. Thomas, President of the World Federation of Education Associations said:

"If there are those who think we are to jump immediately into a new world order, actuated by complete understanding and brotherly love, they are

doomed to disappointment. If we are ever to approach that time, it will be after patient and persistent effort of long duration. The present international situation of mistrust and fear can only be corrected by a formula of equal status, continuously applied, to every phase of international contacts, until the cobwebs of the old order are brushed out of the minds of the people of all lands.”

Adolf Hitler said: “National Socialism will use its own revolution for the establishing of a new world order.”

In the 1932 book *The New World Order*, author F. S. Marvin said that the League of Nations was the first attempt at a New World Order, and said that “nationality must rank below the claims of mankind as a whole”.

Edward VIII became King of England on January 20, 1936, but he was forced to abdicate the throne eleven months later, when he married a commoner. He became the Duke of Windsor, and in July, 1940, became the governor of the Bahamas. He is on record as saying: “Whatever happens, whatever the outcome, a new Order is going to come into the world ... It will be buttressed with police power ... When peace comes this time there is going to be a new Order of social justice. It cannot be another Versailles.”

In a *New York Times* article in October, 1940, called “New World Order Pledged to Jews”, comes the following excerpt: “In the first public declaration on the Jewish question since the outbreak of the war, Arthur Greenwood, member without portfolio in the British War Cabinet, assured the Jews of the United States that when victory was achieved an effort would be made to found a new world order based on the ideals of ‘justice and peace’.”

The “Declaration of the Federation of the World,” written by the Congress on World Federation, which was adopted by the Legislatures of some states, including North Carolina (1941), New Jersey (1942), and Pennsylvania (1943), said: “If totalitarianism wins this conflict, the world will be ruled by tyrants, and individuals will be slaves. If democracy wins, the nations of the earth will be united in a commonwealth of free peoples; and individuals, wherever found, will be the sovereign units of the new world order.”

From an article in a June, 1942 edition of the *Philadelphia Inquirer*: “Undersecretary of State Sumner Welles tonight called for the early creation of an international organization of anti-Axis nations to control the world during the period between the armistice at the end of the present war and the setting up of a new world order on a permanent basis.”

According to a February, 1962 *New York Times* article called “Rockefeller Bids Free Lands Unite: Calls at Harvard for Drive to Build New World Order”, New York Governor Nelson Rockefeller told an audience at Harvard University: “The United Nations has not been able–nor can it be able–to shape a new world order which events so compellingly demand ... (The new world order that will answer economic, military, and political problems) urgently requires, I believe, that the United States take the leadership among all the free peoples to make the underlying concepts and aspirations of national sovereignty truly meaningful through the federal approach.” The *Associated Press* reported that on July 26, 1968, Governor Rockefeller said in a speech to the International Platform Association at the Sheraton Park Hotel in New York, that “as President, he would work toward international creation of a New World Order.”

Richard Nixon wrote in the October, 1967 issue of the Council on Foreign Relations’ (CFR) journal *Foreign Affairs*: “The developing coherence of Asian regional thinking is reflected in a disposition to consider problems and loyalties in

regional terms, and to evolve regional approaches to development needs and to the evolution of a new world order.” In 1972, while in China, in a toast to Chinese Premier Chou En-lai, Nixon expressed “the hope that each of us has to build a new world order”.

Richard Gardner, former Deputy Assistant Secretary of State for International Organizations under Kennedy and Johnson, and a member of the Trilateral Commission, wrote in the April 1974 issue of *Foreign Affairs* (pg. 558): “In short, the ‘house of world order’ will have to be built from the bottom up rather than from the top down. It will look like a great ‘booming, buzzing confusion’, to use William James’ famous description of reality, but an end run around national sovereignty, eroding it piece by piece, will accomplish much more than the old fashioned frontal assault.”

Richard A. Falk, wrote in his article “Toward a New World Order: Modest Methods and Drastic Visions” (from the 1975 book *On the Creation of a Just World Order*): “The existing order is breaking down at a very rapid rate, and the main uncertainty is whether mankind can exert a positive role in shaping a new world order or is doomed to await collapse in a passive posture. We believe a new world order will be born no later than early in the next century and that the death throes of the old and the birth pangs of the new will be a testing time for the human species.” In 1975, 32 Senators and 92 Representatives in Congress signed “A Declaration of Interdependence” (written by the historian Henry Steele Commager) which said that “we must join with others to bring forth a new world order . . . Narrow notions of national sovereignty must not be permitted to curtail that obligation.” Congresswoman Marjorie Holt, who refused to sign it, said: “It calls for the surrender of our national sovereignty to international organizations. It declares that our economy should be regulated by international authorities. It proposes that we enter a ‘new world order’ that would redistribute the wealth created by the American people.”

In an October, 1975 speech to the General Assembly of the United Nations, Henry Kissinger said: “My country’s history, Mr. President, tells us that it is possible to fashion unity while cherishing diversity, that common action is possible despite the variety of races, interests, and beliefs we see here in this chamber. Progress and peace and justice are attainable. So we say to all peoples and governments: Let us fashion together a new world order.”

During the 1976 Presidential campaign, Jimmy Carter said: “We must replace balance of power politics with world order politics.” In a February 14, 1977 speech, Carter said: “I want to assure you that the relations of the United States with the other countries and peoples of the world will be guided during my own Administration by our desire to shape a world order that is more responsive to human aspirations. The United States will meet its obligation to help create a stable, just, and peaceful world order.”

Harvard professor Stanley Hoffman wrote in his book *Primacy or World Order*: “What will have to take place is a gradual adaptation of the social, economic and political system of the United States to the imperatives of world order.”

Conservative author George Weigel, director of the Ethics and Public Policy Center in Washington, D.C. said: “If the United States does not unashamedly lay down the rules of world order and enforce them ... then there is little reason to think that peace, security, freedom or prosperity will be served.”

In a December 1988 speech, Mikhail Gorbachev told the United Nations: “Further global progress is now possible only through a quest for universal consensus in the movement towards a new world order.”

The man who put the New World Order in the

limelight, and did more than anyone to bring about its acceptance, was President George Bush. In a February 1990 fundraiser in San Francisco, Bush said: “Time and again in this century, the political map of the world was transformed. And in each instance, a New World Order came about through the advent of a new tyrant or the outbreak of a bloody global war, or its end.”

On Saturday, August 25, 1990, the United Nations Security Council voted unanimously to allow a joint military force to use whatever means necessary to enforce a UN blockade against the country of Iraq. That afternoon, Lt. Gen. Brent Scowcroft, a CFR member and former aide to Henry Kissinger, who was the National Security Advisor to Bush, was interviewed by Charles Bierbauer of the *Cable News Network (CNN)* and used the term “a New World Order”. In August 1990, (According to an article in the *Washington Post* in May 1991) he said: “We believe we are creating the beginning of a New World Order coming out of the collapse of the U.S.-Soviet antagonisms.” During a September 1990 speech at the United Nations, he announced that “we are moving to a New World Order.” Later, on the eve of the Gulf War, Scowcroft said: “A colossal event is upon us, the birth of a New World Order.” In the fall of 1990, on the way to Brussels, Belgium, Secretary of State James Baker said: “If we really believe that there’s an opportunity here for a New World Order, and many of us believe that, we can’t start out by appeasing aggression.”

In September 1990, the *Wall Street Journal* quoted Rep. Richard Gephardt as saying: “We can see beyond the present shadows of war in the Middle East to a New World Order where the strong work together to deter and stop aggression. This was precisely Franklin Roosevelt’s and Winston Churchill’s vision for peace for the post-war period.”

In a September 11, 1990 televised address to a joint session of Congress, Bush said:

“A new partnership of nations has begun. We stand today at a unique and extraordinary moment. The crisis in the Persian Gulf, as grave as it is, offers a rare opportunity to move toward an historic period of cooperation. Out of these troubled times, our fifth objective—a New World Order—can emerge ... When we are successful, and we will be, we have a real chance at this New World Order, an order in which a credible United Nations can use its peacekeeping role to fulfill the promise and vision of the United Nations’ founders.”

The September 17, 1990 issue of *Time* magazine said that “the Bush administration would like to make the United Nations a cornerstone of its plans to construct a New World Order”.

In a September 25, 1990 address to the UN, Soviet Foreign Minister Eduard Shevardnadze described Iraq’s invasion of Kuwait as “an act of terrorism (that) has been perpetrated against the emerging New World Order”.

In an October 1, 1990, UN address, President Bush talked about the “ . . . collective strength of the world community expressed by the UN . . . an historic movement towards a New World Order . . . a new partnership of nations . . . a time when humankind came into its own . . . to bring about a revolution of the spirit and the mind and begin a journey into a . . . new age”. On October 30, 1990, Bush suggested that the UN could help create “a New World Order and a long era of peace”.

Jeanne Kirkpatrick, former U.S. Ambassador to the UN, said that one of the purposes for the Desert Storm operation, was to show to the world how a “reinvigorated United Nations could serve

as a global policeman in the New World Order”. On December 31, 1990, Gorbachev said that the New World Order would be ushered in by the Gulf War.

Prior to the Gulf War, on January 29, 1991, Bush told the nation in his State of the Union address: “What is at stake is more than one small country, it is a big idea—a New World Order, where diverse nations are drawn together in a common cause to achieve the universal aspirations of mankind; peace and security, freedom, and the rule of law. Such is a world worthy of our struggle, and worthy of our children’s future.” He also said: “If we do not follow the dictates of our inner moral compass and stand up for human life, then his lawlessness will threaten the peace and democracy of the emerging New World Order we now see, this long dreamed—of vision we’ve all worked toward for so long.”

In a speech to the families of servicemen at Fort Gordon, Georgia on February 1, 1991, Bush said: “When we win, and we will, we will have taught a dangerous dictator, and any tyrant tempted to follow in his footsteps, that the United States has a new credibility and that what we say goes, and that there is no place for lawless aggression in the Persian Gulf and in this New World Order that we seek to create.” Following a February 6, 1991 speech to the Economic Club of New York City, Bush answered a reporter’s question about what the New World Order was, by saying: “Now, my vision of a New World Order foresees a United Nations with a revitalized peace-keeping function.”

Bush said in a speech to the Congress on March 6, 1991: “Now, we can see a new world coming into view. A world in which there is a very real prospect of a New World Order. In the words of Winston Churchill, a ‘world order’ in which the ‘principles of justice and fair play ... protect the weak against the strong’. A world where the United Nations, freed from cold war stalemate, is poised to fulfill the historic vision of its founders. A world in which freedom and respect for human rights find a home among all nations.”

On August 21, 1991, after the failed coup in the Soviet Union, *CNN* reporter Mary Tillotson said that the President’s “New World Order is back on track, now stronger than ever”. In an interview with *CNN* at the height of the Gulf War, Scowcroft said that he had doubts about the significance of Mid-East objectives regarding global policy. When asked if that meant he didn’t believe in the New World Order, he replied: “Oh, I believe in it. But our definition, not theirs. ” On January 25, 1993, Clinton’s Secretary of State, Warren Christopher, said in a *CNN* interview: “We must get the New World Order on track and bring the UN into its correct role in regards to the United States.”

In April 1992, Sen. Joseph R. Biden Jr. wrote the article “How I Learned to Love the New World Order” for *The Wall Street Journal*.

While campaigning for the passage of NAFTA, Kissinger said: “NAFTA is a major stepping stone to the New World Order.” In a July 18, 1993 *Los Angeles Times* article about NAFTA, Kissinger is quoted as saying: “What Congress will have before it is not a conventional trade agreement but the architecture of a new international system . . . a first step toward a New World Order.”

On May 4, 1994, Leslie Gelb, CFR President, said on “The Charlie Rose Show”: “ . . . you (Charlie Rose) had me on (before) to talk about the New World Order. I talk about it all the time. It’s one world now. The Council (CFR) can find, nurture, and begin to put people in the kinds of jobs this country needs. And that’s going to be one of the major enterprises of the Council under me.”

On September 14, 1994, while speaking at the Business Council for the United Nations, David

Rockefeller said: “But this present window of opportunity, during which a truly peaceful and interdependent world order might be built, will not be open for long. Already there are powerful forces at work that threaten to destroy all of our hopes and efforts to erect an enduring structure of global interdependence.” He said at another time: “We are on the verge of a global transformation. All we need is the right major crisis and the nations will accept the New World Order.”

In the July/August 1995 issue of *Foreign Affairs*, Arthur Schlesinger, Jr. wrote: “We are not going to achieve a New World Order without paying for it in blood as well as in words and money.”

Former West German Chancellor Willy Brandt said: “The New World Order is a world that has supernational authority to regulate the world commerce and industry; an international organization that would control the production and consumption of oil; an international currency that would replace the dollar; a World Development Fund that would make funds available to free and Communist nations alike; and an international police force to enforce the edicts of the New World Order.”

Somehow, the implications from these quotes, lends a sinister overtone to this New World Order. After 25 years of research, it is clear to me that this country has been infiltrated by conspirators, members of an organization who are dedicated to establishing a one-world socialist government—with them in control. It sounds unbelievable, like something out of a James Bond movie, yet, it is a fact. A fact that the media has refused to publicize, even attempting to cover it up, and deny its very existence.

In the 1844 political novel *Coningsby* by Benjamin Disraeli, the British Prime Minister, a character known as Sidonia (which was based on Lord Rothschild, whose family he had become close friends with in the early 1840s) says: “That mighty revolution which is at this moment preparing in Germany and which will be in fact a greater and a second Reformation, and of which so little is as yet known in England, is entirely developing under the auspices of the Jews, who almost monopolize the professorial chairs of Germany ... the world is governed by very different personages from what is imagined by those who are not behind the scenes.” On September 10, 1876, in Aylesbury, Disraeli said: “The governments of the present day have to deal not merely with other governments, with emperors, kings and ministers, but also with secret societies which have everywhere their unscrupulous agents, and can at the last moment upset all the governments’ plans.”

On October 1, 1877, Henry Edward Manning, Cardinal Archbishop of Westminster, said of the trouble in the Balkan States: “It is not emperors or kings, nor princes, that direct the course of affairs in the East. There is something else over them and behind them; and that thing is more powerful than them.”

In 1902, Pope Leo XIII wrote of this power: “It bends governments to its will sometimes by promises, sometimes by threats. It has found its way into every class of Society, and forms an invisible and irresponsible power, an independent government, as it were, within the body corporate of the lawful state.” Walter Rathenau, head of German General Electric, said in 1909: “Three hundred men, all of whom know one another, direct the economic destiny of Europe and choose their successors from among themselves.”

President Woodrow Wilson said in 1913: “Since I entered politics, I have chiefly had men’s views confided to me privately. Some of the biggest men in the United States, in the field of commerce and manufacture, are afraid of something. They know that there is a power somewhere so organized, so subtle, so

watchful, so interlocked, so complete, so pervasive that they better not speak above their breath when they speak in condemnation of it.”

John F. Hylan, mayor of New York City (1918-25), said in a March 26, 1922 speech: “ . . . the real menace of our Republic is this invisible government which like a giant octopus sprawls its slimy length over city, state and nation. Like the octopus of real life, it operates under cover of a self-created screen . . . At the head of this octopus are the Rockefeller Standard Oil interests and a small group of powerful banking houses generally referred to as ‘the international bankers’. The little coterie of powerful international bankers virtually run the United States Government for their own selfish purposes. They practically control both political parties.”

In the December 1922 edition of *Foreign Affairs*, Philip Kerr wrote: “Obviously there is going to be no peace or prosperity for mankind as long as (the earth) remains divided into 50 or 60 independent states until some kind of international system is created ... The real problem today is that of the world government.”

In a letter dated November 21, 1933, Franklin D. Roosevelt wrote to confidant Colonel Edward House: “The real truth of the matter is, as you and I know, that a financial element in the large centers has owned the government ever since the days of Andrew Jackson.”

In her novel, *Captains and the Kings*, Taylor Caldwell wrote of the “plot against the people”, and says that it wasn’t “until the era of the League of Just Men and Karl Marx that conspirators and conspiracies became one, with one aim, one objective, and one determination”. Some heads of foreign governments refer to this group as “The Magicians”, Stalin called them “The Dark Forces”, and President Eisenhower described them as “the military-industrial complex”. In the July 26, 1936 issue of the *New York Times*, Joseph Kennedy, patriarch of the Kennedy family, was quoted as saying: “Fifty men have run America and that’s a high figure.” In 1952, U.S. Supreme Court Justice Felix Frankfurter, said: “The real rulers in Washington are invisible, and exercise power from behind the scenes.”

According to the California State Investigating Committee on Education (1953): “So-called modern Communism is apparently the same hypocritical and deadly world conspiracy to destroy civilization that was founded by the secret order of The Illuminati in Bavaria on May 1, 1776, and that raised its whorey head in our colonies here at the critical period before the adoption of our Federal Constitution.” [The] purpose of this book is to show the connection between the Illuminati, and what would become known as the New World Order. Through the years, the term ‘Illuminati’ has developed an anti-Semitic connotation, because some researchers have insisted that the move toward a one world government has been engineered as part of a Jewish conspiracy. This is not true. One of the documents that provided evidence concerning this has been proven to be a complete fabrication. Although some of the International Bankers which actually control this group are Jewish, there is no basis for indicting the entire Jewish race. In 1966, Dr. Carroll Quigley, a professor of history at the Foreign Service School of Georgetown University, published a 1311-page book called *Tragedy and Hope: A History of the World in Our Time*. On page 950 he says: “There does exist, and has existed for a generation, an international Anglophile network which operates, to some extent, in the way the radical Right believes the Communists act. In fact, this network, which we may identify as the Round Table Groups, has no aversion to cooperating with the Communists, or any other groups, and frequently does

so. I know of the operations of this network because I have studied it for twenty years and was permitted for two years, in the early 1960s, to examine its papers and secret records. I have no aversion to it or to most of its aims and have, for much of my life, been close to it and to many of its instruments ... my chief difference of opinion is that it wishes to remain unknown, and I believe its role in history is significant enough to be known . . . because the American branch of this organization (sometimes called the ‘Eastern Establishment’) has played a very significant role in the history of the United States in the last generation.” On page 324, he elaborates even further by saying: “In addition to these pragmatic goals, the powers of financial capitalism had another far-reaching aim, nothing less than to create a world system of financial control in private hands able to dominate the political system of each country and the economy of the world as a whole. This system was to be controlled in a feudalist fashion by the central banks of the world acting in concert, by secret agreements, arrived at in frequent private meetings and conferences. The apex of the system was the Bank for International Settlements in Basle, Switzerland, a private bank owned and controlled by the world’s central banks which were themselves private corporations. The growth of financial capitalism made possible a centralization of world economic control and use of this power for the direct benefit of financiers and indirect injury of all other economic groups.” Bill Clinton, during his acceptance speech at the Democratic Convention, said: “As a teenager, I heard John Kennedy’s summons to citizenship. And then, as a student at Georgetown (University where he attended 1964-68) I heard that call clarified by a professor I had named Carroll Quigley.” This is where Clinton received his indoctrination as an internationalist favoring one-world government.

In the mid-1970s, Dr. Tom Berry, who was pastor of the Baptist Bible Church in Elkton, Maryland, said: “At most, there are only 5,000 people in the whole world who have a significant understanding of the plan.” Professor Arnold Toynbee (a founding member of the Round Table) said in a June, 1931 speech to the Institute of International Affairs in Copenhagen: “We are at present working discreetly with all our might to wrest this mysterious force called sovereignty out of the clutches of the local nation states of the world.” H. G. Wells, a member of the Fabian Society, wrote in his 1933 book *The Shape of Things To Come*: “Although world government has been plainly coming for some years, although it had been endlessly feared and murmured against, it found no opposition prepared anywhere.”

Major General John Frederick Charles Fuller, a British military historian, said in 1941: “The government of the Western nations, whether monarchical or republican, had passed into the invisible hands of a plutocracy, international in power and grasp. It was, I venture to suggest, this semi-occult power which . . . pushed the masses of the American people into the cauldron of World War I.”

On June 28, 1945, President Harry Truman said in a speech: “It will be just as easy for nations to get along in a republic of the world as it is for us to get along in a republic of the United States.” On October 24, 1945, Senator Glen Taylor (D-Idaho) introduced Senate Resolution No. 183, which called for the Senate to go on record as advocating the establishment of a world republic, including an international police force.

In 1947, the American Education Fellowship (formerly known as the Progressive Education Association) called for the “establishment of a genuine world order, an order in which national sovereignty is

subordinate to world authority . . . ”.

Brock Chisholm, the first director of the UN World Health Organization said: “To achieve one world government it is necessary to remove from the minds of men their individualism, their loyalty to family traditions and national identification.” On February 9, 1950, a Senate Foreign Relations subcommittee introduced Concurrent Resolution 66 which began: “Whereas, in order to achieve universal peace and justice, the present Charter of the United Nations should be changed to provide a true world government constitution.”

James Warburg, a member of the Council on Foreign Relations, told the Senate Foreign Relations Committee on February 17, 1950: “We shall have world government whether or not you like it, by conquest or consent.”

Sen. William Jenner said in a February 23, 1954 speech: “Today the path to total dictatorship in the United States can be laid by strictly legal means, unseen and unheard by the Congress, the President, or the people . . . Outwardly we have a constitutional government. We have operating within our government and political system, another body representing another form of government, a bureaucratic elite which believes our Constitution is outmoded and is sure that it is the winning side . . . All the strange developments in foreign policy agreements may be traced to this group who are going to make us over to suit their pleasure . . . This political action group has its own local political support organizations, its own pressure groups, its own vested interests, its foothold within our government.”

In September 1960, Elmo Roper, in an address called “The Goal is Government of All the World” said: “For it becomes clear that the first step toward world government cannot be completed until we have advanced on the four fronts: the economic, the military, the political and the social.”

In a 1963 symposium (sponsored by the leftist Fund for the Republic, of the Ford Foundation) called “The Elite and the Electorate: Is Government by the People Possible?” Senator J. William Fulbright, the Chairman of the Senate Foreign Relations Committee said: “The case for government by elites is irrefutable . . . government by the people is possible but highly improbable”

Sen. Russell Long of Louisiana, who for 18 years was the Chairman of the Senate Finance Committee, said that our “government is completely and totally out of control. We do not know how much long term debt we have put on the American people. We don’t even know our financial condition from year to year . . .” He also said: “We have created a bureaucracy in Washington so gigantic that it is running this government for the bureaucracy, the way they want, and not for the people of the United States. We no longer have representative government in America.”

Congressman Larry P. McDonald, who, in 1983 was killed in the Korean Airlines flight 007 that had been shot down by the Soviets said: “The drive of the Rockefellers and their allies is to create a one world government combining supercapitalism and Communism under the same tent, all under their control . . . Do I mean conspiracy? Yes I do. I am convinced there is such a plot, international in scope, generations old in planning, and incredibly evil in intent.”

Zbigniew Brzezinski, who was President Carter’s National Security Advisor, said: “ . . . this regionalization is in keeping with the tri-lateral plan which calls for a gradual convergence of East and West, ultimately leading toward the goal of ‘one world government’

...National sovereignty is no longer a viable concept . . . ”

Norman Cousins, the honorary Chairman of Planetary Citizens for the World We Chose (as well as the President of the World Federalist Association) is quoted in the magazine *Human Events* as saying: “World government is coming, in fact, it is inevitable. No arguments for or against it can change that fact.”

During the 1991 Bilderberger Conference held in Evians, France, Dr. Henry Kissinger said: “Today, America would be outraged if UN troops entered Los Angeles to restore order (referring to the riot caused by the Rodney King incident). Tomorrow they will be grateful! This is especially true if they were told that there were an outside threat from beyond, whether real or promulgated, that threatened our very existence. It is then that all peoples of the world will plead to deliver them from this evil. The one thing every man fears is the unknown. When presented with this scenario, individual rights will be willingly relinquished for the guarantee of their well-being granted to them by the World Government.”

On October 29, 1991, David Funderburk, a former U.S. Ambassador to Romania (1981-85), told a group in North Carolina: “George Bush has been surrounding himself with people who believe in one-world government. They believe that the Soviet system and the American system are converging,” and the manner in which they would accomplish that was through the United Nations, “the majority of whose 166 member states are socialist, atheist, and anti-American”.

Time magazine on July 20, 1992, in an article called “The Birth of the Global Nation”, Strobe Talbott, an Editor (later Clinton’s Deputy Secretary of State) wrote: “In the next century, nations as we know it will be obsolete; all states will recognize a single, global authority. National sovereignty wasn’t such a good idea after all ... By October 2nd, 1944, the ICRC warned the German Foreign Office of the impending collapse of the German transportation system, declaring that starvation conditions for people throughout Germany were becoming inevitable.

Booted unceremoniously off one popular website for a story I consider spurious—an event preceded by Jon Carlson’s laughable hit piece about me on Rense.com (which Rense himself insisted he hadn’t read) alleging I was Naval intelligence. And then generally excluded from websites that had previously embraced me, all because I used the word Jew. And challenged the orthodox version of the so-called Holocaust. And 9/11. And the Iraq war. And America’s motivation in general. And most especially, the obvious influences exerted in all walks of life by the Jewish community, which camouflages its efforts behind the labels Zionist and Israeli in a mostly successful attempt to evade criminal charges for its horrid manipulations in the general categories of money and media.

Are there any Americans remaining who think the good ole USA is actually following a noble path? If so, what kind of poison is in your water that has totally addled your mind? And why can’t you see the effect Jewish influence has had on us all? Don’t you hear the Iraqis and Palestinians screaming as they starve? All these Jewish writers—Chomsky, Blum, William Rivers Pitt, and that ilk—always pinpoint the American disease without properly identifying its underlying Jewish influence. Because that is their purpose. To conceal the name of the true perpetrators in an intellectual blizzard of superficial detail.

I have chosen the path I thought was best, and most of you have turned your backs on me. Readers should know that. And editors can gauge their shuddering integrity by it, as well.

NWO ‘Red Symphony’

“RED SYMPHONY”

Incredible and bizarre as it sounds, humanity is indeed the victim of a diabolical conspiracy. War, depression and genocide in the past century were not accidental or inevitable but the result of malevolent design. Shocking evidence is a 1938 Stalinist police (NKVD) interrogation of a founder of the Communist International, Christian G. Rakovsky, 65, who was facing execution for plotting to overthrow Stalin. The 50-page transcript of his interrogation, dubbed “The Red Symphony”, was not meant to become public. It confirms that the Rothschild-Illuminati planned to use Communism to establish a world dictatorship of the super rich. This is perhaps the most explosive political document in modern history. It reveals why the Illuminati created Hitler and then sought to destroy him, and why Stalin made a pact with Hitler in 1939. Christian Rakovsky was a veteran Communist insider. Born Chaim Rakeover in 1873, he studied medicine in France before becoming a revolutionary. He was the leader of a terror group that attacked government officials. In 1919, Lenin put him in charge of the Soviet Ukraine government. He successfully kept the area for the Bolsheviks during the Civil War. Stalin appointed him Russian ambassador to Paris in 1925. Rakovsky belonged to the powerful Trotskyite faction that took their orders from the Rothschilds. Many of this group were shot in Stalin’s 1937 Communist Party purge.

MIDNIGHT INTERROGATION

The circumstances of the midnight interrogation Jan. 26, 1938 were very dramatic. What could Rakovsky possibly say to save his life? Rakovsky appears to use the tactic of “deceiving with the truth”. He wins trust by revealing the truth but leaves some of it out. He tries to impress his interrogator that he and Trotsky represent an invincible power he calls the “Capitalist-Communist Financial International”. He confirms that the “revolutionary movement” was designed to enlist support by pretending to serve mankind’s moral and collective ideals. The real aim however is to give total world power to the bankers by dividing society and undermining established authority. “Revolution” really means, “overturning” Western civilization. “Christianity is our only real enemy since all the political and economic phenomena of the bourgeois states are only its consequences,” Rakovsky, says. (Griffin, p. 264) Peace is “counter-revolutionary” since it is war that

paves the way for revolution. Rakovsky, whose tongue was loosened by a mild inebriant in his wine, refers to the Illuminati as “they” or “them”. He is a member although not part of the inner circle. He explains that the “Illuminati” is a Masonic secret society dedicated to Communism. Significantly, its founder Adam Weishaupt took the name from “the second anti-Christian conspiracy of that era, gnosticism”. (*ibid* p. 249)

HOW THIS GRIPPING ACCOUNT SURFACED

The interrogator was one of Stalin’s cleverest agents, Gavriil Kus’min known as “Gabriel”. Apart from him and a hidden sound technician, a doctor Jose Landowsky was the only other person present. Conscripted by the NKVD to help “loosen the tongues of detainees”, Dr. Landowsky was sickened by the many tortures he witnessed. The interrogation of Rakovsky, however, was cordial. Dr. Landowsky doubts if the mild euphoric he put in Rakovsky’s drink had much effect. The interrogation, conducted in French lasted from midnight until 7 a.m. After, Kus’min ordered Landowsky to translate the interview into Russian and make two copies. The content was so mind boggling that Landowsky made an additional carbon for himself. “I am not sorry that I had the courage for this,” he wrote. (*ibid* p. 279) (The Bolsheviks had shot Landowsky’s father, a Tsarist colonel, during the 1917 revolution). A Spanish Fascist volunteer later found the manuscript on Landowsky’s dead body in a hut on the Petrograd front during World War Two. He took it back to Spain where it was published as *Sinfonia en Rojo Mayo* in 1949.

The complete text of *The Red Symphony* was put online by Peter Myers. The transcript was published in English in 1968 as *The Red Symphony: X-Ray of Revolution*. You can find it in Des Griffin’s *Fourth Reich of the Rich* (1988). I recommend this book and everything this fine man has written.

REVELATIONS

Rakovsky gives his interrogator an astonishing inside view of modern history in order to prove that his sponsors control the world. “Money is the basis of power,” Rakovsky says, and the Rothschilds manufacture it thanks to the banking system. The “Revolutionary Movement” was an attempt by Meyer Rothschild and his allies to protect and extend this monopoly by establishing a totalitarian New World Order. According to Rakovsky, “The Rothschilds were not the treasurers, but the chiefs of that first secret Communism . . . Marx and the highest chiefs of the First International . . . were controlled by Baron Lionel Rothschild, [HM: 1808-1878] whose revolutionary portrait was done by Disraeli the English Premier, who was also his creature, and has been left to us [HM: in Disraeli’s novel *Coningsby*]”. (*ibid* p. 250) Lionel’s son Nathaniel (1840-1915) needed to overthrow the Christian Romanoff Dynasty. Through his agents Jacob Schiff and the Warburg brothers, he financed the Japanese side in the Russo Japanese War, and an unsuccessful insurrection in Moscow in 1905.

Then he instigated the First World War (Trotsky was behind the murder of Archduke Ferdinand); and financed the 1917 Bolshevik Revolution. Rakovsky says he was personally involved in the transfer of funds in Stockholm. (*ibid* p.251-252) The Jewish labour movement or “bund” was Rothschild’s instrument. The Bund’s “secret faction” infiltrated all the socialist parties in Russia and provided the leadership for the Russian Revolution. Alexander Kerensky, the Menshevik Prime Minister was a secret member. (*ibid* p. 253) Leon Trotsky was supposed to become the leader of the USSR. Trotsky, a Jew, married the daughter of one of Rothschild’s closest associates, banker Abram Zhivotovsky and became part of the “clan”. Unfortunately “national” Communists like Lenin (one-quarter Jewish) got in the way. Lenin overruled Trotsky and made peace with Germany (*Treaty of Brest Litovsk*, 1918). This was not the Rothschild’s plan. World War One was supposed to end the way the Second World War did. Russia was supposed to overrun Germany in 1918 and assist local “revolutionaries” in establishing a “peoples’ republic”. Trotsky was responsible for an attempt to assassinate Lenin in 1918 but Lenin survived. When Lenin had a stroke in 1922, Trotsky had Levin, Lenin’s Jewish doctor, finish him off. At this critical moment, the unexpected happened. Trotsky got sick and Stalin was able to take power. At this crucial juncture, the Trotskyites pretended to support Stalin and infiltrated his regime in order to sabotage it. Rakowsky characterizes Stalin as a “Bonapartist”, a nationalist as opposed to an International Communist like Trotsky. “He is a killer of the revolution, he does not serve it, but makes use of its service; he represents the most ancient Russian imperialism, just as Napoleon identified himself with the Gauls . . . ”. (*ibid* p. 257)

CONTAINING STALIN

In order to control Stalin, international finance was forced to build up Hitler and the Nazi party. Rakowsky confirms that Jewish financiers backed the Nazis although Hitler was not aware of this. “The ambassador Warburg presented himself under a false name and Hitler did not even guess his race... he also lied regarding whose representative he was... Our aim was to provoke a war and Hitler was war . . . [HM: the Nazis] received...millions of dollars sent to it from Wall Street, and millions of marks from German financiers through Schacht; [HM: providing] the upkeep of the S.A and the S.S. and also the financing of the elections . . . ” (*ibid* p. 259-260) Unfortunately for the bankers, Hitler also proved intractable. He started to print his own money! “He took over for himself the privilege of manufacturing money and not only physical moneys, but also financial ones; he took over the untouched machinery of falsification and put it to work for the benefit of the state... Are you capable of imagining what would have come ...if it had infected a number of other states and brought about the creation of a period of autarchy [HM: absolute rule, replacing that of the bankers]. If you can, then imagine its counterrevolutionary functions . . . ” (*ibid* p. 263) Hitler had become a bigger threat than Stalin, who had not meddled with money. Rakovsky’s present mission was to convince Stalin to make a pact with Hitler and turn Hitler’s aggression against the West. The purpose was for Germany and the Western nations to exhaust each other before another front was opened in the East. [HM: According to Walter Kravitsky, the head of Soviet Military Intelligence in Europe who defected to the

West and was later assassinated in 1941, Stalin was determined to make a pact with Hitler as early as 1934. He had no desire to fight the Nazis. Is it possible Rakovsky and his sponsors did not know this? (*Kravitsky On Stalin’s Secret Service*, 1939)

Rakovsky urged the Russians to use the tactic of “deceiving with the truth”. The Russians were to impress Hitler with their genuine desire for peace. Hitler was not to suspect that he was being set up for a war on two fronts.

Stalin was given a choice. If he agreed to divide Poland with Hitler, the West would declare war on only one aggressor, Germany. If he refused, the bankers would help Hitler to depose him.

Kus’min demanded some high level confirmation. Rakovsky told him to see Joseph Davies, the U.S. ambassador in Moscow, a fellow Freemason and representative of the International Communist Roosevelt administration.

Someone was sent to Davies who confirmed that “much would be gained” if Rakovsky got an amnesty. On March 2, 1938 a powerful radio message was sent to Moscow in the cipher of its London embassy.

“Amnesty or the Nazi danger will increase,” it said. Davies attended Rakovsky’s trial and gave him a Masonic greeting. On the same day, March 12 1938, Hitler marched into Austria.

Rakovsky’s death sentence was commuted. Some believe he lived out his years under an assumed name. Another source has him shot in 1941.

Secret negotiations were begun with Hitler. The result was the Ribbentrop-Molotov pact signed in August 1939 just one week before the invasion of Poland.

The interrogation seems to have created an accord between Stalin and the Illuminati.

RUSSIA STRUGGLES IN ROTHSCILD CLUTCH

Europe and the United States long ago succumbed to Rothschild Illuminati control. In Russia, there are still some death spasms.

Recently, Vladimir Putin arrested Mikhail Khordordovsky, the head of Russia’s largest oil company “Yukos” and “the richest man in Russia”.

Putin announced that Russia would seize his \$12 billion 26% stake in the oil company, one of many national assets plundered in the reorganization of Communism 15 years ago.

Then we learn the shares already had passed to none other than banker Jacob Rothschild under a “previously unknown arrangement” designed for such a circumstance. The two have known each other for years “through their mutual love of the arts”.

Rakovsky told Kus’min that the Illuminati never take political or financial positions. They use “intermediaries”.

“Bankers and politicians are only men of straw . . . even though they occupy high places and appear to be authors of the plans which are carried out . . .” (*ibid* pp. 248-249)

Obviously Khodordovsky is an “intermediary” for Rothschild. So are Richard Perle, Henry Kissinger and Ariel Sharon who each spoke out against Putin’s action. Perle, the architect of the Iraq war, called for the expulsion of Russia from the Group of Eight. Sharon expressed concern about “persecution of Jewish businessmen”. Khodordovsky is Jewish as is Simon Kukes his successor. And Perle and Kissinger.

Many Jews serve the Illuminati and that is a cause of anti Semitism. But Tony Blair and George W. Bush serve it too and are not Jewish. The membership of the Bilderbergers and the Skull and Bones is mostly not Jewish. The Illuminati is an alliance between the Rothschilds, and the world’s super rich united by **Freemasonry, whose God is Lucifer.**

Mankind, God’s magnificent experiment, has been

subverted and compromised. From the U.S. soldier in Iraq, to the taxpayer who pays the national debt, we are all “men of straw”.

THE RED SYMPHONY, PART 2:
TERMINATED!
FREEMASONRY’S FINAL REVELATION

Freemasons “have to die at the hands of the revolution which has been brought about with their cooperation”, according to C.G. Rakovsky, a founder of the Communist International.

“The real secret of masonry is the suicide of Freemasonry as an organization, and the physical suicide of every important mason.”

“Gentile masonry blindly serves as a screen for us and our objects, but the plan of action of our force, even its very abiding place, remains for the whole people an unknown...”

This disclosure is from a 1938 Stalinist police interrogation entitled *The Red Symphony* (Transcript in *Des Griffin, Fourth Reich of the Rich*, p. 254).

“It is clear that I know of this not as a Freemason, but as one who belongs to ‘Them’,” [HM: the Illuminati] says Rakovsky, a colleague of Leon Trotsky arrested for plotting against Stalin.

Rakovsky’s aim is to convince Stalin, a nationalist, to cooperate with the “the Communist-Capitalist International”. I introduced this document last week in my *Rothschilds Conduct ‘Red Symphony’* where the Internet location of this document is given.

‘PROTOCOLS OF ZION’
AND ‘RED SYMPHONY’

Freemasonry is the world’s largest secret society with over five million members, including three million in the U.S. It is instrumental in the totalitarian conspiracy. In *The Protocols of the Elders of Zion*, the author (whom I believe is Lionel Rothschild) writes,

“Gentile masonry blindly serves as a screen for us and our objects, but the plan of action of our force, even its very abiding place, remains for the whole people an unknown mystery . . . Who and what is in a position to overthrow an invisible force?” (Protocol 4)

Again he writes, “we shall create and multiply free Masonic lodges . . . absorb into them all who may become or who are prominent in public activity, for in these lodges we shall find our principle intelligence office and means of influence.... The most secret political plots will be known to us and will fall under our guiding hands . . . We know the final goal...whereas the goyim have knowledge of nothing . . .” (Protocol 15)

In his interrogation, Rakovsky says that millions flock to Freemasonry to gain an advantage. “The rulers of all the Allied nations were Freemasons, with very few exceptions.”

However, the real aim is “create all the required prerequisites for the triumph of the Communist revolution; this is the obvious aim of Freemasonry; it is clear that all this is done under various pretexts; but they always conceal themselves behind their well known treble slogan [HM: Liberty, Equality, Fraternity]. You understand?” (*Des Griffin Fourth Reich of the Rich* p. 254)

Masons should recall the lesson of the French Revolution. Although “they played a colossal revolutionary role; it consumed the majority of masons .

. . .”. Since the revolution requires the extermination of the bourgeoisie as a class, [HM: so all wealth will be held by the Illuminati in the guise of the State] it follows that Freemasons must be liquidated. The true meaning of Communism is Illuminati tyranny.

When this secret is revealed, Rakovsky imagines “the expression of stupidity on the face of some Freemason when he realises that he must die at the hands of the revolutionaries. How he screams and wants that one should value his services to the revolution! It is a sight at which one can die . . . but of laughter!” (*ibid* p. 254)

Rakovsky refers to Freemasonry as a hoax: “a madhouse but at liberty”. (*ibid* p. 254)

Like masons, other applicants for the humanist utopia master class (neo cons, liberals, Zionists, gay and feminist activists) might be in for a nasty surprise. They might be tossed aside once they have served their purpose.

WHO ARE “THEY”?

When the interrogator presses Rakovsky for Illuminati notables to approach with an initiative, Rakovsky is sure of only two who are now deceased: Walter Rathenau, the Weimar foreign minister, and Lionel Rothschild. He says Trotsky is his source of information.

Others he insists are speculation: “As an institution, the bank of Kuhn Loeb & Company of Wall Street: [and] the families of Schiff, Warburg, Loeb and Kuhn; I say families in order to point out several names since they are all connected . . . by marriages; then Baruch, Frankfurter, Altschul, Cohen, Benjamin, Strauss, Steinhardt, Blom, Rosenman, Lippmann, Lehman, Dreifus, Lamont, Rothschild, Lord, Mandel, Morgenthau, Ezekiel, Lasky....any one of the names I have enumerated, even of those not belonging to ‘Them’ could always lead to ‘Them’ with any proposition of an important type.” (*ibid* p. 272)

By allowing bankers the privilege of creating money, we have created an insatiable vampire. If you could manufacture money, imagine the temptation to own everything!

COVERT REVOLUTION

Rakovsky refers to the 1929 Crash and Great Depression as an “American revolution”. It was deliberately precipitated by the Illuminati for profit, to break the “classical American”. and to take political power.

“The man through whom they made use of such power was Franklin Roosevelt. Have you understood? ...In that year 1929, the first year of the American Revolution, in February Trotsky leaves Russia; the crash takes place in October...The financing of Hitler is agreed in July, 1929. You think that all this was by chance? The four years of the rule of Hoover were used for the preparation for the seizure of power in the United States and the USSR: there by means of a financial revolution, and here [HM: Russia] with the help of war [HM: Hitler, World War Two] and the defeat which was to follow. Could some novel with great imagination be more obvious to you?” (*ibid* p. 273)

Rakovsky proposes that Stalin cooperate with the Illuminati, (which he subsequently did). The first condition is that he stops executing Trotskyites. Then “several zones of influence” will be established dividing “the formal Communism from the real one”. There will be “mutual concessions for mutual help for a time while the plan lasts...There will appear influential persons at all levels of society, even very high ones, who will help the Stalinist formal Communism. . . .” (*ibid* p. 276)

Rakovsky outlines the Illuminati plan to blend Communism and Capitalism. In each case, the Illuminati will control all wealth and power.

“In Moscow there is Communism: in New York capitalism. It is all the same as thesis and antithesis. Analyse both. Moscow is subjective Communism but [HM: objectively] State capitalism. New York: Capitalism

subjective, but Communism objective. A personal synthesis, truth: the Financial International, the Capitalist Communist one. ‘They’.” (ibid p. 276)

CONCLUSION

The *Red Symphony* confirms that our political and cultural leaders are mostly dupes or traitors. The subversion of the United States is part of a plan for world tyranny. I have not discovered all the components. People urge me to research the Vatican and the Jesuits, and I will.

But obviously an occult cabal of bankers and other wealthy people is bent on enslaving humanity. Many are Jews who seem to be following the primitive Talmudic injunction to rule the world and usurp all its wealth, as outlined in The Protocols. A manifestation of the Rothschilds’ emerging Luciferian tyranny based in Jerusalem is the Masonic design of the new Israeli Supreme Court building.

Most Jews are not party to this plan, would oppose it, and are themselves victims of it. Anti Semitism is used to distract us from the real issue, the creation of a global police state dedicated to projecting Illuminati wealth.

RED SYMPHONY, PART 3:
CENTRAL BANKERS
SEEKTOTALITARIAN POWER

The “War on Terror” is a ruse by central bankers to control every aspect of your life.

Rereading *The Red Symphony* recently, I was shocked to read an insider’s statement that the bankers are not content with infinite wealth, but want unlimited power.

The Red Symphony is a 1938 Stalinist Secret Police (NKVD) interrogation of Christian Rakovsky, a Soviet ambassador who was a close associate of Leon Trotsky, Rothschild’s agent.

I introduced this explosive 50-page document to my readers two years ago. It strips the veil from modern history and explains the real meaning of Revolution, Communism, Freemasonry and War. It was not intended to become public knowledge. The translator, a Dr. J. Landowsky, made an unauthorized copy.

The human experiment is endangered by private interests who have usurped the function of money creation. Modern history reflects the gradual process by which they transfer all wealth and power to themselves, destroying Western Civilization and creating a world police state.

Rakovsky, whose real name was Chaim Rakover, was sentenced to death in Stalin’s purge of the Trotskyite faction of the party. Leon Trotsky wrote in his autobiography, *My Life*, : “Christian G. Rakovsky . . . played an active part in the inner workings of four Socialist parties—the Bulgarian, Russian, French, and Roumanian—to become eventually one of the leaders of the Soviet Federation, a founder of the Communist Internationale, President of the Ukranian Soviet of People’s Commissaries, and the diplomatic Soviet representative in England and France . . .”

Rakovsky tried to convince his interrogator that Stalin should cooperate with the bankers who “are just like you and me. The fact that they control unlimited money, insofar as

they themselves create it, does not...determine the limits of their ambitions . . . The bankers, have the impulse towards power, towards full power. Just as you and me”.

They created the Communist state as a “machine of total power” unprecedented in history. In the past, due to many factors, “there was always room for individual freedom. Do you understand that those who already partially rule over nations and worldly governments have pretensions to absolute domination? Understand that this is the only thing which they have not yet reached.” [HM: emphasis mine]

A pernicious force paralyzes our national life. Rakovsky identifies it: “Imagine to yourself, if you can a small number of people having unlimited power through the possession of real wealth, and you will see they are the absolute dictators of the stock exchange and [HM: economy . . . If you have enough imagination then... you will see [HM: their] anarchical, moral and social influence, i.e. a revolutionary one . . . Do you now understand?”

The Revolutionary Movement, which defines modern history, was a means to increase banker power by destroying the old order.

In the French Revolution power subtly passed to the bankers who weren’t constrained by Christian niceties, Rakovsky says. “The supreme Royal power was taken over by persons, whose moral, intellectual and cosmopolitan qualities did allow them to use it. It is clear that these were people who had never been Christians, but cosmopolitans.”

Communism, far from distributing wealth, is designed to concentrate it in the hands of the world’s wealthiest people. (The State owns the wealth and they own the State.) And Marxism, “before being a philosophical, economic and political system, is a conspiracy for the revolution”.

Rakovsky scoffs at the “elementary Marxism...the demagogic popular one” that is used to dupe the intellectuals and the masses.

[HM: Whatever its intrinsic merits, Socialism seems designed to bribe and make people dependent on big government, which the bankers control.]

As for Freemasonry: “Every Masonic organization tries to create all the required prerequisites for the triumph of the Communist revolution; this is the obvious aim of Freemasonry,” says Rakovsky, a high-ranking Mason himself.

The aim of the Revolution is no less than to redefine reality in terms of the interests of the bankers. This involves the promotion of subjective truth over objective truth. If Lenin “feels something to be real” then it is real. “For him every reality, every truth was relative in the face of the sole and absolute one: the revolution.”

In other words, white is black and up is down. This is the way it was in the Soviet Union and this is now happening to us. Truth and justice are being replaced by political diktat. “Political correctness” a Bolshevik term is now in common usage. Physicists like Steven Jones who question Sept.11 are silenced. Historians like David Irving are jailed.

Rakovsky marvels that “the benches on which sat the greasy usurers to trade in their moneys, have now been converted into temples, which stand magnificently at every corner of contemporary big towns with their heathen colonnades, and crowds go there ...to bring assiduously their deposits of all their possessions to the god of money...”

He says: “the Soviet five-pointed star represents the five Rothschild brothers with their banks, who possess colossal accumulations of wealth, the greatest ever known.”

Isn’t it strange that Marx never mentions this fact? Rakovsky asks. Isn’t it strange that during revolutions, the mobs never attack the bankers, their mansions or banks?

War is the means by which the central bankers advance their goal of totalitarian world government. Rakovsky says Trotsky was behind the murder of Arch Duke Ferdinand (which sparked WWI). He recalls the phrase used by the mother of the five Rothschild brothers: ‘If my sons want it, then there will be no war.’ This means that they were the arbiters, the masters of peace and war, but not emperors.

Are you capable of visualizing the fact of such a cosmic importance? Is not war already a revolutionary function? War? the Commune. Since that time every war was a giant step towards Communism.”

After the murder of [HM: Illuminati member Weimar Foreign Minister] Walter Rathenau in 1922, the Illuminati give political or financial positions only to intermediaries, Rakowsky says. “Obviously to persons who are trustworthy and loyal, which can be guaranteed a thousand ways: thus one can assert that those bankers and politicians [HM: :in the public eye] are only men of straw . . . even though they occupy very high places and are made to appear to be the authors of the plans which are carried out.”

In 1938, Rakovsky outlined three reasons for the upcoming Second World War. The first is that Hitler began to print his own money. “This is very serious. Much more than all the external and cruel factors in National-Socialism.”

Secondly, the “fully developed nationalism of Western Europe is an obstacle to Marxism. . . . the need for the destruction of nationalism is alone worth a war in Europe.”

Finally, Communism cannot triumph unless it suppresses the “still living Christianity”. He refers to the “permanent revolution” as dating from the birth of Christ, and the reformation as “its first partial victory” because it split Christianity. This suggests that the “conspiracy” also contains a racial or religious factor.

“In reality, Christianity is our only real enemy since all the political and economic phenomena of the Bourgeois States. Christianity controlling the individual is capable of annulling the revolutionary projection of the neutral Soviet or Atheist State.”

Now the Central Bankers are promoting World War Three as in “The Clash of Civilizations”. Substitute Islam for Christianity above.

CONCLUSION

Our beliefs must adjust to the truth and not vice versa. Apparently, the truth is that a relatively small clique of Jewish banking families and their non-Jewish allies in the leading families of Europe and America have usurped control of money creation, and with it the destiny of the world.

This overclass owns or controls most of the world’s largest corporations, media organizations, intelligence agencies, secret societies, universities, politicians, foundations, think tanks and NGOs. It also appears to dominate organized crime.

Sept. 11, the War on Terror and Iraq are part of an inexorable process by which this overclass increases its wealth and control. The end goal is a world police state in which the masses will be deprived of their wealth, freedom and possibly their lives.

Therefore, you must grasp the moment, prioritize the “list(s)” and then take action in an appropriate and effective manner of ACTION, even if the “action” be simply “in thought”, which is the first most important ACTION in all instances. You can react in necessary “reaction” but SORT IN DEFINITIVE THOUGHT FOLLOWED BY APPROPRIATE “ACTION”. THEN, FRIENDS, YOU MUST CONTINUE TO EVALUATE MOMENT BY MOMENT AS THE “NOW” IS ALL YOU HAVE TO HOLD YOUR “ACTIONS”. OTHERWISE, YOU WILL OFTEN “ACT” AND BECOME “TOO LATE SMART”. MINIMIZE YOUR LOSSES BY CLARITY OF THINKING. You can then “evaluate” the circumstance after security is attained.

And indeed, yes I do have a practical example for your integration within your functional time and source management considerations.

Here we have to daily face many myriad activities of which all are incredibly important to our success or failure in any given “day”.

First we must always be absolutely CURRENT in any information coming from every direction as impacts our job at hand. We must put these things, as they present, to you of the public but we don’t have time to go back and REWRITE the material over and over again for the “game” at hand. If you have TWO receiving stamps on something and they bear the same date of filing and recording information you can be pretty sure that the stamped date is more appropriate as validation of filing BUT NOTHING AS TO THE DATES OF PRESENTATION OTHERWISE. WE WILL ALSO EXAMPLE THAT ELSEWHERE FOR I DO NOT WISH TO SPEND TIME ON IT HERE.

AWARENESS:
AWARENESS DEPENDS ON ATTENTION!

We WILL live in the currently present moment whether or not we like it. That is reality of expression. However “awareness” of the momentary incidents varies according to the attention devoted to the incident. The most IMPORTANT incidents can and do occur all the time but of which you remain individually and totally UNAWARE. Most things are NOT in your space of recognition or are “off your stage”. This can be exemplified by a storm outside your area, no matter how large or small, and that which is within your experience as raindrops blow against you or your window glass. Which gets more attention?

I like the description of some as to “awareness” and “moment”. A moment is actually the short span of time between a split millisecond and a few seconds but it also means the difference between “nothing” and “infinity”, misery and/or bliss. Life itself is the sum total of these moments; the more significant each moment lived, the more significant one’s life presents. As much as living in the present, you must also learn to grasp the moments and savor the fleeting experience.

YOU MUST INCREASE YOUR AWARENESS:

This can be accomplished by many means but first RELAX in the moment so that reason, logic and senses can properly attend whatever is presented. Even as with a fire to be extinguished, panic only further confuses the immediate issue. More appropriate to anything is “attention”. Example: When you misplace your keys or your glasses, perhaps still on your face, it is not Alzheimer’s friends; it is the absence of awareness in WHERE YOU PUT THEM IN THE FIRST PLACE. If this happens many times and becomes a recognized discomfort to you it is a fact that you WILL PAY BETTER ATTENTION. The more discomfort resulting in the loss the more important it becomes to watch what you do WHEN YOU DO IT.

So, be calm and let things unfold or recheck sequence and if you are not “dead” you will find the likely incident needing recall.

When you do “act” on something intentionally you must treat the action as something being experienced for the first time and not as an habitual automatic “reaction”. It is good, in fact, to change your habits so that you are more aware of what you are doing and it also protects you from the “enemy” or thief awaiting your appearance as in “habitual” activities. Do NOT be dependable FOR YOUR ENEMY. You will also find new information every time you change the approach be it to the market or to a document where information offered must be noted and sorted.

In a document, for instance, just the addition of the most tiny offset of print proves tampering in any given sentence.

One good and immediate example of a fraudulent document is one which VK has offered openly to attempt to prove her marriage to Russell Herrman, Hermann, Herrmann, Herman. She has tried to authenticate by

A Painful Update from Eustace Mullins

THE CONTRACT MURDER OF EUSTACE MULLINS

For more than five years, I have been battling to stay alive in the State in which I live. My adversary has not been the mafia, but the Commonwealth of Virginia. The occasion was my publishing the *American-Christian Messenger*, founded in 1972, in the summer of ‘72 issue, titled the *Red State of Virginia*. I revealed for the first time that the famed Byrd machine, which maintained iron control over the people of Virginia for many years, was actually the Rothschild-Byrd Machine. In December, 1893, Tom Martin, a railroad lawyer representing Jacob Schiff of Kuhn Loeb and Company, the American branch of the House of Rothschild, ran for the U.S. Senate from Virginia. He was predicted to lose against the popular Fitzhugh Lee, but Kuhn Loeb bought ten members of the Democratic Caucus of the Virginia Assembly for the sum of one thousand dollars each. They then switched their votes from Lee to Martin, who won the Senate seat. Two young men from Martinsburg, VA are launching their careers at that time. They were long time friends, Harry Byrd and Lewis Lichtenstein Strauss. Strauss joined Kuhn, Loeb and Company and with his financial backing, Byrd went into the Martin Organization, which later became the Byrd Machine, with Rothschild backing. After many years of total dictatorial rule in Virginia, Byrd finally died. Strauss pushed his son to replace him, and the Byrd Machine continued with his son Harry Jr. It was continuing now and was always known as the Byrd Machine, but although to those in the know, it was always the Byrd-Rothschild Machine. When Byrd Jr. decided to run as an Independent, Strauss mailed flyers to every voter in the State of Virginia, notifying them that he supported Byrd Jr. as an Independent. Speaking of this strange alliance, over WRNL, Richmond, VA . Feb. 10, 1949, Colonel Frances Pickens Miller said “Virginia has not been functioning normally as a free society because of the Political Clique that has controlled the Commonwealth during the past half century”. Byrd referred to Byrd’s lieutenant, a man never elected to any Office, E.R. Combs, State Chairman of the Compensation Board, who set the pay for every Byrd henchman who held every Office in the State, which was modeled after the Communist Party of the Soviet Union, which Byrd had used as a model in setting up his own totalitarian State bureaucracy in Virginia. Miller then had to move to North Carolina after making this speech. There has been no opposition to the Rothschild-Byrd Machine since 1949, in Virginia. This continues the absolutist tradition in Virginia, which began as huge Estates, owned by men like King Carter and the Byrd’s. From its inception, it has been the very rich and masses of peasants. Its Capitol, Richmond, VA is referred to as FIC, referring to three groups which have always held power there. F is for Freemasons, I is for the State of Israel and C for Communism. All three flags have on occasions flown over the State Capitol in Richmond. There is no Virginia flag, as Virginia is the last thing in the minds of the Virginia legislature, as corrupt today as it was in 1893 when its bribed members voted Tom Martin into the U.S. Senate. When we think of the wonderful people we have had in this State, Washington, Jefferson and so many others, we wonder how we came to this sorry pass? The truth is, Virginians haven’t changed that much. We have been deleteriously influenced by changing mores, and changing times. The people in my area, Staunton, VA, have not changed that much, but their morals have been loosened that much. The pressures around them have changed. It is as deep sea diving, we have gone beyond our depths, and we are now trying to change to adapt to the pressures of a lower depth. If indeed we are in the lower depths, we must recognize our situation and adapt to the lower depths. The rise of the Byrd-Rothschild rule in Virginia does not mean that we must ignore the changes of history. The fact is

that the Byrd-Rothschild group thrust Virginia onto the stage of world history. Kuhn Loeb, which bought Virginia for the Rothschilds, also bought Tom Martin. They long for Communist rule of the entire world Not only did Woodrow Wilson become the champion of world terrorists, but he condemned the 20th century to be remembered eternally as the century of terrorism, all the work of one man. I am still hated today in Richmond today for my ground breaking expose of the Communist empire and its use of the Federal Reserve System to create the Communist world empire, which finally collapsed only because it was a fake system, as its fake Federal Reserve origin. Wilson supported and defended the Communist Dictatorship to his dying day, and is remembered still for his status as a hero of the Soviet Union. He bailed out the collapsing Bolshevik government by embezzling \$100 million of the Special War Fund which Congress had voted him to defend the U.S. in WW-1, and which saved Communism when he sent it to the Soviet Union with his compliments. This gift is rarely mentioned in histories of the time. I mentioned this unknown chapter of history in a lawsuit filed against the Commonwealth of Virginia January 30, 2006 in Federal Court, which they are now trying to dismiss with prejudice. This case must be heard in the remembering of history as it actually happened. I had filed this suit in trying to defend myself against the furious vendetta which the Rothschild-Byrd organization had launched against me, which had languished for five years. It was caused by a series of strokes and heart attacks brought on by the stress in my work. The Rothschild-Byrd machine seized on this opening as I was in a series of nursing homes trying to regain my health, and during this period my Virginia Drivers License had expired without my knowledge. The alert bureaucrats seized on this opening and began to harass me daily to renew the license. As I had been driving for 72 years without incident in this State, I expected no problem with this routine renewal, but the Rothschild-Byrd organization seized upon this opening and denied my renewal. Over the next 5 years, I took the test 82 times. Each time I was told that I failed the written test, which denied me the driving test. I continued to drive to medial appointments and offices, realizing that I was in extreme danger. I then filed a \$900 million damage suit against Commonwealth of Virginia in the Federal District Court of the United States in Harrisonburg, Virginia, charging violations of Federal laws against age discrimination, but not mentioning the Rothschild-Byrd terrorist organization. Having no response to my lawsuit from the Commonwealth, I waited 20 days and filed the usual Motion for Default Judgment This got immediate attention and they launched an all-out campaign against me. On April 3, I went to the store to pick up medicine. When I returned, I noticed a number of local police cars in my vicinity. As I turned onto my street, I was surrounded by many squad cars. I counted 25, which was very unusual, as rarely would more than 2 cars answer the most serious call. The size of this terrorist attack was to panic me into making a run for it, which would have been fatal to me in this terrorist assault. I stopped immediately and the Officers began yelling orders to me, many of them conflicting with each other. The Officers then wrote me a number of tickets, including the usual “Expired Driving Permit”. This was the notorious driving license scam. Some years ago, someone had come up with the idea that the State should hold all Titles to vehicles, mailing a Certificate of Title to the ‘owners’. This created a legal fiction that the State owned the vehicles. Drivers were thus driving a State owned vehicle, mandating drivers must have a license to drive a State vehicle, which was false. The State reaped many millions with its drivers license scam, and began issuing heavy fines for not having a State

license. Writing the tickets, the Officers warned me that I could not drive a few feet to park in front of my home. I was near collapse from the shock of this assault, having had a number of strokes and heart attacks at the age of 83. I later found out that this was a police murder raid which the attackers were certain I could not survive. A few minutes later, I collapsed on the steps to my front door and suffered a massive coronary occlusion which shut down my heart and nervous system. I fell down a flight of concrete steps, inflicting many abrasions and broken bones. A neighbor saw me fall and rushed over to take me to the emergency room where I remained for many hours. This was my first intimation of the murder plot against me. I was never intended to survive this assault. I left the State to recuperate from this attack and remained away for some weeks. I had returned the tickets because I had filed a lawsuit on drivers licensing in Federal Court. On January 30. I returned home in late May. On Sunday morning, June 3, I was awakened by armed Police, who began to shout at me to produce any weapons I had. I replied that I had no weapons. They then cuffed me for the first time and dragged me in my pajamas to a police car and [then I was] taken to jail. The charge was failing to appear in Court, a standard charge for assaults on citizens. A TV set produced a Magistrate who set the date for my sentencing, July 28, 2006. I was then told I could go and had to walk up a steep hill back to my home, stumbling on my flimsy slippers. I realized this was the second police murder raid on me, in my home. The demands that I tell police what weapons I had was designed to force me to produce weapons and be shot down at once as a crazed writer in a battle with police. I had known of many such cases. An old friend, Bill Cooper, a prominent anti-Communist writer, had recently been shot down under the same circumstances. For 18 years after my fathers death, I cared for my invalid mother and my handicapped sister in their home. During this time, they were constantly harassed by police because of my well known anti-Communist writings. After they passed away, the police had only me to harass and they never let up on their surveillance of me. At that time, I had not learned of the longtime association of the Rothschild-Byrd machine and its Communist work, which would have explained their antipathy to me. I and my relatives had been assigned to the blacklist of the Richmond Taliban, fanatical Communist zealots who are determined to attack anyone who criticized Communism, and which inspired the two Staunton Police murder raids on my Staunton home. These murder raids on an anti-Communist were reminiscent of other terrorist acts in Recent history, the Waco holocaust, in which an entire Christian congregation was burned alive in their Texas church, the only time this has happened in the history of America, not a single protest was heard from any minister, which of course would be bad for business. Then the Ruby Ridge massacre in Idaho, in which Randy Weaver living in a mountain shanty, was charged with ‘failure to appear’, then attacked in his home by a Swat Team of FBI assassins, and the most famous assassin, Lon Horuichi of the FBI, then shot his wife in the head as she was holding their baby in her arms. No one has ever been charged with these murders. I have grounds for a class action suit in the police murder raids on my home, and also with conspiracy to murder by a political organization, which would make a very interesting civil rights case. I cannot charge the Rothschild-Byrd party with these crimes because it is composed of two units, the Virginia Democratic Party, known as the Scalawags since they were organized by the occupation troops in 1865, and the Virginia Republican Party, known as the Carpetbaggers, formed on the same date. Since I as the Plaintiff cannot charge these criminal groups under their correct names, it will be difficult to obtain indictments against them. President Bush constantly warns us of the terror, but neglects to tell us that they are government agents.

AHMADINEJAD’S POSITIVE TALKS IN SHANGHAI

SHANGHAI (MNA) - President Mahmud Ahmadinejad who was in China to attend the 6th Shanghai Cooperation Organization (SCO) summit held separate and fruitful talks with leaders of China, Russia, Kazakhstan, Pakistan, Tajikistan, and the Indian oil minister who represented his country in the conference.

The Iranian president discussed bilateral ties, regional and international issues, energy, economic and security cooperation with the SCO members.

The summit was officially opened on Thursday and lasted until Friday.

Ahmadinejad also discussed Iran’s nuclear policy, notably with Vladimir Putin of Russia and Hu Jintao of China, the leaders of two major countries which, along with the European Union trio of France, Britain, and Germany and the United States, presented a nuclear offer to Iran on June 6.

President Ahmadinejad’s participation in the SCO summit and his separate meetings with the leaders of China and Russia received a wide-scale media attention. The U.S. administration was not able to hide its anger at the presence of Iran in the SCO regional bloc which Washington sees as a threat to its presence in Central Asia.

The SCO groups China and Russia with the four Central Asian states of Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan. Iran, Pakistan, India and Mongolia are observer nations.

Addressing the summit meeting on Thursday, the Iranian president called on SCO members to increase their energy cooperation, especially since the SCO region is home to half of the world’s population when observer members are included.

The president also told the delegates that the SCO can counter the bullying of outside powers, the Mehr News Agency (MNA) correspondent reported.

Tehran Beijing Ties Benefit World: Ahmadinejad

Ahmadinejad held talks with Chinese President Hu Jintao on Friday, discussing matters of mutual interest, especially Iran’s nuclear program.

“Iran and China have many common views on world developments,” Ahmadinejad said, adding, friendly Tehran-Beijing relations benefit not only the two countries but also the Middle East and the entire world.

Sustainable peace can only be established based on brotherly relations, he opined.

“Iran and China enjoy great potential in this regard.”

He emphasized the need to continue and deepen political consultations between the two countries, saying, “Some powers are opposed to the expansion of ties between Iran and China although it is not detrimental to any nation”.

He announced that Iran is prepared to step up

cooperation with China in various areas, especially transportation, telecommunications, and energy.

Commenting on the nuclear issue, Ahmadinejad reiterated that Iran’s nuclear activities are within the framework of international obligations and treaties and only for peaceful purposes.

He also thanked Beijing for its stance on Iran’s nuclear dossier.

The Chinese president said that China and Iran have many common views and have had satisfactory political relations and economic exchanges over the past few years.

China supports Iran’s right to use nuclear energy for peaceful purposes, Hu asserted, adding that Beijing believes that the nuclear impasse should be resolved through negotiation.

“I am sure that Iranian officials will make the correct decision on the nuclear issue based on their national interests,” he observed.

He also announced China’s readiness to play a constructive role in resolving the nuclear impasse by maintaining its close consultations with Iran.

“The two countries have had good consultations on various world issues, especially human rights and reform of the United Nations structure,” he added.

The two ancient civilizations of China and Iran should boost their cultural and individual exchanges, Hu said.

China and Iran have long had close economic ties, especially in the oil and gas fields, and are currently in negotiations over an energy deal that was tentatively inked in 2004 and could be worth more than 100 billion dollars.

As part of the initial memorandum of understanding, Sinopec, China’s largest refiner, would buy 250 million tons of liquefied natural gas over 25 years, which alone could be worth more than 100 billion dollars . . .

. . .Iran-Russia Regional Security Cooperation

Iranian president and Russian president held discussions on matters of mutual interest. Ahmadinejad called Iran-Russia political and security cooperation to strengthen regional stability effective, adding, “Certain countries do not want to admit the significant roles of Iran and Russia in enhancing peace and security in the region and are attempting to influence regional issues to further their own interests.”

Iran and Russia share common views on many international issues, and Iran is determined to have long-term relations with Russia in all spheres, he noted.

Putin said that Russia supports Iran’s peaceful nuclear program and will fulfill all its commitments to Iran, despite the international pressure.

“We believe that diplomatic dialogue is the only solution to Iran’s nuclear dispute,” Putin stated, adding that Moscow is prepared to cooperate on Tehran’s nuclear plans for the future.

He went on to say that Russia appreciates Iran’s efforts to establish balance in the region, citing Tehran’s assistance in resolving internal problems in Iraq and Afghanistan as examples.

Ahmadinejad Says Russia, China Agree on Many Issues

Iran, China and Russia agree on many issues, Ahmadinejad said, after holding talks with the leaders of both countries.

“We cannot speak about the details of our

discussions,” Ahmadinejad told reporters as he held talks with the two heavyweight presidents.

“Our views and positions on many issues are close or even identical.”

Ahmadinejad, Musharraf Discuss Ties

Ahmadinejad stressed the need for the expansion of bilateral ties with Pakistan on Thursday.

“The way is paved for the development of Iran-Pakistan mutual relations in the economic, cultural, and political spheres,” Ahmadinejad told Pakistan’s President Pervez Musharraf on the sidelines of the summit.

He also expressed hope that the finalization of the Iran-Pakistan-India (IPI) gas pipeline project would enhance bilateral economic ties.

Musharraf described Tehran-Islamabad relations as good. He said Pakistan is interested in expanding ties with Iran and called for expediting the finalization of the IPI project, which is also known as the Peace Pipeline.

Pakistan is prepared to cooperate with Iran in the areas of security and intelligence in order to increase border security, Musharraf added. Iran and Pakistan should increase their cooperation in the campaign against terrorism and boost security on their shared border, Ahmadinejad said.

“We view Pakistan as a friendly country and believe the ground is paved in many ways for cultural, economic, and political cooperation.”

The Iranian president emphasized Iran’s inalienable right to access peaceful nuclear energy, noting that Iran has fully cooperated with the International Atomic Energy Agency on the nuclear issue and is always ready to hold fair negotiations ...

“Sanctions” Should Be Removed From Political Vocabulary: Ahmadinejad

The word “sanctions” should be removed from the political vocabulary, President Mahmud Ahmadinejad said on Friday in reference to Western threats to take UN Security Council action against Iran over its nuclear program.

“We do not see a dead end in Iran’s nuclear dispute because we are moving forward using negotiations and wisdom, and if everyone obeys the law, there will be no problem,” he told reporters at a new conference in Shanghai.

“We believe that the word ‘sanctions’ should be removed from the political vocabulary and that sanctions should not be used as a threat or instrument of power,” Ahmadinejad added.

The Iranian president said the offer from the five permanent members of the UN Security Council and Germany was a “step forward”.

Iran Considering Nuclear Package

“I have asked the (Iranian) officials to seriously study the offer, and we will definitely give our response, based on our national interests, in due time,” he explained.

Commenting on Iran’s conditions for negotiations on the nuclear standoff, he said, “We prefer talks to tension under any circumstances, and we welcome the fact that our friends (the EU) who had stopped the talks have returned to the negotiating table.

“We do not seek nuclear weapons. The experience of Hiroshima is not far from us, which has disturbed the entire history of humanity.”

Ahmadinejad stated that Iran and China are longtime friends with many common views and extensive relations and interests which consult each other on key global issues...



NEVADA CORPORATIONS:

Stay Small Or Increase Substance In Nevada

Budget’s “Tip of the Week” #18:

More on “Nexus” and “Substance”

Two legal issues crop up when operating a Nevada corporation which might have some activities in a foreign jurisdiction: “nexus” and “substance”. Without getting into a full-blown legal definition for the purposes of this discussion, nexus can be considered equivalent to the related word, “connection”. And for purposes of this discussion we can consider the legal issue of “substance” to mean “physical presence”.

We have previously pointed out a list of conditions under which a Nevada corporation is not considered to be “doing business” in a foreign jurisdiction. It may, for instance, use an independent contractor to effect sales outside of Nevada, as long as each sale is not considered final until accepted in Nevada. If, however, a Nevada corporation has significant nexus in (connection to) another jurisdiction, in many cases the tax-hungry foreign state will seek to extend its tax laws to compel the Nevada corporation to pay some home-state taxes. A Nevada corporation with little presence in Nevada but which provides all sorts of equipment to an independent contractor working in, say, California could find itself under attack from the California Franchise Tax Board.

So far, at least, **there are very few examples of small, private situations undergoing such scrutiny.** However, in cases where the amounts of revenue derived from the foreign jurisdiction are large enough to present a “target of opportunity”, various states are becoming increasingly aggressive in extending their tax tentacles. In auditing such a situation the home-state taxation authority will pose many questions relating to the “substance” (physical presence) of the Nevada corporation in Nevada.

Actual audit questions in establishing the substance of the Nevada corporation in Nevada can be very detailed and probing, including but not limited to the following: employees (compensation, responsibilities, payroll returns); identification of officers and compensation; copies of phone bills; actual payments made on notes; list of suppliers and professional-service providers; where decisions are made regarding investments; copies of corporate records including minutes and resolutions; banking (copies of all bank statements, checks and deposit slips).

The Nevada Department of Taxation uses the following criteria to evaluate nexus in Nevada: use of an office, distribution house, warehouse, service enterprise or other place of business; maintenance of a stock of goods; solicitation of orders by employees or independent contractors; regular engagement in the delivery of property in this state, other than by common carrier or United States mail; or regular engagement in any activity in connection with the leasing or servicing of property which is located within this state.

From the foregoing it should be obvious that it is always best to remain small in order to keep the bureaucrats out of your private business affairs whenever possible. And if and when your business grows to become a substantial potential target, it may become necessary to broaden its Nevada base, in order to retain more “substance” in Nevada relative to “nexus” in the foreign jurisdiction.


