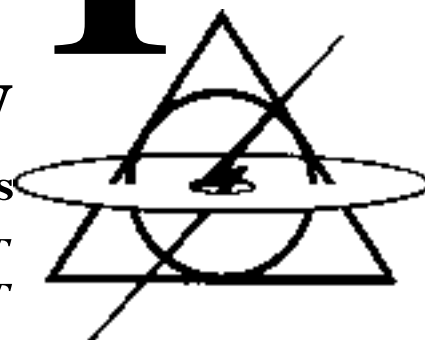

During the campaign that ended Tuesday, nearly every viable candidate met with AIPAC professional staff members and submitted a position paper summarizing his or her views on U.S. Middle East policy. ... AIPAC has for decades worked with Republican and Democratic members of Congress to strengthen the ties between the United States and Israel.”

The new Speaker of the House, Nancy Pelosi, has already ruled out any possibility of impeachment

proceedings. She has also affirmed her commitment to Zionism. According to Jennifer Jacobson, writing for *JTA*:

“She likes to say that, growing up in Baltimore, she went to a bar or bat mitzvah every Saturday,” Amy Friedkin, a former president of AIPAC and a friend of Pelosi’s for 25 years, wrote in an e-mail message to *JTA*.

Friedkin noted that there’s even a soccer field in the Haifa area of Israel named after the lawmaker’s family.

While the Republicans had campaigned partly on the premise that support for Israel among Democrats has waned, exit polls from Tuesday’s voting show that Democrats won an overwhelming majority of the Jewish vote.

With Pelosi as speaker, Jewish activists and officials are confident that the U.S. Congress will remain strongly pro-Israel.

“I’ve heard her say numerous times that the single greatest achievement of the 20th century” was the *[achievement of the Zionist goal of]* founding of the modern state of Israel, Friedkin wrote.

“She has been a great friend of the U.S.-Israel relationship during her entire time in Congress and is deeply committed to **strengthening** that relationship.”

... Rabbi Doug Kahn, director of the Jewish Community Relations Council in San Francisco [is] confident that Pelosi, as speaker, will be effective in persuading people with a broad range of views on the Middle East, the importance of maintaining bipartisan support for Israel.

When it comes to Israel, “she truly gets it,” said Matt Dorf, a consultant to the Democratic National Committee. She gets “Israel’s value and asset to U.S. security” and its “importance as **the only democracy in the Middle East**”. ...

Let’s just pause and look at that word, “democracy”, for a moment, before proceeding to expose the Zionist-AIPAC connection. **A democracy is supposed to do the will of the people, right?**

Some 362,346 people participated in the MSNBC online “Live Vote” shown on this page and 87% of them said BUSH SHOULD BE IMPEACHED. His party has just been DESTROYED in the elections; the so-called “Democrats” have an absolute mandate to REMOVE the great Decider—but somehow, in this purported “democracy”, the nightmare goes on and on.

And that’s the way it is: You have so-called “Republicans” who don’t give a damn about the Constitutional Republic and “Democrats” who don’t care a lick about democracy, all servants of the Money Masters and all conspiring for Zionism.

We don’t want to steal *American Free Press*’ thunder but Michael Collins Piper has an excellent article coming out in their November 20 issue (available online already) captioned, “Zionists Call for Witch-Hunt”. As a bit of a teaser, we’ll excerpt some of this piece while encouraging readers to support *American Free Press*—and Michael Collins Piper’s efforts in particular—as you are able, please.

The article begins: **“A leading voice of the pro-Israel lobby is pushing for an old-style ‘witch-hunt’—under the guise of ‘homeland security’—to identify (and expel) individuals in the U.S. government and our military who are suspected of being hostile to Israel.”**

Mr. Piper attributes the call for a witch-hunt to

the Fall 2006 issue of the *Journal of International Security Affairs* published by the Jewish Institute for National Security Affairs (JINSA). He identifies numerous Bush administration members who have been (and are) associates of JINSA, ‘a virtual agency of the Israeli government’.

“... [I]n the fevered minds of JINSA and hard-line Zionist elements,” Mr. Piper writes, “the real concern is that **there are growing numbers of people high up in the FBI and the CIA and in the military who are getting ‘fed up’ with Zionist power in America.**”

Of course, anyone who would so much as QUESTION 100% backing of anything and everything Israel does, including its own acts of state terrorism such as the last-minute indiscriminate blanketing of Lebanon with cluster bombs, must be some kind of “Jihadist”, at least from a Zionist perspective.

To their credit, certain truly patriotic members of the FBI have not backed off on their investigations of

of tens of millions of dollars! **94% of House seats were won by the candidate spending the most money.** As reported by “CapitalEye” of YubaNet.com (emphasis added):

... The **average** cost of winning a 2006 House race was about \$960,000, based on pre-election finance reports, and **\$7.8 million for a Senate seat.** ...

Based on pre-election spending reports, the Center has revised its prediction of the total cost of the 2006 federal election, from \$2.6 billion to \$2.8 billion, including candidates, national political parties and outside issue advocacy groups. **That would make ’06 the most expensive midterm election ever.**

... Despite the record expense to elect Congress, nearly one quarter of House races—111 in all—involved a candidate with zero financial opposition. One senator, Richard Lugar (R-Ind.), faced no financial opposition. In 36 House races, the winning candidate ran completely unopposed. Another 75 winning candidates faced challengers who either spent no money or filed no reports with the FEC. Federal rules require candidates to file detailed reports of their contributions and expenditures if their campaign raises or spends \$5,000.

“The House changed hands, and the Senate might too, but overall this election was not competitive,” [Center for Responsive Politics Acting Executive Director Sheila] Krumholz said. **“Incumbents overwhelmed their opponents—or simply ran unopposed—because they had a huge cash advantage.”**

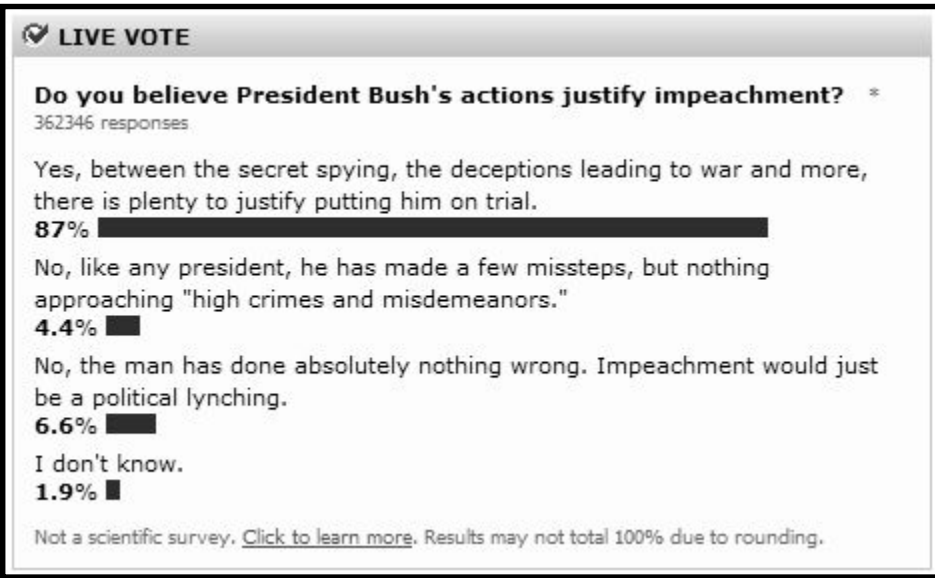
The most expensive race in the country, as measured by the candidates’ spending before Election Day, was the \$45.7-million Senate race in New York—and it was not much of a contest. Incumbent **Hillary Rodham Clinton, the Democrat, spent at least \$35.9 million and won with 67 percent of the vote [“Someone” REALLY wanted to ensure Hillary’s victory, “no matter what”, by the looks of things.],** defeating Republican John Spencer, who spent at least \$4.8 million. At last report Sen. Clinton had about \$14 million left in the bank, which she could apply to a presidential campaign, should she decide to run in 2008.

While the overwhelming majority of yesterday’s races featured incumbents running for re-election, money was also decisive when newcomers squared off. **The top spender in House open-seat contests won 88 percent of the time.** ...

Following a long tradition, Tuesday’s elections did not go well for self-financed candidates. Forty congressional candidates spent more than \$500,000 of their own money in 2006. Only 23 of them even made it to the general election, and just six appear to have won ...

THIS IS NOT A REPUBLIC; IT IS NOT EVEN A DEMOCRACY; IT IS A PLUTOCRACY—RULE BY THE WEALTHY. And it is surely just a coincidence of some strange kind that the wealthy are, overwhelmingly, ZIONISTS?

The REAL WAR is between those who still believe in the existence and principles of the Constitutional Republic in which they “thought” (assumed) they were raised and the plutocratic, Mammon-worshipping, Zionist supremacists who will stop at nothing in their efforts to enslave all of

Mr. Piper sums up his piece by listing several (old) FBI investigations involving those in the JINSA sphere and “possible misuse of American defense and intelligence information on Israel’s behalf”, including:

- The founder of JINSA, Stephen Bryen, a former Senate aide on Capitol Hill, faced certain indictment on charges of espionage for Israel until pressure on the Justice Department forced Justice to back off;
- Richard Perle, investigated in the 1970s when he was a top aide to then-Sen. Henry Jackson;
- Douglas Feith, who—although later promoted to a high post in the Bush administration in 2001—was fired from the National Security Council of President Ronald Reagan; and

• Paul Wolfowitz, now head of the World Bank and former deputy secretary of defense in the Bush administration, investigated in the 1970s by the FBI on suspicion of passing classified information to Israel.

Of course, all of the parasites named above are still well ensconced in the power circles of Washington, DC (District of Criminals), now aided and abetted by a “new” rubber-stamp Congress and Senate which won’t do ANYTHING to undo the damage done by those whom they have replaced.

Patriot Acts I and II, the War Commissions Act, the 9-11 cover-up, the bogus “War on Terror”, the wars of aggression in Afghanistan and Iraq, the looming Israeli attack on Iran—the elections changed NONE OF THE ABOVE. The Money Masters and their parasites are still in pretty much complete control of the vital organs of the Constitutional Republic.

Perhaps we should mention the role that MONEY played in these so-called “free” elections. Oh, sure, “Anyone can be president,” IF they have the backing

Anyone remotely familiar with the American political landscape knows that the Israeli lobby plays a very large role in shaping U.S. foreign policy in the Middle East. This influence has been achieved through clever use of financial muscle and control of large sections of the media from newspapers to cable TV channels to think-tank organizations. ... It was thought (correctly) that media played a very important role in creating or destroying the public image of any minority group in the country.

But somehow along the way, some of these organizations were hijacked by Zionists who equated Jewishness with being the loyal supporters of Israel. *[The “somehow” has been very well explained; it was NO ACCIDENT but rather an intentional plan exactly as spelled out in the Protocols of Zion more than a hundred years ago.]* This minority group set about turning these lobbying groups’ agendas from one of fighting against prejudice to one of working to advance Israel’s interest. A large number of Jewish Americans naturally did not, and do not, agree with the aim of these Zionists. This silent majority (such as the Neturei Karta group, Peace now movement *[Jews Against Zionism]* etc) is seen by the Zionists as false Jews who are traitors to the state of Israel. *[Well, not really, but it makes a nice cover story.]*

... After having succeeded in penetrating the corridors of power, these groups have become overconfident and arrogant. What used to be suggested is now demanded. What was previously politely asked for is now commanded. How long can this continue before it triggers a terrible reaction is anyone’s guess; but it surely cannot continue unchecked for long.

The strength of these groups [has] increased to such a level that they can now determine the outcome of elections (through money and the media). The situation has gotten so bad that now, most of the **congressional hopefuls (Democrats and Republicans), even presidential hopefuls, have to declare their absolute support for Israel first before even entertaining the thought of running a serious election campaign.**

One of these pro-Israel lobbying groups is the American Israel Public Affairs Committee (AIPAC). We know of course that AIPAC has some very wealthy members. These supporters (official/unofficial) also control major part of the media. **Money and media are the things that determine the outcome of most elections.** So it is not surprising to see that most politicians and government officials always try to stay on extremely friendly terms with AIPAC and its clones.

But things have gotten out of hand. One no longer can determine where the U.S. foreign policy starts and where Israel’s ends and whether the U.S. foreign policy is being formulated in Washington or in Tel Aviv. Are the elected officials in U.S. (knowingly or unknowingly) working to advance U.S. interest or Israel’s interest?

“While reportedly under investigation for her ties to an influential pro-Israel lobbying organization, California Rep. Jane Harman last month hosted a private dinner for the group that was attended by two top Bush administration officials—Director of National Intelligence John Negroponte and Secretary of Homeland Security Michael Chertoff *[who is in charge of ALL defense and intelligence agencies]*.”

“The Sept. 13 dinner took place at the home of Harman, the ranking Democrat on the House Select Committee on Intelligence, and was attended by over 120 top financial backers of the American Israel Public Affairs Committee (AIPAC). The highlight of the evening was a panel discussion in which Harman played the host, questioning Negroponte and Chertoff about Mideast developments, international terrorism and homeland-security issues, according to an AIPAC official.”

Why was California Rep. Jane Harman being investigated?

The FBI has been looking into claims since mid-2005 that Harman of California, the top Democrat on the House Permanent Select Committee on Intelligence, made explicit pledges to the American Israel Public Affairs Committee, AIPAC, in exchange for the group’s support in her quest to keep her spot on the intelligence panel.

The *Washington Post* reports one of those pledges was that for AIPAC’s help, she would ask Republican administration officials to ease up on a probe of two former AIPAC lobbyists charged with violating the *Espionage Act* by receiving national defense information and transmitting it to journalists and Israeli Embassy employees. News of the FBI’s investigation first appeared last Friday in *Time* magazine.

What is being produced in the intelligence committee? It is Intelligence assessments, of course. The very thing that can be used to justify wars such as the one going on in Iraq or the one that is contemplated for Iran.

... Every now and then, through these scandals we get a glimpse of the power of AIPAC. We have a top elected official pledging allegiance to a lobby group for Israel to KEEP HER JOB on the INTELLIGENCE PANEL. What does this say to you? Is it the American people who are determining who works in various positions in the government or state of Israel? Anyway, why was she, while being under investigation, giving a dinner party for the very same group of people that she was being accused of working for? And more importantly, who were these AIPAC financial backers and what did they want from Director of National Intelligence and Secretary of Homeland Security? Why did they have dinner with a person that is under investigation? Can you think of anything? Could it be that they were discussing Iraq II (i.e. Iran)?

But it seems what is very obvious to outsiders, is still unknown to the American people. Even after scandal after scandal, the things continue as before. The Iraq war is still claiming thousands of lives and yet people have already forgotten how it was started in the first place. They have forgotten that it was the very same lobbying groups and their favorite politicians (both Democrats and Republicans) that were manipulating facts to start a devastating and unjustified war. We just have to look at one of the convicted lobbyists to see who knew of the events a year before the American people did.

If I was an American, I would ask my President to explain why some lobbyist like Abramoff would know about the plans for an invasion of Iraq a year before he informed the congress. And who was Abramoff’s Israeli friend that he was passing the

information to and why? Look at the following e-mail from Mr. Abramoff to his Israeli friend with the handle: “Octagon1”.

From Abramoff, Jack (Dir-DC-Gov)
Sent: Monday, March 18, 2002 8:31 AM
To: “octogon1”
Subject: RE: Sunday

I was sitting yesterday with Karl Rove, Bush’s top advisor, at the NCAA basketball game, discussing Israel when this email came in. I showed it to him. It seems that the President was very sad to have come out negatively regarding Israel, but that they needed to mollify the Arabs for the upcoming war on Iraq. That did not seem to work anyway. Bush seems to love Sharon and Israel, and thinks Arafat, is nothing but a liar. I thought I’d pass that on.

Octagon1 is the handle for Jack Abramoff’s friend who apparently was an Israeli official.

Exactly one year after Mr. Abramoff’s email to his Israeli friend, President Bush informed the American people that having tried all diplomatic avenues to solve the Iraqi “crisis”; he had no choice but to invade Iraq:

March 18, 2003

Dear Mr. Speaker: (Dear Mr. President:)
Consistent with section 3(b) of the Authorization for Use of Military Force Against Iraq Resolution of 2002 (Public Law 107-243), and based on information available to me, including that in the enclosed document, I determine that:

(1) reliance by the United States on further diplomatic and other peaceful means alone will neither (A) adequately protect the national security of the United States against the continuing threat posed by Iraq nor (B) likely lead to enforcement of all relevant United Nations Security Council resolutions regarding Iraq; and

(2) acting pursuant to the Constitution and Public Law 107-243 is consistent with the United States and other countries continuing to take the necessary actions against international terrorists and terrorist organizations, including those nations, organizations, or persons who planned, authorized, committed, or aided the terrorist attacks that occurred on September 11, 2001.

Well, it seems to me that some lobbyists knew much more about U.S. foreign policy than some elected officials in the Congress and the Senate. Again I may be totally wrong. It may be that the AIPAC financial backers wanted to discuss the tax reform and its effect on the intelligence services’ employees. After all there must have been something to do with intelligence work otherwise they would not have invited the Director of National Intelligence John Negroponte and Secretary of Homeland Security Michael Chertoff.

Or maybe AIPAC wanted to talk to these gentlemen about Jonathan Pollard, a convicted Israeli spy and a former United States Naval civilian intelligence analyst. After all, recently most of the Israeli newspapers have been saying that Mr. Pollard should be released and sent to Israel.

Or maybe they wanted to know about the U.S. intelligence agencies’ progress in finding the supposedly, Israel’s highly placed agent code named “Mega”.

In the 11 years since former Navy analyst Jonathan Jay Pollard was convicted of selling U.S.

military-intelligence documents to Israel, both Jerusalem and Washington have worked hard to heal the wounds from that spy scandal. But apparently both countries are still stealing secrets from each other. Last week the *Washington Post* revealed that the National Security Agency's electronic snoopers, which had been listening in on the phone conversation of an Israeli intelligence officer, uncovered tantalizing evidence that Israel may have a mole even better placed than Pollard was: a senior U.S. official code-named "Mega" who may be passing on U.S. diplomatic intelligence.

After all, during Monica Lewinsky affair, there were strong rumours that the President was being pressured to forget about Mega or else.

The British investigative journalist Kevin Dowling has released an article for publication to a variety of British and American news organizations, charging that the Israeli Mossad was bugging the Watergate apartment telephone of Monica Lewinsky, and was able to obtain material used to blackmail the Clinton administration into shutting down a probe of widespread Israeli espionage in Washington.

Dowling reports that well-placed sources in Tel Aviv say that full transcripts of more than 30 sexually explicit conversations between Clinton and Lewinsky are held by the Israeli foreign intelligence service, the Mossad.

The backdrop is as follows, Dowling reports, and it is backed up by published sources in the U.S., that the U.S. government was aware, from late 1995 on, that the Mossad was carrying out extensive espionage activity in the United States. When the Defense Investigative Service issued a warning to defense contractors about the Israeli spy program, the Anti-Defamation League of B'nai B'rith went into an all-out mobilization to denounce the DIS memo as "anti-Semitic". [*Definition of Anti-Semite: Anyone whom the Zionists hate.*] Of course, just one year earlier, the ADL had been the subject of a lengthy espionage probe by the FBI and the San Francisco Police; and the ADL had earlier been deeply implicated in the Jonathan Pollard spy affair.

In May of 1997, the *Washington Post* and other media reported that the U.S. National Security Agency had intercepted a phone conversation between a Mossad officer posted at the Israeli embassy in Washington, and Danny Yaton, the Mossad chief, in Tel Aviv, during January 1997. The Mossad agent was seeking clarification whether he should attempt to obtain a copy of private letter from then-Secretary of State Warren Christopher to Yassir Arafat, via a Mossad mole high up in the Clinton administration codenamed "Mega". The Mossad boss told the agent that under no circumstances should "Mega" be approached, as s/he was the top Israeli penetration agent inside the Clinton inner circle. An extensive FBI counterintelligence probe to determine the identity of the high-level Israeli mole in the U.S. government was triggered by the NSA intercept.

Comparisons to the Pollard spy affair were naturally raised; the deeper issue is that many observers believe that Pollard's controller (sometimes referred to as "Mr. X" or the "X Committee") is still burrowed deep in a high-level position in a U.S. government agency.

According to the Tel Aviv sources cited by Dowling, there was an emergency meeting of top Israeli intelligence officials, as soon as the NSA intercept was discovered; a Mossad electronic-bugging team of *yalohim* was dispatched to Washington, and one of the targets of their operation was the home telephone of Monica Lewinsky.

According to the Dowling sources, the Mossad obtained wiretap tapes of at least 30 X-rated conversations between the President and Lewinsky.

These tapes, according to the sources, were hand-carried back to Tel Aviv, and were then used to blackmail the Clinton administration into calling off the search for "Mega"; the threat was that if the search for "Mega" were not shut down, the Israelis would begin leaking material from the tapes.

Or maybe they wanted to talk about AIPAC's Steve Rosen and Keith Weissman problems.

The immediate issues of illegal receipt of classified information, possible espionage, and failure to register under the *Foreign Agents Registration Act* (FARA) are bad enough, but the larger issue is the exposure of AIPAC's operating methods. The FBI has a couple of years' worth of wiretap evidence, and the information initially leaked to Rosen and Weissman by Larry Franklin was linked to the push for war with Iran (a rather timely issue, to say the least). The Israel lobby knows good and well that if the transcripts of their conversations with Capitol Hill staff get publicized by way of a trial, they are going to be a lot less effective. Their power has rested on being able to promote Israel's interests (as they see them) away from public view—i.e., they didn't have a position on the Iraq War resolution, but everyone in Washington of any degree of political sophistication knew that they were making an "unofficial" effort to secure its passage. If most Americans knew the extent of this sort of "hush hush" political arm twisting, and the damage it does to American interests, there would be a movement to counterbalance AIPAC, particularly now that a clear majority of Americans believe the Iraq War was a mistake, and have an interest in knowing who was responsible for misleading us into it.

Or maybe the AIPAC financial backers simply wanted to know about all those Israeli agents that were arrested right after 9/11.

... Or maybe they just wanted to shake hands with the big guys in the government. Whatever the case may be, there is simply too much evidence of Israel's involvement (mostly through lobbying groups such as AIPAC) with how things are run in U.S. This creates a huge problem in a democracy; where people expect their representatives to work for their interest and not for the interest of a foreign power. The United States simply cannot become an enforcing arm of the State of Israel. It is too costly for the United States and too dangerous for the world. We have seen some of the consequences of this in Iraq, and if we are not careful, we may see it again in Iran. Who will be next: Syria, Egypt or Sudan? Which other country is on the list of threats to the state of Israel? Should United State systematically engage in one war after another to make Israel feel secure? What about U.S. security? Should U.S. start a war with 52 Islamic countries, one after the other, just to ensure that Israel remains a regional superpower? Are the American people willing to pay the price? Will the silent majority (Jews) remain passive and allow this Zionist minority group to destroy them as well? These are questions that only the American people (Jews and gentiles) can answer.

Final Warning: Part 10a

In order to continue with this excellent outlay of information from author David Allen Rivera's Final Warning: A History of the New World Order at a reasonable pace, we are going to skip through the material highlighting just the most useful parts. Accordingly, Part 10a in our series skips over the author's introduction to the Protocols in order to get at the meat of the matter: some excerpts from the Protocols themselves.

We conclude Part 10a with some examples of military men who have “gotten wise” to the plan and their subsequent ignominious disposition. Part 10b will cover the lies surrounding Pearl Harbor, reminding us from historical records of that which all should know about the more recent “Pearl Harbor” event, 9-11, which has been used by the Zionists to launch the “War on Terror”.

[QUOTING, emphasis added:]

PROTOCOLS OF THE LEARNED ELDERS OF ZION

The Protocols of the Learned Elders of Zion is a 25,000 word document, which contains 24 ‘Protocols’ by a member of a secret group of Jews, known as the Elders of Zion. ...

One inescapable fact is that the *Protocols* do reflect some of the views of Weishaupt and the writings of various Socialists on Bolshevism; and because of that, they were not easily dismissed. Even though they were written so long ago, they have become an accurate barometer of events during this century and seem to parallel the goals of the Illuminati, as you can see in these excerpts from the Victor Marsden translation:

Out of the temporary evil we are now compelled to commit will emerge the good of an unshakable rule, which will restore the regular course of the machinery of the national life, brought to naught by liberalism. The result justifies the means.

Let us, however, in our plans, direct our attention not to what is good and moral, as to what is necessary and useful. Our power in the present tottering condition of all forms of power will be more invisible than any other because it will remain invisible until the moment when it has gained such strength that no cunning can any longer undermine it. Before us is a plan in which is laid down strategically the line from which we cannot deviate without running the risk of seeing the labor of many centuries brought to naught ...

Only force conquers in political affairs, especially if it be concealed in the talents essential to statesmen ... This evil is the one and only means to attain the end, the good. Therefore we must not stop at bribery, deceit and treachery, when they should serve towards the attainment of our end. In politics one must know how to seize the property of others without hesitation if by it we secure submission and sovereignty.

Our international rights will then wipe out national rights, in the proper sense of right, and will rule the nations precisely as the civil law of States rules the relations of their subjects among themselves. The administrators, whom we shall choose from among the public, with strict regard to their capacities for servile obedience, will not be persons trained in the art of government and will therefore easily become pawns in our game in the hands of men of learning and genius who will be

their advisors, specialists bred and reared from early childhood to rule the affairs of the whole world.

Do not suppose for a moment that those statements are empty words: think carefully of the successes we arranged for Darwinism, Marxism, Nietzscheism. To us, at any rate, it should be plain to see what a disintegrating importance these directives have had upon the minds of the goyim.

Through the Press we have gained the power to influence while remaining ourselves in the shade; thanks to the Press we have got the gold in our hands, notwithstanding that we have had to gather it out of the oceans of blood and tears.

To this end we have stirred up every form of enterprise, we have armed all parties, we have set up authority as a target for every ambition ... disorders and bankruptcy will be universal.

We appear on the scene as alleged saviors of the worker from this oppression when we propose to him to enter the ranks of our fighting forces—Socialists, Anarchists, Communists—to whom we will always give support.

Our power is in the chronic shortness of food ... Hunger creates the right of capital to rule the worker more surely than it was given to the aristocracy by the legal authority of kings.

By want and the envy and hatred which it engenders we shall move the mobs and with their hands we shall wipe out all those who hinder us ... When the hour strikes for our Sovereign Lord of all the World to be crowned it is these same hands which will sweep away everything that might be a hindrance thereto.

This hatred will be still further magnified by the effects of an economic crisis, which will stop dealings on the exchanges and bring industry to a standstill. We shall create by all the secret subterranean methods open to us **and with the aid of gold, which is all in our hands, a universal economic crisis** whereby we shall throw upon the streets whole mobs of workers simultaneously in all the countries of Europe.

Remember the French Revolution, to which it was we who gave the name of ‘Great’: the secrets of its preparations are well known to us, for it was wholly the work of our hands ...

We shall create an intensified centralization of government in order to grip in our hands all the forces of the community. We shall regulate mechanically all the actions of the political life of our subjects by new laws ... These laws will withdraw one by one all the indulgences and liberties which have been permitted ... to wipe out any unenlightened who oppose us by deed or word.

We have set one against another the personal and national reckonings of the goyim religious and race hatred, which we have fostered into a huge growth in the course of the past twenty centuries. This is the reason why **there is [not] one State which would anywhere receive support if it were to raise its arm, for every one of them must bear in mind that any agreement against us would be unprofitable to itself.** *[We just have to butt in here to say that the Global Alliance Program has **UNDONE** this protocol, if anyone cares to USE it.]* We are too strong—there is no evading our power. The nations cannot come to even an inconsiderable private agreement without our secretly having a hand in it ...

Nowadays it is more important to disarm the peoples than to lead them into war ...

In order to put public opinion into our hands we must bring it into a state of bewilderment by giving expression from all sides to so many contradictory opinions and for such length of time as will suffice to make the goyim lose their heads in the labyrinth and come to see that the best thing is to have no opinion of any kind in matters political, which it is not given to the public to understand, because they are understood only by him who guides the public. This is the final secret.

By all these means we shall so wear down the goyim that they will be compelled to offer us international power of a nature that by its position will enable us, without any violence, gradually to absorb all the State forces of the world and to form a Super-Government ... Its hands will reach out in all directions like nippers and its organization will be of such colossal dimensions that it cannot fail to subdue all the nations of the world.

We shall raise the rate of wages, which, however, will not bring any advantage to the workers, for at the same time, we shall produce a rise in prices ... We shall further undermine artfully and deeply sources of production, by accustoming the workers to anarchy and to drunkenness ...

In order that the true meaning of things may not strike the unenlightened before the proper time we shall mask it under an alleged ardent desire to serve the working classes and the great principles of political economy about which our economic theories are carrying on an energetic propaganda.

The intensification of armaments, the increase of police forces—are all essential for the completion of the aforementioned plans. What we have to get at is that there should be in all the States of the world, besides ourselves, only the masses of the proletariat, a few millionaires [well, nowadays, billionaires] devoted to our interests, police and soldiers.

In a word, to sum up our system of keeping the governments of the goyim in Europe in check, we shall show our strength to one of them by terrorist attempts and to all, if we allow the possibility of general rising against us, we shall respond with the guns of America or China or Japan.

Our directorate must surround itself with all these forces of civilization among which it will have to work. It will surround itself with publicists, practical jurists, administrators, diplomats and, finally, with persons prepared by a special super-educational training in our special schools.

We have in our service persons of all opinions, of all doctrines, restoring monarchists, demagogues, socialists, communists and utopian dreamers of every kind. We have harnessed them all to one task: each one of them on his own account is boring away at the last remnants of authority, is striving to overthrow all established forms of order.

We have fooled, bemused and corrupted the youth of the goyim by rearing them in principles and theories which are known to us to be false although it is by us that they have been inculcated.

Above the existing laws without altering them, and by merely twisting them into contradictions of interpretations, we have erected something grandiose in the way of results. These results found expression first in the fact that the interpretations masked the laws: afterwards they entirely hid them from the eyes of the government owing to the impossibility of making anything out of the tangled web of legislation.

The chamber of deputies will provide cover for, will protect, will elect presidents, but we shall take from it the right to propose new, or make

changes in existing laws, for **this right will be given by us to the responsible president, a puppet in our hands ... We shall invest the president with the right of declaring a state of war ...**

Not a single announcement will reach the public without our control. Even now this is already attained by us inasmuch as all news items are received by a few agencies, in whose offices they are focused from all parts of the world. These agencies will then be already entirely ours and will give publicity only to what we dictate to them.

Our wise men, trained to become leaders of the goyim, will compose speeches, projects, memoirs, articles, which will be used by us to influence the minds of the goyim, directing them towards such understanding and forms of knowledge as have been determined by us.

Economic crises have been produced by us for the goyim by no other means than the withdrawal of money from circulation ... You are aware that the gold standard has been the ruin of the States which adopted it, for it has not been able to satisfy the demands for money, the more so that we have removed gold from circulation as far as possible.

Thanks to such methods (paying interest on loans), allowed by the carelessness of the goy States, their treasuries are empty. The period of loan supervenes, and that has swallowed up remainders and brought all the goy states to bankruptcy.

... [By the implementation of] any form of taxation per head, the State is baling out the last coppers of the poor taxpayers in order to settle accounts with wealthy foreigners, from whom it borrowed money from the pockets of the poor to those of the rich ...

We have got our hands into the administration of the law, into the conduct of elections, into the press, into the liberty of the person, but principally into education and training as being the corner-stones of a free existence.

... [I]t is indispensable for us to undermine all faith, to tear out of the minds of the unenlightened the very principle of Godhead and the spirit, and to put in its place arithmetical calculations and material needs.

When we come into our kingdom it will be undesirable for us that there should exist any other religion but ours of the ‘One God’ with whom our destiny is bound up by our position as the Chosen People and through whom our same destiny is united with the destinies of the world. We must therefore sweep away all other forms of belief.

After reading these words, you may also have a feeling of uneasiness. Seemingly, the Protocols do elaborate on the Illuminati program for world takeover that would not have pertained to the world at the time the *Protocols* were alleged to have been written. Because of the depth of information given on the various aspects of the plan, I believe that they were written by or based on the writings of someone who had an intimate knowledge of the future plans and inner workings of the international bankers. ...

[The document] speaks of a “King of the blood of Sion” who will preside over a “Masonic kingdom” and that this king will be of “the dynastic roots of King David”. It claims that the “King of the Jews will be the real Pope” and “the patriarch of an international church”.

Eliphas Levi (Alphonse Louis Constant), who had joined a Martinist-affiliated Masonic lodge, which later merged with the Memphis and Mizraim Lodges, had assisted Charles Nodier (Grandmaster of the Prieuré de

Sion 1801-1844) to sift through the Vatican documents taken by Napoleon. Before he died in 1875, he said that “... a new political and religious ‘universal Kingdom’ would be established, and that it would be possessed by ‘him who would have the keys of the East’.” This unusual comment has lead researchers to believe that he had access to the original *Protocols* document which was kept at the Mizraim Lodge.

Protocol number 3 states: “When the hour strikes for our Sovereign Lord of all the World to be crowned it is these hands which will sweep away everything that might be a hinderance thereto. ‘Ours’ they will not touch, because the moment of the attack will be known to us and we shall take measures to protect our own. Ever since that time we have been leading the peoples from one disenchantment to another, so that in the end they should turn also from us in favor of that King-Despot of the blood of Sion, whom we are preparing for the world.”

Protocol number 15 states: “When the King of Israel sets upon his sacred head the crown offered to him by Europe he will become the patriarch of the world.”

Number 17 says: “The King of the Jews will be the real Pope of the Universe, the patriarch of an international church.”

And number 24 reads: “I pass now to the method of confirming the dynastic roots of King David to the last strata of the earth. The prop of humanity in the person of the supreme lord of all the world of the holy seed of David must sacrifice to his people all personal inclinations.”

It concludes by saying that “certain members of the Seed of David will prepare the Kings and their heirs ... Only the King and the three who stood sponsor for him will know what is coming.” It is signed “... by the representatives of Sion, of the 33rd degree”. These strange references have been linked to a little known organization known as the Prieuré de Sion, which will be discussed in a later chapter. ...

TOP MILITARY MEN SACRIFICED

Gen. George S. Patton wanted to retire because he planned on being able to speak his mind about America being “soft on Communism”. However, before resigning his Commission, he died after an automobile accident forced him to be hospitalized. In 1979, Douglas Bazata, a former Secret Service agent for the Office of Strategic Services (OSS, the predecessor of the CIA) revealed that he was ordered by the Director ‘Wild Bill’ Donovan to kill Patton in 1944. Although he didn’t, he knows who did and said that Patton was killed with cyanide at the hospital he was taken to after the accident.

CHAPTER 15
DENIALS AND MORE DENIALS

“They found gold in Napindan,” Craig Nelson tells a couple of reporters from *Ang Pilipino Ngayon* (APN), Rufino Miranda and Al Pedroche, in a telephone interview held on April 12, 1989. Nelson, an American who lives on the island of Saipan, was a major investor and the Assistant Project Manager of the Napindan Dam Gold Recovery Project.

Why had Charles McDougald never mentioned anything about Napindan in his two books?

In the same interview, Nelson expressed his willingness to help the Government recover all of the 340 tons of gold bars dug up in the area, even if this would mean having to make personal appearances in the halls of the Philippine Congress.

Nelson vehemently denied allegations that he executed a “second affidavit” disavowing his previous exposé of 340 tons of gold recovered in Napindan, worth about \$4.5 billion at that time. According to him, the only document that bore his signature had something to do with the full payment of a drill rig, which he had purchased for \$150,000. The rig, subsequently used in the Napindan project in Cainta (Rizal), became the object of much talk when Nelson sent a fax message (to no. 415-883-3473) which read:

“I hereby authorize Atty. Ted Hume and Kevin Kinzler to be my representatives concerning the hydraulic drill I purchased in September 1988 (CLLDM-115). This drill was placed in the name of a company formed and owned by Mario Ongkiko, CHARLES MCDOUGALD, and the brother-in-law of Emmanuel Soriano.”

Nelson stipulated in the message that he was to be paid immediately the amount of \$75,000. Otherwise, the rig would remain under his ownership until the balance of \$75,000 was paid in full.

[H: ... TELL ME AGAIN WHY GOD SHOULD ANSWER ALL YOUR PRAYERS FOR ABUNDANCE? WHEN YOU WILL SCREW YOUR VERY PARTNERS AND LIE, CHEAT AND LITERALLY “STEAL” FROM THEM—WHY SHOULD GOD HELP YOU GAIN ANYTHING?]

Ang Pilipino Ngayon was the first publication to have exposed the alleged gold recovery in Napindan on March 29, 1989, based on the three-page sworn statement made by Craig Nelson, which was annexed by Charles McCubbins, Project Manager of International Precious Metals, Inc. (IPMI) in his letter to Executive Secretary Catalino Macaraig, requesting Malacanang to “dig deeper into Nelson’s story”. This

was followed by ABS-CBN’s anchorman Noli de Castro’s interview with Nelson over DZMM Radio. In their conversation, Nelson reiterated his preparedness and willingness to testify on everything he claimed, despite the denial made by National Security Adviser Emmanuel Soriano. Soriano branded Nelson’s story “a big joke”.

No one from the Aquino Administration admitted participation in any gold recovery. Two years later, *Philippine Newsday* reporter Barbara Fabian dropped an unexpected bombshell. She revealed that President Corazon Aquino’s relatives were in Hawaii in 1988 to ask the former strongman for “eighty percent of an alleged gold hoard worth \$25 billion, in exchange for permission to return home”. The deal, however, fell through. Mrs. Imelda Marcos confirmed this information in an interview aired over GMA Channel 7’s program, *Business Today*.

When President Ferdinand Marcos finally agreed to give the authority to sell the gold, the relatives asked for 80 percent of the earnings, with 20 percent going to the Marcoses. The former First Lady further added that “There exists a document containing the proposal for a \$20 billion-\$5 billion sharing agreement of the proceeds from the sale of the gold.”

Asked by Marcos how much money would go to the Government, the relatives said, “Nothing”. Marcos then insisted that his share should go to the Philippine Government. “There are (also) documents to prove this deal,” Mrs. Marcos pointed out. “Some were even signed by Ambassador Emmanuel Pelaez.”

Pelaez, however, denied having seen such a document, much less having signed anything pertaining to it, in a separate telephone interview from Washington, D.C., with television host Ricardo Puno. “This is either a fantastic story or the product of somebody’s fertile imagination,” Pelaez said.

But on May 22, 1991, Tarlac Rep. Jose Cojuangco, Jr., younger brother of President Aquino, faced newsmen in a press conference and virtually admitted, for the first time, the truth behind Mrs. Marcos’ testimony. He confessed his involvement in *Operation Big Bird* launched in 1986 to recover part of the Marcos wealth stashed in Swiss banks.

Cojuangco was also mentioned in the report submitted by Rep. Victorico Chaves of Misamis Oriental, Chairman of the House Committee on Accountability, and said to have been briefed on the recovery operation.

Sen. Jovito Salonga, who was held responsible for having aborted the operation, likewise mentioned Cojuangco as having authorized the appropriation of a twenty percent commission for Michael de Guzman, who carried out the secret operation together with General Jose Almonte, then Chief of the Economic Intelligence and Investigation Bureau (EIIB).

According to *Daily Globe*’s Miguel Genovea who covered the press conference, Almonte and Rep. Dante Tinga of Taguig-Pateros disputed claims made by Salonga that the latter had no knowledge about the operation, that he did not abort it, and that the whole operation was a “big sting”.

Chaves overturned Salonga’s statement by presenting a letter from one of the Swiss lawyers hired by the Philippine Government, which clearly indicated how Salonga and then Secretary of Justice Sedfrey Ordenez had instructed him (the Swiss lawyer) to “stop the operation”. Thus, Salonga could not feign innocence—since his very own people had been regularly updating him on the progress of the entire operation.

Denials, denials and many more denials.

CHAPTER 16
AGENT REINER JACOBI

Reporting on his Swiss gold-hunting mission, PCGG Chairman David Castro told President Aquino on June 20, 1992 that he had finally confirmed the existence of some \$5 billion worth of gold owned by former President Ferdinand Marcos at the Kloten Airport warehouse and other places in Switzerland. His informants included Reiner Jacobi, an ex-PCGG agent, who had been arrested in Germany for illegally tapping into Swiss bank computers, and an American lawyer based in Geneva.

Castro reported that two sets of prospective buyers from Monaco and Rome had shown him documents and footage of the gold hoard totaling 325 tons. However, another newspaper reported that Castro saw the gold only on film clips shown on German television.

Castro told Malacanang reporters that the same sources had said that the gold was minted at the Central Bank minting plant, based on their files, which they later turned over to the PCGG. However, another news report claimed that Castro had based his findings on the deposition of several trustees of Mr. Marcos, three of whom are Filipinos and the remaining three, foreigners.

According to Jacobi, Adoracion Edralin Lopez, a relative of Marcos, claimed to be one of the signatories when the gold was deposited in the Kloten Airport bonded warehouse in 1983. She likewise claimed that the other two signatories were a Filipino and a foreigner, both living outside Switzerland, but did not reveal their names. The gold was deposited at the Airport to avoid having to declare and register the entire list at Customs. Lopez added that Marcos rented the space for ten years until 1993.

Lopez flew to Zurich sometime in 1990, a year after Marcos’ death, to inquire about the gold. This was how she discovered that her name had been deliberately deleted as signatory, without her permission. “Her objections at the bank fell on deaf ears,” writes McDougald. “She knew the power of the people she was dealing with, so she came home to Manila to try and think of a way to reclaim her rights. Eventually, she and Mama Mary crossed paths.”

Mama Mary reportedly has been a close friend of Mrs. Marcos since her teens. Her real name is Maria I. Gosilatar, but Imelda fondly calls her the “Midnight Lady” because of her unusual habit of visiting the First Lady at ungodly and late hours. She claimed to have once had possession of the “Blue Book” which allegedly contained a complete record of all the Marcos gold shipments to different banks, with their corresponding account numbers.

A year after Castro submitted his report, a London-based television network reported the very same old story about the Kloten gold, with slightly differing sets of figures. A report by British Channel 4’s *Dispatches* program indicated 1,240 tons of gold, worth about \$15.5 billion, stored in a bonded warehouse at Zurich’s Kloten Airport.

“We are not storing the Marcos gold,” says Walter Michel, a manager at Freilager AG, the storage company named by British Television. “I wish we were, because it would be great business,” he added.

The program, likewise, quoted one gold dealer to have said, “Its very existence can’t be admitted at the moment due to a deal between Imelda and the Philippine Government that she would return the booty.” The hoard, which would be more than double the gold holdings of the Bank of England, is now

reported to be in the custody of major Swiss banks. Rhona O’Connell, a bullion analyst of T. Hoare and Company, said, “The sources of any Marcos gold hoard were usually assumed to be purloined Philippine production and Japanese war booty. The Philippine Government had been buyers of gold from 1978 to 1980 at an average of about \$620 per ounce. It then became a distressed seller at around \$440 in 1985.”

Just when the Philippine Government was finally closing in on the Marcos gold, another cloud of mystery surrounded the PCGG office. Magtanggol Gunigundo, the man who took over from Castro, discovered that some documents on the Marcos gold were missing. The new PCGG boss suggested sabotage, because the discovery of the missing papers coincided with the discovery of four paper shredders situated in four offices at the commission. Gunigundo found the presence of the shredders highly questionable.

... [Hatonn comment removed.] “I came to realize that the shredders could [have been used to destroy] vital documents, which can otherwise be taken out or removed from the office,” he said.

Noemi Alacala, a staff writer of the *Daily Globe*, reported that among the missing documents were the files of Reiner Jacobi, the commission’s controversial consultant on intelligence and security.

Jacobi reportedly was the first to discover the gold through industrial espionage. A German court refused to extradite him due to insufficient evidence.

Earlier, the Philippine Government set in motion an investigation on the alleged attempt by a group claiming to represent it, and allegedly commissioned to withdraw hundreds of millions of dollars worth of gold from a Swiss bank in London.

Castro, however, pointed out that before any gold could be withdrawn, “the consent and participation of at least four unknown Marcos trustees would be needed”. Obviously, not one of the trustees was a part of the group which attempted to rip off the gold deposits.

CHAPTER 17
WHERE’S THE GOLD?

“Where’s our gold?” Julie Amargo, the indefatigable protectress of consumers’ rights and welfare in this country must have asked the nagging question several times in her newspaper articles.

“The people have the right to know,” Amargo insists. She’s absolutely right. Article VI, Section 6 of the Philippine *Constitution* states: “The right of the people to information on matters of public concern shall be recognized. Access to official records and documents pertaining to official acts, transactions or decisions shall be afforded the citizens subject to such limitations as may be provided by law.”

Amargo’s invocation of constitutional rights was a reaction to the sudden replacement by President Marcos of Central Bank Governor Gregorio Licaros, in favor of Jaime Laya. Amid the cry of protests from CB officials and employees, Licaros was unceremoniously eased out of his position on January 15, 1981. “Many say that it was IMF pressure”, says Amargo, “but I am more inclined to believe that it had got to do with our gold.”

To Filipino consumers, Licaros was some sort of a demigod who built several vital structures such as the CB building, the PICC complex and the DBP building, all of which are monuments to his foresight and vision. Licaros was a true statesman, who saw to it that the welfare of Filipinos always came first and foremost. “Gifted with an executive ability that is unmatched up to this time, he was the

real consumer hero who did not allow himself to be a puppet,” adds Amargo.

Licaros openly opposed World Bank-IMF impositions. During the oil crisis in the 1970s, he was pressured to sell our gold reserves to finance the importation of crude oil. Instead, Licaros chose to deposit our gold abroad, in case the credit of the Philippine Government was placed in serious doubt. “Our deposits of gold abroad served as an umbrella so that when IMF-World Bank conditionalities and impositions were not palatable, Governor Licaros ran to these banks where our gold was deposited for help. Such a strong psychologically planned buffer held us in good stead in the Licaros years,” Amargo explains.

Note: This was the reason why the late President code-named his last will and testament, The Umbrella, specifically appropriating 80 percent of all his earthly possession to the people of the Republic of the Philippines through a Marcos Foundation, all these acts cloaked in secrecy. This document now being controlled by the duly authorized yet undisclosed key personalities is different from that being exhibited lately by Mrs. Imelda Marcos at the Newsmakers Forum at the Hotel Sofitel on March 26, 1998. This personally handwritten will of the late President was willingly executed to assure the people of the Republic that it is the strongman’s intention to make them truly benefit from his funds, consequently vindicating his name. At the time, there was so much pressure from both the banking Mafia and the Trilateral Commission that Marcos had to let Licaros resign.

On one unexpected occasion, Licaros confided to Amargo how he developed a nervous and acidic stomach from all the American and other outside pressures. And these came at a particular time when intrigue against his person was relentless. “Julie, when I am gone, fight for the Filipinos,” Licaros said. “We are actually sitting on a mountain of gold; *hindi dapat maghirap ang Pilipino*; my hands are tied, and I am too old to battle the giants.” With the parting words, Licaros handed Amargo important detailed data and whispered, “These will prove how I have tried to manage well the monetary system of the country despite tremendous pressures. I have fought devaluation because it is the poor man’s Waterloo. If I had my way, every Filipino should be able to stand on his own two feet.”

Amargo waited for the proper time to use her secret weapon. It came when Jaime Laya committed the serious mistake of accusing the Licaros Administration of overstating our international reserves by \$600 million when, in truth and in fact, it was the other way around. “Our gold reserves appeared in the Central Bank records at historical cost, which was \$35 or less per ounce and during the Licaros years, at one time, the price of gold even soared up to more than \$800 an ounce,” Amargo counters. This led to Amargo’s exposé of the gold in the latter part of 1983, leaving Marcos no choice but to transfer the erring Laya to the Department of Education, Culture and Sports.

In her now famous Open Letter to Laya, the feisty woman activist raised the following important question: “Considering that the Central Bank continues buying gold up to September 30, 1983, a total of \$848 million worth of gold was demonetized per CB official records, what happened, Governor, to the rest of the gold deposits of December 31, 1980, the gold deposits of the Central Bank indicating location and number of ounces, are as follows: (1) Federal Reserve Bank of New York, ‘874,651,970’; (2) Bank of Nova Scotia, ‘112,429,702’; (3) Bank of England, ‘68,910,381’; (4) N.M. Rothschild, ‘72,071,898’; (5) Trade Development Bank of Geneva, ‘202,040,819’?”

Amargo went on to expose the interlocking directorates involving Far East Bank & Trust Co., Arthur Andersen & Co., Societe Cooperative and SGV, concluding that “Whichever way the wind blows, we are at the mercy of the SGV.”

“Our international reserves have gone down so low to the extent that a new Central Bank Authority is being created so that investigators and researchers cannot anymore follow the trail of our gold after the Licaros years,” laments Amargo. “I know the real story why Licaros was forced to resign despite another six-year term... I know the people who intrigued with Marcos to have Licaros booted out of the Central Bank. They are very visible among the ‘Mafias’, and they are afraid that my exposé on the SGV, AA & Co., and the Societé Coop will certainly blow the lid off a situation that is hidden from the public eye.” Maybe so. But the question remains unanswered: Where is our gold?

Since the early ’80s, the Trilateral Commission had exerted exceptional pressure on the late President Ferdinand Marcos into finally concurring to convert our Central Bank into a Central Monetary Authority. This would have been another masterpiece by the international banking Mafia to specifically gain full control over the Marcos gold scattered in different banks worldwide, particularly in the U.S. However, the wily Marcos immediately discerned and quietly detected the ulterior motives of the globalists. He instead made his snappy move to protect the Central Bank by making the good Governor Licaros become the convenient fall-guy to effect the conversion process.

The Trilateral Commission attempted to repeat the same *modus operandi* with the Ramos Administration and they almost succeeded. Upon personally learning about the treacherous scheme, I immediately contacted the office of the Presidential Commission on Good Government (PCGG), headed by Chairman Magtanggol Gunigundo, and the office of the National Security Adviser, Jose Almonte. Marching to Satan’s Drummers

Produced by “Fight the Good Fight Ministry” the DVD analyzes the lyrics, interviews and album art of more than sixty superstars. The consistent espousal of the ideas of Satanists Aleister Crowley, Anton LaVey (Howard Levey) and Madame Blavatsky, and their inclusion in the album art, along with familiar Satanic imagery, is part of a deliberate elite agenda. The list of artists exposed includes the Beatles, the Rolling Stones, Michael Jackson, Madonna, Led Zepplin, Kurt Cobain, Marilyn Manson and Eminem. You can see excerpts on line. I recommend you watch Cobain, Manson and Eminem.

This excerpt from “DEMONS” by Rigor Mortis is typical of heavy metal:

We come bursting through your bodies
Rape your helpless soul
Transform you into a creature
Merciless and cold
We force you to kill your brother
Eat his blood and brain
Shredding flesh and sucking bone
Till everyone’s insane
We are pestilent and contaminate
The world Demonic legions prevail

The DVD explains how music is the most effective means of brainwashing and mind control, especially if the audience thinks it’s listening to spontaneous creative expression. The DVD traces the Satanic message “Do as thou wilt” (formerly “do your own thing”) in many songs advocating free sex, drugs, violence, murder and mayhem. You are God! You can do anything you want! There is no moral order based on universal Love. The rock concert scenes are chillingly reminiscent of the Nazi Nuremberg Rally.

The unabashed espousal of evil raises the question: why are the world’s biggest corporations purveying this poison? Why is tainted spinach intercepted, yet this toxic filth is actually pumped into the minds and souls of millions of unsuspecting children?

The Illuminati’s central banking cartel controls

these corporations. Its aim is “revolution” i.e. “communism”—banker world dictatorship and the destruction of Western Civilization (i.e. the four pillars of our strength and identity: religion, nation, family and race). 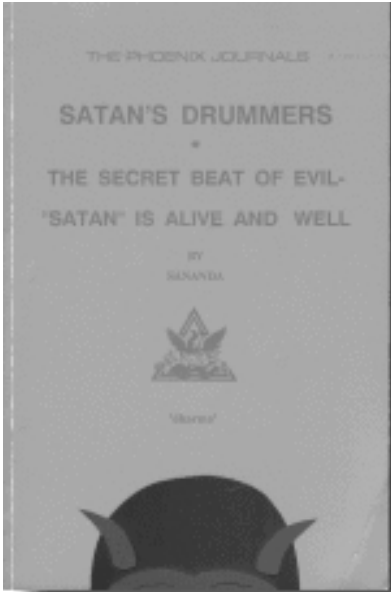

It is widely believed that one of the major reasons we chose to put a priority on toppling Saddam Hussein was due to the lobbying efforts for Israel in Washington. The overcommitment of American forces to a senseless and lethal occupation of Iraq has led to unexpected consequences that will be with us for decades. One of them is a possible military confrontation with Iran, now being openly discussed in Washington. This ignores the limits of American power and the potential for disastrous effects for our friends in the Middle East, including Egypt, Jordan, Saudi Arabia and Israel itself.

Many in Washington are proposing a “grand bargain”: the U.S. would no longer seek a regime change in Tehran, and Iran would give up its nuclear weapons ambitions. But a wiser and far more credible use of American power would be to renegotiate the NPT (Nuclear Non-Proliferation Treaty), as billionaire peace activist George Soros argues, in order to bring all nations under a global system of control of nuclear weapons. Israel is not a signatory of the present NPT, and the Lobby can be expected to oppose any effort that acknowledges Israel's own estimated 250 to 300 nuclear weapons.

The Lobby at Work: The Destruction of Lebanon

By its refusal to deal with Hezbollah as an insurgency that has converted to governance in Lebanon, the United States gave a blank check to Israel, allowing her to attack Lebanon for 34 days and destroy much of the rebuilding that had occurred in the last ten years. The absence of dialogue with emerging Islamic nationalist movements continues to erode our credibility in the region. The Agony of Palestine Continues

While Lebanon burned, so did Gaza and the West Bank. Following the war, Prime Minister Ehud Olmert immediately announced plans to expand the largest settlement in the West Bank and canceled plans to withdraw from smaller settlements. The U.S. made ineffective efforts to persuade him to delay the construction announcement. We are doing even less to promote a real peace process in the Middle East. While Palestine collapses into chaos and civil war, neither we nor the Israelis have a policy that leads to defining Israel's final borders and ending the vindictive and humiliating occupation.

Freeing the four million Palestinians on the West Bank and Gaza so they can have a normal life with free access to the outside world is clearly now a necessity for American interests in the Middle East.

In addition to his role in the Iran-Contra affair and his role in the Iran-Iraq war (above), Gates has been criticized on several other matters:

According to Robert Parry, a reporter who closely tracked CIA history in the 1980s, "In 1985, Gates closeted a special team to push through another pre-cooked paper arguing that the KGB was behind the 1981 wounding of Pope John Paul II" despite the fact that CIA analysts knew that the charge was bogus.

Critics have charged that Gates concocted evidence to show that the Soviet Union was stronger than it actually was, and that he repeatedly skewed intelligence to promote a particular world view. Critics have also said that over a period of many years as deputy director and director of CIA, Gates and his staff failed to predict the decline and disintegration of the Soviet Union.

One has to wonder if Rummy had been set up to be the scapegoat for the quagmire in Iraq and he was smart enough to quit before he was fired. With only two scapegoats left, Rummy's pupil VP Cheney may likewise be in the unemployment line soon. With James Baker and big Bush's coterie of cronies now on the scene with the Iraq Study Group, Daddy Bush is trying to make sure his bungling and idiotic little boy stays on track and not be a scapegoat.

Is it safe to say that if Cheney goes, the next VP has an inside track to the 2008 Republican presidential nomination?

DETAINEES SEEK CHARGES AGAINST RUMSFELD

A dozen men who were held at Abu Ghraib intend to file charges with Germany's top prosecutor to seek a criminal investigation and prosecution of the outgoing defense secretary, along with various other top Bush administration officials, over the detainees' alleged mistreatment.

The plaintiffs in the case include Mohammad al-Qahtani, a Saudi held at Guantanamo, whom the U.S. has identified as the so-called "20th hijacker" and a would-be participant in the 9/11 hijackings and 11 Iraqis who were prisoners at Abu Ghraib.

According to lawyers for the plaintiffs Brig. Gen. Janis Karpinski, the one-time commander of all U.S. military prisons in Iraq, will testify on their behalf. Karpinski has issued a written statement to accompany the legal filing, which says, in part: "It was clear the knowledge and responsibility [for what happened at Abu Ghraib] goes all the way to the top of the chain of command to the Secretary of Defense Donald Rumsfeld."

Adam Zagorin of *Time* magazine says that, "Germany was chosen for the court filing because German law provides "universal jurisdiction" allowing for the prosecution of war crimes and related offenses that take place anywhere in the world. Indeed, a

similar, but narrower, legal action was brought in Germany in 2004, which also sought the prosecution of Rumsfeld." After reassurances from the Bush administration that U.S. authorities and the courts would deal with the allegations, Germany did not pursue the matter and disposed of the case.

Zagorin continues: "In bringing the new case, however, the plaintiffs argue that circumstances have changed in two important ways. Rumsfeld's resignation, they say, means that the former Defense Secretary will lose the legal immunity usually accorded high government officials. Moreover, the plaintiffs argue that the German prosecutor's reasoning for rejecting the previous case—hat U.S. authorities were dealing with the issue—has been proven wrong."

"The utter and complete failure of U.S. authorities to take any action to investigate high-level involvement in the torture program could not be clearer," says Michael Ratner, president of the Center for Constitutional Rights, a U.S.-based non-profit helping to bring the legal action in Germany. He also notes that the *Military Commissions Act*, a law passed by Congress earlier this year, effectively blocks prosecution in the U.S. of those involved in detention and interrogation abuses of foreigners held abroad in American custody going back to Sept. 11, 2001. As a result, Ratner contends, the legal arguments underlying the German prosecutor's previous inaction no longer hold up.

ZIONISTS' AGENDA MOVES FORWARD

The stranglehold of our Zionist Occupied Government continues with a couple of key positions, the Speaker of the House and the Secretary of Defense, staged to go to sympathizers of the Zionist/Israeli agenda.

Now with the Democrats holding a House majority Representative Nancy Pelosi, current Minority leader, is the heir apparent to the top seat in the House. Ms. Pelosi's allegiance is easily determined by a pep talk she gave to AIPAC on May 27, 2005.

The American Israel Public Affairs Committee (AIPAC) is a special interest group that lobbies the United States Government in favor of maintaining a close U.S.-Israel relationship. Describing itself as "America's Pro-Israel Lobby" it is a mass-membership organization including both Jews and non-Jews. AIPAC was formed during the Eisenhower administration, and since then has helped increase American aid and support to Israel. It has also been the source of much controversy and criticism, including alleged espionage and its heavy political influence.

In today's climate a political career is determined by how well you lick the boots of AIPAC and in her pep talk Ms. Pelosi shows how it's done.

Here are a few excerpts to gather a close-up look of her thoughts about Israel and the Middle East:

"Thank you, Amy Friedkin, my dear friend for so many years ... are proud of your great leadership at AIPAC. And to Bernice Manocherian, President of AIPAC, thank you. This spring, I was in Israel as part of a congressional trip ... One of the most powerful experiences was taking a helicopter toward Gaza ... We set down in a field that belonged to a local kibbutz. It was a cool but sunny day... and it felt at that moment as if I were home. One thing, however is unchanged: America's commitment to the safety and security of the State of Israel is unwavering. America and Israel share an unbreakable bond: in peace and war; and in prosperity and in hardship. There are those who contend that the Israeli-Palestinian conflict is all about Israel's occupation of the West Bank and Gaza. This is absolute nonsense. In truth, the history

of the conflict is not over occupation, and never has been: it is over the fundamental right of Israel to exist. Proliferation represents a clear threat to Israel and to America. It must be confronted by an international coalition against proliferation, with a commitment and a coalition every bit as strong as our commitment to the war against terror. The United States will stand with Israel now and forever. Now and forever.”

I’m sure you get the drift and keep in mind that should a sitting president be unable to fulfill his duties the Speaker of the House is next in line behind the vice president in the transference of power.

Through his previous member status in the Iraq Study Group Robert Gates likewise exposes his true colors. The Group, an independent commission set up by Congress with the approval of President George W. Bush and co-chaired by James Baker with a roster of Bush cronies, may recommend carving up Iraq into three highly autonomous regions—an agenda that has been a Zionist goal for more than a century.

In his *Complete Diaries*, Vol. II. p. 711, Theodore Herzl, the founder of Zionism, says that the area of the Jewish State stretches: “From the Brook of Egypt to the Euphrates”. Rabbi Fischmann, member of the Jewish Agency for Palestine, declared in his testimony to the UN Special Committee of Enquiry on 9 July 1947: “The Promised Land extends from the River of Egypt up to the Euphrates, it includes parts of Syria and Lebanon.”

In 1982, Oded Yinon, an Israeli journalist and formerly attached to the Foreign Ministry of Israel, wrote an article called “A Strategy for Israel in the Nineteen Eighties” that appeared in *Kivunim (Directions)*, the journal of the Department of Information of the World Zionist Organization.

As translated by Israel Shahak a former Professor of Chemistry at Hebrew University in Jerusalem, the former president of the Israeli League for Human and Civil Rights, and an outspoken critic of the Israeli government and of Israeli society in general, this document is the most explicit, detailed and unambiguous statement to date of the Zionist strategy in the Middle East. Furthermore, it stands as an accurate representation of the “vision” for the entire Middle East of the presently (1982) ruling Zionist regime of Begin, Sharon and Eitan. Its importance, hence, lies not in its historical value but in the nightmare which it presents.

The plan operates on two essential premises. To survive, Israel must 1) become an imperial regional power, and 2) must effect the division of the whole area into small states by the dissolution of all existing Arab states. *Small* here will depend on the ethnic or sectarian composition of each state. Consequently, the Zionist hope is that sectarian-based states become Israel’s satellites and, ironically, its source of moral legitimization.

According to SaveTheInternet.com Congress is pushing a law that would abandon the Internet’s First Amendment—a principle called Network Neutrality that prevents companies like AT&T, Verizon and Comcast from deciding which Web sites work best for you—based on what site pays them the most. The SavetheInternet.com Coalition is more than 1.2 million everyday people who have banded together to protect Internet freedom by urging Congress to preserve Network Neutrality.

How does this threat to Internet freedom affect you?

· Google users: Another search engine could pay dominant Internet providers like AT&T to guarantee the competing search engine opens faster than Google

on your computer.

· Innovators with the “next big idea”: Startups and entrepreneurs will be muscled out of the marketplace by big corporations that pay Internet providers for dominant placing on the Web. The little guy will be left in the “slow lane” with inferior Internet service, unable to compete.

· Ipod listeners: A company like Comcast could slow access to iTunes, steering you to a higher-priced music service that it owned.

· Political groups: Political organizing could be slowed by a handful of dominant Internet providers who ask advocacy groups to pay “protection money” for their websites and online features to work correctly.

· Nonprofits: A charity’s website could open at snail-speed, and online contributions could grind to a halt, if nonprofits can’t pay dominant Internet providers for access to “the fast lane” of Internet service.

· Online purchasers: Companies could pay Internet providers to guarantee their online sales process faster than competitors with lower prices—distorting your choice as a consumer.

· Small businesses and tele-commuters: When Internet companies like AT&T favor their own services, you won’t be able to choose more affordable providers for online video, teleconferencing, Internet phone calls and software that connects your home computer to your office.

· Parents and retirees: Your choices as a consumer could be controlled by your Internet provider, steering you to their preferred services for online banking, health care information, sending photos, planning vacations, etc.

· Bloggers: Costs will skyrocket to post and share video and audio clips—silencing citizen journalists and putting more power in the hands of a few corporate—owned media outlets.

DESPERATE MEASURES

Gloria and Chavit Singson must be running really scared these days, as reports have stated that Singson, as well as Big Mike, and even Justice department officers, have been visiting Charlie “Atong” Ang in Las Vegas, reportedly to convince him to testify against the detained President, who remains popular despite all the demonization of him and his being imprisoned for over five years.

But given their histories, they are pretty good at having witnesses recant their testimonies, as evidenced by the recantation of then eye witness Udong

Mahusay, who even produced evidence of Mike Arroyo being Jose Pidal, or the recantation of a Sharia’h Judge Moner, who had executed a sworn statement for the Senate, to the effect that he was paid some P3 million by Gloria to keep his trap shut about the poll cheating in Mindanao. His affidavit also stated that Big Mike, along with a Presidential Security Group member, was involved in financing the special poll operations.

... Experienced in the ways of getting witnesses to recant their testimony, Malacañang must have figured that getting Atong Ang to recant and testify against Erap would get Erap convicted by the Sandiganbayan—by giving the court the “justification” for his conviction.

Still, it is a bit too late for that, since the parties have rested their cases. But if Ang is called in anyway as a rebuttal witness—which, to quote Justice chief Raul Gonzalez “merely shows that the prosecution case is weak”—at least in the case of the alleged rape victim Nicole against the four American servicemen—what will he be rebutting, the testimony of Erap on the alleged tobacco tax diversion of some P130 million? But that is a pretty stupid rebuttal, given the fact that this Chavit testimony has been ripped to pieces by Erap’s counsels. Besides, the Commission on Audit reports already show a pattern of diversion of the funds by Chavit from the day the law he crafted was passed.

This was way before Estrada became President.

But Malacañang needs something to make sure Erap stays in detention. Once freed, he can become a big headache for Gloria, especially if he is acquitted before the polls are held.

It will be recalled that it was during the senatorial campaign of 2001 when Estrada was ordered arrested by Gloria, which gave rise to Edsa III.

Erap on the campaign trail was making mincemeat out of the Gloria bets. People came in droves to see him and listen to his campaign spiel for his opposition bets.

Now more than ever, Gloria needs to win the majority of the seats in the House and in the Senate, as she knows that having the opposition in the majority will spell her end.

Even worse, she is in a fix about Estrada. If he is acquitted, it will be a big problem for her, since the *raison d’etre* of him having been ousted was the charge of his having plundered public funds, as well as him having accepted bribes, both of which Estrada proved to be untrue. At the end of April 2006 a certain agency of Global Alliance Investment Association (which shall remain unnamed for now) was approached by an agent of the IRS with an allegation of possibly unlawful activity and a request to submit a comprehensive list of documents for review. Global Alliance Investment Association shares with Cosmos Seafood Energy Marketing, Ltd. the status of Creditor with regard to the United States Treasury (documented by cross resolutions which have been previously publicly noticed). The Internal Revenue Service is the collection agent of the United States Treasury (for the Federal Reserve System and International Monetary Fund—and ultimately the International Bankers), i.e., the debtors. Thus, the action of the IRS was a case of the debtor making demands of the creditor. Our initial response was to both Mr. John Snow, then Secretary of the Treasury, along with a Notice to Cease and Desist Actions against the Creditor to the Internal Revenue Service’s Mr. Gerald Reese. Mr. Snow immediately resigned as did the General Counsel. There has been no protest against the Cease and Desist Notice. In late July, however, a letter from a Special Agent of the Treasury Inspector General Tax Administration (TIGTA) suggested that the letter to Gerald Reese could be construed as “an attempt to interfere with administration of internal revenue laws through corrupt or forcible interference”. There is nothing, of course, either corrupt or forcible about our contractual, commercial position. Our response to the agent’s suggestion is contained in our letter of July 21 to J. Russell George, the head of TIGTA and the agent’s top boss. There has been no protest or response of any kind to that communication.

This letter along with a copy of the Notice to Cease and Desist Actions Against the Creditor at the top of page 15 was sent by certified mail to then Secretary of the Treasury John Snow and was signed as received May 23, 2006. Mr. Snow resigned immediately.

In fulfillment of legal requirements for sufficiency of notice, this is the third and final running of this notice.

Now that you have been informed of our position we expect you to act appropriately and in accordance with prior agreements as well as the Notice to Cease and Desist Actions against the Creditor transmitted to your employee, Mr. Reese, IRS WAC Director (attached for your reference). Please note: "Damages and penalties assessed and invoiced for non-compliance with this Notice are to be paid by the individuals responsible and not from the Public Trust."

Notwithstanding our status as Creditor we choose to remain compliant with all rules and regulations of the United States and we wish to conduct our business affairs in an exemplary manner. If any of our entities is in violation of any law we appreciate being notified of such infraction so we can bring any such entity into compliance forthwith. As Creditor, however, we do this to be a good example and not because we are subject to penalties or injunction. We wish to thank Mr. Reese for his diligence but we require specific details of any perceived infraction so we can set things straight.

You are hereby given notice to cause your agent, Jacob Riley (employee ID 44014AP) and all other agents of the Internal Revenue Service under your direction to CEASE AND DESIST actions against the CREDITOR and all wholly owned subsidiaries of the CREDITOR immediately. We presume you are aware of our status as Creditor of the United States Treasury and Federal Reserve per the documentation attached as well as your previous position as Policy Adviser in the administration of George HW Bush, when you no doubt gained some firsthand knowledge of his "Superfund". The underlying asset, more properly referenced as Bonus 3392-181, has been the property of COSMOS SEAFOOD ENERGY MARKETING, LTD. since 1988.

Our relationship to the United States is spelled out quite clearly in the Articles of Incorporation of Global Alliance Investment Association, Nevada ID # C11415-1997. We have appended a copy of Article VI: Juridical Personality, Immunities, Exemptions and Privileges for your review. We consider the United States to be a member of our corporate body but recent actions by a certain individual representing your office put this relationship in peril.

Please see the enclosed copy of a letter from John Kirk, Agent of the Office of the Inspector General written to the undersigned officer of the Creditor. Without questioning and without allowing our comments Mr. Kirk has misconstrued the use of the word peril in our message to Mr. John Reese. We do not condone the use of force. The statement Mr. Kirk has chosen to focus upon implies only commercial risk. To make our position perfectly clear: If any of our officers, employees or agents is harmed by this apparently deliberate misconstruction, the individual(s) involved can expect the realization of substantial commercial liability.

If we do not hear back from you within ten (10) days, it is presumed you take no exception to the foregoing facts AND that you accept responsibility for ensuring appropriate treatment by TIGTA of our officers, employees and agents in accordance with the immunities, exemptions and privileges spelled out in Article VI of our Articles of Incorporation. We expect compliance with the Cease-and-Desist Notice received by (now former) Secretary of the Treasury John Snow on May 23, 2006 without protest.

Budget’s “Tip of the Week” #9:

Keep A Low Profile

It has been estimated that over 90% of all lawsuits in the entire world are filed in the United States. A medium-sized business is typically involved in a lawsuit per year here and larger corporations are compelled to maintain teams of full-time attorneys to defend themselves. At the other end of the scale, an individual proprietor risks everything to engage in business without a corporate structure and even individuals who are not involved in business are at risk if they have any assets attached to their names. Meanwhile, the law schools keep churning out more attorneys at an increasing rate.

What’s the solution? KEEP A LOW PROFILE. In business and in our personal lives, too, ideally it would be best to never show up at all on the enemy’s “radar”. In the game of “getcha” it is always better to present a minimal target profile for the “getcha gang” and the best way to accomplish this feat is very often through the use of Nevada corporate shelters.

In some cases it may be possible to shelter assets and income in a single corporation but when success is achieved and that first corporation starts to take on a higher and more vulnerable profile, it’s time for some creative thinking. The first step should always be to **separate assets from potential liability**, so if you have an operating business it is good to ensure that it holds no assets of its own. Often the best solution is to have the operating entity lease its equipment from another, unrelated (by ownership) corporation. The next step could be to consider spinning off the existing business’ departments into separate corporations: the marketing department could become a separate marketing company, as an example. Almost all businesses must purchase some goods from outside sources, so why not deal with a friendly supply company, one over which you may exert some control from behind the scenes?

Not only will this approach severely limit the prospects for damage by prospective litigants, it will also, by and large, keep the IRS out of your affairs. Audit rates continue to show (not surprisingly) that the smallest corporations have by far the lowest audit profiles. A corporation with less than \$250,000 in assets had an audit rate of just .28% in the year 2000, while the rate for a corporation with \$1 million in assets was more than TEN TIMES as high at 2.90% and the rate for the largest corporations skyrockets to more than ten times that figure at 30.51%.

The key to making this work is to treat each corporation as its own separate interest and to ensure that each entity always acts out of its own self-interest. In so doing you ensure that each corporation has minimal exposure to lawsuits and IRS audits and the aggregate exposure is far, far less than it would be with a single, high-profile corporation.
