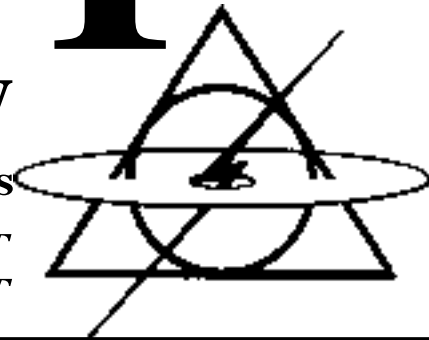

Clash of the TITANS

One Move from Checkmate

“If ever again our nation stumbles upon unfunded paper, it shall surely be like death to our body politic. This country will crash.”—George Washington, first President of United States of America (paraphrased from a letter to Jabez Bowen, Rhode Island, Jan. 9, 1787)

Indeed, the United States has ‘stumbled upon unfunded paper’ since the *Federal Reserve Act* of 1913 and, just as George Washington predicted, the ‘body politic’ is now hardly more than a zombie. The country HAS ALREADY CRASHED in terms of global opinion and prestige—and it seems certain that the economic engine is about to flame-out. The housing market, which had been the primary beneficiary of “loose money” policies, is sputtering despite the greatest increase of “money” (DEBT) in the history of the system.

ONE THING HAS HELD THE UNITED STATES’ PRE-EMINENT POSITION IN THE

WORLD AND ONE THING ALONE: THE FACT THAT THE U.S. DOLLAR HAS BEEN “**THE**” RESERVE CURRENCY OF THE WORLD. Please note: “has been”.

When Saddam Hussein started exchanging his country’s oil for EUROS instead of DOLLARS, this was a potentially lethal blow to both the Zionist Money Masters and the Skull and Bones Cult of 322 (NATO-Nazi) controllers, which HAD TO BE COUNTERED BY FORCE; at least, in their way of thinking. Now Iran has promised to begin trading oil in euros and Russia has taken steps to do the same, along with making the ruble convertible (putting it in direct competition with the dollar). It is the death-knell of the Almighty Dollar.

GCH advised us that there are “a whole lot of would-be kings trying to sort out their positions” and with regard to the clash between them, “it will be so confusing that you will not be able to know”; so we’re really going somewhat beyond our capabilities—“where angels fear to tread”, you might say—in even trying to sort all of this out. For instance: Is Syria a “client state” of Iran? Is Iran some kind of a “client state” of Russia? Certainly, the 2,000-pound gorilla in

the corner, China, is NOBODY’S “client state”—and yet all of these nations of “the thrid faction” have quite naturally and informally come into an ALLIANCE of individual nations opposed to global hegemony by ANY OTHER, which is why these countries merit a common label.

The Zionist Money Masters faction is of Rothschilds lineage. The NATO Nazis are of the Habsburg line and yes, you will find that the Bush family (including Franklin D. Roosevelt/Rosenvelt) are of this lineage which, according to research presented by David Icke (but ignore the “shape shifting”, please), traces all the way back to Ramses II of the Eighteenth Dynasty in Egypt. and focus than those running the United States. Russia’s approach to global politics has basically been “live and let live” and their geopolitical strategies have resulted in great strength through what I would call the informal Alliance of Nationalists. The countries in this grouping are quite content to “take care of number one” and generally mind their own business. It’s a step short of taking care of “the One” but far less abominable than enslaving all nations under the control of the Money Masters. Let’s not forget to add in the 118-member Non-Aligned Movement (NAM) nations to this rather large and powerful grouping we are calling the Alliance of Nationalists.

If YOU were God, which of these three factions—Money Masters (Rothschilds), NATO Nazis (Habsburgs) or this unofficial Alliance of Nationalists (led by Romanovs)—would YOU favor? Indeed, the enemy of our enemy has been and is favored and the purging and sorting continues as the Titans fight for supremacy.

When the dust settles following this Clash of the Titans perhaps the victors will be able to more clearly see the advantages afforded by Global Alliance. There is, after all, a certain comfort in knowing that God is on your side!

China has basically been an unwilling “client” of the Rothschilds ever since the days of the opium trade but in recent years it appears the leadership of China has been persuaded into a mutually beneficial alliance with Russia, adding great strength to the anti-Habsburg balance of power in the World.

The NON-group of naturally aligned nationalist countries looks to Russia’s example, so we should not be surprised at the massive efforts being made to vilify Russia, despite or actually because of her ever-increasing influence on the World stage.

There are many examples of attempts to detract from Russia’s example, all of which are destined to boomerang right back at the detractors. We’ll touch on some a little farther along in this piece but, for now, let’s get back to the central issue: the demise of the dollar as the world’s reserve currency.

Edgar J. Steele wrote a good piece on this issue entitled, “Are We There Yet?”, in which he cites the following received from one of his list members:

“This has long been said to be the line of demarcation for the U.S. dollar. Below \$0.85 there is not much to support it. Only five or six years ago it was around \$1.25. Thirty-five percent is a lot of value to lose in that short period of time. From here, further decline could be faster. China—by its buying of the world’s resources—is going to create enormous upward pressure on all commodity prices. This includes industrial metals, precious metals, grains, lumber, concrete, oil, many types of food, etc. **This comes at a time when many nations are simultaneously—and increasingly—disconnecting their economic associations from the U.S. dollar.** Russia, China, and several other nations have announced that they will increase the amount of gold in their reserves. These nations will buy large amounts, thus making the metal cost more. The term ‘extreme’ may apply.”

Edgar Steele qualifies the above numbers by stating: “The figures given in the quotation above are the standard quoted for the dollar as in index of six foreign currencies, each weighted by the amount of trade done with the U.S. At the moment of this writing, the dollar is at .8448 and sinking fast.”

Russia has just concluded a giant energy deal with European partners which includes the construction of a giant pipeline under the Baltic Sea, feeding Germany directly and bypassing the troublesome,

NATO-Nazi-influenced countries of Ukraine and Georgia and bypassing the latest NATO candidates, Latvia and Lithuania.

Ukraine’s position in all of this was trumpeted in the “Western” press as Russia wanting to DOUBLE the cost of its energy and this was, presumably, unjustifiable. Oh, those BAD Russians! Using energy supplies as a weapon like that! That, of course, is not the whole story.

What really happened? Sure, the price of Russian gas was doubled—to come into line with the prevailing market price. The “sweet deal” Ukraine had enjoyed while its policies were aligned with Russian interests ceased to exist when the country joined up with NATO and agreed to host nuclear missiles on its territory. (How’s that for “neighborly”????!!) Further, Ukraine was “not accounting for” all of the gas in transit through its territory—in short, it looks like they were siphoning off (STEALING) more than a little all along. And as Russia moved to resolve the problem, Ukraine threatened to (and actually did, for a short while) CUT OFF all throughput to the rest of Europe, jeopardizing Russia’s position as a reliable supplier to other European nations.

Russia set about making lemon pie, the culmination of which is that the two cornerstones of Europe, France and Germany, are now well aligned with the Alliance of Nationalists (the third faction identified earlier in this piece, the enemy of our enemy).

According to *Pravda*’s Vladimir Anokhin in a piece captioned, “Putin creates new axis in Europe to oppose USA’s global hegemony” (emphasis added):

The agreements concluded by Putin, Chirac and Merkel in Paris will show a considerable influence on the global energy policy. The new European “axis of energy” has become a response to Washington’s aspiration to dominate the whole world.

... The Paris-Berlin-Moscow axis appeared in Europe last week. It can be interpreted as a link of international politics run by three superpowers—Russia, France and Germany.

... President Putin said that German Chancellor Angela Merkel raised a question about giving the European orientation to Russia’s giant Shtokman gas field. “I can say that Gazprom is considering the opportunity now. The decision will be made shortly,” President Putin said.

The Shtokman gas field is one of the largest gas deposits in the world. Its reserves make up 3.2 trillion cubic meters and 31 million tons of gas condensate. It is possible to extract about 70 billion cubic meters a year, which means that the field reserves may last for 50 or even 70 years. It was previously believed that liquefied gas would be delivered to the USA, where Gazprom initially planned to develop one-tenth of the U.S. market and subsequently enlarge its share to 20 percent.

... The success of the talks can be explained with mutual economic interests and close political views. It is an open secret that Russia,

France and Germany stand against the establishment of the unipolar world structure. The three countries share similar positions regarding the events in the Middle East and Iran too. To crown it all, special relations with Russia can bring the leading place for France and Germany in Europe.

Russia is developing relations with Old Europe against the background of USA’s concerns with Moscow’s home and foreign policies. ...

... The European axis (Paris-Berlin-Moscow) is a normal reaction of experienced politicians to USA’s hegemony. The USA has become a defense machine making its way to global reign. **The agreements in France show that “Old Europe” approaches Russia as an independent and attractive center of power.**

The (Habsburg-Bush) NATO Nazis have been absolutely stymied. If the Almighty Dollar had remained the only reserve currency, it would not have been necessary for them to gain control over the OIL—but that did, indeed, become necessary. So, they set about trying to contain (Romanov) Russia, bribing nation after nation on Russia’s borders into joining NATO.

(Russia’s response shows the depth of their understanding of the situation: Russia asked if it, too, could join NATO! WHY NOT?)

There were only three principle objectives for the Bush-led NATO gang and all could be met, they figured, by WAR: They needed to sustain the U.S. economy, which involved increasing its money supply and DEBT (with a happy corollary, to them, being enslavement of Americans’ life energies until the population is culled); they needed to gain control of the primary non-Russian sources of oil, including those of Iraq and Iran, along with the Caspian Sea oil; and they needed to control all outlets for competing Russian oil.

The strategy was simple: Get a foothold in Afghanistan, from which force could be applied to Kazakhstan and Turkmenistan (two countries with Caspian Sea frontage); consolidate “Western” power in Georgia (also on the Caspian Sea) and Ukraine (the conduit for Russian energy to Europe); blocking other easy access to Europe by having Latvia and Lithuania assimilated into NATO; and all the while fomenting “multi-purpose” terrorism in Chechnya.

Afghanistan was important for another reason, of course: Those nasty Talibans had almost entirely stopped the production of OPIUM, which has been a staple of the NATO-Nazi leader known as “Poppy”. 9/11, of course, was the trigger event. Today, you might note, Afghanistan is held by NATO forces.

As somewhat of an aside here: Kazakhstan has been made the brunt of a recent Hollywood production called *Borat: Cultural Learnings of America for Make Benefit Glorious Nation of Kazakhstan*, in which the people of Kazakhstan are marginalized and DEHUMANIZED through their portrayal by one, Sacha Baron COHEN. The point of this film seems to be subliminal: It is always easier to kill a dehumanized enemy. (Thanks to “Il Bagattel” for this observation.)

Russia, however, has played this chess game masterfully, engineering natural partnerships with China, Iran, the “Stans”, India and numerous organizational groups of nations who have had ENOUGH of NATO-Nazi-style “democracy” and “freedom”, either from the barrel of a gun or as slaves of the Almighty Dollar. (Note: Russia will not allow showings of the highly offensive film, *Borat*. Does this mean Russians are less FREE—or just that someone has sense enough to stop such damaging material from being propagated?)

ENTER THE WISE GUYS

It’s almost Xmas, so it seems entirely appropriate that we should now encounter “the Wise Men”: George H.W. Bush’s “Iraq Study Group” headed up by James Baker. They are referenced as “the Wise Guys” in the caption because Mr. Baker is often referred to as the *consigliere*, a *Cosa Nostra* term.

What are their options? Their own military men are apparently going to prevent them from fully impaling the U.S. military with an attack on Iran which CANNOT succeed, as demonstrated by Israel’s failure to subdue those defiant Hezbollah in Lebanon—not to mention Iran’s recent “war games” demonstration of technical capabilities far in excess of what was expected of them. And if you dare not extend war to Iran, you certainly can’t go head-on with either Russia or China, much less both of them at the same time.

Indeed, what are the options for ones whose only strategy, ever, has been WAR? They are NOT going to be able to turn China or Russia with gobs of “dollars” any more, not now that the world’s economy is based on OIL which is out of their control (ENERGY, actually, and the difference is really very important). Maybe with enough time and a change of approach they could deceive their way past the guards of Iran? “Good luck.”

What has been floated as a trial balloon of sorts is the potential for discussions with Syria and Iran to negotiate an end to “sectarian violence” (which they, themselves have set up) in Iraq. What are the odds that both Tony Blair and George W. Bush would come up with this exact same “idea” at the same moment?

After buying some time with this canard, the real discussions, no doubt (**and this is somewhat confirmed by the last report of “144,000” U.S. troops in Iraq**), will not revolve around making peace but rather, the usefulness of that wildcard country not yet mentioned in this report: **Israel**, the country that was made and put in place quite literally to be destroyed as part of the Money Masters’ Armageddon scenario.

These “Wise Men” are DESPERATE and absolutely RUTHLESS. Think of the Bohemian Grove, where “Care” (**CONSCIENCE**) is sacrificed and know that these ones are the cream of that crop of willfully conscienceless beings. KNOW, further, that the agenda all along has called for massive, planet-wide depopulation and that the Money Masters would be delighted with Armageddon. Do you really think any of these guys would bat an eyelash over nuking the “Green Zone” of Baghdad, if they thought it would advance their agenda?

The “April Revolution” at the Pentagon disclosed by Seymour Hersh seems to be the main reason we have not yet experienced “Armageddon”, as the Joint Chiefs of Staff refused to draw up plans to nuke Iran at that point. It is not, apparently, that either the Money Masters or the NATO-Nazis wouldn’t like to pull the trigger but rather that the gun has, at least for now, been taken from their hands. THANK GOD!

And while you’re at it, thank God that the Russians are distinctly more CHRISTian in orientation than their Judeo-Xtian counterparts. (Xtians are “sort of” like Christians, at least that is what they call themselves, but leave out the “Christ” and replace it with “X”, as in “Xmas”; “X”, in numerology, being a “6”).

The PRESSURE on the situation is enormous.

A few weeks ago there were Internet reports of “molasses in the hydraulics” of an Air Force One helicopter. There were mechanical problems with Air Force One as it set down with President Bush aboard for the APEC meeting in Hanoi. Somehow, a purse thief got past the Secret Service and stole one of the Bush twin’s cell phones and purse. Somehow, a

Secret Service agent guarding her was injured. And somehow, Greg Pitts, the guy who handles travel for the White House also got beat up in Waikiki on his way home from APEC and lost HIS cell phone (and its bound-to-be-interesting numbers).

Mr. Putin is also being pressured. Someone murdered Anna Politkovskaya, a journalist who had been openly critical of Putin’s policies. Then someone took out former FSB spy and Putin critic Litvinenko. In this latter case, however, the answer to *cui bono* points to none other than Boris Berezovsky (formerly Abramovich), who is hiding out in England to evade charges from Russia of plotting to take down the Russian government by force. The situation in Georgia involving the breakaway republic of Ossetia was exacerbated when the Georgian government surrounded a building with Russian soldiers in it. Ukraine, as pointed out previously in this article, has tried to derail Russian agreements with France and Germany.

You might recall that President Ahmadinejad of Iran attended a brief meeting with the Council on Foreign Relations while he was in New York for the United Nations’ summit. Apparently that was quite an interesting session as it is said that Mr. Ahmadinejad let them know “what side of the bread the butter is on”—i.e., that God (by any name, please) was on his side and NOT backing them. In a recent statement, the leader of Iran is credited with saying that the whole World “is getting Ahmadinejadized”. There are, however, a few notable holdouts: the United Kingdom, including Canada, Australia, New Zealand and the rest of the Commonwealth countries; the United States; and, of course, ISRAEL.

Back to Russia and America: On the heels of the CFR being put in its place by the leader of Iran, the Money Masters and the NATO Nazis found themselves getting a “reality check” from Mr. Putin’s former Chief of Staff, Alexander Voloshin, who had his own meeting with the “Money Masters” in the form of the Carnegie Endowment people and numerous political heavyweights.

Kommersant’s Dmitry Sidorov reported on November 3 (excerpts only, emphasis added):

... Alexander Voloshin ... held eight meetings with high-placed officials of the Bush administration in two days and spoke at an invitation-only dinner at the Carnegie Center. ... [H]is presence in the U.S. is evidence of a **serious crisis in Russian-American relations**.

... [T]here were about 20 people present, including the former ambassadors to Russia and Ukraine Jim Collins and Steven Pifer. Fiona Hill, who was recently named CIA national intelligence officer for Russia, was also at that meeting.

... Voloshin’s close ties with the current Russian administration made it easy for the Carnegie Center to arrange meetings between him and White House officials. **Practically no one refused to see him**.

U.S. Secretary of State sent Undersecretary for Political Affairs Nicholas Burn and Assistant Secretary of State Daniel Fried in her place with apologies for her busy schedule. Presidential national security advisor Stephen Hadley sent his assistant J.D. Crouch to meet with Voloshin after he was called to Iraq urgently. U.S. Trade Representative Susan Schwab also insisted on a meeting with the one-time “gray cardinal of the Kremlin”.

Sources say that Crouch wanted to find out whom in Moscow it was possible to have a normal conversation with ...

Voloshin was more than an hour late for his meeting with Schwab. Burns and Fried were responsible for that, as was Voloshin’s cellular

phone, which was lost and subsequently found in Fried’s office. **[ANOTHER lost cell phone? Hmmm....]** Fried was interested in discussing the Russian-Georgian conflict with Voloshin.

... At almost all his meetings in Washington, **Voloshin emphasized the U.S.’s debt to Russia**, which partially explains the poor relations between the countries at present. “We make claims over bilateral relations, and they make claims against us about internal affairs,” Voloshin commented to Kommersant. He added that **“the American political elite got very drunk at the funeral for the USSR and still has a hangover.”**

... Voloshin’s visit is already evidence of a crisis in Russian-American relations. *Kommersant* sources comment that the great demand for Voloshin’s time was caused by the absence of real contacts between Moscow and Washington. Effective working contacts and information exchanges on the level of the presidential administration, which existed several years ago, have been severed. One person commented that “Voloshin is a unwitting political tourist because, **except for meetings between Bush and Putin, there is no effective ties between the White House and Kremlin.**”

At this point, another unusual meeting should be noted: the Chairman of the Joint Chiefs of Staff, General Pace, found himself making an impromptu visit to Moscow on October 30. With the U.S. fleet in the Persian Gulf in force, Israel posturing as if it will “go it alone” in attacking Iran and drawing on U.S. support, and the Wise Guys scratching their heads—we imagine General Pace got an earful in discussions with his counterparts in Russia.

How much longer should the hand holding the sickle be stayed? God only knows, while very few Americans have any inkling and most Judeo-Xtians are simply counting down the days to Xmas and checking for any sign of increased credit limits on their card statements.

By now many Americans have become aware of the recent sag in housing prices. Conditioned by decades of non-stop gains punctuated only by brief setbacks, it is understandable that they don't understand the real significance of a downturn in home prices at this juncture.

LEVERAGE WORKS BOTH WAYS

It's all about the leverage. You see, when someone signs for a \$300,000 mortgage, their signature on that debt has just "created" that much more money in the system but multiplied many times over by the fractional reserve banking system. At a 10% reserve ratio, that \$300,000 becomes \$3 MILLION of new "money" in the system. Eliminating a \$300,000 mortgage has exactly the same effect—in reverse—eliminating \$3 million from the system.

So many properties are now at a point of ZERO to NEGATIVE EQUITY that there is nothing to fall back on and when things start to snowball in this direction, there is no way to stop the slide. That is because someone who has defaulted on a mortgage is no longer creditworthy; they have been eliminated from the pool of potentially creditworthy "customers".

As Edgar Steele points out, there are going to be some very irritated American Dreamers—and that is the main reason for all of those new internment facilities.

To put some numbers on all of this, we turn to a comprehensively researched piece dated November 22 by blogger Mike Whitney, which he called "Housing Bubble Smack-Down" (excerpts only, emphasis added):

... In 2000 the total value of homes in the U.S. was \$11.4 trillion. Today that number has shot up to \$20.3 trillion; nearly double. ... [M]ortgage-debt in 2000 was ... \$4.8 trillion ... while in 2006 it skyrocketed to a whopping \$9.3 trillion.

... The housing bubble ... is the predictable result of dramatically increasing the money supply while expanding personal debt via home-mortgages.

... [The Federal Reserve] doubled the money supply and then sat back and watched while \$4.5 trillion went directly into the real estate market via mortgage loans to people who were "under-qualified" (knowing that these same people would eventually fail to meet their payments and adversely effect the entire market).

The Federal Reserve knew all of this. In fact, they knew where every dime was going, but decided to persist in their swindle to the bitter end.

Have the real effects of this monster-bubble been softened by the huge trade deficit?

Yes, because America currently borrows \$800 billion a year from China, Japan etc. which keeps the economy sputtering along while our manufacturing sector continues to be ransacked.

The \$800 billion account deficit is like a sedative which lulls us to sleep while the country is looted right in front of our eyes. For example, in the last 12 years, foreign ownership of U.S. assets has soared from \$3 trillion to over \$12 trillion (400%). At the same time, over 13,000 major U.S. companies have been sold to foreign corporations since 1980.

... Americans borrowed another \$825 billion from their home equity in the last 12 months (to spend on house repairs, shopping, boats etc) and ... without that consumer spending the nation's growth rate (GDP) will shrivel to nothing ...

So, what does this mean for the homeowner whose future depends on the steady increase in his home equity? What can he expect?

Well, first of all, you can ignore all the gibberish you hear on the business channel about "soft landings" and a "temporary downturn".

There'll be no soft landings. This is the Big One; Real Estate Armageddon followed by a plague of locusts.

JUST LOOK AT THE NUMBERS! There's a \$10 trillion difference between the aggregate in 2000 and 2006! \$4.5 trillion of that is new mortgage-debt!

That's more than a little "froth" as Greenspan likes to say. In an economy that's currently growing at a feeble 1.6%, a plummeting housing market could pave the way for another (dare I say it) Great Depression.

\$10 trillion!?! Some things are worth repeating.

First of all, (if we compare our situation to what happened in Japan during the 1990s) we can expect that prices will continue to fall for years to come, perhaps, a decade or more. Many of the slower markets are already showing a decline of 10% to 20%. This is a trend that is likely to speed up dramatically in 2007 when \$1 trillion in ARMs reset. That's when we'll begin to see a truly new phenomenon in the U.S., that is, people who've always been solid members of the middle class sliding downwards into the ranks of the working poor.

... Imagine paying off a loan for \$400,000 when your house has been reassessed at \$250,000 or \$300,000; that'll be the reality for an estimated 30 million Americans. Meanwhile, inventory will continue to grow (already at an 8 month backlog) the economy will continue to contract, and the dollar will continue to weaken. (Many of the major home builders; Centex, Beazer and Toll Bros, are reporting that profits are down by nearly 65%.)

At the same time the Fed just issued another \$10 billion in Treasury Bonds last week raising the national debt to a mind-boggling \$8.6 trillion. This loosey-goosey approach to printing fiat money and creating debt explains the recent surge in the markets. As *The Daily Reckoning's* Richard Daughty says, the "bull market is manufactured from rampant government deficit-spending and financed by the Federal Reserve creating the money."

... Daughty also notes that "revolving credit like credit card loans grew by \$2.85 billion, or at an annual rate of 4.00%, to \$857 billion."

So, credit card debt is going up, which is an indication that the people who were siphoning money from their home equity have switched over to plastic. That's a sure sign the writhing consumer-beast is in its last throes. The end is near.

Why should I care about Net Long-term Capital Inflows?

In another bit of disheartening news the net long-term capital inflows fell short of what the U.S. needs to cover the current account deficit. The inflows were only \$65 billion when we need \$70 billion to make ends meet. This is another way of saying that **foreigners are no longer mopping up our red ink**. Interestingly, foreign central banks are buying considerably fewer Treasuries; \$9 billion in U.S. securities and a paltry \$8 billion in Treasury bonds.

What does it mean? It means that **no [nation] is dim-witted enough to buy our debt anymore because we're no longer a good risk**.

... Also, according to *Marketwatch*, "U.S. residents purchased a net \$22.9 billion in foreign securities, up from \$2.7 billion in August. Foreign holdings of dollar-denominated short-term securities, including Treasury bills, fell by

\$10.8 billion.”

Foreign investments are up \$20 billion in one month?!? Are you kidding me?

So, the smart money is getting out of Dodge pronto; leaving the rest of us behind in a leaky canoe.

... So, what was the “Grand Plan” the Fed had in mind when they decided to anesthetize the American public with low interest rates and flood the planet with worthless green scrip?

Did they think that Bush would corner the oil market and, thus, force the rest of the world to take our anemic greenbacks? ...

[RK: THAT IS EXACTLY WHAT THE PLAN WAS. NOW PLAN “B” COMES INTO EFFECT AND THERE ARE GOING TO BE SOME VERY GRUMPY SOMNAMBULISTS AWAKENING TO A NEW REALITY, WHETHER HERE OR “KINGDOM COME”.]

Final Warning: Part 10b

We continue with our serialization of David Allen Rivera’s Final Warning: A History of the New World Order offering our great appreciation for his research and documentation.

If you never knew what really happened at the “original” Pearl Harbor, how can you understand the lack of conscience involved in, say, 9/11? The controlling elite have to work very hard to get people involved with their wars and very often it is through playing upon our OUTRAGE, while the truly outrageous behavior is theirs but hidden from view.

THE DECEPTION OF PEARL HARBOR

In the Pacific Theater, the stirrings of World War II actually began years before. China had allowed Japan to drill for oil in several provinces because Standard Oil’s price for kerosene was too high. Through contacts in the Chinese government, Standard Oil had been able to keep anyone from drilling until the Japanese came and developed huge fields. Standard Oil pushed them out but the Japanese vowed to return, even going as far as saying that they would seize China to recover their oil investments.

When the Japanese invaded China in the 1930s, one of their first acts was to destroy Standard Oil property because they had been responsible for their ouster.

In 1931, Henry L. Stimson, the Secretary of State (a Rockefeller lawyer and agent) met with President Herbert Hoover, on behalf of the Illuminati to make a deal. The international bankers promised to end the Depression if Hoover would declare war on Japan and send in the military to protect Standard Oil property. Even though Hoover accommodated the bankers in many cases, this was one deal that he refused.

So Stimson pitched the idea to Governor Franklin Delano Roosevelt *[RK: A descendant of Claes ROSENVELT (Jewish), often referred to only slightly incorrectly as ‘Rosenfeld’ and as confirmation of his lineage, his mother, Sarah Delano, was also of Jewish origins]* (who has a dozen U. S. Presidents in his family tree) *[RK: INCLUDING COUSIN GEORGE H.W. BUSH AND HIS SON, GEORGE W. BUSH, ALL MEMBERS OF THE HABSBURG ROYAL FAMILY]*, who was indebted to them because of his philanthropic operation at Georgia’s Warm Springs.

Roosevelt was born at Hyde Park, New York in 1882. He graduated from Harvard, received a law degree from Columbia Law School and in 1910 was elected to the New York State Senate (re-elected in 1912). He was appointed Assistant Secretary of the Navy by Wilson in 1913 on orders from Col. House. According to House biographer Arthur D. Howden Smith, Col. House “picked Roosevelt as a natural candidate for the Presidency long before any other responsible politician”. In the 1920 Presidential election, Roosevelt was James Cox’s running mate but the Democratic team suffered from the mistakes of the Wilson Administration and lost miserably to the Harding-Coolidge ticket. Roosevelt later became a two-term governor of New York. After the 1932 Democratic convention in Chicago, where Roosevelt became the Party’s nominee, he met with Col. House at his Massachusetts home. House told another biographer, Charles Seymour, in 1938: “I was close to the movement that nominated Roosevelt ... He has given me a free hand in advising (Secretary of

State, Cordell) Hull. All the Ambassadors have reported to me frequently.”

The Illuminati put all their political power behind Roosevelt to get him elected and in 1940, Roosevelt appointed Stimson (a CFR member) to the post of Secretary of War, even though he was a Republican. House, who was 75 years old, didn’t become Roosevelt’s ‘alter ego’. That role was filled by another Wilson advisor, Bernard Baruch, who became the liaison between Roosevelt and the bankers. FDR’s uncle, Frederic Delano, was a member of the Federal Reserve Board, and in 1925, became the Chairman of the League of Nations Committee. In 1934, he was appointed as Chairman of the National Resources Planning Board and in 1936, became Chairman of the Federal Reserve Bank in Richmond, Virginia.

Roosevelt was a 32nd degree Mason, a Knight Templar, and a member of the Shrine. He is a direct descendent of socialist Clinton B. Roosevelt, the New York assemblyman who wrote *The Science of Government Founded in Natural Law*, where he revealed a plan for world government. Clinton Roosevelt and Horace Greeley (founder and owner of the *New York Tribune* and *New Yorker* magazine) were the pioneers of social engineering research. In the February 1953 edition of the *Empire State Mason*, the official publication of the Grand Lodge of New York, the claim was made that **if one-world government ever came about, FDR [RK: or his cousin, George H.W. Bush, as it turns out] should get much of the credit.**

In 1932, Major General Smedley Butler of the U.S. Marine Corps was approached by Grayson Mallet-Provost Murphy (a director of Guaranty Trust), Robert S. Clark (a banker who inherited a fortune from the founder of the Singer Sewing Machine Co.), and John W. Davis (a 1924 Presidential candidate, who was an attorney for J. P. Morgan) with a plan to lead a revolution to overthrow the government and establish a Fascist dictatorship. Butler was to “seize the White House with a private army (of 500,000 veterans), hold Franklin Roosevelt prisoner and get rid of him if he refused to serve as their puppet in a dictatorship they planned to impose and control.” Butler chose to expose the plot rather than lead it, supposedly because of his patriotism. Or was it because he recognized their true aim, which was for Roosevelt to impose a dictatorship during a national emergency, so the government could take complete control. Butler is on record as having said: **“War was largely a matter of money. Bankers lend money to foreign countries and when they cannot repay, the President sends Marines to get it.”**

When the planned revolt didn’t materialize, other plans were developed. Frances Perkins, Secretary of Labor, reported: “At the first meeting of the Cabinet after the President took office in 1933, the financier and advisor to Roosevelt, Bernard Baruch, and Baruch’s friend, General Hugh Johnson, who was to become the head of the National Recovery Administration, came in with a copy of a book by Gentile, the Italian Fascist theoretician, for each member of the Cabinet, and we all read it with care.” **Future plans called for the government to be moved towards Fascism and government control without a revolution.** They decided that the best method was through war and Jim Farley, Roosevelt’s Postmaster General, said that during the second Cabinet meeting in 1933: “The new President again turned to the possibility of war in Japan.” Gen. Johnson wrote: “I know of no well informed

Washington observer who isn’t convinced that, if Mr. Roosevelt is elected (in 1940), he will drag us into war at the first opportunity, and that, if none presents itself, he will make one.”

Roosevelt wanted Japan to withdraw, not only from Indo-China, but also China (Manchuria). To enforce his demands, he froze all Japanese assets in this country and cancelled a 1911 commercial treaty. He had their fuel supplies cut and placed an embargo on 11 raw materials which were necessary for their military. In December 1939, this was extended to light steel. In England, Winston Churchill, and later the Dutch government, followed suit. Former President Herbert Hoover observed the various political manipulations and said in August 1941: “The American people should insistently demand that Congress put a stop to step-by-step projection of the United States into undeclared war...”

On September 28, 1940, Japan, Germany and Italy signed the *Tripartite Treaty*, which declared that if any of the three were attacked, all three had to respond. So if Japan attacked the U.S. and the U.S. would declare war against Japan, they would also be at war with Germany and Italy.

In October 1940, part of FDR’s strategy to push Japan into committing an overt act of war was to move America’s Pacific fleet out of California and have it anchored at Pearl Harbor. Admiral James Richardson, the commander of the Pacific Fleet, expressed to Roosevelt his strong opposition to putting the fleet in harm’s way. He was relieved of his command. **Richardson later quoted Roosevelt as saying: “Sooner or later the Japanese will commit an overt act against the United States and the nation will be willing to enter the war.”**

Roosevelt and Churchill had already been working on a plan to get America to enter the war in Europe. After the German ship *Bismarck* sank the British ship, known as the *Hood*, Churchill suggested in April 1941 “that an American warship should find the *Prinz Eugen* (the *Bismarck*’s escort ship) then draw her fire, ‘thus providing the incident for which the United States would be so thankful’ i.e., bring her into war.” While Roosevelt planned for such a provocation in the Atlantic, Hitler told his naval commanders in July 1941 to avoid confrontation with the United States while his Russian campaign was in progress.

Joseph C. Grew used his post as the U.S. Ambassador to Japan to encourage the Japanese to enter a state of military preparedness. They were shipped steel scrap from the entire 6th Avenue Elevator Railroad of New York. The Institute of Pacific Relations, through a \$2 million grant, funded communist spies who were to help induce the Japanese to strike back at the United States.

Since then, it has become common knowledge that the attack was not the surprise it was claimed to be. On January 27, 1941, Grew sent a telegram to the Secretary of State to report the following: “The Peruvian minister has informed a member of my staff that he heard from many sources, including a Japanese source, that, in the event of trouble breaking out between the United States and Japan, the Japanese intended to make a surprise attack against Pearl Harbor.” (Source: U.S., Department of State, Publication 1983, *Peace and War: United States Foreign Policy, 1931-1941*, Washington, D.C.: U.S., Government Printing Office, 1943, pp. 617-618)

In August 1941, Congressman Martin Dies, Chairman of the House Committee on Un-American Activities, collected evidence that the Japanese were planning to attack Pearl Harbor. The Committee was in possession of a strategic map prepared by the Japanese Imperial Military Intelligence Department that clearly indicated their plans to attack Pearl

Harbor. Dies was told not to go public with his information. An Army Intelligence officer in the Far East discovered the plan for the Pearl Harbor attack and prior to the attack sent three separate messages to Washington detailing the plan.

Soviet agent Richard Sorge told the Russian Government in October, 1941 that “the Japanese intend to attack Pearl Harbor in the next 60 days,” and received a response from his superiors that the information had been passed onto President Roosevelt. Dusko Popov, a British double agent, received information from Germany about Japan’s plans and passed the information onto Washington. It was never acted on.

As early as 1944, Presidential candidate, New York Governor Thomas E. Dewey, said that Roosevelt knew about the attack on Pearl Harbor before it happened. In documents declassified by the National Security Agency in 1981, America had broken the Blue (diplomatic) and Purple (naval) secret codes of the Japanese, knew all the details of the attack and the

whereabouts of the Japanese fleet. **From September 1941 until the attack itself, all Japanese communications had been intercepted and decoded by American intelligence and indicated an impending attack on Pearl Harbor.**

One transmission, from a fake weather report broadcast on a Japanese short-wave station, contained the words “*higashi no kaze ame*”, which means “east wind, rain”, which the Americans already knew was the Japanese code for war with the United States. Top military officials denied that the “winds” message existed and attempted to destroy all traces of its receipt.

Late in November 1941, the following order was sent out to all U.S. military commanders: “The United States desires that Japan commit the first overt act.” According to Secretary of War Stimson, this order came directly from Roosevelt. According to Stimson’s diary, 9 people in the war cabinet, all the military people, knew about FDR’s plan of provocation.

The State Department knew on November 20th that a naval force, which included four of the largest Japanese aircraft carriers, was heading towards Hawaii and this information was passed on to Pearl Harbor on November 27th. However, the American base in Hawaii was not given this information. Three days before the attack, Australian Intelligence spotted the Japanese fleet heading for Hawaii. They sent a warning to Washington but it was dismissed by Roosevelt who said it was a politically motivated rumor circulated by the Republicans.

On December 1, 1941, the head of the Far East Division of U.S. Naval Intelligence wrote in his report to head of the Pacific Fleet: “War between the United States and Japan will begin in the nearest future.” The Report never made it to the commander’s desk because it had been ‘accidentally’ detained by his superiors. Early in December, Army Intelligence knew that the diplomats at the Japanese Embassy in Washington had been ordered to destroy all codes and to return to Japan. Washington also knew that Japan had ordered all of its merchant ships home because they would be needed to transport soldiers and supplies for the war. On December 5, Col. Sadtler from U.S. Military Communications transmitted the following telegram to his superiors,

based on information he had received: “War with Japan will begin immediately; exclude all possibility of a second Port Arthur.” This telegram never got to its destination.

In 1932, the U.S. Navy had conducted tests at Pearl Harbor which indicated that it was vulnerable to an attack from sixty miles away without being able to detect it. Admiral J. O. Richardson, Commander-in-Chief of the Pacific fleet, wanted the fleet withdrawn to the west coast of the United States because they were inadequately manned for war and because the area was too exposed. It was not done. In January 1941, Richardson was relieved of his command. It was later revealed that Roosevelt wanted him to create a naval blockade around Japan, to provoke them into a response, so the United States could declare war. He refused to do it, saying it was an act of war.

Besides knowing about the security weaknesses at the base in Pearl Harbor and having previous knowledge about the impending attack, **Roosevelt guaranteed a slaughter by ordering that the planes be grouped in circles, with their propellers facing inward**, because he claimed that he wanted to protect them against ‘acts of sabotage’. Rear Admiral Robert A. Theobold, USN, Retired, author of *The Final Secret of Pearl Harbor*, and Col. Curtis B. Dall, the son-in-law of FDR, in an interview with Anthony Hilder for his book *Warlords of Washington*,

admitted that they knew about the Pearl Harbor attack before it occurred. **Theobold, the Commander of all the destroyers at Pearl Harbor, said in his book that Roosevelt knew about the attack 21 hours before it happened.** So the result of this positioning of the aircraft made it difficult for them to get out of the circle and up in the air because they didn’t have a reverse gear. Theobold wrote: “An incontestable fact in the true history of Pearl Harbor is the repeated withholding from Admiral Kimmel and General Walter C. Short (Navy and Army Command in Pearl Harbor) of supremely important military information ... There’s never been a case in history when a commander was not informed that his country will be at war within a few hours and that his forces will most likely become the first object of attack at sunrise.”

Theobold also cited the testimony of Admiral Harold Stark (head of Navy Headquarters in Washington) who did not reveal Japan’s *de facto* declaration of war to Admiral Kimmel and said he was acting on orders from a “higher authority”, referring to Roosevelt, because Marshall did not outrank Stark. Marshall merely passed on the Roosevelt directive of December 4th, which said that no communications could be sent to Pearl Harbor unless it was cleared by Marshall.

On November 26, 1941, Roosevelt had sent an ultimatum, insisting that the Japanese withdraw all their troops. He refused any negotiations with Prince Konoye, the Japanese Prime Minister, even though Joseph Grew (CFR member, and Rockefeller agent), the Ambassador to Japan, said that such a meeting would prevent war with the Japanese. The Japanese response from Tokyo to the Japanese embassy, encrypted in the “purple code”, was intercepted by the Navy, decoded and given to Roosevelt on the evening of December 6th. The thirteen-point communiqué revealed that because of the intense pressure of the economic sanctions diplomatic relations with the United States were being terminated at 1:00 PM Eastern time on Sunday, December 7th. For all intents and purposes, this was a declaration of war and upon reading it, Roosevelt said: “This means war.” It was not passed onto Pearl Harbor command and it was at that time that the attack began.

While FDR was pushing Japan into drawing first

blood, he told the American public in his famous campaign statement of 1940: “While I am talking to you mothers and fathers, I give you one more assurance. I have said this before and I shall say it again and again and again: Your boys are not going to be sent into any foreign wars.” *[RK: Does anyone yet recall cousin George H.W. Bush’s “Read my lips” statement? It runs in the family: These guys have no problem whatsoever making barefaced lies.]* Then he said later that he wouldn’t send our boys to war unless we were attacked.

Lieutenant Commander Arthur McCollum worked for Naval Intelligence in Washington and was the communications routing officer for FDR. All the intercepted Japanese messages would go to McCollum, who would then route them to Roosevelt. In October 1940, he wrote a memo which contained the basis for FDR’s plan for provoking the Japanese into attacking at Pearl Harbor. It was given to two of Roosevelt’s closest advisors. The memorandum revealed his sentiments that it was inevitable that Japan and America were going to war and that Germany was going to be a threat to America’s security.

He said that America had to go to war but he also understood that public opinion was against that. So public opinion had to be swayed and Japan had to be provoked into attacking America. He named eight specific suggestions for things that America should do to make Japan more hostile towards us, ultimately pushing them into attacking us. That would rally the country behind the war effort. Because he was born and raised in Japan, he said that he understood the Japanese mentality and knew how they would react. This included moving the Pacific fleet to Hawaii and decimating Japan’s economy with an embargo. McCollum said: “If you adopt these policies then Japan will commit an overt act of war.” Although there is no proof that FDR actually saw this memo, he ended up implementing all eight of McCollum’s points.

The Administration discovered that in 1941 a Japanese naval officer was working at the Japanese consulate in Honolulu under an assumed name. They followed him and began to intercept his messages to Japan, which enabled the Japanese to develop a timetable for the attack and even bomb plots. They never stopped him and it enabled the Japanese to prepare themselves for an attack against us.

Fleet Admiral Halsey wrote: “Our intelligence data spoke of a likely attack by Japan on the Philippines or the Dutch East Indies. Although Pearl Harbor wasn’t excluded from discussion, everything relayed to us pointed to other objects of attack. If we had known that the Japanese were continually collecting detailed information about the exact location and movements of our warships in Pearl Harbor (which is made clear by intercepted reports), we naturally would have concentrated our efforts on preparations to repel an attack on Pearl Harbor.”

Secretary of War Henry L. Stimson, after meeting with the Roosevelt administration on November 25, 1941, wrote in his diary: “The discussion was about how we should maneuver to force the Japanese to fire the first shot, while not exposing ourselves to too great a danger; this will be a difficult task.”

Admiral Husband E. Kimmel wrote in his memoirs: “It was part of Roosevelt’s plan that no warning be sent to the Hawaiian Islands. Our leaders in Washington, who deliberately didn’t inform our forces in Pearl Harbor, cannot be justified in any way. The Pearl Harbor Command wasn’t informed at all about ... the American note of November 26, 1941 delivered to the Japanese ambassador, which practically excluded further negotiations and made war in the Pacific inevitable. **The Army and Navy**

Command in the Hawaiian Islands received not even a hint about intercepted and deciphered Japanese telegrams which were forwarded to concerned parties in Washington on the 6th and 7th of December, 1941.”

The Pacific fleet had consisted of nine battleships, three aircraft cruisers and some smaller ships. The aircraft carriers and the smaller, more mobile ships were moved prior to the attack because Roosevelt knew they would be needed for a war at sea. On November 28th Fleet Admiral William F. Halsey (under Kimmel’s command) sailed to Wake Island with the carrier *Enterprise*, three heavy destroyers and nine small destroyers; and on December 5th, the *Lexington*, three heavy cruisers and five destroyers were sent to Midway and the *Saratoga* went to the Pacific Coast. The other battleships were considered dispensable because they had been produced during and prior to World War I and were viewed as old and obsolete. They were to be sacrificed.

On December 7, 1941, the Japanese attacked the U.S. fleet at Pearl Harbor, instead of attacking Russia, as they originally intended to do. The ‘sneak attack’ gave Roosevelt a reason to direct the full force of America’s military might against Japan. The next day, Roosevelt asked Congress to declare war on Japan: “We don’t like it—and we didn’t want to get in it—but we are in it and we’re going to fight it with everything we’ve got.” On January 1, 1942, the 25 allied nations who went to war against Germany and Japan signed a “Declaration by the United Nations”, which indicated that no one nation would sign a separate armistice, and Gen. Douglas MacArthur was appointed as the ‘United Nations Commander of the South Pacific’, becoming the Commander-in-Chief of all armed forces in the Pacific Theater.

The attack on Pearl Harbor resulted in the deaths of 2,341 American soldiers and 2,233 more were injured or missing. Eighteen ships, including eight battleships, two destroyers, two squadron minesweepers, were sunk or heavily damaged; and 177 planes were destroyed. All of this, just to create an anti-Japanese sentiment in the country and justify American action against Japan.

General George C. Marshall (Supreme Commander of the U.S. Army) and Admiral Harold R. Stark (Supreme Commander of the U.S. Navy) in Washington testified that the message about the attack was not forwarded to Kimmel and Short because the Hawaiian base had received so many intercepted Japanese messages that another one would have confused them. In truth, Marshall sat on the information for 15 hours because he didn’t want anything to interfere with attack. The message was sent after the attack started. Internal Army and Navy inquiries in 1944 found Kimmel and Short derelict of duty but the truth was not revealed to the public.

Two weeks before the attack, on November 23rd, Kimmel had sent nearly 100 warships from the Pacific fleet to, what turned out to be, the exact location where Japan planned to launch their attack. Unquestionably, he was looking to prevent the possibility of a sneak attack. When the Administration learned of his actions, he was criticized for “complicating the situation”.

Eleven days after the attack, the Roberts Commission, headed by Supreme Court Justice Owen Roberts, made scapegoats of Kimmel and Short, who were denied open hearings, publicly ruined and forced to retire. Short died in 1949 and Kimmel died in 1968.

The most incredible of the eight investigations was a joint House-Senate investigation that echoed the Roberts Commission. Both Marshall and Stark testified that they couldn’t remember where they were

the night the declaration of war had come in. *[RK: SURE thing. Just like GHWB couldn’t remember where he was when JFK (his rival from the Cavendish Royal Family line) was taken out.]* A close friend of Frank Knox, Secretary of the Navy, later said that Knox, Stark and Marshall spent most of that night with Roosevelt in the White House, waiting for the bombing to begin, so they could enter the war.

According to historian John Toland, Marshall told his top officers: “Gentlemen, this goes to the grave with us.”

In 1995, a Department of Defense study concluded that “Army and Navy officials in Washington were privy to intercepted Japanese diplomatic communications ... which provided crucial confirmation of the imminence of war.”

The full extent of the deception came to the forefront with the publishing of the book *Day of Deceit: The Truth About FDR and Pearl Harbor* by Robert B. Stinnett, a retired *Oakland Tribune* photographer who served in the Pacific during World War II. After retirement, he began his investigation by interviewing former American military communications personnel and filing *Freedom of Information* requests with the National Security Agency. For 17 years he gleaned through volumes of previously classified messages which had been intercepted from the Japanese.

Stinnett discovered that on **November 25, 1941, Japan’s Admiral Yamamoto dispatched a radio message to the group of warships that would be used to attack Pearl Harbor. It read, in part: “... the task force, keeping its movements strictly secret and maintaining close guard against submarines and aircraft, shall advance into Hawaiian waters, and upon the very opening of hostilities shall attack the main force of the United States fleet in Hawaii and deal it a mortal blow.” From November 17th to 25th, the U.S. Navy intercepted 83 messages that Yamamoto sent to his carriers.**

This Pearl Harbor scenario was a repeat of the American battleship *Maine*, which was ‘sunk’ by a Spanish mine in the port of Havana in 1898. The rallying cry of “Remember the *Maine*” was used to stir up anti-Spanish hysteria in America to justify us declaring war on Spain. Years later, when the ship was examined, it was established that the hull had been blown out by an explosion from inside the ship.

So what did World War II accomplish for the Illuminati? With the Japanese prepared to surrender in February 1945, the war was prolonged in order to destroy much of the industrial areas of Japan with a devastating air attack of incendiary atomic bombs. This allowed the ground to be cleared for the Illuminati to rebuild Japan with new industries so they could use cheap labor to flood the American market with cheaply manufactured goods. This would turn the United States into a nation that consumed more than it produced, creating unemployment and financial instability.

As stated previously, on the European front, the War enabled the Russians to gain control of Eastern Europe, promoted Communism, paved the way for the United Nations **and the creation of the nation of Israel.** *[RK: “Mission Accomplished”!?!]*

At a cost of about \$400 billion, the War raised our National Debt to \$220 billion and pushed us deeper into the clutches of the Illuminati’s international bankers. Because of all the intricate angles involved in this conflict, it would not be an understatement to say that World War II was probably the most costly event in American history. We may have won, but, in the long run, we lost.

CHAPTER 18

ALL THAT GLITTERS...IS GOLD?

Just how much gold are we really talking about here? No one knows exactly. But Hilarion (Larry) Henares, the National Economic Adviser of the Macapagal Administration has given us something slightly better than a ballpark figure.

“At the time I was appointed Chairman of the Gold Commission, I inspected three sites in Metro Manila where the gold was stored. The highest authority told me that the total gold amounted to 400,000 metric tons. One metric ton of gold is equal to 32,151 troy ounces and is worth (at \$400 per troy ounce) \$12,860,400. Multiply 400,000 tons of gold, we get \$5,144,160,000,000 or more than \$5 trillion.” These figures, which appeared in Henares’ regular *Inquirer* column (“Make My Day”), have probably reached the \$15 trillion mark, interest included and compounded.

“This gold can transform this country into a prosperous, industrialized and powerful nation, with the right kind of leaders,” Henares added. “But I do not trust the Cory Government, I do not trust her economic advisers, the Council of Trent, who will only steal the gold for themselves. I do not trust the Americans who need our gold to save their floundering economy.”

Henares’ bold but frank statement was in response to the Reagan Proposal of “transferring the gold bullions to the U.S. Federal Reserve Bank in exchange for U.S. Treasury Bills”, which, as Henares correctly surmised, will push us further at the mercy of Uncle Sam. Instead, Henares proposed the establishment of an International Gold Bank & Trust in Manila, which will issue gold drafts for international payments, so that Third World countries can affiliate with this bank, granting them loans at concessional rates of interest, “unlike the IMF and its clique of international pirates”.

Henares, of course, was justified in not trusting the “government of denials”. According to dossiers captured by the Reform the Armed Forces movement during the December 1989 coup attempt, copies of which were furnished several people like myself, and several hard-hitting newspapers like the *We Forum*, the Aquino Administration, indeed, set up a top-secret organization to recover the remaining gold bullion allegedly left behind by Marcos.

Despite the people’s indignation triggered by the death of two workers at the site of the gold digging and the vociferous desecration of the Fort Santiago site itself, a national shrine, the Aquino Government continued with its gold-retrieval project and had further intensified its operations “tapping the resources and facilities of Channel 4, a government-controlled TV station in Quezon City, which was besieged by rebel soldiers in the latest coup attempt”, wrote Joe Burgos, *We Forum*’s fearless publisher.

At the height of the last coup attempt, everyone expected Colonel Red Kapunan’s RAM troops to use the broadcast facilities of Channel 4, which they had easily captured. It turned out that the rebels had another mission—to seize certain highly classified documents on the Marcos gold stored inside the PTV-

Channel 4 compound. Burgos wrote that a *We Forum* correspondent who was with the raiders divulged [that] the documents retrieved from hidden cabinets in an office on the third floor of the station’s main building showed how Marcos, in connivance with certain Central Bank officials and other individuals in and out of government, shipped out gold bars from the Philippines to several points around the world—China, Malaysia, Singapore, Indonesia, Hong Kong, Japan, the United States and Europe.

Also included was a document addressed to President Aquino indicating specific banks abroad where the former strongman and his trustees had deposited gold bars “valued at \$375 billion”. It also revealed actual transactions of gold from Manila to Europe and other places. (See Chapters X & XI.)

Was there any gold retrieved by the Aquino Administration?

“After almost seven months of digging, National Security Adviser Emmanuel Soriano sought an extension of the excavation in Fort Santiago, claiming the location of six vaults of gold bars, six drums of coins and jewels, which came from other Asian nations, and other hidden treasures, estimated at \$1.7 billion had been pinpointed and would be unearthed within two to four months,” Burgos stated. But nothing was ever declared to have been retrieved.

“There are rumors that the diggers were able to unearth the P13 billion worth of gold which they spirited away at night,” said Burgos. “These are mere rumors.”

However, what was significantly omitted and left untold was who actually led the 1989 *coup d’etat* against the Aquino Government. Principally, it was led by Colonel Red Kapunan, and not by Colonel Gringo Honasan, as earlier presumed.

Another untold story which yet awaits unfolding was the actual reason behind the yellow Army’s and the pro-Cory forces’ rush and haste to recover the Channel 4 complex as soon as possible.

A report by Craig Nelson (see Chapter XV) included the loot recovered at the Napindan channel. The loot was moved in time for the military exercise of then National Capital Region Defense Command Chief, General Rodolfo Biazon, which the JUSMAG office in Quezon City was transferred to Roxas Blvd. at the U.S. Embassy Seafront area. This was why all roads leading to Channel 4 then had been barricaded for quite some time. The gold and the pertinent documents were also the driving force behind the persuasion flight of the U.S. Phantom jet, upon orders of the Trilateral Commission, through then Vice President Dan Quayle. The poor unsuspecting soldiers had been gypped by some of their colleagues, who had earlier connived with the foreign carpetbaggers.

CHAPTER 19

LOSSES AND MORE LOSSES

After the death of the two workers and the desecration of Fort Santiago, Soriano was reported to have deposited over one million pesos in a bank. Naturally, the country’s National Security Adviser was furious at the bank official who had tactlessly made the disclosure. Worse, he used a very lame excuse. Soriano claimed that the money was entrusted to him by International Precious Metals, Inc. (IPMI) for “safekeeping”. But why couldn’t IPMI bank the money on its own?

Soriano was “fired” by President Aquino as NSC Chairman after the group failed to find gold. “Instead of gaining funds as Mrs. Aquino had prospected, the Government is poorer because of

the diggings and stands to lose more millions to restore the tottering fort that threatens to cave in, unless Soriano is made to cover the diggings himself,” read Burgos’ commentary.

The Aquino Government was now besieged by several other misfortunes. What needed immediate attention was the worsening inflation. During the six-day coup attempt in December 1989, prices of commodities soared by as much as 40 percent. Quickly, the beleaguered Administration imposed price controls on nine basic commodities—rice, canned liquid milk, powdered filled milk, sugar, dressed chicken, hard flour, pork, kerosene and liquefied petroleum gas. But the problem seemed to have gone out of control. Shortly thereafter, Aquino expanded the coverage of price controls to include eggs, cooking oil and other pork products.

Two days before Christmas, Aquino signed the *Emergency Powers Act* which penalizes profiteering, speculation and hoarding, declaring them as crimes against the people. It was during these hard times when many among those who were connected, one way or another, with the buying and selling of the Marcos gold wanted to obtain an audience with the President “to talk over prospects of financing her deficit-ridden government”. One of them was Woodrow Yap, whose proposal led to the formation of a “Wealth Chase and Recovery Program”.

This recovery group was headed by Conrado (Dodie) Limcaoco, Jr., then Manager of PTV-4, duly assisted by Maria (Mama Mary) Gosilatar, Carlos Gonzales, Brian Kim, Kwong Lau and Jojo Flores. Their first target was the recovery from China of the “19,000 metric tons of gold in Taiwan and Beijing, moved from 1973 to 1978, with the special intercession of a late Chinese official and coordination with the depository Thamen Bank of China”, according to documents gathered at PTV-4 during the 1989 coup.

Some \$290 billion worth of gold was also reportedly stashed in different accounts in 10 Hong Kong banks in 1983 under the code name “AAA” used by Marcos in his transactions. Lau was chosen to assist in the proper approach and representation to China for the gold.

According to information gathered by Limcaoco’s group, the gold haul was spread out to the following banks in Hong Kong: (1) 12.5 kilogram bars amounting to 5,000 metric tons in Citibank N.A.; (2) 3,700 metric tons in the American Express Bank; (3) 75 kilo bars of 1,000 metric tons each in the Hang Lung Bank, Wing Lung Bank, Hang Seng Bank and Bank of America; (4) 200 metric tons in the Overseas Bank & Trust Company; and (5) two pieces of gold bars in the Industrial Bank.

The gold was supposedly moved in 1983 by Marcos’ military officers, secret agents, some Central Bank officials and employees, the CIA, Pan Am Airlines, SABENA and KLM, including a cargo vessel that sailed from Manila to Hong Kong via Taiwan and into the port of Beijing, using the shipping code “AAA”.

On October 25, 1983, the \$290 billion was allegedly placed in trust in one of the banks as “standby money for payment of 32,000 metric tons of gold of assorted sizes”.

A certain Mr. Bruce Bullock, introduced to President Aquino by one, Quirico Dumasig, Managing Director of the International Phil-American General Services, Inc., offered to make available to the Administration “huge resources up to U.S.\$750 billion on a strictly confidential Trust Transaction basis”.

Nothing profitable ever came out of these deals. All the Aquino Administration incurred were losses and more losses.

All the gold transactions were supported by voluminous documents, letters, affidavits, memoranda, official receipts and facsimiles of other pertinent papers. But the name of Ferdinand E. Marcos never appeared in any of the documents; nor did any of the names of his family. The only reference to Marcos was a letter written by Bruce Bullock offering a portfolio of billions of dollars to pay for the Marcos gold. This particular deal had to do with 100,000 metric tons of gold.

As Teodoro (Teddy) Benigno of the *Philippine Star* once commented, “Marcos was a devil of a genius, who wove tales with such stunning and superlative skill that he could make even the likes of Enrique Zobel hang on like a gape-mouthed child in the grip of a *Canterbury Tale*.”

The mystery of the Marcos gold remains a mystery, incurring heavy losses to those who dare uncover it.

CHAPTER 20 YAMASHITA'S GOLD—AGAIN?

On October 5, 1990, the *Philippine Star* came out with the stunning news that the late President Marcos actually recovered half of the estimated \$80 billion worth of Yamashita's fabled treasure. The fishy report came from Solicitor General Francisco Chavez, who was in Negros Occidental at the time.

According to Chavez, former Aurora Province Governor Orlando Dulay had confirmed to him and PCGG Chairman David Castro that the Yamashita Treasure was excavated in two places in Luzon by the late strongman. The rest, according to Dulay, was still in Antipolo and could be worth up to \$40 billion at the current price of gold.

Chavez told a press conference in Bacolod City that Dulay had some "verifiable old facts" that may be worth looking into. Dulay reportedly admitted that he was one of three trustees named by Marcos to look after the gold, but he did not name the two others.

Yamashita Treasure?

Manuel L. Morato, then Chairman of the MTRCB, found it hard to believe. "If, indeed, there is such a treasure, it could not have been buried in this country... it could be possible that this fortune was brought to Japan, knowing that the Japanese are very nationalistic... this could be the reason for Japan's phenomenal rise from the ravages of war."

Manoling, as he is fondly called by friends, expressed this possibility "because my father's car was brought to Japan by Yamashita".

Don Tomas Morato, the illustrious Mayor of Quezon City, had a "Graham Bell" limousine, a very special model, which his family used before the war. It was the Mayor's hobby to be the first proud owner or buyer of any latest model brought to the Philippines by La Estrella del Norte, Inc., then the premier importer of automobiles. Unfortunately, the prized car was confiscated by Yamashita and became his official service vehicle while he was here. Later, the Japanese General took it to Japan and, since then, the Morato family had not heard about it.

Joe "Take It Away" Quirino of the *Philippine Star* concurred with Manoling. "Yamashita was not only a brave officer; he was also upright and honest and would never think of hoarding someone else's treasure or gold. When he took command of Nippon forces in a last-ditch effort to defend the Cordilleras, Yamashita had no time for gathering gold bullion or any kind of treasure. It is completely unfair, therefore, to link Yamashita to any treasure hoard or gold bullion," Quirino insisted.

Despite the clear fact that Yamashita was a victim of judicial lynching, he never lost his composure. One of his prosecutors reportedly told Yamashita's chief defense counsel, Frank A. Reel, "Damn it. It makes me mad, seeing him decked out in uniform. He steals the show, dominates the council room. If I had my way, I'd put him in prison overalls and chains."

According to Quirino, Yamashita accepted the verdict calmly, saying, "I am not ashamed before God for what I've done when I have to die. But if you say to me, 'You do not have the ability to command a Japanese army,' I should say nothing because it is in my own nature. I know that all your American military officers have been very tolerant and exercised rightful judgment, when I have had good treatment,

kind attitude from your good-natured officers who, all the time, protected me. I'll never forget what they have done for me. Even if I die, I don't blame my executioners. I'll pray to God to bless them."

Are these the words of a thief and a plunderer?

So why did Dulay insist that the Marcos Gold Haul is a part of Yamashita's treasure? Perhaps that is what he was made to believe—by his peers and maybe by Marcos himself.

"He, Dulay, was approached by Castro and Chavez. I think the Solicitor General helped him with a manifestation in his petition with the Supreme Court," said Chuck McDougald in an interview by Roy de Guzman of the *Inquirer*. "But he was given a condition: He had to show one gold bar before he is taken out of prison. He did not, so it did not push through."

Dulay never came out of his prison cell alive. He died A MYSTERIOUS death.

CHAPTER 21 IMELDA AND THE WE FORUM SERIES

In her latest political charade charade designed to capture the attention of voters in the 1998 presidential elections, Madam Imelda Marcos told a press forum: "If you know how rich you are, you are not rich. But me, I am not aware of the extent of my wealth. That's how rich we are."—*Inquirer*, March 27, 1998

The former First Lady publicly admitted, for the first time, that her family has more than \$800 million in secret bank accounts abroad, over and above the \$540 million in two Swiss banks which the Philippine Government claims to be part of Marcos' ill-gotten wealth.

[H: Don't you just love the over-and-over-and-over-again reference to Marcos' "ILL-GOTTEN" wealth? WHO SAYS THE WEALTH MARCOS HELD WAS/IS "ILL-GOTTEN"? IT WAS NOT "ILL-GOTTEN" AND WE FULLY INTEND, BEFORE WE FINISH THIS TALE, TO PROVE THAT FACT.]

"There is more wealth that this Government is not aware of but, for the time being, I can admit that there is only \$800 million kept in various banks. But I cannot reveal them," she added.

In January 1990, the now defunct *We Forum* ran an investigative series on the magnitude of the Marcos gold. In the first part, Eric Giron revealed some shocking information on the Gold Haul. "Whatever gold General Tomoyuki Yamashita, the wartime overall commander of the Japanese Imperial forces in the Philippines, was able to scrape from Asian sites as claimed, was a mere drop in the bucket of the 75,000 metric tons of gold transmitted by Marcos to London and other foreign gold pools between 1970 and 1983," according to Giron. "This haul," he added, "would be nearly equal to all the gold estimated to have been mined legitimately throughout history."

The revelation practically doused cold water on Dan Swihart's claim that "gold bars had been found in Tarlac and five areas in Nueva Ecija", and that some survivors of World War II testified that 3,000 Philippine areas kept treasures of Yamashita taken from Asian sites. Swihart claimed to be a consultant of the International Precious Metals, Inc.

The *We Forum* series, likewise, asserted that Marcos' private airplane and commercial airlines

ferried the gold bullion to a bank in Zurich about 12 times. A KLM Royal Dutch Airlines flight to Zurich reportedly carried a cargo of seven tons of bullion on September 26, 1963. At the same time, another 3,000 kilos were shipped to London.

Marcos' method of shipping his bullion out of the country was discovered by U.S. Customs personnel who stumbled upon a pouchful of documents carried by one of General Fabian Ver's operatives. "Marcos devised a scheme to float large loans using the gold bullion stored in a privately owned bank of Marcos crony Roberto Benedicto. The sale was to be made through an accountant with CIA connections in Alexandria, Virginia," elaborated Giron.

This information was supported by confidential correspondence received by Giron from a Makati-based corporation, which read, "gold bars in the Philippines of about 62,321 metric tons or more with 99.99 percent purity were negotiated for investment loans from 1980 to 1984... The huge sums intended for investment loans were still intact, or 'frozen' with 800 prime banks in the U.S.A. and 500 prime banks on the European continent..."

Giron's set of documents also included one which showed former President Ferdinand Marcos as "a coded private seller of scattered gold bars using the services of coded agent PN-1518254 and his 25 secret groups", with the participation of U.S. and European secret organizations.

"Even when Marcos was an exile in Honolulu on February 22, 1987, he was still selling gold bullion, this time openly," pointed out Giron. "The stationery bearing an etching of the deposed President's face, the Malacanang seal and his signature carried an offer of 25,000 metric tons or more of gold bullion with 99.95 percent purity or 24 karats in different places such as Canada, Australia, Holland, Alaska, India and Zurich."

The personal and very confidential letter dated 21 February, 1981 addressed to "Her Excellency, Madam Imelda Romualdez-Marcos, Malacanang Palace", opening with a list of Government officials and top-ranking businessmen concerned with what was camouflaged as "Japanese financial aid to the Philippines", was part of the coded sales, insisted Giron.

The letter further read, "The Japanese aid consists of accumulated interest income of dollar fund left in trust by General MacArthur to the Imperial Family. The trustees are two Americans and one Japanese by the name of Mr. Yutaka Aoki... We are devising a means of how to bring out the money to Hong Kong under the authority of the Ministry of Finance of Japan and your cooperation is needed. It shall be made to appear that the money will be loaned to a Japanese company doing business in the Philippines and they found that Kawasaki is qualified. The Trust money in the hands of the Imperial Family has already been deposited with Sanwa Bank in Osaka and is ready for the economic development project of the First Lady."

NOTE: One nagging problem is Imelda Marcos' continued promises to share Marcos' wealth with the Filipino people. Some of the Marcos gold accounts under her name had been earlier changed by the late President into other accounts in 1987 to safeguard and secure the fruits of his toil. In the process, Marcos was merely protecting his family and the Filipino people, who will finally stand to benefit from all his wealth.

CHAPTER 22

PEDROSA’S TOUCHÉ

What really are our chances of recovering the Marcos gold from Switzerland?

Very slim. There are many things which even Filipino scholars do not know about the Alpine State. Switzerland is a federal republic “invented” by the Rothschilds and other prominent members of international banking and finance who organized the Congress of Vienna (1814-1815). It was primarily designed to become the new financial center. Since then, globalists have used Swiss banks to trap the unwary. Even if a head of state was knowledgeable and wise enough not to choose a bank with a name like Rothschild, the fact remains that the conspiracy controls several other banks in Switzerland.

Here is where the trouble comes in, as prominent author and top *Star* columnist Carmen Nararro-Pedrosa discovered, in her probe into the Marcos wealth. It only goes to show that nations need an honest-to-goodness professional consulting firm to determine how to benefit from Switzerland’s unique political, legal and banking system—and avoid the crooks.

In her regular *Star* column “From a Distance”, Pedrosa writes: “What stands in the way of the Philippine claim is Switzerland, a powerful and wealthy country that has traditionally rejected attempts by countries victimized by their own leaders to recover the wealth. Filipinos must recognize that Switzerland is a country sustained by an iniquitous banking system. Any initiative by the Philippine Government, whoever is at the head, will be vulnerable to the blandishments of the Swiss system, who are used in warding off any attempt by claimants to remove disputed deposits, whether stolen gold or cash, from their dominion. It is a given that the Swiss will attack the credibility of any individual involved in any campaign against the Swiss banking system. This partly explains the timidity of officials in tackling the Marcos gold despite evidence that the Swiss have not been forthcoming about it. Earlier attempts to defeat the Swiss banking system were ultimately destroyed by intrigue and innuendo.”

Pedrosa points to *Operation Big Bird* and *Oplan Domino*, which failed because “the role played by those protecting the Swiss banking system was not properly recognized.” How true! Some of those involved in the recovery project worked clandestinely with the Swiss authorities!

An American expert who has been involved with the Swiss banking industry for thirty years has cautioned individuals and nations over the years that they must deal only with a publicly owned Swiss bank. Under Swiss law, publicly owned banks with stock in the hands of the public must be controlled only by Swiss citizens. In other words, the voting shares cannot be sold to foreigners. This simple fact is absolutely critical in maintaining the security of the Swiss political, legal and banking system.

So, why didn’t Marcos deposit his wealth in publicly owned Swiss banks? Why did he opt to deal with highly touted banks like UBS, which is controlled by globalists?

“The Swiss were co-conspirators of Marcos in stashing the wealth away from the Philippines,” Pedrosa insists. “This was blatantly demonstrated by Peter Cosandey when he ‘raided’ Freilager A.G. to satisfy Swiss media and the public that the gold does not exist.”

Cosandey’s behavior was, indeed, suspicious. First, he publicly announced that a raid of the Kloten warehouse was to be initiated by him just before he conducted it. Then, he invited members of the media to accompany him on his “raid” but

did not allow any of them to enter the warehouse. Cosandey’s moves have been more than enough to prove nothing but complicity.

According to Pedrosa, the whole thing was triggered by what she believed to be a mistake on the part of the PCGG agent, Reiner Jacobi. “He represented the evidence to Peter Cosandey, the Zurich District Attorney, who was in charge of ‘helping’ the Philippines in its search and claim for the Marcos Swiss gold deposit.” The evidence pointed to the physical whereabouts of the loot—in the form of account numbers in the Union Bank of Switzerland and storage vault numbers in Freilager A.G.

In his search for the Marcos gold, Jacobi, a private investigator from Australia, was arrested and imprisoned three times while gathering evidence. His last arrest was in his Sanctuary Cover residence in Australia, on the same charges hurled against him in 1992, when he was in Hong Kong. At that time, he had just discovered the location of the Marcos gold in Freilager A.G., a warehouse situated underneath the Kloten Airport in Zurich.

At present, Jacobi is free and is now back in Australia. Strangely, Pedrosa has noted the telltale pattern when every time he revives public interest concerning the Marcos gold in Switzerland, he always gets into trouble.

In the light of everything that has been revealed by Mrs. Pedrosa on her end, how do we increase our chances of getting back the Marcos gold from the Swiss?

“The key to the success of our campaign or any other campaign is to keep our minds focused on what unites us, not on what divides us, even if what divides us is true,” Pedrosa pointed out. I agree. But you can bet your bottom dollar that the Swiss authorities will do everything in their power to keep us divided.

This is the very reason behind former President Fidel V. Ramos’ usual application of his pet principle: “pliant like a bamboo”, by keeping humble, patient and calculating, to unify the Filipino people, from the right, to the left, from the Moroland, our listless military, and now, the political factions each being given their piece of the action, all in the name of peace.

CHAPTER 23

THE PHILIPPINE FREE PRESS VERSION

The *Philippine Free Press*, a hard-hitting publication owned by Teodoro Locsin, Sr., **[H: now deceased]** has its own version of the Marcos Gold Haul. Its writers believe that Dulay’s claim that “Marcos found half of the estimated \$80 billion Yamashita Treasure” is not all true, and that the figures could be far bigger than what is popularly believed.

In his story, Michael Duenas stated that when Marcos started getting upset by pressures from the U.S. Central Intelligence Agency, he was reported to have mumbled, “If only the Americans know how much gold we have, they will be fair to me.” **[H: Harumphhhh, the Americans would be fair? My, what innocence.]**

American officials have confirmed the existence of the Marcos Gold Hoard, which they estimated to be “worth around \$240 billion”. Aside from the E.F. Hutton group which came out with the estimate, Hirschfield and Chastain, too, revealed the information that former President Ferdinand Marcos asked them to borrow \$25 million for him “to finance a (counter) coup in the Philippines”. They secretly taped their private conversations with Marcos, in which the strongman admitted that he had 1,000 tons of gold hidden in the Philippines “about which Imee (the eldest daughter) knew”. **[H: Does anybody note WHO the players are here, as in E.F. Hutton, a Jewish brokerage house which shouldn’t know anything about anything in the Philippines? And note: “secretly taped”. Isn’t that against the law? You had best take note, citizens, because you live under two sets of rules: one for the crooks in high places and the other for you whose place gets lower and lower every day!]**

Duenas points to the 1988 report of Japan’s English-language daily *Yomiuri Shimbun* claiming that from the spring of 1986 through 1987, some 20 tons of gold bars worth \$330 million were sold in the black market there by men identified with Marcos. Also, two men who they said were working for Marcos “showed *United Press International (UPI)*, also in early 1988, a draft contract offering for sale 38,000 metric tons of gold (London delivery) and 37,000 metric tons of 75 kilogram gold bars, estimated to be worth around \$240 billion, the bulk of which were in London warehouses.”

[H: I can’t resist a notation RIGHT HERE. Notice that the paper was “English”-language—WHY? And notice “(UPI)”, which is owned by the group of brokerage octopus named. All these stories appeared exclusively in the pages of the *Free Press*. **[H: Well, there is certainly one major mark AGAINST them.]**

Duenas cited Filemon V. Tutay’s two-part series, “The Yamashita Treasure Hunt Goes On!” as a basis for his own version of the Marcos gold story. “The

Hunter Group, which was engaged in a massive hunt and retrieval operation for the fabled Yamashita Treasure, was headed by Charlie (codename for then President Marcos) and Jimmy (codename for Fabian C. Ver, then Chief of the Presidential Security Command),” wrote Duenas. The latter reportedly brought the Americans to Marcos’ hideaway in Mariveles, Bataan aboard the presidential yacht to finalize laundering agreements for selling the gold in Zurich and London markets.

In this case, “laundering simply meant two things—the elimination of the original identifying marks on the retrieved gold, and the necessary processing to change its characteristics from those of its actual origin to those of gold mined in the Philippines,” explained Duenas. **[H: Yes, indeed, like wiping out that gol-danged Phoenix ID.]**

The secret new process, according to Ver, could presumably extract much more gold than the known conventional process and it could serve, too, as the explanation for the sudden increased production of Philippine gold.

Upon reaching the Marcos summer palace on the Bataan Peninsula, the Americans were treated to a variety of sports and other forms of relaxation, including a sightseeing tour of Corregidor, the famous island fortress. After a hearty dinner, they were brought on a guided tour which ended in an underground concrete vault measuring about 30 by 30 feet.

According to one Curtis, who related this account to Steve Psinakis before reaching the *Free Press* desk: “The vault was full of gold bars, neatly piled one on top of the other from floor to ceiling! Each gold bar measured 4 by 4 by 16 inches, weighed 12.5 kilograms of 24 karats, 999 fine. At the corner of the cavernous vault, as if on guard, sat the Golden Buddha, about three feet in height, made of pure white gold, with a detachable head in which were hidden diamonds and other precious stones.” **[H: Hummmnn, “THE” “GOLDEN BUDDHA”, white gold? Wow, could it be...that...?]**

Ver reportedly told Curtis that the gold in the vault “came from only one of the many sites of their retrieving operations and it was a relatively small one”. However, the pile Curtis saw was the reason why “the laundering facility must become activated as soon as possible because of security”, unless it could be laundered and sold as it was retrieved.

“The Yamashita Treasure retrieval operation hit the jackpot on July 8, 1975,” declared Duenas. “As Tutay narrated... the workmen reached the top of the concrete tunnel where the vast treasure was supposed to have been stored. But instead of becoming a cause for rejoicing, finally reaching the treasure sought started a series of unsettling events that panicked the LEBER group (Legitimate, Ethical Business Enterprises, Related) to fly out of the country as though they were running for their life,” added Duenas.

[H: Here they give you another clue as to how to measure these politicians who suddenly have to spend more time with their families—LIKE IN THE U.S., CANADA OR GREAT BRITAIN.]

Apparently, Marcos had warned Curtis of leaks about the treasure-hunt projects. The day before, Lee Marcussen, Curtis’ business associate in Reno, Nevada, told him about Jack Anderson’s column, which mentioned buried World War II Japanese treasure in the Sierra Madre Mountains in the Philippines. In his account, Anderson also included “a bribe attempt of Primitivo Mijares not to divulge Marcos’ involvement in the hunt for Yamashita’s buried treasure in the controversial area.”

A psychic reportedly warned Curtis and his group that “something was wrong and their lives were in grave danger”. All of them left the

Philippines immediately. **[H: WOW, IT DOESN’T REQUIRE A PSYCHIC.]**

A month later, Curtis tried to get in touch with Marcos and Ver to no avail. Finally, he contacted Ambassador Amelito Mutuc, who allegedly told them: “The operations have resumed full blast but on top security. Not even I can get there, and they are doing it already.”

Despite the elaborate tale, however, Duenas showed no proof that the gold hoard did belong to General Yamashita. **[H: And that, of course, is because IT DID NOT!]**

CHAPTER 24
VATICAN’S SECRET

“How come no Japanese authority, no Japanese officer, no survivor of the Japanese Imperial Army, no goose-stepping colleague of Yamashita, has ever stepped forward to authenticate the story? How come no witness (Japanese, Filipino, Mangyan, Igorot, Baluga) ever lived to tell the tale? Were they all massacred? How come not one of the Southeast Asian countries supposedly looted by Yamashita of their gold holdings ever came out in the open after the Second World War to protest and seek reparation?” These are but some of the many questions raised by Teodoro Benigno, a former Cabinet member of the Aquino Administration who writes for the *Philippine Star*.

Short of calling him the devil incarnate, Benigno insisted that Marcos’ word must never be believed by anyone. “There was never anybody like Ferdinand Marcos when it came to inventing something out of the whole cloth,” Benigno said. “He was Harry Houdini, Mandrake, the Mystic of Mandalay, David Copperfield. He was a superb forked root from the genus Mondrangora which could only be pulled from the ground at midnight to project the maximum powers of the dark Earth,” he added.

To this veteran journalist, the Yamashita tale is impossible to believe. But just like the others, he came up with the wrong conclusion on the matter. “There is gold. There is Marcos gold, presumably plenty of it, piled up in locked bank vaults known only to the High Hemphets of Credit Suisse and possibly other Swiss banks. Perhaps buried in some secret places in our country. But it is not Yamashita gold. It is stolen gold, looted from the Central Bank and some gold mines in the Philippines. This has been documented in detail in Ric Manapat’s book, *Some Are Smarter Than Others*,” swore Benigno.

Some, indeed, are smarter than others. The smarter ones believed that what Marcos carried away with him came from the Vatican treasury, fabulous financial baggage which should have been long discarded by Peter’s successors, as suggested by ex-Jesuit Malachi Martin in many of the books he has written, concrete valuables which provide collateral that rises in the hundreds of billions of dollars.

The Vatican’s loss may have been something destined. As Filipinos love to say, kinarma. After all, “the dowry of Constantine is too much to carry in today’s world,” said Pope Paul VI, the well-read humanist who in his lifetime always recalled lines from *Dante’s Inferno*: “Alas! Constantine, how much misfortune you caused, not by becoming Christian but by that dowry which the first rich father accepted for you!”

It is, therefore, not strange to speculate or even believe that scandals like the embezzlement of Peter’s Pence should happen within the confines of the Papal State. Father Jose Antonio Diaz may have been the “Paul Marcinkus” of his time.

Marcinkus’ career, which eventually brought him to the position of “God’s Banker”, was launched by the Cardinal of New York, Francis Spellman, who headed one of the wealthiest dioceses in the world at the time and was frequently referred to as “Cardinal Moneybags”, according to David Yallop, author of the controversial book, *In God’s Name*.

During a quick visit to downtown Rome sometime in 1964, Pope Paul VI was suddenly faced with the danger of being trampled upon by an enthusiastic crowd. Marcinkus, with his huge gorilla-like physique, appeared in a flash, “using shoulders, elbows and hands” to help clear the way for the nervous pontiff. From then on, said David Yallop, he (Marcinkus) became the unofficial bodyguard to the Pope, and his nickname, “Gorilla”, was born. When Pope John Paul II came for a visit to the Philippines, he (Marcinkus) was one of the JPPI’s close-in security.

Marcinkus was an important part of “Vatican Incorporated”. It was the structure that more often than not controlled the fiscal policy of the Church. “You can’t run the Church on Hail Marys,” said Marcinkus. He preferred the assistance of the Mafia to help him run the Church’s financial affairs. Later, Pope John Paul I would initiate moves to remove him from the Vatican Bank. His good friend, Sicilian banker Michele Sindona, was deeply in association with Propaganda Due (p2), the Masonic Lodge operating inside the walls of St. Peter’s.

Until this day, Marcinkus, together with Cardinals Jean Villot, Roberto Calvi, Licio Gelli and Cardinal John Cody, have been suspected of applying the Italian solution against Papa Albino Luciani (John Paul I): “The Pope must die!” He did—on the evening of September 28, 1978. Father Diaz may not have been as brusque as Marcinkus, but he was equally deadly. His ingenuity in the field of finance and gold trading proved to be profitable. In the end, however, he, too, had to give away Constantine’s dowry to a strongman who would in turn lose it to the globalists. Could it be that the Vatican bullion carries a curse upon those who dare stash the treasure?

POPULIST REP PAUL'S REFLECTIONS

Representative Ron Paul from Texas, the leading spokesman in Washington for limited constitutional government, low taxes, free markets and a return to sound monetary policies based on commodity-backed currency and therefore always a thorn in the side of the Establishment, urges Americans to work towards the repeal of the grossly un-American *Military Commissions Act* and the *Patriot Act*. There are no signs that there is anything being done in Washington to correct the problem. Spending is going to continue and probably going to get worse, the deficits are going to stay high if foreign policy is not going to change."

TAKING ON THE TAX MAN

When there is an income tax, the just man will pay more and the unjust less on the same amount of income.—Plato

It has been a well-established fact for a number of years that the oppressive and progressive income tax that strangles Americans today was fraudulent from the beginning and that there is no law requiring citizens to "render unto Caesar". Why would former IRS commissioners state that they appreciate our "voluntary compliance" to their absurd tax system?

Many citizens, including the We the People Foundation, have answered that question and are doing something about it. Earlier this year the Department of Justice dismissed a felony tax prosecution—*With Prejudice*—after the *Paperwork Reduction Act* defense was raised.

"We the People" had this to say:

On May 12, 2006 in Peoria, Illinois, the attorney for the U.S. Department of Justice (DOJ) begged the court to dismiss all charges against IRS victim Robert Lawrence in federal District Court.

The motion for dismissal came on the heels of a surprise tactic by Lawrence's defense attorney Oscar Stilley.

The tactic threatened exposure of IRS's on-going efforts to defraud the public. The move put DOJ attorneys in a state of panic that left them with only one alternative: beg for dismissal, with prejudice.

Stilley's tactic paid off. Sixty days earlier, the DOJ had indicted Lawrence on three counts of willful failure to file a 1040 form, and three felony counts of income tax evasion. The federal Judge dismissed all charges with prejudice, meaning the DOJ cannot charge Lawrence with those crimes again.

"The trial was to have started on Monday morning, May 15th.

On Wednesday, May 10, Stilley mailed a set of documents to the DOJ in response to DOJ's discovery demands. The documents revealed to DOJ for the first time that Lawrence was basing his entire defense on an act of Congress, 44 U.S.C. 3500-3520, also known as the *Paperwork Reduction Act (PRA)*.

In Section 3512 of the Act, titled "Public Protection", it says that no person shall be subject to any penalty for failing to comply with an agency's collection of information request (such as a 1040 form), if the request does not display a valid control number assigned by the Office of Management and Budget (OMB) in accordance with the requirements of the Act, or if the agency fails to inform the person who is to respond to the collection of information that he is not required to respond to the collection of information request unless it displays a valid control number.

In Section 3512 Congress went on to authorize that the protection provided by Section 3512 may be raised in the form of a complete defense at any time during an agency's administrative process (such as an IRS Tax Court or Collection and Due Process Hearing) or during a judicial proceeding

(such as Lawrence's criminal trial).

In sum, the *PRA* requires that all government agencies display valid OMB control numbers and certain disclosures directly on all information collection forms that the public is requested to file. Lawrence's sole defense was he was not required to file an IRS Form 1040 because it displays an invalid OMB control number.

Government officials knew that if the case went to trial, it would expose the fraudulent, counterfeit 1040. They also must have known that a trial would expose the ongoing conspiracy between OMB and IRS to publish 1040 forms each year that those agencies knew were in violation of the *PRA*. That would raise the issue that the Form 1040, with its invalid control number, is being used by the Government to cover up the underlying constitutional tort—that is, the enforcement of a direct, unapportioned tax on the labor of every working man, women and child in America.

Any information collection form, such as IRS Form 1040, which lacks bona fide statutory authority or which conflicts with the *Constitution*, cannot be issued an OMB control number. If a control number were issued for such a form, the form would be invalid and of no force and effect.

Under the facts and circumstances of the last 24 years, it is safe to say that IRS Form 1040 is a fraudulent, counterfeit, bootleg form. Government officials responsible for this fraud should be investigated and face indictment for willfully making and sponsoring false instruments.

Caught between a rock and a hard place, the DOJ and IRS decided not to let the Lawrence case proceed because it would reveal one critical and damning fact:

The *PRA* law protects those that fail to file IRS bootleg Form 1040 [emphasis added].

The DOJ knew that it stood a significant chance of losing the case, and if that happened, the press and others would quickly spread the word, and leave only fools to ever file a 1040 again. Oscar Stilley's pleadings and documents made these points quite clear:

IRS Form 1040 violates the federal *Paperwork Reduction Act (PRA)* and is therefore a legally invalid form [emphasis added].

Under the Public Protection clause of the *PRA*, no person can be penalized for failing to file a 1040 if the IRS fails to fully comply with the *PRA*.

The *PRA* statutes explicitly provide that a *PRA* challenge is a complete defense and can be raised in any administrative or judicial proceeding.

The IRS Individual Form 1040 has not and cannot comply with the requirements of the *PRA* because no existing statute authorizes the IRS to impose or collect the federal income tax from individuals. That lack of *bona fide* authority makes it impossible for IRS to avoid violating the *PRA*.

We The People Foundation have researched the facts, law and circumstances surrounding this case, and have determined that:

A public trial would have opened a "Pandora's Box" of legal evidence and government testimony under oath that would establish the IRS 1040 form as both fraudulent and counterfeit.

Oscar Stilley's *PRA* defense "checkmated" the DOJ and IRS [emphasis added].

The Office of Management and Budget (OMB) appears to have been complicit with IRS in deceiving the public and in helping perpetuate the 1040 fraud by promulgating federal regulations that negate the plain language of the *PRA* laws passed by Congress and by allowing the IRS to continually skirt the explicit requirements of those statutes.

Accordingly, We the People Foundation have petitioned the U.S. Attorney General, the IRS Commissioner, and Director of the OMB, requesting an official explanation of their conduct in Peoria.

It is important to understand that our justice system is merely upholding contract law and the *Constitution* and *Bill of Rights* simply do not apply in those situations. The question remains—how many tax protesters enter the courts with “clean hands”, armed with George Mercier’s teachings of the invisible contracts and those chains that bind? To play this game how many have structured themselves properly through the rescission of bank accounts, credit cards, and mortgages just to name a few?

The Globalists might have made a mistake when they taught the Filipino people “People Power” because there, at least, it seems they still believe they have the power to change out the government at any time.

DECISIVE SIGNS OF COMING “REGIME CHANGE”?

One can’t possibly ignore the handwriting on the wall expressed by events of the last 12 months.

First, there was the resignation of the “Hyatt 10” composed of members of this administration at both Cabinet and sub-Cabinet levels. PRESIDENT BUSH IS SENT A MESSAGE

But Greg Pitts, the acting White House travel director, was less fortunate as the President made his way back to the U.S. from his visit to south-east Asia and the Pacific Rim summit in Vietnam. Mr. Pitts was beaten and robbed by unknown assailants outside a nightclub in Waikiki at 2am on Tuesday during a stopover by the presidential party in Hawaii.” Captain Frank Fujii of Honolulu Police said, “He was knocked down, punched, kicked—his wallet and ID were stolen.”

Cornwell continues by saying that “Hours after that incident, three local motorcycle officers in the motorcade taking Mr. Bush to a military air base for his return to Washington were involved in a crash which left two of them seriously injured, after their bikes skidded on a rain-drenched road as they were about to enter the base area.”

“The final entry in this catalogue of mishaps was the unspecified mechanical difficulties encountered by his Air Force One Boeing 747 during the summit trip, as it was scheduled to leave Vietnam to ferry Mr. Bush to Indonesia (where he spent six hours in talks at a resort near Jakarta before heading to Hawaii). The problem forced Mr. Bush to take a smaller Boeing 757 back-up plane, obliging many in the White House delegation to switch to the accompanying press plane.”

Have the Bush bunch and their twigs been sent a message by Israeli Zionists and the Mossad to continue to play the Zionist’s hand in the Middle East? An executive or manager of a foreign corporation affiliated with a U.S. corporation can qualify for an L visa, if the following requirements are fulfilled:

1. The foreign corporation must be affiliated with the American (Nevada) corporation and should have assets in excess of \$500,000.
2. Document that you are in fact an executive or manager of a foreign corporation affiliated with the U.S. corporation.
2. Document that the U.S. corporate affiliate is in need of someone with your skills and abilities. (An advertisement demanding a special combination of skills and abilities that just happen to match your own will help a lot.)
3. Document your skills and abilities relative to the U.S. corporation’s needs.

In addition to the L-type visa, foreign nationals may be able to avail themselves of E-type visas, which typically involve investment in U.S. businesses. We suggest you consult with an immigration attorney.
