is a libertarian), but the audience—with lots of students from the University of New Hampshire—was definitely fair and balanced, as their enthusiastic reaction showed.

My opponents called for more war, more torture, more secret prisons, more eavesdropping, more presidential power. Some seemed to identify the government and the people as if they were one entity. But you and I know that once the government moves beyond its very limited constitutional mandate, it is an opponent of the people, a rip-off operation that takes our money and our freedom and our social peace, and gives us a mess of statist pottage in return.

The government failed miserably on 911 to protect us, despite spending trillions. So the answer was supposed to be the giant, socialist Department of Homeland Security, protecting you and me from taking our toothpaste on the airplane. When one of my opponents said it was OK to lose elections through supporting the Iraq war, that set party people's teeth on edge, and rightly so. The Republican party is shrinking. We need new people. It's either our ideas or President Hillary, and more and more people recognize it.

APEC MEETING WHAT'S WITH INDONESIA? OPEC/APEC, AUSTRIAN/AUSTRALIAN

BOTH President Bush of the United States and President Putin of Russia stopped off in INDONESIA on their way to the recent APEC forum held in Australia. What's in Indonesia? Oh, only the second largest stash of gold in the World, in all likelihood—another "Marcos" stash. Let's look at an excerpt from David Guyatt's book, *The Secret Gold Treaty [caveat lector*, please, because there is a lot of incorrect information as well but the following is "interesting" and PLAUSIBLE]:

The Spanish connection to the Marcos gold story is of interest because amongst Johnston's other bullion transactions with Imelda Marcos was one that related to a very large transaction that came from the estate of Don Franco Miguel de Avila and Dona Trinidad Asis de Villarba de Avila. It concerned gold, cash and gems "located in thirty three (33) countries and deposited in fifty seven (57) banks." This included bullion belonging to the estate of the late Pedro Palafox Laurel—one of the former henchmen of Ferdinand Marcos who was reportedly murdered by Marcos. Laurel's assets in the form of "gold certificates, cash and ownership certificates of various properties" were stashed in a safety deposit box at the Overseas Trust Bank, Hong Kong, and formed part of Ferdinand Marcos' vast web of foreign holdings held by trusted nominees. Interestingly, a portion of the Laurel estate was stashed in the LIPPO bank in Jakarta.

That Marcos operated as a cat's-paw for the Vatican—as suggested earlier by Marcelino Tagle—is confirmed in documents relating to the estate of Don de Avila that reference 47,500 metric tonnes of gold belonging to the Vatican. This metal was held in Westpac, head office, Melbourne, under the codename FLAT.

What we haven't spoken of in any detail is the huge quantities of gold, platinum, gemstones and priceless religious treasures that are still stashed on Indonesia. This piece of information has been held back until last for a very telling reason. Earlier, I mentioned the 1955 meeting in the Indonesian town of Bangdung, where the world's "non-aligned" nations met for the first time as a group. Virtually unknown to contemporary history is the suggestion that Indonesia's then President Achmed Sukarno along with a number of other Third World leaders had secretly planned to establish an international non-aligned bank, to be

headquartered in Jakarta and backed by gold reserves recovered from World War II treasure stashed in Indonesia. This represented, apparently, trillions of dollars in gold reserves-making the bank a serious force to be reckoned with and one, moreover, that undoubtedly was viewed as a grave threat to US interests.

We now know that Allen Dulles and company at the CIA began planning Sukarno's downfall at this same time. For example, during the 1955 elections in Indonesia, a "million dollars U.S. got converted to rupiahs to prop up the Moslemoriented Masjuni party and give Sukarno competition".

By 1956, the Dulles brothers were fit to burst with Sukarno's grandiose plans, and Frank Wisner—the CIA's Deputy Director of Plans (for covert operations)—typified the prevalent feeling when he said "I think it's time we held Sukarno's feet to the fire." Holding Sukarno's feet to the fire was, apparently, a droll euphemism for assassination. Despite this, the CIA's early covert efforts against "Bungkarno" resembled the antics of a Keystone Cops re-enactment society more than anything else, but success was eventually achieved and Sukarno was deposed in 1965.

With him went the idea of an independent and alternative world bank answerable to the interests of those participating non-aligned nations that had no desire to continue to be exploited by Anglo-American interests. Today, the gold that was to be used as reserves for Sukarno's bank remains stashed in various parts of Indonesia under armed guard.

So, now you can perhaps appreciate WHY INDONESIA was on the agenda of two top World leaders at the same time. There are very definitely movements afoot to do something CONSIDERABLE about the mess that has become of the World's economic system based on fiat ("by decree", unbacked) currency. As everyone can now see (and, by the way, as presidential candidate Ron Paul advocates) and as the Divine Plan REQUIRES: it is NECESSARY to base currencies on some sort of VALUE as the erstwhile U.S. dollar is being inflated out of meaningful existence as "the world's reserve currency"—and the very concept of "world reserve currency" no longer means anything.

The recent "liquidity crisis", brought on by "fun and games" with U.S. financial "products" (both on and off the books), has marked the END OF THE PARTY FOR THE USURPERS who benefited so enormously for so long at the expense of EVERYONE ELSE. IT IS TIME TO "GET REAL".

According to RIA Novosti, 9/9/ 07: "The Joint Leaders' Statement rounding off the summit highlighted the need to promote 'open, efficient, transparent and flexible economies' as a means of protection against 'economic volatility and disruption caused by natural disasters and other threats to sustainable growth'."

Did President Bush REALLY make a gaffe when he substituted "OPEC" for "APEC"? DON'T JUMP was all about OPEC-but in a gold-based economy, business communities."

might it not be all about APEC? Ah, yes, there are definitely some light bulbs switching on.

What about the little slip when Mr. Bush substituted "AUSTRIAN" for "AUSTRALIAN"? Was Gunther Russbacher (deceased) REALLY "all puff" or was there some sort of reason our attention was directed to Kurt Waldheim (Secretary General of the UN from 1972 to 1982, deceased June 14, 2007) and AUSTRIA—LIKE THE GOLD CONNECTION? And where has THE POPE just been on a 3-day visit—and why now the interest in Austria? These are valuable CLUES for GOOD STUDENTS to consider, please. BUSH INVITES ASEAN TO TEXAS

There was a very strange—from a diplomatic perspective—invitation made by President George W. Bush to Southeast Asian leaders, as he invited seven heads of state of ASEAN countries with whom he was enjoying a luncheon to his ranch in Crawford, Texas. According to Associated Press (9/7/07), the seven ASEAN members of APEC invited to Texas were: Brunei, Indonesia, Malaysia, Philippines, Singapore, Thailand and Vietnam. The AP report cited the most curious response from President Gloria Arroyo of the Philippines: "He invited us to Texas," Arroyo told reporters. "We'll have it done there at the convenience of ASEAN." CURIOUSLY, there is no explanation or qualification as to what "IT" is to be done in Texas. WHAT DO YOU THINK "IT" IS? Wouldn't that have been a logical question for any reporter to have asked? Hmmm...

FISHING IN SIBERIA?

Previous reports have highlighted the significance of the visit and fishing expedition between Presidents Bush and Putin at Bush's father's place in Kennebunkport, when Mr. Putin was the only one to catch a fish, which was acknowledged to belong to apparently. Please keep that little background story in mind, particularly the part about the fish as SEAFOOD, as in COSMOS SEAFOOD.

Following his meeting with President Bush at APEC, President Putin began his press statement by saying: "First of all, I would like to say that I am very glad to have the opportunity to meet with the U.S. President within the framework of the APEC summit. And I began our meeting today with words of gratitude for the very warm welcome we received during our recent visit to Kennebunkport."

Among his other comments, President Putin stated: "We also covered our economic relations. We discussed various major economic projects whose TO CONCLUSIONS! In a petro-dollar economy it implementation is in the interests of both countries'

RE: MASSIVE AMOUNTS OF GOLD MOVED IN 1993; FORESIGHT, HINDSIGHT AND THE CONFRONTATION

One of the many new readers of this publication (you know who you are) sent me a link to look at Dr. Len Horowitz's new book, *LOVE the Real Da Vinci Code*. I've always felt a peculiar affinity to the "Renaissance Man", as he is known, and so I spent some time skimming through the book. THANK YOU for sending the link and I hope everyone can gain a little bit from what I will share in this article.

Before we dive off into that most interesting subject, I will share the results of some diligent research with regard to the events of 7, 13 and 14 years past. One of the first things I encountered of great interest was in an article from page 5 of the September 14, 1993 issue regarding the Philippines gold. As usual, I'm sure I read this more than once at the time—but it means ever so much more to me NOW.

[QUOTING from GCH 9/7/93:]

GOLD AND OTHER STRANGE THINGS

I am often asked why do I not comment on "gold prices" and actions of the market on Friday instead of the first working day of each week. Because the manipulations are planned and happen on weekends. YOU are the only ones not doing the most activities on the weekends.

Gold is down abruptly this morning and may go lower—THE TIME TO <u>BUY</u>! What happened to make it fall? Look at the world situation and challenge your library of knowledge—where there may SEEM to be no connection.

THE PHILIPPINES

There is a great "show and tell" of the "Marcos" burial in the Philippines—but what is really going on? Well, let us just say that, to get that fact accomplished, Mrs. Marcos paid off the Philippine national debt, for all practical purposes, along with other political extortion.

There is (was) a mammoth store of gold which was bargained for in the Philippines (actually now, mostly out of the islands) wherein the British Crown extorted great compensation in return for allowing the remainder stores to be utilized by the rightful owners. Much of that gold was bargained for through the central banks in London at around \$373/oz. As the "shifting" takes place great amounts of gold are changing hands and hitting the market. This is exceptionally

GOOD news to many of you and as the "cover-up" over the weekend price setting (again) it is hoped that most of you won't notice—that you are nearing the end of the mass manipulation to the heavy owners of reserves. You are going to have fluctuations continually as the big boys pull down the economies everywhere and try to latch onto all wealth—at least through "control" of it.

[END QUOTING]

How do you define "mammoth"? From meeting tape 940911-2a (downloadable from the website), we find that it was "enough to back the currency". That was still somewhat vague, so further research was in order. Listening through meeting tapes 940618-1a, 940703-1b and 940703-3a confirmed that the amount of gold involved in this shifting was **1.4 MILLION TONNES**.

1.4 million tons is a LOT OF ANYTHING. A semi-trailer can hold 20 tons, so to move, say, the 400,000 tons referenced in the reconstituted 1972 Agana *Decision with Compromise Agreement* would require 20,000 semi-trailer shipments. You just don't see American-style semi-trailer trucks here in the Philippines, so it can be deduced that the gold was not moved in that manner—if at all. Of course, it is not necessary for the physical gold to be moved anywhere, as long as it is covered by proper paperwork (warehouse receipts). But the ongoing presence of United States Armed Forces in the Philippines might make a whole lot more sense if you put "gold shifting" in the picture.

Wait just a minute, though, because it says the BRITISH CROWN was involved and there is no reference to the United States. Can you see why it might make a difference as to whether or not the United States is operating UNDER the Crown? Perhaps it makes more sense now, too, when Christopher Story writes about the United States STEALING some \$5 trillion worth of "Her Majesty's" gold. By the way, however, the Queen of England is NOT the Crown: she bows like everyone else when entering the City—home of the Crown and where the price of gold is "fixed"—whose Lord Mayor visited the Philippines last year, "by the way".

The excerpt reprinted above is a VERY IMPORTANT PIECE OF THE PUZZLE. Imelda Marcos "paid off the Philippine national debt, for all practical purposes"? "Funny thing" but the country still labors under the crushing burden of debt owed to the IMF/WB to the extent that all new loans are used simply to pay the INTEREST.

There's something else to keep in mind here: Neither Ferdinand nor Imelda Marcos had any right whatsoever to sell or even ENCUMBER the PRIVATELY OWNED gold referenced in the Agana Decision of 1972 (Civil Case 3957-P)—the 400,000 tons. So, the 1.4 million tons must have been separate

and apart from, not including, the 400,000 tons which was apparently LEASED to the NATIONAL Central Bank, which predates the PRIVATELY OWNED *Bangko Sentral Pilipinas* (BSP).

Whatever agreement was consummated with the Crown was ostensibly "for allowing the remainder stores to be utilized by the rightful owners". The "remainder stores" had to have been AT LEAST the 400,000 tons, possibly the full 617,500 tons referenced in the Agana Decision—which was for the benefit of the PEOPLE OF THE PHILIPPINES.

At one point, a "rumor" surfaced that there was some kind of unwritten government strategy in effect, by which all possible "rightful owners" of the assets described in the reconstituted Agana Decision—including both the land and the gold—would be set one against the others, effectively preventing ANYONE from using the assets as ordered. Evidence that such a strategy might be in play is provided by the fact that NO ONE has managed to "get their hands on" the gold. Who are the several claimants?

Up front there is supposed to be something called the "Japanese Mandate" in which a certain percentage of the gold goes to Japan and the rest is split between other nations in the region—as I understand things, never having seen any hard evidence of this presumed Mandate. It is believed that this Mandate could account for the "missing" 217,500 ton difference between 617,500 tons and 400,000 tons. It is also entirely likely that most if not all of this gold was used in the Reagan-Marcos Ang Bagong Lipunan (ABL) program, in which packages typically of 3,500 tons each were allocated and possibly shipped out to other nations. This is believable because Marcos could not use any of the gold labeled as "plunder" from World War Two-which had been frozen by the International Court of Justice through 1976, then extending into 1986, when something had to be done about the situation and Marcos was deposed.

So, let's only talk about the PRIVATELY OWNED 400,000 tons. There is NO QUESTION that this gold SHOULD exist for the benefit of the PEOPLE of the Philippines—and there is little doubt that its existence has been withheld from the people while everyone ELSE has tried to work their own angles. According to some, this gold was never part of any "fantasy" Tagean-Tallano clan but supposedly came from the Sultanate of Sulu. Even within the history as presented in the reconstituted Agana documents-that is PLAUSIBLE but DOESN'T CHANGE THE FACT THAT THE GOLD SHOULD EXIST FOR THE BENEFIT OF ALL PEOPLE OF THE PHILIPPINES. Much has been made of the meeting held at the Gilarmi Hotel in February 1999. I tried for many weeks to obtain a full copy of the meeting tapes from that date and finally, after taking time to consider whether he could determine my intentions, Jerry came through with the MP3 files.

There is a LOT on the tapes—but almost nothing relating to the supposedly nefarious purposes to which VK Durham has long referred. Yes, this is the same VK Durham who insists that Global Alliance's friends include the likes of: "Robert Rubin, Secretary of the U.S. Dept. of the Treasury, Lawrence Summers, Secretary of the U.S. Dept. of the Treasury, both Presidents being Bush and Clinton, James Baker III, CitiGroup Banks, CitiBank, JP Morgan-Chase, Bank of America, Chicago and Los Angeles, GOMEX or COMEX Gold Traders (Los Angeles), The Ayahtollah Koehmeni through the Greek Banks of Papandreaous, months later, in Tehachapi, California and some of Mexico's Banamex, Sophina Bank, Brownsville, which I still have not found) to serve her own Texas, Riggs Bank, Washington D.C., BCCI Bank's in purposes, entirely out of context, amounted to some Saudi, Brunei's Banks, Banks in Rahmadi, and HSBC or Hong Kong Shanghai Bank China, and CITIGROUP OF CHINA, CITIBANK OF CHINA and Peru, Korea and the usual etceteras."

VK DURHAM'S VERSION OF THINGS

Uh-huh, sure, right, VK. In her usual, sneaky, twisted way, VK Durham strung together bits and pieces from SEVERAL recordings and made her case. At TheAntechamber.net you can find two such cutand-paste recordings on one of her site's pages. Let's first review these first.

[First Player:]

Well, we are working in Asia with some of the bankers and the ones that—well, you've seen the one on the Rich and Famous that is basically organizing the ASEAN circumstance because this one was willing to put up 80, no, 20% of their entire gold wealth. You see, everybody wants to talk about— Rick, especially, wants to talk about—the Global Alliance instruments. Those instruments are only for a security 4, 5, 6, 10 years out.

To hear VK Durham tell the story, the meeting at the Gilarmi Hotel from which she has sliced and strung together non-contiguous segments (some of which were taken from another meeting altogether, kind of plot to take over the World. As usual, VK Durham can't keep her facts straight. On her website, this meeting is referenced as having occurred in February 1998. The tape is not dated—at least, the very first portion was apparently clipped and not recorded—but according to the introduction by EJ Ekker, the taped meeting at the Gilarmi Hotel occurred in February 1999, not 1998. From the tape, we can tell that the meeting occurred on a Tuesday and it is believed this was probably the first Tuesday of the month. Accordingly, I have chosen to date the Gilarmi meeting tape at February 2, 1999.

WHAT REALLY HAPPENED: EJ, RICK AND CHARLES VS DORIS EKKER

The SUBJECT MATTER of this meeting was a scribe "greatly, greatly under stress". Doris had been set upon by the three not-so-gentle men in her environment—Rick "Martin", Charles Neil and her own husband, EJ Ekker for a particular message from Commander Hatonn which they viewed as "confusing". These ones were privileged to have messages directly from Commander Hatonn through Doris' faculties to guide them through on a day-byday basis. The "final straw" seems to have come with one particular message which was said to be "confusing", "tainted" and "unclear". You might have expected that Doris would have been backed up "to the hilt" by her own husband—who should have KNOWN that she was merely the SECRETARY and that the Secretary's Boss almost always has good reasons for EXACTLY the way things are worded—

but no, he apparently had quite a lot to say of a negative variety toward and/or about Commander Hatonn prior to this meeting, by his own admission, and there is no question that it was a case of THREE AGAINST ONE. As you will see, however, Commander Hatonn was easily able to hold His own in protection of his scribe and HIS writing-and Doris was, thankfully, "elsewhere" in consciousness to allow this confrontation to occur in her "absence", even though it was her voice-box that was used to stymie the attack.

I have **bold-underlined** the brief, out-of-context segments used by VK Durham to help her conjure up an effort to "take down the World's banking system". **Bolding** is used to draw the reader's attention to key segments within the overall encounter. The technique of ALL CAPS is used, as usual, to denote EMPHASIS on particular words. My comments and input are in braces, in bold italics.

[EJ:] ... February 1999. We're at the Gilarmi in the Philippines for a meeting with the Commander. [pause] Greetings.

[GCH:] Good morning.

[Rick:] Good morning. [GCH:] Problems in River City. I come in the Light of God. I come WITH [pause] IN the Light of God. I have a receiver and she is greatly, greatly under stress. Now, you gentlemen are going to make up your mind—and I hope before this session is over-whether or not we have a mission that can **be completed here**, whether we are going to eat each other alive until we are quite dead in the water. We're going to bury a few EGOS—or I can't function with you. There are MANY things that need to be tended. That's my favorite word, "imminent"—because the ego snatches "imminent" and goes to work on you, according to what it wants to accomplish.

(Name of Corporation)

ARTICLE I

MEETINGS

Section 1. Annual meetings – The annual meetings of the members shall be held at the principal office of the association on April 7 of each year. The President shall render his annual report to the members regarding the activities of the association. The election of directors shall also be held during this regular meeting.

Section 2. Special Meetings – Special meetings of the members shall be called as the need thereof arises, by the Board of Trustees or the President or upon petition of 1/3 of the general membership.

Section 3. Notices – Notices of the time and place of annual, and special meetings of the members shall be given either personally or by special delivery mail, at least two (2) weeks before the date set for such meeting. The notice of every special meeting shall state briefly the purpose or purposes of the meeting.

Section 4. Quorum - A quorum for any meeting of the members shall consist of the majority of the members and majority of such quorum may decide any question at the meeting, except those matters where Corporation Code requires the affirmative vote of a greater proportion.

Section 5. Order of Business - The order of business at the annual meeting of the members shall be as follows:

- a. Proof of service of the required notice of the meeting.
- b. Proof of the presence of the quorum.
- Reading and approval of the minutes of the previous annual meeting.
- d. Unfinished business.
- e. Report of the President.
- f. Election of the Trustees for the ensuing year.
- g. Other matters.

Bylaws of the Tallano-Acop Foundation Article VI—Suspension, Expulsion

ARTICLE VI

SUSPENSION, EXPULSION AND TERMINATION OF MEMBERSHIP

Suspension, expulsion and termination of membership, shall be in accordance with the rules and regulations o the association.

Any member of the association may file charges against a member by filing a written complaint with the Secretary of the association. The Board of Trustees shall call a special meeting to consider the charges. The affirmative vote of majority of all trustees shall be necessary to suspend a member; Provided that where the penalty is expulsion, the affirmative vote of majority of all members of the association shall be necessary.

That members of the Foundation and/or members of the Board of Trustees of the foundation may be suspended, separated or terminated as members of the Foundation and/or members of the Board of Trustees of the Foundation on any one of the following grounds:

- non-payment of membership dues and other assessments;
- 2. habitual absences in meetings without reasonable basis
- 3. conviction of a crime involving moral turpitude
- neglect of corporate duties and/or delegated duties;
- any act or acts committed that are inimical to the interests of or contrary to the purposes of the Foundation;
- any act or activity similar to or analogous to any of the above. (As amended on 04-09-05)

ARTICLE VII

FUND

Section 1. Funds – The funds of the association shall be derived from admission fees, annual dues and special assessments of members, gifts of donations.

Section 2. Disbursements – Withdrawal from the funds of the associations, whether by check or any other instrument shall be signed by the Treasurer and countersigned by the President. If necessary, the Board of Trustees may designate other signatories.

Section 3. Fiscal Year - The fiscal year of the association shall be from January 1st to December 31 of each year.

ARTICLE VIII

CORPORATE SEAL

Section 1. Form – The corporate seal of the association shall be in such form and design as may be determined by the Board.
