JOHN F. KENNEDY'S MURDER

I have received so many requests for comment on the murder of J.F.K. that we shall respond in Express format. The new information flowing forth from the young Don White is indeed correct, but you need more information than a simple yes or no.

On November 22, 1963, the U.S. and the world were shocked and stunned by a horrible news bulletin-President John F. Kennedy, riding in a motorcade, had been shot. In remarkably short order a *single* suspect named Lee Harvey Oswald was promptly caught and jailed. Does anyone realize that Oswald was actually an <u>employee</u> of that Texas Schoolbook Depository?

Then there came one named Jack Ruby (well known to the Dallas police and instantly recognized by them), who was permitted to make his way to Oswald's side while still inside the police station. Millions watched as Ruby proceeded to shoot and kill Oswald. Oswald had been protesting over and over that

he had been "set-up" and obviously it was intended to remain that way.

Interestingly enough, tough and ruggedly healthy Jack Ruby then strangely became ill and soon died while in jail. At the same time Dorothy Kilgallen, the syndicated Columnist and TV personality, announced that she knew the facts and intended to blow the case wide open. (Will you ones never learn to subdue the ego and keep your mouths SHUT?--until you can bring truth in proper format?)

Well, she wrote the column but it was never published, her interview and outlay by Jack Ruby. She quickly died "of a mixed dosage of drugs and alcohol" although she had no history whatsoever of using either one.

Everyone with information bearing on President Kennedy's murder died or vanished left and right in the months that followed--before they could talk. This immediately went beyond any type of coincidence.

WARREN COMMISSION

This Commission was appointed by Lyndon Johnson after becoming President. Further, if you refer to our prior material, I told you that he had informed his mistress prior to the assassination that it was going to take place so he was up to his eyes in the conspiracy.

The Commission was chaired by the then Chief Justice Earl Warren (remember him from the current Journal?), who was actually guided in the examination by the then senior member of the CommissionCongressman Gerald Ford.

PAY ATTENTION HERE TO THE 25th AMENDMENT

The basic proposal for the 25th Amendment to the U.S. Constitution, under which both Ford and Nelson Rockefeller acquired their offices by appointment, was introduced in the Senate only three weeks to the day after President Kennedy was killed--it was ready and waiting. That proposal was introduced on Dec. 13, 1963 by Senator Birch Bayh, who had been put into office by none other than Nelson Rockefeller.

After the Warren Commission completed its work, Ford wrote a book strongly defending it and the findings of a "lone gunman". But there came a hue and cry to reconsider the case as evidence mounted that there had to be more than one gunman. There seemed to be no motives and the question loomed as to why John Kennedy was killed, and how.

Let us look first at "why" Kennedy had to be "taken out".

During the summer and early fall of 1962, Senator Kenneth Keating of New York embarked on a campaign to alert Americans to the presence of nuclear warhead missiles in Cuba aimed at the defenseless underbelly of the United States. For months he was ignored, scoffed at and ridiculed by appointed officials in the government. He might just as well have told the world the gold was gone from Fort Knox--which was also true, and/or going to be--but that is another story. It was obviously too mind-

blowing to be true.

After a while, however, President Kennedy became concerned personally--that there might be something to Keating's charges. He decided that, in any case, they should at least be seriously investigated so that the country's fears could be put to rest if they proved untrue.

Such a course of action is nothing more than common sense and once the President took a personal interest in the matter it was quickly discovered that Keating's charges were indeed true. Within a matter of days, with the U.S. on a Worldwide military alert, President Kennedy went on nationwide television to tell Americans about the missiles and to demand that Russia remove them immediately. *The Cuban missile crisis was upon you!*

Now you must know right now, that Kennedy's courage was greater than you know, for he was not only confronting the Soviet Union in a deadly showdown, but he was also double-crossing the Rockefeller interests, which had enabled him to become President in the first place.

CUBA/TELEVISION SCRAM-BLES/ROCKEFELLER/ TURNER

Herein allow me to point out some interesting current events. Do you remember when all the satellite TV signals would be scrambled and little boxes would be needed for personal satellite users? Well, do you further remember Ted Turner saying he would defy the U.S. and would supply Cuba with those boxes so they could continue to receive CNN news? Guess who sits as a major Board person on the Turner network corporations? Of course, the entity David Rockefeller. Old ties go back a long, long way--David Rockefeller is, however, not the "original" David Rockefeller. Mr. Kissinger's mob saw to the demise of ALL those lovely Rockefeller players.

By exposing the Cuban missile buildup and stopping it just short of fully operational status, Kennedy threw a massive monkey wrench into an attempt to speed-up the schedule of nuclear blackmail, which was part of the Rockefeller plan for complete control of America, in cooperation with their ancestral Bolshevik home--Mother Russia.

ENTERS GUYANA

The discovery of the missile bases in Cuba required the finding and development of a NEW base to replace them. This was accomplished in the Republic of Guyana, a neighbor of Venezuela. Guyana had been turned into a complete police state by Forbes Burnham, who was put in office for that very purpose by David Rockefeller. The Temehri Airfield in Guyana, 25 miles outside of Georgetown, bigger than JFK Airport in New York, was prematurely turned back to Guyana in 1965 by President Johnson in obedience to Rockefeller orders and it was then ringed by offensive nuclear missiles targeted on the Panama Canal and on cities within the U.S. I ask that you refer to the prior Journal in which I outlayed the truth of Guyana/Jim Jones/the Mossad, etc. I will not cover it herein.

At that time this meant a slowing of the ability of Russia to surpass the American military research and development.

Then you ended up with the Vietnamese conflict, into which you were already being dragged for other purposes. This would cause you to waste your military resources by grinding up massive quantities in war without focusing much on improving military technology and with all your enemies and allies working toward the same end--you had to be totally involved.

But here, too, Jack Kennedy was getting in the way. Before he was killed he had already initiated a sequence of events which were to reverse an increasing Vietnamese involvement and extract you from the Indo-China combat scene relatively quickly. All that meant that Jack Kennedy would have to go. He had launched his new frontier with an idealistic view of an ambitious governmental program, which had been put together for him by Rockefeller agents for purposes quite different from those he himself envisioned.

Kennedy began to see the light about what was going on, even stating in a broadcast that, "Castro was a tool of an international Conspiracy." Had he been given the chance he might in time had added up too many things correctly and that was not going to be allowed to happen. He was, further, an object of the vendetta of the Mafia against his father, Joe and, what appeared later to be friendship with Onasis of Greece, was truly a ploy to get even with the Kennedys. Robert nailed Hoffa and Hoffa "disappeared" and then, of course, so did Robert in another staged and stupid murder. The evidence is so blatant in these instances that it taxes my imagination to believe you ones can be so blind.

For his act of bravery in the Cuban Missile Crisis, President Kennedy finally put the contract on his own head and thusly became a marked man. He had come into realization of too many misadventures and was beginning to rise above the control of the ones who put him into the Presidency for their own purposes. And, brothers, when the Vice-President, even, is out for your head--you are going to lose it one way or another.

Agents of the CIA, which had been strictly a tool of the Rockefellers ever since its inception in 1947, arranged a series of possible assassination setups in 1963. As it happened, the one which was actually carried out was the one in Dallas. This brings us to how the assassination was actually carried out.

There is no delicate way to present this aspect of the case which is critically important. But, contrary to the Rockefeller agents who dominated the U.S. government and those who would take this scribe out today, I believe you are adult, as Americans, enough to get on with truth.

As you know the Warren Commission concluded that Lee Harvey Oswald acted alone in killing President Kennedy. But, this conclusion which was elaborately and vigorously defended by Gerald Ford, Walter Cronkite, and many other camp followers of the Rockefellers, rested on a premise that is a total insult to the intelligence of every

world citizen. The premise of a socalled single bullet theory is stupid beyond the imagination of anyone to believe it could be thrust upon a viewing public.

WARREN COMMISSION THEORY

According to that theory, which was the official judgment of the Commission, a single bullet fired from a barely operable 20-year-old rifle by a poor, poor marksman named Oswald passed through President Kennedy, changed course, went through a car seat, struck Governor John Connally, smashed a rib or two, then smashed his wrist, then injured his leg, (leaving behind fragments which Connally still carries in his body today) and then ended up in perfect laboratoryspecimen condition, completely undamaged except for the ballistic marks used to trace Oswald's gun.

This is such nonsense that a mystery novel with such a stupid episode, if it made it somehow into publication, would be instantly thrown into the trash heap. But this fairy-tale was the only way that the Warren Commission could end up with their pre-determined conclusion that Oswald acted alone and that you would therefore put the idea of conspiracy out of your minds. Oswald, of course, was not around to tell his story! A note was most conveniently found which, you were assured, Oswald had written explaining that he planned to kill President Kennedy. There are no limits beyond which the Satanic forces will not go to achieve their ends.

A single bullet, of course, did not kill anyone. And, now you know that films done secretly in analysis have been brought forth which tell the incredible truth revealing the President was murdered by means that were far more reliable than even the best "sharpshooter".

Before the fatal shot, Kennedy had already been hit from behind by a shot which caused him to lean slightly forward and face downward. He was then killed by a shot that literally blew the upper rear portion of his head away. Several square inches of the skull were actually blown away. The fatal shot snapped his head and body violently

backward and somewhat upward in his seat.

Debris from President Kennedy's head exploded <u>to</u> the rear, landing all over the left rear deck of the open top limousine. Kennedy was sitting in the right rear seat. At the instant of the fatal shot there was a blast (force) into Kennedy's face <u>from downward</u> and in front of him from a position within the car.

The Presidential limousine in which the assassination occurred was dismantled and destroyed within 48 hours. This was a grossly illegal destruction of material evidence.

Pathologists and researchers reported to the National Archives, that the remains of President Kennedy's brain, another crucial piece of evidence, to say the least, strangely disappeared--vanished, missing and was gone.

The Conspirators left nothing to chance or to the vagaries of marksmanship. Kennedy was killed by a device--mounted inside the limousine and fired at him from point blank range. The murder weapon was, of course, hidden, mounted inside the seat upholstery in front of the President and the driver is actually shown in the act of using it--on film. That man was a Secret Service agent, William Greer. I ask you to refer back to the last Express regarding Watergate for it intermeshes with this prior story.

Connally was a product of freewheeling Texas oil politics and had not been a favorite within the socalled Eastern Establishment ruled by the Rockefeller family. It was hoped that the incident in Dallas would simply get rid of him forever or bring him under total control. Remember also, from the prior Express, that I told you that when the CIA decided to get Ford by assassination because it was intended that Nelson Rockefeller be the next president instead of Ford (who was running and decided to not "play ball"), an effort was again made to pull in support from the President's Security Service. The Secret Service role was, however, neutralized by one Michael Milan, and when two subsequent efforts to kill Ford were carried out, the Secret Service conspirators, to cover their own ini-

tial complicity in the whole Kennedy affair as well as participation in the Ford assassination plans, backed off and declined to participate.

Michael Milan was a part of the secret organized-crime-linked hitsquad which carried out operations for the CIA and other government agencies. He was also a part of the "team" that immediately "removed" witnesses and was, in fact, personally dispatched to Dallas to kill one of the key witness who could have blown the whole Kennedy cover.

Milan rejected a role in the Ford assassination conspiracy and did, in fact, repeatedly seek to alert the President to the plot. This caused consternation and confusion within the Secret Service which caused them to back away from the plot.

WHAT WERE YOU LOOKING AT ON FILM?

The weapon in immediate point essentially similar to an "extremely sawed off shotgun". The blast was produced by what would be known as a "shaped" charge in a special mounting. A shaped charge is a specially configured explosive device which essentially produces a focused explosion--that is an explosion that mostly aims in one direction instead of going in all directions like a stick of dynamite. A shaped charge is what enables, for instance, a "bazooka" to blast a Sherman Tank out of action and shaped charges come in all varied sizes, including some small enough to be hidden easily in an automobile along with the firing instrument.

An advantage of the shaped charge, from a Conspirators' view point, is that, contrasted to a gun or shotgun, it would not produce a bullet or buckshot which might be found by someone in the vicinity and cause undesirable questions. only problem with such a shaped charge is it's noise. Such a "bang" would tend to attract the attention of others in the car. However, the Conspirators knew that Jackie Kennedy would be too distraught to attend such details and the confusion level would be incredible. But that left John Connally riding in the front seat ahead of the President. The sound of the shaped charge could be expected to attract his attention, even if it was muffled and partially lost in the confusion of gunshots from snipers.

The possibility existed that Connally alone might be able to detect that some sort of device had been fired just behind him and to his side inside the car. Therefore, Connally was a specific target in the ambush. He was not merely the victim of a stray bullet, much less the victim of bullet that had first struck Kennedy as alleged by the Commission. Connally was potentially the single most dangerous witness to the assassination. So, it was imperative that he be incapacitated or killed outright. It did not really matter whether Connally was killed or just seriously injured, so long as his ability to observe events clearly was ruined. This they accomplished and later the man could be "bought" and/or silenced should he survive-which, of course, he did.

Multiple sharpshooters were firing at the motorcade for several purposes as it passed through Dealey Plaza. First, they were to create an ambush environment--a distraction so that the murder blast from within the car would not be recognized for what it was. Second, they were to shoot Governor Connally. Merely as a third priority they were also to hit the President with a shot or two just as insurance against any possible malfunction of the murder device within the car. Vice President Lyndon Johnson was not a target as he was a part of the whole conspiracy.

Once it was recognized that the murder blast came from within the car from a position of firing slightly upward into Kennedy's face, all the contorted and forced explanations you have heard cease to be necessary. The bazooka-like blast very naturally threw him violently backward, inflicted the incredibly massive head wound that killed him and threw debris all over the rear deck of the car. Furthermore, it was all too clear why the Conspirators would have wanted such an elaborately rigged car destroyed immedi-This could not have been done, by the way, without orders or at least approval from the new President, Lyndon Johnson. It is

also obvious why Kennedy's preserved brain was spirited away. Well, actually a lot of things took place in transferring the body and routing of that body from Dallas back to Washington and I have already covered that portion elsewhere so I shan't repeat it all. But the body ended up in Washington with no brain at all.

At any rate, the outline of the 25th Amendment cooked up by Nelson Rockefeller years prior was proposed to Congress only three weeks after Kennedy died.

Also, seizing on the complete lie that he had been killed by a lonely loony with a cheap gun, a powerful campaign was launched to disarm the American people under the euphemistic banner of GUN CONTROL! LBJ was used to ramrod massive chunks of the disastrous Rockefeller governmental program through Congress--all the time saying "Let's do it for Jack".

Deep involvement in Indo-China helped the Rockefellers to eventually attain the control they desired over vast high quality oil reserves in that region which rival those of the Middle East and South China Sea (I knew you knew that!). The Rockefellers, who were the biggest munitions makers in the World--the merchants of death--would and did reap incredible profits at the expense of taxpayers money and GI's lives and injuries.

The whole event was set up and fully orchestrated by the CIA and is linked all the way to your present President Bush and colleagues in terror.

Yes, one Roscoe White was one of three CIA operatives who literally fired shots that day in Dallas. White was known by code name "Mandarin" and his two accomplices were known as "Lebanon" and "Saul". Do you find those code names interesting--perhaps well trained operatives through the Mossad of Israel? These were expertly trained assassins.

These things sometimes bear upon a man's mind until he breaks. Roscoe White was a family man and was a regular "church-going 'Christian'". The son, Rickie Don White, had overheard his parents discussing the matter with a minister as Roscoe White began to repent his soul burdens. He had kept a diary which was accidentally recovered by the son at his father's death. That Dallas minister, Rev. Jack Shaw, was a close family friend and came forward with truth about Ricky's mother, Geneva, who had overheard her husband and Jack Ruby discussing the plot before the assassination.

At Mr. White's insistence, Mrs. White later underwent four shock treatments to "help her forget what she heard". Shortly before Roscoe White's death, Mrs. White began to remember what had happened after speaking with a man in New Orleans who was involved in organized crime. She confronted her husband who then told her much of what happened.

Well, Geneva is the only other person who has total familiarity with the diary's account of the assassination but somehow, she is suffering such poor health that she is not *allowed* to speak with anyone. And so the sordid stories go - - -!

Roscoe White died in 1971 from burns "suffered in a fire" of questionable origin. I don't believe we have to "question" it too much, do you?

In 1988, the entire subject came to the forefront of the media again and Ricky White was nudged to reveal the diary. He contacted the FBI but did not release the diary to them--IT IMMEDIATELY DIS-*APPEARED*, HOWEVER. Ricky White was so badly shaken by his treatment at the hands of the federal agents, who grilled him for over five hours, he refuses to fur-"The ther cooperate with them. FBI scared me so bad, I completely dropped my father's investigation, White said.

Tom Kirspel, supervisor of the Midland FBI office, would neither confirm nor deny that the agents had seen the diary.

WHAT PROMPTED WHITE?

In March of 1989 White contacted officials of the JFK Assassination Information Center in Dallas, who

were interested, but unconvinced. Their inquiry picked up in June when White found hidden in his grandfather's home in Paris, Texas, a metal cylinder containing his father's Marine Corp dog-tags and three coded intelligence messages that refer to a directive to carry out the assassination.

One of those messages, dated in 1963, states the objective of the exercise was "to eliminate a national security threat to worldwide peace". Interesting, to say the least, I would guess.

Further, the Dallas police officer, J.D. Tippit, who was killed following the assassination, was killed because he had seen too much. HE WAS KILLED BY ROSCOE WHITE AND NOT BY OSWALD AS BLAMED. ROSCOE WHITE SERVED IN THE MARINES WITH OSWALD. Oswald was a part of the conspiracy but only incidental as a confusion factor. He did not realize he would be the blamed assassin and he fired no shots at all.

CIA SPEAKS FOR ITSELF IN DENIALS

Mr. White was the man on the famous "grassy knoll" who fired two shots that hit Kennedy in the throat and head as the President's motorcade passed through downtown Dallas.

As a result, most of you would pay little attention to the foundation on which all else would rest. Underlying all the smiles and happy words, there was to be an agreement by which American troops would be sent to the Middle East as supposed guarantors of the "peace". It would all be made to appear logical and honest, and no one would dare to raise a finger to criticize the plan.

But guess what was really planned far back in those ancient days?--for only if you know the truth will you have any chance to protect yourself in the disastrous days that lie ahead for only small tid-bits have been changed.

This all had to do with plans for Nuclear War. That war plan had nothing to do with preservation of your so-called "National Security"-it was a last-ditch Rockefeller blueprint for national suicide. But my word, chelas, the players have gotten more deadly and more ruthless on every count. Rockefeller is only a public "double" to keep you distracted by his confusing presence so that you can't see the trees for the forest.

First, the Camp David summit was to set the stage for Middle East war while seeming to do the opposite. Then, as soon as the special American forces would be in position for their strikes against the Russian space triad, a major incident would poison the Middle East peace atmosphere. One option involved the Siani, but other options were also being prepared. Regardless of the details of the incident, it would be staged in such a way that the finger of guilt would point toward Saudi Arabia. It had to be that way for it had to be an enemy of Israel and I assume that you can see that that has been currently accomplished.

Tensions would build fast, and with them American public opinion against Saudi Arabia. Meanwhile the Rockefeller propaganda machine would excite fears that somehow the Soviet Union was preparing to move full blast in the Middle East. There would be additional incidents and clashes, and the very existence of Israel would appear to be at stake. At the same time, America would be reminded of the key role of Israel as a military ally in the Middle East. American public opinion would be inflamed with fear for Israel, anger at Saudi Arabia, and a desire to get tough with Russia--and then it would happen.

Well, in the current plan, Russia isn't playing ball according to the rules. She has cleverly joined in the pretense of efforting to settle the squabble with Iraq so you don't have any EXCUSE to nuke her. I remind you that the Bolshevik/Zionists want to start a nuclear war and regain Russia--DO NOT MISS THE POINT OF THIS MANEUVER. Russia does not want war but the bullying will continue until some incident will be created heinous enough to precipitate response. It is a "do it now" or delay longer and perhaps give the world a chance to find out the truth of the circumstances. Which will it be? Dear ones, you had better pray very diligently for Hussein and Russia this day.

Back then, in the world's first limited nuclear strike, Saudi Arabia would be brought to her knees at a single blow. Back then, in this way nuclear warfare would begin to be domesticated in your minds and no longer unthinkable.

The cut-off of Saudi-Arabian oil would trigger gas rationing in the U.S. and severe dislocations in Europe and Japan. This would provide an excuse for Jimmy Carter to declare a "NATIONAL EMER-GENCY" as the U.S. secretly prepared to go to war. Jimmy Carter's energy crisis--that was the moral equivalent of war--would be manipulated into reality. Across the Persian Gulf from Saudi Arabia, Iran would react to the oil field raid by going on a full scale nation-wide alert. The Shah would point to the serious rioting which had an anti-Western flavor. He would point to ominous behavior by the Soviet Union, and he would raise the spector of a Russian attack on Iran like the American-Israeli attack on Saudi Arabia.

With Saudi Arabia gone, Iran would be America's largest remaining source of Middle East oil. With gas rationing already under way by then, Americans would find the Shah's warnings very frightening. The Shah would publicly remind Washington of the "total U.S. commitment to come to Iran's aid in an emergency" which was announced on November 16, 1977. Ah, the intrigue of year to year hindsight!

The American public would demand that it was time for the U.S. to stand up to Russia and, with full public support, American troops and weapons would pour into Iran. From that point onward, the outbreak of Nuclear War One would be all but impossible for the public to follow by way of the so-called

"news".

Incidents and clashes would condition the American public to the increasingly aggressive behavior of Russia. You would hear more and more about Civil Defense, especially the plans to evacuate your cities in the event of war. But, when it would happen, all government and the major media would be "caught completely by surprise". It would begin, according to the American first-strike strategy, with the surprise attacks against the Russian space triad. SPECIAL PREPARATIONS

Special preparations were under way to make the follow-up attack on Russia more effective and to evade the Soviet defense system as much as possible. For example, America's fleet of giant Titan II ICBMs were being modified for fractional orbital bombardment by Martin-Marietta, the Titan's manufacturer. The work was being financed through a number of secret avenues. One example was the \$32,000,000 contract from NASA to build a rescue rocket for SKYLAB, which of course was already destroyed.

Another factor in the follow-up American nuclear war was to be high-power laser weapons in two ways--the first way had to do with your ICBMs. Floating over all American ICBM installations were Soviet Cosmospheres--they were there in order to blast your ICBMs at the moment of launch, using their Charged particle Beamweapons. But one of the secret American weapons programs was the Laser Program. Some time previously laser scientists solved a major technical problem in high power laser weapons. Called "thermoblooming", the problem made lasers relatively ineffective when fired within the atmosphere but the new high-powered lasers were being deployed near your major ICBM bases.

Just before the missiles would be launched, these lasers would be used, if possible, to shoot down the threatening Cosmospheres. Then the missiles would be launched at Russia. The other role of lasers in the planned war was to involve the moon.

Your Secret Rulers knew very well that the destruction of Russia's Cosmosdromes would trigger a furious counterattack and, in particular, the lunar Particle Beam bases were certain to start blasting American targets on earth. In order to at least reduce the damage which the moon would be able to inflict, several extremely high-powered lasers were deployed on CIAcontrolled ships at sea. INTERNATIONAL ATOMIC ENERGY AGENCY (IAEA)

Although not one in a thousand of you have ever heard of such a thing, the world depends on this little-known regulatory authority to keep a check on atomic weapons and on the materials needed to fabricate them.

Every five years, the 70-odd nations who are members in good standing of the IAEA gather for a formal assembly to review the status--and to censure the violations--of the covenant known as the Nuclear Non-Proliferation Treaty (NPT)-the basic law that currently sets the rules for nuclear research and production among civilized nations.

Under the NPT accord, nations are divided into two categories. So-called "nuclear-weapon states" are the major powers--the U.S. or the USSR, for instance--that have "manufactured or exploded a nuclear weapon or a nuclear explosive device prior to January 1, 1967.

The second category includes the smaller countries who are latecomers to the atomic age. These governments, if they want to belong to the NPT, must permit teams of IAEA inspectors to supervise their atomic installations and to verify that the fissionable materials they may legally acquire are used only for peaceable pursuits, not to make nuclear weapons.

Surprisingly enough, Iraq has long been rated as one of the most dutiful and well-behaved members of this nuclear non-proliferations club. In fact, Iraq has adhered to the NPT covenant as early as 1969--before the USSR. Its conduct has been impeccable ever since Saddam Hussein came into power.

In the American press, Israel has the white hat, and the Arabs must wear black. But in reality, Israel has been condemned as an atomic bandit by every international forum from the UN on down.

Because of the illbehaved Israelis, the Arab bloc fought long and hard for international sanctions against the worst outlaw atomic power--Israel--and they almost got their way at the 1985 IAEA general assembly. But--they were blocked by the U.S., whose delegation intervened to protect Israel, as they do in ALL international forums.

Thwarted in their legal moves against Israel's atomic banditry, the Arabs tried a new tack. In 1988-89, five additional Arab governments--Saudi Arabia, Algeria, Kuwait, Qatar and Bahrain--became signatories on the NPT and members of the IAEA. With these five added votes, the Islamic block expected to muster a vote condemning Israel at the next IAEA general assembly. But the U.S. government, pulling strings and weilding its financial influence among the small, subservient gulf sheikdoms, drove a wedge into the Arab bloc.

Once again, the CIA and the Mossad sowed division and intrigue in the gulf. However, this time they are very well likely to harvest the whirlwind and thunderstorm. With the Arab voting bloc at the then-upcoming IAEA assembly split and impotent, the enraged Saddam of Iraq threatened to leave the inter-

national nuclear regulatory system. Well, less than a full month later-you see the handwritten page already put to press in the Middle Fast.

CRISIS A GODSEND TO TRILATERALS

The Trilateral and Bilderberg groups have immense stakes in Mexico and other Latin American countries. There, labor is cheap and plentiful and not burdened with such costs as minimum wages, pension funds, vacation days or health insurance which are imposed on American firms through legislation or federally arbitrated union agreements.

Now watch the speedy hand moves. Mexico has oil and Venezuela has lots of oil.

In a related development, congressional investigators charged the Treasury Department with giving Mexico a \$192 million subsidy by selling that country underpriced bonds to help it reduce its foreign debt.

The criticism by the General Accounting Office could influence the current negotiations between Venezuela and its private bank creditors, since the South American country is expected to request Treasury Department support for a debt reduction package similar to that obtained by Mexico.

The Treasury Department simply circumvented the congressional appropriations process in that Congress has "the Constitutional prerogative and responsibility for appropriating public money for allocating it to subsidize foreign governments!"

Meanwhile, back in the domestic oil fields, these economic burdens keep oil wells in Texas capped and unemployment high while the bankers call for American tax dollars to prop up the Mexican oil industry to meet a "shortage" that doesn't exist because of a "crisis" they manufactured.

Funny thing-Mexico is producing at near-full capacity, relates the DOE. But the bankers are calling for American tax dollars to be used for further exploration and drilling in that country. Ah, so be it and Selah.
