In the period of 1791-1894, the number of flowing into the United States was also stepped problems in China with the spotlight of world concern shining upon them, the plutocrats of the Knights of St. John and the Order of the Garter transferred some of their attention to Persia (Iran).

'The ACLU in St. Louis is working with us, but because no attorney has yet been appointed, they too are stymied for the moment. If the

public defender's office does not appoint an attorney by Monday, we will try to find an attorney who will take the case pro bono, either through the ACLU or as a friend of Political Prisoner, Gunther Russbacher.

"Most lawyers who are familiar with our case know that one of our lawyers was murdered in June of 1993 and another was disbarred in 1993. This doesn't make it easy to find a lawyer, especially one who will take the case pro bono due to the fact that the last four years of incarceration have financially bankrupted Russbacher and his family."
