**IRS raids tax-protest group.** Federal agents arrest leaders of Parker-based Liberty Foundation in three-state operation. By Ann Carnahan, Rocky Mountain News Staff writer: Parker—The IRS has crushed the nations' biggest tax protester group, accused of bilking more than 10,000 people and the federal government of at least \$21 million.

Federal officials Monday swooped into the Parker offices of the Liberty Foundation, which claims Americans don't have to pay income taxes.

Six people were arrested in simultaneous raids in Parker, Aurora, Utah and California, where the group was based until early this year.

"Their avowed goal is the destruction of the IRS," Steven V. Giorgi, head of criminal investigations at the agency's Sacramento office, said Tuesday. "They have not succeeded."

The group's leaders, Phillip and Marlene Marsh, conduct workshops across the country on ways for taxpayers to "legally and permanently" remove themselves from the "voluntary" tax system. [H: Indeed, a worthy cause but so "against" the "system" that they could not be allowed to succeed. Until you people learn to stop fighting with little guns against the big guns, you cannot "win". You must play within their games and within their laws, even if they are not "Constitutional" because it is the NEW LAW OF THE LAND! These people did not have real "Constitutional" care about your nation and your freedom. They chose a fragment which could be built into a money-making market and sink a lot of unsuspecting participants into trusts, etc., which were destined to do you in.]

They coined the term "untaxing" to describe that process.

The foundation, formerly called the Pilot Connection Society, moved from Stockton, Calif., to Parker after it was raided by federal agents.

Leaders recruited people who "had trouble" with the Internal Revenue Service, Giorgi said.

Members paid between \$45 and \$10,000 for kits and services to learn how to disappear from tax rolls forever and conceal money in offshore trust accounts.

Giorgi would not rule out arrests of other members. He said that some were "willing participants" in defrauding the government, but that many were simply victims.

"All that many of them ended up doing was delaying the final call with the service," he said.

Phillip Marsh, 69, and Marlene Marsh, 57, who earned between \$1 million and \$6 million in 1991, according to affidavits, were arrested in Los Angeles.

Their daughter and son-in-law, Jill and Darrell Spencer, were arrested in the Denver area. Darrell, 25, was the general manager, and Jill, 27, was the office manager.

A foundation administrator, Robert Singleton, 59, was arrested in Salt Lake City, and Douglas Carps, 48, the trust producer, was already in prison on another charge. Two other foundation leaders were being sought.

All will be charged with conspiracy, mail fraud and aiding and abetting. If convicted, they could each face seven to 10 years in prison, Giorgi said.

Parker police and Douglas County sheriff's deputies participated in the raid, which culminated a three-year investigation by the California and Colorado office of the IRS.

As he spoke to reporters, Giorgi stood by a large photo of the Marshes.

## Estate Planning Today! (PART 1)

**Keeping Control but Giving Away Ownership.** Moving your assets into a corporation can be very prudent estate planning. We will take a look at how you pass your estate corporately to your family and making it work without probate and attorney's costs. There are many approaches to family estate planning that are valid and excellent ways of preserving family estates. But this area of the tax and legal world needs to be carefully considered because the tax and legal rules are always changing. One thing I want to note, is if someone has a sizable estate and ends up using one of these strategies, work with a competent accountant and legal counselor to make sure that everything has been put together properly. Because again, the rules are changing all of the time. The IRS wants everything that you have and it is your job to keep it from them!

Planning for the next generation is important. Currently there is great concern about changes coming that will effect the amount that is allowed to pass through estates from parents to children. Today, individuals can pass \$600,000 to their heirs without any estate taxes on that money. There is talk, at least with the Democratic administration, that this is going to change to \$200,000. I wouldn't doubt that in the next 5-10 years, with the way the tax situation is going, that it will be included as regular income for tax purposes. It may come down as low as \$100,000 or even lower. It is something for everyone to think about who has assets that they plan on giving to their heirs later on. Estate taxes can eat up about 1/2 of a family's estate and then usually attorneys, probate and court costs come in and eat up 1/2 of that, leaving little of the estate left for the actual heirs to work with. Start making plans because there are creative ways of keeping the government out of your pocket.

When working with a corporation, you want to start by moving or transferring real property into the corporation to protect those assets from probate and high estate taxes. While other types of assets may also be protectively moved into your corporation, you would likely want to start with real estate. We have a legal instrument known as a Grant Bargain Deed; this document works in California for transferring property from an individual's name into a corporation. Some counties require the use of a Quitclaim Deed.

There are documents that each county has that you would fill out to show if this is a transfer, or a sale. By making it a transfer, you successfully place your property into your corporation and avoid sales taxes. In some counties, like Los Angeles County, you have to prove ownership of the corporation by bringing in your stock certificates and showing them that you are still the owner of this corporation and that actual ownership has not changed—only the name the property is held

under has changed. In some cases you may not want to show the connection between yourself and that piece of property and your corporation, therefore you can go through the process of selling it to the corporation. It depends on what kind of visibility you want with the corporation.

Always remember your corporate formalities and have a corporate resolution drawn up authorizing a corporate representative to transfer the property into the corporation and the corporation accepting that property.

When transferring a vehicle into a corporation you would start off with a corporate resolution. In transferring a vehicle into a corporation keep in mind that you would be making a public announcement about your ownership of that corporation. To avoid this just sell your car to the corporation. You would then go through the same process that you would if you were to sell a car to any other party. Go in to the vehicle registration department and present your stub from the title and go through the process of reregistering the vehicle into the new owner's name (which would be the corporation). Take time to weigh the benefits of placing vehicles into a corporate name because you may find that your insurance rates will take a big jump on a corporate car. Look before you leap.

**Personal Affects:** To move personal affects into your corporation, your corporation would need a resolution that states the specific personal affects that are going to be transferred into it. Another way to handle this is to use something as simple as a Living Will. Your personal assets are always changing. Living Wills are simple to use and to create; you can get forms for them at office supply stores or a bookstore and they cost maybe \$25.00. You just list your home furnishings and other items that you wish to pass to your heirs and that way you are going to eliminate any court situations after you die. Keep in mind that Living Wills will only allow you to avoid probate, not estate taxes. (PART 2 CONTINUED NEXT WEEK 12/28/93)

## JANET RENO AND GUN LICENSING

In the December 10 edition of the *FINANCIAL TIMES* (London), in an article by George Graham, "Attorney General Janet Reno, who has been asked by President Bill Clinton to study the proposal, said yesterday she strongly favoured a licensing test to show that individuals can safely and lawfully use a gun.

"I think it should be at least as hard to get a license to possess a gun as it is to drive an automobile," Ms. Reno said.

"A taskforce of mayors and city police chiefs also backed gun registration in a meeting yesterday with Mr. Clinton to discuss crime and violence.

"Mr. Clinton has not taken a firm position on the idea of registration, but he said yesterday that he believed the U.S. was now ready to act on violent crime. 'We have to move and I think we are prepared to move,' he said.

"The mayors' taskforce also called for a ban on the manufacture, sale or possession of all semi-automatic assault weapons and their components, much higher taxes on firearms and ammunition and much stiffer controls on gun dealers."

## JIHAD

In an AP article appearing in the December 9 edition of the *JOHNSON CITY PRESS*, Algeria: "Morale is low, nerves are on edge. And no end is in sight in the guerrilla war by Islamic extremists that has pushed Algeria to the brink of chaos.

"People count the friends and relatives who have fled, disappeared or been killed.

"Two years ago, robed fundamentalists paraded around the capital like conquerors after winning the first round of parliamentary elections. Today, they're in jail, in hiding or joining the  *Jihad* , an increasingly nasty holy war now said to feature mutilations and other scare tactics to bolster its ranks.

"Allegations of fundamentalist brutality are countered by equally grim reports of torture and abductions by government security forces."

## NATO

In the October 9 edition of the *FINANCIAL TIMES*, "A new Nato command system enabling allies to send task forces for peace-keeping and other missions outside their own territory is due to be drawn up within six months," writes David White.

"A U.S.-inspired Combined Joint Task Forces scheme, which would involve setting up flexible headquarters able to deploy ad hoc forces is set to be formally approved by allied leaders at their Brussels summit on January 10-11."

## CUBA EXPORTS MILITARY ADVICE

In an article written by Jonathan Broder, appearing in the December 13-16 edition of the *WeWMMB* ["The First Independent Russian-American Newspaper"], "Cuba is trying to raise money by selling the one export it perfected during the Cold War—its military expertise.

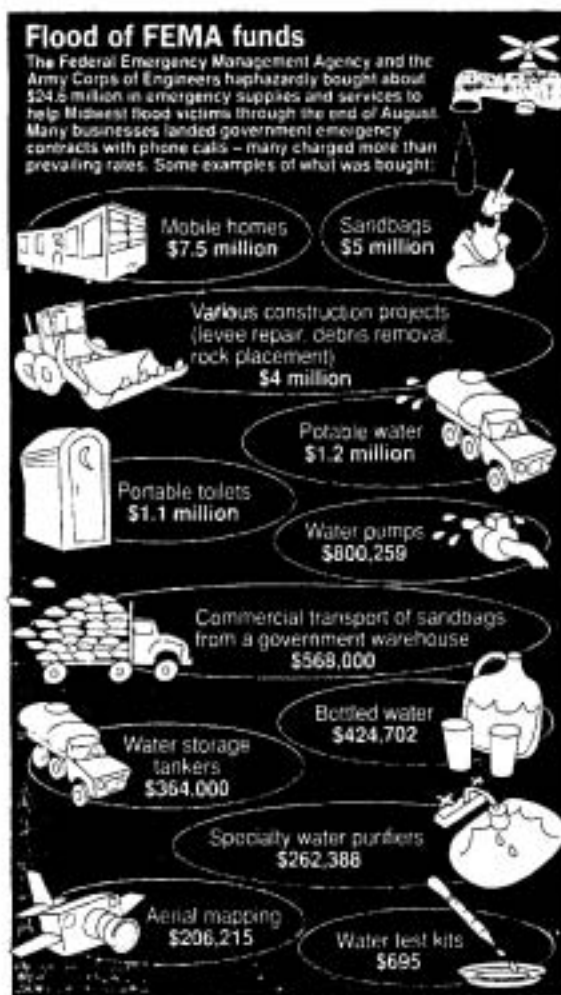
"U.S. officials say Cuban military advisers have been turning up in Iran, Lebanon and Angola over the past year to help those countries rebuild their armed forces. Unlike the Cold War days, when the Cuban leader Fidel Castro provided such services for ideological reasons, today's Cuban advisers are working strictly for cash."

## HAPHAZARD SPENDING

In an AP article written by Jennifer Loven, appearing in the December 6 edition of the *ALBUQUERQUE JOURNAL*, "During the summer's Midwest floods, government emergency contracts were awarded so haphazardly that companies could land business with a simple phone call and agencies sometimes paid far more than prevailing rates, a review of contracts shows.

"Disaster agencies, scrambling to help flood victims, hastily signed off on millions of dollars worth of contracts for urgently needed items from generators to bottled water.

"Amid the chaos of such a vast disaster, federal officials readily acknowledged they chose convenience over frugality."



## CLINTON ON NORTH KOREA

In an article dated back on December 9, appearing in the *JOHNSON CITY PRESS*, "President Clinton expressed reservations that 'a full-blown crisis' with North Korea can be averted and said that if conflict comes, he is sure the United States can 'do what we need to do.'

"Clinton, sounding a new note of pessimism on breaking a stale-mate over nuclear inspections, declared that the United States had 'looked at all possible contingencies and I hope we are not headed toward a full-blown crisis.'"

## MISSILES CHANGING DIRECTION?

In an article from the December 6 edition of *THE NEW YORK TIMES*, in an article by Michael Gordon, "In a largely symbolic move that could reduce the dangers of accidental launchings, the Pentagon has drafted a plan to aim its nuclear missiles at desolate spots in the open seas and is talking with Russian generals about how to put a mutual pledge to *detarget* into effect.

"For months now, these officials toiling in underground command centers have been working on another top-secret task: figuring out how to aim the hundreds of missiles in America's nuclear arsenal away from Russia."

## BOMBING IN TEXAS

From the December 3 edition of *THE GLOBE AND MAIL*, in an article by Matthew L. Wald, comes the following: "Mishaps at a weapons plant in Texas have slowed the U.S. program to reduce its nuclear arsenal. In one incident, technicians dropped the heart of a nuclear bomb about 50 centimeters, according to a report by Congress's General Accounting Office. In another, they let radioactive gas escape from a weapon. In a third, there was an operational failure involving a truck that carries bombs on interstate highways, resulting in a halt to shipments of weapons.

"As a result of the mishaps, workers at the plant had taken apart fewer than two-thirds of the bombs they had planned to dismantle in the plant's past fiscal year.

"The Department of Energy, which owns the plant, known as Pantex, in the Texas panhandle near Amarillo, wants to dismantle 2,000 weapons a year as part of the reduction of the U.S. nuclear stockpile from 21,000 weapons in 1990 to 3,500 in 2003.

"The process is difficult because the bombs contain radioactive materials surrounded by high explosives meant to detonate the bomb. Explosives in older bombs—the first to be dismantled—are sensitive to heat and shock."

## CANADA'S DEBT

The following comes from an article out of the December 8 edition of *THE GAZETTE*, (Montreal) and is written by Rob Carrick: "Canada's national debt is on track to hit \$1 trillion and overshadow virtually all economic output by 2001."



AIDS — A RARE CASE?

In the December 5 edition of the *ALBUQUERQUE JOURNAL*, in an article by Herb Jackson, "A rare case in which the AIDS virus was passed from one child to another living in the same house has been documented..."

"But the doctors warned against public overreaction..."

"We do not think this will alter school or day-care situations..."

"The researchers said they believed the children, who lived in a foster home, passed the virus through a toothbrush or a nose-bleed."

SECRET NUCLEAR TESTING

In a recent edition of the *FINANCIAL TIMES*, from an article by George Graham, "The U.S. admitted yesterday it had concealed more than 200 nuclear tests since 1945 for fear of giving information to the Soviet Union."

"Mrs. Hazel O'Leary, the energy secretary, said yesterday the U.S. had conducted 925 nuclear tests between 1945 and 1990, including 204 previously undisclosed."

"Mrs. O'Leary said the announcement was 'a foot in the tub' for the energy department's plan to release far more information about its activities and restore public trust in the agency for the important debate about where and how to store nuclear waste."

Oh yes, I feel much more trust now.

RUSSIAN PROPHECY

In the same edition of the *FINANCIAL TIMES*, "The following gloomy prediction is not the pre-election bombast of the communists, but the prophecy of Mr. Boris Nemtsov, one of Russia's ground-breaking economic reformers and a candidate in this weekend's parliamentary elections. 'Unfortunately the next year in Russia will be a year of tremendous inflation, unemployment, strikes, factory closures and very acute political conflicts. I see nothing good in the future.'"

ABM TREATY

In a little article appearing in the December 5 edition of the *MODESTO BEE*, "The United States is seeking changes in the Anti-Ballistic Missile Treaty that would enable it to defend American forces and allies against missile attacks by Third World countries. The ABM Treaty, completed in 1972, prohibits defenses against intercontinental missiles. A State Department spokesman said a new approach is needed to address the problem of defending against attacks from states that may develop shorter-range missiles."

IRS REORGANIZATION

From the December 2 edition of the *DENVER POST*, comes the following information in an article by Albert Crenshaw: "The Internal Revenue Service yesterday announced plans for a fundamental reorganization of the agency that will affect as many as 20,000 workers and could increase the agency's effectiveness in tracking down tax cheats."

"The reorganization fits with the Clinton administration's 'reinventing government' initiative but primarily is an outgrowth of the IRS's \$12 billion replacement of its computer system. The new systems will reduce by about 34 percent the number of people needed to process tax returns and do other manual chores."

90s CHILD CARE

In an article from the *LOS ANGELES TIMES*, appearing in the December 5 edition of the *MODESTO BEE* and written by Bettijane Levine: "What teacher would deny a hug to a crying child? Or reject a toddler's plea for a moment of closeness?"

"Many would—and do, children's advocates say. A decade of highly publicized child-abuse accusations—from the McMartin preschool case to Michael Jackson—has taken a troubling toll: more parents on the alert for child molestation; more teachers afraid of being wrongly accused. Three million cases of suspected child abuse were reported last year, up from 1 million 10 years ago."

"And now, some experts say, the nation's youngsters are paying the price for adults' increased fears. An unwritten edict has been issued at many schools and day care centers across the nation: Do not touch the little children."

"As in: Do not hug, kiss, lift, stroke, offer your lap, rub the back, tuck in the shirt, pat the hair, or be in any way physically responsive to their needs. It has all gone too far, some of the nation's leading child-development experts say."

BRAZIL'S NEW CURRENCY

In the December 8 edition of the *FINANCIAL TIMES*, in an article by Angus Foster, "Brazil yesterday announced a wide ranging package of measures, including the introduction of a new currency, designed to tackle the country's soaring annual inflation rate of about 2,000 percent."

IRAN-CONTRA REPORT

In a somewhat old, but interesting, AP story from the December 4 edition of the *MEDFORD MAIL TRIBUNE*, "In a sharp attack on two former presidents, the Iran-Contra prosecutor's final report concludes that Ronald Reagan 'set the stage' for the scandal's illegal activities and George Bush failed to tell the truth about his role, according to sources familiar with the document."

"Lawyers for Reagan and Bush have read the report by Iran-Contra prosecutor Lawrence Walsh and were quick to dispute its conclusions. Reagan's lawyer called them 'utterly irresponsible' while Bush's attorney called on Walsh to 'fold his tent.'"

FREE TRADE PACT

In the December 7 edition of the *FINANCIAL TIMES*, Damian Fraser writes, "Mexico, Venezuela and Colombia have concluded negotiations on a free trade pact to come into effect in the first half of next year, according to Mexico's

trade ministry."

"The treaty will bring together economies with a combined population of about 150 million."

BUYING LAND IN RUSSIA

In an article from the December 13-26 edition of *WeWMMB*, Tad Stewart writes, "Despite President Yeltsin's recent decree freeing land sales, it nearly is impossible for foreign investors to buy land in Russia, leaving leasing as the only effective way to obtain long-term use of property."

"But the latest decree offers some loopholes that may benefit foreign investors if the new Parliament doesn't close them."

"Direct foreign ownership of land remains a highly sensitive political issue and the Parliament may well reverse Yeltsin's decree or at least close the loopholes Western lawyers see."

THE VATICAN & ISRAEL UNITE

In the following article by Peter Steinfels, appearing in the December 15 edition of the *DAILY NEWS*, and written for *THE NEW YORK TIMES*, "Israel and the Vatican will end years of diplomatic standoff by establishing official relations by the end of this month, Israeli officials and American religious leaders said."

"The agreement, which follows 18 months of intensive behind-the-scenes diplomacy, is said to include a pledge by the Catholic Church to join Israel in new efforts to oppose anti-Semitism."

# Ray Renick Update

Ray: I'm kind of hesitant about mentioning anything that's in the paper because every time I do I kind of get on the Commander's [Hatonn] list, you know when I first came...

Rick: Can you talk up a little bit?

Ray: Sure. When I first came there, I mentioned something about Bo Gritz not being exactly honest and everybody looked at me like I was blaspheming, you know.

Rick: Right.

Ray: The way it turned out, many times, I was right. In the paper you had an article about Project Monarch.

Rick: Yes.

Ray: Project Monarch is so old it's got moss growing on it.

Rick: So old it has moss growing on it?

Ray: The name was changed to Project Marathon.

Rick: Marathon?

Ray: Yes, as in marathon runner. And it is connected with a thing called Saturn Schools.

Rick: Saturn Schools?

Ray: Right and another thing called TESSERECT (spelled out) School.

Rick: Ok.

Ray: And it's all got to do with the kidnapping of children and taking them out of the country like Monarch has.

Ray: Well, two other people that have been political prisoners have been released also and I can't give you their names yet, but there might be something happening in this vein. There must be some reason why they are letting these people out.

Talk about Project Monarch. Somebody should take a good look at people like Claudia Gritz and stuff.

Rick: Oh?

Ray: Yeah.

Rick: That's an interesting hint. Can you tell me more?

Ray: I got a real bad cold a couple of days ago. It's colder than hell in here, but I'm alright now, I guess.

Rick: Can you request more blankets or whatever?

Ray: I don't know. I don't talk to these people very much and they don't talk to me. I think they are starting to get the idea at least. They used to mock me a lot when they went by.

Rick: They probably have an idea now that there is something to it.

Ray: Right. They've started looking the other way. They've opened enough of my mail and monitored enough of my phone calls. They ought to know something.

Rick: Do you have any court hearings coming up in the near future?

Ray: Not till January.

Rick: Well, I guess you're just kind of on ice, so to speak, in the meantime.

Ray: The Public Defender came to see me and I gave him a whole list of maybe 20 things here. Any one of these things could get everything thrown out of court, but I don't think he's going to do anything. I think he is just going to sit on his thumbs and I'll have to go to court cold turkey like I did last time.

Rick: Well, I told you that Gary Wean volunteered to testify on your behalf, if he were served with a subpoena.

Ray: That's right. That was the first thing I told the guy. I told him to get in touch with Gary Wean, Dennis Dale, all these are [Judge William P.] Clark connections.

Rick: What's the Public Defender's name again?

Ray: Mike Adams.

Rick: I'll give this information to Gary Wean. I don't know if he'll do anything with it but I'll give it to him anyway.

Ray: Ask him if he knows anything about where Dennis Dale is at.

Rick: Who is Dennis Dale?

Ray: He was the DEA that was in charge of that central tactical unit that was investigating Riverside County and San Luis Obispo County during the Inslaw blockade where they were trying to shoot all... and this is between '81 and '84 when Michael [Riconosciuto] was there and (garbled) was on [the Cabazon] Indian reservation. This is the also the same time that I was ...two friends of mine, Scott Alexander and Mike

Davis were allegedly working for the DAPS and the DEA right here in San Luis County and they were on the same investigation that Dennis Dale was on investigating San Luis County and they got into the District Attorney's office of both Riverside and San Luis County and the Judges, and of course, the main Judge in this County being Ronald Reagan's buddy, [William P.] Clark. Ronald Reagan spent a lot of time on Clark's ranch, you know. So, I was told at that time, but I wasn't given specific names back in '84 and '85 that this whole thing went all the way up to the highest officials in the land, this drug trafficking thing, this Operation Zapata. Ray: So, I mean he is in this up to the

eyeballs and he was my Judge. Nice huh?

Ray: Hey, I don't think Jim Vassilos is going to be around too much longer, I'd like to have you interview him and see what he says. You got to look to the people that are in real bad shape, that are dying in prison. These are the people you have to listen to not the people that are driving around in prestigious airplanes. Then there are other people like Bo Gritz that flies all over the country in his airplane and he's not worried about his airplane being blown up like John Tower, and John Heinz and many other people.

Rick: Well, I will give Jim a call just to see what's going on right now. If there have been that many people killed around him, then there is something going on.

Ray: You may have trouble getting him because he is hiding out most of the time, and most of the time you will just get his answering machine. You may have to try a number of times.

Rick: Ok. Well, I'll call him. Thank you, Ray.

workers. **So that means a hundred million dollars a year is paid out to nobody. Get the message?**

Rick: Yes, I do.

# Conversation With Jim Vassilos

12/15/93 RICK MARTIN

*(In the above telephone conversation with Ray Renick, prisoner in San Luis Obispo, California, and exposé of Judge William P. Clark and the "SLO Connection", Ray mentioned that he felt Jim Vassilos, disbarred attorney from Chicago, might be the next Paul Wilcher [former attorney for and close friend of Gunther Russbacher who was suicided some months ago]. He expressed concern over Jim's physical safety and recommended that I telephone him and listen to what he had to say. What you are about to read is that conversation.)*

Jim: Ok, what area are you interested in?

Rick: Well, Ray mentioned that there have been quite a few people killed around you and he was concerned for your own health and well being. Can you tell me about that?

Jim: Well, on September 9, 1993 Gordon Arnett, one of my colleagues, was murdered here in Chicago and he was murdered over a civil case that could expose a deep covert Israeli black-budget operation. He was apparently murdered by the Mossad, one of their teams.

Rick: What kind of operation was it?

Jim: Well it's a "black". Well, it's basically the bankruptcy courts in Chicago, but what they did was, they traded the sewer department for the bankruptcy courts, in other words the bankruptcy bust-outs were originally run by Italians. In order for what's called the patch to be put in to patch over to trade one thing for another so that the money that the Italian Mafia was making out of the bankruptcy courts could be transferred to the Israelis and Golda Meier (thirty years ago was known as the great shmaltzer) put in the patch; in other words, she agreed to give them the sewer department if the Israelis could take over the bankruptcy courts, for their black-budget operation. Rick: Yes, there is protection in God,

Dear Mr. Martin:

Thank you for your letter to Attorney General Dan Lungren regarding an alleged hate crime.

If you have information which you believe may indicate criminal conduct on the part of any of the individuals referred to in your letter, we suggest you submit firm proof to the district attorney in the county where the incident occurred.

The state Attorney General undertakes the role of a prosecuting officer in specific cases only when a county district attorney is disqualified from the case or when he or she (without justification) fails to act. Based on the information you have provided, and a review by our office of the case, we have determined that this office cannot take action in this matter.

## OATHS OF OFFICE . . . AND MORE WACO

(Puyallup, Washington) . . . Recalling the 61-days of government atrocities played out against the Branch Davidians in Waco, Texas, it would be most telling to verify the Oaths of Office of the various officials involved, especially the Governor of the State of Texas, and the Chief Law Enforcement Officer of the State of Texas, the Attorney General. Once determined, this information should be published and made available to potential jurors who will decide the fate of the 12 surviving Branch Davidians, who are being forced to stand trial this January in San Antonio, Texas, as the result of a ten-count Federal Grand Jury indictment. The ten-counts include: *Conspiracy to Murder Federal Officers*; 18 USC 1114 and 1111 - *Murder of Federal Officers*; 18 USC 924 (c) (1) - *Possession of a Firearm During the Commission of a Crime of Violence*; 28 USC 5861 (d) - *Possession of an Unregistered Destructive Device*; 18 USC 371 - *Conspiracy to Unlawfully Manufacture and Possess Machine Guns*; 18 USC 922 (b) *Unlawful Possession of Machine Guns*; and 18 USC 2 - *Aiding and Abetting*. It is abundantly clear the federal government will, as they did in the Randy Weaver trial in Boise, Idaho, fold, spin, and mutilate justice using whatever means of deception necessary to arrive at "plausible deniability" of any wrongdoing. And like the

Why is it important to know about the Oaths of Office? The State of Texas as a sovereign power by the mandatory provisions of the Constitution upon all State Officers, is the *ultimate power* to either approve or deny permission to the foreign corporation, *The United States Government*, or any of its agencies to move forward with bringing its military force and *federal jurisdiction* to bear upon the Citizens of Texas. If the powers being asserted by those assuming the Oaths of Public Trust are without their Oath being properly executed and filed, then those powers are necessarily being *usurped unlawfully* and without the will and consent of the governed. In addition, Title 18 of the United States Criminal Code at Section 1385 prohibits the use of the Army or the Air Force as a *posse comitatus* against civilians and is punishable by a fine of not more than \$10,000 or imprisonment of not more than two years, or both. With the Constitutions being generally recognized as a "contract" between government officials and the people, when any official voluntarily enters into the contract, by entering upon a sacred Oath of Office, he or she is bound by the mandatory terms of that contract. When the people of the State of Texas elected Anne Richards at the polls to be Governor of Texas, a deal was struck - a "contract". The Citizens agreed to entrust her with the exercise of certain *enumerated powers* contained in the lawful Articles of the Texas Constitution and provisions of statutory law. In return, Governor Anne Richards agreed to swear to exercise the power of the Governor's office *only* within the terms and limitations of the Texas Constitution. But if the official Oath of Office is not carried into fruition by following the provisions of Texas State Law, such as filing the Oath of Office with the Secretary of State prior to discharging the duties of that office, the Governor's office is said to be *standing vacant*.

The positive law embodied within Title 18 of the United States Criminal Code at Section 1621 states that, "Whoever - (1) having taken an oath before a competent tribunal, officer, or person, in any case in which a law of the United States authorizes an oath to be administered, that he will testify, declare, depose, or certify truly, or that any written testimony, declaration, deposition, or certificate by him subscribed, is true, willfully and contrary to such oath states or subscribed any material matter which he does not believe to be true; or (2) in any declaration, certificate, verification, or statement under penalty of perjury as permitted under Section 1746 of title 28, United States Code [28 USC 1746], willfully subscribes as true any material matter which he does not believe to be true; is guilty of perjury and shall, except as otherwise expressly provided by law, be fined not more than \$2,000 or imprisoned not more than five years, or both. This section is applicable whether the statement or subscription is made within or without the United States [emphasis added]."

This situation creates the potential for unlimited legal chaos. Laws signed by the Governor during the last two years could very well be without the force of law; the entire Executive Branch of the Texas State Government could be without lawful authority to enforce any law or regulation. Moreover, innumerable criminal convictions could be called into question and all civil court cases prosecuted by Attorney General Morales and the entire Attorney General's office - which derives its authority from the Attorney General's Oath of Office - could also be unlawful.

According to information received here, Texas Governor Anne Richards and Texas Attorney General Dan Morales were elected to office in 1990. Once elected, they were *mandated* by Texas State Law to take an Oath of Office that was to be kept on file by the Texas Secretary of State. Interestingly, the Oath of Office of Attorney General Morales, which was dated January, 1991, was not *file stamped* until March, 26, 1993, and Governor Richards' Oath of Office has *yet to be located* by the Secretary of State. Upon prima facie evidence, it appears probable that the Governor and the Attorney General had not taken their respective Oath of Office for two years after they were elected. This being the case, then, it follows that any official duties they have performed or anything they have signed in an official capacity in the last two years are unlawful and a nullity, without any legal merit.

premises and under the Drug Interdiction Assistance Act, 10 USC 374, 379, assistance by Department of Defense personnel and military equipment were utilized under authority granted for such use by Texas Governor Anne Richards. Of course, no such drug activity existed.

Waco has placed a "gag order" on attorneys, which prohibits them from discussing the case.

38 Am Jur 2d, Section 1: "Under the constitutional provisions of the several states defining the powers of the government and vesting them in three separate branches - the legislative, the judicial, and the executive - the executive is charged with the authority and power of causing the laws to be duly executed and granting commissions to all the officers of government for the exercise of their respective functions for the benefit of the whole . . . The office of governor does not exist by virtue of the common law. Under the American system it is constitutional, and the people of the state by amendment to their constitution, may abolish the office altogether." Section 4: Emergencies do not create power or authority in a governor, as the executive, but they may afford occasions for the exercise of powers already existing."

Under the statutory powers conferred upon the Governor, in the instance of the State of Washington, the governor is the sole official organ of communication between the government of this state and the government of any other state or territory, or of the United States . . . the governor shall see that all offices are filled, and the duties thereof performed, or in default thereof, apply such remedy as the law allows; and if the remedy is neglected, acquiescent the legislature therewith at its next session.

7 Am Jur 2d, Section 1: "A state attorney general is the chief law officer of the state, to whom is usually entrusted not only the duty of prosecuting all suits or proceedings wherein the state government is concerned, but also the task of advising the governor and other administrative heads of the government in all legal matters on which they may desire his opinion. In most, if not all states, the attorney general is a constitutional officer."

In Washington State, a similar problem exists involving not only the Governor, but virtually all State Officers within the Executive Branch. In the case of Governor Mike Lowry, while his Oath of Office was properly administered on January 13, 1993, after being elected, it was *not* read until April 29, 1993, thereby violating the statutory provisions of the Revised Code of Washington and causing the Office of Governor to become vacant as a result of that violation. RCW 43.01.020 is implicitly clear that the oath or affirmation *shall be read* in the Office of Secretary of State *before the officer shall be qualified to discharge any official duties*. Also, RCW 42.12.010 states that every elective office *shall become vacant* upon any offense involving a violation of his or her official oath or by his or her refusal or neglect to take his or her oath of office, or to give or renew his or her official bond, or to deposit such oath or bond *within the time prescribed by law*.

The seriousness of failing to properly execute the Oath of Office becomes readily apparent when one understands that a person is guilty of the crime of "criminal impersonation" when he or she pretends to be a representative of some person or organization or a public servant and does an act in his or her pretended capacity with intent to defraud another or for any other unlawful purpose. Under Washington Law, "Criminal Impersonation" is a gross misdemeanor. In addition RCW 9A.80.010, "Abuse of Office" defines Official Misconduct as the act of one who intentionally refrains from *performing a duty imposed upon him by law*, also a gross misdemeanor. Similar provisions exist within the statutory provisions of Texas State Law.

An information in the nature of a *Writ of Quo Warranto* may be filed against any person when they shall usurp, intrude upon, or unlawfully hold or exercise any public office or franchise within the state and is the proper civil remedy at law for trying the title to a public office, that is, to determine whether the incumbent has unlawfully usurped or intruded into, or is unlawfully holding such an office, and if so, to oust such incumbent therefrom, and lies for the protection of the public and the benefit of the community rather than for the gratification or protection of any particular individual, and is in the nature of a public prosecution to recover to the state, usurped or forfeited offices.

Reportedly, not one of hundreds of "visiting judges" in Texas have Oaths of Office on file. Not one! Which implies that when they hear a case, they may not be obligated to "uphold and obey" the Constitution. This in turn may explain why "visiting judges" are routinely employed as "hatchet men" to handle *politically difficult* cases in Texas. No doubt, the forthcoming Branch Davidson trial will be one of those *politically difficult* cases in which the federal government will undoubtedly attempt to bury the evidence and the true nature of what really happened in Waco, Texas leading up to the February 28th assault, and 51-days later, on Monday, April 19th, 1993, the illegal smashing into the Branch Davidson home of upwards of 96 men, women, and children with military tanks from nearby Fort Hood, the gassing of those persons with tear gas and nerve gas, the cold blooded murder (with a bullet to the forehead) of David Koresh and perhaps as many as two (2) dozen others, the killing by lethal injections so that all of the remaining inhabitants in the compound who had not already been murdered, would perish . . . and did perish in the hellish conflagration which ultimately consumed them and their home and destroying evidence at the crime scene. Already it is rumored widely that prospective jurors will be *chosen in secret* and their identification will remain anonymous.
