### TO THE HIGHEST BIDDERS

Senators like Sen. Dennis De Concini voted to pay away the U.S. Canal at Panama even though he received thousands of calls and letters from his constituents, telling him not to vote for the Carter-Rockefeller fraud. De Concini did it again with NAFTA and GATT, because he knew that he could not be called to account

to the voters of Arizona through their State Legislature. De Concini knew that no matter if he was not reelected, his lobbyist cronies had a cozy future all lined up for him and so he as able to thumb his nose at the Sovereigns of the State of Arizona.

There are some who would say that the lawmakers meant well when they adopted the 17th Amendment. To them I would say, "Did the Congress also mean well when it passed the Federal Reserve Act in the same year?" I think not. We should take care not to give the benefit of the doubt to those who, from the very beginning of this infant Republic, laid plans to destroy it FROM WITHIN. That plan included the destruction of the near-perfect system for the election of Senators in the original Constitution.

In its place we have a babel of voices, a polyglot mob of special interest groups, Lobbyists, buying and selling the Senators who are supposed to represent We, the People, in a noisome, hubbub of the Turkish bazaar, where millions of vote-buying dollars trade hands almost every day in what has become Treason Hill. The Senate buildings have become a mosaic of foreign interests, where people from every corner of the world lord it over the debased Sovereigns of the several States. **The 17th Amendment MUST BE REPEALED.**

Take another example of a senator gone astray, Senator Stevens. Some time ago a letter was sent to Sen. Stevens at the time he violated his oath to uphold the Constitution, by voting for so-called line-item veto powers for Pres. Clinton, thereby violating the principle that neither of the three branches of government can transfer their powers to each other. Sen. Stevens never bothered to respond to the letter: after all, it was not as if it came from some political action group or powerful Lobbyist.

Imagine the surprise when I heard that the Tenth Amendment Enforcement Act of 1996 was sponsored by Sen. Stevens. The bill would require, inter alia, that all proposed legislation cite the constitutional authority for the power sought by the bill. This is merely a restatement of the rule when legislators in the period 1880-1900, always insisted upon this provision and added the second proviso—not contained in the Stevens bill—that the measure be properly debated as to its constitutionality.

[H: Can't you see, citizens, that your Constitution is simply laid aside on a dusty shelf and is TOTALLY IGNORED?]

I cannot expect Sen. Stevens to be aware of this as I don't believe he has ever made a study of the *Annals of Congress*, the Congressional Globe and the *Congressional Record*. In my view, as I have so often stated, a minimum period of 5 years of intensive study of these documents might qualify one as an individual who knows something of the Constitution. [H: Do not ever err in expectation of any POLITICIAN knowing anything at all about the Constitution!]

As noble as Sen. Stevens' 10th Amendment Act of 1996 appears to be, what the Senator has to do is first work to repeal the line item veto power measure he gave to Pres. Clinton. Sen. Stevens should RESIGN his position as chairman of the Conference Committee to reconcile differences between the House and Senate versions of this vile instrument and publicly state his opposition to it. Until then, I, for one, will have serious doubts about what Sen. Stevens stands for.

[H: Yes indeed, a line item veto power sounds GOOD. The reason being that lots of garbage is sneaked into bills which should not be placed there. However, you will note that what happens in political circles is that the line item vetoed would end up being the only good legislation in the whole of the Bill. Where there is a sneaky way of doing something TO YOU-THE-PEOPLE, the politicians will find it and USE IT.]

Someone phoned me to say that I had better realize that a U.S. Senator is the most powerful person in government. That is a view with which I thoroughly disagree. A U.S. Senator is merely a SERVANT of We, the People. *It is the Lobbyist who is the most powerful person in Washington D.C.*

It is worth quoting Gibbons again, because his description of Rome A.D. 285, seems to describe most of the largest cities across America:

"...if we except the inimitable Lucian, this age of indolence passed away without having produced a single writer of original genius, or who excelled in the arts of elegant composition. The authority of Plato and Aristotle, of Zeno and Epicurus still reigned in the schools and their systems transmitted with blind deference from one generation of disciples to another, precluded every generous attempt to exercise the powers, or enlarge the limits, of the human mind. The beauties of the poets and the orators, instead of kindling a fire like their own, inspired only cold and servile imitations."

For 50 years after 235 A.D. there was no public order, as murder and wholesale theft became an epidemic, threatening in a most dastardly manner, all life and property and where nowhere was it safe to be. The Roman Empire reverted to an Oriental Despotism ruled by Diocletian. One might be forgiven for thinking this a description of Washington D.C. and indeed most of the cities of the United States today in 1996.

The social organism introduced by the Pilgrims and nurtured by the Founding Fathers and the Framers of our beloved Constitution gave the North American Continent a new civilization where the total worth of the individual was emphasized and eulogized, where a strict moral code was established and was expected to grow, where religion, art, philosophy, legislation, law, a system of a government controlled by We, the People who were called the Sovereigns, was laid down. This was in every sense of the word an original creation of esthetic and intrinsic beauty. This was a decisive moment when the cornerstone of a new civilization on the basis of the Christian religion was laid down in the North American Continent.

Rome became debased when citizenship became available to all and sundry. The same is happening on a far more vast scale with the United States. Citizenship and sovereignty go hand-in-hand and are the basis of any nation that can be properly called a nation.

The question of United States citizenship has become more and more clouded, and deliberately so. Nowadays the definition of citizenship embodied in the Constitution is virtually nullified. It is a good thing to look back in our history and examine the role played by the Democrat (Socialist) Party, in bringing this about. It is also a good thing to look back at the history of the Roman Empire, the mightiest in the world at the time, and which collapsed for much the same reasons which

are causing the United States to collapse.

The Edict of Caracalla (Constitution Antoniniana) of 212 extended Roman citizenship to all free inhabitants of the empire, with one or two small exceptions. Caracalla (really Caracallus) angered native born Romans and there was heated opposition to the decree because most of the leaders at the time felt that citizenship was thereby thoroughly demeaned; citizenship now meant so little and was seen as part of the process of the leveling-down of distinctions which had been long standing from Rome's beginning.

The attack on the *U.S. Constitution* and *Bill of Rights* continues to gather dangerous momentum. The Fabian Socialists, who in 1895 recognized the *U.S. Constitution* and State Constitutions are the biggest single impediment to Socializing and then Communizing the United States, are in full cry. To those who would doubt that there is such a plan to Socialize and then Communize the United States, allow us to quote what one of the *ARCHITECTS OF COMMUNISM* had to say on the matter:

"I can prophesy that your grandchildren in America will live under Socialism. And please don't be afraid. Your grandchildren will not understand how their grandparents did not understand the progressive nature of a socialist society." Nikita Khrushchev, head of the Soviet Communist Party and President of the USSR, speaking on [an] American nationwide television program, June 1957.

When he was preparing to leave for his celebrated visit to the United States, Khrushchev made the following statement:

"We cannot expect Americans to jump from Capitalism to Communism, but we can assist their elected leaders in giving Americans small doses of Socialism until they suddenly awake to find they have Communism."

#### ATTACKS ON THE CONSTITUTION

Here are some of the parts of the *Constitution* being attacked, and remember, an attack on one part is an attack on the whole. The Supreme Court is in the vanguard of these attacks with the legislators not far behind.

In the current climate of passion and hysteria where stump speech laws are being rushed through the Congress, instead of calm, reasoned, dispassionate debate, there is rapidly developing a threat to the *Constitution of the United States* and the *Bill of Rights*, such as has not threatened the American people and their *Constitution* since the Civil War.

It is therefore the intention to review how much of a role the SUPREME COURT has played in shredding certain key amendments, and the role of the Court, the Congress and the Executive in this ever-increasingly violent assault on the *Constitution of the United States*. The subject matter of this article may be divided as follows:

- The Supreme Court.
- Separation of Powers.
- Executive Orders-Habeas Corpus.
- Interstate Commerce.
- Federal Elections.

There has been much discussion of late on the Supreme Court being *coequal* with the Legislature and the Executive branches of government. **THIS IS INCORRECT.** The Supreme Court was created by the Congress, as was the Executive department of government. Neither the executive branch NOR the Supreme Court come even close to being coequal with the Congress. The notion that the Supreme Court operates under a set of superior rules is without basis in fact. The Supreme Court is bound by the same delegated powers under which the Federal Government oper-

ates, and which bind the three branches of government. The Supreme Court Justices are bound particularly by the *9th Amendment*; they cannot read their own thoughts into law. In other words, the Supreme Court is one of the delegated powers, not original powers.

The Supreme Court CANNOT LEGISLATE, although it purports to do so more and more these days. The first tenet of constitutional law is very simple; the THREE branches of government CANNOT DELEGATE any of its powers TO EACH OTHER. The judicial department cannot delegate any of its powers to the legislative or executive departments and vice-versa. The legislative department cannot delegate any of its powers to the executive department.

For this reason no U.S. President has the power to make war on his own; he lacks war powers that belong solely to Congress. Congress likewise cannot delegate its authority to a private enterprise such as the Federal Reserve Banks which it purported to do through the Federal Reserve Act of 1913. James Madison and Daniel Webster both wrote excellent articles on the subject of separation of powers.

The Supreme Court can only make *CASE LAW*, and then ONLY if the Congress decides to place the Court's decision into so-called law. The tragedy of what is happening to the *Constitution*, thanks to Supreme Court rulings, is something to weep over. Increasingly, the Justices' predilections and opinions pass for constitutional law, forbidden by the *9th Amendment*. The constant flouting of the *9th Amendment* by Judges, if not checked, will end in the destruction of the *Constitution*. Their inroads into the *4th* and *5th Amendments* have virtually destroyed these two vital constitutional protections.

There ought to be a mandatory rule that every would-be judge first be tested as to his or her knowledge of what is the *Annals of Congress*, the *Congressional Globes* and *Congressional Record*, before they are appointed to the bench. Reading the speeches of Senator Thurmond of Ohio should be compulsory, especially for the Justices. Nominees for the post of Attorney General must have first spent at least five years in intensive study of these documents.

Sen. Thurmond was a great constitutional scholar and criminologist, whose style of debating issues can never be matched by our current crop of Washington politicians, whose fuzzy thinking, inability to properly debate a proposed measure, are the root cause of the thousands of bills that they pass, to the detriment of law and order, and which has created anarchy in Washington D.C.

The only thing "coequal" is that the Supreme Court through rule by predilection has caused as much confusion and crime as has come from the criminals and from Socialist legislators in the House and Senate. The Achilles Heel of the American people is that they do not know their *Constitution*, all the complex layers upon layers of it, which can only come with reading the *Annals of Congress*, the *Congressional Globes* and the *Congressional Records* over many, many years.

Senator Sam Ervin, the great constitutional scholar—perhaps the greatest of the 20th century—frequently and strongly disagreed with the Supreme Court and this shows in his comments.

His contributions to the *Congressional Records* on constitutional law should be compulsory reading for every judge and every legislator in the land, especially his remarks on pages 24932-24938, *Congressional Record*, Senate, Aug. 2, 1968, "How the Supreme Court is Performing Its Role as the Interpreter of the *Constitution*". The great constitutional scholar's criticisms of the Supreme Court were never muted and are just as valid today as they were in his lifetime. Ervin's opinions pointed up the fact that the crime situation today can be traced back to the U.S. Supreme Court, which constantly seeks to amend, not interpret, the *Constitution*, which practice must immediately be called into question and halted. What the predilections of the Supreme Court Justices have done to the *4th* and *5th Amendments* of the *U.S. Constitution* should be cause for the gravest concern on the part of the American people.

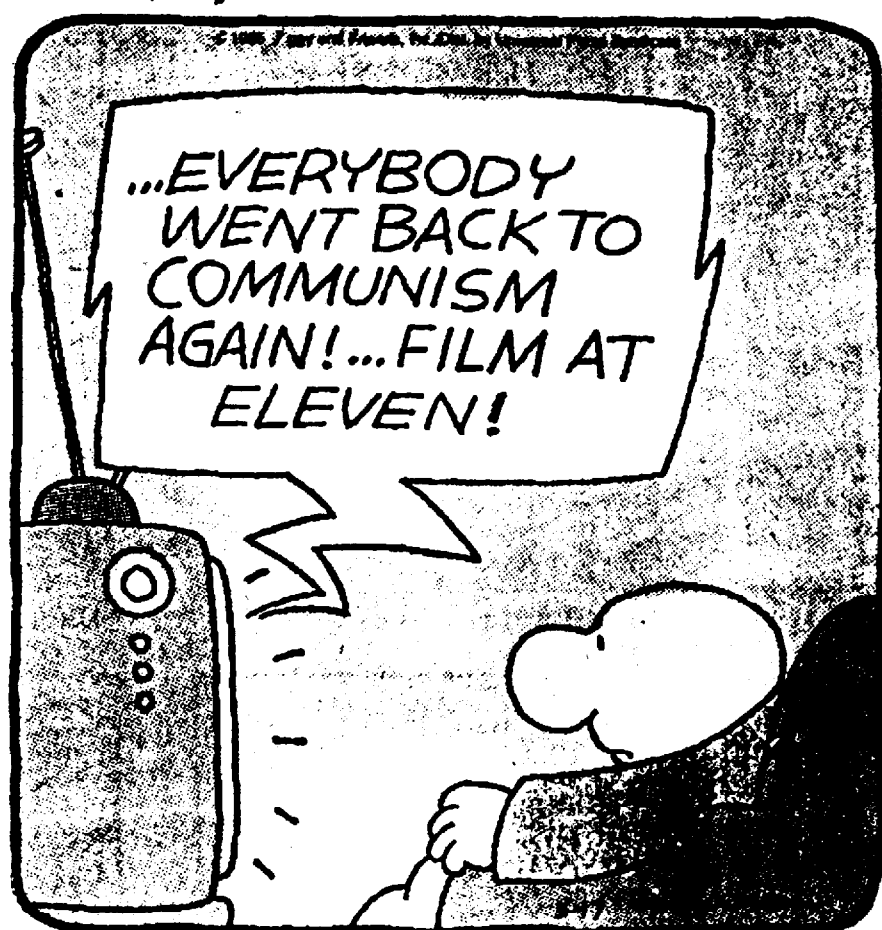
#### SO-CALLED GUN CONTROL LAWS

Senator Ervin's vast knowledge of the *Constitution* was never more clearly demonstrated than in his opposition to the scores of attempts to violate the *2nd Amendment to the Constitution of the United States*. One of the most dangerous attacks on the *Constitution's* equipoise is the Socialist/Marxist attack on the right of citizens to keep and bear arms. (Note: The *Constitution* does not talk about "hunting rifles" or "assault weapons"—classic Communist terminology—but only of ARMS.)

The "Citizens for Handgun Control", a thoroughly Marxist think tank graciously allows that citizens should be allowed to keep "sporting rifles" and recently, President Clinton echoed the words of this Marxist institution, using the word "hunting" while pushing for gun control legislation. We must not allow ourselves to become word-conditioned by such Tavistockian language.

Then we have the attempts by Senator Feinstein and others of her opinion, of whom Rep. Schumer is a good example, trying to give legal color to gun control. Time and again, Feinstein, Schumer, and the advocates

of violating the *2nd Amendment* try to tell us that guns come under interstate commerce rules. This is a **flat-out falsehood**. Attempts to stretch the interstate commerce clause to include guns is about as judicially false as the attempt to stretch *4th Amendment* rights to fit abortion. Regardless of what the Supreme Court has said, neither of these aberrations can be squeezed into the *Constitution*.

Through these two legislators in particular and in a more direct manner, the Federal Government tells us that it has **supervision and charge over guns**, particularly through the interstate commerce clause, which claim I have already dismissed as having **no constitutional basis** whatsoever. But the States kept their privileges and immunities in Article IV, Section 2, Cl. 1 of the *U.S. Constitution* and the Federal Government **cannot interfere**.

The Brady Bill is an example of gross infringement of the citizen's right to keep and bear arms. It also violates the *9th* and *10th Amendments*, and Article III, Section 2, Cl. 3 of the *United States Constitution*. No bill like the Brady Bill can have any force of law, and especially not at the federal level, for the simple reason that an attempt to make a criminal bill out of it, falls down in the face of the existing, prior *2nd Amendment* right which cannot be supplanted by the Brady Bill.

In addition, one has to read Article III, Section 2, Cl. 3, in conjunction with the *10th Amendment* and the *2nd Amendment*. The first, Article III, Section 2, Cl. 3, states as follows:

**"The trial of all crimes, except in cases of impeachment, shall be BY JURY; and such trial shall be held in the State where the said crimes shall have been committed..."**

It buttresses the *10th Amendment*. What Rep. Schumer, Sen. Feinstein and Pres. Clinton tried with the Brady Bill and indeed all other so-called gun control measures, was to **unconstitutionally co-mingle State statutes on crime violations with federal violations which is 100 percent UNCONSTITUTIONAL**. The Brady Bill is a perfect example of how this very serious and gross VIOLATION of the *Constitution* is being perpetuated.

St. George Tucker who fought in the American Revolution and who wrote *Blackstone's Commentaries*, said in his "View of the *Constitution of the U.S.*" on page 315:

**"The Congress of the United States possess no power to regulate, or interfere with the domestic concerns of any State; it belongs to them (that is, the States) to establish any rules respecting the rights of property; nor will the *Constitution* permit any prohibition of arms to the people; or of peaceful assemblies by them for any purpose whatever, and in any number, whatsoever they may see occasion."**

We need people in Congress who will **boldly acclaim this and challenge** Feinstein, Schumer, President Clinton, and all those legislators who hate the *2nd Amendment* and oblige them to obey the *Constitution of the United States*.

In other words, the rights under the *Constitution* cannot be twisted into a wrong tort by either the House and the Senate, or the White House. The Founding Fathers were quite properly afraid of big government, which is why the Federal Government was delegated only **very limited powers**. One of the strictest curbs on the central government is the *2nd Amendment*.

The right of the people to keep and bear arms has naught to do with hunting; it has to do with **protecting We, the People, against the excesses of a central government**. That was clearly spelled out by George Washington, St. George Tucker, among an overwhelmingly large number of the Founding Fathers in favor of the right to keep and bear arms. This is a recital of FACT, and not, as some would have us believe, "rebellion" against the Clinton Administration.

Without arms—which the British sought to confiscate—George Washington would not have been able to defeat them. Likewise, as we know from the history of Lenin, Stalin, Mao, Castro and the Khmer Rouge—plus our experiences with our own government at Waco and Ruby Ridge, we need arms to defend ourselves against a government that may wish to impose tyranny upon us when it feels the moment is opportune.

The right to keep and bear arms is a RIGHT and not a privilege embedded in the *Constitution* for the preservation of the sovereign powers of the sovereign citizen, and not for hunting or any other extraneous, imagined purposes. The Anti-Crime Bill and the Brady Bill signed by Clinton are no more and no less than an attempt to create a pretext to rob the American people of their right to keep and bear arms.

I read the Brady Bill on pages H2821-2880, *Con-*

*gressional Record*, House, May 8, 1991: "Providing for consideration of H.R. 7, Brady Hand Gun Violence Prevention Act..."

The fallacious, puerile, specious, nefarious, sinister, unconstitutional arguments set forth in the Brady Bill should be studied, really studied, by every patriotic American because it reveals how the minds of the haters of the *2nd Amendment* work. Our constitutional defense against those lusting after our guns is well-stated on pages 546—549 of the *Congressional Globe*, "Amending the *U.S. Constitution*" by Rep. Denison:

**"The Tenth Amendment** fixes the type of limitation upon organic law, and makes the Federal Government one of delegated, not original powers. We are not, therefore, to take any power by inference. The power to be exercised must be clearly expressed in the *Constitution* or we cannot take it. We have in the fifth article of the *Constitution*, the right to amend, for such is the word used, but NOT to make anew. It would not be an amendment to abolish the *Constitution*.... An amendment must therefore be something germane to the instrument or it is not an amendment but the making of a new constitution, and would only be binding upon such States who agree to be bound by it and could not be a part of the *Constitution* until every State shall adopt it..."

For gun control measures to become lawful it would require an Amendment to the *Constitution of the United States*, first, properly debated, and second, ratified by the States. Of course it would never make it past the first of several safeguards against some political opportunist. In fact, it could not even be brought to the floor of the House.

As to the patently unconstitutional Crime Bill, Congress cannot even sweep its own backyard clean and make it crime free. Almost every time the President makes a speech from outside of the White House, sirens can be heard wailing continuously in the background, only three blocks away. Yet Washington D.C. has the most comprehensive crime-prevention, gun control legislation in the nation.

Does the President really believe the Brady Bill will make one scrap of difference to the criminals in the District of Columbia, or anywhere else for that matter? If he does, he is extremely naive and does not know

the ingenuity, resourcefulness and cunning of the criminal mind is the basis of nearly all criminal law. Our laws spring from the resourcefulness of the criminal mind, that is why gun control laws punish the law-abiding citizen and not the criminal. Of course there are all types of criminal minds: It took very ingenious, resourceful, criminal minds to come up with the Federal Reserve Bank Act of 1913 and the U.N. treaty/agreement of 1945.

How then could the President sign H.R. 7 without violating his oath to uphold the Constitution? The fact is that he couldn't. When he signed H.R. 7, President Clinton VIOLATED his oath of office and should have been impeached. Trying to bring out the facts of Whitewater is fine, but here is a matter on which the President CAN AND SHOULD BE IMPEACHED.

Another point worth mentioning is that the Brady Bill violates the General Welfare Clause of Article 1, Section 8 of the delegated powers of Congress. The word, "welfare" means the common welfare of all of the sovereign citizens of the sovereign states, and does not in any way, shape, or fashion conform to the wants and desires of an individual. Individual welfare is NOT general welfare and is a Communist tenet from the Communist Manifesto of 1848.

The Brady Bill was wrongfully signed by Clinton to further gun control and in part to please one man's wife, Mrs. Sarah Brady, and it was an act of extreme selfishness on her part. There is another aspect to the Communist terminology "assault rifle" and we need to be clear on this; the term "assault rifle" is pure word-conditioning and as it is not mentioned in the Constitution, it is prohibition of term. IT IS A TYPICAL TAVISTOCK PHRASE.

#### WHAT OF TAVISTOCK AND TALK SHOWS?

The Tavistock method of "conditioning" used in their "long range penetration and inner conditioning" teaches that words can be used to change perceptions to such an extent that the target population (or group of any size down to an individual) can destroy thought, and replace it with the desired perceptions. With groups, they felt they were a part of something which was a reason to believe the group was right.

Recently, I happened to see, quite by chance, a Geraldo Rivera program pushing hatred of patriotic groups, whom he smeared from one end of the program to the other. In the course of the harangue, host Geraldo asked one of the participants if he recognized that a ban on automatic weapons "is the law of the land".

The participant agreed, not knowing any better, and probably thinking the "group" was the "stronger" power representing the law. But he was 100 percent wrong, as was Rivera. This is a Tavistock method of getting false statements across which are then be-

lieved by the majority, and it is amazing how participants in the type of TV talk shows so popular today, fail to realize how they are being manipulated to get across viewpoints other than their own.

The 1930 and 1968 gun control bills are as unconstitutional as the Brady Bill and Feinstein's "assault rifles" ban. The former violates the 2nd Amendment and the latter violates Article 1, Section 8, Clause 8, of the United States Constitution:

"To promote the progress of science and the useful arts, by securing for

limited times to authors and inventors the exclusive right to their respective writings and discoveries."

This denies government the authority to interfere with the science of developing modern rifles, so-called "assault rifles", which SHALL NOT be denied to the American people. There is no authority anywhere in the Constitution and the Bill of Rights that would grant Feinstein and her fellow Socialists the right to stop the sovereign citizens of the sovereign states from develop-

ing, keeping and bearing MODERN WEAPONS OF ANY TYPE. Feinstein and her Socialist colleagues and President Clinton violate this right by purporting to pass laws that INFRINGE on the right of the citizens to keep and bear arms, which includes modern rifles, the so-called "assault rifles". The description here given is intended to confuse and instill a sense of guilt.

If this were not so, then the same Communist forces could have prevented the United States from developing the nuclear submarine, the F-16 fighter plane, for example. These anti-American forces could have gone to the Supreme Court and sought an injunction to stop their production. "The enumeration in the Constitution of certain rights shall not be construed to deny or disparage others retained by the people."

The people retained the right to scientific progress, which brought them, among other items, the automatic and semi-automatic rifle, and if such items of commerce are made in the States, they are a part of the States' internal commerce, not subject to Federal Government control, especially not interstate commerce controls and there is no power in the Constitution that would allow the haters of the 2nd Amendment to pass laws that seek to INFRINGE ON THOSE RIGHTS. So where is the authority for the Feinstein and or Brady Bill or the 1968 Katzenbach Bill? It is not there! There is absolutely NO constitutional authority to restrict automatic and or semiautomatic rifles, weap-

ons, to the sole use of the Federal Government only, nor is there any constitutional authority for the Federal Government to ban their manufacture in the States.

#### INTERSTATE COMMERCE

During the 1920s—1930s, the *Congressional Records* reflect the history of Communist/Marxist/Socialists striving mightily to make children a part of interstate commerce—they called it "stretching" the interstate commerce provision of the *Constitution*—but did not try then to include guns. Even after the Civil War there was no attempt to disarm the Confederate States; the Communists (yes, we had them in abundance even in those times) knew better than attempt to take arms away from the Confederate States. The *4th Amendment* says that a man's home is his castle, likewise he has the right to defend his home which is not a part of interstate commerce and that right of self protection is the oldest right known to man. The Interstate Commerce clause is not found in the *Bill of Rights*. GUNS DO NOT COME UNDER INTERSTATE COMMERCE. The *2nd Amendment* is superior to the interstate commerce clause which in no way can be used as an excuse to override the right—and

note it is a right, and not a privilege—of the American people to keep and bear arms. This goes back to Colonial America and even before that, to Ancient Rome and Greece.

Nowhere in the interstate commerce clause is it expressly implied that the Federal Government can regulate guns or any other articles of commerce which are part of the internal commerce of the States. The States have individual commerce clauses through which they control all commerce in their States. The only place the Federal Government has any jurisdiction is where there is a bridge over a waterway connecting two States.

We need to ask ourselves, "Who is financing the Brady Bill and the massive public relations/brainwashing campaign that preceded its passage through the Senate?" The wounding of Brady came at a propitious time for the Socialist/Marxist haters of the *2nd Amendment*. Likewise, the shootings at the 101 California Street highrise in San Francisco provided an all too propitious, handy reason for Feinstein to present her 100 percent unconstitutional ban on "assault weapons" bill, a piece of glaringly unconstitutional legislation. The public was "word conditioned" into believing that there was a need for such legislation, when it was NOT a CONSTITUTIONAL matter but a criminal matter.

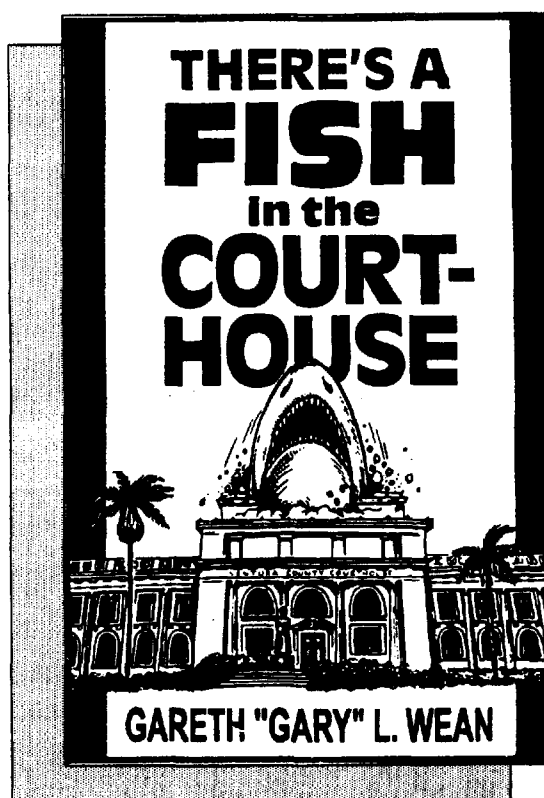

*Constitution*, not just parts of it.

The Warren Court's ruling on so-called separation of church and state was no more than a predilection decision. There is no basis for it in the *U.S. Constitution*. Great violence has been done to God through the imposition of this utter FALSE doctrine by the Supreme Court. The 1st Amendment says NOTHING about separation of Church and State. This shows how dangerous it is to let the Supreme Court get away with interpretation of the *Constitution* by predilection and then calling it "the law".

Justice Fortas wrote many opinions that sought to legalize the Communist invasion of the United States. Fortas was unmasked by Senator Ervin, and I would strongly recommend a close study of pages E7552-E7554, August 22, 1968, "Fortas lacks judicial restraint." More compulsory reading, in my opinion, would be pages 21135-21138, *Congressional Record*, House, May 15, 1969, "Excellent Testimony Against the Nomination of Justice Fortas", Representative H.R. Gross of Iowa.

Those legislators who in the past supported gun control measures like the unconstitutional Brady Bill and Feinstein's "assault weapons" infringement of the 2nd Amendment have willfully failed to uphold and support the *U.S. Constitution*, which the Founding Fathers held to be a most heinous crime. Any legislator and any private citizen (both have an equal responsibility to uphold the *Constitution*) who supports gun control attempts CANNOT be for the *Constitution*, or, put another way, support for gun control "laws" is a violation of the oath to support and uphold the *Constitution of the United States*.

Of course there are many "progressive, moderate, liberal" Socialists in both parties in the Congress who just haven't the ability to understand and assimilate the *Constitution* and the fact that constitutional law goes back to the Roman and Greek Empires. Even if they had the ability, it would be nullified by "inner conditioning" and group thought.

Washington's Farewell Address should be made part of the *Constitution of the United States* by way of an amendment ratified by the States. If this cannot be done, then the Address should be compulsory reading for all members of the legislative, judicial and executive branches of government, which should be included

in the "bar exam" of the *Constitution* as expressed above.

Pages S1525-S1527, *Congressional Record*, Senate, Feb. 19, 1979, "Reading Washington's Farewell Address":

"...to fix the true character of governments, as of other human institutions: that experience is the surest standard by which to test the real tendency of existing institutions of a country; that facility in changes, upon the credit of mere hypothesis and opinion [the basis of many Supreme Court decisions 1933-1995] exposes to perpetual change from endless variety of hypothesis and opinion: and remember, especially that for the efficient management of your common interests..."

Washington's warning about tampering with the *Constitution* is even more relevant today than when first published. This document was no product of "fast track" legislators, but was produced through intense effort that spanned five years. What Washington was telling the nation was, "beware of governments that recklessly deviate from the *Constitution* [practically every administration since Woodrow Wilson] with their hypotheses heaped upon piles and piles of hypotheses. The message of the *Constitution* is clear: keep government as small as possible; keep the Alien and Sedition Acts, and keep away from foreign entanglements."

There is a major lesson here for the revolution at the polls of the November 1994 elections, especially in the climate of hysteria that perverted America then, as it does two years further on, what with the President urging "instant action" on measures that the *Constitution* mandates MUST be properly debated. We have a whole slew of legislators, and sad to say, these include important members of the Republican Party in Congress, jumping to the crack of Clinton's whip in the most ill-advised downright deplorable knee-jerk response in a dangerous climate of hysteria, where calm, rational thinking is being driven to the wall.

The worst crime of all is to rush legislation through the Congress in a climate of overheated passions. Passion is the worst enemy of fair, constitutional legislation. Congress has been "word conditioned".

The Supreme Court saw to it that the safeguards of the Alien and Sedition Act and the unAmerican Committee were disposed of, and as a result, we have horrendous crime today. Page 1032, *Annals of Congress*, January 1795 "History of Congress Naturalization Bill":

"...It was political slander upon the fundamental laws and political institutions of our country to suppose that a few aliens, because they possessed titles in foreign countries after renouncing their allegiance to those countries, even if they were disposed to do it, could, as if by magic, overrun the established habits of our people, and the liberty of Government in which they incorporate themselves."

These words were aimed against George Washington, who had sought to protect the young nation from

the Jacobins and anarchists. We see now the folly of the Supreme Court of our time striking down this much-needed defense. The Supreme Court is not the law of the land, the *CONSTITUTION* is. The Justices went beyond their authority, starting with the Roosevelt Administration's appointees, and now act as if THEY are actually the *Constitution*. Let us remind them otherwise:

Article VI Section 2 of the *U.S. Constitution*:  
 "...this *Constitution* and the laws of the United States...shall be the supreme law of the land; and Judges of every state shall be bound thereby: ANYTHING IN THE *CONSTITUTION* OR LAWS OF ANY STATE TO THE CONTRARY NOTWITHSTANDING." [Emphasis added.]

It is important to note the use of the word, "shall" which is much stronger than "will". Another interesting thing is that federal judges are nowhere mentioned in Article VI, Section 2, and where the *U.S. Constitution* is silent on a power or proposed power, the power or law proposed is unconstitutional unless incidental to another power or is expressly implied or statutory law.

The *U.S. Constitution* is silent on federal judges like it is silent on political parties. So in reality, **POLITICAL PARTIES AND FEDERAL JUDGES ARE UNCONSTITUTIONAL**. The *U.S. Constitution* must be interpreted in the history and times of the Founding Fathers, otherwise statutory law becomes pure anarchy unless new amendments to the *Constitution* are passed.

Nor is there any provision for the Supreme Court to sit in their ivory tower in Washington like the **NINE UNKNOWN MEN of secret societies**. They should travel from state to state and try cases, like their earlier members, who traveled by horseback to the States for that purpose.

# The Untold History Of America

## Part III of a Series

To reflect for a moment on just how far we've come in the last 504 years, records available from the famous expedition of Christopher Columbus in 1492 show that, regarding the native peoples he encountered, (quoting:)

As soon as they see that they are safe and have laid aside all fear, they are very simple and honest and exceedingly liberal with all they have; none of them refusing anything he may possess when he is asked for it... They exhibit great love toward all others in preference to themselves. They also give objects of great value for trifles, and content themselves with very little or nothing in return... (End quoting)

The disparity between the native peoples who were as loving and giving as anyone could imagine, and the absolute brutality and barbarism of Columbus and his men, comprised a gulf unfathomable and incomprehensible to either group. The native peoples could never have imagined that their gracious hospitality would be met with the inhumane torture they received. And the greedy, conquering Columbus could not imagine that the natives would be so naive and ignorant of the ways of "civilized" man. Have we really changed so much today? Are the attributes of loving and giving revered as those most likely to help one get ahead and succeed in the corporate world or in society? Or has cooperation been replaced by apparent competition (there is no real competition anymore)? Many feel that it's a dog-eat-dog world and one needs to be very tough today to make it at all. Those who have manipulated the world for centuries appear to have been quite successful at making us all slaves to their system.

When we left off with Part II of this series, we saw that the U.S. had won the Spanish-American War in 1898, taking, among other things, the Philippines as one of our new possessions. Many have argued that this war marked the real birth of American Imperialism. There had been heated debate in the U.S. about whether or not we should take the Philippines. One report about how President McKinley had arrived at the decision to take the islands concerns what he allegedly told a group of visiting Ministers at the White House, (quoting:)

...The truth is I didn't want the Philippines, and when they came to us as a gift from the gods, I did not

know what to do with them... I sought counsel from all sides—Democrats as well as Republicans—but got little help.

I thought first we would only take Manila; then Luzon, then other islands, perhaps, also.

I walked the floor of the White House night after night until midnight; and I am not ashamed to tell you, gentlemen, that I went down on my knees and prayed to Almighty God for light and guidance more than one night. And one night late it came to me this way—I don't know how it was, but it came:

(1) That we could not give them back to Spain—that would be cowardly and dishonorable.

(2) That we could not turn them over to France or Germany, our commercial rivals in the Orient—that would be bad business and discreditable.

(3) That we could not leave them to themselves—they were unfit for self-government—and they would soon have anarchy and misrule over there worse than Spain's was; and

(4) That there was nothing left for us to do but to take them all and to educate the Filipinos, and uplift and civilize and Christianize them, and by God's grace do the very best we could by them, as our fellow men for whom Christ also died. And then I went to bed and went to sleep and slept soundly. (End quoting)

President McKinley was asleep long before he made that speech. It is understandable and to be expected that the reader may not have been able to get through that quote without getting a bit nauseous. It is difficult to imagine that McKinley actually believed that story, or that his audience would swallow it. So that is how American Imperialism was born? All new possessions from that day forward would presumably be "gifts from the gods", no matter who had to be killed.

Apparently the Filipinos did not get the same message from the gods. They decided to revolt against American rule in February of 1899. President McKinley said the fighting started when Filipinos attacked American forces. Later, American soldiers testified that the U.S. had fired the first shot, and an Army officer said his colonel had given him orders to provoke a conflict. It took 70,000 U.S. troops three years to crush the rebellion. Why didn't McKinley just send a copy of his above message to the Filipinos? On second thought, they may not have really appreciated it. Oh well!

Although there were economic panics in 1873, 1893 and 1907, it appears that a major thrust began about 1890 that included economic depressions, war and territorial conquests, deplorable working conditions and wages for the masses, strikes against those working conditions and wages, and a general unrest caused by severely stressing the entire economic situation—that was all aimed toward the achievement of a specific objective, namely, the total and complete control of America's monetary system. That objective was consummated in 1913 with the passage of the Federal Reserve Act, which, in essence, sold the United States, lock, stock and barrel, to the international bankers.

From that day forward, those bankers have owned our entire monetary system, even though our old *Constitution* forbids this. The *Constitution*, Art. I, Sec. 8, cl 5, states that only Congress shall have the power to coin money and regulate the value thereof. Congress exceeded its authority by delegating a delegated authority. It is inconceivable that the Congress was unaware of exactly what they were doing. Even if the reader has trouble accepting the fact that the United States of America was dissolved in 1861 (as discussed in Part II), thus leaving us with no legitimate Congress, it should not be too difficult to comprehend the fact that they did commit treason in 1913. This being the case, the consequence has been that we have not had a legitimate Legislative Branch of government since at least 1913; we have had no Congress. Let's see how all this unfolded.

By 1890, John D. Rockefeller's Standard Oil of Ohio was refining more than 90% of all American crude oil and was well on the way to international expansion. The Rockefeller family was the subject of repeated Congressional investigations for anti-trust violations and criminal conspiracy. In 1911, the Supreme Court of the United States ruled that Standard Oil had long been in violation of the Sherman Anti-Trust Act (passed in 1890). The firm had to be split, the holding company dissolved and its shares to be distributed among 33 companies to break up the monopoly. However, it soon became evident that Mr. Rockefeller owned 25% of the stock in each of the new firms, "...and that there wasn't a shred of competition among any of them". The new companies included Standard Oil of New Jersey, Standard Oil of New York, Standard Oil of California, Standard Oil of Indiana, Standard Oil of Ohio, etc., etc. (More recently, following World War II, Laurance Rockefeller visited Japan to get in on the ground floor of the new business action then taking place there. How many people know what SONY stands for? Apparently it is not a Japanese word. According to Colonel Fletcher Prouty it stands for Standard Oil of New York!!) The gigantic expansion of Standard Oil was made possible by funds provided by National City Bank of New York and Kuhn, Loeb & Co. The Sherman Anti-Trust Act, written by and for the wealthy, was designed to allow the incredible expansion of monopolies while making it appear as though they were actually being broken up.

Child labor was not outlawed until 1938. By the mid-1890s, because of the long depression, children worked side by side with their parents in sweatshops in New York City and elsewhere, under deplorable conditions, just in order to have food to eat and a place to live. As the 20th century began, 284,000 children between 10 and 15 years of age worked in mines, mills and factories. In Philadelphia, Pennsylvania, in 1903, children worked 60 hours a week in textile mills. New York City alone had 500 garment factories. A seemingly endless flow of immigrants supplied an incredible work force who would work for almost nothing. In the January 1907 issue of *Cosmopolitan* magazine, Edwin Markham wrote, (quoting:)

In unaired rooms, mothers and fathers sew by day and by night. Those in the home sweatshop must work cheaper than those in the factory sweatshops... And the children are called in from play to drive and drudge beside their elders...

All the year in New York and in other cities you may watch children radiating to and from such pitiful homes... their faces dulled, their backs bent under a heavy load of garments piled on head and shoulders, the muscles of the whole frame in a long strain...

Is it not a cruel civilization that allows little hearts and little shoulders to strain under these grown-up responsibilities, while in the same city, a pet cur (dog) is jeweled and pampered and aired on a fine lady's lap on the beautiful boulevards?

(End quoting)

The glaring contrast between poverty and wealth was here in America for all to see. The rich were

getting richer and the poor were getting poorer as the wealth of the nation was consolidated into fewer and fewer hands. By 1904, over 1,000 railroad lines had been consolidated into six major conglomerates, each connected with a Morgan family or a Rockefeller family interest. The Hawaiian Islands had been annexed by a joint resolution of Congress in July of 1898, in the middle of the Spanish-American War. And, of course, Marine Corps Maj. Gen. Smedley Butler was making Honduras safe for the American fruit companies in 1903, and he helped make Nicaragua a safe place in 1909-12 for the international banking house of Brown Brothers.

Everywhere, workers were becoming more and more fed up with the deplorable working conditions which were also unsafe due to low or non-existent safety standards. In 1904, over 27,000 workers were killed on the job, in manufacturing, transportation and agriculture. In New York City alone, in one year, there were 50,000 accidents in factories. Hat and cap makers got respiratory diseases, quarrymen inhaled deadly chemicals, and printers were getting arsenic poisoning.

Also, the number of women in the work force was increasing dramatically at the turn of the century. In 1870, there were about 19,000 women office workers.

In 1900, there were about 500,000.

As workers were no longer able to accept the intolerable working conditions, they resorted to striking for better pay, less hours and a safer working environment. In the 1890s, there were about 1,000 strikes per year. By 1904, there were more than 4,000 strikes per year. In a strike by textile workers in 1903 at Kensington, Pennsylvania, of the 75,000 strikers, at least 10,000 were little children.

Striking workers were more often than not dealt with by violent force, as the law and the military were used again and again, by the rich, in an effort to punish workers for even complaining about poor pay and conditions. On January 21, 1903, Congress created the National Guard, which was also used against striking workers. On September 10, 1897, striking miners were marching on a highway to the Latimer Mine in Pennsylvania. The local Sheriff and his deputies opened fire on them, killing 19, most shot in the back, with no outcry from the press. In 1909, about 6,000 workers struck in McKees Rocks, Pennsylvania against an affiliate of the U.S. Steel Co. The strikers defied State Troopers, and battled with them. In Spokane, Washington, in 1909, street meetings were banned. Thousands marched into the center of town to speak. One by one they spoke and

were arrested, until 600 were in jail. In a miners' strike in Colorado, the National Guard was called in. The Rockefellers paid the Guard's wages. There are numerous instances of this kind of brutality happening. An entire article could be written on this alone without exhausting the subject. Would people of today tolerate this?

Another very important objective of the wealthy was the control of the American educational system, which would turn the unsuspecting masses into perfect slaves. In a policy statement published in 1904 by the General Education Board, forerunner to today's Rockefeller Foundation, John D. Rockefeller, Sr. revealed his plans for education. He said, (quoting:)

In our dreams, we have limitless resources and the people yield themselves with perfect docility to our molding hands. The present educational conventions fade from our minds, and, unhampered by tradition, we work our own good will upon a grateful and responsive rural fold... (End quoting)

Was all of this just mind control of the masses? It would seem that way. And the Rockefeller brand of "good will" has only contributed to the destruction of true education.

All of this was part of a three-phase plan, used by the wealthy, known as "The Most Secret Knowledge"; a science which outdates history. It is as follows, (quoting:)

(1) Through the control of wealth comes the control of public information and the necessities of life.

(2) Through the control of news media comes control of information.

(3) Through the control of basic necessities comes direct physical control of people. (End quoting)

Concerted efforts to seize the power of government are as old as the institution of government itself. Remember, in politics, nothing happens by accident. If something happens, you can know for sure it was planned to happen. As well, government seldom, if ever, achieves only one objective by any singular event. War, for example, gains territory, it gains profits for banks, oil companies and manufacturers, it controls and employs the masses by getting them to believe certain propaganda, and it teaches other countries who is the boss. And the history of the event is then written by the winner, who, according to the rules of "control", will never tell the truth.

America had been dominated for some time by a hierarchy of wealthy families, including the Morgans, the Rockefellers, the Mellons, and Brown Brothers, among others. Historically, government has been the servant of private wealth, but the founding of the United States of America had reversed this trend, putting all power into the hands of "We The People". However, we also know that the wealthy forces, through the international bankers, regained control by establishing National Banks of the United States.

Prior to the artificially created (by the bankers) economic panic of 1907, Jacob Schiff, senior partner of Kuhn, Loeb & Co. of New York, had said in a speech before the New York City Chamber of Commerce, (quoting:)

Unless we have a central bank with adequate control of credit resources, this country is going to undergo the most severe and far-reaching money panic in its history. (End quoting)

In this very carefully orchestrated plan, the bankers were simply telling the people what would happen if we didn't succumb to their evil threats. And they made good on their promise. The panic of 1907 occurred in a good crop year, when industry was productive and America was enjoying general prosperity. During the panic, Woodrow Wilson, then governor of New Jersey, said, "All this trouble could be averted if we appointed a committee of six or seven public-spirited men like J.P. Morgan to handle the affairs of our country." Wilson was obviously ignorant of what was really happening. Yet, because he promised to support the Federal Reserve Act, the bankers supported him in

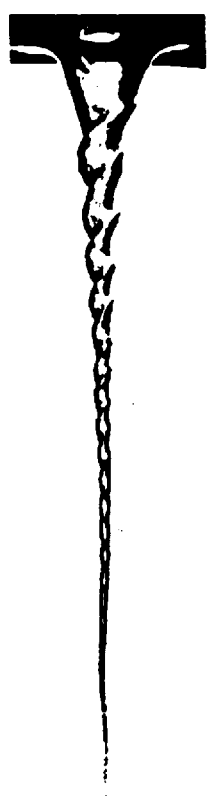

his successful bid for the Presidency of the United States.

Central and very instrumental to the overall achievement of this plan was a man named Paul M. Warburg, who had come to America in 1902. Paul Warburg was from the M.M. Warburg Co. of Hamburg, Germany. M.M. Warburg Co. was the chief representative of the European banking family of Rothschilds. By 1910, Paul Warburg was already a senior partner at Kuhn, Loeb & Co.

U.S. Senator Nelson Aldrich, one of a group of 5 Senators then ruling the Senate, was connected to major corporations, and devoted his powers to achieving the program of the international bankers. Aldrich was the head of the National Monetary Commission, created by Congress after the economic panic of 1907. It just so happens that the panic of 1907 was actually ordered by J.P. Morgan to wipe out the competition of certain banking, shipping and iron industries.

In November of 1910, Aldrich, Warburg, the Assistant Secretary of the U.S. Treasury, the President of National City Bank of New York, a senior partner of J.P. Morgan & Co., and possibly a few other prominent men held a meeting in total privacy at Jekyll Island Hunt Club (owned by Morgan), off the southern coast of Georgia. The purpose of the meeting was to draft the full plans for the Federal Reserve Act. In 1911, their plan became the official platform of the Republican Party. The collusion was deep among everyone involved in this insidious plan.

One of the most outspoken opponents of the Act was Congressman Charles Lindbergh, Sr., who said at the time, (quoting:)

This Act establishes the most gigantic trust on Earth. When the President signs this Act, the invisible government by the money power, proven to exist by the Money Trust Investigation, will be legalized. The new law will create inflation whenever the trusts want inflation. From now on depressions will be scientifically created. (End quoting)

To make a long story short, the Federal Reserve Act was passed by Congress on December 23, 1913. Presidential advisor Colonel Edward Mandel House (a representative of the Rothschilds) then convinced President Wilson to sign the Act into law. Wilson later regretted what he had done. Before his death, he said, "I am a most unhappy man—unwittingly I have ruined my country".

The *16th Corpus Juris Secundum* (a legal encyclopedia of the principles of American Law), at Section 141, states that Congress cannot delegate or sign over its authority to any individual, corporation or foreign nation. But the U.S. Court of Appeals, in the case of *Lewis v. U.S.* (1982), 680 F.2d 1240, stated that the Federal Reserve Banks "are independent, privately owned and locally controlled corporations". The Federal Reserve is no more Federal than Federal Express. They're both private corporations. Do we have a major contradiction here? It certainly appears as though Congress committed treason in 1913 by delegating a delegated authority. Or were they unaware of the *Constitution*? They all took an Oath to uphold and defend it.

What all of this boils down to is the fact that the international bankers set up in America the largest confidence game (con game) in the history of the world, before or since. And it is still in operation today. And why has no one in government ever put a stop to it? Would you believe they're all in on the take? The few who are not in on the take are ignorant of this complicated scheme.

(1) The U.S. Treasury orders the Bureau of Printing and Engraving to print some money.

(2) The Bureau of Printing and Engraving then sells this money to the Treasury for the cost of printing, which is about 2 cents per bill, whether it is a \$20 bill, or a \$100 bill, or a \$1,000 bill.

(3) The private Federal Reserve Bank places an order with the Treasury for money. The Treasury sells the money to the "Fed" for the same price they paid for it, the cost of printing.

(4) The Congress alerts the Treasury it needs money to operate, and the Treasury asks the Federal Reserve Bank for a loan. The Federal Reserve Bank happily loans the money, AT FACE VALUE.

(5) As if that's not bad enough, the Federal Reserve Bank demands security for the loan, so Congress authorizes the issuance of bonds to the Federal Reserve in an amount equal to the loan.

We are like birds with a broken wing. My heart is cold within me. My eyes are growing dim—I am old... (End quoting)

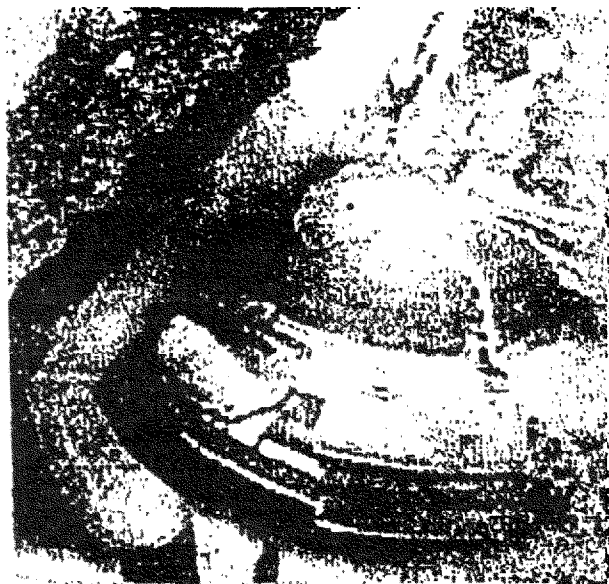

## UFO WRECKAGE NEAR TITANIC

From *PEOPLES MAGAZINE*, S. Africa, 8/5-18/96, [quoting:]

Wreckage of a spaceship found near the sunken *Titanic* proves the legendary ocean liner was involved with the UFO during its deadly plunge to the bottom of the sea.



The UFO was located just metres from the remains of the *Titanic* by a French-British oceanographic team. "Our pictures show the first real evidence of what happened to the *Titanic*," says Edmund Quincy, a member of the international team. "It's clear from the hole in the hull of the ship and the damage to the space vehicle that the two clashed somehow."

The saucer-shaped object has several massive cracks in it and a few huge pieces are lying around it.

## A COLLISION

Pieces that look like they come from the UFO were also found near the *Titanic* itself.

The researchers say this proves there was a collision.

No aliens were found because the explorers weren't able to get close enough to look inside.

Mobile robotic units were used to take videos and pictures of the crashed vehicle.

The sunken luxury liner was discovered on the sea bottom in 1985. Since that time, investigators have examined the hole that was supposedly caused by an iceberg.

## SMOOTH HOLE

"The hole does not appear to have been smashed by thousands of tons of solid ice," says Dr. Raymond Selzner, A Belgian researcher who has studied photographs of the *Titanic* wreckage.

"The hole looks smooth as if burned by a laser. At the time there was no explanation except for an iceberg."

There were no reports of UFOs on April 15, 1912 when the *Titanic* went down on its maiden voyage, claiming more than 1,500 lives.

"Historians have always wondered about a mysterious ship seen by the *S.S. Californian* in the area," says Dr. Selzner.

"This ship has never been found. It's possible it could have been a UFO." Dr. Selzner believes the hole

in the ship was caused by a laser-like weapon, and that the UFO might have crashed into the *Titanic* as it was going down.

Quincy says photos and videos taken by the British-French teams will be studied further.

"We want to find out why the UFO came to be down there and how it happened," he says. [End quoting]

One gets the impression that every conceivable avenue will be exploited to bring "aliens" to the attention of the public consciousness. Can that fake "alien invasion" be far behind?

## FDA ALLOWS FOLIC ACID CLAIM

## CONFIDENTIAL

### COBDEN CLUBS SECRETARIAT FOR WORLD ORDER September 20, 1991 INITIATIVE FOR ECO-92 EARTH CHARTER

#### 1. THE PRESSING NEED

a. The time is pressing. The Club of Rome was founded in 1968, Limits to Growth was written in 1971, Global 2000 was written in 1979, but insufficient progress has been made in population reduction.

b. Given global instabilities, including those in the former Soviet bloc, the need for firm control of world technology, weaponry, and reduction of world population, according to the mid-1970s recommendation of the Draper Fund, must be immediately affected.

c. The present vast overpopulation, now far beyond the world carrying capacity, cannot be answered by future reductions in the birth rate due to contraception, sterilization and abortion, but must be met in the present by the reduction of numbers presently existing. This must be done by whatever means necessary.

d. The issue is falsely debated between a political and a cultural approach to population and resources, when in fact, faced with stubborn obstruction and day-to-day political expediency which make most of the

leaders of the most populous poor countries unreliable, the issue is compulsory cooperation.

e. Compulsory cooperation is not debatable with 166 nations, most of whose leaders are irresolute, conditioned by localist "cultures", and lacking appropriate notions of the New World Order. Debate means delay and forfeiture of our goals and purpose.

## CONFIDENTIAL

f. The U.N. action against Iraq proves conclusively that resolute action on our part can sway other leaders to go along with the necessary program. The Iraq action proves that the aura of power can be projected and sustained and that the wave of history is sweeping forward.

## 2. PERILS TO BE HEEDED

There is a two-fold opposition which must be eliminated by quick action. There are rumblings among some of the "South" regions, notably Brazil and Malaysia, to thwart the aims of the UNCED Earth Charter and to thwart the international gathering in Brazil in June 1992. There is also the unfortunate vacillation in our own ranks, an argument that the UNCED leaders have made the agenda "too political" and that the way must first be prepared on a less abrasive cultural basis. We present only the most recent evidence:

\* Gilberto Melio Mourao, the Brazilian writer, warned in the August 4 *Folha de Sao Paulo* that in Munich in 1938, "it won't against the current type of ecological epidemic, unleashed against our country, which threatens the structure of our cultural, spiritual and political values, and against our very national sovereignty...Messrs. \* An official of the World Wide Fund for Nature (WWF) said September 10th that the Geneva UNCED results were "absolutely a serious setback." There will be no convention on forests by June 1992 for Brazil. The situation has reached a deadlock. This is the first casualty for the UNCED process.

#### THEREFORE THE FOLLOWING POLICY MUST BE IMPLEMENTED:

A. E. All of the above constitute the New World Order, in which Order, all nations, regions, and races will cooperate with the decisions of the Major Nations of the Security Council.

The purpose of this document is to demonstrate that action delayed could well be fatal. All could be lost if mere opposition by minor races is tolerated and the unfortunate vacillations of our closest comrades is cause for our hesitations. Open declaration of intent followed by decisive force is the final solution. This must be done before any shock hits our financial markets, tarnishing our credibility and perhaps diminishing our force.

**U.S. IS SENDING MORE TROOPS TO PERSIAN GULF**

WASHINGTON—Despite two terrorist bombings aimed at forcing American troops from the Persian Gulf, the U.S. military is intensifying its power in the region, not depleting it.

They will be joining the 21,000 troops already there. Of that number, about 15,000 are afloat on 20 warships in the Persian Gulf and nearby waters.

**COPS PUT PARAPHERNALIA IN HOUSES**

Officers admit they placed pipes and syringes before the media visited houses.

TAMPA—Police officers admit they scattered drug paraphernalia in abandoned houses targeted by the city for demolition in a high-profile campaign to clean up neighborhoods.

The syringes and pipes were merely props, not evidence, police officials insist.

These items were taken into buildings before the houses were demolished to show the news media how the place looked when drug users were there, deputy Tampa Police Chief Ken Taylor said a preliminary investigation indicates.

Under department rules, drug paraphernalia found in an abandoned building should be seized as evidence before a house is condemned.

"I don't think there was any malicious intent," Taylor said Friday. "They might have been thinking when they invite the media in, it would be nice to show what we are finding here."

Officials aren't sure when and where it happened during Operation Crackdown. The program, which dates to the late 1980s, allows abandoned houses used by drug addicts to be razed quickly.

Tampa drew national attention in the early 1990s when then-Mayor Sandy Freedman launched a cam-

paign using the city's condemnation powers to destroy abandoned houses where drug addicts would hide. [End quoting]

## CLINTON VIOLATES HIS CONSTITUTIONAL MANDATE

*Financial analysts say Clinton's international speculative schemes are far greater than any of the numerous domestic scandals facing the White House.*

President Bill Clinton has violated his constitutional mandate, abused his regulatory authority and misused billions in public funds to aid and abet the massive scams of smash-and-grab Wall Street speculators from whom he receives indispensable financial support.

The complicity of the mainstream media, now largely under the control or the influence of billionaire market manipulators such as Ronald Perelman, Henry Kravits, Edgar Bronfman Jr., George Soros, Oded Aboudi and Morton Zuckerman, has kept public attention focused on Whitewater and other comparatively minor rip-offs while covering up a number of volcanic scandals. For example:

A number of close White House allies, including Goldman Sachs, the giant Wall Street investment bank

of Treasury Secretary **ROBERT RUBIN**, have been linked to huge criminal payoffs made to former Mexican President Carlos Salinas through his bagman brother Raul, in jail since February 1995 on charges of arranging the murder of a political rival.

[H: Could all of this perhaps be one of the reasons the Clintons like to spend so much time around and about Israel in their cute little beanie-hats?]

"During the Clinton years, international speculators literally looted Mexico's richest assets, buying up 'privatized' public companies such as the national airlines, the telecommunications system, even oil exploration rights at nominal prices set by the corrupt Salinas administration," says Dr. Ignacio Huertas, a Mexican economist who now lectures at New York University.

Other sources confirmed the scholar's assertions. "Instead of paying anything like a fair price for such prize Latin American assets, New York financiers found it a lot cheaper to pay off [ex-president] Salinas," says reporter Isabel Brody, who has recently returned from Mexico City.

Moreover, Wall Street's dirty money was efficiently laundered by Citibank, the largest U.S. money center, where a specially briefed vice president converted the briefcases of cash brought in by Raul Salinas into sanitized Swiss bank accounts totaling at least \$140 million, investigators close to the case say.

"Will there be any indictments in this sordid affair? Not while Clinton is president, and most likely not even after that," said Dr. Aldo Milinkovich, a former U.S. Treasury analyst who is now an investment adviser in

New York City.

The Reichmann brothers, an Israeli syndicate of speculators based in Canada, chiseled more than a billion dollars from American investors with a series of deviously manipulated bankruptcies. They used the process to get in on new rackets in Mexico and Europe.

"Had Clinton used his regulatory authority to go after the Reichmanns, they would have been most likely indicted by now," Milinkovich noted.

"When they went unscathed, they were imitated by dozens of copycat bankruptcy fraudsters," he added. "The resulting losses shook the real-estate markets in several cities."

## GEORGE SOROS

There were similar comments from Wall Street insiders about the massive speculative raids engineered by George Soros, "King of the currency crushers," as one bond trader described him.

In 1992, after the election of Clinton, Soros syndicated a financial attack on the British pound. In the ensuing panic, not just England's but also Italy's and Sweden's currencies collapsed, and taxpayers lost tens of billions of dollars. Soros, however, cleaned up, with net profits among his consortium of money manipulators running at an estimated \$8 billion.

Soros also opened the floodgates to years of uncontrollable monetary instability.

"When the *New York Times* says the Federal Reserve has committed \$10 billion to 'stabilize' the dollar in the international markets, do you know where that money goes?" asked reporter Steven Balint. "A lot of it ends up in the pockets of speculators like Soros. It's a loser's game for taxpayers and wage earners."

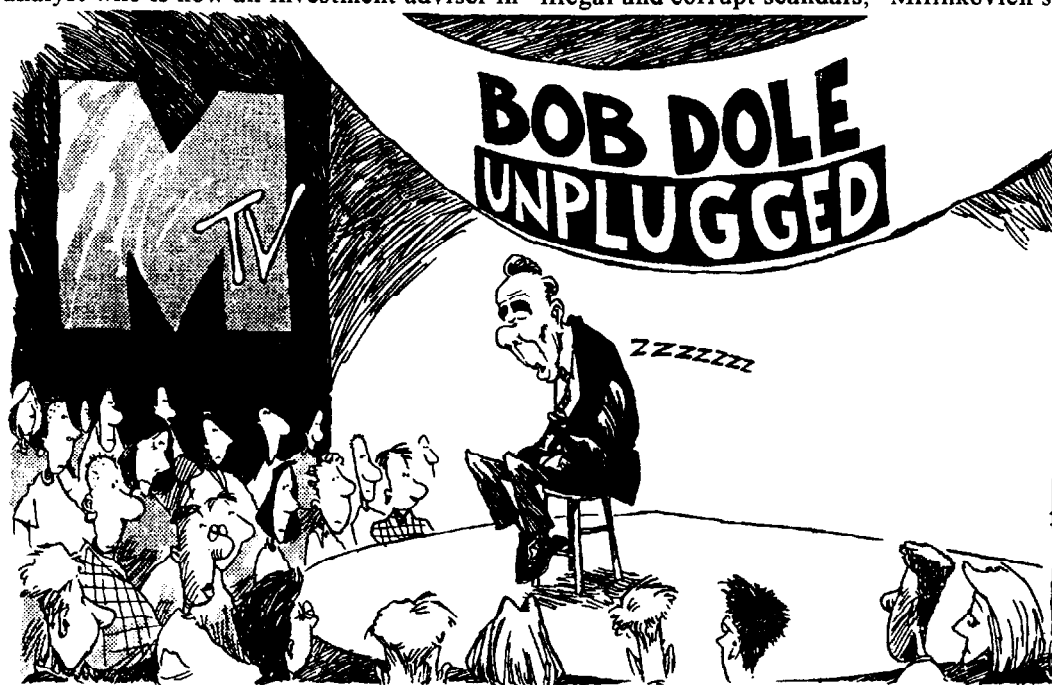
Clinton could halt this "gushing hemorrhage" of national resources "by simple regulatory measures and legislative proposals curbing runaway speculation and market manipulation", Milinkovich said. "But he won't. He has allied himself with the most predatory elements in our economy."

In fact, Alan Greenspan, Chairman of the Federal Reserve, has provided cover, encouragement and massive taxpayer bailouts to self-dealing speculators who miss a big bet or two, sources say.

"It's no longer news that Clinton and Greenspan poured out some \$50 billion in public funds to rescue a flock of vulture investors when the Mexican peso collapsed under their looting," Balint said.

Greenspan also rigged the stock and bond markets to bail out megaspeculators such as Henry Kravits in moments of crisis, says Michael Thomas, a former patrician investment banker who is now New York City's most perceptive financial columnist.

"These moves have involved Clinton in a tangle of illegal and corrupt scandals," Milinkovich said. "The



losses to taxpayers, savings depositors, wage earners and small investors have been incalculable.

"The day Congress finds the intestinal fortitude to dig up some of this mammoth dirt pile, Clinton will no longer play the role of Whitewater witness," he added. "He'll be facing impeachment on infinitely more serious charges."

(Rumors on Wall Street and in Washington indicate an even bigger bailout is in the works—\$103 billion for Boris Yeltsin's Russian government before the end of the year. See page 2, this issue.)

The system links hundreds of Russia's most modern missiles and brings to life an idea first shown in the film *Dr. Strangelove*, when a nuclear war was fought by machines.

Although the existence of the system has been known for two years, American intelligence officials say it has only NOW BEEN DEPLOYED. Russia is

spending billions of scarce rubles upgrading the system to ensure that, even if the Russian leadership is destroyed in a nuclear strike, retaliation is certain.

The doomsday system is almost entirely AUTOMATED. Computers hidden in underground bunkers outside Moscow and in the Ural Mountains have been programmed to launch rockets that can broadcast codes that in turn unleash nuclear missiles.

The existence of the project, when Russia is supposed to be stepping back from the Cold War's "balance of terror", has caused deep concern in Washington. America has no comparable system. "It is not a threat at the moment," said one intelligence source. "But any nuclear attack system run by computers is bad news."

The Russians began the development of the doomsday system after Pershing II nuclear missiles were deployed in Europe in 1983. Until then, both the Russians and the Americans had adopted a strategy known as "launch on warning". If a nuclear missile was fired, the other side would retaliate before the missile had time to reach its target.

However, the Pershings were exceptionally accurate, could penetrate command bunkers and reach their targets around Moscow in under 20 minutes, the minimum time it would take the Russians to launch a retaliatory strike.

The result was the doomsday project, which was designed to reassure Soviet leaders that whatever happened, America could never launch a first strike and

survive unscathed.

The automated system was designed to supplement the three "footballs" containing nuclear launch codes that are in the hands of President Boris Yeltsin, the Russian defence minister and the chief of the general staff. The new system uses SS-25 mobile missiles, which are the most likely to survive a first strike, to carry radio transmitters into space. These can activate SS-18 and SS-24 missiles in silos and other SS-25s carried on trucks. All can be launched by computers automatically.

**THE PROJECT WAS DISCOVERED TWO YEARS AGO BY BRUCE BLAIR, A SENIOR FELLOW AT THE BROOKINGS INSTITUTION, A WASHINGTON THINK TANK. He has extensive contacts in Russia and scientists there alerted him to the project's existence.**

"The fact that Russia is continuing to rely on this system is evidence of their paranoia about their vulnerability to western nuclear attack," said Blair.
