There are some very important legal points in here which might make it worthwhile to print the entire Memorandum. MEMORANDUM OF POINTS AND AUTHORITIES

Plaintiff, Eustace C. Mullins, appearing for himself as the movant, a private citizen, a citizen in party, who has firsthand knowledge of the facts, herewith submits to the Court the Memorandum of Points and Authorities to support this Motion, as

1. This is an action brought alleging violations of the First Amendment rights of Plaintiff, denial of freedom of speech, and denial of the right to peaceably assemble, protected by the language of the First Amendment (1791) "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof, or abridging the freedom of speech, or of the press, or the right of the people peaceably to assemble, and to peti-

tion the Government for a redress of grievances." 2. This is a historic First Amendment action, citing grievous violations of these rights. The Court is sworn to uphold the Constitution, and has the responsibility to fully protect Plaintiff's First Amendment rights. Freedom of speech is the citizen's exercise of political power; without it, he is emasculated and has no political being in this Republic. The Nation in its issue of July 21, 1997,

speech we hate"; Holmes called for a "a free trade in ideas" and declared that "the best test of truth is the power of the thought to get itself accepted in the marketplace". The Nation cites two Supreme Court decisions upholding this right, the recent striking down of the Communications Decency Act in Reno v. A.C.L.U., and the Supreme Court's 1976 ruling in Buckley v. Valeo, stating "The concept that the government may restrict the speech of some elements in our society in order to enhance the relative voice of others is wholly foreign to the First Amendment".

- 3. In this same issue, "Speech and Power" of *The Nation*, Ronald L. Collins and David M. Shover, law professors at Seattle University write, urging that we "liberate the public discourse of the First Amendment from lawyers and law professors and open it up to other perspectives." Floyd Abrams, who lectures on the First Amendment at the Columbia Graduate School of Journalism, states, "The oldest reality about the First Amendment is this: Hardly anyone really believes that we should protect the speech of those from whom we differ." This was the attitude of Defendant in its assault on Plaintiff, and it is the attitude of Defendant throughout its Discovery demands made upon
- 4. Throughout its Discovery, defendant perpetrates a fraud and a hoax upon the Court by largely ignoring the First Amendment violations and attempting to focus this action on racial issues, which it deliberately created and interjected in order to incite racial hatred throughout the Berkshire area. An even greater hoax was its crude attempt to convince Jewish residents of the area that they were in dire peril from Plaintiff despite Plaintiff's prior advertisements that he intended to lecture only on the Federal Reserve System, with no mention of race, gender, or national origin. Plaintiff hopes to allay these unwarranted fears and reassure the alarmed Jewish residents of the area by citing Jacob Heilbrunn, in his article, Christian Rights, in the July 7, 1997 issue of the New Republic. Heilbrunn commends Michael Horowitz, whom he defines as "a Jewish neoconservative" and cites Horowitz' article in the Wall Street Journal, July 5, 1995, "For American Jews who owe our very lives to the open door of 'the blessed land', silence should not be an option in the face of persecutions eerily parallel to those committed by Adolf Hitler." Horowitz was urging people to protest the present persecutions of Christians in China, Africa, and the Middle East.
- 5. Defendant's Discovery reveals a determination to force Plaintiff out of this action by heaping upon him irrelevant and unanswerable demands, such as all of Plaintiffs places of residence since 1951, forty-six years during which Plaintiff traveled and researched extensively in many cities in temporary housing of a few days at a time, and of which he maintained no records, due to not having an office, any employees, or places in which to house such records. By these actions, defendant hopes to bring about what one famous attorney calls "Death by Discovery", the total destruction of an aged litigant in poor health by forcing him out of the action out of law, in effect, making him an "outlaw", which was the original meaning of this term. Part I: Former FBI Operative

RICK: I would like to spend more than a until 1986. He was bedridden and could hardly walk. couple minutes, like we did yesterday, on the very beginning of the story. How did the FBI choose you? Why did they choose you? And then, what your assignment was from there? What were you doing before the FBI came to you? Let's start there.

DARLENE: Originally my background had absolutely nothing to do with law enforcement, whatsoever. I grew up and had gone to a private finishing school, and had a very good education. I'm an only child. My grandfather was a Baptist minister and my mom played the piano in the church and I sang. That basically was the beginning of, you might say, a singing career (laughter). And at a young age, I was only three years old, and we had revival meetings and things like that.

RICK: Reach back into that revival background and belt out your voice as we talk here.

DARLENE: Yeah, OK, I'll sing at the top of my lungs-only volume. After that, what had happened, I went into modeling, because that's what I could do. And at age 13 I was Miss National Teenage Safety, and I represented the state of Maryland and also the United States overseas in Europe on behalf of Traffic Safety for teenagers, etc., and, though ironic, it was also for the abatement of drugs. After that I went into singing more and acting. I went to New York and had a manager. He also managed—they were a lot older than I was at the time-Tom Jones and Englebert Humperdink, to name a few. And I recorded for Atlantic Records.

RICK: Under what name? Under your name? **DARLENE:** No, under Darlene Masi, M-A-S-I. RICK: OK.

DARLENE: And after that, I basically had befallen some bad health problems, things like I had a bout of Rheumatic Fever and they didn't know if it was the second occurrence or what happened to me. But I became very ill and could not keep up with the pace of New York or the theater at all. I met a young man through someone in my family—when I was convalesing, you might say-by the name of Kevin Novinger, who was going to be my husband, and was. It was very strange; he was an automotvie spraypainter and an artist and he had exhibitions in some art galleries on the East Coast. It was fascinating, because our backgrounds were so diverse and everything, but we got along wonderfully and got married, very young. We bought a home and we were married for about 4 years when he was injured in a industrial accident with isocyanates, a paint substance of vapor that is in fact in the paints in automotive finishes at his work. And he was blinded and had neurological degeneration of his bladder and his central nervous system and it was a matter of time, the doctors said, before he would die. I kept him at home and took care of him from 1977

During that time period I applied, in his behalf, for workman's compensation, in the commonwealth of Pennslyvania.

RICK: This sounds horrible.

DARLENE: Oh, they had a story (I'm just interjecting this in), the senior writer, Mr. Ben Franklin (you'll like that name) for the New York Times, in March of 1982 (you probably can get it at any mall, library or something on microfilm). It was so bad, the New York Times wrote a story, and this was a pressedout case, they were so scared more painters were going to come out with—it was a plasticizer in the paints, and it literally was like he was hit with nerve gas. And I watched him go from a healthy person to an invalid. exactly how cruel—I mean you had good people and bad people—we had people who had actually laughed at my husband when I was trying to take him to the hospital. And I thought, "Gee, they think people in chatting. I thought, "No one's driving all this way, theater are strange." I had never run into ignorance of this magnitude, you know. They would say, "Is he really blind?" And anyway it fired my spirit enough to go after the Workman's Compensation Bureau in the commonwealth of Pennsylvania, because they denied him workman's comp. And I might add, he never received it, but the late Senator Hines of Pennsylvania made sure he got Social Security disability for blindness, and just disability. And I mean we had to fight them tooth and nail and during that time it was—I can surely say it was rough because you could not leave him alone, especially in the first couple of years. He had an awful time trying to get adjusted to going blind and he had to wear a bag for his bladder. And so, it was a horror story.

Then after, while this is going on I'm fighting with commonwealth of Pennsylvania—I make it up to the Attorney General's office there, complaining about the wrongdoing, and the corruption in the insurance commission which handled the workman's comp. They had it on the 6 o'clock local news almost every night, this fight that was going on, and I had no wish to really be on the TV. I was not glory-seeking anything, I wanted justice for my husband. By this point I found more victims like him, to whom the same thing was happening. Well, to make that story shorter, I walked out of there after trying to get the Governor at the time. I walked across the street to the Federal Building and went over into the office of the FBI and asked them, 'Can you people do anything about fraud? I'm talking about massive corruption and fraud in the commonwealth." Well, the senior agent there said, "Come on in." This was a chance meeting we had, and he said, "I know all about it. We've been watching you on the this whole thing. Well, he was ecstatic. He equated

And I said, "You have?"

He said, "You know, you really are giving those guys a rough time over there. We like your work."

Anyway, he gave us some guidance. He said, "Be careful, because you're dealing with criminals."

I said, "You're telling me."

He said, "No, I'm not kidding you." And he said, "But keep up the good work."

And I said, "OK."
But he said, "We cannot intercede on your behalf on something like that."

I said, "I see." At the time he was a very nice man who gave me some sound advice. I left there thinking I'll never see any of these people again; I mean, it was one of those "enraged-citizens-hunting-for-justice" things. And I continued. The battle went down, back and forth, and the news kept following this on the local TV. Lo and behold, one day I was literally—my husband liked chocolate-chip cookies and pineapple upside-down cake. I was-it sounds almost like you're making it up, though; I'll never forget. I was baking cookies, being very domesticated for my late husband, when a rap came at the front door. I opened up the door and there was the head of the Federal Crimes Strike Force, standing there, and he showed me his

RICK: Now this was FBI?

DARLENE: Yeah, in other words, he would be in charge of their coordinated efforts.

RICK: OK.

DARLENE: He lived in Virginia and drove up from Washington, D.C. And I couldn't believe it; I looked at his ID, I looked at him. I had never seen him before and I said, my first thought was, "What did I ever do wrong? It must be something on this comp case," or something, you know (laughter). I thought they were coming for me.

RICK: That's funny.

DARLENE: And he comes in, he sits down; we And it was really horrible because I didn't understand have coffee, and I'm sitting there waiting for what this man wants.

RICK: Waiting for the other shoe to drop.

DARLENE: Yeah, I mean he's there, talking and the head of the Crime Strike Force, to talk to me." Yet there's something really wrong here. So he tells me, "I've heard some good things about you."

And I thought—at that point my husband said, "Oh, that's so wonderful. Your mom can take care of me if you go on assignment."

And I said, "Where will I be going?"

He said, "Well, we're going to train you locally, for a while, and we think you're going to work out real well. And then we're going to move you up." And I kept thinking, "OK, I've really never heard of this before," and I didn't know what a covert operative was (laughter). I'm sitting there and...

RICK: Kind of falling in it (laughter).

DARLENE: The man at the New York Times knew this story and he used to call it the "Perils of Darlene" (laughter).

Bureau. RICK: Can you say their name? **DARLENE:** Of the family?

RICK: You were naive.

DARLENE: (Laughter) He was laughing about this. And, you know, he said, "You want some orange

I said, "No, I want to hear about Jeb and the Vice President." I said, "How do I know that you're not making all of this up."

RICK: Well, what was he saying about them?

DARLENE: Oh, he's standing there telling me prostitutes to them and he's promised the [job of] 'Roving Ambassadorship" for the Caribbean Basin. And they're pushing for the Caribbean Caribbean Basin Initiative, which he will profit heavily on. And he

Anyway, I get out of there and after that I told this to some other people who were in; they're operatives and some of them were with different agencies and I had two people that I told this to because I was so scared thinking about what I'd just per!" heard.

RICK: Sure.

DARLENE: And I said, "This isn't the regular drug investigation, I've run into something really big." And after they heard it, they said, "You sure did, and we're lucky we all don't get killed from this thing." And I thought, "What would you suggest doing?

"Making copies, mail everything out, hide them for your own protection, in and out of the country, with very trusted people," which I did.

That was one of my first things, and I said, "Why am I hiding this from the—I mean, what is it that I fear from the FBI? I work for these people. What are they going to do to me?"

Everybody goes, "Watch out, they're political. They're going to turn on you."

And I said, "I don't think that, I mean we worked together pretty long. We had a close relationship. (Laughter) I said, "I don't think they're going to do anything like this to me." And they said-nevertheless, right before I went in to turn my report in I'm walking around with this thing, you know, burdened down, worried about it, trying to check all I can about it, and another agency pulls me aside and polygraphs me and said, "We'll keep this; we'll give you a copy. You send it to who you want because you're going to need it." And I thought, before you turn in your report to the Federal Bureua of Investigation. And they saidnow they're not telling me what to do, but it was my duty, I could not hold back what I had learned. I turned and told them about the report, what I had heard and learned

RICK: Now, who was this you were telling? **DARLENE:** The Federal Bureau of Investigation.

RICK: You were telling the FBI that now, at this

DARLENE: Yeah, I then—after being polygraphed by another agency who said, "Watch out, they're political.'

RICK: Can you tell me what agency that was? DARLENE: The Intelligence.

RICK: OK.

DARLENE: And they gave me a copy. I spread out this polygraph test and did an hour-and-a-half interview and they tried to punch holes back and forwards, but I passed with flying colors because I was telling the truth. I said, "Believe me, who would ever want to make up a horror story like this and be caught in the middle of it, you know?" And my main concern was all they're going to do is let them check it out and either they're going to prove it or disprove it, but they're not going to-I mean, why come after me? You know? I didn't really—I'm just doing my job. So I, at that point an agent came in December of 1982 and picked me up, one I had worked with on other cases, who I trusted yet, at the time, and took me to the Harrisburg, Pennsylvania, Federal Building, where the FBI is located. I met a man I had never met before, by the name of agent Patrick Kelly. And we went into the conference room there and he had a polygraph machine but he wasn't very interested in getting me a polygraph test. He was more interested in screaming at me, banging on tables. This went on for, like, seven-and-a-half hours, and wanting me to sign a piece of paper that I was hallucinating about this report and what I heard about George Bush and Jeb.

RICK: Now yesterday when I spoke to you, you

DARLENE: Yes, because we were in this room, it was Ronald Reagan, a big portrait of him and he had and this man got so beside himself and he was bloodred. And, I mean, he was right in my face, and when it was not he went over and opened the window and he looked over and he looked half-crazy, at that point, to me. And I thought, "What is he going to do, throw me out of the window or what?" I mean, I thought, "I've never seen anything like this in my life before.'

And I thought—I said, "I can't. I'd be lying on myself, I cannot do it, I won't do it." After seven-anda-half hours, I just said, "You'll have to kill me, but I'm not signing that piece of paper because it's true." It went from intimidation, fearing for my life, to justthey plain-out got me mad. I mean this man really just—I had enough with this "sign this piece of paper"

RICK: OK. Now I'm going to stop here, stop you here

DARLENE: OK.

RICK: Now, I'm a reader of the CONTACT newspaper and we've gone along here and I'm with you so far, and this is 1982 and what does this have to do with anything? Why should I as a reader keep reading? What is the relevance of this today?

DARLENE: Um.

RICK: And I know you're going to get to it with the rest of the story but just to give our readers a statement of why this is important today.

DARLENE: What happened after that infamous day in my life had changed my entire life, even to this day, because I am still suffering the repercussions of the George Bush investigation, which was classified, and the Bureau gave it a name, operation "Nimbus", N-I-M-B-U-S. And...

RICK: Do you know what that means?

DARLENE: I know what operation "Nimbus" means, it's the, it's involving George Bush and his son Jeb, into illegal activities of drugs.

RICK: OK.

DARLENE: Drug activities. And it was based fully on my report that I turned in. And, what had happened after that will go full circle in my life-and it's still haunting me and you cannot run away from it because it keeps coming back.

RICK: Why is this important to the average citi-

DARLENE: Because it's still going on. And what's happened is that, not only that, I've run into more people, more pieces of the puzzle. I'm only one piece of a puzzle. I've run into more people. Now it makes a lot of sense why they reacted the way they did, with me and how, once you are involved with these people, how you cannot just say, "I quit," and get away and get out of things. Once you're involved in something of this magnitude, you don't quit; there is no way out of this thing. I've lost two family members, my late husband Kevin in March of 1987, his body was found in the Susquahanna River, 18 miles south of Harrisburg, Pennsylvania. And I was told the reason his death occured was because of this incident with the George Bush investigation. I also lost my father in 1993; I was speaking out about this harassment, which I can get involved in what happened that day. But, of my dad, who was found in Baltimore, Maryland, and a lady called from the state of Washington, by the name of Debbie Holiday, and stated about him dying, why he was going to die, how they killed him, what the coroner was going say and she said they were going to use nitrogen. Ah, I hit the memo button, having to catch this woman on tape, telling me everything about it. She said, "And the reason why is because of the report I gave of George Bush and his son, Jeb." And she said, "And your mother is next." And at that point, she said, "The best thing you can do is get out of the country,

now; go to Canada, head west and come to Washington state" where she'll try to hide me because, she said, You have no idea what you stumbled into." And she had called my mother numerous times, who had an unlisted phone number and said to her about her life being in danger. And my mother said, "I know that," because my mother had been shot at. People have attempted to run her off the road—this is both of us, ongoing. This has been ongoing since 1983, these in-

cidences that were non-stop, and harassing phone calls.


She said to my mother, "Your daughter's (blank)," behind, I'll use that word, "is so hot it's glowing."

And at the time, in '93, I just kept hearing more and more things. People were calling me up telling me more pieces to the puzzle and it was sort of like I started putting a lot of things together and, quite truthfully, I knew that this woman was not a trusted person, number one. She came out of nowhere. Later on, I had been told that she had worked as an agent to terminate people, within the government. I reported this to the homicide department in Baltimore. They called her—I managed to track a phone number for this woman, and I gave it to the police. They tracked it, she admitted she said it, and the police at that point wanted nothing to do with this entire case. And they just let it drop. So, I have two family members that are dead and I get phone calls saying why they're dead, and who's going to be next, which is my 76-year-old mother. And what they have been doing to her.

This ties in, ironically, at the same time, when I found this out, another agent in 1983, by the name of Joe Price, was given that same packet, operation "Nimbus", which is my investigation, in Washington, D.C. He was a U.S. Customs Agent. He was sent to Miami to investigate further the material that I had developed. I did not know we were all working on the same case, as was another man by the name of Bradley Aires. He was working for DEA. We had independent investigations running, and kept running, and they're finding more about the Bush family and their national narcotics dealing.

An interesting note: in January '83, a month after the incident with the Bureau and I-and me being interrogated and intimidated-Mr. Bush's entire staff was dismissed and replaced, and it was reported in the Washington Post, but they did not say why they were replaced. So, I knew there was a lot of validity to what that drug-lord was telling me. And I thought this is a very, very serious matter—looking back on it I didn't realize how serious it was. I don't want to lose my chain of where we were going on this thing.


