Who Got The Gold? Provocative WW-II Mystery Gets Deeper As More Facts Emerge

Recently we received a most interesting letter from Colonel Fletcher Prouty, which we share with you below. He provides interesting confirmation material concerning two subjects that have been addressed for 6-8 years now by Commander Hatonn. One subject is the mystery of where some rumored, very large stashes of gold went during World War II; the other is the discrepancy in the facts concerning the numbers associated with the so-called "Holocaust".

AND NOW A VISIT FROM YOUR GOVERNMENT!!

FDA WRITES LOOPHOLE INTO ITS RULE ON 'MAD COW' DISEASE

From *CONSUMER REPORTS*, August 1997, [quoting:]

As we predicted in last month's Your Health column, the U.S. Food and Drug Administration has issued new rules on animal feed that fall short of assuring that the U.S. will never experience something like the epidemic of mad cow disease that has devastated the British beef industry.

Mad cow disease—the shorthand name for the most notorious member of a family of ailments called TSEs—is virtually unknown in this country, so there is no reason to panic about the safety of U.S. beef.

The trouble is, the pathways that appear to have allowed TSE disease agents to get into animal feed, into the food animals themselves, and into humans in Britain, all exist in this country, too.

We think those pathways should be blocked by banning the feeding of any mammal remains to food animals. That's what the British government did last year.

The FDA's final rules, issued June 5, do prohibit the feeding of cattle and sheep remains to other cattle and sheep. We think that's a good start. But the agency allowed the remains of pigs, horses, and chickens (as well as blood and gelatin from any animal) to be used in animal feed.

The final FDA rule also contains a surprising loophole that was not in preliminary versions. The agency will allow animals *known* [emphasis mine] to have TSE diseases—such as sheep with scrapie—to be fed to pigs, fed to chickens, even turned into pet food.

We think that's begging for trouble. The most powerful lesson that science has learned from the British mad cow epidemic is that the agents causing TSEs appear capable of jumping from species to species through food.

The FDA has said it wanted a regulatory "firewall" to prevent TSE agents from spreading through the food supply. But the FDA's director of veterinary medicine told us the agency is primarily concerned with controlling mad cow disease. Similar diseases in other animals are of lesser concern, he said.

By taking such a narrow view of the problem, the agency has perpetuated a risk where none needs to be. And it's hardly built the firewall it promised.

We continue to favor a broad ban on the use of animal remains in feed. Other countries and international organizations have taken that step. American consumers deserve no less a degree of protection. [End quoting]

Notice how the Elite almost always leave themselves a loophole big enough to drive a train

through? As long as we aren't very vigilant we will sink further and further into the muck they made/make for us. Notice how they never give up. We must do the same for the cause of freedom, honesty and integrity.

NOT FREE TO SPEAK UP?

Referring again to the above matter, again from *CONSUMER REPORTS*, only now for September 1997, [quoting:]

If our reports in July on mad cow disease and vegetable burgers caused you to make a careless antibeef comment, you may have a problem. Thanks to industry groups, beefs about beef or about agricultural products in general are risky business in 15 states where laws now protect their tender reputations.

No wonder *The Washington Post* warned, "Don't dis (sic) your vegetables." Under "veggie libel" laws, food producers can now sue you for falsely disparaging their products as unsafe, even if you intended no harm. (Don't laugh. Oprah Winfrey is actually defending a lawsuit brought by a cattle rancher for \$6 million. Under laws in many of these states, she would be required to prove that the on-air concern she voiced about eating beef—in light of the reports about mad cow disease—is based on "reliable scientific inquiry, facts or data".) As I write this, five more states are considering similar laws.

Such laws, we believe, give the food and agriculture industry the power to choke off concerns and criticism about food quality and safety. People who voice concerns about mad cow disease in beef—certainly appropriate at this moment—can be required to spend huge sums of money defending litigation brought by powerful ranchers, and would have to marshal the evidence of reliable scientific inquiry in a lawsuit.

At least those incursions on free speech are visible and can be challenged in court. Others are insidious. In April, *The Wall Street Journal* published a forthright and well-documented description of how certain major advertisers demand—and receive—prior notice of magazine articles that might displease them, so they can withdraw advertising from the issue if they find the material offensive. According to *The Journal*, magazines that have accommodated advertisers include *Esquire*, *Sports Illustrated*, *The New Yorker*, *People*, and *Vanity Fair*; the advertisers include Chrysler, Ford, Ameritech Corp., and tobacco companies.

Advertisers penalizing a publication after it runs something "offensive" to them is an old story. Advertisers obtaining prior notice of what a magazine plans to publish is a newer development. We agree with the reader whose letter in *The Journal* complained about this "threat to American press freedom", saying that the decision about what to print should not be ceded to advertising agencies.

The *Journal* article evoked a lot of commentary; most of it condemned checking content with advertisers. The American Society of Magazine Editors, an industry group, expressed deep concern about advertiser "early warnings." In a statement, ASME says it "worries that some advertisers may mistake an early warning as an open invitation to pressure the publisher or editor to alter, or even kill, the article in question." But not all the responses to *The Journal* article have been in that vein: Apparently, more advertisers have now asked magazines for similar treatment.

Magazines pressured to tailor content to suit advertisers' views? Cattle ranchers suing beef crit-

ics? The *Bill of Rights* recognized how critical free speech and an independent press are in a democracy. Consumers must have the right, unimpeded by advertisers' power to censor, to obtain the information they need to form sound judgments about products, services, and policies. The integrity and independence of the press is important to all of us. If the press kowtows to the demands of advertisers, all Americans are losers. [End quoting]

Do you notice that the Elite almost always leave a loophole big enough to drive a train through when they pass laws?

With natural rubber used in more than 40,000 products, allergies to proteins in latex from the Brazilian rubber tree has created both a problem and an opportunity.

The problem is that people who are allergic to the latex can develop symptoms ranging from rashes and hives to life-threatening anaphylactic shock, says Katrina Cornish, of the USDA Agricultural Research Service. Fortunately, she has the solution.

Cornish has developed a procedure to make hypoallergenic latex from the rubber of the guayule (why-YOU-lee) shrub. It is a plant that has been successfully grown in California, Arizona, New Mexico and Texas.

Earlier this year, the latex successfully passed tests at three clinics. The USDA has now granted rights to manufacture products that make use of this process to a Philadelphia-based company. The firm, Yulex, says its first products will be latex gloves. [End quoting]

ROCKFORD, ILLINOIS BROUGHT TO KNEES

DRESSING FOR A DIRTY JOB

Teflon, the material used to make nonstick frying pans, can now be bonded to clothing fibers to make them stain-resistant.

Of course, there are other stain-resistant materials, but they add significant weight or adversely affect the fabric's breathability, feel or appearance. Bonding Teflon to individual fibers appears to avoid these shortcomings, say DuPont engineers.

The process begins at the mill after fibers are dyed and woven into sheets. These lengths of materials are then dipped into baths containing a mixture of Teflon and softeners. The Teflon immedi-

ately surrounds and bonds to the surface of the individual threads. Excess liquid is squeezed out, and the damp material is then run through a dryer that has a long conveyor belt and is called a tenter frame.

Several clothing manufacturers plan to introduce Teflon clothes in their "casual Friday" collections. [End quoting]

Hopefully this will be a very useful product. I hope they have done thorough allergy tests, however.

TWISTED FEDERAL LOGIC THREAT TO COLORBLIND UC

LIBRARY AT ALEXANDRIA TO BE REBUILT

The world-famous library at Alexandria, Egypt, which in ancient times housed hundreds of thousands of great works, is being rebuilt, near the site where the library's great head, Eratosthenes, taught geometry and geography more than 2,000 years ago. It was an Alexandrian historian, Mustafa Al-Abbadi, who first came up with the idea in the 1970s, but it was not until seven years ago that the \$230 million for the project was pledged, so that work could get underway.

According to the project manager, Mohsen Zahran, the library called Bibliotheca Alexandrina, has so far acquired 350,000 books, among them a complete microfilm record of the priceless Arabic manuscripts in the Escorial Library in Spain, donated in June by the Spanish royal family.

The library will house up to eight million volumes plus hundreds of thousands of manuscripts, tapes, CDs, and videos, and is expected to become a center for learning and research with emphasis on the civilizations of ancient Egypt, Greece, and the rest of the Eastern Mediterranean. [End quoting]

EMPLOYEE ROBS POST OFFICE—OPENLY

There was some news from the Post Office, too. Well, actually this time the news is coming from the office of the Post Office's Inspector General.

The IG reports that a Marjorie Brown was installed as postmaster last Jan. 10, in a ceremony held in the Atlanta City Council chamber. She is the first woman to hold the Atlanta post, which

oversees 45 post offices and 2,400 employees. So they had a little party to celebrate. A \$45,593 party!

First, they spent \$21,348 to produce a video about Ms. Brown's life, the IG report said. An additional \$9,911 was spent on air fare for out-of-town postal workers who attended—and, of course, for the limousines necessary to drive the guests to and from the party.

Then there was another \$4,738 charge for a photographer, audio-visual support and postage. The postage was necessary for the \$2,405 worth of programs, invitations and thank-you cards. Rounding it off was the \$4,800 for the buffet lunch to feed the 300 attending the party, and for the breakfast for 30.

The House subcommittee on the Postal Service originally asked for the accounting.

This could give new meaning to the term "going postal". [End quoting]

Is it any wonder that the Postal Service (a private corporation) routinely begs for handouts from Congress?

THE LAND GRAB PLAN

By this time, most readers know that significant action is being taken to fight the UNESCO and U.S. Man and the Biosphere land-grab program. UNESCO already formed two "International" biosphere reserves here in Kentucky, and they are ultimately planning on grabbing about one-quarter of the State's land mass. UNESCO has similar plans for most states.

When we published this information over a year ago, few people cared. In fact, we were "flamed" by international lawyers, college professors and assorted liberals from around the world for about three weeks straight. Apparently, even though we write the truth, we were wrong—err, not politically correct—for mentioning the program. That was supposed to be their little leftist-liberal secret, and we went and blabbed to the world.

What changed this year? Well, first, a very influential Kentucky State Senator noticed that his family's 600-acre farm was smack dab in the middle of a proposed biosphere. . . . Yeah, that helped some. . . . Youbettcha!

A resolution against the Bio-Diversity Treaty (mandating hundreds of large biospheres in the United States) and the UNESCO and U.S. Man and the Biosphere Program sailed right through the Kentucky State Senate at warp speed, without so much as one word of dissent! You see, when other State Senators started looking at that UNESCO biosphere map, they did not like what they saw, either.

And, that's good news. So last June, we took the plunge and wrote about the subject again. This time, we received hundreds of letters of encouragement, and not one flame. We also helped Lance Crowe of the American Constitutional Campaign Committee send out a very strong press release, which was published in dozens of newspapers around the country.

Then, a lot of you called Congress. A LOT of you contacted Congress! Which, we should add, made a difference. Because, Congress added an amendment to quite a few agency appropriations bills declaring that, starting next year, no money may be funnelled into the Man and the Biosphere Program.

Your calls and letters put Congress on notice. [emphasis mine] They got part of the job done

last month. Now, we want them to finish the deal. Oh, and incidentally, we also want them to punish the wrongdoers in government—and there are quite a few. Here's a quick wrap-up of why:

In the 1970s, the United States (Carter) joined into limited agreements with UNESCO. Part of that was to form a few small biosphere reserves in the center of national parks. Thirteen federal regulatory agencies and the State Department formed the U.S. and UNESCO Man and the Biosphere Committee for that purpose.

By 1984, the Reagan administration noticed that UNESCO was ripping American taxpayers off for hundreds of millions of dollars annually, and we were getting nothing in return. So, we backed out of everything. All agreements were off. All programs were canceled. It was all over.

However, that U.S. and UNESCO Man and the Biosphere (MAB) Committee didn't see it that way. They just kept right on with the UNESCO plan, making biospheres wherever they could get away with it. Today, we have 94 biosphere reserves in the U.S., which have a total combined land area (at least) the size of the State of Colorado. That is land which is no longer able to be used by American citizens—for any purpose.

Not only that, but they created buffer and cooperation zones around the biospheres and placed strict land-use regulations on the people living there. All this with no authority. Remember, the MAB Committee should not have even existed after 1984, let alone bothered American citizens with all those land-use regulations. [emphasis mine]

Of course, the MAB Committee never bothered to ask Congress if they could use federal land as biosphere reserves. Nor did they ever have authorization to spend taxpayer funds on the project. The fact is, the MAB Committee misappropriated both the land and the money. They had no authority. And, as anyone who has ever been in the military or worked for government knows, they broke the law.

Kentucky State Senator Dick Roeding (whose district is not affected by any existing or proposed biospheres) noticed that misappropriation point even before we presented all of the information to him. He volunteered to tell his colleagues at this week's annual American Legislative Exchange Council (ALEC) Convention. And, since there will be about 2,500 state legislators from around the country there, we expect there might be a little action forthcoming.

ALEC, for those of you who don't know, is a national, *Tenth Amendment*, Jeffersonian type group of State legislators. They are very interested in this type of thing. So, when Senator Roeding called to see if he could get on the agenda to present this, he got a "yes" back within about five minutes. It was presented to the Task Force on Property Rights yesterday. If they approve, it goes before the group as a whole. If the group as a whole approves, they will collectively "inform" Congress.

In that case, they will inform Congress that the U.S. and UNESCO Man and the Biosphere Program must end now. They will also call for a Congressional investigation into why this unauthorized MAB Committee was allowed to function for thirteen years, and harass American people.

And maybe, just maybe, the misappropriation angle will also be approved. Regardless, we voters can push that aspect of the problem. Because, once an investigation starts, they will have to ask where all the money was coming from for all these years. Everyone in Congress already knows of

course. But, by actually admitting under oath that they diverted unauthorized funds into an unauthorized program, they will have admitted to a federal crime. [emphasis mine]

That should put a lot of federal bureaucrats—regulators, one and all—out of work at once. It may even lead to a few going to prison.

We might also add at this time that there are 30 to 40 other such frauds perpetrated by the far left on the American public via the federal regulatory bureaucracy. This biosphere business is just the most visible of the unauthorized programs at the moment. A win by the American people on this matter will have a very interesting domino effect on the others. [emphasis mine]

So, if your legislator suddenly starts looking like he or she wants to lead this “dump the biosphere” parade, please encourage them. In fact, line up behind them and make sure they don't stop till you're sure that it's all over.

Next week, it will be time to get cards and letters to Congress ready. A simple handwritten postcard to your three Members of Congress is all that will be necessary. This is important, too. It looks like we can see the end on this one, folks. One or two more big pushes and it looks like we're there. [emphasis mine] [End quoting]

New Filing In Historical Civil Rights Case

Legal Update From Eustace Mullins

Editor's note: The story of the historical civil rights case filed by Eustace Mullins appeared in our 8/19/97 CONTACT on p. 5. We are pleased to present the latest new filing in this historic matter.

8/21/97 EUSTACE MULLINS

A historic legal request filed at U.S. District Court in Springfield, Massachusetts today by author Eustace C. Mullins is “Plaintiff's Motion to Prohibit Discovery”. Mullins civil rights action against the *Berkshire Eagle*, a newspaper serving the famous Berkshire area, charges denial of freedom of speech, denial of the right to peaceable assembly, and criminal libel. It has been in litigation for a year.

Mullins, 74, of 126 Madison Place, Staunton, VA is the author of many books, including the only history of the Federal Reserve System, and the only authorized biography of his mentor, the poet Ezra Pound. He had previously challenged the *Eagle's* voluminous “discover” demands as “overly broad, failing to cite requested documents by date and title, and beyond the scope of the complaint.” He now moves further, in asking the court to prohibit discovery in one of the most historic civil rights cases ever heard in the United States. Discovery has long been known as the “cash cow” of the legal profession, because of the enormous income which it generates for the lawyers. Attorneys call it “Death by Discovery”. One attorney says, “Discovery simply means an attempt to discover the best way to get rid of the opponent.”

Mullins' latest challenge to the legal monopoly's discovery process will be pursued

by the National Commission for Judicial Reform, a citizen's activity group. He states that discovery violates the 4th, 5th and 7th Amendments to the Constitution, including the 4th Amendment's guarantee that “the right of the people to be secure in their persons, houses, papers and effects, against unreasonable searches and seizures, shall not be violated.” He points out the discovery violates the 5th Amendment's guarantee that a person shall not be compelled to testify against himself, as well as the 7th Amendment, which guarantees the right of trial by jury. Mullins points out that “pretrial discovery” actually usurps and precludes a jury trial, becoming a trial in itself, a Star Chamber procedure in which a litigant is subjected to the orders, directions and commands of the opponent.

Two recent headlined cases, the Texaco discrimination case, a \$176 million award, and the tobacco case, a \$368.5 billion award were won because of unlimited discovery by the complainants, in which all private records of the companies were turned over to them. Reopening the discovery could result in the tobacco companies refusing to pay the award.

Mullins cites America's preeminent legal scholar, Frederic Jesup Stimson, who points out in his definitive work “The Law of The Federal and State Constitutions”, that “no fact can be found without the intervention of the petit jury.” Stimson also reminds us that legal maneuvers such as discovery were “an extraordinary, un-English, Norman and tyrannical power of ordering a free citizen to do something he did not wish to do, which he calls an Oriental or Roman despotic power, which violates the ancient Anglo-Saxon common law.”

Nora's Research Corner

Comparing Some Prophecies Of Edgar Cayce, Nostradamus, And Jeane Dixon On Earthquakes And The Antichrist

I began checking on some prophecies of Edgar Cayce when Commander Soltec suggested, in his article titled "Recent Volcanic Clues To What's On The Way" in the 7/15/97 issue of *CONTACT*, that we "recall the timing clues for major Earth changes connected to these sister volcanoes [Mount Etna in Sicily and Mount Vesuvius near Naples, Italy] given forth by ones such as Edgar Cayce." Further, he states: "You who are there on Earth now will witness the great changes prophesied through many sources. There is no avoiding this possibility." Mary Ellen Carter, in her book *Edgar Cayce On Prophecy*, lists the Earth changes as prophesied by Mr. Cayce. They are as follows (quoting):

SOUTH PACIFIC: The changes will begin to be apparent "when there is the first breaking up of some conditions in the south Sea (that's South Pacific, to be sure) and those as apparent in the sinking or rising of that which is almost opposite it, or in the Mediterranean, and the Aetna (Etna) area. Then we may know it has begun."

THE ATLANTIC: "Lands will appear in the Atlantic as well as in the Pacific." "And Poseidia will be among the first portions of Atlantis to rise again...."

THE PACIFIC: "Lands will appear..." "The greater portion of Japan must go into the sea."

EUROPE: "The upper portion of Europe will be changed as in the twinkling of an eye...." "Even many of the battlefields of the present (1941) will be ocean, will be the seas, the bays, the lands over which the new order will carry on their trade as one with another."

AMERICA: "All over the country many physical changes of a minor or greater degree. The greater change will be in the North Atlantic Seaboard. Watch New York, Connecticut and the like.

"Many portions of the East Coast will be disturbed, as well as many portions of the West Coast, as well as the central portion of the United States.

"Los Angeles, San Francisco, most all of these will be among those that will be destroyed before New York, even.

"Portions of the now east coast of New York, or New York City itself, will in the main disappear. This will be another generation, though, here; while the southern portions of Carolina, Georgia, these will disappear. This will be much sooner.

"The waters of the Great Lakes will empty into the Gulf of Mexico.

"If there are greater activities in Vesuvius or Pelee, then the southern coast of California—and the areas between Salt Lake and the southern portions of Nevada—may expect, within three months following same, an inundation caused by the earthquakes.

"Safety lands will be the area around Norfolk,

Virginia Beach, parts of Ohio, Indiana, and Illinois and much of the southern portion of Canada and the eastern portion of Canada."

ARCTIC AND ANTARCTIC: "There will be upheavals in the Arctic and the Antarctic that will make for the eruptions of volcanoes in the Torrid areas, and there will be the shifting then of the poles—so that where there have been those of a frigid or semitropical will become the more tropical, and moss and fern will grow..."

SEALANES: "Strifes will arise throughout the period. Watch for them near the Davis Straits, where there will be attempts to keep open a life line to a land.

"Watch for them in Libya and in Egypt, and in Syria. Through the straits around those areas above Australia, in the Indian Ocean and the Persian Gulf.

"Ye say that these are of the sea. Yes, for there will be the breaking up, until the time where there are people in every land who will say that this or that shows the hand of divine interference—or that nature is taking a hand—or that this or that is the natural consequence of good judgements..."

GENERAL: "The Earth will be broken up in many places. The early portion will see a change in the physical aspect of the West Coast of America. There will be open waters appearing in the northern portions of Greenland. There will be new lands seen off the Caribbean Sea, and dry land will appear... South America shall be shaken up from the uppermost portion to the end, and in the Antarctic off Tierra del Fuego, land, and a strait with rushing waters..."

The shifting of the poles, as a logical consequence of large scale crustal displacements, according to the Geologist, will be due much later. According to Cayce, this will occur around the year 2,000 to 2,001.

But it will begin with the signs in the South Pacific and the Mediterranean which Cayce describes, and the appearance of land near Bimini. The West Coast destruction will be early on this time-clock of events, as will the inundations of parts of the Carolinas and Georgia.

To show how unlikely is the safety of relatively high ground when this begins is the example of Norfolk, which was told it would remain a good place to be even though it is low and close

to the sea. "Norfolk is to be a mighty good place, and a safe place when turmoils are to arise," one person was told; "Though it may appear that it may be in the line of those areas to rise, while many a higher land will sink. This is a good area to stick to." [End quoting]

Those of us who have worked to awaken people to the coming dangers have long hoped that our efforts would succeed and people would begin to see what is taking place on our Earth and change it. Hatonn, Sananda, and the Hosts, as well as Edgar Cayce and Nostradamus have taught in effect that man could change the script if enough of us chose to do so. Hatonn has also taught that this is possible up to a critical point. Now Soltec advises that it is unavoidable—we will witness the Earth changes.

Mary Ellen Carter gives us some insights into Cayce's thought on the subject in the chapter of her book titled *Time and Prophecy*, (quoting:)

How is prophecy possible?

Destiny, said Edgar Cayce, is created in Time and Space.

"Those activities (of men) make for such an impression upon the realm of data, or between Time and Space, as to make for what men have called Destiny...in the material affairs of individuals."

Then, we might ask, along with J.B. Priestly, author of *Man and Time* (New York: Doubleday, 1964) "What is Time?" Or, as he states it, "What is the future?" For of course the future is a part of time. "The future can be seen and yet be changed, it is neither solidly there, laid out for us to experience, moment after moment, nor is it nonexistent, something we are helping to create, moment after moment. If it does not exist, it cannot be seen; if it is solidly set and fixed, then it cannot be changed.

What is this future that is sufficiently established to be observed and perhaps experienced, and yet can allow itself to be altered?"

God, said Cayce, is Time, Space and Patience. And all Time is one; the past, present, and future.

"For to the entity—as to the world—patience is the lesson that each soul must learn in its journey through materiality. [End quoting]

According to Mary Ellen Carter, Cayce's major Earth Changes prophecies "cover a period of sixty-two years, from 1936 to 1998." The changes were to "begin in a gradual way and become more pronounced beginning in 1968 or 1969." I believe it was this prophecy that caused a great deal of concern among Earthquake watchers, especially those on the West Coast of America near the San Andreas earthquake fault line in 1968 and 1969 and on into the 1970s. I was among them. Several authors and prognosticators gave warning of the potential catastrophe based upon numerous predictions from several sources, visions and scientific records of seismic events. You may recall some of the murals of the time showing California going into the sea! It is possible, in my mind, that those very warnings may have caused enough people to change their thinking and thus to postpone the event. Unfortunately, when the great quake was delayed, many not only returned to sleep but lost respect for the visionaries as well. Today, in the year 1997, we are up against the final year of Edgar Cayce's prophecy for major Earth changes—1998. Further, as commander Soltec has advised, we on Earth today will "witness these great changes...There is no avoiding this possibility."

To return to Edgar Cayce's prophecy regarding the South Pacific area, it is said that the changes will begin to be apparent "When there is the first breaking up some conditions in the South Sea (that's South Pacific, to be sure) and those as apparent in the sinking or rising of that which is almost opposite it, or in the Mediterranean, and the Aetna (Etna) area. Then we may know it has begun." Consider well the nuclear testing done by our own government and international cohorts within very recent time in the South Pacific, and also the current activity of Mount Etna in Sicily. Consider also that Mount Etna is very close to Mount Vesuvius, and that they (the volcanoes) are all connected, deep in the Earth. Now read again in Cayce's Prophecy for America regarding the activities of Mount Vesuvius or Mount Pelee (generally thought to be on the island of Martinique in the Caribbean, although another volcano with a similar name is in the South Pacific area). (Quote:)

If there are greater activities in Vesuvius or Pelee, then the southern coast of California—and the areas between Salt Lake and the southern portions of Nevada—may expect, within three months following same, an inundation caused by the earthquakes. [End quote] (Ref.: *Edgar Cayce on Prophecy*)

Nostradamus in his prophecy, Century I-87, said:

"Earthshaking fire from the center of the Earth will cause tremors around the new city. Two great rocks will war for a long time. Then Arethusa will redden a new river."

According to Dolores Cannon, who worked through a channeler to contact Nostradamus, Nostradamus' explanation of this prophecy is: "He is saying there are three cities involved, a triangle affect. And it will affect the West Coast. That

New York will be experiencing an earthquake that will be devastating because the buildings are so tall there. But this is not the one referred to in the quatrain. And this [New York earthquake] will be experienced within the next year... The three cities are on the West Coast. A triangle...it will affect the city called...Los Angeles, San Francisco and 'Los' something... People have since suggested that he might have been trying to say Las Vegas, which would form a triangle with San Francisco and Los Angeles. He said the earthquakes would affect the three cities during the same time period." (Ref.: *Conversations With Nostradamus, Vol. I, pg. 53.*)

Of course, if Nostradamus intended to say "Las Vegas", then his prophecy would correspond very much with Edgar Cayce's at the time of the "greater activities in Vesuvius or Pelee".

I found a reference to *Arethusa* in the book *California Superquake 1975-1977?*, page 217: "(Arethusa was a nymph who was changed by the goddess, Diane, into a stream which passed BENEATH THE SEA to come out a fountain at a far distant place."). Nostradamus is well known for his use of history, legends, myths and historical places in his quatrains.

There are numerous accounts of other psychics regarding the California quakes to be found in the book: *California Superquake—1975-1977?* Not all of them provide a time schedule, but most agree as to the great devastation involved.

A personal note: I was in Oregon at the time of the volcanic eruption of Mount Saint Helen—which is in Washington State and across the Columbia River from Portland, Oregon. In fact, I was in Lebanon, Oregon, at the time. Lebanon is about 100 miles south of Portland. On the day of the eruption of Mount Saint Helen I smelled sulfur fumes in some fields west of Lebanon—I knew of no cause for the fumes until I saw the volcanic eruption later reported on television. This phenomenon of sulfur fumes was experienced by one of the psychics who foresaw the coming great earthquake in the Los Angeles area—a certain sign of underground volcanic activity. The sulfur fumes seep up through the cracks in the Earth. This psychic was a seventeen-year-old boy, who "saw" the great California earthquake during a brain concussion that lasted several days. His story appeared in Jessica Madigan's *World Prophecy, Book Three*. The boy's name was Joe Brandt. (Ref.: *California Superquake 1997-1977?*, page 149.)

Jeane Dixon originally predicted the great earthquake in California for the years just before and including 1966. She later changed her prediction to 1975. This was one of her prophecies which undoubtedly was potentially possible but did not occur. Nevertheless, she foretold many future events which did occur, including the assassination of President John F. Kennedy. Therefore, I decided to compare some of her prophecies with those of Nostradamus, and came upon a very thought-provoking comparison.

Ruth Montgomery, in cooperation with Jeane Dixon, wrote the book *A Gift Of Prophecy* in 1965. In chapter 19 of the book, Ruth relates the "vision which Jeane considers to be the most significant and soul-stirring of her life." It occurred shortly before sunrise on February 5, 1962 and had been preceded by unusual signs. On this February morning, Jeane was looking out her large bedroom window which faces east when the vision occurred. (Quote:)

As she gazed outside she saw, not the bare-limbed trees and city street below, but a bright blue

sky above a barren desert. Just above the horizon was the brightest Sun that she had ever seen, glowing like a golden ball. Splashing from the orb in every direction were brilliant rays which seemed to be drawing the Earth toward it like a magnet. Stepping out of the brightness of the Sun's rays, hand in hand, were a Pharaoh and Queen Nefertiti. Cradled in the Queen's other arm was a baby, his ragged, soiled clothing in startling contrast to the gorgeously arrayed royal couple. "The eyes of this child were all-knowing," Jeane says softly. "They were full of wisdom and knowledge."

A little to one side of Queen Nefertiti, Jeane could glimpse a pyramid. While she watched entranced, the couple advanced toward her and thrust forth the baby, as if offering it to the entire world. Within the ball of the Sun, Jeane saw Joseph guiding the tableau like a puppeteer pulling strings. Now, rays of light burst forth from the baby, blending with those of the Sun and obliterating the Pharaoh from her sight. Off to the left, she observed that Queen Nefertiti was walking away, "thousands of miles into the past". The Queen paused beside a large brown water jug, and as she stopped and cupped her hands to drink she was stabbed in the back by a dagger. Jeane says that she "distinctly heard her death scream as she vanished."

Jeane shifted her gaze back to the baby. He had by now grown to manhood, and a small cross which formed above him began to expand until it "dripped over the Earth in all directions. Simultaneously, peoples of every race, religion, and color (black, yellow, red, brown and white), each kneeling and lifting his arms in worshipful adoration, surrounded him. They were all as one." Unlike previous visions, which had gradually faded away from Jeane, this one moved ever nearer until she seemed to be in the very midst of the action, joining in the adoring worship. "I felt like a tiny seed ready to sprout and grow," she says, "but I was only one of millions of similar seeds. I knew within my heart, 'Here is the beginning of wisdom.'" The room was becoming dark again, and though she was still caught up in the spell of the vision, Jeane glanced automatically at her bedside clock. The time was 7:17 A.M.

What does it mean? What is the significance of this strange visitation on a dull February morning in Washington, a third of the way around the world from Egypt? Jeane feels that she has been shown that answer. A bit haltingly, she explains it this way: "A child, born somewhere in the Middle East shortly after 7 A.M. (EST) on February 5, 1962, will revolutionize the world. Before the close of the century he will bring together all mankind in one all-embracing faith. This will be the foundation of a new Christianity, with every sect and creed united through this man who will walk among the people to spread the wisdom of the almighty Power.

"This person, though born of humble peasant origin, is a descendant of Queen Nefertiti and her Pharaoh husband; of this I am sure. There was nothing kingly about his coming—no kings or shepherds to do homage to this newborn baby—but he is the answer to the prayers of a troubled world. Mankind will begin to feel the great force of this man in the early 1980s, and during the subsequent ten years the world as we know it will be reshaped and revamped into one without wars or suffering. His power will grow greatly until 1999, at which time the peoples of this Earth will probably discover the full meaning of the vision."

Attempting to describe her own sensation, Jeane says: "I felt suspended and enfolded, as if I were surrounded by whipped cream. For the first time I

understood the full meaning of the biblical phrase, 'My cup runneth over.' I loved all mankind. I felt that I would never again need food or sleep, because I had experienced perfect peace."

As a reporter, I felt there were questions that must be asked. How could she be sure that the queen in her vision was Nefertiti? Who was the Pharaoh who disappeared back into the Sun? Why was Joseph in the vision? Jeane could answer only in part. She said that she recognized Nefertiti from a small bust of the famed Egyptian Queen, which a friend once brought to her from Cairo. She "knew" that the Pharaoh was married to Nefertiti but had no idea of his name or identity. Joseph seemed to be controlling the couple and inducing them to present the child to the world, but she did not know why.

Baffled by the meaning of the strangely compelling vision, I consulted the *Old Testament* to jog my memory about Joseph. I recalled, of course, that as the favorite son of Jacob he had been sold into Egyptian bondage by jealous older brothers. I knew that eventually he saved his family from starvation, when famine came, but beyond that... what? Turning to Genesis, I read that "hidden things were revealed to him" and he was able to "interpret dreams". Because of this, a grateful Pharaoh made him governor of all Egypt and presented him with a wife, Asenath, whose father Potipherah was an influential priest.

So Joseph could understand hidden meanings and interpret dreams! I next turned to the *Encyclopedia Britannica* and learned that Nefertiti was the wife of Pharaoh Amenhotep IV who, after abandoning the worship of Amon, "devoted himself to that of the Aton (the solar disk)." He thereafter changed his name to Ikhnoton and built a new capital dedicated to worship of the Sun on the banks of the Nile above Cairo. Archaeological evidence suggested that Nefertiti was also an "ardent supporter of the Aton (Sun worship) religion". They had seven daughters but no sons.

Suddenly I realized how strange it was that Jeane Dixon, who was totally unaware that Nefertiti and her husband had worshiped the Sun, nevertheless "saw" them stepping forth from the solar disk in a vision. [End quote]

I am not qualified to interpret the vision given to Jeane Dixon on February 5, 1962. However, the vision cannot relate to the return of Immanuel for He is not yet returned to this Earth, and will not return as a child in incarnation this time. Further, in this year of 1997, there is yet no public knowledge of such a person, who has "reshaped and revamped the world into one without wars or suffering". Nevertheless, the prophecy could still be potential but delayed in time due to the occurrence of other events and the intervention of mankind's choices. At the time of Jeane Dixon's vision the world, and especially the United States

and Europe, was being inundated with propaganda of a one-world government, one-world religion, the brotherhood of man, etc. The propaganda has continued through our present time. Many good people were influenced to consider a one-world government under the United Nations in the 1960s and Jeane Dixon's prophecy as presented by Ruth Montgomery became, for good or ill, part of that influence. Nevertheless the inclusion of Nefertiti, the Sun and "a pharaoh" (which is possibly Akhenaton) is of serious interest to students of Hatonn's messages today. How it all relates with the Truth will be interesting to learn.

There is another aspect of this prophecy by Jeane Dixon which is troubling. That is the fact it had been preceded by another vision of a huge serpent, which was interpreted to be the embodiment of wisdom by Mrs. Dixon, according to Ruth Montgomery. The idea that the serpent represented wisdom was promoted by the snake people, of whom most of the pharaohs except Akhenaton were members.

For a description of Immanuel's return see the biblical *Book of Matthew 24:21-31*, [quoting:]

21 For then shall be great tribulation, such as was not since the beginning of the world to this time, no, nor ever shall be.

22 And except those days should be shortened, there should no flesh be saved: but for the elect's sake those days shall be shortened.

23 Then if any man shall say unto you, Lo, here is Christ, or there; believe it not.

24 For there shall arise false Christs, and false prophets, and shall shew great signs and wonders; insomuch that, if it were possible, they shall deceive the very elect.

25 Behold, I have told you before.

26 Wherefore if they shall say unto you, Behold, he is in the desert; go not forth: behold, *he is* in the secret chambers; believe it not.

27 For as the lightning cometh out of the east, and shineth even unto the west; so shall also the coming of the Son of man be.

28 For wheresoever the carcass is, there will the eagles be gathered together.

29 Immediately after the tribulation of those days shall the Sun be darkened, and the Moon shall not give her light, and the stars shall fall from heaven, and the powers of the heavens shall be shaken:

30 And then shall appear the sign of the Son of man in heaven: and then shall all the tribes of the Earth mourn, and they shall see the Son of man coming in the clouds of heaven with power and great glory.

31 And he shall send his angels with a great sound of a trumpet, and they shall gather together his elect from the four winds, from one end of heaven to the other. [End quote]

Obviously, the return of Immanuel, according to biblical prophecy, is at great variance to Jeane Dixon's prophecy.

Jeane Dixon wrote another book, *My Life And Prophecies* (1969), which is quoted by Dolores Cannon in her book, *Conversations With Nostradamus, Vol. Two*, page 333, quote:

On February 5, 1962 Jeane Dixon had a powerful vision that was filled with symbolism. From these symbols Ms. Dixon deduced that the person who will be known as the Antichrist was born on that day. She saw that his life would parallel the life of Christ to a remarkable degree, even though he was to be the mirror image or exact opposite of Him. She saw that he was no longer in the country where he had been born but had been taken to another Middle Eastern county, possibly a densely populated area of the United Arab Republic. She didn't know the reason for the move, but felt there were forces around him that protect him. She said an event of tremendous importance would happen

to him around the age of eleven that would make him aware of his satanic mission and purpose in life. Quote: "He will then expand his influence, and those around him will finally form a small nucleus of dedicated followers when he reaches the age of nineteen. He will work quietly with them until he is twenty-nine or thirty years old, when the forcefulness and impact of his presence in the world will begin to bear his forbidden fruit." She saw that he would have the backing of a powerful "machine" that would advance his cause beyond anything ever thought possible.

Quote from Dixon: "His domain will be the intellectual seduction of mankind. It means a mixture of political, philosophical, and religious ideology that will throw the populations of the world into a deep crisis of faith in God.... As official forerunner, one of his (the prophet's) first duties and responsibilities in readying the world for the advent of his 'master' is to manipulate the available propaganda machines. With teaching and propaganda the prophet will cause people not merely to accept the Antichrist but rather to desire him with positive enthusiasm, to create the

conditions of his coming and to participate actively in organizing the frightful and terrifying despotism of his World empire.

"Secondly, there will be 'miracles', the signs and wonders that will 'lead astray the inhabitants of the Earth'. His most convincing sign will be the conquest of the powers of nature, of which the 'fire from heaven' is the ultimate symbol. These will not be supernatural or preternatural events, but rather the prodigies of science and human achievements, but interpreted in such a way as to lead men away from God and toward the worship of the Antichrist."

Note the similarity between this fire from heaven and Nostradamus' prediction that Rome would be destroyed by some type of force or fire coming down from the sky. He was never able to clarify whether this would be caused by an extremely unusual natural event or something man-made. It astonished him so much that he could not define it.

"The prophet will communicate to men through his world propaganda machine the supreme ambitions of human science. He will announce that science is able to penetrate all of the secrets of nature, to domesticate all of the forces of nature, especially those of life, indeed of human life itself! He will profess that men will be able to live as they please, so long as they please, and to die as and when they please—and all without suffering—if they will only follow him."

This all sounds very much like the scene we were shown of the evil Imam and the group of backers in the estate on the banks of the Nile.

These are all supposed to be preparations accomplished before the Antichrist enters the public scene. Ms. Dixon says that from his first appearance he will completely mesmerize the youth of the world. Around the time he is thirty years old, as a result of the tremendous propaganda efforts by the prophet of the Antichrist, "the youth will have become extremely vulnerable to the coming of the man. I see that the youth of the world will accept him and will work closely with him in placing the world into his eager hands.... When the 'man' has reached the age reserved for the outset of his mission, no one will be able to hold the children back, for to capture the youth and, through them, the world, the little boy was born." She says that through our far-advanced communications network the entire world will be exposed to this new "spiritual" ruler even though his headquarters will be in the Holy Land.

Ms. Dixon states: "The Antichrist will be a phenomenon of the political order. He is not simply a religious 'heretic' whom the world at large could safely ignore. No! He will hold earthly power in his hands and use it as his instrument. All the tyrants of history are mere children in comparison with him. This means first of all that he will be a military figure beyond anything the world has ever previously seen. He will conquer the whole Earth and hold it in complete mastery with the most modern weapons. He will rule his new World Empire with the utmost of military might and glory. Furthermore, the Bible prophecies make it intelligible that the World Empire of the Antichrist will be a totalitarian state in the most extreme meaning of the word. He will exercise power over the entire world and each person intensively, controlling even his thoughts. There will be no 'neighboring state', and the whole world will become an island within the universe. War as it has been known will fade away, and the Antichrist will announce himself as the 'prince of peace.' ... But I foresee something

deeper in the coming godless social order of the Antichrist, something more than mere political system, something that reaches into the fallen condition of human nature. He will establish and lead a strange and fundamentally anti-human 'religion' of atheism and anti-religion.... So there is more involved here than the mere political authority of a World Empire. I see two definite characteristics distinguishing the Antichrist: dominion over men with a rod of iron and seduction of their minds by a false ideology and propaganda. He will present himself to all mankind as the supreme ruler who stills and quells all warfare on Earth, as the teacher of man's new modernized approach to life that leaves the Christian heritage behind as outmoded, and as the 'redeemer' of all men from their old fears, guilt complexes, and mistreatment of each other. He will be the exact opposite of Christ. He will be His adversary and at the same time appear to be His imitator.... He will seem to be a religious figure, offering to men a strangely twisted fulfillment of their spiritual desires.... He will receive the worship of many people, as if he, in his person, were actually God."

She quotes Cardinal Newman's comments on the Antichrist: "He promises you civil liberty; he promises you equality; he promises you trade and wealth; he promises you a remission of taxes; he promises you reform. This is the way in which he conceals from you the kind of work to which he is putting you; he tempts you to rail against your rulers and superiors; he does so himself, and induces you to imitate him or he promises you illumination. He offers you knowledge of science, philosophy and enlargement of mind. He scoffs at times gone by; he scoffs at every institution that reveres them." [End quote]

It appears that Mrs. Dixon's own account in 1969 of her vision of the child born on 2/5/62 has been given a different slant and more clarity from that account in Ruth Montgomery's book *A Gift Of Prophecy*. According to Dolores Cannon, Nostradamus, through the astrological signs of the Antichrist's birthdate, revealed to her and her astrologist helper, John, the birth date of the Antichrist. It is February 4, 1962. (See pages 117-119 of *Conversations With Nostradamus, Vol. Two*.) Considering the fact that one part of the Earth may be in the time zone of February 4, 1962, and another part of the Earth be in the time zone of February 5, 1962, Jeane Dixon and Nostradamus appear to be together on this prediction regarding the Antichrist's birthday. Nostradamus and Mrs. Dixon also agree on many other aspects of the Antichrist's life, as described above in part by Mrs. Dixon.

You may recall that Nostradamus predicted that the Antichrist's name would be the "next to the last" name of Mohammed, which is a "rather long name". I was not able to locate more than two names used in Dictionaries, Encyclopedias and other books on Mohammed, although I located many names from his origins which could be used. The two names given in the book *How The Great Religions Began*, by Joseph Gaer, gives the names as Mohammed ibn Abdullah, which would make Abdullah (aka Abdallah) a likely name of the Antichrist. (See my book, *The Garden Of Aton*, for further details on Mohammed's name.)

You may also recall, in my article titled "The Foreseeable Aftermath of the Four Horsemen of the Apocalypse" in the 6/3/97 issue of *CONTACT* newspaper, that I reported on Dr. Coleman's investigation of Prince Abdullah of the ruling house in Saudi Arabia. At that time I could not see Prince Abdullah

in the role of the Antichrist due to my lack of knowledge of his age and the fact he had instigated and led the 1973 Gulf Oil Embargo against the West, which caused Americans to line up for gas at the pumps for the first time and greatly increased the cost of oil and gas. If the Antichrist's birthdate is February 4/5, '62 then he would have been only eleven years old in 1973—an age I had considered too young for such a manifestation of power. Now, surprisingly, I read that Jeane Dixon, in *My Life And Prophecies* (1969), had predicted that an "event of tremendous importance would happen to him [the Antichrist] around the age of eleven that would make him aware of his satanic mission and purpose in life. "He will then expand his influence, and those around him will finally form a small nucleus of dedicated followers when he reaches the age of nineteen. He will work quietly with them until he is twenty-nine or thirty years old, when the forcefulness and impact of his presence in the world will begin to bear his forbidden fruit." She saw that he would have the backing of a powerful 'machine' that would advance his cause beyond anything ever thought possible. This aspect of the rise of the Antichrist was also foretold by Nostradamus.

It is quite revealing that Nostradamus saw the number of years for the activities of the Antichrist as twenty-seven. The beginning of his activity in 1973 plus twenty-seven years would bring us to the year 2000—a date which could be delayed (as with other prophecies) due to other events occurring in man's psyche and in the world. However, the twenty-seven years could also pertain to his later public activities, most of which have not yet become known to the world.

I suggest that you keep a watchful eye on Prince Abdullah of the ruling house in Saudi Arabia. Although the Antichrist will try not to let his family connections become generally known for security reasons, according to Nostradamus. Also, according to Nostradamus the Anti-christ will be preceded by another leader who gathers all the Muslim nations together in one political bloc, making it easier for the Antichrist to take over. The organizing of Muslim and African nations is now underway through the leadership of M. Quadaffi of Libya and Nelson Mandela of South Africa. The *Final Call* newspaper has been carrying an on-going account of their activities, which is thought by the Muslims and Africans will be of great benefit to their nations.

of CONTACT): "You have to understand that Philippine 'gold' is not the only treasure in point with those intrigues as will be told to you—the 'German Nazi gold dumped off Corsica' and recovered, resides in Austrian banks. Patton's Third Army, in April 1945, discovered German treasure hidden in a salt mine near Merkers. One huge vault contained nearly 250 tons of gold, 2.7 billion Reichmarks, millions in foreign currencies, and priceless objects. The treasure was transferred to allied authorities in Frankfurt.

In June 1945, part of the German gold reserve was found stashed in a cave in the Einsiedel mountainside. The find was kept secret until the Guinness Book of World Records, thirty years later, reported that 728 gold bars and six sacks of money from this cache vanished.

The plot thickens. The team investigating the theft perished in a fire. Civilians who tipped off military police vanished. General George S. Patton ostensibly died from injuries sustained in a minor auto accident. No autopsy was performed.

Patton's staff car was inching across railroad tracks when a slow moving GI truck swerved into his limousine, creasing its front fender. Neither

General Hobart "Hap" Gay, who sat beside Patton, nor Patton's driver, Pfc. Horace Woodring, received a scratch. T/5 Robert L. Thompson, driver of the truck, was not detained, and simply vanished.

Former OSS (Office of Strategic Services; forerunner of the CIA) agent Douglas Bazata told the Washington Star that his superiors advanced him \$10,000 to "put him down". He said he did not assassinate Patton, but was told how it was done by a fellow spook credited with the deed. Polygraph tests taken by Bazata indicated that he was telling the truth.

So, what became of the gold and treasure that was turned over to Allied authorities?

Rick,

What I am enclosing is a slightly revised letter that I have previously sent to my Congressman. I feel it is too important to leave it there. Since CONTACT has been doing such a fine job with the subject, especially on the Front Page of the June 10 issue, I thought that I ought to get it to you.

I have no idea who or what CONTACT really is, except that I find it most valuable, and generally accurate—I must write to the guy who writes about "fossil fuel" when he means petroleum. He must be an underground Oil Monopoly agent. I'll try to break it easily. I was the pilot of the plane that first flew a U.S. Geological Survey Team to Saudi Arabia just before the Cairo Conference, Oct. 1943, so that a report could be made to Roosevelt then. When I have guys locked in my plane for hours, I go back and talk with them. It's an education, and I have still kept in contact (there's that word again) with SaudiAramco since then. I just received a copy of their beautiful and most important Corporate Book. But now for tonight's subject.

You may use this as you wish, and I will be pleased to review whatever you draft, if you wish.

As I was reading the White House BULLETIN a few days ago I came upon an article of great im-

portance; but it appears to be unknown on this side of the Atlantic. I am enclosing a copy of that article with the BULLETIN heading. This is the subject of what they call the "NAZI-ERA GOLD". They are terribly misinformed.

As a function of military orders during WW II, I became involved in uncovering a massive gold smuggling operation that ran from Germany through the Balkans and Turkey to the Army's Air Transport Command (ATC) in Cairo. From that huge and most active base, the gold was hidden on Air Transport Command aircraft and flown via Tunis to Casablanca and Dakar on the west coast of Africa. There it was put on trans-Atlantic flights to Natal, Brazil, where it was off-loaded and put in the hands of Argentinians who were responsible for getting it to a German ring in Buenos Aires, Argentina.

I knew nothing of this at the time; but I was the Chief Pilot of the huge Air Transport Command base in Cairo and had been issued the only permanent Passport to Turkey in the days when that country was "violently" neutral. This is the reason I received the call from General Giles' Middle East Command headquarters to attend an important meeting.

There the General introduced me to some Army Counter-Intelligence Corps (CIC) officers. They had found evidence of a huge smuggling ring; but had been unable to uncover its U.S. Military "leader" and method of operation. Subsequently they had an idea how it might be possible to uncover him in Turkey, and because I possessed that Passport and would not draw special attention because I went to Turkey with some frequency, they wanted me to go there and carry out a plan for them. They were quite certain that this gold horde must be transiting Adana near the east shores of the Mediterranean Sea where it would be off-loaded and shipped to Cairo. I had been to Adana many times.

Their idea was for me to fly to Adana with a normal crew and cargo, and then to check-out a certain list of places to eat to see if I recognized anyone there whom I knew in our Air Transport Command organization that regularly flew between Casablanca to India, via Oran, Algiers, Tunis and Cairo to Karachi many times per day.

We landed in Adana and checked into our usual hotel, and went out in two teams to look over the eating places. Without delay I spotted the ATC Operations Officer from Tunis at the bar as I entered a hotel. There was no doubt about it, so I turned quickly and left. We left early the next morning for Cairo, and once back I called a Colonel whom I knew well and asked him to make the contact with the CIC office. We went there and they were delighted with the news. They thanked me and directed me not to take any flights anywhere until I heard from them.

About a week, or so, later the Colonel called me and without any special emphasis asked me to join him for "afternoon tea" on the beautiful outdoor veranda of the Shepherd's Hotel. Then he told me to sit quietly and to keep watching every cab that pulled up to the hotel to see if I recognized any passenger(s). If I did, I was to pick up the menu on the table in my left hand and read it carefully as though preparing to order something. I wondered if anything would happen, but it was a nice afternoon and all went well—up to there.

Later, a cab, among many others I had watched, came up and out jumped that same ATC Operations Officer from Tunis. As he turned to pay his fare, I picked up the menu and instantly about fifteen others on the veranda leaped to their feet and sur-

rounded the cab. I had not known they were there. At least they had their man; but was he the guilty man, the gold smuggling ring leader?

He was. There followed a quiet trial in Cairo and it was confirmed that he headed an enormous ring operating from the Balkans to Argentina regularly and with large loads of gold concealed as "aircraft parts" etc. He had a whole chain of agents on the ATC bases from Cairo to Natal. It was a large and active ring. He was charged, tried, and found guilty. You'll be surprised: he was Bruce Cabot, the famous "pre-war" movie actor and close friend of Errol Flynn.

The Army chose not to publicize the gold ring, the trial, the guilty party. Rather they kept things very quiet. Later I learned that Cabot had been transferred to a remote oasis in the Sahara named Atar. It was a place we stopped for fuel when needed. Otherwise it was remote and unnoticed. I never heard about him after that.

With that information, which the government learned from Cabot and his accomplices, the entire ring was broken; however, the gold was well concealed in Argentina and I never learned what the end of the story was. What concerned me was that this was a Nazi-USA-Argentina ring and did not involve—at least directly—Switzerland in any way. It has always concerned me that this was the true German gold outlet and that Switzerland was a small-time "fall-guy", primarily because of its war-time isolation. The men I had worked with always spoke of how enormous the "Adana" ring was and how Argentina was going to be the post-war repository of stolen Nazi gold, as it was for countless "guilty" Nazis. (Note how this is almost what HATONN wrote 6/4/97)

Not too long after this incident, I was transferred to the Pacific with the Air Transport Command and was in Japan on the day before the surrender on Sept 2, 1945. I was based then on Okinawa, and shortly after the end of the war I was transferred to Yale University as a professor of Military Science (the first classes of Air Force ROTC) for four years—while Bush was a student there, and captain of the baseball team.

I have always believed that the continuing charges against the Swiss with respect to illegal deposits of Nazi gold, gold perhaps taken from Jewish people sent to concentration camps, might not be accurate. (I'm enclosing some useful *World War II Almanac* data. This *World War II Almanac* by Robert Goralski and first published in Great Britain in 1981 contains a few important notes about the subject exacerbated by the "Holocaust" story as related to this gold charge against the Swiss banks.)

On page 81 of the *Almanac*, copy enclosed, there is the comment:

"Of the 500,000 Jews in Germany when Hitler took power, 319,000 fled. Most who remained became victims of the Holocaust."

I'm just a newspaper reader and I have always read the figure of "6,000,000" Jews as victims of the Holocaust. It is this figure that balloons the estimated amount of gold allegedly stolen from these Jewish prisoners that has multiplied the problem of the Swiss banks today. That's interesting: there is such a big difference between the figures "6,000,000" and "181,000"... "those who remained". Since

I had always known that an enormous quantity of gold went from Germany via Turkey and the Air Transport Command to Argentina, and that Argentina was the depository for Nazi gold, I have wondered what was behind these current stories.

Since the always reliable *BULLETIN* reports that Pres. Clinton makes reference to "the government archives" and to the fact that the "Treasury Department has assured me that they have historians combing the records", to "let the facts take us where they lead us", I thought it might be helpful to recount a few paragraphs of confirmed U.S. Military history on this important subject.

If this account is of interest to you, and if you

would like to take it a few steps farther, I certainly support such an idea. If it might be useful to discuss this further, you have my address, telephone and FAX numbers (below).

Dynamics Of A Bursting Bubble

Editor's note: The following astute financial observations are from the August 14, 1997 issue of Executive Alert Service, which is an offering of Executive Intelligence Review, P.O. Box 17390, Washington, D.C. 20041. For those of you who have been monitoring the financial markets on a regular basis, what was astounding in the way of a roller-coaster ride not so long ago is now commonplace. These current kinds of wild, hundred-point swings on the the stock market are the precursor "quakes" to massive financial instability.

Dynamics of a bursting bubble. One month ago, we alerted you of an "August financial earthquake". The question was and remains, whether this "earthquake" would lead into an accelerating systemic financial collapse during the September/October period, or if there would be a more extended transition phase of extreme financial volatility resulting in a global crash in early 1998.

As of now, major turbulence has shaken several "fronts" of the global financial system simultaneously: the Thai financial crisis, the Asian currency crises, the Japanese banking crisis, the fall and the wild oscillations of the Deutschmark, declining bond markets in the US and Europe, growing fears of interest rate increases in Germany and the US. On Aug. 7-8 the New York Dow Jones stock index lost almost 3%, and parallel stocks declined also in Europe. On Aug. 11, the Tokyo Nikkei index, after already falling by about 6% in a two-week period, plunged again by 780 points, that is 4%, below the 19,000 point level. In this "multi-front war" situation of the world financial system, the limits of financial "crisis management" manipulations by governments and central banks are being currently tested, if they have not been reached.

An interesting insight into how the dynamics of a bursting bubble works, can be found in the book *Men and Money* on the October 1929 crash, written

by Hugo Ritter in 1952. Excerpts from this book were featured in a special supplement on financial markets on Aug. 2 by the German daily, *Die Welt*. Ritter's description of the market euphoria preceding the 1929 crash is a striking parallel to the present psychological situation of investors in Europe and the US. "The growing unemployment was in sharp contrast with stock values," but warnings of the unsustainability of the Wall Street bubble were not heard "by an American public, fascinated by the romantic belief in ever-lasting prosperity." A "speculation fever" was spreading through the country, affecting all social layers, including "hairdressers" and "housewives". So-called "small investors" increasing borrowed money to speculate in stocks, taking out more and more credit from their banks. Since June 1928, Wall Street had been shaken by a series of mini-crashes, but as the next surge in stock prices came, all was forgotten and the belief in ever-rising stock markets re-consolidated.

Since 1928, interest rate increases by the Federal Reserve had been in the pipeline. However, fearing the consequences of an interest hike on both the speculative bubble and the real economy, the Federal Reserve rather restricted the expansion of long-term bank credits, while allowing short-term money to continue to fuel the speculative bubble "had to burst", but one should try to postpone the moment of truth "as long as possible". In October 1929 the time had come. After a first round of crashes between Oct. 22 and Oct. 24, an emergency meeting by leading Wall Street banks took place at J.P. Morgan, in order to create an illusion of an effective crisis management.

But on Oct. 29, "the hour of death" had come for the "ever-lasting bull market". Hugo Ritter writes: "The credit bubble burst, the speculative structure collapsed like a house of cards. Billions of dollars just disappeared. The illusions of the American masses were shattered. The prosperity had come to an end, and the world economic crisis had begun."

An Interview With Darlene Novinger

Part II: Former FBI Operative

[Editor's note: This is the second part of an interview between Rick Martin and Darlene Novinger, a former FBI operative. Part I was our Front Page Story last week.]

RICK: How does Dick Thornburgh play in all of this and what about people around him.

DARLENE: OK. Just the ending to that story is, Jeff Price was framed after six or nine months—not quite sure—nine months after he investigated the Bush connection. He was framed and convicted of trying—he was a 30-year veteran, with an impeccable background—and was framed for trying to sell five-thousand-dollars worth of hashish oil to an undercover agent for the FBI. And the Federal Bureau of Investigation...

RICK: Big mistake.

DARLENE: ...Arrested him with it. We all know he was set up. Mr. Ayers has been threatened and is running for cover constantly.

RICK: How do I spell that name?

DARLENE: Bradley Ayers, A-Y-E-R-S.

RICK: OK.

DARLENE: And, he is—he had written a book, *The War That Never Was...*

RICK: OK.

DARLENE: And, it's very, very—he worked for the Central Intelligence Agency and DEA—it was Captain Ayers, and a very highly patriotic person; they have ruined his life also. And, at my dad's funeral they put a dead canary there for me to see. And Mr. Ayers received two dead canaries with their legs chopped off, after we appeared on the *Jeraldo* show, about political corruption, but we were not allowed to say who it was on that show. Now, swinging into Dick Thornburgh—and it centers there—Dick Thornburgh was the Governor of Pennsylvania. Being that the person I married and I had family members there, I had lived, when I was married, in Pennsylvania. My mother had lived there also, so, to make a long story short, there's the base line of what I'm doing in Pennsylvania. But, um, (laughter) it's a hot place for me to be though, I can tell you (laughter).

RICK: I'm sure.

DARLENE: What happened there was the following: I was on another—the day after all this took place, I was so engrossed in so many narcotics assignments, the head of the Bureau, in Harrisburg, called up and said "We just have a misunderstanding about the Bush thing. You're just out of step."

And I said, "About George Bush?"

I mean, you know, he said, "We wanted to test you to see how strong your story was and just keep on going with your other investigations and we're going to just concentrate on those for a while." In

other words, I had to coexist with the Bureau because we were all entangled in so many drug investigations.

RICK: Check.

DARLENE: So I had to work with that friction of knowing, after what they had been doing, and that intimidation, I had this distrust that was building up rapidly for them. And in the course of another investigation of a large drug dealer, I come across an informant, but he actually did not know he was telling this to me, who worked for the drug dealer and he said, in passing, he said, "You know one of the best costumers I have is the criminal prosecutor at the Pennsylvania Attorney General's office."

I said, "Really, and who would that be?"

He said, "Richard Goida." And that's G-O-I-D-A.

And I said, "Really; well."

I mean, he said, "You should talk about a bad habit, he's got one of the worst habits of anybody that I have ever met." And it was notorious throughout the drug trade. He was one of the biggest cocaine abusers of all. I found out that they were doing (and I had eye witnesses) lines of cocaine at the U.S., excuse me, at the Attorney General's office of Pennsylvania. I reported this. Nothing was done. This kept on going.

I was out watching a drug dealer at a night club called the V.I.P., in Harrisburg, PA, with another investigator, and I looked over and saw none other than two U.S., excuse me, Pennsylvania Attorneys General, doing lines of cocaine on a mirror, openly, in a night club with a group of people. And I said, "Can you believe the audacity of these people, to do this?"

And it was further corroborated—we went on a show after they were convicted in 1991—on *A Current Affair* about that particular incident. It was further corroborated by another party who spoke up on that show. But, after that they had full knowledge, there were five assistant Pennsylvania Attorneys General, one whose had a criminal investigation, that were openly abusing cocaine. I called Governor Thornburgh's office and tried to get through—I was so frustrated over the whole thing—to try to let him know that people are aware of what's going on. Their response: nothing from the Bureau; nothing was going on. After that I received a summons in the mail and it was for prescription alteration—for a medication, a controlled substance, that my sick husband was taking. And that was in 1980—it was just going on 1985 when this happened.

I received a citation to appear before a District Justice for drug alterations on prescriptions—a

controlled substance. Ah, the order, I found out, was dated and signed and came from the Pennsylvania Attorney General's office, signed by none other than Richard Goida, the man I was investigating. And he was seeking to have me in prison for six years for this charge—which I had never done anything like this. Someone got into the prescriptions and altered them with a black magic marker over a ballpoint pen. And I did not see the evidence until the trial. It was interesting. I feel that was in direct retaliation for investigating and finding out about their cocaine activities.

RICK: Sure.

DARLENE: And so, to make a long story short, I hired an attorney, he got me aside and he said, "I don't know what to do, but I've got to tell you something." And I could admire him for this. He said, "They told me that if I win this case I'll never practice law again in Pennsylvania."

I said, "Then you want off the case and I don't blame you. Go ahead."

He said, "What are you going to do?"

I said, "I'll have to go to the law library and do the best I can." And I said, "I'll tell the truth; that's all I can do." I was not allowed to bring up anything about doing undercover work. I had to—the judge was so hostile and he was a friend of the Attorney General; I found that they were having these meetings and everything. There were some leaks in their office and I was getting some accurate reports that they had full intentions of trying to send me away for six years for something I did not do. At that point I kept thinking, isn't it strange how everybody that keeps doing an honest job ends up framed or dead or something happening to them. And it seems to be haunting, going back to various things. Anyway, I represented myself; the only time I really got a chance to speak was in the summation and I told the truth to the jury and it was the first hung jury in a place called Cumberland County, in Carlyle, Pennsylvania, in a hundred-and-seven years. And I actually thank God, because I thought what would I ever have done with a sick husband who's dying. But the Bureau was nowhere to be found while this was going on. And this third thing was, I did not do it and I know it was direct retaliation, because of this investigation. So anyway, later on down the line President Bush decides to make Dick Thornburgh the U.S. Attorney, in Washington, D.C. Who does Mr. Thornburgh choose as his five assistant U.S. Attorneys but the very same five cocaine users that I pointed the finger at—and the Bureau knew about it as early as 1984. And these people—he took them to Washington, they passed an FBI security check at the Department of Justice, they all signed papers. They went full circle on us, yeah.

RICK: So, let's finish with Dick Thornburgh.

DARLENE: OK; so anyway, they sign papers—and in fact committed perjury—that they did not use drugs. That was also brought out on *A Current Affair* with ex-congressman Don Bailey. At that point they were convicted in 1991, after a lot of pressure from behind the scenes from news media of use of cocaine. And Richard Goida was convicted of use of cocaine and distribution while at the Department of Justice. Mr. Thornburgh left, tried to run for Senate in the vacancy of then Sena-

tor Hines position; he was killed in a helicopter crash and lost to somebody because, directly because of this scandal that was really prevalent in, especially, the Pennsylvania area. Back, circling around—I guess where we can go from here is the fact that these people that want Henry Barr, one of the people that was convicted as the Assistant U.S. Attorney and long time friend of Dick Thornburgh was the former Pennsylvania Insurance Commissioner. And I had forgotten, and my mother did not know—her home owner's policy was with a company called the Erie, E-R-I-E, Insurance Company of Erie, Pennsylvania, who was the focus of a federal probe in the early '80s, who my late husband had given information to the Federal Bureau of Investigation about criminal wrongdoing. Erie—I do have some files—knows exactly who I am and about that situation, and has a bone to pick and are very, very close with the Thornburgh group. I did find all of these connections with them. So, in 1993, after threats still keep going on with people and everything, we had in 1994, January 28th, my mother's house caved-in from ice and snow, with full coverage on her home. They will not fix the house, it is presently still sitting there. She has arrest warrants for weed violations; it's turned into a biological waste site. We've lost—I've lost all my personal belongings; she's lost the house and everything she's owned, and she's 76 years old. They are persecuting her to death.

We went in to see the acting Insurance Commissioner at the time and he acknowledged that he knew Henry Barr very well and Richard Goida, and was so hostile that you couldn't even deal with him on this case. I mean, it's very blatant what is going on. I feel that it's another retaliation, how things are coming full circle and how they're using a 76-year-old woman to, again, get to me for trying to do an honest job. And they have got us at the point where you just are sitting there fighting for your life back and forth with these people—and it's ironic.

The other day—to be quite truthful, I have good and bad days and ever since we inhaled this stuff in that house and some other things, our house has been—we've been going as out patients to the hospital—believe me, yesterday I was trying to go through that story and I thought, and I knew you were tired, 'cause you hadn't eaten. It was the end of your day and I thought maybe I could get it done in case I'll feel worse the next day, but in a way you might have had a little foresight because I feel a little bit more together than I did last night.

RICK: Well, so do I and there's—there are three things that I want to cover, most importantly, before we do anything else, and I want to try and keep these things fairly succinct, if possible.

DARLENE: OK.

RICK: And that is, starting with your husband, we kind of jumped from him being extremely ill to being "suicided" in the Susquahanna River.

DARLENE: Uh-huh.

RICK: So, I guess I need more clarity on why you believe your husband was killed and why you believe Bush was associated with it?

DARLENE: The reason that I feel that he met with foul play was the fact that my husband could not get around without the aid of another party. He was disabled, he was legally blind; in other words he had maybe a pinpoint of vision. And he had to have assistance with his bladder and everything. Why I believe that he met with foul play is the following:

My husband had taken a bus; I had him in Florida for treatment, to try to get help for him.

I'll try to condense this down. He wanted to come home for the Christmas holidays, and on December 18th of 1986—right before that, about five days before that, we were going to drive home and someone hit our car. We were not in it. The man repeatedly backed up—it's on a report in Fort Lauderdale, Florida—and just kept ramming the car. And I had to get that under control. My husband, who had been ill for quite a while, was very insistent on going home. He would not fly; and I said, "My mom will pick you up on the other end," because she was used to taking care of my husband—while I would get the insurance company to fix our car so I could get it back home. He wanted to come home very badly, and he wanted to take a bus. And I thought, "this is disastrous." I checked with his physicians; they said, "Quit being a mother-hen over the man;" you know, "just make sure that he calls you like every so many stops and the bus driver will know about him," and what have you. I put him, on the advice of that physician, on that bus for Harrisburg, Pennsylvania, while my mother was to meet him on the other end.

I had to track this down myself. He disappeared. The last thing anyone had seen was by a security guard, in Washington, D.C., and he was asking someone to help him to a pay phone—in other words, assist walking him 'cause he couldn't see to get to a pay phone in the bus station in Washington, D.C. That security guard that I tracked down did not remember him getting back on the bus again.

RICK: So, he went from Florida to Washington, D.C.?

DARLENE: Yeah.

RICK: On his way to Pennsylvania?

DARLENE: Right. He made it that far and

after that we had reason to believe—I hired detectives because I was so upset, I couldn't—someone like this just does not disappear on their own, somebody had to either get him or assist him or whatever.

RICK: Why was going to Washington, D.C. before Pennsylvania?

DARLENE: There's a stop on Route 2, that you go there before you get to Harrisburg, which is north another, maybe 2 1/2 hours, if you're on a bus, you know.

RICK: OK.

DARLENE: So, he made it that far, I know that. I've had people confirm sightings of seeing him in Pennsylvania, but I could never really pin them down and the party that he supposedly was seen with has disappeared out of Pennsylvania and I've been trying to track that person down (who was a close friend of his). And the whole thing still goes around the following: my husband—I had been repeatedly warned and had threatening calls that they were going to harm my husband or another member of my family if I did not keep my mouth closed.

RICK: And this was specifically concerning Bush?

DARLENE: Yes, it was. Um, I received a phone call from one of the drug lord's family members asking me, after he disappeared, how I was doing at my home. This was after this incident, and I said, "They found my husband in a river."

And he said, "Good."

And I thought, "that's real interesting." I didn't expect him to really be comforting about it, but I found the phone call unusual. The Bureau kept silent about it. They knew my husband quite well because he helped out occasionally, as best he could.

They even used him as a decoy on a drug assign-

ment. This is a blind, sick man, and they said, "Well, they'll never suspect you now." And I thought, this is getting to be a little, you know, I never really approved of using my sick husband as a decoy on a narcotics operation. But nevertheless the Bureau did, and they did use my husband. Now, not one of those people came to the funeral. The state police waited two weeks and would not positively—they would not, but one person looked at the body. I have two different autopsy reports on him. The eyes—I don't want to get this story too long, but this is the type of thing that's been going on. They had the wrong color; my husband had blue eyes—this autopsy report's got a man with brown eyes. They've got him at size 11; my husband was five-foot-seven. There's the height, the weight—everything does not match. When I asked if somebody could ID him, even the detective, they refused to let anyone ID the so-called body that they found in March of '87.

Now, it seems to me, afterwards they circled and they made a funny thing about the whole incident. My personal address book, which had the name of a lot of people involved in operation "Nimbus", which was the George Bush/Jeb Bush inves-

tigation. Nimbus, N-I-M-B-U-S, like the cloud.

There was a reason, there was a joke about that, if you—and I looked it up in the dictionary and I understand, you know, somewhat—it's the highest flying cloud and it encompasses an entire sky. And I kept thinking, "these guys have a vivid imagination of how they get names for things." And, to be quite truthful with this whole thing, when they said my husband and was so decomposed, my mother went to look at pictures because they—I was totally—I was recuperating from what I feel was someone tampering with my car. And we had a very, very severe accident with a criminal investigator, who drove my car, because I was too upset. We were out hunting because of people saying he was in the Pennsylvania area, when the wheel locked-up on the vehicle and we were almost killed in this car wreck. The car was totally demolished. I'm laying in my house recuperating, the state police come and they first told my mother—they made their ID with my personal address book, which disappeared in a hotel room in Florida, that I could not find for life of me. And I carried this thing because it had FBI agents unlisted home numbers; there were people at Central Intelligence, their home

numbers in this book and there was the drug dealers' numbers in this book and it went back to George Bush and his son Jeb. When the state police, later on, made a comment to my mother and said, "We stumbled; we found the address book on the body." Now, mind you, the body was supposed to be in the river a couple months with a garbage bag that's not waterproof wrapped around somebody's waist, but yet you can read this address book. You know, like it's not been wet, in water. They brought this; they said, "Is this your address book?" And I wasn't allowed to touch it.

I said, "Yes, that's my address book." They took it back; they looked and showed me a wedding band. And I said it looked like my husband's wedding band. I said, "Why can't anybody ID the body?" you know?

They said, "It's too decomposed." You know, either the coroner said we're going to cremate it or you're taking it. So, inevitably I had—they discouraged two people from picking the body up and eventually I had it removed out of the state of Pennsylvania and put in a mausoleum in Maryland. Two weeks after the funeral the state police came. They also made a statement on the phone to my mother; they—I think you'll enjoy this part—they've "really stumbled into a giant cocaine ring based on that address book." And I was thinking, "Oh, yes they did."

RICK: Who said this?

DARLENE: The state police said they stumbled into a giant cocaine ring with this address book of mine. And I thought, "Yes you have." But I couldn't say what it was about and I would not make a comment. But I thought, "Well, if you follow the leads it should be quite interesting if you go and make an arrest, because it's going to lead you to Mr. Bush and his son Jeb and the drug lord in Miami." So I thought—I just sat back thinking; I was devastated because of my husband and it was getting more confusing. Eventually, they put in the newspaper—they kept ruling it was a suicide. I said, "My husband had a deadly fear of water. He would never, ever jump into a river." Well, at that point they got so upset, between that and everything else, they made a hundred-and-eighty degree turn, called my mother up and Major Blackburn said to her, from the Pennsylvania state police, "How do you know your daughter didn't kill her husband?"

And I thought, I couldn't believe what was going on with these people and I kept thinking, here we go again. I mean, it's unbelievable with, you know, the harassment. They made the same comment to another reporter from a very small newspaper in Harrisburg and he knew my husband and I quite well, he and the lady who owned the small newspaper there. At that point, that went nowhere. They harassed me for about two months on that. But to date I do not have the ring, nor do I have my address book back, which has, really, numbers that would air-out this entire investigation. In other words, they're illegally holding my personal property, and they have never made a positive ID.

RICK: OK. I'm still looking for the Bush connection. How you feel, why you feel it was Bush who had this done? After they found—I'm a reader out in the audience...

DARLENE: OK, I understand.

RICK: It's all conjecture, everything I've heard so far, as a reader. Just as a reader, I believe.

DARLENE: I understand.

RICK: I want to hear why you really believe this.

DARLENE: OK.

RICK: Succinctly.

New Element— Administratium

Editor's note: The following tongue-in-cheek news flash has been bouncing around the corridors of academia and high-tech industry for at least ten years now. One of our readers, J.R., recently faxed me (E.Y.) this version which may help to explain why your mail, driver's license renewal, and anything else the bureaucrats control seem to slow down further with each "new, improved" streamlining of the system. Maybe Administratium is the key to causing the New World Order to grind to a complete halt?! What do you think?!

NEWS FLASH—New Element Discovered

The heaviest element known to science was recently discovered at the Lockheed Research Center. The element, tentatively named Administratium, has no protons or electrons, and thus, has an atomic number of zero.

But it does have one neutron, 125 assistant neutrons, 75 vice neutrons, and 111 assistant vice neutrons. This gives it an atomic mass of 312. These 312 particles are held together, in a nucleus, by a force that involves the continuous exchange of meson-like particles called morons.

DARLENE: Ayers, A-Y-E-R-S. He worked for the DEA.

RICK: OK.

DARLENE: That I had mentioned. We kept on going, after we were ordered to stop this investigation. "Just drop everything on this particular family and the Bush connection."

RICK: Hmmhmm.

DARLENE: We kept probing into our findings and we found out a lot more, more than we could ever handle, and there was nowhere to take it to. We were literally being chased in cars and what have you. We received phone calls that told us to drop what we were doing or suffer the consequences. My husband, at one point, told me that he received a phone call stating that what I was involved in, that being the Bush investigation into narcotics trafficking, that we were going to be killed. And I was not home at the time when this call came in. And I said, "Kevin, it's just someone trying to scare both of us." I said, "Believe me."

He said, "No, I'm used to these calls."

I said, "Well, you've received calls like this before?"

He said, "Yeah, but I didn't want to worry you."

At that point—I was always extra cautious with Kevin, but I didn't want to smother him—after his death a comment was made to me, on the telephone. I received a call and they said, "You have yourself to thank, why he's dead, because you won't keep your mouth shut about George Bush."

RICK: OK. That's what I was looking for.

DARLENE: Thank you. You know, when you—it's easy if it's another part of a case, but one of the hardest segments is describing my husband and the connection, and it's haunted me. I had a lady in '93 reconfirm, again, my husband's death and why he died. In other words they will never, ever.

RICK: OK. Now let's jump to your father.

DARLENE: OK.

RICK: Same thing. Why do you suspect foul play?

DARLENE: OK. My father, who I might add, met Mr. Ayers while we were doing an investigation in '86. My dad was an avid, by the way, George Bush supporter and my father, literally, only heard a little bit about what we were involved in and really was very upset over the whole thing, saying, "He could never do something like this."

And I said, "Dad, I don't want to tell you or anybody what we're working on and you really don't want to know about it," because I didn't want any of the family endangered in this thing. Later on down the line, it was interesting because in 1993 the threats kept on going; you know, I was still getting the phone calls. Mr. Ayers was being threatened; I was being threatened; we were being shot at; people trying to run you off the road, and my mother. A lady called me at my mother's unlisted phone number by the name of Debbie Holiday and she was from the state of Washington. And she has a lot of connections with covert government people in different agencies. Now she called me and told me about my father, why he was going to die; about speaking on the Tom Valentine radio show. And four hours after I did Tom's show my father was dead. She said how he was going to die, to be quite truthful, and my mother was next. She said the coroner was not going to find any traces of foul play. It was going to look like a heart problem. And that's exactly what's happened to him. The

police called Ms. Holiday and she repeated the story to them directly. The same exact story she was telling me. And she said I was next—and my mother, they were going to remove her because of the George Bush report.

RICK: OK. Now, let me stop you there. You said yesterday that at your father's funeral there was a canary—on the coffin, was it?

DARLENE: Yes.

RICK: Why would a dead canary be at your father's funeral? Was he involved in some type of disclosure or was the canary message for you?

DARLENE: I feel—and I had spoken to Mr. Ayers, who received two dead canaries, as I mentioned, with their legs cut off. That canary was a symbol of, in other words, your "singing"; in other words, I'm talking about George Bush.

RICK: Hmmhmm.

DARLENE: Like Ms. Holiday and some anonymous people on the phone had called and kept warning me to keep quiet about this. And I felt it was my responsibility; we've been threatened, my husband was already dead. RICK: Do you have a copy of that report?

DARLENE: I have a copy of the polygraphs and the report, and I've mailed those; I have them locked away, to tell you the truth, in and out of the country. Ms. Holiday did say to me, "The only reason why you're alive is because your life insurance is the things you sent away." Now...

RICK: Has that report ever been published?

DARLENE: No, it hasn't. And the closest this thing has ever gotten to be on a national level was Bradley Ayers and I appeared on the *Jeraldo* show and they were talking about government corruption in high places. And Mr. Ayers and I could go into detail about a drug investigation; and Mr. Ayers got in the point, he said, "And it goes to the highest office in the land." Which, to me, is like saying who it is. At that time period, it was 1991 and, I

mean, it was incredible because after that was when he received the two dead canaries in his mail, with the legs chopped off. And he told me about that and I thought, "Obviously these people are not going to let up, no matter if you sit and keep your mouth closed or proceed forward." But, at that point, we—I started to get embroiled again with one of Mr. Bush's associates, Dick Thornburgh, again. He keeps—he resurfaced in the picture. And, so it seems like you can go full circle and there's a group of politicians that, if you are investigating something, you keep running into a group of people; that's forming a pattern. You compare this to other investigators who are honest ones and you are running into the same people.

RICK: That's right.

DARLENE: And I thought, OK. Ms. Holiday stated to me that I've got something that is so detrimental that my backside—only I shouldn't use that word—is so hot it's glowing in the dark. She told my mother that. And for me to get out of the country if I want to live and, you know, go to Canada and then go to Washington state and she would try to help me. You know, stay alive. Needless to say, I didn't trust Ms. Holiday, nor was I about to leave town and go to the state of Washington.

RICK: Right.

DARLENE: Because, I thought, for all I know that could be something where I might never be heard from again by doing this. I thought there's no use running; I mean, I've suffered all these consequences of losing family members and, people shooting at you, and running you off the road, and harassing my mother. I felt a responsibility; I thought, "I've got one family member left now and she's been threatened," and I kept thinking I felt a moral obligation as any normal, decent person would. I mean, this woman has nothing to do with my work for these people, but, nevertheless, I'm losing family members from it. And I thought, I am not the only person, after, you know, talking to other people who have suffered the loss of people in their family and that's basically—I've been told this—Mr. Ayers is under the opinion, also, that this is why my family members are deceased. My husband and my father. There's enough information on people calling me, telling me. I get messages of "Do you have your life insurance paid, burial insurance recordings?" This would go on all hours of the night on the phone and, you know, things of this nature. And occasionally someone would talk and tell me why this happened to me.

PROBLEMS OF FEEDING THE WORLD

MORE FOOD ON LESS LAND

Excerpted from *21st CENTURY SCIENCE & TECHNOLOGY*, Summer 1997, [quoting:]

Although the gains in rice production made throughout Asia during the last three decades are impressive, the amount of land available for rice production has decreased. Scientists at the IRRI, led by Dr. Gurdev S. Khush, are developing even higher-yield rice varieties to meet the challenge of growing more food on less land. Using breeding and genetic engineering, they have created an entirely new type of rice plant to be released by the turn of the century. The new rice type produces more biomass per hectare, with an increased percentage of grain—a 20 to 25 percent higher yield. Current high-yield rice can produce 18 to 20 tons of biomass per hectare, with 50 percent of that being grain.

The new "super rice" produces 21 tons of biomass per hectare, with 60 percent of that being grain, giving it a 12.0 to 12.5 tons of rice per hectare yield. "Super rice" will be released at the turn of the century, after disease- and insect-resistance genes are incorporated into it.

Khush stressed that research must continue to meet the challenges ahead. "We cannot rest on our laurels," he said.

WHAT STOPS NEW TECHNOLOGIES?

The advanced technologies to easily feed the world already exist, so what is stopping them from being used? While the media has prominently featured the radical environmentalists who block the use of new technology, such as genetic engineering, not so well known are the practices of the food cartels, which are restricting the use and research of biotechnology for the public good under the guise of "free market" policies. By patenting genetically engineered seed, plants, and the techniques to create them, the cartels not only can restrict their use, but also can block the government from conducting research in areas in which the cartels hold broad patents.

There are several recent legal means that are used by the cartels to control new technologies in agriculture. The most powerful has existed since 1985, when the patent office ruled that genetically modified plants could qualify for this strong form of patent protection. This type of patent can be used to lock up new high-yield crop varieties; it does not allow any exemptions for research or for use by farmers, without a license from the cartel company.

Much of the success of the "Green Revolution" resulted from the fact that discoveries made by sci-

entists in the public or private sector were made readily available to the public. Today, the cartels' increasing control over agricultural research makes it very difficult for new discoveries to be widely distributed for the public good. In most cases, the cartel companies hold patents and licenses on any new discovery that could produce higher crop yields.

In contrast, in the 1960s, new hybrid seeds, or advanced farming techniques developed by government-funded research within the USDA, were directly and freely released to individual farmers and breeders, and no one could then patent any of these discoveries to stop others from using it. The advent of the industrial plant patent in 1985, and the changes to the Plant Variety Protection Act in 1994, however, made it impossible for the USDA to freely release its new discoveries to the public.

Since 1985, the USDA must license and sell the right to any new plant variety it comes up with to the highest bidding company. In this "free market" system, the largest and most powerful companies stand in the way of the widespread use of public-sector discoveries, and control who gets access to new technology.

Over the past 10 years, because of budget cuts, the Agricultural Research Service has had to fund new projects through cooperative agreements with private companies, which now make up the majority of these agreements. (In the past, most of these agreements were with governments of developing-sector nations.) The private companies provide part of the funding for a short-term project, which usually ends up producing a patentable new plant variety or technique.

The companies retain the exclusive marketing rights of any discoveries made during these research projects, so often discoveries made by government scientists end up in the exclusive control of the cartels. If the cartels patent the technology, they can then restrict the government scientists from continuing research in the area those scientists pioneered.

CARTEL RESTRICTIONS

A few years ago Monsanto was granted wide patents on all genetically engineered cotton and soybeans. This decision by the patent office caused USDA researchers to drop projects in these areas, and instead try to "invent around" the patents. These particular patents were subsequently restricted through a legal battle, but the long-term damage to government research programs has already been done.

Another case is the new Bt corn that resists pests. The patent on this variety prohibits anyone, including government researchers, from doing research using Bt corn without a license from the company.

The new plant patents and the Plant Variety Protection Act are also being used by the cartels to restrict farmers' rights. The Plant Variety Protec-

tion Act, amended in 1994 to meet GATT (General Agreement on Trade and Tariffs) standards, denies farmers the right to exchange or sell any protected or patented seed. However, many of the plant patents go even further, prohibiting the farmer from saving seed to replant, allowing inspection teams onto his farm to enforce patents, and dictating what chemicals he can use on his crops. The farmers must also pay large licensing fees, in addition to the cost of these new patented seeds, just to access the technology. This new system is squeezing the independent farmer into bankruptcy, forcing him under the control of the cartel companies if he wants to use genetically engineered seeds that would give higher crop yields.

The 1994 GATT agreements also have provisions whereby developing-sector nations must recognize the patents and intellectual property protection held by foreign companies on plants and other living organisms. This gives the cartels the ability to deny developing-sector nations access to advanced agricultural biotechnology, and provides enforcement of their patent rights by the World Trade Organization.

CARGILL IN INDIA

For example, Cargill has been pushing hard for intellectual property rights for its seeds in India. Cargill was marketing sunflower seeds promising high yields, but refused to submit seed samples to the Indian Government seed bank, as required by law, claiming this would violate their private property rights. When these seeds were grown by local farmers, the yields were disastrously low, sparking a protest against Cargill and its support of the GATT agreements, in which some farmers burned the files and seed samples of the local Cargill office in 1992. [End quoting]

The name of the game is: control the food and you control the world. Also the Elite intend to depopulate this planet to 1 billion or less people—which means unimaginable horrors resulting from this—if they have their way.

DANGERS OF GENETICALLY ENGINEERED FOODS

* **Toxins**—Genetic engineering can cause unexpected mutations in an organism, which can create new and higher levels of toxins in foods. In 1989, a genetically engineered form of the food supplement tryptophan produced toxic contaminants. As a result, 37 people died, 1500 others were permanently disabled and 5000 others became very ill. (Ref: *The New England Journal of Medicine*, August 9, 1990)

* **Allergic Reactions**—Genetic engineering can also produce unforeseen and unknown allergens in foods. Without clear and precise labelling, millions of people who suffer from food allergies will have no way of identifying or protecting themselves from offending foods. (Ref: Food and Drug Administration 57 Federal Register 22987)

* **Decreased Nutritional Value**—Transgenic foods may mislead consumers with "counterfeit freshness". A luscious-looking, bright red tomato could be several weeks old and of little nutritional worth. Consumers will have no way of accurately judging food quality, if the foods aren't labelled.

* **No Long-term Safety Testing**—Time has proven herbicide and pesticide use hazardous to personal and environmental health. Now, genetic

engineering is being promoted as the new harmless solution to agricultural problems. But changing the fundamental make-up of food could cause unanticipated problems, just as herbicides and pesticides have. Genetic engineering uses material from organisms that have never been part of the human food supply. Without long-term testing no one knows if these foods are safe.

* **Problems Cannot Be Traced**—If these products remain unlabelled, our nation will be sitting on a time bomb. Without labels, our public health agencies are powerless to trace problems of any kind back to their source. The potential for tragedy is staggering.

* **Increased pollution**—Scientists estimate that plants genetically engineered to be herbicide-resistant will actually triple the amount of herbicide use. Farmers, knowing that their crops can tolerate the herbicides, will use them more liberally. Biotech claims that pesticide use will decrease are also misleading. Transgenic corn, altered to contain its own insect-killing toxin, is now registered by the U.S. Environmental Protection Agency as a pesticide and not a vegetable at all. (Ref: *Weed Technology*, 6, 1994)

* **Unpredicted and Unknown Side Effects**—No one knows the long-range implications of this technology. In one case, a genetically engineered bacterium developed to aid in the production of ethanol, produced residues which rendered the land infertile. Corn crops planted on this soil grew three inches tall and fell over dead. (Ref: *The Oregonian*, August 8, 1994)

* **Threatens Our Entire Food Supply**—Insects, birds and wind can carry genetically altered seeds into neighboring fields and beyond. Once transgenic plants pollinate, genetically original plants and wild relatives can be cross-pollinated. All crops, organic and non-organic, are vulnerable to contamination from gene drift.

* **Imprecise Technology**—Genetic engineering is like performing heart surgery with a shovel. Scientists don't know enough about living systems to perform DNA surgery without causing mutations and changes in the organism. They are experimenting with very delicate, yet powerful forces of nature, without full knowledge of the repercussions.

* **Gene Pollution Cannot Be Cleaned Up**—once genetically engineered organisms, bacteria and viruses are released into the environment it is impossible to contain or recall them. Unlike chemical or nuclear contamination, negative effects are irretrievable and irreversible.

CULTIVATING ALTERNATIVES TO METHYL BROMIDE

Most of us at one time or another have been in a factory. An environment that is sterile, 'dirt free', and the single goal is production. Over the years, the most obvious difference between 'regular' and 'organic', or sustainable farming is this. In regular farming the soil is the factory for production. Where methyl bromide is used to 'sterilize' the soil; kill nematodes and other 'bad bugs', and prepare the soil (factory) for production. Then get in as many plants, as many times of the year as you can. Produce. Produce. Produce. Is that Produce, or produce?

The statistics on how many thousands of tons of methyl bromide are used each year are staggering. And in the United States alone, over 24 million tons of pesticides and chemical fertilizers are used. Commercial farming uses petroleum-based, synthetic fertilizers that cause nitrite, salt, and bicarbonate to build up in the soil. And these fertilizers' 'nutrients' are actually the hardest for plants to take up. The soil then becomes acid, hard, full of salt, depleted and susceptible to harboring nematodes. If a farmer wants to grow plants there, he is caught in a vicious cycle; having to use methyl bromide to kill the nematodes that were actually 'cultivated' in the poor soil.

Using REF (Radiant Energy Forces) technology, we now have recent data that the frequencies are killing nematodes. Populations of 39 dropped to zero. And beneficial populations increased. We are looking at an alternative for strawberry growers to methyl bromide.

Using frequencies and negatively charged water we're cultivating healthier soil, increasing beneficial organisms, growing healthier, nutritious, pest-resistant plants, and a soil that nematodes have a more difficult time surviving in because they are being attacked by their enemies, the beneficial, and the frequencies are so disruptive that they eventually leave.

Last week, in response to an article in the *CALIFORNIA SUN*, I was called by university professors interested in what we're doing. There is an effort to find safer solutions. And in switching over, farmers won't lose everything as they have been made to believe. I now have vineyards, almond, and peach growers reporting that their nematode populations are dying out. They're also reporting a decrease in aphid, mites, peach-twig borer, and phylloxera. We're increasing soil and plant health tremendously. Keep in mind, we're not doing anything 'magical' or 'mystical'. Everything in nature has a frequency or vibration. Science agrees and has proven it. We're simply moving nature from one side of that frequency 'band' to the other. That is, from the unhealthy end over to the healthy end.

Work has progressed over this last year, and we now have more units in the fields. We're working on connecting the universities and research people with the farmers who've been

using these methods, and hopefully bring the research people out into the field. Grafting their research and findings with ours.

Thanks to the *CALIFORNIA SUN*, the information will be internationally known, fostering our progress, and accessing the solutions we desperately need to help bring our planet and ourselves back into a state of health and balance. We will keep you informed about our progress. Ironically, our 'environmental crisis' has actually become an 'economic crisis', and that has encouraged more of us to find solutions; and find them quick.

HERB INDUSTRY GIVEN REPRIEVE REGULATION DEADLINE EXTENDED

From *THE MORNING STAR* (of Canada), 7/7/97, [quoting:]

Herbalists are breathing a sigh of relief after Health Minister Allen Rock announced a six-month reprieve from new regulations for the herbal-remedies industry.

The deadline for the new regulations has been pushed back from July 1 to Jan. 1, 1998 in an effort to give the industry a chance to learn more about the new licensing requirements and respond to Rock.

Allen Smith, president of the Associated Ginseng Growers of B.C. said that the reprieve is good news for the industry and will pay off for herbalists and small business owners.

"It looks like everyone's going to benefit from this," said Smith, Monday.

"It will give a lot of smaller businesses a chance to discuss some practical issues and alleviate any problems that might arise."

Under the new regulations, businesses that produce or distribute drugs would have to comply with Good Manufacturing Practices (GMP), a set of Health Canada standards.

"Without knowing about some of these regulations beforehand, a lot of small health food and drug stores would be put out of business," said Smith.

"Then a lot bigger companies would come in and take their place, charging whatever they wanted for their products.

"This would affect the public greatly."

Smith said that there is a growing trend towards the use of herbal medicines he stressed are both very safe and effective.

"There is a real swing towards these alternative medicines," said Smith. "What we need is some sort of a compromise between herbal medicines and traditional Western medicines."

"The Canadian people deserve to participate in these remedies."

Smith is now representing ginseng growers across Canada in the ensuing discussions and will advise on any agricultural concerns that may come up.

Smith said that some of these issues will involve everything from the economic impact to the cultural and philosophical implications.

The committee is slated to deliberate on these issues during a two-day working session in September and will then give feedback to both the government and the businesses. [End quoting]


