#### RUNAWAY BALLOON DRIFTS INTO RUSSIA FROM NORWAY

INTERNET, <para-discuss@tje.net>, 8/31/98: [quoting]

A rogue weather balloon from Canada drifted into Russian air space from Norway on Monday in spite of efforts by planes from three countries to shoot it down, Norwegian aviation authorities said.

The balloon, as tall as a 25-story building and regarded as a hazard to air traffic, entered Russian air space about 7 a.m. (0500 GMT) over the Barents Sea just north of the Arctic island of Spitzbergen.

"The balloon entered Norwegian air space at around 10 p.m. (2000 GMT) last night passing south of Bear Island and moved into Russian air space at seven o'clock this morning," Stein Erik Finnevolden, supervisor at the Bodoe air traffic control center, told Reuters.

"It is moving in a constant northeasterly direction at between 27,000 and 37,000 feet (8,230 to 11,280 meters)," he said. The balloon would cover an area equivalent to five soccer pitches if deflated.

The unmanned, 300-foot (100-meter) high balloon has traveled cross the North Atlantic over Iceland and Norway. It went out of control after being launched on August 24 in the western Canadian province of Saskatchewan to measure ozone levels.

Atlantic had to be rerouted to avoid the heliumfilled balloon, which has defied attempts by jet fighters from Canada, Britain and the United States to shoot it down.

The Norwegian Air Force made no attempt to shoot down the balloon.

Scion of the Roxas-Ayala-Zobel clan, his ancestor, Domingo Roxas, founded the family's first trading company in the Philippines in 1834. It grew into a billion-dollar empire. By the time Marcos came to power, Zobel was one of the richest men in the Philippines. He wasn't a crony and he had not made his fortune by pillaging the country. To the contrary, he was a man of enormous vision whose success came

> love was polo. One of his polo-playing friends was the Sultan of Brunei, the tiny oil-rich

> Zobel could have played the role of landed gentry but that wasn't his style. Chairman of the board, president, and director of dozens of corportions, his financial and managerial prowess could especially be seen in the Bank of the Philippine Islands, which he took over in the mid-seventies and built into one of the nation's largest financial institutions. He also built Ayala Corportion into a billion-dollar real estate and industrial conglomerate.

> By the early eighties Marcos and his cronies had effectively destroyed the economy. Zobel agonized over what was happening to the country. He helped organize the Makati Business Club as a forum to critique and comment on government economic policies but soon he realized nobody was listening. In 1985 he told the New York Times, "If you had money to invest in Southeast Asia, the Philippines is the last place I would tell you to put it now." He was one of the few that could say something like that and not risk the ire of

> Upset at Marcos' heavy-handed tactics, Zobel resigned from both Ayala Corporation and the bank and began concentrating his efforts on businesses outside the Philippines through another of his companies, Ayala International. Through all this, he maintained a grudging his senses and turn the country around. He supported Marcos in the 1986 snap election but even powerful friends couldn't help that time.

They had been subpoenaed the previous May but they appealed, claiming they were entitled to their Philippine constitutional rights. This motion was denied and they were ordered to comply by August 8. They then claimed head-of-state immunity. This motion was also denied and they were ordered to comply by August 18. An appeal was filed. The Court of Appeals denied the claim on October 19. The Court also held that the Grand Jury had the authority to order the Marcoses to sign consent directives, authorizing the foreign banks to turn over their financial records. The case was elevated to the Supreme Court. They lost and were ordered to report to the FBI.

Pascual finally fled into Manila in late November and met with Zobel. She asked if he could loan Marcos \$250 million, and showed him the note. It had been antedated to October 17, by Marcos. It stated: "In consideration of Short, stocky, and competitive, Zobel's first this loan I promise to deliver three-million ounces of gold within three years after I return to the Philippines." That was more than 85 return. Zobel checked his calendar and told Pascual he would meet Marcos in December.

A few days later his own doctors issued a report that described him as chronically ill with multiple abnormalities of the kidney and heart.

> On December 8, Zobel met Marcos for dinner. Marcos hardly ate and looked very tired and weak. He asked for the promissory note that Pasqual had delivered. Zobel had to go back to his residence, ten minutes away, and retrieve it

> On returning, he told Marcos he didn't have \$250 million available, but he asked how the loan would be repaid if he could arrange it. Marcos asked his nurse, Teresita Gallego, to fetch a folder. Zobel leafed through it. It was about an inch and a half thick and full of deposit certificates for gold stored in various banks all over the world—Switzerland, Monaco, the Vatican, the Bahamas, and other places. He mentally calculated that, at \$400 an ounce, the price of gold at the time, the value was approximately \$35 billion.

In June the doctors removed the kidney that had been transplanted in 1984. From there it was all downhill. Marcos turned seventy-two on September 11. He died seventeen days later

never signed.

In deference to Marcos' death, Zobel did not bother the family in mourning. He heard from Pascual that Bong Bong retrieved the folder containing the gold deposit certificates from Marcos' nurse. Later Imelda showed some gold foundation that Marcos wanted to set up. That certificates of the same description—yellowed Imelda had known for a week and not told her with age and dated 1946 to 1948—to journalists on two separate occasions.

> Zobel believed the certificates were real and quietly pursued the business Marcos never finished. He hoped Imelda and Bong Bong would follow through with Marcos' plans and set up the foundation.

In November 1989 he attended the Volvo Golf Tournament in Spain with Rainer E. Gut, chairman of the board of Credit Suisse. He asked Gut if the Swiss banks would release the gold if the foundation presented two letters of authority—one signed by President Aquino and one signed by the Marcos heirs. Gut replied it could be done. This heartened Zobel. He was a busy man with a vast business and financial Marcos' medical condition was rapidly empire to oversee. Still, he took the time and did everything he could to see this project through to its fruition. He could not know of the terrible tragedy he would soon face.

As the PCGG went about the task of attempting to locate and recover the hidden wealth of Marcos, they waded through mountains of documents and interviewed

having gold deposited in banks in the U.S., Hong Kong, Singapore, Switzerland, and several other European countries, but nothing could be traced to him because the accounts were set up differently.

There was mention of an organization known as Umbrella, which he had set up along the line of communist cells. Each gold account was controlled by a group of trustees, usually three. Each group was unknown to the other. To access an account required approval of all trustees to that account.

Marcos and Bong Bong were the only two people who knew the entire Umbrella structure. After Marcos died, Bong Bong told Imelda. They decided to dismantle the organization but there was a problem. Some people in these groups were loyal to Marcos, not Imelda or Bong Bong, and were out to protect their own interests. The PCGG was aware of this. Imelda had told them as much. They knew that, even when they had the account number, the vault number, and the serial numbers of the bars, the bank would deny the gold's existence to protect its clients.

Marcos had set it up well. His brilliant legal mind combined with the financial skills of the Swiss could make any gold in his possession seemingly disappear.

He wasn't so lucky in other areas. Before he died, an old nemesis returned to haunt him.

One of the first to get a close look at the 2,068 pages impounded by the Bureau of Customs in Honolulu in February 1986 was Bonnifacio "Boni" Gillego. In 1982, he was the first to write about and expose the Marcos war medals as fake. A furious Marcos ordered his arrest but he managed to escape to the U.S.

In the States he worked as a hotel clerk to support his family. He kept up the fight by joining the Movement for Free Philippines (M.F.P.), a US. group devoted to peaceful lobbying against the corruption and human rights abuses of the Marcos regime. Marcos' agents in the States were aware of the group and continued to hound him and other members.


After Marcos was overthrown, Gillego returned to the Philippines. Aquino asked him to serve as executive director of the PCGG to investigate Marcos' illegal accumulation of wealth. Later he would be elected to congress, but it was while working in the PCGG that he made his discovery.

It seemed only fitting that someone persecuted by Marcos would be the one to find proof that the murders of Gene Viernes and Silme Domingo could be traced all the way to the palace and expose Marcos' regime as coldblooded killers. He also found something else—<u>THE U.S. GOVERNMENT WAS A</u> WILLING ACCOMPLICE.

## GLOBAL ALLIANCE INVESTMENT ASSOCIATION MEMORANDUM OF DIRECTIVE

The following points and authorities are offered hereby to eliminate any misunderstandings between negotiating parties as relative to the PERUVIAN BONUS CERTIFICATE # 3392-181, originated in 1875 and accepted as United States of America Treasury debt in 1906.

Since this debt was assumed prior to any other agreements involving monetary departments, divisions, or branches of government, this is a bonafide outstanding debt of the United States of America, the U.S. Treasury, the Federal Reserve System, the International Monetary Fund and the central World Bank and/or branches thereof.

The applicable restrictions and limitations in this transaction will apply to all participants. Due to NATIONAL SECURITY considerations no input to change or remand the validity of the debt created by BONUS 3392 will be accepted from the COUNCIL ON FOREIGN RELATIONS, the UNITED NATIONS, or any other entity, foreign or domestic.

As of November, 1997, all records formerly kept (and available for inspection) at the Peruvian Consulate in Los Angeles have been moved to Peru to prevent their possible destruction. Only individuals having appropriate authorization and credentials will be allowed to view them there.

All relevant documents, including the lawful chain-of-title of Bonus 3392, were legally recorded on August 10, 1998 at 8:35 A.M. and may be found at the office of Judith A. Vandever, Clark County Recorder, 500 South Grand Central Parkway, Las Vegas, Nevada 891-55-1510, Book 980810, Instrument 00323.

Because the amount of debt created by BONUS 3392 is so large that the global economy could be brought to collapse through its misuse, agreements have been finalized to allow the hypothecation of portions of the debt (through the use of contracts or deeds of assignment or leasing agreements) pursuant to the following rules and restrictions:

While prior use of the contract/certificate is noted, the parties using it will not be named in this document. Should such parties refuse their cooperation in the future, they may be named.

The contract has been utilized by the U.S. and hypothecated as COLLATERAL for use of the IMF and WB for the support of United Nations activities.

It has been agreed that the United States Federal Government may continue to use these contracts as collateral up to fifty percent (50%) of the accrued value.

The Holder of the contracts will be allowed to utilize the other fifty percent (50%), PROVIDING:

The Holder and its funding parties restrict themselves to single contracts not exceeding fifty billion dollars. (This does NOT preclude the offering of more than one such contract to any one entity.)

To avoid exposure of too large an asset it will be permissible to utilize corporations of common ownership to hold such additional contracts.

Under extraordinary circumstances warranting the issuance of one larger contract, for instance, the purchase of a single property, larger contracts may be issued if care is taken not to exceed the 50% use limitation.

It is anticipated that the Holder will purchase gold equal to the value of its portion of the contract to be pledged as collateral for a line-of-credit. Any "lease" arrangement must be structured to accommodate this requirement. The payment for leased collateral will be applied only to the funds available to the funder (not those of the Holder) and will be one percent (1%) per month for 120 months or two percent (2%) for 60 months.

As a consideration of National Security (as well as Global Security),

transactions WITHIN these guidelines will not be interfered with or blocked by the U.S. or its assigns. The consideration for such noninterference is that none of these contracts will be lodged for collection until such time as there is an additional agreement as to the lodging and honoring, through payoff, of the contracts.

Generally, it will be the practice of the Holder to expect the funder to provide loan capabilities and to purchase the gold as needed wherever there is security and it is NOT required to be housed within the U.S.


The Holder will not directly do business with any national group under sanction by either the U.S. or U.N. There is to be no restriction, however, on other parties or nations conducting business in their normal way. The Holder will conduct itself in the strictest accordance with all applicable laws.

The Holder has agreed to use its portion of funds for humanitarian purposes. No portion of its funds or assets will be used for purposes of ARMS ACQUISITION, WAR MAKING, OR THE OVERTHROW OR SUBVERSION OF ANY NATIONAL GOVERNMENT. However, the Holder has no way to police the use of funds by any other participating party.

Any abuse of these contracts or this DIRECTIVE will be considered by the U.S. as TREASON.

We must repeat that which is already obvious: THIS ONE ENTITY HAS VALUE ENOUGH TO DESTROY THE ENTIRE WORLD ECONOMY AND THIS WILL NOT BE ALLOWED THROUGH MISUSE THEREOF. 


