U.S. MAY BUY BACK DEBT

By Martin Crutsinger, AP Economics writer, 8/5/99

WASHINGTON (AP)—The Clinton administration, seeking ways to manage the government's finances in a new era of budget surpluses, said today it is exploring buying back a portion of the \$3.6 trillion national debt held by the public, something that has not been done since 1972. [H: Don't miss that that was when the President took you OFF THE GOLD STANDARD— OFFICIALLY.1

The Treasury Department released for public comment a proposal that would allow it to take competitive offers from bond-holders on a voluntary basis to reduce the amount of debt. Officials said that after a 60-day comment period they hope to establish final rules for the procedure by January. [H: Now you move away from the three-step and into the Waltz across Texas and right into the seductive Tango.]

Speaking to reporters at the White House, President Clinton said the new procedures will set the stage for completely eliminating debt held by the public by 2015, something that has only happened once before in the nation's history, in 1835, when Andrew Jackson was president.

Clinton likened the proposal to a family refinancing I will offer some Libyan ideas as presented. And I its mortgage to save when interest rates decline and then

"Let's refinance our nation's mortgage and then wipe the ledger clean," Clinton said. "We have the chance of a lifetime to do it." [H: Yes, indeed, but not through this pile of buzzard-poop—through good old bat guano!]

The Treasury has not bought back securities since 1972, when a few existing bonds and notes held by the public were swapped for new debt issues.

Because of huge budget deficits in the 1980s and early 1990s, the national debt has exploded, climbing from less than \$1 trillion before Ronald Reagan took office to \$5.5 trillion currently.

The government last year enjoyed its first budget surplus since 1969. And the administration is projecting that last year's record, \$69.2 billion surplus will be followed by an even bigger surplus of \$98.8 billion this year, marking the first back-to-back surpluses since insight on the real motive behind this action by the Dwight Eisenhower was president in 1956 and 1957.

Indeed, the administration and the Congressional Budget Office are projecting continued surpluses over the next 15 years—assuming agreements to cut government spending are honored—enough to totally eliminate the \$3.6 trillion in debt held by the public in 2015.

Up until now, it has been able to just reduce the size of new borrowings rather than being required to buy

back debt from the public. But officials said they do not torches." want to reduce current offerings too much and believe they can save taxpayers money through lower interest rates by buying back debt already held by the public, much of it at higher rates than current offerings receive.

Summers told reporters that use of debt buybacks raises a "number of complex issues that will need to be worked out."

Officials stressed that any government purchases would be on an entirely voluntary basis. They would be done through a type of reverse auction, in which the government would announce the type of securities it was interested in buying and accept the most competitive bids from holders of those securities.

Gensler announced another change in Treasury auctions today that will take effect

AFRICAN LEADERS BEGIN FOUR-DAY EXTRAORDINARY SUMMIT

TRIPOLI, Libya (AP)—Col. Mohammar Gadhafi Of that amount, \$3.6 trillion is in public hands, and securities back to the government, Treasury would have kicked off an African summit on Monday with a call for the establishment of an African union modeled after the United States, the former Soviet Union or the European

> "I've been impatiently waiting for this day," Gadhafi told African foreign ministers at the opening session of the four-day extraordinary gathering. "We have no future without unity."

> Gadhafi called for the extraordinary summit in July at the OAU's annual meeting, which was held in Algeria to discuss a long-overdue restructuring of the organization's charter.

> Several heads of state have already arrived in Libya to participate in the last two days of the summit starting Wednesday and a military parade on Tuesday, celebrating the 30th anniversary of the coup that brought Gadhafi to power.

> Gambia's foreign minister, Mohamed Sedat Jobe, said Africans would like to reconstruct the OAU charter "to make it a much more functional charter that would reflect the strengths of the continent".

> "The fact that we are not solidly united makes us very vulnerable to exploitation on the continent," added Jobe. "I do hope that we leave here a stronger OAU."

> Gadhafi said that, following consultations with African experts and heads of state, he found out that some leaders favor the establishment of a United States of Africa similar to the United States of America, while others preferred a union modeled after the former Soviet

> Gadhafi said he found the 1991 Abuja Treaty, which called for the setting up of an African economic community by 2025, to include all elements of unity, such as the establishment of an African congress, a bank and a court.

THIS IS A WARNING TO ALL CONCERNED PARTIES, AGENCIES AND AUTHORITIES. THIS MEMORANDUM, FURTHER, IS TO PUBLISH THE FACTS OF THE ABOVE-NAMED INCIDENT.

THIS IS CONSIDERED, BY GLOBAL ALLIANCE, A FULL BREACH OF ALL AGREEMENTS AS REGARDS ONGOING NEGOTIATIONS, CONCERNING GLOBAL ALLIANCE INVESTMENT ASSOCIATION AND/OR PROPERTY THEREOF. THIS MEMORANDUM WILL BE PUT TO PRINT BUT WILL NOT, YET, BE RUN AS A PUBLIC NOTICE, SHOULD WE RECEIVE A COMMITMENT THAT THE CIRCUMSTANCES WILL BE PROPERLY ATTENDED.


It is not mine, readers, to JUDGE your choices— THOSE ARE YOURS.

Earthquakes, Volcanos And The Phillipines

The following article, reprinted from the first-ever issue of CONTACT (Vol. I, Issue 1—April 30, 1993), provides sound geophysical lessons, as well as a reminder of the adversarial attacks of that time.

I am Commander Ceres Anthonious Soltec, henceforth known as "Toniose", in charge of the geophysical aspects of this Earth-Shan, planetary-transition project, come as the Hosts and present in the Radiance of the Holy God of Light. Yours has been a busy week, geologically speaking, as you have experienced both volcano eruptions and earthquakes, and now the promise of yet more strong storms approach your western areas.

It has also been a very busy week at the offices of the newspaper and we are well pleased to be invited at the beginning of a new and great stage of the mission. You celebrated the beginning of your Spring Season with a real good "spring cleaning", and the house is clean, fresh and aired out as you are readying yourselves for the warm Summer sunshine.

We shall not mourn that which has passed away, for a great metamorphosis has now taken place, as you can well see from this new newspaper publication. We salute all those who are "hanging in there"—for the rewards, though not of the worldly kind, hold great promise. It has been a long and difficult road that you ones have traveled, and you have certainly received more than what you feel is your fair share of the slings and arrows and, though your burdens have been great, there have also been many good times and great lessons. Both shall serve you well in the coming days.

MOUNT MAYON, PHILIPPINE ISLANDS

But now, on to the subject of this message. The volcano eruptions of which I speak are those of Mount Mayon in the Philippines, as it erupted on Sunday last, March 21, not just once, but *seven times in one day*, with the last of the seven having been the strongest. The smell of sulfur is strong in the air, indicating that more magma is rising and forming yet another volcanic dome, which will lead to more eruptions. This is almost a foregone conclusion, as this part of your globe is a hotbed of geologic activity and promises only to bring more as time goes on. The eruptions are still ongoing, so LOOK OUT! This is but the heralding of yet greater seismic and volcanic events to follow in this and other areas of that Pacific Rim.

That little tectonic plate, on which this chain of islands lie, is literally teeming with renewed volcanic and seismic life. The magma chambers below the surface are rising, as the heat and gases from beneath exert pressure causing the magma to build into another dome, priming the mountain for yet another explosive display. Please recall our previous writings regarding this area of your globe as we, at that time, told you ones that it was a mere matter of a short period of time before this volcano would continue with its eruptions. Recall, also from previous lessons, that these islands are of volcanic origin, and with the renewed activity

in the Pacific Ring of Fire, more and more intense seismic and volcanic activity is to be expected.

The Philippine Plate is caught between three other great tectonic plates—they are: the Pacific Plate to the East, the Indian-Australian Plate to the South, and the Eurasian Plate to the West. As these other plates move toward the Philippine Plate from all directions, they are slowly subducting beneath the little Philippine Plate, causing it to push upward, or uplift. The subducting masses, then, also place pressure on the already full magma chambers, causing the magma and the gases to push upward and out the vents—in this case, Mount Mayon. As the subducting process continues, the magma continues to rise, creating more lava domes within the crater.

The strong odor of sulfur in the area indicates that gases are still rising and in most cases it is the precursor to more eruptions. Keep also in mind that these gases are extremely volatile and explosive in nature, so the eruptions of these volcanoes are explosive and spectacular. It was reported by your own scientists that the ash cloud extended approximately thirteen miles upward—that is 68,640 feet—quite an explosion, would you not agree? All that I can tell you is that it "ain't over till it's over". And believe me, it ain't over by a long shot! This part of your world, as I have taught previously, has entered a new geologic cycle and you are now beginning to see part of the awesome power that lies within the Earth.

This volcano is but a tiny glimpse of what was experienced when the Island of Krakatoa was destroyed by three, thought-to-be-inactive volcanoes in the Pacific Ocean in 1883. Only about one-third of the island was left after the eruptions. This, too, was an Indonesian Island and rose approximately 800 meters [about 2500 feet] out above the water before the eruption. After, there was a 300-meter depression where the island had formerly been. This explosion was felt over 5,000 miles away. On the island of Java, thousands of people died in a tidal wave that resulted from this tremendous volcanic eruption. That type of potential still exists in this place today, chelas. Will an eruption of that magnitude occur? That is a difficult one to call, as many variables are in effect. I am just informing you that the potential does exist—the statement is not meant to be prophetic in nature.

PORTLAND, OREGON EARTHQUAKE

Let us now cross the vast Pacific Ocean to the East and examine the site of an earthquake which occurred just today near Portland, Oregon. It measured 5.7 on your scales, was felt for approximately 45 seconds, was reported as a rolling sensation, and felt as far away as 120 miles. To you who reside in California, this should sound very familiar, as it was the same type of shock wave that has rocked your place several times in the past year. Recall your past lessons regarding this type of rolling-motion earthquake—it was very deep within the Earth, so that the 5.7 would actually

equate out to nearer a 6.0 shock.

What you should find most interesting about this earthquake of today, if you have been following my lessons at all, is that it occurred in a place where much the same type of conditions exist as in the Philippine incident. You once again have a plate (the Juan De Fuca Plate) which is subducting beneath another plate (the North American Plate) and this mass, pushing below, is exerting pressures on magma chambers beneath the Cascade Mountains in the area. Look at the similarities.

Prior to the eruptions of Mount Pinatubo and Mount Mayon, there was a series of moderate to strong earthquakes. The causes of these occurrences were when one or more of the opposing plates moved against the Philippine Plate and pushed land mass beneath it. The little Juan De Fuca Plate is moving against the North American Plate as the Pacific Plate pushes against it, causing it to dive beneath the North American Plate. This exact scenario has been covered in recent, previous writings, and we have shown you ones that the potential for seismic and volcanic activity in this place not only exists, but there is a very good chance for such events to accelerate with greater amounts of energy releases. This potential for more activity grows with each passing day, as your world is now experiencing the time of changes foretold by many, both past and present.

What is concerning your scientists is that this area has been so quiet for so long, they fear another event, such as that which occurred with Mount St. Helens, several years past. One scientist even admitted that what they are concerned with is that this is a subduction zone. *Fill in the blanks, and you have exactly what we have been informing you of prior to this event.* Your scientists may have been caught off-guard, but you who had been following the now-deceased *PHOENIX LIBERATOR* [Ed: *CONTACT*'s forerunner]should not have been caught unawares, for there have been numerous warnings and instructions given regarding this possibility.

CALIFORNIA AREA ACTIVITY

This letter is intended to confirm our telephone conversation of Friday, April 14 relating to the Ekker problem.

I would recommend that each person defrauded by the Ekkers write a detailed letter to Ed Jagels, Kern County District Attorney, Don Lundgren, Attorney General of the State of California, the Fraud Department of the U.S. Post Office, and the Fraud Department of the Securities and Exchange Commission in Washington, D.C. setting forth a detailed account of how they were defrauded and requesting criminal prosecution of the Ekkers. I would also recommend that each person send a similar letter to the District Attorney of the county in which he/she resides. In addition, I would recommend that each person defrauded send a similar letter to the Attorney General of the State of Nevada as the Ekkers do a substantial amount of business in Nevada. Lastly I would recommend that each person who was defrauded contact any local government official they know and ask that government official to apply pressure to the District Attorney or Attorney General. For example, if Mr. Jones was defrauded and he is friends with an Assemblyman where he lives he should contact the Assemblyman and ask the Assemblyman to set up an appointment with the District Attorney of his county and with the Attorney General of his state. Hopefully, all of this pressure will get some action on the criminal front against the Ekkers.

If I am retained as the attorney, I would assist in preparing the above letters and contacting the appropriate prosecuting officials.

Both of us know what the Ekkers are and, therefore, no further description of their honesty, integrity, etc. is needed. If I am retained as the attorney for the persons defrauded, I would want a substantial warchest. The Ekkers will fight every inch of the way and will attempt to hide their assets and, therefore, going after the Ekkers will be a full time job. To put it slightly differently, I would have to give up my entire practice and only proceed against the Ekkers. Not only would I have to proceed against them in the courts, I would also have to proceed against them on the public relations front. That would require providing evidence to the editors of all appropriate newspapers so that they and their shills cannot use the newspapers to attack the victims, appropriate law enforcement agencies, and every one else concerned in their fraud.

You have indicated to me that you were contacted by people that were defrauded in the approximate amount of \$2 million/\$2.5 million. I believe it only fair for each person to put up 10% of the amount he/she was defrauded so that my warchest would be \$200-250,000 for legal fees and costs. I would not proceed until and unless that money was deposited in my Attorney's Trust Account so that I could be assured of receiving payment for the services I render and for the substantial costs I will incur. I will incur substantial filing fees and, in all probability, incur substantial private investigators costs.

I think the above summarizes our conversation. As I advised you, if the people cannot put up a warchest equal to 10% of the amount they have been defrauded, I am not interested in proceeding against the Ekkers. If the people haven't got the courage to put up 10% of the amount they were defrauded to hopefully recover the amount they were defrauded, then they do not deserve competent legal counsel.

FEDS BUILDING GIANT SURVEILLANCE SYSTEM

I think it's time to raise the warning flag! Once again, our source has come through with startling revelations of a giant surveillance program geared to build "personality profiles" and trace our every move...

...The Washington Post has now reported that the Federal Communications Commission issued an order, on Aug. 27, that could turn every cell phone in the country into a homing beacon that law enforcement could use to track the general location of criminal suspects.

This news, in turn, comes only weeks after word leaked of a Clinton-administration proposal being readied that calls for the government to put surveillance features on all computers in government networks and to encourage private networks to do the same. The goal: (they say) to spot patterns of suspicious hacker activity and to relay that information to a central computer-defense agency for analysis. The side effect: A great deal of Internet surfing could be traced.

One of the groups that helped draft the legislation was the Center for Democracy and Technology, a District high-tech policy group. James X. Dempsey, who monitors telecommunications issues for the group, said, "We thought we were creating a balanced statute, one that would keep the FBI from getting everything it wanted. We got a specific assurance from [FBI Director | Louis Freeh—we thought that location information was not covered by CALEA."

Since the passage of the 1994 bill, however, the FBI has pushed the FCC to require the industry to include cell-phone tracking and other features that civil liberties groups contend go beyond the scope of the law. "When the FBI director gets to set the technical standards for the nation's telecommunications system, clearly something is amiss," said Rotenberg.

An FCC official told me there is a balance in the new technical specifications for cell phones, which would allow law-enforcement people to determine only the general location at which a cell phone was used...

...I called Clifford Fishman, a professor of law at Catholic University, who wrote a leading text on wiretap law...

"I'm confident that the number and frequency of illegal taps is very low," Fishman said. He also said that, since the police know the location of the wire-line phones they tap, the cell-phone location information simply gives law enforcement the same kind of information with the new technology.

It all comes down, he suggested, to whether you trust government to do the right thing.

PRIVATE FIRMS ARE **BIG SPIES ON OUR LIVES**

When we worry about who might be spying on our private lives, we usually think about the feds. But the real snoops are in the private sector—and their snooping is protected by law.

Take your phone records: The government has to get permission from the Justice Department before it can look at them.

But under a court decision rendered in mid-August, your phone companies can sell your personal records to an outside marketing firm, with minimal notification to you. The marketers can find out where you called, when and for how long, and use that information to sell you other products.

By law, phone companies can't sell your records without your approval. The Federal Communications Commission defines "approval" as meaning affirmative consent: You have to be asked if you want your records sold, and you have to say yes.

US West and other phone companies challenged this interpretation before the federal court of appeals in Denver and won. The FCC will appeal.

If the FCC loses again, here's what will happen: You'll get a notice, in fine print, stuffed into your phone bill along with other notices, saying that your personal records will be sold unless you say no. Many customers won't read the notice. That will constitute "approval", and your records will be up for sale.

You have almost no protection from businesses that want to use your personal records for profit...

- ...- No federal law shields "transaction and experience" information—mainly, the details of your bank and credit card accounts. Your bank can disclose them, at will, to telemarketers or other commercial users. (A few states have privacy laws, notably Florida, but they're limited.)
- Our Social Security numbers are on sale by private firms...and [they] ship your number to commercial firms.
- Self-regulation doesn't work. A firm might publish a privacy-protection policy, but who enforces it?...Customers were promised, in writing, that "all personal information you supply to us will be considered confidential." Then...[they] sell your data to a telemarketer.

Minnesota sued a bank for deceptive practices. The bank settled the case without admitting wrongdoing.

- No law protects your activity on the Internet. Most web sites openly (or surreptitiously) collect data about what you view and buy. It's sold to others who want to market to you.
- The next frontier will be the data held by states. Personal stuff from driving records is already sold by many Departments of Motor Vehicles. Marketers also have access to your property-tax assessment or the price of your new house.

The states hold many records that are already public-say, wills and divorce agreements. Is it OK to publish them on the Internet? Could they be compiled, mixed with your financial data and sold for marketing purposes? Without a good privacy law, the answer is

SENATORS WARN AGAINST Y2K STOCKPILING

WASHINGTON—The Senate's top two experts on U.S. preparedness for the year 2000 computer bug are warning Americans against hoarding cash, medical supplies, food and other items out of paranoia that the Y2K glitch will severely disrupt society.

Sens. Bob Bennett, R-Utah and Christopher Dodd, D-Conn., said that although governments and businesses have made great strides in preparation for the millennial date change, there will be some problems, with threats from outside the United States offering the most potential for chaos.

Bennett, the chairman of the Senate's special committee on the Y2K problem, and Dodd, the vicechairman, are preparing to release their second major report on the issue before the end of September...

Bennett...[who] mentioned that he has purchased a 55-gallon drum he intends to fill with drinking water before the end of the year, said people and organizations should "stockpile information" about what might affect them if the Y2K bug takes hold at midnight on Dec. 31.

Dodd urged Americans that hoarding cash and perishables "could certainly do more damage" to the economy than whatever techno-glitches might be lurking in U.S. systems, and he asked for "reasonable, common-sense preparation," such as what might be adequate to wait out a hurricane...

...People who rely on medication should maintain their usual supply, though, Dodd said, because a shortage would be more difficult to rectify than a computer error in distribution networks.

While the senators said the Y2K season most likely won't change the average American's life, they emphasized that key U.S. computer networks could be under siege if...cyber-terrorists or information warriors are able to exploit them.

Meddling whiz kids, industrial spies, foreign terrorists or even other governments could infiltrate, Bennett said, noting that top Chinese officials have said the most effective way to fight the United States would be in the cyber world, not on the conventional battlefield...

...Russia remains a concern for its nuclear arsenal, and the senator said he has written Moscow twice to urge it to join in a Y2K early-warning project connected to the NORAD system based in Colorado.

The project's goal, Dodd said, would be a "clear look at the skies", so that all nuclear-capable nations, even late-comers, India and Pakistan, could be sure their airspace information is accurate and not corrupted might erupt between Myanmar forces and those of the modern viruses might be a mixture of highly evolved

expects the Russians will sign on within the next few insurgency groups fighting the central government. weeks.

Despite all the warnings, the senators were largely optimistic about what the new year might bring.

"The bottom line is, we're in a lot better shape than either of us would have predicted 10, 12, 14 months ago," Dodd said.

Bennett today also denied that he ever said Y2K could lead to martial law, calling the reports "nonsense".

...Still, while the All Nines appeared to be shaping up to be just another day in the computer world, it was anything but ordinary for thousands of gamblers, eccentrics and lovers across the world...

...In Malaysia, four-digit lottery ticket hawkers were on a roll, The Sun newspaper reported, with "9999" being a hot bet at lottery outlets. And 999 senior citizens were to attempt to set a new-albeit obscure—Malaysian record for the largest gathering of older persons in a circus.

Malaysian couples were also rushing to get married. Ninety-nine couples took their wedding vows in a mass ceremony, at exactly 9:09 a.m., at a Buddhist temple in the capital of Kuala Lumpur. VIRUS FOUND IN ARCTIC ICE

The discovery of the first virus preserved in the Arctic ice has prompted a warning that there may be more, and that warm weather may release them to start epidemics.

The virus, a tomato mosaic tobamovirus (ToMV), was found by a team of American researchers.

The discovery, reported in the magazine New Scientist, suggests that other viruses, possibly including flu, smallpox and polio, may also have survived in the

... His colleagues, Scott Rogers and John Castello, of the State University of New York in Syracuse, had earlier found ToMV, a common plant pathogen, in clouds and fog.

It can survive in such environments because it belongs to a family with very tough protein coats.

The researchers thought they might find the virus in the ice because it is widespread, moves in the atmosphere, and is very stable.

So they examined four ice cores, from three sites in Greenland, containing ice between 500 and 140,000

To prevent contamination they first disinfected the outside of each core using ultraviolet light, and then searched the inner core for RNA from the tomato pathogen using the polymerase chain reaction (PCR).

As they had suspected, the RNA was present—and sequencing revealed 15 strains of the virus.

The PCR method destroys organisms as it amplifies their genetic material, so the team is not certain the viruses had retained the protein coats that help them to invade cells.

But John Castello says they probably needed the coats to survive for centuries in the ice.

The team says a brief rise in temperature could let loose any viruses and cause disease.

Scott Rogers told BBC News Online: "We think micro-organisms are being released constantly, during periods of warming, and when glaciers calve"...

...Alvin Smith, a virologist at Oregon State University, said: "If you've got these things lying in the ice for a thousand years or more and their usual host has not had to deal with them, this may be a source of epidemics."

He has found that caliciviruses, which can cause diarrhea, emerge from time-to-time from the sea to cause new infections.

Identical caliciviruses have appeared at 20-year Apparently taking such rumors seriously, the intervals on opposite sides of the USA, he says, and could have spent years in the polar ice before reemerging.

> "How did these viruses stay the same for so long?" John Castello says the discovery could mean that

"Perhaps they are actually ancient populations that have been recycled over and over again. How can you do evolutionary studies if that's true?"

He and his colleagues now plan to use other techniques to see whether viruses in other cores are still viable.

They will also look at ice from the Antarctic that is up to 400,000 years old.

Among the first cities to champion the battle against illegal antennas was Beersheba with Mayor Yaakov Turner recently announcing that all illegal antennas were going to be removed by the city. The announcement prompted providers to call for a meeting where the sides ironed out their differences.

COVERT CROP OPERATION

WASHINGTON—Grain traders worldwide will be on high alert Friday when the government releases its monthly U.S. crops forecast assembled under conditions worthy of the spy business.

Before it's made public, only nine people in the U.S. Agriculture Department are privy to a report that can influence farm product prices from Chicago to Tokyo. Under century-old secrecy rules, even the president doesn't get advance notice, as he does with some other economic statistics.

The report is the most detailed and reliable crop forecast in the world, compiled by an army of people who count corn kernels, cotton bolls and soybean pods. Last month's report predicted bigger-than-expected harvests, sending corn and soybean prices tumbling.

"There's nothing more important than the USDA's production numbers," except perhaps the weather, said Dick Loewy, president of AgResource Co., a Chicago commodity research company. Crop prices already are rising on expectations the USDA will reduce its forecasts, after a heat wave slowed some plant growth.

Every month, the crop report is treated like CIA data: It's assembled in secret, after a midnight rendezvous behind locked, guarded doors, using coded dispatches from field operatives.

The nine analysts who enter the inner sanctum at the Agriculture Department the night before give up contact with the outside world until the report is released at 8:30 a.m. Washington time. Phones are disconnected. Rooms are swept for bugs. Window blinds, embedded with lead wires to jam electronic signals, are drawn. Elevator doors are bolted shut...

... The Commerce Department figures the gross domestic product the day before the public release and gives it to the president. The Labor Department prepares its reports on consumer and producer prices a day ahead. An advance copy goes to the president's chief economic adviser.

Preparations for the monthly crop report are among the most secret for good reason, economists said.

For many government reports, interpretations can vary widely. Statistics suggesting a strong economy could mean rising profits, leading investors to buy stocks...

...In agriculture, there's less ambiguity. A crop report showing less supply than expected, usually means just one thing: higher prices...

...By the time of that scandal, the department had already been doing crop surveys more than 40 years ever since President Abraham Lincoln created it in 1862 to "collect seeds and distribute statistics", Allen said.

The acquired wisdom and the resources of the federal government have helped establish the crop report's reputation...

...Friday's forecast of the corn harvest will probably be accurate within 5.8 percentage points of the eventual total, based on September predictions over the last 20 years. By November, with the harvests almost complete, it's within 3.9 percentage points.

Collection of raw data for this week's report began

in late August. About 400 part-time workers inspected pre-selected fields in the major growing states. Workers tread carefully, lest their presence influence the harvest. "You don't even pull the weeds," Allen said.

Other workers survey 27,600 farmers in other states by phone or mail, asking about plantings and their harvest expectations...

...Results are fed to Agriculture Department offices in each state and tallied. State offices make a harvest estimate and send encrypted data to Washington...

...Around midnight before the report...the information is decoded and put on spreadsheets in the BAT room, which is scanned continuously for eavesdropping devices.

Allen and eight other officials tally the numbers, matching them against historical data, weather conditions and other factors before arriving at harvest estimates about 3 a.m.

Two reports, one domestic and one global, are printed on a press inside secured corridors.

PUTTING A FACE ON ID THEFT

Gerald Neustadter is 5-foot-3 and African-American, but that didn't stop him from slipping on the victims were out identity of Morton Grove resident David Neustadter, who is 5-foot-11 and white.

An estimated 500,000 people a year become victims of identity theft in the United States, with about three victims a day calling the Cook County state's attorney's office for help.

In a report to Congress in April on financial identity theft, the Federal Trade Commission said the Social Security Administration conducted 1,153 investigations of Social Security number misuse in 1997, compared with only 305 in 1996. The report also said the Trans Union credit bureau reported 522,922 consumer fraud inquiries in 1997, up from 35,235 in 1992.

Recognizing the growing problem, Congress and the Illinois Legislature have passed new laws.

Police say criminals are finding more ways to gain access to personal information, from rooting through trash bins for personal papers to hacking into computer files.

Thieves use someone's name, address, date of birth, Social Security number and other information to obtain bank accounts, apply for home and car loans, and even file income tax returns in the victim's name to obtain refunds.

The biggest financial losers usually are the banks and credit card companies. But lawmakers are now recognizing the toll on victims.

On Aug. 13, Gov. Ryan signed a law making identity theft of money or property of more than \$300 a felony, with stiffer penalties for targeting the elderly.

Congress passed a federal law against identity theft A companion agency, the World Agricultural in October 1998, carrying a penalty of up to 15 years in prison. The Federal Trade Commission now takes complaints and helps victims and has started tracking the number of identity theft cases for the first time. A new FTC Web site, www.consumer.gov/idtheft, was launched Aug. 23.

PUBLIC NOTICE

In fulfillment of legal requirements, this is the second of three required publications of this Public Notice.

The Officers and Directors of **Global Alliance Investment Association** (GAIA) do hereby commit, as requested, in public notice, an understanding of agreement, by and between GAIA and as-yet-unnamed representatives of the Federal Reserve Board of Directors, the U.S. Treasury Department, the International Monetary Fund and authorities of the World Bank, as representatives of what are considered the "Establishment" Banking-Cartel, that we shall act within said agreement as follows:

We of GAIA will issue no documents or funds for the sole purpose of any Trading Programs, local or international; we will not participate knowingly in any way to assist or contribute to those programs called "Roll-Over", or in any way join with any portion of GAIA's assets in any form of "currency trading or manipulation" of any nation.

It is recognized that GAIA has no authority over, or responsibility for, any portion of any assets held by any Joint Venture Partner (JVP), or the transactions between or "in house" of any Banking Institution, Central or otherwise.

We will always lay as a foundation the request that our portion of any transaction be backed immediately by something, i.e., gold, as a collateral base for all transactions. This is to secure all parties to any transaction and, most specifically, any participating bank or banks. We accept no responsibility for that which is the property of any JVP.

It is hereby noted, however, that we fully recognize that the Establishment Economic Community is phasing out of all "trading" types of programs, and our best efforts will be toward discouragement of any investment in such ventures.

We also state that we are ready, willing and able to assist, in any way possible, a movement toward the return by any nation, inclusive of the United States of America, to a "Gold Standard", as was recognized prior to the *Federal Reserve Act* of 1913. The "GAIA DEEDs" are now recognized as VALID AND NEGOTIABLE INSTRUMENTS.

We are further aware and in knowledge that reserves—of some 48% of that left for the People of the United States of America—are funds sufficient for paying the national DEBT in full, and forming a foundation upon which the nation can be self-sustained throughout the various States of the Union of the United States of America.

We acknowledge ongoing negotiations and agreements by said entities involved, that any ongoing interchange with the various Sovereign Nations of the Native Tribes within any Lands subject to Federal Regulations—be they U.S., Canadian or any national Tribal Communities on Sovereign land—shall be without interference, and assistance in economic structure, facilitating ongoing international trade and commerce of all types, will and shall be honored. All natives of all Tribes will and shall RETAIN citizenship within the nations of which they have been SUBJECT. It is further agreed and binding that there will not be interference in Tribal Councils, and Control by any Federal Government shall cease and desist from the withdrawal of welfare or Federal financing.

Further, the Native Councils shall be fully recognized as a governing body of FREE AND SOVEREIGN STATES, and also recognized is dual-citizenship status, as to each individual of each and every recognized Tribe.

Globally, it shall be recognized that Tribal Lands are Sovereign States. Those Tribes are to be further identified at forthcoming Global Councils as Alliances, formed under INTERNATIONAL LAW for the protection of ALL CITIZENS THEREOF.

For the Public Interest, however, we must recognize that we are required to agree, through PUBLIC NOTICE and INTERNATIONAL ANNOUNCEMENT, our agreements, while our co-negotiators have no restriction on their identity, and can and do constantly INTERFERE with ongoing activities.

We do, therefore, state publicly that as the Global Establishment-Elite break their resolutions to this Alliance, we shall not be restricted by this agreement. Prior agreements have continually been broken by these parties in point and this is also to be put into public notice. We note that our word is our bond in agreements, both oral and written, but there is no return by either honor of verbal agreements, or any form of written contract.

This Public Notice, therefore, is fully recognized as the Agreement by and between the parties of authority, and is hereby recognized by signature of the President and Director, and the Secretary and Director of Global Alliance Investment Association.

THIS AGREEMENT IS FULLY LEGAL AND BINDING AS OF SEPTEMBER 9, 1999 (9/9/99), AND IS HEREBY DATED AND SIGNATURES AFFIXED THIS FIFTH DAY OF SEPTEMBER, IN THE YEAR OF THE LORD, ONE THOUSAND, NINE HUNDRED NINETY-NINE.
