UK GOLD SELL-OFF TARNISHED BY IMF

GORDON BROWN, the Chancellor, will be obliged to back an embarrassing compromise deal at the International Monetary Fund (IMF), after the US Senate spurned his plan to sell IMF gold.

The new proposals come as the gold market waits nervously for tomorrow's UK Treasury gold auction. The

second planned bimonthly sale of 25 tonnes [880,000 ounces, worth \$224,400,000] is part of a programme to policy, which has been to support central bank auctions in ditch most of the UK gold reserve.

IMF officials have now drawn up plans that effectively revalue its gold stock, avoiding any necessity to sell it. The change will leave the UK as the main enemy of developing countries that mine the precious metal.

Their lobbying succeeded because the IMF sale was meant to provide a fund to defray debt of the poorest countries but had a worse effect on many of their export

The new proposals will enable the IMF to use its gold reserves to relieve Third World debt without flooding the depressed market for the metal. As a result, much more aid might be financed. [H: Anyone already barfing? No? Well you will within, surely, the next three paragraphs.]

Finance ministers will study at least two ideas before which Mr. Brown now chairs, in an effort to win critical support from the US Congress.

The scheme most likely to be adopted by the IMF, would see countries that are due to repay debt to the IMFbuy the gold at the market price and give it back immediately as a means of repaying the debt.

FOR POLITICAL REASONS, IMF GOLD IS VALUED AT ABOUT \$45 (£27) AN OUNCE COMPARED WITH THE MARKET PRICE OF \$255. SO THE SCHEME COULD GENERATE AN ACCOUNTING PROFIT FOR THE IMF OF \$210 AN OUNCE. THE SURPLUS WOULD BE INVESTED AND THE INTEREST USED TO FUND DEBT RELIEF. [H:

An alternative scheme, approved by Japan, INVOLVES THE IMF SELLING SOME OF ITS GOLD TO CENTRAL BANKS, ON THE CONDITION THAT THEY COULD NOT SELL IT INTO THE MARKET. AN IMF BUYBACK GUARANTEE WOULD BE NEEDED TO AVOID THIS RISK.

The idea of selling about 300 tonnes [worth \$2.7] billion, the interest on which, at 7%, yields \$188 million "for debt relief"] of the IMF's gold reserves—drastically to cut Third World debt—was the brainchild of Mr. Brown. The Treasury said he remained committed to the plan but was open to alternative means of achieving the debt reduction objectives. [H: By the way, that sum of money wouldn't even start to pay a pittance of the debts of these countries.]

The Chancellor has already been blamed for the slump And what is the claim today by the UK and the in the price of gold. Since the Bank of England announced that it would sell 415 tonnes, the price has tumbled from \$290 an ounce, cutting the value of the world's gold reserves by 12-percent and shrinking the base for world credit. CITY: ROTHSCHILD IN U-TURN ON GOLD RESERVES SALE

NM ROTHSCHILD, one of the City's oldest merchant banks, apparently made a U-turn yesterday after it attacked the Government's policy of selling more than half of Britain's gold reserves through open auctions.

Clive Turner, a Rothschild director, told the BBC's Today Programme that it would "cause far less disruption in the price" if the gold was sold through the twice-daily gold price fixing, which is run by Rothschild and provides the benchmark for the world gold price.

Mr. Turner seemed to overturn Rothschild's previous principle. Last summer, Helen McCaffrey and Ric Simes, two of the bank's senior economists, wrote in a report: "What the market needs now is the announcement of an orderly and transparent strategy regarding gold disposals."

They quoted approvingly Robert Guy, another Rothschild director, who said in a speech: "Gold auctions have the merit of being both practical and transparent. The mechanism of official gold auctions has been tested and proven.

"This is not a theoretical concept—it is one rooted in the precedent of the IMF and the US Treasury gold auctions in the late 1970s."

However, Mr. Turner said last night that he had been "quoted out of context". He said: "I was not questioning the openness of what the Government is doing, I was just saying the fix is a viable alternative to auctions. Selling the gold—bit by bit, on a daily basis—would cause much less price volatility than the bi-monthly auction of 25 tonnes. I was not questioning the auction method or saying they shouldn't make the sales."

Yesterday was the 80th anniversary of the price fix, STARTED AFTER THE FIRST WORLD WAR [H: Note: Rothschild's baby.]. Gordon Brown has been under fire since he announced in May that the Bank of England would sell 415 tonnes of its gold.

There are 110,000 books (*Journals*) MISSING and said destroyed. This was AFTER the Judge had ordered them to NOT BE SOLD BY GREEN, ET AL. At Green's own pricing, that amounts to well over a million dollars. He has owed, since 1990-2, over \$150,000 in

loans taken from the Institute and this has been validated in a Nevada court. That requires another \$150,000 interest for these years, in addition. Now, adding to that, Green took with him packages of KNOWN gold coins from David Overton, sent to the Phoenix Institute, but taken by Green and moved to Nevada and buried in Green's back yard. He took more gold than that, but some of it was recovered because he couldn't hide it.

We also have proof of diversion of funds, through Green, intended for the Constitutional Law Center, as worked out between Green and Gary Anderson through a Colorado bank account, while Gene Dixon was head of the Law Center and officed in the same suite as was Gary Anderson. There is PROOF of all these things and still the contempt continues. Do you ever expect true satisfaction? Do you ACTUALLY think George Green is truly going to have to pay for those books or meet that obligation on the loans? He has twice filed bankruptcy to bury the misdeeds and never even bothered to STOP selling the Journals through his "finger" corporations, through Grant Megan, Desireé and Mark Williams. Do you truly expect to COLLECT? All you can probably hope to get is some kind of a Judgement against Green, and what is that worth, in actuality?

Green is a self-described millionaire (at least 4-1/2 million \$\$\$); he was also a founder of the Institute and has been referenced as perhaps owning the Institute. Missing corporation record books and stock ledgers sustain that possibility. He would cover that as tightly as possible because, otherwise, he is 100% responsible for any debts of said Institute. Is this yet making sense to any of you?

Green, et al., have done everything in their power to get that Institute into Receivership, so they could claim whatever they wish to claim, and Green wouldn't have to pay his due-and-owing loans for the books, or produce the books. He also thinks he AND HIS ATTORNEYS would have access to assets, and he would get the gold he stole in the first place. ANSWER TO OIL CARTEL: WATER-POWERED CAR!

There is a direct solution to the problem of rising costs of gasoline and other oil products used by motor vehicles.

The solution is to stop using gasoline for motor engines and thereby bring down the oil oligopoly and all the leeches clinging to it.

Incredible as it may seem, FILIPINO inventor Daniel D. Dingel, a former NASA engineer who has several fantastic money-saving inventions to his name, has a gadget that makes a motor car run on water!

Strictly speaking, the car does not run on water itself, but on the hydrogen gas extracted from plain water by his invention, a mini-reactor, attached to the car engine.

We (F.D.P.) inspected last Sunday his water-powered car, a red Toyota Corolla whose gas tank had been disconnected.

Under the hood, there is a box-like gadget the size of a car battery, covered with a clear-plastic case through which one sees water—the fuel. There is a gadget, Dingel calls it a reactor, immersed in the water.

When the ignition is on, the reactor in the box runs and the water percolates. Bubbles rise in the water and break at the surface. The water molecules (H₂O) are continuously broken down into their hydrogen and oxygen components.

The hydrogen, which is lighter than oxygen, rises and goes to a pipe leading to the internal combustion chamber of the engine. The oxygen goes into a slightly smaller pipe, also leading to the combustion chamber.

In the chamber, the two gases are ignited by the usual spark plug, causing an explosion and moving the engine's piston as in the conventional, gasoline-fed engine.

Dingel has installed in his car an auxiliary reactor, a smaller version of the first reactor, performing the same function of producing hydrogen gas. When the engine's

the engine's performance more efficient.

A gallon of water that you get for free anywhere, he says, can take you 500 kilometers. Compare that to special gasoline, costing P13.37 per liter, that can take you from six to eight kilometers to the liter only.

The prototype cost Dingel only around P1,000 to fabricate. How's that for economy?

Dingel says that his invention can use any water, although he said hard water is preferred to distilled water. Tap water with traces of chlorine will do also. In fact, if one needs water when out in the countryside, he can scoop clear water from any stream. The residue can be drained later without much trouble.

There have been earlier experiments worldwide on using water as a source of hydrogen to run combustion engines. Many of them worked, but they were not viable. Nor have they been found suitable or practical for hooking up to a regular car engine.

One surprising aspect of the Dingel reactor is that it uses only the usual 12-volt car battery to run it. In the more sophisticated processes of extracting hydrogen from water, an ultra-high temperature of about 5,400 degrees Fahrenheit is needed.

While other experiments abroad are on the hightechnology level, Dingle's approaches are more basic. One is tempted to add intuitive.

His reactor has not been patented. Asked if this was because he did not trust the patent office, he recalled instead, reported cases of inventors submitting their gadgets to the patent office, leaving them for assessment and coming back days later, only to be told that a similar invention had been patented.

He is looking for somebody he can trust to help him patent his invention worldwide, without risking its being pirated at the patent office.

On the prospects of earning billions from an invention, he says he wants to use the money for paying off the country's foreign debt. He stresses that his invention is Filipino and not the product of the ingenuity of foreigners.

When asked what college degree he has, he says he completed Grade 6—in the Philippines. This is probably true, but we learned that he had been sent on special studies abroad, has trained extensively, has demonstrated his theories in foreign laboratories and has worked with the US National Aeronautics and Space Administration.

Dingel has a similar invention—a marine engine that runs on seawater. Imagine motorized watercraft drawing their fuel from an endless supply of seawater!

Many foreign visitors go to his place showing interest in his inventions. Volvo, manufacturer of marine engines, heard about Dingel's invention and sent an emissary and some technical men to look at it.

Result: Volvo is paying Dingel a substantial amount monthly, on agreement that he would not give or sell his invention to any other person or entity. Volvo is reportedly refining the Dingel invention and is planning to unwrap it for the market around 2002.

"Nevertheless, a host of auto makers—including all three American manufacturers, Japanese producers Toyota and Mazda, and Germany's Daimler-Benz and **death from pollution from those gas machines. That** BMW—are experimenting with hydrogen technology.

"It is potentially attractive,' said Brad Bates, Motor Co. 'It is worthy of study...But I think that a hydrogen-powered personal transport, the way you or I think of it, is still decades away.'

"Hydrogen—an odorless, colorless gas—is the lightest and simplest of all the elements in the universe. A hydrogen atom has a nucleus containing a single proton that is circled by a single electron. (An atom of uranium has a nucleus with 92 protons and 146 neutrons, surrounded by 7 shells containing 92 electrons.)

"Hydrogen is also highly volatile and flammable. It devastating bombs.

"But it is not the combustible nature of hydrogen for more than 150 years.

"Electricity can be used to split water molecules into their basic components-hydrogen and oxygen. This process of running electricity through a solution to separate materials is called electrolysis.

"In 1839, Sir William Grove demonstrated that if electrolysis was 'run in reverse'—that is, if hydrogen and oxygen were combined to make water—the process would release electricity.

"This is what a fuel cell does. The hydrogen fuel is fed into one end of the cell, where it comes in contact with a PLATINUM plate. The platinum acts as a catalyst that helps break down hydrogen atoms into positively-charged ions and negatively-charged electrons.

"The electrons are then screened-out using a substance called an electrolyte. The ions can pass through it; the electrons cannot. All the electrons are collected and sent through a wire. That stream of electrons is electricity, which can be used to power a motor. The wire eventually is routed back to the cell, where the electrons, ions and oxygen combine to make water—the fuel cell's only waste product.

"It was not until NASA began searching for onboard power supplies for its Gemini and Apollo spacecraft that hydrogen fuel cells became a true, applied technology.

"In space travel, traditional internal combustion power is not feasible. Fuel-cell technology is efficient; the fuel is light, and there is no heat or waste gas to deal with. In fact, fuel cell technology is sometimes called 'cold combustion'."

Mount Mayon Explodes, 8.1 Quake Hits Taiwan

A SHARP BANG WAS HEARD AS THE VOLCANO SHOT A MUSHROOM-SHAPED PLUME OF ASH ABOUT SIX KILOMETERS INTO THE AIR AT ABOUT 11:45 A.M., WITNESSES SAID.

HOWEVER, THE PHILIPPINE INSTITUTE OF VOLCANOLOGY AND SEISMOLOGY (Philvolcs) WAS QUICK TO ALLAY FEARS OF AN IMMINENT FULL ERUPTION. it pretty distressing. The front page of the paper here, on Wednesday, read: "1,700 killed in Taiwan's worst quake in decades". That was yesterday, while the only reference today was that perhaps this would cause better relations

"This is a slight explosion, not an eruption," Philvolcs chief, Raymundo Punogbayan, said in Manila. "We cannot say definitely if it will lead to an eruption." [E-E: Is this some kind of insanity, or what? We have "clients" with major operations in current use and major additional plans for expansion—on the side of that volcano. It is not so very far from Manila as to be quite unnerving, if nothing more. Oh, well—.]

Punongbayan noted that there was no indication of any threat from the ash, nor were there signs of volcanic mudflows. Famous to tourists for its perfectly symmetrical cone, the 2,462-meter volcano last had a full eruption on Feb. 2, 1993, killing at least 78 people and affecting 50,000 others.

Cedric Daep, chief of the Provincial Disaster Management Office, said all residents within seven kilometers from the volcano's crater were being evacuated.

He said at least 2,000 people were being evacuated to school shelters. The villagers could return once the volcano stabilizes, he explained...[END OF QUOTING]

"More than 1,000 after-shocks of up to 6.8 on the Richter scale were recorded in the 12 hours after the quake, officials said."

So now it is reported that 100-percent of those buildings are destroyed, and the city will be razed.

A TRAGEDY IN TAIWAN

Filipinos were transfixed but not alarmed when a powerful earthquake rocked Turkey last month, leaving 15,000 people dead. Early yesterday, a stronger quake rocked Taiwan, toppling buildings and plunging many parts of the island into darkness. By afternoon yesterday, 1,100 people had been reported killed, and the death toll was expected to rise as thousands more remained trapped in collapsed buildings. Experts warned of thousands of aftershocks in the next two weeks. The quake, measuring up to 8.1 on the Richter scale, was strongest in the mountainous area of Nantou, about 150 kilometers southwest of Taipei.

That's too close for comfort in this quake-prone archipelago. The Philippines sits on a major fault, and two trenches and lies along the so-called Ring of Fire, a zone that encompasses some 540 historically-active volcanoes around the globe. A major quake that struck Luzon in 1990 not only toppled buildings but also caused structures to sink as the ground liquefied. A mountain in Zambales that wasn't even included in the list of volcanoes in the Ring of Fire erupted in 1991, permanently altering the landscape of Central Luzon.

CHIEF VOLCANOLOGIST RAYMUNDO PUNOGBAYAN WARNED YESTERDAY THAT A QUAKE AS DEVASTATING AS THE ONE IN TAIWAN CAN STRIKE THE PHILIPPINES AT ANY TIME. HE

LAHAR (LAVA ASH)-COVERED LAND IN CENTRAL LUZON THAT THE SOIL IS PRONE TO LIQUEFACTION, MEANING THE GROUND COULD SWALLOW UP THEIR HOMES IN CERTAIN CASES OF SEISMIC ACTIVITY. THERE IS NO SUCH WARNING SO FAR IN METRO MANILA. BUT YOU DON'T NEED EXPERTS TO TELL YOU THAT MANY BUILDINGS IN THE NATION'S CAPITAL ARE STRUCTURALLY WEAK AND COULD BE DAMAGED OR DESTROYED BY A STRONG EARTHQUAKE.

Newer buildings have installed safeguards against quakes, although even modern technology can't guarantee that a structure is 100-percent earthquake-proof. Some of the weakest buildings are located in the most denselypopulated areas, such as the student dormitories in the University Belt. They get a perfunctory inspection after every major earthquake, but only a few get upgraded to comply with safety standards. The quake in Taiwan should remind the government that buildings and structures in Metro Manila must be regularly inspected for structural safety. [D: Oh sure! THE PHILADELPHIA EXPERIMENT, VALLEE, "DUDGEON", MARSHALL BARNES AND THE DEBUNKED

Jacques Vallee, a fairly well known and "credible" UFO researcher, whom, I discovered several years ago, has had substantial and verifiable links to intelligence/military agencies in the U.S., going back 30 or more years (in other words he was a high-level spook and disinfo agent who was recruited from France, and worked with J. Allen Hynek and other spooks/scientists for Air Force Intelligence and similar groups; initially at the Batelle Institute near Wright-Patterson AFB in Ohio), published a report in 1994, which purported to totally debunk the Philadelphia Experiment and show that it was a hoax.

The problem is, Vallee's article itself was complete and utter bullshit, utilizing as its primary source one, "Edward Dudgeon", some phony with absolutely no credibility, who has been conclusively proved a liar—and thus, by extension, Vallee has been so proved as well. The person who busted these clowns is named Marshall Barnes, an independent researcher who, in addition, has heavily and thoroughly investigated the Phoenix Project from Philadelphia all the way through the Montauk Project, and has found SOLID evidence to support many of the major claims being made about Phoenix—as well as scientific data and so forth— which prove that many of the claims are quite possible.

Vallee and Bernhard Haisch, editor-in-chief of the *Journal of Scientific Exploration*, which published Vallee's article and has refused to disclaim or otherwise back off it, have become the targets of an ongoing private investigation focusing on them having promoted research fraud. Proof which shows Jacques Vallee's article to be an outright fraud has been made public by Barnes, leaving no room for doubt that the world-famous UFO researcher was an active participant in an official cover-up effort.

Barnes shows irrefutably that there was, on the part of the Navy and other government agencies: 1.) a strong agenda to make a ship both radar and sight-invisible; 2.)

knowledge of the physics by which this can be done; and 3.) possession of the technology by which this physics could be applied in the field.

Apparently, these facts are so disturbing to the "powers-that-be" that they have, in desperation, engaged or coerced two well-known scientists into perpetrating a bizarre act of deliberate scientific debauchery; risking their names and reputations, and those of any organizations they may belong to.

The so-called Dudgeon reportedly told Vallee, "Your book, *Revelations*, was wrong about making the ship invisible to radar: the Germans hadn't deployed radar at the time...". Dudgeon is referring to the summer of 1943. Without any question whatsoever, the German navy had radar on their ships before WWII. There is information, posted on a website at http://www.cnd.net/~kais/ navy/ raiders.htm, which provides hard, factual data regarding the Nazi's development of radar. By scrolling down to the third and fourth paragraphs under the heading, "The Pocket Battleship, Admiral Scheer", one can find information on how these same radar systems were used with devastating and deadly effect against Allied ships and crews. The so-called Dudgeon's comments on this point, as on so many others, are utterly worthless drivel.

As for the entire issue about Dudgeon's "credentials" and papers which supposedly support his contention that he was even in the Navy at the Philadelphia Yard during this time—the "papers" he showed Vallee are completely insignificant and prove nothing of the sort. In fact, not even Vallee has said anything about seeing any hard documentation/confirmation of these critical elements of Dudgeon's story, and Dudgeon, as we see, is untrustworthy at best. Vallee doesn't even describe what kind of "identification" papers he saw. Who really knows if this so-called Edward Dudgeon is even Edward Dudgeon! In light of the following evidence of his blatantly untruthful testimony, this issue of his real identity becomes especially significant.

One of the main points which Dudgeon (or whoever) and Vallee make, which they say gives lie to the claims about the Philadelphia Experiment. has to do with the dates of the shakedown cruise for a number of vessels. Dudgeon claims that the *Eldridge* accompanied his ship, the *DE 50*, *U.S.S. Engstrom* and two other ships on shakedown together during the first week of July. Surprise! The Navy's own official records for the *Eldridge* show that the ship wasn't even launched until July 25, didn't receive its commissioned crew until August 27 and then didn't go on its shakedown cruise

until September. It was within the period of time between July 25 and August 27 that a skeleton crew could and would have been used in the clandestine experiments, as they would not be listed as the official commissioned crew and thus, any tracing of them would be pretty much impossible. Barnes says, "I assure you that these dates are accurate because they reflect the same information that I got from three different published, official, Navy, ship-record sources, as well as other books that have quoted the same records."

At this point, Vallee's article and the "testimony" which make up the bulk of it are shown, clearly and unarguably, to be the complete garbage that they truly are.

Why then, and at whose direction, have editor Bernard Haisch and his *Journal of Scientific Exploration* refused to issue a disclaimer regarding this work of outrageous fraud and in fact continue to publish it on their web-site and doubtless elsewhere, also? Very good questions but most likely also rhetorical ones. Undoubtedly relevant is the fact that Vallee, for one reason or another, deemed it desirable to have his report "reviewed" and obviously censored, or "cleared", by one, "Vice-Admiral William D. Houser". Hmmm...

Very interesting, as well, is the fact that apparently a false connection was made by Dudgeon between the "St. Elmo's Fire" phenomenon and the witness descriptions of the visual phenomenon observed during the Philadelphia Experiment; that is, that the phenomenon, in fact, does more than just impart to a ship a greenish, glowing aura—due to the coronal discharge—but can also have the effect of rendering the ship relatively invisible to sight, and presumably to radar, as well.

However, this claim only came up in a summary of Vallee's "research" into Dudgeon's claims and on a TV interview of Dudgeon by Vallee, and is not mentioned in the article itself, which was reviewed by the Vice-Admiral. St. Elmo's Fire was mentioned by Dudgeon only as a disinformation ploy, to provide a false explanation for any bizarre conditions noted by a number of eyewitnesses regarding the condition of the *USS Eldridge*. No mention was made in the printed article to the effect that St. Elmo's Fire can also result in invisibility—something much more significant from a defense or "covert operations" point of view than some greenish glow—and which, if true, would indeed, logically have a direct relation to the Philadelphia Experiment technology itself.

If this were really true, then there WOULD be a scientifically valid way to make a vessel or other object invisible—by merely replicating the effects of St. Elmo's Fire! Thus, the Vice-Admiral would have advised Vallee to remove this material from the printed article, regardless of the fact that Dudgeon's yarn about St. Elmo's Fire is false, and was only originally offered at all as a way of explaining the other accounts, which attest to the ship becoming invisible.

A POSSIBLE PERSONAL LINK

I have had a number of personal contacts with Preston Nichols, a few with Peter Moon, and I have conversed with both of them on the phone many times; and with Al Bielek, several times. Nichols did a "Reichian" (according to methods developed by Wilhelm Reich) energy reading on me during our very first personal meeting, and he concluded that there were extremely strong indications of a personal involvement in the Montauk Project on my part. This reading was, however, somewhat cursory and incomplete, because at

one point I became intensely emotional about something related to my childhood and my family— feelings which definitely seemed to be connected to the entire business.

Although we were not able to pursue it at the time, I felt distinctly that, along with whatever else had been going on with me personally in relation to the Project, the entire matter had a sizable and negative, though hidden, effect on our entire family and was responsible for a certain amount of emotional turmoil, pain and disruption. This is all a subjective impression—at this point in time I have no hard evidence to back up that aspect of things. Nichols felt that my skills in communications could have been utilized in dealings with ETs; he also picked up from my energy patterns that I had several implants, and that I had been used in time-travel experimentation as well. Other definite indications of some kind of direct personal involvement in some aspects of the Montauk Project were discussed in my first report on the project. Other strongly suggestive memories, impressions, vivid dreams and experiences of mine, most of which material is covered in Part 4 of my initial report, "Montauk Air Force Station—Active Or Not?", indicate a definite likelihood of some type of connection to, or involvement with, the Montauk Project on my part, very possibly beginning at a rather young age.

My trip to eastern Long Island in the summer of 1998, which included a number of side trips to Montauk, showed a possible link between the underground facility at the WWII Navy submarine base on Montauk's Fort Pond Bay and some peculiar experiences of mine as a child, during the time my family began vacationing right up the road from this area, in 1959 and 1960.

This relates to an exceptionally vivid dream/nightmare, one I can remember to this day, from when I was 5-6 years old. Not the standard fare of goblins or monsters threatening to gobble one up: this dream presented, it would seem, a scenario more along the lines of what "Dr. Jonas", in the movie Conspiracy Theory, described as the focus of his "work" as a "research" scientist for the CIA in the field of mind control, as part of the well-known MK-ULTRA program—which was terminal sensory deprivation. There is a stong factual link here to the ubiquitous and repugnant "dean of modern psychiatry", Ewen Cameron, and his MK-ULTRA experimentation at McGill University and Allen Memorial Insitute in Montreal, Canada during the 1950s and 1960s. Cameron—who had made no secret of his slavering admiration for the monsters and butchers of Begen-Belsen, and indeed for the entire Nazi movement in all aspects—rightly viewed his psychotic and brutal "work" for the CIA and other agencies, as a continuation of the experiments carried out by the Nazis upon their millions of helpless, human victims. Circumstantial evidence and a number of personal accounts indicate that similar operations were, in fact, also being conducted on Long Island, probably at Camp Hero, Fort Pond Bay Naval Base in Montauk, and at Brookhaven Labs during this time period, perhaps involving Ewen Cameron himself.

The main image in this early-childhood dream was of being naked, freezing cold, and huddled on the floor of a featureless, cement cube or "box" of some kind, perhaps 12-15 cubic feet; the atmosphere was chilly and very damp. My terror increased substantially when I observed that liquid of some kind was beginning to enter holes in this cube, and the implication was that, at some point, I would drown. Naturally, I woke up screaming from that one. An interesting point is that my family did not own a TV and our trips to the movies were fairly infrequent. At that age and at that period of time, I can't

imagine where or how I could have "picked up" or otherwise appropriated such a terrifying image from any conceivable source.

The memory of this dream experience, as noted, has stayed with me since that time, and now that I am aware of the Montauk Project and related operations on Long Island at the time I was growing up there, I've wondered if perhaps this dream was a psychic bleed-through of some horrific event actually experienced by me. Interesting then to notice—on my recent trip to the old WWII Navy submarine base at Fort Pond Bay in Montauk—an old concrete cube about 12-15 cubic feet in dimension right at the shore line, obviously some structure related to the submarine pens on the bay here. This is less than a half-mile from the hotel on Fort Pond, which is where my family began vacationing on eastern Long Island, when I was about 6 years old. Hmmm...

OTHER CORROBORATIVE INFORMATION

Michelle Guerin—who has uncovered within herself, buried memories of some very traumatic and significant events at Camp Hero and nearby Ditch Plains—has provided the following information on a number of points concerning the Montauk Project and related issues (Michelle has a web-site detailing some of her Montauk experiences—http://members.aol.com/nymush/ sands.html).

"Preston Nichols states in his books that he worked for 'BJM' (note: 'BJM' = 'AIL'), a well-known defense contractor on Long Island. While a pseudonym has been used for the company in order to protect himself from possible lawsuits, I have a friend that did, indeed, work with Preston, at a well-known defense contractor on Long Island.

"I have an uncle that is very familiar with the area around Montauk, as he spent most of his summers there, from childhood through adulthood. Up until 3 years ago, he owned a home in Montauk. My uncle has some very unusual memories concerning something that happened at the camp when he was younger. At the time, his family summered at a campsite near Camp Hero. Due to an impending hurricane, the residents of the campsite were evacuated to the base. All of the children were housed in a separate building, on the second floor. During the night, he woke up and recalled seeing a face at the window and was mesmerized by the eyes. He's never forgotten this. Remember, he was on the second floor! He only related this story to me after I told him of my own experiences at Montauk.

"My cousin (his daughter) then told me of her memories of Montauk. Every summer when they arrived there, for about a two-week period, she would experience an unusual "sensation"—she would feel depressed, uneasy and lethargic, for no apparent reason. Then she said it was as if she would get used to the sensation, and it no longer bothered her. She had never mentioned this to her family until I started to ask about Montauk.

"I myself have been to Montauk and can attest to the strange 'vibes' there. My psychic antennae seem to be most affected in an area near the location of the Sage radar dish, along a stretch of an isolated road known as Old Montauk Hwy. We had been able to verify (through the use of an EMF detector), anomalous EM readings in that location."—© Michelle Guerin

I got a very noteworthy e-mail from a woman in the New York area, regarding the fateful day of August 12, 1983, when the major phase of the Montauk Project "crashed and burned". Judith wrote to me as follows: "I live in the tri-state area, so your article interested me. I did

some research at the New York Public Library a couple of months ago on the Philadelphia Experiment—supposedly the ship which disappeared-reappeared in Montauk, August 1983—I was living in Manhattan at the time, and I clearly remember a late-night news broadcast about this ship reappearing and the reporter saying the base was totally closed; nobody could get in to check it out. But, I could not find anything in the local newspapers about it from 1983. What I DID find was that the entire midtown area in Manhattan lost ALL electrical power at about the time the ship was supposed to have shown up. The subways were virtually stopped. The outage was so severe as to have crippled midtown for an entire three-four days before it could be restored. I seem to remember this, too, back in 1983. There is no mention in the papers about WHY this occurred."—Indith

Several other individuals from the New York/Long Island area with whom I have spoken also recall seeing a spot on local news about the military vessel, which appeared mysteriously off Montauk Point for at least a few days that August.

The following, written by Stephanie Chesler, was posted by Ellie Crystal on her web site:

"I read with great interest your material about Montauk in the Universal Updates. I grew up in a small town called Port Jefferson on Long Island's north shore, about half-way to Montauk from the city. My father worked with a division of Grumman Aerospace, on top-secret projects that involved the Navy, and I remember our neighbors often told my mother that the FBI had come around the neighborhood to 'check' out my father's activities in the community. I remember him speaking about rumors of an underground base at Montauk.

"My neighbor across the street was a scientist of some sort, who worked with the government. He never revealed to me exactly what he did, but he had some very complicated electronic apparatus in his garage that I was fascinated with. I babysat his children twice a week, and I would always take a peek in the garage after I had put them to bed. When I questioned him about the purpose of the instruments, he blew me off with a wrong answer. I knew enough that he was lying, as I was keenly interested in science at that time, having won first place in the High School Suffolk County Science Fair two years in a row.

"The other strange thing was that they were definitely under some kind of guard or surveillance that my neighbor was completely aware of. There were frequent visits by unmarked cars parked in front of their house, always with two men in the front seat. Very weird for a quiet, suburban neighborhood!! My father was told it was government-job related, not to worry about it. When I was in my sophomore year at school (1976-77), my neighbor hurriedly asked me to watch his children for a weekend, while he and his wife looked for a house to relocate to in Montauk. They told me they had bought a pharmacy there. The move was completed in less than two weeks. Strangely, though, when I drove to Montauk to return a book I had borrowed, the family had vanished! There was only one pharmacy in Montauk at that time, and they had never heard of my neighbor. I never saw them again.

"Another interesting thing was that I frequently did see a greenish glow in the sky, always on cold winter nights in the direction of Montauk. I wouldn't say it was a beam, but it was definitely localized in certain areas of the sky. When I told my science teachers that I had seen this occur, they told me I was imagining it, as we were too far south to observe an aurora-borealis type of sky.

But I know, my family and I saw it!

"Here is the strangest story of all. My family frequently went to Wildwood State Park just east of Shoreham. I remember always passing a small sign, on a metal-fence gate, off what was then a two-lane road, that read 'TESLA Research Station'. On this particular day, my family decided to take a walk on the beach, which is composed of pebbles, not sand. I lagged behind at quite a distance, picking up beautiful pebbles and looking for frosted sea glass. All of a sudden I froze, as I sensed a "wall" of energy enveloping me. It had moved rapidly from off the Long Island Sound, heading from the north to south. I didn't like it at all, and somehow I felt trapped. I seemed to move in slow motion, as if thick honey had been poured over me. When I screamed to my family for help, my screams seemed to bounce back at me as if deflected by some invisible wall. They never even looked at me. But I was struggling with all my might to break free of this energy. I was very cold and sobbing, and my heart was pounding very quickly. I ran toward my family, with a huge effort, and I felt a resistance, sort of like traveling through a wall of very thick jello, then a pop as I began to more easily run, like a devil was after me. My father looked up in a panic when he saw my state, and he told me they hadn't seen me at all for the last few minutes. After all was said and done, my "adventure" was chalked up to an overactive imagination. I was told I read too much, and I was actually teased quite a bit about this incident.

"Well, there are some of my wild stories!! I never did figure out what happened to me on the beach at Wildwood, but my family can tell you I never went to that section of the beach again!"—© Stephanie Chesler

Christine Oliva wrote to me with some very intriguing recollections of her childhood on Long Island, with a father deeply involved in covert government / military projects and a knowledge of the underground at Montauk, as well as her own experiences working at numerous defense contractors on Long Island herself.

"I was wondering if you are aware that there are underground tunnels leading from AIL to who-knowsalso Brookhaven Labs.

"I grew up on Long Island-my father was involved with black projects for many years during his career as an electronic engineer, mathematician, designer and inventor. He was definitely involved with the manufacturing of microchips and helped to design one so that it could go into some of the spaceships that we sent to outer space. All of the work he did for our government was top-security cleared; his history follows from WWII, with Nazi technology.

"Not to get off the subject of AIL, I worked there, among other places, and my work was also security cleared, although not as high of clearance as my father's. AIL is a priority on my mind because of the extensive interrogation I got there from the persons doing the security clearances; these people definitely were not your average guy-on-the-street. They looked mean and acted very cold; I felt as if I were being inspected under a microscope.

"This was the first time I felt like this while being cleared for security. I will never forget it. They asked the most ridiculous questions, expected me to remember my grandparents' histories and asked me, also, if I could remember more than that, regarding my family's history.

"After I passed their interrogations (seemed like hours for me! and their staring at me was very uncomfortable), I had to go for drug and other medical

examinations, in order to satisfy their qualifications. These people were not playing around!

"After a few months working at AIL, there were rumors that there were many stairways, leading to secret doors, that lead to underground tunnels and parts of the building you could not get to, unless you knew how and where they were. It was as if there was another part of the building hidden away from everyone else.

"One day I was approached by a fellow whom I did not know well; he started talking about these secret entrances. I now feel as if he was testing me out for some reason. I acted surprised at what he was telling me, because I was! I had heard rumors before but thought they were just that. He asked me if I believed what he was saying, and I sort of doubted him (I am the type of person who does not fall for rumors easily), and when he saw the doubt on my face, he asked me if I would like to see what he was talking about. I said to myself, something was wrong here, who was this person? Why was he approaching me with this information? And why didn't he care if he got caught? The red flags were thrown up for me! I followed my intuition that danger was near. I felt very uneasy and angered that he would suggest such a thing to me, knowing very well how dangerous it was. I said to him, "No thank you," and didn't he realize the dangerous situation he would be putting the both of us in? He laughed and said, 'Oh, come on, nothing is going to happen!' I said, again, "No thanks" and walked angrily away. I know he was not lying! And I still cannot figure out why he chose me, among all of the rest, to tell this to, and to try to persuade me to go along with him. I can only thank God that I did not follow him out of curiosity.

"So there is my story about AIL, and the underground tunnels and secret doorways to who-knowswhere. Again, my gut feelings say that most of Long Island has these underground tunnels leading from military outposts, electronic manufacturing facilities, military airports, etc. I believe that Brookhaven Labs is also intertwined, underground, with the rest.

"I now know that because of working at the places where? I suspect that the tunnels lead to Montauk and I did, and the type of work I did, I was definitely controlled in some way, since childhood I might add, and I suspect that ELF waves were used on me and whoknows-what else. My memory has been definitely affected. The time sequence is a mess for me, remembering those years. In other words, I can remember important events but not the sequence in Air Force Station, they weren't exactly strangers to the which they occurred—very frustrating, to say the least. Everything is scrambled for me."

> A further message from Ms. Olivo revealed the following:

"OK, first of all, I had no idea that Nichols worked at AIL too! Amazing! Who knows? I probably brushed shoulders with him and didn't know it. Or at least my mind won't let me remember it! I am hoping that my father, being old now and probably retired, won't care anymore. I am, of course, not on speaking terms with him, sad to say, because I know within my heart, he knows a mouthful and more! He definitely knows about alien technology. He said some very important things to me about it when I was very young, and now when I reflect back, alien technology was his forte.

"My father did some really awful things to my deceased mother and me while I was growing up and later on. This included brainwashing, hypnosis, and God-only-knows what else he did in his laboratory in our family's basement home. I do believe that the

phenomena that took place during those years were due to his meddling around down in the basement of our home with all kinds of equipment, radars, oscillators and generators. I know for a fact that the company he worked for, Loral—located in Vermont and then Long Island—loaned him all of that equipment; some of it was way too expensive for him to buy on his own, and why would he when the company gave him all of it.

"He would go to his regular job in the daytime, and then come home to continue his job in the basement. This went on for thirty years, and the last time I saw the basement, he had added computers that he built himself to do God-knows-what. Even though my father being as such, he is still my father, and I haven't come to the point yet in revealing his name to anyone. For some reason I still feel protective of him, but if there were someone I could really trust, I guess I would reveal his name, as long as I was kept updated to what was found concerning him, given the truth and guaranteed that no harm would come to him. I wouldn't even mind someone asking him questions, but he is tight-lipped, believe me. Now that all of this stuff has come out, he might not be."- Christine Olivo

THE SAGE STORY

I think there is a good chance that most or all of the SAGE radar sites were deliberately chosen to coincide with geomagnetic hot spots, earth-grid power points, or something along these lines, and that (most) SAGE sites have had a connection to mind control all along; in other words, I consider it possible that the SAGE system had at least a twofold agenda going since its inception, or soon after. Nearly all military installations have been constructed on earth-grid power points; in particular, those constructed in this century.

It wouldn't surprise me if some of the other SAGE radar sites are used in Montauk-type operations as well. At a SAGE location in Germany, it was observed that many of the people in the adjacent town seemed to be "under the influence" of EM/RF mind-manipulating transmissions; San Francisco area researcher and author Ken Wells, Jr. informed me that there is a SAGE radar site close to San Francisco. (All SAGE radar-dish sites were constructed with at least four levels of underground directly underneath the supporting tower structure itself.)

When the Phoenix operation pulled in to Montauk Air Force there, and, in fact, base personnel related to the new arrivals, data they had amassed on how the SAGE transmissions caused some very definite effects on personnel at the base; which varied, depending on the particular frequencies being transmitted by the SAGE dish. (One gets a good idea exactly what kinds of "effects" these were, further ahead in this report, in the section entitled "More Weird Tales Of Montauk AFS").

THE AIR FORCE AND THE (MYSTERIOUS) MONTAUK BASE

Important information about the Montauk base—as well as some exceptionally intriguing anecdotes—come my way from a former Air Force radar technician/ engineer named Bob Tidwell.

Bob was briefly stationed at Stewart AFB, an installation otherwise noteworthy for the fact that it has, without doubt, figured significantly somehow or other into the (lower) Hudson Valley UFO phenomenon. Many black NSA choppers seen at or near the sightings

Stewart by investigators, during the course of this yearslong series of UFO sightings—unsurprisingly, long after Stewart's "official" closure.

regarding SAGE and other radar systems. He also notes that it was highly unusual for a SAGE site to be situated so close to the shoreline—virtually all other sites he knows of are much further inland. He specifies a few other instances of incongruities and anomalies regarding the equipment used at Montauk AFS. Additionally, Tidwell's information shows how Stewart was used as a staging area for operations at the Montauk base and probably as a paper-trail cover for Montauk as well.

The following material is from a number of e-mails sent to me by Mr. Tidwell:

"These special sites were referred to as SAGE sites, which is very misleading. SAGE (Semi-Automated Ground Environment) actually refers to the manner in which radar and communications information was automatically routed from all radar sites to a central Control & Command center. Most locations also had an associated "ground radio" site that would allow C&C to communicate with whatever intercept aircraft were currently in that particular area. This specialized system involved the setup of multiple communications paths and new protocols to ensure that all of this information would reach C&C. This new technology would later evolve into today's World-Wide-Web. I don't know why these sites themselves were referred to as SAGE, unless it was a ploy to draw attention away from the manner in which our radar sites communicated with C&C.

"The Air Defense Command constructed most of these sites in the 1950s, but most were decommissioned in 1969 and 1970 because of the new airborne-radar aircraft, which overcame the curvature problem without having to use the lower frequencies. Some sites that were in sensitive areas remained open as late as 1980.

STRANGE GOINGS-ON

"I can positively say that this site (Montauk Air Force Station) was in operation, in some manner, as late as 1972. This was verified to me by a personal friend a few years ago. He was serving submarine duty in the area and was leaving for extended sea duty within a few Long Island and were looking for a beach area to have one last beer party before shipping out. One of the guys suggested the old Montauk Base, as it was deserted, and they could get drunk and spend the night on the beach without getting into trouble.

"They were able to enter the base area OK—the main gate was open and in disrepair-so they started looking for a good place to party. When they came to the location of the radar site, they discovered a shiny new security fence, and they were immediately surrounded by armed security police. They were then escorted off base and told to NEVER COME BACK (emphasis added).

"It has been suggested to me by several persons during my investigations that Stewart AFB was acting as a staging and transfer center for Montauk. Steward certainly had connections to the electronics and radar schools at Keesler AFB in Biloxi, Mississippi. I, myself, was given orders to the 1st Air Force at Stewart. When I questioned my orders, I was told that Stewart was, indeed, my correct destination and to consider my orders secret, even though this was never officially stated on paper. I've been told that certain personnel were being

eliminate a paper trail leading BACK TO MONTAUK (emphasis added)."

Tidwell has some pertinent technical information I have heard the same kind of thing from other sources and this practice may, in fact, be continuing presently. In fact, in 1996, while combining a visit to my family in East Hampton [Montauk is in E. H. Township] with my ongoing investigation into the project, I overheard at a supermarket some comments made by the two guys in front of me (one in particular was especially talkativealmost in a nervous fashion) to the checkout girl. This fellow was saying that he and his companion had just arrived in the area and, in fact, had orders to report to Montauk! (Obviously there is no overt military facility ON THE MAP anywhere in this area these days). His decidedly more taciturn buddy grunted in a discouraging way—like, "shut up dude," but blabbermouth kept on obliviously, to the effect that they had come in "through" in. Back then I didn't question any of this strangeness. New Jersey" (as if to provide some paper-trail cover), in order to be stationed at Montauk. After they left, I inquired of the young lady about their comments, adding, "What branch of the military has an active installation at Montauk?" She replied animatedly, "Yeah! That's just what I was wondering!"

> If I had to hazard a guess as to which branch of the military these guys were in, I would say Navy. I definitely didn't seem to get an "Air Force" vibe. Also, as they were both pretty chunky—I would think they were probably officers of one degree or another!

> Tidwell continues: "I remember the trip up there and the trip back, but the few days that I was there are only a blurred memory. I remember showing my orders to the guard at the main gate and being directed to a location that was away from everything else. There was a small, one-story, barracks-like building that had been converted into office space.

> "I went in and presented my orders. There were only three people in this building: a female secretary, a First Sergeant and a Captain. I remember then being told to go outside and police the area (pick up cigarette butts), while they checked my orders. Looking back now, this memory seems very absurd—having a new person walking around, picking up trash in a dress-blue

"After what seemed like an hour, I was called back days. He and several shipmates were on shore-leave on in and told to go into the Captain's office. He informed me that my orders were a mistake, and that I would be reassigned to another location. He had my new orders on his desk, already typed out, except for the new location. The nearest location would have been Buffalo, but the Captain simply asked me where I wanted to go (this is unheard of in the military). In a daze I said, 'Back to Alabama'. He then took my orders out to the secretary and returned a few minutes later, with the Alabama location typed in. He never called or checked with anyone to OK this, and I never checked in with the base personnel office, which is standard practice. They seemed pleased to get me out of the area.

> "One of the things that seemed to trouble them was that I had gotten married a few months earlier and had brought my wife with me. I vaguely remember being there about one to two weeks, and I had even rented a place to live. I also have vague memories of shopping on the base, although I don't remember anything else about the base. Also, why would I be there that long if I had gone in and was told that I wasn't supposed to be there? So, I loaded up my car and drove back to Alabama. I spent the next year at the Dauphin Island

> "We were again asked to fill out the dream sheets This last comment is very interesting to me, because for reassignment. After the site closed, the personnel began leaving for their new assignments. After a while, the base commander called me into his office and wanted to know why I was still there and hadn't left yet. I informed him that I hadn't received my new orders yet. They started checking and appeared to be experiencing some confusion. At one point, I was asked if I had been getting my paychecks OK.

> > "The next day I was called into the Commander's office, and laying on his desk were my new orders with the new assignment location blank. I was again asked, 'Where do you want to go?' The nearest location that was still active was North Charleston, S.C., so I requested that. He took the orders out to his secretary and returned a few minutes later with that location filled I just told myself that I was being extremely lucky.

> > "I spent my remaining two years at North Charleston. While going through my out-processing physical, several doctors were very interested in my knees. They asked several times if I was having any trouble with them. This seemed strange to me, as I have never had any trouble with my knees in my life. I was then asked who had performed the reconstruction work on both of my knees, as they were amazed at how precisely it had been done. I told them that they were mistaken, and that nothing had ever been done to my knees. This seemed to really trouble them. Later, when I got home, I examined my knees and discovered traces of faint surgery marks on both knees. The marks are still visible today.

> > "After going back to civilian life, I occasionally would have a recurring dream. In this dream, I was told that I would have to go back into the Air Force and work for an additional two years. I thought that this dream might have a connection with being on inactive duty status for two years before I would receive my permanent discharge, but the dreams continued on for about 20 years. They were very vivid and were always connected in some way. I would be stationed at a strange radar site, and I worked on equipment that I was not familiar with. The site was located on what appeared to be a section of a larger base, although I couldn't quite picture the base. It was also located near water. In the dreams, I would do normal, everyday things (besides work at the radar site), like shop in stores and ride around in my car. It was as if I were reliving another life in my dreams.

> > "Then, sometime in the early 90s, I noticed a book titled Montauk-Experiments in Time. The name drew my attention, so I picked up the book and started thumbing through it. My blood then seemed to turn into ice-water, for here was the location that I had been dreaming about. All of the photos and illustrations had been in my dreams, even the ones that supposedly pertained to time travel.

> > "I know that there wasn't enough time for me to have been stationed there, as I was only in New York for a few days, although several people that have helped me with this (author Marc Davenport and quantum physicist, Dr. Fred Allen Wolf), insist that some form of time travel could have been involved.

> > "A few vague memories that have come back to me regarding my time at Stewart are: being taken to a Holiday Inn(?), to a room on the second floor, and being strapped into a chair and drugged. There is also a memory of being put on an aircraft and taken to another

location. This reminds me of your mention of psychotronic devices—maybe used for mind control. Another point that has surfaced in the last month concerns the time that I was stationed at Dauphin Island. I wrote an article for my newsletter about UFO radar reports and used my knowledge of working on equipment at North Charleston. After completing the article, I realized that I didn't refer back to my experience at Dauphin Island. I then realized that I didn't remember exactly what it was that I had worked on there. I do remember everything else there, except what I was supposed to actually be working on, and probably would not have realized this had I not decided to write the article.

"As a quick note, during my investigation into sites and bases here in Alabama, I discovered that Maxwell AFB, at Montgomery, was the original NORAD Command & Control Center. I have several eyewitnesses to the fact that Maxwell has several underground levels. My investigation into this goes as far as to even show what happened to the dirt that was removed. It is still being used for research and development projects, among other things, and one of my information sources stated that the basic research for the HAARP project was conducted at Maxwell. I haven't been able to confirm this but thought that it might fit into your research."—© Bob Tidwell

Tidwell recollected an incident, which happened to a friend of his in the Air Force, around 1980. This fellow had just reported to a base in Maine, and the next thing he knew he was waking up in the Navy hospital in Boston. He was told that he had fallen and hit his head badly. He had no recollection of any such event, or what happened in between that and waking up in the Navy hospital. As fortune would have it, he was befriended in the hospital by a nurse, and when he was released, he was given some time off from active duty to continue recuperating. The nurse invited him to spend a few days with her at her parents' house on Long Island. Major and continual feelings of deja vu washed over this fellow after he arrived on Long Island, coupled with some very strange feelings about things that he felt may have happened to him during the time he was supposedly "unconscious", after his "accident".

As Tidwell put it-

"He then told me about having dreams of being stationed at an unusual site that he felt was located at Montauk Point. In his dreams, he felt as if he were an officer, because everyone would salute him. He also said that the site was a joint Air Force-Navy project of some sort."

This person became progressively more curious about what might be going on and subsequently became aware of the Montauk Project operation, which he was sure he had somehow been involved in. As Tidwell noted, the man believed, based on what he found out about the Montauk Project, that it was an operation involving both the Air Force and the Navy (as HAARP was originally). Not many people know this and I don't believe it was mentioned specifically in Nichols' books.

Tidwell also relays how his friend has to have a yearly checkup as a requirement for his disability classification. Bob writes, "Every time he undergoes his physical, he is questioned as to his medical records. It seems that he has two identical files with his correct name and social security number on each file. The other file incorrectly identifies him as a Marine Corps Captain (He was put into a Naval Hospital after his injury, not an Air Force Hospital)."

NO RECORDS OF AIR FORCE RADAR PERSONNEL FROM MONTAUK!

Bob Tidwell keeps fairly close contacts with other Air Force radar techs, and they are somewhat a specialized breed. He confided to me that, although there is absolutely no doubt that Montauk AFS exists (or existed), that it was a radar station for the Air Force and that obviously it was staffed, neither he nor any of the numerous radar techs he has contact with know of, or [have] ever heard of, anyone who was ever stationed at Montauk.

Here's what Bob had to say:

"Radar techs tend to stay in touch with each other, even after all these years. I contacted some of them and requested the names of anyone that was stationed at Montauk AFS, and at a site that I'm looking into here in Alabama that may have been similar. What we discovered was that none of us has ever heard of anyone that was ever stationed at Montauk, before or after 1969. This is very odd, in that we are usually able to track down people from sites all over the world. There are major web sites devoted to us radar techs, but nobody can remember ever hearing of anyone that admits to being stationed at Montauk. We put out feelers everywhere and came up completely blank. The radar site was there, no question about that, but the people that were stationed there are like ghosts. The same is true for several other sites that I am looking into.

"We did find out that when Montauk closed in 1969, and was reopened through TAC [Tactical Air Command], that this was most unusual, and it also suggests to us that the site was being used as a cover for something else. I did find out, though, that Montauk's military connections after 1969 were being made through Hancock Field in New York. Hopefully this can be of use to you."—© Bob Tidwell

MORE WEIRD TALES OF MONTAUK AFS

Information which strongly suggests that some most unusual things were going on at Montauk Air Force Station in the late 1950s and early 1960s, comes from a fellow whose father was an Air Force Colonel and Assistant Base Commander at Mitchell Air Force Base, in central Long Island (he wishes to retain anonymity). Periodically, personnel from Montauk AFS would come to Mitchell for R&R. These fellows caused considerable consternation and distress to personnel at Mitchell due to the peculiar, bizarre, dissociative and generally loony behavior exhibited by just about all of them. Among other oddities, a number of the men became totally lost and disoriented, though they had not gone very far at all from the central base area. The group from Montauk was monitored closely and constantly by their commander. Something seemed seriously out of whack with the entire group, and the Mitchell commander was asked by other Mitchell personnel to have the Montauk group leave before their R&R tour was over. This was in the very early 1960s, and the number of these kinds of occurrences prompted this colonel to conclude that something was, indeed, amiss at Montauk AFS, and to drive out to Montauk a number of times with his son in the interest of attempting to find out what was going on at the Camp Hero location.

Even though this phase of the Phoenix Project—now known as the Montauk Project—had not yet "officially" gotten underway, let's not forget that Camp Hero has had a reputation of being a "psych" base, pretty much throughout its entire existence, shortly after the land was

legally stolen from its Montauk Indian owners around 1910. In other words, it has always been a center for experimental, psychologically-oriented or -based (i.e. intelligence) government projects. Nichols indicated that there were some indications that, even before the Montauk Project commenced, there were ties between Brookhaven Labs—with its considerable (ex)-Nazi scientist contingent—and the Montauk Point base on a major earth-grid power point, with its connections to the preexisting underground, and a significant, well-established, pro-German (Nazi/Aryan) community in the Montauk area.

On top of this, there is some very strong evidence that Montauk (Camp Hero) was the site of some weirdness with psychedelic drugs in the mid-60s. As Peter Moon noted, there is almost certainly a link to Timothy Leary and Richard Albert of Harvard during this period of time at Montauk Air Force Station. A base building—which had a number of rooms painted in full-on psychedelic style, circa 1967-68—were found and videotaped by Preston Nichols with a video crew at Montauk Air Force Station.

A Mrs. Sneed, of Sag Harbor, visited Montauk AFS in 1980 and related to me her experience there. She was with a friend and on legitimate business for her husband, a retired military man. The trip was pursuant to certain consumer goods and other items being made available to veterans at a major discount and obtainable at the PX of any nearby military base. Mrs. Sneed had with her the letters/documents of authorization. Montauk AFS was the closest base to them, so that's where they went (Let's not forget, however, that Montauk Air Force Station was officially decommissioned and closed 11 years prior to this; of course, the reality was that it was NOT closed and, naturally, many people in the area knew this obvious fact).

Strangely (or not!), they were treated with extreme brusqueness, suspicion and rudeness, first by guards at the entrance to the base, then by other base personnel and officers called to the scene by the guards, all of whom attempted in every possible way to deter the women from entering the property, despite being shown the official authorization numerous times.

Mrs. Sneed refused to back down, having made up her mind not to have undertaken the 50-plus-mile round trip for nothing; and seeing no good reason why the desired items should not be made available, according to the terms of the authorizing document she presented.

Finally, the women were admitted and escorted directly to the PX, with vehicles directly in front and in back of their car. They were not allowed to stop or slow down. Although the base itself did seem to be unusually quiet on the "surface"—judging solely by the reception they'd received—there was obviously something rather "important" and secretive going on there.

Mrs. Sneed stated that there were air-vent stacks protruding from the ground all over the place. She told me she felt very strongly at the time that substantial underground activity was taking place at the Montauk base and, in fact, she commented on this to her friend. Mrs. Sneed stated that, though she and her friend couldn't possibly be any threat in any imaginable way to anything (legitimate at least) that was going on there, they had people standing right next to them when they went into the PX and were escorted right back to their cars and right off the base. According to Mrs. Sneed, everyone they encountered was acting very strangely, downright creepy.

GREED AT CORE OF **INDONESIA'S TIMOR PROBLEM**

WASHINGTON, D.C.—At its core, the problem of East Timor, and indeed much of Indonesia, has a lot to do with greed, rather than the Muslim-Christian divide portrayed in the media.

From ancient times until the 7th Century AD, Indonesia was ruled by various Hindu kingdoms, among which the Majapahit Empire became the most powerful. Sumatra was then known as the "Island of Gold", and Java as the "Rice Island".

Muslim traders began arriving in the 13th Century, and Islam spread peacefully through the islands...In the early 16th Century, the Hindu kingdom of Mataram converted to Islam...

...Then came 350 years of brutal colonial rule and exploitation. First to arrive were the Portuguese, in 1511 AD. The Portuguese were followed by the Dutch (1602 to 1799 AD), the British (1811 to 1815 AD), and again the Dutch (1816 to 1908 AD).

The colonial masters took slaves and forced the natives to grow crops for export, which resulted in famines and destroyed the thriving, inter-island trade.

By 1908, nationalist movements began seeking selfgovernment, and Indonesia declared its independence on August 17, 1947. Sukarno, a leader of the independence movement, became president. He was overthrown in 1965 by Suharto, in a U.S.-backed military coup, in which it is reported that one million people, mainly Chinese, were killed.

When the Dutch and Portuguese formally partitioned East Timor between them in the 19th Century, East Timor remained a part of the Portuguese colony. The governor of Portuguese Timor, in 1974, granted permission for political parties, and five

Said to be lacking popular support, Fretilin-

terror. Civil war broke out and, on August 27, 1975, the governor and Portuguese officials abandoned the capital, Dili. The U.S.-armed-and-trained Indonesian military entered East Timor to stop a civil war.

Fretilin, supplied with arms from the Portuguese army arsenal, declared East Timor independent. The four other parties in East Timor declared their independence and integration with Indonesia. East Timor became the 27th province of Indonesia, but this claim was not recognized by the UN.

Rich in natural resources, Indonesia's primary problem is the equitable sharing of these resources. Foreign interests, and internal corruption, add to the inherent difficulty that, while Java is Indonesia's most heavily-populated island, many of the resources are located in less-populated islands.

According to former U.S. Ambassador to Indonesia, Edward Masters, Indonesia did more in 35 years to develop barren, infertile East Timor than Portugal did in four centuries.

Indonesia allocated development funds to East Timor at a rate six times the national average...By 1994, East Timor had 600 elementary schools, 90 middle schools and three colleges...there were 10 hospitals and nearly 200 village health centers built...500 km of hard-surfaced roads...and the number of Catholic churches in predominantly Catholic East Timor quadrupled under Indonesian rule

But Fretilin continued to resist Indonesian rule, and offshore oil discoveries made matters worse.

"Australian oil technicians say that the Timor seabed could yield some of the world's most productive oil fields," reported the Multinational Monitor. A treaty was signed in 1989 by Australia and Indonesia. This Timor Gap Treaty came into force in 1991 and is due for review in 2031. Australia desperately needs this oil, and massive revenues are said to flow to both governments. Independence for East Timor would likely give it a larger share of these revenues.

The division of natural resources is also at the core of secessionist movements in Aceh, Irian Jaya and in the neighboring Philippines.

On Aceh, in 1971, Mobil Oil discovered one of the world's richest onshore reserves of natural gas, estimated at 40 billion cubic metres...Mobil Oil is reported to have caused massive environmental damage and is said to be linked to the Indonesian military's land seizures, bombings and massacres.

On Irian Jaya, military repression and massive environmental damage has been linked to Freeport McMoRan, a Louisiana corporation.

In April 1967, Freeport McMoRan became the first foreign company granted an operating permit following the 1965-66 U.S.-backed coup that installed General Suharto. Former U.S. Secretary of State Henry Kissinger is credited with having introduced company officials to President Suharto. It is reported that Mr. Kissinger sits on Freeport's board, earning \$500,000 a year, and Freeport also retains his law firm, Kissinger and Associates, for a reputed \$200,000 a year.

In 1999, Freeport McMoRan received approval to almost double production, which will increase land seizures and environmental damage. With reserves valued at \$40 billion, the Freeport project is the largest single GOLD deposit in the world and the third largest open-cut copper mine...

US "FACING INSECURE FUTURE"

The U.S. is expected to retain its pre-eminence as a world power during the next 25 years, but Americans will become less secure and face the likelihood that many will die the victims of terrorism on home soil, a study says.

The Pentagon-funded study also concluded that, during the next two decades, the United States' military superiority "will not entirely protect us" from threats; dependence on foreign energy sources will grow, and some important nations—left unnamed—could "fragment or fail".

"Although a global competitor to the U.S. is unlikely to arise over the next 25 years, emerging powers—either singly or in coalition—will increasingly constrain U.S. options regionally and limit its strategic influence," it said.

The U.S. would have "limited ability to impose our will, and we will be vulnerable to an increasing range of threats against American forces and citizens overseas, as well as at home.

"States, terrorists and other disaffected groups will acquire weapons of mass destruction...and some of them will use them.

"The most serious threat to our security may consist of unannounced attacks on American cities, by sub-national groups, using genetically-engineered pathogens.'

The study, by a panel chaired by former senators Warren Rudman, a Republican, and Gary Hart, a Democrat, described the world confronting the U.S. in the new millennium.

The experts cautioned that while "the American moment in world history will not last forever", for the foreseeable future, U.S. leadership in the world was of paramount importance.

In the financial area, the panel concluded that the economic future would be more difficult to predict and

While global economic growth would continue overall, "serious and unexpected economic downturns,

increasing vulnerabilities in global electronic infrastructures, labor and social disruptions and pressures for increased protectionism will also occur."

The panel also concluded:

*An economically-strong U.S. was likely to remain 2025. It would remain "the" principal military power;

*Much of the world "will resent and oppose" the establish and sustain;

*World energy supplies will remain largely based on fossil fuels, and U.S. "dependence on foreign sources of energy will also grow over the next two decades";

*Weapons of mass destruction will proliferate, making the maintenance of a robust U.S. nuclear deterrent essential;

*Some "important states" would not be able to manage the challenges now emerging and "could fragment or fail". New states, international protectorates and zones of autonomy would increase, many born of violence;

*Weapons would probably be put in space. Space would become permanently manned;

*New technologies would divide the world as well as draw it together. An anti-technology backlash was

RARE PLANETARY ALIGNMENT IN 2000 COULD COST THE EARTH

The conjunction of Mercury, Venus, Mars, Jupiter and Saturn in the year 2000 could lead to a big increase in insurance "premiums", because brokers are taking seriously, predictions that the rare event could cause earthquakes, tidal waves and volcanic eruptions.

Lloyd's, Britain's leading insurance market, is turning to astrology amid fears that a planetary conjunction in 2000 could force huge payouts.

The conjunction, in which Mercury, Venus, Mars, Jupiter and Saturn will line up with the Sun and Moon, is expected to generate a collective gravitational pull that could initiate earthquakes, tidal waves and volcanic eruptions.

The alignment, which will happen in early May 2000, has long been a source of dire predictions among astrologers but has never been taken seriously elsewhere—until now. Last week, however, it emerged that DP Mann, one of the biggest non-marine syndicates at Lloyd's, has formed a group to study such threats.

The group has asked Dr. Julian Salt, an insurance expert who specializes in assessing the risks posed by natural perils, to look at the threat from space at a

major disparities of wealth, volatile capital flows, is taken seriously, it could lead to higher premiums. Salt, employed by the Loss Prevention Council, a subsidiary of the Association of British Insurers and Lloyd's, has published his first report on the subject in which he warns that, although the risks are small, they cannot be ignored.

It could produce mile-high waves, hurricane-like winds and volcanic explosions worldwide."

> Such disasters would come at the same time as problems caused by the millennium bug—the design flaw in computer chips that is predicted to cause global malfunctions in 2000 and which is already causing concern to insurers.

Conjunctions have been linked with disasters for *Pressure for the U.S. to reduce its military centuries. One of the most significant is said to be that of Jupiter, Saturn, Uranus and Neptune, which has happened seven times in 3500 years. The last, in 1812, was followed by "the year of no summer", in which the Northern Hemisphere suffered freezing temperatures for months, which destroyed crops and led to widespread

> In 1962, a conjunction of five planets coincided with an earthquake that rocked the Middle East, killing 20,000 people in Iran. In Europe, flooding killed more than 600...

> ...Dr. Peter Smith, editor of Geology Today, said geologists would take a particular interest in the alignment. "The general theory is that the conjunction of planets in May 2000 will be capable of creating sufficient stress on our planet to cause natural disasters. I doubt that will happen."

> Chris Forbes, managing director of DP Mann, said the company was trying to decide whether such risks posed a threat to its markets or presented an opportunity to sell more insurance.

HONEY IS STICKY ALTERNATIVE TO ANTIBIOTICS: RESEARCHERS

TORONTO-Medical researchers in New Zealand are suggesting you can catch more "bugs" with honey than with ordinary antibiotics. The findings of a study that tested honey as a treatment against antibioticresistant bacteria or "superbugs" were released at an international convention of beekeepers last week.

Researcher Peter Molan and his colleagues at the University of Waikato Honey Research Unit tested honey, known by scientists for its anti-bacterial activity since the 1960s, on superbugs in the laboratory.

They found that the bacteria—resistant to other seminar for its directors and underwriters. If the threat antibiotics—were as sensitive to the honey as regular

Molan says this may be a big finding for medical personnel, who are trying to find different ways to fight the bacteria, which are constantly adapting to new

Although there have been no clinical trials to back up honey's effectiveness against the superbugs, Molan says plenty of research has been done on honey's ability to fight bacterial infection.

'There's a lot of published work, including randomized, controlled, clinical trials, where it's been shown that infected wounds can have the bacteria cleared very rapidly by using honey," Molan says.

Molan says honey works as a wound dressing because of an enzyme or protein that bees add to the nectar. When honey is applied to a wound, the enzyme produces hydrogen peroxide, a well-known antiseptic. It is released slowly as the enzyme continues to produce small amounts of the hydrogen peroxide and the wound is cleaned without any damage to the tissue.

Molan says not every variety of honey is an ideal bacteria fighter.

"We're using honey that has been selected to have a high level of anti-bacterial activity," he says.

Molan says the next step for his research is clinical trials on the use of honey against the deadly flesh-eating disease. Laboratory evidence suggests the sticky substance may be as effective at getting rid of the bacteria as the usual procedure of surgery to cut away the affected flesh.

Honey has an added bonus, says Molan, of stimulating actual healing of the wound, which reduces scarring in the tissue.

[JR: Once honey is officially approved by the FDA as a treatment against antibiotic-resistant bacteria or "superbugs", we will then only be able to get it by prescription.]

U.S. ESTIMATES 76 MILLION FOOD POISONINGS A YEAR

ATLANTA (Reuters)—Contaminated food may cause 76 million illnesses and 5,000 deaths in the United States every year, federal health officials said Thursday, using information from a new tracking system...

...In what it said was the agency's most complete estimate to date, the Centers for Disease Control and Prevention (CDC) said 325,000 people are hospitalized because of food-borne diseases in the United States every year.

CDC Director Dr. Jeffrey Koplan said the new, more precise estimates are based on a number of sources, including data from a new tracking system called PulseNet, which uses DNA fingerprinting at more than 35 laboratories to more quickly detect food-borne illnesses.

Researchers also used other surveillance systems, death certificates and published studies from academic institutions to estimate that diseases caused by food, may cause 76 million cases of gastrointestinal illness and 5,000 deaths annually.

The CDC said the number of known causes of food poisoning has increased more than five-fold since 1942, and the chance of contamination through food-handling errors has risen, as more people eat out or eat processed food.

"While the U.S. food supply remains one of the safest in the world, these new findings further support what we have said all along—the public health burden of food-borne disease is substantial," Health and Human Services Secretary Donna Shalala said in the CDC statement.

Earlier this year, the CDC said illnesses from two of the nation's leading causes of food poisoning declined last year because of food safety programs, including better inspections of meat and poultry plants.

Preliminary data from the FoodNet tracking system in five states showed a 14-percent decline in salmonella infections between 1996 and 1998 and an 8-percent decline in illnesses caused by campylobacter, the most common, bacterial, food-borne pathogen in the United States.

DEADLY NEW VIRUS FEARED

SCIENTISTS SAY THE OUTBREAK WAS PROBABLY DUE TO A MYSTERY VIRUS

The deaths of at least 34 young children in Malaysia may be due to a mystery virus which causes massive brain and heart collapse, say researchers.

The children, aged five months to seven years old, died within just five months in Sarawak.

The deaths were initially blamed on an outbreak of hand, foot and mouth disease.

But all the children who died had a fever, which rapidly progressed to heart and lung failure, suggesting both their brains and hearts had been affected by the

A study of patients at Sibu Hospital, where 20 of the 34 children died, was unable to identify any existing virus as causing the outbreak.

Experts examined 16 cases of children who died after developing a fever, and eight children whose bodies became paralyzed and floppy—one of the main symptoms of the illness—but survived.

The scientists had suspected an enterovirus—a common cause of diseases like meningitis and myocarditis, which causes pressure on the heart.

But they found that only three of the 16 children "We're extremely pleased to have a new baseline to who died-none of the survivors-showed traces of enteroviruses.

Two children had the enterovirus associated with

illness in that part of Asia.

Researchers, writing in The Lancet...say hand, foot and mouth disease does not usually progress so rapidly and does not usually affect the heart.

They say that, for those who died, myocarditis was the major cause, rather than other reasons such as brain

Since only three of the children showed traces of enteroviruses, they think the myocarditis could have been caused by a type of adenovirus, which they have dubbed "Agent Y".

Adenoviruses are not normally associated with lifethreatening conditions. They usually only cause mild illnesses, such as colds.

They were particularly surprised to find Agent Y in brain fluid as well as heart tissue.

And they believe the fact that the outbreak coincided with a seasonal hand, foot and mouth disease outbreak suggests the agent may interact with other

They conclude that scientists have only a basic knowledge of the way viruses develop in Southeast

A similar outbreak took place in Taiwan, in 1998,

WEED OUT SECRECY

The hype linking a commonly used weed-killer to cancer in dogs is turning out to be based on some questionable research. Making matters worse is that the agency responsible for that scare, tried to keep its scientific methods secret, even though the research was financed with taxpayers' dollars.

At issue is 2,4-dichlorophenoxyacetic acid, commonly known as 2,4-D. The National Cancer Institute reported in 1991 that the rate of canine lymphoma doubled where dog owners used the chemical on their lawns four or more times a year. That, naturally, frightened dog owners and brought, what else, a new government regulation. The Environmental Protection Agency required warning signs posted on lawns sprayed with the weed-killer.

This scary research, which was one of those statistics-based studies, was suspect to cancer specialists because there was no actual, physical examination of University, funded by 2,4-D producers, debunks the institute's warning. The institute is sticking by its warning. But the agency's credibility is damaged by its refusal to release the original research data to the 2,4-D producers. It took the industry, using the Freedom of Information Act, 18 months to pry the data from the institute.

Information law is under constant attack. Critics, including respected groups such as the National Academy of Sciences, say the law may compromise intellectual property rights. It is understandable that scientists and technology firms would want to profit from their research. But if scientific discoveries are funded by public money, then that research should be freely available. Only research critical to the national defense should be exempt.

[JR: This reminds me of the cancer reports on ethylene dibromide (EDB), an extremely hazardous pesticide that was banned by the US Environmental Protection Agency in 1983. I am told that the producers quickly found another use for this banned EDB chemical. It is an excellent flame retardant now used in JP-8 military jet fuels. FDA APPROVES NEW ANTIBIOTIC

The Food and Drug Administration, yesterday, approved the first member of a new class of antibiotics to treat hospital patients infected with bacteria that are resistant to all other drugs.

The medicine, Synercid, is effective against a species of bacteria, Enterococcus Faecium, that increasingly resists treatment with Vancomycin, an antibiotic that hospital physicians have used for 30 years to fight infections when nothing else would work. The FDA also approved the new drug to treat complicated skin infections caused by the more familiar staph and strep bacteria.

The FDA's action comes, as bacteria that used to succumb to familiar antibiotics, such as penicillin, are increasingly evolving new strains that cannot be killed by those drugs, making many infections harder to cure. For that reason, doctors have been urging pharmaceutical companies to develop antibiotics that work in new ways. Yesterday, they welcomed the news of Synercid's approval...

..."I would say that it's always exciting to have another option available," said George M. Eliopoulos, an antibiotics researcher and member of the Infectious Disease Division at Boston's Beth Israel Deaconess Medical Center.

At least three other new classes of antibiotics are being tested in patients, he added.

Synercid can only be given intravenously, and experts said, yesterday, that for most patients, running it into a small arm vein is so painful that it has to be delivered straight into one of the large veins in the chest or abdomen. It will cost an average of \$250 to \$300 per day and is expected to be used almost exclusively to treat certain seriously-ill patients in hospitals and skilled nursing facilities.

The people whose lives may be saved by Synercid, are likely to be desperately-ill patients in intensive care units,

including recipients of transplanted kidneys and livers, and those who have had recent surgery and whose immune systems have been weakened by cancer treatment," said Peter K. Linden, an associate professor of medicine and anesthesiology at the University of Pittsburgh School of Medicine.

Such patients are vulnerable to infection with E. This is a cautionary tale because the Freedom of Faecium, a species of bacteria that lives in the human intestinal tract, and can be spread by the hands of healthcare workers and even by contaminated stethoscopes and blood pressure cuffs...Linden said about 50-percent of hospital-acquired strains of this bacteria are resistant to Vancomycin.

> In studies supported by Synercid's manufacturer, Rhone-Poulenc Rorer, the drug was given to 1,222 patients with Vancomycin-resistant E. faecium infections, who had no other treatment options. Although all patients were severely ill, the drug's overall effectiveness rate was 52 percent, said Sandra Kweder, acting director of the FDA's Office of Drug Evaluation....

> ... More than 2 million Americans acquire infections in hospitals each year, and about 1.4 million people in the United States receive Vancomycin annually, said Bruce Lavin, associate director for U.S. medical affairs at Rhone-Poulenc Rorer. He said the company estimates that Synercid will capture 3-percent to 5-percent of the Vancomycin market and will be used primarily for patients whose infections are resistant to Vancomycin, who are allergic to that drug, or who cannot tolerate it because of side effects...

NAME CHECKERS STILL WANT TO KNOW WHO IS JEWISH

Buried in a New York Times story last week—about Viacom Chairman Sumner Redstone—was the anecdotal nugget that his father, Max Rothstein, bought the Latin Quarter nightclub years ago from Lou Walters, Barbara Walters' father.

Obviously, media-mogul Redstone has a homogenized name. When Robin Quivers mentioned this discrepancy on the Howard Stern show, Stern said, "What, is he ashamed of being Jewish?"

(The *Times* noted in a parenthetical aside that "Mr. Rothstein, not Mr. Redstone, changed the family name.")

Stern, who is half-Jewish, is one of the few media personalities with the guts to comment on whether public figures are Jewish—something that shouldn't matter in an idealized world, but in the real world happens to be of great interest to an awful lot of people, for various and often deplorable reasons.

The thinking goes like this: "We need to know who's Jewish and who isn't, because of course the Jews control things through their infiltration of the media.'

Right. Just ask White Supremacist Matthew Hale.

A feature on Stern's show invites panelists to "guess the Jew", from a list of celebrities who don't "seem" Jewish. The primary purpose is to elicit uneasy laughs but it also serves as a social lesson. If you can't figure out who's Jewish, hmmm, maybe you shouldn't be

stereotyping. Besides, what difference does it make when you find out William Shatner happens to be Jewish?

Also tackling this sensitive subject through humor is Adam Sandler, whose "Chanukah Song" is a classic. In his own goofy way, Sandler lampoons anti-Semitism by listing some Jews who don't "seem" Jewish:

When you feel like the only kid in town without a Christmas tree,

Here's a list of people who are Jewish just like you and me:

David Lee Roth lights the menorah,

So do Kirk Douglas, James Caan and the late Dinah

Guess who eats together at the Carnegie Deli? Bowser from Sha Na Na, and Arthur Fonzerelli, Paul Newman's half Jewish, Goldie Hawn's half, too, Put them together, what a fine lookin' Jew!

Clever. And if you're proudly anti-Semitic, do you now make a note to boycott the music of Van Halen and the films of Jimmy Caan?

In talking about this with a Jewish friend of mine—I'll resist the temptation to say some of my best friends are Jews-she told me about an Internet site called Jewhoo.com, which provides an exhaustive list of famous Jews, including such "surprises" as Alicia Silverstone, Matthew Broderick, Elisabeth Shue, Robert De Niro (his mother is Jewish), Bob Hoskins, Sean Penn, Dyan Cannon, Gwyneth Paltrow (her father is Jewish), Nell Carter, Rosanna Arquette and Natalie Portman (not her real name).

The site also lists journalists, directors and even from "The Simpsons", whose father is Rabbi Krustofsky, voiced by Jackie Mason. (And let's not forget Kyle and his family from "South Park".)

So why does a Max Rothstein change the family name to Redstone? Why does Winona Horowitz become Winona

Maybe they're just following a time-honored media and entertainment tradition...Surely Max Rothstein knew his children would have an easier time in life with the last name of Redstone. It's the way of the world.

Weirdly enough, I've been the target of occasional, albeit relatively minor, anti-Semitism—even though I'm a Roman Catholic of German-Irish heritage. For the first 25 years of my life, nobody ever asked me if I was Jewishbut ever since I've been working in the media, I've often been the recipient of anti-Semitic letters or phone calls.

After all, I've got a newspaper column, and they let me talk on radio and TV. You do that much media, you've got to be a Jew, right?

"Are you Jewish!" a drunken and quite famous media personality once barked at me in an accusatory tone. I have no idea why it was important to him. Or why it's important to so many others...the girl who plays Queen Amidala in "The Phantom Menace" is of considerable interest and speculation.

If you are anti-Semitic, I don't even know how you can watch TV, or go to the movies, or read a newspaper or magazine, what with all those Jews in power. Best if you just unplug the electronic media, close the blinds and sit there in the dark with your closed little mind.
