what choices are and what is going to come down on unsuspecting mankind, like NOW, any minute of any day.

#### WHAT COULD BURST THE BUBBLE?

#### By Hal Bryan, August 1999

In 1929, it was the expansion of credit at below-market rates by the Federal Reserve and the banks which, together with margin buying, propelled stocks to unstable levels. In the late 1990s, we find ourselves in the same situation.

Long-time readers of this publication know that our view is a longer one—that we try to prevent our readers being caught-up in the moment but, instead, move them to project their positions months and years into the future. Since personal circumstances are so vitally impacted by the status of one's portfolio, it may be said that lifestyle is the ultimate portfolio, which is the reason people expend so much time and energy thinking about it.

Recently, we have been barraged with questions from subscribers asking, in effect, "You have explained how the credit bubble is fueling the stock market boom, but what

could cause the bubble to burst?"

It is a question with much validity, and we have attempted in many past issues to come to grips with it. But there appears [to be] a new urgency, driven by recent highs in the Dow, even as broader indexes have slipped into the negative, causing losses in many portfolios.

#### SOME OBVIOUS THINGS

instability, which greatly magnifies the risks to market participants—not just to investors but to entrepreneurs, businessmen, employees, consumers and everyone who buys and sells; that is to say, all of us. Unstable markets are predisposed to collapse because, as every investor knows, the very uncertainty which breeds volatility is anathema to the market. It is also understood that collapses usually follow new market highs and that the steeper the run-up, the sharper the expected decline. [H: Check it out this verv week!1

There is nothing new in any of this, but millions of investors seem to have forgotten it.

There is another reason for volatility in the markets, which is also common knowledge—the expansion of paper money and credit, which we know as INFLATION. Any statistic which tends to suggest an increase in the general price level is viewed with apprehension because of the threat of higher interest rates, increasing the cost of capital to business and weighing down upon the markets in stocks and bonds. Consequently, we have a generation of professional "Fed Watchers", whose ears are always tuned for any hint of action by the central bank(s) to raise rates.

[H: So, do you actually think the Fed is somehow not aware of Global things which we hold? Yes, indeed, they are aware, and they are smart enough to know we don't hurt them—we salvage their assets, spelled any way you wish. They will also go to whatever lengths we ask to keep us totally private in our negotiations and in our business transactions—so they can have ALL the nice credit. This is a politician's dream of Heaven achieved for, where our program is used, there will be dancing in the streets, instead of rallies against the leadership. If a President is wise enough to go this route with G.A.I.A., they have gained their nation and stabilized it at the same time. The Philippines has the hard ASSET, and the people holding same are given the opportunity to earn their way right into production and industrial achievement. The outlying provinces and TREASURY AND NOW BOUND BY THE townships can also be utilizing G.A.I.A. and running INTERNATIONAL MONETARY FUND, THE their own affairs, while there would not have to be taxation, only a percentage of transactions to run the central government—actually, in the extravagance to which they have become accustomed, through total corruption.]

Virtually all financial letters (publications) deal with these more obvious factors, largely ignoring more fundamental causes of market volatility.

#### THE NOT SO OBVIOUS

#### [H: NOW, START REALLY PAYING ATTENTION!]

Perhaps the most fundamental of all underlying causes of volatility is the declining value of the currencies in which markets are traded. During the period of the gold standard, prices were remarkably stable over time. In 1929, it was the expansion of credit at below-market rates by the Federal Reserve and the banks—which, together with margin buying, propelled stocks to unsustainable levels.

The SEC was supposedly established to end the overleveraging of share purchases. In the late 1990s, we find ourselves in the same situation, with leveraging on a much greater scale through the use of derivatives, such as index funds. AND THIS TIME THERE IS NO GOLD FLOOR TO SUPPORT THE CURRENCY, AS THERE WAS UNTIL ROOSEVELT ADOPTED OUR PRESENT FIAT CURRENCY IN 1933.

WE ARE, THEREFORE, FACED NOT ONLY WITH Extreme volatility in markets suggests fundamental THE POTENTIAL OF MARKET COLLAPSE, BUT CURRENCY COLLAPSE AS WELL, JUST AS HAPPENED RECENTLY IN ASIA.

> Another super-fundamental which seems completely ignored, even in the hard-money press, is the loss to the marketplace of the capital expended on the Welfare state, one of the most inefficient systems the world has known. The misspending—malinvestment—by government has wasted hundreds of billions of dollars which might have gone into efficient production in the private sector, creating millions of jobs and increasing productivity by whole orders of magnitude, improving the standard-of-living for all. This capital is lost, forever, and we can only guess at how many businesses have failed, how many jobs have been lost, how many new technologies have foundered, how many cures for serious disease have not been discovered, how much sweat and tears have been wasted and how many dreams have been abandoned, because of the lack of it.

> BECAUSE OF THE INSATIABLE APPETITE OF THE SOCIALIST STATE FOR CAPITAL, POLITICIANS HAVE HAD TO DIVORCE THE CURRENCY FROM GOLD AND USE THE PRINTING PRESS TO MANUFACTURE THE ARTIFICIAL CAPITAL NECESSARY TO SUSTAIN IT. WHEN PRICES BEGAN TO BETRAY THE FACT THAT WE WERE ON THE BRINK OF HYPERINFLATION, THEY HAD TO SWITCH FROM PRINTING FEDERAL RESERVE NOTES TO PRINTING TREASURY BONDS, SENDING THE PUBLIC DEBT INTO THE MULTIPLE TRILLIONS OF DOLLARS.

> [H: NO, THIS DOES NOT INCLUDE THE GLOBAL (G.A.I.A.) ASSETS. OUR ASSETS GO ALL THE WAY BACK TO THE 1800s AND ARE BACKED AS PAYABLE BY HARD METAL; GOLD, GOLD BULLION, COINS, ETC. THIS WAS ALL PRIOR TO THE FEDERAL RESERVE ACT OF 1913, AND THE FEDERAL RESERVE BECAME RESPONSIBLE FOR THAT DEBT AS TURNED OVER BY THE WORLD BANK AND ACTUALLY THE WORLD BANKS THEMSELVES, BECAUSE THE ONES WHO OWN THE FEDERAL RESERVE ARE THE BANKING CARTEL. THEN, IF THAT IS NOT ENOUGH, IF THESE FAIL—THE TREASURY OF THE UNITED STATES OF AMERICA, INTO PERPETUITY, IS RESPONSIBLE FOR THE DEBT, IF IT, INDEED, REVERTS FOR PAYMENT. At most, if there should be a moratorium on the redemption of Treasury securities, it would not affect G.A.I.A.—but only further SECURE IT AS A RESERVE ANYWHERE IN THE WORLD!]

When that began to be obvious, they had to transfer "off budget" some of the largest expenditures of the Welfare State. If the people understood the true cost of socialism, they would end it overnight. Knowing this, featherbedding politicians must continually disguise the fact that their extravagance has consigned the people, their children and their children's children to economic serfdom—for the rest of their natural lives. It is upon this flimsy financial base

that our markets rest—not upon a sound footing, but upon a fictitious and ephemeral "money", based not upon gold or real assets, but upon debt. While the global economy today has been termed a "house of cards" by some writers, even this description is not really apt, for in a house made of cards at least the cards are REAL. Imagine, for a moment, that instead of playing cards, the units are paper IOUs, and perhaps you will gain some insight as to the precarious nature of our economy. Then decide how much of your hard-earned capital you want to risk in today's volatile and unstable markets.

All of this suggests that the bubble may burst by IMPLOSION, as well as by EXPLOSION. If we can determine which, perhaps we can make some important financial decisions before it is too late.

#### WILL IT BE IMPLOSION OR EXPLOSION?

Once we recognize that there are two ways in which bubbles may burst—and we know they always do—it remains only to list a number of events which might lead to one or the other, then try to pick the more likely.

If you believe the FED will continue to pump money and credit into the economy through below-market interest rates, thus continuing to increase the already-huge debt overhanging the economy, and especially if you think the FED will rush in with huge bailouts in the event of a significant downturn, then you are in the EXPLOSION camp, meaning that you expect an explosion of credit/debt.

If, on the other hand, you believe that our central bank will raise interest rates, allowing the stock and bond markets to take their lumps, you are basically opting for IMPLOSION. In this scenario, credit does not explode, it simply collapses, just as it did in Asia.

What must be understood is that both scenarios lead, not to deflation—wherein the currency becomes more valuable—but to a dollar decline.

In the explosive scenario, the value of money declines because huge influxes produce what amounts to a hyperinflation of money and credit. In the implosive scenario, markets fall, causing foreign investors to sell their shares and convert their dollars back to their home currencies, thus driving the dollar's value down. [H: Note that the dollar in any scenario is BASED ON NOTHING!

But, since all investments in American markets are DOLLAR-DENOMINATED, THEY WILL SUFFER NO MATTER WHICH SCENARIO PREVAILS.

The only rational response by government would be a massive and preemptive tax-cut, both for individuals, investors and businesses. Since even the most sweeping tax-reform bills working their way through the legislative process provide miniscule tax relief until the year 2005 and beyond, and since the President is inclined to veto even watered-down versions, there is virtually no hope for such an intelligent preventative of economic collapse. We must, therefore, conclude that, indeed, the bubble will burst, and so let us look at some potential triggers of what promises to be the collapse, not only of global markets but, ultimately, of the Welfare State as well. [H: And then, people, who is going to pay the bills? The jobs will be GONE, and all of those myriads of Welfare recipients will be dumped onto the disaster already under wayand the end looks pretty bleak!]

#### **POTENTIAL TRIGGERS**

We will not spend a great deal of time looking at the obvious events that could burst the global credit bubble.

reserves banks are required to deposit with the FED and abandonment of direct market intervention—all political acts of the FED. To these we must add the economic reactions of investors, brokers and fund managers, corporations, small businesses, banks, etc.

Another is the collapse of a major brokerage house or fund, which we have already seen in the case of Long Term Credit Management (which required a hurried and massive bailout, engineered by the FED). There is no shortage of over-leveraged financial-management firms with significant solvency problems, both here and abroad. In addition, we have the approaching advent of the Y2K phenomenon, which some believe will disrupt the nation's payments system, bringing business to a standstill for an extended period of time.

[H: This is all to not even mention, yet, the false reporting of gold and all the assets MISSING from these funds-brokerage records and actual gold simply MISSING. There have been oodles of gold leased without any gold. Good game, as long as it lasts, I suppose—but that game is sharply OVER.]

But there are other possibilities, depending upon how far afield you want to roam intellectually. [H: Yes, we do want to go that far afield, and I will ask that the words be in capitals so that none of you readers, even sleepy ones, will fail to see them!]

FOR INSTANCE, GIVEN THE PROCLIVITY OF THE PRESIDENT TO GOVERN BY EXECUTIVE ORDER, A PROCESS RELYING ON THE CONTINUATION OF THE DECLARATION OF EMERGENCY BY FRANKLIN DELANO ROOSEVELT UNDER THE WAR POWERS ACT ORIGINATED BY THE WILSON ADMINISTRATION IN 1917, A PROGRESSION, WHICH MAY BE DUBBED THE "FREEZE SCENARIO", SIMPLY HAS THE PRESIDENT CLOSING THE MARKETS AND THE BANKS UNTIL THE SYSTEM CAN BE RELIQUEFIED BY THE MASSIVE PRINTING OF CURRENCY, OR PERHAPS SCRIP (AN IDEA CONSIDERED, THEN ABANDONED AS UNNECESSARY BY THE ROOSEVELT ADMINISTRATION). SUCH A PLAN WOULD PROBABLY INVOLVE AT LEAST A TEMPORARY MORATORIUM ON THE REDEMPTION OF TREASURY SECURITIES.

[H: Please realize that there are already executive TRANSPORTATION, **MARTIAL** LAW (IMMEDIATELY TAKING PLACE, WITHOUT EVEN SEPARATE ORDERS) AND ALL THINGS IN BETWEEN. THIS IS TOTAL SOCIALISTIC-FASCISM. Now, in addition to that, KNOW that the U.S. has effectively been UNDER MARTIAL LAW SINCE THOSE VERY DAYS OF THE WAR POWERS ACT AND CERTAINLY SINCE THE EARLY, EARLY

I CERTAINLY WOULDN'T WANT TO BE HOLDING TREASURY OR FED RESERVE SECURITIES—BUT I WOULD WANT ABOUT ALL THE G.A.I.A. CONTRACTS AND AGREEMENTS I COULD POSSIBLY GET IN MY HANDS, AND HAVE THEM IN THE BANKS AS RESERVE, AND GOLD PURCHASED BY THE BANKS, AS DEMANDED BY THE AGREEMENTS—AND WATCH HOW SOFT ALL THOSE SEATS ARE BEGINNING TO FEEL **UNDER YOUR OTHERWISE BARE ASSETS!** 

They are, of course: interest-rate rises, a raising of the AGREE TO NOT ISSUE THESE DOCUMENTS IN THE DOMESTIC U.S.A. BUT WE CAN USE THEM FOR PROJECTS, BY CIRCULATING THE FUNDS BACK AROUND INTO PROJECTS OR INTO SOVEREIGN NATIVE AMERICAN "STATES". OTHERWISE, WE CAN ASSIST IN FUNDING MASSIVE PROJECTS ELSEWHERE AND STABILIZING WHOLE MYRIADS OF NATIONS. I REPEAT, RUSSELL HERMANN LEFT ENOUGH ASSETS TO ATTEND THE U.S.A.—AS TO DEBTS AND FUNDING FOR A STABLE GOVERNMENT, TREASURY AND INDUSTRIAL GROWTH BEYOND YOUR IMAGININGS. BUT, FOR STABILITY, YOU HAVE TO BACK IT WITH GOLD—REAL, HARD GOLD—BECAUSE THAT IS THE COMMODITY NAMED IN THE CERTIFICATE/CONTRACT. YOU CAN USE CURRENCY—BUT THE CONTRACTS ARE BASED ON HARD ASSETS.]

> FINALLY, THERE IS THE "DEATH-OF-THE-DOLLAR" SCENARIO. IN WHICH THE MONETARY UNIT IS SIMPLY ALLOWED TO COLLAPSE ALONG WITH THE MARKETS, TO BE REPLACED BY A NEW "GLOBAL CURRENCY", WHICH WOULD SUCCEED THE EURO (WHICH WOULD ALSO HAVE COLLAPSED, ALONG WITH FOREIGN BOURSES). A NEW GLOBAL TAX SYSTEM WOULD REPLACE THOSE OF INDIVIDUAL COUNTRIES. IT IS VERY POSSIBLE THAT NATIONAL DEBTS WOULD BE ERASED. SIMPLY BY THE EXPEDIENT OF NOT FIXING A RATE-OF-EXCHANGE BETWEEN NEW AND OLD CURRENCY, THUS LEADING TO A GLOBAL BOND DEFAULT. IT WOULD NOT BE THE FIRST TIME, AS THIS WAS THE STRATAGEM USED IN GERMANY AFTER WW II.

[H: Now, readers, don't go away saying this can't happen! IT HAS HAPPENED, EVEN IN THE GOOD OLD U.S.A. THIS BREAK IS PLANNED, THIS ASSAULT ON THE WORLD, FOR NOW—SO THAT MOST OF YOU HAVEN'T ANY NOTION WHAT CAME BEFORE—AND YOU HAVE BECOME BRAIN-DEADENED, INTENTIONALLY. #### **CONCLUSION**

Whether you embrace the explosive or implosive end to our bubble-economy—or perhaps some combination of the two—it is time to accept that THE BUBBLE WILL BURST, no matter how many economists proclaim a new financial utopia, no matter how many historians insist on "the end of history" and no matter how many media commentators assure you that "it can't happen here".

Please remember that we are approaching the most dangerous time of year for markets, which have historically crashed in September/October [H: AND JUST WHERE ARE YOU NOW? I WOULD TAKE AN OATH THAT THIS IS THE 27<sup>TH</sup> OF SEPTEMBER (WITH OCTOBER DEAD AHEAD), 19-HUNDRED-AND-99.]. If for no other reason, you should consider moving to the sidelines, at least until early next year.

# The Phoenix Institute: Recap And Scenario

#### URGENT TO CONTACT AND PHOENIX SOURCE DISTRIBUTORS

Hatonn—It is noted that in the first 53 *JOURNALS*Whether you embrace the explosive or implosive end ordering, and it is still represented as: America West Publishers.

New information must be reflected within these books, both at the beginning and at the end, so that ordering information is reflected properly. And, yes, I will tell you how it has gone thus far.

When it was found that Mr. Green, of America West Publishers, and Mrs. Green/Mr. Green had taken nearly \$400,000 in gold coins INTENDED FOR THE PHOENIX INSTITUTE and secreted them away to Carson City, it was also KNOWN that George Green and Desireé Green, through America West Publishers and America West Distributors, had in their possession, in Nevada—110,000 volumes of *JOURNALS*, each priced at \$10.00. This amounts to over a million dollars in value, which would have been credited, less \$1.50 publishing cost (each), 50% to the Phoenix Institute. [Technically, and legally, since the publishing cost for most of them had been recovered by prior sales, and they were pledged as security for the loans from Phoenix Institute, 100% of the value belongs to the Institute.]

Dharma (the Ekkers) had signed over all rights and income from those books to the Phoenix Institute, as were the proceeds and profits of the paper, *Liberator*, SIGNED OVER TO THE INSTITUTE.

Mr. Green borrowed one-hundred and fifty-thousand dollars, collateralized by those *Journals*, from the Institute. Mr. Green also, however, charged all expenses for the entire America West Publishing and Distribution corporation(s) to the Institute, as can be easily shown from records required for the court at that time.

In confrontation in court, Mr. Green claimed all sorts of absurd things, but it was obvious to the Judge that he was not telling the truth and a trial was mandated. Years have passed, with hearings and other attention to a myriad of circumstances to keep Green from having to account in court. However, these things should be noted:

The court ordered that Mr. Green put the remainder of those books (110,000) in a safe and secure place, that he sell no books and that he fully insure the entire inventory.

It was shown [in another case] that prior to their move to Nevada, with only a small number of books sold and accounted, Greens were making over \$170,000 per year.

Years later, Mr. Green was stating [in the second of his bankruptcies] that he had no books (*Journals*), and that they had been taken to the dump because they were damaged, while at the same time stating he had the old pocketbook of the "*Manual*" or something that he had printed for distribution [which he tried to mislead the court to think was the only security for the PI loans]. [The bankruptcy court immediately gave PI leave to pursue its case against Greens in State court. That was in February

1998; through legal maneuvering, Attorney Horton has managed to stall off the trial, which is now set for October 18, 1999.]

Green was unable to produce any record of destruction or placement of the books. He gave a storage address and [named] a man, who refused to get involved and did in fact name an attorney (who happened to be a Horton FRIEND). All we requested was a receipt for the disposal of the books. But, there was no flood as claimed at the site, for it sat high-and-dry on a knoll in Carson City and "the flood" was in Reno—many miles from Carson City.

Mr. Green had continued to sell the books, including copies of the *Pleiades Connection* "series"—banned from distribution by the Federal Court in Fresno, California—some of which had been turned over to the court for disposal. We have had many confirmations of those continued sales.

Mr. Green had signed a lawful note for the borrowed funds but then, when confronted for collection to square away Phoenix-owed assets—like the \$150,000 (plus years of interest)—which were collateralized by the books, he claimed that the documents were "just paperwork", and he owed NOTHING, and also refused to turn over the *Journals*, which he claimed were the property of the "Distributing" company and not HIS to turn over. However, HE HAD LISTED THEM AS HIS PROPERTY, AS COLLATERAL FOR THE LOANS.

He claimed, in addition, that he had put up some funds for the publication, etc., (WHAT IS A PUBLISHER FOR?) and, therefore, was due everything he gained. That sum grew from a quarter to about 3-million dollars in his presentations over the ensuing years. [Remember those wonderful cartoons in *CONTACT* of George's Pinocchio nose?]

He also claimed that he made his funds on "other" books which he published and distributed. Well, the "best-sellers" were two books, *Immaculate Deception* [which the authors put up some \$50,000 for printing and of which they did not even receive "author's copies"], and Dr. Coleman's best-seller, *The Committee of 300*, [which was 100% prepared and paid for by people of the Phoenix Institute—from editing/typing/formatting to a loan to pay for the publishing cost]. Dr. Coleman had to pay for his own copies, just as the Institute and Phoenix HAD TO PAY FOR EVEN THE AUTHOR'S COPIES. So, The Phoenix Institute did, in FACT, publish Dr. Coleman's book!

Now, somebody tell me how it can be that the Institute, and two people who simply served as Directors of same, are responsible for all the business done by the Institute and now, somehow, owe millions of dollars to lenders. Assuming this to be so, how can any debt be paid, if the collectable assets go uncollected? These were PROJECTS established and presented as being projects of a business nature for the Institute.

The VALUE of the *Journals*, alone, would have easily paid off all outstanding debts of the Institute. These *Journals* list right up there with those books of Dr. Wayne Dyer, Dr. Scott Peck, Dr. Robert Schuller and any UFO writer on the face of the Earth. Dr. Coleman's book is well-read and recognized, just as is the paper, *CONTACT*—all over the world. It is sad but true that Dr. Coleman's

Philippines—as a first-hand observation—along with CONTACT and various of the PHOENIX JOURNALS.

THE DIVINE PLAN, which still bears Green's information, along with THE RAINBOW MASTERS, are in such demand as to be put to copy from the few allowed copies here in the Philippines. So, SOMEBODY sold a LOT of these books, and it had to have been clandestinely, and the one with any printed "rights" [on the copyright page inside the books] would have been George Green.

Now, let us consider more recently: another book put together by, basically, our people was/is TRANCE FORMATION OF AMERICA—also a best-seller, to the point that enough books were sold by Phoenix Source (after George Green departed with America West) to run a sizable tab for payment to the authors. Gail Irwin and Rick Martin had TOTAL CONTROL OVER THE ACCOUNTS OF the authors were paid nothing and, when Ekkers went home in April, they spoke to M. Phillips (author) and he was due over \$15,000. Is the light of possibilities happening, readers?

Ekkers paid half of that out of their personal travel funds, and Social Security, and still are committed to the remainder, plus interest and, frankly, are committed to making up damages-Phillips [and O'Brien] had lost everything, including their home. It is also KNOWN that Green had asked for the privilege to sell TRANCE FORMATION, and Phillips denied a working relationshipso Green just went the other route, and got the books through others at a discount and went forth and sold them anyway. He continued to feature the other books named in his separate catalog—even after changing the "distributor" to another corporation.

I want to bring this to your attention so that you get our books into collective shelter, with REMOVAL [of America West information] or glued-in information-stickers in every Journal. There has been nothing preventing Green from re-publishing these Journals, for copies of the manuscripts have been provided, free of charge—by Al Overholt—TO THE INTERNET AND THUS, DIRECTLY, IN FINISHED FORMAT, TO GEORGE GREEN.

#### PAPER EXPLAINS LGUs' LIMITED FUND ACCESS

#### [H: Well, bear with us, because here is another speaking paper.]

Two factors severely limit private-sector interest in providing funds for Local Government Units (LGUs).

These are the depository requirement of the Commission on Audit (COA) and the lack of clarity on an intercept mechanism for the Internal Revenue Allotment of LGUs.

This observation was made in a paper titled "Issues in Local Government Finance Loans", which was published under the Governance and Local Democracy project of the Associates in Rural Development and the U.S. Agency for International Development.

Against this backdrop, the paper said national government agencies should take steps to remove existing constraints on private lending, by allowing local governments to deposit funds in accredited private commercial banks and clarifying the IRA intercept provision, to make it available to both government financial institutions and private banks.

The LGUs, themselves, can usefully concentrate on improving their capacity to raise their own account revenues, thus providing a stronger base for commercial borrowing.

The paper noted that resources of government

financial institutions and the Municipal Development Fund (MDF) are sufficient to address the expanding financial requirements of LGUs, particularly with their expanded responsibilities under the Local Government Code of 1991.

There is a pressing need to facilitate local government access to private loan resources.

Until now, it was noted, there has been no clear-cut delineation of how the MDF, government financial institutions and private lenders can support local government borrowing. Despite the pressing need of LGUs for private credit, little progress has been made.

The 1991 Local Government Code provides more liberal rules for local government borrowing. Setting a limit on LGU indebtedness, the code states that "the amount of appropriation for debt servicing shall not exceed 20-percent of the regular income of the local government concerned."

1975, which governed local government credit finance in the Marcos era.

Specifically, the code repealed a provision of PD752 compelling local governments to seek Department of Finance (DOF) approval before applying for bank credit, or issuing bonds and other forms of indebtedness.

However, the borrowing capacity of local governments under this provision is roughly three to ten times as large as under the COA's earlier "net paying capacity" formula.

The code also encourages local governments to secure debt finance not only from government financial institutions but [also] from private lenders.

The MDF, created in 1984 as a conduit for foreign loans and grants contracted by the national government for local governments, emerged in the late 1980s as virtually the only source of long-term credit finance for local governments.

The government financial institutions' credit to local governments, previously a significant source, dwindled following the build-up of unpaid obligations in the first half of the 1980s, but the code resuscitated the government financial institutions' interest in the local government credit market.

These institutions accounted for 86-percent of the P12.6 billion of local government loans approved in 1992-1995.

During the period, the MDF remained an important source of local government credit finance, but private banks shunned lending to local governments despite occasional statements of interest.

Thus, the paper said, there is a compelling need for the MDF to refocus its efforts in the short-and medium-term. The government financial institutions and the private capital market will not be able to address the credit needs of many LGUs, particularly those that are financially weak.

On the topic of increasing local government access to private credit, local officials and outside observers identified several approaches for consideration.

The new LGU credit framework (developed by the DOF) should be implemented as soon as possible, with all local governments made aware of their borrowing status. (Manila Newsfeatures and Commentaries)

Our displeasure, however, does not merit impulsive idiocy in reaction—we just offer more of ourselves to get the job done, and so we shall. We work with that which we have and that is all we can do. Keep your eyes on the prize—IT'S WORTH IT!

Meanwhile, we have several in direct contact with us in Manila and, you who are among them, just realize that we CANNOT get back to you timely. When we respond, we instantly get back a new bunch of pleadings for information and instructions. NO, we can't do it and I don't even want my people to shift focus.

Lester, YES, we will have a place and facilities to further your work, with others like LS in California (and others), and probably, to save "start-up" time, we will have to arrange something here in the Philippines. produced are yet to be constructed and certainly are not ready to take on foreign elements. That does not mean, however, that a lot cannot be worked out for interim facilities—but NOTHING can be done until we get over the hurdles of permits and other problems immediately

NEW YORK (Business Wire)—September 27, 1999—The World Gold Council (WGC) said today that it welcomed the initiative of the European central banks to introduce a five-year moratorium on new sales of gold from official reserves.

Mr. Wim Duisenberg, President of the European I do not write these articles, such as we will offer Central Bank, said in Washington yesterday, following a meeting of the Group of 10 leading industrial countries, that the central banks of the Euro-system, plus the Bank of England, [along with] Switzerland and Sweden, had agreed to limit sales of gold from official reserves to a maximum of 2,000 tonnes over the next five years. This figure includes the potential sale of 1,300 tonnes by the Bank of Switzerland and the current sales by the Bank of England. The sales would be limited to a maximum of approximately 400 tonnes

> The central banks have also agreed not to increase their gold lending arrangements and derivative operations above current levels for the next five years.

> "The World Gold Council welcomes this move," said Robert Pringle, head of the WGC's Centre for Public Policy Studies. "These decisive measures by a group which accounts for some 50% of all official gold holdings [H: Note the word "official" tucked in among the speakings.] will reduce dramatically the scope for rumour and speculation which has been such a damaging feature of the gold market in recent years.

> The other major holders of gold—the United States, the IMF, the Bank of Japan and the Bank for International Settlements—while not part of this agreement, are associated with it. [H: They are not just "associated", they are the CAUSE of it.] The Reserve Bank of Australia several weeks ago also stated that it had no intention of selling more gold in the foreseeable future. This brings almost 90 percent of official gold holdings worldwide within the scope of a general restriction on gold sales and lending. [H: And to you who are asking about our wish to sell gold no, we are NOT interested in selling gold.]

> "The WGC has been drawing attention to the dangers of instability in the gold market fuelled by speculation, and we are pleased to see that central bankers share our concern and have taken steps to limit the opportunity for unfounded rumour. WE ARE ALSO PLEASED TO NOTE THAT THE WORLD'S MAJOR CENTRAL BANKS HAVE ALSO RE-

#### GOLD SURGES US \$13 ON EU STATEMENT

Hong Kong—Sep. 27—Spot gold rose by US \$13 to \$284 from \$271 in Asian opening, due to massive SHORT-COVERING worldwide on a statement from major European central banks Sunday that said the banks would cap their gold sales, dealers in Hong Kong said. Market sentiment turned from mixed to bullish today and many expect the price to rise to \$300 in the near future. [H: Well, so far so good!]

The European Central Bank, 13 EU central banks and the Swiss National Bank released a statement on Sunday in Washington to clarify their positions on their gold reserves. The statement said that there would be no sales beyond those already announced over the next 5 years, and that the annual sales will not exceed approximately 400 tonnes, and that total sales over a period of 5 years will not exceed 2,000 tonnes. The statement also said the signatories have also agreed not to expand their gold leasings and their use of gold futures and options over the 5 years. It stressed that gold is to remain an important element of global monetary reserves. Also on Sunday, the International Monetary Fund announced that it has officially endorsed a plan to re-value 14 million ounces of its gold reserves through off-market gold sales. This eliminated previous fears that the IMF's gold sales in the open market would push down spot prices. THE DEALERS SAID PLAYERS HOLDING SHORT POSITIONS WORRIED THAT THEY WOULD NOT BE ABLE TO BORROW SUFFICIENT GOLD TO COVER THEIR POSITIONS, BECAUSE THOSE CENTRAL BANKS WILL NOT LEASE MORE GOLD TO THE MARKET. This forced many shorts to cover their positions in the spot market today, they added. As Sunday's statement reconfirmed gold status as "an important element of global monetary reserves", market sentiment quickly turned to bullish, which attracted some fresh buying, they said. Some dealers see gold rising further in the overseas market today to \$290 and to \$300 in the near term. Others, however, were cautiously optimistic about a further rise, saying that gold was overbought as the price has already risen \$13 in Asia. Due to the strong gold [prices], silver, platinum and palladium were steady in sluggish trade as dealers FOCUSED ON GOLD.

Low gold prices over the past two years have caused the closure of over 130 mines. The only reason production is up 1% is that major mining companies are hi-grading their reserves.

In early September, short positions rose from 184 to 196 tons. One-month lease rates were about 4.85% late in the month, 12-month rates were 3.25%. Both are historically high levels. Some central banks are not rolling existing loans, causing the pressure.

Comment from important Indians has recommended some time early in 2000. The IMF had to throw in a that the country should take advantage of the current low prices to increase its gold reserves. Mr. S.S. Tarapore, former Deputy Governor of the Reserve Bank of India, said India's reserves of 375 tons could safely be doubled and accounts for only 8% of external reserves.

We don't know if former Vice Minister of International Affairs at the Japanese Ministry of Finance, Dr. Eisuke Sakaibara, was right in his statements in May to the Australian Financial Review, that Wall Street would crash over the next year, but he certainly coined the name for the U.S. economy, Bubble.com. If Mr. Sakaibara is correct, it goes a long way toward explaining why the Bank of England is in such haste to sell or transfer the gold reserve holdings of the people of Great Britain to other Elitists and, at the same time, save them from their investments involving the gold carry-trade; the carry-trade positions being just one part of the \$300 trillion in financial obligations floating in the world financial system. There is always more than one reason why these people do things. It was not some bolt-out-of-the-blue that prompted the UK's sale of 415 of 715 tons of gold. It was grand theft of the people's assets. As a result, 130 mines have been shut down and thousands are out of work. This has been abetted by the IMF, which wants to sell 311 tons but was forced to use accounting procedures to turn its hoard into dollars, after the U.S. Congress sent them the message that they wouldn't approve the sale. As we close in on the day of reckoning of the financial system, the effrontery and greed of the Elitists becomes more easily recognizable: sale, or proposed gold sales, by the BofE, IMF and the Swiss and the scandals hitting banking every month, such as major banks being caught money laundering, which is nothing new to our readers, in their quest for easy profits. Whether it's Coutts, Chase, Citibank, or Bank of New York, they are all involved. If the BofE gold sales are any yardstick, you can rest assured gold is still the only store of value, at least the Elitists think so; they are buying it.

Second-Quarter gold demand hit a record high of 809.5 tons, up 16% from 1998's 807 tons. [H: Of course, readers, realize that if you believe those particular numbers, you are not seeing the real picture—even the arithmetic is wrong.] Jewelry demand was up 13% and investment demand 32%. In the U.S., Gulf States and India, demand was at the highest level ever for a Second Quarter.

In July, the average, daily, net-clearing turnover in London gold markets was up sharply to 1,082 tons, or much higher than actual demand.

On September 21st, the BofE said it had sold 25 tons of gold from reserves at \$255.75 an ounce, slightly above price expectations. The sale was eight times over-subscribed. Three times over would have been bullish. Eight times is somewhat astonishing. Interestingly, gold-mining companies were among the bidders, and it was significant that South Africa's Gold Fields said it bought 12.5% of the total. This could be very positive, as it shows a genuine belief in higher prices and could signal a slowdown in producer hedging and possibly even future buy-backs. Other positive news was a report in the Tribune de Geneve that said Swiss central bank sales would probably start in 2001, rather than 2000; although the Swiss National Bank later said it plans to sell half its 2,600-tons reserve

canard, that it is considering a plan to sell more than 10-million ounces to raise money for debt relief. They can't, without U.S. approval, and neither can the Swiss, without voter approval.

Any sane person with any intellect whatsoever has got to believe, given the facts, that central banks, with the assistance of some major gold producers, have been manipulating the price of gold since 1986. Who in their right mind would lend an asset at 1.5% interest? It certainly can't be a profitable endeavor. We know central banks have admitted leasing gold. The Fed denies having done so. We suspect the Fed has been writing call options, which allows bullion banks to hedge their gold-leasing activities. It also could be true that the Fed and other central banks have sold call options in the \$290-\$300 per ounce area. This could be another reason why the BofE took the unprecedented step of selling off part of Britain's gold reserves. The writing of call options would invigorate gold leasing, but low gold prices going into option expiration time would be beneficial to the writer. Thus, the BofE action could have carried banks through a period of terminating maturities. During such a period, a lessor would not be leasing or writing calls, thus, the increase in gold lease rates from 1.5% to 4%. It is possible that the Fed and others, last May, when gold prices looked like they might move to \$310-\$320 an ounce, requested the BofE take the drastic step that it did—selling gold reserves—thereby suppressing prices. This happened at almost the same time that hedge funds got in trouble in the yen and franc carry-trades. The BofE could have had two reasons for suppressing prices. It is the function of central banks to prevent financial breakdowns, and driving down gold prices under these circumstances would be justified. What is not justified is the manipulation of gold prices in the first place. If the central banks are in the market, investors and speculators have to lose money due to their actions. Not only do they manipulate markets for their own benefit, but they also lie about it under the guise of it being in the national interest.

Of course, the national interest is whatever the Elitists deem it to be. Their interest is the national interest. The British excuse for selling, borders on the ridiculous. At least sales by other EU countries had a rationale and that was meeting Maastricht criteria. The Swiss do have excess gold reserves, but we doubt the public will ever allow them to be sold, but just the announcement of such an event sabotages the market. We are convinced that that is what Swiss sales are all about; consequently, for whatever reasons, they are also part of the problem. Bullion bank leasing is not leasing if the borrower sells the gold. Banks have sold the gold through an intermediary, for interest, hoping they'll get the bullion replaced. The intermediary uses the cash and leverages. All we can say is: one problem and the whole system could collapse. Thus, the first to go could be gold-lending central banks. If our reasons are correct, and the financial system went to the edge, without our being told, it could have a frightening enough effect on central banks, so that they might cut back or end leasing arrangements. If that does happen, gold is certainly headed higher.

At the end of 1998, official gold reserves were approximately 33,500 tons, or 15% of total, world foreign-exchange reserves. The five largest holders,

the U.S., France, Switzerland, Germany and Italy, own 20,000 tons. Annual turnover at the London Bullion Exchange is 250,000 tons. The net short position in gold derivatives is between 4,000 and 14,000 tons. Whatever the figure is, that amount has been sold into the bullion market and must either be bought back or rolled. We always tend to look at the price of gold in terms of higher prices. Gold selling unnaturally at \$252-\$265 an ounce, on the other hand, presents a great buying opportunity, which has led to major physical demand at these levels by traditional buyers in the Middle East, India and throughout Asia. In June, we said we thought gold had finally bottomed at \$252 an ounce. If we are correct, longterm buyers should be taking advantage of what could be a golden opportunity.

As discussed in our last issue, the IMF plans to revalue 14-million ounces of gold to finance its share of a debt-relief initiative. The value is about \$5.5 billion. The U.S. intends to seek funding from Congress for their share of funds, so its contribution may never materialize. [H: Oh, I don't know. Didn't Billy Clinton just FORGIVE the debts of the 29 most impoverished nations, as owed by those nations to the U.S.? Of this, the U.S. would only have an outgo of \$1 billion, as they write off the \$5 billion, because they couldn't collect the rest anyway. He was urging other nations to do the same. Well, now, why do you suppose this write-off would be handled in this manner? Ah ha, in politics nothing is coincidental or by chance. There is a REALLY BIG problem here, people, and the Elite don't know how else to do this amazing manipulation that allows for survival.] As you can see, the IMF revalues its gold but expects members to fund the giveaway. Instead of selling gold, they revalued it and then assessed the \$5.5 billion to membership, which is just another tax of the taxpayer, or another scam. We hear all these platitudes about the tragedy it will be if we miss this opportunity to further aid the indebted poor. Having spent years in Africa, we can assure you that any debt relief we execute will descend into a bottomless pit, and the whole cycle begins anew. While the IMF is demanding more taxpayer funds, they have abruptly changed the rules on international lending. It is fine to change the rules, but they should have given fair warning to lenders. Remember, the IMF created the lending problems in the first place by bailing out everyone with taxpayers' hard-earned money.

What's further distressing is that even a social "movement", such as what's known as the "New Age" philosophy, which has some undeniably positive aspects—including a sensitivity and openness to the fundamental connection within each of us to all life and to higher realms of understanding, wisdom and awareness, as well as an enhanced sense of respect for and desire to coexist with all facets of Nature on this planet—can be "infiltrated", subverted and manipulated by some of the many tentacles of the beast that is the worldwide, covert control-system, or government.

I believe that more than a few fundamental, "New Age" tenets and theories—such as an impending pole-shift, dimensional shift, or other galactic or planetary realignments of a potentially massive, even catastrophic nature, including the "end-of-time" scenario, as per the Mayan Calendar and other schools of esoteric knowledge—could be getting played upon through the implementation of some very subversive social manipulation, by some very devious people and agencies, using any and all available means of influencing and shaping human consciousness (including certain highly-advanced technologies like those EM/RF systems perfected in the Montauk Project, and now HAARP).

It would be pretty easy to make it seem like the poles, magnetic fields and everything else are shifting, if the ionosphere is being whipped into a veritable frenzy with HAARP's EM/RF transmissions, which deeply impact weather, mind, seismic activity and just about everything else! And HAARP is just one of the ways in which various aspects of our "reality" can be manipulated and our perceptions thus "controlled".

Byron Weeks has put it as well as I ever could, and I reprint below some of his thoughts on this topic:

"With what we know of electronic warfare, I am sure that it has occurred to many of you that we have the potential for one-heck-of-a millennial celebration!

"We have harnessed the Tesla Effect and are able to roil the magma at the core of the earth enough to create tectonic plate disruption, sufficient to produce earthquakes and volcanoes. The HAARP Project has demonstrated the ability to control weather, produce giant storms, cause severe droughts and, quite probably, [affects] the phenomenon known as "El Nino". High-wattage microwaves are capable of melting rocks and leveling small mountains. ELF waves are versatile and have been used successfully in mind control, with a typical reaction being the hallucinated appearance of alien beings. Holographic projections can show realistic movies against the sky and could entertain us with a fake Second Coming of Christ, angels in the sky, trumpets and celestial music. Biological warfare could give a good imitation of the punitive plagues of the last days...

"...Do you suppose any of the above might cause chaos and rioting that would necessitate calling in United Nations troops to keep order? If that wasn't dramatic enough, our government has buddied-up to Russia, in a continued war against the drugged-up and dumbed-down people of 'Amerika'. Along with the anticipation of global governance, the NWO probably has more up its sleeve: such as planned economic collapse, and civil insurrection engendered by the collapse of welfare payments, involving rabid minorities, armed with Chinese weapons and whipped into a finely-tuned state of paranoia, through the application of ELF waves.

"It has always been a little troubling to me to consider that a loving, Eternal Father in Heaven would bring the dreadful punishment of an Apocalypse down upon a sinful world. Could it not be that what the prophets have always told us may have come from God's foreknowledge of Mankind's tendency to self-destruction? Perhaps He thinks it wiser to let us decimate ourselves, since the human experiment has not turned out very well, anyway.

"But we can be very proud that our technology has advanced to the point at which we can self-annihilate in a very short time, whenever the fancy strikes us. Imagine! Our very own Apocalypse! I guess we can show those aliens a thing or two!"-- Byron Weeks

#### THE FUNDAMENTALS OF CONTROL

The entire philosophical impetus and conceptual basis for what the secret government is trying to accomplishwith what I've called "reality control", implemented on a very widespread basis—is a subject worthy of much study in itself.

Others have done a tremendous amount of excellent research and writing on this topic, which needs not be duplicated—even if I could do so. Rather, it makes sense to quote some pertinent material from different sources, to help portray some of what underlies the Montauk Project and many other mind-control/consciousness-manipulation operations.

Again, Byron Weeks has some excellent writing on one aspect of this; the complete de-spiritualization of human

beings. In other words, inculcating the concept that we are nothing more than "meat machines", thoroughly mechanistic, biological systems, whose "consciousness"—in terms of emotion, creativity, or any "higher" awareness whatsoever, not to mention anything remotely spiritual—is nothing more than a synaptic byproduct of the interactions of purely physical components and processes. In other words, we are nothing but a body—a view reinforced by our civilization's officially sanctioned, modern "science" at every conceivable turn.

As Mr. Weeks put it, in The Psychology Behind Mind Control and Psychic Warfare:

"Body identification gives rise to a host of sociological phenomena, the least of which is the mechanistic view that consciousness is a product of the brain and, secondarily, that the mind is centered in the brain. Dr. Jose Delgado was one of the chief proponents of this viewpoint. Delgado was the author of the book *Physical Control of the Mind:* Toward a Psychocivilized Society. For Delgado, the mind existed only in the brain; to postulate its existence as an independent entity was, to him, sheer nonsense.

"He rejected the concept of free will and proposed that the mind was a functional entity produced by the electrical operations of the brain and, as such, should be manipulated and controlled, in order to control the behavior of the population. This is a view that seems to be shared by proponents of the New World Order. Delgado, since the mid-1970s, was the director of the Spanish neurophysiological laboratory, Centro Ramony Cajal. As time went on, his interests shifted from direct stimulation of the brain to the broader area of the biological effects of electromagnetic fields, an area that has been eagerly embraced by the military and political system, as a means to achieve their goal of absolute control of the population.

"There are several psychological schools of thought that have been adopted by government psycho-scientists and the military to justify mind control. All of them relate to the idea of psychic energy as originating in the human psyche, typified by the work of Carl Jung. The energy originating in the human psyche consists of thoughts, feelings, emotions and neuro-physiological stimuli and responses. It consists of a physical component that can be measured and an etheric, hyper-spacial component that can only be human population can easily be manipulated by electronic measured by specialized equipment."

#### SCIENTIFIC MANIPULATIONS—FALSE DATA

Weeks goes on to describe, extremely coherently and lucidly, how the public is continually manipulated and our evolution and progress substantially restricted by the suppression, destruction, and/or alteration of significant, important information.

Weeks refers particularly to an alteration of Maxwell's equations, which resulted from Maxwell's extensive research into electromagnetism—alterations which drastically affected the entire course of "mainstream" science and physics forever afterward; notably in the information made available to scientists and physicists of the time, such as Einstein, as well as the subsequent conceptual framework which Einstein arrived at. To cut to the chase, the missing link, which would provide the key to the Unified Field Theory, was deliberately cut out of Maxwell's equations by a rather sinister group of scientists, before Maxwell's work was presented to the scientific community and the world. Of course, his original work and all the implications thereof were, and are now, known to the covert world government, as are the resultant, advanced sciences and applications of this knowledge of very high technology.

This technology is all being implemented in the furtherance of unquestionably evil, abusive, oppressive, brutal and rapacious agendas and goals; with consequences which are destructive to nearly every significant aspect of human beings; destructive to human society and any of its positive, hopeful and constructive goals; and destructive globally, to the fabric of life itself; in part, due to a general state of mind which has no understanding of, respect for, and connection with and to Nature and the Earth, with its multitude of life forms; a state of mind which is the product of our current, dehumanized, mechanistic and massively mind-controlled (through every available means) existence, at the hands of the worldwide covert government and its super-hi-tech arsenal of mind-manipulating technologies.

I found the information below—regarding Maxwell's original equations and the inter-dimensional implications thereof—very interesting and, I feel it is extremely relevant to what is known about the work of Wilhelm Reich, regarding what he called "orgone" energy, some characteristics of which are "electromagnetic" in nature but outside of the commonly understood "EM" frame of reference. The information is also quite relevant to what Preston Nichols has reported on regarding the Montauk Project—both the mind-control and inter-dimensional/timetravel aspects of the Project.

From The Suppression of Vital Data in Physics, by Byron Weeks:

"For thousands of years, many discoveries have been suppressed from the populations of the planet, in order to keep them in bondage. The burning of the libraries of Alexandria is one example of how information can be suppressed. Another example would be the common technique of suppression of scientific information, by alteration of the information itself.

"Perhaps the most blatant and far-reaching alteration of data was the alteration of Maxwell's equations. James Clerk Maxwell was a mathematical genius who lived in the late 19th century. His original work, which is available to covert scientific departments in the government, had the potential to radically alter the entire course of our civilization.

"It is certainly clear to most of you by now that the means, using various methods developed through the military-industrial complex. What may not be clear to you is that many of the EM effects can be initiated from outside of what is normally seen as the electromagnetic spectrum. Just as a magnetic field in a wire is at right angles to the current flow, other fields and waveforms exist that are an integral part of the electromagnetic spectrum, yet exist at a certain number of right-angle rotations (orthogonal rotations) away from the electromagnetic-field components we are normally accustomed to. If these hyper-spacial components—which are not subject to the usual electromagnetic constraints of time and space—are generated and manipulated, they can, in turn, generate EM effects that have the ability to influence human biology and consciousness.

"Let's take a brief look at how and by whom the equations of Maxwell were changed, in order to make subsequent, open, scientific development—that would have influenced civilization in a positive way—impossible."—© Byron Weeks

The following section contains crucial information about the massive deception and manipulation of scientific concepts, which so extensively impacts our view of "reality" in this present-day, materialistic culture and is quoted directly from Valdemar Valerian's Matrix III, Volume One, 1992, pp. 310-311:

#### THE HERTZIAN CONSPIRACY

"In late 1864, James Clerk Maxwell published his epic material on electromagnetic waves. His material dealt not only with electrical and magnetic waves but also the relativistic/ethereal psychoactive component of these waves (representing electromagnetics of the second order and above). The equations also included transformations that enabled the change from inertial frames of reference to noninertial frames of reference. Maxwell's original equations were written in Quaternion notation, a complex mathematical system available at that time, before Vector Analysis was introduced by Oliver Heaviside. Today's generalized equivalent of Ouaternions is Tensors.

"In short, Maxwell's original work gave the necessary information for gravitational propulsion and psychoactive devices. Someone, somewhere, recognized this, for shortly chemist Willard Gibbs and the physicist Heinrich Hertz, decided to "edit" or "interpret" Maxwell's famous equations which were—in the original form—the foundations of electromagnetics and Unified Field Theory (UFT). This "unholy trio", especially Heaviside, disregarded the Quaternions or Scalar components of Maxwell's original equations, because they represented potentials and not fields. He thought potentials were akin to "mysticism", because "everybody knows" that fields contain mass, and mass cannot be created from apparently nothing, which is what potentials are, both literally and mathematically; they are an accumulation, or reservoir, of energy. Furthermore, not only did they throw away the gravitational component with the Quaternion/Scalar, but they also postulated that gravitation and electromagnetism were mutually exclusive, not interdependent. That was the death blow to subsequent efforts by scientists to realize a functioning Unified Field Theory. Because of this one act, electromagnetism was reduced from its original five dimensions to only four: X, Y, Z and time. The element of G was removed.

Because of this deliberate act, twenty-two other errors exist today in electromagnetic theory. The very concepts of force, mass and charge are ill-defined, and the so-called "static" electrical charge has been discovered by quantum mechanics, not to be static at all, but to move rotationally by virtue of the quantum-mechanical spin. Finally, adding insult to injury, the so-called "imaginary components" of Maxwell's original equations—as well as the mutilated version of the equations—have also been discarded or ignored. With this last error, the door to hyper-spacial domains was forever closed, for the present mathematics and physics of electromagnetic theory do not allow for hyper-spacial domains (domains outside of three dimensions), superluminal signals (signals that exceed the speed of light or are infinite in speed) and a Unified Field

"The edited version of Maxwell's work, which every physicist and engineer has had to contend with, discards electrogravitation and avoids the unification of gravitation and electromagnetics. It also prevents the direct engineering of gravitation, space-time, time-flow rates, freeenergy devices and quantum changes—which is viewed by the altered equations that are vector-based as only a statistical change. The Quaternion approach captures the ability to utilize electromagnetics and produce local curvature of space-time. Heaviside wrote a subset of Maxwell's equations, where this capability is excluded.

"Dr. Henry Monteith has independently discovered that Maxwell's original Quaternion Theory was a Unified Field Theory. Einstein assumed, because he only had access to the altered equations, that curving space-time could only be

the local frame would always be a Lorentz frame, which would mean that all operations would be constrained to "conservation laws of physics". "In the 1960s, the Hertz (Hz) replaced Cycles-Per-Second. Since then, everyone thinks that all electromagnetic waves are hertzian. Only the upper portion of the spectrum—before Infrared contains Hertzian waves. ELF and ULF are not [Hertzian]; waves in bio-systems and natural phenomena are not Hertzian in nature."—— © Valdemar Valerian

#### THE ANCIENT HISTORY OF MONTAUK AND SURROUNDING AREAS

#### POWER POINTS—TETRAHEDRAL PHYSICS

There are two researchers who have contacted me after his death, the mathematician Oliver Heaviside, the independently with what I feel is some quite significant information. The work of each of these individuals dovetails and coincides to a great degree with that of the other on some very intriguing points. The information brought forth by each is very significant in relation to the truly ancient history of Montauk and, what's more, to the real history of the human race on Earth as well.

> Dr. Bruce Cornet, of New Jersey, was the first of the two to contact me. Dr. Cornet's detailed and extensive research relates to the tetrahedral physics developed by Carl Munck, Bruce Cathie and Richard Hoagland (who popularized it) and applies tetrahedral formulas to the Northeastern U.S., in particular, in this case—as it relates to a planetary grid-system and specific power-points. Cornet has accomplished this by means of correlating the tetrahedral data to topographical features, geomagnetic anomalies and known locations of metaphysical/ parapsychological phenomena, and he has cross-referenced this data with the esoteric and ancient history of the region, to come up with some most intriguing ideas.

> To sum it up, Mr. Cornet has pieced together evidence and information as noted, related this to the photographs of Mars' Cydonia region, and states that much of the northeastern area of the U.S. had actually been terraformed many millennia ago (obviously, by some technologicallyadvanced civilization), in what amounts to a replica, or analog, of the Cydonia region of Mars!

> Of particular note would be the lower Hudson Valley region of New York State, an area with a very significant history, both recent and not, of a great number of occurrences of paranormal, metaphysical phenomena. Areas of New Jersey and Pennsylvania would be included in this region, and Long Island and Montauk, itself, would figure in this overall scheme of things as researched by

> This is a good place to mention that for some time I have felt or intuited a "connection" of some kind between the lower Hudson Valley region and Montauk. My feeling is that this connection could be "esoteric" and energyrelated, and there could possibly be actual physical connections as well—perhaps tunnels. In fact, I have had this intuition corroborated by a number of people. In terms of hard evidence, I offer this statement, which came my way through Bruce Cornet, from Mr. Bob Tidwell:

> "I was assigned to Stewart AFB, near Newburgh (lower Hudson Valley area) in 1969, so I'm familiar with that area. (I was only there for two weeks, and that's a story in itself. Stewart was used as a staging point for Montauk personnel.)"

> Let's keep in mind, here, that Montauk Air Force Station was officially decommissioned in 1969. Why would the Air Force need a staging area for a base which was

achieved by the weak gravitational force due to mass; that closed? In fact, Stewart AFB was also supposedly closed right around this time, as well, though it is well known throughout the area that it, in fact, is not the least bit closed—even today! Stewart AFB seems to have played a rather significant role in some way or other in the widely publicized "Hudson Valley UFO" phenomenon-tens of thousands of sightings of mostly huge, boomerang-shaped craft—throughout much of the middle and late 1980s).

Dr. Cornet wrote:

"By the way, Montauk occurs at the same latitude as Colchis, on the eastern side of the Black Sea. Colchis was important as an early, ancient-Egyptian outpost and was the place where the Golden Fleece of Greek mythology was hidden. The Golden Fleece, according to Temple (1976), is Horus or Hero. Colchis is also where the native saffron and crocus plants are located—the only known source of a chemical that cures gout. Read The Sirius Mystery, by Robert K.G. Temple (http://www.gotoit.com/titles/ sirmysti.htm).

"Oh, and by the way, my area of specialization in geology was the Newark Supergroup, and one of the basins I concentrated my studies on was the Newark basin of PA, NJ, and NY. It is shaped like a giant Ark or Argo, with Philadelphia as its rudder, Newark near its bow, the Empire State Building at its prow and the Statue of Liberty along its keel. Long Island and Montauk fit into this picture as a forward, submarine extension of this Ark—something like a ramming device."—© Bruce Cornet

Another researcher, named Michael Lawrence Morton. contacted me with some similar information: to wit, that he had applied the tetrahedral formulas of Munck, Cathie and, to some extent, Hoagland—to the area around Turtle Cove/ Camp Hero, using topographical maps—and came up with what were, to him, some very startling correspondences. Within the central area of Montauk Air Force Station, itself, according to the noted formulas, the two main bunkers and radar hill came up as being very major power spots—right on the nose, so to speak!

Granted that these hills were the result of construction by the government and military within (mostly, we think) the 20th century—nevertheless, the data and numbers on these three small hills are so significant that it appears certain that the construction took place at these exact locations precisely because of their "tetrahedral", planetarygrid significance. What's more, it appears at least very possible that these exact spots could well have been the locations of the "Pyramids of Montauk", the existence of which, at one time, anyway, does seem fairly certain.

Dr. Cornet estimated that the date that this large-scale terraforming would have taken place would have been at least 10-12,000 years ago. Interesting to note is that the Montauk Indians are believed to have inhabited what was, until recently, the island of Montauk—for at least 8,000 years, if not longer.

#### RECENT CHRONOLOGY OF CAMP HERO AND THE PROJECT, "STAR WARS"

There are some signs and testimony that "negative", malevolent forces were not in control of the power spot and subterranean facilities/laboratories at Montauk Air Force Station, between (approximately) 1993 and mid-1997, although more recently this appears to have changed, once again.

Between 1993 and 1997, the facility was operated by an Air Force contingent, utilizing particle-beam technology in defensive operations concerning Hale-Bopp and the object said to be trailing the comet; perhaps also against "hostile" UFOs.

#### **CHANGING OF THE GUARD**

In late February of 1998, a psychic in NYC told me that her reading on Camp Hero indicated to her that the Force agents raided an underground base about 15 miles time portal, so to speak, was currently shut down.

Not long after, in a phone conversation with Al Bielek, he told me more-or-less the same thing: that certain groups had closed off the access to the portal (stargate) for those regressive forces which have been responsible for so much of the severe horror and abuse at Montauk—not only abuses against human beings, but abuses of the power-point/interdimensional gateway, itself.

According to Bielek, the Montauk Project, per sewhich Moon and Nichols have written about and which my report covers—was primarily being operated from the future, and the project was (and still is) in support of the so-called "New World Order" objectives, using a veritable army of 5-10,000,000 intensively-programmed individuals in the U.S. alone. Bielek informed me that these negative agencies have numerous other locations in the U.S. and elsewhere worldwide, some very close to the Montauk base itself; in fact, some within a few miles (one directly north of the village of Montauk, beneath an old Navy submarine base on Fort Pond Bay). So, it's not as though they've packed up and gone home!

Bielek also told me that "positive" (for lack of a better word) Constitutionalist groups within the U.S. Air Force had been instrumental in rousting these creeps, to some extent—NOT that the Air Force is totally unified on this or related issues. It seems that most of the armed services are in a condition of schizophrenia on the whole issue—with some elements supporting the New World Order and some not. Bielek's information indicates that the Camp Hero underground (as opposed to other underground facilities in and near Montauk) was recently the site of a defensive operation utilizing particle-beam weaponry and other technologies, reportedly directed against malevolent ET intrusions. According to Al Bielek, this Air Force crew deflected the Hale-Bopp comet from a collision course with Earth, and the object "hiding" behind it was then destroyed (however, an escape pod did manage to bail out before destruction). The reason this object was targeted was that the Air Force called in over 130 remote viewers to get a reading on the trailing object and came up with 130+ different readings—indicating to them that the object was being heavily cloaked/screened and, therefore, its intentions had to be considered hostile. Time manipulations have been involved in some of this defensive activity, by Bielek's accounting, and the fact that the time portal has been shut perspective.

I subsequently contacted Preston Nichols to get his input on this. For the most part he did, in fact, corroborate Bielek's information—in fact, much of it came from Nichols. However, he can or will NOT say positively that there were no negative forces anywhere in the extensive Montauk underground during this period of time.

As best he could personally determine, through his active contacts with Air Force agencies recently at Camp Hero, there did not appear to be any EM, mind-control operations going on there at the time, but given the way projects can be hidden within other projects and the way compartmentalization works, secret agendas can be piggybacked onto "legitimate" operations, with no way for anyone involved in the above-board activities to even be aware of it. Nichols pointed out that his most recent investigations indicate that there are EM/RF mind-control transmissions still being picked up in the vicinity—by his estimation, emanating from Block Island, about 15 miles

directly east of Montauk Point—but not emanating directly out of Camp Hero.

He confirmed Bielek's statement that "anti-NWO" Air west of Montauk, in Sag Harbor, being operated by the Montauk Project's mind-control crew, in August of 1996 and turned up records on 30,000 programees (New World Order shock troops—mostly recent ones) at that base alone! Apparently, this caused (the Air Force) some consternation; in some respects, there is a serious, secret conflict or even a war underway, between two opposing factions within the (covert?) government.

Apparently, this "Montauk Boys" programming operation in Sag Harbor was operated with the assistance of a Catholic religious order known as the Pallotine groupa monastic order working with the secret government to help train an elite fighting group of children, along the lines of Delta Forces. There will be more on this aspect, later in this report.

#### MONTAUK—THE PROJECT THAT WOULDN'T DIE

The Montauk Project (especially the EM/RF, mindcontrol aspect) was reactivated—more like exhumed from the grave—in 1988, and a phase of the project was carried out at Camp Hero until around 1992. There are some indications that security had then become excessively problematical, as the first Montauk Project book by Nichols and Moon had been published, and curiosity seekers and others were becoming far too prevalent and nosy. There are other rumors of conflicts among different groups over the use of the facility and, in 1993, the Montauk Project moved out.

The Project was eventually reorganized at Robbins Air Force Base near Atlanta. However, after a period of time, it seems, Project directors realized that certain aspects of the Project just couldn't be implemented adequately other than at Camp Hero due, it would seem likely, to the geomagnetic characteristics of Montauk. Additionally, directorship of the Montauk Project appears to have shifted to the Navy at this time, as has occurred with HAARP. A linking of some elements of the Montauk Project to HAARP—previously, often suspected and which may have already existed—has now been proved to be underway at the Camp Hero location.

#### TROUBLED TIMES AT CAMP HERO

It would seem that there were some sort of contentious off does, in fact, have some drawbacks from this or adversarial activities at the Air Force Station beginning in late 1997. In mid-February 1998, in the immediate vicinity of Camp Hero State Park/Montauk Air Force Station, the following conditions were observed; consequently, clear proof now exists of a maintained, covert, subterranean facility operating at this location, a facility the very existence of which has been covered up for years—as it is currently by covert, federal, intelligence/ military groups, the NY State government and the NY State Parks System, along with other local and regional governments and relevant agencies.

> There is an old bunker southeast of the base proper, outside the "restricted area", which is relatively close to the lighthouse and right on the Atlantic cliffs, with a paved circular area directly in front of it, which was (at one time) an artillery emplacement. (This was the location where Siemens-subsidiary Cardion Corporation tested a very hightech, particle-beam, radar system for at least five months in 1994; all clearly visible from the lighthouse.)

The bunker entrance—adjacent to this circular,

concrete area was—recently demolished in an "unauthorized" and "unofficial" fashion, in an obviously substantial endeavor, according to certain witnesses from the Montauk area. A section of the thick concrete was completely broken through, exposing an underground area. This hole was, subsequently, cemented over again by certain

A contingent of people from Montauk were at this location, checking out the current situation there, after having witnessed the previous conditions just described.

Continuing along the remnants of Old Montauk Highway, west-through the locked "fisherman's gate", towards the "fisherman's (parking) lot", the first paved road on the right (heading roughly north)—leads to the southeast entrance to Camp Hero/Montauk AFS. About halfway to that entrance, along this road, on the left (west) side, is a large boulder, which had somehow been moved a bit, and clearly visible underneath was a well-maintained concrete well or entrance, with a metal ladder bolted to the side all in good repair. Despite extensive, drenching rains around this time, when a rock was dropped, there was NO SOUND of it hitting any water. The boulder hiding this entrance was quite large and would require at least a few people to move it.

Further on this road, at the base entrance, the extremely sturdy, locked gate at this entrance was severely impacted—smashed and basically wrecked—although entry with other than a tank would not really be possible. The same thing also happened to the main entrance to Montauk Air Force Station off Highway 27 (Montauk Highway), about 6 months ago, and to at least one other entrance, at the baseball field "leased" (by whom I haven't ascertained) to East Hampton Township for recreational use by the residents of the small neighborhood right nearby—the old base housing area.

#### SCHISM WITHIN THE NATIONAL GOVERNMENT

Certain of the underground facilities at Montauk AFS, as noted, were used by the Air Force, in what they considered to be legitimate, defensive operations related to Hale-Bopp comet and an object (said to be) following it. Preston Nichols, as noted, was working occasionally with the Air Force during this time on a sort of "consultant" basis. Nichols believes these operations were not in any way a part of the "Montauk Project".

At this time, as well (1996-1997), Nichols was openly working with an Air Force contingent, which had busted the "Montauk Project" mind-control operations in Sag Harbor, as described above. Apparently, the Air Force was either unaware of the mind-control operations at the WW II Navy base on Fort Pond Bay in Montauk, or else these activities started up (again?) more recently (since 1997).

Nichols has affirmed that he had not been in the Montauk underground since late spring of 1997, when the comet departed our skies. His suspicions—that the current tenants at Camp Hero/Montauk Air Force Station are Navy operatives, connected to the HAARP project-got some solid confirmation from a source who often receives reliable information from connections in certain ultra-top-secret intelligence and military agencies. This source has stated that the Navy/HAARP contingent has, without doubt, taken control of the Montauk underground installations, in a decidedly heavy-handed fashion; i.e., they were definitely not given the keys.

A linking of certain aspects of the Montauk Project with the global capabilities of HAARP, is high up on the agenda right now, as well as using the Montauk (Turtle Cove) power spot to boost other HAARP (Tesla technology)

operations and experiments.

#### **DOWN THE HATCH**

This would be a good place to pass along some information conveyed to me by Preston Nichols in March 1998. I asked Nichols if he was consciously aware of how one enters the underground facility at Montauk and, if so, whether or not he would tell me. He replied instantly, "Sure, I know. The main checkpoint entrance to the areas of the Montauk underground, which I and Air Force personnel I was working with used, is beneath the 'Montauk Tower' building, right in the middle of Montauk village!"

This was most interesting, because that building has had an unusual history and was the subject of some investigation on my part not long ago. The results of that investigation make up the latter section of Part Four of my my investigations on this particular building—purportedly at this time, privately-owned "residential condos"—turned up a substantial number of major anomalies, incongruities and obvious indications of outright BS, lies and misrepresentation on the part of numerous government/ bureaucratic officials at various regional and local levels, real estate agents, supposed occupants—you name it.

The roughly 9-story building was constructed in the 1920s—a peculiarity in its time and still the tallest building on Long Island's east end (that's not saying much, mind you). After failing to attract many tenants, it was appropriated during WW II by the U.S. Navy, which operated a submarine base with underwater "sub pens" about a mile north of the village on Fort Pond Bay, as well as at Camp Hero, and the "Montauk Tower" became a major command point.

Its history after WW II is notably obscure. I think it's safe to say that the structure was utilized by means of tunnels connecting it to Camp Hero at Montauk Point during the 1950s and 1960s, before the "Montauk Project", per se, got into gear and in certain forerunner projects being operated on Long Island, as well as during the Montauk Project, from roughly 1970-1983. And as we now know, even after its supposed conversion to privately-owned condominium residences, it is still, in fact, part of the secret operations in Montauk, NY.

One thing I asked about continually—when I was posing as a prospective buyer for certain units available (supposedly) for sale—was what was the basement of the building used for; how did one gain access to the basement, and such. Never once did I receive a straightforward, clear response to this line of inquiry from any supposed tenants or realtors. And guess where one gains access to the Montauk underground? Well, of course, not by way of the penthouse apartment, though that "apartment" was unquestionably an Air Force facility, staffed with Air Force personnel, at least up until mid-1997.

Nichols said that one enters an elevator, which goes to the basement; however, this is NOT the main elevator for the six floors of "condos", which has no button for a basement level (I know, because I was in it). After exiting in the basement, one walks to a small room off the main basement in which there is another elevator, which seems to go down quite deep. One exits into a small room with armed guards and is there subject to what Nichols called a retina scan: word is that this does more than just correlate patterns in the iris and such, but actually can scan thought and consciousness, as a way of making an absolutely foolproof identification. From there, one enters into the underground.

surrounding everything about this building and what it's supposed to be, I wasn't too surprised to hear this from Preston Nichols; nevertheless, there it is in black-and-white: eyewitness testimony about how one gains entry to the Montauk underground facilities.

Towards the completion of the "Sky Pebbles" operation with the Air Force, and prior to the U.S. Navy assuming control of the Montauk underground, Preston Nichols entered the underground by means of the entrance beneath the "Tower" building in the middle of the village of Montauk, in the company of an Air Force General. Nichols says this man had orders from the Pentagon, granting him access to the subterranean facility: he and Preston were authorized to snoop around, making sure that by all indications and evidence the operations being run there were the operations which had, in fact, been authorized.

A question arises, however, as to which levels or areas report on the Montauk Project. Suffice it to say here that of the underground the General and Nichols were given access to. Furthermore, the way compartmentalization works, certain groups could be involved in certain activities without any knowledge that their operations may be a small part of some much larger project, the overall scope of which they are not even remotely aware. Also, secret agendas can be piggybacked onto "legitimate" operations, with no way for anyone involved in the above-board activities to even be aware of it. Thus, at Montauk, for instance, there could be Air Force people working on something to do with particlebeam technology, with no knowledge that, for example, it's being used against ETs. Again, there may be personnel there who are unaware that their particular activities may, in some way, "plug into" HAARP operations; or if they do know that, they are completely ignorant of what some of the real objectives of HAARP actually are!

#### WHO'S ON WHOSE SIDE

Of particular interest, as well, in this account is the fact that some cadre within the Air Force dispatched this General to the Montauk underground to check up on what was going on there; in other words, to check up on what some other Air Force faction was doing or had done in the "Sky Pebbles" (Star Wars) particle-beam operations. This would tend to bolster reports of a massive, virtually acrossthe-board split within the many levels and layers of the federal government—both covert and overt—and certainly within the military and intelligence agencies, into at least two main factions: pro- and anti-New World Order. Undoubtedly, many further subdivisions and splinter factions exist within these two general camps.

#### NEARBY UNDERGROUND FACILITIES

In late 1996, I took a ride with Preston Nichols northeast of the village of East Hampton, and north of Amagansett, in the Devon, Stony Hill and Springs areas. In the woods west of Albert's Landing and Devon, we found what seemed clearly to be the remains of an old bunker; several are known to have existed in the general area. This particular location seemed as though it had been excavated, cleared and then "landscaped" a bit—perhaps 5 to 10 years previous to our visit.

These bunkers, which date back to before and during WW II, connected underground and underwater to Montauk, via tunnels beneath Gardiner's Bay. Noteworthy, also, is that there is said to have been a Nazi underwater submarine pen near Stony Hill, linked to an underground facility there. (Don't laugh: There is voluminous evidence of a great many instances of a highly peculiar and rather

Considering the high levels of obvious bullshit constant Nazi presence and a strong, Pro-Nazi element on Long Island, before, during and after WW II. Peter Moon has covered many facets of this entire, mind-blowing story in the Montauk Project book series co-authored with Preston Nichols, and I refer readers to this, as well as to the sources Moon cites for further details.) As it seems the bunkers and underground facilities were still intact during the 1970s, there is a strong likelihood these bunkers were somehow used in the Project—perhaps as a way to bring kids into the underground for programming. As at Camp Hero, there were recreational facilities quite nearby, often used by youth groups, day camps and boy/girl scouts.

> Later on this same trip, while driving through the surrounding woods. Nichols noticed and commented upon the numerous red standpipes protruding from flat cement slabs, all throughout this mostly undeveloped area. These seemed at first glance to be fire hydrants. There are some residences here, but the density is fairly sparse. It seemed a bit unusual to have so many hydrants in this kind of area, so we stopped and checked them out more closely.

> It seemed that a good percentage of those numerous standpipes were not, in fact, hydrants, because in most cases there was a smaller, straight pipe with a vented cap adjacent to the larger pipe, which looked like a hydrant. This immediately gives rise to the solid hypothesis that these larger pipes are not for getting water from but are, in fact, for pumping something, such as fuel, intounderground storage tanks, which would need to be vented. Some of these concrete slabs did not have this vent pipe. indicating that they were, in fact, the "real" fire hydrants in the area. The same kind of standpipes with accompanying vent stacks are seen along Old Montauk Highway, directly adjacent to Camp Hero.

> Following this train of thought along some very substantial and well-bedded tracks, there can't be too many reasons for numerous (fuel) storage tanks throughout this area; the private residences here use no common fuel tanks or anything like that. It stands to reason that such underground storage tanks are, in fact, for adjacent underground facilities, and the existence of bunkers in the general area, which were once linked to the Fort Pond Bay Navy base and Camp Hero, would lead one to think that this area still has such connections, and there is some kind of currently active underground here.

> Nichols also noticed on this trip the existence of triplephase electrical lines all throughout the area; this would be totally unnecessary in any residential or even light-industry area and would simply never be seen in such areas. Triplephase power lines are only for heavy industry or other activity in which major amounts of electrical power would be used. This does not fit at all with any of the visible, surface conditions and characteristics of this entire area of eastern Long Island. Shipbuilders or other known industries nearby would not use triple-phase power.

> My trip to the area in June and July of 1998 brought to light some other conditions regarding this general vicinity of East Hampton Township, in relation to apparent underground installations, which is discussed further along in the article.

> Changing locales a bit, there is some corroborative testimony regarding very substantial underground areas at Brookhaven National Laboratories, related by a building contractor from eastern Long Island. He told reporter Jerry Cimisi, from Dan's Papers on Long Island, that he has, on several occasions, done on-site construction work in the subterranean levels of BNL, and he stated in no uncertain terms that the underground areas at Brookhaven were vast—and that only refers to what he got to see!

#### HIDING BEHIND THE FIRST AMENDMENT

As summer slips into autumn, it must be time for the American Library Association's seasonal rite known as Banned Books Week

... What a crock it is that America is not being overrun by book-burners...you still can easily find the *Bible*, *Little* Red Riding Hood and other books that the Chicago-based ALA calls "banned" or "threatened"...Thanks to the ALA's zealotry, many American libraries still allow children access to violent, pornographic and offensive Web sites and other materials.

The ALA apparently doesn't take very seriously Hillary Rodham Clinton's dictum that child-raising takes a village. Or at least, in the ALA's village, there is no shared responsibility for raising children free of disturbing and damaging influences. The ALA labels as censorship any restrictions placed on materials that children "want or need", arguing that parents alone are responsible for monitoring their children's reading. At the same time, the ALA hypocritically refuses to let parents see their children's borrowing records...

... The ALA's Manual of Public Policy Positions supports the Equal Rights Amendment, nuclear freeze, gay rights, national health insurance and minors' access to sexual resources, in and out of the library. Children clicking on the ALA's Web site can find their way to the ALA's recommended reading list, which includes sexuallyexplicit advice that many parents find objectionable.

At the same time, it extends neither the same courtesy nor rights to those who disagree with its own interpretations of the First Amendment. Talk radio's Laura Schlessinger, who has campaigned against the ALA's position, finds herself on the nasty end of a campaign to censor her through her advertisers.

It falls short of the kind of positive response from citizens, parents, educators, trustees and library professionals concerned about how public library policies affect children and their families. Based in Fairfax County in northern Virginia, the group is offering a sensible alternative to Banned Books Week with its own Family Friend Books Week. It reminds everyone, especially the ALA, that included in the *First Amendment* is a guarantee that citizens have the right "to petition the government for redress of grievances"... It also should remind everyone that public libraries are exactly that—public bodies that are run by self-governing citizens...

...Karen Jo Gounaud, Family Friendly Libraries president, is not conducting a war against librarians... Librarians should be assisted in expanding collections to ensure that family-friendly materials are equally represented. (At the same time, Gounaud makes clear, she is not conducting a campaign to rid libraries of materials she does not agree with.)

But she also encourages parents to become involved in what are, after all, their libraries...They should work for parental access to their children's borrowing records, and should be alert to one-sided collection building and displays on controversial issues, such as Gay History month...

[JR: The ALA now seems to be an extension to the OBE (Outcome Based Education) educational system coming to your local school districts.]

#### MONSANTO PLAN TO CASH IN ON WORLD **WATER CRISIS**

MONSANTO, the genetically-modified-food giant, drew up plans to make billions of dollars out of the world's water crisis, confidential company documents reveal. The documents, seen by the Independent on Sunday, identify a 'vast economic opportunity" for the company in impending global shortages of resources such as water.

They outline a strategy to use "environmental issues" "deliver strong financial returns" and create "a compelling possible future for Monsanto—financially, strategically and aspirationally".

The revelation of the strategy—drawn up in connection with recently dropped plans to establish water businesses in India and Mexico—follows the publication 10 days ago of a report on the growing, global environmental crisis by the United Nations Environment Programme.

The GEO 2000 report identifies impending water shortage as the world's greatest environmental problem after global warming. It says that over one-third of the world's people already live in countries suffering "water stress" and that, on present trends, two-thirds will do so by the year 2025...

...The confidential Monsanto document—a "sustainable-development sector strategy" and a "water business plan" use the same statistics and take up the same theme. The business plan adds that two billion people worldwide "still lack reasonable access to safe water" and says that this is likely to rise to 2.5 billion over the next

The document, like much of Monsanto's material on genetically-modified foods, is written in idealistic language. It adds that there would be "other strategic benefits", including "reshaping Monsanto's image as a more sustainable and environmentally-positive company".

It goes on: "Population growth and economic development will apply increasing pressure on naturalresource markets. Those pressures, and the world's desire to prevent the consequences of those pressures if unabated, will create vast economic opportunity."

Yesterday, Dr. Vandana Shiva, director of the Research Foundation for Science, Technology and Ecology in New Delhi, India, said: "Monsanto is seeking a new business opportunity because of the emerging water crisis. Since water is as central to food production as seed, and without

water, life is not possible, Monsanto is now trying to and businesses to 25 percent. #### BIOTECH FOOD COMPANIES PLAN DEFENSE

Monsanto Inc., Du Pont Co., Novartis AG and other companies that produce genetically-modified foods, are gearing up to defend their products, as safety concerns gain momentum in the United States.

For these companies, which have staked their future on biotechnology, U.S. acceptance is crucial. Health concerns have led Europeans and the Japanese to spurn the technology, which inserts new genes into crops to make them more resistant to pests and weed killers.

The companies hope to stave off similar sentiments in the United States, where much of the food supply already contains genetically-modified ingredients. Half of the U.S. soybean acres and 38 percent of corn acres were planted with genetically-altered seeds this year. About 60 percent of packaged foods contain soy, a source of oil and protein, while corn, a source of starch, oil and sweeteners, is found in about 13 percent of foods.

"With all the static in the air, we need to make our own statement," said Ed Shonsey, President and CEO of Novartis Seeds Inc., a U.S. subsidiary of the Swiss drug and agriculture giant. We have to reassure (the public) and be activists somewhat ourselves.

About 40 religious, farm-owner, environmental and other activist groups in the United States, are participating in Genetic Engineering Action Network USA, which held a two-day retreat outside San Francisco in August. The groups plan a campaign questioning the environmental and health effects of gene-altered foods. They also intend to lobby Congress and state legislatures for stricter regulations on testing and labeling.

Separately, Greenpeace—which has crusaded against genetically-engineered food in Europe-started a U.S. ingredients in their products have been genetically

Du Pont spokeswoman Kathy Forte acknowledged that U.S. environmental groups are becoming more vocal in their opposition.

#### MYSTERY IN SPACE: GIANT FLASH OF ENERGY

WASHINGTON—Astronomers worldwide are tracking down a mysterious and unusual burst of energy that exploded like a flashbulb in the sky last week, lingered several hours and disappeared.

The sudden flash turned a star too dim to see—except with a good telescope—into one almost visible to the naked eye. But the outburst really wowed astronomers in invisible wavelengths—X-ray, gamma-ray and radio—where it flashed more than 120 times stronger than normal, to become briefly the brightest thing in the sky.

Messages flashed through cyberspace as astronomers campaign this year, is asking 50 food companies whether buzzed about something very peculiar going on. "It's become a kind of global detective story," said American University astronomer Richard Berendzen.

> On Sept. 15, as a storm approached in Australia, Rod Stubbings, an amateur astronomer, snatched a glance at a star that is known to flicker a bit in the southern constellation Sagittarius.

> "Wow! This is some outburst," Stubbings recalled via e-mail. "I closed up the observatory, ran inside and reported the outburst."

> Then the worldwide hunt started. Researchers scoured the spectrum from long-range radio waves to very shortwave X-rays and gamma-rays. Astronomers at the Massachusetts Institute of Technology diverted a NASA Xray telescope to take a look.

> "This one came screaming out of nowhere at us," said MIT researcher Donald Smith.

Smith enlisted the help of radio astronomers at observatories across the United States.

"Something really unusual is going on," said astronomer Bob Hjellming at the National Radio Astronomy Observatory in New Mexico. "It's gotten odder and odder as we've gotten pieces of data on it."

Gamma-ray astronomers started an independent

McDougall isn't new to controversy.

When rapper Ice-T released his 1992 song, "Cop Killer", McDougall tried to have him charged with sedition.

When an abortion provider asked McDougall for protection from protesters, McDougall said he would protect the doctor's free speech, as he would protect "a baby killer like yourself".

Howard Simon, executive director of the American Civil Liberties Union of Florida, called the sheriff's latest letter distressing and said McDougall needs to brush up on the protections afforded by U.S. law.

Surveillance devices now in the hands of government

and corporate officials include: heat-sensing imaging devices that can tell if a house is occupied, voice amplifiers, light-amplifying/night-vision devices and techniques for reading mail without breaking the seal...

...The Olivetti Corporation is now marketing its "active badge" to employers—a tiny device employees would affix to their clothes, emitting an infrared pulse every 15 seconds. The pulse is picked up by sensors throughout the workplace and processed through a central computer, allowing managers to ascertain the precise whereabouts of any employee at any time.

On any given day more than 4,000 phone calls are legally tapped by authorities. No one can be sure, but illegal telephone eavesdropping by corporations and other private bodies may exceed that number by a factor of 10.

The National Security Agency, tape records every international phone call placed in to or out of the United States. Technically, monitoring domestic phone calls is against the law, but the NSA monitors all microwave transmissions, which is legal—and a huge number of long-distance phone calls are now beamed by microwave transmission.

There is no law protecting the privacy of non-voice transmissions. Fax-interception equipment retails for \$20,000 or less, well within the budgets of most corporations...

...Within the workplace, e-mail is completely devoid of legal safeguards. Your messages are company property.

In April 1995, Great Britain opened up the world's first DNA database. By the end of the century, 5 million Brits are supposed to have their genetic codes in the Home-Office master computer. Under the current law, only convicted criminals get a DNA database listing...

...A recent survey by *Macworld* magazine found that 22 percent of CEOs and other top managers acknowledged snooping around in their employees' e-mail, voice mail and computer files...

...Electronic workplace surveillance has become so commonplace that many networking software packages have worker-monitoring features—such as keystroke monitoring—built in...

...The United States has the world's most extensive system of computer databases of personal information on citizens. The information is collected for purposes ranging from monitoring criminals, to credit reporting, to demographic research for product marketers and everything in between. The types of personal information collected on millions of Americans and stored in databases includes the basics, like names and addresses, as well as more intimate information, such as medical records, psychological profiles, drinking habits and political affiliations.

Some of the largest collectors of such data are creditreporting agencies—private bureaus that advise prospective lenders on customers' creditworthiness. Even under the Fair Credit Reporting Act of 1970— ostensibly designed to protect the privacy of people who want to borrow money (a group which includes almost every American these days) individuals have no right or means to find out where their files are kept unless their credit is denied, nor does the subject of a credit report have any right to see the actual report, even though it contains extremely personal financial information. The law, however, places no real limit on who else can gain access to credit files...

...The State of California keeps records on more people in its criminal information system than there are people in California.

In 1989, it was revealed that the FBI ran a "library surveillance program", attempting to ascertain the political bent of library users by monitoring the books they check

out. When some librarians blew the whistle on the program, the FBI investigated them.

In 1990, the Internal Revenue Service seized people's personal property in 125% more cases than a decade earlier, even though delinquent tax cases were up just 32%. Under the inaptly named "Taxpayer Bill of Rights", the IRS is allowed to seize all but \$1,650 worth of your personal property. There is only one body that handles appeals in such cases—the IRS itself.

As mandatory drug-testing grips the world of corporate and government employment, methods to fool the standard urine-test detection method have become well known. To combat this trend, some companies have turned to the more reliable method of hair testing. Hair maintains a permanent and unalterable record of all drugs an individual ingests...

...A person's history of drug indulgence is therefore as easy to read as his or her hair is long. But head hair is far from the only source for that information. Body hair and fingernails also do the trick...

...With such methods for identifying people as blood typing, semen analysis and fingerprinting apparently not reliable enough, law-enforcement agencies are turning to analysis of DNA, an individual's genetic code, to make identifications.

Between 1978 and 1984, the FBI and other federal agencies tripled the amount of private mail they opened and read or inspected for "national security" reasons. Between 1980 and 1984 the government doubled its requests for electronic surveillance. Federal agencies must apply to the Foreign Intelligence Surveillance Court before placing a subject under electronic surveillance, but the court had never denied a request as of the end of the Reagan administration.

The U.S. Customs Service plans a computer system that would classify incoming airline passengers as "high risk" or "low risk" based on information supplied by airlines...

#### NYC SEARCHES ABUSER MEDICAL RECORDS

NEW YORK (AP)—City officials plan to start searching welfare recipients' medical records for evidence of drug use in an effort to funnel abusers into treatment programs, *The New York Times* reported today.

For such abusers, the treatment program would be a mandatory condition for receiving public assistance.

Officials say checks are needed, because the city's current drug-screening system is finding unrealistically low substance-abuse rates.

But Paul N. Samuels, director of the nonprofit advocacy group, Legal Action Center, said the search would be an invasion of privacy, "that will upset just about everybody".

"Violating confidentiality is an ambush that will drive many people away from treatment," he said.

Jason A. Turner, commissioner of the city's Human Resources Administration, said information would be collected from computerized Medicaid insurance bills submitted for applicants who have voluntarily sought substance-abuse treatment.

"These are our own records," Turner said. "We are not interfering with the doctor-patient relationship. We're helping poor people."

No date has been set to begin the review.

With few exceptions, a federal law passed in the 1970s bars the disclosure of information on patients in drug and alcohol treatment programs without the patient's narrowly-defined written consent. That consent does not allow redisclosure for any other purpose.

Christopher H. Peacock, spokesman for the Federal Health Care Financing Administration, which oversees Medicaid records, said he had not received official notification of the plan.

"But there are confidentiality provisions in New York's Medicaid plan, and we expect them to be followed," he said

#### CIA SETS UP VENTURE-CAPITAL FIRM TO INVEST IN INTERNET-AGE TECHNOLOGIES

WASHINGTON (AP)—The CIA, not wanting to be left behind in the Internet age or be outsmarted by techsavvy adversaries, is teaming up with Silicon Valley entrepreneurs to invest in companies developing computer technologies that could assist in intelligence gathering.

Foregoing its usual clandestine ways, the agency has set up its own venture-capital firm with money appropriated by Congress with offices in Washington and Palo Alto, Calif. It will invest in promising new start-up/hi-tech companies.

The CIA picked a fanciful name for the new company: In-Q-It. The "In" stands for intelligence. The "It" stands for information technology. And the Q? That's the code name of the James Bond character who comes up with all the gadgets that the fictional British spy uses.

"We do have a sense of humor," Central Intelligence Agency spokesman Bill Harlow said today, confirming the existence of the new company.

Harlow said the venture-capital company "is clearly tied to us, but they make a big point of being independent."

The venture, first reported by *The Washington Post* and *The New York Times* in today's editions, was actually set up last February as a nonprofit organization.

He said he has no experience in espionage "and I want to keep it that way".

The company's board of directors includes John Seely Brown, Director of the Xerox Corporation's Palo Alto Research Center; Norm Augustine, Chairman of Lockheed Martin; William Perry, the former Defense Secretary; and Jeong Kim of Lucent.

#### CELL TOWER PROPOSED IN CHURCH CROSS

ALEXANDRIA, Va. (AP)— A financially struggling church is considering a deal with Ma Bell: Allow AT&T to build a 130-foot-tall cross with a cellular-phone tower concealed inside, and First Christian Church will get \$18,000 a year.

"This could be a godsend, from our perspective," said the Rev. Tim Mabbott, the church pastor.

The money would represent almost 10 percent of the church's annual budget and help put the church back on solid footing.

But for the church's neighbors, the proposed cross is a troubling sign of things to come.

"We do not have anything against the church," said Michael Cassidy, who lives directly behind First Christian. "The church has been wonderful to this neighborhood. We believe in the church, but we don't believe in the encroachment of AT&T in a residential neighborhood."

AT&T usually places cell-phone equipment on existing buildings, but about 15 percent of the time that isn't possible, said Alexa E. Graf, a company spokeswoman.

The company initially approached Alexandria's First Baptist Church, she said, but the Baptists were not interested in hiding the equipment in their steeple.

"We are debating what we are going to do," Ms. Graf said. "If the community opposition stays as strong as it is right now, we are going to have to rethink our other options."

That is not what Mabbott wants to hear.

Three years ago, First Christian was on the verge of closing its doors. The church was running an annual deficit and the aging congregation considered selling its land to a neighboring retirement home.

"This is a very valuable piece of property, and there was some talk of selling it to raise money and moving out to an area with more young children and families," Mabbott said. "But we decided to give it another try."

#### TOWER COLLISIONS KILLING MILLIONS OF BIRDS

Bad weather, radio signals and lights on communications towers are spelling death for millions of birds across the United States. Bird scientists gathering at Cornell University last month for the annual American Ornithologists' Union meeting looked ahead to fall migration time with dread.

Although birds have been hitting structures in North America for at least 100 years, there are now more tall towers than ever before—especially for cellular phone and digital television transmission—with even more on the drawing boards. "The more towers, the more dead birds," said Bill Evans, a consulting ornithologist for the Cornell Laboratory of Ornithology who helped organize the first scientific session of its kind, "Avian Mortality at Communications Towers".

"Many of these species face degraded habitats at both ends of their migration flights and the thousands of towers are a new threat along the way," said Evans, citing estimates of bird collisions with manmade objects at four million per year. Albert Manville, a biologist from the U.S. Fish and Wildlife Service (FWS) Office of Migratory Bird Management in Arlington, Virginia said that television stations converting to the digital format in the United States plan to erect more than 1,000 "megatowers", each at least 1,000 feet tall. The FWS biologist said that friends of birds can expect more catastrophes such as the January 22, 1998 incident, when an estimated 10,000 Lapland Longspurs died one foggy, snowy night in western Kansas. The television tower that killed the neotropical migrants was "only" 420 feet high.

#### CARDINAL AND ACTIVISTS TAKE SIDES OVER **VIRGIN MARY WITH ELEPHANT DUNG**

NEW YORK (AP)—Cardinal John O'Connor on Sunday asked Catholics to join him in condemning a painting of the Virgin Mary embellished with a clump of elephant dung, while civil rights activists defended the Brooklyn Museum of Art's right to show the piece.

Mayor Rudolph Giuliani, meanwhile, reiterated his pledge to cut all \$7 million of city funding to the museum, one-third of its budget, unless the painting is pulled from an exhibit scheduled to open Friday.

"I'm saddened by what appears to be an attack not only For longtime church-member Betty Pratt, the debate on our blessed mother...but one must ask if it is not an attack on religion, itself, and in a special way on the Catholic Church," said O'Connor in his weekly sermon at St. Patrick's Cathedral.

> O'Connor did not name the mayor, but said he was "grateful to city officials", adding: "It is their right, if not their duty, to express themselves on such matters"...

...But New York Civil Liberties Union Director [JR: It may provide a healthy financial environment but Norman Siegel said the Mayor's threat to cut the funding "violates the First Amendment. His assertion that New York City can withdraw all funds for the museum, based on

a single exhibition that he finds offensive, illustrates a serious misunderstanding of the Constitution."

Siegel, who discussed the controversy Sunday as a speaker at St. Mary's Episcopal Church in Harlem, later said by phone that government funding may not legally be withdrawn because public officials dislike particular works.

"You don't have an obligation to provide funding to the arts but once you do, you can't de-fund a museum solely because public officials are displeased with the expression of the art," he said...

...Giuliani, meanwhile, defended his funding threat at a news conference at a new riverfront park in the West Village.

"There is nothing in the *First Amendment* that supports horrible and disgusting projects," Giuliani said. "If you're going to use taxpayers' dollars, you have to be sensitive to the feelings of the public."

... The painting, "The Holy Virgin Mary," depicts Mary with dark skin, African features and flowing robes. It features a shellacked clump of elephant dung and two dozen cutouts of buttocks from pornographic magazines.

The artist, Chris Ofili, 30, a Black Catholic who was born in England and lives there, has said he used the pornographic images because classical images of Mary are often sexually charged.

He also told Salon magazine in February: "Elephant dung in itself is quite a beautiful object"...

...Ofili began using elephant dung during a six-week stay in Zimbabwe. He is now famous for using the material, which he gets from the London Zoo, in virtually all his artwork. In 1998, he won Britain's prestigious Turner Prize, a \$33,000 award for artists under 50.

#### **INVASIVE MITES THREATEN** U.S. HONEYBEES, BEEKEEPERS

SALOME, Ariz. (AP)—...In a dirt lot alongside a field of alfalfa seed plants, hundreds of pine containers are stacked on pallets. Inside, 800 colonies of honeybees are resting after a hard season in the fields. They pollinated almonds and cherries in California, cantaloupe and watermelons in Arizona.

Back in the McMullen Valley, 10,000 acres of farmland 100 miles northwest of Phoenix, they're gearing up for another round of work come fall. More melons await, along with cotton and alfalfa.

Clad in jeans and a T-shirt labeled Bee World Inc., Ken Orletsky inspects his lot, prying open boxes and pulling out screens laden with thousands of bees. There are four colonies per pallet, each colony swarming with as many as 40,000 bees...

...Over the past two decades, 90 percent of the nation's wild honeybees have been wiped out by two mites that arrived in the United States in the 1980s, transported by insect and man. Managed colonies owned by beekeepers such as Orletsky have dwindled from 5 million to 2.4 million, while the number of U.S. beekeepers has fallen from 212,000 to about 125,000.

The culprits are the tracheal and varroa mites. First detected in Great Britain in 1921, the tracheal mite clogs a bee's breathing tube. The varroa, native to Asia, feeds on the blood of developing bees, which emerge from the hive with deformed wings or missing legs.

Together, these alien creatures are destroying U.S.

honeybees, themselves a non-native species first brought to coast to perfect a tidal-wave bomb believed to be potentially America in the 1500s by Catholic orders that used them for winemaking and wax.

Today, honeybees account for much of the food in the nation's supermarkets. Besides producing an average 210million pounds of honey each year, they pollinate just about all the fruit, nut and seed crops: everything from apples, cherries, cantaloupes, watermelons, blueberries and strawberries to almonds, cashews and alfalfa seed, which feeds cattle and poultry.

"Many people do not realize that without the honeybees, their diet would be reduced to a few grain crops, potatoes and rice and a nut crop or two," says Eric are contained in 53-year-old documents released by the New Erickson, director of the US Department of Agriculture's Carl Hayden Bee Research Center in Tucson.

In the late 1980s, when the tracheal mite migrated to Arizona, Orletsky began treating his colonies with pesticides. He's never stopped, and spends at least \$12,000 annually on mite medication.

"We can't work without them," Nicolosi says.

honeybees has coincided with the arrival of Africanized bees in the United States. These intruders are resistant to the deadly mites. So as the bee population recovers, it is a hybrid mix that tends to be more Africanized than European, researchers say.

Africanized bees pollinate just as well as European bees, but beekeepers don't want them because they're more aggressive.

Researchers are trying to develop additional techniques to fight the mites, including the use of essential oils and breeding mite-resistant bees. An African beetle that first appeared in the United States last year is threatening bees along the East Coast.

"Between man-assisted methods and wind currents, these creatures can go virtually anywhere," Erickson says. "People traveling from west-to-east in automobiles, trains and planes—all those conveniences provide an opportunity for creatures to hitch a ride."

#### NEW ZEALAND TIDAL-BOMB EXPERIMENT **COULD HAVE MATCHED ATOM BOMB**

WELLINGTON, September 25 (AFP)—Top-secret wartime experiments were conducted off the New Zealand

as effective as the atom bomb, a report said Saturday citing declassified files.

Auckland University professor Thomas Leech set off a series of underwater explosions triggering mini-tidal waves at Whangaparaoa, just north of Auckland, in 1944 and 1945, the New Zealand Herald reported.

His work was considered so significant that United States defense chiefs said if the project had been completed before the end of the war, it could have played a role as effective as that of the atom bomb.

Details of the tsunami bomb, known as Project Seal, Zealand Ministry of Foreign Affairs and Trade. Papers stamped "top secret" show the United States and British military were eager for Seal to be developed in the post-war years too...

#### **PRION DISEASES** SPREADING THROUGH GRAINS?

SANDPOINT, ID—Though mad cow disease may have spread to English cattle that ate sheep brains, the infectious crystalline agent associated with the disorder, called a prion, did not likely originate there. A new theory on such Transmissible Spongiform Encephalopathies (TSEs) provides a sobering likelihood that the sheep likely became initially contaminated by eating fungal-infected grains.

Indeed, a growing body of scientific evidence shows that yeast, or fungi, may carry the resilient, infectious prion responsible for Creutzfeldt-Jakob disease (CJD) in humans, scrapie in sheep, mad cow disease in cows and several other transmissible brain disorders affecting other species of wild animals.

This new prion theory, according to Harvard graduate and internationally-known public-health authority Dr. Leonard G. Horowitz and his colleague, principle investigator Dr. Joseph E. Barber, forecasts that these

deadly TSEs foreshadow a biological apocalypse that will make "AIDS seem like an appetizer at a cataclysmic picnic".

According to their new 511-page text, Healing Codes for the Biological Apocalypse (Tetrahedron Press. 1999), Dr. Barber, a naturopathic physician, was intuitively guided to research prions while treating patients suffering from fungal infections.

Accessing to the scientific literature, he happened upon a report in *Cell* by researchers at the Howard Hughes Medical Institute at the University of Chicago. They reported that a prion-like protein found in yeast, a fungus, was able to transmit apoptosis (programmed cell death), through crystal growth, without depending on DNA or

This, they reported, occurred "much like" what was observed in the brains of mad cow diseased cattle and humans with CJD. Though the article reassured consumers not to worry about prions in bread and beer, Dr. Susan Lindquist, one of the Institute's team leaders, said that these particles relayed genetic inheritance through a mechanism associated with several devastating neuro-degenerative diseases, including Alzheimer's.

Upon further research by Dr. Horowitz, the authors concluded that consumers of yeast, or fungal-infected grains, may not be free of prion risks. Prions, the authors wrote, "are able to pass toxicity and inheritable messages from one generation of fungus to the next." And since these crystalline structures effectively resist chemical control, and even extreme heat, they can be passed through even processed foods—as was the case in the British outbreak of CJD in beefeaters. These diseases, "mad cow", scrapie, and CJD are equally, then, if not more likely, transmitted by the prion crystal pathogens identified in contaminated fungi and their primary host—grains.

Lending support for this theory, a widely-publicized case of CJD in Britain occurred in a young woman, Claire Tomkins, who was a longtime, steadfast vegetarian.

Compounding their evidence is a complaint filed with the Food and Drug Administration (FDA) by the Consumers Union (CU). The 1997 petition alerted officials regarding the likelihood that prion diseases were being transmitted by unregulated swine wastes and pork products. The CU reported that at least two epidemiologic studies in the scientific literature had addressed the issue of dietary risk factors for CJD.

Both found links to pork. Other species at risk for prion infections, according to the CU, included chickens and mink as well as other animals that may eat swine-waste contaminants that commonly spill into rivers and streams or spread through fertilizers to open fields, thus infecting grains and grazing animals.

According to U.S. Government health officials, CJD is virtually nonexistent in North America, though wild animals are increasingly developing TSEs. According to University of Pittsburgh researchers, however, 5.5 percent of Alzheimer's patients may have been misdiagnosed. A similar CJD study at Yale found more than twice that amount. Even at that small percentage rate, the authors concluded, with more than 2,000,000 Alzheimer's cases in the United States today, there is likely a hidden CJD epidemic of approximately 200,000 cases.

"Unless health officials from around the world heed this warning, scrutinize these facts, and take preventive precautions," Dr. Horowitz concluded, populations may fall victim to a biological apocalypse unprecedented in Earth's


