PENTAGON STUDY FINDS CHINA PREPARING FOR WAR WITH U.S.

Strategic writings by China's military and party leaders show

Chinese writings by 200 authors reveal China's strategy to defeat a superior foe, using both military and nonmilitary means, such as propaganda, deception and covert action.

They also reveal the extreme distrust of the United States by China's military and party leaders. Chinese generals state that the United States intentionally bombed the Chinese Embassy in Belgrade, Yugoslavia last May as part of a long-term strategy to prompt an arms race that will cause China's collapse.

The Chinese statements from the mid-1990s through last year discuss issues normally couched in secrecy inside China.

They appear in the book China Debates the Future Security Environment, published last month for the Pentagon's Office of Net Assessment, the unit in charge of long-range planning. The translations were edited by Michael Pillsbury, a defense policy planner in the Reagan Administration who is fluent in Chinese.

Beijing government that China poses no threat to the United States or other nations.

Chinese strategists plan to use a combination of Marxist-Leninist doctrine and ancient Chinese tactics against the United States, which is compared in Chinese military writings as a "hegemon" on a par with Nazi Germany.

Gen. Li Jijun, described as one of China's most distinguished military authors, states that the United States engineered the collapse of the Soviet Union and the Iraqi invasion of Kuwait as a "strategic misdirection" or deception.

Other Chinese authors state the United States is working covertly to "dismember" western China, namely Tibet and Xinjiang.

The report is a public document, but the Pentagon is limiting its distribution, presumably because of its stark disclosures of Chinese military thinking. According to the book, the late Chinese leader Deng Xiaoping set the current military strategy for dealing with the world's only superpower in the slogan "bide our time and build up our capabilities". A key debate among Chinese military and party writers is how rapidly the United States will decline, a view based on the Marxist ideas on the collapse of capitalism.

Deputy Chief of Staff for Intelligence, who finished three days of Pentagon meetings last week, as one of China's hard-line theorists. "Any efforts for seeking hegemony and world domination can only result in accumulating contradictions and fermenting war," Gen. Xiong was quoted as saying in a speech at Harvard University. Chinese plans also discuss means of taking out U.S. aircraft-carrier battle groups. Chinese writer Ying Nan says the groups have numerous vulnerabilities.

The United States sent two such groups to waters near Taiwan in 1996 in response to Chinese military exercises aimed at the island.

Mr. Ying stated that weaker Chinese forces could defeat the huge carriers because the groups are hard to conceal from radar, are less effective in bad weather and are hampered by shallow water or when operating close to the coast.

Carriers also are vulnerable to repeated attacks with precision weapons fired from unmanned aircraft and to electronic warfare from small ships, offshore islands and aerial balloons that can "create confusion in the electromagnetic environment," he stated. Carrier battle groups also can be defeated by advanced submarines and by attacks on their support ships because the carriers' anti-submarine capabilities are "relatively poor," Mr. Ying states. Mr. Ying also cited the carriers' elevators, catapult launchers and arrester wires as "extremely vulnerable" to precision strikes that would make the ships useless.

Chinese military strategists also draw upon the 1991 Persian Gulf War. Chinese tactics—pre-emptive attacks before allied forces had massed covert attacks inside Saudi Arabia and operations to split the U.S.-led coalition—could have won for Iraq, they wrote.

China now seeks to avoid head-on confrontation until around 2030, when the Chinese expect U.S. power to decline significantly.

However, a war between China and the United States could erupt over Taiwan, according to the

CHINA ARMY TELLS U.S. "WE'RE NO YUGOSLAVIA"

BEIJING—The mouthpiece of the People's Liberation Army, furious over U.S. legislation to boost military ties with Taiwan, warned the United States Friday not to mistake China for Yugoslavia.

"China is not Yugoslavia. And Taiwan is not Kosovo," the Liberation Army Daily said in a commentary, referring to the U.S.-led NATO bombing of Yugoslavia last year over atrocities against ethnic Albanians in the southern province of Kosovo.

The House of Representatives voted 341-70 Tuesday in favor of the Taiwan Security Enhancement Act, which would establish direct military communications between Washington and Taipei and expand U.S. training of Taiwan military officers.

Wednesday, the Chinese Foreign Ministry summoned U.S. Ambassador Joseph Prueher to protest against the act and demanded the United States curb the sale of advanced weapons to Taiwan.

NO COMPROMISES

The newspaper commentary said China would make good its threat to invade if Taiwan, which Beijing considers a breakaway province, declared independence.

"The Chinese government has never compromised in the least on this kind of major issue of principle," it

"At this occasion of reunion for millions of families, we miss our Taiwan compatriots more than ever," he said.

"We will continue to work to develop the cross-Straits relations and promote the peaceful reunification of the motherland," he said.

President Clinton, anxious not to upset the delicate balance between China and Taiwan, has threatened to veto the act if the Senate also votes in favor.

Taiwan's Nationalist rulers, who fled into exile after losing a civil war to the Communists on the mainland in 1949, have many friends in Congress. The United States has been the main arms supplier of wealthy and democratic Taiwan.

In Washington, Liu Xiaoming, Deputy Chief of Mission at the Chinese Embassy, said Thursday the legislation would increase the chances of war between Taiwan and the mainland, possibly dragging in the United States.

It would also encourage separatism on Taiwan, Liu said.

George Tenet, Director of the Central Intelligence Agency, told a Senate hearing Wednesday he saw "a high potential for yet another military flare-up across the Taiwan Strait this year" with the Taiwan presidential election on March 18 a potential catalyst for tensions.

China menaced Taiwan with war games in the runup to the island's first direct presidential elections in 1996, prompting the United States to send two aircraft carriers to the Taiwan Strait, a narrow strip of water separating the rivals.

EXTREME DANGER

The Liberation Army Daily splashed pictures of China flexing its military muscle—successful tests of China's first atomic bomb in 1964 and a submarinelaunched missile in 1988—alongside the commentary.

The newspaper commentary said the legislation was an "extremely dangerous signal".

"It exposes the ambitions of some forces in the United States to try to block China's reunification," the commentary said. "This is, no doubt, playing with

"Not only will it not guarantee Taiwan's 'security', on the contrary, it will aggravate tension between the two sides of the Taiwan Strait," it said.

"It will also have a serious, negative impact on China-U.S. relations," the commentary added.

once a week I write personally. I've tried to do that anyway, in the past, to accommodate some kind of mental triggers for allowing us to remember WHEN things might have happened and, basically, even in our own little system, who might have been involved. Ron C. said it well: In these circumstances it is hard to remember if something happened this morning or a year ago. Plus the fact there are so many things taking place but the basic routine of living is so much the same as to have nothing save the decorations across the street for recognition of an approximate date to affix to anything and NOTHING to do much to have any day vs. another stand out from the others. Even that happening seems to have no attachment to a date, place (because it will be here), and only the "who" needs particular recall.

This needs to be done as a sort of diary but. moreover, there needs to be reference as to "legal" matters to which I may well only make reference. However, PLEASE, when we write these long dissertations or rebuttals to ones like Emil of Four Winds, or the Bopsie Kids, please MAKE SURE BRAD GETS FULL COVERAGE. I suggest someone ask Brad, if he doesn't receive everything, if he would like to, simply for the record. Then came the "underground" rumors that he was somehow "in trouble". We concerned over that all week but went right on with business while literally running into MORE INTRIGUE. We got a "supposedly" direct personal response from Mr. Buenaventura of Central Bank fame. Mr. A. is the second party working through the SEC screw-up. However, the first party, Mr. DG, did in fact "retire" from the follow-up ABRUPTLY and left town on business. So interesting things DO TAKE PLACE.

We can only be grateful for the oversight of our "Director", for that political (lobbying, educational) nonsense in our new Association-which would include E.J. and Doris—would have been difficult to harmonize with our Public Notice agreements. So, we have to request our application be returned. (who as agent, signed them and entered them into the State records). We NOW set up all our corporations using those articles.

Well, back to the Mr. B. letter: This paper looked far less authentic than the other, so we are advising Mr. B. that we are WITHDRAWING our application, for we don't need the headache of another business entity and certainly not at this time. Our suspicions are that NEITHER communiqué is authentic. This all works very well for us, for our G.A.I.A. articles and bylaws give us full functioning capability ANYWHERE and we can meet regulations when there IS BUSINESS to merit the bother. This new Board of Directors "THING" had me already at the end of my rope and I was turning in my resignation BEFORE THE THING EVEN GOT DONE.

Well, the "second" person, Mr. A., called last evening and he is not only, apparently, not "in trouble" but is meeting this week with the SEC, etc., to move to finalize the acquisition of a bank, which we will call "Security Bank"—which IS in trouble of loss because of too-low reserves, etc. This one move would allow for so many steps forward as to be stunning. That one step achieved will allow the very acquisition of the Islamic Bank. These "people" have the collateral to back everything and it seems if the paperwork can be accomplished, it is the most relevant step made to date. Oh, and that S. Bank is partially owned by one of the most powerful people in the Philippines, who ADVISES President J. Estrada. Small world?

So what of Ms. J? Well, they seem to have gotten their own business affairs caught up into some kind of a tidy bundle and are off on pushing bankers, especially for release of our loan. Things bog the instant the light goes off focus for ANY reason. We are told everything is in place and approved but the banks simply don't release anything. A zillion people can attest to this trickery. We have requested that a harder focus be placed on completion of that project and then we can all better participate in getting other things and projects under way. So, with that in mind, "Mr. Man" was returned to his "live-in" care facility for a medical rest and Ms. J. immediately left to attend some straggles elsewhere. All assets of Mr. Man have—according to the finished documents we have seen—been lawfully and legally put into the corporation with Ms. J. as President. And, by the way, with whom "Global" has a separate "joint venture agreement" or "contractual and working partnership" on bunches of the larger possibilities. Simple "people" projects are in the names of the corporate association and corporations (actually, all of them must be in the name of CORPORATE structures) which will actually do the projects, and that is NOT in connection with agreements other than "regular agreements" with Ms. J.

Since that is only a facet of our attention or participations, we don't need to spend more time on that. We have now, since restructuring of our own GAIA "caretaking", over 1100 fully documented, signed and sealed "assignments" with recipient project corporation recognition, signed by the authority involved and

witnessed by "their" person—so that E.J. can not only talk to the people, giving personal reminders about attending to the strict agreements and guidelines (or their participation is cancelled), but also simply sit and get a bit acquainted PRIOR to doing business interchange. Time consuming? Like totally, but we must learn along the way.

in itself has been THE TRAINING GROUND and those ones have about played out their "time" limitations.

We have no longer any recognition of anything prior to GAIA but—as parties come up for discussion—we will review all instruments and certainly all agreements. This, however, negates any interference or co-arrangements with such as V.K.D. and HEI as to those first headache documents with her. We have no call on any such interchange—PERIOD. What she may have done with those documents, her "false at the time" trust, etc., is none of our business. It would be our wish that she could be totally successful in all her efforts for the U.S. and for herself. We are not here to JUDGE anyone or how they came to be with anything, if it does not involve us.

Russell Herman had done his work and actually did it quite well without any further follow-up—except to dig out the legal documents and directives. This is WHY we can work with anyone on the globe, including those we would otherwise choose to ignore or wish to go away. WE KNEW GOD WOULD HAVE PERFECTION OF OPPORTUNITY and we do NOT have to attend any others' agenda. IF WE DO OURS AND DO IT WELL, WE HAVE ALL WE NEED FOR ANYTHING WE NEED.

Please, all who will receive this from us, leave personal reactions out of it. We have to share where we can. We do NOT enjoy the negative "lessons" any better than ANYONE, but we can't get bent out of shape at being used as an example.

For instance, as I write here right now, Ms. J. called and reported that she had been deeply involved in pushing on some items about which she and E.J. had had focused conference. And, since she returned to the Manila area a day early, it is assumed she may well have made progress of some kind. We do not discuss these sorts of PERSONAL things on the phones.

Our wonderful friend "Shariah Professor" is due in this week. He has been conducting group meetings to get "his" people up and informed so that they will be ready to respond instantly with projects and literal "construction" start-up, as we get our "papers" and the "go-ahead" financing worked out a bit more clearly.

By the way, for "just sharing", I want to give appreciation where and when due, and I don't intend to go my lifetime having to ignore the wonderful gifts and sharing with our friends before they declared themselves our enemies. I don't consider them "enemies" now; I consider them far worse, but less personal things than "enemies". That aside, some of you will remember the WONDERFUL Egyptian art piece (picture) Rick got for us a couple of years ago. It was worked on papyrus fiber and was truly special and unique. That being perhaps more unique to us than otherwise being such a special artform. Well, the beautiful addition to that picture is that Mrs. Professor went "home" to Egypt and spent months there visiting and came back only as Ramadan began. She, as a gift, brought TWO of that same type of Egyptian "pictures", which will make an incredible wall focus along with "Rick's" picture.

These are gifts from the heart, and YES, I DO believe that Rick's came directly from his heart. Rick has incredible talents—and what I feel for Rick is sadness but recognition of HIS RIGHT TO DO THAT WHICH HE WILL. I finally realize what this old "love" topic is about. Just as with my own children, there is right of them to do that which they will, whether or not I like or dislike it—it does not cause me to love HAVE RIGHTS, LEGALLY, TO PURSUE THOSE

them less or lose respect for that which was between or among us. I do not know what contracts are made with God to allow us these lessons and ENSURE SUCCESS IN SUCH A MAJOR ENDEAVOR AS WE ATTEMPT TO CREATE HERE INTO WHOLE-CLOTH PRESENTATION. WITHOUT RICK (AND YES, CHARLES) WE COULD The ones early on who lied and used false NOT HAVE DONE IT AS WISELY OR AS GENEROUSLY. We were structured in the wrong direction of movement and flow and something had to cause the course correction. Consequences of actions, however, are not my prerogative to dismiss. That does not mean that I can't totally enjoy and appreciate the feelings of "that moment" of giving and sharing in an Egyptian drawing for a wall.

> I think back to having all this work with the gold, etc. and as we "went along", a party came to Tehachapi and among other things with the PI she personally gave "Doris" several gold coins AS A TOTAL GIFT. Doris, however, never felt good about it and couldn't dump it into the pot, as all other things were offered—for the lady was right there. Well, when the anger flowed back, Doris saw to it that every single gift and the gold were returned—personally delivered TO HER. I should not have done that, for the GIFT was given, I suppose, in full love and in an effort to share something on a personal level. One thing should not be considered another. However, I am still functioning in my "better part of wisdom" to have done exactly that, for today we actually find that that person has "seen the light" (as she put it) but it was basically that the final realization was that "THE GOLD WAS RETURNED".

> Perhaps this is why I find it so difficult to accept "gifts" because when and if the feelings change within "that gifter", I am caught not having clear vision as to what to do. For instance, we ATE Margie's cookies so couldn't turn them back. To the Institute, we NEVER felt people were giving TO EKKERS—and have been bewildered as to what has come to pass-for Ekkers, too, put everything and MILLIONS of dollars into debt which hangs like Damocles' Sword over our very lives, into making "this project" work and, finally, couldn't even use the very funds made available FOR the projects because of the assaults.

> We got blamed for using funds to defend (by law), the Institute from one assault after another and the very assaulting parties insulting us in court by saying we were using Institute funds for legal things and legal counsel. THE LAW REQUIRES THAT ALL CORPORATIONS HAVE QUALIFIED (BY LAW) REPRESENTATION IN COURT. We did, yes, have help of a personal nature regarding our property struggle, but those were specifically recognized assistance and some loans which WE WILL ALSO PERSONALLY REPAY. That case is the very thing that has allowed US TO BE IN MANILA, meagerly "making it"—and yes, we WILL and SHALL repay, abundantly, every gift and every, no matter how small, loan. It no longer has anything at all to do with something called PI. We will attend that, too, but THAT is different. We WANT to attend it, however, so that our name is not further bashed and our friends and lovedones saddled with the awful accusations cast against them and us during these miserable encounters. And YES, we are structuring it so that if anything happens to us physically, those things will be handled in full, through legal counsel. This also will give those from whom we borrowed and our families— RIGHT TO LEGAL RECOURSE, in that event. There are enough pending cases to repay everything just in litigation or potential litigation awaiting action.

> Do we think the "culprits" have anything with which to pay those debts? They claimed to have had it when they started these horrendous suits and claims, thefts and even theft of the paper, where they publicly stated that they would have "sufficient" funding, etc., for keeping the paper they just STOLE. So be it. We-or anyone attached to us-MUST

as the wonderful Millers, who—I can't imagine why not should pursue legal actions against the culprits themselves. We have no reason to think Millers were not worse "caught" than were we. Responsibility has it, however, that NO, we CANNOT just say "oh, well" and walk away! RESPONSIBILITY DEMANDS AND REQUIRES THAT WE CONFRONT IT HEAD-ON.

Can the miscreant "pretend legal counselors" of Bilger and Cortright afford the "malpractice" suits? That is NOT "our" problem, don't you see-whoever Millers listened to and on whose input and advice they acted—it is their problem, NOT OURS. LEGALLY, OUR CONFRONTATIONS ARE CHOSEN "FOR" US AS TO WHAT IS "UNDER RULE OF LAW". The property case is only one thing we must attend and those scumbags set Millers up to have to be THE ONES solely responsible. But nothing stops THEM from confronting these self-appointed legal experts.

No, I don't know WHY Ekkers bear all the brunt of the assaults, including the last TV notoriety by Dominick, Tuten and Bilger (made available by Neil, et al.). Ekkers were away and we have never even seen the "SERIES" yet. NOW, it appears that the "luxurious COMPOUND" featured in the EXTRA SERIES and follow-up encounters is in total control and holding by the culprits in point. How will the NEXT TV presentations appear—and why have there been NONE? YOU were hurt, participants, family and friends, by that slander, those lies and that MISrepresentation. Gulf War Illness And Squalene Antibodies

Gulf War Syndrome (GWS) is a multisystemic illness afflicting many Gulf War-era veterans. The molecular pathological basis for GWS has not been established. We sought to determine whether [or not] the presence of antibodies to squalene correlates with the presence of signs and symptoms of GWS. Participants in this blinded cohort study were individuals immunized for service in Desert Shield/Desert Storm during 1990-1991. They included 144 Gulf War-era veterans or military employees (58 in the blinded study), 48 blood donors, 40 systemic lupus erythematosus patients, 34 silicone breast-implant recipients, and 30 chronic-fatigue syndrome patients. Serum antibodies to squalene were measured. In our small cohort, the substantial majority (95%) of overtly ill, deployed GWS patients had antibodies to squalene. All (100%) GWS patients immunized for service in Desert Shield/Desert Storm who did not deploy, but had the same signs and symptoms as those who did deploy, had antibodies to squalene. In contrast, none (0%) of the deployed Persian Gulf veterans not showing signs and symptoms of GWS have antibodies to squalene. Neither patients with idiopathic auto-immune disease nor healthy controls had detectable serum antibodies to squalene. The majority of symptomatic GWS patients had serum antibodies to squalene.

Squalene is a substance found naturally in the body. It is also synthetically produced by pharmaceutical companies, under government license, expressly for use in experimental vaccines as an adjuvant component. Even then, a special caseby-case license must be granted because of the danger

Squalene has not undergone the rigorous testing required for common vaccine usage. It is, apart from the vaccine antigen itself, experimental. The vaccine adjuvant's purpose is to boost the immune system so that it will produce antibodies to the introduced antigen, build immunity to infectious agents such as anthrax, faster and more effectively.

One of the reasons squalene was selected for use in adjuvants was precisely because it is found in the body. The logic behind its choice is that if it is found in the body it would, therefore, be less likely to trigger an auto-immune response. Such a response would lead to what has been called human adjuvant disease, a disease in which the body's immune system attacks tissues and systems of the human body, mistaking them for invading agents. These kinds of diseases, like systemic lupus erythematosus, rheumatoid arthritis and multiple sclerosis, to name a few, are commonly known as auto-immune diseases.

In the history of American vaccines, only one compound has been approved for general use as the primary, active compound in adjuvants because of the very real danger of causing human adjuvant disease. Aluminum hydroxide, alum for short, is that compound.

Another reason squalene was chosen for use in experimental vaccines is because the vaccines with which it was being coupled required a far stronger adjuvant. The reason they required a high-powered adjuvant is because the infectious agents they were being aimed at were far more potent, requiring the immune system to react faster and more powerfully to the threat. The only way to make these kinds of vaccines more effective was to use the industrial-strength adjuvant squalene.

At least one of these infectious agents was HIV, the virus causing AIDS. The DoD, not to mention the Departments of Health and Human Services and VA have been very much involved in AIDS research. HIV is so pervasive and pernicious that research for a vaccine isn't much closer to fruition today than it was a decade ago. A recent Scientific American article hinted at the possibility that an AIDS vaccine was close to being called a dead-end in research! (It's interesting to note that an anthrax antigen would not necessarily be more effective with a stronger adjuvant like squalene. It might build antibodies faster, but that's not a primary issue because the body appears to need a more extended time period or a better antigen than a stronger adjuvant.)

Some of the latest trends in the intentional leaks the conspiracy is making to people who think they are in the know is that the anthrax vaccine administered in the Gulf was coupled with squalene instead of alum. It was just an honest mistake aimed at protecting the troops.

This is an interesting turn of events, still not officially admitted by anyone in the government, since all government agencies involved have gone to great lengths to avoid any investigation of the vaccines and have flat-out denied that squalene was used in any vaccines in the Gulf. But, is it the real truth this time? Why would the anthrax antigen be mixed illegally with the experimental adjuvant squalene, when research already showed that squalene had the potential to cause disease and antibiotics were even then, arguably, the

most effective prophylactic?

In short, now that science has proved them to be liars, they are changing their story. The fact that government officials are not telling the truth is provable in a laboratory and has been for years. Hundreds of Gulf Warera veterans, many who never went near the Gulf, have tested positive for squalene auto-antibodies.

Antibodies are produced automatically by the autoimmune system in response to a perceived threat. What that means, without any equivocation, is that members of the military were given experimental vaccines containing squalene. The auto-immune system did not previously think squalene was a threat because squalene is found in minute quantities inside cells. No one has tested positive for squalene antibodies who wasn't vaccinated with experimental vaccines. The action of injecting squalene into the body is the only explanation for the finding of **squalene antibodies.** The auto-immune response is very specific. It could not have been caused any other way. Injecting more people with squalene adjuvants can easily reproduce it.

When people with squalene antibodies are tested properly they are found to be positive for many different auto-immune diseases. But it is only one disease—Gulf War Syndrome. If you happen to hear a government official or some member of the medical profession proclaim—while neglecting to mention their incompatible conflicts of interest—that GWS being a human adjuvant disease is preposterous, remember the following: Go to any major medical reference book and look up systemic lupus erythematosus. It is one of the common auto-immune diseases for which GWS sufferers are testing positive—when those tests are actually done. Somewhere in the disease description it will tell you that it can be triggered by the use of prescription drugs. If lupus can be triggered by the use of medicinal drugs, then why is it so preposterous to believe that it cannot be triggered by the injection of a vaccine adjuvant designed intentionally to affect the response of the auto-immune system? How then could it be preposterous that GWS was caused by an experimental vaccine adjuvant chosen because it had high-powered properties?

Politicians, government officials and high-ranking officers of the U.S. military have not been lying because they did not know about the experimental vaccines. They are lying because they know the finding of squalene antibodies points directly at experimental anti-HIV vaccines. If you don't think so, ask yourself a few more questions. As reported in Insight magazine, why was the blood of sick Gulf War veterans checked for the remnants of HIV? Gold Utilization Boosted By Recent IMF Tactics

IMF'S OFF-MARKET GOLD SALES: TOWARD THE NEW ORDER?

Speaking this week in Gabon, Michel Camdessus, the retiring Managing Director of the IMF, revealed that the Fund has "almost tripled the resources of gold" that it is prepared to use in support of its plan to lower the debt burden of poor countries (www.imf.org/external/ np/tr/2000/TR000112.htm).

Originally the IMF, with the support of Britain and the U.S.—but not that of several European countries, particularly Germany—proposed to sell some of its gold reserves to finance its so-called Heavily Indebted Poor Countries (HIPC) and Enhanced Structural Adjustment Facility (ESAF) initiatives. The income from investment of the proceeds of these sales was to be applied to fund these initiatives. However, given the relatively small amount of income likely to be generated, there were suspicions in many quarters that the scheme had an important ulterior purpose: namely, to help balance the growing gap between annual gold demand—in excess of 4000 metric tonnes—and new mine production—around 2500 tonnes. Gold bugs, of course, smelled manipulation aimed at capping the gold price.

The weak gold prices that followed in the wake of the Bank of England's May 1999 announcement of its own gold sales program galvanized additional strong opposition to the IMF's original plan, which also required approval of the U.S. Congress. As a result, the IMF advanced and secured approval of an alternate plan to fund its HIPC and ESAF initiatives. This plan replaced the proposed gold sales with certain off-market transactions in gold (www.imf.org/external/np/sec/nb/ 1999/nb9962.htm).

These transactions, which involve settlement of certain obligations coming due to the IMF by member countries, operate as follows: First, the IMF sells gold to the member at the current market price, placing the profits from the sale in a special account to be invested for the benefit of the HIPC and ESAF initiatives. The profits are the difference between the IMF's book carrying value of the gold (i.e., one ounce=35 SDRs, or approximately U.S.\$48) and its market value. Second, the member purchasing the gold then satisfies its obligation to the IMF by returning the gold at the same market price. Accordingly, the amount of gold involved in any single transaction will be that amount which at

the current market price equals the member's obligation. The IMF explains further:

The net effect of these transactions will be to leave the IMF's holdings of physical gold unchanged. No gold will be released to the market, and thus there will be no impact on the supply-and-demand balance in the market. The IMF's gold holdings accepted in settlement of members' obligations...will be recorded at a higher value on the IMF's balance sheet, and acceptance of this gold (instead of currencies or SDRs) in such settlements will reduce the IMF's liquidity by the amount of profits transferred for the benefit of the HIPC and ESAF initiatives...and its net income.

According to the above link, the original plan called for transactions involving in total 14 million troy ounces (about 435 metric tonnes) of gold. Taking Michel Camdessus at his word, it appears that now more than 40 million ounces are committed to the plan. The IMF's total gold stock exceeds 103 million troy ounces (3200 metric tonnes), making it one of the largest official gold holders in the world. More information on its gold holdings and policies with respect thereto can be found at www.imf.org/external/np/exr/facts/gold.htm. Subject to approval by an 85% majority vote, the IMF can sell gold at market prices and accept gold in settlement of members' obligations at agreed prices based on market prices. It cannot buy gold or engage in any other transactions in gold (e.g., loans, leases, swaps, etc.), nor can it use its gold as collateral for

The IMF's second off-market gold sale, involving just over 655,000 troy ounces (20.4 metric tonnes), was completed with Mexico on December 17, 1999 (www.imf.org/external/np/sec/nb/1999.htm). The press release states in relevant part:

The IMF retained about SDR 23 million on its own account as required by the Articles of Agreement. The remainder of the proceeds—SDR 111 million (about U.S.\$152 million)—was invested with the Bank for International Settlements (BIS) to generate income for the Heavily Indebted Poor Countries (HIPC) initiative.

The term **SDR** refers to the **IMF Special Drawing Right**, which is essentially an accounting convention of the Fund. SDRs are described at www.imf.org/ external/pubs/ft/survey/sup0998/11.htm. The SDR is a weighted composite of the currencies of the U.S., Britain, France, Germany and Japan—which today means the dollar, euro, pound and yen. Its value is determined daily by the Fund on the basis of market rates for its components. The SDR interest rate is adjusted weekly on the basis of certain domestic shortterm rates in the five specified countries. SDRs can be used in transactions among the Fund, its members and 15 other "prescribed" institutional holders, presumably including the BIS. However, while the IMF can create international liquidity by allocating SDRs to its members, it cannot allocate SDRs to itself or prescribed holders.

mechanism for creating SDRs for the Fund itself by revaluing a certain portion of its gold from SDR 35/troy oz. to current market prices expressed in SDRs. These new SDRs are apparently being placed with the BIS, a prescribed holder, because IMF rules prohibit its Special Disbursement Account—which includes the HIPC and ESAF initiatives, and other accounts administered by it-from holding SDRs directly.

Although I have read speculation that some IMF gold may be reaching the market through its off-market gold sales, I am unable to come up with any plausible scenario as to how this might happen. On the other hand, the apparent success of the IMF's program may have favorable longer-range implications for gold.

Certainly, until all its gold is revalued from SDR 35/troy oz. to market prices, the argument for outright gold sales by the IMF will be difficult to make. Indeed, if ever there were a situation of eating one's cake and having it too, these current off-market gold sales would seem to be it. Of course, once all the Fund's gold is revalued to market prices, only further increases in the gold price itself will support creation of additional SDRs in this manner for the Fund's own use.

A good argument can be made that the EMU's ultimate vision is not a euro fixed to gold, but a euro regularly measured against gold at market prices. Under a system of this sort, the euro could serve as the domestic currency of the EMU countries without the rigidities of the classical gold standard. It could also serve as a major currency, possibly the dominant currency, for settlement of private international transactions and for international finance. But gold would resume its role as the international standard of value—the yardstick for all currencies. It would also become the principal component of most nations' international monetary reserves and, at market prices, the standard medium for settlement among national governments (i.e., central banks) and international monetary authorities. The days of one nation's paper currency serving as the world's principal international monetary reserve would be over.

The beginnings of a system of this sort can already be glimpsed in both the EMU's practice of marking its gold reserves to market quarterly and the Washington Agreement affirming that gold will remain an important part of the Euro Area's international monetary reserves. Although starting with a proposal for gold sales much like the BOE's, the IMF ended with a system of offmarket gold sales involving settlement of international obligations in gold at current market prices. In hindsight, this IMF program could well be perceived as another step, however small, toward restoring gold to a major role in the international payments system.

In any event, by dropping the fiction of gold at SDR 35/troy oz. and embracing market prices, the IMF has aligned itself with the EMU as an official sector institution in which the market price for gold has a significant and current balance-sheet impact. In the long run, institutions operating in this manner are likely to find that it is more in their interest to have an honest, free-market price for physical gold than an unrealistic price subject to manipulation in largely paper markets such as the COMEX, TOCOM and LBMA. Increasingly, these large official holders of gold should come to realize that rising gold prices are not always a harbinger of rising prices or proof of bad monetary management. Instead, they can be at times an indicator In essence, the IMF's off-market gold sales are a of rising general productivity relative to gold, and in

that context an opportunity for a fundamentally benign upward revaluation of existing gold stocks in accordance with market dictates and to the benefit of gold holders.

Put another way, if the IMF can do a lot for poor countries with a gold price near \$300/oz., it could do twice as much with a gold price near \$600/oz. That is the price that even today many knowledgeable gold analysts suggest may be necessary to bring physical gold demand and new mine production back into equilibrium. Why, then, should the IMF fight it? Indeed, why should any large official holder of gold, except of course the U.S. which now enjoys "the exorbitant privilege" of printing its way out of its deficits?—Reg international row@ix.netcom.com; http://www.goldensextant.com [END QUOTING]

NEW YORK (AFP)—The International Monetary Fund (IMF) should be recognized as a lender of last resort similar to a national central bank and be authorized to inject money into the international financial system in times of crisis, IMF Managing Director Michel Camdessus said.

Addressing the COUNCIL ON FOREIGN RELATIONS [H: big clue], Camdessus also argued that the IMF should have the right to impose a temporary freeze on legal action by private creditors against countries that, despite good faith efforts, CANNOT avoid default. Camdessus, who will step down in mid-February after 13 years as Managing Director, said the IMF was already "the closest that the international financial system has to a lender of last resort". [H: There it is in black and white, readers.]

"It is a function that we have been performing and adapting for over 50 years, and it wouldn't hurt to recognize it, to confirm the Fund in this role and to invite it to continue to offer the international community this vital guarantee with enough of a judgmental basis to avoid any risk of moral hazard."

[H: By the way, for your information, it is that the highest-level positions in the economic quarters of nations—the officers, such as the Secretary of Treasury, Attorney General, and others from the Central Bank on down-ARE PAID DIRECTLY BY THE IMF AND THAT IS WHY THOSE JOBS ARE SO EAGERLY SOUGHT! The term refers to the danger that governments as well as creditors might be encouraged to make imprudent financial decisions on the assumption the IMF will always be there to bail them out.

Once designated as a lender of last resort, according to Camdessus, the IMF should be given the authority to intervene more forcefully in times of crisis.

"It is not unreasonable to expect that, in a grave crisis, the leading countries would collaborate to inject a proper amount of international liquidity through a very simple mechanism which could decisively underpin confidence in the international system," Camdessus said.

"To this end, the IMF might be authorized to inject international liquidity and to withdraw it when the need had passed, in a manner analogous to that of a national central bank." [END OF QUOTING]

You, BR, refer to the PGC and "this instrument", demonstrating your complete ignorance of the facts. You are obviously trying to describe the GAIA "asset", which is an absolute and irrevocable assignment (gift, if you will) of the Russell Herman half of the interest accumulated to the jurat/contract reissued to Cosmos Seafood Energy Marketing Ltd. made to Rick Martin and subsequently to Global Alliance Investment Association (not GAIA Corporation as you so carelessly state). The assignments from Herman to leaving the "authority" for the PGC basically with the Rick and Rick to GAIA were published in CONTACT

before our coming to the Philippines.

BR (9): This whole scenario has problems. Alaska Airlines Flight 261 Motive For Shoot-Down?

Another airplane tumbles from the sky and the mainstream media goes far out of its way to AVOID asking key questions—sound familiar? 1. NTSB states that the previous flight crew flying this particular MD-83, with the flight originating in Anchorage, experienced "mechanical problems" on its way down to Mexico—the flight just before the one that ended with the deaths of all those aboard. NTSB states that this crew reported control problems with the horizontal stabilizer. Alaska Airlines emphatically DENIES there was ANY anomaly with this aircraft. Who is telling the truth? Was this story planted by NTSB as a cover?

Was Flight 261 subjected to an intentional or accidental military mishap?

- 2. NTSB Chairman Jim Hall—the same fellow who has continually LIED to the public about the cause of the downing of TWA Flight 800 and how its center fuel tank caused the crash by [inexplicably] "exploding" (NOT!)—said the pilots of Alaska Airlines Flight 261—the Monday afternoon flight from Puerto Vallarta bound for San Francisco and Seattle—had turned to a maintenance crew in Seattle for help in their efforts to regain control of the plane. Where is the confirmation from Alaska Airlines regarding this statement? If, in fact, there are tapes of the crewmembers' conversations with the Seattle maintenance base regarding a control problem with the horizontal stabilizer in the possession of Alaska Airlines or the NTSB, why haven't TRANSCRIPTS of those conversations or audio excerpts been released to the media? Why the "he said—she said" routine, as reported by the media?
- 3. At the time of the crash of Alaska Airlines Flight 261, the MD-83 was located either within or slightly adjacent to Restricted Area R-2519, which is depicted by both the Los Angeles (LAX) Sectional Aeronautical Chart as well as Low Altitude and High Altitude Enroute Charts as being under control of Naval Air Station Point Mugu, to "unlimited" altitudes and "continuous" hours of operation. Restricted Area R-2519 is also contiguous to Warning Area W-289, which is located in an expanding arc further southwest and south, out into the Pacific Ocean,

encompassing Anacapa and Channel Islands. W-289 is also to "unlimited altitudes" but with "intermittent operation". The importance of Alaska Airlines Flight 261 being located in or adjacent to these Restricted and Warning areas is important from the aspect that Naval Air Station Point Mugu, in concert with the China Lake Naval Weapons Center and other military installations in the area, routinely conduct high-tech weapons testing in these areas, with potential danger to aircraft transiting the area. For example, "Restricted Areas", such as R-2519, "denote the existence of unusual, often invisible, hazards to aircraft such as artillery firing, aerial gunnery, or guided missiles." (FAA Airman's Information Manual, Section 3-4-3). Similarly, a "Warning Area" such as W-289 is "airspace of defined dimensions, extending from three nautical miles outward from the coast of the United States that contains activity that may be hazardous to nonparticipating aircraft." (FAA Airman's Information Manual, Section 3-4-4). It is EXTREMELY SIGNIFICANT AND TROUBLING that Alaska Airlines Flight 261 DID NOT HAVE A PROBLEM UNTIL IT ARRIVED WITHIN, NEAR OR ADJACENT TO, RESTRICTED AREA R-2519 AND WARNING AREA W-289. Was military weapons testing in progress as Flight 261 approached this area? Was the MD-83 or its tail section (Flight 261) struck or damaged by some "invisible hazard", or "aerial gunnery" or "guided missile" that INDUCED control problems with the horizontal stabilizer and subsequently caused the complete and total loss of control of

4. It is also extremely significant and troubling to learn that NTSB placed a "muzzle" on at least one eyewitness, who so far appears to be the closest eyewitness to the crash site. The following quote from *Associated Press*, dated February 2, 2000 at 12:05 AM ET, raises the suspicion that NTSB is doing "damage control" by limiting what the media is reporting, to wit:

"Drew Gottshall, 45, a Channel Islands National Park worker, was putting up a trail sign near the Anacapa Island lighthouse when he heard the jet, looked up and watched it slam into the water 2½ miles to the north. 'The plane made a quick entry into the water upon impact and disappeared,' Gottshall said in a statement released by the Park Service, which noted that at the NTSB's request it did not include observations of the plane's flight path and orientation."

- 5. Over the years we have come to know that the military-industrial complex has experimented on various people much like they were laboratory animals, with radiation, toxic poisons, etc., in some cases "shock testing" an entire city to determine the results and effectiveness of the experiments. Is it possible that Alaska Airlines Flight 261 was determined to be an expendable resource and, because of certain personages on board, "terminated" for purposes of political expediency?
- 6. Perhaps the most disturbing commentary from the media is the absence and ABSOLUTE SILENCE BY THE FLIGHT CREW OF ALASKA Flight 261 in the last six minutes before the airplane impacted the Pacific Ocean. This is extremely odd, given the fact the PTT (push-to-talk) microphone button for radio transmission is located on the control wheel. Why didn't either of the pilots at least cry out to Los Angeles Center, "Alaska 261 is going down", or "we've lost control, we're going in"—or at least something? If, in fact, there was total silence on the part of the flight crew, that raises the additional suspicion that perhaps they were incapacitated, given the further report by the media that the aircraft was spinning and tumbling. This *AP* report at 12:05 AM ET on February 2nd raises the specter of something more sinister going on with Flight 261:
- "NTSB member John Hammerschmidt released preliminary transcripts of air traffic control communications with the airliner. The last routine transmission came at 3:55

PM PST, when the flight was cleared to continue to San Francisco. At 4:10 PM the pilots said they had control difficulties and were descending below 26,000 feet. A few seconds later they advised they were at 23,700 feet and there was 'some discussion about their ability to control the aircraft', Hammerschmidt said. Over the next few minutes, the pilots said, 'we're kind of stabilized and going to do some troubleshooting,' but then said they had a jammed stabilizer. At 4:16 PM, they were cleared for an emergency landing in Los Angeles. The controllers cleared the plane to 17,000 feet. The crew acknowledged that in what was the last known transmission from Flight 261, Hammerschmidt said. At 4:21 PM, the aircraft dropped from radar."

NewsHawk has already raised the issue of Flight 261 being cleared for an emergency landing at LAX, located 40 miles away, when Naval Air Station Point Mugu with its 12,000 foot runway was immediately adjacent to the crippled flight's location, a mere five or ten miles away. It does not make any sense that the flight crew would request an emergency landing at an airport over 40 miles distant, knowing that they might never make it with the kind of control problem they were apparently experiencing. It is further incongruous that LAX Center would not suggest or recommend NAS Point Mugu as a viable alternative to flying to an airport 40 miles away, versus one as close by as Point Mugu, with all kinds of emergency equipment the Navy has at its disposal to deal with an airplane crash.

From the AP story above, roughly 5 or 6 minutes elapsed after the purported "last known transmission" from Flight 261, apparently after which the MD-83 went completely out of control. During these 5 or 6 minutes, did Flight 261 completely lose the rudder and horizontal stabilizer, or the ability to control them? And lastly, unlike the EgyptAir-990 crash into the Atlantic Ocean off Nantucket Island on October 31, 1999, where NO BODIES WERE EVER REPORTED AS HAVING BEEN RECOVERED, the NTSB reported in the instance of the Flight 261 crash that only four bodies were recovered, yet the debris field as shown by the media was of small pieces of the wreckage, as if the airplane disintegrated into a million pieces. We've all seen the shoe floating and some of the luggage. The debris field doesn't jive with the number of bodies recovered and, at least from this writer's perspective, is INCONSISTENT with an 80-degree nosedown impact of the airplane as reported by NTSB. An airplane striking the water at the speed and angle exhibited by Alaska Airlines Flight 261 would result in the utter explosion and disintegration of the airplane and its contents—it would be like slamming the airplane into a concrete wall. Where are the bodies, or body parts? [Perhaps Cmdr. Hatonn knows?] And why haven't the media shown anything other than the repeated showing of the shoe and luggage? We have seen literally no evidence of any of the salvage of the MD-83.

Alaska Airlines Flight 261 may well have had a control problem with its horizontal stabilizer; but what external force initiated it? Remember, everything was "NORMAL"—up until 3:55 PM, when Flight 261 neared Naval Air Station Point Mugu and the weapons-testing area.—John R. NO POISON SUPPLY AT AUSCHWITZ, **SAYS IRVING**

LONDON—Eyewitness evidence of the existence of homicidal gas chambers at Auschwitz was "totally demolished" because there were no holes in the roof through which to insert poison, historian David Irving told the high court today, Jan. 26. Mr. Irving, the 62year-old author of Hitler's War, who is seeking libel damages for being called a "Holocaust denier", said that his theory "blows holes in the whole gas-chambers story".

He said that a number of "revisionist" researchers had entered the ruins of Crematorium Two at Auschwitz, in which Holocaust historians say 500,000 died, and photographed the collapsed underside of the roof-but found no holes.

"I do not accept that the Nazis in the last frantic days of the camp, when they were in a blue funk, would have gone around with buckets of cement filling the holes that they were going to dynamite."

Mr. Irving, who is representing himself, made the comments during his cross-examination of Professor Robert van Pelt, who has said that there was a mass extermination. Professor van Pelt has said that more than normal scrutiny". He questioned the validity the gas chambers were first dismantled and then of Tauber's evidence, as he had wrongly asserted that dynamited when the gassings stopped in November 1944 as the Russians advanced.

Deborah Lipstadt and Penguin books, who are fighting Mr. Irving's action, he says that the evidence for gassing included eyewitness accounts, photos and drawings from memory of a sonderkommando—a Jewish inmate selected to work in the crematoria.

He referred Mr. Justice Gray to a photo taken by an SS man in February 1943, which showed openings above ground on the newly completed roof of Crematorium Two with a kind of cover on top of them. The defence case is that these projections were from four introduction columns through which Zyklon B pellets traveled.

Mr. Irving, who says that the gas chambers were only used to de-louse corpses and objects, claimed that the picture was taken in December 1942 during building works and that the objects on the roof were drums containing sealant.

Professor van Pelt also relied on an aerial photo taken by the Americans in the summer of 1944, which showed "four dots" on the roof of Crematorium Two. He said that this showed very clearly that there were "introduction devices" on top of the building.

Mr. Irving questioned the authenticity of the photo and said that whatever the dots were, they were too big for the purpose put forward by the defence.

Professor van Pelt also cited the drawings, undertaken in 1945-46, of surviving sonderkommando David Olere, which showed openings for the introduction of the pellets into the gas chamber at

Crematorium Three in Auschwitz. Olere, he said, was a "very experienced draughtsman and painter" who had a good visual memory and was a credible witness.

Mr. Irving is suing over Professor Lipstadt's 1994 book, Denying The Holocaust: The Growing Assault On Truth And Memory. Accused by the defendants of being "a liar and a falsifier of history", he depends on a 1988 report by a man called Fred Leuchter, who had taken samples from ruins at Auschwitz and concluded that there were never homicidal gas chambers there.

Mr. Irving says Professor Lipstadt's book has generated "waves of hatred" against him.

Mr. Irving said that the defence's "so-called" eyewitnesses were a relatively small number for the large proposition at stake. Apart from that, he added, there was not "a single document of any credible worth" which explicitly set out the defence case in all the "hundreds of thousands" of papers in the Auschwitz Museum and the Moscow archives.

He submitted that his position on the Holocaust was justifiable and not perverse.

He went on to question Professor van Pelt's reliance on the evidence of sonderkommando Henryk Tauber, which included descriptions of gassings in Auschwitz's crematoria.

He said that some of Tauber's accounts "test a "massive amount of evidence" of the camp's use for reasonable historian's credulity" and "should be open to four million had died at Auschwitz.

Professor van Pelt said that he considered that Giving evidence for American academic [sic] Tauber was "an absolutely amazingly good witness...I find his power of observation very precise and don't have any general reason to doubt his credibility as a witness.'

U.S. ADMITS EMPLOYEES' EXPOSURE **TO RADIATION**

WASHINGTON (NYTNS)—After decades of denials, the government is conceding that workers who helped make nuclear weapons beginning at the dawn of the nuclear age were exposed to radiation and chemicals that produced cancer and early death.

The new finding—that radiation exposure led to higher-than-normal rates of a wide range of cancers among workers at 14 nuclear weapons plants—raises the prospect of compensation to them....

...The new conclusion comes from the government's most comprehensive review of studies of worker health and raw health data. The review accepts

were made sick by their exposure.

The finding goes far beyond an acknowledgment by the government last July that one substance handled by to become ill from breathing beryllium dust.

Of the new conclusion, Energy Secretary Bill Richardson said in an interview, "This is the first time that the government is acknowledging that people got cancer from radiation exposure in the plants."

The finding is detailed in a draft report prepared by officials of the Energy Department and the White House with the cooperation of a dozen government agencies.

President Clinton ordered the study in July, when the Energy Department concluded that some of the workers at plants that had supplied beryllium to the government for bomb making had developed beryllium disease, an incurable lung ailment. The President asked for a broad study that would include the effects of radiation and chemical hazards from uranium, plutonium and other substances.

Legislation proposed by Rep. Paul Kanjorski (D-Pa.), whose constituents include some of the berylliumdisease patients, calls for payments to an estimated 500 to 1,000 former workers who either have the illness or are at high risk of developing it. Total payments in the beryllium cases could range from \$15 million to \$30 million a year, officials said.

One question that Congress would have to resolve in the beryllium compensation, and that would have to be addressed in any compensation plan developed as a result of the cancer finding, is whether [or not] to make payments to survivors.

In the 57 years since the Manhattan Project began processing radioactive materials to produce bombs, the government has until now minimized the hazards of radiation and chemicals, criticized epidemiological studies that raised related questions and spent tens of millions of dollars in defending itself against lawsuits charging that the bomb plants had made workers sick.

"In the past, the role of government was to take a hike," Richardson said, "and I think that was wrong."

One expert on nuclear weapons manufacturing, Robert Alvarez, a former Energy Department official, welcomed the government's conclusion that many of its critics had been correct.

"A review of the studies by a body impaneled by the President is official recognition," Alvarez said.

Daniel J. Guttman, a lawyer for the paper, Allied-Industrial Chemical and Energy Workers Union, which represents workers at 11 weapons factories, said "That's stunning."

"The prior story line is, 'What's the big deal, the risks were marginal," said Guttman, former Executive Director of a commission formed by the Clinton Administration to look into improper radiation experiments using human subjects.

Richard D. Miller, a policy analyst with the Union, said the change was remarkable because the Energy Department and its predecessor, the Atomic Energy Commission, had "spared no resources in seeking to defeat claims" by employees who said they had been made sick by radiation or chemicals.

> ...At the meeting's opening session, many of the 3,000 world leaders in business, government, the media and the arts took remote-control voting machines into their deerskin-soft hands and voted on what they considered the most important issues facing the globe.

> The result was a gut-level read on some of the world's most important trends in politics, business and the arts. And judging by some of the prodigious CEO bellies in attendance, this crowd could offer gut-level thoughts until all of Switzerland's cows came home and still have room for dessert.

SHADES OF SEATTLE RIOT AS CLINTON ADDRESSES ELITE ECONOMIC FORUM

DAVOS, Switzerland—The unfocused but persistent global protest movement that disrupted trade talks in Seattle last December followed President Clinton across the Atlantic to the small ski town of

About 500 mostly French and German protesters took to the streets less than an hour after Clinton addressed the World Economic Forum Meeting here. Clinton told the international crowd of about 3,000 leaders from government, business and the media that global trading systems need to take into account legitimate concerns about labor rights, the environment and the need for sustainable economic development.

Defying police orders to disperse, the protesters marched down Davos' main street toward the convention hall, carrying banners with slogans like "Global Killers" and "Against the New World Order". They threw steel barricades and wooden poles through the window of Davos' only McDonald's, ignoring a banner that read, "Think Globally, Eat Locally".

At one point, witnesses said, at least three police officers received head wounds and were taken away by ambulance before police began arresting protesters and taking them away by bus.

Just as they did at the World Trade Organization meeting in Seattle, the Davos protests highlighted concerns that are developing in the U.S., Europe and elsewhere that the growing power of global business is a threat to individual liberties and to the sovereignty of less-developed countries.

These concerns have been the subject of heated

debate inside the Davos meeting. Representatives of less powerful countries and from non-governmental interest groups like Greenpeace and Friends of the Earth have urged leaders of major corporations and Western approach to global trade.

Clinton allied himself with such concerns. "Trade can no longer be the private province of politicians, CEOs and trade experts," Clinton said.

Clinton said people living in a global economy all have shared concerns about human rights and economic progress. "A few of us live on the cutting edge of the economy, and too many of us live on the bare edge of survival, without the means to move up," Clinton said.

Clinton urged all countries to cooperate in a system of fair trading rules. "Developed and developing countries alike must insist that the benefits of free trade flow widely," he said. But the move toward more open trade will not be reversed. "The consequences of running away from a dialogue on the vitally important issues won't be more trade, it will be more protectionism," Clinton warned.

Still, the protesters were not in any mood to reason about trade. Nor did they seem to care about some of the nuances that make international business such a ousting a president they viewed as corrupt and complex target of protest....

...On the streets, billionaires mixed with roustabouts as the protests created a strange mixture of

...Inside the convention hall, the protesters drew sympathy from some World Economic Forum attendees. Thilo Bode, international Executive Director for Greenpeace International of the Netherlands, said the Davos mind-set tends toward arrogance.

"Most of the people here think everything is fine," Bode said. "We just need to explain it to the poor, stupid people who are outside the Elite."

Protester Charles Pasqua, who said he traveled from central France to participate in the Davos demonstration, doesn't think he's enlightened enough.

"We're against the power of global companies," he said. "We want to live like we want, and not like commercial people want us to live."...

ECUADOR'S INDIAN MOVEMENT FLEXING POLITICAL MUSCLES AFTER OUSTER

QUITO, Ecuador (AP)—Most of the 5,000 ponchoclad Indians who took control of Quito's streets in outrage over soaring food prices and forced the ouster of an unpopular president are back in their villages high in the Andes.

But a few of their leaders remain in the capital, and the Indians warn they are ready to march on Quito again if necessary—a warning Ecuador's political elite no longer takes lightly.

The leader of the Indian movement whose revolt

precipitated the overthrow of President Jamil Mahuad on January 21 says Ecuador's 4 million Indians have finally forced political leaders to take them seriously.

"We showed that we have the capacity to bring governments to develop a more inclusive and sensitive down presidents and corrupt governments," said Antonio Vargas, a 40-year-old bilingual school teacher who was elected President of the Indian federation a vear ago.

> Coups have been common in Latin America's turbulent history but this was the first provoked by an Indian group. Ecuadoreans were stunned when the military high command forced Mahuad from power to avoid "a social explosion" and replaced him with the vice president.

> Clearly, Ecuador's Indian federation has emerged as the most organized and influential indigenous movement in a region where native peoples in several countries are engaged in struggles over land, language and civil and political rights.

> confidence in Ecuador's Indians and they have no intention of fading back into their impoverished villages to be forgotten again by the government....

> ...The Indians achieved their primary goal of incapable of halting Ecuador's disastrous economic decline, and they express pride in their growing power.

> Often forced to migrate to the cities for work, Indian men end up as street vendors or as laborers who haul mammoth loads of produce on their backs at public markets. The women and children beg on street corners, reinforcing the scorn of the White elite and mestizo population....

> ... Vargas warned last week that if the new President does not eradicate endemic corruption and take steps to end Ecuador's deep poverty, the Indians will rise again in six months, setting off "a great social explosion that could lead to civil war".

Officials have learned not to ignore the Indian movement's threats....

...The Indian federation has taken strong stands against repayment of Ecuador's foreign debt, privatization of state companies and Mahuad's controversial plan to replace the national currency with the U.S. dollar, all of which it considers economic threats to Indians.

Although experts on the Indian movement agree the successful revolt has strengthened the Indians' political power, they say it has also increased suspicion, fear and racism among the middle and upper classes....

PEACEKEEPERS BATTLING PR PROBLEM **IN KOSOVO**

VITINA, Yugoslavia (AP)—Lulzim Ukshini says he was hanging out with his buddies in Sam's Pizzeria when a grenade exploded in a Serb store across town. He also says the first he heard about the attack was when four U.S. peacekeepers came looking for him.

"They started to beat me non-stop, telling me to admit that I did it," he said. "Then they pulled a knife out and threatened to cut me into pieces.'

Ukshini's story of mistreatment at the hands of American soldiers is being echoed by other ethnic Albanians in Kosovo, who tell of beatings, inappropriate body searches of women and daily harassment by U.S. troops.

The allegations come at a time of heightened The success in ousting Mahuad has instilled concern following the rape and murder of an 11-yearold ethnic Albanian girl. U.S. Staff Sgt. Frank J. Ronghi, a weapons squad leader from Ft. Bragg, N.C., was charged this month with murder and indecent acts with a child in connection with her death.

> Ethnic Albanians say the killing is not their only complaint against the Americans.

> Their allegations have prompted an official Army investigation and threaten a breakdown in trust between the U.S. peacekeepers and the citizens they were sent to protect.

> U.S. officials declined to discuss specific allegations because many of the complaints are under investigation. But the Army acknowledges it has a big problem with community relations in Kosovo.

> "These are serious allegations that we do take seriously," said Maj. Erik Gunhus, a public affairs officer at Camp Bondsteel. "We will investigate and if we find they are true, we will act accordingly. We want to show that no one is above the law.'

> In a statement issued Sunday, the Army said preliminary findings indicate several U.S. soldiers may have been involved in misconduct, "including improper use of physical force and threats against Kosovar males and inappropriate physical contact with Kosovar females." Gunhus confirmed several soldiers have been transferred out of Vitina.

> Still, Ukshini and other Vitina residents are skeptical.

> "I wouldn't complain to KFOR because it does no good," Ukshini said, using the acronym for the NATO-led peacekeeping force that entered Kosovo in June after a 78day bombing campaign forced a halt to Yugoslav President Slobodan Milosevic's crackdown on ethnic Albanians.

> "Every time we went to complain, they told us: 'It's not true. Our soldiers don't behave like that," said Ramiz Hasani, 21, whose father has been detained by the Americans in the death of a Macedonian police officer. Hasani said U.S. soldiers have entered his father's restaurant several times and harassed customers.

2,000 INTERNET-RELATED TAXES **IN STATE LEGISLATURES**

State legislators will take up more than 2,000 Internetrelated bills this year. After recovering from the initial shock, we realize what's behind the push. A widespread attitude out there says nothing can exist apart from government control.

Most of the bills fall under three categories: privacy, content and sales and access taxes. Surely, not all of them can be harmful. We'd support any bill that bars new taxes on Internet sales.

In the Internet, we are truly witnessing a historical revolution that's deeply changing our lives. By the end of this year, 100 million Americans—more than a third of the population—will be online. The Web—after its birth as a government communications system—has proceeded quite nicely without further government involvement.

We can talk to each other through the Internet. We shop there. We invest online. Vacations are planned, recipes are found, careers are improved and goods are auctioned in cyberspace.

Have a health question? Find the answer online. And is there a limit to what children can learn on the Web?

The Web—a true reflection of the free market at work—has done a good job of policing its content (like television, parents have the ultimate control over what their children see) and pleasing customers in a relatively untaxed environment (studies indicate that taxes would shrink this growing medium).

In a working paper, Jason Oxman, counsel for the Federal Communications Commission's Office of Plans and Policy, thoughtfully reminds that the Internet has developed because government has thus far largely kept its hands off.

The FCC's challenge, he wrote, "is to maintain its deregulatory stance towards data services and the Internet".

We suggest that state and local governments do the same. If they don't—and the 2,000 bills awaiting action indicate they're not inclined to back off-then the freemarket defenders will have to fight hundreds of battles in 50 new venues.

As Grover Norquist, President of Americans for Tax Reform and a member of the Federal Advisory Commission on Electronic Commerce, says, "It's the federal government's job to protect the Internet from being looted and bled to death by a thousand cuts inflicted by state and local officials."

The interstate commerce clause, included in the Constitution to prevent states from erecting protectionist policies that interrupt the free flow of interstate trade, should be applied.

At a White House conference during his second term, President Reagan famously explained the bureaucrats' and lawmakers' mind-set: "If it moves, tax it. If it keeps moving, regulate it. And if it stops moving, subsidize it."

In those few words, Reagan also provided insight into what's happening in the States more than a decade later. So now we ask: Who in Washington is going to step up and defend the Internet from a state legislative onslaught? [JR: Well, since Al Gore invented the Internet (haha), it has to follow that our fearless leaders would have to step in to collect on what is theirs. NEGOTIATORS SEAL DEAL ON GENETICALLY-MODIFIED FOODS

MONTREAL (AP)—After negotiations late into the night, delegates today reached an international agreement on the trade of genetically-modified food and other products.

Just before dawn, Colombia's Environment Minister Juan Mayr announced to a conference hall full of delegates that the yearlong stalemate had ended.

"The adoption of this protocol represents a victory for the environment," Mayr said, fighting back tears. "But don't forget that this only represents the beginning. We have still before us a great challenge."

The Biosafety Protocol to the UN Convention on Biodiversity provides rules intended to protect the environment from damage by genetically-modified plants, animals and bacteria.

The protocol allows a country to ban imports of a genetically-modified product if it feels there is not enough scientific evidence showing the product is safe. It also provides rules for the transport and labeling, requiring that the words "may contain living modified organisms" appear on all shipments of geneticallyaltered commodities, such as corn and cotton.

"The text is good, from our point of view, very good," said Adrian Bebb, an environmental activist with Friends of the Earth.

Environmentalists and a few scientific studies have raised concerns that genetically-modified organisms could wipe out native species, disrupt natural cycles and cause other ecological damage.

that countries should be allowed to refuse imports of a genetically-modified product if little is known about its environmental effect....

...Today, U.S. negotiators said they were satisfied with the final agreement.

"On balance, we think this is an agreement that protects the environment without disrupting world food trade," said head U.S. delegate David Sandalow....

...In one of the main compromises, the United States and its supporters were able to amend rules that would have required labels to give specific details on what genetically-modified materials are in a product.

Under the compromise, for two years after the protocol comes into effect, labels must say only that a product may contain such materials, without specifics. During those two years, negotiators will work out more specific labels.

Negotiators also reached a compromise on the thorny issue of how the protocol would relate to the World Trade Organization. After months of debate over which treaty should prevail, it was finally decided that the two should be "mutually supportive", with a specific statement in the document declaring that nothing in it is "intended to subordinate this Protocol to other international agreements"....

... Talks last February in Cartagena, Colombia ended in disarray when the United States and five other countries—Canada, Australia, Argentina, Chile and Uruguay—rejected a draft agreement favored by 125 other countries.

NOT WHAT THE NSA HAD IN MIND

For covert operation, Echelon makes a lot of news

If the worst thing for a multinational spying system is publicity, there are probably a lot of long faces these days at the headquarters of the National Security Agency (NSA, Fort Meade, Md.). Suddenly, its fivecountry super-secret snooping outfit, Project Echelon, is getting as much attention as Ricky Martin and Pokemon.

The long-rumored project, said to be a cooperative The European Union and developing nations argued effort between the NSA and its counterparts in Canada, the United Kingdom, Australia and New Zealand, intercepts as many as 2 million e-mails per hour and eavesdrops on cell-phone, fax and wireline communications at similar rates, experts say. They peg total per-day intercepts at 3 billion messages.

> "I would describe Echelon as the mechanism that has automated the largest systematic invasion of privacy probably in history," says Ethan Preston, a law clerk for the Electronic Privacy Information Center (EPIC, Washington, D.C.).

> The NSA, Echelon's supposed directing partner, neither denies nor confirms its existence. Few people who follow this sort of thing for a living have any doubts, however. "There are a few questions, but the existence of Echelon isn't really one of them," says Steve Bellovin, a fellow at AT&T Bell Labs (Holmdel, N.J.).

> The project, which has roots deep in the Cold War, is gradually coming—or being pushed—into the open. Last spring, the European Parliament reported that Echelon exists and Australian government officials conceded the fact. Last month, the American Civil Liberties Union (ACLU, Washington, D.C.), in conjunction with EPIC and other groups, established an Echelon page on the ACLU web-site. This month, EPIC filed a federal lawsuit seeking NSA documents that the organization had refused to provide earlier this year to the White House Intelligence Committee, which oversees the NSA.

Rep. Bob Barr (R-Ga.)—a former Central The situation has changed since then, with major Intelligence Agency (CIA) official and United States Attorney—asked House Government Reform Committee Echelon. It is unclear if Burton has agreed, but insiders say they will occur.

Barr, one of the most conservative members of the House, attached language to the *Foreign Intelligence Authorization Act for 2000* indirectly seeking information on Echelon by mandating that the NSA, CIA and Department of Justice (DoJ) outline the legal statutes under which communications involving American citizens are intercepted. The reports are due in February.

The likelihood that something exists and the NSA's inability to talk about it create the perfect breeding grounds for wild rumor. It's possible that Echelon exists—in a perfectly legal form. After all, legitimate clandestine activities are part of the NSA's mandate.

It is also unknown how powerful or sophisticated Echelon is. "We don't pretend to know all the details," says Barry Steinhardt, Associate Director of the ACLU. "In many respects, it's a black box."

There have been some interesting glimpses inside that box. Echelon-watchers point to a patent on voicerecognition technology that was assigned to the NSA in August. Some say Echelon may have the tools to see billions of messages but is unable to efficiently find those of interest. Experts also speculate that it may be struggling with the changing technologies used by the public network carriers on which it snoops. For example, the switch to fiber optics makes eavesdropping difficult, Bellovin says, because photons don't leak through fiber as freely as electrons slip through copper. The next few months will likely determine if a fullblown scandal ensues. NSA officials may be in for a bad time if rumors of industrial espionage are substantiated or if it has been operating outside the proper channels. "If the NSA has been evading these committees, I think Congress is going to blow a gasket," Bellovin says.

Because the intercepted messages are carried by public networks, service providers may be in a difficult position. Some laws compel them to secretly allow governments access to their customers under certain conditions. Indeed, the level of cooperation between carriers and Echelon-like organizations is perhaps the key to the project's effectiveness. It's vital to have access to carriers' infrastructure elements, such as Signaling System 7 (SS7) networks and dial-up Internet protocol (IP) address databases, experts say.

Involuntary participation notwithstanding, carriers can't do much except force elected officials to get to the bottom of the matter and urge customers to use high-level encryption. "If ISPs [Internet service providers] and application providers learned how to teach their customers to encrypt their e-mail, then there would be no possible way that any law-enforcement agency on Earth could break all of the traffic," says Bill Schrader, CEO of PSINet Inc. (Herndon, Va.).

Echelon. It is unclear if Burton has agreed, but ENZYME LETS ALGAE PRODUCE HYDROGEN

Researchers have found a metabolic switch in algae that allows the primitive plants to produce hydrogen gas—a discovery that could ultimately result in a vast source of cheap, pollution-free fuel.

Hydrogen, which can be used as a clean-burning fuel in cars and power plants, is virtually limitless in availability, because it is part of the water molecule. It is a candidate to become the world's primary fuel in coming decades.

But until now, it was obtainable in quantity only through relatively expensive extraction procedures involving the electrolysis of water or processing natural gas.

The breakthrough, by scientists at the University of California at Berkeley and the U.S. Department of Energy, would make possible the commercial production of hydrogen gas by photosynthesis in tanks, ponds or the open ocean.

"I guess it's the equivalent of striking oil," said Tasios Melis, a microbial biology professor at UC Berkeley. "It was enormously exciting. It was unbelievable."

Melis made the discovery with UC Berkeley researcher Liping Zhang and with Michael Seibert, Maria Ghiardi and Marc Forestier of the National Renewable Energy Laboratory, a Department of Energy project in Golden, Colorado.

The team's findings appear in this month's issue of *Plant Physiology*, a science journal.

Seibert said it has been known for decades that algae give off small amounts of hydrogen. The problem from a commercial perspective, he said, was hydrogenase—an enzyme that produces hydrogen, but does so only in the absence of oxygen.

All green photosynthetic plants—including algae—consume carbon dioxide in the presence of light to build tissue, respiring oxygen as a waste product.

"But because hydrogenase shuts down in the presence of oxygen, it doesn't function during photosynthesis," he said. "It basically only works during darkness, when photosynthesis isn't occurring."

Because plant functions are at low ebb during darkness, Seibert said, the amount of hydrogen produced is minimal.

But the team was able to solve the problem, said Seibert,

by imposing a "nutrient stress" to the algae.

"First we grow out the algae, 'fatten' it under normal photosynthetic conditions," he said. "Then we withhold sulfur."

Sulfur is critical for the completion of normal photosynthesis, Seibert said. In the absence of the element, the algae ceased emitting oxygen and stopped storing energy as carbohydrates, protein and fats.

Instead, the algae cells began using "an alternative metabolic pathway" to exploit stored-energy reserves anaerobically—in the absence of oxygen. The hydrogenase was activated, splitting large amounts of hydrogen gas from water and releasing it as a byproduct.

"The significant thing is that the plant is using the energy of the sunlight to produce hydrogen, not oxygen," said Melis. "Without sulfur, it produces a great deal more hydrogen in the presence of light than it does under normal circumstances in the dark."

The algae ultimately would die if the nutrient stress were maintained for more than a few days, but they can be "fattened" again with sulfur and sunlight, allowing for repetitions of the process and continued harvesting of hydrogen gas.

Eventually, the process could be used for the production of huge quantities of hydrogen. Hydrogen burns clean and hot, and it constitutes one-third of the water found in the Earth's oceans, rivers, lakes and atmosphere.

Cars already have been developed that run on hydrogenpowered devices known as fuel cells. These vehicles are virtually pollution-free; the only substance emitted from the tailpipe is water vapor. They do not release carbon dioxide or other heat-trapping gases, which are widely considered the primary culprits in global warming.

Fuel cells big enough to power electrical generating plants could also be built.

"Our long-term goal is to develop strains of algae that we would grow in mass cultures to produce enormous quantities of hydrogen gas," said Melis. "But at this point, we have to improve the production performance."
