

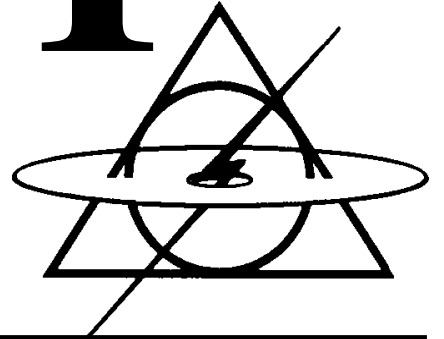

HERPES HIDES BUT VIRUS CAN STILL INFECT

People infected with genital herpes can spread it even between flare-ups, when they have no symptoms, new research suggests.

Until recently, patients and

even most doctors thought people with herpes could safely have unprotected sex when they had no symptoms, which can include painful, oozing blisters, fissures and tingling and burning. Most doctors advised patients to abstain from sex during flare-ups.

In a study disproving some myths about the widespread incurable virus, University of Washington researchers found it in genital secretions even when patients did not notice symptoms.

“The message from this study is first to encourage people who might be at risk for genital herpes to be tested and, No. 2, they should abstain during outbreaks and use condoms at all other times,” said Dr. Anna Wald, Assistant Professor in the Department of Medicine and Epidemiology.

The study was reported in today’s *New England Journal of Medicine*.

Genital herpes, usually caused by the herpes simplex virus type 2, lurks in about one-fourth of U.S. adults, although only an estimated 20 percent of them know it.

Drugs can reduce the severity and frequency of

THE NEW WORLD ORDER ASSURES A DARK PROSPECT IN THE 21ST CENTURY

Former U.S. President George Bush said it casually in September 1990: "The Persian Gulf crisis is a rare opportunity to forge new bonds with old enemies... Out of these troubled times, a New World Order can emerge, under a United Nations that performs as envisioned by its founders." Four months later, he was quoted as saying: "We have before us the opportunity to forge for ourselves and for future generations a New World Order, a world where the rule of law, not the law of the jungle, governs the conduct of the nations." Later in the same month, Bush would say the same thing: "The world can, therefore, seize the opportunity (the Gulf crisis) to fulfill the long held promise of a New World Order."

Five years later, in Davos (Switzerland), George Soros said: "The globe is in need of a New World Order." His comment echoed those of President Bill Clinton, who addressed the opening session of the Davos forum.

What do these people mean? "A One World Government and one-unit monetary system, under permanent non-elected hereditary oligarchists, who self-select from among their numbers in the form of a feudal system as it was in the Middle Ages. In this one-world entity, population will be limited by restrictions on the number of children per family (as in Red China), diseases, wars, famines, until one billion people who are useful to the ruling class, in areas which will be strictly and clearly defined, remain as the total world population," writes Dr. John Coleman in his monumental book, *Conspirators' Hierarchy: The Committee of 300*.

Under this New World (Dis)Order, "There will be no middle class, only rulers and servants. All laws will be uniform under a legal system of world courts practicing the same unified code of laws, backed up by a one-world police force and a unified global military to enforce the laws in all former countries where no national boundaries exist. The system will be on the basis of a welfare state; those who are obedient and subservient to the one-world government will be rewarded with the means to live; those who are rebellious will simply be starved to death or declared outlaws, thus a target for anyone who wishes to kill them (as practiced in North Korea). Privately owned firearms or weapons of any kind will be prohibited," adds Coleman. This will explain why, in almost all countries, there is a strong lobby for a "gunless society". These movements are financed by the globalists.

According to Coleman, "Only one religion will be allowed and that will be in the form of a one-world government Church, which has been in existence since 1920.... Satanism, Luciferianism and Witchcraft (take note of movies being shown regarding this subject) shall be recognized as legitimate... All Christian churches have already been subverted and Christianity will be a thing of the past in the one-world government."

The New World faith synthesis to replace all religions, especially Christianity, is usually called UNIVERSAL BROTHERHOOD. It is the end product of the Chicago WORLD PARLIAMENT OF RELIGIONS in 1893 and other succeeding fora campaigned for by such groups as the Baha'is, Theosophists, Unitarians, World Council of Churches and a host of similar bodies in every country.

Although the syncretistic religion was very much

evident in the 1920s, it was not until 1950 when a formal organization was established. In 1983, John Cotter of the Canadian [Security] Intelligence Service [CSIS] revealed the names of the WORLD BROTHERHOOD MOVEMENT big-wigs, which included U.S. President Dwight D. Eisenhower, John Foster Dulles, Allen W. Dulles (CIA chief), Henry R. Luce (*Time* and *Life* magazines), Herbert Lehman, Paul Hoffman, George Meany, Norman Thomas, Mrs. Eleanor Roosevelt, John F. Kennedy, John J. McCloy, Adlai Stevenson, Chief Justice Earl Warren, Canadian ex-PM John Diefenbaker, liquor multi-millionaire Samuel Bronfman, German ex-Chancellor Konrad Adenauer, ex-NATO Secretary-General Paul-Henri Spaak, ex-UN Secretary General Trygve Lie, French ex-PM Paul Reynauld, Marcus Wallenberg (Swedish bank President whose family once controlled the Nobel Prize awards), Prince Bernhard of the Netherlands, Madame Pundit and Dr. S.S. Radhakrishnan of India, the Shah of Iran, Carlos P. Romulo of the Philippines, Sir Zafrulla Khan of the International Court of Justice and many others (*A Study in Syncretism*, p. 17).

Continuing with the New World Order set-up, Coleman states, "Pornography shall be promoted and be compulsory showing in every theater or cinema, including homosexual and lesbian pornography. The use of 'recreational' drugs shall be compulsory, with each person allotted drug quotas which can be purchased at the one-world government stores throughout the world. Mind-control drugs will be expanded and usage become compulsory. Such mind-control drugs shall be given in food and/or water supplies without the knowledge and/or consent of the people. Drug bars shall be set up, run by one-world-government employees, where the slave-class shall be able to spend their free time. In this manner, the non-elite masses will be reduced to the level and behavior of controlled animals, with no will of their own and easily regimented and controlled."

The July 2, 1999 editorial of the *Executive Intelligence Review* entitled "The IMF Demands Blood Money", tells it all: "Colombia, a nation which has been virtually assassinated by bestial armies of narco-terrorists, has now been told by none other than the International Monetary Fund (IMF) to legalize the illicit drug trade on which narco-terrorists depend. The message was delivered in the form of a 'recommendation' that the country include income from illegal drug crops in national statistics and calculation of Gross Domestic Product. In other words, Colombia is now supposed to count blood money as a national asset... Back in the mid-1980s, IMF and World Bank officials nonchalantly told *EIR* researchers that drug crops should be treated the same as other commodities and that their revenues could be used to enhance the country's solvency."

How do you think the IMF and World Bank will dispose of the huge amount of drugs paid to them by Third World countries out of their "Gross Narco Product"?

Let's continue with Coleman's exposé. "The economic system shall be based upon the ruling oligarchical class allowing just enough foods and services to be produced to keep the mass slave-labor camps going. All wealth shall be aggregated in the hands of the Elite members of the Committee of 300. Each individual shall be indoctrinated to understand that he or she is totally depending upon the state for survival. The world shall be ruled by Committee of 300 Executive Decrees which become instant law. Boris Yeltsin is

using Committee of 300 decrees to impose the Committee's will on Russia as a trial run. Courts of punishment and not courts of justice shall exist."

The *maquiladora* system in Mexico is a classic example of the New World Order's economic structure. The IMF forced Mexico to stop producing for domestic consumption, and to export like crazy in order to earn foreign exchange with which to pay the foreign debt. As *EIR* noted, "Production of market-based items for the domestic economy shriveled, and national employment fell with it, while the *maquiladora* sector geared up significant manufacturing production—all of it for export. Thus, while Mexico proper was losing 700,000 manufacturing jobs after 1981, employment in the *maquiladora* assembly plants grew from only 131,000 to 707,000 in 1996 to 1,050,000 in June 1998."

These slave-labor camps may be located on Mexican soil; they may employ Mexican workers, but they are, in fact, foreign enclaves on Mexican territory, which assemble goods out of imported parts and export largely semi-finished and finished products, mainly to the U.S. Admittedly, even the miserable slave wages that the workers are paid scarcely have an impact on Mexico, because a large percentage is used by the workers for purchases across the border. Mexicans are just like Filipinos. They prefer PX goods over locally manufactured ones.

"The only thing the *maquiladoras* leave Mexico, is a monstrous social and political bill for the 'privilege' of providing slave labor to facilitate debt repayment. Gigantic urban ghettos of *maquila* workers and their families have spread along the border, with little or no infrastructure available. The squalor and health hazards are matched only by the slave-labor working conditions that the assembly workers (in their majority, young women and girls) are forced to endure... the *maquiladoras* are far worse than a foreign enclave on Mexican soil. By all rights, they must be considered an economic cancer, which has grown prodigiously on the body of the Mexican economy," reads a portion of the *EIR* report on Mexico in February 1997.

What about public health for the old and infirm? Here's Coleman's reply: "Euthanasia for the terminally ill and the aged shall be compulsory. No cities larger than a predetermined number as described in the work of Kalgeri. Essential workers will be moved to other cities if the one they are in becomes overpopulated. Other non-essential workers will be chosen at random and sent to underpopulated cities to fill 'quotas'... those who refuse to go shall be exterminated in the manner of the one-world-government experiment carried out by Pol Pot in Cambodia."

What about hospitals and medical services for the young and middle-aged? "All essential and non-essential pharmaceutical products, doctors, dentists and health workers will be registered in the central computer data bank and no medicine or medical care will be prescribed without express permission of regional controllers responsible for each city, town and village," says Coleman. "At least four billion 'useless eaters' shall be eliminated by the year 2050 by means of limited wars (wars of attrition), organized epidemics of fatal, rapid-acting diseases and starvation. Energy, food and water shall be kept at subsistence levels for the non-Elite, starting with the White populations of Western Europe and North America and then spreading to other races. The population of Canada, Western Europe and the United States will be decimated more rapidly than other continents (this is debatable), until the world's population reaches a manageable level of one billion, of which 500

million will consist of Chinese and Japanese races, selected because they are people who have been regimented for centuries and who are accustomed to obeying authority without question."

It is no longer a secret that the Haig-Kissinger depopulation policy has taken over various levels of the U.S. Government and is, in fact, determining U.S. foreign policy. The planning organization operates outside the White House and directs its entire efforts to reduce the world's population by 2 billion people "through war, famine, disease and other means necessary" (*Behold a Pale Horse*, William Cooper, p. 169). This group is the National Security Council's (NSC) *ad hoc* group on population policy. The policy planning staff is in the State Department's Office of Population Affairs (OPA), established in 1975 by Henry Kissinger. This same group, in cooperation with Dr. Aurelio Peccei's Club of Rome, prepared the now infamous Global 2000 Report submitted to then U.S. President Jimmy Carter.

"The real reason the Shah of Iran was overthrown was that his best efforts to institute 'clean programs' of birth control failed to make a significant dent in the country's birth rate... Under Ayatollah Khomeini, the clean programs have been dismantled. The Government may make progress because it has a program 'to induce up to half of Teheran's 6 million residents to relocate', writes ex-globalist conspirator William Cooper; 'Iran's war with Iraq really pleased the OPA... Marcos fell victim to the same policy.'"

Other means of population control have, likewise, been promulgated. For example, tobacco fields in the U.S. have been fertilized with the radioactive tailings from uranium mines, resulting in a tremendous increase in the incidences of lip, mouth, throat and lung cancer.

Malathion, a nerve gas developed by the Nazis during World War II to kill the enemy, is being sprayed regularly on population centers in California. The alibi used is that it will kill the Mediterranean fruit fly!

Heart disease used to be a very rare illness. Now it is an epidemic. A century ago, people consumed more sodium (salt), cholesterol and everything else on which heart disease is blamed, but still the disease remained rare. Why do you think it has become one of the world's leading killers?

To begin with, there's dioxin, one of the deadliest chemicals known to man, present in drinking water in alarming levels in America and Europe. Then you have the periodic release of germs and viruses into the atmosphere by armies testing their biological-warfare capability. The U.S. Central Intelligence Agency's "Project MK-NAOMI" launched in the Bay Area of San Francisco (U.S.) a few years ago, is a case in point. Many still recall the experimental bacteria known as "Legionnaire's Disease" released from a Government-operated boat.

Some areas of the world now have such a high rate of cancer that virtually anybody who lives in those areas will die of unnatural death. The true extent of radioactive gases, waste and toxic material, especially cesium-137, strontium-90, uranium-mine and mill tailings, thorium-230, radium-226 and radon-222 that leaked or has been purposely planted in the atmosphere, soil and ground water is far beyond anything we can imagine. Cover-up has become SOP (standard operating procedure) at all levels and in all departments of all governments.

Another cause of widespread depopulation is the *North American Free Trade Agreement (NAFTA)* ban on DDT, which is costing more lives. Here's why:

Since its discovery in 1942, DDT has saved more lives than any other man-made chemical, without any toxic

effects on man. When DDT was banned in the United States in 1972, for admittedly political reasons, and was then removed from use in most tropical countries, the incidence of malaria and deaths from malaria skyrocketed. Now, in Africa, for example, an estimated 1 to 2 million children die every year from malaria, a preventable and curable disease. Hundreds of millions more children and adults are weakened by the disease.

Mexico and a few other nations where malaria is endemic have continued to produce and use DDT for malaria control in public-health programs (until 2007, per *NAFTA*), because it is the most effective and inexpensive way to control disease-carrying mosquitoes. (Replacement pesticides are 14 to 19 times more expensive, have to be applied more frequently and are more toxic.) Studies have shown that a small amount of DDT sprayed on house walls twice a year, at a cost of \$1.44, can effectively control malaria, even when the mosquitoes are resistant, because of the excito-repellant effect. The mosquitoes are repelled by the DDT sprayed on house walls and do not stay around to bite the residents.—(Report of *EIR*'s Marjorie Mazel Hecht, July 31, 1998)

[H: Note: If you kill off the HIV "CARRIERS" and "SPREADERS", you slow up depopulation, however, don't you? And the side-effects of such as DDT? Well it is shown that DDT can cause birds to lay defective-shell eggs. WHO SAID? My dears, anytime you have birds, they can have "anything" from anyplace along their migration route. Am I saying DDT is "not bad"? NO, ALL PESTICIDES ARE BAD BECAUSE IN KILLING OUT ONE THING YOU ALSO KILL OUT OTHER THINGS—WHAT I AM EMPHASIZING IS THAT THERE IS A STEADY MARCH TO YOUR DEMISE, INTENTIONALLY PRODUCED, AND WHEN EVERYTHING IS OUT OF BALANCE, YOU ARE OUT OF BALANCE AND CAN BE KNOCKED OFF YOUR TIGHT-WIRE WITHOUT FURTHER EFFORT.

When a malaria-bearing mosquito bites, the DNA of the HIV structure is automatically converted (mutated), then when that same mosquito introduces that malaria (or any blood-carried disease) into another host, the mixture of the digestant with the first virus or microbe is introduced into the host as well. The digestant of the mosquito is a protection for the carried microbe, so that BOTH are introduced into the new host and then break down allowing full merging with whatever microbe the host might also be carrying, e.g., HIV is a good one to look at because it hides nicely within cells—the digestant from the new "injection" protects the introduced microbe but BREAKS DOWN THE WALL OF THE HOST CELL OF THE HIV and allows instant merging. I will get into this later. So, is DDT bad? YES, but so are plague-carrying vermin!

21st Century Science & Technology, a U.S.-based publication, came out with two successive reports on DDT and malaria in 1992 and 1993 to prove that DDT is, indeed, the "mother" of environmental hoaxes. "The U.S.

Environmental Protection Agency (EPA) hearing officer, Edmund Sweeney, ruled that DDT should not be banned, based on scientific evidence: DDT is not carcinogenic, mutagenic or teratogenic to man, and these uses of DDT do not have a deleterious effect on fish, birds, wildlife or estuarine organisms. But two months later, without even reading the testimony, EPA Administrator William Ruckelshaus banned DDT," writes Marjorie Hecht. "He admitted that he made the decision FOR POLITICAL REASONS." WHY? ALEXANDER KING, FOUNDER OF THE MALTHUSIAN CLUB OF ROME, gave the answer in his biographical essay in 1990: "MY CHIEF QUARREL WITH DDT IN HINDSIGHT IS THAT IT HAS GREATLY ADDED TO THE POPULATION PROBLEM."

WHEN IT COMES TO WHOLESAL DEPOPULATION, THE IMF IS THE MOST USEFUL TOOL OF THE GLOBALIST CONSPIRACY. The IMF's conditionalities are the crux of the matter, as they are all deliberately geared to wrecking the physical economy of the victim nation. To wit:

DEVALUATION: Forced devaluations are always accompanied by demands that the nation not permit this to lead to an "inflationary spiral", meaning that the devaluation will artificially increase the cost of the foreign debt and of all imported items; but local costs of production, most especially wages, are to be forcefully held down. The net effect is that real wealth is transferred out of local consumption and into exports, in order to obtain foreign exchange with which to pay the foreign debt.

REDUCTION OF THE GOVERNMENT BUDGET DEFICIT: Countries are instructed that they must raise more tax revenue; eliminate government subsidies for food and other necessities; privatize and otherwise dismantle technology; and stop investing in infrastructure projects needed for national development. The only line in the government budget which is allowed to skyrocket is interest payments on the public debt. Needless to say, these measures all damage the physical-economic output of the country.

FREE TRADE: This is the oldest trick in the British colonial book: National industry is destroyed by a flood of

cheap, foreign imports, leaving the country with no productive apparatus of its own.

HIGH INTEREST RATE: This is supposed to "stop inflation", but the only thing it stops is economic activity. With domestic interest rates driven up to 40, 50 and 60%, the national banking system is quickly drowned in a sea of non-performing debt. Any borrowing for productive activities is made prohibitively expensive.

GLOBALIZED BANKING: Under the rhetoric of "the free flow of international capital", the weakened financial system in the victim nation is taken over by foreign banking interests, frequently linked to drug-money laundering. Once globalized, such a banking system will not bother lending to any local, productive enterprise.

"END CORRUPTION": This refrain, which has recently been incorporated as an IMF conditionality, simply means that any and all political opposition to the IMF's destruction of national sovereignty must cease.

Just look at the face of Hell awaiting every nation on this planet, should these globalist policies continue. Look at Russia, for instance. Since 1992, the annual rate of population loss in the Russian Federation has been "more than double the rate of loss during the period of Stalinist repression and mass famine in the first half of the 1930s", economist Sergei Glazyev states in his 1997 book, *GENOCIDE*, on the supposed reform process in Russia. The title was lifted by Glazyev from Article II of the 1948 *UN Genocide Convention*, which defines as genocide "actions committed with the intention of annihilating, completely or in part, some national, ethnic, racial or religious group as such". Sections C and D of Article II specify among the instruments of this crime, "The premeditated creation for any group of people of such conditions of life as are intended to cause the physical destruction of the group in whole or in part," and "measures intended to prevent births within the group".

From 1992-98, Russia experienced an excess of deaths over births in each of those six years, ranging between 600,000 and 890,000. Four-and-a-half million more people died than were born in that period.

According to economist Rachel Douglas, "The disaster in Russia resulted from the political enforcement of an evil and insane idea: British 'free market' liberalism." In the midst of the power crisis in Moscow in August 1991, which marked the disintegration of the Soviet Union, the London *Times* announced what was about to be inflicted on Russia: It reported that Lord Harris of High Cross, chief of the Mont Pelerin Society's Institute for Economic Affairs (IEA), in London, was viewing Russia as "the perfect laboratory" to test out Thatcherism and was ready to move in.

Dr. John Coleman defines the Mont Pelerin Society as "an economic Foundation devoted to issuing misleading economic theories and influencing economists in the Western world to follow models it lays out from time to time". Its leading practitioners were Friedrich Von Hayek and Milton Friedman.

THE POST-KOSOVO PERIOD

By Erick San Juan

The globalists' wars of attrition, featuring rival factions such as Arabs and Jews and African tribes, will continue. Differences will be magnified and wars of extermination will be waged against each other, under the watchful eyes of NATO and UN observers. The same tactics will be used in every continent where large groups of people with ethnic and religious differences live, such as the Sikhs, Tamils of Sri-Lanka, Moslem Pakistanis and Hindu Indians, etc.

Meanwhile, only genuine reconstruction will secure peace in the Balkans. The conflict in Kosovo has caused a deterioration of the global security situation, making it more imperative for U.S. President Bill Clinton to “bring Russia and relevant nations of Western Europe into the effort of building an exit strategy” in that region.

Kosovo and the nearby areas have the potential to turn into a new Thirty Years War, and even drag the rest of the world with them.

Controlled media and NATO call the Serbian action against those whom they refer to as “ethnic Albanians” as “ethnic cleansing”. The real issue, however, is nationalism. “The Serbian people have continually assumed that in every century, they would again find it necessary to defend their rights to their land, self-determination and freedom of worship. History in the Balkans continuously repeats itself! In 1690, more than 180,000 Serbs were forced from Kosovo and, again, an equal number were exiled in 1737. After the Congress of Berlin in 1878, another 150,000 Serbs were expelled. This ongoing trend took on tragic proportions following the war in Crete between Turkey and Greece in 1897. Diplomatic efforts to stem the tide of atrocities against

Serbs were useless, but documentation remains to testify to the crimes committed against the Serbian population. The Balkan War of 1912 was fought not only by Serbs but also by Montenegrans, Bulgarians and Greeks to liberate their people from centuries of uninterrupted Islamic aggression. The situation is little changed today,” writes W. Dorich, author of the 1992 book, *Kosovo*.

On July 30, 1998, Sara Flounders wrote an article exposing what could be the real reason behind the globalist-inspired Balkan conflict, entitled “THE WAR IS ABOUT MINES”. She began her article by stating, “Wars are at root about economics, and the rapidly expanding war in Kosovo is no different. So why have millions of dollars in high-tech weapons suddenly become available to the so-called Kosovo Liberation Army by way of the U.S. and Germany?” To her amazement, Flounders discovered that what *New York Times* correspondent Chris Hedges had already uncovered, is true: The real wealth of Kosovo is the “Stari Trg mining complex”, rich in lead, zinc, cadmium, gold and silver.

Flounders continues, “according to the mines Director, Novak Bjelic, the War in Kosovo is about the mines, nothing else. This is Serbia's Kuwait—the heart of Kosovo. In addition to all this, Kosovo has 17 billion tons of coal reserves. The United States Government has stated that our national interests are at stake, but they do not define what those national interests are. U.S. United Nations Ambassador Richard Holbrooke, President Clinton or the Pentagon generals never publicly discuss the enormous mineral wealth of Kosovo. They speak only of ‘self-determination’ of the Albanian population of Kosovo. Of course, they never mention what U.S.-imposed ‘self-determination’ means. It means colonization under the guise of ‘liberation’, like what the U.S. did to Puerto Rico, Cuba and the Philippines a hundred years ago.”

The average person has no idea that the wealth of Stari Trg is legendary, and that the blood, sweat and tears of millions of laborers throughout Yugoslavia built this mining complex, and it belongs to the sovereign state of Yugoslavia.

As the world financial system crumbles, the **British-American Commonwealth (BAC)** apparatus, also known as the Anglo-American Establishment, the real brains behind the bombing of Yugoslavia, is using the “humanitarian” and “human-rights” crises it helped to create, to wage war against the nation-states.

In the Sudan-Eritrea conflict in Africa, the entire strategy of the British has been to utilize the so-called frontline states—Uganda, Ethiopia, Eritrea and Egypt—as bases of military and/or political operations against the Khartoum Government. Part of the British plan against Sudan has been economic warfare. It was through British efforts that sanctions against Sudan were pushed through the UN Security Council in January 1996. “If the country could be isolated economically, the population, under increasing hardship, could be prevailed upon to rise up against it.” So far, this strategy has not worked in Iraq or Sudan.

London's genocide against the Africans, also known as the “Kampala Plan” that did not originate in any African capital (but with Field Marshall Montgomery in the 1940s), calls for the re-division of Africa into six mega-countries: Sahara Republic, Senegambria (West Africa), Central Africa, Erithomia (sections of the Horn of Africa), Mozambica (southern Africa) and the Swahili Republic.

Th UPDF, together with its spin-off, the Rwandan Patriotic Army, has made tremendous progress since 1994 on the formation of the “Swahili Republic”. The new entity is to include Uganda, Rwanda, Burundi, Kenya, Tanzania, southern Sudan, most of Angola and the Democratic Republic of Congo. While the East African community of Tanzania, Uganda and Kenya is being put together diplomatically, wars have brought Rwanda and Burundi into the Ugandan orbit. With regard to Sudan, Uganda continues to support the military operations of John Garang and the British-backed Sudanese People's Liberation Army against the Government. Its troops have established a Ugandan military and civil base in the Congo city of Kisangani. Ugandan military equipment and advisers are also in Angola to support Jonas Savimbi's UNITA, against the MPLA Government in Luanda.

“British policy toward Africa has two primary essentials,” writes Linda de Hoyos of *EIR*, “to develop the resources and to effect such a grouping of British (Commonwealth) Africa as will break down the many existing barriers” (July 30, 1999).

Meanwhile, in the next flashpoint, which is the Caucasus region, Chechen incursions into Russia could result once more in a wrong Russian response, that is, sending troops into Chechnya, again. Less than two months since Stepashin became Prime Minister, Russian counter-escalation has begun. With Putin, an ex-KGB spy, it could even be worse. “The change in Russian policy is dangerous, and a potentially fatal response according to profile, to a dramatic escalation in British-steered irregular warfare, using Chechen and imported ‘Mujahideen’ assets against the Russian Federation,” writes *EIR* political observer Konstantin George. He sees a Russian version of the “Domino Theory”, with the growing danger of a Caucasus quagmire.

Another potential flashpoint, as we have pointed out in one of our articles, is the Transcaucasus, which, since the dissolution of the USSR, has existed as three newly independent republics: Georgia, Armenia, and Azerbaijan.

Developments in this region, along with the Caucasus, mirrors a London-driven strategic decision to replay, in geopolitical essentials, the “royal board game” by which the Russians were severely battered and contained during 1815-54, from the end of the Napoleonic Wars until the outbreak of the Crimean War. During that time, Russia was bogged down in military involvement in the Balkans (when the British were playing the Ottoman Empire off against Russia), in wars in the Caucasus, including a 20-year war against the Chechens and, finally, wars in Central Asia. “Now, as then, the British aim has been to engage Russia in three theaters of a protracted conflict: the Balkans, the Caucasus and Central Asia,” according to Konstantin George.

The British-sponsored terrorist, Osam al bin Laden, the self-proclaimed mortal enemy of both Russia and the United States, is reported to finance the operations of the Chechen and Mujahideen groups operating from Chechnya. They are bin Laden's “Afghansi” guerillas, veterans of fighting Soviet groups in Afghanistan.

Close to home we have China, which the BAC is attempting to “surround”, “isolate” and “carve up”. The BAC, together with the Anglophiles operating inside the Clinton Administration, is bent on sabotaging any “constructive engagement” or strategic relationship between the United States and China. To this end, NATO is said to have deliberately bombed the Chinese

Embassy in Belgrade, while, at the same time, the U.S. Congressional "Cox Committee" released a report claiming that China had stolen U.S. military technologies.

The BAC game plan against China was explicitly laid out by Gerald Segal, of London's Institute of Strategic Studies, in a March 1994 paper entitled "CHINA CHANGES SHAPE, REGIONALISM AND FOREIGN POLICY", promoting the dividing of China. "The outside world has no interest in the formal breakup of China. But... it may be the only way to ensure that China does not become more dangerous as it grows richer and stronger, is to ensure that in practice, if not in law, there is more than one China to deal with." Reverberating the patented British "divide and rule" policies for more than two centuries, Segal's paper laid out a perspective to involve not only the then Crown colony of Hong Kong, but also Taiwan and Japan in the process.

Lee Teng-hui's recent utterances are a confirmation of the BAC's design to "surround" and "isolate". By stating that the China-Taiwan relations are now "nation-nation" or "special state-to-state" ties, he has made clear that he is playing the BAC's geopolitical cards. Lee asserted, "Taiwan's geographical position allows it to control sea routes in the western Pacific Ocean which are very important to the United States, Japan and Southeast Asian countries. Therefore, whether in cross-Strait relations or regional stability, Taiwan is playing an important role."

China's response, of propping up North Korea, is a trap cleverly laid out by BAC operatives. It only hastened the missile-defense cooperation between Japan, the U.S., South Korea and even Taiwan. Recently, India (now China's ally) protested the newly signed defense pact between Japan, the United States and Australia. Japan represents America's northern anchor, while Australia represents the southern anchor.

In 1996, Lyndon LaRouche warned of exactly the kind of scenario that is now unfolding before our eyes. He wrote:

"The U.S.'s vital strategic interests are threatened by a coordinated series of destabilizations, ringing China, all coordinated by the British Foreign Service and its intelligence arms. These British-fired hotspots include Britain's 'Pushtunistan'-oriented Taliban operations into Afghanistan, Kashmir and Pakistan itself. They include the British campaign to coordinate the overthrow of the present Government of Myanmar on the usual, flimsy 'human rights' pretexts. It includes the attempt to induce Japan to perceive itself as taking political hegemony over the northern tier of China (and Mongolia), from the central Government in Beijing. It includes the repeated efforts by London and their U.S. Republican Party assets, to destabilize the uneasy peace between the northern and southern portions of Korea..."

The provocateurs who are behind the current media-hype may just succeed in forcing China to commit a crisis far worse than the scale of March 1996, when the U.S. sent an aircraft carrier into the Taiwan Strait after a world media hype about Chinese military maneuvers.

Meanwhile, the New World Order's economic planners have not moved one iota away from their original banking masterplan, and the mergers we currently see are a giant step toward their direction. "No central bank—save the Bank of International Settlements (BIS) and the World Bank—shall be allowed to operate," says Coleman.

Coleman also insists that part of the masterplan calls for "only ten banks allowed to transact business globally". The merger agreement announced recently by Dai-Ichi Kangyo Bank, Ltd., Industrial Bank of Japan, Ltd., and Fuji Bank, Ltd., which has created the world's largest financial institution—has been ominously described as "the start of something big".

About this gigantic merger, Toru Nakakita, a professor of economics at Tokyo University, has this to say: "I hate to say

this but I think we've created another *Titanic*: We have the biggest bank in the world but it's certainly not the most competitive." True. That's because the Japanese are not the frontliners in the dash, not for money, but for the post-crash scramble. The BAC has long devised a plan to trigger a world-banking-system collapse. But first, they must get their hands on all the world's gold reserves.

The head of the Bank of England, Eddie George, is expecting the world financial system to explode very soon. This is the reason behind this latest caper, scam if you wish, of setting up a special, private market, for allowing certain cronies to raid the bank's gold reserves, which includes among others, Long Term Capital Management (LTCM), the financial backers of Vice-President Al Gore's White House ambition, and prominent members of the London Gold Bullion Market Association (LBMA) headed by AIG International, Goldman Sachs' J. Aron & Co., Bank of Nova Scotia-Mocatta, Barclays, Chase Manhattan, Credit Suisse-First Boston, Deutsche Bank, HSBC, Midland Bank, Morgan Guaranty Trust (J.P. Morgan), N.M. Rothschild & Sons, Republic National Bank of New York and UBS AG.

To make matters worse, these leading bankers are running worldwide scams, raiding their own banks, in operations even worse than Eddie George's pilfering of the Bank of England's gold reserves. "Before these current, globalized swindles come to an end, it will be the taxpayers—including the U.S. taxpayers and ordinary bank depositors—who will have been cheated by the Bank of England and its Wall Street accomplices," says Lyndon LaRouche, Jr. (*EIR*, July 30, 1999).

The overall financial picture is becoming clear. To avoid a collapse before the appointed time, the bankers are bolstering the financial system with drug money. There are several indications of this state of affairs, the clearest of which is the visit of New York Stock Exchange (NYSE) Chairman Richard Grasso to the southern jungles of Colombia, to strike a deal with the drug-running Revolutionary Armed Forces of Colombia (FARC), the largest cartel dominating the dope trade from Colombia today. This is the rationale behind the IMF's and Wall Street's campaign for drug legalization!

As early as 1978, Lyndon LaRouche already gave a clear picture of the prospect (?) of world and regional situation in the 21st Century. He said, "The threatened tidal wave of drugs is the first phase of a deliberate and operational plan by the World Bank, International Monetary Fund and allied London, Amsterdam and turncoat American financiers. They are engaged in forcing major portions of the Third World to abandon 'expensive, wasteful' development hopes and become profitable, starving narcotics plantations. The minds and bodies of America's youth are to be sacrificed to this debt-and-austerity imperative, along with the lives of millions in the Third World, even as these bankers extol the economic benefits of expanding the drug trade."

Which drove Michael Baigent, Richard Leigh and Henry Lincoln, the authors of *The Messianic Legacy*, to write, in 1986, the following words:

"If 'mankind' is destroyed, it will not be by 'man' but by a handful of specific individuals whose power, derived from the trust reposed in them, has been mishandled and abused... It is not ultimately 'humanity', but a frighteningly small conclave of political figures—some more or less 'democratically elected', some not—who wield the authority of life and death over the entire planet. Some of them are intelligent and responsible, but some are unimaginative, insensitive, even positively stupid. Some are manifestly incompetent. Some are arguably insane, to one or another degree. Yet, it is they who, with a signature appended to a document, or even with a single spoken word, can send individuals into battle, can determine people's nationalities, can dictate the circumstances in which one lives, can pronounce

where one can go or cannot go, what one can do or cannot do. It is they who, for example, by drawing a line on a paper map, can conjure a 'frontier' into being, a barrier as restrictive and insurmountable as any physical wall. They can even order the construction of a physical wall to mark the fictitious 'frontiers' they have invented. And it is they, not 'humanity' who, if there is, indeed, to be an apocalypse, will bring it about" (p. 221).

Very few people are cognizant of the fact that the whole world is presently in the process of being dismembered and reassembled in the utopian image in accordance with the alchemical adage so precious to secret societies, *Solve et coagula*, dissolve and consolidate. According to the traditional Catholics we have spoken to (most of whom are "in the catacombs", so to speak), out of this rearrangement of the world map will rise "a great satanic world republic", which was shown to the prophet Daniel under the figure of a beast "terrible and exceedingly strong, which shall be greater than all the kingdoms and shall devour the whole Earth and shall tread down and break it in pieces" (*Dan. 7:7,23*). Through the press and media of all sorts, the President has now a rating of minus 32%. That is a lie in all circumstances, for out of 100 phone calls reaching no one except the ones known to be against the President, there were still several “for” the man. So, you don’t even have “0” percent, do you? And, furthermore, you CANNOT have minus 32 percent (-32%). One hundred percent is all you can have either way!

But is it important? Yes! It is the most important thing for consideration in Southeast Asia today.

WHITE KNIGHTS

So, you might ask in a reasonable conversation: “Why don’t we just fix it?” Because our white hat, white horse and white suit might well be clean and whole—but nothing else is ready. We already have some who have come to hurriedly get help to have assets to cover what they have themselves

participated in using, which brings shortages in the accounts of various banks and places of important fund accounting.

For an agenda, arrangement or grouping to qualify as a conspiracy, exactly who, what and how many must be involved? On Tom Valentine's *Radio Free America* broadcast, Retired U.S. Army Colonel L. Fletcher Prouty, the Army's chief liaison to the CIA (1955-1962), pointed to the JFK assassination as one most fitting example.

FOREWORD

According to L. Fletcher Prouty, a conspiracy is born from the agenda of a select "nucleus of core conspirators" in a secret hierarchy, with just a handful, from four to eight, including the chief planner. Coupled with adequate funding and "mattoidal intelligence", this core can conveniently draw and manipulate others into their "sphere of influence", usually without any one of those involved even ever finding about the existence of such complicity and machination.

To carry out a core group's projects and missions, unwitting pawns in the lower echelon, most of the time, do not even know of their direct involvement and view

their participation as simple as taking job/service orders for a price.

Less talk makes less mistakes. Silence is the key in every conspiracy's success. The members' non-familiarization with the core group nor thorough knowledge of the whole project is a most crucial asset in the success of a conspiracy. Secrecy is one strong guiding force.

However, strong and wide connections in the media and print would definitely be a plus factor. This is where disinformation and propaganda play their indelible and impressionable roles. In Oswald Spengler's *Decline of the West* (1924), he expressed the power of the (capitalistic) press in "mass-mind control".

It is interesting to note that most significant conspiracies have been conceived and perpetrated by only a handful of core planners. Fear, on the other hand, is a very powerful motivating force—not only for the underlings, but even among the hardened in the core group. Every one in the nucleus knows for certain that should any one among them suddenly awaken with a conscience to beg to opt out, the core can only be too sure that their professional careers can conveniently be erased by a "manufactured scandal". In the event that any one or even the chief planner decides to divulge the conspiracy, or even, unthinkable, the names of other top planners to print and media, everyone in the core knows for a cold fact that their existence would and could be snuffed out by an "unsolvable" murder, mysterious accident or "suicide".

However, a similar sanction may likewise be meted out to whoever may expose any vital information leading to the conspiracy's burning out. Many mysteriously unsolvable deaths have remained big, bugging question marks to this day.

However, [those] of the public who continually refuse to believe in the existence of any conspiracy become a part of the conspiracy, because by sheer denial or ignorance, they do nothing to help to counteract it, much less report it. "Inaction by otherwise responsible citizens has the same effect as sanctioning a heinous plot."

There have been countless recorded conspiracies to this day. And countless mysterious deaths to boot.

Taking up the presumption that evil does not exist, then on what grounds can we ascertain that some acts are good? This will depend on each one's perception of good and evil. Thus, it can only be safe to conclude, at this point, that every man has an innate sense of good and evil. But in the struggle for the minds of men, consciences often become hardened. That is when evil predominates.

Taking, however, the mechanistic view, it could very well be clearly argued that "might equals right".

THE COLOR RED DAWNS ON THE LOYALISTS

The August 28, 1987 failed coup was a big blow to the rightists. But it did not discourage the Marcos loyalists from attempting their own power grab.

A few days after the RAM fiasco, Colonel Reynaldo Cabauatan, leader of the pro-Marcos Nationalist Army of the Philippines (NAP), issued an open letter to his fellow soldiers in the AFP. It reads:

"You are about to witness the unfolding of a heroic attempt to come to the rescue of our Republic from the control of an admittedly Communist leadership, under Mrs. Aquino. There is no doubt she is a Communist.

Mr. Salvador Laurel came out with documents showing that there are Communists in her government. General Ramos has confirmed the same thing. Even Aquino herself has admitted there are 'harmless' Communists under her leadership. Her actions confirmed the charge that she is a Communist. The 'tora tora' planes were never used against the Communists but they were used against us. Medals were given to those who killed soldiers but not to those who killed Communists. Top Communist commanders were released so they could eliminate and destroy us. What more proof do you want to show that you have been following the orders of a Communist leadership?

"Since you have already obeyed the orders of these Communists in Malacanang, and since your superior officers have also followed the said orders, the time for you to complain has come. We are asking all of you to support the Nationalist Army of the Philippines (NAP), and thereby help us fulfill our constitutional duty to act as the protector of our Republic. Again, when we launch the final attack, no soldier will be shot, and no military camp will be attacked. Pray that Mother Mary, who declared an all-out war against Communism at Fatima in 1917, will guide us through this dark and terrible night of our history. With your help, I am sure we will prevail.

"(Signed)"

No one can deny that since 1917, the corpses created by Communism have numbered in five to eight-digit figures annually. They still do.

As thousands of priests, nuns and churches go up in flames, the so-called "Catholics" of the free world remained unconcerned. They sought no solutions. They did nothing. And they continue to do nothing. Cabauatan realized this fact the hard way.

In 1917, the Jewish Wilson-Baruch Administration inveigled the U.S. into World War I to "make the world safe for democracy". This was accomplished. While Germany and Hungary were fighting Russia, the Jews were secretly preparing a revolution that would operate across the battlefronts to strike them all.

At that time, the brilliant diplomat M. Oudendyke was the Netherlands' Foreign Minister in Petrograd. In the chaos of the deliberate murder of nominally Christian Russia, he sent an urgent communiqué, which he concluded with the following prophetic words: "The foregoing report will indicate the extremely critical nature of the present situation. The danger is now so great that I feel it my duty to call the attention of the British and all Governments to the fact that if an end is not put to Bolshevism in Russia, at once the civilization of the whole world will be threatened. This is not an exaggeration but a sober matter of fact. I consider that the immediate suppression of Bolshevism is the greatest issue now before the world, not even excluding the war which is still raging. It is organized and worked by Jews, who have no nationality, and whose one object is to destroy for their own ends the existing order of things."—*Foreign Relations Papers*, U.S. Department of State, Russia: 1917, pp. 674-679, published 1931

Not too well known is the fact that the Rothschild-Schiff-Kuhn-Loeb-Warburg ring of Jewish international bankers financed the "Russian" Revolution. "It was a family enterprise," according to Jacob Schiff, the German-born Jew who swore to destroy Czarist Russia.

But what should interest Filipinos more is the group's connection with those who engineered a Cory Aquino takeover of the Philippines in 1986. In the same article he

wrote about the Philippines, Al Douglas states:

"But the real basis for Greenberg's power is the 'joint-stock company' of Russian and Western financial interests known in intelligence parlance as the 'Trust', the grouping which ran the Bolshevik Revolution and continues today as the principal advocates of a 'New Yalta' deal with the Soviet Empire. According to knowledgeable sources in the Philippines, the C.V. Starr Insurance empire was established in Shanghai in 1919, when a young Californian named Cornelius Vander Starr made contact with a group of influential White Russian families who, bitterly opposed to the modernizing and Westernizing of Russia at the end of the 19th century, had helped to sponsor the Bolsheviks as a battering ram against that westernization, from their positions in the Czarist police, the Okhrana."

Now it can be told. While half a million Christian Filipinos sang and danced along EDSA on February 25, 1986, a group of underground Catholics in Metro Manila sent the following message to their American counterparts: "How many more nations would fall to the tyranny of Marxist dictatorship under the aegis of the Vatican II popes who are the most effective propagandists for Communist (globalist) revolution in the whole world? Cuba, South Vietnam, Cambodia and Laos have already fallen to the most cruel, godless tyranny the world has ever known. Since 1976, South Yemen, Angola, Mozambique, Ethiopia, Afghanistan, Rhodesia and Nicaragua followed the same course. Who can gauge the immensity of the sufferings of our Catholic brethren in Nicaragua and El Salvador, who are plunged into endless civil wars instigated by Jesuits and Maryknoll Fathers, in the name of a treasonous liberation theology?"

Three months later, an underground Catholic publication based in Florida issued Bulletin No. 49, which reads: "A few months ago, the Philippines was hijacked by the Conciliar episcopate under Cardinal Jaime Sin in Manila. The last Christian nation in Southeast Asia was delivered up to the dictatorship of the pro-Communist Corazon Aquino. It was a dramatic usurpation of world power by the Conciliar Church, shaping the destiny of the nations."

As expected by the underground Catholics, the NAP coup plot never saw the light. Cabauatan's group was jolted by frustrating news from the United States. The two Americans who were supposed to purchase the necessary firearms for the NAP were intercepted by U.S. Customs agents. Later, court papers revealed "a veritable laundry list of weapons and ammunition, enough to equip up to 5,000 troops". Among the items listed were Uzi (Israeli) submachine guns, 9 mm pistols, M-60 machine guns, M-16 automatic rifles, grenades and a large amount of ammo.

The color red, which was to haunt the RAM Boys for the next few years, has finally dawned on the Marcos loyalists. Which left only one more military element untouched—the Soldiers of the Filipino People (SFP) headed by Generals Jose Zumel and Edgardo Abenina.

Little did they realize that what they were up against was not the classical Marxism which is normally accompanied by a violent overthrow of the ruling structure by the working class. No, sir. What confronts them is something more dangerous—Antonio Gramsci's brand of Communism, the one currently sweeping the rest of the free world.

Gramsci, founder of the Italian Communist Party, did not believe in the call of Marx and Lenin to impose their ideas by violent force. It was no wonder that,

even in his time, the only Communist State that existed was imposed and maintained by the barrel of a gun. Gramsci thought that if Marxism could not find a way to change that formula, it would have no future.

“What was essential,” insisted Gramsci, “was to Marxize the inner man.” Only after this was done could the advocates of Marxism-Leninism successfully dangle the utopia of the Proletarian Paradise, “to be accepted in a peaceful and humanly agreeable manner, without revolution or violence or bloodshed” (*The Keys of This Book*, Malachi Martin, p. 248).

Gramsci’s success in introducing Communism with a kind face is phenomenal. And [he did it] with no opposition from the Roman Catholic Church, once the bulwark of anti-Communism.

Why is this so?

Malachi Martin explains: “The process of secularization in the Catholic and Protestant churches progressed so rapidly and with such energy that, just as Gramsci had foreseen, it fed into other streams of anti-Church influence in the West. Those were streams that, seemingly independent of Marxist influence, advocated a materialistic interpretation of all sectors of human thought, investigation and action” (Ibid, p. 262).

Gramsci instructed his followers to engage in the normally accepted democratic processes, in lobbying and voting. They are to behave in every respect as the Western democrats do—not only accepting the existence of many political parties but forging alliances with some and friendships with others. A keen observer, however, can easily spot the Gramscians in Philippine politics. They are the most ardent defenders of pluralism.

Gold And Other Interesting Things

Thus, the metals information is “old” but the facts are pertinent to the material offered as of 1998. We will refrain from much input and rely on our own readers to pick up and refresh themselves on current ups and downs in the metals market, as well as other references suitable to this presentation. It is all so important that if you miss something, you will be quite sorry at the carelessness of overlooking your homework. OUR TEAMS DO THEIR HOMEWORK.

I would also note that there is such interference with this computer that we may have to withdraw use on short notice but we will go as far as time and energy permit. It is, Dharma, better to get this to disk, even with the hash, than to get stopped. We need to push through so that we get our authors and contacts into security, as well as the material. Just take a break when you feel the need. I don't want to simply deal in copies of this manuscript, because it needs to be set to computer and I need to monitor closely as we go along.

Let us just whip right along please.

CHAPTER 12

WHAT'S WITH THE PRECIOUS METALS?

Late in 1995, something undeniably significant was observed to be happening in the precious-metals market. Silver stocks in the U.S. were surreptitiously removed from domestic warehouses, including those registered with the COMEX division of the New York Mercantile Exchange. Who did it? The Exchange didn't make any comment. Even the U.S. financial press did not encourage investigative reporters daring enough to ask the right questions.

That same year, American stockpiles of the metal fell sharply, causing an acute rise in silver prices to the \$6.20 per troy ounce level. Soon after, European stockpiles were also being drawn down and no one seemed to know why—or who was purchasing the metal. Stocks of silver in London fell [to near] zero level, and those in Zurich were likewise low.

It was very clear that forces were manipulating the market, but this time, no one could determine who it was. In a news report published by *Today* and the *Inquirer* late in 1995, a huge portion of the Philippine Government's gold and silver deposits in the Bangko Sentral was reported missing. This was confirmed by the Commission on Audit, which discovered the discrepancy in the records of the Treasury Department and that of the Mint and Gold Refinery.

According to COA, “Gold and silver holdings of the Bangko Sentral ng Pilipinas had an unreconciled difference of 33,450,079 troy ounces of gold and 23,736,323 troy ounces of silver in the record of the Mint and Gold Refinery”—*Today*, 13 November, 1995. Moreover, the Commission confirmed that gold account balances in depository banks until December 31 showed a difference of 9,672,182 troy ounces worth P90 million. Even receivable interests from foreign banks for time deposits were overstated by \$172,268.32 or about P4.2 million then.

But BSP Governor Gabriel Singson was quick to deny all this, saying that the government's gold and silver holdings were safe and intact. The reported disparity in deposits arose from the differences in the recording method used by the Treasury Department, which opted to use the defunct Central Bank's system. Really, Mr. Governor?

It has been customary for producers to lease silver and gold from warehouses, liquidate it and pay the loan back with their own production. This is a cheap way to borrow money. But, now, instead of paying one percent per annum to borrow silver, the rental rate has reached the 8 percent level—with no one willing to lend. This has been causing confusion, as no one knew where all the silver was going!

Our American associates say that if we were to combine this event with the production of the new U.S. currency to the Russians, a domestic rescue of the dollar (which would not last) and a disastrous sale of Treasury debt (resulting in hundreds of millions of dollars of losses), it would make one begin to smell the advent of a horrendous crisis.

Who was accumulating the silver stockpiles worldwide? Did this particular group know anything at all about a monetary reorganization and the introduction of a new currency? Most definitely! There was no way to keep these people out of the markets, and they always get the word very early from their bosses and buy up as much of the commodity as possible without causing any ripples. This was exactly what seemed to be going on.

The New World Order is taking as few people on the next upward hike in price as is humanly possible. They intend to make precious metals ownership risky, uninteresting and even boring. The CIA may have been used to play up such stories in the press. They may have even set up fake companies to deal in metals, which would only end up cheating customers out of their money. (Remember the story of Bill Kennedy and the Monetary War College, which cooperated with the Jewish bank, SAFRA of Los Angeles, along with a small bank in Washington State?) Just keep your position in gold-related assets.

Meanwhile, Kenneth Curtis (First Vice-President of the Deutsche Bank of Asia) had predicted, in late 1995, a 25% probability of a global financial and economic collapse as a result of the worsening performance of the Japanese banking industry. He revealed this alarming forecast at the conclusion of the 12th general meeting of the Asian Bankers Association. Reacting to this observation, Dr. Ching-Mai Wu of China Trust (Taiwan) assented: “Japan is the key.”

CHAPTER 13

THE 1940 SHIPMENT

History seems to repeat itself. Imelda Marcos is running once again for the presidency, and is all over again using the Marcos gold as a convenient come-on for the unwitting voting public to vote for her. Although privy to the U.S.\$365 million (now, worth almost U.S.\$800 million, inclusive of accrued interests), she still does not know who actually controls Ferdinand Marcos' other accounts.

It had been gathered from several sources as early as 1992 that the Gold Hoard, estimated then at 20,000 metric tons, did not comprise anything of the so-called Yamashita Treasure, but that of a 1940 shipment from the Vatican, which came from the bulk of the wealth of the Catholic Church.

Although the bulk of the precious metals is intact in several bank depositories worldwide, especially in Europe, the value of the combined gold, precious metals and jewelry cache has been comfortably placed at U.S.\$1 trillion. It was strongly believed that a good half of the total hoard is still hidden in several parts of this archipelago, still waiting to be found.

Sources claimed that the Vatican had acted as a repository of the treasures of European families, which sought papal assistance upon the Nazis' invasion in 1939. At the time, the Pope reportedly ordered a big bulk of the cache transported to the Philippines, in the custody of one Fr. Jose Antonio Diaz.

The same sources cited records showing that

when World War II ended, the real owners sought to recover their billions (reportedly in 75 kg. bars) but discovered that the custodian, a priest, had allegedly refused to return everything back to them, forcing them to file the necessary claims for the recovery of their metals and jewelry with the International Court of Justice in The Hague in October of 1946. Fr. Diaz then sought the assistance of Ferdinand Marcos, a brilliant young lawyer, offering him 15 percent of the entire hoard for his fee.

But some sources say that soon after, in the Seventies, the aging Dr. Diaz died, leaving behind a holographic will assigning 15 percent of the total stashed gold to his trusted young lawyer, Marcos, another 15 percent to the priest's heiress (which turned out to be Remedios Trinidad, Imelda's mother), and the rest of the hoard to the Filipino people. (TRUTH: Fr. Jose Antonio Diaz in 1978 at the San Juan de Dios Hospital, with his wife, Luz Rambano, by his side. The photograph is in my care. His tape-recorded message was also given to me in confidence by this trusted friend. Imelda Marcos was reportedly related to Fr. Jose Antonio Diaz, alias Colonel Severino Sta. Romana, which means The Servant of Rome.)

Soon after, the young Marcos deposited part of the gold in 18 foreign banks in Hong Kong, London and Switzerland. These deposits were reportedly those covered by certificates now in the possession of Imelda Marcos.

The very same sources claimed, too, that in Hong Kong alone, some U.S.\$20 billion of the Marcos gold was held in secure vaults, a fact known to all the relatives of then President Aquino. They further added that when national disorder came about after the assassination of former Senator Benigno Aquino in 1983, the late strongman ordered part of the gold shipped through Sumatra en route to banks owned by his friends. It was said that about 4,000 metric tons of gold was transported out of the country in 1984 alone.

Sources close to Imelda, however, insisted that the 40-year prescription for the recovery of the gold by its original owners lapsed in October 1985. (Despite this setback, several more country-claimants have filed their cases with the International Court of Justice, with the prescription in Year 2005.) There being no legal impediment to the disposition of the hoard now, Imelda Marcos believes that she can almost immediately dispose of the gold in London, Zurich and Tokyo to generate the much-needed cash to finance her presidential bid. Now, which is which?

CHAPTER 14

THE FAILED TREASURE HUNT

After a successful military career, U.S. Army Major General John K. Singlaub dedicated himself to conservative causes and anti-communist movements. After all, the battle-scarred veteran served as Chairman of the World Anti-Communist League (WACL) and headed its American chapter. His close buddy, Lieutenant General Daniel O. Graham, erstwhile Director of the Defense Intelligence Agency (DIA), became its Vice Chairman.

Until 1986, Singlaub pursued his anti-communist

activities working with friends from the private sector to gather unofficial worldwide support and assistance for the Nicaraguan Contras. It was around this time that Singlaub's attention "was unexpectedly diverted from Central America to Southeast Asia", thanks to an American treasure-salvage group called Nippon Star, whose chief investors included a reputable couple named Harrigan from Memphis, who touched base with Singlaub concerning their work to uncover hidden Japanese war booty in the Philippines.

With John Harrigan were John Granbush, Tom Polk, Allan Forringer, Ron Healy and John Voss. All were connected to the National Commodity and Barter Association, based in Denver. Its members were primarily active in the Mormon Church. Granbush, the Association's President, took a special interest in the treasure-hunting activities and helped finance the operation for some time.

According to Charles McDougald, Singlaub was not one given to "flights of fancy or chasing rainbows". So why did he decide to join a treasure hunt that would take him halfway around the world?

"The Harrigans produced credible documents that estimated upwards of 300 tons of bullion and other gold which had reached the Philippines in 1941." This was Singlaub's reply. Like McDougald, the retired General was convinced that Marcos' fortune (which he estimated at \$12 billion) came from the legendary Yamashita Treasure. The Japanese Imperial Army's field commanders "looted the national treasures, private banks and temple complexes in Hong Kong, Burma, IndoChina and the Dutch East Indies, and shipped hundreds of tons of gold bullion and golden temple artifacts for safekeeping in their proposed future colony, the Philippines," says Singlaub.

McDougald insists that a man like Singlaub, whose military career is "the stuff of legend" and who once belonged to the CIA, would not be talking openly about the so-called "Asian loot" if he did not have the correct information in his possession. Thus, everything he said about Yamashita's gold hoard must be true.

[H: Let me also assure you that someone like the one you recognize as Russell Herman would not be holding—as per treasure dealers and V.K. Durham—objects worth a nation's ransom. Among those things listed by V.K. are Ming Dynasty robes, ivory ceremonial cups, diamonds (some from the third eye of Buddhas), etc.—along with some dandy, if not too colorful wall hangings. And yes, indeed, it is now dispersed so greatly and widely as to be an interesting safety net, woven of a thousand strands of silk thread. The only gold desired by Ekkers is that which backs loans and allows some projects to be developed—by the people to whom this wealth belongs. There is no intervention in political squabbles nor are there any clandestine “arrangements”. There are some legal and lawful ventures put to document—and records set forth in the public domain for the purposes presented.

Is there “treasure” in those hills around the countryside? Yes. Is there a lot of stuff in those infamous tunnels? Yes, and there is lots more in those Atmospherian sub-oceanic conclaves. We leave the loot and the treasure to the looters and treasure holders and hunters. We also leave the false paper and documents to the printers and scams (of which the abundance of same runs into the billions of \$\$\$) to the scam artists. This is neither our business nor our interest, so don’t believe the garbage you hear from such as the mis- dis-information kids. And we note that today marks a year since the team split and the run-out on Ekkers happened. And yes, it has been a difficult and painful year, aided-and-abetted in the hurt by other members of the trusted friendship circle. But as the cycles pass, so too does the integrity prove itself. Oh, well.]

The Japanese plan to annex the Philippines failed because the advancing American forces “cut off the Philippines before the Japanese could ship their gold back to Japan”. Faced with the dark prospects of defeat, “General Yamashita dispersed the assembled treasure around the islands, where it was buried in 172 carefully chosen sites,” adds Singlaub. An elite team of geologists and miners performed the burial operations.

Singlaub’s group discovered one underwater site in Calatagan Bay (Batangas)—a shaft blasted seventy feet deep into a coral reef. “Japanese records indicated five tons of gold bullion and several barrels of precious stones had been deposited there... by General Yamashita’s staff, who used coded maps and ledgers, which were flown back to Japan before the capitulation,” Singlaub explains.

Nippon Star eventually gave up the Calatagan site excavation. “Progress was slow and costly,” writes McDougald. “This haphazard stop-and-go operation went on until finally they decided that another site might be easier.”

Singlaub was convinced that Marcos had managed to “rake off” a dozen or so of the biggest sites. In his estimation, over a hundred sites were left untouched. The problem was that several of the most promising sites *Nippon Star* had staked out were in remote provinces controlled by the New People’s Army (NPA). “The group needed a qualified security adviser and offered me a job,” Singlaub explains. “What made the offer attractive was their promise to provide several percent of the eventual profit directly to the U.S. Council for World Freedom. I agreed to help them.”

Singlaub periodically came to the Philippines to head the *Nippon Star* operations until it ran into what he claimed were “funding problems”.

McDougald disagrees. The latter insists that “it was because of Singlaub’s association with friends like (Ray) Cline... and his association with (Teddyboy) Locsin in the palace that a rumor was passed around that the operation was jointly sanctioned by President Reagan and President Aquino”, and to disprove this, the whole thing had to be scrapped.

McDougald never admitted that President Aquino knew about the salvage. But Singlaub swears that all he did was “to build better bridges to the Philippine Government” by “giving periodic and detailed reports of our activities to Teodoro Locsin, Jr.”, a key adviser to President Aquino.

McDougald’s denials worked well for him. In the end, “Charles McDougald, the American treasure hunter who dug up Fort Santiago and Napindan Channel,” was reported by the *Manila Standard’s* Ariel Bocobo as “living in style in the U.S.” McDougald “has homes in snooty Hillsborough in the San Francisco Bay area, in Beverly Hills in Los Angeles and in Dasmarias Village in Makati.” McDougald “mysteriously disappeared after his diggings were suddenly stopped,” adds Bocobo. “He did not even bother to restore the mess he has created in his diggings. Emmanuel Soriano, former National Security Adviser, clammed up after his American partner returned to the U.S.”

There are speculations that McDougald has discovered part of the fabulous Marcos Gold Hoard. Does this mean that the “Asian loot” which the presidential treasure hunter mentioned in his book is the same chain of properties suddenly acquired by him after the great Manila caper?

Businessman Gregorio “George” Cadhit denied yesterday being a bagman for Gregorio Araneta III and Irene Marcos-Araneta in the alleged sale of \$65 billion worth of gold.

In his testimony before the Senate Blue Ribbon Committee, Cadhit also rejected allegations that he acted as front for the Araneta couple in maintaining a \$4-billion account in Sanwa Bank in Hong Kong.

“That’s a brazen lie,” he said. “I don’t know Greggy Araneta, not in person, not even by phone.”

Earlier, Mayor Renato Vizcarra of Ramon Town,

Isabela accused Cadhit of selling gold for the Aranetas and maintaining an account for them in a bank in the former Crown Colony.

During the same hearing, Emmanuel Cabral, Tandang Sora Branch Manager of Metropolitan Bank & Trust Company, presented several documents showing that Cadhit had a savings and checking account with them until September 19, 1998.

Cabral testified that Cadhit opened the account with an initial deposit of P100,000, (\$2,500.00) and that before he closed the account, the deposit had reached P1.2 million (\$30,000.00).

Cadhit had waived his right under the *Bank Secrecy Act* and had volunteered to make public his accounts in Metro Bank or any local or foreign bank.

Two witnesses, Erick San Juan and Luz Domingo, testified that they often saw Cadhit in the company of the former first lady, Mrs. Imelda Romualdez Marcos.

San Juan, who is a former close Marcos associate, said he saw Cadhit inside the suite of Mrs. Marcos in the Philippine Plaza Hotel in Manila sometime in 1992.

Cadhit also admitted making several trips to Europe, Hong Kong and the United States, but insisted that he traveled to those places as a tourist, and that his friends had sponsored the trips.

[H: Does this remind you of Mr. Clinton and his “it depends on what is, IS”? Note that if you are NOT traveling under a “business” visa, you are traveling under a general or “tourist” visa—and nobody checks as to who bought the tickets. He rebutted point by point Vizcarra’s allegations, particularly the one that he withdrew an average of P100,000 to P10 million a day from several banks.

However, he admitted hosting trips for local and *barangay* officials in Manila as a gesture of goodwill, with money from his personal account.

Asked why Vizcarra had made the allegations, Cadhit said “bad blood exists” between them, and that it started during a recent town fiesta and involved a beauty contest.

Cadhit said Vizcarra is also afraid that he would endanger Vizcarra’s political base because he had been raising funds for several *barangays* in Ramon, Isabela.

“It’s purely a political controversy,” he said.

CADHIT: A MAN IN SEARCH OF SNAKE OIL

He holds a Swedish passport and travels throughout the world in search of snake oil.

Cadhit, a lawyer who works as a property consultant, believes that snake oil can cure his asthma.

[H: And how do you think the translators will translate the meaning of this report, presented as factual news, some 300 years from now? This is what gets a whole bunch of snakes killed for curing asthma.]

And Senator Aquilino Pimentel Jr., Chairman of the Senate Blue Ribbon Committee, assumes Cadhit is actually looking for the ancient remedy closer to home because the potion is available only in Asia.

“I’m sure that there is no snake oil in Switzerland,” he said.

[H: Well, don’t be too sure about that. If the “stuff” he seeks looks like gold, lays heavy like gold and is called “snake oil”, so be it! What exactly does “snake oil” look like? Maybe there is a LOT of snake oil in Switzerland, for there surely is a lot of other “loot” in Switzerland that the Bolsheviks are trying to get “liberated”.]

Cadhit said he travels as a tourist with his trusted aide, Fred Tabag, and insists that his trips are financed by “wealthy and powerful friends in various parts of the world”.

Tabag is the reason why Cadhit was at the Senate yesterday answering questions from Pimentel. Tabag had introduced him to Vizcarra, who has accused him of being a bagman in the sale of alleged Marcos gold.

Cadhit does not recall how many times he had traveled abroad, but he is sure that his airfares were always prepaid by “wealthy friends from all over the world”.

“I was just a plain tourist,” he said.

He said he traveled regularly to Hong Kong to buy snake oil and not to deposit money in a bank, as Vizcarra had accused him of doing.

However, one senator said that Cadhit’s trip to Scandinavian countries may have something to do with the alleged Marcos Gold Hoard.

Records at the Bureau of Immigration showed that Cadhit frequently traveled to Switzerland, Japan, Hong Kong, Indonesia and other countries.

Cadhit, on the other hand, said he could not be a Marcos associate because he had helped draft a congressional resolution banning the return of the Marcoses to the country.

CHANGE OF COMMAND OFFERS NATO WAY TO SAVE FACE

When NATO turns over command of the Kosovo peacekeeping mission (KFOR) to Eurocorps on April 18, the alliance will have an opportunity to hold onto its dignity while drawing a neat, although purely semantic, end to its mission. NATO has been backed into a corner by an extremist faction of the former Kosovo Liberation Army (KLA), which has blatantly ignored NATO's requirements that Albanian rebels be demilitarized. The alliance is being forced to choose between abandoning its mission in Kosovo or clawing its way out of a public-relations nightmare.

For the past two months, a faction of the former KLA based within the protected border zone between Kosovo and Serbia has been instigating violence in Serb towns inside the border and with an ethnic Albanian majority. The group, which calls itself the Liberation Army of Presevo, Bujanovac and Medvedja (UCPBM), surfaced early this year in a village called Dobrosin, just over the border from the U.S.-guarded sector of Kosovo. Despite the group's March 23 commitment to political resolution of conflict, the militants are not likely to back away from their aggressive campaign in southern Serbia.

An estimated 500-800 armed UCPBM members have been operating what U.S. forces believe is a boot camp out of Dobrosin, taking advantage of the three-mile-wide buffer zone established at the end of the war. According to the cease-fire agreement, neither Serb military nor police, nor NATO troops, are allowed in the buffer zone. The *Washington Post* reported that the commander of the observation post at the U.S. checkpoint, Captain Eric McFadden, had observed new recruits rotating through the village, undergoing basic training. The UCPBM even wear uniforms and insignia identical to those of the former KLA. But both leaders of the former KLA, Agim Ceku and Hashim Thaci, deny links to the group.

NATO is in the embarrassing position of defending itself and its mission, against those it originally went in to defend. As the UCPBM in Serbia and the former KLA in Kosovo continue to spark conflicts, NATO must acknowledge that there are rogue elements of the ethnic Albanian population that cannot be defused by Western diplomacy alone. In the only overt mission against the UCPBM so far, on March 17, U.S. troops seized more than 200 uniforms, 22 crates of rifle and machine-gun ammunition, two mortars, 28 hand grenades, seven rifles, six land mines and other military equipment, reported the *London Guardian*.

To further crack down on the UCPBM and the KLA, NATO can take advantage of the upcoming change in KFOR leadership. On April 18, command and control of KFOR will pass from NATO's Allied Land Forces Central Europe (LANDCENT) to Eurocorps, a European military alliance with troops from Belgium, France, Germany, Luxembourg and Spain. Eurocorps, under the command of Spanish Lieutenant General Juan Ortuno, will deploy 350 troops to KFOR headquarters for six months.

The symbolism of the transition offers NATO a

chance to publicly declare the success of the Kosovo War while allowing another organization to carry the responsibility for the much-needed stern enforcement of peace. Operationally, this change will have virtually no effect because all KFOR troops will remain under the ultimate authority of General Wesley Clark, NATO Supreme Commander.

The installation of Eurocorps leadership is a formality that serves several purposes. First, it gives the fledgling European defense alliance an opportunity to work within a large-scale multinational operation—without having to coordinate the logistical or technical aspects. Second, it gives the United States a break from the bad public image that has resulted from the Kosovo campaign, while allowing Washington to hold onto continued influence.

Most importantly, from now on, the assignment of Eurocorps will justify the emphasis on European goals in KFOR's mission. Whereas NATO's goal in Kosovo was to defend the Kosovar Albanians from Serb "ethnic cleansing", Europe's goals are different. These goals include regional stability—which does not rule out a KFOR crackdown on the ethnic Albanian extremists. With the change in command, NATO can hand over the keys to Kosovo and slink out of the picture, leaving Eurocorps with the responsibility of whipping the militants into shape.

[JR: What we have here is the old "good cop (NATO)-bad cop (Eurocorp)" routine. NATO slips out thinking their special secret agreements with the KLA/UCPBM are no longer valid when Eurocorp replaces them. This scenario is an orchestrated event, in that a 3-mile buffer zone was only created so that these rebellious factions could train and arm themselves with the aid of the CIA but without interference. This is the old Hegelian dialectic in practice—"Create a crisis to solve a crisis."]

BELGRADE WAR CRIMES TRIBUNAL ACCUSES THE WEST

BELGRADE, YUGOSLAVIA—A Russian-led tribunal sought to turn the tables on the West in Belgrade Wednesday by accusing NATO leaders of war crimes during last year's air strikes.

The tribunal, made up mainly of communist sympathizers from the former East Bloc, convened in the Yugoslav capital for a hearing on the 78-day bombing, launched over Yugoslav President Slobodan Milosevic's repression of Kosovo's Albanians.

Its list of accused included President Clinton, NATO Secretary General Javier Solana and leaders of Britain, France and Germany.

Carla del Ponte, Chief Prosecutor of the United Nations War Crimes Tribunal in The Hague, was asked to observe.

"We had no replies," Mikhail Kuznetsov, a Russian lawyer who presided over the tribunal, told the audience in the Sava Congress Center in Belgrade.

Opponents of Milosevic in Serbia said the composition and nature of the hearing, at which there was

no cross-examination and the verdict was a foregone conclusion, only served to help NATO dismiss awkward questions about the bombing.

"Anyone who was here during the air strikes knows civilians were killed," Sonia Drobac an editor at the *Glas Javnosti* daily, told independent Belgrade Radio B292. "But this is a farce."

After two days of debates, including witness testimony and speeches from around a dozen jurists, mainly from Russia but also from Bulgaria, Ukraine, Afghanistan, Poland and Germany, the tribunal came out with its verdict Wednesday afternoon.

It said the accused had launched the bombing without declaring war and with no legal basis, and alleged it had deliberately targeted civilians, including children.

Listing a string of United Nations conventions it said NATO had violated, it demanded a criminal investigation of the accused and added that its conclusions would be sent to the United Nations and the Hague Tribunal.

It also called for the disbanding of NATO, the dismissal of UN Secretary-General Kofi Annan and asked the countries involved to put their military and political leaders on trial.

The jurists were not optimistic their demands would be met.

"Our tribunal may be small but it represents heartfelt support for the people of Yugoslavia," Kuznetsov said.

NATO insisted throughout the air strikes that it was aiming only at military targets and took all possible precautions to avoid civilian casualties.

When the Washington-based Human Rights Watch said last month that 500 civilians were killed by the air strikes, NATO said its report constituted legitimate criticism but that its actions could not be compared with Serb violence in the province.

Some of the Belgrade tribunal's charges echo those leveled by the West against Milosevic, who was indicted by the Hague Tribunal last May for alleged war crimes in Kosovo along with four close aides.

[JR: The charges against NATO are valid but will be summarily dismissed and ignored by the bigger powers. NATO did bomb civilians without a declaration of war and did, indeed, abuse the rights of a sovereign nation. You can debate the issue but you can't defend the illegal actions taken.]

THE IMF STUMBLES

There may be no single institution with greater pernicious influence in the world than the International Monetary Fund. Now, for the first time, the IMF faces a real challenge to its existence, at least in its current form.

For two decades, the IMF has had a stranglehold on the economies of developing countries, denying them the funding they need to make foreign debt payments and avoid default, unless they enact "structural adjustment" policies.

Structural adjustment can fairly be described as a virulent strain of Reaganomics. The basic idea is to make countries open their labor markets and natural-resource riches to multinationals, shrink the size and role of their governments, rely on market forces to distribute resources and services, and otherwise integrate themselves into the global economy.

Structural-adjustment policies might include: privatizing government-owned enterprises and government-provided services; slashing government spending; reorienting the national economy to promote exports;

lifting trade restrictions; implementing higher interest rates; eliminating subsidies on consumer items such as food, fuel, and medicines; and imposing tax increases.

The IMF's structural-adjustment ethic has succeeded in diminishing the scope of government in developing countries and in integrating them into the global economy.

But it has also immeasurably increased suffering in developing countries. **In most of the world's poorest nations where structural-adjustment policies have been implemented at the IMF's behest, poverty has increased, health-care systems have collapsed and income inequality has skyrocketed.**

Developing countries that have done well in recent decades, primarily those in Asia, including China, have succeeded by violating central tenets of structural adjustment: They have maintained a strong government role in the economies and they have protected certain parts of their economies.

But citizens of other developing countries have protested angrily against IMF policies. Riots have broken out after the IMF ordered price subsidies lifted on goods such as bread and gasoline. But because the IMF derives its authority from rich countries, not the poor nations where its policies are most often applied, it has been able to weather these outbursts.

In the last two years, however, momentum against the IMF has grown in more prosperous countries, as well as in the developing world.

Structural adjustment has blown up in the IMF's face before: Its admitted mishandling of the Asian financial crisis in 1997 and 1998 made the economic contraction there much worse. The structural-adjustment agenda further slowed the Asian economies that had already plunged into recession.

This incompetent performance finally sparked widespread criticism of the Fund in the industrialized countries.

Meanwhile, the worldwide Jubilee movement is increasingly winning support for the idea of debt cancellation for the poorest countries.

The IMF has deftly tried to turn these weaknesses to strengths. It adroitly used the Asian financial crisis to win \$90 billion in new funding from the rich countries. The Fund needed more money, proponents claimed, to keep the crisis economies afloat.

And the IMF has sought new monies [for] very modest debt relief through its Enhanced Structural Adjustment Facility (now known as the Poverty Reduction and Growth Facility, an Orwellian twist)—in exchange for countries agreeing to years of closely supervised structural adjustment.

But these jujitsu tactics may be running out of steam. Political momentum against the IMF ratcheted up in recent weeks, when the Meltzer Commission, a bipartisan advisory commission to the U.S. Congress, released its report.

While the members of the Commission disagreed on many matters, they agreed on two: First, the IMF (along with the World Bank) should use its existing resources to cancel all debts owed to these institutions by the poorest countries. Second, the IMF should get out of the business of long-term lending—the kind of development loans to which structural-adjustment conditions are normally attached.

The report has shifted the terms of debate over the IMF in the United States and the U.S. Congress. Unfortunately, the IMF is only seeking a relatively small amount of new money from the Congress—and if that money goes through, Congress will lose most of its influence over the monetary agency for several years (until the next funding request).

But the shift in policy circles is now being accompanied by a new progressive public protest against the IMF in the United States. On April 16, during the IMF's annual spring meeting, thousands of demonstrators will take to the streets of Washington, D.C. to protest the deadly toll of IMF policies.

Infused with the spirit of Seattle that shut down the World Trade Organization meetings, the demonstrators are planning a direct action to shut down the IMF, as well as a massive, permitted rally and march.

Street demonstrations against the IMF in Washington have the potential to awaken people in the United States to the needless suffering imposed by the Fund on people throughout the world, and to mobilize a critical mass of opponents in the country that exercises a dominant influence at the Fund.

U.S. ACTIONS LED TO MORE DANGEROUS RUSSIA

In late February, as the first anniversary of our intervention in Kosovo approached, American peacekeepers launched house-to-house raids in Mitrovica looking for weapons. They encountered a rock-throwing mob and withdrew. Such is our reward for our glorious little victory in the Balkans: police work from which even Madeleine K. Albright, architect of the War, admits there is no foreseeable escape. ("The day may come," she wrote on Tuesday, "when a Kosovo-scale operation can be managed without the help of the United States, but it has not come yet.")

The price is high. Our occupations of Kosovo and Bosnia have already cost tens of billions of dollars, draining our defense resources and straining a military (already hollowed by huge defense cuts over the last decade) charged with protecting vital American strategic interests in such crisis areas as the Persian Gulf, the Taiwan Strait and the Korean Peninsula.

But there is another cost, more subtle and far heavier. Russia has just moved from the democratically committed, if erratic, Boris Yeltsin to the "dictatorship of the law" promised by the new President, former KGB agent Vladimir Putin. Putin might turn out to be a democrat, but the man who won the presidency by crushing Chechnya will more likely continue as the national-security policeman of all the Russias.

What does that have to do with Kosovo? "Without Kosovo, Putin would not be Russian President today," says Dimitri Simes, the Russia expert and President of the Nixon Center.

The path from Kosovo to Putin is not that difficult to trace. It goes through Chechnya. Americans may not see the connection, but Russians do.

Russians had long been suffering an "Afghan-Chechen syndrome", under which they believed they could not prevail in local conflicts purely by the use of force. Kosovo demonstrated precisely the efficacy of raw force.

Russians had also been operating under the assumption that to be a good international citizen they could not engage in the unilateral use of force without the general approval of the international community. Kosovo cured them of that illusion.

And, finally, Russia had acquiesced in the expansion

of NATO under the expectation and assurance that it would remain, as always, a defensive alliance. Then, within 11 days of incorporating Hungary, Poland and the Czech Republic, NATO was launching its first extraterritorial war.

The Russians were doubly humiliated because the Balkans had long been in their sphere of influence, with Serbia as their traditional ally. The result was intense anti-American, anti-NATO feeling engendered in Russia. NATO expansion had agitated Russian elites; Kosovo inflamed the Russian public.

Kosovo created in Russia what Simes calls a "national-security consensus", the demand for a strong leader to do what it takes to restore Russia's standing and status. And it made confrontation with the United States a badge of honor.

The dash to Pristina Airport by Russian troops—under the noses of the allies as they entered Kosovo—was an unserious way of issuing the challenge. But the support this little adventure enjoyed at home showed Russian leaders the power of the new nationalism.

The first Russian beneficiary of Kosovo was then Prime Minister Yevgeny Primakov. But it was Prime Minister Putin who understood how to fully exploit it. Applying the lessons of Kosovo, he seized upon Chechen provocations into neighboring Dagestan to launch his merciless war on Chechnya. It earned him enormous popularity and ultimately the presidency.

One of Putin's first promises is to rebuild Russia's military-industrial complex. We are now saddled with him for four years, probably longer, much longer.

The Clinton Administration has a congenital inability to distinguish forest from trees. It obsesses over paper agreements, such as the chemical-weapons treaty, which will not advance American interests one iota. It expends enormous effort on Somalia, Haiti, Bosnia and Kosovo, places of (at best) the most peripheral interest to the United States. And it lets the big ones slip away.

Saddam Hussein is back, building his "weapons of mass destruction". China's threats to Taiwan grow. The American military is badly stretched by far-flung commitments in places of insignificance. Most important of all, Russia, on whose destiny and direction hinge the future of Eastern Europe and the Caspian Basin, has come under the sway of a cold-eyed cop, destroyer of Chechnya and heir to Yuri Andropov, the last KGB graduate to rule Russia.

Such is the price of the blinkered do-goodism of this Administration. We will be paying the price far into the next [administration].

[JR: The fallacies of the Clinton/Albright foreign policies are coming home to roost on our shoulders. It makes you wonder how many more blunders this dynamic duo will commit before Russia's Government is again ruled by an iron fist that the Western allies helped to create.]

SIXTH GRADER TARGETED FOR PRO-GUN REMARKS

School officials at Harbor Lights Middle School flagged a Holland, Michigan boy as potentially dangerous because the 12-year-old suggested to a teacher that one way to prevent school shootings would be to arm instructors.

Derek Loutzenheiser, a model student who had such good grades that some teachers recommended he be tested early for a popular standardized pre-college performance test, made his comments in early March, after being asked

by a social-studies teacher what he thought might make kids safer in school.

Derek had been asked to participate in a classroom discussion about “school shootings and safety”, said the sixth grader’s father, Tim Loutzenheiser.

“My son simply stated that his opinion was that he would feel safer if some of the adults at the school were trained and allowed to carry firearms,” Mr. Loutzenheiser told *WorldNetDaily*.

His reply caused him to be “flagged” as a potential violence risk by teachers and school administrators, who then contacted his parents to suggest they meet with the school’s “Hazard and Risk Assessment Team”.

“My wife and I were in disbelief when they (school officials) telephoned us and told us that’s what they wanted to do,” Loutzenheiser said. “We asked, ‘Do you have the right kid?’”

In resulting talks with school officials, Loutzenheiser said he learned that his son “often spoke favorably about the *First* and *Second Amendments*, but the comment he made to his social-studies teacher was the one that triggered this action.”

School officials told the couple that because of Derek’s comments he should be separated from the other students and forced to enter the school’s “Mentor” program, where he would be studied by an adult supervisor who would monitor Derek’s thought processes.

“We were told that this would be in the best interest of my son, and by doing this the school would not have to involve Social Services,” Loutzenheiser said. “We refused.”

At that point, the couple contacted an attorney in nearby Grand Rapids, Michigan—one referred to them through the National Rifle Association’s *Institute for Legislative Action*. The couple has also been told by a representative from the Rutherford Institute, an international legal and educational civil-liberties organization, that “they would be willing to take on this issue”.

Loutzenheiser said when he and his wife, Shelly, arrived for the Hazard Team meeting March 8, “We were outnumbered 7 to 2.” He also told them he had brought along a tape recorder and would be taping the proceedings, since none of the legal organizations that said they would represent him could send a representative to the meeting on such short notice....

...However, and though “team” members denied it, the elder Loutzenheiser said he believes teachers and school administrative personnel began to form a bad impression of his son when, in January of this year, the sixth grader refused to sign a “Red Letter” vow of peace to celebrate Martin Luther King’s birthday.

“The letter, which was written by the principal,” Loutzenheiser said, “asked the students to take an oath to turn in their friends for suspicious activity, to vow to never defend themselves if attacked, and something to the effect of never to use a gun or other weapons. Derek simply told the principal, ‘I’m not signing that.’”

“I think that’s what got him ‘noticed’ by some of the administrative staff at least,” he said.

Of the meeting with “team” members, Loutzenheiser said, “We got right to the point and determined that the charges against my son are without merit. They all assured me that he is a wonderful student, gets straight ‘A’s, and because he is a little more advanced academically (at their suggestion he took the ACT test and scored very well), they feel he may need an ‘adult’ to talk to about issues.”

Loutzenheiser admitted he didn’t know what team members were implying about having Derek “talk to an

adult about issues”. He added, “We were able to determine that because my son knows and understands political and constitutional issues so well, that he often speaks in terms not typical of a 12-year-old, and we should be assured they have no issues with this.”

The couple believes Derek’s social-studies teacher was the impetus for the inquiry.

“She felt concern when Derek stated—when she asked—that he would feel safer if some of the adults would be trained and have access to firearms at school,” said Derek’s father. “Because this teacher felt this [was an] irrational threat, she spoke to other ‘team’ members who are also Derek’s teachers.”...

...One of the vice principals, the couple said, also felt Derek may need some “mentoring” because he was “attacked by three older students last September, in which Derek fought back and deterred his attackers on school property,” Loutzenheiser said.

“They (school officials) wanted to reinforce how understanding they were, in light of the fact that the school has a zero tolerance policy—no fighting, even in self defense—and how Derek was not punished in any way for defending himself,” Loutzenheiser said....

...“We also asked them why, if these problems were so terrible, no one had bothered to pick up the phone and call us before it came to this,” said Loutzenheiser.

More disturbing to the couple was the school’s constant alluding to “a list”—ostensibly, the same “list” their son Derek was on, albeit briefly.

“No one really explained what this ‘list’ was,” Loutzenheiser said, “but from the sound of it, if you raised anyone’s eyebrows at the school—for any reason—you made this ‘list’...”

...The principal explained that Harbor Lights uses the mentoring program to “match students who have particular interests, with teachers or adults (who are volunteers) who have similar interests”.

When asked about the so-called “list” that Loutzenheiser mentioned, Klomprens reiterated that it was school policy “not to discuss the status of our students”....

...But the Loutzenheisers remain unconvinced.

“Each of these people on the ‘team’ probably had no issue with Derek, but by virtue of assembling together and talking, they were able to feed upon each other’s concerns, no matter how small, and allowed them to grow,” said Tim Loutzenheiser. “We’re convinced that Derek will now be placed under a microscope for observation more than ever.”

[JR: I’m sure that if Derek is put through this “Mentor” program, more than his thought process will be monitored—his views will be greatly altered. I would make a wild guess that this Hazard Risk Assessment Team is funded by either the feds or a private foundation with an anti-gun agenda.]

LAWMAKERS AMONG TAX LAGGARDS

WASHINGTON (AP)—Internal Revenue Service employees can be summarily fired for nonpayment of taxes, but not the members of Congress and their staffs who helped write that law and owe about \$10.5 million in unpaid taxes.

IRS data released Thursday shows that the nonpayment rate as of October 1999 for the House was 8.4 percent, while that in the Senate was 7.5 percent. The 1998 *Internal Revenue Service Reform Law* passed by Congress made nonpayment grounds for immediate

dismissal of the agency’s workers.

The President of the National Treasury Employees Union, Colleen Kelley, said in a letter to congressional leaders Thursday that the immediate firing provisions for IRS employees are “especially harsh when compared to the fact that no similar penalty of any kind applies to members of Congress or congressional staff”.

“It seems patently unfair to hold those who write the tax laws to a lesser standard than those who must enforce them,” Kelley added.

Senate Finance Committee Chairman William Roth agreed.

“Members of Congress and their staffs have an obligation, like all taxpayers, to pay their taxes in full and on time,” said the Delaware Republican, who frequently gets extensions to pay taxes but is not running behind, a spokeswoman added.

The agency did not release the names of those who owe.

The total for most civilian agencies of the executive branch was 6.2 percent, but some Cabinet agencies were much higher. The Education Department, for example, had a 9.2 percent nonpayment rate; Housing and Urban Development’s was 8.5 percent and the Labor Department was 7.7 percent.

Other high nonpayment rates: 8.2 percent for the FBI and 7.9 percent for the Coast Guard. The CIA’s nonpayment rate was nearly 4 percent, while the Federal Reserve System rate was 8.2 percent. The Defense Department’s nonpayment rate came to 7.3 percent.

The Treasury Department, which includes the IRS, had a tax nonpayment rate of 3.8 percent, the lowest of the Cabinet agencies. The White House nonpayment rate was 6.5 percent, an improvement over the 13 percent recorded last year.

The IRS has compiled data on federal employee nonpayment of taxes through its document-matching systems since 1993 as a way of spurring greater compliance throughout the Government. The numbers include people who are gradually paying off their tax bills through installment agreements with the IRS.

All told, the nonpayment rate for the federal Government is about 5.2 percent, compared with 8.1 percent for the U.S. population. The balance owed by these federal employees is estimated at \$2.4 billion.

MAN TRIED FOR BELITTLING HOLOCAUST

LAUSANNE, SWITZERLAND (AP)—A Swiss Holocaust revisionist who denied the existence of the Nazi gas chambers went on trial Monday, charged with racial discrimination.

Gaston-Armand Amaudruz, 79, is being tried at the Lausanne Correctional Court. He faces a maximum sentence of three years in prison.

The charges stem from an article in Amaudruz’s magazine, *Le Courrier du Continent*.

In it, he stated: “For my part, I maintain my position: I don’t believe in the gas chambers. Let the exterminationists provide the proof and I will believe it. But as I’ve been waiting for this proof for decades, I don’t believe I will see it soon.”

Amaudruz was charged under Switzerland’s 1995 anti-racism law, which outlaws belittling of the Holocaust

under a provision that makes it a criminal offense to “deny, grossly minimize or seek to justify genocide or other crimes against humanity”.

French Nazi hunter and historian Serge Klarsfeld plans to address the Court during the trial. His organization—the Association of Sons and Daughters of Deported Jews of France—is a civil party to the case, along with the International League Against Racism and Anti-Semitism and the Swiss Federation of Jewish Communities.

The trial is expected to last four days with the verdict coming next week.

[JR: Where’s the difference between this and communist Bolshevik Russia, which did the same thing or worse to those who criticized the Jews and their activities? SIXTY PERCENT OF ARMY MAY BE HIV-POSITIVE

JOHANNESBURG, SA—The rate of HIV/AIDS infection in the South African National Defence Force may be as high as 60% to 70% while, in at least one military unit, 90% of the troops are infected with the virus. These extraordinary figures, leaked this week, were taken from preliminary HIV testing being conducted by the SANDF.

The 90% infection rate was found at a military police base in northern KwaZulu-Natal, and its infection status was discovered by accident. As part of a study into malaria drugs, the military recruited the soldiers to try out new medicines. The unit based at Josini was chosen, as the town is a high-risk malaria area. But before the soldiers could be given the drugs, they had to submit to a comprehensive medical evaluation, including an AIDS test. Thirty out of the thirty-three members of the unit tested HIV-positive and the test had to be abandoned.

It is understood that this unit was not the only one to test high. Some units around Pietermaritzburg and on the South Africa/Mozambique border have posted rates of well over 70%.

At present, all members of the Defence Force are being given medical examinations, including HIV tests, to check on their operational readiness. In terms of United Nations regulations, HIV-infected troops may not be sent on international peacekeeping operations.

At this stage, the figures for all military units are not known. Brigadier General Prem Naicker of the Military Health Service said the exact figures will only be known in two months and the available figures are not accurate. He said high figures posted by isolated units are not necessarily indicative of the situation in the rest of the country.

Some two years ago, Metropolitan Life AIDS-researcher Dr. Thomas Mühr claimed that about 40% of the SANDF were HIV-positive. At the time, the military believed the figure was far lower but was not conducting tests for HIV/AIDS. Mühr said he based his initial estimate on statistics from other African states, where men in the military were twice as likely as the civilian population to contract HIV/AIDS.

Mühr pointed out that the areas mentioned by the *Mail & Guardian* were high-risk areas anyway and the general population would have a high incidence of HIV infection. Nonetheless, he said the figures were worrying.

The rate of HIV infection being found in the SANDF at present compares favourably to that of the military in Malawi (75%) and Zimbabwe (80%), but it is worse than in many other African countries, including Angola and the Democratic Republic of Congo.

[JR: If this high rate of HIV/AIDS was found in the military, you can just imagine the rate among the civilian population, which has not been fully tested. Does somebody not want us to know how effective the AIDS epidemic is in Africa?]

REPORT DETAILS MODERN-DAY SLAVERY TRADE

WASHINGTON—As many as 50,000 women and children from Asia, Latin America and Eastern Europe are brought to the United States under false pretenses each year and forced to work as prostitutes, abused laborers or servants, according to a CIA report that is the Government’s first comprehensive assessment of the problem.

The carefully annotated and exhaustively researched 79-page Agency report, “International Trafficking in Women to the United States: A Contemporary Manifestation of Slavery”, paints a broad picture of this hidden trade and of the difficulties Government agencies face in fighting it.

The report, completed in November, is based on more than 150 interviews with Government officials, law-enforcement officers, victims and experts in the United States and abroad, as well as investigative documents and a review of international literature on the subject.

Law-enforcement officials have seen episodic evidence for years of trafficking in immigrant women and children, some as young as 9. The report says officers generally do not like to take on these slavery cases because they are difficult to investigate and prosecute. It also says the nation does not have sufficient laws aimed squarely at this problem, meaning that the penalties often are insubstantial.

Two years ago, Attorney General Janet Reno chartered an interagency task force, saying, “We are not interested in containing modern-day slavery. We want to eradicate it.” The report mentions many efforts to fight the problem but also many barriers to doing so.

During the past two years, while up to 100,000 victims poured into the United States, where they were held in bondage, federal officials estimated that the Government prosecuted cases involving no more than 250 victims.

The Justice Department said it could not provide precise figures.

The report was prepared by a Government intelligence analyst, who was working on assignment to the CIA.

While the report is not classified, it has not been made public. Another Government official who wanted the report’s findings publicized provided a copy.

[JR: How come we never seem to have sufficient laws or enforcement directed at this INS problem, when the 13th Amendment to the Constitution prohibits slavery? I would take slavery to include concubines (prostitutes), indentured servants and extortion of illegal aliens. Are we now following the “New Constitution”?]

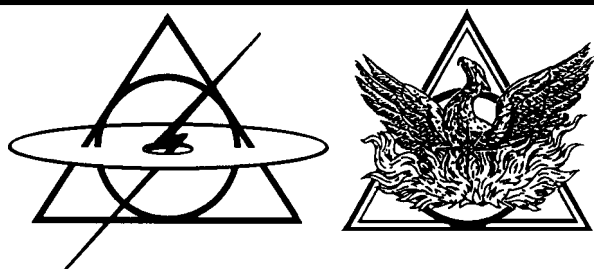
