

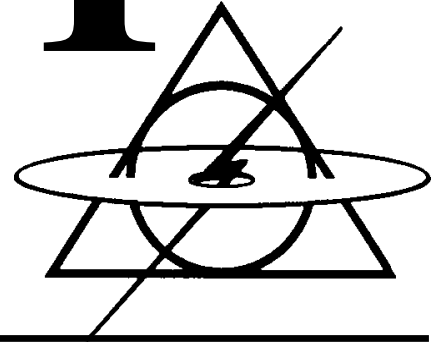

REFORMISTS, OR AGENTS OF VIOLENCE?

Call them what you will, Reformists, the Brady Bunch, OR even "Nietzschean superstars on the stage of violence", as Alfred W. McCoy, a pro-Cory writer and professor of political science at the University of Wisconsin at Madison, did in his series of articles on the RAM Boys published by the *INQUIRER* from late December '89 to January '90.

But it won't change the fact that while Gringo Honasan and his comrades started out as the Defense Department's security force, they nevertheless played a vital role in preventing the communists from taking over from the Menshevik-like Government of the inept Corazon Aquino. Credit must, therefore, be given to the man responsible for molding them into an elite commando force—Juan Ponce Enrile, Marcos' Defense Minister from 1971 to 1986.

Thanks to the behind-the-scene maneuverings of the "forces of separatism", the AFP, after 1978, began splitting into factions which supported rival contenders for Marcos' succession. "Physically weakened by a potentially fatal disease called lupus, Marcos, in an effort to transform his dictatorship into a dynasty, maneuvered to appoint General Fabian Ver as his Chief of Staff. Although a reserve officer with no known combat experience, General Ver was a close Marcos cousin and boyhood friend from Ilocos Norte, whose loyalty was beyond question," notes McCoy.

Naturally, the move alienated Ver's two closest rivals for the all-important post—Defense Minister Juan Ponce Enrile, a brilliant lawyer who has always been regarded as presidential timber; and General Fidel V. Ramos, another Marcos cousin, who graduated from the U.S. Military Academy at West Point.

Marcos reorganized the Armed Forces of the Philippines (AFP) to increase his direct control over the chain of command and put Ver on top of it. "In a radical restructuring of the military hierarchy, Ver divided the country into Regional Unified Commands (RUCs), each a multi-service headquarters that reported directly to the Chief of Staff. Although the RUCs crippled the AFP's combat capacity by overcentralizing authority in GHQ, they allowed Ver direct command over company-size units," McCoy writes.

It was Machiavelli time once again, and "the end justified the means." The new RUCs effectively stripped General Ramos of his Constabulary command. At the same time, Minister Enrile was removed from the chain of command, denying him the authority to move troops. "With all power thus concentrated at GHQ, Ver staffed key posts with his factional partisans, drawn largely from the intelligence community and reserve-officer alumni of his *alma mater*, the University of the Philippines." Moreover, "Ver's system required patronage for all postings and promotions, a change that embittered the regular graduates of the military academy."

Honestly, now, all this is not a simple case of "Absolute power corrupts absolutely." I have always believed that both Marcos and Ver had a legitimate reason for doing what they did. The two gentlemen never had the reputation of being "foolhardy" or reckless.

The reorganization of the AFP, however, was enough to cause the emergence of the Reform the Armed Forces Movement (RAM) in late 1984. To a large extent, it was, as McCoy correctly surmised, a response to the changes introduced by Marcos: "Under martial law, the AFP became thoroughly politicized—no longer the servant of

the state, but the strong arm of a particular regime. Specifically, Marcos used the military to demolish democratic institutions and buttress his new oligarchy."

But did Marcos really "destroy" democratic institutions with the help of his loyal AFP Chief of Staff?

Do not forget that Marcos' decision to "transform" the AFP carried the approval of Big Brother in Washington, D.C. Says U.S. President Ronald Reagan: "He (Marcos) may be a son-of-a-bitch, but he's our son-of-a-bitch." This official policy was reiterated, albeit decently, by then Vice President GEORGE BUSH with the equally unforgettable retort, "We love your adherence to Democracy, Mr. President," during his Manila visit.

[H: With this "connection" continually cemented into place, why is it that we cannot seem to move forward with the very assets born and validated by such as Mr. Bush? Because they have to have a way, in their own realization, in which "containment" can be somehow accomplished without destroying themselves in the process. They know people will not pay attention to these writings—until possibly into the next millennium. So, patience—and realization that WE WILL NOT BREAK OUR COMMITMENTS—HAS TO BECOME REALITY. If we each do our proper things in total reason and logical sequence, all will benefit as freedom begins to spread its fledgling wings once more. Remember that eating all the candy in the store is not a solution to having freedom to eat candy and have it, too!]

We want to work with such as the IMF in a responsible manner, for we need those who can do the bookwork, keep the accounting, share in the growth and keep the criminals and corruption OUT OF THE WORKING ORGANIZATION ITSELF. So, when the dancing and sniffing is over, a better way will evolve and it will be in a workable measure of freedom in its most basic form—at the ground, sea, and for all mankind.

And to you who want it "your way" or feel that a year is too long to accomplish a GLOBAL REVERSAL OF MOVEMENT—so be it, go try it YOUR WAY and let's see what YOU ACCOMPLISH. Not likely, is it? The RIGHT way SHALL present itself and so be it.]

Unfortunately, Marcos' decision to employ the military as a mailed fist "demoralized an officer corps once proud of its professionalism". Thus, when the RAM colonels decided to break from the ranks of the Marcos-controlled military and marched on to the "bridge of no return" by way of a dramatic protest at the Philippine Military Academy (PMA) in March 1985, both local and foreign media hailed them as "idealistic reformers".

Little did the sick, isolated Filipino strongman realize that the incident marked the beginning of the end of his 20-year rule. "As far back as 1982, we had been getting persistent reports (from whom?) that there were efforts to eliminate us... and it was at that point that we decided to organize a group to protect ourselves... now known as the AFP Reform Movement," explains Enrile in a 1986 press conference.

According to reports received by defense intelligence personnel, "The new Chief of Staff had organized a hit team in Mindanao to eliminate Enrile." Working feverishly through loyal PMA graduates on his staff, Enrile slowly but surely recruited some 300 officers and men for his personal security force at the Defense Ministry. As the intrigues between him and Ver escalated in 1983-84, Enrile reportedly employed two British instructors, formerly with the Special Air Service (SAS) commandos, to train Honasan and Company in counter-terrorism. "With the help of proteges at the Bureau of Customs, where he was once Commissioner, Enrile smuggled in over a thousand specialist weapons, mainly Uzis and Galils, PURCHASED THROUGH HIS CONTACTS IN ISRAEL'S MOSSAD," writes Cecil

Arillo in his 1986 bestseller, *BREAKAWAY*.

Not to be outdone, General Ver countered with Israeli instructors for his loyalist elite force, training throughout 1984 and preparing for a battle which never occurred.

[H: No, I don't have a comment, DO YOU?]

Meanwhile, RAM gradually developed into a "Janus-faced group in the AFP". (Janus, the most ancient of the Roman gods, was represented by a double-faced head to signify his knowledge of the present and future. He was a god of the doorway and protector of all entrances.) The public reformist movement has also become a clandestine coup group led by PMA's Class of 1971. Colonel Gregorio "Gringo" Honasan, the Class Captain (Baron), was the logical choice to head its core group, with able assistance coming from fellow Colonels Edgardo "Red" Capunan, Tito Legaspi, Vic Batac and many others.

[H: How many redheaded Gringos do you think there were working for the CIA at that time in historical adventure in the Philippines?]

"Within 18 months of graduation, the Class of '71 became the enforcers of martial law. Instead of learning to respect the primacy of civil authority by serving as its protectors, many of these young officers were learning to dominate and intimidate civilians," McCoy laments. "Over the next 15 years, Class of '71 and its successors had the experience of arresting and torturing civilians who otherwise would have been their social and intellectual superiors."

McCoy, however, conveniently omits any reference to the U.S. CENTRAL INTELLIGENCE AGENCY (CIA) as the RAM boys' silent superiors.

In his interview with Melanie Manlogon of the *INQUIRER*, Navy Captain Rex Robles, the chief political strategist of the AFP Reform Movement, unmasked Alfred W. McCoy as an asset of the Asian Security Intelligence Service (ASIS). "And he also feeds information to the U.S. Embassy. Like in July 1986, during the takeover of the Manila Hotel, he went to Kaplan (CIA station chief)... and told a lot of allegedly intelligence information regarding who was behind the takeover. Actually, he's a paid agent. He's a hack," adds Robles.

Robles was never forgiven by McCoy for this exposé, aside from the fact that the RAM Navy Captain caused McCoy to lose a huge amount of money in the filming of *A Dangerous Life*. "I told the producers that he (McCoy) was a very unreliable source... he was writing about the President (Aquino) being at EDSA, passing through the multitude, like Moses parting the Red Sea. He's too flamboyant. He writes very well. He's an extremely seductive analyst because he can marshal data to support his claims," Robles insists.

Don't they all? I mean, the paid hacks?

The great American industrialist Henry Ford said, "History is bunk." And Napoleon Bonaparte called it "a collection of lies statesmen have agreed upon". For countless generations already, history is what happens in the history books. And, as a Catholic scholar aptly puts it, "Education rests on texts revised with every shift in public policy."

Leaders of the Association of Southeast Asian Nations (ASEAN) have not completely ruled out the possibility of forming a regional parliament and eventually developing a common currency as the group searches for a new mandate under the emerging economic regime.

Trade and Industry Secretary Manuel Roxas II has expressed optimism that the creation of an ASEAN currency would be a natural development as the region matures as an economic and political bloc similar to the European Union.

According to Roxas, ASEAN is now in the process of reassessing its role in the region, especially in the light of the growing tendency towards regional grouping in the global market trying to achieve maximum economies of scale.

“A common ASEAN currency is definitely possible although its development would not be in the phase that most people imagine,” Roxas said. “But the important issue here is that the ASEAN itself is recognizing the need to reassess its new role and identity.”

[H: Ah, but—!]

According to Roxas, the ASEAN parliament would be a natural progression of the regional grouping and the creation of a common currency is not impossible.

“But we have to remember that it would take a long process before this happens,” Roxas said. “The European Union took 50 years after the Second World War to harmonize its legal, political, economic and financial systems.”

Oh, indeed, there is more chest pounding as to what “I”, “Me”, etc. have “tried”, and thus and so—and how it has to take eons to move on anything. I ask you: How long will the farm wait before it is grabbed and YOU go bankrupt?

And dead certainty of delay after delay? “The Department of Finance is still reviewing the impact of this commitment on the Government's revenue targets, but it's likely to be insignificant since the actual volume of trade...”

Looks pretty hopeless, doesn't it?

INTERVENING IN A FAMILY FIGHT

On August 27, 1989, *THE MANILA CHRONICLE's* Pia Hontiveros adorned the Opinion Page of the said newspaper with a provoking article to commemorate the second anniversary of the Reformists' failed coup. She asks an all-important question: Can the RAM stage another coup?

"The EDSA heroes had fallen into a deep, dark abyss. The propaganda leveled against them was unforgiving and unrelenting. They had defied authority, and they were going to pay for it. They had been thrown into oblivion, buried by an avalanche of criticism, judged (prejudged, they claim) by an angered leadership and a disappointed civilian populace. RAM has become synonymous with Honasan, *coup d'état*, messianism, and adventurism," writes Hontiveros.

A week earlier, PC-INP chief Maj. Gen. Ramon

Montano downplayed the RAM threat, stating that the extreme rightist group has become "merely a tertiary threat after the New People's Army (NPA) and the Moro National Liberation Front (MNLF)".

NCRDC Commander Brig. Gen. Rodolfo Biazon concurred with Montano's assessment: "The whole caboodle is reduced to insignificance as a form of threat to the system of government."

Despite information supplied by retired Gen. Rodolfo Canieso, chief of the National Intelligence Coordinating Agency (NICA), that "open communication lines and secret meetings between the rebel officer (Honasan) and active-duty officers were ongoing, and the alleged reluctance of ordinary foot soldiers manning the checkpoints to get Gringo", similar pronouncements of RAM's impending demise have come from all strata of the AFP's corps of officers. They were all wrong.

Late in the afternoon of Thursday, November 30, 1989, the U.S. Pentagon received reports that a 1,000-strong rebel force had seized two air bases in the Philippines. "General Colin Powell, who'd spent much of the day in budget-sessions with the chiefs and the CINCs (Commanders-in-Chief, pronounced "sinks") was alarmed," recalls Bob Woodward, celebrated author of *VEIL: THE SECRET WARS OF THE CIA 1981-1987*; *WIRED*; *The Short Life and Fast Times of John Belushi*; *The Commanders*; and co-author of *The Brethren*; and *All the President's Men*.

[H: Don't miss the coincidence of timing here, my good buddies: This was as the "Contract", now Global, etc., was recertified, registered and all those other nice things—BY ONE, RUSSELL HERMAN. Oh, my goodness....]

Powell immediately motored to Defense Secretary Richard Cheney's office armed with maps and additional intelligence reports. After briefing the Secretary, he went home for dinner. Shortly after 11 p.m., he returned to the Pentagon to take part in a formal NSC meeting conducted by video. According to Woodward, Vice President Dan Quayle chaired the meeting because the President, accompanied by Secretary of State James Baker and Brent Scowcroft, was airborne on the way to Malta for a summit meeting with Soviet boss Mikhail Gorbachev.

"Robert Gates (future CIA Director), Scowcroft's deputy, was reluctant about U.S. military involvement," Woodward reports, a position not taken by Deputy State Secretary Lawrence Eagleburger, who said: "Look, we have no choice. We have to go in, in some form. This is a democratic government that we have sponsored. There really should be no debate. There can be no debate."

Eagleburger's proposal that the Defense Department intervene met with no serious challenge. It was at this point when Powell received reports that Malacanang Palace was being bombed and strafed. These were followed quickly by requests from the Philippine Government that USAF F-4 Phantom jets stationed at Clark Air Base (CAB) bomb the two captured airfields, which the rebels were using to launch the attacks against the presidential palace.

According to Woodward, at around midnight, Quayle received confirmation from Ambassador Platt that the request for intervention was coming directly from Aquino: "Quayle said they had to give President Bush a recommendation and indicated that he thought Mrs. Aquino's request was legitimate and that the United States should comply with it. State and the CIA agreed."

The propeller-driven, World War II vintage T-28s driven by rebel pilots were no match against the F-4 Phantoms. Once again, RAM's latest *putsch* went pffftt. But not before it inflicted heavy damage.

About 400 rebel troops decided to make a gallant stand inside the commercial buildings, luxury hotels and first-class condominiums in Makati's plush Ayala Avenue district, the nation's financial center. For several hours, Rebel and Government troops exchanged fire around the area where the headquarters of 19 of the country's 28 commercial banks and the offices of foreign banks were located.

After the latest coup attempt, a visibly shaken Jaime Cardinal Sin, Cory Aquino's most influential ally, warned of "a social explosion" unless Aquino swiftly defused "unceasing reports of the abusive roles of presidential relatives" (*TIME*, 1/15/90).

A month later, Aquino fired nine of her Cabinet ministers—the third such shakeup of her presidency, in an effort to regain public confidence. *TIME's* John Greenwald was not impressed. "None of the ousted ministers had been accused of corruption, but some of their departments were widely considered ineffective, particularly Justice, Transportation and Education, where services had virtually broken down," writes Greenwald, "To many Filipinos, however, the reshuffling looked too modest to silence claims of scandal in high places."

The favorite target of Metro Manila's rumor mills was Aquino's controversial brother, Rep. Jose "Peping" Cojuangco, Jr., of Tarlac. "Shortly after Aquino took office, newspaper stories charged that Cojuangco had helped some of his cronies gain control of a lucrative cargo-handling business," notes Woodward, "he is also suspected of using family ties to get jobs for friends in Manila casinos."

Cojuangco's wife, Margarita, who later on became Tarlac's Governor, was also a favorite topic among social and political circles. She was suspected of having taken a \$1 million bribe from an Australian national to help him obtain a license to operate a casino. The National Bureau of Investigation (NBI), however, filed no charges against her. Instead, Margarita "Tingting" Cojuangco was exonerated. The NBI said that a woman who impersonated her was the real culprit. Such is the justice system "in a country where the rich and powerful are perceived to be above the law".

Meanwhile, the rifts in the military continued to grow deeper, despite the capture of Brig. Gen. Edgardo Abenina, the highest-ranking leader of the failed December 1989 coup. With Abenina in custody, Gen. Renato de Villa, the AFP's Chief of Staff, proudly announced in a press conference that Rebel forces had "undoubtedly weakened" and that Abenina's fall had "further reduced the capability of the 1,000 or more accused plotters still at large to destabilize society" (*TIME*, 2/12/90).

But *TIME's* William R. Doerner was not impressed by de Villa's claim. "The very circumstances of Abenina's capture suggest otherwise," Doerner observes. "He was apprehended while meeting at the home of millionaire businessman Venicio Ramos, with two middle-ranking Philippine Constabulary (PC) officers not previously linked to the coup attempt. Their association with a fugitive *putsch* leader—and one with a \$47,000 price tag on his head at that—added credence to rumors that mutinous military leaders have begun recruiting active-duty officers for the next coup against the Government of President Corazon Aquino," he adds.

Prior to his capture in February 1990, the now defunct *NEWSDAY* published General Abenina's message to the public. Part of it reads:

"The soldiers of the people will see to it that real democracy and peace will soon dawn on our prostrate nation. Lest we forget, peace and democracy do not mean

the continued plunder by the Aquino elite of the limited resources of our country, the unprecedented graft and corruption nationwide, the proliferation of gambling and other illegal activities for the benefit of the Cojuangco-Aquino minions. It does not and should not at all mean the runaway rise in the price of basic commodities in the midst of the wage ceilings and unemployment. It does not mean continued monopoly of the fruits of our labors by a few. It does not mean the absence of basic services despite tremendous increases in the national budget. Peace and democracy do not mean silence in the face of grave injustice nor opportunism amidst continuing misery. Neither should it mean the abject surrender of our national pride and sovereignty. This is not the kind of peace and democracy we all cherish and fight for" (1/13/90).

General Edgardo Abenina will always be remembered by his comrades-in-arms as one of the AFP's most brilliant and able commanders. But the world of geopolitics is more complicated and more difficult to read than a military map marked with troop deployment.

"Politics make for strange bedfellows. A nation or an institution under pressure, fighting for its objectives and even for its survival, will make alliances when and where they can be made—and often, if expedient, with nations or institutions theoretically inimical. History, on one level, is a compendium of strange, ill-associated coalitions, grotesquely mismatched marriages." This aptly describes the U.S.-Aquino alliance which confronted the RAM-SEP-YOU in the field of this latest acoustics warfare.

Why acoustics? Because some of those who orchestrated the whole affair, like General Powell, were not prepared to kill some of their own creation. "If we kill Filipinos, no one in the Philippines will forgive us. Let's try something short of bombing. We can't stick our nose too far into a family fight," Powell said.

But the Americans did. Don't they always?

Gold And Other Interesting Things

Hatonn—E.J., regarding the deeds, contracts, and what have you wherein you keep getting demands for "AAA" certification and such as "where is the certificate" and other such irrelevant matters, I suggest you do a simple paper with some of these ideas:

If you present a "certificate", certified copy of same, or give locations as asked; the response from the bank, politician or Federal Reserve/IMF/U.S. Treasury Dept. will be: "That is totally invalid (in other words, no good). CHAPTER 20

YAMASHITA’S GOLD—AGAIN?

On October 5, 1990, the *Philippine Star* came out with the stunning news that the late President Marcos actually recovered half of the estimated \$80 billion worth of Yamashita’s fabled treasure. The fishy report came from Solicitor General Francisco Chavez, who was in Negros Occidental at the time.

According to Chavez, former Aurora Province Governor Orlando Dulay had confirmed to him and PCGG Chairman David Castro that the Yamashita Treasure was excavated in two places in Luzon by the late strongman. The rest, according to Dulay, was still in Antipolo and could be worth up to \$40 billion at the current price of gold.

Chavez told a press conference in Bacolod City that Dulay had some “verifiable old facts” that may be worth looking into. Dulay reportedly admitted that he was one of three trustees named by Marcos to look after the gold, but he did not name the two others.

Yamashita Treasure?

Manuel L. Morato, then Chairman of the MTRCB, found it hard to believe. “If, indeed, there is such a treasure, it could not have been buried in this country... it could be possible that this fortune was brought to Japan, knowing that the Japanese are very nationalistic... this could be the reason for Japan’s phenomenal rise from the ravages of war.”

Manoling, as he is fondly called by friends, expressed this possibility “because my father’s car was brought to Japan by Yamashita”.

Don Tomas Morato, the illustrious Mayor of Quezon City, had a “Graham Bell” limousine, a very special model, which his family used before the war. It was the Mayor’s hobby to be the first proud owner or buyer of any latest model brought to the Philippines by La Estrella del Norte, Inc., then the premier importer of automobiles. Unfortunately, the prized car was confiscated by Yamashita and became his official service vehicle while he was here. Later, the Japanese General took it to Japan and, since then, the Morato family had not heard about it.

Joe “Take It Away” Quirino of the *Philippine Star* concurred with Manoling. “Yamashita was not only a brave officer; he was also upright and honest and would never think of hoarding someone else’s treasure or gold. When he took command of Nippon forces in a last-ditch effort to defend the Cordilleras, Yamashita had no time for gathering gold bullion or any kind of treasure. It is completely unfair, therefore, to link Yamashita to any treasure hoard or gold bullion,” Quirino insisted.

Despite the clear fact that Yamashita was a victim of judicial lynching, he never lost his composure. One of his prosecutors reportedly told Yamashita’s chief defense counsel, Frank A. Reel, “Damn it. It makes me mad, seeing him decked out in uniform. He steals the show, dominates the council room. If I had my way, I’d put him in prison overalls and chains.”

According to Quirino, Yamashita accepted the verdict calmly, saying, “I am not ashamed before God for what I’ve done when I have to die. But if you say to me, ‘You do not have the ability to command a Japanese army,’ I should say nothing because it is in my own nature. I know that all your American military officers have been very tolerant and exercised rightful judgment, when I have had good treatment, kind attitude from your good-natured officers who, all the time,

protected me. I’ll never forget what they have done for me. Even if I die, I don’t blame my executioners. I’ll pray to God to bless them.”

Are these the words of a thief and a plunderer?

So why did Dulay insist that the Marcos Gold Haul is a part of Yamashita’s treasure? Perhaps that is what he was made to believe—by his peers and maybe by Marcos himself.

“He, Dulay, was approached by Castro and Chavez. I think the Solicitor General helped him with a manifestation in his petition with the Supreme Court,” said Chuck McDougald in an interview by Roy de Guzman of the *Inquirer*. “But he was given a condition: He had to show one gold bar before he is taken out of prison. He did not, so it did not push through.”

Dulay never came out of his prison cell alive. He died A MYSTERIOUS death.

CHAPTER 21

IMELDA AND THE WE FORUM SERIES

In her latest political charade charade designed to capture the attention of voters in the 1998 presidential elections, Madam Imelda Marcos told a press forum: “If you know how rich you are, you are not rich. But me, I am not aware of the extent of my wealth. That’s how rich we are.”—*Inquirer*, March 27, 1998

The former First Lady publicly admitted, for the first time, that her family has more than \$800 million in secret bank accounts abroad, over and above the \$540 million in two Swiss banks which the Philippine Government claims to be part of Marcos’ ill-gotten wealth.

[H: Don’t you just love the over-and-over-and-over-again reference to Marcos’ “ILL-GOTTEN” wealth? WHO SAYS THE WEALTH MARCOS HELD WAS/IS “ILL-GOTTEN”? IT WAS NOT “ILL-GOTTEN” AND WE FULLY INTEND, BEFORE WE FINISH THIS TALE, TO PROVE THAT FACT.]

“There is more wealth that this Government is not aware of but, for the time being, I can admit that there is only \$800 million kept in various banks. But I cannot reveal them,” she added.

In January 1990, the now defunct *We Forum* ran an investigative series on the magnitude of the Marcos gold. In the first part, Eric Giron revealed some shocking information on the Gold Haul. “Whatever gold General Tomoyuki Yamashita, the wartime overall commander of the Japanese Imperial forces in the Philippines, was able to scrape from Asian sites as claimed, was a mere drop in the bucket of the 75,000 metric tons of gold transmitted by Marcos to London and other foreign gold pools between 1970 and 1983,” according to Giron. “This haul,” he added, “would be nearly equal to all the gold estimated to have been mined legitimately throughout history.”

The revelation practically doused cold water on Dan Swihart’s claim that “gold bars had been found in Tarlac and five areas in Nueva Ecija”, and that some survivors of World War II testified that 3,000 Philippine areas kept treasures of Yamashita taken from Asian sites. Swihart claimed to be a consultant of the International Precious Metals, Inc.

The *We Forum* series, likewise, asserted that Marcos’ private airplane and commercial airlines ferried the gold bullion to a bank in Zurich about 12 times. A

KLM Royal Dutch Airlines flight to Zurich reportedly carried a cargo of seven tons of bullion on September 26, 1963. At the same time, another 3,000 kilos were shipped to London.

Marcos' method of shipping his bullion out of the country was discovered by U.S. Customs personnel who stumbled upon a pouchful of documents carried by one of General Fabian Ver's operatives. "Marcos devised a scheme to float large loans using the gold bullion stored in a privately owned bank of Marcos crony Roberto Benedicto. The sale was to be made through an accountant with CIA connections in Alexandria, Virginia," elaborated Giron.

This information was supported by confidential correspondence received by Giron from a Makati-based corporation, which read, "gold bars in the Philippines of about 62,321 metric tons or more with 99.99 percent purity were negotiated for investment loans from 1980 to 1984... The huge sums intended for investment loans were still intact, or 'frozen' with 800 prime banks in the U.S.A. and 500 prime banks on the European continent..."

Giron's set of documents also included one which showed former President Ferdinand Marcos as "a coded private seller of scattered gold bars using the services of coded agent PN-1518254 and his 25 secret groups", with the participation of U.S. and European secret organizations.

"Even when Marcos was an exile in Honolulu on February 22, 1987, he was still selling gold bullion, this time openly," pointed out Giron. "The stationery bearing an etching of the deposed President's face, the Malacanang seal and his signature carried an offer of 25,000 metric tons or more of gold bullion with 99.95 percent purity or 24 karats in different places such as Canada, Australia, Holland, Alaska, India and Zurich."

The personal and very confidential letter dated 21 February, 1981 addressed to "Her Excellency, Madam Imelda Romualdez-Marcos, Malacanang Palace", opening with a list of Government officials and top-ranking businessmen concerned with what was camouflaged as "Japanese financial aid to the Philippines", was part of the coded sales, insisted Giron.

The letter further read, "The Japanese aid consists of accumulated interest income of dollar fund left in trust by General MacArthur to the Imperial Family. The trustees are two Americans and one Japanese by the name of Mr. Yutaka Aoki... We are devising a means of how to bring out the money to Hong Kong under the authority of the Ministry of Finance of Japan and your cooperation is needed. It shall be made to appear that the money will be loaned to a Japanese company doing business in the Philippines and they found that Kawasaki is qualified. The Trust money in the hands of the Imperial Family has already been deposited with Sanwa Bank in Osaka and is ready for the economic development project of the First Lady."

NOTE: One nagging problem is Imelda Marcos' continued promises to share Marcos' wealth with the Filipino people. Some of the Marcos gold accounts under her name had been earlier changed by the late President into other accounts in 1987 to safeguard and secure the fruits of his toil. In the process, Marcos was merely protecting his family and the Filipino people, who will finally stand to benefit from all his wealth.

CHAPTER 22

PEDROSA'S TOUCHÉ

What really are our chances of recovering the Marcos gold from Switzerland?

Very slim. There are many things which even Filipino scholars do not know about the Alpine State. Switzerland is a federal republic "invented" by the Rothschilds and other prominent members of international banking and finance who organized the Congress of Vienna (1814-1815). It was primarily designed to become the new financial center. Since then, globalists have used Swiss banks to trap the unwary. Even if a head of state was knowledgeable and wise enough not to choose a bank with a name like Rothschild, the fact remains that the conspiracy controls several other banks in Switzerland.

Here is where the trouble comes in, as prominent author and top *Star* columnist Carmen Nararro-Pedrosa discovered, in her probe into the Marcos wealth. It only goes to show that nations need an honest-to-goodness professional consulting firm to determine how to benefit from Switzerland's unique political, legal and banking system—and avoid the crooks.

In her regular *Star* column "From a Distance", Pedrosa writes: "What stands in the way of the Philippine claim is Switzerland, a powerful and wealthy country that has traditionally rejected attempts by countries victimized by their own leaders to recover the wealth. Filipinos must recognize that Switzerland is a country sustained by an iniquitous banking system. Any initiative by the Philippine Government, whoever is at the head, will be vulnerable to the blandishments of the Swiss system, who are used in warding off any attempt by claimants to remove disputed deposits, whether stolen gold or cash, from their dominion. It is a given that the Swiss will attack the credibility of any individual involved in any campaign against the Swiss banking system. This partly explains the timidity of officials in tackling the Marcos gold despite evidence that the Swiss have not been forthcoming about it. Earlier attempts to defeat the Swiss banking system were ultimately destroyed by intrigue and innuendo."

Pedrosa points to *Operation Big Bird* and *Oplan Domino*, which failed because "the role played by those protecting the Swiss banking system was not properly recognized." How true! Some of those involved in the recovery project worked clandestinely with the Swiss authorities!

An American expert who has been involved with the Swiss banking industry for thirty years has cautioned individuals and nations over the years that they must deal only with a publicly owned Swiss bank. Under Swiss law, publicly owned banks with stock in the hands of the public must be controlled only by Swiss citizens. In other words, the voting shares cannot be sold to foreigners. This simple fact is absolutely critical in maintaining the security of the Swiss political, legal and banking system.

So, why didn't Marcos deposit his wealth in publicly owned Swiss banks? Why did he opt to deal with highly touted banks like UBS, which is controlled by globalists?

"The Swiss were co-conspirators of Marcos in stashing the wealth away from the Philippines," Pedrosa insists. "This was blatantly demonstrated by Peter Cosandey when he 'raided' Freilager A.G. to satisfy Swiss media and the public that the gold does not exist."

Cosandey's behavior was, indeed, suspicious. First,

he publicly announced that a raid of the Klotten warehouse was to be initiated by him just before he conducted it. Then, he invited members of the media to accompany him on his "raid" but did not allow any of them to enter the warehouse. Cosandey's moves have been more than enough to prove nothing but complicity.

According to Pedrosa, the whole thing was triggered by what she believed to be a mistake on the part of the PCGG agent, Reiner Jacobi. "He represented the evidence to Peter Cosandey, the Zurich District Attorney, who was in charge of 'helping' the Philippines in its search and claim for the Marcos Swiss gold deposit." The evidence pointed to the physical whereabouts of the loot—in the form of account numbers in the Union Bank of Switzerland and storage vault numbers in Freilager A.G.

In his search for the Marcos gold, Jacobi, a private investigator from Australia, was arrested and imprisoned three times while gathering evidence. His last arrest was in his Sanctuary Cover residence in Australia, on the same charges hurled against him in 1992, when he was in Hong Kong. At that time, he had just discovered the location of the Marcos gold in Freilager A.G., a warehouse situated underneath the Klotten Airport in Zurich.

At present, Jacobi is free and is now back in Australia. Strangely, Pedrosa has noted the telltale pattern when every time he revives public interest concerning the Marcos gold in Switzerland, he always gets into trouble.

In the light of everything that has been revealed by Mrs. Pedrosa on her end, how do we increase our chances of getting back the Marcos gold from the Swiss?

"The key to the success of our campaign or any other campaign is to keep our minds focused on what unites us, not on what divides us, even if what divides us is true," Pedrosa pointed out. I agree. But you can bet your bottom dollar that the Swiss authorities will do everything in their power to keep us divided.

This is the very reason behind former President Fidel V. Ramos' usual application of his pet principle: "pliant like a bamboo", by keeping humble, patient and calculating, to unify the Filipino people, from the right, to the left, from the Moroland, our listless military, and now, the political factions each being given their piece of the action, all in the name of peace.

TOP COURT TO WEIGH “PARTIAL-BIRTH” ISSUE

Orlando Sentinel, 4/24/00

WASHINGTON (AP)—The U.S. Supreme Court on Tuesday will hear a challenge to the Nebraska law banning so-called partial-birth abortions. It is the Court’s first major case dealing with abortion rights in eight years.

People on both sides of the issue say the Court’s decision will either safeguard or significantly erode abortion rights in the United States.

“Partial-birth abortion” is not a medical term; it is the term used by abortion opponents. Nebraska’s law defines the banned procedure as “partially delivering, vaginally, a living unborn child before killing the unborn child and completing the delivery”.

Nebraska Attorney General Don Stenberg, who is using the case as the cornerstone of his U.S. Senate campaign, plans to argue that the ban is limited to a procedure doctors call D&X, or dilation and extraction, which involves cutting the skull of a fetus and draining its contents before extracting it.

Dr. LeRoy Carhart, whose suit is challenging the law, maintains the ban is written in such a way that it could be used to outlaw all abortions.

Under the Nebraska law, performing the procedure

described in the law—for any reason other than to save the life of the mother—is punishable by a 25-year prison sentence. The law was put on hold until the matter was resolved in the courts.

The High Court took the Nebraska case because of conflicting decisions by federal appeals courts.

Ah, but Mom and Dad will bring the child in and wash off all that wondrous soup, scold if his clothes are soiled and then go wash down the area, disallowing further creative adventures until the mud puddle dries. Moreover, one tablespoon of good clean mud soup has more nutritive value than a week’s intake of junk food, on which mankind now relies for maintenance. You do, indeed, usually throw out the best part of the soup! Ah, but it is the grit in the teeth that is such a turnoff? Yes, I know.

So, about us—as individuals—trying?

Sometimes, people individual, when you take away from the very harmony and unity of a group of community people, you are more selfish in your own self than all the others put together. If our way is insufficient in the face of open debate and potential—yours included, as in suggestions for improvement—then you are most certainly free to move on or away. People latch on at all costs, while we have no chains or strings AT ALL—ON ANYONE.

Is THIS a put-down? NO, IT IS FULL RECOGNITION OF YOUR FREEDOM AS AN ADULT INDIVIDUAL WHO NEEDS FREEDOM TO FUNCTION ACCORDING TO “YOUR OWN” ACCEPTED NEEDS AND DESIRES.

Don’t lay that old guilt trip onto us, either—that one that says, “But I gave up everything to come, go, swim or fly to do this job or service, or waiting game or WHATEVER.” NO, YOU DID NOT! WHATEVER YOU DID OR DO IS FOR SELF—PERIOD—END OF DEBATE. Most, in fact, came without invitation or livelihood for selves and then wanted jobs, income, shelter, etc. And now, they dump their never-ending complaints on those who couldn’t produce enough to please them for their intrusion. No, thank you, we accept no more flagellation across our backs. GO BE WHERE YOU CHOOSE, DO THAT WHICH YOU CHOOSE, ASSOCIATE WITH WHOM YOU CHOOSE—AND THAT IS SIMPLY THE WAY IT IS.

However, we are not here for your entertainment, business acquisitions or management opportunities. We most certainly are NOT welfare programs.

People who loaned help to the Phoenix Institute were CLEARLY and KNOWINGLY lending to a program for projects which would be humanitarian and growth-oriented to both soul and body. We have so many projects underway and begun years and years ago—which have subsequently been attacked and made non-productive through direct assaults by the very inside recipients of the rewards. No, it is NOT OK, and to those who DO find this project underway to be the greatest in the world itself—you have severed your connections, in most instances, from even knowing about it. Even if you have a poison serpent and you kill it dead—you have ended your potential source of anti-venom. There is no fruit from a “chopped-down” tree. I HAPPEN TO BELIEVE THAT THOSE WHO WERE SET UP TO TAKE THE BLAME WILL NOT LONGER SIT STILL IN A COURT OF LAW FOR THE THIEVES TO GO FREE, WHILE THEY ARE FOUND GUILTY OF THAT WHICH THEY “DID NOT DO”.

Yes, indeed, of all the things we have learned, one is that you can live a full LIFETIME—and until a building falls down of old age—before the judicial system does its work. Justice aside, the game is to delay and defraud, and keep the case alive and income flowing to the system and the lawyers. BANKING EVENTS AND RECEIVERSHIPS

Hatonn—Without pushing panic buttons, I would like to point out a few things underway and coming public—at least in the Philippines, currently—regarding banks, losses, gains, receiverships and especially “runs”.

Do we, for instance, wish Rick Martin to SUFFER throughout his life, in poverty and trouble? There were projects laid forth early in our acquaintance, by Rick, that still bear positive potential, and my suggestion is that he be structuring some possibilities of projects for building and growth. I would guess that it might well be more “comfortable” in some other location than at present because trust and reliance are now missing in relationships. But that, too, can be overcome.

There will NEVER again be a structured interchange or participation as existed prior to now. And people who find it difficult to function within a given circle of co-workers must realize that there can only be service in setting forth independently within your own “mission” or “business” venture/adventure.

As for Charles and “projects”, he has a great potential contribution to make and reward to be gained. He worked constantly and diligently on projects and growth, as necessary, without stinting.

Each individual, however, must act for self—and yes, indeed, bring along your friends, for God has plenty of room and plenty of jobs available.

I do not choose to address anyone(s) other than Rick, Gail and Charles. And furthermore, yes, indeed, there is great restitution to be set forth before my team finds acceptance and my presentation has NOTHING to do with “team attitudes” about the same named parties. Ultimately, the HUMAN realization and perspective must be balanced and made JUST before going forward in any relationship. It is mandatory that responsibility is met in all instances where there has been DELIBERATE DAMAGE PURPOSELY INFLICTED, EVEN IF ONLY THROUGH ASSOCIATION, BUT THIS GOES FAR BEYOND ASSOCIATIONS.

Surely, Rick realizes that he is not particularly respected or desired by the *Spectrum* “management” as a person or attachment—but it is also quite obvious that Rick is providing the CONTENT of value to the *Spectrum* paper itself. OST JUDGE RULES: ATTORNEY GENERAL ERIE DISBARRED INDEFINITELY!

RED CLOUD BUILDING, PINE RIDGE INDIAN RESERVATION, S.D.—In their continuing struggle for justice, the Grass Roots Oyate won a battle in the war against corruption today. An elder member of the Grass Roots Oyate, acting on his own behalf, filed a petition to the tribal Court requesting that temporary tribal Attorney General Richard Erie reimburse the Oglala Sioux Tribe for funds he received for travel expenses. The plaintiff, Robert Ecoffey, Sr., alleged that Richard Erie, a non-tribal member, was double-billing the Tribe for travel and mileage on his expense report and that he should be disbarred for his deceptive practices.

Erie, who arrived at the tribal courthouse in a white limousine with two elderly Lakota women, sauntered into the courtroom and maintained a flippant attitude throughout the proceedings. The women that accompanied Erie, staunch supporters of the allegedly corrupt tribal government, seemed to be attempting to bring credibility to Erie's deteriorating reputation. However, OST Head Judge Patrick Lee was not swayed by Erie's usual melodramatics. One day after hearing the case, he ruled in favor of the plaintiff, citing that Erie, as a professional attorney, must conduct himself above that of an average citizen. He went on to say that Erie showed deceptive tactics by double-billing the Tribe and that it was grounds for disbarment under the Tribe's judicial code. The ruling stated that Erie's tribal license is to be immediately revoked and he is to be disbarred indefinitely, pending a final ruling by the Oglala Sioux Supreme Court.

Grass Roots Oyate spokespeople believe that the power of the sacred pipe, which has been the only instrument used in their peaceful occupation, has again brought out the truth. Since arriving on the reservation, Erie has used unprecedented measures to remove the Grass Roots Oyate from the Tribe's administrative offices.

Another interloper has been exposed on the Pine Ridge Reservation. A group called United Native Nations, headed up by Rudy James and Antoinette Red Woman, non-tribal members, attempted to host referendum elections that would effectively abolish the 1868 *Fort Laramie Treaty* that the Tribe signed with the U.S. James has lured a small group of unwitting tribal members with promises of immediate access to \$100 million, if they sign his documents. The Grass Roots Oyate became very leery of James' offer and, through an investigation have found that no such funds are available to the Tribe—**unless they relinquish their mineral rights or possibly accept settlement monies from the Black Hills Land Claim Judgment.** Further, his claim that "self governance" is the only solution for our Tribe is callous and arrogant, say Grass Roots spokespeople. The Oglala Lakota, one of seven bands of the Great Sioux Nation does have an active treaty with the U.S. Therefore, the self-governance approach does not apply here. The Grass Roots Oyate, along with the newly appointed Traditional General Council, are formulating a transitional government that will reestablish the original form of governance that

effectively administered this Tribe for centuries. To that end, the Grass Roots Oyate passed a resolution to prohibit James and his organization from holding elections here.

Millie Horn Cloud, keeper of the original sacred pipe used at the signing of the 1868 *Fort Laramie Treaty*, took the Grass Roots' case to Washington. In a 45-minute meeting with U.S. Senate Minority Leader Tom Daschle (S.D.), Ms. Horn Cloud briefed Senator Daschle on the events that have surrounded the occupation in Pine Ridge. She requested that Daschle use whatever power and influence he has to initiate a Senate Select Committee investigation into the misappropriation of federally-allocated tribal funds and the Bureau of Indian Affairs involvement at the local, regional and national levels. Daschle, who introduced a bill to the Senate to take over 100,000 acres of treaty land from the Great Sioux Nation, has been harshly criticized by indigenous tribes. This action was a direct violation of the 1868 *Fort Laramie Treaty*. The bill successfully passed through the Senate. If Daschle does not attempt to save face and assist the Oglala Lakota in their efforts to expose corruption and reformulate their government, the Grass Roots Oyate will seek assistance from Republicans, currently chomping at the proverbial bit to look favorable to Indian nations in this election year.

In the 102nd day of the peaceful occupation of the Red Cloud Building, the Grass Roots Oyate maintain an optimistic attitude and remain hopeful that justice will prevail. One of their nine demands, a five-year, full forensic audit of the Tribe's financials, is well underway. The Grass Roots Oyate are confident that this audit will support their allegations against the tribal Treasurer, Wesley "Chuck" Jacobs, the Tribe's C.P.A., John Donham, and members of the tribal Council for gross mismanagement and embezzlement of tribal funds.

OPENING KOSOVO TO FOREIGN CAPITAL

In occupied Kosovo under the mandate of UN peacekeeping, State terror and the "free market" go hand in hand. The concurrent criminalisation of State institutions is not incompatible with the West's economic and strategic objectives in the Balkans. Notwithstanding the massacres of civilians, the self-proclaimed KLA Administration has committed itself to establishing a "secure and stable environment" for foreign investors and international financial institutions.

Minister of Finance Adem Grobozci and other representatives of the Provisional Government invited to the various donor conferences are all KLA appointees. In contrast, members of the KDL of Ibrahim Rugova (in duly elected parliamentary elections) were not even invited to attend the Stabilization Summit in Sarajevo in July 1999. More recently, UNMIK Head Bernard Kouchner has called for the dissolution of Rugova's Parliament.

"Free-market reforms" have been envisaged for Kosovo under the supervision of the *Bretton Woods* institutions largely replicating the structures of the *Rambouillet Agreement*. Article I (Chapter 4a) of the

Rambouillet Agreement stipulated that "The economy of Kosovo shall function in accordance with free-market principles". The KLA government will largely be responsible for implementing these reforms and ensuring that loan conditionalities are met.

In close liaison with NATO, the Washington-based financial institutions had already analyzed the consequences of an eventual military intervention leading to the occupation of Kosovo: Almost a year prior to the beginning of the War, the World Bank conducted "simulations" which "anticipated the possibility of an emergency scenario arising out of the tensions in Kosovo".

While the bombing was still ongoing, the World Bank and the European Commission were given a special mandate for "coordinating donors' economic assistance in the Balkans". The underlying terms of reference did not exclude Yugoslavia from receiving donor support. It was, however, clearly stipulated that Belgrade would be eligible for reconstruction loans "once political conditions there change".

With regard to Kosovo, the World Bank, rather than providing loans to rebuild the province's infrastructure, has focused its intervention on providing "assistance in designing the reconstruction and recovery program", as well as so-called "policy advice in economic management" and "institution building", namely "governance". In other words, an army of lawyers and consultants have been sent in to ensure Kosovo's transition to a "thriving, open and transparent market economy".

Support granted to the KLA Provisional Government would be geared towards "the establish[ment] [of] transparent, effective and sustainable institutions". An "enabling environment" for foreign capital is to be established alongside suitably devised "social safety nets" and "poverty alleviation programs".

Meanwhile, Yugoslav State banks operating in Pristina have been closed down. The deutschmark has been adopted as legal tender and the banking system has been handed over to Germany's Commerzbank AG, which is the sole private shareholder in Micro Enterprise Bank (MEB) formed in early 2000 at the initiative of the World Bank's International Finance Corporation (IFC), the European Bank for Reconstruction and Development (EBRD) together with the Nederlandse Financierings-Maatschappij voor Ontwikkelingslanden (FMO), Germany's Internationale Micro Investitionen (IMI) and Kreditanstalt für Wiederaufbau (KfW). Commerzbank AG will gain control over commercial banking functions for the province including money transfers and foreign exchange transactions.

The Trebca Mines

The "reconstruction" of Kosovo financed by international debt largely purports to transfer Kosovo's extensive wealth in mineral resources and coal to multinational capital. In this regard, the KLA had already occupied (pending their privatization) the largest coal mine at Belacevac in Dobro Selo, northwest of Pristina. In turn, foreign capital had its eyes riveted on the massive Trebca mining complex, which constitutes "the most valuable piece of real estate in the Balkans, worth at least \$5 billion". The Trebca complex not only includes copper and large reserves of zinc but also cadmium, gold and silver. It has several smelting plants, 17 metal-treatment sites, a power plant and Yugoslavia's largest battery plant. Northern Kosovo also has estimated reserves of 17 billion tons of coal and lignite.

The management of some of the State-owned enterprises and public utilities was taken over by KLA appointees. In turn, the leaders of the Provisional

Government of Kosovo (PGK) have become “the brokers” of multinational capital committed to handing over the Kosovar economy at bargain prices to foreign investors.

In the wake of the bombings, the Zvecan smelter (belonging to the Trebca Complex) located northwest of Mitrovica, however, remained under Serb management. In July 1999, UNMIK head of mission Bernard Kouchner issued a decree to the effect that: “UNMIK shall administer movable or immovable property, including monetary accounts, and other property of, or registered in the name of the Federal Republic of Yugoslavia or the Republic of Serbia or any of its organs, which is in the territory of Kosovo”.

In November 1999, the International Crisis Group (ICG), a think tank supported by financier George Soros, issued a paper on “Trepca: Making Sense of the Labyrinth”, which advised the United Nations Mission in Kosovo (UNMIK) “to take over the Trepca mining complex from the Serbs as quickly as possible” and explained how this should be done prior to their eventual privatization.

Meanwhile, the George Soros Foundation for an Open Society had opened a branch office in Pristina, establishing the Kosovo Foundation for an Open Society (KFOS) as part of Soros’ network of “non-profit foundations” in the Balkans, Eastern Europe and the former Soviet Union. Together with the World Bank’s Post Conflict Trust Fund, the Kosovo Open Society Foundation (KOSF) will be providing “targeted support” for “the development of local governments to allow them to serve their communities in a transparent, fair, and accountable manner”. Since most of these local governments are in the hands of KLA appointees, this program is unlikely to meet its declared objective. Out of the 20 million dollars budget for this program, only one million dollars is being provided by the World Bank.

[JR: Wake up, people of the lie! This article clearly shows that the War in Kosovo was to secure the wealth of this area for the multinationals and the World Bank—and for Soros to make a new career move. IMF, WORLD BANK SET OWN PACE FOR REFORM DEBT RELIEF PLAN NOT AFFECTED BY PROTESTS

WASHINGTON—The protests against the International Monetary Fund and World Bank are likely to have little real effect on the pace of reform at the two financial institutions.

The two institutions were already walking grudgingly down that path, pushed in part by private Non-Governmental Organizations (NGOs) and some Third World governments, which have complained for years about the impact of IMF and World Bank policies in the developing world.

In its final statement, the World Bank governing committee pledged to continue a debt-relief program already underway. The private organizations and Third World governments have consistently argued that the failed lending policies of the 1970s and ’80s have saddled many of these countries with crushing debt-repayment schedules that sap their ability to provide health, education and infrastructure improvements for their poorest inhabitants.

The World Bank also pledged unlimited resources to combating the AIDS epidemic that is ravaging the developing world. Of nearly 50 million people infected by the virus, nearly half live in sub-Saharan Africa.

“For efforts to combat AIDS, there will be no limit” to bank lending, World Bank President James Wolfensohn said. “I said to our African clients, ‘If you have programs, we will fund them.’”

The Bank’s development committee rejected criticism that it was moving too slowly on debt relief for highly indebted, poor countries, known as the HIPC initiative. Five countries have already qualified for \$14 billion in such debt relief with 15 more expected to qualify by year’s end, Wolfensohn said.

He said fewer countries than expected had entered the program because of the Bank’s insistence that the qualifying countries adopt poverty-reduction strategies that outline how the budget savings would be used. “Although you don’t get a dollar-for-dollar outline for the use of HIPC savings, you do get a picture of the overall approach of the country,” he said.

The World Bank, though controlled by the seven leading industrialized nations which provide it with most of its money, is usually called on in these international meetings to represent the interests of less-developed nations. In the final communiqué, the World Bank development committee called on the advanced industrial nations to provide more market access for poor countries, especially in agricultural commodities and textiles.

The U.S., Japan and the European Union have fought Third World efforts to lower agricultural barriers. The U.S., responding to trade-union complaints, has opposed a faster reduction in textile quotas, which are slated to expire in 2005....

...“It is the strong belief at the Bank that a crucial aspect of development is giving access to markets,” said Wolfensohn. “It makes no sense to encourage developing countries to build their capacity to produce goods and not allow access to [industrial nation] markets.”

While the protests forced the IMF and World Bank to focus on the needs of the poor in their public pronouncements, the two institutions have a larger agenda **[Yes, they do: outright theft of the total natural resources of all nations and a worldwide, genocidal (bye-bye “useless eaters”) depopulation agenda]** for reform that often dominated the quiet discussions among finance ministers.

Those discussions focused on reforms the two institutions should take to avoid a repeat of financial crises like the one that ravaged eastern Asia in 1997 and 1998. Most entail placing additional requirements **[shackling “AUSTERITY” pound-of-flesh extortion measures]** on developing countries.

Indeed, the IMF is moving slowly toward a “new financial architecture” that will require governments that borrow from international financial institutions to put in place banking systems **[private central banks that will ensure bankruptcy for once-upon-a-time sovereign nations—and guarantee abject slavery (GCH: “ARE YOU FREE?” or “ARE YOU A SLAVE?”) for all respective citizens thereof]** that will assuage skittish private investors.

The core assumption of the system’s architects, which was unchanged by the weekend protests, is that a global economic system characterized by expanding trade and increasing foreign investment represents the best hope for the world’s poorest people. **[Do any thinking people still honestly believe that these heretofore described Khazarian-Zionist-Bankster Greedmongers actually care about their canon fodder—“the world’s poorest people”?]**

“Everything we know about economic development tells us that countries with stable political structures that attract foreign capital have the most rapid advances in

standards of livings,” said Alan Meltzer, a conservative scholar at the American Enterprise Institute who chaired Congress’ IMF-World Bank Reform Commission. “The IMF is moving gradually in the right direction.”

Protest leaders derisively call this world view the “Washington Consensus”.

“The World Bank should get back to its core mission of alleviating poverty and not catering to the investment interests of large, multinational corporations,” said Andrea Durbin, Director of International Programs at Friends of the Earth.

She called the weekend protests a major success. “Our protests elevated the world’s attention to these international institutions, and how they have to change to better reflect the needs of poor people,” Durbin said.

That is one area where the critics on the left and right agree. They want the IMF to restrict its lending programs to financial crises, and the World Bank to focus on alleviating poverty, the original missions of the agencies.

But officials at both institutions reject those limitations. “In the middle of a crisis, you have to look at where your resources are and what it takes to save your client country,” Wolfensohn said.

He said the long-term reform plans at the two institutions would use the IMF as the lender of last resort in a financial crisis, while the World Bank would focus on long-term development finance. “But we can’t be doctrinaire until we see what kind of crisis comes up,” he said.

[JR: The last statement is the new policy in a nutshell. The IMF/WB reform is in the area of long-term planning, so nothing is really resolved for the present. Most foreign ministers and heads of central banks in these Third World countries work for and are paid by these two institutions, so I wonder how much poverty will really be alleviated and how much funding will actually go to combating (contributing to?) AIDS in Africa.]

ROOTING OUT THE BAD SEEDS?

A pilot program to identify dangerous kids currently is being conducted in public schools without the knowledge of most parents. What will the government do with the data?

To ensure that America’s youth enjoy good mental health, psychologists have been deployed to learning institutions to diagnose behavioral problems and distribute psychotropic drugs such as Ritalin. *Insight’s* groundbreaking articles on this issue have excited commentary from the *New York Times* to *Time* and *Newsweek*. But, as with the gunmen at Columbine High School in Littleton, Colorado, or the 6-year-old shooter in Flint, Michigan, crimes continue to occur in schools despite **[because of]** the growing network of prescription drugs and psychobabble. For parents who are becoming just a little crazed about all this psychological evaluation of their children, the newest initiative to weigh and record the state of mind of every student in the public schools may put them over the edge.

Mosaic 2000, a “method” designed to identify potentially violent children, is being tested at random in high schools throughout the country. The problem for those wary of educators caught up in such psychological experiments is that parents will not have a clue about what soon could amount to criminal profiling of every child. Nor will they know where, beyond the immediate school officials, the information obtained from their children is

sent or how it might affect their future....

...This would-be electronic mind reader isn't the first of its kind. Mosaic computer-profiling systems have been used for years by several federal law-enforcement agencies, including the Secret Service, the U.S. Marshals Service and the Bureau of Alcohol, Tobacco and Firearms (BATF). Contrary to media reports, the BATF is not "involved in Mosaic other than assisting de Becker in the preliminary screening", according to Jeff Roehm, chief of public information for that agency. Roehm explains: "We had a couple of folks who sat on the panel and shared their expertise in law enforcement. They helped in fleshing out the questions that may be asked, but de Becker is a private company offering it to schools."

The BATF is just one of the law-enforcement agencies that played a major role in developing criminal profiling of kids through Mosaic 2000. According to de Becker, Gil Garcetti, the Los Angeles County District Attorney; Richard Devine, the State's Attorney for Cook County, Ill.; and Donald W. Ingwerson, Superintendent of the Los Angeles County Office of Education, are the "three leaders who partnered to facilitate the development and testing of the new system for evaluating threats in schools"....

...Mosaic 2000 is described on the de Becker website as a "computer-assisted method for helping evaluate situations involving students who make threats and might act out violently". Children are questioned by school or law-enforcement officials and the information is fed into the Mosaic system (the children are not told who will evaluate the information or how it will be analyzed). The system then produces a report on the child being evaluated for criminal tendencies....

...After a subject's answers are run through the computer, they are rated on a scale of 1 (low potential for violence) to 10 (high potential for violence). School officials or law officers then make a "threat assessment" of the student.

Critics say the worst potential problems with Mosaic 2000 are encapsulated in what the company stresses never would occur. For instance, de Becker says, Mosaic 2000 is "not a computer program. It will not share information about the students (at least in the field tests), student names will be automatically deleted from the system after the evaluation process is complete and, because Mosaic 2000 helps evaluate situations and not students, it does not explore any demographic questions such as age, gender, ethnicity, socioeconomic situations, etc." In other words, students are not being evaluated—"situations" are evaluated. The information that is fed into the system about the "situation" is not shared with anyone and there is no record of the "assessment"....

...The most important elements of the system, the questions, are carefully guarded and simply unobtainable for independent evaluation. "We don't know if this thing is fish or fowl. We don't know how the information is going to be used," Ted Deeds, Chief Operating Officer of the Law Enforcement Alliance of America, a Virginia-based coalition of law-enforcement officials, victims and citizens united for justice, tells *Insight*. "First, if the data does work, what the hell do you do with it? Will the schools segregate the potentially violent students, isolate them, carry out more locker checks or send them into counseling? What's the review mechanism? They all say it's not a profiling of the student, but we're not convinced."...

... Parents would be insane to allow their children to be put into this kind of database—it could show up for the next 20 years. Does anyone really believe that this information won't be used by other law-enforcement agencies? Just look at the Social Security Number, which

we were promised would never be used for general identification. We've seen these promises before. This isn't anything new; the spin is just a little different"....

...“The principal,” says Aaron Ross, Assistant Superintendent of Reynoldsburg School District in suburban Ohio, “can make a decision with the additional information that has been delivered by Mosaic 2000 with greater confidence in determination of the risk. It's a nice system. It takes the information from the answers provided by the student and organizes them into relevant categories. There is no rating of kids or situations. In fact, it can be completely anonymous. The point of the program is to help the investigator. When he's done, the notes will be thrown away.”...

...Everyone concerned with this project agrees that Mosaic 2000 was born out of the tragedy that occurred last year at Columbine High School, and that its purpose is to identify the potential for violent behavior in schoolchildren. But according to data released by the Bureau of Justice Statistics (BJS) and the National Center for Education Statistics (NCES), schools are safer now than they have been in years. In fact, according to a recent BJS/NCES report, “A child is more likely to be a victim of a violent crime in their community or at home than at school.”...

BAGHDAD, BELGRADE AND MOSCOW COLLABORATE AGAINST WASHINGTON

SUMMARY

Russia has reportedly brokered a deal to upgrade Iraqi air-defense systems. The weapons upgrades Iraq could receive are of the same type that may have downed an F-117 stealth plane over Serbia during *Operation Allied Force*. After a visit to Belgrade, Iraq's Defense Minister met his Russian counterpart in Moscow April 14. There is a substantial history of military cooperation among the three countries, and Iraq and Yugoslavia have recently indicated a possible alliance. The possibility of such an alliance, tacitly supported by Russia, may be nearing reality and could threaten U.S. policy.

ANALYSIS

Iraqi Defense Minister Col. Gen. Sultan Hashim Ahmad arrived in Moscow April 14 and met with Russian Defense Minister Igor Sergeev, reported *Interfax*. Prior

to his arrival in Moscow, Ahmad was in Belgrade, Yugoslavia. The past military cooperation among the three countries offers an explanation of Ahmad's travels. The three may be cooperating to create simultaneous crises for U.S. policy.

Prior to and during Operation Allied Force, Yugoslavia and Iraq maintained close military cooperation. A Yugoslav military delegation, headed by the Deputy Defense Minister, visited Baghdad just before commencement of the NATO bombing of Serbia, according to a March 1999 *Jerusalem Post* report. Both nations, threatened by U.S. warplanes, needed improved air-defense systems. Serb technicians regularly serviced Iraq's Soviet-made MiG-21s and MiG-29s, according to the *Jerusalem Post*. The two nations also reportedly worked out a deal. In return for Yugoslavia rebuilding Iraqi air defenses, Baghdad would provide Belgrade with oil and cash to sustain the war effort.

The Washington Times in March 1999 cited a U.S. intelligence official who said that some of Iraq's integrated air-defense system, including surface-to-air missiles (SAMs), was of “Yugoslav origin” and may have been sent from Russia via Yugoslavia. The paper also claimed that there were reports of limited contacts between Iraqi and Yugoslav air-defense officials several months prior to *Operation Allied Force*.

During *Operation Allied Force* on March 27, 1999, a U.S. Air Force F-117 stealth fighter-bomber went down over Yugoslavia. A U.S. Pentagon official initially assessed that a Serb SAM hit the F-117, reported *The Washington Times*. The official said the plane apparently dropped below 20,000 feet, at which time the Serbs optically spotted the plane and launched either an SA-3 or SA-6 SAM. The report also cited several unnamed U.S. sources, who speculated that Russia had helped upgrade Serbia's air defenses.

The *Times* of London reported Oct. 7 that Russia, in violation of an arms embargo, had actually supplied the Yugoslav Army with new warheads, fuses and sensors for its SA-6 missiles. The Pentagon has still not officially disclosed its findings on what caused the F-117 to go down.

Operation Allied Force stretched U.S. forces to their limits. When the bombing campaign began in March 1999, the aircraft carrier *USS Theodore Roosevelt*, stationed in the Persian Gulf, re-deployed to assist the war effort. Another carrier, the *USS Kitty Hawk*, re-deployed from the Pacific region to cover the Persian Gulf—leaving the entire Pacific region void of a U.S. carrier presence for 86 days. Additionally, many U.S. warplanes stationed in Turkey to enforce the northern no-fly zone in Iraq were used for missions in Yugoslavia—leaving the northern no-fly zone under-patrolled.

Recently, Iraq and Yugoslavia have expressed renewed enthusiasm in mutual cooperation. A Yugoslav delegation, headed by Deputy Prime Minister Maja Gojkovic, was in Baghdad March 28 and met with Iraqi Vice President Taha Yasin Ramadan, who expressed Iraq's eagerness to expand comprehensive cooperation with Yugoslavia.

Iraq now appears to be looking to Yugoslavia and Russia to upgrade its air defenses. The *Interfax* Russian news [agency] reported April 16, 2000 that Iraqi Defense Minister Col. Gen. Sultan Hashim Ahmad arrived in Moscow via Belgrade. In Moscow, Iraq's Defense Minister met with Russian Defense Minister Igor Sergeev.

On the same day, the London-based *Sunday Telegraph* reported that Russian military officials have brokered a deal with Belarus to rebuild Iraq's air defenses.

The report stated that the Belarussian state-owned military hardware company, Beltechexport, agreed to upgrade Iraqi air-defense systems. Under the deal, Beltechexport will upgrade Iraqi anti-aircraft guns as well as Iraq's SA-3 anti-aircraft missiles. Also, Iraqi air-defense crews will reportedly be sent to Belarus for specialized training, where they will be familiarized with the latest Russian electronic-warfare systems.

If the report is true, it would not be the first time Iraq has attempted to upgrade its air defenses to threaten U.S. and British warplanes. In 1998, the CIA uncovered a plot by Iraqi agents to secretly purchase Tamara—a special electronic-warfare system made in the Czech Republic that can track radar-evading stealth planes like the F-117 and B-2 and may have been involved in the F-117 stealth shoot-down over Serbia.

Military and technological cooperation between Baghdad and Belgrade poses potential simultaneous threats in two different arenas. Milosevic may simply be helping Iraq to give himself some leeway without launching his own crisis. However, if Iraq seriously threatened U.S. warplanes while Milosevic simultaneously ignited a crisis in Kosovo, the United States would have serious trouble containing both crises. It is not certain that Saddam acting alone would want to shoot down U.S. planes—even if he could. There would be severe repercussions, such as the extensive bombing of palaces and military facilities. The real threat is a dual crises in Iraq and Yugoslavia.

Russia is positioned to challenge U.S. policies and has criticized the NATO bombing of Yugoslavia and the UN bombing of Iraq. The downing of the F-117 in Serbia was linked to reports that Moscow upgraded Yugoslav air defenses, and Russia is now reportedly behind Iraqi attempts to upgrade its air defenses. The possibility of an Iraqi-Yugoslav alliance tacitly supported by Russia is becoming more of a reality. The ramifications of such an alliance could result in simultaneous crises that threaten the safety of U.S. forces and the maintenance of U.S. policy in each region.

MOCK CHEMICAL ATTACKS TO STRIKE THREE CITIES

NEW YORK—Authorities in three U.S. cities will fall victim to simulated chemical, biological or radiological terrorist attacks next month, in which emergency responders will be tested and trained on how to handle the real deal.

The date, time and some details of the exercises are secret. The only publicized aspects of the terror drills are the locations: Denver, Washington and Portsmouth, N.H.

When the exercises begin, notification will go out to all hospitals, law-enforcement agencies, the National Guard and state agencies. In Denver, Police Detective Mary Thomas said only a few city officials know the exact details of the drill.

“The high-ranking department heads are taking part, but they’re not allowed to tell anybody,” said Thomas, a department spokeswoman. “It’s supposed to be a surprise, basically. We don’t know the day or what our actual roles are.”

The exercises, dubbed *Operation TOPOFF*, short for

“top officers”, will run for 10 consecutive days in each city. The TOPOFF drills promise to be mammoth, involving hundreds of emergency personnel from federal, state and local agencies, said Doug Johnson, spokesman for the **U.S. Department of Justice, which is sponsoring the drills in tandem with the Federal Emergency Management Agency. [There you have it—case closed and end of story!]**

In Denver, authorities will test their mettle against a simulated release of a disease-spreading biological agent such as anthrax or the Ebola virus. Washington must cope with a simulated release of a deadly chemical, such as sarin nerve gas or mustard gas.

The preparation exercises have been ordered by Congress and intend to test and coordinate the enormous and complex multi-agency responses needed to cope with an actual terrorist attack, officials said.

The United States has never been the site of a deliberate, deadly attack using chemical, biological or nuclear agents—known as weapons of mass destruction or WMDs. The best-known WMD terrorist incident took place in Tokyo in 1995, when members of the Aum Shinri Kyo cult placed open containers of sarin nerve gas on subway cars.

That incident, which killed 12, wounded 60 and sent 5,500 victims to hospitals, could have been much worse, said Ben Venzke, Chief Executive of Tempest Publishing, a private-intelligence firm that advises firms and governments on terrorism.

“Had they actually sprayed it on the passengers, you would have seen many more casualties,” Venzke said....

...But the Tokyo attack triggered growing unease about the simplicity of making and using chemical weapons. In the United States, where funding and domestic preparedness are suddenly a priority, FBI Deputy Director Thomas Pickard says some U.S. cities have yet to plan for nuclear, biological or chemical terrorist attacks....

...In the upcoming U.S. drills, authorities are releasing some details to the public to ensure the zealous exercises don’t trigger mass panic. Residents in Denver, Portsmouth, Washington and Prince George’s County, Md. can expect to see police, fire and emergency workers responding to simulated emergencies and treating, decontaminating and transporting volunteer victims.

While major parts of the training will be kept away from congested neighborhoods, some drills involve hospitals and other facilities that will remain open to the public. In Denver, Thomas said the Department would notify local media in time to allay fears.

Elsewhere in the United States, the U.S. Army Soldier Biological and Chemical Command (SBCCOM) is now training responders in 120 U.S. cities. Initial training in 75 of the cities has already been finished, said Ann Gallegos, a spokeswoman at the Biological Chemical Command at Aberdeen Proving Ground, Maryland.

“If a terrorist event takes place, the natural response is to rush in and assist the victims,” Gallegos said. “What we need to do is have them assess what the victim looks like and determine whether it may be a chemical or biological event.”

In the case of an attack with a chemical agent—such as sarin, mustard or sulfur gas—the first responders must recognize the symptoms, which would be apparent almost immediately: running eyes and nose, possibly vomiting or convulsions and obvious physical discomfort, according to an Army report provided by SBCCOM.

The danger to victims and responding emergency personnel is higher in a confined space, such as a theater, than in an outdoor stadium, for example, where the gas

could float away in the atmosphere, Gallegos said.

“[Emergency personnel] need to suit up with protective equipment, otherwise they’ll become casualties themselves,” Gallegos said.

In order to save the lives of those contaminated with the chemical agent, Army guidelines say responders must decontaminate victims as quickly as possible by removing their clothes and washing their bodies with a “low-pressure deluge” of water from a fire hose. For better decontamination results, bleach or soap can be added to the water....

...A biological weapon is more difficult to create and to combat than chemical weapons, Venzke said. A biological agent could be released into the air in a theater or an office building’s ventilation system discreetly, without an explosion or other warning sign evident to those under attack.

“It’s very unlikely you’re even going to know an attack took place,” Venzke said. “There’s no immediate panic, where people start suffering immediately.”

Or viruses or bacteria could infect initial victims slowly, with them getting progressively sicker over days or a week and then unknowingly spreading the agent into hospitals and homes in far-flung areas. A delayed reaction would give terrorists time to disappear, Venzke said.

“Should it happen in an airport, people could be in any country in the world before it’s evidenced,” Gallegos said.

HOLOCAUST DENIER PURSUES NEW LAWSUIT

LONDON—Holocaust denier David Irving is proceeding with a libel action against a London Sunday newspaper and a British writer, despite his recent defeat in a similar lawsuit.

The Observer and journalist Gitta Sereny are asking the courts to nullify Irving’s action against them in light of his defeat last week against Holocaust scholar Deborah Lipstadt.

Irving lost his lawsuit against Lipstadt and her publisher, Penguin Books, with the judge ruling that Irving is an anti-Semitic Holocaust denier and Hitler apologist who distorted historical data to suit his own ideological agenda.

Irving’s latest case is based on an article by Sereny, “Spin Time for Hitler”, which was published in *The Observer* on April 21, 1996.

Irving claims the article accuses him of inflating tenfold the death toll in the wartime Allied air raid on Dresden, of obtaining the microfiche plates of the Goebbels diaries in Moscow by subterfuge and of using “invention, omission or distortion to express an obsession”.

Irving is claiming damages on the grounds that *The Observer* failed to publish his reply to the article and that Sereny had pursued a campaign of defamation against him for nearly 20 years.

The Observer has already spent some \$1 million preparing its defense against Irving’s charges.

The disgraced Irving, facing bankruptcy from a bill for costs of some \$5 million as a result of his defeat in the

Lipstadt trial, is also facing arrest warrants in Germany and the United States.

The German warrant accuses Irving of engaging in Holocaust denial—a criminal offense in Germany—during a speech he made there in 1996.

A California court has issued a warrant for his arrest for failing to repay a \$10,000 loan he received in 1997 to help reprint four of his books. The court has found him in contempt.

There are also a number of court judgments against him, mostly for relatively small amounts.

Irving has claimed to have received about \$500,000 from more than 4,000 supporters.

Those donors will now be sought for payment of costs by Lipstadt's lawyers on the grounds that they helped Irving sustain his case against her.

Irving told journalists that he had no doubt that Lipstadt's lawyers "will come for their pound of flesh, but I can assure them I am made of British beef. I know how to fight."

WHEN SEEING AND HEARING ISN'T BELIEVING

"Gentlemen! We have called you together to inform you that we are going to overthrow the United States Government." So begins a statement being delivered by General Carl W. Steiner, former Commander-in-Chief, U.S. Special Operations Command.

At least the voice sounds amazingly like him.

But it is not Steiner. It is the result of voice "morphing" technology developed at the Los Alamos National Laboratory in New Mexico.

By taking just a 10-minute digital recording of Steiner's voice, scientist George Papcun is able, in near real-time, to clone speech patterns and develop an accurate facsimile. Steiner was so impressed, he asked for a copy of the tape.

Steiner was hardly the first or last victim to be spoofed by Papcun's team members. To refine their method, they took various high-quality recordings of generals and experimented with creating fake statements. One of the most memorable is Colin Powell stating, "I am being treated well by my captors."

"They chose to have him say something he would never otherwise have said," chuckled one of Papcun's colleagues.

Most Americans were introduced to the tricks of the digital age in the movie *Forrest Gump*, when the character played by Tom Hanks appeared to shake hands with President Kennedy.

For Hollywood, it is special effects. For covert operators in the U.S. military and intelligence agencies, it is a weapon of the future.

"Once you can take any kind of information and reduce it into ones and zeros, you can do some pretty interesting things," says Daniel T. Kuehl, Chairman of the Information Operations Department of the National

Defense University in Washington, the military's school for information warfare.

Digital morphing—voice, video, and photo—has come of age and is available for use in psychological operations. PSYOPS, as the military calls it, seek to exploit human vulnerabilities in enemy governments, militaries and populations to pursue national and battlefield objectives.

To some, PSYOPS is a backwater military discipline of leaflet dropping and radio propaganda. To a growing group of information-war technologists, it is the nexus of fantasy and reality. Being able to manufacture convincing audio or video, they say, might be the difference in a successful military operation or coup.

Pentagon planners started to discuss digital morphing after Iraq's invasion of Kuwait in 1990. Covert operators kicked around the idea of creating a computer-faked videotape of Saddam Hussein crying or showing other such manly weaknesses, or in some sexually compromising situation. The nascent plan was for the tapes to be flooded into Iraq and the Arab world.

The tape war never proceeded; killed, participants say, by bureaucratic fights over jurisdiction, skepticism over the technology and concerns raised by Arab coalition partners.

But the "strategic" PSYOPS scheming didn't die. What if the U.S. projected a holographic image of Allah floating over Baghdad urging the Iraqi people and Army to rise up against Saddam, a senior Air Force officer asked in 1990?

According to a military physicist given the task of looking into the hologram idea, the feasibility had been established of projecting large, three-dimensional objects that appeared to float in the air.

But doing so over the skies of Iraq? To project such a hologram over Baghdad on the order of several hundred feet, they calculated, would take a mirror more than a mile square in space, as well as huge projectors and power sources.

And besides, investigators came back, what does Allah look like?

The Gulf War hologram story might be dismissed were it not the case that *WashingtonPost.com* has learned that a super-secret program was established in 1994 to pursue the very technology for PSYOPS application. The "Holographic Projector" is described in a classified Air Force document as a system to "project information power from space... for special-operations deception missions".

Voice morphing? Fake video? Holographic projection? They sound more like *Mission Impossible* and *Star Trek* gimmicks than weapons. Yet for each, there are corresponding and growing research efforts as the technologies improve and offensive information warfare expands.

Whereas early voice morphing required cutting and pasting speech to put letters or words together to make a composite, Papcun's software developed at Los Alamos can far more accurately replicate the way one actually speaks. Eliminated are the robotic intonations.

The irony is that after Papcun finished his speech-cloning research, there were no takers in the military [**NO GUANO?—RIGHT!**]. Luckily for him, Hollywood is interested: The promise of creating a virtual Clark Gable is mightier than the sword.

Video and photo manipulation has already raised profound questions of authenticity for the journalistic world. With audio joining the mix, it is not only journalists but also privacy advocates and the conspiracy-minded who will no doubt ponder the worrisome mischief that lurks in the not-too-distant future.

"We already know that seeing isn't necessarily

believing," says Dan Kuehl, "now I guess hearing isn't either."

REPORT: DEAD HARVESTED FOR PRODUCTS

SANTA ANA, CALIFORNIA (AP)—Donated human remains are processed into medical products that generate hundreds of millions of dollars for U.S. companies despite laws barring profit from body parts, *The Orange County Register* reported Sunday.

Although grieving families are told that the donations are a gift of life, the newspaper found that material harvested from the dead, fuels an industry that is expected to have \$1 billion in revenues by 2003.

"I thought I was donating to a nonprofit. I didn't know I was lining someone's pocket," said Sandra Shadwick, whose brother's remains were given to a Los Angeles tissue bank. "It makes me angry. It makes me appalled. If it's not illegal, it ought to be."

The *National Organ Transplant Act* of 1984 banned profits from the sale of tissue, but companies and nonprofit tissue banks are allowed to charge reasonable fees to handle and process the parts. The law does not define a reasonable charge.

"The law has never been tested in court. Nobody has ever decided what is selling and what isn't," said Jeanne Mowe, Executive Director of the American Association of Tissue Banks.

Nonprofit tissue banks may obtain body parts useful for up to 100 patients from a single cadaver. The parts are then sold to companies that make products used by doctors and dentists, and the banks and businesses share revenues.

Survivors urged to donate usually are told about vital organs, such as hearts or kidneys, but most of the products derived from the dead are far from lifesaving: Cadaver skin may be used to puff up the lips of models, enlarge penises or smooth out wrinkles, the newspaper said.

A single body can provide material that is worth up to \$34,000 for nonprofit tissue banks, including skin, tendons, heart valves, veins and corneas that are then made available to doctors and hospitals for up to \$110,000.

With bone taken from the same body, a cadaver can be worth \$220,000.

"People who donate have no idea tissue is being processed into products that per gram or per ounce are in the price range of diamonds," said Arthur Caplan, a professor at the University of Pennsylvania's Center for Bioethics.

Lives are enhanced by donations: Tendons help athletes, cadaver skin helps solve bladder problems and corneas help the blind to see, said Michael Jeffries, Chief Financial Officer for Osteotech, Inc., a leader in the bone business.

"There is a profit," he said. "It's not an evil thing

because the profit is **put to good use.**"

The two largest for-profit tissue companies had \$142.3 million in sales last year and each pays its chief executive more than \$460,000 annually, the newspaper said. The four largest nonprofit tissue banks will make \$261 million in sales this year, it said.

The number of organ and tissue donors increased 172 percent nationwide over the past five years, according to the American Association of Tissue Banks.

Last fall, Vice President Al Gore announced \$5 million in grants to organ and tissue agencies.

"I did not know that the amount of money involved was as large as you have pointed out," Gore told the *Register* in a recent telephone interview.

SOUTH AFRICA LENDS EAR TO AIDS SKEPTICS

JOHANNESBURG—When David Rasnick, an obscure California biochemist, answered his cell phone recently, he scarcely could have imagined that the call would touch off the world's latest—and perhaps most bizarre—controversy over the nature of AIDS.

"A voice came on the line and said it was Thabo Mbeki," Rasnick recalled, naming South Africa's President. "I didn't believe it at first. I didn't know presidents just called out of the blue like that."

Apparently, when it comes to AIDS, Mbeki does. And for 15 minutes the African leader quizzed Rasnick about his work at the University of California, Berkeley.

"He was checking me out, seeing if I was legitimate," Rasnick said. "I suppose I passed his test, because he asked me for my personal support of his anti-AIDS efforts and I gave it to him."

The trouble is that more than 99 percent of the world's other AIDS experts would have flunked Rasnick. Along with a tiny group of other so-called dissident researchers, Rasnick espouses the radical view that AIDS simply does not exist. **The deadly disease that the world calls AIDS is not linked to the infamous virus known as HIV, he insists, but instead is merely a collection of more mundane illnesses associated with recreational drug use and malnutrition. [How about homosexuality and other appalling, deviant behavior?]**

To argue otherwise, he maintains, is to be duped by a vast conspiracy among governments, drug companies and mainstream scientists who are milking billions of dollars from the "AIDS industry"....

...Activists in South Africa and abroad have attacked Mbeki's Administration for flirting with pseudo-science instead of facing the ruinous AIDS crisis in South Africa, where some 4 million people, or nearly 10 percent of the population, are infected with HIV. The scandal has plunged the nation's already troubled AIDS policy into further confusion as bewildered scientists worldwide are scratching their heads over why South Africa would choose to breathe new life into a discredited hypothesis that they fear will only hamper global efforts to combat the disease.

"All President Mbeki is saying is, 'Let's listen to everybody,'" said Parks Mankahlana, a spokesman for Mbeki, who noted that the President has ordered that a panel be organized in South Africa to re-evaluate the

evidence behind the global AIDS epidemic.

"Let's not silence one group or another with hysterical declarations," Mankahlana said. "To find a solution to this thing we have to look at all angles."...

... "I consider those guys real evil characters," said an angry World Health Organization official in Geneva. "By denying the link between HIV and AIDS, they're undoing 20 years of public health efforts. Why would anyone want to give them this credibility?"...

...In 1997, when he was still Deputy President, Mbeki touted an alleged South African cure for AIDS called Virodene. The drug has quietly faded from the public scene. And last year, after succeeding President Nelson Mandela in the nation's second democratic elections, Mbeki again became embroiled in controversy when he publicly questioned the safety of AZT, an anti-retroviral drug widely used in the developed world to block the transmission of HIV from mother to child. Health experts say that as many as 5,000 South African babies are born HIV-positive every month, fueling the fastest-growing disease infection rate in the world.

Mbeki, who has made clear his contempt for the international pharmaceutical industry—"the profit takers who are benefiting from the scourge of HIV/AIDS", his office recently called them—apparently stumbled into his latest AIDS controversy while on-line.

One of the more prominent AIDS dissident web-sites belongs to Duesberg, a professor of molecular and cell biology who shares his lab with Rasnick at Berkeley.

In it articles with headlines such as "AIDS not infectious—but caused by recreational and anti-HIV drugs" outline the dissident manifesto that reads "various AIDS diseases are brought on by the long-term consumption of recreational drugs and AZT" and other drugs that treat AIDS.

In essence, Duesberg declares that despite thousands of medical studies, there is still no conclusive proof that HIV causes AIDS.

He further asserts that the scientific establishment is cynically propagating AIDS with the very anti-retroviral drugs used to treat it. And as for AIDS in Africa, where 70 percent of the world's people with HIV live—and where almost nobody has access to expensive drugs such as AZT—the skeptics argue that the AIDS phenomenon is caused by common ailments linked to hunger and poverty....

...Rasnick is even more pointed. "What's behind all these shrill attacks on Mbeki?" asked the biochemist, who belongs to an AIDS dissident group that claims 600 members. "It's thousands of activists and scientists who fear they're going to be out of a billion-dollar business."

What the world's AIDS community seems to be registering in this strange debate, however, isn't so much fear as genuine bafflement....

...So noisy has the outcry against Mbeki's contact with AIDS skeptics become, in fact, that his office issued a terse statement last week insisting that "the President has never said that HIV does not cause AIDS."...

... "Mbeki's panel? Who the hell cares?" asked Charlene Smith, an AIDS activist who noted that 75 percent of pediatric deaths at Johannesburg public hospitals are AIDS-related. "We're dying down here," Smith said bitterly. "Play all the intellectual games you want on the Internet, but we're dying down here."

[JR: It is reported that there are 33 million AIDS cases in the world—of which an unusually large concentration is in South Africa—and the numbers are still growing. There are 10 million orphaned children in Africa because of AIDS. Now, whose agenda does Mbeki serve in aligning himself with those whose job it is to deny that there is an AIDS

pandemic raging in South Africa? AIDS was created for the purpose of depopulation. It may be coming soon to your nice little part of the world, if the Elite have their say. TINY MACHINE USES DNA TO DO ITS WORK

WASHINGTON (*Reuters*)—A tiny machine that can physically bend DNA to do its work may be just the first member of a whole generation of microscopic robots, Swiss researchers said on Friday.

They might be used to diagnose medical conditions, read genes or operate microscopic valves for precise drug delivery, the team at IBM Research in Zurich and the University of Basel in Switzerland said.

Writing in the journal *Science*, they said they found that DNA can be used to bend tiny silicon "fingers" that have a thickness of less than one-fiftieth of a human hair.

They rigged up a system of these little cantilevers—anchored at one end and free to bend up and down at the other—and glued single strands of DNA onto the top.

DNA naturally forms a double helix like a twisted ladder and when cut apart will naturally try to put itself back together again.

When the researchers put their cantilevers into a solution with the missing halves of the DNA strands, the pairs zipped themselves together and the little cantilevers bent under the force.

The movement could be used to see genetic variations in the DNA, such as a mutation, but could also itself be harnessed to do work, the researchers said.

"This biomechanical technique has the potential to enable fast and cheap biochemical analysis, and could be used for mobile applications," Christoph Gerber of IBM Research, who led the study, said in a statement.

He said the same technology could look for active proteins being produced by cells, including those the body produces during disease or after an injury such as a heart attack.

James Gimzewski of IBM Research said the experiment showed that the unique properties of DNA could be put to work in tiny robots.

"We have found a way to get DNA to do the work for us, so we don't need batteries, motors, or the like to operate tiny machines," he said.

Such a little device might be used to open a valve, perhaps to deliver drugs in precise doses right where they are needed in the body.

"For instance, we can envision a system to attack cancerous growth—the release of just the proper doses of chemicals in the appropriate location of the body could be achieved using tiny micro-capsules equipped with nano-valves," Gimzewski said.

"They could be programmed chemically to open only when they get biochemical signals from a targeted tumor type. This would enable the right therapy at the right place at the right time, with minimized side effects and no invasive surgery."

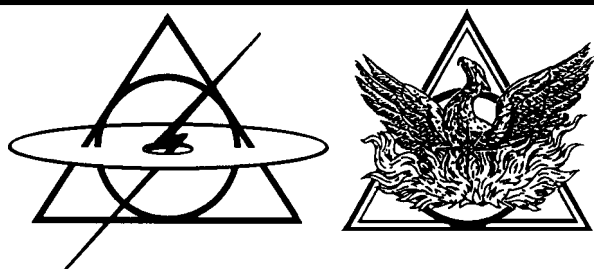
