

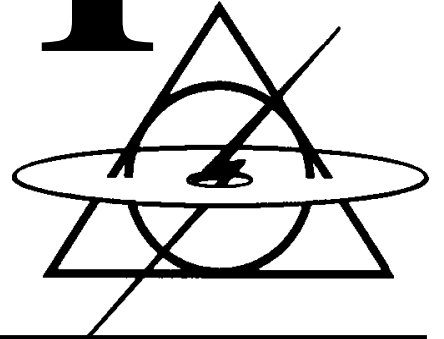

THE PLOT TO BLOW UP THE DOME OF THE ROCK

When Ariel Sharon made the provocative move to virtually invade Jerusalem’s Temple Mount with an army of 4,000 “security forces”, it was more than a “symbolic” provocation. What is known to every political observer of the Middle East, and especially of Israeli/Palestinian relations, is that there has been an active underground movement in Israel, commanded by Sharon, among others, that pushes the cultist theme, “Eretz Israel”, or “Greater Israel”. It is this network that killed Prime Minister Yitzhak Rabin in 1995, and which has carried out numerous murderous assaults on Islamic holy sites in Israel, especially Al-Haram al-Sharif, and the Dome of the Rock.

Sharon’s visit was a reminder of the atrocity committed by this network when Brooklyn-born “Baruch” Goldstein entered the mosque of the Cave

of the Patriarchs in Hebron on Feb. 25, 1994 and murdered 50 worshippers and injured hundreds more after he opened fire with an automatic weapon during Friday prayer service. Goldstein was one of Sharon’s zombie killers, deployed through the illegal settlers’ movement protected by Sharon.

EIR has documented the command structure behind this terrorist underground since the early 1980s. In 1986, *EIR* published a 125-page special report, “Moscow’s Secret Weapon: Ariel Sharon and the Israeli Mafia”, which detailed the support networks around Britain’s Lord Harlech (Sir David Ormsby-Gore), Henry Kissinger, George Bush, and Wall Street’s network of global corporations known as “Dope, Inc.”. The following report covers only a small portion of *EIR*’s previously published material.

THE CULT BEHIND THE TEMPLE MOUNT PLOT

The scheme to blow up the sacred Muslim sites, the Al-Aqsa mosque at Al-Haram al-Sharif in Jerusalem, and the Cave of Patriarchs in Hebron, has long been the public aim of Jewish radical assassin networks such as the U.S.-based Jewish Defense League (JDL) and the West Bank Jewish settlers movement, founded and nurtured by the networks of Sharon since shortly after the end of the June 1967 Arab-Israeli war.

It is this network of organizations in the United States and Israel that was denounced by Prime Minister Rabin as “errant weeds”, alien to Judaism, just weeks before he was killed on Nov. 5, 1995. It was this network that created Rabin’s killer, Yigal Amir, who was “blessed” with the “sacred” mission to kill the pro-peace Prime Minister, from the cultist rabbis associated with the terrorist underground.

Bitterly, Israeli founding father and former Prime Minister David Ben-Gurion referred to Zionist Mussolini admirer Vladimir Jabotinsky, as “Vladimir Hitler”.

The Jewish “settlers movement” of which Hebron assassin Goldstein was a part, is the product of a centuries-long Venetian and British conspiracy to destroy Judaism from within.

The Zionism represented by the JDL settlers movement today can be traced back to the *Kabbalah*, the Jewish mystical heresy which the Babylonian priesthood had imposed on Mosaic Judaism in the first centuries of the Christian era, and which was later patronized by the Venetian oligarchy. This peculiar strain of Zionism, at least, has always been dedicated to destroying Islamic and Christian holy sites, creating a paganized Judaism practicing animal sacrifice at a rebuilt Temple of Solomon in Jerusalem, and fostering the generalized religious warfare in the region. The cult’s Masonic sponsors, especially among varieties of Protestant fundamentalist sects, view such cults as “necessary” in order to bring on Armageddon.

The settlers’ movement is an extension of the network of Jabotinsky, who founded the Zionist Revisionist movement and Irgun terrorist movement. Jabotinsky was an avid follower of 19th-Century British Foreign Minister Lord Palmerston’s top

operative Giuseppe Mazzini, and had been recruited to Zionism by Mazzini’s non-Jewish followers in Italy. Serving British intelligence, Jabotinsky also doubled as an agent of the Russian Tsarist secret police, Okhrana, operating within pre-World War I Ottoman Turkey, along with British super-agent Alexander Helphand-Parvus to set up the Young Turk regime.

Although these elements have long existed within the Zionist movement, it was only after the Israeli Army seized control of East Jerusalem and the West Bank in 1967, where many of the key Islamic and Christian holy sites are located, that their gameplan for “Apocalyptic” religious warfare was put into motion. In that year, Asher Kaufman, an operative of London’s Quatour Coronati freemasonic lodge, arrived in Jerusalem to oversee an assault on Jerusalem’s holy places.

There are two phases to this Masonic assault, both involving Israeli Kabbalistic patsies. One, with which the settlers’ movement has been most associated, is the rebuilding of Solomon’s Temple on the Al-Haram Al-Sharif in Jerusalem. Upon his arrival, Kaufman began sponsoring archaeological work to justify destroying Al-Haram Al-Sharif.

GROWTH OF KABBALISM

The Temple Mount “project” dates back centuries. Today, the British oligarchy, and the Venetian/Jewish oligarchical families, the Recanati and Luzzato, continue to be primary promoters of the “Temple Mount” project. Eduard Recanati, for example, runs the Temple Mount Foundation. Recanati had formerly run the Italian B’nai B’rith. His family owns Israel’s third-largest bank, the Israeli Discount Bank.

In the early 20th Century, when the British *Balfour Declaration* boosted Zionism, the British oligarchy helped create one of the leading proponents of Kabbalistic cultism—Rabbi Abraham Isaac Kook. As explained below, Kook’s son, Rabbi Zvi Kook, has been the creator of many of Sharon’s killer cult organizations.

Rabbi Kook was raised in Russia, and became a rabbi in Palestine shortly before the 1905 Russian Revolution. On the eve of World War I, Kook traveled to England, in order, he said, to spread Zionism. He returned to Palestine following World War I, arguing that the *Balfour Declaration* meant the “time of redemption”, the coming of the Messiah, was at hand. Elected Chief Rabbi of Palestine in 1921, Kook became the spiritual leader of the Jabotinsky wing of Zionism, and established a network of yeshivas, or Jewish religious schools, which trained many of the leaders of Jabotinsky’s Irgun, and its split-off, the Stern gang. The two terrorist groups trained the leadership of what comprise the Likud bloc today.

Kook’s dangerous legacy was his cultism: He was the patron within Palestine of the project to rebuild the Temple, as part of the general effort to prepare for the coming of the Messiah. In 1921, Kook formed the Yeshiva Torat Cohanim in Jerusalem, WHICH HAD ONE CENTRAL PURPOSE: DESTROY THE ISLAMIC HOLY SITES AT AL-HARAM AL-SHARIF IN ORDER

TO REBUILD "SOLOMON'S TEMPLE".

The founding document of Kook's 1921 yeshiva reads in part: "god's message concerning the rebuilding of the Temple and the renovation of the sacerdotal rites will certainly be fulfilled very shortly."

Rabbi Kook's son, Rabbi Zvi Yehuda Kook, who lived into the 1970s, carried on his father's legacy. He became a key ally of Asher Kaufman in the freemasonic plot against the Al-Haram al-Sharif begun in 1967. He simultaneously deployed his followers to open up the Kiryat Arba settlement outside of Hebron, charging them with taking over the Cave of the Patriarchs. Rabbi Zvi Kook became the spiritual leader of the "Temple Mount" crazies today, of whom his most important protégé was Rabbi Meir Kahane, the founder of the JDL. Another top protégé was Rabbi Moshe Levinger, the founder of the associated Gush Emunim (Bloc of the Faithful), and the spiritual leader of the Kiryat Arba settlement responsible for the Hebron massacre.

THE PLOT TO ATTACK HEBRON

Kabbalistic plans to take over the Cave of the Patriarchs and drive the Muslims out of Hebron were first announced publicly by JDL and Gush Emunim patron Rabbi Zvi Kook in the weeks prior to the 1967 war. The West Bank of the Jordan River, where Hebron is located, and also East Jerusalem, were then still part of Jordan. "Where is Hebron?" Kook raved and prophesied. "Do we let it be forgotten? And where is our Schechem [Nablus] and our Jericho? All of Transjordan is ours. Every single inch, every square foot belongs to the Land of Israel."

After the 1967 war, Kook deployed his student, Rabbi Levinger, to the outskirts of Hebron to settle it with Jews and to prepare to expel the Muslims. By 1969, some 40 families had begun the settlement, soon named Kiryat Arba. Now the residence of some 6,000 fanatics—mostly from the JDL/Kach movement and the Gush Emunim—Kiryat Arba was the first, and remains the most important settlement on the West Bank; it has always been committed to a Jewish war with Islam. Kiryat Arba was the base of Hebron mosque assassin Goldstein.

In 1973, Kook formed the Gush Emunim together with Levinger. The central tenet of the movement was that "Eretz Israel" included all the territories seized, and consequently the *Torah* forbade the Jews from ever giving these territories back to Muslims.

In 1979, Kook, Levinger, and Kahane became upset that the Camp David peace treaty with Egypt would mean that the territories would be relinquished. They decided that the best way to sabotage the accords would be to bomb the Dome of the Rock and carry out assassinations.

In 1980, the group met at Kiryat Arba to plan the assassination of several West Bank Arab mayors for the same reason: to sabotage any peace with the Arabs. Three of these mayors were severely maimed in separate bombings later that year. In July 1983, Levinger's son-in-law led a Kiryat Arba team that sprayed the Islamic College of Hebron with machine-gun fire, killing three students and wounding 30 more.

Instead of being imprisoned, Meir Kahane got a seat in the Israeli Knesset (parliament).

FINANCING THE TERROR

To get money for his operations, Rabbi Levinger set up the Hebron Fund in 1982, to provide a financial conduit for North American Zionists to carry out his "ethnic cleansing" against Muslims and Arabs in the West Bank.

The fund's prominent contributors have included: Albert and Paul Reichmann of Canada, and Canadian real-estate operative Marc Belzberg.

The Reichmann brothers and Belzberg are frontmen for the Meyer Lansky-linked Bronfman family that dominates the Anti-Defamation League of B'nai B'rith. Paul Reichmann and Peter Bronfman also serve on the board of the Canadian-British Hollinger Corp. media empire, as do Richard Perle, an adviser to George W. Bush, and Sir Henry Kissinger. **[H: Don't forget that it is actually ALSO, "Sir" George H. W. Bush.]**

In April 1984, Levinger's son-in-law and others attempted to blow up Arab buses in East Jerusalem in order to trigger riots. The attempt failed, and several of the terrorists were arrested. The JDL/Kach movement established a legal defense fund in the United States. Most of the \$100,000 that was raised was contributed by Lansky's former bag-man Charlie Fox. Following their conviction, where the 18 defendants received moderate sentences, then-Prime Minister Yitzhak Shamir praised the terrorists as "excellent people who made a mistake".

THE PLOT TO BLOW UP THE 'TEMPLE MOUNT'

In 1978, two disciples of Rabbi Zvi Kook established the Ateret Cohanim (Priestly Crown) Yeshiva in the Muslim quarter of occupied East Jerusalem. The two, Mattiyahu Dan and Rabbi Shlomo Aviner, were both officers of Israel's domestic intelligence service, Shin Bet, and were deployed by Sharon. Aviner is also currently the chairman of the West Bank's rabbinical council.

The stated purpose of the yeshiva was to train rabbinical students in animal sacrifice that would be reinitiated at the new Temple of Solomon to be rebuilt following the destruction of the Al-Aqsa mosque and Dome of the Rock. It has carried out deadly acts of terror.

In 1980, Kahane and his associate Andy Green, another Brooklyn-born associate of Goldstein at Kiryat Arba, were arrested for plotting to blow up the Dome of the Rock. Now known as Baruch Ben-Yosef, Green today leads the JDL's "Temple Mount Yeshiva", directly opposite the Muslim holy site.

In 1982, Mattiyahu Dan *et al.* began to tunnel secretly under the Al-Haram al-Sharif, as part of their preparations for destroying the Islamic holy site. Also in 1982, a JDL member named Alan Goodman walked onto the Al-Haram al-Sharif and began firing on Muslims during worship, killing one. Kahane paid for his legal fees.

In 1984, Chief Rabbi of Israel Avraham Chana

Shapira, another Kook protégé, endorsed a fundraising letter for Ateret Cohanim. That same year, the so-called "Lifta gang", a JDL/Gush Emunim cell, was rounded up after its members tried to place 30 pounds of dynamite at the site.

Also in 1984, American gambling entrepreneur Irving Moskowitz, a board member of the Ateret Cohanim, financial patron of Sharon and longtime Kahane crony, founded the "American Friends of Ateret Cohanim" to fund the terrorist underground.

Major contributors have included Mark Belzberg of the Bronfman circles; Abraham Dwek, leader of Brooklyn's Syrian Jewish banking elite; and Cyril Stein, the recently retired chairman of Ladbroke's, the private betting house of Buckingham Palace; Stein's family has been the cream of Britain's aristocracy since the 1700s. He is also a patron of Sharon, and is the main sponsor of efforts to open up casino gambling complexes in Israel. Stein leads the fight against the peace accords within England, labeling them a "desecration of the name".

Prominent backers have also included then-Israeli President Chaim Herzog (today a member of the board of Hollinger Corp.), then-Likud chairman Benjamin Netanyahu; and (Americans) former New York Mayor Ed Koch, and Malcolm Hohlein, leading member of the Conference of Presidents of major Jewish Organizations, and who met with Sharon during the latter's most recent U.S. trip, where the Temple Mount provocation was planned.

In 1995, Yigal Amir, another zombie created by these networks, shot and killed Prime Minister Rabin. The murder set the conditions for Sharon and Netanyahu to return to power and cancel the 1993 Oslo peace agreement between the Israelis and the Palestinians. In 2000, with the Barak government tottering, the war-mongers hope the Sharon assault on Temple Mount can again bring them to power.

THE TEMPLE MOUNT FAITHFUL

Yet another of the terror apparatus is the Temple Mount Faithful, founded by Gershon Solomon, a disciple of Jabotinsky and an Irgun veteran who ran the youth department of Menachem Begin's Herut Party, until he quit in a dispute over the Camp David peace treaty with Egypt.

Solomon helped form the Tehiya Party in 1979, at the suggestion of Rabbi Zvi Kook, together with Yuval Neeman, former head of Israeli military intelligence, and Gerula Cohen, who had first brought Kahane to Israel.

Among the group's controllers is Stanley Goldfoot, an Irgun veteran from South Africa who oversees much of the terrorist apparatus in the Occupied Territories. Goldfoot had organized an archaeological expedition underneath Al-Haram al-Sharif. Goldfoot's "expeditions" have been financed out of the United States by a group of Christian evangelicals, centered in the American Jerusalem Temple Foundation (AJTF), who advocate the rebuilding of the Temple in order to hasten the Second Coming of Christ.

U.S.-based Christian doomsday groups funding the terrorists have included Oklahoma oil man and convict Terry Reisenhoover, and

Douglas Kreiger of Tav Ministries. Before his incarceration for fraud in 1987, Reisenhoover, the founder of the AJTF, poured at least \$8 million into Goldfoot and Goldfoot's operations. Goldfoot's work has also been promoted by Christian Coalition's Pat Robertson.

On Oct. 8, 1990, the Temple Mount Faithful attempted to lay the foundation-stone for "Solomon's Temple" at the site of the Al-Aqsa mosque. Muslims at the site began throwing rocks at the group, and the Jews as they prayed at the nearby Western Wall of what is believed to be the original Temple. The subsequent riots left 20 Muslims dead. The riots were used to psychologically prepare the population for the coming Anglo-American war against Iraq, and provoked Prime Minister Shamir to close the doors to the mosque (for the first time since the Crusades). On Oct. 17, 1990, Gershon Solomon gave an interview to Hollinger's *London Daily Telegraph* on his sect's program. The Al-Aqsa mosque "must be dismantled and moved to Mecca", Solomon raved. Al-Aqsa is a product of "Arab imperialism". Once the mosque and the nearby Dome of the Rock are removed from the "Temple Mount"—the Jewish fundamentalist name for the Al-Haram al-Sharif—the Third Temple must be "rebuilt" in their place. "God gave us this land forever," he ranted. "and what God has given cannot be taken away by other people."

The Temple Mount Faithful continue to be an active part of Sharon's killer network today.

WHO RUNS ARIEL SHARON?

Gen. Ariel Sharon is entirely a creation of powerful British and Anglo-American financial elites, imposed on Israel, and used to foment local warfighting and destabilizations. But, as in the case of Adolf Hitler, Sharon's actions are those of a "Frankenstein's monster", and in a period of strategic and financial breakdown as today, his provocations could unleash a global war.

Sharon's career has been made through the networks of international organized crime, and the financier oligarchy. Those who have been his points of control have included:

MESHULAM RIKLIS, the New York-based Anti-Defamation League "legalized crime" kingpin who financed Sharon's first electoral campaign. Along with the late Armand Hammer, head of Occidental Petroleum, Riklis was responsible for "cleansing" the blood from Sharon's paws. In 1982-83, the two paid for Sharon's lawsuit against *Time* magazine, which had documented his role in the genocide at the Sabra and Shatilla civilian Palestinian refugee camps in southern Lebanon. Sharon did not "win" the case, but the settlement was an important part of his rehabilitation, opening the door for him to become a cabinet minister in the 1984 National Unity government.

HENRY KISSINGER, the former U.S. Secretary of State and Hollinger Corp. board member.

A network of British oligarchs typified by

LORD HARLECH (DAVID ORMSBY-GORE) and LORD PETER CARRINGTON, who otherwise dominate the Hollinger Corp.

These individuals have played a leading role in diverse conspiracies, many of which involve Sharon, including:

* Building the "Jewish settlers movement" within the Occupied Territories. The British formed the Jewish settlers movement to give themselves an independent capability of sparking an Arab-Israeli war at any time they choose—even if opposed by the normally compliant Israeli government. Sharon is one of their agents assigned to that task.

* Preparing for the mass expulsion of the Occupied Territories Arab population. The British have long considered creating a "Greater Israel" through mass expulsion of the 1.7 million Palestinians living in the territories, in part sparked by settler atrocities against the Palestinians.

* Preparing for an Israeli civil war. The British have long considered plunging Israel into a civil war ultimately leading to a military dictatorship dedicated to a "Greater Israel" and region-wide war. Sharon has been picked as one possible military dictator.

* Fostering the growth of the Israeli Mafia. The British and U.S. organized-crime creation of a massive Mafia network in Israel is among the ways the British have sought to give themselves an independent power base in Israel.

By the June 1967 war, Sharon, then a General in the Israeli Army, had already demonstrated his qualities as a "good investment" for the financier oligarchy criminals who picked him up. Within hours of the seizure of the West Bank, Sharon deployed armed Jewish civilian "settlers" into the West Bank, under the pretext of creating a "defense perimeter". Although still an active-duty general, Sharon was involved in sponsoring the 1969 creation of the Kiryat Arba settlement near Hebron; he has publicly praised that settlement's spiritual leader, Rabbi Moshe Levinger, as a "true hero of Israel".

By 1973, the Anglo-American establishment ordered Sharon to enter politics, to mobilize the Israeli population on behalf of further wars. The orders came through Riklis, the New York-based owner of Rapid American Corp.

Sharon's bloody career has included playing a major role in the "Terror Against Terror" assassination teams, and in running the espionage network that deployed Jonathan Jay Pollard, the Israeli-Soviet mole in U.S. Naval Intelligence, who is serving a life sentence in the United States, after pleading guilty in 1985.

The following excerpt from "The Trust: An Introduction", by Lyndon H. LaRouche, appeared in the *EIR Special Report* of March 1, 1986, "Moscow's Secret Weapon: Ariel Sharon and the Israeli Mafia": "During 1982, from various sources in the United States, Western Europe, and Israel, ... *EIR* learned that Kissinger was deeply involved in a scandalous real-estate swindle in the Israel-occupied West Bank territories. We were tracking leaks from Alexander Haig's State Department... reported to have been key in prompting Sharon to set up Israel's invasion of Lebanon.

"There was a meeting at Sharon's dacha in Israel. This hideaway was provided to Sharon by

In this place we are a bit at a loss as to how to bring current information into your attention. Many very valid, current editorials are sent to us. Our effort was to respond to letters with as much personal input as possible, although I repeat to you ones, please do not ask us for personal input to be responded to via this placement. Our mission in this place is to bring knowledge which is suitable unto the multitudes—even if Aunt Minnie cannot find her spectacles—and, precious ones, I understand the reason that you would write with such inquiries; and it is fine if you write to me with those types of perceived prayers, if you will, but I shall decline to answer them via this mode of communication. We have very precious ones who are completely involved in their life as it circulates around their beings. Some of these ones are in their shadow years as you count, in their 80s, and I honor them and I respect them as the elders having grown into these shaded years. The years of change have been very

difficult for these beings, for they have watched a world descend from respect of elders into total disrespect of all things, all property and all people.

Ones will fight out toward the ones who are oppressing or taunting. I can only remind you ones that God answers all prayers—and perhaps your perceived enemy is also praying for God to solve his problem. Wisdom and justice are always from two varying directions. What is right for one will not be presumed right for another. These are physical, earthly, conscious quarrels. God is about your soul progression—and if you're harboring hate, then you're not harboring God; but for elderly ones who cannot remember from day to

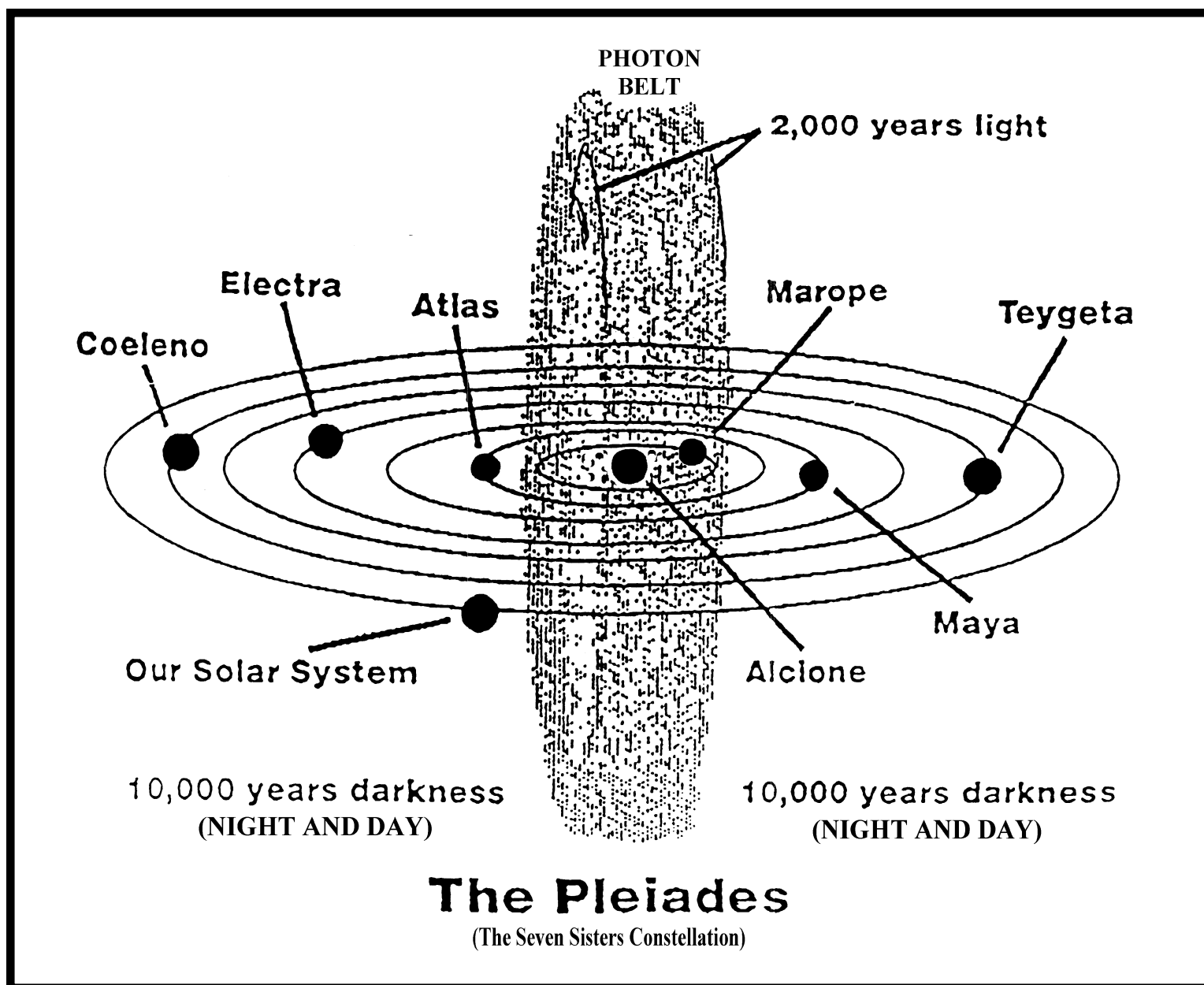
day even what was their quarrel, I just can honor them, give them respect and ask them to seek God and find peace and solace if possible. Know that the petitions are heard and, as we can find time, we will respond because these are very precious, very beloved beings. Please be patient with us as we grope through the time restraints of the physical dimension.

Another situation that has come to bury us in paperwork are the myriads of inquiries regarding certain elements of that which we have written, but more specifically, writings from other placements asking for thorough comment as in this example: I have a note sent to one of our people in this location and it is appended to a very good presentation which was

our connections—this Earth connection with Pleiades—and our own person should be privy to that information and not have to require that Hatonn speak on the subject because it will be repetition with the exception of dated material. Hatonn never gives dated material. I will give you generalities, I will give you what is projected by others and sometimes, or maybe not, make comment about it because, as you are moving into these latter days of experience on the planet, you will find that many, many prophecies and projections from the past are coming into integration now.

I don't want to speak on whether or not a channel or speaker is valid or invalid—only on information—and our effort is to give you whole Truth, whole cloth from

which to cut your garment, so that when it is finished it has all of its parts and not a missing collar or a missing arm hole. I have no way to update *JOURNALS*, except through these messages and, therefore, we will be making more and more audiotapes which will also be transcribed for your use and you will have to upgrade those *JOURNALS*. Without that prior information you are not going to understand it, still. For instance, this particular document in point is extremely valid, extremely important and it regards the Photon Belt. If you have not read the *PLEIADES*



published in Australia and let me just quote it. "Dear X, This data comes through, via fax, from Australia on April 14th from one of my contacts down there. Try to find out what Hatonn will come up with concerning this matter. I've said for years that Nature would intercede and never allow these culprits to take over the planet. I will call you in about a week when I return. I am going down to explore a bit of Mexico. Regards, R."

I have great frustration from my scribe. The first response is that, well, but X should know the validity of this information because it is all expressed in the *PLEIADES CONNECTIONS* and in prior *JOURNALS* even before the *PLEIADES CONNECTIONS* regarding

CONNECTIONS and understand electricity, light and its function and its projection, you have nothing upon which to base information of an educational nature regarding this story no matter what I tell you—because, to lay a foundation, I would have to repeat what is in some seven *JOURNALS* to allow you to understand that, for instance, there is only one kind of electricity, one kind of light functioning into capacities.

There is not a positive electricity and a negative electricity and if ones write a story under these assumptions, the conclusion may even be correct, but the information is erroneous. I can only ask you to go back and get that information, else much of the current

information is going to be very frightening to you and this is a very, very good example because it's going to put into your vernacular and your perspective, basically, what I have been talking about—about a brilliant light which will blind and then be followed by darkness which will come with the appearance of the entire Heavens falling.

If you have not understood and studied carefully that which was given in the *PLEIADES CONNECTIONS* by Pleiades contacts before this, because we are your elder brothers, we are from whence will come the information. We are efforting to give you explicit instructions—and pulling these final prophecies into some reasonable mode of your ability to comprehend them.

Because this one is so very important, I'm going to take it bit by bit and then we will be able to discuss it. I'm not going to take the time required to go into "Now I'm going to quote and now I'm going to speak and, etc." We're going to just handle this as a general dissertation, please.

The studies have shown that your solar system is about to enter a cosmic cloud. This is a part of a 12,000-year cycle—or so man on Earth is projecting. Now there was an article written in approximately 1981 that was very thoroughly and well documented. This came out of Australia and we honor those ones. For one thing, they have had the Aborigines of that nation, Australia, to come out of their dream time expecting the cycle to end and now know that the new cycle has begun and they are in this period of what you can call a null or a void, awaiting the unfoldment of these times. I have told you over and over that these Aboriginal people, the hu-man people, as given the name by God, have ended this dream time. Their calendars ended on the 17th of August, 1987, in your counting. That is why we number and label the writings on a daily basis—this being your year five. The 12,000-year cycle is a bit off. We have labeled the progression of time and consciousness levels of man on the planet in two or three places in the *PLEIADES CONNECTIONS*. So I'm not going to go into that. I'm not going to go greatly into this null time or when the system rests, but it will be mentioned here and, therefore, I must mention it.

All over your world, people are grasping and reaching out for these little bits and pieces of knowledge of enlightenment. Your hope for the future and the future of your children in a world of growing degradation is uppermost. The prophets of doom—of which, brothers, I am not one; if anything, if you must label me a prophet, call me a prophet of hope and fulfillment. I do not come with doom. I come with your way off there—or a new resurgence of lighted knowledge on your place. Those prophets of doom, as you want to call them, preach physical horror and annihilation. Well, precious ones, it depends on which side of the coin you are in service or in serving. If your service and balance is unto the Lighted God, you will be moving back into following those guidelines given to you for harmony and balance on your planet.

If you are not moving in that direction but continue to demand that which is of totally the physical plane in greed and lust and misbehaviors or breaking the laws of God, you're in trouble and it is doomsville. They're telling you truth. This is one of the darkest planets in the universe—and it's one of the most beautiful planets in the universe—but you go farther away from the Truth and teachings of God of Light and go more and

more into the clutches of doom, as a matter of fact. And all of the rebuttal, all of the disagreement that you might feel about it actually has little impact on the physical changes unless you take action and move back with that pendulum swinging unto the Light because, as you are going, you are headed for that destructive pause at the end of the pendulum swing. At the end of the cycle it will either come back into Light, or it will end in devastation so that you can begin again.

I don't know how better to explain it than to say it's like a great, great vortex. Everything in your universe is a cycle, a circle, a spiral and this one that you're in is a great vacuum or a great sucking spiral and it's leading ever downward into blackness and despair for you, the people. You are clutching at straws and the straws are sinking because of the lies and the facade thrust upon you. The freedoms have been removed while the politicians and the Elite anti-God people have taken control. If you just stop and look, you can see the Light at the top—and you can grasp and take our hand and together we can come up out of that despair.

Precious ones, the Truth sometimes is so simple that you miss it. It's right in front of you and yet, you end up not seeing it—or, if in seeing it, it is so overwhelming or so blatant that you choose to ignore it and, in ignoring it, you must then look and try to find a much more complicated answer to things; and yet God is simplicity—open, completely open. Only mystery and mysterious because you have not yet understood all, but there is nothing mystical related to God. Nothing hidden, nothing intentionally kept secret from you. Just illusive to you until you can grasp understanding, but the answers are there right in front of you all the time—staring you directly in the eyes, right in the face, and it's your passport out of this vortex. Unless you get out of this vortex, you cannot move into a more positive future. That is gained through experience and learning.

Now we have to go back to some of the most fundamental thought processes which are completely outlined with diagrams and in total in the *PLEIADES CONNECTIONS* by Germain. You're going to have to start with a little atom and those cute little electrons that run around it. I'm not even going to go into gravity, etc.—and how a substance seeks its own density—because if you have not studied that, it isn't going to make sense to you anyway. So I'm going to just push right on by this and let you know that the entire thing, the entire subject lies in that one little atom. Dr. David Anderson, I believe his name was Carl David Anderson, did some very insightful writings in the early 1930s and that material is still very valid. He has not really grasped the truth of there only being one pulsed wave action—and he chooses to still call things by a bit of an erroneous label. For instance, when he discovered anti-electrons—as he calls them, positrons—he gave them names according to what he perceived in his discoveries and they're alright for the purpose of this kind of discussion because where we will go is to the photon—to light. So the little errors in the statement are not massive enough to require great instructions because that has already been given and you can find it in diagrams; but this man discovered a little particle, a little element, a little being, that was somehow, in his acceptance, an anti-electron and he chose to call it a positron. As you moved on then in advanced technology, you moved into the 1950s—and

with that kind of information to back it up, a couple of other particles were discovered and those were labeled anti-protons and anti-neutrons. Well, they perceived that when an anti-particle is formed, it comes into existence in a universe of ordinary particles—and it is only a matter of time, in fractions of a second, before it's going to meet and collide with an electron.

Now, these things cannot be new, can they? Only the perception, only the "finding" of these things is different—because within the laws of the universe, those laws of physics, universal physics, these are always present. So they didn't just happen in the 1930s and the 1950s. So it means they are either reintroduced into your environment after having somehow been removed or they were always there and you just didn't know it. That's what higher education and knowing is about, the unveiling of the mysteries.

Well, these charges cancel each other in the laboratory and, when they do that, the total mass of the pair is then converted into energy in the form of photons—and now we have at least a bit of an assumption upon which you can visualize this. You have now had these two particles come into contact, merge and basically become a converted form which we'll call a photon and, of course, what you actually now hold is the unprecedented powerful source of energy. The thing that controls your planet is energy—and the ones who can control the energy utilized by you-the-masses, control the world. That is the Elite bankers. They are not your friends. They are your enemy. Obviously, the planet cannot continue in its abuse. It's damaged. The logical, balanced approach to energy is through these photons—light. I'm not even going to consider whether or not light is a source of heat or cold. Light is. Light is the source of all things. God is Light.

Let's talk about a band of energy. By speaking of band, I call it a binding or a thing, a group, a belt, if you will, and this belt, this photon belt or band was discovered in your place in outer space in the early 60s. No, I'm talking about 1960. Where was it before that and why had you not found it? Because you ones live in this narrow little world of lies. It was not that it was not there and that it was not coming up in your perceived future at some point—because that would be a logical sequence of this spiraling illusion in which you are acting out your experiences, but at any rate, let us just go with the story and say that in 1961 it was discovered. Well, they get around to telling you what they want you to believe, by saying it was through means of one of your satellites—that instruments got out there and you could measure these things and there's no point in arguing it. It's good enough, it's there—it most certainly is there.

Well, what in the world would this have to do with Pleiades other than possibly information having come through this manner of communication? Well, it has a lot to do with Pleiades and I would ask that you listen up here. Pleiades is called the Seven Sisters by ones on your planet, by the ancients. It's recognized as the Wee Dipper or always the Seven Sisters by any language. It's an estimated distance—this man has estimated it as 400 light years away from Earth. That is incorrect. It is a little over 500 light years from planet Earth—and that really is quite a remarkable difference in accuracy.

This little group of stars, which is not little at all, but only in your perception, forms the basis of

mythology in many, many of your countries that once ruled your world, were the highest—the highest in knowledge in your world. In Greece, for instance, the Seven Sisters were all integrated with the Greek gods, completely, completely utilized in the mythology of the Australian Aborigines in their dream time and in the ancient Chinese mythology. The books are filled with the association with this Seven Sisters constellation. Ones made a special study of the Pleiades. For instance, years ago one by the name of Sola was an outstanding researcher into that particular constellation—and you're going to find it was discovered that the Pleiades form a system of which your Sun is a part. Now that may end up being very interesting to you, but the fact is—it should be most urgently important to you.

This should have more of an important ring to you when you realize that, being so attached from our life source, we're very similar in beingness, in Creation. When planets of your solar system get in trouble as you have, many ones are often shifted to Pleiades—to various and sundry planets in Pleiades—and you will have to realize at some point that much of your populations come from Pleiades. That is the source of your ancestry. Pleiades is different from your solar system, however, because in Pleiades there are several other suns and all of them have orbiting planets or different singular planetary systems. You're going to find that some of your great astronomers will be getting more and more attention as more phenomenon comes from the heavens and one, Frederick Bessel, has shown that there is a proper motion of some 5.5 seconds of arc per century in that same direction of Pleiades.

Now you've got a lot of false information and ones who have written great future shock stories and much science fiction, such as Issac Asimov, will say that you can, therefore, assume that all the stars in this cluster (meaning the Seven Sisters) are the same chronological age. Well, you can't say that because you don't know that—and there cannot be such an assumption if you understand anything at all about Creation and formation of planets, their purpose and their creation. That is like saying, "Well, Pluto and Earth must be the same age." That is an assumption you cannot make—where you have no facts upon which to base it.

Now Dr. Halley, or you sometimes call him Haley, but it's spelled H-A-L-L-E-Y, who studied the position of the stars, made note that at least three stars were not in the spots in Pleiades as recorded by the Greeks. Well, does that mean that the Pleiadians get around a lot or there's great shifting or maybe you just don't understand the system and maybe you don't understand what a starship is and how, under controlled mental authority, you can move anything? You don't know what you're looking at and starships can very frequently move very rapidly. Like with the speed of thought. I did not say light; I said thought. Well, Mr. Halley discovered that the difference was so great, in fact, that it was unlikely that either the Greeks or Halley could have made a mistake. It wasn't like they were just so close that both could assume and, therefore, you have to know that these stars at least move within some given system. Just as do your revolving, cycling, spiraling planets.

So another made a great study of the system—this wondrous system of Pleiades of which your Sun is a part—and it was discovered that at absolute right angles to the movements of the suns, a Photon Belt—

or also called Monastic Ring—a phenomenon which scientists have not yet been able to reproduce with laboratory instruments, was noted. Now it takes your Sun 24,000 years to complete an orbit of your own system and as seen or could be seen by a diagram. (See diagram on page 5.) That orbiting cycle is divided into sections. There's the 10,000 years of "darkness" and this is the period as you know it now—daytime and nighttime—and the 2,000-year period of all light and again 10,000 years of "darkness" and 2,000 years of light. Now what does this mean? Well, basically it means that you're now poised, precious ones, to enter this Photon Belt. It's inevitable that you do so and your own people (and this takes it out of the realm of an invisible voice) have worked diligently—and they have come up with the probability that it cannot be past the end of your century. What does it mean? It means that you've completed the full circle and you're now back at the beginning, precious ones.

It is described in detail in your *Bible*, even with its flaws. Historically, they could not remove the truth of this. They could not just write it away because through the Oral Traditions it was known that this could come again and, therefore, it had to be a portion of the prophecies. So it's in your *Bible*; it is in all of your valid books on mythology; it's been told to you by that one you really enjoy, Nostradamus and, quite frankly, by your modern-day scientists—if anyone would but listen to them. They're so busy feeding you lies and putting up telescopes and radiosopes so that they can hear if we're out there. They know that we're out there. They're picking up this transmission right now. It's you that they do not wish to know that we're out here.

But let's quote your scientists. This is what they say. If the Earth enters first into the Photon Belt—get this—the sky will appear to be on fire. Very, very, incredibly bright, very damaging to the eyes, but not to be concerned, they say, just be assured this is a cold light. Well, as a matter of fact, the Sun is cold. Heat is not what you perceive those big flashes from the Sun to be. Space is cold, precious ones, and that Sun is shining right through that space. So heat is not created by *what* comes off that Sun. It is created *as* it comes off and *as* it again enters into atmosphere.

If the Sun enters this Photon Belt first (because it's invisible, you're not going to literally be able to see it; this will be an instrument reading), you're going to have immediate darkness and this is now even computed, at your speed traveling through space, to last some 110 hours, approximately. Nobody can be absolutely sure. This would run you into the fifth day, the projections having been that there will be three days and nights of total darkness without the Sun rising. The interaction between the solar radiation and the Photon Belt will make the sky look as if full of falling stars—because you're going to get reflected matter. As the Earth moves into this radiation belt, all molecules will become excited, all atoms will change, things will become luminescent. There will then be constant light. There can't be darkness. Not within the deepest cave, not within the human body. So you're going to have to realize that there will be a perception of total voidance of light, but then luminescent objects will begin to create their own light system and then, according to your biblical projections, all the stars will fall from the sky—and the sky will be no more. Well, it isn't logical, is it, and where will it fall to and where will they fall from?

That is the mysticism approach. Please go and study your lessons. It is not mystical. It has a foundation of pure physics upon which to base knowledge. So what can you expect next? Well, it's expected that the rotation of the Earth will diminish, speeds are going to change, impacts are going to occur—and you don't know enough about it so you cannot calculate it. Because of the reduced solar radiation the temperature can be expected to become cooler—and then the ice caps are expected to extend down to a latitude of about 40 degrees in both of your hemispheres. This simply indicates, just as your history books can tell you, that you have had at least five what you call "Ice Ages" which have been recorded and these seem to last about 2,000 years.

So it can be noted that in the world communication centers and fixed satellites, U.S. bases and experimental sightings are within the "safe zone". Is that by design or by accident? Obviously, somebody knows. Someones have enough historical knowledge to know where to place these things. So what are you faced with? You're faced with having to wonder about you, yourself. There are at least three types of people in your cosmos: corporeal, like you—solid and human; atmospherious or atmospherean, also solid to a point (but the molecular structure is quite different); and ethereans, with no mass at all—energy forms.

When you enter the Photon Belt a normal, healthy person is expected to feel a jolt similar to putting your finger in a live light socket. It's a true shock. This is like going through a light wave—and some bodies cannot stand it. The transformation, however, will be complete. You will, in that period of time, have changed from a Corporeal person to an Atmospherean person and if you can't make it, you'll be changed to immortality—and here comes the important concept—without the separation from death and it will happen in the twinkling of an eye. Your theologians have written at great depth on *Bible* characters and they assert that they have lived in the period of light. The sky and atmosphere were different and apparently it never rained. Nostradamus, in his quatrain about the end of the world as you know it in 1999, said "and it will rain no more, but in 40 years, it will be normal."

An Aboriginal myth said, "Men were different to what they are now. We had a bridge to the stars." In all their stories, if they fell out with the chief or elder, they fled to the sky and so did the Greeks. So it appears that space travel is simple when you're within that Photon Belt, you see, because you come into total Light.

The year 1962 was the year that you came within the influence of that Photon Belt. And what happened in 1962? In the late 50s, well, all through the 50s and into the 60s, were great years for the sighting of UFOs—and you still go back to that period of time just before you begin to enter into this Photon Belt when sightings were the most pronounced and you did not yet have the technical capabilities that you do today and, therefore, the sightings were more valid than they are today. As you move closer and closer, you're going to have more unidentified flying objects and persons surveilling your place. This is a great time of change—of great responsibility for the Cosmic Brotherhood.

Does this mean you came more closely in range of space travelers? For space travelers often use that Photon Belt, that Light Belt—because you see, thought is a projection of light. What do you come up with? That possibly it's easier to travel through that Photon

Belt? Well it is and—for space beings not quite as far advanced as some others who travel by thought projection—you need that speeded-up perception of time through light. Since you don't have this experience with which to relate in your educational process, it's very hard to comprehend, but it's very, very simplistic if you're looking in from where we look.

I have a little reminder for you ones who forget your stories, even the far-fetched ones. I'd like to go back to what Eric von Daniken found when visiting South America in his search for *Chariots of the Gods*. It was discovered that there was a tribe which was given an object by the "Sky People" thousands of years ago. They have the Oral Traditions, everything is handed down, but the object still exists and they tend it very, very well. They were told by these Sky People to keep it clean and to listen and watch—and when it hums like a thousand swarms of bees, we will be returning. Well, it started humming, friends, about 1978. So now you have a cosmic alarm clock alerting you to the coming of the light.

Now aren't we finding this interesting? I certainly hope so because you have had a description in detail of how this works and this is a very, very important timing clue. In fact, some civilizations live permanently within the light—and when your planet leaves this period of light and returns to the 10,000 years of darkness, what happens to them? Do they return to the light and wait your eventual re-entry? Ah, so! When we speak of remnants, of what do we speak? Somehow, isn't it beginning to make a little bit of sense?

What happened to those Mayans? The Mayans departed hurriedly with the message also of their return which scholars will now say is imminent. Well, how so? There are rock carvings around the world and they all show drawings very, very similar to the system of Alcione. It's important. Then you have Ball Lightning—a phenomena about which little is known. Could this be little pockets of the Photon Belt? Little utilized balls of electricity? Please note these are being considered and have been seen before every earthquake. Might not they have something to do with the time of the cycle in which you are experiencing?

You may as well realize that these little craft are also always showing an interest in your nuclear installations because that's a serious, serious problem to unleash. Where you could make it through undamaged, the release of nuclear energy can devastate the planet. So what will happen to a reactor within the belt? Photon energy is the energy of the future—and reports indicate Photon rockets on experimental craft. You have it now. The headlights, if you will, appear to be on the rear of the craft. That is because you are utilizing light for the thrust system. When you have a system of Photon density, what may have been a very cumbersome, slow craft, now becomes very speedy and very efficient—and during that period of time, wondrous things in space technology can be developed, just as have the Russians accomplished with their space platforms and their light particle beams, etc., their Cosmospheres. They have learned to utilize a lot of this Photon energy and you have not yet perfected it well enough to get beyond their defense system.

Is it because the radiation of your Sun will be modified by that Photon energy that your scientists only pay small lip service to the development of solar energy? You could have had massive

amounts of energy, but you have noted—note please, that it is very, very scarcely used.

So let us think a minute about your planet coming out of the Light and into the darkness. Well, the Aboriginal mythology says, "You were cast out into darkness and were much afraid, so the Gods gave you a Sun to warm you and a Moon to see at night." If the ice caps form within the light years, then the increased solar radiation when leaving the belt must surely melt the ice and, therefore, you will have floods. If it doesn't rain within the period of light, then it's certainly understandable, isn't it, why Noah might have been extremely awed by the sight of that first rainbow? The *Gilgamesh* talks of great floods, but that, precious ones, was apparently 10,000 years before Noah's flood. So look again at the cycles.

You think a lot about your world and the effect on a single person. It's natural to name self as the first thought in your existence, but what about humanity as a whole? Is it not conceivable, precious ones, that many people cannot, will not, survive the initial jolt if they're not prepared for it? If the ice extends to latitude 40, that covers half the U.S.A. and most of Europe and Asia. That's a lot of people without a home and will they be accepted in other countries? In this limited space of fertility, will it be possible to support untold millions? I think you know the answer to that—and I think you must come into realization that your politicians know the answer to that. They are prepared to attend their own needs in either event, they think. They have made preparations in places like New Zealand, Australia, in the Southern Hemisphere right at the Antarctic, so that if these times come, they will have protection. It is only you, the masses, who will perish and make transition. This is what they are preparing for and they will prepare for this with the inclusion of war—so that if they are wrong in one perception, they can make it through and rebuild at the proper time or the proper sequence according to their desires.

This is not, however, the remnant. It's a very serious time. I'm not going to place years as have some of your prophets. I'm not interested in years, for if you are prepared, it matters not. If you are *not* prepared, it matters not. What will make you get prepared for such a transition? Only education and Truth can give you the freedom to make this transition. Ignorance will not see you through it. Ignorance is worthy of God's forgiveness for acts, but if you don't know what you're about or where you're going—if you have no goal, you cannot arrive. So be it. May God walk with you.

* * * * *

This, again, is Gyeorgos Hatonn continuing with the subject regarding the cosmic cloud, or Photon Belt, as we have been discussing it. This is April 25th in your year 1992.

I have been discussing relationships with Pleiades, orbiting cycles, etc. I believe that you need a little bit of summary because when you get into this electromagnetic null zone which you are going to really begin to feel the impact of very soon and, by the next year in your counting, 1993. Because of the reaction of the particulate and its electrical charges, you're going to have even more radioactive material released, still bearing its radioactivity, falling back toward your Earth, seeking its own density. All of these things are shocking but all of these things we have discussed in great length, more particularly in the *PLEIADES*

CONNECTION volumes because this was an outlay of how, factually and physically, sequences emerge in your experience. Always remembering, please, that anything to do with the physical manifestation of the human entity—this thought projection from God in manifestation—is not spiritual as such. It is an illusion of experience in a format of coalesced material and elements which make up your very beings.

I would caution you as we move along here with this discussion, not to assume, as some ones project, that this is **The Transition** or somehow magically you will move into a 4th or higher into a 5th dimension. When you speak of dimensional changes, you cannot put finite levels onto them. You are living and experiencing in what is called a 3rd- or 2nd-dimensional compression.

There are typical factors involved in this manifestation. You have the five senses with which to deal. The physical aspect is totally encompassing of your being and your thought, your consciousness. You are not able to comprehend a timelessness or a spacelessness—and if you do not study your lessons, you shall not be able to understand it because there is a perfectly logical physics response to the question of, "What do we mean, that everything is happening at once?" because in your dimension, everything happens according to time.

In the outer dimension, everything occurs according to sequence of events; therefore, it is highly unwise for ones to give a specific date to some happening because all factors can impact that date and cause it to not be accurate. Usually ones projecting a date only give the adversary advantage. Sometimes that is exactly what is planned so that other ones receiving that information can say, "Well, nothing you said has come to be," and energy plays go into effect to affect and effect the coming events to either stall them, speed them up or, depending on its purpose, pull them off at the right time depending on what is wished to be accomplished—and these things can be done on the physical plane. The physical plane cannot affect, however, the spiritual plane except as man descends into that allowance. You have to agree to be "had", in other words. You cannot be made a fool of by another. Only you can allow that to happen to you, as a for instance.

We're going to talk a little bit about the null zone. This is an electromagnetic zone where there is an energy vacuum and there is an absence of electromagnetic fields. Everything is canceling everything.

Your solar system—whether you can accept this or not, you will at some point know that this is true: You are a part of the larger Pleiades solar system and this solar system is just about to enter a cosmic cloud which, as I have said, is recognized by the label of Photon Belt or Manasic Ring and it's a part of your Earth Shan's Earth, if you wish. It's a part of a 24,000-year cycle of events—and this event has occurred on a regular basis ever since the Creation. Every time you come around in this spiral, in this circle, you're going to hit it. All of this revolves around solar systems—solar systems out from solar systems all revolving around Alcione which is the sun, central sun, of Pleiades and you're, let us say, the seventh solar system out from that sun. So a lot of changes have to take place regarding your ability to live closer to that great central sun.

I cannot be more specific than to say that this Photon Belt, through which you will pass, generally is in a duration because it will vary somewhat—expand

and contract as all in this universe does expand and contract—but you can, by rule of thumb, say that this Photon Belt passage represents some 2,000 years of your timing in your Earth solar system.

Now the null zone influence where you have this energy vacuum—and this is very important because it will affect you greatly during this relatively short, short period of time—but as you make those changes it is going to be exactly like a spacecraft in front of your car interfering with all electromagnetic pulses and killing your motor. You're going to go into nullville.

The major influence will be of about 120 hours, some 4 to 5 days in duration. You're going to have some signs and indications of its approach. You're already getting some of them. You're going to, number 1: have some very strange lighting—strange colors in the sky—and a perception actually of less light even though it be mid-summer in your time zone. It will seem a little less lighted to you. In other words, you're going to have a gradual darkening of the planet itself.

You're going to note that some of the animals, most of you will not notice it, but you're going to have early hibernations and some animals even moving into hibernation in the early fall if it comes into the fall, you see. Right now you have already experienced that wherein many of the animals have just gone into longer hibernation.

In all of the United States, you have just experienced the warmest winter since you have been keeping records. This is one of the signs of approaching this Photon Belt.

You're going to pick up more of what you think is Tinnitus and you ones who experience what we call those Woodpecker pulses are going to recognize the difference. Also, ones such as Dharma, who pick up the very shrill or very high-pitched frequency of our transmission, will recognize this—as just from time to time you will simply be conscious of this humming sound that seems to come from all around you and has no source of transmission that you can find and, along with that, you're going to have more and more experience with unidentified flying objects that are not from your place—because you have surveillance crews watching over you. Don't let that concern you because most of what you are experiencing now in your skies are Earth-made, Earth-manned craft sent forth for you to experience under the assumption that they are alien craft. They are not.

Right now, in these few years right at this time, you're in what is known as a Space/Time overlap and you're getting increasing cosmic bombardment of the polar regions which is, in fact, causing melting of the polar ice caps. This is also releasing some built up, what you would call in an engine, torque. Torque is also something like the pressure built up in an earthquake fault, for instance. This is manifesting itself as volcanic and earthquake action along Earth's crust fault lines, but the little quakes or the specific quakes that you might be experiencing right now are manmade, man-triggered for their own purposes.

You just experienced one in the Palm Springs or Palm Desert area of California that was man-made. The hope was that it would trigger the San Andreas Fault and a lot of hoopla came out with that earthquake that within the next few hours you would probably have the "Big One" and everybody went helter-skelter, running hither and yon, unprepared as usual and each

hour that passed they said, "You get safer and safer," so everybody immediately goes back to sleep. Those are intentional. I would ask that my ones pay close attention to those and act accordingly. That particular quake in that particular location can give you incredible information regarding one of the projects you're working on, regarding the growing of chlorella. So let us take every opportunity in what the adversary does to allow for whatever lessons or insight you can gain from that information.

I better explain a little bit what a Space/Time overlap is. It's when Electromagnetic-Magnetohydrodynamic changes begin to take place prior to (just before) entering this null zone—and this moves, we can call it Life Zone of gravitational compression—into a larger graviton spectrum. Now you're going to have to understand and go back and read what I have given you on gravity to truly understand this. **It will let your mind adapt more easily to a new frequency, this new type of light coming in, and it's going to allow you a much lighter compression so that you can come into knowing and more understanding much more easily.**

Ones want to pin it down and say, "That's the 5th dimension. You're all going to move into the 5th dimension." No, you will not all move into the 5th dimension. Many of you will simply experience some most incredibly terrifying times wondering what in the world is happening, but the whole of you and the whole of your planet will not be moving into any 5th-dimensional level of experience.

The final process of the Space/Time overlap will be an interfacing of two evolutionary structures. This is a touching or an integration in some experiences between this 3rd and 4th dimension of experience and an experience of the 5th.

Because of the expansion and compression of this Photon Belt, if you will, it's very hard to predict with any accuracy (especially with instruments on your place) which will enter this band or this Photon cell first—the planet or your Sun—and, therefore, **you're going to have to be prepared for each and both** because there will be a relatively short but very, very important impacting time during those anywhere from three to five days that it takes to adjust.

Now if the Sun enters first, there will be immediate darkness. This is going to last about 120 hours and then it will move into continuous light because you will be refocusing magnetically and this pulls you more into the orbiting system of Pleiades where you're going to have at least two suns—and we're not talking necessarily of the larger central sun, other than that at any given time, for a long period of time, you will be experiencing a form of light or sunlight throughout your 24 hours. You won't be having darkness because of the balance of the rays from either direction.

If the Earth enters first, you're going to have the phenomenon occur which basically is more dreadful to us because you will act probably in panic. In the dark you may act in panic, but there's very little you can do other than run into things. If the light comes—and you're unprepared for this type of light—you're going to be damaged, seriously damaged.

Now you're experiencing what they call "Ozone Holes" and extra ultraviolet rays. No, you are experiencing the coming into this Photon Belt—and you're going to have to consider this to be x-rays, invisible penetrating rays of light, and this can be extremely

damaging. Your scientists, your higher Elite controllers, know about this. There has been great discussion and great attempts made to ignite that radioactive belt **[discovered some 49 years ago by Dr. James A. Van Allen and bearing his name]** about your planet which will then burn for approximately three days and then these Photons can be drained off, but in this period of time it is going to be intensely hard on the eyes—and if that is ignited, it is going to cause massive blindness completely encircling your globe.

At any rate, the sky will appear to be on fire but you will know that you made it past that point, at least, in security and safety—and with adequate protection you will be fine because this is a cold light. In other words, you will not get burned as in a heat burn, but it will be a penetrating type of light (and your bodies are not prepared for that type of light), so you're going to have to begin to consider a protection.

The interaction between the solar radiation and the Photon Belt will make the sky look as if it is full of falling stars—and all the molecules will become excited and atomic structures will change—and all things will become luminescent. You will all glow in the dark, so to speak. Then there will be constant light following this period of darkness, but you're not going to have the day-and-night rotations which you take for granted for that entire next cycle.

Now, you're entering the very outlying lip of the null zone and you entered that some years back but the effects really began to get serious in your 1991, early in the year. You are literally being moved, shifted into a different location in the galaxy and it's a location where you will, as I said, get light from two suns.

Now, ones want to call this the "ascension of planet". No, it isn't the ascension of a planet. It is a place created for the inhabitants who make the transition and this will probably take place during the period of the null zone when everyone is responding to the correct vibration frequency—so that it is easier for us to get you off your planet and replaced onto the new and the more beautifully created place where you will have more balance and harmony to continue. That is not necessarily the 5th dimension. You don't go from a mental mindset of 3rd dimension automatically into a 5th dimension. It just doesn't work that way.

The ones on a higher level of understanding and knowing will probably go at least to the 5th dimension—but you will set up a society in Truth in that dimension and continue with manifested experience but without the evil counterpart to pull you down. This is where you will come into knowing and higher, greater knowledge of your worthiness as a creation of Creator.

Now a lot of you have been told, and especially if you have been exposed to the *Keys of Enoch* which some ones consider to be a very valid *Bible, Holy Bible*, prophecies of how it will be. Well, I'm not going to get into prophecies or how it will be because, you see, the Oral Traditions of the Ancients of Wisdom and the wisdom-keepers have handed forth all of this information. So, it's hard to tell what one has brought with him into this experience or what has been handed down historically—and it really doesn't matter because you are now being given instructions so that you can count your timing. **And information is being opened up to you—and genetic files, for instance, are being returned to the planet for your discovering again, so that you can make this**

transition and begin to heal the damaged planet and the damaged physical beings.

There's great thought that your whole solar system will be picked up and reseeded in a different vibratory dimension in the galaxy. Your whole solar system will come into closer proximity to Pleiades and you will be rearranged somewhat, but reseeded, no, it is not quite like that. So don't get carried away if ones say, "Oh, well, they're going to now reseed every planet and upgrade civilizations, etc." That is not so. That's not going to happen.

So, what do we have? The solar system will actually be projected off the lip or off the edge of the null into that different operating system—that different frequency, harmonic frequency, tone—and **you're not going to need these dense physical bodies that you have.** Does that mean you have to get rid of your body? Many will because you're not going to be prepared to make that transition. However, what will happen will be a further lightening weight-wise, a light-like density, vaporous density almost, which then can be compared to a 5th-dimensional being.

I believe, I'm searching my memory banks, but I believe if you would refer to the *Book of Revelation* somewhere in the early, early chapters, maybe chapter six, you'll find that it says, "There will be no Sun, Moon or stars." Well, precious ones, there's not going to be any electricity. The batteries will simply not work. That means cars will not run and after a day or so, you won't have any water, you won't have any gasoline. You're going to be pretty hard up, so you'd better be a little bit prepared. It's going to be as bad or worse than in an earthquake because everything will just simply be shut down and auxiliary power is not going to fill the need, fill that void. Electric power generation systems on your planet utilize Earth's magnetic grid to function and, therefore, no grid, no electric power.

You're going to have to make sure you have adequate food and water for at least a week. Now that's for everywhere. You who are prepared for earthquake damages will probably be all right if you have an alternative method of heating your food or heating your room with a little propane or something. I wish that I could offer you more in the form of generating capacity, but most of your interim generators simply are not going to work either. They will come back into service for you first, if you have your own generator run by a separate fuel system than, say, your big electric grid—because many things are going to be happening at the same time as this shock hits.

Everything will be jolted tremendously and, therefore, you are going to have earthquakes and other geographic types of incidences occurring which will also probably interrupt your flow of lifeline necessities, especially the western coast, say California. Beyond the San Andreas Fault, you can expect to be without those lifeline services at any rate. So, you need to be prepared with water, toilet facilities and some manner of heat. In other words, you must be prepared to be without electricity for some 4 days to a week—and that means that you'll need some alternative means of lighting and cooking or be prepared with foods that do not need cooking. You're going to end up with people completely panicked. This is why the instructions so far have been to stay absolutely indoors. During that period of time, keep off the roads. Some

people are going to literally be blind—and it is going to be very, very dangerous to travel.

Now, these are the things that are simply going to happen. They are known by your scientists that they will happen. You cannot be sending any probes at all into your atmosphere and into the reaches of space to any extent and not know of this Photon Belt that you're going to pass through. There is no way that it has been missed—only *you* have been lied to.

So the next big deal is "when?". "Well, Hatonn, when, when, when?" I can only tell you what the indications are. I do not even necessarily agree with them, but because I want you prepared and ready, I'm going to tell you the worst scenario. It will not be later probably than the end of July. Many predictions put it right on the 25th of July of 1992. That's not very far from now and you're already experiencing a great many pulse-system strikes that are nullifying your electromagnetic field. You are having plane crashes. You are having ball lightning around, before and during earthquakes. You are experiencing earthquake action with preceding explosions. This indicates a striking of the Earth with some kind of electromagnetic pulse system. It gets harder and harder for you to distinguish which would be Mother Earth or universal.

There is one very interesting thing that will happen, the phones won't ring, either, and that could be good for tape-makers!

The reason that I'm not going to give credit or denounce that particular time projection is that you are already into the fringes, and have been for some time, of this Photon Belt. Your adversary has perfected technology enough to utilize it to his own advantage and it's why you must know about your enemy who is doing these things to you—and what their game plan is and by when do they expect to take the planet. It goes along, precious ones, with the year-2000 plan of total global control. Even if there was the ability to guarantee a day and a moment of something like this happening, you must go back to what I have told you prior to this about life. What is life? What is this experience? You are a portion of the whole of it, any segment of which can change that whole. If you understand and can comprehend the projection of manifestation of Creator/Creation, then you can see that under the right set of circumstances this could be called off instantly. It would be simply un-created.

Don't worry so much about new appearing planets in your solar system. I'm asked about this every day, "Well, what about this black hole that wasn't, when we got there?" and "What about this new planet?" and "What do we talk about this star over here?" and "There was a star over here...". **What you are not being told and what you are not capable of perceiving is that you are shifted, you are being shifted. You are in the process of now shifting and it doesn't mean that ones are coming into your solar system. It means you are moving on into a higher level of solar orbiting.**

You must come out of this me-ness about your corner of this little universe or this great universe or the whole universe. You are but a part of it. You are not the center of it and you are now coming into, let us call it, the inhaling of the Creator portion. He's sucking you back to the central source and other things will be appearing in your telescopes because there's much going on out there, not the least of which are those considered planets and stars that are actually

starships—and they do appear to be moving closer to you *because they are closer to you*, but guess who's moving? Isn't it an interesting concept? This is only a clue. This is only a sign. Don't go off the deep end. "The sky is not falling," as Henny Penny says—and after this period passes, things will come back on-line. You will notice, it has happened over and over at scattered places about your own nations. Different cities have gone off grid, electricity shut down, radar systems have malfunctioned. This is sometimes done deliberately, other times it is simply a fluke, a passage through this zone, this null zone.

After this period of time, everything should work completely well and then, of course, you will begin to experience more daylight, more daylight, more daylight. I realize you ones want specifics. I'm not going to give you specifics. I'm not going to let you fudge on your homework. You say, "Well, why don't you give us what we need?" We have—to the tune of some 56 books (*Journals*) now.

I can tell you (or actually remind you) that all things, all bodies are continuous, spiraling, cycling, absolutely continuous. They never cease but they do reverse their potential. They reverse their potential twice in every cycle of their eternal journey within and beyond the range of your sensing, by compressing into visibility and then expanding into their invisible seed recordings. Now if you don't understand what that means, I suggest you get *PLEIADES CONNECTION*, Volume 7. All of these bodies are expressed in cycles—and a cycle is a continuous 2-way spiral journey from the expanded condition of a body to its opposite compressed condition and back again to its wondrous expanded condition. You have it happening every day. It's called Day and Night and each is the opposite half of the other, just as is one's breathing in and out.

You see, you have a cut-and-dried perception of things such as life. What actually is daylight? Why do you have daylight? Why do you have dark? Well, let's look at it from a side of physics. Daylight is nothing in the world but light compressed—and you can't label everything either dead or alive because you can't logically state that invisible night light is somehow dead. You can't truthfully say that only those things which respond to your senses are living—and others which are beyond your senses are dead. I don't even understand, for instance, when we spoke at the Tehachapi Community Church when we were asked to consider a Pleiadian's view, or my view, if you would, of reincarnation. I can't even understand why you have to ask yourselves whether or not you believe in reincarnation or do not believe in it. A human being is a unit of an imperishable eternal idea from Creator. Human's body manifests that idea. When his body disappears, it passes beyond his sensing—but his identity as idea cannot be other than continuous, just as infinity and eternity are continuous. You can go another step and I can remind you that the form is just as visible to us in this dimension as it was to you in yours. It's never changed in the vision or idea of God, its source and, therefore, it cannot cease to be. For instance, sometime you can pick apples from a certain tree. In October you cannot pick those apples if they ripen in August because that tree is going to produce its apples for you to pick every August and you're going to wait or pick early or whatever the cycle of that tree might be.

So, you're going to have to think of life as beginning at birth and ending in birth. You can't continue to think in erroneous terms. Man of Earth literally has written reincarnation out of his books—because it lessens the control that human man has over human man. You've not learned to think of it as a continuity such as the cycle, say, of a piston stroke in an expansion/contraction engine, yet, one is just as continuous as the other. Somewhere about your middle-life expression, your regenerative power reverses and you begin to die just as you begin to live that first half of your cycle—but what does that mean? It means that you're only getting ready to begin another cycle as you end that one because Nature balances all of her divided cycles. If the visible body disappears, it means only that the whole life is shortened somewhat for this particular cycle—and it will balance itself out and you don't have to really worry about it.

To you who have studied your lessons and, as we speak of this **null time**, I don't want you, please, to consider this **void time** or the **voidance point** and I'm not sure just how to express it so that you do not misunderstand it—because it's a very important difference. You see, actually there is not a void in experience as you enter this null time or this null cycle, this few days. You are still experiencing. You are just experiencing differently and there is no gap, there is no void in any other portion of the cycling to interrupt the absolute continuity of every effect of motion into its opposite effect. The cause of all effect is eternal—and if there were any gap or any void or discontinuity in effect, precious ones, cause could not be eternal. So this is a part of the continuing spiral in an effort to reach this point of voidance where there is rest—because there does come one voidance point where all is at rest. **[The Twilight Sleep of Creation lasting some 2,177,280,000,000,000 years as calculated in our counting systems.]**

At this time, you have a limited range of perception and it's born the idea of discontinuity within you. Your concept of death is one of the results of that gap in your range of perception—and it's something you're going to have to go beyond in understanding. Therefore, you're going to have to reconsider and come into understanding of this absolute cycling of all things before you can move into the next dimension of experience. Therein lies what it is you're searching for. How do you get past that and into understanding and, of course, it is through the soul. You're not going to achieve this kind of understanding and knowing through the physical aspects of your experience. There is no way. It can only be experienced from the soul. The soul is the fulcrum from which the polarized lever of motion extends to manifest the polarized body, but all those bodies are then divided. Therefore, by the same token, all bodies are polarized.

Now, what does that mean? It means a body which is divided into two seemingly separate male and female parts because of two opposite conditions which cause that seeming separateness, but the whole universal body is polarized into these mated pairs. It is also multiplied into compressed light waves of matter which you can see, and into expanded waves which you cannot see—and this gets, again, into the lessons as given for your study and your higher understanding so that, as you come to these places in your cycles, you will be able to move into the next portion without panic, without fear and simply move forward.

I would ask you to please note what takes place in your political arena. It's especially prevalent at this moment since you are now into your called “election year”. Look what is happening with your nation relative to other nations in your hemisphere and on the entire globe. The United States, for instance, was making a move to bring some troops and some more added power and confusion into Peru, which is what brought down your plane, not the lies that you have been told. Your plane was five hundred miles from its customary course—and what would a C-130 cargo plane, a huge cargo plane, be doing with Air Force troops and military personnel? Those are geared for flying, in and out, cocaine and, unfortunately for you ones, you have to face the fact that that is a very large business for the United States of America, the shipment of cocaine. There is so much more to every political move than meets the eye, that you're going to have to look beyond what you are shown, so that you can know the truth of it. These are all distractions. These are all very physical-oriented impacts, bombardments against you-the-people. You're going to have to separate what is soul evolution from what are the cycles, ordinary cycling of planets in the universal order of the solar system. **You are coming into higher integration with the higher brotherhood of man and, at the same time, you're having the adversary of the higher brotherhood fighting out a battle for control of the world on your planet.**

It's coming through to you in the form of political speeches, ideology that says, “One World, New World Order”. This sounds like grand order with freedom for all but that's not what it is. In fact, I wonder how many of you actually have a definition of Mr. Bush's New World Order that he likes to spout off about and under the guise of which he gives away our nation in the most heinous, treasonous manner on your place to date. What did this President Bush mean after winning a non-war, after this horrendous affront to your world and our senses called the Gulf War? He announced to you that you're in the era of the New World Order. Well, what in the world did he have in mind? How many of you know what he meant? Let me tell you what the 5th Socialist International Congress in England defined it as being: “The New World Order is a world order that has a Super-National authority to regulate world commerce and industry. An International Organization that would control the production and consumption of oil. An International Currency that will replace the dollar and a World Development Fund that will make funds available and an International Police Force that will enforce the edicts of this New World Order.”

Many of you ones take great exception with the projection that you can have robotoids, that you can restructure and recreate and also create life forms from genetic and DNA alterations and actually having a DNA code you can replicate. How is it that you can completely discount whatever we bring to you and, at the same time, your own public announcers are telling you, just yesterday as a matter of fact, that you are now able to—by taking DNA particles from plastic substance and introducing them into plant substance—create plastic that will be biodegradable. Why is that less far-fetched? But it's true. **You ones are going to have to catch up with the times because there is an entire vacancy, a vacuum where you have**

been given nothing but lies on your media and in your press, so that you will believe exactly what you are told to believe—and it is to keep you blinded so that, as the cyclic changes come, you will be terrified, uninformed and you will automatically depopulate your own planet.

Now, I cannot do this for you. I have no intention of doing this for you. I have no intention of intervention. This person sending information on this Photon Belt asked this question and then states, “I knew they would intervene before these culprits could pull down this world.” No, we will not intervene. You will go right through the cycles and that is not intervention. **When the proper sequence of time for integration is at hand, there will be integration.** This is not intervention. I ask you to think upon these things and I thank you for your attention, for I shall be writing and speaking more often now for, as we move out of some of the necessary unfolding of information, we'll be moving more in depth into some of these subjects which I certainly hope you will find far more interesting—because you have a wondrous journey in front of you, but you have to know what to expect or you won't be around to make that journey. I bid you good day. Salu. Hatonn to clear.

Understanding Gaiandriana

LIVING FORM OF LIFE
(GAIANDRIANA)

As we sit to write on this subject I am, again, stuck with using that which has been put into what I have to consider, crude language. I am forced, by labels placed before my expression, into utilizing incorrect perceptions to achieve any relative understanding. Obviously, terms such as nucleotides, human genes, DNA, RNA, etc., are readily recognized. Then come misperceptions, but remaining suitable for use, such as scrolls, chondriana, etc., which have been already utilized and, therefore, give some understanding without gross misperception. Then we have “scalar” which represents “life” energy known more widely as “prana” energy, etc.

I want you to realize that “chondriana” is a term which I cannot now simply “toss aside”, for it is what has been “named” as an entity recognized by many researchers. This is a “living crystalline” life form—cell, if you will, with the duality of all things—male/female, etc. It is not recognized on other planes as such but rather “Gaia” meaning “living” and “driana” meaning cellular or crystalline cellular “form”. These “forms” take the very sex identity of male—“chondrion” which greatly resembles its precursor, “mitochondria” of your cells. The mitochondria of your cell is as a unique organelle and its main purpose task is converting glucose to useable adenosine triphosphate (ATP) molecules. This guy is aggressive and active. He is really looking for that lovely lady who might be called his “twin flame” by your metaphysical searchers. These creatures were independent life forms many billions of years past—and now God has presented them in their “whole” form to serve you.

The female is a lovely, passive, single-layered-membrane type of creature that becomes energized by the male during the “courting” process.

The male gives protections to the female from any virus, bacteria, malignant or mutant cells—and if placed within the chondriana’s environment, the male gives “birth” to chondriettes, best described as “killers”. These are ancestors to your lymphocytes, “the T cells”.

The killer cells sequence DNA production of specific protein-digesting enzymes that break up the cell membranes of foreign invaders, etc. Note that the life forms themselves are the primary energy source—but foreign invaders stimulate a fast reproductive cycle within the gaiandriana (or recognized by researchers as chondriana) by supplying extra food.

It is important for WH to understand that conversion fuel comes from ATP “ion” complexing with magnesium ion. I have laid out a lot of this prior to this writing and will not continue the boring outlay. However, to make sense, if you just entered door one, you need at least this brief statement. Scrolls represent the “energy packets” which come from and are received from “cosmic radiation”. We won’t even burden you, at this point, by “scalar” confusion.

HOW DO THEY WORK, THOUGH?

The “males” (Gaiandrions [chondrions]) give imprint of their own biological defenses to destroy non-human invading life forms. It will become immediately obvious that their application is magnificent in fighting off any and ALL diseases. These gaiandrions can be separately “injected” (but we aren’t going to deal with that yet) intravenously into the body. As we have written before, at one hour after injection, the patient will have a shaking “T-Cell reaction”. We are not going to get into this because this is not acceptable in the continental U.S.—and I do not intend to complicate this natural substance with any kind of “treatment programs”. The same result can be brought into experience by taking it “easy” and allowing the gaiandriana to do its perfect work without provocation of the societal structure, medical community or governmental control boards. God didn’t go around “injecting” anything intravenously to do His wondrous work. Will you EVER have available these more rapid methods? I hope so but that is up to you in reclamation of control over your sovereign beings.

For Dr. Young I am going to re-present information—and Earth-bound “laws” of quantum mechanics are sufficient. The electron between two carbon atoms fluctuates between positive and negative carbon ions. To assure the stability between two carbons in, let us use the diamond lattice, it can be proved that the carbon in the diamond is, indeed, in the positive and negative ionic state, and that this is also responsible for the diamond’s “hardness”. Because polarity is resonating back and forth, it seems non-polar. Researchers can produce at least two types of diamonds at atmospheric pressure by pairing homo-polar carbon ions. This, of course, in turn proves that a diamond is homo-polar.

This is only important to the extent that it represents a third application for prana technology—“scalar” if you must. Earlier work has shown that, for instance, to make a diamond, you must have an atomic syntropic transducer. This allows transducing “scroll” waves (free energy braiding into photons) to the higher energy level in order to control chemical bonding. **Scroll resonant energy leaves its signature on everything throughout the whole universe including ALL FORMS OF LIFE.**

If you introduce single ionic nitrogen to form carbon bonds by an exchange reaction in the lattice—substituting nitrogen for a carbon isomorphously—these carbon-nitrogen bonds form paramagnetic centers, and convert orthohydrogen to parahydrogen with paramagnetic properties.

Since this is very integrated with “cold fusion” and “free energy”, I shall not continue to outlay further, the implications. For that, you come to me directly! I will continue with the subject in point, however, and I believe to you who are awaiting answers—they may well become quite clear as you follow this through. All things are related to all things and what is sauce for the goose is equally sauce for the gander. You will find that by adjusting humidity—i.e., say, dropping it to around 6%—you drastically reduce the conductivity of the air as well as the static charge of the air. If you are working with plants in research—at this level they will tend to move into dormancy. Phototransducers in the chlorophyll, stall due to lack of conductivity (it is not

relative to moisture content as might be thought). At this low humidity fruits will cease growth even if intensive irrigation is provided. If you wish to continue growth, then surroundings must be altered by raising local conductivity artificially. I hope this is giving you insight into growing “fields” or “greenhouse plant” growing.

The syntropic phototransducer is very similar to autotrophic and heterotrophic transducers which Nature built within the living cells. They are, therefore, the prerequisites to life formation and continued existence. This is why tampering with your atmosphere is going to kill you all if it isn’t stopped.

OK, you now see how the Carbon-Nitrogen (C-N) bond, semi-absorbed, promotes paramagnetic sights where “ortho-to-para” conversion takes place. By upsetting the ortho/para ratio the hydrogen will lift ortho-delta-positive link to the delta-positive, HWC-delta-positive [HNC?], and so on. This opens the way to transport reactions—transporting suboxides coupled to para-hydrogen, vapor phase at low temperature.

Researchers have already utilized this technology to build alternate rows of nitrogen-doped carbon atoms where the layers of 111 oriented surfaces formed a superlattice (all 111-100 and 110 faces were constructed from the bent carbon rings of graphite). DO NOT ASK MY SCRIBE TO EVEN CONSIDER OFFERING INPUT ON THESE SUBJECTS—THEY ARE HIGHLY TECHNICAL, PRIVATE AND SHE DOESN’T KNOW A DAMNED THING ABOUT IT. If you who would work with this do not understand it—get with me or Tesla or someone who DOES.

Pioneers in the field used the para-proton transport reaction technology for new forms of metallic carbons, diamond, etc., with different distribution spacings. More important to the subject in point, there have been synthesized hundreds of exotic new materials which are years and years (centuries) ahead of the natural evolution development. Through capturing the free energy (scrolls) you can harness the Sun’s clean energy for a pollution-free world.

What you are doing with the gaiandriana is utilizing a syntropic transducer not only able to stimulate solar fermentation, but also you can produce electric current and free hydrogen by simply transducing the lower-level energy. Chlorophylls have different geometries of antenna. This produces different patterns of isobars, as the resonant molecule absorbs or emits its transduced photon energy. The three-dimensional field so produced follows the scroll pattern sideways, which is similar to the three-dimensional field produced in the very first cold fusion process back in your sixties. Electrons excited by the scrolls are different from electrons in the normal state—as verified by their own tiny fingerprints on an EPR spectrum [**Determined by Electron Paramagnetic Resonance (EPR) spectroscopy, as opposed to the Electron-Nuclear Double Resonance (ENDOR) spectrum or the Nuclear Magnetic Resonance (NMR) spectrum**]. Through this, energy couples with the nuclei and the orientation of the nuclei differ with respect to an external field. The larger the number of excited electrons—and if their spectrum is proportional to their number—then the higher the number, the narrower the band will be.

Scrolls determine the size of the photon that is

absorbed by the spin-aligned electron or proton; this alters their position correspondingly. Thus their energy level is transduced to the absorption frequency to match the absorption frequency of the host electron or proton. Changing the direction of the spin on a proton depends on the strength of the external field, and can also change the absorption spectrum due to spin polarization.

A strong North pole of the proton can suck in countless scrolls by their South poles and reverse the spin. By forcing the position of the proton to the opposite attracting position via scrolls—and by reversing the orientation of the proton—ortho-proton can be converted to para-proton. In the atomic wrench, the nitrogen and electrons result in hyperfine interaction. The hyper-excited carbon-nitrogen transducer can lase an immense photon flux and, subsequently, transduce enough upshift of the frequency to reverse the proton spin.

THE SEED OF LIFE: FREE ENERGY

A three-dimensional vortex, performing three-dimensional motion, inverting through its poles back and forth and changing signs constantly. Gosh, this is hard because this interchanging is explained best in Germain's presentation of "Light", "God", etc. Oh, well, this is for only one or two of you at this time, at any rate. (WH: Besides you and I, only two others have this writing, so please help protect it. Thank You, E.J.)

The scrolls form strands with matching frequency of oscillation and equal wavelength. These strands of scrolls braid into photon vortexes. The vortex of an electron is fed by 918 pairs of photons.

A 917-pair electron vortex will copy the genetic trait to form the proton, and 918 electrons form the neutron. Every time an atomic vortex inverts through the North pole of the proton, the scrolls form a coherent field followed by pole splitting which then reverts through a white hole (assuming the North pole of the proton to be considered a "black hole"), followed by an incoherent field. Each absorbed scroll adds up to increase the mass of the host. However, due to the increased mass, the spin will change on the host, followed by a change in wavelength and frequency of oscillation.

WORKING FREE ENERGY

The plasma membrane of the living cells is permeable to ions that are driven by the self-induced field generated by free energy (scrolls). The net result is an electrical potential between the inside of the cell (-) and the outside of the cell (+). Sodium and chlorine ions are responsible for the conductivity in the plasma medium. (This will require some reference material but I do not want you cluttered with it at this time. I have lots to say and if you go off the deep end, you will be boggled "intentionally". All of this will be unfolded in its proper sequence, so take it easy.)

The cell membrane, along with its plasma, acts as a condenser, and is negatively charged inside with respect to the outside, which is positive. The condenser membrane is charged by the scrolls (static charge of the air). The potential difference varies between 40-80mv depending on the scroll-energy density. Such free-energy density will vary with the incoming cosmic rays, and also with

atmospheric conditions such as pressure, moisture content, static charge, etc. Keep in mind I said "cosmic rays", not "sun".

What you must hold in your hearts here is that, in general, all biological activity STRICTLY FOLLOWS THE WEATHER PATTERNS, being dependent on the unmolested atmospheric conditions.

OK, I want you to not be preoccupied with ANYTHING as I lay this out for you. I don't want you to go, at this time, and research any other's work. At this time I don't even want you to blow your brains out because clarity seems elusive.

Now, to consider the substance with which we began this writing, living crystals, we must consider the prana technology which results in the very...

ENERGIES OF LIFE

This is a fun and most miraculous "twist".

The asymmetric carbon atoms in living crystals polarize and "twist" the light (photons) in opposite directions according to the mirror image of the crystals. Likewise, the bonding energies line up asymmetrically according to the force of attraction. These optically active crystals are twisting the strands into a double helix, thus leading into the life process. Further, the storage batteries (phosphates) are located on the strands bonded to five-carbon sugars of asymmetric crystals, where the mirror image of the energy transducers laterally bridge the strands with T (Thymine) and C (Cytosine) molecules—this places the amino groups in full mirror-image position. (Maybe I'll let you have a diagram here.) Once again, the energy pattern dominates the life cycle.

Optically active crystals rotate the quantum of light in both clockwise (CW) and counter-clockwise (CCW) directions (CW crystals absorbing, CCW crystals transmitting) by twisting the plane of the polarized light. If joined, the two tendencies may cancel. In this very action you can see the value of LIGHT and frequencies of the various "tones" or spectrum rays. At some point you can actually devisualize if the right frequency is attained. Likewise—you can "ascend" (Oh, my goodness! What have I said?). Herein is the very reason that I do not want any of you rushing off to research another's work—because obviously—they do not have what is needed and I must give it to you in a most subtle manner. This is "why" this writing will not have meaning to almost everyone.

The introduction of protonic hydrogen reverses the tendencies! The enzymes utilize this characteristic to cut loose hydrogen ions from the chain—thereby reversing tendencies and separating the strand by the reverse twist of light (hotdog!—going and coming!). Energy compounds in living organisms have asymmetric carbon atoms and the organisms make use of one of the forms in synthesis with the exception of the double helix. The simple sugars in the living tissue fall into a D-series, while the amino acids (the building blocks of proteins) fall into an L-series. Unpolarized light travels in all directions in disarray like magnetic moments. Light passing through these living crystals will emerge polarized! While the array of macrocrystals is in lockstep, their fields restrain the photons, cleaving and reflecting them polarized, with the twisted polarization plane setting the path for the very evolution of life!

This optical activity of the life crystals monitors the twisting of the DNA—and the strands, the mirror images of the macrocrystals in lockstep which, with extended

power, twists the plane CW and CCW. Once the DNA is zipped, the molecules are bonded in close position and the CW and the CCW twists (opposing tendencies) are neutralized. Enzymes are utilizing these tendencies to activate the right molecule (macrocrystal) to rotate the energy in the proper direction to zip or unzip the DNA strands. The key to the changing rotation lies with the positive ions which are present as bridges in the strands. The enzymes are able to turn these keys to levorotary or dextro-rotary position.


Ah, and, therefore, if you can introduce the frequency (which at some point you shall be able to do) of, say, 16.9433 directed even from a very common short-wave radio band (within the weather satellite range), you will find invisibility taking place. That is the frequency at which we transmit to Dharma—and also it is the frequency of "visualization" of our own craft and persons. I just thought you might find this an interesting point. Furthermore, it WILL answer some of Wendell's questions regarding the work he is doing in other transmitting projects left herein unnamed. Indeed, the procedure "works" and at that transmission frequency will travel very, very rapidly. Furthermore, it builds in intensity as it resonates instead of dissipating. This actually transcends "speed of light" or any "sound" and can be targeted precisely. We are considering, herein, the speed of thought. This is far advanced of Earth-technology at this time—but hold your breath, students, and we'll get there. If you try to prove this by your regular technology—especially without that which is known and denied you—you will simply get lost in the confusion. **Know that it is possible, simple and will be given; but please continue in your patience and allow flexibility in thought—almost to the reversal of all perceptions as have been "taught" by the idiots calling themselves scientists.**

But back to living crystals: Nucleotides are purines, or pyrimidines, with either ribose or deoxyribose and a phosphate group. In the nucleic acid's structure, the sugar portion of the nucleotide is bonded to the sugar portion of the next, by means of a phosphate group attached to both. A sugar phosphate backbone runs the length of the molecule, and from it extends purines and pyrimidines, one to each nucleotide. Nucleoproteins consist of two parts of large macromolecules.

Cantril: Cantril was primarily responsible for establishing the Association for Humanistic Psychology based in San Francisco that taught Tavistock methods. It is in institutions of this type that we find the lines between pure science and social engineering becoming totally obliterated. The United States has very large contingents of Wells’ converts who would not hesitate to follow such a policy once the New World Order becomes a reality. Walter Lippmann was one of Wells’ most ardent disciples.

Unpublished Letters. Kipling, Rudyard. Kipling was a Wells disciple, and like Wells, believed in Fascism as a means of world control. Kipling adopted the Running Cross as his personal emblem. The Running Cross was later adopted by Hitler—and with slight modifications, became known as the swastika.

Memoirs of a British Agent. Lockhart, Bruce. In this book we are told how the Bolshevik Revolution was controlled out of London. Lockhart was Lord Milner’s representative who went to Russia to watch over Milner’s investment in Lenin and Trotsky. Lockhart had access to Lenin and Trotsky at short notice, even though Lenin frequently had a waiting room full of high-ranking officials and foreign delegates, some having been waiting to see him for as long as five days. Yet Lockhart never had to wait more than a few hours to see either man. Lockhart carried a letter signed by Trotsky informing all Bolshevik officials that Lockhart had special status and should be given the utmost cooperation at all times.

The Pugwash Conferees. Russell, Bertrand. In the early 1950s, Russell led a movement urging a nuclear attack on Russia. When it was discovered, Stalin warned that he would not hesitate to retaliate in kind. This led to a quick “rethink” on the part of Russell, who almost overnight became a pacifist. Thus was born “Ban the Bomb” Campaign for Nuclear Disarmament (CND) out of which arose the Pugwash anti-nuclear scientists conferences. In 1957 the first group met at the home of Cyrus Eaton in Nova Scotia. Eaton was a long-time American

communist. The Pugwash Conferees dedicated themselves to anti-nuclear and environmental issues, and were a thorn in the side of U.S. efforts to develop nuclear weapons.

The Works of Jeremy Bentham. Bowering, John. Bentham was the leading liberal of his day, and the agent for Lord Shelburne, British prime minister at the end of the American War of Independence. Bentham believed that man was no more than a common animal, and Bentham’s theories were later written up by his protege David Hume. Writing about instinct in animals, Hume said “...which we are so apt to admire as extraordinary and inexplicable. But our wonder will perhaps cease or diminish when we consider that the experimental reasoning itself which we possess in common with beasts, and upon which the whole conduct of life depends, is nothing but a species of instinct, or mechanical power that acts in us unknown to ourselves... Though the instincts be different, yet still it is an instinct.”

Public Agenda Foundation. Founded in 1975 by Cyrus Vance and Daniel Yankelovich.

Beasts of the Apocalypse. O’Grady, Olivia Maria. This remarkable book gives details about a large number of historical figures, including William C. Bullit, who conspired with Lloyd George to pull the rug out from under White Russian Generals Denekin and Wrangle at a time when they had the Bolshevik Red Army on the very brink of defeat. U.S. Congress, House, Committee on Internal Security, Reporting on the Institute for Policy Studies (IPS) and the Pentagon Papers. In the spring of 1970, FBI operative William McDermott went to see Richard Best, who at that time was Rand’s top security officer to warn him of the possibility that Ellsberg had removed Vietnam study papers done by Rand, and copied them outside of Rand premises.

Best took McDermott to see Dr. Harry Rowen who headed Rand, who was also one of Ellsberg’s closest friends. Rowan told the FBI that a Defense Department enquiry was going on, and on this

Barker was one of the Watergate Burglars. My meeting with Barker took place outside an A&P Supermarket, quite close to the Coral Gables Country Club in Coral Gables, Florida. Barker said Thompson was with his law partner who was on a short visit to his mother in Coral Gables, which was only about five minute away from the A&P Supermarket. I went there and met Thompson who expressed his disappointment over the way Ervin had imposed such severe restrictions on what evidence he, Thompson, could admit.

“Watergate: Further Notes”. Coleman, Dr. John. There were actually two operations on the night of the break-in at the Watergate complex. According to what Frank Sturgiss told me, the burglars were set up and were being secretly watched all the time by another group he referred to as “the plumber watchers”. After the first attempt to break in, when Martinez found the door locked, proving that someone had removed the tape over the lock, the team went back to room 273 in the hotel across the street from the complex.

“At that time I thought, wait a minute, is this guy (McCord) working for someone else, the CIA or what, and I was feeling that way,” Sturgiss said. Sturgiss was most probably right. In the arraignment in court the afternoon following the attempted break in, before anyone realized the significance of it, the judge asked McCord his occupation, which McCord answered by saying “security consultant”. Pressed by the judge for details, McCord said he had recently retired from government service. The judge, his curiosity aroused, demanded to know which service of government. In a barely audible whisper, McCord answered, “The CIA”.

“We did not want to go back,” Sturgiss said,

“but McCord ordered us to go back.” Sturgiss said the rest of the group were appalled, “because we all knew that the removal of the tape from the latches meant that the break-in had been discovered... During the discussion, McCord left the room, giving us no explanation where he was going. He never told us where he had been when he came back, and the next thing you know, was, he told Bernard (Barker) that we could not use our walkie-talkies. When we went back the second time, we had no communication with the others.” (He was referring to the group in the hotel across the street.)

The plumbers obeyed, leaving the tape over the latches, which McCord was to remove behind them, but McCord did not remove the tapes. Once inside the offices of the Democrat Party, Sturgiss said: “We heard a lot of sounds—you know, like people running around, running up and down the stairs. We were scared, and asked McCord what the hell it was. It sounded to me as if security had been alerted and were about to grab us, but McCord assured us it was nothing.”

Obviously, security personnel HAD been alerted, and what Sturgiss and the others heard was the noise of the guards positioning themselves to see that none of the plumbers got away. Security guard Willis, obviously knew exactly where to look for the tell-tale tapes, clearly visible, and alerted the Washington, D.C. police.

In a very strange episode, Nixon offered McCord executive clemency in the form of a brief prison sentence, if he, McCord, would agree that the blame for the break-in lay with the CIA. But McCord told Jack Caulfield, Nixon’s go-between, that he would not allow this, even though it was pointed out to McCord that all of the other plumbers had agreed to this plan of action. There is no doubt that the CIA could not have denied complicity in the break-in had McCord talked.

Had McCord not held out, the CIA would have been implicated and Richard Helms would have found himself out of a job. Nixon’s hand would have been greatly strengthened; he would have been able to appoint his own men to positions in the CIA, positions from where they would quickly have uncovered the role played by Kissinger and Haig in undermining him. Several letters written by McCord to CIA agent Paul Gaynor, clearly revealed why McCord would not go along: “I have evidence of the involvement of John Mitchell and others, sufficient to convince a jury, the Congress, and the press. The maximum effect is accomplished if everything is held until the trial has started, and then surface everything at once...”. Why did McCord write in this manner? What “maximum effect” was he talking about, and against whom was it to be directed? The obvious answer is, the Nixon presidency. There can be no other explanation but that McCord was part of the setup to “get Nixon”.

THE AUTO-DEMOLITION OF THE ESTRADA ADMINISTRATION

Many world leaders today, from President Fujimori of Peru to President Estrada of the Philippines, face the dilemma of how to ensure the continued survival of their political leadership, in the face of globalist-sponsored insurgencies, terrorism, economic warfare and even military attack. The astute, patriotic leader knows what is basically needed to defend the national sovereignty. To save his country from dismemberment and ruin, he must have the earnest sympathy and powerful cooperation of his loyal fellow-countrymen. Without this primary and essential condition, all his efforts will only be in vain. Unfortunately, President Estrada is fast losing the popular support he once enjoyed.

Up against a morally decaying popular culture, a free-falling peso, a *vox populi* demanding the modern equivalent of Caesarism's "bread and circuses" under the banner of "people power", an increasingly hostile press and foreign-sponsored political forces fueling mass action, if not outright insurrection, Estrada's scandal-ridden government cannot possibly survive this latest destabilization attempt. **[D: Well, a week or so later it appears it will be a battle to the end.]**

"A country which does not submit to the rules of the financial markets, is a country which will pay the price," an IMF stooge told *CNN* lately. President Estrada blindly followed this dictum to the letter and ran "a government which does not get in the way of investors". But his unabashed cronyistic practices terribly upset his handlers. He has to go—with or without bloodshed. Thus, Vice-President Gloria Macapagal-Arroyo's ascendancy to the top position of the land is just a matter of time.

The electorate, however, is cautioned against prematurely celebrating Arroyo's impending presidency. She may yet go the way of Alexander Kerensky's "transition government" in Russia, just before the Bolshevik takeover. Because of her track record of supporting globalist initiatives like free trade, deregulation and privatization, Arroyo is viewed by nationalist economists as "the female counterpart of Mexico's Vicente Fox". The latter was backed by London and Wall Street financial interests, and also got a quiet endorsement from the Trilateralist-controlled U.S. government as well. Unless she proves otherwise, Arroyo is perceived to be using the "political revolution" just to "fan the free-market revolution" which I believe is not true.

Madam Vice-President Gloria Macapagal-Arroyo must guarantee that, under her administration, certain kinds of business activities ought to be prohibited, such as buying stocks in credit, and also hostile corporate takeovers.

"Every single mega-merger is a relapse into the Stone Age," says Wilhelm Hankel, former chief economist at the Bank of Reconstruction. Such assertion is not new. In the 1940s, economist Josef Schumpeter emphasized that, contrary to what Karl Marx wrote, "The real road to socialism leads through a process of monopolization." And this is taking place right now.

Meanwhile, we must expect the worst. Everything is not going to be a "walk in the park", as Americans love to say. A bloody civil war could break out, as battle lines are now being clearly drawn. A division between supposed Amarillos of EDSA 1986 vintage on the Arroyo side and supposed Marcos "Loyalists" of the Estrada government, is already being encouraged from several sides. This is the apparent intent of the globalist Mafia which is out to dismantle the nation-state and to conserve the international tyranny of free trade, through "democratic" bread and circuses.

The globalist puppet-masters have come to realize that the only way they can plunge the country into a bloody civil war is to adopt the Mexican scenario (not the Indonesian one) in the 19th Century, and in the 1920s and 1930s, here in the Philippines. This is the old Venetian tactic of manipulating patriots on both sides of a fraudulent dividing line between "the corrupt and reactionary forces" (linked to the various churches) and the liberal and progressive anti-clerics of the Estrada regime.

The *Sydney Morning Herald* (one of the newspapers which remembers there’s a place called the Philippines where the natives are even surlier than in Indonesia, and is north of East Timor) ran an editorial headlined: “ESTRADA ON THE ROPES”.

Despite this gloomy description of Erap’s plight, however, the *Herald’s* editors did not condemn him so roundly.

While the editorial started with “President Joseph Estrada of the Philippines is in desperate trouble” and reports that the House of Representatives is beginning debate on a motion to have him impeached “over charges that he accepted millions of dollars in bribes from illegal gambling syndicates” and that there have been “mass defections from his ruling coalition (which) means the Opposition can easily muster the necessary 73 votes in the 218-member chamber to have him tried by the Senate”, it did not predict his downfall.

It concluded: “The question now is whether the anti-Estrada forces will generate the sort of mass passion that toppled the dictatorship of Ferdinand Marcos. Many analysts doubt that they will, or that anything as dangerous is necessary. Recent weeks have seen some attempts to replicate the ‘people’s power’ rallies of 1986—yellow shirts, confetti and rosaries—but the

situation is very different, Mr. Estrada may be a crook but he is not a monster. He may be corrupt and a master of patronage politics, but he was democratically elected. He has said he is prepared to submit to a Senate trial, or a referendum. That was not the Marcos style.”

That’s a fair comment.

Even before the Social Weather Stations (SWS) survey, published yesterday, boosted President Estrada’s sagging morale (he’s reported full of “vim and vigah” and ready to fight back), the United States Department of State has BEEN TRYING TO QUELL SPECULATIONS THAT THE AMERICANS ARE PRESSURING ERAP TO “RESIGN. [D: NOW PLEASE GET SERIOUS.]

Ambassador Mike Malinowski, the U.S. Deputy Chief of Mission in Manila, has stated that the U.S. will not interfere in the internal affairs of the Philippines during the current political crisis. The Americans, Alikabok told me yesterday, have said, in separate meetings with the President and his opposite number, Opposition leader and Vice President Gloria Macapagal-Arroyo, that they will support the constitutional process and will recognize “only duly elected officials” of the Philippine government.

U.S. intelligence representatives, in the meantime, have held discreet meetings with Philippine military officers of “star-rank” and, basically, reiterated to them that it’s best they remain “neutral” and stay put. My spook-chasers inform me that there are about 250 Central Intelligence Agency (CIA) operatives within OUR military. They were first put in place during the former Cory Aquino administration when the Americans became alarmed at the five coup attempts which occurred during her tenure in office. CIA CATCHES FLAK IN PERUVIAN ARMS DEAL

THE U.S. SPY AGENCY GAVE THE OK TO SELL THE WEAPONS—WHICH ENDED UP IN COLOMBIA

WASHINGTON (*NEW YORK TIMES*)—Late in 1998, Jordanian officials went to the chief of the Central Intelligence Agency’s station in Amman with a routine question: Would the United States mind if they sold 50,000 surplus AK-47 assault rifles to the Peruvian military?

The CIA official did a bit of checking and got right back “Our answer was, ‘No, we can live with that,’” an American intelligence official recalled.

What seemed a modest arms deal, however, turned out to be anything but. Last spring, CIA officials told the Clinton administration they had discovered that thousands of the rifles had gone not to Peru but to leftist guerrillas in Colombia. Peru’s longtime intelligence chief, Viadimiro Montesinos, a crucial CIA ally in the region, then stepped forward to take credit for dismantling an international ring that he said had smuggled the guns. But his account of the sale was immediately challenged by officials in Jordan and Colombia who suggested that the Peruvian government was more deeply involved.

Now, after dismissal in September, Montesinos has himself been implicated in the arms deal by the two men who organized it. Peruvian officials are moving to prosecute him in connection with a large personal fortune he apparently had in Swiss banks, and State Department officials are complaining privately that the CIA was slow to tell them about what had gone on.

American officials say the evidence of Montesinos' possible role in the gun running remains unclear. But they say the CIA's handling of the case has raised new questions about the agency's ties to Montesinos, deepening a rift within the Clinton administration over its dealings with an official who has been linked to human-rights abuses and other crimes.

"We don't know for sure that he was involved, but there's a lot of smoke coming from his direction," one administration official said. "We do know that we should have had a lot of the information a lot earlier than we got it."

Intelligence officials, who like others would discuss the matter only on the condition of anonymity [D: Yes, same as always with these "anonymous" dips.], defended the CIA's actions. They said that while the agency may have been slow to uncover what had happened, it informed administration officials promptly after the guns had been traced to Jordan.

While the CIA had worked closely with Montesinos and depended on him to support covert anti-terrorism and drug interdiction programs the United States has operated in Peru since the late 1980s, they said the agency had also reported on his purported misdeeds. [D: Barf!]

Montesinos has not been heard from. He fled to Panama on Sept. 24, after the disclosure of a videotape showing him bribing an opposition legislator forced him to leave the country. When Panamanian officials refused private pleas from the United States and the Organization of American States to grant Montesinos asylum, he suddenly flew back to Peru on Oct. 23 and went into hiding.

After Switzerland's discovery of five bank accounts holding some \$50 million, Peruvian officials announced Friday that they will try to prosecute him for illegally enriching himself during his decade-long tenure as President Alberto Fujimori's most powerful adviser.

BEWARE OF ALLIES

"Target: America." "Terror in the Middle East." "Sneak Attack." "Act of War." The hysterical headlines were routine. An American destroyer was the target of a suicide bomber in the Gulf of Aden, 17 American sailors died, and the media had a big story. How would the president "respond"? (And which candidate would gain?)

Bill Clinton pledged to "find out who was responsible and hold them accountable". We've heard these words so many times, and in this case those who were responsible seemed to have died in the blast. They made themselves accountable in the most direct way.

But nobody really cared. Ordinary Americans know perfectly well that they weren't the targets. A warship, allegedly "their" warship, was. They are vague about why their "defense" forces are scattered all over the globe, but they understand that it's none of their business, really. These foreign policy decisions are made by committees of experts in some Washington office, prattling of "U.S. interests", meaning their own. The rest of us aren't invited to sit in on the meetings. In a democracy, the people are allowed to vote. They have no say in running an empire.

The bombing of the *USS Cole* wasn't a "terrorist" attack. That's just the word Madeleine Albright automatically uses to express her disapproval, in the apparent belief that she can scold her enemies into behaving themselves. No, this was an attack on a military target. The bombers—the "terrorists"—probably had no help from or association with any government.

When governments bomb, it isn't "terrorism". Terrorism is a private-sector affair, usually employing homemade materials. Part of its essence is that it's officially unauthorized. American and Israeli bombs that fall on civilian populations aren't considered terrorist, but counter-terrorist.

The devilish thing about private, unauthorized violence is that the target country's government doesn't know whom to retaliate against—or, as they say, "respond" to. Of course, it can pretend it knows and unload a few bombs to display its "resolve" and "determination", but this is only a gesture. An empire can't afford to look helpless.

There are no fleets of Arab destroyers off the coast of Florida, no Chinese fleets off San Diego. There are American fleets around the world, and they aren't popular. Now and then an incident reminds us of this. And the usual moral is drawn: "The world is still a dangerous place."

Yes, it is, if you go around asking for trouble. And that is what the U.S. government does. There is nothing "defensive" about its enormous military system, at a time when we face no military threat whatever. The only enemies we have are the enemies our government continues to make for us, particularly by meddling in the Middle East. And even so, those enemies can do little damage to us at home; for the most part they can only strike our military and diplomatic targets abroad, though that may change.

Countless people are "anti-American" in the sense that they don't want to be ruled or bullied by this

country and its allies and clients; but they aren't anti-American in the sense that they would wish us ill, let alone try to hurt us, if we minded our own business.

The wisest foreign policy is simply to avoid making enemies. That should be too obvious to need saying, and it used to be this country's policy. It was called "neutrality". But we abandoned it and got into two world wars that created bigger problems than those that caused them.

After World War I, many Americans drew the appropriate lesson: Stay out of foreign wars. They are now censured as "isolationists". That's what you get for having learned from experience.

But isolationism died at Pearl Harbor, when the foolish Japanese attack gave Franklin Roosevelt his wish by plunging Americans into a war frenzy. So far, fortunately, the "terrorist" attacks haven't disturbed our slumbers. Our enemies are real but puny. But our extravagant military supremacy makes war seem a more remote possibility than it really is.

It's not so much our enemies as our allies that we should worry about. Some of them want war, and they will never rest until they can provoke our enemies into provoking us.

[JR: Since we are the world's favorite target wouldn't it be a good idea to go back to being neutral—as we then had more friends and fewer enemies? The day we gained our independence, the plans were set into motion to re-colonize the U.S. by the behind-the-scenes king-makers of Europe. We are now their servants and they again are our masters.]

"PRESIDENT ELECT" TO ANSWER AIDS BIOENGINEERING LAWSUIT

CLEVELAND, OHIO—It's Halloween 2000. In less than seven days Americans choose which presidential candidate will answer lead plaintiff for worldwide AIDS apology lawsuit charging the United States government for its participation in the "creation", "production", and "proliferation" of an ethnic "super germ" known as AIDS. The case, originally filed by Boyd Ed Graves, J.D. on September 1998, concludes the AIDS pandemic is the result of a secret federal virus development program called the "Special" Virus. Naval Academy graduate Graves' eight years of research into the origin of the AIDS resulted in the rediscovery of the research logic flow chart of the program. The top-secret program began officially as early as 1961 to aggressively hunt for a contagious cancer that selectively kills. The discovery of the research logic flowchart coordinates over 20,000 of the program's scientific papers, and led Graves to file his historic lawsuit against

Secretary of Defense William S. Cohen in September 1998 for the laboratory birth of AIDS in Cleveland, OH. After one full year of silence from the federal court, Judge Leslie Brook Wells threw the case out of court, citing the origin of AIDS as "frivolous". While major African newspapers devoted four-page feature stories to the issue, the major American media remains completely silent.

Since March 3, 2000 the class has been waiting for a decision from the sixth circuit court of appeals in Cincinnati. The court has failed to explain the eight-month delay in determining if the issue of AIDS bioengineering is "frivolous".

"Every day a decision is delayed furthers the global AIDS holocaust," said Graves. "The class and the people of the United States require better from the sixth circuit."

With Graves' appeal the people's case took on greater historical significance as the office of The President of the United States was named as lead defendant on March 3, 2000. Graves flew to Washington D.C. hand delivering over 3000 signature petitions to members of Congress and each of the year-2000 presidential candidates demanding bipartisan review of the evidence. Less than sixty days later on April 30, 2000, President Clinton formally declared AIDS a Threat to National Security and in an unprecedented move, placed the National Security Council in charge of AIDS health policy. Neither candidate has mentioned this issue.

Now only seven days before the 2000 presidential election, some voters indicate they will write Graves' name in on election day; sending a direct message to the president elect—"Graves vs. The President of the United States and the evidence of the laboratory birth of AIDS will not go away."

This week Graves released his highly anticipated book *State Origin: The Evidence of the Laboratory Birth of AIDS*, including the research logic flow chart of the government's secret "Special Virus" program and other shocking documents as evidenced in this landmark case.

Today, as the nation celebrates the annual festival of the dead, America is given the unique opportunity to vote for life by never again allowing the greatest democracy in the world to masquerade behind public policies founded in the economics of eugenics.

The next president will have to figure out how a workforce, a third the size of the retired population, will be able to pay social security and Medicare benefits.

The next president, Bush or Gore, will have to deal with these and many more problems that have been ignored for the last eight years. These problems will have to be addressed and the solutions will NOT be painless.

Mutual Funds—No Longer A Safe Haven

With the recent volatility in the U.S. markets, even mutual funds are no longer a safe haven for investors to store their wealth. The typically strong and steady annual gains that many mutual fund investors had become accustomed to, following the boom in the U.S. economy, are not going to greet them at the year's end.

As a consequence of the stock market's weak performance in 2000 and the enormous capital gains taxes from the market spike last winter, many investors will experience flat, even decreasing returns on their mutual-fund investments.

Most of the seasoned mutual-fund investors will not suffer as much from this year's poor mutual-fund performance since many of them have already "reaped the benefits of outstanding performance during that time," stated Vernon Lee, an independent financial planner and head of Lee Investment Consulting.

However, according to Mr. Lee, it will be the new investors, who rode in on the wave of a booming tech-stock economy, "who are going to be shocked...those who got in at the top when the market was peaking." What is going to affect these young fund investors the most will be the impact of the capital gains taxes.

Capital gains taxes are imposed on the profits that are generated by the sale of stocks, bonds, and other investments. The large increases in capital gains taxes were the direct result of fund managers who sold stocks while they were at their peak values in order to generate the most profit for their investors before the stock market setback of last spring. "A lot fund managers realized those heady days wouldn't last forever and took some profits when they had the opportunity," said Burt Greenwald, a Philadelphia-based mutual fund consultant.

The setback comes on the heels of the technology-based NASDAQ stock market plummeting about 16 percent and Dow Jones Industrial average down more than 4 percent during 2000. Even the traditionally strong S&P 500 index posted flat performance, with the Vanguard 500 index fund, a fund that has typically produced double-digit gains, dropping 1 percent in 2000.

The traditional safety offered by mutual funds is rapidly fading as the technology fund niche has finally come crashing down. Investors can no longer rely on a mutual fund's broad base of investments as a safe haven in which to diversify the wealth of their hard work.

Historically, gold has served as a safe haven during periods of economic instability. Gold tends to appreciate in value in response to negative economic conditions and uncertainty. Today there are many reasons for investors to worry about the safety of their investments in such a volatile market. Gold is consistently the asset that can provide true economic security.

SUMMERS WARY ON GLOBALIZATION

DEVELOPING NATIONS MUST BE PROTECTED, HE SAYS

A strong global economy requires restraints on market forces, but the major nations are still debating how to do this, Treasury Secretary Lawrence Summers said Thursday.

"An integrated global economy is essential but it can't just be based on letting market forces operate," Summers said in an interview at the University of Chicago, where he gave a speech extolling the Clinton-Gore economic program.

It is necessary to protect developing countries from unrestrained global capital markets, increase the power of the International Labor Organization, increase global environmental cooperation and spread global technology, Summers said.

There have been suggestions that at least some of this, including labor and environmental protections, could be taken over by the World Trade Organization, the most developed body of global governance. But Summers disagreed.

"It's probably best," he said, "to have a variable architecture, to make progress in a range of different organizations on a range of different questions...."

"It's going to take time," he said. "Trade is too important to leave only to trade negotiators. This has to be worked out in the broader context of how the rules of the economic system operate."

He said there is a role, but a limited one, for some of the non-governmental organizations (NGOs) involved in protests at the WTO meeting in Seattle last year and at other global forums since then.

“We’re finding our way on the role of NGOs,” he said. “These NGOs clearly speak for people that have not been spoken for in the past. They have a great deal of very specific and useful knowledge.

“On the other hand,” Summers said, “these NGOs are not elected nor democratically accountable. We have to be conscious of the need to allow democratically elected governments to represent themselves.”

Summers expressed confidence in a new arrangement between the Securities and Exchange Commission and the Commodities Futures Trading Commission to permit single-stock futures, or trading of futures on individual stocks.

The trading would expose investors to potential unlimited losses, especially if sold by unscrupulous peddlers to unsophisticated investors, critics say. But Summers said the government made sure “that none of these investments become vehicles for eroding the protections that have made American financial markets the most honest... in the world.”

Summers brushed off concerns raised by the New York Stock Exchange, Chicago Board Options Exchange and other securities exchanges.

“There is always tension between new entrants and established incumbents,” he said.

Results of the local elections held in Kosovo under the aegis of the UN and the North Atlantic Alliance are already known. As the leader of the Democratic Alliance of Kosovo Ibrahim Rugova stated yesterday, his party emerged victorious in 17 out of 18 municipal districts of the territory, Pristina and four other main centres of the territory are among them. It should be pointed out that the Rugova party’s main goal is to separate the territory from the Yugoslav Federation and to set up an independent state. Despite the fact that these goals are drastically at variance with the UN Security Council’s resolution 1244 and the Yugoslav constitution, Rugova enjoys active support by officers of the United Nations Organization and the European Union.

Anyway, even before a formal declaration of the election results, both the Head of the UN Mission in Kosovo Bernard Kouchner and the former NATO Secretary-General and the present-day EU Supreme Commissar for external policies and security matters Javier Solana allowed themselves to publicly rejoice over the results received. The former has already managed to declare that he will appoint his representatives to the local councils in the areas mainly populated by the

Serbs, who refused to participate in the elections, to “safeguard their rights”. The latter has noted that the elections held are “an illustration of the fact that the people of Kosovo long for a democratic future”. Solana, who a year ago gave orders to destroy Serbs, stated yesterday that the elections became “historical”.

One could, probably, be glad together with them about tremendous successes of democracy. But you do not feel like it. First of all, for objective reasons which do not allow to qualify these elections as valid and civilised. And the matter is not only that they, as was already mentioned, contradict the UN Security Council’s resolution and the Yugoslav constitution. The main question is whether they are legitimate.

It should be noted that the decision to hold local elections was taken, let’s say, not by the previously elected popular assembly or, which would be fair if the former is non-existent, by the higher legislative assembly or the parliament of the country. They were fixed ... by a UN officer who has no authority for that.

Further: One of the principal conditions for elections to be democratic is the opportunity for everyone who temporarily stays outside his or her territory, to participate in the elections. For instance, not only the citizens staying in the territory of Russia on election day participated in the presidential elections, but also those who left this country for official or personal reasons and obtained the so-called absentee voter certificate. The same was the situation when a Chechen representative to the State Duma was elected. Chechen refugees in the Ingush Republic and representatives of the Chechen community in Moscow took part in the elections. The right to elect and to be elected is exercised in the same way in all civilised states of the world. Observance of this right was not provided for in Kosovo elections. The Serbs, who left the territory as a result of the UN military contingent’s connivance, could not vote whatever their desire. Kouchner decided not to set up mobile polling stations in the refugee camps, referring to the shortage of funds.

What comes out? Even if we disregard yesterday’s statement of the Yugoslav government on the illegal character of the elections, they do not meet the democratic standards in any case. Moreover, no matter how strange it might seem, direct UN, EU and NATO connivance to hold completely monoethnic elections, shows that today these international organisations openly advocate... fascism.

It is this term that characterises what is occurring in Kosovo today. The Serbs, Gypsies, Jews have been ousted from the territory. The UN did not allow them to participate in the elections held. Privilege enjoyed by one nation in respect to others is apparent. What else is a distinctive feature of man-hating ideology? Here it is—treatment of culture. Here again is evidence of the above: *PRAVDA—Ru* published the lists of destroyed religious and cultural sacred places in the Kosovo territory. We also told previously about murders of Christians...

Any sane person will confirm: elections held at gunpoint of foreign tanks can hardly be termed an expression of the free will of the people; such elections can not be recognised as legal. Any sane man is aware of this. Is Javier Solana one of them? Certainly, he is. But it is him who is stained with a great deal of the blood shed in the territory, therefore, it is to his advantage to talk about historical significance of the illegal elections. Is Bernard Kouchner one of them? Certainly, he is as well. The point is, however, that he organised the elections!

One cannot regard Bill Clinton, Tony Blair, Gerhard

Schroeder, Jacques Chirac and many others as sane. One cannot. But they, despite the undemocratic nature of the last elections, will be active in recognising them, because these elections are the fruit of their thinking, the outcome of their actions.

The point is, however, that it is exactly in this way that fascism comes into being, imperceptibly and under general acclaim and in hope that everything will work out in the future. We should draw attention to the fact that, when the brown plague begins to again spread in Europe, the first we are to thank for the revival of fascism are those who are talking these days about “the victory of democracy” in Kosovo...

[JR: The illegally held election by the UN/EU in Kosovo is truly historical—as it implements the rules of the new UN Charter for World Governance. This election arbitrarily dissolved the rights of a sovereign nation, its people and its constitution. A VENEZUELAN CASTRO

The next president of the United States is going to need a strategy toward Venezuela’s Hugo Chávez. That is so because Mr. Chávez, a former colonel who led a failed coup before winning power democratically two years ago, is not just another Latin American strongman. He is a strongman who controls the biggest oil reserves outside the Middle East, who supplies the United States with a good chunk of its energy imports and who seems intent on spreading his brand of leftist anti-Americanism throughout the region.

Mr. Chávez’s role model appears to be Fidel Castro, who concluded a five-day visit to Venezuela on Monday. Mr. Chávez proclaimed that “our two peoples are one and the same,” and strutted about with his mentor in copycat military outfits. Mr. Castro reminisced that the young Chávez government reminded him of the early years of revolutionary Cuba, and dismissed George W. Bush and Al Gore as “little gentlemen” of no substance. As a going-home present, he got a promise of greatly subsidized oil shipments.

Even before this embrace, Mr. Chávez had been conducting the kind of anti-American foreign policy that Che Guevara might have smiled at. He turned the recent OPEC summit into a platform to sound off against the West; he has gone to Iraq to visit Saddam Hussein; he has flirted with the leftist opposition in Bolivia and with Colombia’s drug-peddling guerrillas. Meanwhile, he has used oil to buy influence in Central America and the Caribbean, recently signing a deal to supply 12 countries there with cheap energy.

The next occupant of the White House may be tempted to hope that Mr. Chávez is just posing. After all, the Venezuelan leader is democratically elected; he mixes his wild rhetoric with pragmatic appeals for foreign investment; the U.S. oil industry—whose voice would be especially loud in a Bush administration—has an interest in mollifying him. But Mr. Chávez has now been sounding off against the United States for two years. It would be foolish to assume that he won’t make trouble where he can. One nightmare scenario has him recognizing the legitimacy of a secessionist state declared by the Colombian rebels.

Rather than merely hoping for the best, the next president needs to limit Mr. Chávez’s opportunities to

export his ideology. That means getting more engaged with Latin America, as Mr. Bush has urged, including with the sort of nation-building that he has often disparaged. If Latin America's democracies fail and its economies collapse, popular frustration will create openings for Mr. Chávez and his imitators. But if the United States helps moderate governments succeed, the Chávez rhetoric may not matter.

FIDEL CASTRO: SOUTH AMERICA WILL BE FUTURE POWER

On a five-day visit to Venezuela, the Cuban leader Fidel Castro praised his host, President Hugo Chávez, saying that "I believe that the idea of Chávez is viable, transforming Latin America into a centre of power, so as to create a multipolar world," more just and better balanced than the present state of affairs, with the U.S.A. proclaiming itself as the world policeman.

The historic revolutionary leader went on to say, "with men like Hugo Chávez, Latin America will resist any challenge and will be able to unite itself, to construct a great power base in a new international order".

Questioned about whether South America will be able to resist pressure from the U.S.A. to keep the continent totally dependent upon its aid and, therefore, politically impotent, Castro shouted :

"If a small island can resist and fight for forty years, what would happen if it was the whole continent?"

Cuba and Venezuela have just signed a treaty through which Venezuela sells its crude to Cuba at special rates. Castro has found a strong ally in Chávez, a President who is seeking a new identity for his country and his continent, in a "pluripolar world", to quote Chávez himself.

Castro's revolution in Cuba in the 1950s freed his people from the corrupt, Mafia-controlled regime of Fulgencio Baptista. The Florida Mafia declared revenge on Castro and the anti-Castro lobbies in the United States have been active, trying to find ways to oust or assassinate the historic leader of nearly half a century—he was elected prime minister for the first time on January 2, 1959. Loved by his people, this truly popular figure has managed to build a pluralist and truly democratic society, based upon the principles of Communism. Now, as he looks to the future, beyond his death, Fidel Castro is as always true to his warcry.

FBI AGENT SUES TO REVEAL AGENCY MISCONDUCT

WASHINGTON (AP)—A 20-year veteran FBI agent went to court Friday seeking the right to report to President Clinton and key members of Congress what he considers serious and criminal misconduct by federal workers during a top-secret, undercover national security operation.

FBI Director Louis Freeh and Deputy Attorney General Eric Holder have denied agent Joseph G. Rogoskey permission to relay his allegations to Clinton, Secretary of State Madeleine Albright and House and Senate committees that oversee the FBI.

In a lawsuit against the FBI and Justice Department, Rogoskey said that as an undercover agent he "witnessed acts of serious misconduct and violation of federal law by employees of the federal government during the course of their employment."

Justice Department and FBI spokesmen did not immediately respond to requests for comment.

Now on paid administrative leave, Rogoskey spent 12 years, 1987 through 1998, on top-secret operations involving information among the government's deepest secrets, accessible only to specified people.

Rogoskey is barred from telling his lawyer, Stephen Kohn, any details of the operation or the alleged misconduct. Kohn said he understands only that "it doesn't involve anyone stealing money. It involves what they were ordered and permitted by the government to do in this operation."

Like the FBI, Holder advised Rogoskey by letter that he should report "whistle-blower-type allegations" to internal FBI investigators or Justice inspector-general agents who "have the appropriate security clearances".

But Kohn said, "Keeping whistle-blower allegations within the institution that authorized the misconduct does not serve the public interest and raises grave constitutional questions."

Rogoskey first reported his allegations to his immediate supervisor in late 1997, "promptly upon observing them," Kohn said. "We don't know if the FBI has fixed the problem," Kohn said, because Rogoskey has been on leave since the summer of 1998.

Since making the allegations, the FBI has retaliated against Rogoskey, the lawsuit said. The suit said this included an allegation of misconduct against Rogoskey, of which FBI investigators cleared him; efforts by superiors "to call into question his integrity"; and recently threatening to fire him for medical reasons if he fails a fitness-for-duty exam.

"Fitness reviews are extremely intrusive," Kohn said. "They include psychiatric exams, interviews with his wife and examination of his sex life."

A fitness exam was ordered of another FBI whistle-blower client of Kohn's, Frederic Whitehurst, the FBI chemist whose allegations led to an inspector-general's finding the FBI Laboratory engaged in sloppy science and gave biased testimony for the prosecution.

"Even though Whitehurst was found fit, the FBI tried to discredit him with material from the fitness exam," Kohn said.

Kohn said Rogoskey has applied for workman's compensation because two doctors concluded he suffers from post-traumatic stress disorder caused by his work. "He has work-related injuries because they kept him undercover too long and from the retaliation," Kohn said.

FBI officials have said that agents who spend

long periods undercover can suffer tensions from maintaining dual personalities.

In the lawsuit, Rogoskey asked the U.S. District Court here to decide whether he can transmit his allegations to Clinton, Albright and congressional oversight committees, to bar the government from retaliation and to process his workman's compensation claim instead of ordering a fitness review.

Because of secrecy rules, Rogoskey submitted his allegations in a sealed envelope to the FBI's publication review clearance board in May 1999.

The agent had no publisher, wasn't seeking compensation and did not intend to publish the material for the general public, but wanted permission to send it to the named officials, Kohn said.

FBI attorney Lyn Brown "denied the permission the next day by phone and said the information in the envelope should have been transported by armed guard," Kohn said. Freeh and Holder later upheld that denial.

[JR: Anyone who has the courage of a Mr. Rogoskey is in for a battle for his life. He has taken on an administration that is rife with secrets and intrigues that are protected from disclosure by the very same agencies whose job it is to look into these matters. DIGITAL ANGEL UNVEILED

Human-tracking subdermal implant technology makes debut

A NASDAQ-traded company has finally unveiled its long-touted and highly controversial "Digital Angel"—a subdermal microchip implant designed not merely for keeping tabs on pets, but for widespread, worldwide use in tracking human beings.

The high-tech device, engineered by Applied Digital Solutions, Inc. had its debut Monday before an overflow crowd of more than 300 invited guests at Cipriani 42nd Street in New York City.

The audience included U.S. Secretary of Commerce Norman Mineta, who addressed the crowd, as well as other government officials, potential joint-venture/licensing partners and press representatives.

Richard J. Sullivan, Applied Digital Solutions' chairman and CEO, waxed eloquent about the market potential of Digital Angel, claiming the company has "uncovered a total marketplace that is conservatively estimated to exceed \$70 billion."

Randy Geissler, chairman and CEO of Digital Angel.net Inc., a wholly owned subsidiary, zeroed in on potential applications.

"Our analysis shows that we are well-positioned to move quickly into certain applications while developing a number of others. Two areas of particular interest are in the healthcare arena," he said, "monitoring heart disease and respiratory disease patients." The tracking and monitoring of pets, he added, are also "right up our alley."

The demonstration, which was conducted by Dr. Peter Zhou and Dr. Keith Bolton, showed how Digital Angel "can be used to monitor a person's key body functions—such as temperature and pulse—and transmit that data wirelessly, on a real time basis, along with the accurate location of the person, to a Web-enabled ground station or monitoring

facility,” according to a press statement.

The technology consists of a miniature sensor device, designed to be implanted just under the skin, that captures and wirelessly transmits the “wearer’s” vital body-function data, such as body temperature or pulse, to an Internet-integrated ground station. In addition, the antenna receives information regarding the location of the individual from the GPS satellite. Both sets of data—medical information and location—are then wirelessly transmitted to the ground station and made available on Web-enabled desktop, laptop or wireless devices.

A more sophisticated version of microchip technologies currently used as electronic ID tags for pets, Digital Angel is powered electromechanically through muscle movement, or it can be activated by an outside monitoring facility.

As *WorldNetDaily* has reported, in addition to locating missing persons and monitoring physiological data, Digital Angel will be marketed as a means of verifying online consumer identity for the burgeoning e-commerce world.

In August, Sullivan told *WND*, “We are currently talking to a watch maker who is interested in placing the device on the back of their watches.” He added that “technology is being developed that would allow Digital Angel to function from the back of a cellular phone, transmitting bio-sensor information when carried by the user.”

And in an interview last March, the chief scientist, Zhou, told *WorldNetDaily* he believes the implant will be as popular as cell phones and vaccines.

Digital Angel “will be a connection from yourself to the electronic world. It will be your guardian, protector. It will bring good things to you,” said Zhou.

“We will be a hybrid of electronic intelligence and our own soul,” he added.

[JR: This implant certainly does have great potential for future application. It will not only monitor your body functions but also your activities and behavior. This digital “angel” (??) may start out as a benign program as your guardian and protector but may turn into your jailer and controller. How else can this company project a \$70 billion market potential if Big Brother isn’t going to buy into it?]

PUTIN APPROVES MORE PROBES INTO STALIN REPRESSION

Inside Russia, 11/3/00

MOSCOW (*Reuters*)—President Vladimir Putin gave the go-ahead on Thursday for deeper probes into the fate of millions of people summarily killed or sent to the Gulag camps during the rule of Soviet dictator Josef Stalin, *RIA* news agency said.

Alexander Yakovlev, father of Mikhail Gorbachev’s “glasnost” campaign to allow more public transparency in the 1980s, said after meeting Putin that the ex-KGB officer felt the need to thoroughly investigate two decades of Stalinist repression. **[We’ll sleep much better, knowing that.]**

“He takes to heart this tragic period of our history,” Yakovlev, who also heads the Presidential Pardons Commission dedicated to reviewing millions of arbitrary verdicts in the 1930s and 1940s, told *RIA*.

Yakovlev, a senior member of the ruling Communist Party politburo under Gorbachev, said Putin had agreed with his proposal to give the commission a broader scope.

The president also favored including officials from the Interior Ministry, the FSB domestic security

service, the Defense Ministry and other institutions whose archives could help the research.

Yakovlev said the commission would comb through newly obtained material to establish “how many people were ground down by the bloody mill” of Stalin’s regime.

Mass executions and imprisonment by the NKVD, precursor to the KGB secret police, have been publicly condemned in Russia since Gorbachev’s time.

But none of the perpetrators has faced trial, and investigations have centered mostly on rehabilitating the victims.

Yakovlev said his commission, set up in 1989 as glasnost was gaining pace, has rehabilitated more than four million people, some 800,000 of whom are still alive.

Half a million cases are waiting to be examined, he said.

“But many more people have been executed anonymously, starved or died of diseases in the camps,” Yakovlev said.

[JR: It would have served the victims of this bloody era better if the officials who carried out Stalin’s purges were identified and prosecuted. Why didn’t Glasnost accomplish that during Gorby’s tenure? Maybe those same people are connected to the Elite now in power? NEW AIR FORCE SQUADRON TRAINS FOR SPACE-BASED AGGRESSION

SCHRIEVER AIR FORCE BASE, COLORADO—Air aggressor squadrons are not new. Since the creation of the Air Force, these flying squadrons have played the villain of the exercise scenario, attacking fellow blue-suited pilots in war exercises to train them as effectively as possible for the time when they had to go up against the real thing. By using the doctrines and technology the enemy has and utilizing them, these aggressor squadrons sharpen our sense of the enemy’s abilities and how to counteract them. The long-used nickname for these aggressors is “Gomers”.

Now the Air Force has followed that legacy into the future—into the deep reaches of space.

The 527th Space Aggressor Squadron, under the Space Warfare Center at Schriever, became the first space aggressor squadron in history Oct. 23 in a ceremony at Peterson AFB, Colo.

“There have been a number of different aggressor squadrons, but this is the first time that space has stepped into the arena,” said Lt. Col. ‘Rad’ Widman, the first commander of the squadron. “This is a major step in bringing defensive and offensive counterspace capabilities to the fight. It’s also a new opportunity for Space Command to slip out and play with the rest of the combat air forces on an equal footing.”

The threat of space assets being used against American and allied forces is a relatively new concern for war planners. The space aggressors were created nearly two years ago to study the potential threat of enemies using commercial space assets against the U.S. military. They took the roles of exercise opponents April 1999 and have since been inundated with requests to participate at exercises. The scope of their job propelled the 52-person shop from being a minor branch at Schriever’s SWC, eight miles east of Colorado Springs, into squadron status.

Their mission is similar to the air aggressor

squadron without the aircraft—to make the Air Force warrior realize how much they depend upon space assets and how to counteract the enemy’s attempts to thwart the use of those assets.

“We are what, in this business, are commonly referred to as Gomers,” Widman said. “Gomers are not the enemy, but we replicate them. Gomers have to be the best. We know what the capabilities of blue forces system are, and we must also be experts at employing enemy systems.”

The squadron is divided into four functional areas: the Imagery Exploitation Flight, the Electronic Warfare Flight, the Red Attack Flight and the Space Control Flight.

The Imagery Exploitation Flight explores the Internet for the commercial satellite imagery available to anyone with a computer and a credit card. Commanders on the ground are often astonished at the detail and accuracy of the images.

“The commander becomes very sensitive to that fact that the adversary has a much clearer picture of what U.S. forces are trying to do,” Widman said. “They can find out where planes, depots, soldier barracks and perimeter fences are. It could be done with untrained analysts downloading commercial imagery.”

“They’re extremely surprised at the detail of the images,” noted Master Sgt. John Weeber. “It’s a new potential threat that we in the military are going to have to deal with.” He added that with more and more sensitive systems online, foreign governments, previously without this capability, are now finding they can buy a bird’s eye view of U.S. installations by simply having a credit card.”

The Electronic Warfare Flight uses known adversary technology to jam U.S. systems using the Global Positioning System and satellite communications during exercises. Once more, they only use the equipment and doctrine known to be in potential adversaries’ hands.

“A SATCOM (satellite communications) jammer can be placed anywhere in the satellite’s footprint (the area the satellite covers as it passes over the Earth) and if we can find the frequency they’re on, we simply put another signal on that frequency and they’ve lost their satellite communications. We’re using satellite communication equipment that can be leased or purchased by anyone,” Widman said.

“Since many of our systems depend on GPS for timing and navigation accuracy, we will also deny the use of GPS to blue forces. The intent will be to sharpen their skills for detecting and countering these effects.

The Red Attack Flight coalesces these disruptive abilities and makes a feasible plan to direct them against the regular Air Force’s command-and-control capabilities during an exercise.

“We ask them before we begin ‘How much pain do you want?’” the lieutenant colonel said. “We’re not out to wreak havoc on them just for the sake of wreaking havoc. We want to show them what they’re likely to realistically encounter. As a squadron, we will only play within the certified boundaries of what we know the opposition’s tactics and capabilities are. We can replicate any adversary with space capabilities. And if we do it correctly, blue forces will build countermeasures for air and space superiority as the commander has intended. It makes for a more efficient and effective force.”

Widman said the intent from the Pentagon and Space Command headquarters in Colorado Springs is to pull together his aggressors with air and information warfare aggressor squadrons to create a “full spectrum” opposition force that would mirror the

realistic space abilities of an enemy today.

The squadron flexed its muscles recently at the Joint Expeditionary Force Experiment this year with jamming scenarios. This resulted in a checklist for communications operators to counteract the jamming. The “lessons learned” portion of the exercises falls under the Space Control Flight, which will develop the countermeasures, new tactics and procedures to protect from a space-based onslaught. In August of next year, they will join air aggressors for the first time in an attempt to disrupt the “blue force” operations in Red Flag at Nellis AFB, Nevada.

The squadron will pick up the heritage of the 527th Air Aggressor Squadron, which was based in RAF Alconbury, U.K., for much of its mission and inactivated at RAF Bentwaters, U.K., almost 10 years ago. That squadron flew F-5s and F-16s for their missions.

“There’s a legacy of getting our forces ready for the Cold War and Alconbury did a great job preparing them,” Widman said. “We’re excited about carrying that mission forward in Space Command. That mission is to prepare our forces by playing the enemy. Because if we forego the capabilities that the enemy has, it could mean a space Pearl Harbor.”

[JR: These simulated battle training exercises are only as good as the intelligence we have on our various enemy’s abilities—and that includes international terrorists. Let’s hope it has improved since we targeted the Chinese Embassy in Belgrade. U.S. Blue (good guys) conduct these practice exercises of mock battles with the “Gomers” (red menace) to protect Earth, space, the universe and beyond. Let us hope this battle simulation for space stays a training game, otherwise GCH may have to get involved.]

BRITISH GOVERNMENT
SPEEDS PAYMENT OF FLOOD RELIEF

LONDON (AP)—With water levels peaking Saturday in the northern city of York at the highest mark since at least 1625, the government announced emergency steps to deal with severe nationwide flooding.

Following an emergency Cabinet meeting, Deputy Prime Minister John Prescott said the government would streamline financing of local-level flood relief to ensure resources are available ahead of more rain expected Sunday.

The government also approved an extra \$76.5 million for flood defenses in England over the next four years.

“This will not alleviate all the suffering and disruption, but I believe it will help people and local authorities cope with a very difficult situation,” Prescott said.

An intense storm front battered Britain earlier this week, unleashing high winds and torrential rain that plunged road and rail transport into chaos. After the storms passed, rainwater steadily drained into the nation’s rivers, causing the worst flooding in more than 50 years.

In York, about 200 miles north of London, the River Ouse peaked Saturday just short of the top of the emergency flood barrier. The level—17 feet, 8 inches—was an inch higher than a 1625 flood, the Emergency Agency said.

The agency said some improvement was expected this weekend in the city. But more heavy rain—up to two inches—was forecast for parts of England on Sunday.

David Atkinson of the York City Council said 3,000 homes had been put on evacuation alert Friday night but only 100 people needed to be evacuated.

The agency said the River Severn was approaching a peak in the western city of Gloucester, where about 20 homes had been flooded.

[JR: People in the U.S. who have themselves been victims of flooding can understand what the people of York are going through. This is the worst flooding in Britain in 375 years. Earth changes and the severe environmental conditions are on the increase. Daley, has his brother William as the Gore Presidential Campaign Chief. In previous stories, I have written about Federal Emergency Management Agency. FEMA officials, some of whom are also federal judges, such as in Chicago [unconstitutional, right?], have reportedly been communicating with the two Daleys. They demand “cooperation”, implied as a threat. That is, that the Mayor and his brother not stand in the way of the FEMA officials orchestrating the outcome. As we have pointed out in 1991 in federal court, and in my previous posting, FEMA is ABOVE the *U.S. Constitution*, ABOVE the presidency and the Congress [unconstitutional, right?].

2. The Florida presidential vote matter is to be submitted, under Florida law making it mandatory, to an automatic recount because of the closeness of the alleged result. Vote fraud has been raised. [What about the TV and radio networks OWN VOTE FRAUD through their “votescam” computer in New York?] The recount matter would take at least until after February, at the earliest, making the usual Presidential inauguration cancelled. Some thought President Clinton was hallucinating, when months ago he said he is not leaving the White House even after the year 2000 Election. If the recount is challenged in Court, the matter would go on, according to my estimate, to April or June, 2001, at the earliest.

WASHINGTON'S NIGHTMARE: THE RISE OF EUROPE

Globalization is not going to happen. Borders are not about to come down; states are not about to disappear; U.S. corporations are not about to take over the world. The moment of global U.S. supremacy has come and gone. The world is dividing into geopolitical power blocs. The United States today confronts a superpower rival stretching across much of the Eurasian landmass—the European Union allied with Russia. The European Union, once merely a trading bloc, then a single internal market has evolved into a political federation, aspiring to its own foreign and defense policy. Now it is threatening to make Russia's vast energy and mineral resources its own. This is the stuff of Washington nightmares.

Since the Second World War, successive U.S. Administrations have championed the cause of European unity. They never took the idea terribly seriously, of course. The Europeans had been fighting one another for centuries. They were hardly likely to become peace-loving nations now. By European unity Americans meant little more than the creation of institutions to facilitate compliance with Washington's commands. Rather than having a dozen capitals to call, the President of the United States could convey his wishes with a single phone call to Brussels. The European Economic Community—as it was once known—was seen as a mechanism to ensure that the Europeans paid their share of NATO's costs and did not wander off the

reservation pursuing their own separate foreign policies.

Throughout the Cold War, any assertion of European independence was met by U.S. threats to withdraw from NATO. It was all a bluff, of course, and the Europeans knew it. The Americans were not stationing hundreds of thousands of troops on the European continent out of the kindness of their hearts. Washington had always regarded NATO as a mechanism to ensure U.S. supremacy over potential economic and political rivals. Nonetheless, the Europeans went to some trouble to avoid antagonizing the United States by overt displays of independence. The Soviet Union was still around, and no one in Europe wanted to shell out large sums of money on defense. This suited Uncle Sam just fine, and thus was a relationship of mutual dependence born. Europeans lived comfortably and America got to be "leader of the free world".

The end of the Cold War inevitably brought all this to an end. There was now nothing to stop the Europeans from asserting their independence. While the U.S. subsidy was still nice, there was no real need for it any longer. Europeans could make do with a much smaller defense budget, one that even they could afford. The economic rivalries that had been suppressed for the sake of Allied unity during the Cold War broke out into the open. As individual nation-states the Europeans could not possibly challenge the Americans. They were too small and vulnerable for that. But as member-states of the European Union they comprised a Great Power. I wrote last week about the multiplying trade disputes between the two continents. The World Trade Organization has served to increase the ferocity of these fights, since everyone ignores its rulings. Indeed, it can only be a matter of time now before either the United States or the European Union pulls out of the WTO altogether. The U.S. claims that the EU gives preferential treatment to bananas imported from its former Caribbean colonies. The WTO ruled against the EU. The Europeans ignored the ruling; the U.S. unilaterally imposed sanctions. The United States claims the EU unfairly restricts imports of hormone-treated beef. The WTO ruled against the EU; the EU ignored the ruling; the U.S. imposed sanctions. The EU claims the U.S. subsidizes the exports of its multinationals, through the creation of so-called "foreign sales corporations"—paper companies that U.S. exporters have been allowed to set up abroad for the purpose of claiming breaks on their U.S. tax bills. The WTO ruled in favor of the EU; the U.S. ignored the ruling; the EU imposed sanctions. Now the U.S. is claiming that the EU subsidizes Airbus Industrie, Boeing's chief European rival. Recently, the United States proposed to the World Trade Organization that governments change the way they subsidize farmers. Under the plan, the current domestic subsidies system would be revised to eliminate those agricultural subsidies not directly linked to price and volume of output. There also would be a ceiling on the level of domestic subsidies based on a percentage of the country's total agricultural production. The Europeans strongly object to this proposal. The EU pays farmers not to farm. On the other hand, the Europeans claim that the U.S. also subsidizes its farmers through the annual disbursement of "emergency aid".

Alongside these economic rivalries are the political disputes. The United States is supporting Kosovo's right to secede from Serbia. The Europeans oppose it. There is little enthusiasm for a Greater Albania—a state that would do for global criminal enterprise what Khomeini's revolution did for the revival of Islam. Yet the Americans continue to push for it. The Europeans suspect that the

U.S. objective is to create problems for them down the road. According to *The Guardian* "independence [is] fast becoming a reality on the ground because almost half the Kosovan Serbs had left the province and the Kosovo Albanians were setting up their own judicial and political system." The paper quotes a senior U.S. official explaining: "Kosovo will not be pushed back into Serbia." The same official goes on to argue that while *UN Security Council Resolution 1244* "explicitly recognizes the territorial integrity of Yugoslavia... it does not mean Kosovo cannot be independent." The level of dishonesty on the part of the United States is breathtaking. The secession of Kosovo is being justified on Realpolitik grounds: The Albanians want no part of Serbia, so it is pointless to insist that they stay. Yet this tough-minded realism does not apply to the Bosnian Serbs who want no part of the bogus state of Bosnia, preferring to belong to Yugoslavia. Nor does it apply to the Kosovo Serbs in the northern part of the province. They also would prefer to belong to Yugoslavia.

Most outrageous of all, the Security Council Resolution states unambiguously that Kosovo is part of Yugoslavia. But to U.S. officials a decision that every country in the world has given its assent to is merely a scrap of paper, to be ignored whenever convenient by a piece of lawyerly legerdemain. This is the kind of dishonesty that drives Europeans—and just about everyone else—up the wall. It is of a piece with Vice President Al Gore's claim that building a national missile defense system would not violate the *1972 ABM Treaty*. The idea is absurd. On both Kosovo and on the *ABM Treaty*, the Europeans are in agreement with the Russians and in strong opposition to the United States.

Actually, the Europeans and the Russians agree on many other issues as well. They are both opposed to any further expansion of NATO. They are both much more sympathetic to the Palestinian cause than the United States. The Russians and the Europeans (with the exception of Britain) have for years urged that the sanctions on Iraq be eased. The Russians recently ended the embargo on air flights to Baghdad. The Europeans are likely to follow suit before long. The Russians announced recently that they did not consider the UN air embargo to be justified under the UN resolutions. Soon after, a Russian plane, carrying humanitarian supplies and a delegation of oil officials and politicians, landed in Baghdad. The Russians are almost certainly correct in their interpretation of the Security Council Resolutions. They did not bar commercial airline flights. The ban was merely something the United States insisted on. As a result, Iraq has been without regular airline service for a decade. The Russian airline Aeroflot is also planning to reopen offices in Baghdad in anticipation of resuming flights. The French also made a flight to Iraq recently. Aboard were about 60 French doctors, artists and sports personalities. The United States demands that these flights to Iraq cease. But its influence over the Europeans diminishes daily. During the Cold War, there was the standard threat to pull out of NATO and let the Europeans face the Russians on their own—"agonizing reappraisal" in John Foster Dulles's famous words. But what can Washington threaten now? To pull out of the Balkans? That would be a dream come true for most Europeans.

Incidentally, Iraq handsomely repaid European generosity the other day. Saddam Hussein threatened to withdraw his oil exports from the world markets unless Iraq's customers paid him in euros instead of dollars. He called the dollar "enemy currency". The dollar is, of

course, the traditional currency of the oil trade. Iraq then asked the United Nations to create a euro-denominated account to handle the deposits. He is sticking with the euro even though interest rates on euro-denominated accounts are lower than those on dollar accounts. The UN oil-for-food deal lets Iraq sell oil over a six-month period on a renewal basis to buy food, medicine and other humanitarian goods. Iraq did back down slightly a few days later by promising to continue to accept payment in dollars for the time being. But this is likely to be a temporary respite. For the Europeans Saddam Hussein's gesture was a timely boost for the euro.

The Europeans and the Russians recently signed a number of important agreements. They comprise what is coming to be called a "strategic partnership". Russia will supply Europe with oil, gas and electricity. In return Europe will invest in Russia's fuel production and transport industries. The European Union would oversee the construction of pipelines to transport oil and gas to the West. The project is due for completion in 2020. Currently, Europe imports 75 percent of its oil from OPEC. The Europeans are anxious to reduce this. They want no repetition of the recent massive protests against soaring oil prices. Russia has abundant energy resources. Geologists estimate that the oil reserves of Komi, a Russian republic in the Arctic less than 700 miles from Moscow, could supply the entire planet for 12 years. The Komi reserves are thought to be about 126 billion barrels. At today's prices of roughly \$32 a barrel, the oil is worth around \$4.032 trillion. This week, Russian gas giant Gazprom announced it was forming a new consortium with leading gas companies from Germany, France and Italy to build a \$2-billion pipeline for gas exports that will bring an extra 60 billion cubic meters of natural gas supplies to the European Union every year.

The other day, former Treasury Secretary Robert Rubin delivering the same speech he and his colleagues have been delivering for the better part of the last decade: "The key for the euro is for Europe to undertake the structural, regulatory, open-market reforms that will make Europe more attractive for investment and attract capital inflows rather than experiencing capital outflows." "Eurosclerosis", the "European basket case"—we have been hearing these complacent assertions backed with very little serious evidence for years. Leave aside the issue of how a power that runs a record trade deficit presumes to lecture a power that runs a trade surplus. The important question is this: What will happen—as it inevitably must—when the U.S. stock market takes a tumble? With no capital flowing into Wall Street, the trade deficit will be unsustainable. Therefore, either the dollar collapses—this will lead to inflation. Or the Fed raises interest rates in a big way—this will lead to a recession, more likely a depression. The European economy, not as dependent as that of the U.S. on the stock market, will be in not bad shape to deal with such a crisis. We will see then just how far the Europeans and the Americans will be prepared to take their rivalry.

WHAT DID EZRA POUND REALLY SAY?

From 1945 through 1958 America's iconoclastic poet—the flamboyant Ezra Pound, one of the most influential individuals of his generation, was held in a Washington, D.C. mental institution, accused of treason.

Pound had merely done what he had always done—spoken his mind. Unfortunately for Pound, however, he had made the error of criticizing the American government in a series of broadcasts from Italy during World War II. For that he was made to pay the price.

The July 1995 issue of *The Barnes Review* told the story of Pound's travails. Here, however, *TBR* presents a fascinating in-depth overview of precisely what Pound had to say in those now-infamous broadcasts. Was Pound a traitor—or a prophet? Read his words and judge for yourself—**By Michael Collins Piper**

American students have been taught by scandalized educators that famed American poet and philosopher Ezra Pound delivered "treasonous" English-language radio broadcasts from Italy (directed to both Americans and to the British) during World War II. However, as noted by Robert H. Walker, an editor for the *Greenwood Press*: "Thousands of people have heard about them, scores have been affected by them, yet but a handful has ever heard or read them."

This ignorance of Pound's most controversial political rhetoric is ironic, inasmuch as: "No other American—and only a few individuals throughout the world—has left such a strong mark on so many aspects of the 20th Century: from poetry to economics, from theater to philosophy, from politics to pedagogy, from Provencal to Chinese. If Pound was not always totally accepted, at least he was unavoidably there."

One critic called Pound's broadcasts a "confused mixture of fascist apologetics, economic theory, anti-Semitism, literary judgment and memory". Another described them as "an unholy mixture of ambiguity, obscurity, inappropriate subject matters [and] vituperation," adding (grudgingly) there were "a few pearls of unexpected wisdom".

Despite all the furor over Pound's broadcasts—which were heard between January of 1941 through July of 1943—it was not until 1978 that a full-length 465-page compendium of transcriptions of the broadcasts was assembled by Prof. Leonard Doob of Yale University in association with aforementioned *Greenwood Press*. Published under the title *Ezra Pound Speaking—Radio Speeches of World War II*, the volume provides the reader a comprehensive look at Pound's philosophy as it was presented by the poet himself in what Robert Walker, who wrote the foreword to the compendium, describes as "that flair for dramatic hyperbole".

What follows is an attempt to synthesize Pound's extensive verbal parries. Most of what appears here has never been printed anywhere except in the compendium of Pound's wartime broadcasts. Thus, for the first time ever—for a popular audience—here is what Pound really

had to say, not what his critics claim he said.

When he was broadcasting from Italy during wartime, Pound evidently pondered the possibility of one day compiling transcriptions of his broadcasts (or at least expected—quite correctly—that one day the transcripts would be compiled by someone else). He hoped the broadcasts would show a consistent thread once they were committed to print.

Pound recognized relaying such a massive amount of information about so many seemingly unrelated subjects might be confusing to listeners less widely read than he. However, the poet also had very firm ideas about the need of his listeners to be able to synthesize the broad range of material that appeared in his colorful lectures.

Pound was sure his remarks on radio were not seditious, but were strictly informational and dedicated to traditional principles of Americanism—including the *Constitution*, in particular. In response to media claims that he was a fascist propagandist, Pound had this to say: "If anyone takes the trouble to record and examine the series of talks I have made over this radio, it will be found I have used three sorts of material: historical facts; convictions of experienced men, based on fact; and the fruits of my own experience. The facts... mostly antedate the fascist era and cannot be considered as improvisations trumped up to meet present requirements. Neither can the beliefs of Washington, John Adams, Jefferson, Jackson, Van Buren, and Lincoln be laughed off as mere fascist propaganda. And even my own observations date largely before the opening of the present hostilities.

"I defend the particularly American, North American, United States heritage. If anybody can find anything hostile to the *Constitution of the U.S.A.* in these speeches, it would greatly interest me to know what. It may be bizarre, eccentric, quaint, old-fashioned of me to refer to that document, but I wish more Americans would at least read it. It is not light and easy reading but it contains several points of interest, whereby some of our present officials could, if they but would, profit greatly."

Pound's immediate concern was the war in Europe—"this war on youth, on a generation"—which he described as the natural result of the "age of the chief war pimps".

He hated the very idea that Americans were being primed for war, and on the very day of Pearl Harbor he denounced the idea that American boys should soon be marching off to war: "I do not want my compatriots from the ages of 20 to 40 to go get slaughtered to keep up the Sassoon and other British Jew rackets in Singapore and in Shanghai. That is not my idea of American patriotism," he added.

In Pound's view, the American government alliance with British finance capitalism and Soviet Bolshevism was contrary to America's tradition and heritage: "Why did you take up with those gangs?" he rhetorically asked his listeners. "Two gangs. [The] Jews' gang in London, and [the] Jew murderous gang over in Moscow? Do you like Mr. Litvinov? [Soviet ambassador to Britain Meyer Wallach, alias Litvinov, born 1876.—Ed.] "Do the people from Delaware and Virginia and Connecticut and Massachusetts... who live in painted, neat, white houses... do these folks really approve [of] Mr. Litvinov and his gang, and all he stands for?"

There was no reason for U.S. intervention abroad, he said: "The place to defend the American heritage is on the American continent. And no man who had any part in helping [Franklin] Delano Roosevelt get the United States into [the war] has enough sense to win anything... The men who wintered at Valley Forge did not suffer those months of intense cold and hunger in the hope that... the

union of the colonies would one day be able to stir up wars between other countries in order to sell them munitions.”

What was the American tradition? According to Pound: “The determination of our forbears to set up and maintain in the North American continent a government better than any other. The determination to govern ourselves internally, better than any other nation on Earth. The idea of Washington, Jefferson, Monroe, to keep out of foreign shindies.”

Of FDR’s interventionism, he declared: “To send boys from Omaha to Singapore to die for British monopoly and brutality is not the act of an American patriot.” However, Pound said: “Don’t shoot the President. I dare say he deserves worse, but... [a]ssassination only makes more mess.”

Pound saw the American national tradition being buried by the aggressive new internationalism. According to Pound’s harsh judgment: “The American gangster did not spend his time shooting women and children. He may have been misguided, but in general he spent his time fighting superior forces at considerable risk to himself... not in dropping booby traps for unwary infants. I, therefore, object to the modus in which the American troops obey their high commander. This modus is not in the spirit of Washington or of Stephen Decatur.”

Pound hated war and detected a particular undercurrent in the previous wars of history. Wars, he said, were destructive to nation-states, but profitable for the special interests. **Pound said international bankers—Jewish bankers, in particular—were those who were the primary beneficiaries of the profits from war.** He pulled no punches when he declared: “Sometime the Anglo-Saxon may awaken to the fact that... nations are shoved into wars in order to destroy themselves, to break up their structure, to destroy their social order, to destroy their populations. And no more flaming and flagrant case appears in history than our own American Civil War, said to be an occidental record for size of armies employed and only surpassed by the more recent triumphs of [the Warburg banking family] the wars of 1914 and the present one.”

Although World War II itself was much on Pound’s mind, the poet’s primary concern, referenced repeatedly throughout his broadcasts, was the issue of usury and the control of money and economy by private special interests. “There is no freedom without economic freedom,” he said. “Freedom that does not include freedom from debt is plain bunkum. It is fetid and foul logomachy to call such servitude freedom... Yes, freedom from all sorts of debt, including debt at usurious interest.”

Usury, he said, was a cause of war throughout history. In Pound’s view, understanding the issue of usury was central to understanding history: **“Until you know who has lent what to whom, you know nothing whatever of politics, you know nothing whatever of history, you know nothing of international wrangles.**

“The usury system does no nation... any good whatsoever. It is an internal peril to him who hath, and it can make no use of nations in the play of international diplomacy save to breed strife between them and use the worst as flails against the best. It is the usurer’s game to hurl the savage against the civilized opponent. The game is not pretty, it is not a very safe game. It does no one any credit.”

Pound thus traced the history of the current war: “This war did not begin in 1939. It is not a unique result of the infamous *Versailles Treaty*. It is impossible to understand it without knowing at least a few precedent historic events, which mark the cycle of combat. No man

can understand it without knowing at least a few facts and their chronological sequence. This war is part of the age-old struggle between the usurer and the rest of mankind: between the usurer and peasant; the usurer and producer; and finally between the usurer and the merchant, between usurocracy and the mercantilist system...

“The present war dates at least from the founding of the Bank of England at the end of the 17th Century, 1694-98. Half a century later, the London usurocracy shut down on the issue of paper money by the Pennsylvania colony, A.D. 1750. This is not usually given prominence in the U.S. school histories. The 13 colonies rebelled, quite successfully, 26 years later, A.D. 1776.

According to Pound, it was the money issue (above all) that united the Allies during the second 20th-Century war against Germany: “Gold. Nothing else uniting the three governments, England, Russia, United States of America. That is the interest—gold, usury, debt, monopoly, class interest, and possibly gross indifference and contempt for humanity.”

Although “gold” was central to the world’s struggle, Pound still felt gold “is a coward. Gold is not the backbone of nations. It is their ruin. A coward, at the first breath of danger gold flows away, gold flows out of the country.”

Pound perceived Germany under Hitler as a nation that stood against the international money lenders and communist Russia under Stalin as a system that stood against humanity itself. He told his listeners: “Now if you know anything whatsoever of modern Europe and Asia, you know Hitler stands for putting men over machines. If you don’t know that, you know nothing. And beyond that you either know or do not know that Stalin’s regime considers humanity as nothing save raw material. Deliver so many carloads of human material at the consumption point. That is the logical result of materialism. If you assert that men are dirty, that humanity is merely material, that is where you come out. And the old Georgian train robber [Josef Stalin—Ed.] is perfectly logical. If all things are merely material, man is material—and the system of anti-man treats man as matter.”

The real enemy, said Pound, was international capitalism. All people everywhere were victims: “They’re working day and night, picking your pockets,” he said. “Every day and all day and all night picking your pockets and picking the Russian working man’s pockets.”

Capital, however, he said, was “not international, it is not hypernational. It is subnational. A quicksand under the nations, destroying all nations, destroying all law and government, destroying the nations, one at a time, Russian empire and Austria, 20 years past, France yesterday, England today.”

According to Pound, Americans had no idea why they were being expected to fight in Britain’s war with Germany: “Even Mr. Churchill hasn’t had the grass to tell the American people why he wants them to die, to save what. He is fighting for the gold standard and monopoly. Namely the power to starve the whole of mankind, and make it pay through the nose before it can eat the fruit of its own labor.”

As far as the English were concerned, in Pound’s broadcasts aimed at the British Isles he warned his listeners that although Russian-style communist totalitarianism was a threat to British freedom, it was not the biggest threat Britain faced: “You are threatened. You are threatened by the Russian methods of administration. Those methods [are not] your sole danger. It is, in fact, so far from being your sole danger that I have, in over two years of talk over this radio, possibly never referred

to it before. Usury has gnawed into England since the days of Elizabeth. First it was mortgages, mortgages on earls’ estates; usury against the feudal nobility. Then there were attacks on the common land, filchings of village common pasture. Then there developed a usury system, an international usury system, from Cromwell’s time, ever increasing.”

In the end, Pound suggested, it would be the big money interests who would really win the war—not any particular nation-state—and the foundation for future wars would be set in place: “The nomadic parasites will shift out of London and into Manhattan. And this will be presented under a camouflage of national slogans. It will be represented as an American victory. It will not be an American victory. The moment is serious. The moment is also confusing. It is confusing because there are two sets of concurrent phenomena, namely, those connected with fighting this war, and those which sow seeds for the next one.”

Pound believed one of the major problems of the day—which itself had contributed to war fever—was the manipulation of the press, particularly in the United States: “I naturally mistrust newspaper news from America,” he declared. “I grope in the mass of lies, knowing most of the sources are wholly untrustworthy.”

According to Pound: “The United States has been misinformed. The United States has been led down the garden path, and may be down under the daisies. All through shutting out news.”—*THE BARNES REVIEW*, (202) 546-1586

THE CHURCH AND JEWISH IDEOLOGY

The prevalent Jewish myth today is not the founding myth of Abraham or Moses on Sinai, but the story of Jewish persecution. In our time the Jews are defined less by ancestry than by “anti-Semitism” [Today, approximately 95% of “JEWS” are “self-styled” and **NOT** Semites (offspring of the Tribe of Shem): **“The Khazars are a good example of what happens when history is buried or REVISED to suit a given group of grabbers and human “elders” of a “get-it-all” cult. Even when the Khazars took the choice of Judaism, it was to conveniently avoid having to follow “Christ”ian reality of views. I do not refer to the Christian pretenders. One segment is even worse than the other but not by a pittance difference.**

The term “JEW” was **CREATED** much, much later in the passage of historical time. So, those who actually consider themselves to be JEWISH are not, for the **POWER ELITISTS SIMPLY DECIDED TO CALL THEMSELVES “JEWS” TO PRESENT A “FALSE” FRONT TO THE WORLD. So, the self-styled, self-claimed “Jews” are exactly THAT: anything they want to be, while foisting convenient “traditions” for commercial, warring enterprises off onto the innocent trained “seals” of the geographic location; Jewish is NEITHER RELIGIOUS NOR RACIAL.**

The Khazars came **NOT** from the Tribes of (even) Israel. Nor, actually, are they even Israelites, Judean or anything else. They are from alien races and are brought forth as Khazars out of the Nordic, Russ, and Mongolian lineage.

They most certainly are NOT from the Tribe of Shem (Semites) in any way, shape or form. They are directly from the ALIEN SERPENT RACE and even CALLED THEMSELVES SERPENT PEOPLE, prior to their choosing a new name to make themselves look a bit better. They chose "Judaism" because the "laws" allowed for them to continue in their corruption, wars, commercial thieving and thus and so—while Christianity claimed those things were naughty-kid stuff and couldn't openly bless such activities as were taking place. Spiritual TRUTH is that DIRECT CONNECTION WITH CREATOR, WHO GAVE YOU GOOD RULES TO FOLLOW, CALLED THE LAWS OF GOD—AND THOSE DO NOT MATCH THE INTERNAL AND INFERNAL INTENT OR ACTION OF THE POWER ELITE."—CONTACT (10/11/99, p. 23)], which is cited for many purposes, including the legitimization of the state of Israel. Most Zionists no longer claim that God gave the Holy Land to the Jews; instead they contend that the Jewish state is necessary as a haven for world Jewry.

According to this modern myth, the Jews are in no way responsible for their own unpopularity from ancient times. What, then, is the source of such persistent hostility to this fundamentally innocent people? Why, the Catholic Church, of course!

Many Jewish scholars find the seed of anti-Semitism in the *Gospels of Matthew and John*, where the Jews are depicted as engineering the Crucifixion, with the assistance of Romans who "know not what they do". Some Jews have even demanded that the offending passages be deleted from the Scriptures, not realizing (or caring) that Christians regard their holy books as off-limits to human editing. Others persist in blaming Pius XII for failing to condemn Nazism more strongly for its persecution of the Jews of Europe. The Catholic Church in particular has been targeted as the historic matrix of anti-Semitism; and, unfortunately, many churchmen have accepted the role of defendant against accusers who will never acquit the Church or drop the case.

In recent years the Vatican has tried, as far as possible, to appease Jewish objections. The Second Vatican Council, mindful of Nazi crimes, proclaimed that today's Jews don't share the guilt of the Jews who conspired to murder Christ. Pope John Paul II has been especially eager to cultivate good relations with the Jews, even making an unprecedented visit to a Roman synagogue a few years ago. He has gone so far as to name Steven Spielberg's *Schindler's List* as one of his favorite films—though it contains scenes of nudity and simulated intercourse.

In this spirit, the Vatican last year promulgated "We Remember", a statement of repentance for the failures of the Church and the mass of Christians during the Holocaust (or Shoah, the Hebrew word that has become current lately). Its theme was that "erroneous and unjust interpretations of the *New Testament*" have

contributed to anti-Semitism; and that the Church, though never a party to persecution, should have done more to oppose the "unspeakable tragedy" of the Shoah, which "can never be forgotten". The statement also affirmed the Church's "very close bonds of spiritual kinship with the Jewish people" and the "Hebrew roots of [Catholic] faith".

Many Jews resented the statement's exculpation of the Church for the Shoah itself. The document distinguished sharply between regrettable Christian attitudes toward the Jews throughout European history (it made no reference to Jewish attitudes toward Christians) and the virulent nationalist and racist anti-Semitism that arose in the 19th Century. Predictably, a Jewish historian has rejected this distinction.

In an article in the April 1999 issue of *Commentary*, "The Pope, the Church, and the Jews", Robert S. Wistrich, professor of modern Jewish history at the Hebrew University of Jerusalem, attacks "We Remember" for defending Pius XII and for minimizing the Church's guilty role in fostering anti-Semitism through the ages. Wistrich belittles Pius's efforts to protect Jews as not only insufficient but lacking in "moral courage". As for the 19th-Century anti-Semitic ideologies, they "presupposed a cultural framework that had been fashioned by centuries of medieval Christian theology, ecclesiastical policy, and popular religious myth."

This is nothing new for *Commentary*, which has previously carried articles blaming Christianity itself for the Holocaust. Wistrich doesn't cite, though he might as well have, the charge of the Jewish scholar Jules Isaac that "the permanent and latent source of anti-Semitism is none other than Christian religious teaching of every description, and the traditional, tendentious interpretation of the Scriptures." Isaac's work and influence helped shape the Second Vatican Council's statement about the Jews.

By such reasoning as Wistrich's, it would be easy to blame the Jews for bringing persecution on themselves. After all, they have been unpopular not only in Christian countries, but in pagan and Muslim lands. Cicero, Tacitus, Juvenal, and other Roman authors inveighed against them. They have repeatedly migrated to Christian countries and have been repeatedly expelled, for reasons that have usually had little to do with theology—though the obscene blasphemies against Christ and his mother in the *Talmud*, unique in religious literature, besides reflecting oddly on Jewish demands for Christian tolerance and for the cleansing of offensive passages in the Gospels, have done nothing to endear the Jews to Christians.

Wistrich mentions none of this. Nor does he mention one of the principal incitements to anti-Semitism in this century: Jewish participation in Communism, with its terrifying persecution of Christians. Where is the corresponding statement of Jewish leaders repudiating and repenting the Jewish role in a cause whose crimes dwarf those of Hitler? Did major Jewish spokesmen or organizations condemn Communism as it devoured tens of millions of Christians? Did a few brave Jews in the Soviet Union and the other Communist-ruled countries act, at personal risk, to shield Christians from arbitrary arrest and murder? Even today, how many Jews condemn Franklin Roosevelt for his fondness for Stalin, as they would condemn him if he had shown the slightest partiality to Hitler?

Further, might the Talmudic imprecations against Christ and Christians have helped form the Bolshevik Jews' anti-Christian animus? Did the

***Talmud* help form the "cultural framework" for the persecution of Christians, and for the eradication of Christian culture in America today? If so, will Jews make an effort to expunge the offending passages from the *Talmud*? How many rabbis speak of their "spiritual kinship" with Christianity?**

The answers to these questions are only too obvious. The Jews, with honorable but ineffectual exceptions, judge Christians by a standard that doesn't seem to apply to themselves. Or rather, their single standard is "Is it good for the Jews?"

As shepherd of the Catholic Church, Pius XII was bound to be guided chiefly by the question "Is it good for the Church?" He was not a Jewish leader, after all, but a Catholic one—a somewhat neglected point in these controversies. His first duty was to protect the Church amid the madness of a world war, knowing that its deadliest enemy was not Nazism but Communism [Jewish Bolshevism or, if you will, Zionism] (which, with American assistance, conquered several Catholic nations in Eastern Europe by the war's end). He did what he could to protect Jews and others too, and the most eloquent testimony to his efforts is the conversion of Israel Zolli, chief rabbi of Rome, to Catholicism. Zolli even took the baptismal name Eugenio in honor of Pius, who was born Eugenio Pacelli; he would hardly have done this if he had seen Pius as indifferent to the persecution of Jews.

Yet Wistrich complains that "in confronting the Shoah, Pius XII's chief concern was less with the ongoing annihilation of the Jews than with the interests of the Church". Think of that: A Pope putting the Church first! Nowadays, even the papacy is to be judged in terms of Jewish interests. Self-absorption can go no further.

It's some consolation that even the treacherous Roosevelt is now being criticized for doing too little to save Jewish lives. Jewish critics argue that he might have ordered the bombing of railroads leading to the concentration camps. But the chief effect of such a practice would surely have been to starve the camps' inmates.

The smear of Pius XII—and of the Church—persists, and will no doubt continue indefinitely, in the endless campaign to make Christianity and anti-Semitism synonymous. Wistrich barely acknowledges that the diplomatic Pius may have feared that a more explicit condemnation of Nazism would have backfired not only against the Church, but against the Jews themselves. Besides, if papal condemnations of Communism had failed to deter the persecution of Christians, how could Pius expect papal animadversions against Nazism to be any more efficacious?

Even American Jewish groups refrained from denouncing the Shoah during the war, for fear that speaking publicly about it might do more harm than good. This policy of silence has resulted in bitter recriminations between American and European Jews, but it has discouraged few Jews on either continent from blaming Pius for saying too little.

The prevalent attitude of Christians toward the Jews has been (and remains) not so much hatred as fear. The *Acts of the Apostles* tells how the early Church was forced to take various precautions "for fear of the Jews". Few deny, or doubt, that this is historically accurate; the tolerance recommended to Christians has never been a salient trait of the Jews themselves, when they have held power. **On the contrary, the state of Israel is based on an ethnic supremacism that would be roundly condemned as anti-Semitic if it were enforced against Jews by**

gentiles. Yet most Jews hotly resent any suggestion that Zionism is “racist”. (A United Nations declaration to that effect was eventually repealed in response to American pressure.)

In intellectual life, Jews have been brilliantly subversive of the cultures of the natives they have lived amongst. Their tendencies, especially in modern times, have been radical and nihilistic. One thinks of Marx, Freud, and many other shapers of modern thought and authors of reductionist ideologies. Even Einstein, the greatest [sic] of Jewish scientists, was, unlike Sir Isaac Newton, no mere contemplator of Nature’s laws; he helped inspire the development of nuclear weapons and consistently defended the Soviet Union under Stalin.

Jews have generally supported Communism, socialism, liberalism, and secularism; the agenda of major Jewish groups is the de-Christianization of America, using a debased interpretation of the “living Constitution” as their instrument. When the Jewish side of an issue is too unpopular to prevail democratically, the legal arm of Jewry seeks to make the issue a “constitutional” one, appealing to judicial sovereignty to decide it in defiance of the voters. Overwhelming, Jewish support for legal abortion illustrates that many Jews hate Christian morality more than they revere Jewish tradition itself. This fanatical antagonism causes anguish to a number of religious, conscientious, and far-sighted Jews, but they, alas, are outside the Jewish mainstream.

Today, in American politics, journalism, and ecclesiastical circles, fear of Jewish power is overwhelming. This is most obvious in the dread of incurring the label “anti-Semitic”, in the way Christians shrink from calling this country “a Christian nation” (a phrase that enrages Jews), and in the groveling before Israel that has become a virtual requirement for anyone who aspires to high office. Nobody dares to point out the obvious, that Israel is inimical to the principles Americans profess to share; nearly everyone in public life pretends that Israel is a model democracy and a “reliable ally” of the United States, despite repeated episodes of Israeli spying and betrayal against its chief benefactor. Israel has not only refused to return the documents stolen by Jonathan Pollard—it continues to press the U.S. Government for his release from prison. In fact, Israel exemplifies most of the “anti-Semitic stereotypes” of yore: it is exclusivist, belligerent, parasitic, amoral, and underhanded. It feels no obligation to non-Jews, even those who have befriended it.

Most Jews regard conversion to Christianity as the ultimate treason to Jewry and resent Christian attempts to convert them; never mind that for Christians, concern for the salvation of souls is the highest charity next to the adoration of God. In Jewish eyes, such charity is next door to persecution. Jews for Jesus, a convert group, is especially execrated among Jews, and in Israel Christian proselytization can be punished by law under various pretexts. (Even giving a copy of the *New Testament* can be construed as a “bribe”.) **Yet Christians, who may not claim a nation of their own, are taxed to support the Jewish state.**

History is replete with the lesson that a country in which the Jews get the upper hand is in danger. Such was the experience of Europe during Jewish-led Communist revolutions in Russia, Hungary, Romania, and Germany after World War I. Christians knew that Communism—often called

“Jewish Bolshevism”—would bring awful persecution with the ultimate goal of the annihilation of Christianity. While the atheistic Soviet regime made war on Christians, murdering tens of thousands of Orthodox priests, it also showed its true colors by making anti-Semitism a capital crime. Countless Jews around the world remained pro-Communist even after Stalin had purged most Jews from positions of power in the Soviet Union.

Clearly, it is futile for the Church to try to mollify a hatred so ancient and so deep as the Jewish animus against Christianity. Despite all the sentimental rhetoric to the contrary—such as pious nonsense about “the Judaeo-Christian tradition”—Judaism and Christianity are radically opposed over the most important thing of all: Jesus Christ, who commands us to be wise as serpents and harmless as doves, and to love our enemies, which does not mean mistaking them for friends.

This is not to suggest that true friendship can’t exist between Jews and Christians as individuals. And there is much about the Jews, an immensely talented people, that a Christian can honor and delight in. But any concord based on lies, evasions, and partisan propaganda is false and should be rejected. “We Remember” is an honorable attempt to vindicate the honor of the Church. If only it had dealt more frankly with the real history of Jewish-Christian relations!

NEW KURSK GOVERNOR LASHES OUT AT JEWS

The Communist governor-elect of Kursk, Alexander Mikhailov, said that he and President Vladimir Putin are allies working to rid Russia of Jewish “filth”, drawing an outcry Friday from Jewish leaders.

Incumbant Kursk Governor Alexander Rutskoi, whose mother is Jewish, threatened Friday to sue Mikhailov.

Mikhailov won the Kursk governorship in a second round of voting Sunday—Rutskoi was struck from the ballot by a court for election campaign irregularities on the eve of the first round in October.

Mikhailov said in an interview published in *Kommersant* on Thursday that the Kursk elections had ramifications for all of Russia because it was a “test ground” for fighting the “All-Russian Jewish Congress”.

It was not clear if Mikhailov was referring to the Russian Jewish Congress led by tycoon Vladimir Gusinsky.

Mikhailov said Rutskoi was a “pointman” in the organization and was backed by billionaire Boris Berezovsky, who is also of Jewish origin.

“Today the liberation of Russia of all this filth, which has piled up over 10 years, will start,” *Kommersant* quoted Mikhailov as saying. “In this, the president and I are allies, not opponents.

“Vladimir Vladimirovich [Putin], by the way, is a Russian man. So am I,” he said. “And Rutskoi, in case you don’t know, has a Jewish mother, Zinaida Iosifovna.”

Mikhailov also said he owed his gubernatorial victory in large part to Putin, who sent his

personal psychologist to assist in campaigning.

“Vladimir Vladimirovich has twice sent his personal envoy to meet me,” Mikhailov was quoted as saying. “I don’t want to give you the name, but it was a woman—Putin’s personal psychologist.”

A high-ranking official in the presidential administration called Mikhailov’s remarks nonsense, *Interfax* reported.

“It is complete nonsense, beginning with the fictitious personal psychologist of the president and ending with all the other foolishness,” the source was quoted as saying.

The presidential press service declined to comment Friday.

Rutskoi said he would sue Mikhailov for igniting national hatred.

“As a man, I’m ready to beat him into a pulp, but as a public official I will sue him in court,” *Kommersant* quoted him as saying Friday.

Communist leader Gennady Zyuganov gave Mikhailov a mild reprimand, saying that he should “look into the economy rather than digging up other people’s genealogies,” *Interfax* reported.

Jewish organizations called on Putin to speak out. “We consider these statements, as well as Mikhailov’s hints about some allied relations with Russia’s President Vladimir Putin in liberating Russia of Jews, a serious political provocation,” the Russian Jewish Congress said in a statement.

“The authorities, the president has to speak out,” said Mikhail Chlenov, president of the VAAD Jewish umbrella organization.

Chlenov said he has received numerous telephone calls from outraged Jewish activists across Russia. “He [Mikhailov] is a dense, ignorant, scaly anti-Semite, who has no idea what he is babbling about,” Chlenov said. “These are the mildest terms I can think of.”

Mikhailov’s campaign office in Kursk said the governor-elect and his assistants had no comment Friday.

BLOOD IN THE STREETS?

While Gore supporters are holding protests in the streets, Bush supporters are buying bullets at gun shops. In the three days since the U.S. General Election, ammunition sales throughout the United States have jumped an astonishing 900%. Americans are furious over massive, blatant and widespread vote fraud by supporters of Al Gore and many are openly talking about “blood in the streets”.

Thousands of non-U.S. Citizens—who cannot legally vote—were sent letters by President Bill Clinton just days before the election, informing them they had registered, and even providing them with Voter Identification Cards to sign and use when voting! In New York City, voting machines were tampered with, disabling the Republican voting levers. Leftist Gore supporters and the media are ignoring this fact, spurring outrage by conservatives that the truth is being suppressed and causing minorities in that county to take to the streets demanding a re-vote. SULTAN ADVOCATES ISLAMIC BANKING

His Majesty the Sultan and Yang Di-Pertuan of Brunei Darussalam heralded his nation’s big move to replace its largely conventionally-styled financial architecture with an Islamic system by opening another Islamic bank in the country yesterday.

He did this under the glare of international media spotlight and on the eve of APEC Leaders’ Summit.

His Majesty will host and chair the meetings that will, among others, examine ways to strengthen the weakening international financial architecture that was apparently crumbling after failing to withstand the recent region-wide financial and economic crises.

The country that practises Islam as its religion has been relentless since almost a decade ago in introducing an Islamic financial and banking system as an alternative to the current conventional interest-based [usury-based] financial and banking system.

Already Brunei has two Islamic financial institutions—the Islamic Bank of Brunei and Islamic Trust Fund of Brunei or TAIB.

A new Islamic bank made its debut into the country’s financial market yesterday, taking Brunei to

a new milestone in its efforts to develop its Islamic financial architecture.

“Seven years after we witnessed the launching of the first Islamic bank in our country, we thank Allah that we now take another step forward. This time it is about changing the Development Bank of Brunei to become the Islamic Development Bank of Brunei Berhad.

“This Bank is 100 percent owned by the Government. It is a milestone for our country and will become much more significant in proportion to our status. This change will also alter the financial system that is free of usury,” remarked the ruler in his titah to mark the opening of the new Islamic bank.

His Majesty described the latest initiative to establish yet another Islamic bank as a signal to show the political willingness of the nation to adopt changes—especially if the change is for the better.

“For us Muslims, the value of what is worthwhile or better must be based on the *Syariat* (the teachings of Islam),” commented the ruler.

He expounded with convincing tone that in the matter of strengthening financial architecture, the Islamic way is the answer.

“The Muslim community around the world should be proud that there are now 200 Islamic financial institutions in operation in 60 Muslim and non-Muslim countries,” stressed the ruler.

“Is this not clear testimony that ‘mu’amalah’ or the Islamic way of doing business is being accepted by people across the globe?”

“We are confident that the Islamic way of doing business will be widely accepted by the world at large. This is not only because it brings profits but also offers fairness, and at the same time prevents exploitation”, stressed the ruler.

“On such basis, therefore, Islamic financial institutions, wherever they may exist, are no longer at the sidelines, but are becoming involved in financial transactions that are international in nature”, he added.

His Majesty said it is with this view in mind that there is promising future for the Islamic Development Bank of Brunei Berhad.

“Not only will it handle its operations solely with local clients, but it must also participate in regional and international financial transactions and investments. Another distinctive feature of this Bank is its role in facilitating the growth and development of small and medium enterprises in this country”, said the ruler.

He expressed hope that with efficiency and effectiveness, the new Islamic bank will extend financial assistance fairly to those in real need of help. This co-operation and assistance is based on profit sharing and not interest earning, said the ruler.

He expressed hope that the Islamic Development Bank of Brunei Berhad will not merely be a change of name—but at the same time it will contribute more towards the development of the Muslim community (ummah) in this country.

He said through its ‘mu’amalah’ scheme, it should also be more successful in attracting and enhancing relations between entrepreneurs, businessmen, depositors and investors with the bank—not for the sheer sake of profits alone, but more importantly, it is based on the spirit and concept of joint venture such as through trust financing (mudharabah) and partnership (musyarakah).

September 9, 1996 the Officers and Directors of the Assignee of 50% of the value of PERUVIAN BONUS CERTIFICATE 3392-181 reached an agreement with certain officers of the U.S. Treasury, among whom were Russell Munk and Lawrence Summers (the current Secretary of the Treasury). When those officers refused to sign the agreement, pleading that to do so would not only jeopardize the U.S. Treasury but also the Federal Reserve System, the Assignee converted the agreement to a Public Notice and published it. No objection or rebuttal was ever received from Treasury, or from the FED.

The fourth paragraph of that Agreement/Public Notice reads as follows: *“As a consideration of National Security (as well as Global Security), transactions WITHIN these guidelines will not be interfered with or blocked by the U.S. or its assigns. The consideration for such noninterference is that none of the contracts will be lodged for collection until such time as there is an additional agreement as to the lodging and honoring, through payoff, of the contracts.”*

This Public Notice, however, presents the knowledge of ongoing interference from our counterparts to the agreements and the breaking of each and all of those said agreements to varying degrees of diversion tactics of manipulation, delays and actual stone-wall operations. We acknowledge, however, that we find no outright DENIALS of said program or document value, only delays and refusal to provide information regarding same. We have also noted the utilization of such organizations as the World Bank and IMF to effect the rejection of the use of the collateral through intimidation and bribes of central bank personnel. It is our position, therefore, that we are no longer bound by those agreements as published September 9, 1996.

Because they are sensible, however, two of the requirements will continue to be met: the first being the limit of \$5T per year (beginning in 1996 and thus aggregating \$30T by January 1, 2001) (this restriction will not apply, however, to project funding within the U.S.A.), and the second being the prohibition of any use of “high yield” or “rollover” trading programs, which we believe are being used to grossly inflate the supply of U.S. dollars in an effort to destabilize the financial system of the U.S.A., and thus the world.

We offer this Public Notice as a status report to the current U.S. Administration, and to the parties who will be moving into the U.S. Government Administration, and to other involved persons in charge of governmental affairs in January, 2001. While we realize that most involved persons are very cognizant of current conditions, it is proper that we make an effort to consolidate the record for the sake of accuracy and brevity.

The asset, which is the debt of the U.S. Treasury, guaranteed by the FED, and payable in gold, as valued and established by Messieurs Bush, Herman, Baker, Bentsen, and Greenspan, was assigned to Global Alliance Investment Association (GAIA) April 28, 1998. The Uniform Commercial Code procedure for confirmation of the debt was undertaken and the proper notices to all potential interested parties given, and their receipts noted and published. There was no opposition of any kind made to the procedure, which became final and incontestable as of February 16, 1999. (The signatures at the end of this document shall be construed as a Certificate of Non-Response to the UCC notices.) Researchers have been able to easily establish that the original bearer bond, 3392-181, was reconfirmed, then reconfirmed and reissued as a jurat/contract of identifiable ownership to Cosmos Seafood Energy Marketing Ltd., a corporation set up by its owner and Chairman, Russell Herman. It may be helpful to researchers to know that the owners, officers, and directors of Cosmos are the same as those of GAIA, obviating the need for concern as to the legitimacy of those transfers from Cosmos to GAIA. The asset has been affirmed, albeit by default, as the property of GAIA, and is available for use.

To facilitate the distribution of the asset to deserving end-users, it has been determined, upon advice of counsel, to issue portions of the accrued interest in the form of DEEDS OF ASSIGNMENT FOR CONSIDERATION. Such DEEDS are specifically designed to be banking reserves and, for ease of bankers' understanding, are to be treated exactly as is other U.S. Treasury debt, since such debt is widely used as reserves by banks everywhere.


GAIA has issued some 1,200 DEEDS, worldwide, with a total value of several trillion U.S. dollars. Honoring our agreement, none (to our knowledge) have been issued to U.S. entities. That can be changed; GAIA would be willing and able to support such a program in the U.S., given the cooperation of the U.S. Such a program would offer ability for the U.S. to reclaim gold which has been moved out of the country and upon which the value of the dollar can have established and authentic VALUE affixed. As it is, allowing derivative-based so-called “high yield” trading programs is creating dollars in ever-increasing and uncontrollable amounts. If Alan Greenspan has any claim to managing the “prosperity” of the U.S., it is only that he has held the regulators at bay and prevented them from controlling, or eliminating, the proliferation of derivatives. It is the rapidly expanding money supply that makes such prosperity possible, but without basis it must one day implode. The use of the GAIA asset and the return to a gold standard for the currency would prevent such a catastrophe if implemented in time.

As its name implies, Global Alliance Investment Association intends to become an Association of Allied nations willing to Invest their time and resources, Globally, to achieve financial stability and complete sovereignty. In 1945 the Bretton Woods Agreement established the World Bank and IMF with, ostensibly, similar intentions. Unfortunately, those noble goals have been perverted and the institutions have become instruments of control and collection for the major international banks. While GAIA has no desire to “compete” with the IMF/WB, because it has become so clear that their former beneficiaries became debtors and are now victims to be bled dry, GAIA will have to defend itself from being denigrated for its preference for non-usurious “Islamic-type” banking, or for its recommendation of basing currencies upon gold so that inflation is eliminated and interest rates can be brought to 2-4% as they were in the 1800s and, in the U.S., until the 1940s. High interest rates kill business, put home ownership out of the reach of the masses, and enrich only the already rich.

GAIA intends to offer its collateral as the basis for the creation of many regional “monetary funds” to be maintained under local control, although the overall GAIA program will soon obviate the need for such funds, once the nations taste and feel sovereignty. Such regional funds could be used to free nations from the IMF/WB debt trap by “purchasing” the debt. However, by far the majority of GAIA DEEDS will be issued to all sorts of entities that need additional collateral to enable them to finance peaceful, beneficial projects.

Because the debt to GAIA is payable in gold, and the GAIA program requires that at least 50% of the value of the DEEDS issued be used to purchase gold, and that gold held in the funding bank for the Alliance, the effect is to create substantial reserves that can be drawn upon in emergencies, especially natural disasters. The money would be immediately available, not like the current situation wherein organizations like the UN must beg for the funds.
