



EQUAL PARTNERS IN CRIME AND CORRUPTION:

Organized crime depends on official corruption—specifically, the collusion of politicians and the connivance of law enforcers—for survival and continued profitability. The widely held public notion is that criminals are the main corrupters of public officials, some of whom succumb to temptation. However, research studies are now bringing to light a more accurate view of the relationship between corrupt public officials and criminals. Corrupt public officials and criminals are more often than not equal partners in organized crime. In some documented cases, it is the corrupt politicians who are actually the main organizers of organized crime. This leads to the possibility that in some countries, the head of state and the Godfather of organized crime may be one and the same person. In such cases, the head of state must be regarded as a malignant cancer and removed, lest the entire body politic become infected.

Criminals, quasi-businessmen and corrupt public officials are equal players in the marketplace of crime and corruption. Each party comes to the marketplace with goods and services needed by the other parties. Organized criminals, who are primarily purveyors of illicit goods and services, exchange their illicit goods and services, their money, their influence and the support of their organized crime machinery for protection, selective enforcement against competitors, and favorable policy decisions by the government officials.

A series of exchanges of goods and services takes place. Over a period of time these exchanges between the upperworld and the underworld often become institutionalized and develop into a series of long-term corrupt relationships.

CAN HEADS OF STATE
BE CRIMINAL GODFATHERS?

There are many instances where it was widely believed that a nation’s head of state and the godfather of organized crime were one and the same person. This is often the case in Third World countries lacking in mature democratic institutions to prevent the state from falling under the control of organized crime.

One example is the late President Sani Abacha of Nigeria, whose lust for sex was as uncontrollable as his lust for money and power. Gen. Abacha died of a heart attack in 1998 in the company of prostitutes, reportedly of a heart attack caused by sexual exhaustion. According to the Nigerian government, Gen. Abacha and his henchmen robbed the Nigerian Treasury of \$4 billion since he took power in 1993. Much of the loot was invested in property in Nigeria, but some \$2.2 billion was deposited in foreign banks and offshore companies. The successor government offered amnesty to Gen. Abacha’s cronies and relatives, who returned illicitly acquired money and property worth half a billion dollars.

Under Pres. Abacha’s protection, Nigerian cocaine-trafficking syndicates flourished and became transnational in scope. Numerous pro-democracy demonstrators were killed by police. Over 700 Nigerian environmentalists protesting the rape of the environment by multinational corporations were executed by Gen. Abacha’s dictatorial regime.

Pres. Fulgencio Batista of Cuba, overthrown by Fidel Castro in 1959, was another head of state widely believed to be a protector and partner of organized crime. In partnership with American Mafiosi Meyer Lansky, he transformed Havana into an international drug port and a gambling haven for the laundering of drug money through casinos.

Pres. Francois “Papa Doc” Duvalier and his son Jean Claude “Baby Doc” Duvalier made Haiti into a transshipment point for Colombian cocaine and systematically looted the country while ruling it with an iron hand for 30 years. Over 60,000 Haitians were killed and countless more tortured by the Duvalier’s Tonton Macoutes death squads. The Duvaliers enriched themselves while Haiti became the poorest country in the Western hemisphere. The father-and-son team had no conscience whatsoever. They pocketed foreign aid funds meant for the poor. In 1980, the International Monetary Fund granted Haiti a \$22 million supplement. Within weeks, \$18 million was unaccounted for. The Duvalier’s reign, which began in 1957 when “Papa Doc” declared himself President-For-Life, finally came to an end in 1986, when “Baby Doc” fled angry mobs for asylum in France, with a fortune estimated at \$400 million.

Gen. Manuel Noriega of Panama was another

political strongman widely believed to be a godfather of organized crime. Gen. Noriega converted Panama into a center for cocaine trafficking and drug-money laundering. U.S. intervention caused him to surrender and face drug-trafficking charges. He was convicted in Miami on charges of drug trafficking and sentenced to 40 years imprisonment. **[H: Ah, but—we know that this is not the whole of THIS story—so who is the bigger “Godfather” involved in this “Mafiosi-style” operation? This, however, is “not” my story, so we will continue, please.]**

Pres. Alfredo Stroessner of Paraguay, who seized power in 1954, was an ardent admirer of Nazism. Of German descent, Stroessner offered refuge to many Nazi criminals, including the notorious Joseph Mengele, who tortured and killed millions of Jews [sic] in Nazi death camps. Stroessner practiced the same kind of genocide against Paraguay’s native Ache Indians. To eliminate these inhabitants of ancestral lands targeted for development by multinational corporations, Stroessner had them systematically hunted down, with parents killed and their children sold into slavery. High-ranking members of Stroessner’s regime were implicated in the notorious “French Connection” heroin-trafficking ring. Paraguay was the transshipment point for heroin shipments coming from Marseilles in France to the US. Stroessner was overthrown in a coup in 1988 by one of his closest generals, Andres Rodriguez, who is likewise widely believed to be a drug trafficker. **[H: Could this happen in the Philippines? How about Indonesia? How about the United States of America?]**

RECENT EXAMPLES OF HEADS OF STATE
AS CRIMINAL GODFATHERS

According to an investigation report by the German Federal Intelligence (BND) leaked to the German media in October 2000, recently deposed Pres. Slobodan Milosevic was the Godfather of a Mafia organization which bled Yugoslavia dry for a decade. The Mafia cabal included a dozen senior Serbian politicians who were political allies of Milosevic. Naming Pres. Milosevic as the “boss of bosses”, the BND report reads:

“Considerable evidence indicates that Milosevic and his entourage constitute an organized crime structure and are engaged in drug dealing, money laundering and other criminal acts. The near total control of key economic posts by Milosevic followers opened opportunities for illegal capital transfer for personal enrichment, financing for political plans, weapons purchases and served as camouflage for criminal activity—drug trade.”

The BND report alleged that about 60 people closely allied to Pres. Milosevic have been ruling the country and prospering from the war and chaos. Milosevic, his relatives, cronies and political supporters allegedly controlled the massive smuggling operations in forbidden goods and salted away more than \$100 million in bank accounts in Russia, China, Cyprus, Greece, Lebanon and South Africa. The BND report specifically names as members of the Milosevic Mafia:

* Milosevic’s son Marko, who fled to Moscow after his father was deposed.

* Dragan Tomie, parliamentary President.

* Mirko Marjanovic, Serbian Prime Minister.
 * Dragan Kostic, former Minister of Energy.
 * Banker Borka Vucic, former head of the Nicosia branch of the Belgrade Bank in Cyprus, where some of the Mafia's ill-gotten wealth was deposited.
 * Banker Miobrag Zecevic, former head of the Franco-Yugoslav Bank in Paris, who in 1996 was charged by French authorities for illegal activities.

As of this writing Pres. Alberto Fujimori has recently announced his imminent resignation due to a bribery scandal involving Vladimiro Montesinos, his spy chief. Montesinos was caught on videotape offering Cong. Luis Alberto Kouri a \$15,000 bribe to switch to Fujimori's Peru 2000 Party so the administration would have a majority in parliament. Subsequently, Fujimori attempted to distance himself from Montesinos and ordered that the latter be investigated amidst revelations that Montesinos held three secret bank accounts containing about \$50 million in suspected laundered drug money.

Recent revelations by the British Broadcasting Corp. suggest, however, that Montesinos may have been Fujimori's right-hand man in dealings with the Colombian cocaine cartel. Pres. Fujimori had given Montesinos authority over Peru's anti-drug campaign. BBC published a report "Colombia drugs link to Peru scandal" on Nov. 12, 2000, detailing the revelation by the brother of notorious Colombian drug baron Pablo Escobar that Montesinos was the go-between for the Colombian drug lords to finance Fujimori's first presidential campaign in 1989. Roberto Escobar told the newsmagazine *Cambio* that his brother Pablo Escobar had given a \$1 million donation to Montesinos to support Mr. Fujimori's campaign. According to Roberto Escobar, Montesinos "collaborated substantially in the drug operations carried out by my brother Pablo in Peru from around 1986 to 1992." He said that Montesinos "worked for the Medellin (cocaine) cartel" and was instrumental in getting many Colombians and Peruvians released from prison.

Perhaps it was the BBC report that caused Fujimori to suddenly announce that he would resign within 48 hours. At times, it is the testimony of wrongdoers that brings about the exposure that a head of state is also the Mafia Godfather. In such cases, the head of state must be regarded as a malignant cancer and removed, lest the entire body politic become infected.

GRAVITY OF CRISIS IN THE PHILIPPINES

By Erick San Juan
(Manila, Philippines, December 2000)

Friends:

Very few people in this country are aware of the gravity of the crisis we are facing today. We, as a nation and as a people, can no longer afford to commit mistakes. This time, a grave miscalculation will lead us to the bottomless pit, where there is no more so-called "national salvation".

What is badly needed are leaders who understand the issues, and who are willing—against all odds—to assume responsibility and fight, come what may, without becoming intimidated by lies and slanders, by

tragedies, by lack of means of resources. Because above and beyond man lies the strength of God. Who will lead us to our "promised land", and all of that for which we have been born, and for which we shall die?

This is the reason why we cannot have any doubts here; we cannot allow any liars here. Betrayals cannot be permitted here. Once and for all, the people need to see, in all honesty, what is happening to us and to the whole world. Narco-terrorism, drug trafficking, corruption, and the lack of freedom and human dignity are the tragedies which corrode us.

Is it, therefore, right for us to impeach President Estrada? Morally speaking, yes. Politically, just like what happened to strongman Ferdinand Marcos, only time will tell. And it is the latter dimension which is giving even the most politically astute observers among us, sleepless nights. The majority of Filipinos still remember that great political swindle which befell the nation beginning February 25, 1986, when we were lured into accepting a capitalistic democracy which is anti-Christian because it says all power is vested in the people—whereas we know from traditional Catholic faith that all power is vested in God and passes from God to all those who have authority in our world—people or rulers.

Because of the myth of "People Power", an increasing number of us are now willing to throw in our lot with a socialist democracy that invests in the economic forces of history—and to the Devil with God and the people!

Our people have wisened up. They can no longer be easily swayed by the forces of sloganism and political opportunism. Even Felipe Miranda's pro-Erap *Pulse Asia* can no longer ignore the people's anger. Enough with cronyism, profligacy and kleptocracy. This is the message behind the November 16-24 Net Approval Rating of Senators in the impeachment trial released by *Pulse Asia* through *The Philippine Star*. Erap's perceived allies are on the bottom of the pack, proving once more that public opinion—especially when regimented—can make or break the career of our public servants.

The crucial question, at the moment, is not whether or not Erap will be impeached, but whether or not this nation can survive an acquittal. To illustrate: "The nation held its breath as the Senate contemplated the motion to dismiss the *Articles of Impeachment*. Lawyers of Joseph Estrada raised the technicalities and sought the abortion of the trial," writes political scientist Alex Magno, "Had the Senate allowed the trial to be aborted, all hell would have broken loose." Magno proceeds to tell us why:

"Over the last six weeks, the entire nation has been cast into a political pressure cooker. The debate has been joined. The open media, initially timid (or bribed) has succumbed to the great public thirst for truth and reason.

"This is so unlike the 1983-86 period. During that period of upheaval, media channels were controlled by the dictatorship. Political discussion was reduced to the simplest symbolism.

"Today, in part due to a systematic effort on the part of Estrada operatives to manipulate public perceptions in an open media, the issues are strenuously examined. Every nuance is explored. Every option seriously considered.

"When convictions are formed, they are firm. They are well thought out. They cannot be reversed—

or intimidated... Brilliant lawyering might sway the jurors. But it is unlikely that the technicalities they will heap on the prosecution's evidence will reverse the drift of public opinion." (STANDARD, 30 November 2000)

Indeed, all eyes will not be focused on Erap who, chances are, will not appear personally to confront his accusers, but on the senators who are acting as jurors. Already, the body language of some of them reveal many things, including perhaps, confirming rumors of a heavy pay-off in the form of balikbayan (gift) boxes loaded with crispy 1000-peso bills. Can anyone really blame the rumormongers for spreading such reports? Our population, generally speaking, has become a terribly immoral one. The Yuppies join with the super-rich Ayala Avenue speculators in looting pensions, health funds, and even Social Security, so that the young might profit at the expense of even accelerated death-rates among their parents, grandparents, and other relatives. We see this in Congress. We see it everywhere, this man-eat-man, dog-eat-dog piggishness of Adam Smith and his free-trading, privatizing, globalizing associates like Thomas Hobbes, John Locke, and Bernard de Mandeville.

Look at the immorality of the society which elevated an Erap into the office of the President. But do not fix your gaze at Erap; look at the depravity of the people who supported his candidacy for that position. Look at the depravity of those who supported his policies. Look at the poor, the desperate retirees, throwing the money they cannot afford to lose at gambling tables. Look at the young professionals, bargaining away the health benefits and retirement funds of older workers, just so the employers might reward them with a bit more in their paychecks. Eat your cousin, bury your aged dependents as quickly as possible, sell your kid sister into prostitution—all for the sake of money. Such is the character of a people which has, at least for the moment, lost the moral fitness to survive.

A civil war awaits us, to usher such a depraved people into a bloody conflict which could destroy our nation-state. From where I stand, I can see the moving finger writing the ominous words on the wall where the moneychangers or bankers are celebrating their latest depredations against their fellow Filipinos.

According to a police officer I conversed with, in his 25 years of policing, he has seen larger demonstrations than those currently being staged by the political opposition, but he has never seen any as well-organized as those being staged today against the morally bankrupt administration. Kudos should also go to those policemen who, throughout the past weeks of planned anti-Erap protest actions, acted preemptively, with a minimum use of force, to stymie those among the protesters who entertained the idea of provoking class struggle.

My apprehension of a civil war erupting is the same as that of Alex Magno's "all hell breaking loose". Notwithstanding the implicit denial of leftist spokesmen, under such circumstances, there lies always the need to point to the appropriate historical referent to these kinds of mass action. For this was how Lord Shelburne's chief of intelligence for the British Foreign Office, Jeremy Bentham, through Philippe Egalite (The Duke of Orleans), micro-managed the July 14, 1789 Jacobin riots in Paris,

even writing the speeches of Marat, Danton, Robespierre, and other leaders of that "Revolution".

The purpose of the storming of the Bastille, and the events that followed, was to destroy the pro-Constitutional Monarch forces, grouped around such friends of the American Revolution as the Marquis de Lafayette, as well as to install Jacques Necker, who had nearly bankrupted France, as Prime Minister, on behalf of the Jacobin mobs. So, the question asked by the uncommitted ones among the citizenry is: Who is funding the mass actions undertaken mostly by what veteran journalist Max Soliven describes as an "unlikely alliance" of the Left, Right, and Center?

Before I give the answer, let me first state here that there is nothing "unlikely" in the alliance which has developed right before your eyes. It is a product of long-range planning and radical shift of strategy.

Some of Erap's foreign advisers, like Russian-American Paul Bograd, are actually making him look like a fool in public, with all the so-called "red scare" tactics. But those who know the intricacies of geopolitics are aware that the threat is real; only the politically naive like Erap, do not have the proper knowledge to confront such problems.

Today's successful Marxists are aware that the peak of human happiness is completely different from the Leninist concept of armed-and-violent revolution, although Sison's group would disagree. There is another process, one which captured even the hearts of Roman Catholic bishops, priests, and their counterparts from the mainline Protestant churches. The blueprint for the global victory of Marxism rests on Hegel's distinction between what is "inner" or "imminent" to man and what man holds to be outside and above him and his world—a superior force transcending the limitations of individuals and of groups, both large and small. It now uses Lenin's geopolitical structure not to conquer streets and cities, but to conquer the mind of civil society.

To change the common cultural outlook, the first order of business is to change the outward face of the Communist Party. For starters, the neo-Marxists have dropped all Leninist slogans. No more "revolution" and "dictatorship of the proletariat". Instead, they are now exalting such ideas as "national consensus", "national unity", and "national salvation".

The local Marxists have followed the path of Italian communists. They now engage in the practical and normally accepted democratic processes. In lobbying, voting and the full gamut of parliamentary participation. They now behave in every respect the way Western democrats behave—not only accepting the existence of many political parties but forging alliances with some and friendships with others. In fact, they defend pluralism.

To the neo-Marxists who are reared in the tactics of Antonio Gramsci, one superstructure that needs to be eliminated is Christianity, which still pervades Western culture in all its forms, activities and expressions. This explains why the attack is strong particularly in countries where Roman Catholicism most deeply guides the thinking and the actions of the generality of populations.

Gramsci's idea was that Marxist action must be unitary against what he saw to be the failing vestiges of Christianity. And by a unitary attack, Gramsci meant that Marxists must change the residually

Christian mind. He needed to change that mind—to turn it into its opposite in all its details—so that it would become not merely a non-Christian mind but an anti-Christian mind. It is a fact, pure and simple, therefore, that the residue of Christian transcendentalism in the world is—with the help of the Vatican II Church—gradually and quietly being replaced with genuinely Marxist imminentism.

Such goals are being pursued by means of a quiet and anonymous revolution. No armed and bloody uprisings would do it. No bellicose confrontations would win the day. Rather, everything must be done in the name of man's dignity and rights—in the name of his autonomy and freedom from outside constraint. From the claims and constraints of Christianity, above all. Citizen Cory (Aquino) is one of their more prominent stooges.

Can you now see the real meaning behind those flowery words of Paul VI, his successor John Paul II, and the cohorts of Jaime Cardinal Sin? Their church, the new church of Vatican II, had decided to "opt for man; to serve man; to help him build his home on this Earth (not in heaven). Man with his ideas and his alms; man with his hopes and his fears; man in his difficulties and sufferings." This, mind you, is now the centerpiece of the Church's interest, not our Lord Jesus Christ and His Heavenly Kingdom.

The skeptics among you had better take a closer look at what I am saying here today. Look at the leftist group, SANLAKAS. They use blue banners, not red. NDF have good-looking spokesmen like Teddy Casino, ready to flash a big smile for public consumption. What they are presenting is Communism with a "kind face". But those who have experienced proletarian rule will tell you that they always wear two faces—one before, and one after grabbing power.

This is the reason why the legitimate opposition led by Madam Vice-President Gloria Macapagal-Arroyo should be extra careful with those people with whom she is dealing. This is what that bungling political officer of the U.S. Embassy named Dan Larsen, tried to transmit to Lakas-NUCD executive director Joey Rufino last week. Of course, U.S. Embassy spokesman Tom Skipper had no choice but to retort: "It is not unusual for us to get in touch with different political parties to ask for developments on certain issues. It is part of our job to understand what is happening so we can report back to Washington."

To avoid any further misunderstanding, Tom Skipper added, "We are not trying to influence the outcome of political events. There are no specific instructions from Washington. We were only talking in a general sense. We know it is a domestic issue."

As always, the Americans know something which our politicians don't know. Ever since former U.S. Defense Secretary Caspar Weinberger wrote a book about the next global war, which he perceives to be one that will be fought against China—the Mainland Chinese have been trying to influence events both here and in Taiwan—in order to narrow down the proposed Missile Defense Shield of the United States in Asia and the Pacific. A pro-Communist Philippines would greatly tilt the balance in favor of the Beijing government. Already, there is an informal alliance existing among the members of the so-called "Survivor's Club"—China, Russia, India, Malaysia, and some Central Asian Republics.

There is, however, one sure way to avoid a bloody

civil war. We need to break the present stalemate, since the impeachment process could last till the first quarter of next year. By that time, the national economy would have collapsed and anarchy would have hit the major urban centers of the country. Should that happen, the Armed Forces of the Philippines—with its fast-depleting inventory of munitions due to the Mindanao conflict—will not be able to contain the chaos which will come after the financial bubble explodes. The Praetorian Guards must act with firm and quick resolve, escort “Caligula” out of the Coliseum now, before the lions devour them too.

I will repeat what I have stated but I do not mean to scare the daylights out of my distinguished audience/readers: “I see a REVOLUTION... because we are creating conditions [from] which—when the stock exchange and the national economy convulse—we will have a social conflict. We are creating poverty on a scale we have never seen before.” This could be our last peaceful Christmas.

After the replication of these attitudes and reactions/responses, the other quits trying to offer and you have no opportunity to reclaim the offer—for your own rejection is accepted by them as toward them. Until you can move outside that attitude, you will be both lonely, a tree without support of good foundation—and nobody else will carry you or your load.

Demand for “control” at any manipulation or HELPLESSNESS at all costs are the very means of total co-dependency. BOTH ARE A DEMANDING MASTER OF DECEPTION. The controller does not really WANT to totally control—only to get his/her “way”. The Helpless character does not really want to be guided or take responsibility of learning anything different and certainly does not want a “controller”—but actually requires one to function at all in his/her world of indecision and insecurity.

Don’t get blown out of shape by these statements—just recognize it when it shows up on your doorstep. If all you want out of life is to control or be controlled then co-dependency is fine—for you have the miserable worst of each category. If you want to take change in self for self—you will stop the destructive behavior and both might actually begin to like one another. Moreover, you had better be prepared to LAUGH at yourself in the reality of what you do and not just what you mouth to an audience—who, by the way, KNOW BETTER. The objective audience of whatever age—always KNOWS. Why? Because the audience as individuals are already pretty much masters of “your” game in play.

The most deadly game to SELF is to project: “Look how hard I tried!” This is destructive beyond measure—for usually you have made a “drama” in which all you did was “try”, which is destined to create havoc. You don’t “try” to do something. You either do something or you do not. Try is a most foolish word that lies about itself. Sometimes, however, it is the only accepted term to use in your language of sidestepping

responsibility. Iffing, butting, and trying are your handmaidens for defeat and avoidance of successful accomplishment.

If you want to do something badly enough, you will create a way to accomplish IT. These are often mistakenly called “miracles”. YOU ARE THE MIRACLE, friend, so why don’t you just quit trying and get on with successful experience? If you can think it—you can achieve it! Just be sure you know what it is you ask for!!!

Most people will claim that “I only want to serve God”—or whoever—when really that is just nearly the very last thing really wanted or desired—it just sounds good. Why do you feel a need to say “I’ll do anything...” when what you really MEAN is “except that”, when asked? THESE ARE THE GAMES PEOPLE PLAY.

What happens most often is that when you are crossways with another, you eagerly await the insult to the other to come upon them. There is no point in grudges if you don’t get satisfaction of revenge or witness to loss. I can give you a good example: **YOUR ENEMIES WANT YOU TO FAIL BECAUSE THEY ALREADY HAVE FAILED! DON’T, FOR GOODNESS SALES, GIVE THEM THE PLEASURE OF THEIR OWN MISGUIDANCE.**

So, in closing this writing please be aware of TRUTH: Spirit is the truth of You. It is spaceless, timeless, and without dimension.

Fire cannot burn it and water cannot wet it; wind cannot dry it; weapons cannot kill it; eternal and unbounded and nonchanging, without beginning and without ending, it is nowhere in particular and everywhere in general. LOCATION OF BLAST CANNOT BE TRACED!

DEAFENING BLAST HEARD IN CITY, SEREMBAN
By K. Vijiyan and Sufi Yusoff, 9/22/92

KUALA LUMPUR, MALAYSIA—Police and fire officials are stumped over a deafening blast heard across the city as far as Seremban and Klang.

The blast akin to a sonic boom caused by supersonic aircraft breaking the sound barrier, left housewives, office workers and shopkeepers in jitters and wondering about its source.

Some offices and homes also reported that their window panes were smashed and cracks had appeared on their walls. In some areas like Taman Tun Dr Ismail, electricity supply was cut off.

Housewives left their homes, shopkeepers abandoned their premises and office workers scurried for safety, believing the blast was an earthquake.

This was pooh-poohed by the Meteorological Services Department (MSD).

A spokesman for the department, when contacted in Petaling Jaya, however, admitted that the blast was loud enough for it to record a seismographical reading registering a 56mm ground movement.

However, he said the department was unable to trace the source of the ground movement.

He added that such a reading suggested a violent explosion which was definitely NOT caused by thunder or an earthquake.

The explosion occurred at 1:56 p.m. and lasted several seconds.

Fire and police stations and newspaper offices in the Klang Valley were flooded with calls from curious and frightened people.

Some said it was experimental blasting work by the Defence Ministry or even explosions of its ammunitions depot in Batu Arang, others pointed to Port Klang where there were several chemical plants and oil storage depots which could be on fire and a few thought it could be a huge bomb blast.

Checks with police and fire stations and hospitals in the Klang Valley failed to reveal what had happened.

Police and fire officials reported no major disaster while hospitals also did not have patients with injuries from such incidents.

Selangor Criminal Investigations Department Director Assistant Commissioner Mohamed Ismail Yaman said police were unable to source the blast but were continuing their probe.

Checks with the Department of Civil Aviation showed there were no plane crashes nor any report of a sonic boom from aircraft.

A Defence Ministry official said there was a tattoo rehearsal at Stadium Merdeka but no cannon was fired during lunchtime.

The ministry said no explosion had been reported at any of its army installations.

Quarries contacted said they usually carried out blasting with police help around noon. They, too, could not locate the source of the blast.

A company dealing in explosives in Petaling Jaya said 95 percent of the quarries in the Klang Valley were using "emulite", an emulsion explosive, for blasting operations.

"They only purchase 10 to 20 kg daily and only five to 10 kg is used for each blast.

"It would take many tonnes of the explosive to produce the effect felt today and this is not possible as the authorities are strict about how much is used by each quarry."

The official said he had also not heard of any mishap at any of the quarries today.

BUSHIES FINGERED IN SCAM

Top aides to President George Bush have been implicated in sordid money-laundering scandal.

Acting Secretary of State Lawrence Eagleburger as well as White House National Security Adviser Brent Scowcroft face full-dress congressional hearings and possible criminal indictments after the election, congressional sources have reported. **[H: Realize, please, that this is election politics but where there is this much smoke and other similar incidents exist, it is valid. However, due to "timing" of "leaks" you can know it is being done "now" for obvious political reasons.]** A bank they set up and promoted in New York City has been involved in laundering nearly \$2 billion in stolen funds.

On the trail of covert cash transfers involving vast sums, Swiss authorities have uncovered links leading from major financial institutions in Switzerland and Bulgaria to LBS Bank in New York City, an international money center where Eagleburger served as chairman of the board in 1980-81.

LBS Bank was born of an intimate relationship between Eagleburger and Scowcroft—who were serving, respectively, as president and vice chairman of Kissinger Associates at the time—and Serbia's Communist leaders, congressional investigators say.

"In simple terms, the Serbians were looking to buy influence in the United States; Eagleburger and Scowcroft were selling it," explained a veteran House prober, who has given trustworthy information for nearly a decade, asking only not to be quoted by name. **[H: Note that it is not an "accident" that one, Panich, goes to "run" Yugoslavia just when he was needed by these turkeys. That very man is a wealthy attachment to the San Luis Obispo Connection; and the connection might as well be DIRECTLY placed.]**

HIGH-FLYING CAREERS

"Both men had built high-flying careers in the Washington national security bureaucracy as proteges of former Secretary of State Henry Kissinger. When Kissinger decided to cash in on his worldwide contacts, he set up Kissinger Associates, a high-priced consulting firm in New York City. Eagleburger and Scowcroft joined his firm shortly."

Moreover, the two bureaucrats had long-standing contacts among the Serbian leadership. "For the relationship that developed, built on payoffs, a bank is the ideal instrument," related the congressional prober.

LBS Bank was set up in New York City as the wholly owned subsidiary of Ljubjanka Banka, Serbia's second-largest money center. Eagleburger took over as chairman of the board. Scowcroft served as adviser on behalf of Kissinger Associates, where LBS Bank joined a list of blue-chip corporate clients.

LBS Bank, backed by the Kissinger consortium, soon developed profitable European contacts. Among them was the Trans K.B. Corporation, a cash-rich Swiss investment fund. Headed by two rising Swiss lawyers, Hans Kopp and his wife Elizabeth, Trans K.B. was rumored to have considerable influence in Washington: Mrs. Kopp, nee Ikle, was the niece of Fred Ikle, one of the most powerful U.N. national security bureaucrats of the 1980s.

An ally of Kissinger, Ikle served as under secretary of defense for policy during both Reagan administrations, a post in which he became known as a key supporter of Israel's interests.

One of the shared interests of the United States and Israel at the time was to keep the gulf war between Iraq and Iran going, until both belligerents were exhausted. "It was an era of covert arms sales, intelligence exchanges, and other back-room deals on which the players made overnight fortunes," says Swiss journalist Ernst Boegli, a veteran investigative reporter. "Trans K.B., the financial firm of the well-connected Kopp, had all the right tie-ins to make a killing in the murky market."

It did just that, Swiss law enforcement sources now say. In 1981, the Iraqi government chose Elizabeth Ikle Kopp's firm as the confidential transfer agent for \$2 billion, intended to pay for the purchase of nine high-speed gunboats from Italian shipyards.

What happened next is still under investigation, U.S. probers say. What is known is that:

* Iraq never got its warships.

* \$1.84 billion of the cash intended to pay for them vanished.

* Earlier this year, Hans Kopp was convicted of fraud and related offenses in a Swiss court for his part in the Trans K.B. affair.

SOUNDPROOF COVER-UP

At the time Kopp was found guilty, his wife Elizabeth Ikle had already lost her post as Switzerland's first female minister of police and justice in the wake of another money-laundering scandal. **[H: I wrote about this incident long ago so can only ask that you review that information, for I do not wish to go into it at this writing in more detail than is given herein.]** "The Koppes have been linked to some of the biggest financial scandals of the 1980s," says Boegli.

"But apparently because a number of other influential players, including the U.S. Defense Department and the

CIA, are also implicated in the clandestine transactions, a soundproof cover-up was lowered over the entire billion-dollar mess.”

Privately, however, Swiss authorities warned the U.S. government that one of the money laundries linked to the disappearance of the Iraqi government's billions lost in the Trans K.B. affair was the LBS Bank.

This was the mysterious New York clearing house operated jointly by Eagleburger, the Serbian government and the dealmaking firm of Henry Kissinger—Fred Ikle's long-time ally in the Washington national security bureaucracy.

Congressional investigators are pawing the ground to get at this scandal, House staffers have told the *SPOTLIGHT*.

“Just look at the setup”, says one veteran prober. “Under Fred Ikle, the Pentagon adopts the policy of covert support for Iraq's war machine; so does Israel. Soon afterward, Elizabeth Ikle Kopp's Swiss investment firm receives an eye-popping \$2 billion cash transfer from Iraq for discreet military purchases in Europe. The money—and \$2 billion is a staggering lot of dough—disappears into a dependable money laundry.”

LBS Bank, U.S. law-enforcement sources say, was just such a well-established transatlantic cash cleaner. In 1982, it was indicted and eventually convicted on money-laundering charges in a different case. But that affair was also smothered in a high-level cover-up; Eagleburger was allowed to resign from LBS Bank's board without public censure, and soon he rejoined the Washington power elite as the new Bush administration's deputy secretary of state, the second in command of the U.S. Foreign Service.

Scowcroft followed him from Kissinger Associates into the White House, where he has reigned ever since as head of the powerful National Security Council.

The bitter price of this blatant high-level corruption was paid by the former Yugoslavia's ethnic minorities. Linked to the murderous Serb leader Slobodan Milosevic through the LBS Bank, Eagleburger was in no position to rally U.S. influence against the mounting genocide launched in Croatia and Bosnia by the militias of Milosevic.

“What began as a typical Kissinger and Associates scam for a few million dollars, ended up as a bloodbath of innocent Moslems and other minorities,” concluded Boegli.

JEWISH-DOMINATED FEUDAL ESTATES?

The hint that land will be apportioned to “the

righteous” in sizable estates and the all-powerful position of the Jewish leaders in the Utopian era apparently means that the Jewish planners hope to completely supplant the masters of the old feudal estates. Thus will they at last (if they succeed) bring the revolution full circle.

We find some support for this belief, or surmise, in the economic process in the communist countries: The property was taken away from the gentiles (only a few rich Jews owned property, especially land, in Old Russia and Poland) by the Jewish-communist dictatorship; and by the 1930s and 1940s, certain favored Jews had been granted fabulous state franchises in the Red empire. Miss Karpovskaya, the wife of Molotov (sister of the Jewish importer, Sam “Karp” of Bridgeport, Conn.) was given the perfume and cosmetics concession, supposedly for the entire Soviet Union; the (then) Jewish Deputy Premier Lazar Kaganovic, was put in charge of all the great industrial centers (of gentile slave labor)—quite a sizeable feudal estate. The Jewish financier, Jacob Ashberg, former affiliate of the Rothschild and Warburg banking houses, operating at the Nia Banken in Sweden, handled the finances for the Reds, went to Russia a few weeks after the Bolshevik seizure of power in 1917 and, ever since, has been the dictator of Soviet finance.*

* *THE LONDON EVENING STAR* of Sept. 6, 1948, reported a visit by Ashberg to Switzerland, “for secret meetings with Swiss government officials and banking executives”. Diplomatic circles describe Mr. Ashberg as “the Soviet Banker” who advanced large sums to Lenin and Trotsky in 1917. At the time of the revolution, Mr. Ashberg gave Trotsky money to form and equip the first unit of the Red Army. A spokesman of the Soviet Legation in Berne said, “Mr. Ashberg's visit will be private. He has property in Switzerland.”.... The financial attaché of the Soviet Legation described Mr. Ashberg as “the most unusual man the Kremlin has ever sent to the West. He bears no official title, is attached to no government department, is not in the Soviet Foreign Service and is not a member of the Cominform.”

Note that Ashberg, banker for the Communist empire, was a private capitalist, owning property in Switzerland. Major George Racey Jordan in his book *From Major Jordan's Diaries* (Harcourt, Brace & Co., Bew Tirjm 1952) revealed that Ashberg, during the Second World War, sent a secret message by an extremely secret and important messenger, to “the very big boss” of the revolution in America—Senator Herbert H. Lehman, Jewish banker (for half a century one of the ring leaders of the American Jewish Committee and also of the Anti-Defamation League of B'nai B'rith). We may well believe that Banker Ashberg was for a long time, and may still be, the “very big boss” of the Communist revolution in the USSR. He is without doubt one of the foremost policy shapers of the highly secret self-constituted committee called the Communist Security System (CSS) which runs all Communist governments and all Communist Parties. (End footnote)

The Secret police, which actually constituted the power of, or over, the government, at all times was headed by a Jew, up to the death or liquidation or disappearance of Beria. We have no knowledge of the racial identity of Beria's successor but the “Sheehan Document” (entered into the *Congressional Record* by Rep. Timothy P. Sheehan, August 5, 1957) indicates that there probably has been no change in power; the secret, hidden self-constituted committee called the Communist Security System (CSS) still runs the government and the

Communist Party from behind the scenes and the officials seen by the public are only puppets.

We know that the power of Bolshevism, or Communism, originally was completely Jewish. The Jewish inner clique could do as they pleased with the regime. During the Second World War the regime had to make compromises to keep the whole populace of White Russia and the Ukraine from going over to the invading Germans, and now anti-Communism and anti-Semitism are forcing compromises, and forcing the hidden committee to keep Jews out of conspicuous positions.

Almost immediately after the Communist conquest of Romania and Hungary, it became evident that a few Jewish Reds had divided up the spoils among themselves. Even the internationalist *Time* magazine (Sept. 20, 1948) carried an article describing Bucharest as a city with the air of a pawn shop and told of the complete triumph of the dictator-Jewess Ana Pauker:

“(Ana Pauker) lives in three great houses, moving almost every night because she fears assassins. One of her houses belonged to Prince Brancoveanu. One belonged to Nicolae Malaxa, big industrialist and speculator. And one belonged to red-headed Magda Lupescu, ex-King Carol’s mistress and now his wife.

“Ana replaced them all. The power... has passed into her hands. She runs Romania... She is the leading Communist in the band of states running from the Baltic to the Adriatic... Ana Pauker was born (1903) in Bucharest, where her father, Zvi Rabinsohn, was a shohet, i.e., the man who kills animals in accordance with Jewish rules... Ana went to the Jewish school on Anton Pan Street...

“Through seven huge Sovroms (Soviet-Romanian combines) the Russians (good grief, sic, sic) almost completely control transport, oil, timber, banking and everything else they can lay their hands on, even including Romania’s tiny motion picture industry. [H: If nothing else, this gives away the lie. The Jews have always run the motion picture interests in all nations wherein they have any status at all.]

“... A recent visitor described Bucharest as ‘a city with the air of a pawnshop’.”

Romania was Ana Pauker’s feudal estate. Accusations in America that the Jews were the authors of Communism seemed to have forced the revolutionaries to withdraw Ana and other Jewish dictators from public view and replace them with nondescript characters.

TO BREED TALL, HANDSOME “RACE”

If the plans of the Zionists for conquest of property and people seem fantastic, you haven’t seen anything yet. They plan to up-breed and out-breed their race or tribe into one quite different from the present Jewish strain. **[H: Herein I would suggest you who call yourselves “Jews” pay particular attention—for it is “you” who are intended to “be bred out”.]**

“... A sturdy race of strong, healthy, TALL, youthful and handsome people will be raised.” (p. 58)

“The Holy One thus said: ‘In this era, some people are healthy and handsome, and others are not. But in the ideal era to come, all people will be handsome and praiseworthy.’ This will be in accordance with the prophecy of Isaiah: ‘All that see them shall acknowledge them, that they are the seed which the Lord hath blessed.’... Physical defects, like dumbness, blindness, deafness, lameness, stammering, barrenness in women

and similar bodily imperfections, will likewise, not exist.”

The quotation from Isaiah indicates that the “people” here referred to means the Jewish people, or rather the chosen, “righteous” elements among the Jews.

The most beautiful thing on Earth is human beauty. And the Jewish tribal fanatics are not the only people who have wished their kind more beautiful. Such a wish is normal. Any who does not, either consciously or unconsciously and instinctively, hope each generation of his race and kin will be more beautiful, physically and spiritually, more vigorous and gifted, than the preceding generation must be some sort of pervert. I believe it is generally accepted that the Creator planted in the breast of every man the ideal of his own race and hence the natural urge to see it improve and prosper.

But to set out to make ALL the descendants of present-day Jews beautiful and healthy requires quite a lot of authority over the Jews. Any breeder of good livestock knows the processes by which strains are improved: Kill off all the ugly and unhealthy individuals and breed up only the carefully selected strains. The Jewish planner will have to liquidate untold millions of their own people to stop the breeding of defective individuals and individuals not “tall and handsome”.

All thinking persons doubtless would be sympathetic to a sane and humane up-breeding process for the Jews as well as for each and every race, if the process could be done voluntarily and intelligently among the people themselves—according to the laws of Nature.

Hundreds of writers, speakers and scientists of our time have deplored the progressive degeneracy of the American stock—and some governments in the past have undertaken to improve the stock of their people. Augustus Caesar tried it (with little success) a few years before the birth of Christ, by organizing colonies of settlements of selected families; Adolf Hitler tried it (after his strange fashion) **[H: Ah, but the Adolf Hitler enterprise was thrust forth by the Khazarian-integrated people that became so unpopular as “turncoat” Jews in the German society and co-workers with the Nazi Party. The facts are that it has simply come FULL CIRCLE within and toward the ultimate world order. You will note that the racial “outcome” is identical in intent.]** and the Zionist political and banking machinery went into high gear to induce Nordic Christian anti-Communists of America and Britain to destroy Nordic, Christian anti-Communists of Germany—the best blood of the Anglo-Saxons sacrificed to destroy the best blood of our first cousins, the Germans—the Western world committing suicide, for the benefit of the Communist-Zionist monster.

The one thing above all else which the Zionists could not tolerate was the upbreeding of the race—now much diluted and cowardly—which for over 2000 years had stood between them and world domination.

But notice a striking difference in the gentile and the Jewish advocates of race improvement: The former group idealized the best types of their own race, whereas the latter group want to build a new Jewish race! For “tall... handsome” people are not Jewish, except as the Jews have taken in blood from other racial elements. **[H: Don’t be “thrown-off” by the term “handsome”—for it does not mean in this context that which you perceive. All, and each, race is beautiful or handsome in its own right—what is present here is that the intent is to become handsome and/or beautiful according to “Nordic” or Anglo-Saxon appearance while breeding out the short, dark-haired and -complexioned Middle Eastern appearance. The**

original ones calling themselves “Jews” are the Khazarian Zionists coming from Nordic, Rus (Russian) and Mongol stock. The point is to NOW throw off the remnants of the “stolen” “racial” features that they used for “cover” and come again into the perfection in perception of that which they originally WERE—a band of hoodlums directly from the lineage of Lucifer. You didn’t really think that “old boy” would just go away somewhere did you?]

The Jews traditionally are short in stature and never, so far as I have observed, have been described as a handsome people. Jews of recent centuries class themselves in two ethnic and linguistic groups: the Ashkenazim and the Sephardim. *Webster’s Unabridged Dictionary* defines the Ashkenazim as “the Jews of middle and northern Europe, as opposed to the Sephardim, or Jews of Spain and Portugal.” Of Sephardim the dictionary says “Jews who are descendants of the former Jews of Spain and Portugal. They are, as a rule, darker than the Ashkenazim or northern Jews. They are chiefly settled in North Africa, Greece, the Balkans, the Levant, Holland, England and America.

For many generations the Sephardic Jews considered themselves so far superior to the Ashkenazim that they would rarely intermarry. They traced their culture (and some blood) to Spain of and preceding Isabella’s time (before Isabella expelled most of the Jews to save Spain). But in the past two centuries they have virtually wiped out the lines of distinction. The Ashkenazim in Northern Europe had taken in much German blood; while in Eastern Europe and Asia they had for centuries absorbed blood from the Khazars and other dark, coarse Asiatic, Mongol elements. Thus there are in reality two divisions of Ashkenazim—though both speak Yiddish, a composite of German, Polish, Russian and Hebrew, using Hebrew characters.

It might be said that the Mediterranean Jews, also, are divided into two almost distinct groups: the elements from Ethiopia and the Eastern Mediterranean, with dark skin, thick lips, noses curled downward, heavy lids and kinky Negroid hair; and those interbred with southern and western European stock. (There are, of course, in small numbers, Chinese Jews, Japanese Jews, Philippine Jews, and so on.)

The Mediterranean Jews generally have lost leadership during the past century, while the more virile “German” Jews have risen in finance, in science, in commerce and in political influence. But towering above these in fanaticism, cold-blooded brutality, cunning and political organizing are the “Russian-Polish” Jews. Anna Rosenberg (*And there is abundant evidence that Mrs. Rosenberg was a Communist. The former Communist, Ralph de Sola (himself Jewish) swore before a Senate committee that he had known her as such, and the December 8, 1942, issue of the then-official Communist organ, New Masses, carried a pen drawing of her, fully identifying her as “NY Regional Director, War Manpower Commission”, with an article contributed by her to that Red paper, copies of which still are to be found in some public libraries*), Harry Truman’s appointee as Assistant Secretary of Defense, has some of the features and characteristics of both the Ethiopian and the Russian-Polish Jews: heavy skin, coarse black hair, hooked nose, black or dark brown eyes with heavy, Oriental lids, coarse, crude, vulgar features and a fierce fanaticism which knows no conscience but is utterly brutal. (Generals who suffered humiliation under this small strumpet’s tongue-lashing say she was as foul-

mouthed as any sailor.)

Bernard Baruch might be cited as one example of the “German” Jews. Standing six-feet, four-inches tall, he obviously has a great deal of “European” blood in his veins. He has the Jewish nose and a type of Jewish mouth; but by comparison with so many of the crude, almost hideous Mongol and Semitic-Negroid Jews, he may well have been described as handsome in his younger days.

Strange to say, his Nordic blood has not eliminated the Jewish temperament, entirely, for his life has been steeped in secrecy, cunning and intrigue. It was he who maneuvered to get Truman to appoint Anna Rosenberg; it was he who, with Communist-friend Dean Acheson, drew up the plan to give all our atomic defenses over to a United Nations world police force or dictatorship, as soon as the Soviets would agree to inspection of their war plants—inspection not by Americans, mind you, but by persons appointed by the Jewish-inspired United Nations! Mr. Baruch’s trap may be sprung on us at any time, for our government has publicly committed us to the plan.

During the past two centuries thousands of Jews have inter-married with the British aristocracy. For the most part, they retain the names of the once-great Anglo-Saxon families; they hold the estates; they speak English with a British accent. They had developed a great deal of loyalty to Britain and almost forgot they were Jews until the war with Hitler subjugated them for Zionism. Many of these English Jews are fine individuals, physically and intellectually; many are three-fourths or more Anglo-Saxon.

There are also many handsome French and Spanish Jews, though not very tall as a rule; and some of their women, like some of the English and German Jewesses, are very attractive.

Only by such interbreeding with other racial elements—with tall and handsome people—can the Zionists raise up a breed of “tall and handsome” Jews for Israel. For like begets like; you cannot breed up a line of race horses from plow horses or mules. The genes of your ancestors determine whether or not you are to be tall and handsome.

This strange adoption of the racial ideals of another race is a tantalizing phenomenon. It reminds me of the theory of some students of ethnology that the reason the Jewish propagandists hate and ridicule the “pure Aryan” Anglo-Saxons and other northern Europeans is that they are jealous of the fair complexion and the refined features. Mr. Higger’s *Jewish Utopia* tends to confirm this theory.

BLOND JEWISH CHILDREN?

Reports almost incredible are coming out of Israel to the effect that many of the children, unlike their mothers and fathers, are blonds, even with Northern European features. An article by Adrian Crawley in the *London Daily Telegraph* of May 25, 1938 said:

“Fair hair and blue eyes are so common in Zionists that not even the most blatant Anglo-Saxon can prove his identity.”

Anne Sharpley in the *London Evening Standard* of November 6, 1956 says of a Jewish couple in Israel:

“She and her husband are dark-haired, but by the same strange alchemy that affects all Israel-born children, their baby son is fair-haired. Israel-born Israelis (called Sabras) can be immediately spotted all over the country. They are bewilderingly blond and big.

If you saw them in Whitechapel you would swear they were Swedes.” [H: **So, chelas, use a bit of “deduction”; what think ye that might be going on here? The most modern genetic DNA alterations are done by the Zionists in Israel. The first life-form was “created” in Israel in the form of a crystalline virus! I think you may begin to see the picture if you give attention to it.]**

Blue eyes and light hair come from the genes of only one race in the world, the northern or Nordic, from mostly around the Baltic. There are light brunette Nordic strains (with fair skin) but no other race produces a strain with blue or grey or light hazel eyes and red, blond or light brown hair. Wherever you see these characteristics, you see evidence of Nordic ancestry. Whether Jew or African, Chinese or American, Italian or Spanish, the individual with these features is at least part Nordic.

Whence comes the “blond blood” in Israel of this generation? A brief item in the *California Jewish Voice* of June 28, 1957, may be related to this question:

TEL AVIV (JTA) (for Jewish Telegraph Agency)... *Many children and teen-agers brought to Israel recently have developed deep personal problems as a result of the sudden awareness that they are Jews, Moshe Kol, head of the Youth Aliyah movement reported here.*

“Mr. Kol declared that some of the youngsters who did not know they were Jews—until brought to Israel by the child rescue movement—suffered psychological shock. For those who cannot cope with this shock, the Youth Aliyah leader continued, individualized attention is provided in Youth Aliyah centers.”

Who are these children? Could they have been German and Scandinavian, and perhaps British war orphans, taken over by Jewish agents during and immediately after the war? Could some of them have been “rescued” from Dresden while we, under Jewish incitation, were bombing the women and children of that open center of culture during the Second World War?

There are only two ways by which parents “homogeneous for dark hair and eyes” could acquire blond children: by adoption or by artificial insemination. If the newspaper reports of fair Jewish children in Israel are true (and I have seen numerous such reports), then these children are adopted or are from artificial insemination (unless there were blond fathers who are not the supposed fathers).

It is not uncommon practice in our time for a mother to bear a child from male sperm artificially planted in the womb. It now appears that both the male sperm and the female egg probably can be successfully planted in the womb. If so, a Jewess or a Negro woman could give birth to a blond “pure Aryan” child, which would not be related to her and have not a drop of her “blood” in its veins.

We can only wonder about this process, which seems related to Mr. Higger’s book of wonders.

ISRAEL JEWS FOR CANNON FODDER?

It is significant that Mr. Higger says the inhabitants of Israel eventually will be “selected”:

“Since the city (of Jerusalem) will be the capital of the land of the righteous, its inhabitants will be a selected group of upright and just. In

the terminology of R. Johanan, in the Jerusalem of the present era, anyone may enter; but in the Jerusalem of the ideal era, only those who will be invited will be permitted to enter.”

Mr. Higger says the Jews will have many children. This craving is emphasized frequently in his *Utopia*. (A recent news dispatch says the birth rate of Israel now is higher than that of India.)

Higger analyzes the dictates of the various rabbinical and other Talmudic authorities on the subject of proselytes and concludes that the consensus of opinion is that “multitudes of proselytes will be absorbed and assimilated” by the Jews.

But only proselytes, of course, who accept the Utopian program. We would not suppose that these will be invited to Jerusalem.

While this racial plan for the Jews is of importance to us—in view of the Zionist strength and the fanatical intent to accomplish the Zionist aims—the plan is even more important to most of the Jews of this and other countries, including Israel, for apparently few of them will be chosen. Certainly, if we analyze this plan correctly, the millions of Jews who are not tall and handsome, who are not vigorous and well formed, or who do not otherwise measure up to the master-race requirements, will have no place in the Zionist world. They will not be invited to Israel. They will not be permitted to have children, or at least not grandchildren. They will be eliminated no less than those gentiles who prefer to retain their independence, their culture and their race. The Jews now in Israel—or most of them—evidently are not to be the chosen ones. We must suppose, in fact, that they are to be used as cannon fodder; that they are to be slaughtered so the Zionist machine can cry persecution and rally us stupid Anglo-Saxons to fight the enemies of the Zionists—our Arab friends—clearing the land for Jewish conquest.

If the Zionist plan were one to help upbreed all the races, to improve their intellectual and physical beauty in each generation, the whole world could enter into it with pride and the fullest cooperation. Unfortunately, it is quite the opposite; it is a plan to subjugate or eliminate all but the “master race”.

Observe the contradictory position in which the propaganda machine has put the Anglo-Saxon or Negro or Japanese who loves his own race, and wants it to survive and do well: This racial loyalist is logically bound to be a friend and ally of every other race, anxious for it, too, to survive and prosper. Yet the Zionists, who want to destroy all but their own, have managed to put the onus of scare-names on the man who loves the separate races. He is a bigot, a race hater, a White supremacist, a White chauvinist, an anti-Semite and so on.

The betrayal is most often long ago committed in emotional conflict—allowing for outside influences to intrude. This usually comes in the form of sympathy, understanding and lack of responsibility to the circumstance—only the need to listen or interact in some way physically or emotionally. The problem rests still with the original interchange persons. This is why “affairs” are so prevalent. Most couples in an affair could not last in marriage with responsibility six weeks—for if the problems of the persons involved are not solved, then they will only present in greater show-and-tell when bound by the same set of circumstances as originally displayed.

ISRAEL TO EXPAND

It is not uncommon to hear the question: *Is Israel bent on territorial expansion?*

The answer can be found in many places. *Time* magazine, August 16, 1948, page 25, quoted David Ben-Gurion, Israeli premier, as saying to a *Time* correspondent:

“We would not have taken on this (Arab) war merely for the purpose of enjoying this tiny state... There have been only two great peoples: the ancient Greeks and the Jews... Maybe, when the present process is finished we too will degenerate, but I see no sign of degeneracy at present.”

Time’s correspondent reported that as Ben-Gurion spoke: *“The labor politician was replaced by the*

prophet. A dreamer's stare veiled his blue eyes.* The room was small but his voice throbbed loudly, as if speaking to multitudes against the winds on Mount Carmel."

* *The Ladder of History*, a high school textbook (MacMillan Co., 1945) says of the origin of Greece:

"... a golden-haired race called the Greeks began (probably about 1000 years B.C.) to settle in the big midway island of Crete, and on the north side of the Mediterranean Sea around the straits connecting with the Black Sea. They were much like the Aryans who were invading India... They were a delightful people, indeed, who contributed so much to poetry, art, sports, trade and liberty that their memory has been kept fresh by all peoples since, in gratitude and admiration... These nomads from the north were not the swarthy people of today's Greece, but a tall, muscular, blue-eyed race.... They never numbered more than a few millions, and they really flourished for about five hundred years only (from 600 B.C. to 100 B.C)... But to us they are the most important people of ancient times, for they became the teachers of all Europeans and all Americans of European origin. (End of footnote)

Ben-Gurion further indulged himself in his vision of a Jewish master-race:

"We had a message to give the world but the message was cut off in the middle. In time there will be millions of us—becoming stronger and stronger—and we will complete the message."

Professor Higger told us even more specifically that Israel would expand:

"I will open rivers on the high hills and fountains in the midst of the valleys; I will make the wilderness a pool of water, and the dry land springs of water.' The boundaries of the land will be enlarged and widened and its immediate spiritual, ethical and moral influence on the neighboring countries will be evident and very great."

If Israel continues its militant march, its people will rebuild Jerusalem into a fabulous glittering city, as previously described.

"The rebuilding of that city is a part of the plan of the ideal country, Zion. Jerusalem will be the capital of Zion."

Ben-Gurion, daring, arrogant premier of Israel, knew his Zionist program when he moved the capital of Israel from Tel Aviv to fabled Jerusalem (in defiance of the timid, spinelss restraints of the Western nations). Why should Ben-Gurion fear the wrath of Harry Truman, the total politician? Not a finger was lifted to restrain the rugged Zionist enemy of Western nations and races, though he provoked our Arab allies almost to the point of war which might then—and may yet—atomize the world.

Mr. Higger's dream of world peace and the constant "propaganda for peace" by the Zionists (like the Communists whose basic literature always calls for an ultimate war to destroy the free world) are not to be taken seriously, in view of his revelation of the plan to deliberately bring about the mighty Armageddon—a war to make the world destroy itself. Peace probably is the dream of all races and tribes. But a study of the racial history of Europe indicates that there would have been few wars, probably no major wars, but

for the organizing of the Jewish peace-propagandists to make the non-Jews grind themselves to bits. The supposition is permissible that the Jewish strategists want peace—after they subjugate all opposition and potential opposition.

The question is, whose peace or whose wars are we to "enjoy"? Is man to be free to follow his conscience and worship his own God, or must he accept the conscience and God of the Zionists?

THE REQUIREMENTS FOR THE "RIGHTEOUS"

What specifically is or are the requirements of joining the righteous? What must you do to be saved, by the Zionist standards? What is the Israelitic, or Zionist program we must embrace? Everywhere, the author makes the answer clear: We must embrace world brotherhood and internationalism; we must oppose the capitalists and embrace Socialism, and we must hate and oppose the "anti-Semites".

These are the requirements for the nations; they are also the requirements for individuals, as he repeatedly makes clear. For instance:

"The ideal Jerusalem, the capital of the ideal Zion, headed by the ideal house of David, will have her foundations rooted in universal brotherhood."

Your country will be called unrighteous and will be destroyed if (1) it is a capitalist nation; (2) if it opposes Israel; and/or (3) if it does not embrace the above mentioned universal brotherhood.

"The unrighteous nations, as typified in the traditional Esau... will not share in the ideal era. Their rule will be destroyed and will disappear from Earth before the ushering in of the millennium. The wickedness of these nations will consist mainly in accumulating money belonging to the people, and of oppressing and robbing the poor... Another group of wicked nations, as typified in the traditional Edom and Rome (Rome burned Jerusalem trying to suppress Jewish subversion) will suffer the same fate as the first. Their unrighteousness will be characterized by corrupt governments and by their oppressions of Israel."

Notice that it is wicked for other nations to have money, for they oppress the people; but it is "ideal" for the Jewish Utopians to take over all the wealth of the world.

Notice that it is unrighteous and wicked ("anti-Semitic") to oppose Israel, but the entire plan of *The Jewish Utopia* is a plan of opposition to gentiles, a plot to subjugate them or wipe them out.

Thus, the present Zionist and Communist programs preaching brotherhood, racial integration, Socialism, UNESCO, the Genocide Pact, the so-called *Covenant of Human Rights*, the glorification of the United Nations, the constant undermining and ridiculing and belittling of patriotic nationalism (among non-Jews), the swift and violent attacks on any non-Jews who express pride in their race, the coercive "Fair Employment Practices" laws ("FEPC"—forcing the White man to employ persons of the various races in his community, though White men may go jobless); the cry of anti-Semitism; the world give-away program of our money to uplift all the

other races at the expense of our children and grandchildren who are thus saddled with fantastic debts—all these propaganda and organizational drives identify themselves as part of the program of Jewish nationalism, or Zionism—all moving us toward the goal of *The Jewish Utopia*.

Now that we have seen the full plan—the goal of "world brotherhood" under a Jewish dictatorship—we need not ask who originated the above-mentioned propaganda and organizational drives which sweep and shake our country like a windstorm. Jewish organizations and newspapers make no secret that Jews inspired all these internationalist movements; but we no longer need to be told, for the Jewish fingerprint is on them, every one.

By the *Utopian* definition, religion is no longer the worship of God; it is the political-economic-social-racial gospel of Communist "fronter" Bishop Oxnam and fellow travelers:

"... religion is to be the love of mankind... Nations as well as local organizations will have to establish brotherhood..."

How plain could the author make it? Think of the thousands of local, national and international "brotherhood" organizations which have been put together in our time—and think of their influence in softening and intimidating our people.

It will give us a fair, if frightening, estimate of the ability of the Zionists and Communist machines to reach a dominant position over our unsuspecting people, to remind ourselves that in many of our schools, especially public schools, mental exertion and intelligence have been largely subordinated to "brotherhood"—"social adjustment", meaning largely racial "adjustment"—the acceptance of all the dark races in our social life in utter disregard of our own racial and family future. Our teachers, oblivious to and unaware of the Jewish power machine, have adopted its program.

The master strategists must know what they are doing to us. They must know that never in history have White and dark peoples mixed socially—that they did not presently interbreed, and never has such interbreeding reached advanced degrees that it did not result in chaos and general degeneracy, with utter moral abandon, and crime rampant.

I do not pretend to be wise enough to explain all the reasons why this is so; I do know that it is so. One obvious explanation, at least in part: As long as a racial element, or tribe, White, Black, Red, Yellow, or Brown, lives in homogeneous relationship—having its own culture and conscious obligations of tribal or racial citizenship—the accompanying pride and the training in the ancestral code of conduct maintains moral stability. When the tribe or race breeds out with others, it loses the pride, the consciousness, the sense of obligation.

Even the Jews, despite their rigid code, interbreed quite a bit, in contact with other racial elements; but their interbreeding is nearly always upward in their own opinion. Our out-breeding can only, therefore, be downward (by their own estimation). The Jews stand to gain; we stand to lose. [H: Please understand that this does not have to be "factual"; it simply IS true—whether it be by intent or simply by accident, you come out with the same conclusion. A White child cannot help being white any more than a dark-skinned person can help being dark-

skinned. There is obvious difference in physical aspect—THEREFORE, IT AGAIN COMES TO REASON THAT IN THE EQUALITY OF GOD'S PROJECTION AND LIKENESS OF "IMAGE", IT HAS TO BE REFLECTED IN THE ENERGY FORM (SOUL), FOR SOUL IS "LIGHT" AND LIGHT IS ALL COLOR—ALL THAT "IS"!]

Another reason for racial degeneracy and the decline of White civilization—wherever the White race progressively interbreeds with the dark—is the much lower level of moral requirements and the lower level of energy and constructive imagination among the dark elements. As for crime, the police records in all our big cities show a fantastic difference and the FBI had the courage to publish a pamphlet *Uniform Crime Reports For the United States and Its Possessions*, issued by the Federal Bureau of Investigation, United States Department of Justice, Washington, D.C. Volume XXIII, No. 2, Annual Bulletin, 1952, showing an analysis of the principal crimes in our cities, by racial elements. Under the caption "Race", on page 117, this bulletin (available at the Government Printing Office) reads:

"More than 98 percent of the persons arrested in 1952 were members of the White and Negro races. Almost 73 percent were members of the White race while slightly more than 25 percent were reported as members of the Negro race. The balance were Indians, Chinese, Japanese and other races."

[H: There is a breakdown according to arrest, type of crimes and thus and so—but the date of 1952 so far outdates the reflection of today that there is no real purpose in reprinting it here. It is noted that Jews are not separated from "White". I feel that repeating such information as given in the breakdown gives nothing except more basis for "hate"—which we have to assume was the overall purpose in such a publication in the first place. UN CRITICIZES ISRAEL ON PALESTINIANS

UNITED NATIONS (AP)—In an annual ritual, the General Assembly on Friday strongly criticized Israel's policies toward the Palestinians and called its presence in Jerusalem and the Golan Heights illegal.

The Palestinians expressed hope that the overwhelming support from UN members would send a message to Israel that "its position and practices are unacceptable," but Israel rejected the non-binding resolutions as outdated and one-sided and reiterated its willingness to compromise for peace with all its neighbors.

The United States was the only country to join Israel in voting against all four Palestinian-related resolutions, and a resolution demanding Israel's withdrawal from the Golan Heights which Syria wants returned unconditionally.

As it did last year, the United States abstained on the resolution calling Israel's administration of Jerusalem "illegal and therefore null and void" because the city's final status is subject to negotiations between the Israelis and Palestinians.

"Only Israel has voted against this resolution," the Palestinian UN observer Nasser Al-Kidwa noted, "and this means very clearly that the whole world is on one side and Israel is alone."

During the two-day debate in the General Assembly, many countries blamed Israel for the upsurge in Mideast violence over the past two months which has killed more than 290 people, the vast majority of them Palestinians.

Despite recent setbacks, Israel's UN Ambassador Yehuda Lancry said "tremendous progress has been made in turning enemies into partners for peace."

He accused Iran of supporting the terrorist activities of Hezbollah and of engaging in "terrorist activities aimed at Jewish and Israeli targets around the world."

The Israeli ambassador also accused Iraq of persisting in developing weapons of mass destruction and refusing to allow UN weapons inspectors to return. He warned Lebanon that continued terrorist attacks and its failure to deploy troops on its southern border with Israel as required by UN resolutions "carries with it a danger of imminent escalation."

These accusations spurred two rounds of verbal sparring after the resolutions were overwhelmingly adopted—the four on Palestinian-related issues with over 100 countries voting "yes."

Iranian diplomat Mehdi Hamzei referred to Hezbollah as "freedom fighters".

Noting that Iran has signed all major disarmament agreements, he said it was "astonishing" that Israel, which has not, had made accusations about Iranian weapons of mass destruction.

He and Iraq accused Israel of having the largest arsenal of weapons of mass destruction in the Middle East.

Lebanese Ambassador Selim Tadmoury accused Israel of violating his country's land, sea and airspace. When Lancry complained about Lebanese civilians

throwing stones across the border at Israeli soldiers, he retorted: "Does he want people who spent 22 years under occupation to throw roses and rice?"

[JR: Whenever pressed to abide by the rules set forth for other nations Israel always manages to either ignore or will divert the issues. She now accuses Iran of Hezbollah activities and is warning Lebanon to protect her southern borders with Israel or else. Is this a nice way to show willingness to make compromises for peace? The U.S., in all fairness to "democracy", should place conditions on our support or withdraw it. Let Israel stand alone for once and answer her accusers.]

AS TROOPS DIE, ISRAELIS QUESTION SETTLEMENTS

KFAR DAROM, Gaza Strip—For two months Avishai Menkes has tried not to ask himself too many questions about the 300 Jewish settlers he is safeguarding on the front line of the Palestinian intifada.

Every morning, the Israeli army lieutenant dispatches his soldiers to escort settler buses up a road where hidden bombs may await. Every evening, his troops duck bullets from "Sniper House" or other Palestinian dwellings that encircle the tiny, isolated outpost he commands.

Protecting the settlers is the soldiers' duty. Comprehending why they are all under fire in Gaza is a different matter.

"I don't think about this question. It would drive me nuts," said Menkes, 22, climbing a sentry tower that is now too dangerous for his sentries. "I respect the settlers but I don't understand them."

As the Mideast death toll rises and Israel prepares for new elections, the rest of the country is posing the question that Menkes avoids: Why, many ask, are the lives of soldiers being lost protecting settlements that have little connection to Israel, violate international law and would be gladly turned over to the Palestinians by a vast majority of Israelis?

In eight weeks of clashes, six Israeli soldiers have died in Gaza and dozens have been wounded. And the army has dished out far worse punishment to local Palestinians, engaging in 12-hour gun battles, bulldozing acres of citrus groves to eliminate hiding spots for terrorists, and enforcing blockades of gasoline and other products.

What to do with the Gaza settlements, under siege like never before, is part of Israel's debate with itself as it searches for a way to end the new Palestinian uprising. It is a dilemma that will intensify as the election campaign unfolds and Ehud Barak works to salvage his premiership with a final peace deal.

Many Israelis have rallied around the settlers now that they are in peril, and government officials say not one trailer will be evacuated until the violence ends. But Barak knows as well as any soldier that there likely will be no final peace until the Gaza settlements are removed from Palestinian land.

“Obviously, it is difficult to bring up the issue of removing settlements while children and people are being hurt and killed, [but] in the long run we have to be rational,” said Zehava Gal-On, a lawmaker from the dovish Meretz Party who campaigns against the settlements.

“We need to ask ourselves: Do we want more people to die over a settlement in the heart of Gaza? Do you realize that every time an Israeli child who lives in a settlement in Gaza wants to go for an afternoon activity, an entire military convoy needs to secure him?”

In a speech that opened his election campaign Thursday, Barak outlined a new proposal for a long-term interim agreement with the Palestinians. He said his proposal would recognize a Palestinian state and give the Palestinians 10 percent more of the West Bank than was offered before, while postponing solutions for Jerusalem and the Palestinian refugees for two or three years.

Palestinian leaders rejected the proposal, saying they would insist on a final agreement because, they say, the Israelis have failed to implement previous interim deals.

Barak insists that 80 percent of 190,000 settlers in the West Bank would be allowed to remain under a peace deal, but he has never spoken about preserving the 16 Jewish settlements in the Gaza Strip, which are home to some 5,000 Israelis.

Spread out along the Mediterranean coast, the 16 settlements stick out like red-roofed chunks of suburbia among the sand dunes and densely-packed villages where 1 million Palestinians live in Gaza. Synagogues and palm trees tower over rows of bungalow houses.

The difference is the barbed wire, lookout towers and army bunkers, plus the tanks and troops at every intersection. Since last week, when a bus from Kfar Darom was bombed, killing two adults and severely injuring five children, the earth on either side of all entrance roads has been torn up and bulldozed flat for 100 yards in both directions.

Established after Israel captured Gaza in the 1967 Six-Day War, the settlements were inhabited at the urging of the government, which wanted a security buffer against an invasion by Egypt. Today, they are home to huge greenhouses and a thriving agricultural business, although peace activists assert that up to half of some settlements are empty or inhabited by laborers from Thailand....

Demonstrating at an army base last week, Noam Koenigsberg, 27, a father of two from Michigan who teaches at a Talmudic college in Nevet Dkalim, was asked how the settlers can risk the lives of their children by remaining in such hostile territory. He said the children play an important role in preserving the settlements.

“If it’s just a bunch of men in dormitories here, the government would have no problem evacuating it,” he said. “It has to be settled, and that means families living normal lives.”

Most Israelis have long been ambivalent toward the Gaza settlements. The recent violence has made some more sympathetic and others more hostile to what they see as burdensome obstacles to peace.

Netzarim, one Gaza settlement, “does not exist on any map of a future agreement, not on Barak’s, not on [Benjamin] Netanyahu’s, and as far as I know, not on [Ariel] Sharon’s,” Nahum Barnea, one of Israel’s leading newspaper columnists, wrote last week. “It was not evacuated before today, not because the decision-makers wanted to keep it, but because they were scared to pay the political price entailed in a decision to evacuate.”

In his column, Barnea criticized an Israeli army general for telling Gaza settlers that they are a miniature

reflection of Israel itself, both surrounded by hostile Arab territory. Barnea turned that argument on its head, arguing that Israel soon may become as isolated and vulnerable as the Gaza settlements “if no way is found to reach an agreement with the Palestinian side.”

For the soldiers protecting the settlements, the arguments are academic. All they know is that the shooting starts at about dusk every night, and that roadside bombs can be a feature of almost every journey in their Jeeps or the big armor-plated trucks they call “safaris”.

The casualties so far have been relatively few but they have been hard on morale. Two soldiers were killed when a Palestinian police officer dug under a fence and shot them. A stray bullet to the neck felled an officer at brigade headquarters. A bomb killed a soldier at what was supposed to be a joint security office shared with the Palestinians....

“My unit was the one that closed the gate in Lebanon” when Israel ended its occupation there, said one soldier, peering through sandbags at a row of shot-up Palestinian buildings. “In 20 years, they will say we withdrew from Gaza. In 40 years, will they say we withdrew from Tel Aviv?”

Menkes, the lieutenant in charge, said he knows the children who were maimed in the bus bombing and feels guilty he could not protect them. He said he would never bring his children into Gaza, but he wasn’t sure evacuating the settlements would end the conflict.

“We’re here because of Oslo, not because of the *Bible* or something spiritual,” said Menkes, a suburban Tel Aviv resident who once played on Israel’s national handball team. “By law, the settlers can live here and they have a right to be protected. They know that ultimately we are here for them.”

[JR: The Israelis have occupied Palestinian lands in violation of international law and have 16 settlements with 5,000 Jews nestled among 1 million Palestinians. Is there something wrong with this picture? Why have the UN and the U.S. in particular left this situation unresolved for over 30 years? Wouldn’t it be worth it for the Israelis to just move these settlers out and show the Palestinians and the rest of us that Israel is committed to peace? The point here is that maybe it is not really peace Israel wants, but land—lots of it.]

ACHIEVING MIDEAST PEACE

EVANSTON—As a Jewish woman I have been struggling with how to respond to recent events in the Middle East. I read the *Tribune*’s news and editorial coverage, watch television news, look for Internet sites to garner additional viewpoints, and I search my own conscience as tragedies unfold for both Palestinians and Israelis.

I do feel, in my heart, that in order to achieve peace in Israel there must be justice for Palestinians. Israeli Arabs must be granted equal rights. Economic disparities and the ability to buy land need to be addressed for Palestinians living within Israel’s current borders. People living in the occupied territories, the West Bank and Gaza Strip must be able to live without fear, must be able to get to their jobs in order to provide for their families and feed their children. They must be freed from the fears that armed settlers will shoot at them. Illegal settlements

must be disbanded immediately.

There is a huge power differential in this conflict. The Israeli military is one of the strongest in the world. It has access to and uses tanks and sophisticated weaponry, including helicopter gunships.

Although the Palestinians do have access to some arms, they do not have the military capability of Israel, thus are primarily armed with stones, rocks and slingshots.

There must be an acknowledgment of the inherent humanity of Palestinian men, women and children.

There must also be an end to the demonization of an entire people, and an end to the mistaken notion that Palestinians care less about their children than the rest of us do.

I found an example of that disturbing dynamic played out in Michael Kotzin’s Nov. 3 Commentary piece. Kotzin said, “The regrettable Palestinian casualties, often suffered by youths who are cynically sacrificed on the altar of the Palestinian cause, are used to gain sympathy from the West and to further incite Palestinians.”

We don’t question that Israeli youth are sacrificed by serving in the Israeli army; we don’t remind Israel of its own use of children during its War of Independence, when groups like Irgun and Hagana routinely used 14- and 15-year-old boys in their attacks on Arabs.

Are we really to believe that any family would choose to put its children in danger to gain sympathy? Or that Palestinian fathers and mothers love their children differently than our fathers and mothers love us?

Within Israel many Jews call for peace and justice; there are vigorous debates as to how peace might someday be achieved. In the United States, however, the Jewish community has, for the most part, uncritically supported Israel, including its military and intelligence-gathering methods.

I call on the Jewish community to question the current assault on and killing of Palestinians. I don’t believe we can stand silently by when we see injustice. **[JR: Here is a voice of reason which is being drowned out by the cacophony of words and opinions expressed by Jews in our Zionist newspapers. The Israeli government is sponsoring tours to Israel to visit selective sites that only promote a positive attitude towards their Zionist policies. The spin has been successful in capturing the hearts and wallets of those who are so far removed from the chaos. How many of us are attracted to those who want us to remain blind and ignorant and never see the truth?]**

BETHLEHEM CALLS OFF CHRISTMAS

The hopes and fears of all the years may well be met in Bethlehem this year. But Christmas has been canceled.

After two months of violence, a Palestinian uprising and an Israeli closure of the West Bank town, city officials have called off elaborate festivities for the Bethlehem 2000 Project—designed to bring international choirs to sing carols in Manger Square, pilgrims to pray in the Church of the Nativity and tourists to celebrate the new millennium in the birthplace of Jesus.

There is too much risk of bloodshed. Arab snipers fire nightly from Bethlehem’s Christian suburb, Beit Jala, across the valley at Jewish homes in Gilo on the outskirts of Jerusalem. Israelis fire back with machine guns, tank

shells and helicopter-launched missiles, blasting buildings. Shepherds watching their fields by night in nearby Beit Sahour hear only gun battles as tracer rounds light up the sky. No one, it seems, has a deep and dreamless sleep.

What a tragedy, not just for Christians, but for Jews and Muslims as well. The violence has been disastrous for the Palestinian Authority, which had invested much in Bethlehem's economy, hoping to make it a tourist mecca. For Israel, the fighting has torpedoed the tourist industry. For Christians, there is only sadness at a time when they would normally be counting their blessings.

The hopes that the Mideast peace process would bring stability to the troubled land have been dashed. Fears and mistrust have replaced the confidence that brought Israelis and Palestinians together to sign the 1993 Oslo peace accords. Yasser Arafat's self-rule government later took control of Bethlehem and other towns in the West Bank. Christmas 1999 marked celebrations that made architects of an emerging Palestinian state proud hosts of a new era. This season, the millennium-year festivities were supposed to draw Christian pilgrims from around the world, as they did last year and as they did when Pope John Paul II visited nine months ago to hold a Mass in Manger Square.

Now Christmas lights are dark. Arab Christians insist they will continue as planned with modest services in Bethlehem and observances in the age-old shepherds' fields nearby. But even there, gunfire erupts regularly. An Israeli helicopter recently fired rockets to assassinate a Muslim militia leader, Hussein Abayat.

Christmas will be observed in a quiet and careful way, but it comes this year amid heartbreak, sadness and bloodshed. At least eight Palestinians from Bethlehem have died since violence erupted. In recent days, fierce fighting exploded around Rachel's Tomb, a Jewish holy site. The Arab restaurants and the hotels are empty. Many of the Christian souvenir shops along Manger Square are shuttered. There are no wise men on the horizon, and humanity's better angels, sadly, have gone missing.

If this season has any power to lift the human spirit, let it do so in Bethlehem—this year, of all years, despite barbed wire and sandbags, tanks and helicopters, gunfire and stones. As an era of hope for Mideast peace dissolves into war, Bethlehem may hardly seem the symbol of peace on Earth right now. Yet for many, it could never be anything less. Its dark streets cry out for peace, justice and prayers—everyone's prayers.

[JR: The events leading to the cancellation of planned festivities in Bethlehem have to be seen as deliberate on the part of the Israelis. Christians should be concerned that this situation doesn't lead into the destruction of the town in which the Christ Child was born. We in the U.S. are being programmed not to acknowledge Christmas, but to accept a generic "Winter Festival" season with no mention of Christ. Too many "Christians" today are confused by believing they are now Judeo-Christians (an oxymoron) and forget the special meaning of this particular day as the celebration of the birth of Christ.]

CALLS GROW FOR BOYCOTT OF U.S. PRODUCTS IN WEST ASIA

DUBAI—Denouncing the United States' support for Israel, clerics across West Asia have stepped up calls

for the boycott of American products.

Top Lebanese cleric Sheikh Mohammad Hussein Fadlallah appealed to Muslims Tuesday to boycott U.S. goods in solidarity with the Palestinian intifada (uprising) in the West Bank, Gaza and Jerusalem.

"The easy way for Muslims to change what is being done to our Palestinian brothers is to impose a boycott on all those who support the Zionist enemy (Israel), and especially the United States," he said.

The cleric called the U.S. "the arch-foe of Muslims and Islam". He also called on Muslims to put pressure on their governments to stop them from depositing money in American banks.

The leading Islamic scholar and grand mufti of Egypt, Sheikh Nasr Farid Wasel, has decreed buying of U.S. and Israeli goods as "haram" (sinful), according to an Arabic newspaper report.

These calls follow similar appeals in the Gulf states against several U.S. products.

On Monday, a commentary on Iranian state television asked Islamic countries to shun U.S. and Israeli goods.

In the United Arab Emirates, leaflets have been distributed, listing dozens of U.S. consumer products and companies to be boycotted by Muslims.

Most West Asian governments have so far refrained from commenting publicly on such calls.

Reports suggest that the calls have resulted in a drop in demand for several U.S. products.

An English daily in the UAE reported Tuesday that the U.S. goods had "fallen out of favour in virtual people's embargo".

"The Ramadan-related surge in demand for fruits and vegetables seems not to have touched American goods in a big way as the Intifada is virtually leading to a people's embargo on U.S. products," the newspaper said.

The Gulf states are big importers of Western and American food products.

A salesman told the newspaper that the U.S. fruits were not in demand because people did not want to break their fast with American products.

"There is a definite pattern of people's embargo on American goods, which we can feel here, and that's why they are stagnant," the salesman said.

This boycott of U.S. goods had increased the demand of fruits from Malaysia and Philippines, he added.

A Syrian nurse told the paper that she never liked American apples, but now with a cause (that of solidarity with the Palestinian people), "I can never imagine buying any American product."

Such sentiments have caused an alarm among the local franchisees of U.S. fast-food chains that fear that their business could suffer in the long run.

In order to sooth enraged local feelings, the company that runs McDonald's in Saudi Arabia has begun a campaign to raise funds for Palestinian children's hospitals.

Anti-U.S. feelings are not alien to this region. However, observers point out, the American failure to stop the excessive use of Israeli force against unarmed Palestinians civilians has resulted in an explosion of anger among the populace.

Most Arabs have also given up on any American mediation in the Arab-Israeli conflict.

To complicate matters further, the U.S. election standoff has compounded the growing Arab disenchantment with Washington.

Meanwhile, UAE's leading Arabic daily *Al Khaleej*

Tuesday questioned the ability of the United States to act as an effective mediator in the peace process.

The newspaper predicted that if elected, each of the two candidates will try to show support to Israel. "If Republican candidate George W. Bush is officially declared as winner of the U.S. presidential elections, his presidential term will be full of uncertainties," the paper said.

"For the Arabs, the danger is doubled because 85 percent of the Jewish lobby's votes went to Democratic candidate Al Gore and that puts Bush on an uphill task of wooing the Jews by giving them more concessions, in other words, pledging more support to Israel."

The paper said that like his father, former President George Bush, Bush Jr. is accused of taking the side of the Arab countries, given his vast interests with the major U.S. oil companies that are affected by the Arab resolutions on oil.

"If Gore becomes president (which is unlikely now), his bias towards Israel will be crystal clear and if Bush becomes the president, he will seek to prove his loyalty to American Jews and Israel," the paper added.

[JR: The American and international companies affected by these boycotts could be an influence in changing our government's biased policies favoring Israel. When the profit margins begin to head south, it tends to raise the conscience level of international corporations. The Israelis excel at boycotts, sanctions and intimidation to force things to their advantage. The world's Muslim population is thousands of times greater than the respective Israeli/Zionist numbers in over a hundred countries—so the economic effect could be very damaging to U.S. exports and interest. Boycotts hurt business and it's up to governments to make that hurt go away.]

VOLESKY WANTS TRIBAL DELEGATES IN LEGISLATURE

HURON, SOUTH DAKOTA—The state Legislature and the nine tribes in South Dakota will be asked to deal with an issue that could mend racial tensions in the state.

Ron Volesky, newly elected state senator from Huron, said he will introduce a bill that would allow at least one non-voting delegate from each of the state's tribes to serve in the Legislature.

"The delegates will have an opportunity to be directly involved with various issues that impact tribes. Sometimes the Legislature doesn't have an official tribal position," Volesky said.

The delegates would be able to serve on committee, participate in the debates on the Senate and House floors and in committees, but not have a vote in the final outcome of legislation.

"It would be nice to have a tribal delegate to express (the tribe's) opinion."

"I'm excited about introducing it and getting the bill into the legislative process and see what reaction we get from the state and the tribes," he said.

Volesky said he had not yet taken the idea on a fishing expedition among the legislators or tribes, and won't until the bill is drafted, which is in progress.

"I think it will be interesting how the Legislature will welcome the bill and interesting to see how the tribes react.

Gregg Bourland, chairman of the Cheyenne River

Sioux Tribe, told *The Associated Press* that he would like to see the details, but thought it was a good plan. "I think it definitely has possibilities."

It is not clear whether the delegates will be part of the House or the Senate or both. Volesky offered a theory that would put part of the nine delegates in the House, the remainder in the Senate for one year, then rotate the following year.

Delegates could be selected by a vote of the tribal membership or chosen by the tribal government. They wouldn't be restricted to discussing issues that directly involved tribal government and state-tribal relations, Volesky said.

"This will do a lot to foster state-tribal relations. It offers an opportunity to sit down and get serious about better relations with the tribes."

Tribal delegations in state legislatures are not new. Maine has non-voting delegates in its legislature and in Wisconsin the idea is taking hold with a bill that, like Volesky's bill, will be introduced in the 2001 session.

The Wisconsin measure has support of tribes located within the state.

"Oftentimes, there may be a piece of legislation that has a direct impact on our community, but tribes have thus far been cut out of the debate," Robert Chicks, president of the Stockbridge-Munsee Band of Mohican, said at the gathering of the National Congress of American Indians.

The placement of delegates to the legislature in Maine has been a success, reports the National Conference of State Legislatures. For every state with substantial American Indian populations, to adopt the policy may not be realistic because some 40 American Indians have been elected to state legislatures this year.

In South Dakota four American Indians represent districts in the Legislature.

[JR: The Indian siege at Wounded Knee in 1972 and the recent Oyate occupation vigil at the Pine Ridge Reservation's administration building has not moved the South Dakota Legislature to resolve the issues that have developed mistrust and bitterness among the tribes. This bill to include Indian delegates to the legislature is a beginning.]

MEXICO'S FOX PROMISES INDIANS A NEW WORLD [ORDER?!]

MONTERREY, MEXICO (*Reuters*)—Mexican President Vicente Fox took his inauguration on a road show on Saturday, promising a new world without discrimination and poverty to the country's 10 million Indians, and receiving a peace overture from the Zapatista rebels in reply.

The day after he ended 71 years of single-party rule with a marathon of pomp in the capital, Fox wooed indigenous supporters in the poor, southern state of Oaxaca and later held a rally in the northern industrial city of Monterrey, building a symbolic bridge between the impoverished Mexico of Indian villages in the south and the more developed north.

Fox's tour was eclipsed by Subcommander Marcos, the pipe-smoking leader of the Zapatista guerrillas in southern Chiapas, who announced at a news conference in his jungle hideout that he was prepared to discuss peace.

Fox, who ended seven decades of rule by the Institutional Revolutionary Party (PRI) when he

took office on Friday, addressed an estimated 5,000 people in a square of Monterrey on Saturday night and said he was delighted.

"We heard today with great happiness that the Zapatista Liberation Army of Chiapas (sic) has accepted starting talks. There is a new attitude, there is a new way of thinking," he said to applause.

Fox spokeswoman Martha Sahagun said earlier the new government would evaluate conditions the Zapatistas had put on new peace negotiations, including the closure of seven army bases, and the release of jailed Zapatista sympathizers.

"If it is a proposal for peace in Chiapas, it will be accepted a priori," Sahagun told reporters traveling with Fox on the presidential jet.

The Zapatista National Liberation Army (EZLN) rose in arms on New Year's Day 1994, demanding improved indigenous rights. Peace talks with the government of Fox's predecessor, Ernesto Zedillo, broke down in 1996 and there has been no contact between the rebels and the authorities since that time.

Fox's defeat in July of the PRI opened the door to peace in Chiapas, and he said at his swearing-in the first project he would send to Congress was a 1996 peace accord reached after months of negotiation but never ratified by Zedillo's government.

He followed up by ordering some of the tens of thousands of troops encircling the rebels to withdraw to their barracks on Friday night.

Fox, a 58-year-old rancher and former Coca-Cola de Mexico executive, promised in his inauguration to govern for all Mexicans—rich or poor, indigenous or mestizo. In his first day in power he had breakfast with street children, dined with presidents and rallied with 50,000 people in a capital square.

On Saturday, he took visiting Venezuelan President Hugo Chavez and Poland's former president Lech Walesa, the Nobel Peace Prize-winning founder of the Solidarity Union movement, to the picturesque but dirt-poor southern state of Oaxaca.

There, Fox promised union workers and a scattering of Indians in traditional costumes he would ensure the poor southeast was not left out of economic development.

"There will not be a policy to enrich a few companies or a few areas," he said.

Fox, elected for his promise of change from the authoritarianism of the PRI and the cronyism and corruption many associated with the party's long tenure, also vowed to defend the rights of Mexico's Indians, who make up 10 percent of the population.

"Mexico is the result of the union of different cultures and our human wealth lies in its diversity," he said before a crowd of 5,000 in a central plaza of the colonial city of Oaxaca, the state's capital.

Later, at the former Santo Domingo convent, adjacent to a 16th Century church of the same name, Fox met local Indian leaders and signed an accord with the United Nations on technical cooperation on human rights.

UN human rights chief Mary Robinson said she was delighted Fox had chosen to sign the convention immediately after taking office, and indicated she hoped Mexico's tainted rights record would now improve.

"I think the president was very open. He wants to make genuine progress on human rights," said Robinson, who has criticized impunity in Mexico and the excessive militarization of Chiapas under the PRI.

Robinson also praised Fox's decision to pull back some soldiers in Chiapas, saying: "It's a sign

of political will to create space to bring about the change and hopefully to move forward."

Possibly for security reasons, many Indians were prevented by police earlier in the day from hearing Fox's speech in the Oaxaca plaza, and the audience was mainly trade unionists.

On Friday a shadowy armed group called the "People's Armed Revolutionary Forces" appeared in a town 12 miles (20 km) from Oaxaca denouncing Fox and vowing to fight for a "revolutionary transformation of society", local media reported.

After Fox's speech, Lilita Fuentes, 25, a student, said he appeared to "be very frank and sincere."

But she noted Fox's predecessor, Zedillo, had said the same things but living conditions were unchanged from 10 years ago. "So I remain a bit skeptical," she said.

Fox flew to Monterrey late Saturday afternoon, where booming exports to the United States across the 2,100-mile (3,000-km) Mexico-U.S. border are fueling Mexico's economy.

[JR: I don't think the people in Chiapas will be prone to celebrating too soon as they have become wary of the empty promises in Mexico City and the betrayals that are sure to follow. They may receive some of their demands but will have to compromise.]

FOX CRITICIZES AMERICA FOR FOSTERING DRUG TRADE

SAN CRISTOBAL, MEXICO (*AP*)—Days before his inauguration as president, Vicente Fox said America should deal with its drug habit and pledged to join the United States and Canada in what he called "NAFTA-plus".

In an interview with the *Associated Press* before he takes office on Friday, Mr. Fox said the United States has been too quick to write off Mexico as a corrupt haven for drug smugglers—and too reluctant to look in the mirror.

"The United States year after year blames us. Why?" Mr. Fox asked. "Who lets the drugs into the United States? Who is doing gigantic business in the United States, then sends down millions of dollars that corrupt Mexican police officers and government officials?"

Mr. Fox said the two countries need to "sit down... and work this out together."

Mr. Fox has promised strong measures against drug corruption, but his comments indicate he will continue—or increase—Mexico's long-standing complaint that the supply of drugs would not exist without demand in the United States.

He also said that despite a tepid reaction from both George W. Bush and Al Gore, he was confident that he would persuade his northern neighbors to expand the North American Free Trade Agreement and eventually to open their borders entirely to Mexican goods—and maybe even workers—along the lines of the European Union.

"I am proposing a 'NAFTA-plus,'" he said. "I'm proposing that 20, 30 years down the road we form a North American common market in which we become partners, the United States, Canada and Mexico."

"I will continue to insist on this, and I know I will win the battle," Mr. Fox said. "I am going to persuade Bush or Gore, whoever it is. And I am going to persuade the American people."

Mr. Fox's election on July 2 was a historic change

for Mexico, ending 71 years of rule by a single party. On Friday, the country enters a new era as Mr. Fox takes office—and takes on dire problems including crippling poverty, widespread corruption and rampant crime....

“It’s just like in school,” Mr. Fox said. “When it’s time for exams, the people who have studied go in calmly, with the confidence that everything will go well.... I am going to be the best president this country has ever had.”

Mr. Fox said he was aware of the huge—probably unrealistic—expectations Mexicans have for him, but claimed he wasn’t worried about them. On the contrary.

“I would never throw cold water on that enthusiasm, on that hope,” he said. “I dare say that this is Mexico’s revolution of hope.”

But he cautioned that most of the changes he envisions will take much longer than his six-year term. **[JR: President Fox has the power and authority to close the drug routes into the U.S. and doesn’t need our permission to do what is best for Mexico. Why call a “NAFTA-plus” meeting with the U.S. and Canada to address this issue? President Fox has great plans to open U.S. borders to Mexican workers and goods but isn’t specific as to how Americans will fare with these changes. The Fox is well suited to wield his assumed powers and to implement plans he envisions for Mexico. The question is who besides the Fox is making all these plans to dismantle the U.S. economy and disenfranchise the American people?]**

THE “BASES KIDS” ARE DYING...

Kids suffer from all kinds of diseases in Subic and Clark, an inheritance, say residents, from the Americans who left behind tonnes of toxic waste

Four-year-old Romar Devillena kept asking his mother why he had to see the doctor so frequently.

Just a year ago, the only child was diagnosed with leukaemia. A doctor who treated him even told his parents to start thinking about having another child.

Two weeks ago, he died at a children’s hospital in Manila, three hours from his home at the former Subic Bay Naval Base.

Romar’s parents are not alone in thinking that the two former U.S. bases in the Philippines—Subic in Olangapo and Clark Air Force Base in Pampanga—contributed to his death and hundreds of others among the current and former residents.

His parents are among 120 Filipinos embroiled in a lawsuit against the U.S. and Philippine governments.

They are seeking \$102 billion in damages from Washington for the contamination of both Clark and Subic.

How? By leaving tonnes of toxic waste behind when the troops left.

The Americans departed from Clark in 1991—two months after Mount Pinatubo erupted in June 1991, sending scores of villagers down from the mountain into Clark.

Some 20,000 families stayed in and around the area for close to five years.

The Americans left Subic in 1992.

When *The Straits Times* visited Clark and Subic over

a period of six days recently, there were several children there with congenital heart disease and seizures.

Some had cerebral palsy, tumours and leukaemia; many could not speak and skin disease seemed a common condition.

At every block visited, there was at least one wake.

While no one has been able to finger the pollutants left behind as the cause of the children’s problems, many of those interviewed claimed that the water they drank and air they breathed in were “funny”.

Said Ms. Rosalina Ravellas, 67, a former Clark resident: “The water... looked oily on the surface and it looked and smelt rusty. When we left it standing overnight, the aluminium tubs we used looked like they were glazed with gold in the morning.”

In an earlier report, the U.S. said it had done all it could to clean up the bases.

Earlier this year, both governments sat down to discuss a possible clean-up, estimated to cost around \$1 billion, but there has been no progress so far.

A 1997 environmental study also cleared the Clark water for drinking.

When the Americans left, the Philippines inherited all the salvage metal, barrels, tubes and chemicals.

The bases were home to petroleum-tank farms, ship-repair facilities, airfields, motor pools and firing ranges, all of which generate huge amounts of toxins.

According to Mr. Von Hernandez of Greenpeace, the environmentalists know what pollutants are present and what they can do.

“The pollutants are there and people are coming out with the effects of being exposed to these chemicals,” he said in Tagalog.

Romar’s mother, Mrs. Maria Luisa Devillena, said the doctors advised them to take the boy home as there was nothing they could do.

“We did not have time to grieve as we were worried over the hospital bills.”

Just before he died, Romar asked her if he could stop going to the doctor.

“I don’t want this anymore. I’m very, very tired.”

JUSTICES BAR ROADBLOCKS FOR GENERAL CRIME

6-3 DECISION SAYS INDIANAPOLIS WAS WRONG TO STOP ALL MOTORISTS IN SEARCH FOR ILLEGAL DRUGS

WASHINGTON—Emphasizing strict limits on law-enforcement searches and seizures, the Supreme Court strongly defended a person’s right to be left alone when it ruled Tuesday that random roadblocks designed to catch vehicles carrying drugs in Indianapolis violated the *Constitution*.

In a 6-3 ruling, the court said the roadblocks violated the *4th Amendment*’s prohibition against unreasonable searches and seizures because police had no special reason to do them. Instead, the court ruled, the

roadblocks were part of a general scheme by law enforcement to find evidence of crime.

If it allowed roadblocks for those reasons, the court said, “there would be little check on the ability of the authorities to construct roadblocks for almost any conceivable law-enforcement purpose.”

“Without drawing the line at roadblocks designed primarily to serve the general interest in crime control, the *4th Amendment* would do little to prevent such intrusions from becoming a routine part of American life,” Justice Sandra Day O’Connor wrote for the court.

The ruling affirmed a federal appeals court decision in Chicago, which had sided with a group of motorists who had challenged the roadblocks as an unconstitutional seizure. While the program was in operation, Indianapolis police stopped more than 1,000 cars at six different roadblocks. The stops resulted in 55 arrests for drug possession and 49 for license or registration infractions.

The city acknowledged that the program was designed primarily to find evidence of drugs, but in its ruling Tuesday the Supreme Court said that wasn’t a good enough reason to permit the roadblocks.

The court said police must have a compelling reason for stopping a motorist, such as keeping roads safe from drunken drivers or ensuring the integrity of the nation’s borders. The court previously has said sobriety checkpoints and stops at the border are constitutional.

Kenneth Falk, legal director for the Indiana Civil Liberties Union, called the ruling a “great victory for the *4th Amendment*.” He said it should stop a trend in lower courts to allow searches where intrusions on privacy are minimal—even if police may not believe an individual has done something wrong—so long as there is a strong government interest at stake.

Falk said a contrary ruling “would have been very unsettling for all of us,” because it would have meant that “if the state had an important enough need, a particular search or seizure could have occurred without cause.”...

For a search or seizure to be reasonable under the *4th Amendment*, an officer generally must have cause to believe that an individual has done something wrong. But there are exceptions. The court has allowed broad, random searches and seizures if they were needed for a special reason other than detecting crime, such as testing transportation workers for drugs.

It also has allowed the sobriety checkpoints and border searches, even though police lacked individualized suspicion to stop particular motorists.

In its decision Tuesday, the court acknowledged some emergency circumstances might justify roadblocks where the purpose would otherwise relate to ordinary crime control. For example, the *4th Amendment* would likely permit a roadblock to thwart an imminent terrorist attack or catch a dangerous criminal who is likely to flee down a particular road, it said.

The court said those examples “are far removed from the circumstances under which authorities might simply stop cars as a matter of course to see if there just happens to be a felon leaving the jurisdiction,” as was the case in Indianapolis.

Chief Justice William Rehnquist wrote a dissent that was joined by Justices Antonin Scalia and Clarence Thomas. But Thomas wrote separately to say he was dissenting only because he thought the court’s earlier cases required that result. He said if the motorists had raised the issue, he would have been inclined to overrule those earlier cases and hold that they too were unconstitutional.

“I rather doubt that the framers of the *4th*

Amendment would have considered ‘reasonable’ a program of indiscriminate stops of individuals not suspected of wrongdoing,” Thomas wrote in his dissent.

In his dissent, Rehnquist said the earlier cases were enough to justify the drug roadblocks at issue in Indianapolis. He maintained that the city had a legitimate interest in stopping motorists to check their licenses and vehicle registration. As part of that legal stop, it could also send a drug-sniffing dog around the motorist’s car, the dissenters said.

“Because of the valid reasons for conducting these roadblock seizures, it is constitutionally irrelevant that petitioners also hoped to interdict drugs,” Rehnquist wrote.

The court’s ruling affirmed a three-judge panel of the 7th U.S. Court of Appeals, which, in an opinion by Judge Richard Posner, said the roadblocks were illegal because they were designed merely to detect evidence of crime. Judge Frank Easterbrook dissented in the appeals court. **[JR: Too many unconstitutional laws have been passed by the states to fight the “war against drugs”. This Supreme Court’s ruling clarifies under what circumstances the states are allowed to infringe on a particular motorist’s 4th Amendment rights. Know your Constitution and know your rights and don’t allow others to take them from you. Without the right knowledge you have no knowledge of rights.]**

RED CHINESE GENERAL
PROBES U.S. MILITARY POST

The top Red Chinese general charged with enforcing Communist ideology, accompanied by a contingent of People’s Liberation Army (PLA) colleagues, visited the United States from October 21st until November 4th as guests of the Pentagon in what some defense officials fear was a covert intelligence mission to ascertain potential weaknesses in U.S. military morale.

Prior to the visit, one U.S. official told *Washington Times* reporter Bill Gertz: “They believe one of America’s biggest weak points is morale that can be crushed in a surprise, massive attack. That’s what their goal is for the visit. It’s an intelligence-collection mission.” Which should hardly come as a surprise since, as the *Associated Press* reported on October 21st, “China’s armed forces are seen as preparing for expected U.S. intervention should Beijing’s generals launch an attack on Taiwan, the wealthy democratic island China claims and threatens to take by force if peaceful means fail.” On October 31st, a *Reuters* dispatch also recalled that U.S. defense officials “have expressed concern over Chinese purchases of advanced Russian warplanes and other weaponry.”

That same day, General Yu Yongbo met with Defense Secretary William Cohen at the Pentagon, where they discussed sundry issues related to security, including the status of Taiwan and the American view that the differences between Taiwan and Red China should “be resolved peacefully”. Deep down, General Yu undoubtedly agrees, since the Communists define “peace” as an absence of resistance to Communism.

According to the Pentagon and key administration officials, General Yu was merely anxious to visit ordinary U.S. military bases and see for himself how U.S. troops are provided with health, welfare, legal entertainment, and religious services. Yet such accommodation may have played a role in the bombing of the Navy destroyer *Cole* in Aden, Yemen, only a few days prior to Yu’s arrival in the United States. The *Washington Times* reported on

October 25th that a “Yemeni national was invited on board one of two U.S. Navy destroyers that docked in Aden in August. The Yemeni was invited to a meal in an officers’ stateroom but insisted on eating on the mess deck—the same area that was hit on the *Cole*’s midsection as sailors were eating a meal. Intelligence officials suspect the Yemeni could have been conducting surveillance of the ship.”

General Yu directs the Chinese army’s General Political Department and is in charge of “political education, welfare and morale” for the PLA’s 2.5-million-member military machine. He is also a member of the Central Military Commission that controls the army, and is the highest-ranking PLA official to visit the U.S. this year. With Undersecretary of Defense Bernard Rostker serving as his formal host, Yu’s first stop was the U.S. Military Academy at West Point. He was also allowed to tour Patrick Air Force Base in Florida, Bolling Air Force Base in Washington, D.C., Fort Jackson Army Base in South Carolina, U.S. Pacific Command headquarters in Hawaii—and Disney World.

[JR: A surprise attack may temporarily diminish the moral of our military men but would certainly add to the resolve and determination to meet the enemy and the challenges head on. This was true after the attack on Pearl Harbor. Can we trust our leaders today not to keep advance knowledge of an attack secret—as FDR did—or will our intelligence and policies be lacking as in the USS Cole attack? I wonder how many family vacations were destroyed and what games General Yu played and won to be awarded a trip to Disney World?]

WAR-CRIMES COURT MAY GO AHEAD
WITHOUT U.S. SUPPORT

WASHINGTON—The world community is making a final push to convince the United States to support an international war-crimes court, but a compromise looks unlikely before President Clinton’s term expires Jan. 20.

The International Criminal Court, whose preparatory commission is meeting this week at the United Nations in New York, is being established to try international war-crimes suspects along the lines of Foday Sankoh of Sierra Leone and Slobodan Milosevic of Yugoslavia.

Yet U.S. military officials have resisted throwing their support behind the treaty, saying it could compromise U.S. sovereignty and allow other countries to make politically motivated charges against American soldiers.

There is some support for the treaty within the Clinton administration, however, and because of that, backers of the court see the current meetings as a last chance for the United States to join. A Republican White House would probably look less favorably on the concept, analysts say.

The treaty is supported by nearly every U.S. ally, including Canada, the European Union, and NATO (minus Turkey). It has been signed by 116 countries and ratified by 23. The ICC would work similarly to the temporary tribunal in The Hague, prosecuting war crimes, genocide, and crimes against humanity.

Without U.S. involvement, the court will still go forward, but it will likely have a more difficult time establishing legitimacy. Furthermore, by not joining, the U.S. could weaken its alliances and lose a say in the administration of global justice, an area it has traditionally led.

“This could create a division between the U.S. and its closest military allies,” says Richard Dicker of Human Rights Watch in New York. “That could make consensus on other foreign-policy issues more difficult to achieve.”

The Joint Chiefs of Staff have spearheaded resistance to the court, overcoming moderate support for the measure in the Justice Department and the State Department, analysts say. Senate Foreign Relations Committee chairman Jesse Helms, a North Carolina Republican, has said he would block ratification if the measure reached the Senate.

The U.S. has tried to persuade the court’s preparatory commission to grant exemptions for U.S. nationals.

“We put a proposal on the table, and it’s still being discussed,” a U.S. official says.

But backers of the court say exemptions would undermine the court’s objectivity and produce a “two-tier” justice system. Other international war-crimes courts, including the one for the former Yugoslavia, have been accused of being politically motivated and biased toward the West.

“[An American exemption] can’t work,” says William Pace, who heads the Coalition for an International Criminal Court in New York. “This type of position undermines U.S. leadership.”

The Clinton administration has spent enormous energy promoting the idea of globalization. Washington, for example, has tirelessly pushed and expanded the World Trade Organization, which serves the purpose of, among other things, resolving trade disputes.

Throughout history, the U.S. has championed war-crimes courts, starting with the establishment of the International Military Tribunal in Nuremberg that prosecuted the Nazis following World War II.

More recently, Secretary of State Madeleine Albright led efforts to establish temporary international courts for the former Yugoslavia and Rwanda.

Yet as delegates from around the world were meeting in New York this week, the U.S. took on a distinctly different role in which it was accused of slowing down a historic development in human rights and global justice.

“In particular, we call on our close ally and friend, the United States of America, to sign the statute before the end of this year,” said Hans-Peter Kaul, the head of the German delegation, in remarks to the commission.

“The International Criminal Court needs the support of your great country, which time and again had a decisive role in bringing about the fall of tyranny and dictatorship and in reestablishing the rule of law,” he added.

[JR: We are selective as to what forms of globalization we might participate in and/or promote. MONSANTO PLEDGES SLOWER PACE
WITH GENE-ALTERED FOODS

Monsanto Co., the biggest corporate booster of genetically-altered food and a lightning rod for critics, is promising to back off from some controversial technologies

and take bigger steps to promote food safety.

Under pressure from skeptical consumers and aggressive activists around the world, Monsanto Chief Executive Hendrik Verfaillie conceded to a farm group this week that his company has pushed too hard. "We were blinded by our own enthusiasm," he said.

In a frank corporate mea culpa, Verfaillie said his company had "focused so much on getting this technology right for the grower that we didn't fully take into account the issues and concerns it raised for other people."

Verfaillie said he remains a believer in the idea that Monsanto's high-tech seeds can help ease world hunger, reduce the use of chemical pesticides and stave off some illnesses.

But on behalf of Monsanto, he also promised to be receptive to increased regulation. In a nod to activists who have branded his products "Franken-foods", he pledged never to use animal or human genes in modified crops. And he promised to sell products commercially only after they are approved for consumption by humans as well as livestock—a step that could slow the introduction of new seed varieties.

In addition, Verfaillie announced the formation of an advisory council composed of diverse outside interests.

Verfaillie's comments at a Farm Journal conference in Washington Monday were intended to defuse a growing controversy over the use of genetically-modified farm products, which is stigmatizing the high-tech seeds Monsanto has spent a fortune to develop and commercialize. "We have reached a crossroads in the debate about biotechnology," he said.

U.S. consumer concern has jumped since it became clear this year that a bioengineered corn variety known as StarLink—produced by a Monsanto rival—had found its way into products from taco shells to corn chips, even though it hasn't been approved for human consumption.

Since September, Kraft and other U.S. foodmakers have recalled scores of corn-based products found to contain the unapproved grain. StarLink, made by Aventis SA of France, hasn't been cleared for humans because regulators have yet to establish whether an insect-fighting chemical the corn produces through a genetic modification could trigger allergies.

Verfaillie's speech in Washington came on the eve of an Environmental Protection Agency hearing Tuesday on an Aventis request to clear StarLink for humans.

It also comes in the wake of Monsanto's merger this year with Pharmacia & Upjohn to form Pharmacia Corp. Last month, Pharmacia took its St. Louis merger partner's agricultural-products operation public through an initial offering of a 15 percent stake. Pharmacia, of Peapack, N.J., retains an 85 percent holding in what it refers to as the "New Monsanto".

Meantime, biotech critics say the new stance of the "new" Monsanto falls far short of the steps needed to prove the safety of biotech foods.

"Monsanto's acknowledgement that they've rushed this technology is meaningful," said Julie Miles, a co-founder of the anti-biotech coalition Genetically Engineered Food Alert. "But if Monsanto truly wants to respond to consumer concerns, it should support mandatory testing and mandatory labeling of genetically-engineered foods," she added.

Meantime, Monsanto still sells a variety of genetically-engineered products, including cottonseed altered to resist the bollworm and a strain of corn that resists destructive insects. It has made a big business out of cotton, corn and soybean seeds modified to resist

Monsanto's farm herbicide. That allows farmers to reduce their use of chemicals by spraying weedkiller directly onto their crops during the growing season, when a relatively small dose is most effective.

All of the edible grain varieties that Monsanto has brought to the market have been approved for human consumption in the U.S., and farmers across the Corn Belt have been making extensive use of the company's seeds in recent years, thanks in part to an aggressive marketing campaign.

Yet that commercial success has touched off repeated spats between Monsanto and environmental groups concerned about the safety of modified foods. Until recently, most U.S. consumers hadn't displayed any serious interest in whether their breakfast cereal was made with gene-spliced grain or whether their bacon came from hogs fed with altered corn.

But in Europe, consumer resistance to so-called "GM", or genetically-modified food products has been much greater. Many export markets have refused to clear bioengineered crops for human food, so big grain-processing companies such as Archer Daniels Midland Co. are obliged to keep engineered grain meant for U.S. consumption from mingling with conventional grain for export.

Concerns about potential contamination by unapproved grains have been amplified in the wake of the StarLink episode. And many farmers are torn about whether it might be simpler to go back to conventional seeds this spring to avoid potential hassles in the harvest. **[JR: The issue over gene-altered foods got heated enough for Monsanto to admit to being too enthused and pushing too hard to promote their billion-dollar exclusively-patented technology to own the seed. It seems that comments from the USDA and FDA are conveniently missing on this latest issue. An advisory panel is laudable to oversee such developments—but how effective will they be if test results are provided by Monsanto or their pharmaceutical partner Upjohn? Why are European consumers more aware and alert to the gene-altered food issues than we are? For the U.S. it may be all about profits and convenience.]**

ENRILE: ESTRADA LIKELY TO BE ACQUITTED

One of the 21 judges trying President Estrada's impeachment case is confident the Chief Executive would be acquitted of all four articles of impeachment.

Speaking before former officials of the Marcos administration at the EDSA Shangri-La Hotel in Mandaluyong City last Thursday, Sen. Juan Ponce Enrile said he finds "weak" the evidence presented at the trial by prosecutors of the House of Representatives.

"We had a taste of the kind of evidence against (President) Estrada," he said. "(The prosecution) will lose the case."

Also present to hear Enrile speak were Ilocos Norte Gov. Ferdinand "Bongbong" Marcos Jr., his sister, Ilocos Norte Rep. Imee Marcos and their cousin Leyte Rep. Alfred Romualdez. The three hosted the affair.

Another judge, Sen. Francisco Tatad, told the same gathering that history shows all three Philippine presidents who had faced impeachment were not removed from office.

Tatad, who was press secretary and

information minister under President Ferdinand Marcos, gave as examples the cases of Presidents Elpidio Quirino, Diosdado Macapagal, and Marcos.

Tatad said the impeachment complaint against Quirino in 1949 was thrown out by Congress after the editors of a newspaper admitted they had invented the charges against the President.

As for Macapagal—father of Vice President Gloria Macapagal-Arroyo—charges of involvement in anomalies in the General Appropriations Act in 1964 did not prosper after it was rejected by Congress, he added.

Tatad said the impeachment case against Marcos in 1985 was also thrown out by the Interim Batasang Pambansa, and he was not tried by the unicameral assembly.

Enrile also warned that demonstrations may continue even if Mr. Estrada is acquitted or convicted in the impeachment trial being heard at the Senate.

"There are forces operating in our country to put our government into political turbulence," he said. "I don't possibly see an end to this crisis even if we finished the impeachment and even if we convict (President) Estrada."

Enrile said pro-Estrada groups can muster the numbers to counter the series of anti-Estrada rallies being spearheaded by former President Corazon Aquino and Manila Archbishop Jaime Cardinal Sin.

"They (Cory and Sin) don't know how to forgive and have no charity in the heart," he said. "If (President) Estrada will be acquitted, the forces against him will rally against him."

Enrile said he has rejected the request of some opposition leaders for him to join Aquino and Sin in demonstrations whose purpose is to pressure Mr. Estrada to resign.

"I cannot join Cory who called me a mere miron (fence-sitter), Sin who called me a demon; and (Sen. Franklin) Drilon... who charged me with an (offense) which we cannot even find in the *Constitution* during the Aquino administration," he said.

Enrile said he would not take part again in any military coup to overthrow an incumbent president, which was what he did in 1986 to oust Marcos and install Aquino.

"The military may support to unseat the president," he said. "But never again should the military join to unseat the incumbent president. I experienced that once. I know the consequences and I will never do that again."

Enrile said nobody can convince him to join any "people power II" to oust Mr. Estrada, "not Cory nor Sin nor Drilon" as what happened in 1986.

"I know the danger of such consequence and how it divided the country into two warring camps like what had happened in Spain..." he said. "Let's build a new nation instead of doing that again."

On the other hand, Enrile said he would help the administration do "what it ought to do" to alleviate the present economic status of poor Filipinos.

Enrile, who was one of the implementors of martial law and a principal player in the 1986 EDSA revolution, said the government has failed to "rebuild the nation" 14 years after the people-

power revolt.

“I participated in martial law in 1972 because I believed it was the right thing to do at that time,” he said. “Only God knows why (the EDSA revolution) happened.”

Nine months into her presidency, Aquino fired Enrile as defense minister after he was implicated in a coup plot code-named “God Save the Queen”.

ESTRADA WOOS CHURCH, LEFT:
COMMUTES ALL DEATH SENTENCES TO LIFE,
FREES POLITICAL PRISONERS

BACOLOD CITY—In a surprise move, President Estrada announced yesterday he would commute to life imprisonment the court-affirmed sentences of all death convicts and release some 35 communist rebels and 200 political detainees before Christmas.

“I will order tomorrow (Monday) all those sentenced to death commuted to life imprisonment on the occasion of the Jubilee year,” the President said after attending a “Mass for Enlightenment, Reconciliation and Peace” at the St. Jude Thaddeus Church here. Mr. Estrada was responding to a homily by Bacolod Bishop Emeritus Antonio Fortich, who appealed to the President to issue a decree freeing all political prisoners as a Christmas gift.

“This is the time when prisoners are freed and debts are canceled,” the retired bishop said.

In response, the President said: “And now I heard our beloved Bishop Fortich about giving pardon to our political prisoners. I want to inform the good Bishop that I already ordered the processing of the release of about 200 political prisoners before Christmas.”

The President said 35 communist rebels, jailed for various criminal offenses, will likewise be released as part of a peace agreement signed earlier in the day with a communist breakaway group.

These include Jose Winnie Bargamento, Joaquin Esparez, Armando Occeña, Ronnie Rotuni and Saez Villaespin, who are to be released within 24 hours.

Mr. Estrada said two rebels—Romeo Medalla and Federico Lulan—were released earlier.

However, officials traveling with the President were apparently caught off guard and could not give more details on the announcement on the commutation of death convictions.

There are currently more than 1,300 convicts on death row at the National Penitentiary in Muntinlupa City. Many of their cases still have to be affirmed by the Supreme Court (SC), which under the law automatically reviews each case.

The Church has been a vocal critic of the death penalty in the Philippines. In February 1999 the county broke a 23-year moratorium on executions when it put to death child rapist Leo Echegaray by lethal injection. Six others subsequently followed, but Mr. Estrada ordered a moratorium in March after intense lobbying from the influential Catholic Church.

The decision effectively commuted the death sentences of at least 18 prisoners scheduled to be executed this year, to life in prison because authorities will not be able to execute them within a prescribed six-month period.

Under the death-penalty law passed in January 1994, an execution should be carried out not earlier than

one year nor later than 18 months after a death sentence has been declared final by the SC.

Mr. Estrada had previously backed the death sentence, saying he wants executions to serve as a warning to would-be criminals, especially potential rapists and drug traffickers.

Human rights lawyer Theodore Te, whose legal battle to save Echegaray failed, said Mr. Estrada’s latest announcement could “give some degree of momentum to the lobby against capital punishment.”

“It remains to be seen whether he will push through with that and if he confirms it in writing tomorrow (Monday),” Te said. “If that announcement is carried, then that is a very fitting human rights gift.”

Congress in 1994 reimposed capital punishment for “heinous crimes”—including murder, kidnapping for ransom, drug trafficking and rape. The last execution prior to Echegaray was in 1976. Te, however, said he had “mixed feelings” about the announcement, noting that the President could have ordered the commutation to score some political points amid his ongoing corruption trial in the Senate.

Mr. Estrada has been accused of receiving hundreds of millions of pesos from illegal gambling operators and skimming tobacco excise taxes to finance a lavish lifestyle. He has pleaded not guilty to the charges, but the Catholic Church has been leading protests calling for his removal.

During yesterday’s Mass, the President asked God for moral strength to endure the “agonizing days” of his impeachment trial.

“Lord, I also pray that You may grant me spiritual guidance and moral fortitude to muster the courage and strength to endure the agonizing days that the trial may bring to me and my family,” he said.

The President was accompanied at Mass by Ambassador Ernesto Maceda, Press Secretary Ricardo Puno, Agriculture Secretary Edgardo Angara, Public Works Secretary Gregorio Vigilante and Budget Secretary Benjamin Diokno.—**Paolo Romero, Antonieta Lopez**

GOVERNMENT SIGNS PEACE PACT WITH ABB

DON SALVADOR BENEDICTO, Negros Occidental—President Estrada witnessed here yesterday the signing of a peace agreement with a breakaway communist insurgent faction and said he hopes the pact can be replicated with other rebel groups around the country.

The President flew to Bacolod City yesterday after earlier announcing a major breakthrough in peace talks with the Rebolusyonaryong Partido ng Manggagawang Pilipino-Revolutionary Proletariat Army-Alex Boncayao Brigade (RPMP-RPA-ABB).

The ceremonial signing signaled the start of a cease-fire between the government and the RPMP-RPA-ABB, paving the way for formal negotiations between communist leaders and the government panel headed by Agriculture Secretary Edgardo Angara.

Mr. Estrada turned over a check for P45 million as part of P500-million livelihood assistance to the Salvador Benedicto Cassava, Corn and Coffee Planters Multi-Purpose Cooperative. Most of the members of the cooperative are rebel returnees.

“With the cessation of armed hostilities... we can

now explore a more lasting cooperation with each other to address the root causes of armed conflict and achieve progress and development,” the President said. “Hopefully, this will be replicated nationwide.”

Joining the President in yesterday’s signing was businessman and former ambassador Eduardo Cojuangco Jr., whom he introduced as a “good friend” and the “intervenor” in the negotiations.

It marked the first time the two friends were seen in public since the jueteng scandal broke out early in October.

A majority of the landholdings of the Cojuangcos are located in this town, about 47 kilometers northwest of Bacolod. Don Salvador Benedicto has been made the stronghold of the RPA after its separation from the Communist Party of the Philippines-New People’s Army (CPP-NPA) in 1993. The breakaway group has clashed with both the government and the CPP-NPA in the past.

RPA national commander Carapali Lualhati dismissed yesterday allegations that the faction has become a private army for Cojuangco and the town mayor.

Lualhati said they would implement a cease-fire but their troops would remain in the countryside.

“The peace settlement is not a surrender by our group, and we will continue police functions during the cease-fire period,” the communist leader said.

The rebels also asked for political reforms and called impeachment proceedings against the President a waste of time.

Mr. Estrada is being tried in the Senate on charges he accepted hundreds of millions of pesos in payoffs from illegal gambling operators and kickbacks from tobacco taxes. He has denied the allegations.

Lualhati joined communist chief negotiator Nilo de la Cruz and RPMP chairman Arturo Tabara in signing the peace pact. De la Cruz once headed the ABB, a former communist assassination squad blamed for killing of dozens of policemen, politicians and soldiers in Metro Manila in the 1980s.

In recent years, the ABB has mainly attacked facilities of the country’s oil companies to protest oil price increases.

Angara, designated as panel head after the resignation of former Commission on Elections chairman Haydee Yorac, signed for the government.

The agriculture secretary hailed the signing, calling it “a milestone in the solution to the 30-year-old war being waged by insurgents.”

Negros Occidental Gov. Rafael Coscolluela, who was among the original members of the government panel, was not invited to the signing.

Accused by critics of trying to derail the peace process, Coscolluela was replaced by Rep. Julio Ledesma (1st District, Negros Occidental).—**With Paolo Romero**

PULSE ASIA SURVEY:
MEDIA FAIR IN IMPEACH TRIAL REPORTING

Most Filipinos believe media are fair in reporting news about the impeachment trial of President Estrada, a tracking poll by *Pulse Asia* as of Dec. 9 said over the weekend.

The survey said 46 percent of respondents in Metro Manila agreed that media were balanced in their reporting, just five percentage points off its peak of 51 percent the week previous (Dec. 2).

On the other hand, 22 percent remained undecided about the slant, if any, taken by print and broadcast outlets in the unprecedented trial of an Asian head of state which enters its third day today. The figure sustained a three-day low for the undecided, after a high of 27 percent on Dec. 1.

But those who thought media were biased in their impeachment reportage comprised 32 percent of 300 moving respondents. The number of respondents who disagree/strongly disagree with media's objectivity hovered around the 30-percent mark since the survey started Nov. 30.

Pulse Asia's Project JEST, a series of surveys commissioned by and exclusive to *The STAR*, began Nov. 16 to get the public's sentiments on political issues prior to, and during the impeachment trial of the President in the Senate. It was contracted at a cost of P3 million and will run daily until Dec. 20.

The STAR committed to run the results of the tracking poll regardless of whether these were for or against the administration or opposition, the primary objective being to inform and educate the readers on the present situation. It aims to track changes, if any, in public opinion, in reaction to what they perceive is going on in the impeachment trial.

The survey firm's president, Prof. Felipe Miranda, clarified the other day that presidential adviser Robert Aventajado had commissioned a different survey conducted only on Nov. 26 and 27, called Project Rubicon II for a contract price of P620,000. Miranda made assurances that results of any of their surveys were conducted in the most professional manner and he's staking his academic reputation on the methodologies used. He added that he would never allow the survey outfit to be used for manipulation of results to please the financiers or mislead the public.

Miranda was reacting to criticisms by a few, including opposition groups, that the Project Rubicon II survey seemed to be rigged in favor of President Estrada since it was commissioned by Aventajado.

Miranda mentioned talk-show host and oppositionist Hilarion Henares as "making a mountain out of a molehill" in criticizing the *Pulse Asia* surveys.

SINGSON SET TO TESTIFY TOMORROW

Ilocos Sur Gov. Luis "Chavit" Singson is set to take the witness stand in tomorrow's resumption of the impeachment trial against President Estrada.

This developed as the prosecution panel in the impeachment hearing vowed to present "explosive" testimonies to substantiate their corruption charges, even as a lawyers' group warned the case could fail due to alleged ineptitude of the prosecutors.

Former Albay Rep. Edcel Lagman, now a practicing lawyer assisting the 11-member prosecution team from the House of Representatives insisted, however, that they were "on the right track".

Lagman said they would present today "explosive testimonies and witnesses" against the President.

He said the prosecution would recall to the witness stand Emma Lim, who testified on Friday that she

collected a total of P3 million in jueteng money this year from presidential son and San Juan Mayor Jinggoy Estrada, P5 million from suspected gambling lord Rodolfo "Bong" Pineda and a P1.19-million check from presidential adviser on Bicol affairs Anton Prieto.

Lim is a secretary of Singson whose exposé on the alleged payoffs to Mr. Estrada from jueteng operators triggered the impeachment trial.

Singson, a former political ally and drinking buddy of the President, has admitted acting as go-between for Mr. Estrada and the jueteng operators.

Former Philippine National Police chief Deputy Director General Roberto Lastimoso, the first prosecution witness to take the stand, said Mr. Estrada had instructed him to assist Singson in the illegal gambling activities.

"There is a paper trail and the prosecutors are doing very well," Lagman said.

However, the Integrated Bar of the Philippines (IBP) batted for the replacement of the congressmen-prosecutors, saying they were no match for the powerhouse defense panel led by former Chief Justice Andres Narvasa and former Solicitor General Estelito Mendoza.

IBP president Arthur Lim warned that Mr. Estrada would likely be acquitted "not because there is no evidence, but because the evidence will not be established at all due to the inexperience of the prosecutors in litigation and trial work."

Lim suggested that the House panel allow IBP lawyers to do the actual litigation while the panel acts as managers or supervisors.

Such a setup is reportedly allowed under the impeachment rules approved by the Senate.

Senate President Aquilino Pimentel Jr. was forced to call a meeting between both sides before trial resumes today to iron out "procedural lapses" committed by the prosecutors.

Pimentel noted that the House prosecutors were not prepared for the presentation of documents and evidence, prompting the tribunal to suspend sessions several times during the first two days of the hearing.

But Sen. Renato Cayetano, himself with extensive experience as a trial lawyer, said it was expected that the prosecutors would have jitters at the start of the so-called "trial of the century", the first for any incumbent national leader in Asia.

Cayetano said it was unethical for Lim to criticize the prosecution panel this early and volunteer the IBP services. "They (IBP lawyers) should just relax because to say the panel of prosecutors are incompetent does not speak well for the IBP. They should just let the panel do its job."

The President has pleaded not guilty to the charges of bribery, graft and corruption, betrayal of public trust and culpable violation of the *Constitution*.

The accusations stemmed from allegations by Singson that Mr. Estrada pocketed more than P400 million in jueteng payoffs, skimmed tobacco taxes and financed a lavish lifestyle for his mistresses using public funds.

Singson said more damaging testimonies will be presented today against the President, but refused to identify the witnesses citing security reasons. Lawyer Pablito Sanidad, who is assisting the prosecution panel, said they did well on

Friday after a shaky start the day before.

Meanwhile, former Speaker Manuel Villar Jr. said a "fast and credible" resolution of the impeachment case would restore normalcy in the country.

"Filipinos are looking to a speedy resolution of the case where the truth will be uncovered so their lives can go back to normal," Villar said in a statement.

He has also said that the outcome of the trial must be credible and acceptable to the people so that the faltering national economy could recover.

"It must not be tainted by any kind of political maneuvering, otherwise, it will only be bad for the country's economy," Villar stressed.

Complainants satisfied with prosecutors

The 77 congressmen who signed as complainants in the impeachment case expressed satisfaction with the performance of the prosecutors despite observations that the panel would take a beating from their defense counterparts.

Isabela Rep. Heherson Alvarez said there was yet no need to change the members of the prosecution panel.

"The prosecution is far, far ahead in terms of quantum of evidence," Alvarez said, adding that the prosecutors "need only show the preponderance of evidence to win the case."

"There were gaffes, but these did not diminish the impact of the damaging testimonies of the witnesses for the prosecution," Batangas Rep. Ralph Recto said.

"If the Valhalla check and Emma Lim's testimonies were a preview of things to come, then the defense's client is in deep trouble, and we have to give the prosecution credit for that," Recto added.

He was referring to a P142-million check ostensibly issued by a certain Jose Valhalla, whose signature bore uncanny resemblance to that of the President in the P500 bill, and paid to Jose Luis Yulo for the purchase of a so-called Boracay mansion for presidential mistress Laarni Enriquez.

Brushing aside suggestions that the prosecutors be replaced with experienced trial lawyers, Recto said it is still "too early in the game to make substitutions."

Among the prosecutors who have yet to present their case in the four-point impeachment trial are Makati Rep. Joker Arroyo, Iloilo City Rep. Raul Gonzalez, Quezon Rep. Wigberto Tañada, Misamis Oriental Rep. Oscar Moreno and Pampanga Rep. Oscar Rodriguez.

The influential Catholic Bishops' Conference of the Philippines (CBCP) and the Kilusang Mayo Uno (KMU) also threw their full support for the prosecution team.

A statement by the National Secretariat for Social Action, Justice and Peace, the social action arm of CBCP, said it was God's will that the 11 congressmen were picked as prosecutors in the impeachment trial.

"God has a purpose for the prosecution panel. He will not abandon them. History is being made and the prosecutors know their part," the NASSA said.

KMU chairman Crispin Beltran said the senators acting as judge and jury in the case "still have the opportunity to prove themselves on the side of the people and uphold the verdict that people's courts all over the country have laid down against Estrada."—**Liberty Dones, Sandy Araneta, Teddy Molina**
