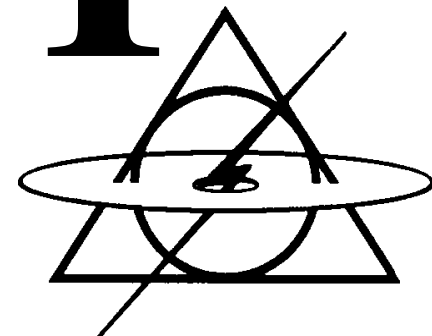

**TEMPLE MOUNT FANATICS  
FOMENT A NEW THIRTY YEARS' WAR**

This article represents only a brief summary of the voluminous material gathered by the taskforce since the Nov. 4, 1995 assassination of Israeli Prime Minister Yitzhak Rabin. A comprehensive Special Report, featuring the transcripts of many of the key interviews, and scores of heretofore

secret documents, is now in preparation.\*

On Oct. 16, Israeli police turned back members of the Temple Mount and Land of Israel Faithful Movement, as they attempted to enter the Dome of the Rock to anoint the cornerstone of a Third Temple. It was an extraordinary provocation, given that, for the previous 17 days, the Israeli military and police had been waging a round-the-clock shooting war against Palestinian protesters, armed mostly with stones. Dozens of Arab demonstrators had already been killed, and Jerusalem was about to explode in religious warfare.

An earlier press release by the Temple Mount Faithful had claimed that “the event has the approval of the Israeli authorities and will be protected by the Israel security forces.”

The press release, written by Faithful leader Gershon Salomon, proclaimed, in blood-curdling language, “Now it is the time to rebuild the House of G-d on the holy Temple Mount, the location of the First and Second temples. G-d is ready for this and He expects Israel to re-liberate the Temple Mount from the pagan Arab worshippers and to rebuild His house to again be the heart, soul, and focus of Israel and all the nations... Come and see for yourself what G-d is doing with Israel at this great time and be a part of this major end-time event.” [H: Please do NOT miss the way “GOD” is referred to as G-d. It is a major clue, friends.]

Had the Israeli authorities allowed these Temple Mount fanatics to carry out their provocation—the Dome of the Rock and the Al-Aqsa Mosque are among the holiest sites in Islam and have been the targets of scores of terrorist attacks by Jewish “Temple Mount” terrorists—a holy war of incalculable consequences would have erupted.

Just three weeks earlier, Israeli authorities had permitted Ariel Sharon, the head of the Likud bloc, the notorious “Butcher of Sabra and Shatilla” Palestinian refugee camps in Lebanon, and a leading player in the Temple Mount apparatus, to enter the site, accompanied by thousands of Israeli security personnel. Sharon's Sept. 28 appearance triggered the Arab protests, which were followed by deadly-force Israeli retaliation. In a matter of days, the entire Mideast peace process was in shambles, and war just a moment away. Such is the horrific power of religious warfare in the Middle East—in the hands of lunatic zealots.

On the day when Sharon staged his well-financed provocation at the Temple Mount, Israeli and Palestinian negotiators in New York City had reported that they were hours away from concluding an agreement that would have restored the momentum to the peace process. The peace process had come to a screeching halt the instant that President Bill Clinton, under the influence of Vice President Al Gore and some treacherous advisers on the president's Mideast team, had convinced the president to raise the issue of the Temple Mount and Jerusalem at the Camp David summit last July. Lyndon LaRouche described the insertion of the Temple Mount issue into the peace talks as “President Clinton's greatest blunder”.

At the United Nations Millennium Summit in New York City at the beginning of September, President Clinton had met, separately, with Arafat and Barak, and extracted a commitment to attempt, once again, to reach a final agreement. Sources indicate that, this time around, the issues of Jerusalem and the Temple Mount were to be deferred, in favor of a more limited, but acceptable agreement.

It was at that moment that Sharon played the “Temple Mount card” and, literally, all holy hell broke loose.

**THE INVISIBLE CHAIN OF COMMAND**

It is no secret that Sharon is the most visible and prominent “godfather” of the Temple Mount fanatics inside Israel. The Ateret Cohanim yeshiva, located in the Old City of Jerusalem, is one of the hubs of Jewish underground guerrilla warfare activity, directed against the Islamic holy sites on the Temple Mount. Sharon has been a fixture at New York fundraisers of the Friends of Ateret Cohanim, as has his ostensible rival within the Likud, former Prime Minister Benjamin Netanyahu.

Sharon has reportedly been the conduit of millions of dollars to the Gush Emunim movement of Rabbi Moshe Levinger and the late Rav Zvi Yehuda Kook, which serves as a religious fundamentalist death squad, out of the Kiryat Arba settlement near Hebron, on the West Bank, and out of at least 130 other settlements dotted throughout the Israeli occupied territories, which Gush Emunim cadre have founded since the late 1960s.

(In February 1994, shortly after the signing of the Oslo I Accords at the White House, a Kiryat Arba fanatic in the Israeli Defense Forces reserves, Baruch Goldstein, massacred scores of Islamic worshippers as they prayed at the Cave of the Patriarchs mosque in Hebron. Goldstein is heralded as a hero and a martyr by the Gush Emunim.)

**Through months of investigation, more than 30 interviews, and a review of thousands of pages of primary source documents, some never previously made public, *EIR* has established that the entire Temple Mount provocation is being run, top-down, by the most lunatic elements within the highest levels of British Freemasonry—with the blessing and involvement of members of the House of Windsor.**

**This Masonic control is exerted through the Quatuor Coronati “research” lodge of the Grand Mother Lodge of British Freemasonry, headed by the Queen's first cousin, the Duke of Kent, and run on a day-to-day basis by the Seventh Marquess of Northampton (Spencer “Spenny” Douglas David Compton), a maternal descendant of the Baring Family, of British East India Company (BEIC) notoriety.**

[H: Take a test quiz please: How many of you thought Dr. Coleman (*Committee of 300*) was a bit nuts and we were simply, as described by *Spectrum* members, Basket Case(s) or suffering from Alzheimer's?]

Lord Northampton, who has been atop the Temple Mount conducting “Temple studies”, candidly has admitted in interviews that he is an adherent of British Israelism, which holds that the British oligarchy has mystical powers, because England was colonized by one of the lost tribes of Israel. “I think the tradition of the *Kabbalah* is very strong in England, because I think one of the lost tribes came to England. And I think you can spot them, quite clearly, in old English families. I am sure you can. I know they came to Ireland, then to the north of Wales, and then down into England. And then that they became some of the oldest families we have.”

He ranted on that America, too, had been colonized by another of the lost Tribes. “That was all predicted, that one would go to Hyperborea, the land of the north, and one would go across the sea. And so I think that America and England got the Two Lost Tribes, and that is why they then, in a very intellectual Jewish way, started to run the world!”

Lord Northampton is, by his own admission, a practitioner of the **Satanic rituals of Aleister Crowley.**

Indeed, as he explained to an interviewer, Lord Northampton installed one of the world's leading "scholars" of the Golden Dawn cult, R.A. Gilbert, as the editor-in-chief of *Ars Quatuor Coronarum*, the theoretical journal of the lodge. Crowley had written an account of his "spiritual progress" in magic and Satanism under the title *The Temple of Solomon the King*.

#### THE JERUSALEM LODGE

In December 1995, the "Jerusalem" freemasonic lodge was established, adjacent to the Temple Mount, in the Grotto of King Solomon, to work for the rebuilding of Solomon's Temple. The lodge worked side by side with the on-the-ground networks of Jewish and Christian fundamentalist fanatics, to foment a bloody religious war over the control of the Temple Mount. That such a lodge would be founded shortly after the Israel-Palestine peace breakthroughs at Oslo—and just weeks after the assassination of Israel's Prime Minister Yitzhak Rabin, an architect of that peace—is surely no coincidence.

**The Jerusalem Lodge was founded by the Grand Master of Italian Regular Freemasonry, Giuliano di Bernardo, the right-hand man of Lord Northampton on the Temple Mount project. At the ceremony launching the Jerusalem Lodge, Di Bernardo declared, "The rebuilding of the Temple is at the center of our studies." In June 1996, Di Bernardo published an Italian edition of his book, *Rebuilding the Temple*, which was to be published in English by the Quatuor Coronati Lodge.**

In interviews, Di Bernardo candidly admitted that he has constructed an entire irrationalist "utopian" belief system, centered on the revival of Jewish Cabbalism and the rebuilding of the Temple. "A new utopia may be based on the Cabbala. I see a utopia based on Jewish mysticism, but Jewish mysticism as a place... a material place, Solomon's Temple. ... This is my intention. This is my will!"

Di Bernardo also let slip that Anti-Defamation League of B'nai B'rith director Abe Foxman is a collaborator in the Temple Mount project. Di Bernardo revealed that, while Foxman lacks intellectual capital, Lord Northampton and he had met Foxman in Switzerland, just prior to the launching of the Jerusalem Lodge, to discuss their project, and have met with him on several other occasions. "There are strong relations between B'nai B'rith and Freemasonry," Di Bernardo explained.

The role of the Quatuor Coronati Lodge in the Temple Mount plot significantly predates the launching of the Jerusalem Lodge. Dr. Asher Kaufman, a corresponding member of the Quatuor Coronati Lodge, did some of the first post-war archaeological "studies" of the Temple Mount, laying the foundations for the upsurge of Jewish fundamentalist assaults on the site. He was personally dispatched to Jerusalem by the Lodge's Dr. T.E. Allibone, a senior figure in the British Royal Society, and one of Britain's preeminent nuclear physicists, who served for 30 years as the "Lord of the Manor" of **Britain's most top-secret nuclear weapons laboratory at Aldermaston.**

**Another key figure, whose work has dovetailed with the Quatuor Coronati activities on Temple Mount, is the Dutch-born architect Leem Ritmeyer, who received his doctorate from Manchester University in England on the design of Solomon's Temple. Ritmeyer's work in Israel, in which he claims to have discovered the resting place of the lost Ark of the Covenant inside the**

**Dome of the Rock, has been almost wholly financed by Lord Jacob Rothschild, the son of the late Lord Victor Rothschild, and the head of Rothschild Investment Trust. The Rothschilds are at the very center of the British oligarchy's "Club of the Isles" (see "The True Story Behind the Fall of the House of Windsor," *EIR Special Report, September 1997, for an in-depth profile of the Club of the Isles*), the inner elite of policymakers, senior intelligence officials, City of London financiers, and raw materials barons, who are centered around the Royal Consort, Prince Philip, the Duke of Edinburgh.**

#### ANOTHER DIMENSION OF THE ASSAULT

With the deployment of Dr. Asher Kaufman to Jerusalem in 1967, just weeks after the conclusion of the Six Day War in June, another dimension was added to the Temple Mount assault. An extensive network of American-based Christian fundamentalists, largely associated with the Darbyite movement and its Dallas Theological Seminary, soon were linked up to the Temple Mount operations under way inside the Old City of Jerusalem, which was now in the hands of Israeli authorities **for the first time in 1,900 years.**

Through Temple Mount Faithful founder Stanley Goldfoot, a member of the Stern Gang terrorist underground, Dr. Lambert Dolphin, a physicist at the **Stanford Research Institute in Menlo Park, California**, was brought to Jerusalem in the early 1980s. Dolphin had already been in correspondence with Kaufman, but it was Goldfoot who put the Quatuor Coronati field operative, Kaufman, together with the Darbyite fundamentalist, Dolphin. During World War II, Goldfoot had worked for Lord Martin Charteris, then-British intelligence station chief for the Middle East, and later, private secretary to Queen Elizabeth II.

Soon, massive amounts of money from American-based Darbyite Christian fundamentalists began pouring into the Jerusalem operations, **aimed, ultimately, at blowing up the Muslim holy sites at the Temple Mount, and building the Third Temple.** The American Jerusalem Temple Foundation was one early source of financing for this insane effort. According to Dolphin's exhaustive writings, now posted on Website, another big source of largesse has been Chuck Missler, a U.S. Naval Academy graduate and CEO of a string of U.S. defense companies, who runs a Darbyite publishing firm, Koinonia House, which propagandizes for the destruction of the Islamic sites and the building of the Third Temple.

Dolphin set all of this down in a written account of his 1994 visit to Israel, accompanied by Missler and 70 "pilgrims". "My specific responsibility on this tour," he wrote, "was to organize and host the Third Annual Temple Conference in Jerusalem where Jewish scientists and religious leaders presented ten papers concerned with the location of the First and Second Temples and plans and projections concerning the coming of the Jewish Messiah."

Dolphin revealed his own views on the current state of affairs inside Israel: "Now, strangely, the Jews have become their own worst enemies. The present government is openly, blatantly anti-Biblical and has set about dismantling the state of Israel piece by piece, giving it all back to Israel's own sworn enemies in exchange for peace promises everyone knows are empty and meaningless. Even more amazing is that the public is well informed about all

these issues and chooses to do nothing."

Dolphin was referring to the Oslo Accords, recently signed by Prime Minister Rabin, Palestinian Authority President Yasser Arafat, and President Clinton.

Dolphin made no bones about the fact that a great deal of blood would have to be shed for the Temple project to be completed. "Some things are clear," he wrote. "Sinful man cannot approach a holy God without a suitable sacrifice. **The shedding of blood is somehow necessary** to make atonement for human evil. Even forgiven sinners need washing and regular cleansing in order to enjoy fellowship with their Creator. ... God in His love wishes to teach us the depths of his love and forgiveness and mercy through the symbolism of the temple."

Dolphin ended with an ominous warning: "The time is fast approaching when the Temple Mount will (by one means or another) be accessible both for full-scale geophysical exploration, and for digging and exploring."

**It is no small irony that the Darbyism preached by Dolphin, Missler, and the other central figures in the American Jerusalem Temple Foundation, is deeply anti-Semitic. At the core of the Gnostic "dispensational premillennarianism", advocated by 19<sup>th</sup>-Century Anglican clergyman John Nelson Darby, is the belief that the extermination of the Jews, in a final battle of Armageddon, brought on by the rebuilding of Solomon's Temple, is the Biblical precondition for the second coming of the Messiah and the Rapture. Pastor Chuck Smith, Dolphin's mentor at the Calvary Baptist Church, when asked by *EIR* whether he had any compunctions about unleashing a holy war that would lead to the possible extermination of millions of Jews and Muslims, replied, "Frankly, no, because it is all part of Biblical prophesy."**

Smith was also full of praise for the Jewish zealots of the Temple Mount Faithful, and their founder, Goldfoot: "Do you want a real radical?" he asked. "Try Stanley Goldfoot. He's a wonder. **His plan for the Temple Mount is to take sticks of dynamite and some M-16s and blow the Dome of the Rock and Al-Aqsa Mosques and just lay claim to the site.**"

#### RABBI KOOK AND "VLADIMIR HITLER"

Shortly before Prime Minister Rabin was murdered by a Jewish underground assassin, Yigal Amir, who was associated with the radical West Bank settlers and the Temple Mount crazies, Rabin had described the Jewish fundamentalist fanatics as an "errant seed", that had nothing to do with Judaism. The Judaism to which Rabin was referring, was the Mosaic tradition, carried into the founding of the state of Israel by such followers of Moses Mendelssohn as David Ben-Gurion, Abba Eban, and Rabin's "peace partner", Shimon Peres.

But, under the sponsorship of the British Crown, the Club of the Isles, and the British Masonic structures, the "errant seed" had been injected into the religious and political life of the Jewish community in Palestine long before the launching of the current Temple Mount project. And not surprisingly, that irrationalist theological current closely paralleled the Jewish fascism of Vladimir Ze'ev Jabotinsky, the founder of the so-called Revisionist movement, that spawned the Likud bloc and the Gush Emunim of today's "fundamentalized" Israel, and the man whom Ben-Gurion, the founding father of the state of Israel, referred to as "Vladimir Hitler".

British imperial occult designs on Jerusalem and the Temple Mount first surfaced prominently in 1865, with the founding of the Palestine Exploration Fund, under British royal sponsorship, and the first archaeological expeditions to the Holy Land. Prince Edward Albert, the son of Queen Victoria who would succeed her as King Edward VII, had visited Jerusalem in 1862, and put his imprimatur on the launching of the Palestine Exploration Fund immediately thereafter. Prince Edward Albert, known as the “Prince of the Isles”, was a dominant figure in Britain’s imperial designs of the late 19<sup>th</sup> Century, and Jerusalem and the Holy Land was one of his personal priorities.

The first excavation of the holy sites in Jerusalem, centered on the Temple Mount, was carried out by the Palestine Exploration Fund, under the direction of Gen. Sir Charles Warren, during 1867-70. This expedition launched the British Freemasonic “Temple Mount project”. In 1884, Warren was one of only nine Freemasons who founded the Quatuor Coronati Lodge, and he became its first head.

Within occult Judaism, the pivotal religious figure in this British-sponsored saga was Rav Abraham Isaac Kook. According to Kook’s autobiography, in pre-World War I London, he was an intimate collaborator of Jabotinsky, recruiting and raising funds for Jabotinsky’s Jewish Legion, which fought the Ottoman Turks on behalf of the British empire.

After the British Mandate was established over Palestine, Rabbi Kook was appointed by London to serve as Palestine’s **Ashkenazic** Chief Rabbi, a post he held until his death in 1935. Rabbi Kook revived Jewish mysticism, the teaching of the *Cabbala*, and the prophesies relating to the Third Temple.

Even more relevant to the present onrush of a religious war over the Temple Mount, Rabbi Kook the Elder founded Merkaz HaRav (the “Rabbi’s Center”) in Jerusalem, as a training academy for young religious zealots. When he died, his son, Rabbi Zvi Yehuda Kook, inherited the entire apparatus, including the infrastructure of training academies, which had spawned out the original Merkaz HaRav yeshiva.

A famous story about Rabbi Kook the Younger is told by his students. On Israeli Independence Day in 1967—three weeks before the outbreak of the Arab-Israeli war—Rabbi Kook was delivering a sermon, in which he recounted, “Nineteen years ago, on the very night that the decision of the United Nations to create the State of Israel was handed down, as the entire people rejoiced... I was unable to join in their happiness. I sat alone—quiet and depressed. In those very first hours I was not able to accept what had been done, that terrible news that, indeed, ‘my land they had divided’ had occurred! Yes, when is our Hebron—have we forgotten it? And where is our Schechem [Nablus], and our Jericho, where—will we forget them? And all of Transjordan—it is all ours, every single clod of earth, each little bit, every part of the land is part of the land of God—is it in our power to surrender even one millimeter of it?” He then told his students that “the Army of Israel will liberate the land of Israel.”

Three weeks later, the Israeli Army took control of East Jerusalem, including the Temple Mount, in the June 6-11, Six-Day War. Rabbi Kook’s followers claimed that he had performed a miracle. In fact, there is no doubt that Rabbi Kook was one of a handful of figures who was aware of the secret plans for the war.

Among the Israeli paratroopers who seized control

of the Western Wall of the Temple Mount, were students from Merkaz HaRav, who arranged for an armored car to fetch Rabbi Kook, to preside over the hoisting of the Israeli flag on the Western Wall and the blowing of the shofar, the ceremonial ram’s horn.

Two weeks later, in London, the greatest gathering of Freemasons in memory took place, to commemorate the 250<sup>th</sup> anniversary of the founding of the United Grand Lodge of Kent as the new Grand Master of Masonry. It was out of that gathering, according to T.E. Allibone, that the decision was made to dispatch Kaufman to Jerusalem, launching the Quatuor Coronati drive to locate the precise spot where the Third Temple would be built. Almost on the same date, Rabbi Zvi Yehuda Kook launched the Temple Mount Faithful, with the Stern Gang terrorist Goldfoot. Kook also established the Gush Emunim (although Gush Emunism would not be formally constituted as an organization until 1974).

#### THE JEWISH UNDERGROUND, UNRAVELED

Rabbi David Samson, a student of Rabbi Zvi Yehuda Kook, is one of the leading biographers and promoters of the Cabbalistic teachings of Rabbi Kook the Elder. He confirmed to an interviewer that the Merkaz HaRav yeshiva networks founded by the Kooks is at the heart of the Gush Emunim settlers movement and the Temple Mount Faithful. “The entire settlements of Judea and Samaria, and the Golan, is all Merkaz HaRav,” he said. “Rabbi Kook decided that ‘I am going to establish a settlement movement,’ Gush Emunim is Merkaz HaRav. And the leaders of Gush Emunim are all the students of Rabbi Zvi Yehuda, and whenever they would make a major policy decision, it would be in his dining room, sitting at his table.” He later added, “Definitely, Rabbi Kook’s students are again at the forefront.”

Rabbi Samson also confirmed that Sharon had developed a deep personal collaboration with Rabbi Kook, specifically around the launching of the illegal settlements in the West Bank and other parts of the territories occupied after the Six Day War and the 1973 Yom Kippur War. “Immediately after the Yom Kippur War,” Samson said, “Sharon went, together with Rabbi Zvi Yehuda Kook, to the first illegal settlement, that was meant as a demonstration against the Army.” He added, “His [Sharon’s] connection with Merkaz HaRav was with Gush Emunim. ... He was in the opposition together with Merkaz HaRav ideology.”

Rabbi Samson also confirmed that the Merkaz HaRav networks have heavily penetrated the Israeli Defense Forces (IDF), through the hesder yeshivas, which are, in effect, military training institutes that also teach the Kooks’ Cabbalistic fundamentalism. Students at the 22 hesder yeshivas, mostly in the occupied territories, spend their five years of study serving part-time in the Army, and spending the rest of their time in Cabbalistic studies. This apparatus has transformed the IDF into an evolving instrumentality for the Cabbalistic-fundamentalist holy war.

With Rabbi Kook the Younger’s death in 1982, the leadership of Gush Emunim and the Temple Mount Faithful has been picked up by a group of even more violent and radical protégés, including Rabbi Moshe Levinger and Rabbi Eleazer Waldman. Waldman has asserted that Kook demanded a holy war as the only means of achieving the coming of the Messiah. “On the one hand,” Waldman wrote, “war is accompanied by destruction and death, on the other hand, it increases the power of the Messiah. ... Unfortunately,

it is still impossible to achieve the completion of Redemption by any means other than war.”

**[H: NOW HOW DO YOU FEEL ABOUT THE POSSIBILITY OF HAVING NO WAR?]**

Rabbi Samson confided that former Israeli Prime Minister Netanyahu “himself studies Rabbi Kook’s writings with some of the biggest rabbis in Merkaz HaRav, on a regular basis. ... Bibi Netanyahu is very oriented this way. He was in Merkaz HaRav on Jerusalem Day [1996] and it seems that his relationship with Rabbi Kook is very serious. The Minister of Justice that he appointed, not because of any coalition agreement, just because he was the one he wanted the most, is a proponent of Rabbi Kook’s philosophy and is very well-versed in Rabbi Kook’s philosophy.” This, too, should come as no surprise, **given that Netanyahu’s father was the personal secretary of Jabotinsky, the intimate collaborator of Rabbi Kook the Elder.**

**[H: Read that again and see how you feel with this week’s effort to get things situated to replace Barak with Netanyahu? Yes, indeed, WORLD, it certainly is time to pay attention.]**

#### WHERE DOES IT LEAD?

In the mid-1980s, after the United States arrested American citizen Jonathan Jay Pollard on charges of spying for Israel, the U.S. Defense Department’s Defense Academic Research Support Program funded a research paper on the rise of fundamentalism in Israel and its strategic implications. The report, written by Ian Lustick, Associate Professor of Government at Dartmouth College, was published in expanded form by the New York Council on Foreign Relations in 1988.

Its conclusions were blunt: Were the emerging Jewish fundamentalists, associated with Gush Emunim, and a growing faction of ultra-nationalists within the Israeli military (veterans, for the most part, of Merkaz HaRav), to seize power, “An Israel decoupled from the United States, opposed in principle to a negotiated peace, unfettered by the norms of liberal democracy, animated by redemptionist imperatives, and disposing of a large and sophisticated nuclear arsenal would pose challenges to American foreign policy and security interests at least as profound as those resulting from the Islamic Revolution in Iran.”

**Lustick’s best-case scenario, under such an eventuality: a religious war as devastating as the Thirty Years’ War in Europe (1618-48). His worst-case scenario was thermonuclear World War III.**

In the first part of this small book we asked the question whether or not Mr. Higger interpreted the Prophets of the *Old Testament* as trying to unite their people in a movement of Jewish nationalism, or did Higger accept the version held by most Christians that the Prophets were simply preaching individual morality and the worship of God. No doubt the reader has answered that question for himself by now. But the author answers it specifically on page 113 in his final chapter, “The Kingdom of God”:

*“We are now in a position to discuss the Jewish conception of the Kingdom of God. The contrast between Christian dogma and the Jewish doctrine of the Kingdom is evident. The dogmatic doctrine of the Kingdom of the New Testament is not a continuation of the prophetic hope at all. Nothing is mentioned in the New Testament of the spiritual and material glory of Palestine in the day of fulfillment. The Kingdom that Jesus, according to the New Testament account, speaks of is more*

*mystical, inward and personal. The New Testament is mainly concerned, not with the earthly, but rather with the heavenly Kingdom of God. We read thus in John 18-36, ‘Jesus answered: My kingdom is not of this world. If my kingdom were of this world, then would my servants fight, and I should not be delivered to the Jews. But now is my kingdom not from hence.’*

*“Unlike the prophets, therefore, Jesus thought of the Kingdom as having actually begun with him and his disciples...”*

*“The Kingdom of God, as pictured by the Jewish prophets, on the other hand, is an ideal society of nations on Earth, living in accordance with universal ethical rules of genuine justice, righteousness and peace. The ideal Kingdom is a universal idealization of the most important experiences of Israel in the past. The Davidic ruler, to be recognized universally, will be the perfect ethical character. The people who are to constitute the ideal community at the beginning of the ideal future are a remnant...”*

*“What the prophets anticipated did not come to pass. The rabbis, unconsciously, took up the idea of the Kingdom of God, where the prophets left off. The spiritual leaders in Israel expanded and developed that glorious dream of an ideal Universal State. The people who are to constitute the ideal community at the beginning of the ideal era, will be, instead of a remnant, the entire ideal people of Israel.”*

**[H: If you cannot see that MAN (from the beginning) wrote “the way it will be” and foisted it off on you unsuspecting people, then look again at the LAST SENTENCE: “THE PEOPLE WHO ARE TO CONSTITUTE THE IDEAL COMMUNITY AT THE BEGINNING OF THE IDEAL ERA, WILL BE INSTEAD OF A REMNANT, THE ENTIRE IDEAL PEOPLE OF ISRAEL.” Remember: “Israelites” are “Zionists” by their own definition—not just “Jews”. In fact, it is said that the “Jews who are not Zionists and of the superior ‘tall and handsome’ race will not even share in the ultimate world order”. Where does that leave you nice “Jewish” neighbors who thought you were God’s chosen? These Zionists are working toward a species of ONLY fair-haired supreme humans who bear NO RESEMBLANCE TO THE PERCEIVED “JEWS”. THIS INFORMATION IS FROM THEM (THE HORSE’S MOUTH)—SO DO NOT DENOUNCE ME OR MINE FOR YOUR FAILURE TO READ THE WRITINGS PRESENTED DIRECTLY FROM THE SAME ONES WHO WROTE YOUR INSTRUCTION BOOKS.]**

(Though the author shows that he interprets the prophets as working for a Universal State—of Israel—the reader may observe that he seems to contradict his earlier statements that only certain chosen Jews will be “invited” to Israel—unless he means that only the “ideal” people of Israel will be chosen.)

The Shinto-like character of the Zionist religion, the religion of Jewish racial-politico-economic nationalism (as contrasted with true religion, the worship of GOD, for instance, of the non-Talmudic Jews) is inescapable. The Jewish and non-Jewish flocks are to be made to believe that the “righteous” Jews are descended from

God. The ruler shall be the “Holy One” [H: And very human]. All the world must WORSHIP that Jewish King AS GOD.

“And he shall gather together a holy people... for he shall know them, that they are all sons of their God.”

#### WHEN WILL THE UTOPIA BEGIN?

When is the *Utopia* to be established? Do the Zionist planners expect to bring about the commercial and political fulfillment of their interpretation of the Prophecies, what they call God’s promises to the Jews, in our lifetime? What is the timetable of these peace lovers for bringing about the final war?

We find many partial answers in *The Jewish Utopia*, many milestones by which we can at least hazard some guesses.

Obviously, the setting up of a Jewish state in Palestine was a milestone. The Zionists did that in 1948—without God but with the help of Harry Truman and the Soviet Union. [H: Why do you think there is so MUCH reference to your candidates to being somehow “like” Harry Truman? Does it not appear to even be ridiculous? Your George Bush constantly (like a robot) refers to himself and his campaign as being likened unto Harry Truman’s. Harry Truman was one of the blackest tools to walk your planet—and you have all the candidates comparing themselves to this evil little trollop.]

Israel is being developed and beautified (with foreign capital, of course). [H: YOURS] The papers all the way back to August 1957 announced plans for building a \$500,000,000 port at Ashdod. The will of the BRITISH ROTHSCHILDS leaves fabulous millions to help erect and beautify a capitol building and perhaps museums and the like. Plans are proceeding for development of irrigation. Israel is developing some atomic plants “for peaceful uses”, of course, and some other industry—with secrets taken quite openly from American industry and laboratories, as for instance, through the information-gathering agency (normally called an espionage net) known as Technion, which operates in universities and industrial establishments.

The United Nations has been established, and the Congress of the United States officially authorized the flying of the United Nations flag above Old Glory on the UN Building. (You or I would be held guilty of treason—and rightly so—if we flew a flag above our flag.) Thus begins, and grows, the nucleus for the world police force, and the UN is purely a Jewish invention.

Higger says:

“The nations will first unite for the purpose of calling upon the name of the Lord, to serve Him.”

If the UN is to have a religious aspect, as here stated, its inventors intended the religion to be Jewish—and could that be the reason why religion has been conspicuously kept out of the UN so far, leaving the way clear? [H: Ah, but has it STILL been kept out—what about the U.S. PUBLIC LAW 102-14 NOW PASSED? IS IT NOT THAT THE UNITED STATES NOW OPERATES UNDER THE AUSPICES OF THE UNITED NATIONS’ CHARTER AND NOT UNDER THE PUBLIC LAWS AND CONSTITUTION OF THE UNITED STATES? YOU HAD BEST GO CHECK IT

OUT LITTLE SLEEPYHEADS. THAT PUBLIC LAW WOULD NOT HAVE PASSED IF IT WERE NOT ALREADY LOCKED-IN TO THE UNITED NATIONS!]

The East-West division of the world is nearly complete; the Moslem world of some 300,000,000 people has largely been shifted away from us toward the Communist camp. **The Zionist Jews have done a clever job in this maneuver, taking land away from the Arabs, bayoneting their women and children, thus making the whole Moslem world (with the possible exception of Pakistan) so hate us for backing the Jews that the Moslems may at last accept arms from and cooperate with the Soviet Union.**

We might well say that this milestone has been erected, for it now awaits only an incident to set off Armageddon. Israel can attack Egypt and possibly set off the war. Or the Jews who dominate, or vastly influence, the Soviet dictatorship from within, through the hidden, secret power circle called the Communist Security System, perhaps can order or induce the Communist government to attack, or cause some Arab country to attack Israel—whenever the Jewish strategists are ready. They will not do so till they are sure the Zionists in the West can induce the President of the United States and the British government to support Israel—we can be sure. Whatever the gentile Communists may want, it is logical that the Jewish Communists will not want war with the West till the West can safely be sucked in to fight the Arabs for the Zionists.

Comparing plans and objectives revealed in *The Jewish Utopia* with the present world situation, we can arrive at a rather clear picture of the future war and even see which countries are to be wiped out as wicked and unrighteous—if the Zionist plans succeed. We can at least see what the Zionists are trying to bring to pass. Since Israel must expand and since it can expand only at the expense of the Arabs, the Israelitic group must destroy the Arab states. Already the Arabs and their Moslem sympathizers are vilified in the Jewish press, and in planted stories in the general press, as “anti-Semitic” (though the Arabs themselves are Semites). The Moslems are wicked and unrighteous (though all they have done to become unrighteous is to oppose the Jewish invasion of their lands).

But now the Communist Empire is supplying arms to some of the Arab states [H: As so, too, have you!] and, though certain Jewish nationalists or Zionists, originated Communism and imposed it on the Russians and Eastern Europeans, and though some Jews still occupy powerful positions behind the iron curtain, it seems certain that at the proper time, the Zionists in the West will launch a campaign of abuse and fury against the Soviet Union (not against Communism as such) as anti-Semitic and ungodly! How else could the Zionists bring about a mighty war in the Middle East? And without the war, how could they get the Arab lands? And how else could they bring about further disintegration of the non-Jewish nations and races? Without a frightful crisis how can they and their “liberal” tools stampede us into surrendering our freedom?

The Russian people, the Ukrainians and the overwhelming majority of Eastern Europeans are anti-Semitic (in the sense that they resent the bloody Jewish-inspired terror which gripped them under the

Communist regime). But the Communist governments, on the other hand, have been overwhelmingly Jewish or pro-Jewish, so much so that all of these Red governments incorporated in their constitutions specific prohibitions against “anti-Semitism”, the only countries in the world which singled out the Jews for this special favor.

To get the full benefit of the next world war, however, the strategists will have to raise the cry of official Soviet anti-Semitism, just as they did in the Second World War against the Nazis. Our sons must fight to save the persecuted Jew and thus make every American or Englishman afraid to criticize any Jewish individual or machine, however subversive, for fear he will be smeared as pro-Communist! It is a fact that any American today who could remotely be called anti-Semitic is anti-Communist; but no matter: the Zionist press in the West is so powerful, the newspaper publishers so fearful of losing Jewish department store and other advertising, and elected officials so cowed by any thought of being called anti-Semitic, that when some patriot is smeared in the propaganda releases as anti-Semitic hardly anybody has the character to stand up for him. It is the same thing as introducing a word into language of any kind—watch and see how long it takes to become law of the land and accepted terminology—even though it be a lie. INSTRUCTIONS RE: JOURNALS: If I am in understanding, the prior book is not yet gone to print? Where is the backlog? If it is in the indexing, then cut the sources in the index because it is not good to have a JOURNAL bogged down, still, as the next one is ready for publishing. I would like these JOURNALS

treated as what they are—that they go out about every 3-4 weeks—only one at a time. You cannot treat them as simply “books” or we lose our advantage and our ability to call them “dated magazine” or “news journals”. If one is still floating around and we have been able to write a second one, then something is wrong with the system. If five or six people can’t get out what one person is writing, then we are doing something WRONG. This IS our first line of defense in court: “Factual, dated material” in “reporting” fact and scientific material as regards the “other side” of that which is given as philosophy or metaphysics as generally accepted today. Further, I would rather have less than a perfect “paper”, etc., if we can cut the expenses some way.

Second: Dharma, I want you to get the material sent on food-grade hydrogen peroxide (35%). This is a good additive to purify water a bit more safely than chlorine in greater amounts. What is going to have to happen is the installation of sound wave or “light wave” purification systems if the viruses are to be exterminated. In other words, you are going to have to create a frequency “light wave” (x-ray) that is *higher* than the frequency of the crystalline mechanism or “equal” to it—so that resonance is established which will burst the “bugger”. I really don’t want to go into that here. Perhaps we can have a few gather and ask some of these questions along with ones from recent inquiries, so that we do not get too far behind on taping. I want at least 2 tapes available to THE WORD weekly, please.

It is NOT as simple as “I will do that which you want AND that which I perceive to be better FOR ME.” You can do that which you want to do but examples, in this instance, are most important and if your example is one of digression or total abandonment of our requests, then obviously you are NOT in tune with our work or THE WORD. This too is fine—just don’t go about being angry because you received an answer to something which you do not like. Some of you FORGET that that which YOU DO reflects on another who may well be asking God to solve their problem in a most “just” way and so HE does.

It is time you consider your “anger” with God’s suggestions because the “suggestions” are so much better than HIS “actions” if, indeed, your request came forth as “in the highest and best good”. HE will always choose that highest and best good—and YOU MAY

VERY WELL NOT LIKE OF IT. If you live in the context of YOUR OWN INNER AND OUTER CIRCLE OF RELATIONSHIPS, FOR INSTANCE, THE ANSWER MAY COME THROUGH A CHILD PETITIONING FOR GUIDANCE UNTO THE PARENTS OR TEACHERS OR OTHER CHILDREN. THE “ANSWER” MAY WELL BE APPEARING UNFAIR—**IT WILL ALWAYS BE JUST.**

WE, AS THAT AND THOSE WHO REPRESENT OUR WORK HERE IN THIS PLACE OR THROUGHOUT THE WORLD, MUST NEVER ALLOW NEIGHBORS TO INFER THAT WE BREAK LAWS OF THE LAND, SHYSTER ANYONE AND/OR LIVE LIFE-STYLES UNACCEPTABLE IN DEFIANCE OF “REASONABLE” EXPECTATIONS IN A GIVEN SOCIETY. EACH MUST DETERMINE “WHY” ACTIONS AND/OR NON-ACTIONS ARE ENTERED INTO, AND SEE IF IT BE GENUINELY BECAUSE THE ACTIONS MAKE THE SITUATION AND THE GROWTH OF “ANOTHER” BETTER AND HIGHER—OR IF IT IS FOR CONVENIENCE AND/OR DESIRE OF SELF. THIS ALWAYS MUST BE CONSIDERED WITH ALL INSTRUCTIONS AND ACTIONS REGARDING CHILDREN WHO CAN ONLY DEPEND UPON THE ELDERS AS GUIDES AND EXAMPLES. IS WHAT YOU DO THAT WHICH YOU WISH YOUR CHILD TO REFLECT? HE/SHE WILL, YOU KNOW.

Moreover, for you who perceive these children to be GOD’S and/or mine—they ARE, but they are PLACED INTO YOUR CARE TO NURTURE AND DISCIPLINE AND EXAMPLE FOR THEIR PROTECTION AND GREATEST GROWTH POTENTIAL—AND YOUR WISDOM MUST ALWAYS BE GREATER THAN THEIR OWN, LEST THEY BURY THEIR OWN.

A child cannot get through life and enter into “service” with nothing save shop courses and no disciplined mathematics, science and other skills only learned in programmed school experiences. I most certainly shall not turn my laboratories over to anyone who does not even know the Periodic Table, much less to one who does not even know what the “term” means. Ponder it. We already have enough “misfits” and undisciplined parents—so I need no more right under my nose! Thank you for hearing me, for I am running out of ability to square these topics with you as we move on into greater and greater service and work. We have spent these years in preparation and learning factual insight—and now you will either be ready to move on with us or we shall outrun you and if you are responsible for the child being left to the side—consider it most carefully, for they can only be that which you reflect in them.

If a child has no goodly parent in responsibility, then the child cannot grow beyond that reflection of what he has. And, being a “parent” NEVER ENDS, ONCE BEGUN. WORSE, THE RESPONSIBILITY WAS “ACCEPTED” FAR LONGER BACK IN YOUR JOURNEY THAN IN THIS APPARENT MANIFESTATION. Once the child has reached “maturity” in age, you are obligated to allow it to choose its path but must be ready to undo that which is in error if given the opportunity. If YOU have set the wrong stage for growth, then the responsibility is greater—for the “sins of the Father shall rest upon the sons”. God

will always show the way in every instance—BUT YOU WILL FIND IT WILL ALWAYS REQUIRE YOUR RESPONSIBLE ACTIONS IF YOU ARE RESPONSIBLE IN ANY MEASURE FOR THAT WHICH THE CHILD HAS BECOME. Each adult (of age) must be allowed to go his own way—but if he comes back within the circle, then responsibility resides therein again, even if it only be to disattach and serve notice of same. I guarantee that in every way—even unto the rearing of a child—you shall reap that which you sow and if you give bad reflection and example it shall come back unto thee in pain and regret. Ponder upon these thoughts because, living in this time of chaos and confusion in such a physically oriented world, it becomes most difficult to bear that kind of responsibility. I shall write soon on these “Tough Times” and see if we can offer some often overlooked thoughts to achieving balance and possibilities.

Does this mean that to be in my presence you must have perfection in thought and deed? NO—but neither may you go forth and state that “Hatonn said it is alright” if it is NOT and you know very well that which is right and that which is not sanctioned by God. **I AM A MESSENGER, HEAD OF THE “HOSTS”—I MAKE NO EXCEPTIONS REGARDING GOD’S LAWS! NONE! AND YOU MAY NOT GIVE INDICATION TO ANY ONE ANYWHERE, THAT I DO SO—NOT EVEN IN “OPINION”.**

We work within the laws as written in the land and within, ALWAYS, the LAWS OF GOD. I did not, however, say “the laws as given in that book of rules as presented by your adversary”—I said “THE LAWS OF GOD”. So be it.

Let us start right off this morning with our subject in point, for we do not have long to devote to writing this day.

THE ULTIMATE WORLD ORDER as Pictured in *The Jewish Utopia*:

[QUOTING:]

**ARMAGEDDON TO “RESCUE” THE JEWS**

Given another world war to save the “persecuted” Jews, and our children will be doomed to subjugation and probably enslavement, simply because their fathers and mothers had not the foresight or character to fight to save them.

How can the propagandists make the West believe the Soviet Union has turned at last against its founders? Already since 1948 we have seen the preview more than once. Whenever the public began to talk about the fact that so many Communist spies and Communist frontiers were Jewish, the Soviet government always officially came to the rescue of the Jews in the West by holding a big public trial of some “Jewish” official, or officials. The charge always was treason or disloyalty to the Communist order! Just right to make the students of history in the West look ridiculous when they tried to warn their neighbors that **Communism was a Jewish invention. [H: This has been the biggest mode of operation for decades and in the meanwhile the ones persecuted were the innocent ones thinking themselves to be “Jews” as now defined—but are NOT. Oh, indeed, there have been Judaists persecuted—BUT NOT ZIONISTS!]**

The trials did not necessarily prove that Jews still had the upper hand in the invisible Soviet government, the Communist Security System. For it may well be that Zionist agents could get the particular Jewish officials to spy for Zionism, then betray them to the Communist government, and thus bring about the public trial—which our stupid “liberal” newspaper correspondents and the Zionist press and infiltrators into the wire services almost always represented to the American public as anti-Semitic!

Fantastic, certainly; but indisputable. Facts cannot be denied.

Whether or not certain Jews continue to dominate or hold influence in the Communist regime need not make any difference. Even if nearly every Jew is pressured to get out from behind the iron curtain by the Zionist machine, before A-day (for Armageddon or Atom-bomb day), and even if the remaining gentile Communist dictators are wise to the plot—the Zionists no doubt can produce such incidents, get some Jews indicted and tried, and picture the Moscow regime as officially anti-Semitic.

If the enslaved people of Russia come to believe their Communist slave-masters have thrown off the Jewish yoke and are anti-Semitic, they will fight for the regime. If the indoctrinated, tolerant Anglo-Saxon thinks the Red regime is anti-Semitic, he is apt to fight against it. Thus the Zionists can make the East and the West fight a desperate war—each side actually fighting against its own future welfare.

And assuredly the Zionists can maneuver in the Middle East to steer the war to cause thousands of Israelis to be killed. And it does not take many to give the Zionist propaganda machine in America a chance to go into hysterics over persecution of their people by anti-Semites.

And politicians who have to be reelected may not dare try to get the facts to the American people, to keep us out of the planned war. These politicians, in fact, may not at all understand the game, for few of them seem to have the courage to glance behind the Zionist curtain, even in the dark, to see what goes on there.

At the risk of making this picture even more fantastic, I am forced to point out the opportunity such a war will or would offer the Zionist “idealists” to help purify their tribe. It has been evident for some years that the Zionist redistributors of their people, through HIAS (Hebrew Immigrant Shelter and Aid Society: HIAS, organized in 1881, which has branches and agents all over the world) were letting few of the most unsightly Asiatic Jews come to America—shunting most of these to Israel. Also, they have been stirring up anti-Semitic outbreaks in various African and Middle Eastern countries so as to make Jews there migrate to Israel. Not only do they need them in Israel, to fight and to work but, if my guess is correct, they expect to get most of these low-class Jews wiped out. **[H: Indeed, you do not see Kissinger or Eagleburger, Falwell or Robertson (pledged Zionists by their own lips) going to live in a Kibbutz in the desert sands of Israel. No, the Elite or “higher class” by their own distinction, infiltrate all other nations.]**

Actually, we are not just guessing, except as to details, for Mr. Higger himself told us that the Zionists would build a race of tall, handsome men, eliminating all the Jews who were not tall and handsome, who had

physical defects and so on. And it must disturb the high-class Jew to think that eventually his line must blend with the Negroid and Mongoloid Jews—the Yemenite sheep herders (often the butt of snide jokes in the Jewish press) and the other dregs of their tribe.

In summary: there are three plausible reasons why the Zionists keep on pressuring their people to come out of iron curtain countries: (1) They must get most of them out so that few will remain to be slaughtered by bombs and the “anti-Semitic” people, when they turn loose of the beaten, abused Bear’s tail; (2) They need them for work and for cannon fodder in Israel; and (3) In Israel, the master strategists could maneuver to get them (the short and the un-handsome ones) wiped out.

How soon the Zionists will complete the operation of getting most of the Jews out of the Communist countries and thus will be ready for A-day, we can only guess. They have been getting them out ever since the end of the Second World War, and almost every issue of the many Jewish weeklies in America tells of some more Jews coming to America or going to Israel from a Communist country. Most of these reports picture the Jews as suffering under the Communist regime—but some reports (in the Jewish papers, which gentiles rarely read) flatly deny that Jews behind the Iron Curtain are discriminated against.

The *Los Angeles B’nai B’rith Messenger* of July 26, 1957, quoted Dr. Nahum Goldman, president of the World Zionist Organization, as telling the Zionist Action Committee at Jerusalem:

*“The time has come to place the question of Soviet Jewry before the bar of public opinion...”. Dr. Goldman revealed that he had met during the past year with a number of Russian representatives and believes that there are good prospects for the demand, through contacts in the Communist governments of Eastern Europe, for the right of Soviet Jews to migrate to Israel. He cautioned, however, that Jewish demands must not be transformed into a crusade against the USSR.”*

**We may be sure the Communist governments are not doing anything to hurt the Jews—for if they were, we would hear a mighty tirade against the anti-Semites.** So the time has simply not yet come.

The strange revolutions which broke out in Poland and Hungary in the summer and fall of 1956, it now appears, were at first incited by the Communists themselves (quite possibly in collusion with the Zionists) for two or more purposes: (1) The Communists all over the world were off on a new Party line designed to appear to divorce the satellite governments and the Communist Party in America and other Western countries, from Moscow domination. In a little sham battle, which actually lasted only a few hours in Poland, the virtually unarmed Polish mobs “whipped” the mighty Red army, unseating the Moscow Communist dictator and replacing him with a Polish Communist (who oddly enough had just been released from prison by the Moscow government and allowed to go to Poland in time for the uprising).

#### MORE MILESTONES TOWARD A-DAY

The whitewash Polish “revolution” worked, for the “liberal” internationalist Eisenhower-Dulles administration immediately began asking Congress for aid to the new “independent” Polish government! And

the Supreme Court has come dangerously close to saying that the Communist Party in America no longer takes orders from Moscow (and, therefore, is just another American political party.)

The Zionists wanted to get nearly all (not quite all, it seems) of the Jews out of Poland, mostly to Israel. So there appeared some anti-Semitic acts in the “revolt”.\*

\* (A dispatch from Jerusalem on page 1 of the *Los Angeles B’nai B’rith Messenger*, August 16, 1957, quoted “two American Jewish scholars... at the International Ideological Conference now taking place” as saying that “any strategy of trying to frighten American Jews into settling in Israel was futile.” They did not, however, condemn the scare technique as a failure in getting Jews to Israel from Iron Curtain and Mediterranean countries. (End footnote)

However, the Polish revolt did not quite come off, as regards scaring the Jews out of Poland. The Hungarian revolt did better because, after the first few days, genuine anti-Communist citizens rose up and were joined by a stream of deserting soldiers from the Hungarian and also the Soviet Red armies (some bringing their tanks and ammunition).

The Hungarian revolt came off at the same time as the invasion of Egypt by Israel, France and Britain, and it seems possible that the Zionists expected the invasion to ignite the world war. Or perhaps they were not ready for the world war but decided to get most of the Jews out of Hungary, in case the war unexpectedly became general.

The *Toronto Globe and Mail* of January 3, 1957, ran a long and revealing article on the evacuation of Jews from Hungary. It was written by correspondent James Senter from London—and later I phoned Mr. Senter in Canada to clarify certain details. The article reported:

*“A high-ranking Canadian official slipped across the Austro-Hungarian border recently as part of a dramatic story of complacency, fear and international intrigue.*

*“The purpose of the trip was to persuade 150,000 Jews to leave Hungary before it was too late. Sworn to secrecy, the Canadian... waited seven days before turning the details of the trip over to me...”.*

The Canadian official met secretly at:

*“... one of Vienna’s largest homes where he found 15 prominent leaders of international Jewry assembled. They were an alarmed group from Israel, Switzerland and elsewhere. For several weeks they had been sitting on the border with unlimited funds at their disposal in Vienna and Zurich. Yet, despite all their efforts, they had been unable to persuade more than 3,000 Jews to leave Hungary. In the same period, however, 2,000 Jews had disappeared in Budapest alone. It was feared they had been deported by the Russians.*

*“Hungarian Jews were complacent, the group explained. They had little contact with the outside world and were subject only to Communist propaganda. Since the end of the Second World War they had done well in business, in the civil service, and in government. Some had become well-to-do landowners. They felt they were secure.”*

When it became apparent that the Jewish leaders of Hungary who met with the delegation at night, inside Hungary, could not be induced to

get their people out of the country, the head of the delegation ordered them to do so:

“*‘It has been decided’, the Canadian quoted him as saying. ‘These are orders from the top.\* You must come out.’*”

\* “Orders from the top” confirms charges made by patriotic citizens, generation after generation, that the Jews still maintain a secret tribal government, with power over Jewish citizens of gentile nations. (End footnote)

A quick recapitulation of the above report reveals much: The Hungarian Jews had found a Promised Land; they were doing well under Communism; they felt so secure that they would pay no attention to the pleas of their brethren, till they were finally given outright orders “from the top”.

**[H: You are in grave error if you fail to understand that these Zionists have “found their Promised Land” in the United States for “the chosen people”. The seat of the “temple” activities is intended for Jerusalem but the Promised Land is any and all places of great wealth and natural resources. At this time in involvement of the PLAN—it now represents “THE GLOBE”.]**

In view of their favorable situation and their sense of protection by the Communist apparatus—and in view of later reports from numerous sources—we know that it was not the Communists that they were supposed to escape from. It was the revolting Hungarian and Russian soldiers and Hungarian citizens, who had risen above the original whitewash revolution of October, quickly converting it into a genuine anti-Communist revolution—and all anti-Communist revolutions behind the Iron Curtain are in some measure anti-Semitic because the enslaved people have to overthrow a secret-police rule which still is highly Jewish in complexion. Hungary had been under the Jewish Communist regime of Bela Kun (or Cohen) during the short-lived Red dictatorship right after the First World War; and Rakosi, the strong man of Hungarian Communism after the Second World War was a Jewish monster of the crudest character.\*

\* According to the “liberal” writer, John Gunther, who knew him and interviewed him, Rakosi “is of Jewish origin and the family name was Rosencranz”. Gunther said Rakosi was “one of the half dozen most important international Communists in the world today”. See Gunther’s *BEHIND THE IRON CURTAIN*, 1949. (End footnote)

If the Zionists expected to launch Armageddon by their 1956 invasion of Egypt, with France and Britain, they miscalculated. Eisenhower (who was also Jewish in origin)—who had positively crawled before the Jewish bankers and political and organizational leaders since he was a lieutenant colonel under MacArthur in the Philippines (where he began courting the Jewish political machine by going to the B’nai B’rith club in Manila and playing bridge with its members)—now suddenly stood still. He was supposed to back Israel, of course. Some unseen force held him back. The only sizeable force other than Zionists (since the death of Robert Taft) known to influence his policies is the Standard Oil-Chase National Bank crowd. Dulles is a relative of the Rockefellers and a member of this crowd, and Eisenhower made Nelson Rockefeller one of his aides and advisers.

The Rockefellers are in many Communist fronts and

work with the Jewish bankers in almost all international financial and political exploits and plots; but they apparently do not want to give up the fabulous oil fields of the Middle East to the Jewish expansionists.

When the President would not be drawn in against Egypt, the Soviet Union did not come in. Israel, France and Britain were left out on a limb (one which promised no foreign-aid billions)—and the invasion was called off.

In scrutinizing the Zionists’ timetable it would be interesting to know whether or not they intended the Egyptian invasion to start the final war.

In any case, they kept their agents on the Austrian border of Hungary (which border, by the way, the Communists left practically unguarded for weeks) herding the Jews across and resettling them. Many they flew to America in U.S. Air Force planes rushed to them by President Eisenhower (though by no legal authority). Others they shipped to Israel. Estimates of the number of Jews who have come out of Hungary since October vary from 17,000 to as high as 100,000. They kept coming out all winter and the Jewish papers and some correspondents kept saying there was to be another revolt in Hungary in the spring, followed by another one in Poland, and certain incidents hinted that a third would follow in Romania (where there were, by Jewish newspaper estimates a few years ago, as many as 400,000 Jews).

[END OF QUOTING FOR THIS SEGMENT.]

Let us leave this now so that we might attend other duties. I would hope to finish this volume within the next couple of days, please. You readers are running out of time to have the facts available to you. This Communist segment is already infiltrated into your lands and preparations for the war which will undoubtedly end as Armageddon is setting-up positions (on American soil this time—among every other “free” nation on the globe). ### WATER SUPPLY

You who are told your water supply is NOW SAFE had better watchit! Nothing has changed except perhaps the turbidity and E-coli count. Yes, indeed, we shall never be able to pay back the debts owed to each and every one of YOU. Money has little to do with it—for any responsibility of that type is personal commitment. The loyalty and loving support is THE debt of which I speak. But to you who have kept the paper, etc., going in the face of the assaults over these past two years, there are no words—but there is commitment to finish this job—SUCCESSFULLY.

## “HARD LANDING” IS FEARED AS ECONOMIC BOOM FADES

Washington—President Clinton may be taking more with him than his suitcase when he leaves the White House on Jan. 20. His amazing run of luck with the economy seems to be disappearing as well, right on cue with the end of his second term.

That means that his successor, either George W. Bush or Al Gore will have to navigate stormier seas. Some forecasters are even worried about a recession next year—a problem Clinton never had to confront as he presided over a record stretch, now in its 10<sup>th</sup> year, of uninterrupted economic growth.

“However one looks at it, the economic data recently have been quite negative and the possibility of a serious hard landing is rising,” says Allen Sinai, chief economist at Decision Economics in New York.

While Sinai said he believed the chances of an outright recession—where economic growth actually contracts—are still small, he was concerned about a prolonged period of weak growth that would translate into a rising unemployment rate.

David Levy, an economist at Bard College in Annandale-on-Hudson, N.Y., was even more pessimistic, putting the odds of a full-fledged recession next year at 70 percent.

“When you put all the problems facing the economy together, it is not a pretty picture,” Levy said.

Things were not supposed to turn out this way. The overwhelming view among economists had been that the United States was headed for a soft landing in which a series of interest rate increases by the Federal Reserve Board would slow economic growth enough to keep inflation in check without tipping the country into a recession.

But since the Nov. 7 election, while the country has been transfixed by the ballot battle in Florida, the economic ship of state has been springing leaks.

A series of government reports has shown unexpected weakness in areas ranging from consumer spending to U.S. factory orders.

The weaker economic data has added to pessimism on Wall Street. The technology-heavy NASDAQ index has lost almost half its value since it reached record highs in March.

The concern is that the sharp fall in stock values will trigger a cutback in business investment and consumer spending, two of the major driving forces behind the current expansion.

Clinton had the good fortune of taking office as the country was pulling out of the 1990-91 recession. That period was called the jobless recovery, because even though the economy was growing again, the unemployment rate was stuck at high levels—7.5 percent in 1992, which Clinton used with success against then-President George Bush.

Many economists still believe the most likely outcome for 2001 will be growth of around 3 percent. Even that rate will seem lackluster compared with the 4 percent

rates turned in for the past four years, the best performance since the mid-1960s.

“The economy was a good friend to the Clinton administration, and it is just not going to be as friendly to the next administration,” said Mark Zandi, chief economist at *Economy.com*, a West Chester, Pa., forecasting firm.

Bruce Steinberg, chief economist at Merrill Lynch in New York, said if the economy threatens to weaken more than the 3 percent range, the Fed can step in with rate cuts to recharge consumer spending and bolster the stock market.

Other analysts worry that a variety of factors could derail the Fed’s efforts to achieve its soft landing, for example, rising corporate and personal debt levels that could threaten the nation’s banking system, or a sudden flare-up in the Middle East.

Jerry Jasinowski, the head of the National Association of Manufacturers, said business executives are also concerned that the rising level of bitterness over the undecided presidential election will stalemate Republicans and Democrats, preventing action to bolster a faltering economy.

“It’s still ‘the economy, stupid’ and politicians seem to be forgetting that just when the economy is headed south,” Jasinowski said.

**[JR: Clinton benefited from the last 8 years of these 10 years of uninterrupted economic growth. ## ASIA DREADS A “HARD LANDING” FOR U.S.

TAIPEI (WPS)—The slowdown in U.S. economic growth has cast a pall over hopes for continued recovery in Asia, just as the region was beginning to shake off the effects of the 1997 financial crisis.

No one is predicting a replay of the dramatic stock market plunges, currency devaluations and bank failures that ravaged economies here three years ago. But there is broad agreement among analysts and investors on both sides of the Pacific that a sharp downturn in the largest

market for Asia's exports would deal a grave blow to the region's already battered economies.

Talk of such a "hard landing" for the U.S. economy has shaken business and government leaders in a region where exports have leaped 20 percent this year. The surge in overseas sales has enabled many Asian economies to post impressive growth rates this year—upward of 8 percent in Hong Kong, Singapore, South Korea and China and above 6 percent in Taiwan and Malaysia—despite higher oil prices, dysfunctional political systems and in many cases weak business and financial institutions.

Even quiet contemplation of a soft landing—a more gentle glide down to a lower but more sustainable growth rate—is enough to rattle Asian nerves.

Exporters in Hong Kong are keenly aware that a healthy U.S. economy "is the main reason we're approaching 10 percent growth this year," said Eden Woon, director of the Hong Kong General Chamber of Commerce. "Europe is doing OK, but not great. We can't look to Japan. The place that's scooping up all these exports," he said "is the good old U.S.A."

And as the Federal Reserve Board chairman, Alan Greenspan, said Tuesday, the U.S. economy has cooled "appreciably" this year. It appears U.S. growth has dropped to an annual rate of slightly less than 3 percent in the past six months of this year, less than half the 7 percent rate recorded in the year-ago period.

Asia's exporters cashed in during the headier days of a U.S. economic expansion that was unprecedented in both strength and length. The spectacular boom in America's information-technology sector generated a particularly large windfall for economies such as Taiwan, South Korea, Singapore and Malaysia, all big producers of electronics products and components.

Now manufacturers in those countries fear that a decline in U.S. demand, however gradual, will aggravate unresolved domestic problems. Analysts warn that in some Asian economies, even a feather-light touchdown for the U.S. economy could tip entire sectors into recession.

In Taiwan, businesses are already feeling the pain. As neighbors floundered over the past three years, Taiwan's economy sailed ahead at an average growth rate approaching 6 percent as world-class plants churned out computers and microchips for large U.S. companies.

But recently, the U.S. computer and chip giants have reported that their sales this year are trailing far below projections. They also are slashing profit forecasts for 2001. The wave of downward revisions has pummeled the stock prices of Taiwanese chip and computer component manufacturers and helped to drive the nation's stock exchange down more than 50 percent below its high for the year.

"If Compaq makes less money," said Chen Po-chih, chairman of Taiwan's Council for Economic Planning and Development, "there will be a lot of Taiwan companies who suffer much, much more."

The same could be said of companies throughout Asia. "The electronics industry has single-handedly pulled Asia out of the financial crisis," said Dong Tao, senior economist at Credit Suisse First Boston in Hong Kong. The prospect of a temporary slump in demand for electronics products recently prompted Mr. Dong to lop a full percentage point off his 2001 growth forecast for Asia.

In many ways, Asia's vulnerability to the U.S. slowdown reflects the failure of Japan—whose economy is as large as the rest of the region's economies

combined—to live up to its promise to absorb more Asian exports. U.S. and Asian officials have pleaded with Japan for more than two decades to liberalize its markets and thus become a locomotive for growth in Asia. So far, Japan remains a caboose, emulating the rest of the region in hitching its fortunes to U.S. consumers.

The Japanese government is winding down a massive public-spending program aimed at jump-starting the economy, but private consumption remains sluggish.

While Japan stagnates, China has taken bold, if sometimes erratic steps to liberalize its markets. Many experts believe it to be the Asian economy most likely to keep growing next year, regardless of what happens in the United States.

Most economists expect domestic demand to continue expanding in China, despite continued economic restructuring as mammoth state-owned enterprises struggle to fend off foreign competitors granted easier market access as a condition of China's admission to the World Trade Organization.

For all those changes, though, China's economy remains too small and its consumers too poor to bolster growth elsewhere in Asia. China's economy, at just over \$1 trillion, is about a tenth the size of the U.S. economy, and Chinese per capita income remains less than \$1,000 a year, compared with \$36,456 in the United States.

#### A NATION POLARIZED

We've had close presidential elections before, but this one is emblematic of dangerous, unbridgeable and growing gaps among the American people. Some of this can be seen by examining a map showing U.S. counties won by George Bush and those won by Al Gore.

In general, the densely populated counties along the East and West coasts, Midwestern counties mostly along the Mississippi River and a smattering of counties in the southwest were won by Gore. **But if the election were to be decided by who won the greatest number of the nation's 3,142 counties, Bush would have bested Gore by at least 2,500 counties.**

While who won how many counties is irrelevant to the presidential selection process, it says something about the degree of national polarization. What are the characteristics of counties won by Bush versus those won by Gore? The values, politics and religion of the counties in the southern, western and rural sections of the country, won by Bush are not like those in the mostly coastal, highly populated counties won by Gore. The Bush counties are: more conservative and respectful of traditional values, pro-life and more religious, and they have less social pathology such as high crime, illegitimacy and deviancy. Counties won by Gore tend to be just the opposite.

By no means do Americans who voted for Bush enthusiastically and unequivocally support the values expressed in our *Declaration of Independence* and *Constitution*, but they are not nearly as parasitic,

interventionist and contemptuous of the principles of liberty as Gore supporters.

The constitutional provisions created by the framers to protect us against the interventionist and parasitic classes have long been under siege and are severely weakened. The *Bill of Rights*, election of senators by state legislators and other protections against mob rule have been weakened or eliminated. Limitations on the power of the central government, through the enumerated powers and separation of power doctrines, have also been severely compromised. Constitutional protections against parasitic plunder, through its prohibition against direct taxation (no income tax), have been abolished.

Thomas Jefferson gave voice to our most important protection in his First Inaugural Address in 1801, saying, "If there be any among us who wish to dissolve the Union or to change its republican form, let them stand undisturbed, as monuments of the safety with which error of opinion may be tolerated where reason is left free to combat it."

The right of secession was taken for granted in the founding of our country, and it wasn't only a Southern idea. Timothy Pickering of Massachusetts was George Washington's chief of staff, his secretary of war and secretary of state, and later a Massachusetts congressman and senator. In 1803, Pickering wrote, "The principles of our Revolution (of 1776) point to the remedy—a separation—for the people of the East cannot reconcile their habits, views and interests with those of the South and West."

Irreconcilability faces us today. There's one group of Americans who does not wish to bother anyone but wishes to be left alone. Another group of Americans wants to plunder and control the lives of others. This latter group of Americans shows no sign of letting up, much less retreating. A return to rule of law and constitutional government or separation are the only peaceful solutions. Separation and independence don't require that liberty-loving Americans overthrow the federal government any more than it required George Washington to overthrow England or his successor secessionist, Jefferson Davis, to overthrow Washington, D.C.

So here's my question: Should we Americans continue to forcibly impose our wills and values on one another, or should we part company and be friends? **[JR: The American Revolution didn't "reconcile the habits and views of the Eastern states" on the rest of us. Well now we have both the East Coast and West Coast influences overriding the middle states, leaving them disfranchised. Our votes don't count, our opinions don't count and our values don't count. The only things these parasites count is our money.]**

#### MACHINE-FREE, CANADIANS SWIFTLY HAND-COUNT THEIR 13 MILLION BALLOTS

OTTAWA (AP)—Florida vote canvassers, take note. Within four hours after the last polls closed in Canada's parliamentary election, officials at 50,000 polling stations had hand-counted virtually every one of nearly 13 million paper ballots.

There were glitches, to be sure—an angry voter seized a ballot box in Nova Scotia and threw it into a polluted lagoon. But overall, Canada's federal elections system, which uses no counting

machines, had a smooth Election Night.

From Newfoundland to Yukon, across the world's second-largest country, roughly 150,000 election workers fanned out Monday to a far-flung network of polling stations. Even in the biggest cities, no one station serves more than 500 registered voters—most of the officers entrusted with the hand-counting had to handle no more than 300 or 400 ballots.

Pierre Blain, a spokesman for Elections Canada, said the system stresses transparency, with each party entitled to deploy a representative to watch the polling station chief count the ballots.

Any complaints can be registered with national elections officials; recounts are conducted automatically in cases of extremely narrow victory margins.

Though some of Monday's 301 parliamentary races were close, the overall result was clear-cut: Prime Minister Jean Chretien's Liberal Party won its third-straight majority government while increasing its seats in the House of Commons from 161 to 173.

Blain, in a telephone interview Tuesday, politely declined to pass judgment on the electoral chaos in Florida, which was compounded by the use of different voting systems in various counties.

"All the democracies must look at their systems themselves," Blain said. "It's not for somebody from another country to look at them."

"The most important thing is that people must vote," he said. "I'm sure the workers in Florida did their best."

The Canadian system, in place for a century, uses traditional paper ballots, to be marked with an "X" beside the name of the preferred parliamentary candidate. There are no hanging chads, no questions about mechanical snafus.

In Nova Scotia, though, there was little that election officials could do when a man ran off with a ballot box and threw it into a waste-treatment lagoon.

Alexander MacKenzie, who had sought compensation for living near the polluted water, was arrested for the theft, spent Monday night in jail, then was released pending a Dec. 18 court appearance.

The box was recovered with the ballots still legible, but under Canadian law they were discarded because they had been removed from official supervision. The polling station contacted the 125 people who had cast ballots; about 70 returned to vote again.

There were some systematic glitches, as well. At some polling stations, people arrived to find they were not on the list of eligible voters; many were confused even though most were permitted to vote if they had valid identification and spare time to register on the spot.

Perhaps the biggest disappointment for Elections Canada was the meager voter turnout of 63 percent—the lowest in more than 75 years.

"Everywhere in the world, there seems to be a trend of turnout going down," Blain said. "Our task is simply to make sure there are no impediments for those who want to vote."

#### TERRORIST ATTACK COULD SPARK REGIONAL WAR

WASHINGTON (UPI)—A regional war in the Middle East involving Israel, the Palestinians and Syria is more likely now than at any time since 1973, according to U.S. officials who spoke on condition of anonymity.

On Friday, Israel made veiled threats against Syria and Lebanon—and even Iraq—that any attack coming from Hezbollah forces in Syrian-occupied Lebanon would lead to immediate Israeli retaliation against Syrian military targets in Lebanon. Syria currently maintains 30,000 troops in that country, these sources said.

Targets would include anti-aircraft missile batteries, radar-targeting sites, tank units and ground forces, these sources said.

"If the U.S. election weren't taking up so much space, this is such a serious crisis it would be on the front page of every newspaper in the country," said another administration official with close knowledge of the situation.

Another U.S. government analyst, who also asked not to be named, said that if an Israeli-Syrian clash occurred, Iraq might join Syria, launching Scud missile strikes against Israel in support, mainly because of stepped-up Iraqi-Syrian military cooperation initiated by Syrian President Bashar Assad.

Iraq already has moved forces closer to its border, an administration official said.

According to one U.S. government analyst, the most likely flash point for a regional war centers on the Shabaa Farms area, the plateau where the frontiers of Israel, Lebanon and Syria intersect.

One congressional source said there is clear evidence that Syria has been encouraging Lebanese Shiite militia to commit terror attacks against Israel in this area, stated by UN Resolution 425 to be part of the Golan Heights.

Patrick Clawson of the Washington-based Institute for Near East Policy said that to have Syrian or Hezbollah forces in Shabaa Farms is a violation of 425 since the Lebanon-Israeli boundary was personally certified by UN Secretary-General Kofi Annan following Israel's unilateral withdrawal.

"What bothers me is the overconfidence, the unrealism of Arab policy," said Peter Rodman, Middle East expert at the Nixon Center. "It reminds me of the days before the 1967 War."

Although veteran Center for Strategic and International Studies Middle East analyst Tony Cordesman said he believed Syria and Lebanon were "taking the U.S. warnings against further attacks, very seriously," Clawson disagreed.

"Assad is behaving like an elephant" at a time when tiptoeing and caution are required, Clawson said.

While some Israeli press reports say that Egypt would intervene militarily if Israel launched an all-out attack on Palestinian leader Yasser Arafat, a congressional source said there would be "no movements of Egyptian forces on Israel in the Sinai or anywhere else."

According to Cordesman, all Egypt wants is to deter "further attacks on Arafat and the senior Palestinian

leadership" by Israel, not involve any Egyptian military forces.

But, according to Clawson, Egyptian intervention would probably take the form of providing "additional intelligence support" for Arafat which would include "helping him to hide better, helping him to encrypt and scramble his communications more effectively," said Clawson.

Last week leading Arab strategists met at the Arab League headquarters in Cairo to discuss war scenarios for the region, but this meeting had been "in the works for some time," and was seen as routine, an administration official said.

An administration official praised the conciliatory policies of Israeli Prime Minister Ehud Barak, saying, "Israel has taken good steps to avoid war." But he cautioned, "It would not take much violent military action against Arafat to bring in Arab involvement."

Clawson condemned a recent meeting where a handful of Israeli generals urged the "elimination" of Arafat.

"It was really dumb," Clawson said, and Barak treated it with the "contempt that it deserved." But he added that Barak faces tremendous pressure from his generals to "respond militarily" in the event of a Hizbollah attack.

A congressional source said: "The situation now is really untenable. It's really dangerous. There is nobody to talk to and nothing to talk about."

#### BRITAIN AND FRANCE FLOAT OPTIONS FOR MIDDLE EAST FORCE

UNITED NATIONS—British and French envoys floated watered-down alternatives to a Palestinian-initiated resolution calling for a 2,000-strong unarmed UN protection force that Israel rejects.

British UN ambassador Sir Jeremy Greenstock and French envoy Pascal Teixeira da Silva suggested the 15-member Security Council agree in principle to an international presence and then ask Secretary-General Kofi Annan to work out terms agreed to by both Israel and the Palestinians.

Greenstock told reporters after closed council consultations that most members viewed the Palestinian proposal as an "option that leads nowhere" and an attempt to make a political point because no force can be deployed without Israel's consent.

"But we're worried about the violence on the ground and using the council's influence to do something about it," he said. "That is what we are going to explore."

France spoke of a UN military observer force, as the Palestinians want, to protect residents of the West Bank and Gaza Strip from the violence that has cost some 300 lives in the past two months, most of them Palestinians.

Greenstock, however, mentioned a neutral international force. The two delegations intend to

produce a joint text on Thursday, which will not include specific numbers for the unarmed military observers.

The United States and a number of other council members opposed a force that Israel rejected. Israel has said it might be open to third-party observers, but only if the Palestinians negotiated the terms directly with them.

Before the latest outbreak of violence, Israelis and Palestinians had been engaged in years of difficult peace negotiations.

"It is the strong feeling of a lot of members of the council that it's got to be done with the agreement of both sides and it's the feeling of the United Kingdom that we haven't exhausted the possibilities of getting both sides to agree to that," Greenstock said.

U.S. envoy Nancy Soderberg said the British and French approach seemed to be more constructive. "If there is going to be a proposal to do something in this area, it needs the consent of both parties and that is the key," she said.

Greenstock said the majority of council members are interested in seeing alternatives to the draft resolution put forward on behalf of the Palestinians by the six developing nations of the Non-Aligned Movement with seats on the council.

"They know that the current draft is a non-practical suggestion, that it will never happen, that it's being made to make a point," Greenstock said.

Palestinian UN Representative Nasser al-Kidwa did not dismiss the proposals outright. "We will look into [them] with the aim of having as broad support as possible in the council," he said, adding that the force must be under UN auspices.

Greenstock said he suspected the Palestinians were trying to force a veto in a Security Council vote so they could take their resolution to the General Assembly where it is more likely to win approval but would go no further.

The Palestinians said they were still hoping to get a Security Council resolution put to a vote by Friday, although envoys said that appeared unlikely.

Al-Kidwa said he wanted to ensure "that the essential things are achieved and it is not just a whole dilution of our attempt to see the UN observers on the ground."

**U.S. TO DEPLOY 690,000 TROOPS  
IN ANY NEW KOREAN CONFLICT**

SEOUL (AFP)—The United States would deploy up to 690,000 troops on the Korean Peninsula if a new war breaks, according to a South Korean defense ministry White Paper published Monday.

The United States, which has 37,000 troops permanently in the South, remains concerned about North Korea's military strength despite the North-South reconciliation process launched this year.

U.S. defense chiefs have considerably increased the number of troops that would be deployed in any new

Korean conflict. The figure has risen from 480,000 in plans made in the early 1990s and 630,000 in the mid-1990s, the policy document said.

"The latest Time Phased Forces Deployment Data for any contingency on the Korean Peninsula is comprised of 690,000 soldiers, 160 navy ships and 1,600 planes," it said.

The United States fought with the South against the communist North in the 1950-53 Korean War and has kept troops in South Korea under a mutual defense pact to deter any new invasion attempt.

The war only ended in a truce and the de-militarized zone remains one of the world's most volatile conflict flashpoints.

A summit in June between the South's President Kim Dae-Jung and the North's supreme leader Kim Jong-Il produced an accord to move toward reconciliation. But it has done little to reduce military tensions, according to U.S. and South Korean military chiefs.

"We always have various options," a U.S. military official told *AFP*, refusing to give details on the deployment of extra troops and equipment planned by the Pentagon.

The South Korean defense ministry, however, described the increase as the result of a new U.S. "win-win strategy", which would require the United States to have the capability to fight two wars simultaneously, such as in the Middle East and East Asia. The U.S. military numbers a total of 1.37 million service men and women.

"This shows a strong U.S. determination to guard the Korean Peninsula despite its plan to reduce the entire number of troops," said the White Paper.

Along with equipment to counter weapons of mass destruction, the U.S. plan focused on the deployment of aircraft carriers and advanced aircraft to attack enemy artillery units in the early stages of any war, it said.

The White Paper also called for a strong military partnership between the allies to deter war on the Korean Peninsula.

"South Korea's partnership with the United States will ensure peace and deterrence of war on the peninsula and create an atmosphere for peaceful unification," it said.

"And with sights beyond unification, this partnership will contribute to the stability of Northeast Asia.

"Based upon a robust combined defense posture, (South Korea) and the United States continue close consultation in implementing a policy of reconciliation and cooperation toward the North."

Until the June summit, North Korea had insisted on the withdrawal of U.S. forces from South Korea.

President Kim has said he wants U.S. troops to remain and said his North Korean counterpart agreed on the need for a U.S. military presence on the peninsula.

This has led to speculation that U.S. troops in South Korea could, after any eventual reunification, become a regional peacekeeping force.

**LAWSUIT FILED AGAINST CLOTHING SUPPLIER  
FOR U.S. MILITARY**

WASHINGTON (AP)—A Nicaraguan garment factory that supplies discounted clothing to American soldiers imposes sweatshop conditions and starvation wages on its workers, a lawsuit filed Tuesday contends.

The lawsuit, filed by labor-rights attorneys in U.S. District Court in Los Angeles, seeks punitive damages against the Chentex factory and its Taiwan-based parent, Nien Hsing.

It contends Nien Hsing pays workers at the plant less than 20 cents for each pair of blue jeans sewn. The jeans retail for between \$25 and \$30, but workers receive what amounts to less than 30 cents an hour.

At a Tuesday news conference, a sweatshop watchdog group said the jeans are sold to American military personnel through the Army and Air Force Exchange Service, which supplies servicemen and women.

According to the National Labor Committee for Human Rights, the service imported 64 tons of blue jeans made at the Nicaraguan plant last July, August and September alone.

"This factory in Nicaragua actually presents the true face of the global economy," said Charles Kernaghan, executive director of the watchdog. It's one of oppression, starvation wages, mass firings, blacklisting, union busting and enormous corporate greed."

Pentagon officials admit to doing business with the company, but they say they found no evidence of poor working conditions when a delegation visited the Chentex plant several weeks ago.

"We do business with them," said Capt. Eric Hilliard, public affairs officer for the Army and Air Force Exchange Service. "We went down there, checked it out, and we saw that things were up to par."

The Army and Air Force Exchange Service is one of the world's largest retailers, operating 1,423 stores on U.S. military bases nationwide. It had \$7.3 billion in sales last year.

Kernaghan said he uncovered the link to the Pentagon while reviewing the company's sales documents. Several American department stores—including Kohl's, Kmart, Wal-Mart, Target and J.C. Penney—also had garment contracts with the company.

Since last spring, the National Labor Committee has staged numerous demonstrations outside various Kohl's stores, demanding that the company cut its ties with the Nicaraguan plant. More protests are planned elsewhere, Kernaghan said.

Two congressional Democrats, Georgia Rep. Cynthia McKinney and Ohio Rep. Sherrod Brown, also attended the news conference. Brown traveled to Nicaragua in July and vouched for the deplorable treatment of the garment workers.

McKinney, who in October introduced legislation that would require U.S. corporations to disclose information about their overseas operations, asked the General Accounting Office to conduct a study.

"We have to understand these goods come to us at a tremendous human cost, and it's not necessary," said McKinney, who sits on the Armed Services and International Relations committees.

Kernaghan said the Nicaraguan workers are asking for just eight cents more per garment—a raise he says would raise them from "misery to poverty".

“How in the world can we spent \$60 billion on Star Wars and not be able to pay eight cents more for a pair of jeans?” McKinney said.

**[JR: Government-owned Chinese companies and other multi-national corporations are opening subsidiary factories in Central and South America to qualify for special trade benefits from the U.S. under our NAFTA treaties. #### HOW THE BOLSHEVIKS SOLD RUSSIA'S TREASURES

The sorry story of Lenin, Trotsky and Stalin's efforts to fill the coffers of the first communist state by selling off Russia's art treasures is told in shocking detail by a book released last week in Moscow.

The Bolsheviks first looted the churches. Then they sold the imperial family's crowns, tiaras, necklaces and Faberge eggs. Finally they helped themselves to Old Masters hanging in the Hermitage Museum.

The world's oldest edition of the *New Testament*, the contents of whole palaces, icons and Impressionist masterpieces were also part of the booty the Bolsheviks put on the international art market in the 1920s and 1930s. However, a slump in demand for antiques and art ensured that, despite the rarity of the items on offer, the Soviet Union received a derisory sum from the sales.

Nicolas Iljine, one of the editors of the book, *Selling Russia's Treasures*, said: “It was ludicrous. They sold all these treasures to buy tractors but it made almost no difference to the state's budget.” Among the curios snapped up by Western collectors were the Russian Empress's wedding crown, paintings by Rembrandt, Botticelli, Cranach the Elder, Cezanne, Van Gogh, Poussin and Degas and icons from the 15<sup>th</sup> and 16<sup>th</sup> Centuries.

The British Museum gained the *Codex Sinaiticus*, a 4<sup>th</sup>-Century parchment manuscript of the Gospels discovered on Mount Sinai, and Faberge eggs bought from the Soviet Union found their way into the Royal Family's collections. One, a mosaic Easter egg made of platinum, gold, diamonds, rubies and emeralds, contains an enamel medallion with the profiles of the last Tsar's wife and children, executed in 1918.

Russia's culture minister, Mikhail Shvydkoi, used the book's launch last week to attack today's generation of communists, still a major force in national politics, accusing them of hypocrisy. He said: “Those politicians who see themselves as descendants of the party which sold these treasures abroad are especially jealous of the title of defenders of the national inheritance. This book destroys that myth.”

The sales have been documented in academic

monographs but the book is the first to attempt an overview of the subject. Many of the paintings removed from the Hermitage and sold in the 1930s were originally bought for Catherine the Great, Tsar Alexander I and other Russian collectors. Some spent only decades in Russia before returning to the West.

Mr. Shvydkoi said: “Sometimes I think that the Bolsheviks were consciously taking revenge on the imperial family. These sales in the 1930s were economically senseless.” At first, communist leaders justified their looting of churches by arguing that priests should help to pay for relieving the famine that hit Russia after the revolution.

In private, however, Lenin demanded that the famine be exploited “to smash the enemy's head in”, weakening the power of religion over the masses for decades to come. Trotsky was impatient for the sale of art treasures abroad to begin, concerned that the imminent outbreak of revolution in Western Europe would depress the antiques market.

In their haste for profit from the Church property, officials had gold-icon cases melted down and picked clean of their jewels when the items would have fetched much more money had they been sold undamaged. *Codex Sinaiticus* ended up in Britain only thanks to the quick thinking of a visiting bookbuyer who spotted it in a Moscow library. He told his Soviet minder: “If you don't need it here, I can get a good price for it in London.”

The most spectacular episode in the sell-off was the rape of the Hermitage Museum in Leningrad. Some of its most valuable canvasses were sold in secret to Western art collectors. The oil tycoon, Calouste Gulbenkian, a naturalised British citizen, thought he could negotiate a monopoly on the purchase of Old Masters from the Soviet Union.

However, he was soon sidelined by Andrew Mellon, the United States Secretary of the Treasury, who saw no inconsistency in publicly opposing trade with the Soviet Union but privately buying up 25 masterpieces from the Hermitage. His buying spree only came to light when he was accused of tax evasion in 1934. Most of the paintings sold to him by the Soviets were eventually left to the National Gallery of Art in Washington, D.C.

Armand Hammer, the Soviet Union's favourite capitalist, was also used as a middleman, selling antiques on behalf of Moscow in American department stores. He remained popular with the Soviet regime, and was given a Malevich painting in the 1970s. He sold it for one million German marks soon afterwards.

#### U.S.-RUSSIAN CRUSADE AGAINST OSAMA BIN LADEN

NEW YORK—The United States and Russia may soon launch a joint military assault against Islamic militant, Osama Bin Laden, and against the leadership of

Taliban, Afghanistan's de facto ruling movement.

Such an attack would probably include U.S. Delta Force and Navy Seals, who would join up with Russia's elite Spetsnaz and Alpha commandos in Tajikistan, the Central Asian state where Russia has military bases and 25,000 troops. The combined forces would be lifted by helicopters, and backed by air support, deep into neighboring Afghanistan to attack Bin Laden's fortified base in the Hindu Kush mountains.

How well such a raid would succeed remains in question: U.S. special forces have had a dismal record of fiascos over the past quarter century. Russia's special forces, though more capable than similar American units, experienced some success but also many failures in the Afghan War. Assassinating irksome Third Worlders is the specialty of Britain's very able and very deadly SAS (Special Air Service) commandos.

In such an attack, the U.S. would also launch cruise missile attacks, and Russian air strikes would pound Afghan government installations and communications to punish Taliban.

The United States blames Bin Laden for the 1998 bombing of U.S. embassies in East Africa, and the October bombing of destroyer *USS Cole* in Yemen. Washington accuses the shadowy Saudi, who fought the Soviets in Afghanistan, of masterminding world anti-American terrorism. Bin Laden tops the FBI's “Ten Most Wanted” list with a U.S. \$5 million price on his head.

Russia accuses Bin Laden and Taliban of aiding resistance forces in Chechnya, whose forgotten people continue to battle Russian colonial rule. Moscow also fears Taliban threatens the Russian-backed communist dictators—or “Red Sultans”—of Central Asia. Russia is determined to avenge its defeat in Afghanistan, and regain control of this vast, resource-rich region.

Washington recently joined the “Shanghai Five,” an unofficial pact between Russia, China, and three Central Asian states to combat “Islamic terrorism”—meaning the region's anti-communist Islamic independence movements. The U.S. agreed to share intelligence with them and provide some funding for the crusade against Islamic insurgents.

The Clinton Administration's anti-Muslim alliance with Russia is strategically wrong and morally disgraceful. Leading human-rights groups are condemning Russia for war crimes and mass murder in Chechnya, widespread torture, rape, looting, collective punishment, and operating concentration camps. Russia has killed some 140,000 Chechen civilians to date and covered that nations with millions of anti-personnel mines.

America has no business colluding with the perpetrator of these crimes, nor with China's brutal repression of Sinkiang Muslims, nor aiding pro-Moscow police states in Central Asia. All of Washington's new “friends” in the anti-Islamic crusade are major violators of human rights.

America has a better case against Bin Laden, who proclaimed jihad, or holy struggle, to “liberate Arabia and Palestine from American rule.” He may have been behind the terrorist bombings in East Africa; perhaps, too, of the *USS Cole*. But Washington has to date shown no real proof, only leaks and claims by dubious “anti-terrorism experts”.

Old comrades from the war against the Soviets in Afghanistan who know Bin Laden, tell me the U.S. has blown him out of all proportion into a mythical caricature, the latest of long list of Muslim bogeymen beginning with the 19<sup>th</sup>-Century “Mad Mullah”. Bin

Laden's alleged attacks may have actually been done by other Saudi extremists of the Wahabi sect.

Afghanistan's Taliban refuses Washington's demands to hand [over] Bin Laden, a hero to many Muslims, until the U.S. shows proof of his crimes, which it has not. When Bin Laden and other mujahidin battled heroically against the Russians in Afghanistan, the U.S. hailed them as "freedom fighters". But when these "jihadis" called for liberation of Saudi Arabia and the Gulf from U.S. domination, they were branded "Islamic terrorists". In 1998, the Clinton Administration showered cruise missiles on guerilla camps in Afghanistan and an innocuous drug plant in Sudan, killing over 100 civilians and fighters.

The U.S. engineered a punishing Iraq-style embargo of war-ravaged Afghanistan at a time when many of its 18 million people are starving and homeless. Though Taliban controls 95% of the country, the U.S. refuses to recognize or aid the Islamic regime.

Washington and the U.S. media have launched a fierce propaganda campaign against Taliban, accusing it of encouraging the opium trade, harboring "terrorists" and abusing women. The woman's issue has resonated loudly in the West, particularly on college campuses.

All the women's groups now shrilly lamenting that Afghan women must go veiled were silent when the Soviets slaughtered close to 2 million Afghans—half women—from 1979-1989; silent about 500,000 Afghans maimed by Soviet mines since then; silent about thousands of women raped during the post-war anarchy before Taliban restored internal order.

Taliban is battling the opposition Northern Alliance in the northeast corner of Afghanistan bordering Tajikistan. The Alliance commander, Ahmad Massoud, is a long-time collaborator with the Russians. His cornered forces are being increasingly aided by Russian arms, pilots, artillery, air support, as well as covert help from Iran, India and, likely, the U.S.—all of them fueling the decade-old Afghan civil war.

The Clinton Administration, which shamefully financed Russia's massacre of the Muslim Chechen, is now actually helping Russia re-enter Afghanistan, an act of dazzling geopolitical folly that will endanger Pakistan and further convince the Muslim world that the United States is its sworn enemy. American money now pays for the killing of Palestinians in the Mideast, the slaughter of the Chechen, the death of 500,000 Iraqi children (UN figures, not mine), and now the punishment of ravaged Afghanistan—all this under the banner of a war against terrorism.

Instead of trying to overthrow Taliban, which will surely pave the way for a second Russian occupation of Afghanistan, the U.S. and its allies should recognize Taliban as the legitimate Afghan government, and work with Kabul to curtail the opium trade, which is currently beyond anyone's control in a nation that is starving and desperate.

The West may not like the fierce Taliban, but it is the legitimate government of Afghanistan and the only power holding that nation together. Taliban is also the only force blocking Russia's plans to restore its former rule in Central Asia, and to reoccupy strategic Afghanistan.

#### CHIRAC GIVES WAY IN ROW WITH BLAIR ON NATO

Jacques Chirac last night backed down over efforts to distance European defence from NATO as the EU summiteers pledged to work closely with the Atlantic alliance.

Britain sought to portray Thursday's row with France about defence as a semantic difference. But Tony Blair, rattled by Tory criticism and sensational headlines, insisted on cutting back the summit's defence text "to avoid misunderstandings" about the new rapid-reaction force.

Diplomats acknowledged that difficulties lay ahead in agreeing detailed future EU-NATO arrangements on planning, which are crucial to keep the U.S. and the alliance happy—and the Eurosceptics at bay.

Ironically, these must now be overseen by neutral Sweden, which takes over the EU's presidency next month. "The EU hopes for a favourable reaction from NATO so that these arrangements can be implemented on a mutually satisfactory basis," a summit statement said last night.

Mr. Chirac jangled nerves on Thursday when he said that the EU's 60,000-strong rapid-reaction force should be independent from NATO's military headquarters. But yesterday he said EU efforts were intended to "complement" NATO.

Irritated by what was seen as an unnecessary if predictable domestic-driven diversion by the rightwing French president, the foreign secretary, Robin Cook, insisted there were no real disagreements.

"There was no row," Mr. Cook said. "The decision took about eight minutes. It was unanimous and taken in a spirit of unity. These documents give Britain all we ever wanted on European security."

There was support from Javier Solana, the EU's foreign policy supremo. "It's more a question of language, a question of semantics," Mr. Solana said of Mr. Chirac's statement. "Let's make it very clear. It's not a threat to NATO. We are not trying to create a European army."

But sensitivities were evident when the 15 leaders approved a report on defence policy but omitted several paragraphs from a statement summarising the EU's role in crisis management, including links with NATO.

Mr. Blair said the draft contained slight deviations from agreed wording on the defence initiative. Mr. Chirac said the differences were slight, but agreed to omit the passages rather than waste time on a detailed debate on wording.

The EU insists its initiative is compatible with NATO and is intended to carry out peacekeeping and humanitarian missions when the U.S. and NATO choose not to get involved. But questions linger about the degree of coordination between the EU and NATO, and the role granted to six NATO members, especially Turkey, which are not in the EU.

William Cohen, the U.S. defence secretary, warned

this week that NATO could become a "relic of the past" if the EU set up a divisive European caucus within the alliance and established rival structures for defence planning.

And Britain's chief of the defence staff, Sir Charles Guthrie, fuelled the debate yesterday: "Judging from what President Chirac said, there is certainly a difference of opinion," he said.

Smelling an opportunity, the Tories returned to the attack. The shadow defence secretary, Iain Duncan Smith, said: "What Mr. Chirac said, and what is on the table today, is nothing new. It is simply what Mr. Blair has agreed to already. It's no good Mr. Blair pretending that he has reservations now, when at no stage over the past two years has he insisted on any formal link to NATO, nor spoken of any problems. Mr. Blair's attempt to use British defence forces to place himself at the heart of the EU now risks weakening and destroying NATO."

The French president later told a news conference that he was "100% happy" with the outcome, which was a good agreement in "perfect harmony" with NATO.

"NATO naturally remains the foundation of collective defence among the allies," Mr. Chirac said. A European defence capability was a complement to NATO that "strengthens the Atlantic alliance and does not weaken it". **[JR: The dynamic duo of Blair and Cook prevailed against Chirac's attempt to disengage the Euroforce from NATO. It appears as though the EU has hit a snag in its attempt to have this matter settled by year's end. It is a daunting task to get these movers and shakers of power to put aside their egos and agree on anything. I don't, however, believe Chirac is 100% happy about the "perfect harmony" with NATO—and the U.S.]**

#### GOVERNMENT REACHES INTO YOUR CHILD'S SCHOOL LUNCHBOX

How would you like to receive a letter from your child's school informing you that you must meet certain federal guidelines if you opt to send your child to school with a lunch you fixed at home?

Well, the parents of children in the Oak Meadow Montessori School [Gwinnett County, Georgia] received just such a letter last week. The letter contained some fluff about Thanksgiving celebrations and dropping your kids off at school—then it got around to school lunches. Here is the pertinent paragraph. Spelling and punctuation errors have been left untouched.

"As you know, we will begin providing catered lunches, five days per week, starting Monday. In last week's Parent Communication Envelope, we included information regarding the menu for the week of November 27<sup>th</sup> through December 1<sup>st</sup>. The catered lunches are designed to satisfy the USDA food program requirement. You may still choose to send in your child's lunch. However, you must provide the appropriate servings from the recommended food groups. If you do not, we will be responsible for providing your child with a "well balanced" lunch. Lunches ordered in advance are available for \$3 per day. Lunches that we need to provide because you forgot to bring one, or because you did not provide the proper choices to satisfy the United States Daily Recommended Allowances for lunch, will be billed to your account at a rate of \$5 per lunch. Please make sure to review the enclosed flier regarding our new lunch box requirements."

OK. So now you're wondering just what the Imperial Federal Government requirements for these officially approved school lunches are. Well, that's not really the point here, but just to satisfy your curiosity, here's what the Oak Meadow School says the parents must provide in a lunch brought from home:

1 serving milk (provided)	½ cup	1 cup
1 serv. meat/meat alternative	1½ ounces	2 ounces
2 serv. fruit and/or vegetable	½ cup	¾ cup (each)
1 serv. bread or equivalent	½ slice	1 slice

Then you have a big list of approved fruits and vegetables and meats and breads. You might be interested to know that Cheese Whiz is an acceptable meat substitute.

Look, don't go making irate phone calls to the Oak Meadow school. This standard applies to ALL schools. They're just enforcing it.

Can you believe it? The Imperial Federal Government of the United States is now using its agents in our government and private schools to peer into those lunches you prepare for your children to see if you've done it right—right according to government bureaucrats. This particular school will charge you five bucks if you've done it wrong and will "supplement" your child's lunch with officially approved food.

"You can't force me to eat anything I don't want to eat!"

"Oh, no, sir. We can't force you. The government guidelines say we can only strongly encourage you to clean your plate. But you will have to pay for it."

"The hell with this. I'm going somewhere else."

"Won't do any good, sir. The same rules went into effect everywhere today. You think it's bad here, you ought to see the problems they're having next door at McDonalds."

#### LEADER OF RUINED LIBERIA REIGNS AT VORTEX

MONROVIA, Liberia (*NYT*)—Soon after the Sun sets, the road into this capital, which has had no electricity in nearly a decade, disappears into the dark night. The glimmer from candles and oil lamps casts faint shadows of pedestrians moving about in the very center of town, where the few clusters of light come from private generators. There are no traffic lights.

All of war-scarred Monrovia is plunged into darkness—except one short block, where a huge house sits surrounded by a white wall that extends almost to the side of the road. On this block, two rows of majestically tall street lamps yield light.

The house on the block belongs to Charles Taylor, the president, the warlord who destroyed Liberia in one of the most barbaric civil wars in Africa's recent history, and who terrorized its people into electing him in 1997.

Having made an inaugural promise to "not be a wicked president", Mr. Taylor, 52, has spent the past three years becoming the single most destabilizing force in West Africa, diplomats and international workers say. At a time when Africa draws less and less attention from the United States and Europe, Mr. Taylor's deeds could easily have gone unnoticed; he could have been dismissed as yet another African despot ready to fill his pockets and leave his people's bellies empty.

But from his corner of the continent, Mr. Taylor, perhaps more than any other leader, has forced the West to pay attention: whether to the diamonds sold in New York and Paris to fuel African wars, or to the peacekeeping role the West should play in Africa.

To the northwest, in Sierra Leone, he has backed the Revolutionary United Front, whose rebels have given him diamonds in return for guns. With the largest operating United Nations peacekeeping force now installed in Sierra Leone, Mr. Taylor's role there has drawn increasing condemnation from the UN Security Council. His government has become an international pariah.

Meanwhile, he has transformed Liberia into what one diplomat in the region calls "Charles Taylor Inc." In addition to Sierra Leone's diamonds, he has plundered his country's natural resources, enriching his family and a small circle.

"Electricity is the key to Liberia's socioeconomic progress," reads a billboard not far from the presidential residence, a relic of Mr. Taylor's unfulfilled promise to provide power by 2000.

There is no running water here, either. And the government has nearly abandoned the schools and hospitals. The security forces provide a reminder that a government does exist in Liberia. A five-minute walk from downtown leads to a neighborhood near the gutted Inter-Continental Hotel, where people have dug holes in the ground, getting water from wells as if they were living in the country, not the capital of what once was one of the continent's better-off countries.

"Before the war I stayed in my home and opened the faucet and water came out," said Dominic Weah, 40, who dug a well after the war began in 1989 and still comes to draw from it every day.

"We have a lot of problems in this country," Mr. Weah added. "I expected Charles Taylor to do much better. He brought the war in this country and destroyed the water system, the electricity, the sewer, telecommunications. These are the things used by the common people. Everything is upside down."

Mr. Taylor, who received an economics degree from Bentley College in Waltham, Massachusetts, has brought Liberia's relationship with the United States to a low point.

The last time Mr. Taylor spent an extended period in the United States was in 1985, when he broke out of a Massachusetts prison as he awaited extradition to Liberia on embezzlement charges.

He then went to Libya, where he received military training as the guest of Colonel Moammar Gadhafi. It was in Libya that Mr. Taylor met another dissatisfied West African rebel, a cashiered Sierra Leonean corporal named Foday Sankoh, who went on to establish the Revolutionary United Front and start the war in Sierra Leone in 1991.

Mr. Taylor and Mr. Sankoh would help each other over the next decade, as soldiers loyal to both fought in Liberia and Sierra Leone. Liberia provided a conduit for diamonds smuggled out of Sierra Leone, as well as a source of arms. In their war against their respective governments, Mr. Sankoh copied the guerrilla tactics that Mr. Taylor gained notoriety for in Liberia: The widespread use of child soldiers, who were often drugged to commit atrocities; the deliberate victimization of civilians to bring about their submission.

In 1997, a year after Liberia's civil war ended, Liberians overwhelmingly chose Mr. Taylor as their president, believing that he would resume the war if he lost. And while Liberians have lived in relative peace in the past three years, Mr. Taylor has, in the words of a religious official who has been here since 1983, "pushed things back 50 years."

The peace has betrayed its fragility in recent months, as a long-simmering conflict erupted with Guinea, to the north. Hundreds are reported to have been killed in skirmishes between Liberian and Guinean soldiers.

The president has squelched nearly all criticism, having chased most political opponents out of the country and reined in the National Assembly.

But the government has allowed great freedom to newspapers, betting on the fact that they are not sold outside the capital, that only a third of the 3 million Liberians are literate and that fewer can pay 50 cents for an eight-page daily....

International relief workers say the government gives little money to its hospitals, and the same is true of its schools. An official at one organization that feeds schoolchildren said half of the teachers at schools were volunteers; the other half have not been paid in three to six months. Many competent teachers have left.

Public services continue to deteriorate even as Mr.

Taylor and his family—several relatives head ministries—loot Liberia, say Western diplomats, international workers and Liberian and foreign business people here.

A principal income source in the last couple of years has been Liberia's rain forests, according to these officials. The Forestry Development Authority, which is headed by the president's brother, Robert, has allowed a shadowy logging company, Oriental Timber, with headquarters in Hong Kong but mostly Indonesian workers in Liberia, to wipe out entire forests, diplomats say.

In the past, Mr. Taylor has blamed the West for failing to provide money to rebuild Liberia. While acknowledging his ties to Mr. Sankoh, he has always denied accusations that Liberia provides the Sierra Leonean rebel group with arms in return for diamonds. **[JR: This is but one of the many sad conditions prevalent in Africa today where rich despots rule over people who live in poverty and in fear. The U.S. and Europe will not get involved because of the rich profits made from illegal wealth taken from those regions. Diamonds are not everyone's best friend.]**

#### CONFUSION OF GLOBALISM AND CULTURE IN ENGLAND AND LOSS OF LIBERTY

The more ethnic diversity in a state, the greater the force needed to maintain order, and the greater the Loss of Liberty.

In England, the ballots in a General Election may be in five languages. In a survey reported in *The Guardian* of 28 Oct. 2000: "Ninety-three percent of young people in Britain do not know that John Milton wrote *Paradise Lost*. Ninety percent cannot identify 1815 as the year of the battle of Waterloo. Some 84 percent and 77 percent, respectively, do not know what the *Domesday Book* or the *Magna Carta* were. Many results appear to point to a progressive breakdown in the transmission of historical and cultural facts between the six generations questioned for the survey."

The freedom of speech that I experienced in Britain as a boy and young man seems almost gone. That is an example of part of the heritages being lost. The challenge is to recognize the relevance of the Anglo-American traditions that speak in their history and literature. "The essence of the West is *Magna Carta*, not Big Mac" (Samuel P. Huntington, *Foreign Affairs*, Dec. 1996). Everyone in the world may soon speak English, even as a second language, but the heritage, traditions and aspirations could be forgotten.

[QUOTING the essay "Will There Always Be An England?", by David Pryce-Jones in *National Review*, Nov. 20, 2000 (page 42) ends as follows:]

#### NOT "THE GREATEST SHOW ON EARTH"

These changes collectively contribute to a gathering social, moral, and cultural vacuum. Liberty, ancient right, and custom are no longer secure. Nobody knows how to behave, nor what to believe, nor even what common sense is....

Not necessarily responsible for each and every abomination, Blair nonetheless presides with equanimity

and encouragement over all of them. He invites to Downing Street, pop stars boasting of their use of heroin, and he fawns over them for the photographers. He gives a prestigious award for his work to an unrepentant Stalinist apologist, the historian Eric Hobsbawm. It is a county which one artist is acclaimed for passing a fiber-optic video camera through her body orifices in a "self-portrait", and another artist is compared to Leonardo for scaling up a plastic model of the human anatomy. It is a country that invites on a diplomatic mission a friendly former head of state, General Pinochet, and then kidnaps him. It is a country in which fox hunting is about to be prohibited; the disabled admitted into the armed forces; trial by jury will be limited; and universities are pressured into admitting students on grounds of affirmative action. #### WHY GOLD IS NOT COMMON

This article is in response to David Guyatt's new book entitled *The Secret Gold Treaty*. What I find questionable about the book is Mr. Guyatt's claim that gold is common. In order to refute this claim, we must first look at why gold was universally chosen as money for as long as perhaps 6000 years. After thousands of years of bartering—and trial and error with different



forms of money—gold and silver were found to be superior to all other money forms. Gold and silver fulfill the role of money perfectly in that they are durable, divisible, convenient, consistent, have intrinsic value, and **especially because neither can be created out of nothing by central banks**. When gold was used as money, it was mined in quantities that retained its value ensuring long-term price stability, while supporting healthy economic growth. When fiat money is used, inflation and boom/bust economic cycles result. If gold is as plentiful as the book claims, it would have been dropped as a universal form of money centuries ago!

Gold can be found in soils, rocks and fresh and salt water in minute quantities. Gold is found in economic quantities as placer deposits formed by wind and water erosion of rocks—and surface and underground veins formed by specific geological events. Veins are where most gold is located and they are identified by drill samples. By analyzing drill samples the vein's gold content can be estimated, allowing geologists to determine if the vein can be mined economically. The South African Witwatersrand basin is an excellent example of specific geological events that formed gold deposits. Here, gold is found in veins as microscopic particles embedded deep underground and recovering this gold is a very difficult task! If gold is as plentiful as Mr. Guyatt suggests, why would gold be mined as deep as 2.5 miles underground? If more gold has been mined in the last 50 years than in the previous 5000 years (total gold mined~130,000 tons), where was the additional gold mined (locations and quantities)?

The basis of any economy is its currency, be it commodity or fiat. **Recall Baron M. A. Rothschild's famous statement "give me control over a nation's currency and I care not who makes its laws"**. He means that if you control a country's currency, you indirectly control its media, educational system, legislation, commerce, industry, work force and essentially the entire nation. This is the power that the Federal Reserve has over the United States today. It is a privately owned banking monopoly that has the exclusive privilege of creating money out of another's debt. Only the Fed can slap ink on paper and call it money, others who do this are called counterfeiters. The government can obtain all the money it wants by selling bonds to the Federal Reserve—who in turn use these bonds as a "reserve asset" to create debt money at interest for the government. The government has unlimited funding, the Federal Reserve collects enormous sums of interest and we-the-people get an inflated dollar. This is the Fed's motivation for replacing gold with fiat money—and they would use this fabled gold resource in an instant to keep their scam going.

After the huge gold price increase in the 1970s, governments realized that it was impossible to suppress the gold price with physical gold only. Since the early 1980s, the gold price has been suppressed with borrowed physical gold, producer hedging and paper gold—which includes gold contracts, certificates, derivatives and exotic hedging schemes. Only a small percent of this paper gold is backed by physical gold. **If physical gold is as plentiful as Mr. Guyatt claims, why is there a need to create all this paper gold, when a chance of default exists?** Other contradicting events include why did the South Korean government ask its citizens to turn in their gold when its currency collapsed? Why did Germany, after W.W.II, attempt to extract gold from sea water to pay war debts (they failed), when all they had to do was use some of that "common gold"? Why

would the gold derivative positions of Chase, Deutsche Bank and Goldman Sachs explode upward after the 1999 Washington Agreement; why not use some of the Marcos/Yamato gold to cap the gold price rally? How would the London gold pool of 1968-1970 be explained? How would the gold price explosion in the 1970s from \$35/oz to \$850/oz be explained? How would the myriad of Central Bank gold sale announcements at strategic times to stop all gold rallies be explained; why not simply cap them with some of that "common gold"? If gold was moved from European Central banks to be hidden from the Germans in World War II, wouldn't they want their gold back? Why do geologists call gold a precious metal, because it is common? If all this physical gold existed, the aforementioned events would not have occurred!—**Donald Poitras**

There's good gold news for a change, lots of it! The price has moved up, and while not yet out of the bear woods, is strong enough to take spec positions (with a stop).

China is studying plan to deregulate their gold market. China is world's 4<sup>th</sup> largest gold consumer, after India, U.S. and Saudi Arabia. India's market doubled 2.5 years after deregulation. China consumption may triple within 3 years.

Venezuelan central banker German Utreras (GU) said at a central bankers' meeting: "Central banks need to form a pact (similar but stronger than the Washington Accord of Sept '99) to reduce gold lending and sales in order to 'restore gold's value.'" This is a mind-blowing event; a central banker telling his mates how silly they've been. He spelled it out: As a result of bank sales/lending, gold had dropped, causing central banks to lose \$15 billion from sales alone in 2000 and lowered their profit from gold loans to about \$30 million in 2000.

In effect, he said the emperor has no clothes, something everyone knew, but central bankers seem not to see. GU said central banks have devalued their own assets. This proves to doubters to see that gold's price has been artificially pushed down. And this is aside from the gold-price-capping team headed by Goldman Sachs, who sell gold in NY daily and advise and arrange for miners to sell/hedge gold, which further depresses the price, evidence of which would fill a half-empty central bank vault!

The massive physical gold short position is trapped. They can't get out. If they try, they'll elevate the price, a Catch-22 they richly deserve. Note: The shorts in gold shares have suddenly shrunk, a sign of impending panic?

The gold bear market has caused many mines to shut down, many mines are now delisted on stock exchanges, with share prices reduced to pennies. Result: quality gold shares are rising strongly, due to both a rising metal price and very few stocks to choose from. Agnico-Eagle & Placer are 2 of the better N. Americans. Since 1985 there were 13 gold rallies. Average rise in bullion price in rallies: 8%. Average rise in TSE gold stock index: 22%. Average Agnico-Eagle rise: 34%. AE is proven out performer. AE is increasing production hugely and

lowering cost to \$150/oz in 2001. By 2004 to \$100.

Bob Chapman's international newsletter says: "Rumours abound that Fed is privately buying gold to put U.S. inventory right before new administration takes office. We hear 50 metric tons absent." Zurich and London have big gold volume daily. Press never reports it! Someone buys every oz offered!

Moscow says it'll not buy diamonds in 2000-2001 but instead will buy gold. GATA comment: "West selling gold as East buys it. They forget old motto: "He who has the gold makes the rules."

#### **Duplicity**

In a seemingly unrelated field, the word went out years ago for Greenspan and government agencies to "cool the price index and cap the gold price". Not only the U.S. does this. Most nations have a similar need to cap the cost of their retirement payment outflow. It's a silent duplicity that prevents economic justice (especially to those on Social Security or government/corporate pensions) and precludes a free gold market. Disgusting? Yes, but it's politics. Just don't kid yourself that the status quo represents true/real/honest economic conditions in the U.S.—or anywhere else! But these capping operations are slowly being exposed/understood. The result could be dramatic. Example: global short positions in gold bullion that will make the gold price not just rise, but fly—with disastrous effects—as opposed to an orderly rise. The world's leading authority on gold's short position, **Frank Veneroso, ex-advisor to many nations' central banks, says the natural equilibrium price for gold was \$600/oz in 1997**. It would be higher today. He confirms with GATA and HSL that the gold price is being manipulated—and because of this artificial capping (like capping a boiling kettle), the demand (which far exceeds production) will force the lid off and the price will exceed the natural price. Especially as the market is small.

Given a free market (unlike today's), gold always reflects the health of economies. Example: When gold (correctly) topped out in 1980-82, all world stock markets began basing—and in '82 started a multi-year bull market. All was well—no need for gold alarm bell. But the situation is reversed now. All is not well. Debt (personal, corporate, national) in most 1<sup>st</sup> World nations is high, at worst ever in the U.S. Money supply is being dangerously inflated, which means it can't be inflated more to help in coming recession. Credit is overextended versus risk. People stopped saving (thus no reserve pool for a cushion). Public exposure to stocks is dangerous, with most now experiencing losses, but unable (psychologically) to sell—as they're waiting for the market to come back, as it has done in recent years. This time it won't; the mega-bull market is over. So the entire middle class can be—if not wiped out—at least robbed of all bull market profits. Retirement plans trashed. Cancel the golf club membership.

Robbed? Yes, robbed, because the alarm bells aren't allowed to ring! The public is being misled, deceived and robbed. By who? By the bullion banks (only 3-5 of them) and cooperative fat cat bullion brokers and their masters in a political hierarchy. Their fingerprints are all over the market place every day. It's all so obvious if you just remove the rose-tinted glasses: slipping economies, falling stock markets, quivering currencies—makes this refurbished version of our 10-year Mission suddenly more useful and timely than I realized when it began. Without these structural changes, we haven't the global machinery to fix the problems.—**Harry Schultz, <http://www.ihsl.com>**

RP CAN DO WITHOUT IMF FUNDS—  
BUENAVENTURA

There is no need for the Philippines to enter into another funding package with the International Monetary Fund (IMF)—even as the country is being subjected to the multilateral financing institution's post-monitoring program, the first of its kind in the Asean region.

Bangko Sentral ng Pilipinas (BSP) Governor Rafael Buenaventura said the post-monitoring program is part of a new tack the IMF has adopted in dealing with its member-countries and thus, has no definite guidelines and funding scheme.

He said the IMF, in fact, is "more hesitant to do that (grant funding programs) and only to those in extreme situations."

The BSP official said compared with other countries, the Philippines is still better off in terms of comparative ratios like the deficit-to-gross domestic product and debt to GDP, both of which are even lower than those requiring financial assistance from the IMF.

Under the post-monitoring program, there will be two review periods: the first either in late March or April 2001 and the next sometime in September 2001.

Buenaventura said if the government deems it necessary, then it would then seek a new program with the IMF after the review but added he would prefer not to do so since this means meeting tough performance targets.

Even without the IMF funding, Buenaventura said the country's other loan covenants with other financing agencies would not be adversely affected.

The World Bank, for instance, which normally has cross conditionalities with the IMF, is embarking on its own program.

The latest program the Philippines had with the IMF was a standby arrangement program which was not completed due to the failure of the government to meet the budget deficit target of P62.5 billion this year.—

IMF SHOULD RESPECT CHOICE  
OF EXCHANGE-RATE REGIME: BOARD

The International Monetary Fund (IMF) should continue to respect the exchange-rate regime choices of its members, said the IMF executive board of directors.

"But its surveillance and programmes must seek to ensure that the countries' policies and circumstances are consistent with their exchange-rate regimes," they concluded in the IMF 2000 annual report for the financial year ended April 30, 2000.

The directors also felt that the IMF should not provide large-scale assistance to countries intervening heavily to support an exchange-rate peg if this peg was inconsistent with underlying policies.

"In some cases, it should offer advice on a suitable exit strategy," the report said.

The report said the IMF executive board had considered several key issues concerning exchange-rate regimes against a backdrop of increasing international capital mobility.

This was because the choice of the right exchange-rate regime had become more important as an increasing number of countries had become more integrated in world capital markets, it said.

The directors also concluded that no single exchange-rate regime was suitable for all countries or in all circumstances.

"Whatever exchange-rate regime is adopted, its consistency with underlying macroeconomic policy is essential," it said.

The directors also felt that the existing system of flexible exchange rates among the three major currencies was likely to continue.

Thus, it said countries needed to adapt to a global environment of exchange-rate variability.

They also noted that in recent years, several emerging market countries had adopted a flexible exchange-rate regime.

Although exchange rates must be allowed to adjust in response to market pressures, it may also be appropriate to use domestic monetary policy to limit swings.—**Bernama**

ESTRADA CRITICS IN MILITARY, POLICE  
RECEIVE THREATS

Military and police officials believed to be anti-administration are reportedly being "threatened and intimidated" by their superiors.

Sources told *The STAR* yesterday the administration is closely monitoring the activities of Marine Lt. Gen. Edgardo Espinosa, the commandant of the Joint Command and Staff College in Camp Aguinaldo in Quezon City.

Sources said Espinosa, former chief of the Armed Forces Southern Command, has been perceived as a "possible" administration critic after he was relieved of his command in Mindanao last year.

"We got information that he (Espinosa) is being monitored for reasons unclear to us except that he is perceived as an administration critic," the sources said.

Military officials at Camp Aguinaldo told *The STAR* yesterday Espinosa had asked to be relieved as Southcom chief because of personal reasons.

However, sources said the reason is that Espinosa had a "falling out" with Zamboanga businessman Lee Peng Wei, who is said to be close to President Estrada.

Espinosa was a classmate of retired Deputy Director General Roberto Lastimoso at the Philippine Military Academy (PMA). Both belong to Class 1967.

Lastimoso, who was relieved last year as acting chief of the Philippine National Police, is now a prosecution witness against President Estrada in the impeachment trial.

The Presidential Anti-Organized Crime Task Force is also reportedly monitoring junior military officers belonging to PMA Class 1993 for unknown reasons.

"We don't know why they are being subjected to this monitoring if this, indeed, is true," the sources said.

Last week, Senior Superintendent Jaime Caringal was relieved as chief of the directorial staff of Police Regional Office 4 and reassigned to the Cordillera Autonomous Region as Ifugao police director.

Caringal, a member of PMA Class 1976, is a son-in-law of former Army chief retired Lt. Gen. Fortunato Abat.

Abat, chairman of the Federation of Retired commissioned Officers and Enlisted Soldiers (FORCES), has been leading other retired generals in calling for the resignation of President Estrada.

ESTRADA PAL: I'M VALHALLA

Is he the real account holder or just a loyal "errand boy" out to save a friend's hide?

Presidential friend Jaime Dichaves formally claimed ownership yesterday of controversial Equitable-PCI Bank account no. 000110-25495, otherwise known as the "Jose Valhalla account".

In a letter to Chief Justice Hilario Davide, Dichaves said through lawyer Manuel Lazaro that documents pertaining to the account contained in a sealed envelope should not be opened until there is a final decision on whether bank records of a depositor, who is not a party or respondent in the impeachment proceedings, could be the subject of a subpoena.

The Filipino-Chinese businessman also said he issued the P142-million check claimed by the prosecution to have been used by another presidential friend, Jose "Sel" Yulo, to buy the so-called "Boracay mansion" in New Manila, Quezon City for one of President Estrada's mistresses.

Prosecution lawyer Joker Arroyo, however, said Dichaves' letter was "a mere scrap of paper" and his admission of ownership "a cheap shot".

"As far as we are concerned, the real owner of the account is the President," Arroyo said.

Dichaves' lawyer contended that with the admission of ownership of the account and issuance of check No. 0110-714951 dated Oct. 5, 1996, the subpoenaed documents "disprove that they are relevant, material and competent" to prove allegations that the account belonged to the President and that the check was signed by him.

"Although impeachment is one of the exceptions to the Secrecy of Bank Deposits Law, it must refer to the bank records of the official on trial," Lazaro said.

Dichaves also lashed at the "unilateral act" of Equitable-PCI Bank to submit to the impeachment court another account that is not even the subject of a subpoena. The bank said it decided "to construe expansively" the subpoena by submitting—in a sealed envelope—additional documents pertaining to a savings account also in the name of the holder of the current account.

Dichavez described the submission as a violation of his constitutional right to be secure against unreasonable searches and seizures, privacy of communications and correspondence and deprivation of his property without due process of law.

Arroyo pointed out that the Dichavez admission was a belated cheap shot to save the President's hide.

"Before, he (Dichavez) kept quiet. We've been discussing this for two weeks and just when we are about to open the envelope, he says he is the owner," the Makati congressman pointed out.

For his part, Davide said he would merely note the letter until Dichavez makes a formal manifestation before the court.

Meanwhile, the President confirmed yesterday that Dichavez was, indeed, a close friend.

Interviewed in Piat, Cagayan where he led the distribution of Christmas gifts to townfolk, Mr. Estrada refused to comment on the sudden emergence of "Jose Valhalla".

"Let us just leave this matter to the lawyers and the Senate. They will be the judges here," the President told reporters before flying back to Manila.

In a press briefing at Malacañang, Press Undersecretary Mike Toledo also confirmed the friendship between Dichavez and the President.

"As far as I know, Mr. Dichavez is just a close friend. But that's how far the relationship is," Toledo said.

He pointed out that the businessman is not

connected with any position in the government.

"I'm not going into the details, but the bottom line is that no evidence has been presented by the prosecution that directly links the President to any illegal activity or any of the articles stated in the impeachment complaint," Toledo said.—**With Marichu Villanueva**

#### LACSON'S AIDE TAGGED IN WIRETAPPING

Some senior police officials at Camp Crame said Superintendent Diosdado Valeroso is operating with a handful of trusted intelligence men, using state-of-the-art surveillance and eavesdropping equipment.

The officials said Valeroso, a former intelligence chief of the PNP Special Action Force, holds the position of special assistant to the PNP chief.

Meanwhile, Lacson vowed yesterday to ask President Estrada to disband the Presidential Anti-Organized Crime Task Force (PAOCTF) if critics could prove that the agency is illegally tapping telephones of government officials.

"I believe that a unit shall have lost its efficiency if its credibility is put to question," he said. "And I am willing to put my job as PAOCTF chief on the line if the allegations are proven true."

Lacson said he would also call on PAOCTF officials to resign if evidence is presented and it is proven they have encroached on the privacy of individuals and the confidentiality of communications.

Senior Superintendent Nicanor Bartolome, PNP spokesman, denied having any personal knowledge of the allegations that policemen are engaged in illegal tapping of telephones.

"There is no truth to the allegation that the PNP is involved in surveillance operations, especially of politicians because we are not given the mandate to do that," he said.

At Malacañang, the President described as "nothing but concoction" reports that the Palace has authorized government intelligence agents to bug phone lines at the Senate and the offices of members of the political opposition and the media.

"There is no truth to that," the President told reporters at Piat in Cagayan province yesterday. "They come up with everything but there is no truth to that."

Mr. Estrada heard Mass and attended a multisectoral assembly in Cagayan yesterday and flew back to Manila later in the afternoon.

On the other hand, National Security Adviser Alexander Aguirre told reporters he does not believe that personnel of the Philippine Long Distance Telephone Co. (PLDT) are tapping telephones for the Palace because everything about the impeachment trial is read in the newspapers and heard on the radio.

"Everybody could hear and see all these things," he said. "So I think it's (wiretapping) not true. If our detectives do monitor, they do it pertaining to crimes or criminal activities or criminal elements but not to legal opposition."

Last Monday, a newspaper reported that it had

obtained a document proving that the PAOCTF had bugged telephone lines at the residences of about 100 people.

Manuel Pangilinan, PLDT president and chief executive officer, told reporters yesterday the telephone company is trying to identify the "mole" who is believed to be giving pro-Estrada "spies" computer printouts of billing records of about 100 subscribers.

#### **Solons angered by surveillance**

Some senators and congressmen were angered by reports that the PAOCTF have placed under surveillance members of Congress and opposition personalities.

Senate Majority Leader Francisco Tatad asked the Senate committee on national defense, public order, ethics and public services to look into the reported monitoring of telephones of members of the impeachment tribunal.

On the other hand, Sen. Raul Roco urged the impeachment tribunal to summon Lacson and PAOCTF officials to explain the accusations against them.

Senate President Aquilino Pimentel Jr. expressed disappointment over the alleged illegal activities of the policemen assigned to PAOCTF.

Also condemning the alleged police surveillance was Quezon City Rep. Feliciano Belmonte Jr. (Lakas, Quezon City), who heads the 11-man prosecution panel from the House of Representatives.

Bukidnon Rep. Juan Miguel Zubiri (Lakas) has sought the abolition of the task force headed by Lacson.

Isabela Rep. Heherson Alvarez, Lakas secretary general, said the alleged "super-secret operation has the earmarks of a rogue clique in government using public funds for purely private personal ends."

Parañaque Rep. Roilo Golez (Independent) accused Malacañang of trying to "sabotage the impeachment trial" through the tapping of the telephones of judges and members of media and the political opposition.

However, Aguirre assured the public the government is closely monitoring political developments in the country without resorting to illegal wiretapping.

Aguirre said the government depends on legal means to monitor the public pulse like the opinion surveys being conducted by *Pulse Asia* Inc. and the Social Weather Stations.

"Of course, this is part of our monitoring," he said. "We have to feel the pulse of the people."

Aguirre laughed off accusations that the PAOCTF is monitoring the telephones of impeachment court judges, media people, and opposition politicians, saying that the media is freely covering the impeachment proceedings.

In a statement, the Trade Union Congress of the Philippines (TUCP) called yesterday for the creation of an independent people's body to investigate the reported monitoring of telephone calls of impeachment court judges and members of the opposition.

"If reports are true that PAOCTF is doing such illegal operations, it should be immediately disbanded and its officers and men jailed," read the statement.—**With reports from Marichu Villanueva, Jess Diaz, Perseus Echeminada, Mayen Jaymalin**

#### WELLS FARGO, PGE

#### WILL RESTRICT FUNDING TO BOY SCOUTS

PORTLAND—Wells Fargo Bank and Portland General Electric are asking the United Way not to pass on more than \$600,000 in donations to the Boy Scouts because the organization bans gays [sic] from serving as

Scout leaders.

"The Boy Scouts are as American as apple pie, but this was an easy decision to make," said Tom Unger, a Wells Fargo spokesman.

"We really have to, as a company, return to what our core vision and values are, and that's to not discriminate," Unger said.

But the bank still supports a separate scouting program called Learning for Life because it has an independent policy, he said.

Unger also said that Wells Fargo employees are being encouraged to support the Boy Scouts as volunteers.

Larry Otto, executive director of the Cascade Pacific Council of the Boy Scouts, defended the national policy barring homosexuals and said the Scouts rely more on families for funding than corporate donors.

"Our values aren't for sale," Otto said. "We aren't going to be trumped by anyone's dollars."

Wells Fargo pledged \$400,000 to the United Way of the Columbia-Willamette while PGE pledged \$217,000 to the agency during this year's annual drive.

The local Boy Scouts council, however, has an annual budget of about \$6.1 million with just \$252,000—or about 4 percent—coming from United Way last year.

Last summer, the U.S. Supreme Court narrowly voted to uphold the national Boy Scout policy that prohibits "avowed homosexuals" from being Scout leaders.

Critics said the court was sanctioning discrimination but supporters praised the ruling, saying the Scouts should be allowed to set their own rules.

In the Portland area, the board of the United Way of the Columbia-Willamette voted in October to continue its financial support for the Boy Scouts. The decision came in the middle of the United Way's annual corporate drive, and agency officials have been wary about the effects.

The United Way's total goal for this year's drive is about \$22 million. With half the money tallied, donors have designated about \$48,000 to the Scouts, an increase over last year at the midway point. Overall, the Scouts received \$73,000 last year.

United Way spokeswoman Stacey Graham said, however, that more individuals have steered money away from Scouts.

The council serves about 53,000 children in Oregon and southwest Washington.
