

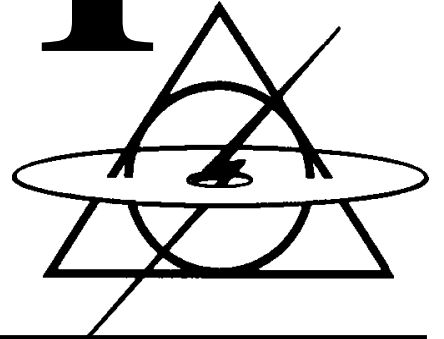

manipulation of the gold market. It will be interesting to see how it plays out, even if dismissed without meaningful hearing.

The key is the secular golden rule: **He who has the gold makes the rules!** Judges will run around Robin Hood’s barn to avoid challenging entrenched powers who control national and international markets.

In the eighties, manipulation of cattle futures was so obvious that the U.S. Senate funded a major study through departments of agriculture of several universities. The study tracked cattle futures manipulation to six powerful cartels. Yet nothing was ever done, and ranchers for all practical purposes were pitched out of court when they tried to litigate. Five international cartels control grain markets, of course. And nothing is done. In fact, they pocket most of the export enhancement funds congress appropriates.

We’ve recently seen something on this order with the parity farm suit filed by Gene Schroeder

and others. The government effectively admitted that farmers are suffering from unlawful commodity price regulations, but the practice has been going on for the last half century so the American farmer is up the proverbial creek without a paddle. The judicial branch isn't going to do anything to relieve the draconian problem even though we continue to lose approximately 500 family-owned farms and ranches per week.

The message is this: Law will be enforced when it is convenient for and to the advantage of entrenched powers.

It will be interesting to see how far the gold-market suit announced in the following release gets against the "I can, therefore I will, crowd" that controls the gold market.—Dan Meador

GATA's REG HOWE SUES BIS, FED, TREASURY, AND 5 INVESTMENT HOUSES TO STOP GOLD PRICE SUPPRESSION

December 8, 2000

A lawsuit filed in U.S. District Court in Boston on behalf of the Gold Anti-Trust Action Committee (GATA) accuses five investment houses, the Bank for International Settlements, and top officials of the U.S. Treasury Department and U.S. Federal Reserve Board of conspiring to suppress the price of gold.

[H: Just "our old gang", so let's make it easy for "us" to win. Immediately on funding a large transaction, please, let us get some HELP to these people filing this suit—they need backup and the best legal teams they can purchase.]

The lawsuit, docket No. 00CV-12485—RCL, charges the defendants with anti-trust violations, securities fraud, and breach of fiduciary duty. The U.S. government officials are also accused of exceeding their constitutional authority.

The lawsuit's plaintiff is Reginald H. Howe, a lawyer, gold market analyst, consultant to GATA, proprietor of an Internet site devoted to gold market commentary (www.GoldenSextant.com), and a shareholder of the Bank for International Settlements (BIS) and Freeport McMoran Copper and Gold Inc. The BIS's plan to cancel those of its shares in private hands—so that the bank might become owned entirely by member governments—is at the center of the lawsuit.

The suit alleges that the BIS proposes to pay its private shareholders substantially less than fair value for their shares. The suit also claims that the BIS, owner of a substantial amount of gold, has been at the center of a scheme with central banks and the investment-house defendants to coordinate the sale of gold and gold derivatives to keep the price of gold low and thereby disguise inflation and weakness in the U.S. dollar.

Officials of the Federal Reserve Board have no authority to hold directorships of the BIS, the lawsuit alleges.

The suit seeks injunctions to stop the Treasury Department and the Fed from intervening in the gold market and to stop the investment houses

from manipulating the price of gold; an order to the BIS to compensate its private shareholders fully; and damages against all the defendants for fixing the price of gold.

Besides the BIS, the defendants include: Alan Greenspan, chairman of the Federal Reserve Bank of New York; Lawrence H. Summers, secretary of the Treasury Department; and J.P. Morgan & Co. Inc., Chase Manhattan Corp., Citigroup Inc., Goldman Sachs Group Inc., and Deutsche Bank AG.

"With this lawsuit, we hope to mobilize the gold mining industry and gold shareholders around the world to help us restore a free market," GATA Chairman Bill Murphy said. "Mining companies, their employees and shareholders, and developing countries have been ruined by the manipulation of the gold market, and it has prompted ordinary investors around the world to put their savings at greater risk than they would have done otherwise. Meanwhile, certain Wall Street interests have made billions from this manipulation. GATA was founded to fight this, and fighting it we are.

"But sustaining this lawsuit against defendants that control most of the world's money will cost money itself, and we continue to appeal to gold's friends for financial contributions to support our work."

A PERFECT WORLD FOR FILIPINOS

A sovereign nation, with sovereign provinces and sovereign people, law abiding and blessed with God's abundance. Is it possible? Of course; with God's guidance all things are possible. Is it difficult, hard to understand, or in some way painful? God's solutions to man's problems are always simple and, with His help, never painful.

How can a people as poor as the Filipinos suddenly be blessed with abundance? First of all, this is not a poor nation. In fact, there is more gold to be mined and treasure to be recovered in the Philippines than in any other nation on Earth. And gold is not the only natural resource that makes the Philippines a wealthy nation.

Then why the poverty, squalor, homelessness, overcrowded cities and pollution? You are told that it is because of a "lack of money", which is quite correct. Colonized peoples have been taught, for centuries, that the supply of a nation's money must be strictly controlled else the money will become "diluted" and lose value. Over the past two centuries all people, and especially bankers and economists, have been cleverly brainwashed to believe that the use of gold as a universal standard of the value of currency was "old fashioned", "awkward", "limiting", and expensive. The truth is, of course, very different from that, with the exception of "limiting". WHAT it limits is the key to understanding why it is denigrated by bankers and

politicians alike, and we will return to this point in some detail a bit later. At this point, let us pause to present proof of some of what we have stated.

The Secretary of Finance has stated, recently, when the peso was approximately 50 per 1 U.S. dollar, that the nation has P1.3T in circulation, which is often referred to as the “money supply”. Expressed in dollars, then, that is \$26B. Divided by 75 million Filipinos, that comes to \$347. In the U.S. the money supply is \$6T, or more than \$22,000 per American. It is probably a bit higher than that in Japan. Who is it that can impose such a limit? The IMF/World Bank, through their loan agreements, control how many pesos can be released into the money supply. **When a country takes a loan from one or both of those, it immediately gives up its economic sovereignty.** Without control of its money, the nation is no longer sovereign. Furthermore, in not many years it will be enmeshed in the Debt Trap.

THE DEBT TRAP

The Debt Trap can best be illustrated by using the current situation in the Philippines. The nation’s debt to just the IMF/WB is something close to \$60B and the interest cost some \$6B per year. The IMF/WB rules do not allow the nation to print money to pay the interest, nor would they accept pesos if it did, so its precious foreign exchange is drained away to pay interest. This has gone on many years until the nation’s money supply is down to less than \$26B. Money is like the blood in one’s body, circulating nutrition and oxygen to all its parts. Too little money supply makes the nation anemic and unable to repair itself or to grow and prosper. When the interest of \$6B has been paid only \$20B (P800B) will be left. There is no way to pay the interest out of taxes; if there are not sufficient foreign exchange reserves, it must be borrowed—and you cannot borrow your way out of debt. No wonder President Estrada has to say, “We don’t have the money.” The more the government borrows the larger become the interest payments and so we have the Debt Trap which will soon gobble up all of the nation’s reserves. There seems to be no way out, but there is.

The long list of problems created by the lack of money, credible money, is well known to the readers of this paper. It will be tempting for you to say, “That solution is far too simplistic,” or “What is in it for me (personally), or for GAIA?” or “If it sounds too good to be true, it is.” Those are all juvenile responses put forth as a defense of one’s psyche to avoid the effort of attempting to understand a new concept. Those questions, along with some more serious ones, will be answered in this paper as you read and think about the concepts introduced.

MIND VS. BRAIN

One further caution, please. The human mind is directly connected to the universal mind of God/Aton/Allah, the Lighted Creator. It is the mind with which we think and receive inspiration; it solves problems and uses “common sense”. It is also the base/

foundation of our sovereignty, our non-“brokered” direct link to our source. The brain is distinctly personal and, in addition to other functions, holds our memories and what we have been taught or have learned on our own. Unfortunately, it does not automatically sort truth from fiction, recording both with the same amplitude, and so a lot of the information it contains and relies upon can be erroneous. We ask that the reader process our information in the mind, and not lightly discard it in favor of some preconceived idea or concept resident only in the brain.

The answer to all of the money problems of the Philippines is gold. Some may say, “That is like saying the solution to money problems is money.” No, it is not. Gold is not the same as money anywhere in the world today. When it is returned to that status in the abundance that it is available, it is unlikely that hunger and, therefore, war will any longer be a problem on this planet, and most especially in the Philippines.

Do we speak of some new application of gold? No. Gold has been used as the basis of currencies for some two thousand years that we know of, and probably much longer than that in Egypt and the Americas. What we advocate is a return to something long proven successful, not something new and untried.

THE GOLD STANDARD

Basing a currency upon gold is often referred to as using the “gold standard”. It implies that any holder of the currency can redeem that currency for gold at any time. Thus the old declaration, “Good as gold!” was frequently intoned when speaking of the paper money of the U.S.A., which was gold-backed until 1933. The gold standard does not require the use of any gold in the money in circulation, even though gold coins have been used throughout recorded history. A nation, or a bank, has some flexibility in the amount of paper money it can circulate relative to the gold it holds in reserve. The result of several historical studies of bank runs and “panics” is the conclusion that no bank or nation that had 40% or more of its issued currency (debt) in available gold failed to meet its requested withdrawals. That allows the issuing of 2.5 times as much currency as there is gold in the vault. As a comparison, currently most banks and nations use various things as reserves, some real property, but mostly the paper debt of other banks and nations. In the Philippines the reserve requirement was recently (October 2000) raised from 14% to 16%, so the ratio of lendable pesos to reserves went from 7-1 to 6-1. In the U.S. the reserve requirement ranges between 4% and 5%, providing a ratio of 20 or 25 to 1. (As an aside, certain currency traders and hedge funds, using derivatives to multiply their leverage, have been able to reach levels of 2000 to 1.)

To cement our point in place, the value placed upon the currency in virtually all nations at this time is dependant upon the payment of debt by someone else; there is no real value behind any of them; their value is derived from proclamation and so they are referred

to as “debt-based”, or baseless, fiat currency (fiat means “by proclamation, declaration or decree”). A currency based upon gold is a “value-based” currency and will always be more stable and desirable to the citizens of a nation issuing it as well as everyone engaged with its citizens in international commerce.

FOREIGN EXCHANGE

While there are many benefits to a nation in the use of gold as the base of its currency, probably the most impressive is its effect upon every aspect of foreign exchange. To understand why this is true, one must have some understanding of why foreign exchange is required of nations whose currencies are unacceptable, which applies to all currencies except the U.S. dollar and the Euro. Quite obviously the real reasons for the currency of one nation to exclusively be, until recently when the Euro was added, the only medium through which international transactions can occur, are mostly hidden. That there is always a profit in it for the dollar, that it creates a huge market for U.S. Treasury debt, and the fact that it creates virtually a monopoly of control for the international bankers is well known.

What is not talked about is the fact that it also gives the bankers complete control of the value of virtually every nation’s currency. We are told that political factors and financial events create changes in the “market’s perception” of the peso, causing it to go up or down, or that the BSP is able to “intervene” by purchasing pesos, thus shoring up the price. The latter is allowed to occur for two reasons: to perpetuate the illusion that there is a “market”, and to capture, for literally zero investment, the reserves of the BSP. “Market perception” can be better read as the “discipline arm” of the London-headquartered bankers making sure the Finance and Central Bank people do exactly as they are told by the IMF/WB. Finally, manipulation of currency values destabilizes governments at the same time as it mortally wounds domestic banks and their major borrowers, usually the same corporations that employ most of the better-paid workers. Vicious and merciless, when the smoke clears the big banks gobble up the little banks and finance the foreign ownership of the nation’s best corporations.

It is much different when a nation’s currency is gold-based, and it gets better as more nations follow suit. There is no further need for the purchase and accumulation of foreign exchange (gold takes the place of foreign exchange in the nation’s financial architecture); payments made in the nation’s currency are directly acceptable by vendors in other nations. Without the need of foreign exchange, there is no further need of remittances from OFWs, or concern with “balance of payments”, or the nation’s “credit rating” since the nation will no longer have to borrow foreign money, which means that all of the constant squabble with the IMF/WB can be done away with.

The value of a currency based on gold cannot be manipulated by either the big banks or the currency traders/hedge funds. Granted that the price of gold is currently manipulated by “fixers” in London, the active use of gold as a currency base

in the amount of only a few hundred tons will soon remove the control exercised by that small cartel. The more nations using gold as their standard for issuance of currency, the more stable and less manipulatable will become the price.

INFLATION

For the greatest majority of the people in the nation, the major benefit of a gold-based currency is that it will not “inflate”. For these people the benefits manifest in savings accounts, insurance policies, and retirement benefits that hold their value, and in low interest rates which greatly enhance their ability to buy new homes and other things they need, and start or expand businesses and, for employees, salary increases are “real” and are not eaten up by rising prices for food, shelter, and transportation. As an example, the cost of housing at an interest rate of 14% is twice as much as at 4%. For banks, 4% is a very profitable interest rate in a non-inflationary economy (mortgages in the U.S. were typically 2% as late as 1950); it is the addition of the 10% to offset inflation that makes goods and services, and especially housing, so much more expensive, thus seriously hampering commerce.

At the beginning of this paper we alluded to many of the objections raised against the use of a gold standard, saying that we would return to the subject of “limiting” later in the paper. The reader, having studied the information presented so far, might wonder what REAL objection could any civic-minded person raise to the use of gold? The correct answer is, of course, none. **Those who do object, however, are those in power, the bankers and politicians. The Big International Bankers object to the use of gold because it limits three of their greatest sources of profit: (1) the amount of credit that they can issue, (2) their ratio of credit to reserves, and (3) the obfuscation created by inflation.**

Many readers will have sufficient background to see the contrast of fiat, baseless paper money with a gold standard from the point of view of a banker; however, since it is hoped that this paper will be read by good people who have not specialized in finance, we will expand each of those, albeit briefly. First, however, let us firmly establish that we are speaking of large, international banks such as HSBC, CitiBank, Bank of America, Standard & Chartered Bank, and virtually all of the others with internationally known names. We are not speaking of banks domiciled in this nation, even though some of the same greed and avarice may have bespattered some of them.

SOURCE OF MONEY

The Big Banks have, for a long time, “owned” the nations in which they claim domicile. They love and promote “democracy” because they can put their people in key positions and buy the loyalty of the legislators, judiciary, and key bureaucrats. With political control, and not constrained by the

impediment of a gold standard, they can issue new currency/credit for any purpose that suits them. They do not permit the “colonies” such latitude, however, preferring to issue credit to them so that the fruit of their labor can be drawn off in the form of interest payments. Thus the necessity to cause all of the people in the colonies to look to them as the source of all money.

RESERVE RATIOS

Domestic banks in “emerging” countries are required to hold two classes of reserves, “statutory” at 10% and “liquidity” at varying rates so that government (central bank) policy can influence the amount of money available for loans. In the Philippines, where there is P1.4T currency in the system, a 1% increase in the liquidity reserve requirement withdraws P14B from availability of loans, resulting (usually) in higher interest rates and more restrictive loan requirements. If the lending rate is only 10% (it probably averages twice that), we can see that the penalty paid by the domestic banks in one year would be a loss of P1.4B interest income for each 1% of increase in the liquidity reserve requirement. During the year 2000 the increase was at least 4% and many of the smaller banks have suffered net losses. **The objective seems to be to force smaller banks to merge into larger ones which can more easily be controlled by the international banks.** In the U.S. there is no “statutory reserve” requirement; only liquidity reserves are mandated and those in the 4-5% range. If a domestic Philippine bank can lend only 6 times its reserves (because it must hold 10% statutory and 6% liquidity reserves, 100% divided by 16% equals 6), how can it compete with a U.S. bank that can lend and earn income on 20 to 25 times its reserves? It cannot, of course; the playing field is not level and soon the U.S. banks will own the Philippine banks. That is what “globalization” is all about. **A gold-based currency does not just “level the playing field”, it moves the game to a different field where the rules are the same for all nations and all banks.**

INFLATION OBFUSCATION

“Inflation” is probably the favorite scare word of the bankers and economists. Like the word “love”, however, it has been used to mean, and to describe, many different conditions. A classic definition once was, “Too much money chasing too few goods”, the presumption being that mismanagement by the central bank has allowed too much money/credit into the nation’s system, diluting the value of its currency. That is a useful definition when speaking of conditions within one nation but is not helpful when international trade is involved. For example, the Philippine peso a year ago was valued at 40 per 1 U.S. dollar (currently [December 2000] the international standard) and is now valued at 50 per dollar. If there was nothing imported into the nation,

there would be no impact upon the citizens. But as materials and goods are imported, their prices will be 20% higher and those price increases will flow through to the citizens, raising prices, which will be called “inflation” but which will have nothing to do with the money supply. Confusing? Sure, meant to be. Bankers will say, “If prices rise 20% in the next year, we have to charge 20% plus our costs and at least a bit of profit,” which means that interest rates will be so high very few businesses will be able to borrow and pay their required interest. New businesses and expansion plans of existing businesses will be put on hold; having no loan business causes banks to fail or merge, unemployment will balloon; unemployed people cannot make mortgage payments so must sell their homes or see them foreclosed by the banks, and real estate values, which are the basis of most banks’ reserves, will plummet, delivering a second blow to the domestic banks.

SOME OF THE BENEFITS

All of these disastrous effects are eliminated by the widespread use of gold-based currencies; they are greatly mitigated in any single nation using gold. To enumerate the benefits of gold-based currency:

1. The “price” (value) of a nation’s currency cannot be driven down by the phony “selling short” by currency traders because the value of the currency is a function of the price of gold. Of course, at this time when nations are not using gold upon which to base their currencies, the price of gold can be (and is) manipulated by the London “fixers”, just as are the values of nearly all currencies.

(Please take note that platinum, which has for decades been priced practically in tandem with gold, a \$10 per ounce differential being recognized as a “trading opportunity”, is now priced at more than \$600 per ounce while gold is held to \$270. This should indicate where gold will go once it breaks loose from the manipulators, again the same Big Banks that are holding it, and silver, at low levels to facilitate their derivative games.)

2. Gold-based currency does not “inflate”. If a central bank follows the rules, it will purchase gold with the new money/credit it issues, after which it may authorize its domestic banks to issue lines-of-credit (LOC) to their borrowers (based upon the gold as collateral) who must be prepared to demonstrate and follow through with the completion of money-making projects with which to pay back the loans made via the lines-of-credit. The effect is an ever-increasing stream of gold into the banking system, thus stabilizing and strengthening the value of its currency world-wide.

3. As a nation increases its reserves, it can increase the currency in circulation. Having said this, we can expect the paper money promoters to gleefully point out that this is what is meant by “Too much money chasing too few goods.” In a world in which the Filipino had the same amount of currency with which to work as his American counterpart, that would be true (if both currencies were gold-based). In the real world, wherein the Filipino has

the equivalent of \$347 as compared to the American's \$22,000, the Philippines obviously has some "room to grow". The Filipino suffers every day from the effects of "manufactured" (false) inflation; it will be a long time, if ever, before he suffers from real inflation.

4. As soon as domestic bankers can recognize that the money they get back in one year, or five years, will be as valuable as the money they loan today, interest rates can come down very substantially, to no more than 4%, and mortgages can be even lower. The effect upon home building, home sales, new businesses and expanding businesses will be no less than electrifying, creating an optimistic, ebullient environment in which employment opportunities exceed the supply of labor and "upward mobility" for working people becomes a reality, not just a dream.

We must emphasize that the GAIA asset is not intended as a rescue vehicle for "governments", although, implemented properly, it will accomplish that. It is God's gift to His PEOPLE who, in the "end times" as you might recall, "inherit the Earth". A more "earthy" way to say it might be: If we are to benefit from "globalization", then we must all benefit, not just the formerly recognized "colonial powers" who are now simply practicing a more sophisticated form of colonialism while calling it globalization.

The GAIA program places its DEEDS OF ASSIGNMENT FOR CONSIDERATION through a Joint Venture Partnership Memorandum of Agreement with Project Proponents so that the funding flows directly to the project and is not quite so subject to the political and bureaucratic nibbling of its corpus before it reaches its intended beneficiaries. Because a large majority of the projects are scattered throughout the provinces, as they get their funding and begin to hire people, the people can begin to leave the overcrowded cities to work at or near their homes, and thus the cities benefit also.

NOT ENOUGH GOLD?

It will be said by gold-standard critics that there is not enough gold to allow all of the nations on the planet to use it as a standard for their currencies. One somewhat superficial answer to that position is that if the 1.05 billion ounces of gold currently reported to the IMF as being held by all reporting central banks were to be priced at \$100,000 per ounce it would be worth \$105 trillion, far more than all of the money currently in circulation. A much more accurate answer, however, is that the satellite maps show that there is enough gold in the Philippines alone to satisfy the need. Further, it is well known that, during the administrations of Presidents Ronald Reagan and George H. W. Bush, President Marcos shipped thousands of tons of gold to some 50-plus countries for the purpose of putting all nations on the gold standard as part of the "New World Order" being promoted at that time. That gold still exists, even though a large part of it may have been confiscated by the

Big Banks in which it was stored. No matter, however, because the claim of Global Alliance Investment Association is inclusive of all gold held by the owners of the Federal Reserve System, who are those same Big Banks and thus the owners of those Big Banks, the Rothschilds, Warburgs, Salomons, Rockefellers, etc. That gold is the basis of the GAIA asset, which it offers to share with project proponents who will work to achieve the funding of the DEEDs.

FOREIGN CONTROL

Through their control of the IMF the Big Banks can dictate policy to all of the Central Banks of nations that have taken IMF or World Bank loans. Time after time the IMF has reneged upon finishing loan programs to the Philippines due to "an oversupply of pesos". That means the BSP issued more currency/credit than its IMF agreement would allow. It also confirms that the Republic of the Philippines is a sovereign nation in name only; others dictate its economic policy. Sovereignty can be regained through a series of actions, which will be carefully outlined in this paper, by the kind of determined leadership that now exists in Malaysia and could exist in the Philippines if any one of several dedicated patriots were to declare their willingness to work closely with GAIA to reestablish the value of the currency, pay off the foreign debt, and allow the PEOPLE to prosper. As long as the leadership here follows the example of the colonialists in keeping the people down through poverty, or to hold the nation in bondage to other nations, there can be no significant help expected from GAIA, and all other "help" will only deepen the problem because it adds to the nation's debt, draining away more and more of its reserves and choking its commerce.

Because of that IMF/WB control, many nations are afraid to assert their sovereignty to use the GAIA program to pull themselves out of debt and get their currencies on a solid gold base. There are many rumors of threats of "sanctions" and other dire consequences to a nation daring to stand up to the IMF/WB. Other nations are controlled through the use of pay-offs to key people in high places. It is well known that 20% of the interest paid by nations to the IMF is used by the IMF for such purposes. How many administrations will forego such personal perks to bring prosperity to their people? Sadly, GAIA has found none so far; however, we recognize that Malaysia escaped the trap in spite of Anwar Ibrahim's deliberate attempts to sell them out but we must observe that even Malaysia has not yet gained its sovereignty; it is still borrowing money from foreign sources and continues to court foreign investors, neither of which it really needs. With GAIA's program it would take only one additional step to permanently free Malaysia from the debilitating drain of foreign ownership of its companies, properties, technologies and natural resources.

USE IS THE ANSWER

The GAIA agreement with the U.S. Treasury has been published and is a part of every information package that we supply to DEEDholders. There will be no interference with any bank using the GAIA DEEDs as reserves; it just requires a real BANKER to use it. Once it is in use, life will become much more pleasant for the IMF/WB people.

COMPETITION, THE MYTH

Before we can begin to detail the precise "way out", we must debunk at least one more myth, the myth of "competition". In 1920 the U.S. industrialist Henry Ford commissioned a two-year, very in-depth study of the economic and political conditions because he was experiencing difficulty obtaining and/or maintaining loans at competitive interest rates coupled with an inordinate number of labor problems. The investigation cost more than \$1 million, a sum worth more than \$25 million in current dollars. When the results began to take form, he decided that they must be published, but the Detroit, Chicago and New York newspapers all declined the material. So he purchased a newspaper called the *Dearborn Independent* and published it as a continuing series in the newspaper and then, later, as a two-volume set of books titled *The International Jew*. Mr. Ford was eventually forced to reach an accommodation with a clique of businessmen and bankers and his businesses were, to a major extent, lost to his control and, after his death, that of his family. The important enlightenment gained was, of course, the information gleaned by the Ford investigators.

What they learned was that, through the use of an extensive network of banks and brokerages, and the use of cross-directorships of hundreds of corporations, a small group of financiers had gained control of the major newspapers, the movie industry, the tobacco and liquor businesses, the oil and steel industries, the shipping companies and railroads, most of the manufacturing companies, and huge amounts of real estate properties in all of the major cities of the U.S. What they couldn't control through direct ownership, they could control through economic coercion and the fomenting of labor problems, since they had organized and controlled the unions.

The most disturbing information that Ford uncovered, however, was the extent of the control exercised by the same group over the "democratic" election process, resulting in the placement of their people, or people designated by them, in the legislative, judicial and administrative branches of government at the highest levels. The "voice of the people" had been stilled, and let us remind the reader, that was in 1920.

A logical question would be, "Why don't the people boot the rascals out and take back their country?" The answer is that most of the people do not know the truth and could not get themselves organized if they did. With tools like the FBI and IRS, and other police-type organizations less known,

those in power in the federal and state governments can keep dissenters so occupied with defending themselves that they are unable to get on the offensive. Even if they could, those in power control the money, the communications, transportation and virtually all munitions—so there is little chance that the problem will be solved in that way, even though the real controllers number in the few thousands and could not remain in power more than a few hours if their paid lackeys were to turn on them.

What does that have to do with the Philippines and competition? Far more than we have space to reveal here; the most important point is to recognize that the Big Banks, the small group of people controlling the U.S.A. and virtually all of the developed nations, have the organization and dedication to make, and change, the banking and brokerage rules to suit themselves, and to assure that those rules are inculcated in all your students of economics, brokerage, and banking. One of those rules is, “To be a successful (student, businessman, business, nation, etc.), you must be competitive.”

That nations must compete with each other for loans and foreign investment money is probably the greatest and most expensive hoax ever designed, developed, and foisted off upon the unsuspecting so-called “developing nations”.

That the hoax is accepted by Filipinos is easily demonstrated. In a group discussing business, when the subject of funding for a project comes up, what is the instant, automatic, and universal response? “Where can we get the money?” The brainwashing has been so effective that all eyes turn outward—to the U.S., Japan, Europe, Hong Kong and Singapore, never thinking to look inward where the real money is.

Please be reminded, when your money is gold-based you do not need foreign exchange. That one fact frees the nation from any further need to be “competitive”. If you are good at making electronics, make good ones and sell them to others at a fair price. If you make clothing for export, make quality goods and sell them to others at a fair price. The world will be changing toward quality first, price second—so, if you must compete, do it in a way that elevates and sustains your self-esteem and joy in doing what you do very well. If you run a company, give at least 75% of your effort and attention to your people; you will never have to scrimp and save on their pay and benefits again. Instead, you can concentrate on their training and upward mobility so that your company becomes a magnet for ambitious and dedicated workers. Capitalize on the positive effects of your competitive drive. God will be watching.

STOCK AND BOND MARKETS

One last item concerning competition: The stock markets. Over the years the Big Banks and Brokerages have turned the world's stock and commodities markets into giant casinos wherein they always have the position of the “House” because they can make, and change, the rules. They have invented and introduced “new products” by the dozen

till only they can remember how to turn a profit with each one. They have common stock, preferred stock, convertible stock, Class A, B, & C stock, voting and non-voting stock. They have bond types, rates, and maturities by the bushel: straight, convertible, sinking-fund, zero-coupon, tax-free, and on and on. They have partnerships, limited partnerships, real estate investment trusts and mutual funds by the thousands. And finally, and so far the worst, they have derivatives, an illusory device that can allow them to borrow (leverage), with the connivance of a bank or group of banks, as much as 2000 times the money they have as collateral. Quite often their collateral is gold, leased from some central bank whose uninformed Board Of Governors, in the spirit of competition, are striving to make money with the central bank's reserves. (No central bank should ever be allowed to make a “profit”. A central bank is a necessary public service, not a “profit center” to be manipulated by foreigners, i.e., the Big Banks.)

The whole stock market idea has been perverted into a trading market designed to steal the money of honest investors and the companies of honest entrepreneurs; any person bringing his new, fresh money to the typical stock market is 99% sure of losing some, or all of it.

A properly structured and managed stock market would be a wonderful device through which to permit the people to participate in the ownership and profitability of the company for which they work. Stock is a useful means of raising capital to start or expand a company. Bonds can pay higher rates of interest than banks to dedicated “savers”, and they deliver a more dependable stream of income than stocks when that is the need. The structural changes needed to turn a casino stock market into a marvelous vehicle to fetch even the poorest of the poor into ownership and participation in a more modern society are very few. (1) All foreign ownership should be excluded and, as soon as feasible, by using the GAIA collateral the corporations can begin repurchasing their stock for later distribution to their employees. (2) Stocks and bonds should not be used as collateral for a loan—ever—but especially not to purchase stock, i.e., no pyramiding. (3) Stock should make a profit for its owner only when it rises, and so-called “short sales” to make money because a stock declines in price should be prohibited. Those three simple changes will eliminate as much as 90% of the skullduggery from a domestic stock market and cause the departure of most of the dishonest brokers and traders.

BSP & GOLD

The best way to illustrate exactly how the GAIA program works is through an example. Let us suppose we wish to construct a high-rise office building for \$100M (P5B) that will earn, with 80% occupancy, \$15M (P750M) per year. We find the money in Singapore. At 10% interest for 10 years the annual payment will be \$16,274,539 and for 20 years \$11,745,962, so we must select the 20 years. That means that we will have \$3,254,038 per year for

operation and maintenance (plus or minus occupancy if it differs from 80%) and we will send nearly \$12M to Singapore each year. At the end of 20 years we will have sent away \$235M (P11.75B) and retained \$65M (P3.25B).

So as not to stretch the minds of the readers too much too soon, let us begin with an easy, but very necessary concept. The Philippine central bank, usually referred to as the BSP, has a gold buying, refining, and storage facility. If a property owner were to find a 75-kilogram bar of gold buried on his property, dug it up and took it to the BSP buying station, he would be paid for it, 90% right away and the balance in a few days, after refining revealed the exact value. At the current price of \$270 per ounce a 75-kilo bar of 22 carats should bring almost P30M so, in effect, the BSP writes the owner a check for P30M which the owner can spend, injecting P30M new currency into the money supply.

This is the part that might require some thought. The central bank now has 75 new kilos of gold in its vault, which it owns and can use as an addition to its reserves. Because it used the new money it issued to buy gold, it has not violated its loan agreement with the IMF. The money supply is P30M larger and the BSP has P30M more reserves, all at what cost? We might say, “None,” but that would not be quite accurate. The check, the ink to sign the check, and some bookkeeping time to record the addition to reserves might cost as much as P100. But would it cost more to buy, say, 1000 75-kilo bars? No. The cost would still be about P100 but the addition to BSP reserves would be P30B. Whoa, now this is getting interesting, even to BSP. How far can this go? Are there any limits? Sure, the gold available. BSP has to have gold to buy.

We are told of fabulous caches of gold off in the jungles, guarded by hundreds of “natives” in mostly NPA territory. We don't know much about those but we have good information that the satellite maps show plenty of gold and that the U.S. worked hard to get a Visiting Forces Agreement and that the U.S. military and CIA are racing madly to collect all of the gold they can. Are they paying for the gold? If they are it will be in fiat, baseless paper money.

If it is such a good deal for BSP, why don't they get busy and go buy the gold? Because the holders of the gold refuse to do business with BSP, or any other part of the government, having had their gold confiscated, taxed, not paid for, and some being thrown in jail. Word gets around.

HOPE

Is there a solution? Yes, but it requires the complete and consistent cooperation of the government and BSP with a third party, in this instance, GAIA. Many of the natives (indigenous people) are very spiritual and have known that God would send an answer to their prayers. We know this because many of them have come quietly to visit us here. Once GAIA has the complete and unqualified guarantee of the government that it will deal fairly with the people, including amnesty where needed, GAIA will issue

a DEED to the holder of the gold in an amount equal to or slightly greater than the value of the gold to be sold. That serves as a bond, or insurance, that, should the gold be lost, the holder will ultimately be paid. With some of the risk, and fear, removed, the gold should begin to trickle in.

Here comes the hard part for BSP. GAIA will make the transactions possible, and will also make possible a transition to a marvelous national prosperity as a result, but not without just compensation. Recalling that the cost to BSP (and the government) is P100 per transaction, for BSP to come away with 50% of the gold when it cannot buy it in any other way, should not be difficult to accept. Is it “greedy” for GAIA to require 50%? Not at all. It depends upon what GAIA does with its 50%. If GAIA sticks to its published plan, which it must to retain its reputation for unblemished integrity, it can draw a maximum of 20% of the value of its gold to be used to further its program around the globe, leaving 80% on deposit with, and on lease to, the BSP as additional reserves. No real value is lost to the BSP except that, should the price of gold rise, the increase in value of its gold will inure to GAIA.

A second hurdle for the government/BSP is to take a rational approach to so-called “treasure”. The Big Banks teach that treasure belongs, at least 75%, to governments. No. All that does is to cause treasure to go “underground” (or remain underground or under water) and turn honest people into criminals. Why would an intelligent government fight its citizens, foregoing most of the value of treasure, for 75% when it can have 100% at no cost and bask in the gratitude of its citizens? All it has to do is to buy the treasure from its citizen-holders, at full price, at no cost because it can issue new money for that purpose. It gets double the benefit because the new money is added to the money supply in a healthy way.

Standing back a moment to view our position, let us recap. In a short time, weeks, not months, gold should be flowing into BSP and pesos should be flowing out to the people. Seeing that, and knowing that it will not be long before the Philippines is in a position to easily pay its interest, if not its entire debt, we think it quite likely that the IMF and World Bank will begin to quietly reduce their presence here. Regardless, as soon as the gold begins to flow in, the second part of the GAIA program can be implemented. To describe that we should now return to our office building example.

THE GAIA PROGRAM

Using the GAIA program, we would first multiply the amount we need, \$100M, by 2.5 (\$250M) so that our 50/50 joint venture will yield \$125M worth of gold to the project proponent and \$125M worth of gold to GAIA. The joint venture partner (JVP) wants \$125M worth of gold as security for its line-of-credit (LOC) so that it has a 20% “cushion” with the bank. The bank may also hold the property and will no doubt, at least in the beginning, want the project as additional collateral, even though the gold should be completely sufficient.

(So as not to offer a lot of boring details, we are ignoring some of the incidental costs that would be properly handled in a live transaction.)

The JVP would take the DEED (for \$250M) to the President of his bank, or to a specially designated officer who has been made familiar with the GAIA program. The JVP would present his corporate and project papers, feasibility study, and all of the other loan documents needed by the bank. When those are all in order, he presents his DEED as ADDITIONAL SECURITY. He requests that the bank use the DEED as its reserve against which to purchase \$250M worth of gold, which equals some 30 metric tons. The likelihood of the bank wanting to move and store 30 tons of gold is not too great, so BSP will probably issue two Warehouse Receipts for 15 tons each to the JVP and GAIA to be held by the bank in lieu of the physical gold, and as security for the lines-of-credit it will issue to the JVP of \$100M and to GAIA of \$25M.

Let us pause here to examine the position of the bank. It has the project (perhaps limited to the value of its real estate) and the DEED as additional reserves. It pledged the DEED to BSP for money to buy the gold and the gold has come in as reserves so the bank still has the project value plus \$250M worth of gold as security for lines-of-credit totaling \$125M. That is a 50% loan-to-value ratio, based upon gold, and bankers usually only get to dream of such great transactions. In the case of default on the part of the JVP, the bank does not have to foreclose on the project and then try to salvage what it can. It simply forecloses on enough of the JVP's gold to satisfy the outstanding balance owed on the LOC and turns the remaining gold over to the JVP. A more likely scenario is that the project pays as agreed and when the loan is all paid off the gold belongs to the JVP, free and clear. The JVP can sell it back to the bank or BSP, or use it again for another project. Another possibility is that gold goes up in price enough that a portion can be sold to reduce or eliminate the debt early. It should by now be dawning on the reader that, in arranging for the funding and purchase of the gold, the JVP has earned its 50%, in this case, 15 tons of gold. It is at this point that the pundits start smirking, “Too good to be true!” GAIA hopes that all of those people giggle and go away; we need to do business with intelligent people who look upon life positively.

WHICH IS BETTER?

Now we should look at our project to see if this is a better way. We know that interest rates will come ‘way down’ in a gold-based currency environment but for purposes of comparison let us leave the interest rate at ten percent and the maturity at 20 years. That means the payment remains the same, the difference being that the payment is now going to a Philippine bank, adding nearly \$12M (P600M) to the local economy and enriching the nation by \$235M (P11.75B) in 20 years. Another silly, thoughtless lament we hear quite frequently is, “But our banks can't do this, they are too small.” The truth is that the smallest

rural or cooperative bank can do this as easily as the largest. What happens is that the bank ends up with an increase in its reserves of 50% of the amount of the DEED. For a small bank, that should represent instant success.

THE RETURN OF SOVEREIGNTY

At page 3 we spoke of returning sovereignty to the Republic of the Philippines. Much of the work of doing so is already accomplished. More than 1200 DEEDs are in the hands of corporations, foundations, associations, and multi-purpose cooperatives. **What needs to be done first is really quite simple—an order from either the President or the legislature affirming that the GAIA DEEDs are to be treated as any other U.S. Treasury debt within the banking system. The banks already know how to handle U.S. Treasury debt as bank reserves.** Then another order from the President to the PNP and AFP instructing them to provide high-priority safe passage to citizens delivering gold to a BSP buying station, which order should include an instruction to BSP to accelerate gold processing and to treat each citizen delivering gold as a personal emissary of the President, i.e., quick, courteous service, no questions asked, plus assistance in the opening of new bank accounts if necessary. Peace will descend upon the archipelago like a soft, warm rain because the people will be too busy to bother with “revolution”.

When EVERYONE in the Philippines understands what God is offering, EVERYONE will be scouring the hills and jungles for gold, and the Philippines will become the Pearl of the Orient Seas, the Pride of the Pacific, the Switzerland of Southeast Asia, and all of those other appellations so long missing from our expectations. The only limit on the program is the amount of gold, and there are some 175 other nations, large and small, that will need gold. God is abundance, not poverty, and this is God's plan. Puny men, even robust men, cannot think and plan such a grand plan—only God/Aton/Allah, the Lighted God, can bring such plan and put it in the exact place where it can be birthed.

Each step taken now is that learning experience which allows us to FINISH this task, protect our position and our product—as well as bringing abundance to the graduating passengers who must run the transportation system, from corporations to diversification, WHILE STRUCTURING A WORKING ORGANISM. CFR FORECAST TEMPLE MOUNT BLOODBATH

By Scott Thompson

For over 20 years, U.S. military and intelligence circles have known full well that actions such as Israeli Gen. Ariel Sharon’s Sept. 28 invasion of Al Haram Al Sharif (also known as the Temple Mount) in Jerusalem could lead to war.

In 1988, the scenario was already fully developed in the book *Jewish Fundamentalism in Israel: For the Land and the Lord*, published for the New York Council on Foreign Relations (CFR) by Ian S. Lustick, now a Professor at the University of Pennsylvania. Lustick has a long background in intelligence work. He began his study in 1979-80, when he worked as a CFR Fellow at the State Department’s Bureau of Intelligence and Research. He later wrote a study on the issue for the Defense Academic Research Program of the U.S. Department of Defense.

Lustick’s CFR scenario outlines how the plans of Jewish radical sects, such as the Gush Emunim, to rebuild Solomon’s Temple on Al Haram Al Sharif, could ignite nuclear World War III. The best-case scenario to be expected would be a protracted bloodbath, such as the Thirty Years’ War. The following are excerpts from the book (the subhead and emphases have been added):

“Some leading rabbis have used recent archaeological finds to eliminate religious restrictions against Jewish entry onto the Temple Mount. The most influential of these has been former Army Chief Rabbi and AshkeNAZI Chief Rabbi Shlomo Goren... Partly as a result of these developments, *partly as a result of the desire by many in Gush Emunim to do something so decisively repugnant to the Arab world that peace negotiations would forever be prevented*, and partly as a result of the very logic of the fundamentalist ideology, the Temple Mount issue has emerged from the realm of crackpot utopianism to occupy a central place in the political activity of the Gush Emunim...

“[The journal] *Nekuda* published two editorials in 1985 and early 1986 warning of the radical and violent steps to be taken by Jewish fundamentalists if the government did not act swiftly to change the status quo: ‘Those in government and the Chief Rabbinate who pay only lip service to the basic rights of the people of Israel to the Temple Mount ... must bear responsibility for the fire liable to erupt... which, God forbid, may ignite a *terrible religious war*, whose echoes would reverberate from one end of the Earth to the other.’ ...

“Nonetheless, according to prominent Israeli newspaper columnist Doron Rosenblum, the destruction of the Muslim shrines on the Temple Mount is ‘only a matter of time’. The aftermath, as he predicts, will be horrible:

“... The immediate cancellation of the peace agreement with Egypt [**H: HUMMNNNN!!!**]; ... spontaneous ‘demonstrations in every Arab country; ... mobilization of reserves amidst reports of tensions on all four fronts; the flow of Egyptian forces into Sinai; firing in the Golan and the Jordan Valley; dogfights with Iranian, Saudi, Libyan, Iraqi, and Syrian planes; ... rumors of the massacre of Syrian Jews; ... guerrilla war in the occupied territories between Arabs and settlers; ‘massacres’ that will be called total anarchy; intervention by the superpowers and war that will go on for months or even years.’ ...

“No event is more likely than a government-supported fundamentalist initiative aimed at **Judaizing the Temple Mount** to achieve a profound realignment of public attitudes within Israel, to precipitate an eminently crushable armed revolt in the occupied territories to disrupt the Egyptian-Israeli relationship, and to distance Israel, politically and culturally, from the entire gentile world. ...

“Should a Labor Party victory appear imminent, or even possible, however, the vanguardists within Gush Emunim will again seek to preempt the political process by raising the banner of the Temple Mount. ...

“Washington must seek ways to prevent the explosiveness that surrounds Jewish fundamentalism from being unleashed. ... In Israel such a crisis would almost certainly involve repeated demonstrations by hundreds of thousands of Jews, violence against both Jews and Arabs, challenges to the authority and legitimacy of the government, ... the creation of scores of new illegal settlements, *threats of civil war*, a sudden influx of militantly ultranationalist diaspora Jews and, as suggested above, attempts at spectacular actions such as the destruction of the Muslim shrines in Jerusalem. ...

A BREAK-AWAY ISRAEL SCENARIO

“Israel is, indeed, so deeply divided on key territorial and ideological issues, and has such a short and essentially untested tradition of constitutional democracy, that successful challenges to the regime cannot be ruled out. The most often discussed scenario of this sort is that of popular but unscrupulous right-wing politicians joining with ambitious military commanders to ‘restore order and sanity’ amid chronic, polarized, and increasingly violent intra-Jewish struggles. ...

“An Israel decoupled from the United States, opposed by the norms of liberal democracy, animated by redemptionist imperatives, and *disposing of a large and sophisticated nuclear arsenal*, would pose challenges to American foreign policy and security interests at least as profound as those resulting from the Islamic Revolution in Iran. *The United States thus has a strong interest in finding effective ways to support those inside Israel who are struggling against fundamentalism.* ... Washington should stress ... the extent to which our friendship and support ultimately depend on ... shared values—values we can directly portray as *unrealizable in the ‘Greater Israel’ [‘Eretz Yisroel’]* to which the fundamentalists aspire.”

Lustick’s scenario, first published in 1988, is an almost exact forecast of events that occurred since Sharon’s march on Temple Mount. The CFR, along with the Defense and State Departments, have long known what the effects of such policy would be, just as David Ben-Gurion had issued such warnings about Zionist fascism. But even worse, Wall Street and elements of the U.S. government helped bring the bloodshed about.

THE CABBALA: GNOSTICISM,
FREEMASONRY AND RELIGIOUS WAR

On Oct. 4, 1995, a group of Cabbalists gathered outside the home of Israeli Prime Minister Yitzhak Rabin, and pronounced upon him the ancient Cabbalistic “curse of death”, the *pulsa denura*, to be executed within 30 days. Exactly 30 days later, Rabin was dead, killed by Yigal Amir, a young fanatic under the influence of the teachings of Rabbi A.I. Kook. Amir’s act had been approved beforehand by a group of Cabbalistic rabbis.

The following month, Prof. Giuliano di Bernado, the British-sponsored head of Italian Freemasonry, established the “Jerusalem Lodge” of Freemasonry, in the ceremony near the Temple Mount. He told an interlocutor, “I try to show the way in which the *Cabbala* may be considered the **Utopia** for the Third Millennium.” He said that his new lodge was committed to the near-term “*material* rebuilding of Solomon’s Temple”, based upon the *Cabbala*.

The ancient Gnostic heresy, the *Cabbala*, is the “red dye” by which one may trace the assassins and would-be Temple builders from the streets of Jerusalem and the occupied Territories, **back to their controllers in the elite freemasonic lodges in Britain, run by the Duke of Kent on behalf of the house of Windsor—those who are now unleashing a new Thirty Years War in the Middle East.**

Created in Babylon during the first two or three centuries after the birth of Christ, the *Cabbala* was constructed upon the alleged mystical properties of the 22 letters of the Hebrew alphabet, and the ten “*Sephiroth*”, or “emanations of God” (as depicted in the Cabbalistic *Tree of Life*), which, combined, yield a mystical “32 paths” to redemption. In fact, as *Cabbala* proselytizer Rabbi Herbert Weiner admitted in his 1960s book on the subject, the *Cabbala* is a Gnostic assault on Judaism, which revived the Satan worship out of which Judaism and Christianity had uplifted mankind: “This feeling for the reality of evil and power of the demonic found its expression through the *Cabbala*, which also became a vehicle for the reentrance into Judaism of old pagan superstitions, theurgic rites, and Gnostic heresies.”

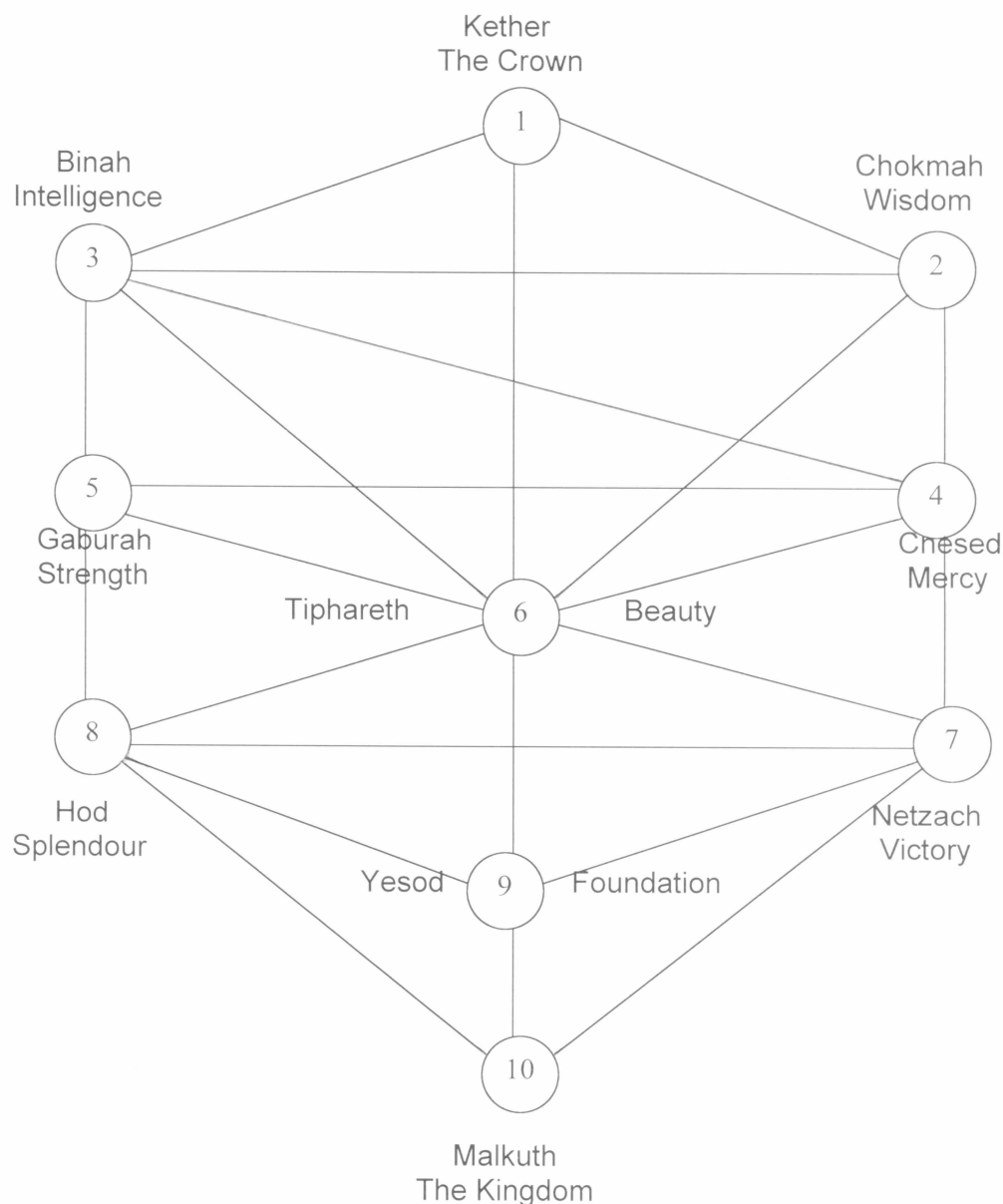
[H: Please go back and read that again!]

Beginning in the 16th Century, the financier oligarchy of Venice, which city had already been for centuries the world’s most evil and powerful financial center, sponsored a revival of the *Cabbala* as part of its deployment of mysticism and religious warfare against the Christian Platonic method which had given rise to the Golden Renaissance, and to the new institution of sovereign nation-states. A member of one of the oldest families of Venice, Francesco Zorzi, who specialized in religious warfare, and who played a key diplomatic role in 1508-09 in breaking up the anti-Venice League of Cambria, in 1525 wrote a book, *De Harmonia Mundi* (*Harmony of the World*), based upon a “Christian” form of the *Cabbala*. Zorzi claimed that Solomon’s Temple

was designed by the “Grand Architect of the Universe”, and that it held all of the mystical secrets of creation.

ZORZI BRINGS THE CABBALA TO ENGLAND

Zorzi personally transplanted these Cabbalistic ideas to England, when he served as the chief “divorce counselor” for Henry VIII, encouraging the king to dump his queen, Catherine of Aragon, the daughter of Ferdinand and Isabel, the monarchs who united Spain. The divorce, in favor of the temptress Anne Boleyn, split England from the Catholic Church, and ushered in the “English Reformation”, and bloody Catholic-versus-Protestant fights in England and on the continent, including England’s wars with Spain. As reworked by

John Dee and others, Zorzi’s *De Harmonia Mundi* gave birth, in 17th-Century Britain, to all of **modern Freemasonry, whose very name commemorates the Phoenician masons who originally built Solomon’s Temple. The 32 paths of the Cabbala became the ascending degrees of freemasonry, up to the highest, 33rd degree.** Zorzi, who was fluent in Hebrew, also propagated a new, messianic, apocalyptic form of Judaism, based upon the *Cabbala*, which stressed the near-term appearance of the Messiah, and the rebuilding of Solomon’s Temple. Zorzi’s messianic *Cabbala* gave rise, under venetian sponsorship, to the first movement in more than 1,400 years to return Jews to Palestine; it also gave rise, centuries later, to Rabbi A.I. Kook.

In 1884, the Prince of Wales (later King Edward VII), the Grand Master of world freemasonry, initiated a *Cabbala*-centered world revolution in freemasonry” (as the masons themselves called it) by founding a “special research lodge”, the Quatuor Coronati (“Four Crowns”). The first Grand Master of the lodge, Sir Charles Warren, had been the chief engineer for British excavations of the Temple Mount two decades earlier and was the head of the Palestine Exploration Fund (PEF), a front for British military intelligence. The PEF employed such legendary figures as Lord Kitchener (“of Khartoum”) and T.E. Lawrence (“of Arabia”) and was founded, in the words of Warren, “with the avowed intention of gradually introducing the Jew, pure and simple, who is eventually to occupy and govern this country.” The PEF is active today and has sponsored two of the three major theorists on the subject of “where the Temple really stood”, including the Quatuor Coronati’s Asher Kaufman, and is reissuing Warren’s original reports on his excavations of the Temple Mount.

The speech inaugurating the Quatuor Coronati Lodge was entitled “Freemasonry as Seen in the Light of the *Cabbala*”. The new lodge, with its emphasis on Palestine and the *Cabbala*, was a key component of the British strategic policy to establish a British Jewish protectorate in Palestine, to protect the pathway to India, the “jewel of the British Empire”.

This 19th-Century, British freemasonic-sponsored Cabbalistic revival took two forms: one “secular” and one “religious”. The secular was the “mystical nationalism” typified by freemasons such as Giuseppe Mazzini, one of whose adherents was Vladimir Jabotinsky; and the second, the apocalyptic religious mysticism of Rabbi A.I. Kook. Both are deployed against the modern sovereign nation-state, on behalf of the British Empire.

VLADIMIR JABOTINSKY

These two Cabbalistic sons of one British mother, came together in Kook’s collaboration with Jabotinsky in Jabotinsky’s British-sponsored Jewish Legion project during World War I, and again in 1934, when two of Jabotinsky’s Revisionists killed the leading labor Zionist of the day, Histadrut leader Chaim Arlozoroff, and Rabbi Kook became the chief public voice defending the murderers. Likewise, the terrorist Stern Gang and Irgun of the 1930s and 1940s were almost entirely composed of followers of either Kook or of Jabotinsky. Sometimes, the same individual embodied both Cabbalistic currents, as did David Raziel, the head of the Irgun (Jabotinsky’s armed followers) from 1936 until his death in 1942, who was trained in Kook’s Merkaz HaRav yeshiva. Raziel also embodied the higher-level control which deployed both Kook and Jabotinsky: Raziel died in 1942 while on a mission to Iraq for British intelligence.

Rabbi Kook and his followers always rejoiced at the prospect of a religious conflagration, as Kook outlined in his major work, *Orot*: “The Truth Concerning the Land [is] Revealed in *Cabbala*. Jewish Mysticism (*Cabbala*) militates for life in the Land of Israel. Rationalistic approaches to Judaism place no special value on the Land of Israel. In wars, national characters crystallize. Israel, as the universal reflection of mankind, benefits thereby. The heels of Messiah follow upon world conflagration. ... **At the hour of the downfall of Western civilization, Israel is called upon to fulfill its divine mission by providing the spiritual basis for a New World Order.**” [H: AGAIN, PLEASE.]

With this mind-set, Rabbi A.I. Kook’s son and successor, Rabbi Zvi Yehuda Kook, was ecstatic about the Six Day War of 1967 in which Israel captured East Jerusalem. Immediately after that war, the Quatuor Coronati Lodge sent its agent, Asher Kaufman, to Jerusalem to begin studies on “where Solomon’s Temple really stood”—while Kook’s Merkaz HaRav yeshiva soon gave birth to the entire West Bank settlement movement, as well as to yeshiva Ateret Cohanim, set up to train priests for a rebuilt temple. Ateret Cohanim was headed by Rabbi Shlomo Aviner, a leading student of Rabbi Kook and an agent of Israel’s domestic intelligence service, Shin Bet.

The plot to rebuild Solomon’s Temple, and to unleash a religious war beyond imagination, had begun in earnest.

THE CASE OF RANDALL PRICE
INSANE FUNDAMENTALISTS IN U.S.

SEEK WORLD WAR

By Anton Chaitkin

Texas-based Armageddonist J. Randall Price is a leading advocate among nominal Christians now urging a mad descent into a Jewish-Arab conflict which, they hope, will bring on the end of civilization.

The filthy ties of Price and similar American “fundamentalists” to Masonic and intelligence circles in England, and to the British-controlled Jewish fundamentalists in Israel, are reflected in Price’s books, including *Ready to Rebuild: The Last Days Temple and The Lost Ark* and *The Last Days: in Search of Temple Treasures*, which we review below.

Today’s American fundamentalism originated with the Rev. John Nelson Darby, the 19th-Century Englishman whose work was a plaything for British Crown geopolitics. Darby (named for his godfather, Lord Nelson, the naval commander of Darby’s admiral-uncle) created the dogma known as “premillennial dispensationism”; Darby first described the so-called “Rapture”.

[H: PLEASE PAY ATTENTION; THIS IS AS SERIOUS AS IT CAN GET IN INTENTIONAL “MIND WARP”.]

Darby wrote that the physical movement of Jews to the land of Israel would herald the second coming of Christ, and identified Russia as the anti-Christ nation, “Gog”, fighting in the Apocalyptic conflict.

This political doctrine was made-to-order for British propaganda aims in setting up a British-run Jewish enclave in the Middle East, and for keeping Tsarist Russia out of the region. British Foreign Minister Palmerston’s son-in-law, the 7th Earl of Shaftesbury, published his *State and Prospects of the Jews* in 1839, at about the same time as Darby’s *The Hopes of the*

Church of God in Connexion with the Destiny of the Jews and the Nations as Revealed in Prophecy. Shaftesbury wrote that the “divine plan” for the “stiff-necked, dark-hearted people”, the Jews, was not for them to have civil rights in England, but to be sent to Palestine. Lord Palmerston soon instructed British diplomats that the Jews burned with a desire to be removed from Europe.

A leading apostle of Darby’s, who transmuted his ravings into what became known in the early 20th Century as protestant “fundamentalism”, was the British intelligence official Sir Robert Anderson. Best known as head of Scotland Yard’s criminal investigation division (during the Jack-the-Ripper murders), Anderson ran Britain’s spy system against Irish nationalists and their American supporters. Among his Masonic and Protestant agents were the notorious terrorist anti-Irish provocateur “Le Caron” and the evangelist Dwight Moody.

JOHN WALVOORD
AND THE MOODY BIBLE INSTITUTES

Darbyism, or fundamentalism, took root in the Moody Bible Institutes. The American center of its most extreme version has been the Dallas Theological Seminary, under John F. Walvoord (president 1952-86), whom a biographer describes as “carry[ing] the mantle of John Nelson Darby for all literalist Christians in the late 20th Century”.

Walvoord trained and supervised Price, **Hal Lindsay**, and many of the other leading Armageddonists of recent decades. Walvoord has been near the center of a British web extending through the Pentagon, academia, and Bush-league intelligence circles. (Walvoord’s 1974 *Armageddon, Oil, and the Middle East Crisis*, typically, does not denounce the oil-shortage hoax, but instead criticizes the traditional American attempt to meet man’s material needs with science, such as developing nuclear power: Why bother, since God wants to end the world?)

Price told an interviewer in 1996, “We are looking for a conflict in the Middle East. It is inevitable.” Price said that he would soon be addressing a “prophetic conference” in Jerusalem, speaking along with Temple Mount operative Gershon Salomon and Gen. Ariel Sharon. Price explained that the irreligious Sharon would be outlining the military situation to the “people who are interested in prophecy”.

In *The Lost Ark and The Last Days: In Search of Temple Treasures* (Eugene, Oregon: Harvest House, 1994), Price pinpoints the efforts of his cohorts to inflame the Middle East and bring on mankind’s annihilation, in the search for the physical remains of the *Old Testament* Ark of the Covenant, as in the Steven Spielberg movie, *Raiders of the Lost Ark*. Price describes (in Chapter 16) what is desired as “The Ark Effect”:

“Effect one: Instigate the Rebuilding of the Temple
“Effect Two: Establish Religious Claim Over the Temple

“Effect Three: Usher in the Messianic Age for Israel
“Effect Four: Provoke a War in the Middle East”—this section begins with Price’s startling statement, “The conflict in the Middle East stems from the imperialistic claims of Islam.”

Price shamelessly throws in the original British Foreign Office canards about Russia as Gog. Under the subhead “The Future Scenario”, he writes, “When the Russian-Arab alliance moves against Israel, the European community will be compelled to intervene.” (p. 238)

[H: ANYBODY IN THERE?]

THE PROVOCATEURS

The provocateurs whom Price is profiling and helping manage are introduced to the reader. These include the most furious internal enemies of the state of Israel. Price writes: "Rabbi Nahman Kahane, the brother of the late Kach Party leader Meir Kahane, ... has long been at the forefront of religious efforts to see the Temple rebuilt. ... He has stated goals [including] the return of the Israeli nation to a monarchy. ... The restoration of the Sanhedrin to elect a high priest. ... The formation of a government with a reigning prophet. ... Rabbi Shlomo Goren [Price's close collaborator] ... has constructed a fully furnished meeting place for the restored Sanhedrin adjacent to the Temple Mount." (p. 216)

Price continues: "The Temple Mount Yeshiva ... [was] organized in March of 1993 by Kach activist Baruch Ben Yosef. ... The ... Yeshiva students, who are also Kach activists, seek to agitate the Arabs and at the same time to exercise their right as Jews to ascend to the Temple Mount. ... In January of 1994 I spent some time with members of the Temple Mount Yeshiva and followed them during their daily circuits on the Temple Mount." Price quotes the Yeshiva's American-born founder and leader, Rabbi Baruch Ben-Yosef: "It is our purpose to clarify to the world that the State of Israel is not the Jewish state; [it] does not represent the Jewish people. It is one of the most anti-Semitic states that ever came into existence. And that is why for 26 years the Temple Mount has been left in the hands of the enemy. ..."

"The Temple Mount Yeshiva and other organizations like it are gaining ground each year. They represent a new generation of Israelis who are more religious and radically determined to see Israel return to its biblical heritage and purpose. Their zeal may well be one of the factors that ... invites the coming conflict with the Arabs" (pp. 290-293).

A little later, Price writes: "To see how a renewed search for (or the discovery of) the Ark under the Temple Mount might provoke the Middle East situation, we need to examine the present struggle between Jew and Muslim over both Jerusalem and the Temple Mount" (p. 299).

Under the subhead "Awaiting the Inevitable", "Price the Christian" applauds the murderous rage of Jews and Arabs which is to lead to heaven, through the hell of war: "The possibility that war may be imminent can be seen from the irreconcilable religious and nationalistic convictions held by Israelis and Arabs." A Hamas spokesman is quoted, "We ... see the killing of Jews as an act that brings us closer to Allah." Price's collaborator, former Chief Rabbi Shlomo Goren, is quoted: "Arafat is responsible for thousands of murders. Therefore, everyone in Israel who meets him in the streets has the right to kill him.' ... Many of the settlers side with Goren; they say the government is insane to order them to evacuate their homes."

Price describes extreme Arab bloodlust and crimes, and a biblical text, to supposedly justify Baruch Goldstein's 1994 shooting spree, then continues: "Many of the settlers... now regard Goldstein as a patriot and hero (after the fashion of Mordecai in *Esther 9:4*). ... As evidence of the community's viewpoint, when the news went out that 50 Arabs had been shot, one woman's outcry [was] ..., 'We should kill 500, not 50!' ..."

"Will the 'peace' process continue, only to be crowned by treachery as the PLO leads an Arab army against Jewish 'occupiers' and forces a final showdown in Israel? Will the ban on 'extremist' Jewish religious

groups force a civil war in Israel. ...? Will the labor government be overthrown and a new reactionary right-wing government take its place, forcing the Arab world to go to war or face expulsion from the land? The specific catalyst for the final conflict is uncertain; but it is clear that such a conflict will come. ...

"And as the Middle East conflict lurches away from the prospect of peace, will the Ark be recovered and move onto the stage of these final days? If our understanding... is correct, it is likely" (pp. 309-311).

THE BRITISH MANAGED RIOTS IN PALESTINE

When Britain and France carved up the fallen Ottoman Empire, the British took control over Palestine and what was then called Transjordan, and the mandates for Syria and Lebanon went to France.

British practice in Palestine, in the years between the world wars, fostered violence and dissension between Jews and Arabs, as a matter of policy. Whenever Arab and Jewish forces moved toward peaceful collaboration, the British sparked riots, putting a bloody end to the chances for peace.

The British colonial regime militarily trained both the Jews and the Arabs during this period. The British policy of divisiveness was such that even today the histories written of the period, depending on the political outlook

of the author, will say that the "British favored the Zionists" or that "the British favored the Arabs". **In actuality, the British favored the Empire, and pursued a policy that ensured wars at other people's expense.** [H: Try on for size here the Gulf War of the U.S. against Iraq over British theft of Iraq's oil.]

THE RIOTS OF APRIL 1920

A case in point were the riots of April 1920. Col. Richard Meinertzhagen, the Chief Political Officer for British Military Intelligence in Palestine, reported in his book, *Middle East Diary, 1917-1956*, that British Military Governor Ronald Storrs and Chief of Staff Bertie Harry Waters-Taylor were encouraging anti-Jewish riots. On the day of the riot, he reports, the Arabs were told: "The Government [the British, that is] is with us; Allenby [the British General who captured Palestine from the Turks] is with us; kill the Jews; there is no punishment for killing Jews."

Waters-Taylor, according to Meinertzhagen, chewed out the Arab mayor of Jerusalem for not rioting more and reportedly told the mayor: "I gave you a fine opportunity. For five hours Jerusalem was without military protection; I had hoped you would avail yourself of the opportunity, but you have failed."

Meinertzhagen later reported to the Palin commission of inquiry, set up by the British government, that the British officials in Palestine had taken the side of the Arabs, and that lives were lost because Governor Storrs had withdrawn British troops from Jerusalem at a critical point, to give the rioters free rein. He reported to the Foreign Office in April that the British Occupied Enemy Territory Administration head, Maj. Gen. Louis Bols, and his fellow officers had caused the riots. He wrote in his diary: "I find myself alone out here, among gentiles, in upholding Zionism. ... And that is the irony of the whole situation, for I am also imbued with anti-Semitic feelings."

Meinertzhagen was fired after his report to the Foreign Office.

May we please begin right away with the continuation of the subject in point: THE ULTIMATE WORLD ORDER as pictured in *The Jewish Utopia*.

In continuation of the subject regarding "Armageddon" let us move right in to

WHO WILL WIN?

[QUOTING:]

According to the Utopian plan, the anti-God Communist forces will have to be destroyed, after they have served their purpose. For the Zionists want all the world to worship a god, their god. They who have made Communism so monstrous evidently expect to be our St. George, and the more monstrous the dragon the more glory to the Zionist knight-in-armor who cuts off its many heads, saving mankind (for such as remains of mankind). Socialism, Socialist governmental monopoly power, will not be one of the dragon heads to be cut off, but anti-religion will be.

It would surely seem that America is to be on the "righteous" side, since our policies, like Britain's, support Zionism while the Communists shadow-box Zionism. But it is not conclusive that the USSR is to remain in the camp of the "unrighteous". The world planners are opportunists and now they are building Red China into a mighty war machine, with know-how and equipment largely from the Soviet Union. It is my guess that the master strategists plan to hurl Red China against both the U.S.A. and the USSR—thus once more forcing us into a wartime marriage with a Communist country. In a desperate atomic struggle, no man would dare criticize

our ally, Soviet Communism or Jewish Zionism or our own government heads. We would quickly merge into a coalition Communist-type dictatorship with the Soviet Union, a world government, all but unrighteous China.

But to be on the side of the "righteous" we must embrace the Zionist god with law and "justice" administered from Jerusalem. The atomic war with anti-God China might well take care of all who opposed such developments. In such an alignment the USSR might be "reformed" from its anti-God position and induced to accept the god in Jerusalem. The world would be Socialist and there would be no further debate about Socialism or Communism, but only mention of pro-God and anti-God, pro-Jewish and anti-Jewish camps—the righteous vs. the unrighteous! [H: If you can't see that this has already come to be, albeit the labels may appear ever so "slightly" different and less obvious, then you are in critical circumstance. These things are already come to pass.]

The role of any particular nation as of now must necessarily be a matter of conjecture on our part but the above plan would satisfy the *Utopian* requirements.

For several years we have been hearing the question: Will Israel be neutral in the next war? If not, which side will she join? [H: It is most important right now that you realize it is out of Israel that the wars, themselves, are planned and caused, orchestrated and arranged so that someone else does their fighting and dying for them! Even to the financing—YOU pay the bill—through the banksters to pay for the wars, making it possible to hold the war and then impossible for you to recover.]

First, it is obvious that Israel would jeopardize the position of some two-thirds of the Jews of the world if she sided with the Communists against us, for these two-thirds reside in America.*

* The eminent Jewish writer and leader in England, Dr. Cecil Wroth, told a B'nai B'rith audience in Kansas City in MAY 1952 (as quoted in a Kansas City newspaper, the exact date of which does not appear on my clipping), "You have now in the United States a good two-thirds of all Jews in the world." We do not know for sure how many Jews there are; the Jewish leaders historically refuse to publish reliable counts. Answering the question "Why is it forbidden to count Jews, one-by-one, even for a holy purpose," the *California Jewish Voice* (Feb. 15, 1957) gave the answer: "This restriction is found in the *Talmud (Babil Yoma 22b)* where it is written that it is forbidden to count Jews even for a mitzvah."

The *New York Times* (owned by the professional Jew, Sulzberger) in 1948 did dare to estimate (not necessarily counting "one-by-one", perhaps!) the Jewish population of the world, putting the figure at between 15,700,000 and 18,600,000. So if America has two-thirds of the total, we must house about 11,000,000 or 12,000,000. [H: Sure does seem to me that if some 6 million or 6-1/2 million were murdered in the "holocaust" that the numbers are somehow

inappropriate. I repeat—there were not 6 million Jews in the German area to be killed in any holocaust of any kind!] Europe did not have six million Jews to lose during the war, as there were not that many Jews in all Europe; millions had left before the war started. Hitler could not have killed them. It seems obvious that they came mostly to America.

[H: Thank you, Mr. "Author", for repeating what I just said. This is the one biggest fact which disproves the Jewish holocaust story and WHY the Zionists make LAWS against questioning or publicly speaking in "revisionist" terms regarding their lies.] (End footnote)

Second, if the Zionists *did not* get some of the Israelis slaughtered in the war—and did not maneuver to have Israel sacked and perhaps burned, or atomized—they would lose the trump card which has drawn so many crocodile tears from us stupid Anglo-Saxons and got so many of our sons killed on Jewish-mapped battlefields. Israel will have to take part, and on the side of the West—or rather, fighting beside those Western nations who are to be duped and used.

Finally, Mr. Higger himself says Israel is to participate: "...Israel, and the other righteous nations, will combat the combined forces of the wicked, unrighteous nations..."

From Prof. Higger's book, it seems that our own country and allies (no doubt Britain and France) are to be among the righteous! This is splendid news, the first news of victory, even before the war starts!

But are we to be victorious? Not in the sense that any of us or our children and grandchildren can profit by a victory. For it is Zion that is to conquer all. Or such is the plan:

"Assembled for an attack upon the righteous nations in Palestine near Jerusalem, the unrighteous will suffer a crushing defeat, and Zion will thenceforth remain the center of the Kingdom of God."

In the next world holocaust there may well be no victor, not even Israel. Certainly, if they succeed, you and I, as defenders of American traditions and individual freedom, will be on the liquidation list. We need not even expose Zionist activities to get into *The Jewish Black Book**. All we have to do is defend our race, our traditions, our religion and our freedom. Mr. Higger made that clear; and the Zionists attack, vilify and ridicule all Americans who become prominent in the fight for Americanism.

* The Jewish Black Book Committee was listed as a Communist front in the 1947 "Un-American Activities Committee Report". Its national head was the late Communist-friend, Albert Einstein. The *BLACK BOOK* is apparently a list of Americans who dare to defend their country and its traditions. (End footnote)

How will they and their "righteous" agents, the "liberals", manage to suppress or liquidate such opponents in this country?

Many ways may be quickly developed under the hysteria of war, an atomic war. One way already is clear, and for this, machinery already is set up and ready: It is the Federal Civil Defense Administration, a Jewish invention. We will need "civil defense", and lots of it, if war strikes. But no possible combination of political appointees could conduct efficient emergency operations in case of bombing, fires, and general hysteria. The only force capable of coping with such an emergency is the local police in their own cities. They are familiar with their respective cities, local environs, terrain—and

seasoned for handling people under excitement.

The only way on Earth to have efficient “civil defense” in a war emergency is to have the responsibility where it already rests, under the American form of government—with the local city governments and the people themselves. Let the police chief handpick, train, equip and organize a citizens’ auxiliary and you will have genuine civil defense. The police chief and mayor naturally will work out plans for cooperating with the county law-enforcement authorities, the county with adjoining counties, and all will work with the armed forces, to save their own lives and children. The authority must remain at home.

HOW TO CAPTURE AMERICANS

James Forrestal, the patriot Secretary of Defense, worked out exactly such a plan and, in the fall of 1948, asked police chiefs and sheriffs throughout the country to organize such auxiliaries. Forrestal was also, at that time, trying to keep Truman from building up the state of Israel in the strategic and oil-laden Middle East. The Marxist propaganda machine, headed by the Jewish smear agent, Walter Winchell, and the Anti-Defamation League mouthpiece, Drew Pearson, went into action against Forrestal. Rarely in our history has such a furious and lying attack been centered on any public official. By December, 1948, I predicted in a article (as any observer could have predicted) that Forrestal would soon be driven out of office. He was out by March and, as the reader doubtless recalls, was hounded to near insanity and either jumped out or was thrown out the window of the Naval hospital (where he had been held virtually incommunicado, denied even the right to see a priest).

The surest sign that the inventors of the Federal (as opposed to local) civil defense machine were not concerned with providing genuine civil defense—to save lives, families and cities, and to preserve the local order of things—is seen in the nature of the organization they induced the President to set up: a Federal bureau of political appointees to run the entire civil defense, from coast to coast, the moment the bombs started falling, or the moment a region should be “threatened with invasion”.

The hodgepodge of political appointees, even if they were seasoned field generals, could not get the job done. Only the local police could and can do it. The backers of the plan were unexpectedly challenged by a few far-sighted fighting police chiefs, sheriffs and perhaps some mayors. They fought for weeks over who should have the authority to give orders. Finally, the local government advocates won. Congress for once wrote into the bill the American way.

But no matter what the law says; every head of the Federal Civil Defense Agency has been a left-wing “liberal” internationalist, fawning on the famous Jewish leaders. And the legal counsel is a Jew who has publicly called for the powers of dictatorship over the people in case of war. And the machine has set up a chain of command, down to the state, county and city, of political appointees of “liberal” internationalist leanings, or else oblivious to the world revolution in which we are caught. Neither these lower appointees nor the American people in general realize that the American system, and the Federal *Constitution*, prohibit the Federal government from coming into our state and our city to police us, under any circumstances, even in war, unless and until asked to do so by the legislature, or if it is not in session, by the Governor. **[H: You should be in total panic at this point in realizing that you now have KGB-trained sheriffs to police you and ready to enforce**

martial law and UN troops (so it isn’t your own sons) to enforce all regulations in any circumstance—all prepared to respond when the chaos is ignited.]

This mighty wall has been our defense for nearly 200 years. It has protected us from a government which otherwise would have become a dictatorship long ago. Freedom can be had only by leaving all police powers entirely to the local community. But we have to man this wall of freedom or it will be beaten down. And if the people do not even know it is there, if they do not even have an inkling of the meaning of local government, and human freedom, how are we to expect them to man the Great Wall of Freedom?

[H: Now, I believe, you can see how dated this book really is. You have passed all requirements of downfall to the point of being totally under regulations of FEMA at this very moment. At the end of this dissertation I shall give you a rundown of who is this author. The volume in use is undated and bears no publishing information. This is for the protection of my scribe. I dedicate these writings in point to this man who braved the gauntlet to bring you truth decades past—only to be tagged and battered by the opposition. Most of these patriots of the past will never be again recognized, but I shall do that which I can to see to it that as many as possible are not passed in vain, for there was no way to fulfill their missions in whole—for the nations’ peoples could not awaken and see and hear.]

The gifted gentlemen who plan the take-over must know all this. They must know that as soon as their planted agents sound the alarm, over radio and television stations owned or dominated by prominent Zionists, the people will take orders from these voices, and the local police will be squelched. For 25 New Deal years our people have been conditioned to take orders from Washington. **[H: Make that over half a century now.]**

Thus, no matter what the law says, the revolutionaries who advise and guide the liberal political appointees will have the upper hand and give the orders, from the first alarm. They will have to use the local police, but they will quickly replace any police chief or mayor who tries to exercise his constitutional duty to his people. They will shut down the schools, churches, libraries and courts, because their whole aim is to destroy local government and state government—the rock which so long has made Communist-Zionist takeover impossible. And the political figure-head arriving in each community will get his orders as to whom to liquidate from the local secret agent of the Anti-Defamation League of B’nai B’rith. **This Zionist machine, by its own bulletin, has agents in 2,000 American cities.**

All Americans who recognize the revolution for what it is, and who dare to protest the destruction of local government and the imposition of a Federal police dictatorship—these “unrighteous” citizens will just disappear in the smoke and the hysteria.

You will not be able to write, wire or phone your Congressman, for the Federal Civil Defense Agency will control the mail, telegraph and telephone systems.

HOW CAN WE DEFEND OURSELVES?

The only defense you and I will have is to educate our neighbors now, while we have a chance to reach them with the facts.

Under such a situation it may be worth a great deal in the struggle to regain freedom, for the citizenry to realize that the defenders of constitutional government

will be legally correct; while the oppressive government which usurps the rights of local and state government will be in the position of the revolutionary. Under such circumstances the *Constitution* seems clearly to authorize the people to make war on the usurpers. *Article II* of the Amendments says:

“A well regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms shall not be infringed.”

And Section I of *Article XIV* of the Amendments says: **“...nor shall any state deprive any person of life, liberty or property without due process of law.”**

Other Articles also specifically provide protection for citizens who defend their constitutional government.

The reader who is unaware of the viciousness and determination of the revolutionaries may refuse to believe that any group in such a powerful position in our country has any such designs. But they have already had 12 or more dry runs in as many American cities, using the equally revolutionary invention, the Military Government forces—which always are headed by leftist revolutionaries or “liberal” dupes. In 1951 these units seized nine cities in California, seized the mayor and police chief, posted proclamations of absolute dictatorship over the populace—and in the name of the United Nations Forces Military Government.

[H: Not simply to cause panic and hysteria but to inform you that you are witnessing it happening again ALL OVER YOUR NATION. FEMA has taken control and Federal troops have been introduced from Los Angeles to Florida—however, what may fry your nerves to a crisp: THE BLACK UNIFORMED DOOR-TO-DOOR CONFISCATORS IN EAST LANSING, MICHIGAN (AND SEVERAL OTHER PLACES) WEAR IDENTIFICATION EMBLEMS IDENTIFYING THEM AS UNITED NATIONS—FEMA—AND/OR MILITARY GOVERNMENT TASK FORCES. IN MICHIGAN, THE ID IS MGTF.]

So complete are the plans for seizure of power that they were leaked to the public via a magazine in 1955 **[H: 37 years ago!(—now 45!)]** The July 1, 1955 issue of *U.S. News & World Report* reported the plan which would annihilate the *Constitution of the United States* and possibly end for all time the individual freedom we have known:

“A military dictatorship, swift and complete, will take hold at the very moment of any big atomic attack on American cities.

“This is the word from top official sources in Washington following ‘Operation Alert’, the civil defense exercise just ended.

“The old idea of ‘standby controls’, which has been worrying some businessmen, no longer has any place in official planning.

“Instead, the President will simply take control—of business, banks, goods, prices, wages, just about everything—and worry about legal authority later.

“Martial law will be clamped on the entire country. This will be the President’s first official act after bombs start falling. With that act the President will assume almost unlimited powers. Dictatorship from Washington, or from the President’s nearby hideaway, will be backed by military forces...”

“Business will be blanketed by regulations already written and ready for issue.... Workers will be ordered not to strike, or change jobs without permission... Censorship will be imposed at once... Factories will be told what to produce... Farmers... may find their livestock, land and crops commandeered for military use...”

“In bombed-out areas, martial law will bring strict discipline, enforced at gunpoint by whatever armed forces are available. The Federal Civil Defense Act will come into full effect, empowering authorities to requisition property, including private homes and automobiles. In these areas people will be subject to draft for whatever labor is needed.

“Individual rights and privileges will disappear for the time being. Habeas Corpus, which protects a citizen against imprisonment without due process of law, will be suspended. So will freedom of speech... Under national martial law, so the thinking goes, there will be no time for haggling over Federal authority, no time for people or business to balk at doing what they are told.

“Once the dust begins to clear, Congress will be asked to ratify the emergency measures ordered by the President.”

Thus, the end of the golden age of human freedom; the wiping out of the glorious Republic with its written limitations on government and its constitutional guarantees against highhanded, arrogant officialdom.

And what a perfect blueprint for conquest by the gifted Zionist planners (who inspired this Federal “civil defense” trap and whose fingerprints are all over it). Julius Caesar, the internationalist, who was always an underling of the Jewish financial and political leaders (and always heavily indebted to them for personal “loans”) thus destroyed the great Roman republic (after centuries of racial homogenization had reduced the people to a state of degeneracy).

We are still talking about milestones on the road to the Zionist’s *Utopia*. We have not yet reached the milestone of A-day, which is suppression of freedom inside our country, but we have reached a milestone on the road to racial and spiritual degeneracy; otherwise, no President would permit a clique to draw up a blueprint for crowning him a Caesar; no President would dare think in such terms. If we had not reached a milestone down the road toward the take-over, Congress and the people would blast out of office any President who dared to put his stamp of approval on a blueprint to wipe out the Republic and end, perhaps for all time, human freedom. **[H: Sorry, chelas, but that milestone has come and is here! Remember, again, that this plan is to be in working perfection with depopulation almost complete BY YEAR 2000!]**

Our people and even our Senators and Representatives seem no longer to understand that the *Constitution* never gives Congress or the President any special powers over the states and the people, regardless of the emergency. Even martial law does not give the President the right to suspend courts and the process of justice, or the right to invade a state and take over police powers (except by request of the state legislature or the Governor). Congress never has the right to grant the President any special wartime or other emergency powers. This innovation of our lifetime is simply a usurpation, an outright violation of the *Constitution*. The frightening aspect of it is that the people permitted it with little protest during the Second World War, and now raise hardly a voice against the “civil defense” blueprint for dictatorship. The people do not seem to realize that no such power is necessary or even advantageous: that the people, given leadership and information, will always respond and, under their local government and leadership, will accomplish more than under compulsion and Federal “planning”.

Another milestone revealed in *The Jewish Utopia* which gives us a general clue as to the Zionist timetable:

“The advent of the new era will thus be preceded by the ‘travail’ of the Messianic time, namely, great distress, foreign invasions, confusions and moral decline. According to another tradition, the three generations preceding the Messianic period will possess abundance of silver and gold, and other luxuries. Hence, the people will lead an immoral and ungodly life.”

Has our level of prosperity and easy living now so completely killed any public conscience, the courage to resist tyranny and subversion, that the time is ripe? Before the First World War the farmers and small-town neighbors would have taken clubs and cleaned out the stinking mess in Washington, and would have made short work of the Communists and Zionists, the Anti-Defamation League, the NAACP, etc.

I remember those men and their courage in the early part of this century. We are now a generation of cowards and money grabbers.

The milestones show that the revolutionaries expect to bring on the crisis very soon.

INTERRUPTIONS

Many interruptions have occurred since we began the various writings of today.

I wish to finish this document, so please understand, readers, that it is after 8:00 P.M. and we are weary.

We will take up the happenings and strategies that are under way with Perot and the politicians—but let it be not overlooked that the entire thing is a study in media interest. I think if you pay attention to that which we have given attention, you can see how things are shaking out. Will Perot run? It doesn’t matter in the least but it is nice to hear the voices of the people being raised above the roar of the media chantings and blackouts. **You will note that Perot does NOT get “blackout” treatment and THAT MEANS THAT IN SOME CAPACITY HE IS ONE OF “THEM”.** With the undercover activities and meetings with Baker, etc., it certainly appears that this group does not want Clinton to win this election. You had best not want that either because with a PAC-bought Congress, you don’t have a prayer in you-know-where of pulling out of this pit. There is so much more than meets the eye that we simply can’t do it justice here tonight. I have probably said far too much as we have moved along because I want YOU to see what is happening—not just have an observer make observations.

Is Perot telling you-the-people the truth? Indeed, but you have to remember he is an advanced guard guest at places like Camp David and where all the “good old boys” go to meet and scheme and play. He has anted money every time the request has been pushed—from POW-backing to anything requested of him. Bush is an old friend and, yet, Brent Scowcroft has his admiration and total respect (in Perot’s own words)—so you have a real can of worms here. Obviously, the Bilderbergers want Clinton in the seat and right now Bush is NOT running the U.S. already. Therefore, you may find that the most secure way to go to buy time and not have the entire nation collapse is to somehow ensure that Bush

makes it—that is, of course, the Republicans or an outsider who can be controlled, because **the man in the slot makes no difference.**

From here on in you are going to be surprised at just WHO seems to be coming to the rescue—because the top Zionists may have overplayed their hands a bit too heavily.

The bombardment against you is in full-blast ahead and nothing is changed in the overall “PLAN”.

So, back to quoting:

CAN THE ZIONISTS TRIUMPH?

There remains the big question: Can they win?

After reviewing the steady progress the Jewish nationalists have made for centuries, in revolution after revolution, and the appalling power they have today as they near the climax of their amazing 2500-year struggle for domination, it might sound ridiculous to say flatly “NO”. Any answer is obviously no more than an opinion, or a blind faith. My answer is, and always has been, “No”. I just do not believe the selfish, scheming, bloody, utterly unmoral Zionist cult can destroy the whole world and bring the smoking remnants under its control.

I believe they have gone too far already. They are challenged in the Communist countries by the people and now they are challenged even in the stupid, kindly, tolerant and timid West where the Zionist curtain of secrecy cannot be kept down much longer.

No matter who incited the Hungarian revolution of 1956, the fact that thousands of Hungarians, including many or most of the younger generation who were supposed to have become indoctrinated with Communism, were willing to fight to the death for their freedom told the tale: The Communist monster cannot destroy the love of freedom; even in the slave state of Hungary, after years of Communist browbeating, men will die for freedom.

An article in the August 18, 1957, *Los Angeles Examiner* quotes Chiang Kai-shek as reporting rebellion throughout Communist-held China—this after the Reds have killed an estimated 15,000,000 of the community and provincial leaders, the best blood of every community. The leader of Free China, who has fought the Reds, ideologically and militarily, since 1927, and who is no gullible optimist, made the blunt prediction that “the general collapse of the entire Soviet empire and international Communism” is underway—one of the most heartening statements published in this generation.

However, the Generalissimo undoubtedly based his prediction on the assumption that men and women both in and outside the captive countries would keep on struggling and fighting the monster—and he warned that, if the men in the Kremlin see their empire crumbling, they may risk an atomic war in the hope of saving it.

It is well known that the Red empire has been on the verge of bankruptcy or internal collapse several times in its history and might well have been overthrown or failed but for the intervention of the United States. Repeatedly, we have rushed food for millions of discontented, hungry rebels, or made loans to the Communist government of Moscow, or instituted some hands-off policy such as Dean Acheson’s policy of “containment”. The policy of the **Roosevelt-Truman-Eisenhower internationalists** has been to do nothing which would seriously harm the Communist governments. This has given them time to grow and consolidate their gains. **[H: I guess you can see that by no mention of subsequent Presidents since**

Eisenhower, you have really “dated” this journal. This can only bode ill for you-the-people, for you can see what has happened. There is no lessening of Communism or Zionism—there is only a lip-service sly and clever move to hide facts and call the hornet/scorpion by another label to further confuse your thinking. Look at the impact since Eisenhower—my, you have had to go through Nixon, Ford, Carter, Reagan and Bush—and I may even have left out one or two—BUT WITH ALL—THERE WAS ALWAYS HENRY KISSINGER PULLING THE STRINGS ALONG WITH A ROCKEFELLER.]

All the Red empire has needed was time—time to train mechanics, build factories, build a war machine, build super weapons with our laboratory secrets. Now the Soviets have the weapons with which—not to defeat us, perhaps, but to precipitate Armageddon and, in committing suicide, kill millions of Americans and wipe out our cities.

The all-important job for us just now is to bring about the downfall, the disintegration, of the Red empire **before the Zionists can use it to bring about the Armageddon which they must have.** If we rob them of the war in the Middle East and the war emergency here at home, we will tear up their timetable and set them back perhaps a hundred years—giving us time to organize our defenses. **[H: Do not be foolish to misread this, for what you have “witnessed” is not a tearing down of the actual empire but a reshuffling of the players which is always a prime mark of the beast in operation. The point missed in this man’s writings is the supremacy of the Russian cosmic crews and craft—he knew not of such a thing at the time of his writings.]**

At the same time, we should outlaw and destroy the Zionist cells here at home. **[H: Well, you certainly have NOT done this—in fact, they have grown steadily more and more powerful even to making their “religion” the public law of the land.]**

One thing we need to understand immediately: The Jewish planners are not infallible. Time and again their plans have misfired—in ancient, medieval and modern maneuvers. They expected to capture Europe through Communism and then all the world, quickly after the First World War. They expected to annihilate the Germans or completely break their fighting spirit by the Second World War. They planned to take over our country immediately after that war in the hysteria of an abysmal financial depression. They evidently expected something big to result from their 1956 invasion of Egypt, but instead they not only had to back out, but their eagerness for blood unexpectedly, almost incredibly, drove hundreds of thousands of Christian laymen and ministers (those who had not been hardened pro-Communists but only deceived and well-meaning “liberals”) away from them. All over America the Christian press turned on the Jewish militarists. Israel no longer was the sacred fulfillment of scriptural prophecy to these ministers.

[H: Hold your breath—is the above true? I thought you would catch the errors. Perhaps it appeared that way at the time of the writing—but in your country the evangelical movement has become totally Zionist and works for the fulfillment of the Zionists’ prophecies in the form of this PLAN—hook, line and sinker. Your own evangelist “Christians” have pulled down your nation into a Zionist movement.]

An Anti-Defamation League survey early in 1957

estimated that 75 percent of the Christian press had turned “anti-Semitic”. **[H: I am almost ready to not print the rest of this gentleman’s writing—for if you are not paying close attention you may, indeed, think that I give you this as current fact. NO, his conclusions may have been seemingly as presented in 1958 but NOT IN 1992. So far, in 1992, the Zionists have brought about every last thing they set out to do and herein is where “hindsight” is so much better than guessing about that which may or may not come to be. The only reason I shall continue to quote is out of respect and honor for the incredibly insightful work of this writer in laying out the planning.]**

We will have to have just one victory at the polls, electing a President with both courage and understanding, to snap off the head of the Zionist snake and keep it from again coupling up with the body, at least in our time. The guilt of the Zionist schemers must make them extremely uneasy with every reversal, big or little. They are obviously guilty of disloyalty to the *United States Constitution*; they obviously have their own world tribal government and now also a political and geographical state, and their loyalty is to that tribal government and state. Obviously, they are trying to bring about the disintegration of our country and its subordination to a world regime under their influence. **[H: Obviously, THAT president has not yet come along, has he? Will it happen this year? CAN it happen this year? How much do YOU hear about Bo Gritz from the national population? Could it happen? Yes, but it surely doesn’t look like it will be through ballots in 1992. And if you don’t do it in 1992—when?]**

This is treason.

And the recognized punishment for treason in all well ordered countries throughout history has been death. **[H: But what have you today? You have death to those who speak out against the treasonists. Doesn’t look too good, does it?]**

The willful, inner leaders of the Zionist world state must be punished and the hundreds of thousands of their followers who have had an inkling of what they were up to, must be banished—as the most humane way to deal with mass treason. They must be resettled preferably on a suitable island **where they can make their own living by the work of their hands** (since that is what their utopian leaders want), but whence they cannot subvert our people and country, and whence they cannot escape.

In this time of discouragement for patriotic citizens, when even our own government often is used against us and against the interests of our country, we should bear in mind the example of an earlier patriot of another country, who went through darker days but won a historic victory. The little green-eyed Isabella came to the throne when she was 20, in a Spain that had suffered such complete degradation under seven centuries of Jewish machinations and Moorish invasions that she had to run time and again for her life. The “new Christians”, the hundreds of thousands of Jews who had gone into the Catholic Church two or three generations earlier (in a political and commercial maneuver and for protection against reprisals) had practically captured the church in that country and were subverting it from within. (Their predecessors in France and Spain had inspired a movement called the Albigenses, which taught the gullible gentiles to believe that the body was evil, so the holy leaders should commit suicide; but which movement, at the same time, gave the masses such license that they sank in complete moral abandon.)

Isabella had a New England conscience and a patriotic zeal; she fought back. For 20 years she fought—not all Jews, but the guilty Jews—and their allies, the Moors. After a lifetime of struggle she succeeded in breaking the Moorish resistance in a decisive battle at Granada (in 1492) and a little later expelled most of the Moors and Jews from Spain.

[H: The next is the final entry by this author and is well worth heeding.]

IT’S UP TO US

Our political leaders are not going to save us unless and until the people demand salvation. It is up to us. We must organize for self-defense. A single organization of White citizens, each required to study the racial history of his people financed by some of our many rich men, and inspiring a similar race-pride organization among the Negroes, with friendly cooperation between the two groups, could ultimately win the victory. Nature is strongly in our favor; neither the Negroes nor the Whites generally want “integration”; several million Negroes in recent years have signed petitions urging Congress to appropriate money to help them settle in a country of their own in Africa, and a bill is now before Congress to help them.

The enemy holds the whip only because of his skillful use of fear propaganda above our cowardice and ignorance. His hold on our presidential nominating conventions and on governments and peoples is precarious. Once we wake up and acknowledge that it is un-Christian to soften and subvert our own race, that in so doing we are betraying our children into slavery, once we begin speaking up against the fraudulent Zionist missionary of “brotherhood” and begin defending the future freedom of our own children, we will suddenly shake off the spell of the voodoo priests. Once we begin talking straight to our elected officials and giving them the necessary moral support, they will outlaw the Zionists as well as the Communists, and the black-magic revolution will vanish like a bad dream.

Let us be warned by the insane outburst of Mr. Higger when he said (p. 19) the motto will be:

“Righteous Unite! Better destruction of the world than a wicked world!”

Better destruction of the whole world if the Zionists cannot make us all conform to their requirements!

The Israelis now are making atomic fission materials in their own secret, guarded plant: and Jewish revolutionaries in America (famous Jewish radicals) have great influence over, if not outright control of “our own” atomic weapons and, unless there has been a recent change, a Communist Jew is head of the atomic projects in the USSR. Bombs can be placed strategically in our industrial cities and exploded at A-day by radar. Atomic dusts are so poisonous that a small organization could poison the nation’s water supply (as Ana Pauker said the Communists would do when the time came).

There are radical Jews high and low in our bacteriological warfare; laboratories; they can spread strange disease among us while covertly vaccinating the “righteous” among their own people. There is strong suspicion that they are already liquidating the foremost of our anti-Marxist leaders by invisible death, possibly inducing cancer in a Senator’s bloodstream by atomic radiation planted in a chair cushion or upholstery.

Unless the American people recapture their government and smash the Zionist machine—the insane elements in that machine may wipe out mankind.

Every man, sooner or later, has got to answer to his children and his country. How will you answer?

[H: Moreover—every man, woman and child, sooner or later, will also ANSWER TO GOD! HOW WILL YOU ANSWER?]

[H: Now, before changing the subject, I have here a bit about the author which is written in conjunction with this information. I think, again, that it is best if I simply ask that what is written be accurately repeated. You have to understand that this is some 30-odd years old.]

ABOUT THE AUTHOR

Robert H. Williams, a native of West Texas, son of a Baptist minister, is a lecturer, news analyst and authority on subversive movements. He is a contributor to *Encyclopedia Britannica's* "Ten Eventful Years", author of several booklets on Communism, Zionism and Americanism, and is publisher of the monthly newsletter *Williams Intelligence Summary*.

In 1942 the author, as S-2, head of the Intelligence staff section, for Basic (or Replacement) Training Center No. 4 of the (then) Army Air Forces Counter Intelligence investigative staffs in the AAF. Later he became executive officer for the Intelligence and Public Relations section, Headquarters Miami Beach Schools (commanded by Brig. General Ralph H. Wooten), with the title The Intelligence Officer. In this assignment he trained and directed the combined and expanded Intelligence section over the various Miami Beach Air installations.

For more than a year thereafter (in 1943-1944) he was a Combat Intelligence Officer (with secondary Counter Intelligence duties) in the Second Air Force, helping train bombardment crews. In August, 1944, he again was assigned to Counter Intelligence (detection and prevention of sabotage, subversion, etc.) as his primary duty, becoming the Counter Intelligence Officer for the 314th Bombardment Wing (of B-29s), and remained in that assignment to the end of his active duty, August, 1945, serving with the bomber wing on Guam, under command of Brig. General (now General) Thomas S. Power.

After the war, he was transferred to Military Intelligence Reserve, from which he was honorably discharged in December 1950. As an Intelligence officer his efficiency rating was never lower than Excellent—for 12 consecutive months it was Superior. On departure from Guam for the United States, he was commended by General Power "for your performance of duty as a member of the Wing Intelligence Section, particularly as Wing Counter Intelligence Officer. You have demonstrated ability and a devotion to duty which have served as a model to other members of the command."

COMMUNISTS ATTACK AUTHOR

Unable to deny the author's carefully documented charges of subversive activities, the Communists and the Anti-Defamation League of B'nai B'rith circulated stories that "Williams is not and never was a member of Military Intelligence Reserve"—though for two or three years after these fables began to appear in ADL and

Communist publications Williams was a Major in Military Intelligence Reserve. When he became over-age in grade and applied for a one-year extension in the Active Reserve, the Anti-Defamation League put intense pressure on G-2 at Washington to drop him, but after a four-month investigation of Major Williams and his publications, his file was marked "NO ADVERSE INFORMATION" and G-2 granted his requested extension, in the coveted classification of Counter Intelligence Specialist.

When President Truman designated Mrs. Anna M. Rosenberg as Assistant Secretary of Defense in charge of personnel (giving her almost absolute power to fill key positions with revolutionaries), Williams published a factual, documented expose of Mrs. Rosenberg's Red record. On the day (Dec. 21, 1950) the Senate confirmed Mrs. Rosenberg's appointment Williams was discharged.

Later, a high ranking officer of the Adjutant General's Department told Williams that the Jewish revolutionary, the late David K. Niles, one of Truman's aides, had ordered the discharge via Mrs. Rosenberg. Presumably, it was her first official act. The discharge was honorable; no charges ever were filed against Williams; it was issued under Para. 6a (11) SR 140-175-1, a paragraph under which an officer can be discharged (honorably) without so much as notifying him. The only answer Congressman John Phillips ever was able to get from the George C. Marshall-Anna Rosenberg Department of Defense as to why the author was discharged was that wide publicity given to certain statements contained in his booklet *Know Your Enemy* and his newsletter impaired the author's future usefulness in Intelligence. **Obviously, this referred to the fact that the author had dared to expose the Zionist revolutionary machine, including certain Jewish generals and officials who were pro-Communist or of doubtful loyalty.**

Williams' hometown daily paper, the *Santa Ana Register*, classified this as one more of the political discharges for which the Truman administration had become notorious.

Williams' publication continued to grow in influence and circulation despite propaganda attacks and the pro-Communists made a still more extravagant effort to discredit the author. While the weak Congressman Harold Velde was chairman of the House Committee on Un-American Activities the Anti-Defamation League of B'nai B'rith and the American Jewish Committee planted on the committee, as its chief legal council, their friend, a radical left-winger, Robert Kunzig, and through him these two subversive organizations, which attack all anti-Communists, arranged and held a secret meeting with Velde in which Velde agreed to use their "finger men" and their so-called files.

Late in December 1954, after Republicans lost the election and Velde was through as chairman and to be succeeded by the fighting American Congressman Francis Walter, and Kunzig knew he was to be fired immediately—he got up a pamphlet which he called *Report on Neo-Fascists and Hate Groups* (using the very terminology of the Communist and Zionist smear agents in his title) attacking more than a score of anti-Communists but not a single Communist individual or organization.

In this so-called report, Kunzig repeated the fables of the Communists and Zionists about Williams:

"Williams advertises himself as a member of Army Intelligence during World War II. The deception is evident from the fact that Williams' Intelligence duty comprised less

than a year as an administrative officer for the Intelligence section of a bomber wing. In the position, he would have received no Intelligence information dealing with the Communist conspiracy. His assignment to Military Intelligence was merely in the Reserves, from which commission he was relieved by official action of the Army, effective December 21, 1950."

When the new chairman of the House Un-American Activities Committee, Francis Walter, read about this so-called report in the papers, he angrily and publicly denounced it, said he had never heard of it before and that the Committee had no knowledge of it, and added: "This sort of thing is going to stop."

He got rid of Kunzig and in June 1955, a four-man sub-committee of the Un-American Activities Committee, holding hearings in Los Angeles, convened a special executive session to hear Williams and correct the falsifications of his record of service in Army Intelligence.

With the appearance of Williams latest booklet, *The Ultimate World Order*, revealing (probably for the first time in history) the actual Zionist plans for domination, the author expects renewed attacks by the alien cults to keep the people from heeding his warning. [End of "Author" section.]

Thank you. Now, I shall just ask for a bit of reminding information:

A FIFTEENTH CENTURY "PROTOCOL"

The principles and morality of these latter-day *Protocols* are as old as the tribe. Here is one from the 15th Century which Jews can hardly pronounce as a forgery, seeing that it is taken from a Rothschild journal. [QUOTING:]

The *Revue des etudes Juives*, financed by James Rothschild, published in 1889 two documents which showed how true the *Protocols* are in saying that the Learned Elders of Zion have been carrying on their plan for centuries. On January 13, 1489, Chemor, Jewish Rabbi of Arles in Provence, wrote to the Grand Sanhedrin, which had its seat in Constantinople, for advice, as the people of Arles were threatening the synagogues. What should the Jews do? This was the reply:

"Dear beloved brethren in Moses, we have received your letter in which you tell us of the anxieties and misfortunes which you are enduring. We are pierced by as great pain to hear it as yourselves.

"The advice of the Grand Satraps and Rabbis is the following:

1. As for what you say that the King of France obliges you to become Christian: Do it, since you cannot do otherwise, but let the law of Moses be kept in your hearts.

2. As for what you say about the command to despoil you of your goods: (the law was that on becoming converted Jews gave up their possessions) "Make your sons merchants, that little by little they may despoil the Christians of theirs.

3. As for what you say about their making attempts on your lives: Make your sons doctors and apothecaries, that they may take away Christians' lives.

4. As for what you say of their destroying your synagogues: Make your sons canons and clerics in order that they may destroy their churches.

5. As for the many other vexations you complain of: Arrange that your sons become advocates and lawyers, and see that they always mix themselves up with the affairs of State, in order that by

putting Christians under your yoke you may dominate the world and be avenged on them.

6. Do not swerve from this order that we give you, because you will find by experience that, humiliated as you are, you will reach the actuality of power.—“Signed V.S.S.V.F.F., Prince of the Jews, 21st Caslue (November), 1489.

In the year 1844, on the eve of the Jewish Revolution of 1848, Benjamin Disraeli, whose real name was Israel, and who was a “damped”, or baptized Jew, published his novel *Coningsby* in which occurs this ominous passage:

“The world is governed by very different personages from what is imagined by those who are not behind the scenes.”

And he went on to show that these personages were all Jews.

[END OF QUOTING]

So, you might say that “this was in 1844 and 1889 and could have nothing to do with any current events”—Oh? Please, read on:

THE FATAL DISCOURSE OF RABBI REICHHORN

In its issue of 10 March, 1921 (No. 214) *La Vieille France* gives the version of a funeral oration which was published in *La Russie Juive*. It is perfectly clear that the funeral oration and the *Protocols of the Elders of Zion* come from one and the same mint. Both are prophetic; and the power which made the prophecies has been able to bring about their fulfillment. **This oration is so important that we again print it herein. There can no longer be any doubt as to whose is the power which is disturbing the world, creating World Unrest, and at the same time reaping all the profits.** Jewry is enslaving all Christian peoples of the Earth as well as all God-loving peoples of other doctrines. 5. The other great power is THE PRESS. By repeating without cessation certain ideas, the Press succeeds in the end in having them accepted as actualities. The Theatre renders us analogous services. Everywhere the Press and the Theatre obey our orders.

6. By the ceaseless praise of DEMOCRATIC RULE, we shall divide the Christians into political parties; we shall destroy the unity of their nations; we shall sow discord everywhere. Reduced to impotence, they will bow before the LAW OF OUR BANK,

always united, and always devoted to our Cause.

7. We shall force the Christians into wars by exploiting their pride and their stupidity. They will massacre each other, and clear the ground for us to put our own people into.

8. The possession of the land has always brought influence and power. In the name of social Justice and Equality we shall parcel out the great estates; we shall give the fragments to the peasants who covet them with all their powers, and who will soon be in debt to us by the expense of cultivating them. Our capital will make us their masters. We in our turn shall become the great proprietors, and the possession of the land will assure the power to us.

9. Let us try to replace the circulation of gold with paper money; our chest will absorb the gold, and we shall regulate the value of the paper which will make us masters of all the positions.

10. We count among us plenty of orators capable of feigning enthusiasm and of persuading mobs. We shall spread them among the people to announce changes which should secure the happiness of the human race. By gold and by flattery, we shall gain the proletariat which will charge itself with annihilating Christian capitalism. We shall promise workmen salaries of which they have never dared dream, but we shall also raise the price of necessities so that our profits will be greater still.

11. In this manner we shall prepare Revolutions which the Christians will make themselves and of which we shall reap the fruit.

12. By our mockeries and our attacks upon them we shall make their priests ridiculous then odious, and their religion as ridiculous and as odious as their clergy. Then we shall be masters of their souls. For our pious attachment to our own religion, to our own worship, will prove the superiority of our religion and the superiority of our souls.

13. We have already established our own men in all important positions. We must endeavor to provide the **Goyim** with lawyers and doctors; the lawyers are *au curant* with all interests; doctors, once in the house, become confessors and directors of consciences.

Let us foster the idea of free love, that we may destroy among Christian women, attachment to the principles and practices of their religion.

CIA BRIEFS BUSH; GOP URGES VOIDING CLINTON ORDERS

George W. Bush received his first daily national security briefing from the Clinton administration yesterday while Senate Republicans urged his running mate, Richard B. Cheney, to reverse Clinton-era executive orders.

"It's going to be important to show the American people that this administration will be ready to seize the moment," Mr. Bush told reporters during another busy day of transition planning in Austin.

A CIA official met with Mr. Bush at the governor's mansion in Texas and gave him the same intelligence briefing that Vice President Al Gore receives daily.

The Bush team had sought the reports for at least two weeks, arguing that Mr. Bush needs the information to conduct a responsible transition.

Meanwhile, on Capitol Hill, Mr. Cheney gave congressional Republicans their first taste in eight years of what it will be like to work with a Republican administration.

He greeted House Republicans in the morning and ate lunch with Republican senators, who encouraged Mr. Cheney in a free-wheeling discussion to have Mr. Bush overturn a long list of executive orders signed by President Clinton.

Senators declined to be specific about which executive orders they want overturned, but one Republican said they advised Mr. Cheney to be "aggressive" about overturning Clinton administration policies. Another Senate Republican said they broached the overall topic but did not get into specific policy areas with Mr. Cheney.

Republicans have long chafed at what they view as Mr. Clinton's excessive use of this executive power to circumvent Congress on a variety of issues, from protecting homosexuals from discrimination to declaring new national monument areas.

"The transition is up and running and operational now, and we look forward to working with members of Congress of both parties," Mr. Cheney said after the closed House session. He pledged "a robust effort to get on with the business of dealing with the nation's problems..."

Speculation continued yesterday about the composition of a Bush Cabinet. House Republicans said Mr. Cheney solicited their suggestions for appointments to key positions.

Privately, some members said they expected Mr. Bush to look at conservative-leaning Democrats such as former Rep. Lee Hamilton of Indiana.

Several Bush advisers have suggested that Mr. Hamilton, who retired in 1998, would be an appropriate choice for an intelligence or foreign policy position, perhaps as director of the CIA or an official at the National Security Agency.

Other House members suggested that Mr. Bush would reach out to Rep. Charles W. Stenholm of Texas and Rep. Gary A. Condit of California, both members of the conservative "Blue Dogs" caucus of Democrats.

Both men have a keen interest in agriculture issues....

The day in Washington began with Mr. Cheney, a former five-term representative from Wyoming, meeting House Republicans in the Longworth House Office Building.

"As a former member of the House of Representatives, I look forward to being president of the Senate," he said to cheers and laughter.

Mr. Cheney also thanked those House Republicans who traveled to Florida to help the campaign during the monthlong recount contest. And he introduced Mr. Rove; David Gribbin III, the transition team's liaison to Congress; and Ari Fleischer, the transition spokesman.

Rep. Henry J. Hyde, Illinois Republican and chairman of the House Judiciary Committee, said the mood in the caucus room was "ebullient, upbeat, enthusiastic, anticipatory".

Rep. Asa Hutchinson, Arkansas Republican, said, "With Secretary Cheney addressing us, it was giving us a flavor of what it would be like with a Republican in the White House. Some of us have never been in Congress when we've had a Republican in the White House. So that was very upbeat."

House and Senate Republican leaders were clearly looking forward to dealing with a Bush administration.

"I think we want to make sure that on this end of Pennsylvania Avenue, both the House and the Senate, in a bipartisan way, can come together and get the things done," said House Speaker J. Dennis Hastert, Illinois Republican.

The relationship with the White House "is going to be better than ever" under a Bush presidency, said Rep. Jack Quinn, New York Republican....

Sen. Peter G. Fitzgerald, Illinois Republican, said Mr. Cheney expressed unhappiness that Mr. Bush had lost almost half the normal transition time, which could slow down the process of naming key officials.

Mr. Cheney suggested that Mr. Bush will concentrate on naming his top Cabinet officials and then delegate considerable authority to those nominees to name their deputies. That way, he said, Mr. Bush might avoid the slow nomination process that plagued the first Clinton administration.

[JR: Let's light a candle in the minds of our Congress and urge them to reverse most of Clinton's Executive Orders—especially those exceeding his authority and where Congress couldn't produce the 2/3 vote needed to overturn them. JEWS TO THE FORE IN LIKELY BUSH CABINET

It is yet another paradox in a presidential campaign year that has abounded with them: Texas Governor George W. Bush won less than 20 percent of the Jewish American vote, and far more Arab-American votes than his opponent, Vice-President Al Gore. Yet in the end, Bush may be surrounded by even more pro-Israel

advisers than Gore would have been.

His top two foreign-policy officials are expected to be African-Americans General Colin Powell, former chairman of the Joint Chiefs of Staff, as Secretary of State; and Condoleezza Rice, former head of the Soviet desk at the National Security Council, as National Security Adviser. Both have strong Jewish connections.

Powell, the son of Jamaican immigrants, speaks Yiddish, which he learned as a boy while working for a Jewish grocer in New York City.

He has won the hearts of American Jewish audiences, including those at the annual policy conferences of the American Israel Public Affairs Committee, with a fluency few of them could have matched.

General Powell was an advocate of sending Patriot antiballistic missile batteries to defend Israel from Iraqi Scud attacks during the 1991 Gulf War. He has always shown strong sympathy with the Jewish state.

Ms. Rice numbers among her own close advisers Richard Haas, director of foreign policy and security studies at Washington's prestigious Brookings Institution, and Dov Zakheim, former deputy undersecretary of defence under President Reagan. Both are Jewish. Zakheim, in fact, has semichah [rabbinic ordination-mob].

He and another prominent Jewish Republican, Paul Wolfowitz, former deputy secretary of defence under President George Bush, have been in Governor Bush and Ms. Rice's inner circle of advisers nicknamed "The Magnificent Seven."

If the younger Bush is confirmed as president by the Electoral College on December 18, Wolfowitz can look forward to cabinet rank, and Zakheim a high sub-cabinet posting probably as a deputy to the Secretary of Defence. Bush is seeking to recruit a Democratic senator for that post.

Mr. Wolfowitz, who had his eyes set on becoming Secretary of Defence, looks like being moved sideways possibly as director of the CIA, still a powerful post.

Colin Powell has always been close to Governor Bush's vice-presidential nominee, Dick Cheney. Cheney, as President Bush's Secretary of Defence, was broadly sympathetic to Israel if strongly opposed to releasing convicted Israeli spy Jonathan Pollard, who has served 15 years of a life sentence.

If Bush is confirmed, one familiar face from Middle East policy-making will finally be missing after more than a decade in that role. Wolfowitz, Zakheim and other key Bush advisers are said to want to replace U.S. peace negotiator Dennis Ross, who has already announced he did not wish to stay on in the post. Mr. Ross, however, may be replaced by another Jewish policy expert, with Mr. Haas seen as a front-runner.

Former U.S. Secretary of State James Baker, *bete noire* to pro-Israel activists during George Bush Sr.'s administration, has been key in the younger Bush's transition team. But neither General Powell nor Ms. Rice is said to favour his having a major foreign policy role. **[JR: This *Jewish Chronicle* article makes some interesting observations about Colin Powell, who Bush calls "the first African-American Secretary of State". Mr. Sieff tells us Powell is a "kosher" African-American, which helps to explain why he has been such a darling of the media. What is also interesting about this article is that it was written prior to announced appointments of Bush's cabinet, which shows the *Jewish Chronicle* certainly has insider information—as Bush's advisors also seem to be Jewish. Perhaps they are simply the leading playwrights of this [Khazarian] world drama.]**

VOTE DISPUTE
UNRAVELS U.S. FOREIGN POLICY

WASHINGTON—While the U.S. is entranced with its own electoral crisis, nobody in the Washington government seems to be paying attention to the fact that the Clinton administration's foreign policy accomplishments are unravelling.

There is, of course, the collapse of the Middle East peace process. But the violence that erupted in late September was only the climax of a slow-motion collapse of the U.S. role as honest broker in the Israeli-Palestinian dispute.

That began when President Bill Clinton publicly pinned the blame for the failure of the Camp David II talks on the Palestinians and extravagantly praised the Israeli generosity of spirit.

Elsewhere in the Middle East, the Clinton administration appears to have been unwilling or unable to halt what appears to be the breakdown of the economic isolation of Iraq.

Arab governments, partly in response to the open siding of the U.S. with the Israelis over the years, have begun to openly defy the ban on civilian flights to Baghdad.

The U.S.-enforced "no-fly" zones in the northern and southern parts of Iraq are now regularly punctured by flights to Baghdad, since the U.S. fighters could never risk shooting down a civilian airliner filled with Arab officials and diplomats.

Iraq's Saddam Hussein could not resist that extra thumb-in-the-eye for the U.S. by insisting that Iraqi oil must now be paid in euros, rather than U.S. dollars.

Formerly staunch allies like Saudi Arabia are openly critical of the U.S. for its failure to understand the deep solidarity within the Arab world over the issue of the sanctity of Islamic holy sites in Al Quds.

Then, of course, there is the apparently eternal problem of the Balkans. After the original rush of euphoria over the fall of Slobodan Milosevic, it appears that he has lost none of his guile and many of his cohorts are still in positions of power.

Milosevic's American-backed successor, in an act of great symbolism, refused to meet privately with U.S. Secretary of State Madeleine Albright at a recent meeting of the OECD in Europe.

The ethnic Albanians, once the focus of U.S.-led rescue effort in Kosovo, have begun to resemble their enemies, the brutal Serbian militias, by conducting murderous raids into Serbia, in effect, thumbing their noses at the American peacekeepers in the area.

The U.S. and its NATO allies are unable to stop the snipers and, in the confusion and distraction of the U.S. electoral crisis, there appears to be a predictable case of peacekeeping fatigue.

The Europeans, meanwhile, are moving ahead on their own standing defence force, which will have a still-undefined relationship with the rest of NATO.

Albright and others in the U.S. government claim to be delighted at the new European display of independent military prowess, but there are some in the U.S. who see the development as the beginning of trans-Atlantic NATO divorce.

In Asia, the situation is not much brighter. U.S. relations with China continue to be testy. While trade disputes are glossed over, the Chinese appear to be intent on building a military force that has the specific aim of countering the U.S., not anybody else.

The Cold War, after a brief respite after the collapse of the

Soviet Union, appears to be returning in another form.

The international intervention to stop the Indonesian rampage in East Timor has stalled, with the Indonesian militia and military again asserting their dominance over the ruined landscape of the site of clashes.

And there is a new crisis looming in West Papua, which has been occupied by Indonesia since 1963, despite promises of independence for the 800,000 West Papuans.

This is another crisis that is so far off the radar screens of the U.S., that it is simply crowded off the newspaper pages in the U.S., not to mention the television programmes.

In what seems to be a perfect miniature of the unnoticed crisis in U.S. foreign policy, the Russian foreign minister, Igor Ivanov, no longer answers telephone calls from U.S. Secretary of State Albright.

The White House, either preoccupied or embarrassed by the events of the past six weeks, does not notice or does not seem to care about the erosion of what was once the boast that Vice President Al Gore's vitality and genius ensured the preservation of the vital Russia-U.S. relationship.

[JR: Our foreign policy under Clinton has succeeded in one thing—and that is making us the most distrusted, biased, unreliable, corrupt, destructive, deceitful and manipulative super power in the world. We have few, if any, virtues and our foreign policy failures reflect this. Our ambassador of ill will, SOS Albright, will not be missed. Let's hope she doesn't land a consultant job with Kissinger & Associates or a professorship at Harvard.]

NEW UN TREATY RATIFIED QUIETLY

The UN Convention to Combat Desertification was ratified by the U.S. Senate on October 18, but few Senators yet know that it has been ratified. Senator Craig Thomas (R-WY) introduced a package of 34 treaties, all of which were ratified by a show of hands—no recorded vote.

Initially, Senator Thomas' office told callers that the Senator had nothing to do with the ratification. On December 8, his office called to explain that Senator Thomas just happened to be on the Senate Floor late in the afternoon of October 18—and was asked by the leadership to handle procedurally, the package of treaties. Senator Thomas has asked the Foreign Relations Committee to explain how, and why, the Desertification Treaty was included in the package.

At the recent climate change talks in The Hague, Senator Larry Craig (R-ID) said the treaty had not been ratified, until corrected by one of his staff. Phone calls to Senator Fred Thompson (R-TN) and other Senators, caught staffers off guard: Nobody knew how their boss voted on the ratification. They could not know—there was no recorded vote.

This treaty was signed by the Clinton administration in 1994. It has been locked up in the Foreign Relations Committee since. Normally, treaties of such monumental importance are debated in committee and then forwarded to the Senate floor for further debate and disposition.

Not this time. The treaty appeared in a package of 34 treaties—most of which were single-issue treaties with single nations, dealing with stolen vehicles, criminals, and the like. The Desertification Treaty, however, is not a single-issue treaty with a single nation.

This treaty is one of several environmental treaties

that emerged from the 1992 UN Conference on Environment and Development in Rio de Janeiro. One of those treaties, the Convention on Climate Change, was ratified in 1992. The Convention on Biological Diversity failed ratification in 1994. The Convention to Combat Desertification was skillfully maneuvered through the Senate to avoid the public reaction which killed the Convention on Biological Diversity.

The Desertification Treaty claims jurisdiction over 70% of the Earth's land area—virtually all of the land that is not covered by the Convention on Biological Diversity. Moreover, this new treaty creates a structure through which all other environmental treaties are supposed to be integrated under a common United Nations implementation regime. A companion treaty is now being developed by the UN Commission on Water for the 21st Century. The United Nations is, in fact, creating the structure in international law and, through its extensive bureaucracies, to control the use of all natural resources on Earth.

The U.S. Senate ratified the treaty on October 18, 2000—whether or not it knew what it was doing. On November 17, the Clinton administration delivered the ratification documents to the United Nations. **The United States is now bound by the international law that claims the power to dictate land use in 70% of the Earth's land.**

The name of the treaty implies that it is concerned about deserts; in fact, it is concerned about all land use. To combat desertification, the treaty seeks to prevent land use that its enforcers think may lead to desertification. Converting forests to pasture, for example, or pasture to row crops, or crop land to subdivisions, are all uses that may lead to desertification, according to literature produced by the United Nations.

There is no distinction between federal land and privately owned land when it comes to land use under the jurisdiction of the UN. The UN sees its role to be the establishment of policy, it is up to the participating nations to see that the policy is implemented. The recent rash of land acquisition measures promoted by the administration and Congress seeks to get more land under federal ownership. The vast expansion of regulatory control over land use by all federal agencies makes it easier for the United States to comply with its international obligations under a variety of international treaties. This new treaty extends even further the U.S. obligation to control land use.

According to the treaty itself, no reservations can be included in its ratification (Article 37). The Resolution of Ratification adopted by the Senate contains several reservations, all of which will be ignored by the United Nations.

Withdrawal from the treaty cannot even begin until after three years of participation, and then another year must pass before withdrawal might be recognized by the UN. Assuming, of course, that there is some desire in the Senate to withdraw.

[JR: One would think our Congress would be alert to these regular covert maneuvers that sign our country's rights over to foreign powers, but evidently they are not. They have proven themselves to be willing participants and only playing the ignorant role for their constituents. A similar illegal maneuver was used to pass the *Federal Reserve Act* and it too was never repealed. Someone should be held accountable—and the action not just shrugged off as another of many "mistakes". The UN is a foreign power and will be run as a dictatorship over every nation on Earth. They are systematically

ARAB LAND BULLDOZED
FOR SETTLERS' BENEFIT

GAZA CITY (AFP) The Israeli army opened a new road for Jewish settlers in the Gaza Strip Monday, plowing over Palestinian agricultural land in violation of peace accords.

Israeli military radio said the army opened the road to take Jewish settlers from the Karni crossing point between Israel and the Gaza Strip to the Netzarim settlement.

The road runs over Palestinian-run areas and was built without the permission of Yasser Arafat's self-rule Palestinian Authority.

"What Israel did is a re-occupation and we consider this action a breach of the agreements," Saeb al-Ajez, chief of the Palestinian National Security Service in the Gaza City area, told AFP.

Witnesses said the army flattened and paved the roughly four-kilometre bypass road, bulldozing Arab houses, fruit trees and farm land in its path.

"It is not just the road, but Israel destroyed along the road houses and razed agricultural land to protect 200 settlers who live in Netzarim. They live at the expense of a half a million residents of Gaza City and its environs," al-Ajez said. "They also destroyed water wells and factories and infrastructure."

The some 7,000 settlers living among more than a million Palestinians in the Gaza Strip have often come under attack while traveling near Arab areas, in particular during the past two months of deadly violence.

The Karni crossing point and the road leading to it have been particularly hot flashpoints, with near daily clashes between soldiers and Gaza Strip residents.

Witnesses said the Israeli army began work on the road more than two weeks ago and that they had uprooted some 200 olive trees belonging to Palestinian farmers and razed agricultural land without providing any compensation.

Israel's *Haaretz* newspaper quoted military sources as saying the road was "a response to an urgent security need".

"The new road is one of several unilateral moves by the IDF (Israeli Defense Forces) in its attempts to provide greater security for the settlers," *Haaretz* said.

The presence of Jewish settlements is one of the greatest bones of contention for the Palestinians who consider them illegal under international law.

Israel was also due to re-open the Rafah crossing point which it jointly administers with the Palestinian Authority to allow travel from the Gaza Strip to Egypt, the reverse route having been opened last week.

But Israel and the Palestinians could not agree on terms after Israel, which has ultimate sovereignty over the terminal, imposed new security requirements for Palestinian personal and moved military hardware into the area.

The Palestinians have refused to cooperate as long as the new security requirements are in place.

[JR: The "peace talks" hide Israel's true intentions. The destruction and takeover of Arab lands clearly reflects Israel's determination to have it all. What lands she does withdraw from are controlled with blockades (e.g. Bethlehem)—depriving growth and a

livelihood for Arab businesses. Israelis may say good will to all men, but it does not apply to Arabs.]

NEGOTIATORS MEET
AMID REPORTS OF NEW PEACE PROPOSALS

JERUSALEM—Israeli and Palestinian negotiators held talks last night aimed at relaunching peace negotiations, amid reports Israel was offering the Palestinians more land than it offered at Camp David, and that Israel would give the Palestinians sovereignty over the Temple Mount, if the Palestinians would back off from the refugee issue.

One senior official in the Prime Minister's Office denied that any substantive talks were under way, insisting that most of the recent discussions have focused on what still must be done to reduce the violence.

Prime Minister Ehud Barak said in a speech last night at an Armored Corps memorial ceremony that he is aware of the risks he is taking to continue peace efforts. "Even if I pay for it with my seat I will be loyal to our path... there is no other way, we must move forward... even on this evening we are making another effort to reduce the violence and to try to see whether we can renew the negotiations—not at any price—but with determination and recognition of our responsibility to avoid another full-scale war."

A Palestinian Authority source said that Israel is also offering more land than at Camp David, namely some 95 percent of the West Bank. At Camp David Barak reportedly was offering the Palestinians 88% of the territories.

"True negotiations have not yet started," the source in Barak's office said, even as Foreign Minister Shlomo Ben-Ami and Barak's bureau chief Gilead Sher were meeting with Palestinian negotiators Sa'eb Erekat, Mohammed Dahlan, and Yasser Abed Rabbo.

The source denied statements made by various Palestinian officials that Israel had offered to grant the Palestinians sovereignty over the Temple Mount, except for the Western Wall, in exchange for the Palestinians backing down from their demand to resettle refugees in pre-1967 Israel.

"We oppose this," he said.

But the Palestinian Authority cannot accept an agreement without a formula for the Palestinian refugees, one senior PA official told *The Jerusalem Post*. Palestinian Authority Chairman Yasser Arafat cannot accept an agreement that does not address the refugee issue and try to solve it, he said. This, he said, is not just because he could not sell such an agreement to the PLO, but also because countries like Egypt, Jordan, Lebanon and Syria—which host Palestinian refugees—are pressuring him to solve the issue.

The official said swapping equal amounts of land in Israel for land Israel wants to annex for settlements would help solve the refugee issue.

On the one hand, it would create more land to settle refugees and, on the other hand, the PA can then claim that refugees were permitted to return to what was Israel.

Erekat characterized recent talks with Israelis as exploratory contacts to prepare for a possible summit in the U.S. aimed at sealing a final peace agreement.

He said that Israel and the Palestinians had yet to make the progress necessary to hold such a gathering and he did not want to raise hopes.

But he added, "I don't think we can describe

negotiations as negotiations if we don't see a summit taking place, and I think all these contacts are preparing to see if a summit can produce an agreement or not." Erekat added that Washington was consulting both sides on the possibility of a U.S.-sponsored summit between Barak and Arafat in the United States.

One PA source close to the negotiations said Arafat could not meet with Barak and engage in negotiations as long as Israel does not lift the closure of the territories. Meanwhile, some 10,000 Palestinian workers are expected to be allowed into Israel today, Israel Radio reported.

A U.S. official said last night that U.S. President Bill Clinton and Secretary of State Madeleine Albright have "said all along that we are willing to do whatever we can to assist the parties in restoring calm and finding a bridge to peace-making. One possible alternative is to have direct discussions between negotiators from both sides in Washington, and we are exploring this possibility with the parties."

One diplomatic source said that the sides are interested in holding negotiations in Washington, possibly this week, to convince Albright and Clinton that they are serious, in order to get Clinton back to the region for one last Clinton-Barak-Arafat summit.

Palestinian negotiator Abed Rabbo said yesterday he sees no prospect of a breakthrough in new peace talks with Israel, because Israel was still not making "the necessary compromises". Abed Rabbo said Barak is trying to deceive the world, as well as the Israeli Left and Israeli Arabs, into believing he was genuine about sealing a final peace deal before February.

"This is election maneuvering. Barak wants us to make compromises and to pay the price of his election victory. We refuse to do that. He has to pay the price of his own victory," he said.

Palestinian officials say that Arafat, at first pleased with talks he held Thursday at the Erez crossing with Sher and Ben-Ami, was angered when he learned three Palestinians were shot in clashes while he was at the four-hour meeting.

"It embarrassed him in front of his people," one Palestinian official said. The Palestinian cabinet met on Friday night and most ministers expressed their disapproval of ongoing contacts and resuming negotiations, another PA source commented.

The PA cabinet issued a brief statement saying: "Whatever sacrifices were made by our people were made to achieve their rights... and establish the Palestinian independent state with Jerusalem as its capital."

Ben-Ami said after the meeting that "An attempt is being made to create the necessary conditions to restart negotiations, a joint attempt to go over to the diplomatic stage." A senior source in the Prime Minister's Office, when asked whether there remained any trust between Barak and Arafat that could enable any serious negotiations, said, "Both sides understand that there is not a military, but only a diplomatic solution, to the situation."

[JR: How can any of the complex issues be resolved in an atmosphere that is filled with the tensions and the distrust of the parties involved? U.S.-LED TEAM SAYS IT WILL BE IMPARTIAL

JERUSALEM—A U.S.-led panel investigating the causes of recent Middle East unrest held its first meetings with Israeli and Palestinian leaders Monday amid continuing violence and a sharp dispute over the team's mission.

Led by former Sen. George Mitchell, the five-member commission pledged to remain impartial in order to ease tensions and get both parties back to peace negotiations. At least 313 people have died, most of them Arabs, in 10 weeks of Israeli-Palestinian clashes.

The commission is to deliver a report in March to the next president of the United States and to United Nations Secretary-General Kofi Annan.

But before that, Mitchell has said, he hopes to find ways to avert bloodshed.

"We have no illusions about the difficult nature of the task ahead," said Mitchell, who also played a key mediating role in the conflict in Northern Ireland.

U.S. President Bill Clinton announced the investigation at an emergency summit he hosted in mid-October in Sharm el-Sheik, Egypt. It was part of a U.S. attempt to satisfy Palestinians' demands for international protection from what Palestinians say is a repressive Israeli campaign against a civilian population defending its land from military occupation.

Israel has resisted the inquiry. It fears Palestinians will use it to accuse Israel of war crimes in their fight for international support to eject Israel from disputed areas and declare a Palestinian nation.

Israel tried to prevent Mitchell and his team from beginning their investigation while violence rages in the region. Israeli officials agreed 10 days ago to let the group begin work after Clinton assured them the commission's investigation would be limited in scope. Israel wants the commission to focus on the four months since the failure of July's peace summit at Camp David.

Palestinians call the fact-finding mission an "international commission of inquiry" and expect it to censure Israel for its handling of the recent violence and for its military occupation of the West Bank and Gaza.

Some observers say they fear the high-profile panel will have a hard time remaining neutral.

The United Nations has accused Israel of using excessive force to quell the riots that began Sept. 28 when Israeli opposition politician Ariel Sharon visited Jerusalem's Temple Mount, a site holy to Muslims and Jews.

On Monday, as Mitchell and commission members met with Israeli Prime Minister Ehud Barak and Palestinian Authority President Yasser Arafat, the clashes in the streets continued.

In Nablus, Israeli troops shot and killed 28-year-old Anwar Ahmed Himram, whom they said opened fire on an Israeli post. Palestinian witnesses called Himram's killing an assassination. **[JR: We could all be more optimistic if it weren't for this investigating team being led by the U.S. Their pledge to remain impartial is dubious, given our policies favoring Israel. KOSTUNICA EDGES CLOSER TO NEW CONFLICT

President Vojislav Kostunica of Yugoslavia called on NATO yesterday to allow heavily armed paramilitary forces to enter the Kosovo border buffer zone to end a campaign by ethnic Albanian guerrillas.

Amid concern that the guerrillas were preparing a fresh offensive in the Presevo valley, in southern Serbia, Mr. Kostunica said the NATO-led force should narrow the three-mile-wide buffer zone by at least half so that Yugoslav forces could reassert control.

The zone, established when Yugoslav forces left Kosovo after last year's NATO bombing campaign, has been exploited by guerrillas seeking to end Serbian rule in an area dominated by ethnic Albanians. Mr. Kostunica said: "Our goal is to cleanse the southern Serbian region of terrorists."

Criticising the failure of NATO peacekeepers to halt the violence in Kosovo despite an overwhelming presence, he said its units had "shown themselves incapable... and if they failed in Kosovo, what can we expect in the Presevo valley?" Nebojsa Covic, the deputy Prime Minister, said: "If the terrorists attack, we will respond by all available means."

Yugoslav anger has been fuelled by a series of attacks by Kosovo-based Albanian guerrillas, who recently exchanged fire with Russian and American peacekeepers. The guerrillas and Yugoslav security forces have been locked in a tense stand-off since four Serb policemen were killed last month.

In the village of Lucane and at other locations, opposing forces are separated by only a few hundred yards. Analysts have given warning that the explosive situation threatens to spill over into Kosovo and Macedonia. There are already signs of escalating violence in northern Kosovo.

In the town of Leposavic, Serbs angered by the arrest of a motorist on Saturday set fire to a police station, stoned vehicles, and briefly took seven Belgian soldiers hostage. One Serb was killed when Belgian troops opened fire and another was wounded. A third had a fatal heart attack.

A company of 150 British soldiers from the Princess of Wales's Royal Regiment has been sent to the area. NATO peacekeepers have been trying to seal the Kosovo-Serbian border to cut off the guerrilla army's main supply route. The Americans, while condemning the guerrilla army, are loathe to antagonise the fighting force and become targets.

Mr. Kostunica's remarks came just days ahead of crucial Serb elections in which his democratic coalition is expected to trounce Slobodan Milosevic's coalition. The issue threatens to become a major electoral issue, with Milosevic's party seeking to exploit simmering tensions on the Kosovo border to gain a political advantage, claiming that the Kostunica government is soft on terrorism and cannot protect the country's borders.

In sharp contrast to his predecessor, Mr. Kostunica has relied on diplomatic activity in an attempt to defuse a potentially explosive situation. Goran Svilanovic, the Yugoslav Foreign Minister, spoke to the United Nations Security Council at an urgent meeting called to discuss the crisis yesterday, while a senior

American diplomat visited the area on Monday.

[JR: The framers of the Kosovo agreement constructed a buffer zone that restricted the authority of the UN/NATO peacekeeping forces. 300,000 CHILD PROSTITUTES IN U.S.A.

LISBON—In a series of reports published recently, namely from the United Nations Organization, the World Tourism Organization and the International Labour Organization, shocking statistics have been released which explode the myth that child prostitution was confined to Third World countries and present statistics which paint a horrific picture of a world crisis of exponential proportions.

According to the World Tourism Association, every year there are 120,000,000 trips made with sexual objectives in mind, 360,000 of which are for pedophiles. However shocking this figure may appear, it seems conservative when compared with others. The Portuguese Daily Newspaper *Diario de Noticias* today quoted "international organizations" as having stated that in Asia, 12 million clients per year went to have their "sexual fantasies" fulfilled... by children.

Most of these clients, the source continues, are from countries belonging to the former "Western world". Of the number of foreigners arrested for sexual crimes against children in Asia in a two-year period between 1992 and 1994, 25% were from the U.S.A., 18% were Germans, 14% were Australians, 12% British and 6% French, totaling 75%.

With child sex accounting for up to 14% of the Gross National Product of certain South-East Asian countries, this is a large business to exploit and too large for which to find an easy solution. In its report "The Sex Factor: The Economic and Social Bases of Prostitution", the World Labour Organization states that sex involving children involves 800,000 children in Thailand, 100,000 in the Philippines and 500,000 in India.

However, it is not only in South-East Asia where child prostitution is a problem. The United Nations Organization quoted the U.S.A. as having no less than 300,000 child prostitutes. However, in this country, the situation is not related to poverty, but to social chaos. A North American Organization which fights against the problem of child prostitution affirmed that:

"The economic status of those involved in child prostitution is middle class. They do not run away from poverty, but rather from dysfunctional families in which they suffer from physical, emotional and sexual abuse".

These reports come in the wake of recent declarations by the General Director of the Spanish Minors Protection Ministry, who said that "In the (Iberian) Peninsula, mostly Portuguese, Dominican, Moroccan and Eastern European children are bought' and sold into child prostitution rings in Spain or abroad.

Many children are said to disappear in Lisbon every day and now we know why and where they go. What a sickening and depraved world we live in.

[JR: We don't seem to relate to the fact that evil has taken over the world, and with it innocent children. These acts of depravity—with children providing entertainment for the rich and powerful—reach into the highest levels of governments. Maybe that's why the UN provides the statistics—but no solutions or recommendations to end such practices.]

GERMAN LAWS ON INCITEMENT OF RACIAL HATRED ALSO APPLY TO INTERNET

KARLSRUHE—In a decision with potentially far-reaching legal and political consequences, the Federal Court of Justice ruled on Tuesday that German laws against neo-Nazi propaganda can be applied abroad even when such material is placed on the Internet by a non-German.

It ruled that German laws against denying the Holocaust and spreading right-wing extremist propaganda were legally valid even when the material was put on to the Internet in another country, and that German courts could file charges for incitement to racist violence against Holocaust deniers who use the Internet even when it is not certain that Internet users in Germany had accessed their Websites.

The court thereby rejected an appeal by Frederick Toben, 56, an Australian of German descent, who had used his computer in Australia to make his own "revisionist" articles available to Internet users. The texts described the mass murder of 6 million Jews by Nazi Germany as an invention of "Jewish circles".

The articles were accessible to anyone in the world who visited the Internet address of an institute run by the defendant.

Mr. Toben was convicted last year by a German court for denying the killing of Jews by the Nazis both on the Internet and in pamphlets distributed in Germany, and a district court in Mannheim sentenced him to 10 months in prison without probation.

But he was acquitted of the more serious charge of incitement to racial hatred on the Internet because, the judges ruled, he had written and published the Internet articles in Australia, thus making him exempt from German law.

The Mannheim judges said German law only applied to acts carried out in Germany—with the exception of certain crimes which did not include incitement. The defendant had not committed the offences in Germany, nor was there any evidence that anyone in Germany except the police had paid any attention to his Internet publications. The mere fact that people in Germany could have accessed the articles was not sufficient grounds for the application of German law, the judges said.

The Federal Court of Justice, however, went a step further, saying German laws against Nazi incitement also apply to material that foreigners "put on a foreign server that is accessible to Internet users in Germany". The presiding judge in the court's first criminal division said that, in his judgment, the Internet articles had been intended "to cause a breach of the peace in Germany."

He went on to say that it was irrelevant whether these articles had really poisoned the social climate in Germany. Given Germany's history, the legislators had rightly aimed at preventing the very possibility of such incitement, he said.

RARE SKELETON HAS SCIENTISTS NERVOUS

Skeleton's DNA Could Shed Light on American Migrations

VANLUE, OHIO (AP)—The discovery of prehistoric tools from an Ohio cave is one of several finds that has scientists questioning the identity of settlers thought to have moved in 11,000 years ago.

A just completed excavation of Sheriden Cave in Wyandot County, 100 miles southwest of Cleveland, revealed tools made from flaked stone and bone. The items are scheduled to go on display next year at the Cleveland Museum of Natural History.

Kent State University archaeologist Kenneth Tankersley, who led the excavation over the past four years, said definite answers won't come until someone finds an Ice Age skeleton and the DNA is tested.

"Disagreement swirls around the timing of their arrival, the nature of their migration, how fast they moved across the landscape and their relationship to contemporary Native Americans," he said.

Some scientists think that the earliest colonizers could have started out somewhere in Europe, not in Asia as previously thought. That idea is rooted in a rare genetic link called haplogroup X—DNA passed down through women that dates back more than 30,000 years.

Recent genetic samples from remains in Illinois show that the rare European DNA was around centuries before European exploration. Today, haplogroup X is found in about 20,000 American Indians.

To some researchers, its presence suggests the Mongolian ancestors of most American Indians were latecomers. Genetic tests show the DNA is completely absent from East Asian and Siberian populations.

That could dispel the more than half-century-old notion that humans migrated across a land bridge from Siberia at the end of the Ice Age, made stone tools and hunted while moving south.

Archaeologists since 1996 have found genetic indications of several migrations, along with evidence that people came from Polynesia, regions near Japan and even Western Europe.

"Frankly, it makes me nervous," Smithsonian Institution anthropologist Stephen Loring said of the idea that the first Americans during the Ice Age were of European ancestry. "It's a heretical argument, and some people, unfortunately, will use it to assert the cultural superiority of Europeans. But it's a good theory that needs to be tested."

Tankersley and Brian Redmond, head of archaeology at the Cleveland Natural History Museum, have been seeking clues about the first colonizers from the cave, which is hidden 50 feet below cornfields.

"To find human remains of that age, 11,000 years old, is really, really rare, and I don't think there are any in that cavern. We would have found them," Redmond said. But he added, "Who knows what may turn up in the future. We're certain it was a camping area."

Farmers and landowners fear they could be tied up in litigation by preservationists and Indian

tribes if old bones are disturbed.

"We know of places where you could probably find human remains up here," said Keith Hendricks, a Hancock County sheriff's deputy whose family owns the sinkhole where the Ice Age relics have been recovered. "But the problem is you'd be opening a Pandora's box. It's a sensitive issue." **[JRN: Why are we seeing such determined opposition to what these findings of fact reveal? Well, it is a complex answer because of the intrusion of two seemingly disparate groups: the Catholic Church and the Talmudic Jews. Both of whom have been very active in the discrediting of the impact of these unusual finds relating to the early Scandinavians, the Irish and other Europeans coming to North America. However, the findings of these White artifacts clearly shows that Europeans were here much earlier than what the Catholic Church would accept and would also seek to defend the idea that Catholic Spain, and Italy should be credited with the first discoveries. Those of the Jesuits who accompanied the early discoverers destroyed much of what they found in the New World as they did to many of the Mayan and other documents and artifacts that would have shown that others had preceded them to the Americas. The Vatican does have some of them, but try and see them.]**

VATICAN BUCKS RP CHURCH ANTI-ERAP ACTIVISM

MANILA—The Vatican has expressed concern over the Philippine Catholic Church's active involvement in the campaign to force President Estrada out of power, and the papal nuncio, Antonio Franco, has been instructed to relay these sentiments to Cardinal Jaime Sin and the hierarchy.

This was reported by Ambassador Henrietta De Villa in a Dec. 13 cable to the home office which was made public yesterday.

De Villa said the Vatican's position was relayed to her in an informal, private conversation with Msgr. Luis Montemayor, head of the Asian desk of the Vatican's Secretariat of State.

"The Vatican believes the position taken by the local Church has placed the entire Church in a precarious situation which could eventually rebound to a negative effect on the country, the Church and the magisterium of the presidency," De Villa said.

"The Vatican believes that respect should be accorded the *Constitution* and the legal processes as well as the office of the president, since these are the symbols of a democratic system that cannot simply be discarded or tampered with, regardless of who holds that office as long as he was elected freely and fairly by the people," she said.

"On the question of Mike Velarde and El Shaddai, the Vatican can see no violation of Church doctrine on Velarde's part concerning his decision to stand by the President. There can be, according to Msgr. Montemayor's emphasis on the Vatican's views, 'no such thing as one Catholic vote'," De Villa said.

"It is dangerous for the Church to be a party to destabilization moves, especially since there is no guarantee that events would (not) lead to violence," she said.

The Catholic Bishops Conference of the Philippines said it has received a copy of the De Villa cable. It has reserved comment on the report until today.

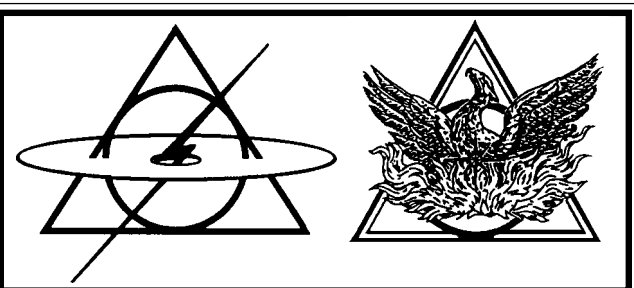
